

### Sultan of Oman congratulates Dr Magufuli on re-election

THE Sultan of Oman, His Majesty Sultan Haitham Bin Tariq Al Said (pictured), has sent "hearty congratulations" to Dr John Magufuli on his re-election for a second and final five-year term following his landslide win in Wednesday's Presidential Election while standing as the ruling CCM's candidate.

In line with Tanzania's Constitution, the election was held simultaneously with the parliamentary and councillorship polls across the country.

The sultan also directed the congratulations to "all the people of Tanzania", saying: "Your victory is a pure testimony of the trust and confidence that the Tanzanian people have on your leadership and performance after steering the country in the right direction during the previous term of five years. We wish you well in this endeavour."

According to the final results of the Union presidential election as announced on Friday by the National Electoral Commission, CCM Magufuli garnered 12,516,252 votes (84.4 per cent of all valid votes cast). Tundu Lissu of the opposition Chadema came second with 1,933,271 (13 per cent).

### Tense wait as US election winner remains unclear

#### **WASHINGTON, DC**

THE outcome of the US presidential election is on a knife edge, with Donald Trump and his rival Joe Biden neck and neck in key swing

Trump, a Republican, claimed to have won and vowed to launch a Supreme Court challenge, baselessly alleging fraud.

Earlier Biden, a Democrat, said he was "on track" to victory.

Millions of votes remain uncounted and no candidate can credibly claim victory as yet. There is no evidence of fraud.

The US is on course for the highest electoral turnout in a century. More than 100 million people cast their ballots in early voting before Election Day, and tens of millions more added their vote on Tuesday.

With the nation on edge, the final result may

not be known for days. Trump has defied the pre-election polls to do better than predicted, but Biden is still in the race and the overall result is not yet clear.

In the US election, voters decide statelevel contests rather than an overall, single, national one.

To be elected president, a candidate must

ZANZIBAR President Dr Hussein Mwinyi yesterday asked officials heading government institutions and agencies to embrace the work ethic for the Isles to achieve its development

Conducting an inspection tour of the newlybuilt warehouse facility meant to decongest the main port of Malindi, Dr Mwinyi said the business as usual work culture is a big problem that must be combated.

He directed top officials of the Zanzibar Port Corporation and the Zanzibar offices of the Tanzania Revenue Authority (TRA) to immediately take measures to end congestion of cargo at the port.

"We have a new warehouse facility here and yet our port is congested. This is just a matter of changing our attitudes towards work," he told port officials.

He said even the warehouse facility took too long to complete despite being constructed by a special operations agency under the Isles government, namely the anti-smuggling unit,

TWENTY heads of state and government have arrived here to witness the swearing-in ceremony of president-elect Dr John Magufuli today.

Briefing reporters yesterday, chief government spokesman Dr Hassan Abbasi said 83 resident diplomatic representatives have also confirmed

A number of countries had sent vice presidents or prime ministers and similar top officials, to feature in the first ever swearing-in ceremony in the newly completed capital of Dodoma.

Prominent guests include former Nigerian

president Olusegun Obasanjo and renowned Nigerian televangelist TB Joshua, a friend of various top political leaders who have frequented his open air church assembly in

Heads of State expected include President Yoweri Museveni of Uganda, President Azali Assoumani of the Comoros, and President Emmerson Mnangagwa of Zimbabwe, the spokesman noted.

LINDI Region has swung into action to beef up security, instructing residents not to accommodate strangers when they appear, and instead they should report them to local government authorities.

Addressing reporters here yesterday, Regional Commissioner Godfrey Zambi said the precautions follow the deterioration of security in neighboring Mozambique and last month's


terrorist attack in Mtwara Region. Lindi has lately seen unusually big numbers of

guests arriving in the town, ostensibly intending to do business or engaging in religious activities, apart from just being casual visitors.

He called on law-abiding citizens not to trust people they do not know as they can turn out to be terrorists, appealing to owners of accommodation facilities not to stick to the 'business as usual' outlook but demand proper identification for guests and report suspicious

win at least 270 votes in what is called the Electoral College. Each US state gets a certain number of votes partly based on its population and there are a total of 538 up for grabs.

The president is projected to have held the must-win state of Florida - a major boost to his re-election bid.

The UK channel BBC projected Trump win in another conservative sunbelt state, Texas, where the Biden campaign had dreamed of an upset victory.

But Biden was on course to take Arizona, a once reliably conservative state, which Fox News and the Associated Press projected it was leaning to the Democrats.

In late night remarks (early morning East African time) Trump aired hopes for taking the previously Republicanvoting state but within hours that hope was dashed, with Biden in unassailable lead.

The rust belt battlegrounds of Pennsylvania, Michigan and Wisconsin, which chroniclers say propelled Trump to the White House four years ago, were the principal states to watch at the close of press time EAT yesterday.

Pennsylvania was leaning for Trump though the votes were still being ounted, with the main worry being the large number of mail-in ballots that the Trump campaign doesn't trust, but late voters tended to vote Trump, on the basis of extensive exit interviews and assessments early yesterday.

Biden retained a narrow lead in Wisconsin and a dithering lead, changing hands from time to time, made people hold their breath constantly in Michigan.

Georgia had largely been won by Trump as well as North Carolina, as well as retaining Ohio and Missouri, known as bellwether states because they have so often predicted the eventual winner, on the basis of analysts' projection.

Controlling the two chambers of the legislature, House of Representatives and Senate was also at stake, apart from the White House, as Republicans battled to hang on to a majority in the Senate while the House of Representatives is expected to stay in Democratic hands.

Trump hosted an election night gathering inside the White House with about 100 guests.

In a speech at about 02:30 local time (07:30 GMT) he said: "We were getting ready to win this election. Frankly, we did win this election."

He went on to express suspicions the Biden camp is 'working to steal this election,' and curiously demanded that no more ballots be received after end of voting on the US in the evening, as late ballots and mail in votes are dreaded by Republican strategists as favoring Democrats. Trump even talked of going to the US Supreme Court to stop receiving late ballots in swing states, but Vice President Mike Pence in brief remarks asserted that 'every ballot will be counted.'

"We want all voting to stop," the president had declared, as it was well past midnight in the US, but analysts saw his remarks as directed at postal ballots. The law on such ballots differs from one state to another as US polls are held at state level.

Observers said millions of ballots have yet to be counted and there was no evidence of fraud.

After the president's remarks, former vice president Biden condemned the president's statement as "outrageous, unprecedented, and incorrect," calling it a "naked effort to take away the democratic rights of American citizens."

Earlier, at about 01:00 local time, Biden predicted in a speech to supporters in his hometown of Wilmington, Delaware, that he was headed to victory, a statement that even at that point was seen as overly optimistic by experts interviewed on BBC.

The Democratic contestant said: "We feel good about where we are, we really do. I am here to tell you tonight we believe we're on track to win this election."

He added: "We're going to have to be patient until the hard work of tallying votes is finished and it ain't over until every vote, every ballot is counted," but the trend was by early morning EAT already showing major swing states going Trump by late voting, though early ballots had mostly veered towards a Biden win.

handed over.

As it is a government project implemented by government agencies. there was no palpable reason to withholding handing over as it often happens when a facility is built by private contractors, he stated.

The problem is with government officials, he said, insisting that the government keeps losing money from port inefficiency, with responsible officials failing to make simple decisions. Ships docking at the port had sharply declined recently as it takes simply too long too unload cargo, he pointed out.

Excess cargo at the port must be moved to the new warehouse facility to allow space for incoming ships to dock at the port, the president directed.

Mcha Hassan Mcha, TRA assistant commissioner in Zanzibar and Salum Udi, acting director general for the Zanzibar Ports Corporation promised to shift cargo, starting to use the new warehouse right away.

The president had on Tuesday visited the port and Maruhubi area to inspect cargo clearance and what delays operations, his first public activity since being sworn in on Monday.

Zanzibar's main port of Malindi is notorious for cargo clearance delays, with queues of containers and incoming ships staying long out at sea before berthing, and now the new leadership is pushing deliberate efforts to end the situation by removing containers at the port to the new warehouse, and speeding up clearance.

Zanzibar's economy very much depends on the port and its sluggish activity ccauses ripples to economic growth, if ships with cargo destined for Zanzibar berth at the port of Dar es Salaam or the port of Mombasa over the northern border.

Offloading Isles cargo elsewhere

causes inconveniences and losses to importers and Isles traders, as

some importers opt not to bring their cargo directly to the Malindi port, the president noted, stressing the need for solutions.

Port authorities have to increase the

pace of offloading and clearance of cargo to reduce waiting time for ships needing to berth, as delays cause rising prices from waiting charges, storage of goods at the port. A dry port facility would reduce

congestion of cargo containers within the vicinity of the port, while port managing director Juma Sururu Juma said some importers delay to clear their goods, apart from bureaucratic red tape.

Goods that obtain fast-track clearance include foodstuffs, cement and special oil cargoes, while berthing of ships involves staying at the port for not more than five days as cargo, he said, as offloading is done day and night.

Ali Haji Haji, the acting director general of the Zanzibar Port Authority (ZPA) said Maruhubi area which will soon be designate as a dry port.

southern corridor in general are prone to attacks, so public officials and residents must be proactive on the issue.

The RC who is chairman of the regional defence and security committee directed similar committees from village to regional level to come up with strategies to ensure security in each administrative unit.

POLICE in Kilimanjaro Region said the invasion of elephant herds in human settlements in Mwanga and Same districts is due to the construction of human settlements in the wildlife corridors.

Police Kilimanjaro Regional Commander Emanuel Likula said: "We have already called game wardens to chase away the elephants, but also the people should understand that the areas they have built up their settlements are animals' corridors."

"This is because they have the habit of moving along their routes even after 100 years. Move about with care and inform the authorities whenever you sight them," he added.

Likula was commenting on reports of the death of a teacher from Kwakoa secondary school in Mwanga District who was killed by an elephant on November 1 this year.

# 'Human settlements along wildlife corridors spur jumbos invasion'

A wildlife corridor is a link of wildlife chasing them away to the reserves. habitat, generally native vegetation, which joins two or more larger areas of blocking of wildlife corridors linking similar wildlife habitat.

Ecologists at the Tarangire National Park expressed similar concerns, saying a wildlife corridor which once linked it with Lake Manyara National Park, the Ngorongoro Conservation Area (NCA) and other areas had been effectively blocked by human activities, including farming, construction of structures and grazing of livestock.

In the past, they said, the corridor stretched between Makuyuni township in Monduli District and Minjingu phosphate mines in Babati district.

# 49 illegal immigrants from Ethiopia arrested in Saadani National Park

OFFICIALS of the Tanzania National Parks (Tanapa) have nabbed 49 illegal immigrants believed to be Ethiopians in Saadani National Park.

Tanapa's Senior Assistant Conservation Commissioner, Communications, Pascal Shelutete said the immigrants were nabbed early this week at Saadan village on the shores of the Indian Ocean, In Bagamoyo District, Coast Region.

Shelutete said the arrest was facilitated in collaboration with the unearthing all those engaging in villagers and Saadani National Park

authorities who had have handed them to the police and the Immigration Department for legal procedures.

He said Tanapa warned all those who use national parks in violation of the laws to stop doing so at once, else legal steps would be taken against them.


"Tanapa is well mobilised to make sure reserve areas remain to be safe for reserve and tourists' activities and not for anything else," he said.

#### Consultancy: World Wide Fund for Nature (WWF) Tanzania Country office Brand Awareness Survey

#### Introduction

The World Wide Fund for Nature (WWF) is a global conservation organization that was founded in 1961, and has grown to become one of the world's largest, experienced and independent conservation organizations, with about 5 million supporters and a global network active in nearly 100 countries. WWF's Mission is to stop the degradation of the planet's natural environment and to build a future in which human's live in harmony with nature.

#### **Tanzania Country Office**

WWF Tanzania has a long history of conserving and protecting the natural resources in Tanzania. From wildlife, marine, forests, fresh water to some of the most endangered species in the world. Through working collaboratively with different stakeholders and partners both within and outside the country WWF has made a significant contribution to improve management and protection of natural resources and biodiversity statuses in different areas in Tanzania.

WWF Tanzania Programme Office was formally established in Tanzania in 1990 and operates under the auspices of a formal Agreement with the Tanzanian Government. As of July 2009, WWF in Tanzania changed its status from a Programme Office to a Country Office. WWF Tanzania envisions that By 2030, Tanzania's outstanding and globally significant natural Wealth and biodiversity are sustained, and support equitable and gender-sensitive local livelihoods and national economic development for present and future generations.

#### Justification for the survey

WWF Tanzania wishes to have a better understanding of the level of perception and awareness of the WWF brand in the country amongst the mass public. It is expected that the results of this Survey will inform how WWF communicates with key audiences, develops marketing and partnership initiatives, and delivers conservation at a scale that matters.

#### 2. Purpose of the Brand Survey

The findings of the survey shall inform the various activities that will be carried out as part of the WWF Tanzania Organization development process. As such, the Survey will be expected to contribute directly to the attainment of the following objectives:

- 1. Provide a clear picture of the health of the WWF brand in Tanzania amongst the mass public
- 2. Support in the formulation of sustainable marketing and partnership strategies that are resilient at the sectoral and multi-sectoral levels:
- 3. Support in the implementation of the TCO Communication Strategy for more effective partnerships development, enhanced brand awareness and greater impact on conservation of the country's rich natural resources and livelihoods improvement;
- 4. Support in awareness-raising and outreach activities to the broader public, while providing a basis for advocacy activities directed at key
- 5. Provide an understanding on the need to engage with various target groups as well as tactics to achieve optimal engagement.

#### **Context:**

Based on the survey template developed by Hall & Partners and adapted by several WWF offices globally the research approach for TCO shall consist of a number of core questions. However, the consultant will be allowed a room to develop locally relevant questions without moving away from the network's brand survey objective. The successful consultant shall be provided with the template from Hall and Partners and granted permission to make relevant edits by liaising with WWF Tanzania.

#### 3. Scope of Work

In line with the objectives of the above-mentioned Survey, the main tasks of the consultant shall be as follows:

- 1. Consult and provide a comparative brand analysis of other conservation organizations similar to WWF in Tanzania.
- 2. Develop fieldwork guidelines and field questionnaire (that will be reviewed and approved by WWF) to conduct the Survey in Tanzania.
- 3. Work together with the WWF Tanzania team and WWF International Brand team to guide adopting the materials in (2) above.
- 4. Conduct the Brand Survey in Tanzania.

#### Methodology

The proposed methodology should include the following stages:

- (a) A desk review of the available secondary data, especially while conducting a comparative analysis of the WWF brand;
- (b) Key informant interviews with relevant government, private sector and I/NGO staff;
- (c) Primary data collection (predominantly qualitative however supported with reasonable and sample based quantitative information), using fieldwork guidelines and field questionnaires provided by WWF;
- (d) Audience analysis and mapping (audiences can be the general public, organizations, community groups, government departments,

CSO networks or individuals with an analysis of what their perception of WWF is);

(e) Feedback and discussions in consultation workshops.

The selected consultant/s will be expected to develop detailed methodology in agreement with WWF Tanzania.

#### 5. Outputs

Deliverables must clearly contribute to the attainment of the afore-mentioned Survey objectives and include in particular:

- 1. An in-depth brand analysis, which recommends a set of key areas to be pursued with target audiences at the local (program area), regional and national levels.
- 2. A branding implementation plan comprising the principal activities to grow the WWF brand for enhanced marketing, building partnerships, and raising awareness of the brand.
- 3. Reports and minutes of preparatory meetings and training
- 4. A final report presenting the principal stages of the process, the work done, the lessons learnt as well as recommendation towards future replication of the approach.
- A PowerPoint presentation to WWF Tanzania Senior Management Team (SMT) and staff on deliverables 1-4 above.

#### 6. Competencies

This work should be done by an experienced consultant or consultancy firm (with the lead consultant taking full responsibility for the work and delivery of products). ### NGO plans to assist Chemba, Kondoa sunflower farmers to boost production

IN EFFORTS to maximize cultivation of sunflower and oilseeds production in central zone corridor, Livelihood Basix Tanzania (LBT) is planning to enroll and assist at least 6,000 farmers in the two districts of Chemba and Kondoa, Dodoma region.

This is after the timely project to prove positive results in its first intervention conducted in the said two districts, whereby a total of 3,000 farmers were benefited.

LBT is a non governmental organisation (NGO) which majors in assisting farmers with free quality sunflower seeds, agro -mechanisms as well as imparting them with sounding knowledge over standard growing methods.

Granting an exclusive interview to The Guardian over the weekend, LBT country Director Atilio Mbwilo said in the next growing season the project expects to register other 3,000 farmers, making a total number of beneficiaries farmers to stand at 6,000.

"During the first phase of our project, beneficiaries managed to acquire professional growing skills hence they yielded bump harvests, ever before. Such an impressive record motivated others to lodge countless request seeking to join with the project in order to benefit from the same," he expressed.

Mbwilo detailed that through the initiative farmers are also receiving professional training from Kibo Seed Company Ltd, Ilonga Agriculture Research Institution and extensional officers from Chemba and Kondoa Districts.

"Most farmers were lacking capital to afford purchasing quality recommended seeds like Records and Kenya Fedha, they also experienced major challenges of getting assured of market for their yields," he said, adding that the project was assisting the farmers in the two sides.

Speaking with this paper in a separate interview, Dodoma Regional Commissioner Dr Binilith Mahenge said despite being endowed with all potentials for the cultivation of sunflower, farmers in the region are yet to benefit from such a rarely economic opportunity as they encounter myriad challenges.

"Most farmers are short of capital to venture into large plantations, they don't have assured and better market for their harvest," he said.

However, Dr Mahenge assured the striving farmers the government in the region was working round the clock in partnership with key stakeholders from the private sector to develop the performance of the law with content.

develop the performance of the key sub-sector.

Dodoma and Singida are famous in production of sunflower and oilseeds but farmers and relevant investors are yet to benefit from their executions due to poor farming methods and lack of enough capital.

In recent years, the government and the private sector initiated various efforts to help spur performance of the farmers so as to boost sunflower oilseed processing industries.

Among the initiatives was the decision by the government to include the two region among regions that are benefiting from SME Credit Guarantee Scheme Fund.

Others proceeding intervention for boosting sunflower growers in the two regions are the Agriculture Markets Development Trust (AMDT) and the 2016-2020 Sunflower Development Strategy Plan.

Mbeya, Rukwa, Katavi, Njombe, Singida, Shinyanga, Manyara, Lindi and Mtwara are among regions with cultivation of sunflower.

#### **Background on PASS Trust**

Some villagers from Mkuzi, Kanga'ta and Madebe villages in Handeni District said they have started to discern the effects of forests' destruction, including the shortage of rains and drying up of water sources.

It is estimated that more than 460,000 hectares of the country's forests disappear every year causing significant drop of government income due to human activities in the forests.

### Researchers develop low-cost rapid malaria test

#### **By Special Correspondent**

RESEARCHERS have developed a simple microneedle patch similar to a bandage to detect malaria, which could ease the burden of disease in countries struggling with poor health infrastructure.

The device developed by researchers from Rice University could cost about a dollar once the manufacturers start producing it in bulk. The microneedles in the patch collect interstitial fluid from the skin, which contains several biomarkers that help detect diseases like malaria.

With 16 hollow microneedles in a 4-by-4 array on one side, the sticky patch is coupled with an antibodybased lateral-flow test strip. The antibodies react when they sense protein biomarkers for malaria and turn two readout lines on the strip's exposed surface red. If the test is negative, only one line turns red, researchers said.

The findings published in the Nature journal Microsystems and Nanoengineering maintain that the test can be completed in less than 20 minutes and require no equipment.

The rapid test project, funded by the disease become even more crucial Bill and Melinda Gates Foundation, during the coronavirus pandemic in has been developed by Peter Lillehoj and Xue Jiang from the Department of Mechanical Engineering, Rice University.

"The disposable patches could be programmed to detect other diseases, potentially including COVID-19," said Peter Lillehoj. "Xue and I have applied the patch to our skin, and it doesn't feel painful at all compared to a finger prick or a blood draw. It's less painful than getting a splinter. I would say it feels like putting tape on your skin and then peeling it off."

According to the World Health Organisation (WHO), nearly 3.4 billion people in 92 countries are at risk of being infected with malaria. There were 435,000 malaria deaths, with 93 percent of deaths occurring in the African region.

"Malaria rapid diagnostic tests have the potential to significantly improve management of malaria infections. especially in remote areas with limited access to good quality microscopy rounded the edges to make it a little services," says the WHO guideline on malaria control and elimination.

Diagnostics and prevention of the 

Africa, where nearly 95 percent of all the world's malaria cases and deaths

The WHO has already raised the alarm over disruptions to insecticidetreated net campaigns and access to anti-malarial medicines due to coronavirus pandemic could lead to a doubling in the number of malaria deaths in sub-Saharan Africa this year compared to 2018.

Tragically, children below the age of five are among the most vulnerable groups affected by malaria, requiring prompt support from medical teams for diagnosis and treatment. In African countries, more than 285,000 children died before their fifth birthdays in 2016.

The new test, according to the researchers, may provide some comfort, especially to children. "We didn't intend for it to look like a bandage," they said. "We started with a rectangular shape and then just more presentable. We didn't plan for that, but perhaps it makes the patch more relatable to the general public."

#### 1. Background Information

The Government of Tanzania (GOT) recognizes that economic development is highly dependent on and closely related to the environment and biodiversity. This realization was translated into policy and legal formulation, which led to the introduction of the Wildlife Policy of Tanzania (WPT) that was passed in 1998 (and revised in 2007) as one of the policy changes fostering greater local community participation, ownership, and benefit-sharing. This shift of policies led to the establishment of the (Wildlife Management Areas) WMAs on village lands as programs responsible for managing natural resources.

The objective of the WMA implementation program includes (i) to increase the participation of local communities in the management of wildlife resources; (ii) to enable local communities to derive benefits from wildlife resources; and (iii) to enhance the conservation of wildlife resources.

Magingo WMA, managed by Magingo CBO, is one of the 24 WMAs comprised of the eight villages (Mirui, Naujombo, Kimambi, Barikiwa, Chimbuko, Mlembwe, Ndapata, and Mpigamiti) and that is responsible for the Liwale Wildlife Management Area (LWMA). The WMA is located in the Liwale District of the Lindi Region of Tanzania.

To guarantee sustainable conservation of wildlife resources in WMAs and safeguard the interests of traditional communities, the Wildlife Conservation (Wildlife Management Areas) Regulations 2018 calls for the development of a General Management Plan (GMP) or Resources Management Zone Plan (RMZP) before the establishment of WMAs. An RMZP, which operated for five years only (20210-2015), before a GMP. Currently, the Magingo RZMP has outlived its usefulness, which calls for a reversion

- Conduct a situational analysis of the implementation of the current RZMP
- Baseline data collection for developing a general management plan
- Analyze problems, issues and concerns, including resource conflicts analysis;
- Analyze outstanding resources and values;
- Analyze the significance of the WMA;
- Carry out GPS survey for demarcating management zones and prepare GIS-based maps;
- Develop management programs; and
- Carry out a rapid environmental assessment for the proposed activities/programs in the WMA.

The consultant shall provide: -

- · An inception report describes team composition and qualifications, the methodology of undertaking the assignment, work plan, and the report's proposed content. The inception report shall be submitted to WWF ten days after signing of the contract;

  - o Vicinity/location map of the WMA showing adjacency to neighboring protected areas. o Management zones map showing infrastructure and physical features, and a land cover map
  - o The draft report must be submitted to WWF thirty days after the signing of the contract.
- After the review, the consultant shall provide ten (10) hard copies and soft copies in a Flash of the GMP document and all GIS files to WWF on the last day of the assignment.
- · All deliverables must be in English and translated correctly in the Kiswahili language, and submitted in a similar number/format as required above.

#### 4. Expertise Required

This assignment requires a multidisciplinary team that combines various skills and experiences. The team leader must possess an MSc or Ph.D. in natural resources and the environment with solid knowledge in wildlife management issues, community-based natural resources, and management aspects, GIS, and not less than five (05) years of working experience in natural resource-related issues.

to the debate on the propriety of the recent general election in Tanzania, one from the Commonwealth and another one is a local view, from a well known research outfit at the University of Dar es Salaam. There is another remark thej Commonwealth statement made which was answered the time that the statement was being issued, that "positive lessons from previous elections could inform current processes. Secretary General Scotland said pointedly that "I hope that every option will be explored to maintain trust in the electoral process and to ensure that democracy, peace and unity are safeguarded in Tanzania." That is what is being done, for instance the offer for a national unity government in Zanzibar.

It would all the same be difficult to expect that all concerns of opposition parties - as echoed in the statement by the Commonwealth, and earlier by the US Embassy in Dar es Salaam - can be

# Gold: A safe haven, or too hot to handle?

■HE spike in the gold price has every person and their dog interested in investing in the yellow metal. Is this a good idea? History may provide some

Financial market moves in 2020 can best be described with one word unprecedented. Equity markets experienced one of the sharpest and speediest declines in the first quarter of 2020, only to recover most of these losses in the four months to the end of

The market moves have been nothing short of breathtaking, with the swift action of governments and central banks to provide support in the form of fiscal stimulus and lower interest rates no doubt playing a role in the recovery.

One of the most significant winners year-to-date in 2020 has been gold. The price of the precious metal has risen 30% in US dollars since the beginning of the year (to the end of July), in the process becoming one of the most talked-about trades of 2020.

This has driven the performance of gold counters listed on the JSE - many of which are up by more than 100% since the beginning of the year.

Even long-term gold cynic Warren Buffett made news headlines recently when it was announced that his company, Berkshire Hathaway, added shares of Barrick Gold to its portfolio in

the second quarter of the year.

Gold has a long history as a safe haven investment. This is largely since the price of gold is independent of other asset classes, which means that the metal has generally performed well during periods of market stress or volatility.

Gold has also traditionally been a refuge against US dollar weakness, largely due to the inverse relationship between the world's reserve currency and commodity prices. Investments in gold generally take place in one of two forms: buying the commodity itself (gold bullion) or buying shares of companies that mine and sell gold (gold equity).

In the South African environment, investments in physical gold usually take the form of investments in gold exchange-traded funds or ETFs.

Due to the impact of leverage (both financial and operating), investments in gold stocks tend to be more volatile than the direct investment in the physical commodity, which depends only on the price of the metal.

#### Investing in gold as protection against market declines

Historically, gold has excelled during periods of significant market declines and periods of unusually high market volatility. The metal has posted significantly better returns during market drawdowns and in some cases, has even notched positive total returns during periods of steep losses in equity

Covid-19 sell-off provided an interesting case study, in that although gold fared better than stocks, it still posted a small loss. This has been attributed to many factors, including the fact that the selloff was liquidity-driven (and therefore all-encompassing) and the feeling that interest rate cuts will support the US dollar (a negative for commodity prices).

Lockdown measures introduced across the globe also caused mine closures and production shutdowns, which affected gold producers negatively. Gold did, however, reverse course, moving significantly higher in the months following the market selloff, reaching a peak of just above \$2,000 an ounce.

#### Gold as an inflation hedge

Despite often being regarded as a hedge against inflation, gold's record of protection is rather mixed. The metal did provide significant protection during the high inflationary period of the 1970s, when higher oil prices and an expanding money supply pushed inflation to extreme levels in the US.

During more muted periods of inflation, including the early 1980s and between 1988 and 1991, gold delivered negative returns, lagging equity markets in the process. Given the unprecedented levels of fiscal stimulus delivered by major central banks and governments in response to the pandemic, concerns have been raised that this may lead to a significant uptick

The behaviour of gold during the in inflation. While this may be true, the evidence suggests that gold's role as an inflation hedge may be overdone and that there is no guarantee that the metal will provide protection if inflation becomes a problem.

#### Does the introduction of gold improve risk-adjusted returns?

Depending on the period in question, adding gold to a portfolio can improve risk-adjusted returns.

What is important to highlight, however, is that the results are largely period-dependent. In some cases, total returns, risk and/or risk-adjusted returns were improved, but the results are not conclusive enough to indicate that adding gold allocations to a portfolio will always be beneficial.

#### So, what can we conclude about gold from the evidence?

The introduction of gold in a portfolio is not guaranteed to improve risk, returns or risk-adjusted returns for every period. Rather, the track record of the precious metal is mixed, and gold can go through long periods of underperformance.

The strongest evidence for holding gold appears to be as a safe haven in periods of significant market volatility.

In our view, it should be viewed as an insurance policy rather than a core holding. Investors should also be wary of the hype currently surrounding the price movements of gold - after all, as Buffett once famously said: "What the wise man does in the beginning, the fool does in the end."

#### Covid-19 challenging technical ingenuity through innovation

■HERE is absolutely no shred of doubt that indeed desperate times call for desperate measures and the current global pandemic is a case in point, to say the least. While the world is caught in an entangled web of what could be the panacea to the novel COVID-19 pandemic that has bedeviled the world, there are some positives that could be drawn from the ravaging menace of this cataclysmic virus against humanity. Truly, necessity is the mother of invention and the technical ingenuity and shrewdness of the world have surely been put to the test in these harrowing times.

The world changed its garment in the dying embers of 2019 when a strange virus was discovered in Wuhan, China. The COVID-19, a large family of viruses that are known to cause illness ranging from the common cold to more severe diseases such as the Middle East Respiratory Syndrome (MERS) and the Severe Acute Respiratory Syndrome (SARS). This was new and first of its kind ever to be discovered. This also

meant a new challenge to test the medical acumen of experts globally. However, in reality, it was a waging war on the survival of humanity that was brewing in the world. Like wildfire in a dry season, it spread and ambushed many unsuspecting countries.

Suddenly, the attention of the world is constantly drawn to the statistical doom spelt by the pandemic on a spreadsheet on daily basis and the press having a feeding frenzy on the new viral attack on the human race. It wasn't getting funny anymore. The numbers were alarming and an obvious premonition of annihilation was in the air.

However, if there is any silver lining that could be seen in this dark cloud upon the land, it will surely be the world's rapid response through innovation and technological invention to combat the spread of the virus and to alleviate the pain inflicted on its victims. Have you heard about the Snood with germ trap? Indeed, 2020 has been a year of novelty in all sense and this innovation coming from the United Kingdom typifies that. This innovation is a mask with "germ trap" technology. This is a result of a 10-year project with the biotech firm Virustatic but had to be hurried into production owing to the pandemic. The product acts as a barrier that attracts, traps, and kills viruses in droplets invisible to the human eye. The masks are safe towear and, according to the developers, the virus becomes inactive after touching

In Mexico, there has been a brainwave that has birthed an invention of a Protective Plastic Capsule. The Mexican Company XE Medical Engineering drew inspiration from neonatal chambers that protect newborns from external bacteria and viruses and reversed the product and developed an isolation capsule to keep pathogens from escaping, lowering the chance of it spreading to health workers. The chamber is a sealed, flexible plastic capsule that has a filter system to keep it inflated. According to the company, the device can be used in ambulances, emergency rooms and hospital wards.

China has also had her fair share of the global rage of innovation and invention provoked by the pandemic.

Kuang-Chi Technologies developed a smart helmet that can scan the temperature of hundreds of people every minute from a distance of up to five metres away.

The headset features an infrared thermometer and can connect to the nearest hospital. It also has an augmented reality visor with facial recognition technology, which allows users to see the person's name and medical history. The company has sold more than 1,000 temperaturescanning helmets and received orders from the Middle East, Europe and Asia

Similarly, a company in Denmark has also created a sterilizing robot that looks like a group of lightsabers on wheels. Using concentrated UV-C ultraviolet light emitted by eight bulbs on its top, each robot can destroy viruses, bacteria and other harmful microbes and sanitize hospital wards without the need for chemicals. This reduces the need to leave these areas empty for several hours during cleaning, allowing hospitals to care for patients in the wake of the pandemic.

# Interest-free loans crucial in empowering marginalised groups

realising fter that women, youth and .people with disabilities (PWDs) lack employment, face financial restraints and have limited access to other opportunities, the government of Tanzania directed all the municipal authorities in Tanzania to allocate 10 per cent of their annual revenue specifically for these groups.

Presenting his paper over the weekend in Dar es Salaam during Policy Forum Breakfast debate on "Economic rights: Making 10 per cent loan work for women, youth and people with disabilities," Secretary General at the United Nations Association of Tanzania (UNA Tanzania), Reynald Maeda said that the 10 per cent loans was first introduced in 1993.

Maeda noted that the mandatory interest free loans were issued by Local Government Authorities (LGAs) from own revenue for empowerment of women, youth and people with disabilities groups to carry out income generating activities to lift their households out of poverty.

He further said that 4 per cent of loans were given to women, 4 per cent to youth, and 2 per cent to people with disabilities (PWDs).

Tanzania advocated for governance and effective implementation of 10 per cent loans regulation at local and national level.



ast August I decided to hire a journalist to produce content for a project. This person would help me with social media posts, newsletters and reports, with the goal of providing other journalists with scientific knowledge coming from social media.

After a few weeks, having worked on the budget and the targets I had in mind, I pivoted the whole plan and hired two part-time developers to create a Twitter bot (software application programmed to do certain tasks) and an automated report delivery system.

In one stroke, I solved two problems: feeding my project's Twitter timeline and providing newsletter content for the users. After the launch, no human hands needed to touch those two streams of content.

It was a classic scenario in which automation literally stole a journalist's job. After all, why would I need someone producing content that my algorithms already provided me almost free of charge? Also, the initial plan was to hire a journalist for a limited time, while automation will last as long I

As I dug deeper into the development of these automated products, one question always popped up: we need strategy and thinking, we need... a journalist. What is the point of just putting content out there with no strategy? So on top of that I hired a community manager to run the ship for a while, and we are now better off with both bots and humans.

Automation in journalism is something that continues to raise quite a few eyebrows - not only for its potential to eliminate tasks that journalists often do, but also because machines are just not the best journalists.

Journalists might (and should) be wary of the effects of automating every single aspect of a newsroom - as Microsoft tried to do with MSN - but the key thing I took from that experience is

that automation is a great ally, not a standalone solution.

Automating repetitive tasks and simple content creation can have a very useful place within journalism and, arguably, it can lead to better jobs in the industry. Think of an elevator operator; with notable exceptions, we now usually don't need people pushing elevator buttons for us anymore. This is just a reality.

This brings me back to 2012, when I was working for Reuters in Brazil with the main purpose of reading corporate filings and writing quick, basic headlines based on them.

I basically repeated what the fillings said. If a public-traded company announced financial reports, a share buy-back or a new product, I would publish one to four paragraphs and leave it to the beat reporter of that industry to figure out the rest.

It was a mechanical, repetitive, boring job. It had importance at the time for the company and for the readers, but the gig had no strategy involved, no actual reporting and decision making.

Why would a journalist need to do that? Fair question, with a predictable answer: exceptions apart, mostly bots do that now.

As with any other matter facing the changes that journalism is undergoing right now, there are definitely issues that should be addressed. A March 2019 report from the Institute for Information Law cited "concerns about selective exposure and selective access to information, detrimental effects on the public sphere, ill-designed recommendation algorithms, and concentration of attention on a few platforms to the detriment of a wider, flourishing media market".

"Undeniably, there is also a risk that AI-driven technologies will be developed to exploit vulnerabilities of users to manipulate, erode privacy, institutionalise intellectual surveillance, and create, intentionally or unintentionally, new digital inequalities," the report noted.

There is a way of thinking about the place of automation in newsrooms - including smaller ones - that does not lead to journalists

But that does not mean that software should do journalistic work. Not at all. If journalists redirect their resources to the work that matters the most - like actual reporting, investigation, analysis - we can leave the repetitive, boring and petty tasks to the bots. They don't

Reuters, Bloomberg and most news agencies do this already. A great story by The New York Times employs exactly that strategy of having automation do the menial things. The Washington Post even won an award for a bot of

Now that we have more and more powerful tools - like OpenAi's GPT-3, a promising language mqodel that uses artificial intelligence (AI) to generate automated human-like text released in Iune 2020 - automation sounds even more promising (and maybe also challenging) than ever for journalism. We should study it and put it to our advan-

There is a back-and-forth discussion among those who see automation as a foe, predicting chaos and mass unemployment, and those who see it differ-

However, there's one thing everyone is on the same page about: it's happening one way or another, in a lot of different industries at once - journalism included - and it is up to us to make an ally out of it, preserving journalism jobs the best we can and increasing productivity in our newsrooms. We just need proper (human) strategy.

# Counter-terrorism in Africa must adapt to new realities

frica experienced 1 168 terrorist attacks from January to more than the 982 incidents in the same period in 2019. Years after numerous counter-terrorism operations were deployed, including the African Union (AU) Mission in Somalia (AMISOM), the Multinational Joint Task Force (MNJTF) against Boko Haram and many non-African missions, the continent is no closer to defeating or containing violent extremism.

The threat is even spreading to regions such as theGreatLakesandSouthern Africa, and to countries such as Mozambique and West African coastal states that until recently hadn't experienced such attacks.

Increasingly, extremist groups are able to launch and sustain military offensives. They've developed the capacity to finance their operations through illicit international networks and transnational crimes such as piracy and mercenary activities, along with trafficking in people, counterfeit goods, drugs, firearms and natural resources.

In some cases they hold territories that are already experiencing instability. Their job is made easier when states have weak security institutions, poor governance and large ungoverned spaces. Another factor is the return of foreign fighters to these areas following the fall of Islamic State in Iraq and Syria.

by violent extremism across Africa shows the need to revisit existing continental responses. African heads of state at the February 2020 AU summit directed the AU Peace and Security Council (PSC) to consider forming a special counter-terrorism unit in the African Standby Force (ASF).

The PSC discussed the proposal on 28 October. Members acknowledged that violent extremism had become a continent-wide threat that required bolstering Africa's responses. But the council couldn't agree on whether a counter-terrorism unit under the ASF was the best response.

A taskforce comprising all stakeholders including the PSC Military Staff Committee, regional mechanisms and AU security cooperation agencies has been formed. It will evaluate the technical, structural, doctrinal and financial implications of the proposed unit and submit proposals to the PSC in the next six months. The AU's Specialized Technical Committee on Defense, Safety and Security will also provide input.

Experts also question the merits of an additional counter-terrorism unit in Africa, calling for existing mechanisms to be held accountable. Others criticise the lack of regional consultations before the proposal was discussed at the PSC, as each regional body has already established counter-terror mechanisms. Some states worry about anti-terrorism units composed of contingents outside their regional bloc, and not under their direct control, being deployed in their 'neighbourhood'.

by member states. This will become a major obstacle in deciding whether the ASF should be deployed in response to specific 'terror' groups.

To reach consensus on the proposed unit under the ASF, the PSC must agree on a draft United Nations (UN) resolution regarding accessing UNassessed contributions. It must also decide on what kinds of interventions will be aided by the Peace Fund, and conclude the Common African Position on Financing.

If the PSC endorses an ASF counter-terrorism unit, it will have to negotiate extensively with the UNSC

The AU's definition and mandate of PSOs differ from those of the UN. While the **UN Security Council increas**ingly depends on the AU for deployments in response to terrorism in Africa, the global body continues to insist that UN-mandated PSOs cannot take part in military responses to terrorism.

The UN Security Council and PSC are also at loggerheads over the mandate of active missions such as AMI-SOM. While the AU, under the provisions of Chapter 8 of the UN Charter, has given the mission a political mandate, this isn't recognised by the UN Security Council.

Ad hoc counter-terrorism missions in Africa currently focus more on military responses to extremism. Yet as experiences worldwide show, these interventions alone cannot overcome the threat. Adopting a hybrid definition of PSOs would help the AU address this problem. However it's unclear whether the UN would support the AU's definition of PSOs.

If the PSC endorses the proposal to form a counterterrorism unit under the ASF, it will have to negotiate extensively with the UN Security Council. The significant doctrinal variance regarding the deployment of PSOs for counter-terrorism missions, so as to access UN-assessed contributions, needs to be resolved.

# AfDB provides training on development of projects eligible for Green climate fund

THE African Development Bank (AfDB) has just launched a training of trainers' programme for the development of projects eligible for funding from the United Nations (UN) Green Climate Fund (GCF). The training involves 80 participants from across the African continent.

The aim of the new training programme launched by the African Development Bank (AfDB) is to strengthen the skills of 80 government institutions, civil society organisations and universities in Africa. Participants in this

programme will then be responsible for passing on their knowledge to potential beneficiaries of the Green Climate Fund (GCF).

"Following an independent and thorough selection process, 80 participants have been selected, including about 40 from Anglophone countries and 40 from Francophone and Lusophone countries," says the AfDB. The online training will last 120 hours

A period during which participants will acquire knowledge through the AfDB's Climate Change and Green Growth Department.

As part of this initiative to increase the GCF's climate financing in Africa tenfold, the pan-African financial institution is receiving support from the Korea-Africa Economic Cooperation Trust Fund, which is financing the work. According to the AfDB, the training programme builds on its work with the GCF and other partners "to help the Bank's regional member countries directly access the resources of the Green Climate Fund".

# Agriculture must take responsibility for water conservation - experts

WITH the lingering aftereffects of a crippling drought, and the National Water and Sanitation Master Plan likely to kick in next year, it was time that all stakeholders in South African agriculture started taking responsibility for their role in protecting the country's scarce freshwater resources.

This was according to water conservation and water law experts, who were speaking during Nedbank's webinar, 'The future of water in South Africa's agricultural sector', held on Tuesday, 3 November.

Shelly Fuller, programme manager of sustainable fruit and wine projects at Worldwide Fund for Nature South Africa, said agriculture used the largest proportion of South Africa's and groundwater surface resources.

While the sector made vital contributions to the country's economy and society, it had proactively implement meaningful actions to conserve water for its own long-term sustainability, and for the future needs of the rest of the country.

"All farmers and other landowners must be the stewards of their land and of the water that is on, or moves through, their farms. How land and water are managed on a farm has a big impact on farms, people and other businesses downstream. Improved management must be carried out individually on the farm, and also collectively with others at catchment level."

Fuller added that such

management efforts needed to include the removal of alien invasive plants that consumed up to 20% more water than indigenous vegetation, and improving soil health through conservation agriculture practices.

James Brand, a senior associate specialising in natural resources and the environment at law firm ENSafrica, said the Department of Water and Sanitation (DWS) had given South Africa's farmers until 10 March 2021 to install water-use meters for their operations.

While the DWS could use readings from these meters to penalise farming operations that exceeded their allocated water supply, farmers could also use these meters as tools to monitor how effectively their on-farm water-use efficiency improvement efforts were working.

Brand encouraged farmers not to grudgingly improve their wateruse efficiencies because the law ordered them to do so, but instead to be motivated by the imperative that water conservation was the right thing to do to protect the future of farmers and the wider South African society.

"The water reality that we are facing is potentially daunting. Water rights and water-use monitoring can be complex, so it's advisable to use the services of an expert to help you understand these aspects, and to handle them within the law," he said.

Fuller added that individuals, businesses, organisations and government needed to collaborate on and coordinate their efforts to secure the country's freshwater resources into the future.





Y boss knocked on my cubicle. His cheeks  $flushed\, and\, his\, shoulders$ clenched like a tightened drum. He had the weary look of a man about to shoot a lame horse.

"I need to speak to you in my office." Every employee dreads those words. I was fresh out of college in my first sales job and, like most young women, I had the stench of people-pleasing sticking to me like cheap cologne.

However, in less than six months, I was bringing in more revenue than most of the seasoned salespeople. I showed up early and left late. My clients loved me and repeatedly told my boss how much they appreciated my hard work.

What could I have possibly done wrong? I stepped into his office and stumbled as the point of my heel snagged his Berber carpet. I straightened my skirt and sat in the cold metal chair facing his desk. He averted my gaze and snapped his pen like he was cocking a gun.

Click. Click. Yes, I was definitely in trouble. "A few of the women in the office have voiced some complaints about you.'

My mind catapulted through my possible traitors. Was it Janet from accounting? I was always pilfering the gumdrops she left out on her cubicle shelf. But so did everyone. No, no...my Judas had to be Trisha from Marketing. She hated everyone.

Click. Click. Double click. Silence. Damn pen. Just say it. My boss sighed and continued: "It's your skirts. Several of the women have complained that your skirts need to be a more appropriate length."

Now it was my turn to redden. I instinctively pulled my skirt towards my knees, wishing it could swallow my harlot legs. I was suddenly back in Catholic school - Sr. Josephine's ruler measuring the distance between my mid kneecap and the hem of my plaid skirt. Shame stuck in my throat as I tried to speak.

"Oh ok, well... I will stop wearing skirts." And that was the end of the conversation. I wore baggy pants and conservative blouses from that point

forward. I stopped wearing makeup and even cut my hair off. And I did not have the cheekbones to pull off a pixie cut.

The women in my office stopped complaining about my skirts, and I was one of the company's top-performing salespeople that year.

I eventually left that job but continued to dress like a schoolmarm at a bake sale. At one company, the men in the office nicknamed me "the librarian" because of my dowdy blouses and tight hair buns.

I didn't care. It was far better than being slut-shammed. My clothing choices never became an issue again.

To be fair, my skirts probably were too short for an office. Back then, my fashion sense could best be described as Rainbow Brite meets Madonna ("Like a Virgin" years.)

I was defiant, artsy, and determined not to blur into the dreary grey canvas of corporate America. But I also didn't have enough sense

to rein in my inner Cyndi Lauper. However, I learned an even more valuable lesson than any fashion 'blunder' - women are sometimes really hard on other women. And it didn't need to be that way.

If my female coworkers took umbrage with my ebullient fashion choices, they could have pulled me aside and given me a much-needed girl talk.

In this dream sequence, I imagined a rueful Betty White counselling me on why dressing like I was going to a punk rock festival might send the wrong message.

But no one did. Instead, my coworkers took the biblical 'stone her to death' approach. And even worse, they made my boss throw the first stone.

My story is not unique. Many women have had a Jezebel moment and wondered why they were castigated for their sexuality. And the slut-shaming can happen with something as benign as the length of your skirt.

Obviously, women waste a lot of resources trying to increase their erotic capital. And we all know why. Research on the halo effect shows that pretty people are viewed as kinder, smarter, and more competent.

Older studies on "Pulchronomics" - the

economics of physical attractiveness - found that pretty women earn more than their ugly stepsisters. They get lighter prison sentences. They even are more likely to get help when stranded on the side of the road.

But dig a little deeper and the newer research might surprise you. Using data from the US National Longitudinal Survey of Adolescent Health, researchers tracked participants ranging from 16 to 29 years of age over thirteen

They then analysed the data against the Big Five personality traits - conscientiousness, agreeableness, extraversion, neuroticism, and openness. Then they cross-referenced these with intelligence and health.

They found that physical attractiveness alone was not an indicator of success. Instead, success was determined by a combination of beauty, intelligence, good health, and winning personality traits. And so the Cinderella plot thickens...

Another study found that female attractiveness was actually a detriment to getting hired. In a study from the Graduate Recruitment Bureau. researchers sent out over 5000 CVs containing pictures of female job candidates with the same qualifications.

They found that unattractive women were twice as likely to get a job interview than attractive candidates. And oddly, the reverse was true for men. Attractive men were twice as likely to get an interview than unattractive men.

Researchers have even coined a term for this beauty bias in reverse - the Bimbo Effect. And the "bimbos" who didn't get a call back were judged by their faces alone. No one even checked their skirt length.

But before ladies start adding warts to their headshots, perhaps the solution is to check your bias at the boardroom door. Maybe next time you see a woman in a mini-skirt, try not to judge. And at the very least, put down the

# Six years with Al Qaeda: The Stephen McGown story



n a few short weeks, the Years With Al Qaeda: The Stephen McGown Story will be released. Here, for the first time, you can get a taste of what to expect from this incredible true-life story of courage and resilience.

Action movies give you a false sense of what real life situations are like. It's always binary - fight or flight, bravery or cowardice. There's no grey area, no description of the paralysis of panic. When you've got people shouting at you, pointing guns at you, dragging, pushing and pulling you, it's fucking terrifying. How you react is beyond your control.

I remember walking. Every movement was very deliberate, I could feel each muscle moving, my foot placed where it was supposed to be placed as my knee lifted up my other leg for the next step. My body awash with adrenaline, it felt like I was wearing a heavily padded jacket and there was this tiny version of me right in the middle. I was aware of everything, from Adam hitting me with the flip-flop, to the contrast of the shade and the sun as I walked out into the street, but I didn't truly feel it. The jacket muted all sounds and sensations. My visual memory of what I saw in those moments is not a high-definition singletake video, but a slideshow of skits. The Table Skit. The March to the Street Skit. The Being Bundled into the Truck Skit.

The initial shock overwhelms you. There is so much new data rushing at your brain and your body;

Where are they taking me? What will they do with me? What do they want with me? How will my family find out? Am I going to die? Will I feel pain? Will I hear the gun? What happens then? Where from the guys with guns do I go? At this stage, heaven

We all know we are going to die, but most of us are pretty confident it is not going to happen today. We envisage it as some future point with ever shifting goalposts the older we get. I couldn't see what they saw, but the finality with which all three mujahideen turned and walked to the vehicle told me that Martin was dead. One of them gave the "A-OK" sign to the driver. The expression on Ghanda Hari's face was one of mild irritation, like when you hit the enter key on your keyboard and it doesn't register or you find your stapler is empty. A slight inconvenience. He didn't look like he had just killed somebody.

I said to Johan and Sjaak, who were facing the other way, "Shit, I think they've killed Martin."

I could hear Tilly on the patio screaming and shout-

I felt a blanket and then a cargo net being dropped over us and secured.

I lost the light.

The driver revved the engine and the vehicle started to move.

# MDBs want smaller banks, SMEs to learn exploit available trade financing

By The Banker Reporter

MALLER banks and businesses should be sensitized exploit financing products available at Multilateral Development Banks in Africa.

A survey commissioned by leading MDBs on the continent established that many small banks and small business owners don't know or understand presence of a variety of trade financing products that they have hence suffer from liquidity shortages.

compounded the lack of awareness problem, preventing typical face-toface meetings to discuss financing opportunities," the Pulse Check report added.

The survey also established that at the onset of the crisis, MDBs responded with a range of facilities to support the private banking industry throughout sub-Saharan Africa. "The intervention of MDBs

# Mozambique's sovereign fund to be supervised by parliament

The Bank of Mozambique yesterday gave assurances that the future Mozambican sovereign wealth fund would, in the name of transparency and accountability, be directly supervised by the Assembly of the Republic and be subject to independent audit.

Mozambique's central bank gave its guarantee during a round table on "The analysis of the model proposal for the sovereign fund of Mozambique" promoted by the Institute for Multiparty Democracy (IDM).

"In the [technical] proposal, we opened the space for the Assembly of the Republic to create, if it so wishes, a body to directly supervise the overall management of the fund," Bank of Mozambique director Jamal Omar said. Under the central bank's proposal, parliament would also have to approve the entire legal apparatus, moving away from a regulatory framework defined at governmental level.

The fund, Omar continued, would also be subject to audit by an independent entity to be designated by the Ministry of Economy and Finance, as well as by the Administrative Court (TA), whose reports would be submitted to parliament.

Omar said that the central bank would conduct the operational management of the fund under contract or delegation of functions by the Ministry of Economy and Finance [MEF], which would in turn have the task of outlining the fund's investment policy and the supervision of its operational management.

A specialised commission would be created within the MEF to provide advice to the Minister. "We believe that, as this is a matter of specialty at the level of the Ministry of Economy and Finance, we propose the creation of a specialised technical commission to assist the minister in decision-making or in the definition of investment policy parameters," Omar said.

The Bank of Mozambique document foresees 50% of revenues from the exploitation of natural resources being allocated to the sovereign wealth fund and 50% to the State Budget, during the first 20 years of the fund's

operation. In the 21st year, when revenue from natural gas projects is expected to decline, the proportion allocated to the State Budget would drop to 20% and the portion transferred to the sovereign wealth fund increase

The Mozambican central bank advocates that the sovereign fund fulfil a double objective: the accumulation of savings, and fiscal stabilisation, given the need to face fiscal shocks resulting from the fluctuation of raw material prices in the international market. Jamal Omar said that the fund would not be used to pay or contract debt in the revenuegenerating sectors that will feed the fund

Mozambique expects to receive US\$96 billion (€81.4 billion) over the productive life of the Rovuma gas fields - almost seven times the current gross domestic product, according to the central bank proposal released for public debate on 12 October. The document foresees a 20-year maturation period for the fund, after which it would contribute 4% of its balance to the State Budget. Prior to that, it would only release funds in the event of a "public calamity" or an "extreme shock" to the economy.



# Africa's vast funding needs to drive Islamic finance industry's growth, Moody's says

Africa's vast financing needs and growing interest of sovereigns in Sharia-compliant debt to bridge funding gaps will help drive the Islamic finance industry's growth on the continent, ac-

cording to Moody's Investors Service. Sub-Saharan Africa accounts for about 16 per cent of the world's Muslim population yet Sharia-compliant bank assets in the region make up about 1 per cent of global Islamic banking assets, Moody's said in a report released

"We expect Africa's large Muslim population, low starting base and growing government interest in the sector to drive growth in Islamic banking assets in the continent," Mik Kabeya, assistant vice president, at Moody's, said.

Governments in Africa - one of the last global frontiers of growth with a population of more than 1.2 billion have increasingly looked to issue Sharia-compliant debt to shore up capital and meet their financing needs. Average annual sukuk issuance for Africa was negligible until 2012, but has averaged \$433 million per year between

2013 to 2019, Moody's said. Expanding into Islamic finance would help African sovereigns diversify their funding sources and reduce funding gaps, as they face an exacerbated financial crisis because of the coronavirus pandemic, the rating

agency said. Sudan, South Africa, Nigeria and

Senegal, all with major Muslim populations, are expected to lead Sub-Saharan Africa and boost their Sharia-compliant banking assets and raise funds through Islamic debt instruments. Existing and rapidly evolving regulatory and supervisory structures will underpin growth of the Islamic finance industry in these countries, Moody's

Egypt and Morocco, the rating agency said, will lead growth in North Africa. "Improved political confidence in Egypt and Morocco's stronger economic performance relative to regional peers, along with Nigeria's low banking penetration and populous markets will provide high structural demand for Islamic banking over the next decade," Moody's said.

Tanzanian Mainland and Zanzibar grew significantly during the year ending August 2020, Bank of Tanzania has said.

In its August monthly economic review, the central bank said the Mainland's exports amounted to U\$9.30 billion (over 20.88trn/-) in August compared U\$8.97 billion (18.55trn/) during the corresponding period

"The rise in the value of exports on the Mainland was realized owing to increase in goods exports. The value of traditional goods exports almost doubled to U\$996 million during the period under review from U\$513

corresponding period in 2019," the BoT report explained saying the increased exports value was for cashew nuts, cotton, cloves and sisal.

The report however pointed out that sisal exports rose on account an increase in both volume and unit prices. Export values for cashew nuts, cotton and cloves rose due to improved export volumes, supported by improved production. By contrast, export values for coffee and tea, declined on account of low volumes and unit prices.

receipts, the central bank report said that receipts declined to U\$3.10 billion from 4.20 owing to a decrease in travel receipts. Travel receipts declined by

# **Capitec launches** its first full home loan offering

JSE-listed Capitec, South Africa's largest retail and digital bank based on number of clients, has announced its foray into the home loan market in partnership with SA Home Loans.

The Stellenbosch-based banking group said in a statement on Tuesday that the launch of "its first full home loan offering" is built on the principles of simplicity and affordability, with the product having "one of the fastest application processes in the country." Its new home loan offering would allow consumers to initiate an application in under five minutes - alongside highly competitive linked interest rates from 6%.

Francois Viviers, Capitec's executive of marketing and communications, says the offering was developed in response to strong demand for a simple and efficient, digitally-led home loan option. "We've continually received requests from both clients and the public asking us to challenge the norms of home loans as we have done with banking.... Previously, application processes have required a lot of paperwork as well as time. We've simplified this by offering potential clients an easy four-step online application that takes less than five minutes to complete," he adds.

"You don't need to have any documents on hand and the questions are easily answered through multiple choice or simple entries such as name, surname and income," he says. We found most application tracking to be vague or use terms that are not easily understood by someone who is unfamiliar with the process. Our tracking is comprised of six easy-to-follow steps, with clear communication describing the details of each step and if anything is required from the client," Viviers explains.

Capitec will offer home loans up to R5 million over 30 years. It notes that clients will get a discount of up to 50% on lawyer fees through SA Home Loans' National Panel of Attorneys. However, it is unclear whether the partnership with Durban-headquartered SA Home Loans goes beyond this element. To qualify they must use the government employee housing scheme (GEHS) stop order.

"This special home loan package (for government) offers a flexible term of up to 20 years on 100% of the purchase price, depending on the applicant's affordability... After an application is underway, it can be tracked in real-time on the home loan portal," Capitec notes.

"Alongside the portal, clients are also assigned a home loans consultant, should they require further assistance through personalised human interaction." Capitec's share price was up more than 2% in morning trade on Tuesday at R1 206 a share at around 11am.

# Bank shares down 33pc on new loan rates row

Bank share prices have fallen by an average 32.8 percent since the start of the year, mainly hit by a decision by the Central Bank of Kenya (CBK) to freeze a bid to raise cost of loans following the scrapping of lending rate controls on November 7, 2019, analysis shows.

The regulator had asked banks to submit new loan pricing formulas that would be the basis of setting interest rates on new credit in an environment where the government was not controlling loan costs.

Approvals on the submissions are yet to be made by the regulator-dimming the performance of bank stocks despite the recent positive sentiments following a phased reopening of the economy by President Uhuru Kenyatta from July 6, after months of a lockdown to curb the spread of Covid-19.

A review of bank stocks shows that Co-operative Bank is currently trading at Sh11.2 down from Sh16.3 at the beginning of the year, Equity Bank at Sh34.4 from Sh54.25, KCB at Sh36.6 from Sh54.25 and Stanbic at Sh80 from Sh109.25. Analysts at Egypt-based investment bank, EFG Hermes said approval of risk pricing models by the CBK could lift bank shares.

"The 'Gremlins' that could potentially derail our positive outlook for the sector are margins remain low for longer than expected as the CBK continues to delay the approval of the banks' risk pricing models or does not allow the banks to significantly re-price lending rates upwards," EFG Hermes said. The CBK, which last year warned banks against reverting to punitive interest rates of more than 20 per cent in post-rate cap regime, wants every lender to justify the margins they put in their formulas.

The government removed the cap after it was blamed for restriction on credit growth during its three years of existence. Banks use a base rate that is normally the cost of funds, plus a margin and a risk premium, to determine how much they should charge a particular customer.

The cap, which set rates at four percentage points above the central bank's benchmark lending for all customers, had taken out that equation and the flexibility that lenders say they need in order to accommodate customers deemed as risky borrowers.

The modern tech-savvy generation is already calling for more use of technology, in order to reduce transaction costs. increase the speed of delivery of value and also safeguard security of their transactions. Technology however, is going to change the competitive landscape in the banking space, where banks are not just competing against each other, but also competing with technology giants which are not banks but can offer banking products and services such as the Google, Apple, Facebook, Amazon (GAFA) alliance.

# Broke Kenya seeks second Covid-19 loan from IMF

Kenya has for the second time in less than six months reached out to the International Monetary Fund (IMF) for budget support to weather the coronavirus economic hardships.

IMF resident representative Tobias Rasmussen said the government had asked the Brettonwoods institution for another loan following the \$739 million (Sh79.3) billion received in May that Kenya sought to help it respond to the economic shocks caused by the pandemic.

This signals the gravity of the country's rapidly deteriorating cash-flow situation that is marked by falling revenues and worsening debt service obligations. Revenue collection underperformed by Sh40 billion in the first two months of the financial year, July and August, amid the coronavirus-related disruptions. The type of credit Kenya has sought from the IMF is a quick-disbursing facility where money flows straight into the budget to top up the public purse and is used at the discretion of the government.

Under the administration of former President Mwai Kibaki, Kenya kept away from this type of credit, with most of the support from institutions like the IMF and the World Bank coming in the form of project support.

"Following up on the support provided by the IMF in May under our Rapid Credit Facility (RCF), the Kenyan authorities have expressed interest in a Fund arrangement. IMF staff is in discussions with the authorities toward such an arrangement," Mr Rasmussen told the Business Daily in an e-mail response.

The budget support funding is not tied to specific projects and can be used to fund politically important activities. This comes amid a spike in Covid-19 cases that has seen infections jump 45 percent to 56,601 over the past month and deaths 42 percent to 1, 027. This could trigger fresh restrictions from the government, risking reducing economic activity and denying the Kenya Revenue Authority (KRA) opportunities to grow tax

Kenya's economy shrank by 5.7 percent in the second three months of 2020, its first quarterly contraction since the global financial crisis 12 years ago, as the Covid-19 pandemic shut businesses and kept people at home. The Treasury expects growth of less than 2.5 percent compared to 5.4 percent last year, and international institutions are making lower forecasts.

Tax collections in the three months to September dropped 14.69 percent to Sh317.6 billion, raising fears Kenya's budget deficit for this financial year could increase due to revenue shortfalls. The Treasury is September said it was in early talks with the World Bank for the provision of an additional budgetary support loan, which was potentially going to

be used in the 2021/22 fiscal year.

The loan will be the third from the World Bank after the Washingtonbased lender started issuing such financing to Kenya last year. The Jubilee administration looks set to borrow an average of Sh2.5 billion daily before the end of President Uhuru Kenyatta's final term in August 2022, highlighting its growing appetite for foreign debt.

Treasury chiefs project in a draft Budget Review and Outlook Paper new loans of Sh1.87 trillion in the two years to June 2020 or Sh2.5 billion daily, pushing Kenya's debt to Sh8.06 trillion. If that comes to pass, Mr Kenyatta will have borrowed at least Sh6.1 trillion to implement his manifesto in 10 years in power having inherited slightly more than Sh1.89 trillion in June 2013.

The Jubilee administration has ramped up spending since 2013 to build new roads, a modern railway, bridges and electricity plants, driving up borrowing to plug the budget deficit. The increased debt has seen Kenya commit more than half of taxes to paying loans, leaving little cash for building roads, affordable housing and revamping of the ailing

But faced with revenue shortfalls amid the coronavirus-related disruptions and

the push to complete projects ahead of Mr Kenyatta's exit, the Treasury is expected to accelerate borrowing over the next two years.

The Parliamentary Budget Office (PBO) - which advises lawmakers on financial and budgetary matters - says underperformance in revenue due to the Covid-19 pandemic is likely to drive Kenya's debt beyond the Sh9.0 trillion legal threshold, a year after Mr Kenyatta leaves power.

"In previous financial years, the primary balance grew on account of significant expenditure on infrastructural projects, energy production as well as social expenditures," the PBO wrote in a budget watch report earlier this month.

"The impact of Covid-19 on the economy is expected to adversely affect revenue generation. Given the current and projected expenditure demands, it is estimated that the Kenyan debt stock could reach Sh9.2 trillion in FY 2022/23."

Kenya plans to spend Sh904.7 billion on debt repayments this financial year ending June 2021 from Sh707.8 billion the previous year against expected taxes of Sh1.52 trillion. This means that nearly 60 percent of taxes will be committed to debt repayments.

### WB to disburse \$1.2bn to Rwanda in three years

The World Bank Group will inject an estimated \$1.2 billion (approximately Rwf1.1 trillion) as part of the Rwanda Country Framework for the period between 2021 and 2023.

The partnership framework and funds committed on Monday this week are expected to play a major role in the country's recovery from the economic effects of the Covid-19 pan-

The partnership framework shows that the \$1.2bn that was committed will go into five broad areas; improvement of human capital, improvement of conditions for Private Sector Development, expansion of access to infrastructure and the digital economy.

The funds will also go into increased agricultural productivity and commercialization and intensified urban agglomeration. In human capital development, the intervention will go into improving learning outcomes which have been found to be falling back and uncompetitive.

In 2018, the World Bank undertook a study dubbed, Human Capital Index where Rwanda scored 38 out of 100. That means that a Rwandan child can be es-

if they had full basic education and health services.

The interventions to be rolled out will seek to raise the odds for Rwandan children through multiple ways such as capacity of teachers, enhancing coverage and equity in access to critical social programs and improve nutrition among others.

The funds and initiatives

will also be directed towards supporting the local private sector improvement such as access to affordable capital, reducing cost of operations and increasing availability of skills in the labour market. The implementation of projects with the funds is expected to have an impact on poverty reduction over time which experts say has been less responsive to economic growth seen over the years.

Aghassi Mkrtchyan, World Bank Senior Country Economist for Rwanda noted that a country diagnostic carried out to inform the framework had among other things revealed that poverty was becoming less responsive to economic growth witnessed over the

timated to be 38 per cent ity, limited participation productive as they could be of the private sector in the economy as well as recurring negative effects of climate change.

Rolande Pryce, the World Bank Country Manager, told The New Times that the rollout and implementation of the programmes under the framework is expected to edge the country closer towards the country's strategic development plan, National Strategy of Transformation among other de-

velopment plans. "The process to identify key objectives and interventions includes; analytical work by the bank, the government strategy, assessment of World Bank's comparative advantage as well as lessons learnt. We then define targets that we want to achieve together," Pryce said.

Uzziel Ndagijimana, the Minister for Finance and Economic Planning, said that the new framework comes at a critical juncture of socioeconomic recovery following the impact of the Covid-19 which has made the economy fragile and will take a while to recover. The latest economic projections noted that the economy will contract by traced to challenges such 0.2 per cent in 2020 before as low human capital levels, resuming about 5.7 per cent growth in 2021.

# **Trump falsely claims** victory, after rival Biden voices confidence

#### WILMINGTON, DEL./WASHINGTON

US President Donald Trump falsely claimed victory over Democratic rival Joe Biden on Wednesday with millions of votes still uncounted in a tight White House race that will not be resolved until a handful of states complete vote-counting over the next hours or days.

Shortly after Biden said he was confident of winning the contest once the votes are counted, Trump appeared at the White House to declare victory and said his lawyers would be taking his case to the US Supreme Court, without specifying what they would claim.

"We were getting ready to win this election. Frankly, we did win this election," Trump said. "This is a major fraud on our nation. We want the law to be used in a proper manner. So we'll be going to the US Supreme Court. We want all voting to stop."

Polls have closed and voting has stopped across the country, but election laws in US states require all votes to be counted, and many states routinely take days to finish counting legal ballots. More votes still stood to be counted this year than in the past as people voted early by mail and in person because of the coronavirus pandemic.

Earlier in the evening, Trump won the battlegrounds of Florida, Ohio and Texas, dashing Biden's hopes for a decisive early victory, but Biden said he was confident he was on track to winning the White House by taking three key Rust Belt states.

Biden, 77, was eyeing the so-called "blue wall" states of Michigan, Wisconsin and Pennsylvania that sent Trump, 74, to the White House in 2016 for possible breakthroughs once those states finish counting votes in hours or days to come.

"We feel good about where we are." Biden said in his home state of Delaware, shouting over a din of supporters in cars honking their horns in approval. "We believe we're on track to win this election."

Winning those three states would be enough to give Biden an Electoral College victory. Fox News projected Biden would win Arizona, another state that voted for Trump in 2016, giving him more options to get to 270 Electoral College votes.

Biden leads 220 to 213 over Trump in the fight for the 270 Electoral College votes needed to win the White House, according to Edison Research.

Even without Pennsylvania, Biden victories in Arizona, Michigan and Wisconsin, along with his projected win in a congressional district in Nebraska, which apportions electoral votes by district, would put him in the White House, as long as he also holds the states that Trump lost in 2016.

"We are up BIG, but they are trying to STEAL the Election. We will never let them do it. Votes cannot be cast after the Polls are closed!" Trump said on Twitter before his White House appearance, which swiftly tagged the tweet as possibly misleading.

"It's not my place or Donald Trump's place to declare the winner of this election. It's the voters' place," Biden said on Twitter in response to the president.

Trump has repeatedly and without evidence suggested that an increase in mail-in voting will lead to an increase in fraud, although election experts say that fraud is rare and mail-in ballots are a long-standing feature of American elections.

In Pennsylvania, Democratic Governor Tom Wolf said the state still had to count more than a million mail-in ballots. He called Trump's remarks a partisan attack. According to Edison Research, more than 2.4 million early ballots were cast in the state, of which nearly 1.6 million were by Democrats and about 555,000 by Republicans.

Supporters of both candidates called the election a referendum on Trump and his tumultuous first term. The winner will lead a nation strained by a pandemic that has killed more than 231,000 people and left millions more jobless, racial tensions and political polarization that has only wors-

ened during a vitriolic campaign.

Trump monitored election returns with members of his family in the living room of the White House residence. Going in and out of the room were first lady Melania Trump, his son-in-law Jared Kushner and his daughter Ivanka among others. "He's calm, chilling," said a source familiar with the scene.

In the East Room of the White House, where 200 Trump supporters were having drinks and eating chicken fingers, sliders and cookies, cheers broke out when Fox News called Florida for Trump, said a source in the room.

"The place just erupted," said the source, who said the mood was both "extraordinarily positive" and "cautiously optimistic." "Everyone started cheering." Florida was a must-win state for any Trump path to victory.

Voters were also to decide which political party controls the US Congress for the next two years, with Democrats trying to recapture a Senate majority and favored to retain control of the House of Representatives.

A Democratic drive to win control of the Senate appeared to fall short, with Democrats picking up only one Republican-held seat while six other races remained undecided early on Wednesday. The six were in Alaska, Maine, Michigan, North Carolina and two in Georgia.

#### No early surprise

There were no early surprises as the two contenders split the US states already projected. Trump captured conservative states like Alabama, Indiana, Kentucky and Tennessee while Democratic-leaning Connecticut, Massachusetts, New York and Vermont went to Biden, according to projections by television networks and Edison

"We feel good about where we are," Biden said in his home state of Delaware. "We believe we're on track to win this election."

Trump's strong performance in Florida was powered by his improved numbers with Latinos. His share of the vote in counties with large Latino populations was larger than it was in the 2016 election.

For months there had been complaints from Democratic Latino activists that Biden was ignoring Hispanic voters and lavishing attention instead on Black voters in big Midwestern cities. Opinion polls in key states showed Biden underperforming with Latinos in the weeks leading up to the election.

Many younger Hispanics were ardent sup-

porters of US Democratic Senator Bernie Sanders during the party's primary campaign, but in opinion polls expressed little enthusiasm for Biden, viewing him as too moderate and out of

In the Miami area, Latinos are predominantly Cuban Americans, where generations of families have fled communist rule in Cuba. Trump's messaging about Biden being a socialist seemed to work with them and with Venezuelans there despite Biden's denials.

Edison's national exit poll showed that while Biden led Trump among nonwhite voters, Trump received a slightly higher proportion of the nonwhite votes than he did in 2016. The poll showed that about 11 percent of African Americans, 31 percent of Hispanics and 30 percent of Asian Americans voted for Trump, up 3 percentage points from 2016 in all three groups.

Edison's national exit poll also found that support for Trump declined by about 3 points among older white voters, compared with 2016.

The poll found Biden made significant gains in the suburbs.

In 42 suburban counties spread across 13 states where most of the votes had been counted, Biden was doing about 5 percentage points better than Clinton did in 2016 and than Barack Obama did in 2012.

US stock futures jumped late on Tuesday as Trump's showing improved, but were volatile and last up 0.25 percent at 1:50 am ET (0650

"I think markets were jolted a little bit by how close the race now appears. We are seeing a little bit of a flight-to-safety response in some asset classes," said Mona Mahajan, senior US investment strategist at Allianz Global Investors, New

On betting website Smarkets, odds reflected a 74 percent chance of Trump winning, up from 33 percent earlier in the day.

Voters, many wearing masks and maintaining social-distancing to guard against the spread of the coronavirus, streamed into polling places across the country through the day, experiencing long lines in a few locales and short waits in many other places. There were no signs of disruptions or violence at polling sites, as some officials had feared.

Biden, the Democratic former vice president, put Trump's handling of the pandemic at the center of his campaign and had held a consistent lead in national opinion polls over the Republi-Agencies can president.

### **Hurricane Eta slams** C. America, causes deadly mudslides

HURRICANE Eta ripped roofs from homes, unleashed maor flooding and caused landslides as it battered the coastline of Nicaragua and neighboring Honduras on Tuesday, reportedly killing at least three people and putting dozens of fisher-

Eta, one of the most powerful storms to hit Central America in years, plowed into Nicaragua as a Category 4 hurricane on the five-step Saffir-Simpson scale, battering roads and bridges in Honduras. Hundreds of people were evacuated.

Barreling ashore south of the port of Puerto Cabezas, Eta was expected to cause "catastrophic" wind damage as the eye of the storm moved inland along the northeastern coast of Nicaragua, the US National Hurricane Center (NHC) said.

When it struck the coast, Eta was blowing potentially devastating winds of 225 kilometers per hour, the NHC said. The storm should weaken rapidly as it advances inland, it added.

On Wednesday the NHC said Eta has weakened to a tropical storm and is expected to become a tropical depression later in the night.

Eta was located about 140 km west of Puerto Cabezas, Nicaragua, packing maximum sustained winds of 110 kph, it said. Nicaraguan media reported Tuesday that two artisanal

miners were killed by a mudslide. In Honduras, a 13-year-old girl died in a landslide on her home, the fire department said. Meanwhile, about 60 fishermen were trapped and in dan-

ger in the eastern Mosquitia region of Honduras, according to Robin Morales, a representative of the local population. The fishermen "remain adrift at sea shouting for help",

Morales said, adding that a Honduran Navy official told him it was currently too dangerous to mount a rescue operation.

"If they aren't rescued, I don't think these people will remain alive for more than 24 hours," Morales said.

By early Tuesday, Eta had knocked down trees and power lines and caused serious flooding in northeast Nicaragua, disaster management agency SINAPRED said. Still, Vice-President Rosario Murillo said the initial damage had been less than feared.

"We're really afraid, there are fallen poles, there's flooding, roofs torn off, some of the zinc on my house fell off," said Carmen Enriquez, a resident of Puerto Cabezas.

The indigenous regions in northern Nicaragua are some of the country's poorest. Many people live in homes made of wood and adobe that are ill-equipped to withstand such a

Earlier, Javier Plat, a Catholic priest, had said there was a citywide power outage in Puerto Cabezas and governmentarranged shelters had reached capacity.

Around 1,227,000 people in Nicaragua, including nearly 500,000 children, were at risk from the storm's fury, the UN children's agency UNICEF said in a statement.

Nicaragua on Monday evacuated at least 3,000 families, including fishermen who live in the most vulnerable villages.

In Honduras, rivers burst their banks, towns and cities on the Atlantic coast flooded, and landslides hit roads.

Eta is forecast to move into northern Nicaragua through Wednesday afternoon and hit central Honduras on Thursday.

Forecasting models then show it snaking back out into the Caribbean over Cuba as a tropical storm toward the end of the week and approaching the tip of the Florida panhandle

on Sunday. Flash and river flooding are also possible in Jamaica, southeast Mexico, El Salvador, southern Haiti and the Cayman Islands, the Miami-based hurricane center said.

#### Malawi to open embassy in Jerusalem in 2021

MALAWI will open an embassy in Jerusalem by the summer of 2021, Malawian Foreign Minister Eisenhower Mkaka said during his visit to Israel on Tuesday.

Mkaka, who arrived in Israel on a three-day trip, made the announcement during a joint press conference with his Israeli counterpart Gabi Ashkenazi in Jerusalem.

"Mkaka reiterated the intent of the Republic of Malawi to open a fully-fledged Embassy in Jerusalem," said an official joint statement signed by the Israeli and Malawian minis-

In return, Israel agreed to increase bilateral cooperation in the fields of agriculture, tourism, investment technology, education and trade, according to the statement.

In a separate statement, Ashkenazi hailed the Malawi government "a pioneer" as the country will be "the first African country to establish its embassy in Jerusalem."

Malawian President Lazarus Chakwera first announced in September his intention to open an embassy in Jerusalem. Malawi and Israel have had official ties since the southeastern African country won independence in 1964.

# Lavrov calls for honest dialogue with European Union

MOSCOW will not make unilateral gestures of goodwill to the European Union as EU countries should understand that dialogue is only possible when it's honest, Russian Foreign Minister Sergey Lavrov said in an interview with the Kommersant daily.

"It should be clear to our European colleagues that interaction is only possible on an honest and equal basis and with respect for each other's interests," he pointed the most absurd ones, to boost at-

out. "There will be no unilateral gestures of goodwill on our part.

We expect that practical approaches and common sense will eventually prevail in the Brussels institutions and EU capitals. We don't mind waiting for it to happen," Lavrov added.

According to the top diplomat, Russia is not to blame for the current crisis in relations with the EU. He emphasized that EU bureaucrats and certain EU countries "seek to use any excuse, including



tempts to contain Russia.

Lavrov noted that the number of sanctions regimes kept growing, though they were illegal from the standpoint of international law. "European media outlets con-

tinue a large-scale anti-Russian campaign. As for trade, Brussels bureaucrats keep taking protectionist measures, violating WTO regulations and introducing politicized rules," Lavrov said.

"At the same time, they tell us that Russia can 'deserve the right' to have normal relations with the EU if it changes its behavior. The cynicism is off the scale," he add-

"We appropriately respond to unfriendly actions but we also remain open to dialogue with the

EU, which remains an important trade and economic partner for us. Businesses on both sides are clearly interested in promoting mutually beneficial cooperation. Russia-EU energy cooperation

also remains relevant," the Russian foreign minister stressed.

According to Lavrov, there are many fields where the parties need to cooperate, including crisis management, healthcare, climate, personal data protection and artificial intelligence.

# China to make greater contribution to safeguarding world peace

"THE great victory of the War to Resist U.S. Aggression and Aid Korea is a declaration that the Chinese people have stood firm in the East, and an important milestone in the Chinese nation's march

Therefore, the war was one between "flesh and iron," in which the Chinese army battled iron and steel with their indestructible wills. The imperial invader was never able to calculate the result of



### **Exclusion of Chinese 5G companies** in Sweden hurts fair competition, consumers' interests

**STOCKHOLM** 

BANNING Chinese 5G suppliers in Sweden will hurt the principle of fair competition and jeopardize the interests of Swedish consumers.

Although rare in the generally business-open Sweden, an administrative demand to strip Huawei and ZTE products from Sweden's 5G networks was announced last month by the Swedish Post and Telecom Authority (PTS), as the two leading telecom companies are poised to bid for the spectrum auctions starting on Nov. 10.

For years, Chinese companies such as Huawei and ZTE have been strictly observing local laws, promoting China-Sweden cooperation -- particularly in the information and communication technology (ICT) field -- and making contributions to the construction of infrastructure there.

According to an earlier report of Swedish National Television (SVT), none of the Swedish mobile operators it interviewed said that they see "a security problem with Huawei as a

Trumpeting so-called national security concerns but without present- a burden for Swedish tax payers. ing any evidence, the Swedish side is groundlessly discrediting Chinese companies by abusing administrative orders and state power.

The blunt and forceful demand also contrasts with the European Union (EU) toolbox on 5G Cybersecurity that was released in late January, which proposed a series of measures to strengthen 5G security from strategic and technical perspectives, but did not prohibit a Chinese or any specific company from participating in the construction of 5G networks in Eu-

Sweden's stance also contrasts with that of its Nordic neighbors.

Norway's largest mobile operator Telenor said it would continue working with Huawei for its 5G telecom network and the Chinese company would be involved in the entire process. Huawei was also one of the 5G equipment providers for Finland, which opened one of the largest 5G networks in Europe last December.

Finland has no intention of banning the use of Chinese telecom giant Huawei's equipment in its networks and Finland does not take a stand on the

countries of origin of such equipment that could pose a risk, Finnish Minister of Transport and Communication Timo Harakka told Finnish national broadcaster Yle.

"Huawei is an important contributor, rather than a threat, to Swedish ICT," Huawei said on its Europe website following the PTS's announcement.

The blatant suppression of Chinese telecommunication companies also politicizes normal economic cooperation and runs counter to the free, open, fair, just, and non-discriminatory market economy that Sweden pursues, as well as the international trade and investment rules.

"And now that only Nokia and Ericsson remain as alternatives in Sweden, it can also lead to a discussion about lack of competition," SVT's report said.

Moreover, Sweden's exclusion of Huawei and ZTE due to misconceptions and unwarranted accusations will negatively affect the quality and efficiency of its own 5G network construction. What's more, the inevitable cost increase resulting from a mandatory phasing-out of the existing Huawei equipment will unquestionably be

The 5G era is a hallmark of global cooperation. Only by following market principles of open development and fair competition can a win-win situation be achieved for all, where there is faster, cheaper, more efficient and inclusive connectivity.

Manipulating free competition in the market with empty slogans of "national security" would only hurt a country's own interest.

A commercial posted on Huawei Europe's Twitter account on Aug. 18 answered a question about how Stockholm has generated so many start-ups.

"It's partly because Sweden has a long tradition of technical knowledge," the ad said, "and partly because Stockholm is very open to new influences from other parts of the world."

The Chinese market has remained open to European companies, including Sweden's. Sweden, largely characterized by an open and export-oriented economy, should also provide Chinese companies with an open and fair business environment, like the one it allegedly provides to other foreign investors.

#### Russians celebrate Unity Day online amid pandemic

YESTERDAY, November 4, Russians celebrated the National Unity Day - most of the events in 2020 was held online.

Russian President Vladimir Putin has laid flowers at the monument to Kuzma Minin and Dmitry Pozharsky in Moscow's

Red Square. The flower laying ceremony traditionally takes place on National Unity Day. Russian citizens should know their rights, but also remember their responsibilities and a sense of duty to the Motherland, he

"Rights and responsibilities must

be in harmony with each other. It would be difficult for our entire society to exist without it," Putin said. He noted that citizens should know their rights and demand their implementation from the state, but each person also has responsibilities.

Deputy Chairman of the Russian Security Council Dmitry Medvedev congratulated the Russians on National Unity Day, noting that this holiday has become a symbol of respect for the rich history of the country. "National unity for us is not only a beautiful metaphor, but also the basis for the existence of our multi-confessional and multi-ethnic people," he wrote on his VKontakte social network page.

National Unity Day is one of the youngest national holidays in Russia. It was established in 2005, replacing the Day of Accord and Reconciliation, which had been celebrated on November 7 since 1996. The holiday commemorates the events of 1612, when people's militias led by merchant Kuzma Minin and Prince Dmitry Pozharsky liberated Moscow from Polish invaders.

On this day, concerts, fairs and other kinds of celebrations take place across the country. The Russian president presents state awards to prominent cultural workers and foreign nationals who contribute to friendship and cultural ties with Russia.

# US voters pin hope on next president to end pandemic, rifts

BRAVING COVID-19 risks, US voters have been turning out in huge numbers to cast their ballots, making a consequential choice that will decide the direction of the country for the next four years and beyond.

More than 100 million Americans opted for voting early, a record-breaking number equivalent to about 73 percent of the total votes counted in the 2016 election, setting the stage for record participation this year, according to data compiled by the US Elections Project.

This year, former Vice President Joe Biden, the Democratic presidential nominee, has taken on incumbent President Donald Trump in the White House race.

#### Pandemic game changer

A majority of the early voters chose to mail in their ballots during the raging COVID-19 pandemic, which some experts said has gone from bad to worse in the United States. As of Tuesday afternoon, the virus has infected 9.3 million Americans and killed more than 232,000.

Still, many prefer to vote in person on Election Day, while taking such precautions as wearing face masks and keeping social distancing.

"I just wanted to vote on Election Day. There was something special about voting on the day," said John Peterson, who arrived at a polling station in the state of Virginia at 5:50 am local time (1050

The 29-year-old tech company employee voted for Biden, citing the Trump administration's pandemic response as one of the primary reasons that influenced his decision.

"I think his (Trump's) handling of the pandemic is similar to his handling of other issues, not well thought out, not planned or implemented effectively," Peterson said.

"The most crucial issue right now is the pandemic," said Alex Le. a Vietnamese American and doctor from New York State. The 22-year-old nonpartisan voter voiced his hope that the next administration could listen to doctors and scientists, and tackle the pandemic.

Figures have painted a bleak picture in recent weeks as most of the United States has recorded a spike in infections, deaths and hospitalizations since colder weather set in.

Nearly 100,000 new COVID-19 cases were reported on Friday, setting a global daily record. The country has not yet seen the worst of it, experts warned.

For many voters, pandemic response cannot be evaluated independently of

how the economic fallout is addressed, and the current government's performance in this regard is up for debate.

Tom Waters from the state of Missouri believes Trump is "getting blamed far more than he should be for how he handled things."

"I try to put myself in their shoes and I don't know what more he could do ... And I'm thankful that, the economy was opened back up and started to get back on track," said the soybean and corn farmer who voted for Trump.

The COVID-19-induced recession has to date rendered tens of millions of Americans without a paycheck. The number of Americans living in poverty has grown by 8 million since May, according to a recent Columbia University study.

"Like many Americans, I'm very concerned that the current administration failed to anticipate, manage, or in any meaningful way address the issues created by the COVID-19 pandemic -- be it the health emergency itself or the economic calamity caused by the pandemic," said Jon Taylor, who identified himself as an independent. The political science professor at the University of Texas at San Antonio voted for Biden.

#### Divisions run deep

This year's election is taking place at a time that many voters said is marked by "division," as racial tensions have been running high and partisanship is running deep in the country.

"People are very divided. 2016 was less divided," said Tom Donald, a Republican from the swing state of Wisconsin. "There is hate of America in our country on both sides," added the 54-year-old store manager, who voted for Trump. "The election has shown how divisive we are and the whole campaign has been that way. The ardent supporters of each candidate see

no good in the other candidate," Randy Hudderson, an engineering consultant, told Xinhua. The 71-year-old from the city of Kenosha in Wisconsin, who identifies as Republican, voted for Biden.

Back in late August, Kenosha became a focal point of both Republican and Democratic campaigns after 29-yearold African American man Jacob Blake was shot seven times in the back by a police officer, sparking protests nationwide demanding racial equity.

"I think no matter who wins the election, racial inequality and the resulting social issues will not be resolved immediately. The turmoil will go on," said Kevin Chan, a Chinese American from San Francisco, California.

The 51-year-old businessman said he did not vote for either presidential candidate. "The current partisan politics in the United States will continue to cause social division, polarization, and fracture, which is very disgusting."

Waters, the farmer from Missouri, used "scary" and "historic" to describe the election. "It's historic. I think the outcome either way is going to have long-term impacts ... it's scary just because we don't know right now, which direction our country's gonna take. And, there's a lot of unknowns and everybody likes to know what's going on."

A more immediate concern, meanwhile, is election-related chaos that federal and local authorities, as well as businesses, have been bracing for, leading to enhanced security measures introduced across the country.

"The protests this summer were bad and I don't want that again," said Kevin Wrighterman from Kenosha of Wisconsin, describing the atmosphere of this year's election as "disconcerting." Identifying as Republican, the 64-year-old educator voted for Trump.

### Kenya, Britain conclude trade talks to ensure smooth trade post Brexit

#### **NAIROBI**

KENYA and Britain on Tuesday concluded an economic partnership agreement (EPA) to ensure smooth trade when London leaves the European Union on Dec. 31.

Kenya's chief negotiator Johnson Weru, who is also the principal secretary at Ministry of Industrialization, Trade and Enterprises Development, and Britain's chief negotiator Paul Walters said that both parties have reached an agreement in principle of the Kenya/East African Community (EAC) -UK Economic Partnership

"When, as expected, the agreement enters into effect at the end year this will secure long-term duty free and quota free access to the UK for Kenyan exports and our overall trade and economic arrangements. This agreement will provide continuity for our businesses, investors and supply chains and will set the foundation for further economic and development opportunities in the future," they said in a joint communique issued in Nairobi.

It said that government officials of the two countries have "initialed" the text, marking the end of the formal negotiations.

"The text will now be prepared for signature in the coming weeks before it is submitted to our respective national processes including parliaments to complete ratification processes," the two officials said.

Betty Maina, Kenya's cabinet secretary, Ministry of Industrialization, Trade and Enterprises Development said that the negotiations covered a host of important issues including barriers to free flow of trade between the two countries.

"We agreed on shared approaches to trade and investment, including the need to adopt common rules of origin and through broader acceptance of products," Maina said.

Maina added that the agreement replicates the effects of the East African Community (EAC) EPA with the European Union that facilitates duty free quota free access to exports from EAC countries to the European market.

Maina noted the bilateral trade pact will deepen the EAC integration by ensuring that exports from Kenya and the EAC region continue to enjoy dutyfree-quota-free access to the UK after Brexit - when the UK leaves the EU on Dec. 31.

Data from the ministry of trade indicates that trade between January to August shows that Kenva's exports were valued at 34.9 billion shilling (320 million U.S. dollars), while imports were valued at 185.2 million dollars and a trade balance of 154.5 million dollars in the east African nation's favor.

Rebecca Fisher-Lamb, British deputy trade commissioner for Africa, said that both countries have reached an "agreement in principle" on the text of the trade pact.

Fisher-Lamb added that the agreement lays the foundation to expand trade between the two countries.

She observed that by granting dutyfree access to UK markets, bilateral trade can continue between businesses as it does now in horticulture, flowers, pharmaceuticals and vehicles.

Before that, the U.S. also peddled malicious lies against China in terms of international security issues at the 75th session of the United Nations (UN) General

The chaos and mess stirred up by such political manipulations will never cover up the fact that the U.S. is trying to gain hegemonic control of other coun-

INTERNATIONAL soccer governing body FIFA' Secretary General Fatma Samoura has been inducted into the International Women's Forum (IWF) Hall of Fame as recognition for her transformative contributions to society.

Fatma worked on United Nations projects for 21-years before becoming the first-ever African, and woman to hold the role of Secretary General at FIFA in its 116-year history.

She has been joined by fellow Hall of Fame honourees, Mary Barra, Chairman and CEO of General Motors and Ginni Rometty, Executive Chairman of IBM, at the online 2020 IWF Hall of Fame Awards Gala.

The gala was held online this year due to the COVID-19 pandemic and featured interviews with each of the three inductees about the paths they took to lead them to their current roles, the advice they have for young women and the causes that motivate them in their daily work.

Salah set up Sadio Mane for Liverpool's fourth before Jota got his hat-trick goal as the Premier League champions recorded their biggest win in Europe since beating Porto 5-0 away in February 2018.

"I'm playing in the best team of my career so far. I don't know if it's the best moment of my career but obviously scoring goals is my way of playing football," Jota told BT

With three wins from three, Liverpool are well on course to top Group D, with Ajax and Atalanta both five points back.

# Maradona undergoes successful brain surgery on blood clot

RGENTINE football great Diego Maradona underwent successful brain surgery for a blood clot in a specialist private clinic in Buenos Aires on Tuesday, his doctor said.

"We managed to successfully remove the clot. Diego coped well with the surgery," Leopoldo Luque said at the icon's private clinic in the capital Buenos Aires.

"It's under control, there's a little drainage (of blood). He'll remain under observation."

World Cup winner Maradona had been taken to hospital in La Plata -- where he is the coach of top flight side Gimnasia y Esgrima -- on Monday for a series of tests after feeling unwell.

A scan revealed the blood clot, and on Tuesday he was transfered to the specialist clinic in a northern neighborhood of the capital.

Maradona, who turned 60 on Friday, has suffered ill health before. He has survived two heart attacks, and also contracted hepatitis and undergone gastric bypass surgery.

Groups of fans congregated outside the clinic with banners showing Maradona's face and the words "Come on, Diego!"

"I came with my wife to support the greatest player of all time," fan Oscar Medina told AFP.

"Once more his health has played a trick on him but he has antibodies to recover with the help of the people," added Medina.



"I feel very sad and impotent but we're going to stay by his side until the last day," said another fan, Matias Di Sciosio.

Earlier on Tuesday, Luque insisted it was "a routine operation" and that Maradona was "lucid" and "calm."

Argentine media speculated the clot was the result of a blow to the head.

Luque said the clot was "imperceptible" and that those suffering from one rarely remembered receiving a knock to the head.

"The operation consists of a small incision to drain the blood. In 24 or 48 hours the patient can leave the Raul Matera told TvC Sports channel.

#### - Anemic -

Maradona transferred from hospital in La Plata, 60 kilometers (37 miles) south of Buenos Aires, to the capital at 6:00 pm (2100 GMT) accompanied by one of his daughters, Giannina.

Dozens of Gimnasia fans outside the La Plata hospital chanted his name as he left.

Earlier in the day, Luque claimed Maradona was feeling "much better and eager to leave" hospital but insisted that the Gimnasia Y Esgrima coach was briefly at the club's hospital," neurosurgeon suffering from anemia -- a training ground on his

lack of iron in his system -and dehydration.

Luque said it has left him feeling "very weak, very tired." After further tests, he was diagnosed with the blood clot.

Не also suggested Maradona's lifestyle had contributed to his condition.

"He's an elderly patient with many pressures in his life. It's a time when we must help him. It's very difficult to be Maradona," Luque said of the star, who celebrated his 60th birthday on Friday.

He said it was a condition that also affected current Vice-President Cristina Kirchner when she was president.

The doctor ruled out any link to the coronavirus pandemic, which is ravaging the South American country, much of it still under confinement.

Maradona is considered at high risk of coronavirus complications should he be infected.

Last week, he began selfisolation for the second time after a bodyguard displayed coronavirus symptoms, though he later tested negative.

He joined his players

birthday, but had obvious difficulty walking and had to be helped away by his assistants after staying only 30 minutes.

"It breaks my heart to see him like this," Giannina tweeted the next day.

#### - 'He needs support' -

Maradona has difficulty retaining iron due to a gastric bypass surgery he underwent in 2005 to lose 50 kilograms (110 pounds), leaving him prone to anemia, Luque said.

Though has he recovered from a welldocumented addiction to hard drugs, Maradona takes medication in the form of tranquilizers and anxiolytics.

"With a patient on medication, there times when hospitalization serves to adjust that medication. That's good," said Luque.

Gimnasia fans flocked to the La Plata clinic to leave messages of support for the ailing icon.

"What he needs most is the support of the people," Luque said.

Alongside Pele, who turned 80 last month, Maradona is widely regarded as one of the greatest players of all time.

# Bale, Spurs on Europa League relaunch mission

GARETH Bale will hope to use Thursday's Europa League game against Ludogorets to further sharpen his fitness following his return to Tottenham, while Arsenal and Leicester can take a step towards the knockout stages with a third win

"I'm feeling good," said Bale. "I'm getting a lot fitter, obviously it's been good to get a couple of starts in the Europa League, getting more minutes (Sunday) will benefit me again. "I'm staying patient, I know I have

to build my match fitness, it's been a while since I put a couple of games together, so I'll continue to work hard in training every day, and in the games when I'm given the chance." Spurs must hit the reset button

after a limp 1-0 defeat by Antwerp in Belgium last week left Mourinho unimpressed, and bemoaning not being able to replace the entire team at half-time.

They visit a Ludogorets side hunting their first points in Group J after Elvis Manu's hat-trick came in a 4-3 loss for the Bulgarians at Austrian outfit LASK Linz on matchday two.

The Games initially were to be held mid this year but they were postponed by the International Olympic Committee (IOC) from its tradition dates in the wake of Coronavirus global pandemic.

Filbert Bayi, TOC secretary general, said that the local athletes should not relax as the dates for the muchanticipated Games are just around the corner.

Bayi, the 1500m Commonwealth Games record holder, said that despite the summer Games' postponement, other athletes across the world, who are determined to excel in the Games, are still in serious preparations for the showpiece.

"The Games are likely to be on, they should see the green light," Bayi, who smashed world records and revolutionized running during his illustrious career,

"Our athletes have been magnificent in their positive attitude to training and preparation for the Games, I urge them to continue training hard and make sure that they excel," the TOC official said. The Coronavirus pandemic has also forced some great

runners to train in their respective countries, following travel restrictions aimed at reducing infections globally. "While there will still be much to work out as a result

of this change, the timing will allow athletes from around the world to properly prepare," he stated. The IOC believes that coronavirus crisis will globally

be under control as Tokyo will be hosting the Games. The Coronavirus pandemic has however, affected several Olympic qualifying series as the final ones are

due to take place early next year. Bayi urged the Tanzania Boxing Federation (TBF) to use effectively their final qualification series in Paris, France in May and make sure that they secure tickets for the Games.

This will be the second attempt for the country's boxers after failing to do so in the Africa Boxing Championship, which took place in Dakar, Senegal in February this year.

Tanzania, according to Bayi, is also expected to feature athletes in swimming and athletics, should they

According to Athletics Tanzania (AT) information officer, Tullo Chambo, only two runners have so far qualified for the grueling event.

They are Alphonce Simbu and Failuna Matanga, who was the first Tanzanian to seal a ticket for Tokyo Olympic Games after finishing third in Hamburg Marathon last year by clocking two hours, 27 minutes and 55 seconds behind Kenyan and Ethiopian runners.

She beat the qualifying time by almost two minutes. Simbu who competed in men's marathon at the 2016 Summer Olympics in Rio de Janeiro, Brazil, finished fifth with 2:11.15.

Simbu also won a bronze medal for the country in the men's marathon at the IAAF World Championship which took place in 2017.

Several other Olympic bodies had written to the IOC requesting that the Olympics be postponed whilst others were against the global Olympic body making such a rash decision.
