

Nigeria praises Africa court on peoples' rights

NIGERIAN Vice President, Prof Yemi Osinbajo, has appealed for more support for the African Court on Human and Peoples' Rights to enable it enhance justice on the

Visiting the court here at the weekend, he expressed concern that this important legal institution is yet to get the support it needs.

The VP said that African Union member states need more sensitization on the role of the Arusha-based court, especially as an alternative resort in guaranteeing justice to people from various African states.

During his meeting with judges of the court led by Lady Justice Imani Daud Aboud, Prof Osinbajo asserted that one among critical issues is sensitization among AU member-

More countries would be more willing to identify as required with the court, but governments need more assurance on their exercise of sovereignty, which amounts to compartmentalization, he elaborated.

Expressing his strong faith in the international and regional court system regarding the respect and protection of human rights, he said that there will always be tensions and challenges as states will always be mindful of their sovereignty.

In May 2019, a court delegation visited Prof. Osinbajo in Abuja for a courtesy call, to discuss Nigeria's support for the African Court on Human and Peoples' Rights, as a continental court established by member states of the African Union by virtue of Article 1 of the Protocol to the Charter on Human and Peoples' Rights.

Samia on tanzanite: Cut

■ President to appear in travel documentary to highlight tanzanite source

PRESIDENT Samia Suluhu Hassan has called for restraint on the offloading of newly mined tanzanite, urging dealers to control the supply of the rare mineral so as to boost its demand and value in international markets.

She was visiting Mirerani township in Simanjiro District, Manyara Region, yesterday, her tour billed to feature in another episode of 'The Royal Tour' TV series.

"We are the only ones who have tanzanite, why do we hurry? Let's sell them in calculated installments so as to increase the gemstones' value in international markets," she urged, addressing town residents outside the sprawling walled compound housing tanzanite quarries.

The area in which the tanzanite ores are found is just here, a rather small location which needs to be treated sensitively to safeguard the valuable deposits, she stated. The gemstones will not last forever so it is important to handle it with utmost care, she urged.

Government intention to construct a market and business center in the area was afoot, in reaction to which Simanjiro MP Christopher ole Sendeka assured the president that a 250 hectare area to house the project has already been secured.

SADC hands 600m/for upkeep of elders



THE Southern Africa Development Community (SADC) has provided Tanzania with more than 600m/- as social services assistance for caring of elders.

The money is part of a project to assist services to elders living in difficult conditions in Tanzania, Malawi and Mozambique.

SADC has provided the funds to Tanzania through the HelpAge Programme that focuses on assistance for elderly, including the provision of health services.



Speaking to reporters at the opening yesterday of a two-day seminar for elderly care institutions in the three countries, HelpAge programme coordinator Dr Edwin Mung'ong'o said the funds will be directed to assisting elders. The targeted programme is based in Handeni and Lushoto districts in

Elders face many challenges in their day to day lives, like the lack of friendly health services, personal income and social security. SADC recognized these challenges and decided to assist, he said.

The programme runs for two years, with Tanzania receiving the funds for the second consecutive year, he stated.

The project was established in Tanzania, South Africa and Zimbabwe and now in its second phase, with Tanzania included in both phases, he further noted.

"HelpAge is closely collaborating with TACAIDS as elders have been skipped in health outreach including protection against HIV/Aids.," he said, pointing out that there are

Hassan got vaccinated against the coronavirus to kick off the nationwide vaccination campaign, using the event to instill confidence in the jab.

She said that as a mother, grandmother, wife and Commanderin Chief of the armed forces, she could not have endangered her life by taking a jab if she was not convinced that it is safe.

The drive initially prioritised healthcare workers, people living with underlying conditions and those aged 50 and above but was later extended to all those aged 18 and above.

Amid the campaign, the government has been battling

vaccine hesitancy fueled by unsubstantiated reports of vaccine risks spread mainly on social media by vaccine and science skeptics based abroad and even locally.

The most pronounced case is that of independent church leader and Kawe MP Josephat Gwajima who has been using his Ubungo pulpit in Dar es Salaam to churn out anti-vaccine harangues.

He has repeated claims, without providing matching evidence, that available Covid-19 jabs did not follow a proper timeline for vaccine development and that some of it could interfere with recipients' DNA.

National Assembly Deputy Speaker Dr Tulia Ackson called on lawmakers to participate in providing education and to

encourage citizens to go for Covid-19 vaccination.

She said that there was a problem with vaccinated people who see non-vaccinated ones as adversaries, saying further that the responsible minister needs to monitor countrywide availability of oxygen cylinders so that areas in short supply are quickly served so as to save lives.

Bishop Gwajima was grilled by the Privileges, Ethics and Powers Committee of the legislature which resolved that he was guilty of putting the House into disrepute by his antivaccination rhetoric. He was penalized not to attend two

parliamentary sittings, the current one and the next, in November. He told his Glory of Christ Church in Dar esSalaam that government officials had been given money so that Tanzania accepts the Covid-19 vaccines, but later told the parliamentary committee that he meant they were promised funds for development projects.

Moving a motion to suspend Gwaiima for two sittings, committee chairman Emmanuel Mwakasaka (Tabora Urban), said that the committee was satisfied that the Kawe MP had indeed put the House into disrepute.

The committee resulted to that security organs follow up on the cleric's utterances, underlining that some of his utterancesk had criminal overtones and could potentially jeopardize peace and national security.

Justice Imani informed the VP that

one of the big challenges the court faces is that scores of African States are yet to ratify the protocol and make the declaration of adherence under Article 34 (6), noting that the court was doing its best in the circumstances.

The 62nd session of the court would be starting next week to deliberate on cases before it, she remarked.

Others present at the meeting include ACHPR Vice President Justice Blaise Tchikay, the Registrar, Dr Robert Eno, while the resident Nigerian High Commissioner, Takalmawa Hamisu Umaru accompanied the VP.

ACHPR complements reinforces the functions of the African Commission on Human and Peoples' Rights, with eleven judges from among AU member states.

Vaccine rollout still slow, 30pc of doses used so far

FIVE weeks after President Samia Suluhu Hassan launched the country's Covid-19 vaccination rollout, just over a third of the 1.2m doses donated by the United States have been used, the chief government spokesman stated over the weekend.

Addressing a weekly press conference to scan various government initiatives during the week, Director of Information Gerson Msigwa said that the number of vaccinated persons it is about 350,000 even as earlier reports highlights of a strong turnout especially in the hard hit northern regions of Arusha and Kilimanjaro.

Callers from the inland district of Maswa in Simiyu region in the Lake Victoria zone queried over access to vaccines, and the director responded that there are new initiatives for outreach in the Covid-19 vaccination drive, beyond the 550 centres already identified to offer vaccination services on a day to day basis.

As to the reasons for vaccine hesitancy even with painstaking efforts by the government, and the personal example of President Samia Suluhu Hassan in being the first of senior government officials and public figures to take the jab, one major cause for doubt is beginning to emerge.

While the criticism of jabs has been clothed in unfinished experimentation as vaccines take years to develop - an argument countered by the need to squeeze experimental periods due to the intensity of Covid-19 infections and fatalities - the concern is being directed elsewhere.

The image of what raises concern in many people was visible from Day 1 of vaccination, when regional Council (BAKWATA), Alhad Mussa Salum, sought to allay fears among his followers that the jab interferes with male potency.

That sphere of interrogation keeps coming up in morning talk shows in various city Radio stations, with callers and commentators not being satisfied with answers, as many brook no experiments in that regard, as they seem to loath a loss of potency more than they fear the virus itself.

In one talk show with an IPP Media radio station, Muhimbili National Hospital staffer and microbiologist Dr Frank Msafiri dwelt on some of the issues raised by callers, for instance what conditions may arise after a person has taken the jab, where only allergy was cited as a possible inconvenience.

Another issue tackled was the condition in which a person can take the jab or cannot take, or what things one cannot do after taking the jab, where the response focused on avoiding a state of being drunk the day before the jab and at least three days more subsequently.

He similarly emphasized on the need to continue wearing facemasks after taking the jab as inoculation becomes effective body defence after two weeks and not immediately after taking the jab, meanwhile as one has to continue taking precautions to prevent infection.

Having better body defences doesn't hinder one from being infected but drastically cuts down chances of severe disease and hospitalization, he stated.

He similarly cautioned on the habit of thinking that one can get the disease and be cured, and there is no problem, noting that after effects of Covid-19 infection linger on for a long time even after healing.

TCU calls for care on course selection

According to TCU executive secretary Prof Charles Kihampa, they have found that there are some candidates who apply for programs which they clearly know that they don't meet their requirements and thus ending up loosing an opportunity of being selected.

Addressing journalists in Dar es Salaam during the weekend, Prof

all eligible applicants to get enrolled into university colleges but this cannot be achieved if the applicants go against set conditions.

"For example, someone goes and apply for engineering program while he/she clearly knows that he/ she didn't pass physics or any related subject, this will automatically lead to not being selected even if you got division one. So this is an area where applicants need to be very careful,"

He said that there are some programs which have high competition so applicants should

also consider this when applying. Prof Kihampa further called on applicants who have been

Kihampa said the commission wants admitted to more than one college to confirm their admission to one of the colleges so as to allow others to get admitted.

He however, said that the commission expects to open third window of application on September 18, this year to allow more Tanzanians and non Tanzanian applications to get opportunity of being enrolled into university.

In addition, the commission announced the third admission window that will run from September 18 to 24, 2021 to fill

vacancies that will be available.

Prof Kihampa wanted universities to provide closer support to the applicants and support them whenever they seek help.

Farmers associate food agency with bizarre dealings in maize purchasing

MAIZE farmers in Songea District, Ruvuma Region, have complained to the government, through the Songea Zone of the National Food Reserve Agency (NFRA) over failure to purchase their maize. Instead, they said, the agency buy the crop during the night from big dealers and various government officials.

Speaking to reporters at different times at NFRA premises here, the farmers who did not want their names revealed said their maize was not being purchased reasoning that it was of substandard, the claims that were not true.

They claimed that during the night trucks full of maize directly enter NFRA premises for weighing and selling the maize in total disregard of queues as required, the situation that has been surprising us while querying the owners of the maize being sold to NFRA at night.

"They said earlier, NFRA pledged to buy 80 bags of the maize from each farmers, but later they reduced the number to 50, but today they say they will only buy 10 bags, what is behind all this confusion, we have been here for more than two weeks with more than 100 bags of maize," said one of the farmers.

Another farmer added: "We fail to understand the fate of the maize we have, every day they register names of 20 farmers picked to buy their maize, but at the time of weighing only 7 farmers succeed to get their maize weighed and while the remaining 13 are told their maize was of low quality."

They are asking the government to look into the issue because, they said, the time remaining for coming farming season was short.

For his part, NFRA Manager for the Southern Zone, Mohamed Mondo said the money they get from the government for maize purchase was small, and as for now they anticipate to buy 4,000 tons of maize only.

However, he said that other claims advanced by farmers did not hold any shed of truth, and challenged farmers with evidence of their claims to report their concerned to authorities for appropriate steps.

TICL registers 45 pct total income increase

TCCIA Investment Company Limited (TICL) has reported a 45 percent total income increase in the first quarter ending June compared to the same period last year.

In its interim financial results report for June 2021, the company attributed the profits which rose to 1.81bn/- from 814m/- last year to an increase in dividend from equities, interest income and realized gains from investments in government securities.

"The profits are due to higher interest income and capital gains from government securities trading, this is a result of diversification strategy from equity to longterm government bonds," said the company's Chief Executive Officer Peter Kifunguomali.

The company however listed a number of issues to be addressed including joint venture with other market players such as brokers to advise capital markets regulators to remove the cap limit on securities so that share prices reflect the correct demand and supply trend.

TICL also plans to continue looking for new investment opportunities in other sectors apart from financial services including private equity and venture capital.

"Private equity is an alternative investment class and consists of capital that is not listed on a public exchange. Private equity is composed of funds and investors that directly invest in private companies," reads the report.

On the same note, the company listed down a number of challenges derailing investment; including lack of funds as currently the company uses investment income for investment purposes as it is not always easy to dispose of some equity investments as planned due to market conditions.

Another challenge was the presence of regulations that limit the movement of prices for securities forcing investors to sell shares at pre-arrangement deals which are below market prices incurring capital losses in the process

"For example, the Touchline Price under Dar es Salaam Stock Exchange (DSE) Rule 137 provides a cap limit of 5-percent to 10-percent on price movement," the report said.

Another challenge was the tight competition in the bond market where institutional investors like pension funds, commercial banks, and insurance companies have been pushing for government bonds causing yields to drop.

The company said there is lack of enough investment opportunities in the capital market, adding that the Tanzanian capital market mainly consists of government securities and few equities compared to other markets such as Kenya, South Africa, and Egypt which offer a range of derivative financial instruments in addition to equities and bonds.

She said in order to have this done an entrepreneur must present a letter of introduction from Small Industries Development Organization (SIDO).

Some of the SMEs who, at

different times, had their products' quality certified told this paper that as for now they have done away with business obstacles that were facing earlier.

One of them, Anna John, a resident of Dar es Salaam said before obtaining quality marks, she used to be queried by customers about TBS certification for her goods, saying that it was a big challenge for her.

The move will enable a number of government services to b accessed at the TPC offices thus making it easier for citizens to access them and bar them from traveling from one government office to another seeking for service.

Addressing journalists in Dar es Salaam during the weekend, Minister for Communication and Information Technology, Dr Faustine Ndugulile said the launch was among strategies by the government to improve efficiency, increase the scope of services and achieve major digital goals.

He said that Prime Minister Kassim Majaliwa is expected to grace the event to be held in Dar es Salaam General Post Office.

According to him, the first phase implementation will involve eleven regions including Dar es Salaam, Dodoma, Mwanza, Kigoma, Arusha, Mbeya, Mjini Magharibi Unguja, Lindi, Tanga, Morogoro and Chakechake.

He said that services that will be available in the one stop

centres include those provided by the Registration Insolvency THE Tanzania Posts Corporation and Trusteeship Agency (RITA), National Identification Authority (NIDA), Business Registrations and Licensing Agency (BRELA) and the Tanzania Revenue Authority (TRA).

Others will be the National Social Security Fund (NSSF), Public Service Social Security Fund (PSSSF), National health insurance Fund (NHIF), immigration and other services provided by various councils.

According to him, immediately there will be multiple windows at the centres but later on, they will embark on a single-window after all the systems being integrated.

Dr Ndugulile further said TPC has recently emerged winner for outstanding performance in two areas of administration and operation council after being voted by several posts corporations across the globe. He said that TPC competed along other posts corporations in Africa and emerged the best in the mentioned areas.

The minister said that the government mulls to improve the corporation and enable it compete commercially for the country's development.

IN July this year, Vodacom Tanzania's 'Tusua Mapene' lottery announced its highest payouts in consecutively 4 year in history of the competition with the main winner being awarded 180m/-

The lottery started four years ago with the intention of rewarding loyal customers and giving them a chance to fulfill their dreams and make lifealtering changes from affordable outlays ranging from 300/- per daily unit to 6,000/- for a monthly pack of 30 units.

Over the period, a total of 4bn/has been paid to more than 500 million winners of daily, weekly, monthly and grand prizes, ranging from 15,000/- to 20,000,000/daily prizes and a grand prize of 100,000,000/-.

Celestine Kilemezi from Musoma in Mara Region who won a 128m/prize said she used the money to build a house, buy a car and a plot of land. She remembers getting the news that she may be a winner and she did not believe it at first.

"I received a phone call late that afternoon and I was told to tune in to TBC1 in the evening since I may be a winner. I thought it was just a random call and went about my nosiness. My grandchild brought me my phone at 7pm that evening and I was told live on TV that I had won,"

Celestine said she was later contacted by Vodacom officials who

arranged a day to meet and hand land which he built a house that over her cheque. After collecting her winnings, she bought a house in a fixed deposit account and Mwanza, a new car and three plots of land that she is developing.

She said the prize cemented her trust that the lottery conducted in a completely fair and unbiased way.

"There are people who believe that these games are unfair and the winners are planned in advance. I can tell you this is not true. With this game held by Vodacom, I had no connection with the organizers nor do I have any relatives or close friends in the company. I would encourage others to take part, they too may win like I did" said Celestine.

The company's Director of Digital and Value Added Services (VAS), Nguvu Kamando said: "The aim of Tusua Mapene is to empower Tanzanians economically. I urge our customers to take part in this ongoing lottery because by doing so you ensure yourself a chance to win

In early 2020, Eveneth Rutiyomba, a resident of Kimara in Dar es Salaam won 150m/-

"This is a dream come true for me," she said adding: "I never thought I would ever have this much money in my possession, but here I am today and my life will never be the same again," she narrated.

Another winner, a 47 year old Marko Kilungala from Simiyu Region, won over 80m/- and used that money to buy a plot of

he currently lives in. He opened deposited the rest of his winnings into it and, after it had matured, he took that money and bought a tractor that he uses for farming and as an investment.

He said: "I needed transportation so I bought a motorcycle. I also bought four other motorcycles that are used for business and contracted drivers for them. I expect to have recouped the money by April of next year and so will be able to make further investments."

"Prior to winning Tusua Mapene, my life was very difficult, I was facing a lot of challenges and had no direction in my life but now, my life has changed completely, I have made successful investments that benefit my family and promise a bright future for myself and my

children," added Marko. The very first grand winner was Jackson Mwankemwa (51) a farmer from Msasani village, Rungwe District in Mbeya Region who won over 200m/-.

The Tusua Mapene lottery has now entered a new phase where another grand winner will be found and have their life forever altered.

NHIF organized the meeting with stakeholders to discuss on how they can improve their services and solve many challenges that were cited by the fund members.

Konga said in every three years the fund revive benefit packages adding that for this year the process to revive the benefit has reached good stage promising its members a bright future.

"We have improved our benefit packages and the process is still going on to make sure we come up with good thing and we have included stakeholders views and health services will be added," said Konga

He said during the process of improving benefit packages they always take on board views and opinions from different potential stakeholders to ensure they all speak the same language of helping Tanzanians in health care provision.

He further said despite the transparency of the fund when solving some challenges there are still many complains especially on payment delays which he said many of them are addressed by some people in wrong channels.

"This complains are not addresses in official channels so that they can be solved so I take this opportunity to argue you participants that use this forum to reveal all you complains. Be open to say all your challenges so that we can discuss and come up with permanent solutions, " said Konga.

He said currently, NHIF pay its service providers within 30 to 45

the payment took up to 60 or 100 days adding that the fund payments has enabled health centers to get enough fund to run their activities smoothly.

Teens spreading terror in cities: Call for fast action

the past half decade been forgotten is rearing its head again, what was usually known as 'panya road,' not the smuggling of goods sense but bands of youths, in their teens mostly, wrecking havoc in big cities. A report from Tanga towards the end of the week said views are

divided there on how to deal with gangs of teenagers terrorizing residents of Tanga city, 60 of whom were recently arrested by the police. As it isn't a daily phenomenon, it is likely to calm down for a while now.

As it was the case at the time that the late President John Magufuli came into office, or by the time he was getting to solve law and order drawbacks and putting the police and local administration on a proper footing, the mobs have not changed. The ruthless 'swarms' of youths armed with rudimentary weapons from households are said to have been operating for some months in Tanga. The issue is so far a regional matter, not one attracting policy decisions on what measures need to be taken; it is localised criminality.

The youths have been threatening, attacking and robbing residents of money and belongings such as purses and cell phones. This was usually the sort of crime propagated by motorcycle hiring thugs and they were stopped from entering the city centre in Dar es Salaam in the final year or thereabouts of the fourth phase government. For the regional authorities, it was a relatively minor law enforcement scenario where 60 teenagers aged between nine and 15 were arrested for robbery-related offences.

SITUATION that has for terms, another already jailed to varios terms and another whose cases are being pursued. Only that the public is hankering for answers.

The public is baffled why teens of that age stock things like machetes, knives, screwdrivers and razors which they use to commit crimes, with some of them figuring out that there are adults involved. Yet this suspicion is hard to built into a case to investigate, for any adult will find it easier to send a son, but how does a father send a son on petty crime? Organised crime knows where to get plenty of money, not send a crowd to rob and then collect the proceeds, while such a crowd is unlikely to have any sense of discipline.

Regional police commander Blasius Chatanda pointed at parenting weaknesses leading to the disturbing situation whereby children who are supposed to be in school or doing homework at home traverse the streets of the city looking for potential victims to attack and rob. He did not appear to have any advice but that if adults don't play their part in parenting the law will always follow its course. That evidently is true but the sore toe is untreated.

It is regional commissioner Adam Malima who has been closest to the point, lately saying that Tanga region cases of drug trafficking and abuse were rising, second only to Dar es Salaam. It means we are back in the days of unchecked social decay and sporadic police operations.

That is a sad situation as boys taking to substance abuse start craving for money, and don't stop at anything. In addition, their sheer size and youthfulness point to lack of organisation but spontaneous action, after whispering to one **The Guardian Limited Key Contacts**



T is not possible for whoever Basil Pesambili Mramba (pictured) truly well to describe him and feel comfortable that a complete job has been done. That is the situation I am as I write this short piece. Accordingly, I will just describe him as a good person.



Despite his ever busy schedule and the ever demanding duties and responsibilities this entailed, Basil was a family man par excellence.

Many would be delighted to be in the company of Basil Mramba in any manner of social situation, casual or other. He commonly turned all the more joyful over a glass of wine, where his remarkable sense of humour kept everybody around

buildings for two schools.

Basil was never seen angry with anybody or any circumstance, even if there was ordinarily some reason to feel bad or uneasy.

Hear this: When he was admitted to hospital on his last journey on earth, the first thing he did was to ask for a priest to administer him a sacrament for the sick. According to Catholic Church tradition, he also wanted to receive the sacrament of confession - and he got all he wanted from his spiritual leaders.

This suggests that Basil fought a good fight, completed the race and kept the faith - and, for him, that was no mere recital. He lived and practised it to the very end, and it is believed and hoped that he is now happy in heaven, singing in the company of angels just as he loved to do in church.

May you rest in eternal peace, brother Basil Pesambili Mramba. Family and friends will ever be with you in spirit.

O what lessons are we meant to take on in terms of stamina and sureness of course and purpose from those who came before us? How do we take that which they gave their lives for and seek to realise it?

Stamina is vital if one is ever to achieve anything worthwhile. It's a little word with a big meaning, requiring disciplined and sustained mental and physical effort in order to achieve an objective. Africa's resistance South movement started more than 100 years ago and those who started it didn't live to see its fruition, yet dedicated their lives and those of their families to the idea that freedom was sure to come for all who live in SA if they organised and mobilised behind this struggle for a democratic country.

Remember, this struggle was the result of the collective and collaborative efforts of ordinary men and women who rallied behind one ideal, which was that of a free and fair society. It was not about rallying behind individuals, because that is not how teams work.

It is sometimes easy to forget that we are a burgeoning democracy and that part of what will get us from fledgling status to maturity is a contestation of ideals something that often proves to be uncomfortable. We are a young democracy punching above its weight because of a set of ideals and values placed before us by the visionary pioneers of our

Some might say that there is no room for idealism when faced with the hard work of building a country, but the strength of a team comes from recognising the value of its differently abled members. There's a reason why we need idealists and visionaries - because they set the course. Even when we do not attain the ideal, it brings us closer to where we need to be.

Admittedly it is tough trying to work towards a vision while others loot and pollute this vision to suit their own needs, sullying things for evervone else.

But we cannot pick up our ball and go home the moment things get hairy or difficult. If that was people's attitudes during the struggle for liberation, we would never have achieved our freedom.

anzania Agriculture research Institute (TARI) has announced that farmers and agricultural stakeholders in the central corridor and western part of Tanzania have no need to travel over long distances in search for improved seeds, instead such high yielding varieties for various crop now available at TARI Tumbi centre in Tabora region.

The farmers and investors whose fields are in Tabora, Dodoma, Singida, Katavi, Kigoma and Rukwa can easily access the improved seeds at TARI Tumbi centre in Tabora region.

TARI Tumbi centre Acting director Dr. Emmanuel Mrema said the centre has thousands of metric tones of stock available for the 2021/22 agricultural

"The new high yielding varieties have been well researched and produced. They have been tested and adopted by our farmers and other stakeholders. On farm trials have proved beyond reasonable doubt that the improved seeds are better than those currently used by many farmers.

Citing an example, he said the centre has three maize varieties and hybrids which are well adopted in the central corridor and western part of the country. They also perform well in moderate drought areas. Yield per acre is around 20 to 25 bags and in most well fertile land like katavi and Rukwa the farmers can harvest up to 40 bags per acre.

He named other crops as cassava and orange fleshed sweet potatoes (OFSP).

"I encourage farmers to purchase the improved seeds because they are highly yielding. We hope that they will increase the yield and improve the standard of living.

Besides maize, the centre has several types of other perennial trees such as the improved mango and oil palm seedlings. We are developing these technologies from time to time to ensure that they we readily available to the farmers and we have enough stock, he said.

TARI director general Dr. Geoffrey Mkamilo explained that TARI has different technologies ranging from improved seed varieties to post harvest management throughout its centres scattered in the country.

The current priority of the Tanzania research institute is to scale up research, production, so that the farmers can achieve agricultural productivity, attain food and nutrition and spur the nation's economy

He said in this 6th phase government, the Ministry of agriculture high agenda on the table is to generate and promote application of knowledge, innovation and agricultural technologies to enable farmers and the nation achieve sustainable agriculture and ensure food security.

He urged the farmers to stop using poor seeds and traditional methods of farming. "I am making

The Ministry of agriculture under Prof. Adolf Mkenda want farmers and the nation transform agriculture, achieve sustainable agriculture and ensure food security.

"There are many technologies that have already been developed at TARI Tumbi Tabora. There are technologies for improved Maize, sorghum, cassava, oil palm and all these are highly yielding for the farmers, investors and other stakeholders in Tanzania.

He explained that normally the farmers get low yield because they are not using latest technologies. For example, most farmers end up getting only seven metric tones per hectare while such farmers if used improved cassava varieties developed by TARI such as TARICAS 4 and followed good agricultural practices could obtain up to 40 metric tons per hectare.

For sweet potatoes, the farmers using traditional methods and poor seeds end up getting 1.5 metric tones per hectare while TARI Tumbi Tabora has released sweet potato varieties that can give the farmer a better yield of up to 22 metric tones per hectare," he said.

TARI Tumbi Tabora has also released orange fleshed sweet potatoes that are rich in several vitamins. In Tanzania, nutrition is an issue of national importance because good nutrition is both a desired outcome for ensuring optimal human health, as well as a key determinant of development, for the individual and for society in general. According to TDHS, 2015-2016; more than one third (34%) of children under age 5 years are stunted (short for their age); 5% are wasted (low weight for height) and 14% are underweight (low weight for age). About 57% of children under 5 (age 6-59 months) and 45% of women of reproductive age (age 15-49 years) are

Micronutrient malnutrition also called hidden hunger falls in the category of undernutrition. Micronutrient malnutrition is caused by deficiencies of essential minerals and vitamins. The main essential vitamins and mineral deficiencies in Tanzania are Vitamin A, folic acid, vitamin B12, iodine, iron and zinc. Micronutrient malnutrition is problem of public health significance affecting a large number of children and women of child bearing age in Tanzania. To address micronutrient deficiency, TARI Tumbi Tabora has developed the OFSP, the nutrition that can be consumed directly as one eats the popatoes or its porridge.

Other strategies used is to promote nutrition education of orange fleshed sweet potatoes so that a many people can be reached.

All these technologies are available at TARI Tumbi Tabora to ensure they are adopted and used by the farmers and other stakeholders," he stressed.

How do you expect to stop war crimes with a request?'

rom Tigray, where the government is trying to choke us to starvation, the international system's dysfunction

I was lucky to get a data connection in Mekelle today, which enabled me to learn about reactions to political developments in Ethiopia. Getting a connection has become a rare luxury for almost ten months now, as Addis Ababa has cut Tigray out of all available infrastructure -from telecoms, to the electric grid, roads, and banking services - as it has used isolation as a weapon of its war.

Reading recent news coverage about Ethiopia left me with mixed feelings. On the one hand, the extent and accuracy of the coverage of the war amazed me. I salute the dedicated journalists and humanitarian workers who have risked their lives to cover the sufferings of Tigrayans. Some have paid with their lives, while so many others have suffered harassment and physical abuse while doing their jobs. I also thought of the sons, daughters, and friends of Tigray scattered throughout the world who have toiled to correct the narrative of the war. The solidarity you feel from being understood generates a sense of hope and adds fuel to the adrenalin of resistance. I would like them to know their efforts are well known to the suffering population of Tigray and well registered in its history of resistance.

On the other hand, I was disappointed to read about the insufficient actions of the international system. It seems there is consensus among international media and rights groups that the conflict in Tigray is not "a law enforcement operation", as the government initially labelled it, but a fully-fledged war. The Ethiopian and Eritrean armies, along with regional militias and special police forces, are known to have committed war crimes including the use of food and sexual violence as weapons of war. Intelligence reports produced by Western capitals have talked of ethnic cleansing and pointed to statements by government officials to suggest underlying genocidal intent. And yet, the actions of the international system add up to little.

Western governments, the UN, international rights groups, and various think tanks have been calling on the Ethiopian government to look for a peaceful resolution to the war and have repeatedly demanded that Eritrea pull its forces out of Tigray. Many have also called for the withdrawal of Amhara militias and said that any claims over land should be pursued through legal means. These may be the correct demands to make, but they have little impact on the ground. How can you expect humanitarian corridors to be opened, war crimes to stop, and accountability for atrocities simply by issuing a request? Didn't you establish that that government has genocidal intentions and has committed war crimes and crimes against humanity? Are they going to agree to

polite requests as though they were guests at a dinner party?

Dysfunctionality of the international

One can clearly see the deep dysfunctionality of the international system. From my reading, I can see that it is concerned with Ethiopia's territorial integrity and is inclined to support Prime Minister Abiy Ahmed as they claim not to see a viable alternative. The desire to maintain the status quo may be understandable, but how can you support the very entity that is ravaging the status quo instead of working towards an alternative solution?

Abiy has used every means to strangle the people of Tigray. He has denied the population humanitarian assistance, access to their bank deposits which they need to maintain their livelihoods, and means of communication to the outside world. What could this be if not a crime against humanity? Yet none of the international organisations, including the UN, has called them such and demanded the regime acknowledge these simple realities and repudiate them. Instead, it is welcome news when the government lets a few truckloads of aid pass through its blockade, the ensuing public congratulations letting Abiy off the hook

for his ongoing siege. In 2005, the responsibility to protect (R2P) was introduced as a principle of multilateralism at the UN. This principle recognised that states are obliged to protect their own people, and that if one was unwilling or unable to do so, this responsibility shifted to the international community. To their credit, some, such as the US and European Union, have attempted to weaken perpetrators of violence by suspending direct budgetary support to the Ethiopian government. The US has also said it will impose targeted sanctions on individuals responsible and recently placed financial sanctions on the chiefof-staff of the Eritrean Defence Force.

These are encouraging but fall far short of the Tigrayan people's expectations. Whatever impacts these measures might have had, the Ethiopian regime continues to choke the whole population of Tigray with the clear intention of pushing it to starvation and collapse. Access to humanitarian aid is still almost zero as the supply lines continue to be closed. Relief agencies have run out of supplies. All essential services are shut down, complicating the already precarious conditions in Tigray.

The Tigray Defence Forces (TDF) have continued their military operations to clear the genocidal forces out of Tigray and expand operations to central and eastern Ethiopia, par-

ticularly to the Amhara and the Afar regions, with the primary objective of opening a humanitarian corridor and forcing the government to negotiate. Eight meetings of the UN Security Council have failed to reach agreement on a common position, let alone a decision capable of arresting the violence. History is registering how countries and multilateral institutions are responding to the crisis. Tigrayans will remember some members of the UN Security Council for standing on their side. They will remember others, particularly the three African countries, for their reluctance to play their part in enabling the international system to deliver serious actions according to the principle of R2P.

African voices

I was lucky to read the recent open letter, signed by over 50 prominent Africa intellectuals and published on African Arguments, calling for urgent action in Ethiopia. I was pleasantly surprised by it as African intellectuals speaking with a collective voice has rarely been observed since the elimination of apartheid in South Africa. Yet while I fully understand the difficulty of reaching agreement and the need to find the lowest common denominator, particularly when the group gets larger, I thought the signatories could have done better.

I sympathise with their dismay over the failure to resolve the conflict peacefully, and I share their pain at the African Union's lack of effective engagement. I agree that its member states must not allow the Ethiopian government to dictate the terms of its engagement in seeking a resolution to the conflict.

However, I differ on some important observations. The TDF is not "expanding" the conflict to the rest of Ethiopia. From the beginning, this was a conflict involving all of Ethiopia, though the fighting was concentrated in Tigray. The African intellectuals' call rightly indicates the reasons for the TDF to move beyond Tigray. There are wars in Oromia, Benishangul-Gumuz, Kimant and other parts of the country. Various regional states have been under states of emergency administered by "command posts". The war in Tigray only came to be a major war because of its magnitude and genocidal intentions. But the fact that the TDF and Oromo Liberation Army (OLA) agreed to coordinate operations doesn't pose a new concern. Rather it is a new manifestation of an existing concern given the intransigency of the regime for the peaceful resolution of conflicts.

I also wish the call for the Ethiopian government and the government of Tigray was separated into separate demands, rather than calling on both parties to respond positively to calls for political dialogue, including with groups in the Amhara and Oromia regions. As far as I know, the government of Tigray has not only responded to repeated calls for talks but has made its own official calls for a peaceful resolution several times. It has already acted on the open letter's demand. By contrast, Abiy has not responded to any of the calls. When the TDF expanded its operations to the Amhara and the Afar regions, Abiy repeatedly made public statements reasoning that the incursions were made to force him to talk. He reaffirmed that he will never talk to an entity he calls "terrorist" but will instead destroy it so he can reassert his rule in Tigray.

Nevertheless, the African intellectuals' collective action is encouraging. And it is reasonable to hope the engagement will grow in quality and intensity. I am hoping the authors and signatories - and many others - remain seized by developments in Ethiopia and encourage the parties of the conflict to move to a peaceful resolution.

Govt, Huawei to empower women in ICT industry

How young female engineers sparkle at Geita Gold Mine

IT is a difficult puzzle why most young Tanzanian female graduates are so reluctant to enter male-dominated professions, especially in mining, engineering or geology. There are reportedly fewer female engineers in Tanzania compared to male engineers.

In 2018, the Engineers Registration Board (ERB) announced that Tanzania has a shortage of female engineers, which is holding back the country's develop-

In 2016, it was reported that although the first female engineers in Tanzania graduated in 1976, according to official statistics, only four percent of all registered engineers in Tanzania were women in 2009.

But under the Structured Engineers Apprenticeship Programme (SEAP), which aims to equip them with knowledge and experience to become professional engineers in a male-dominated field, there is at least a

The programme, run by Engineers Registration Board, Tanzania's professional body with financial support from the Norwegian government, has seen the number of female engineers in Tanzania more than double since 2010.

The demonstrable increase in the number of young female engineers has led to a rapid paradigm shift in the male-dominated scientific professions as most female graduates are now interested in scientific careers despite being discouraged and disappointed by men who still believe that women cannot take up challenging jobs, especially in the mining sector.

In a recent interview with Jesca Laswai, a mining engineer who works for the GGML underground mining contractor, African Underground Mining Services (AUMS), who cited passion, commitment and ambition as unique factors that drive some young female graduates to excel in mining careers.

"I do not think there is a specific profession for boys or men. If that were the case, we would not have seen so many talented young women setting world records," explains Eng. Jesca, a mining engineering graduate from the University of Dar es Salaam.

Jesca had a desire to explore the mining industry, saying: "It was not easy because soon after I decided to pursue a career in mining, most people close to me advised me against it, saying I was wasting my time and jeopardizing my family's future."

But Jesca says things changed after she chose this career, and she is now very happy doing what she does. "I want to encourage other young women and graduates of other colleges to believe that anything is possible on this planet. They should be aggressive and take up any profession, including mining. This mining career ensures my daily bread here in Geita through daily planning of mining activities in Nyankanga.

"I know few girls complete secondary education in Tanzania due to widespread poverty and the perception among parents that girls should carry out domestic rural areas where access to



duties.

"But if they are in school, girls have received little encouragement to pursue mathematics and science subjects, often considered the domain of male students," Jesca explains.

In the next ten years, Jesca sees herself as a successful mining engineer, and she is optimistic that she will reach that level, not only because she is being empowered, but simply because she is able to perform at the required level.

Tanzania is rich in natural resources, such as gold, diamonds, nickel, uranium, and natural gas. It is also home to one of the rarest gemstones in the world, Tanzanite, which is only found in Manvara region.

Despite these unique resources and booming economy, a Tanzania rank 152nd out of 182 countries in the Human Development Index, 134th out of 185 countries in favourable business environment, and has a per capita income of US\$652.

Approximately 70 per cent of the population lives in

facilities is limited or completely absent.

As a result, the country continues to face many socioeconomic challenges that are further compounded by high illiteracy and dropout rates, leading to an increase in unemployment.

The chairman of the ERB board, Eng. Ninatubu Lema more than 2,000 engineers are currently graduating from universities in the country every year, but only 800 of them are registered with the ERB, with more than 1,200 engineers disappearing into the unknown, leading to the presence of air engineers in the country.

He says the number of registered engineers in the country is 21, 742 of while 2,153 are women, which is equivalent to 10 percent.

He says the number of female engineers in the country has been increasing and that in 2010 their number was only 96 and so far it has reached 443, that is due to the efforts of the Norwegian country, which have been providing scholarships to female engineers.

Eng. Lema says despite having that number, it is small compared to the country's needs for engineers in the construction industry.

"Efforts should be increased to enroll students in universities, as the number of engineering students enrolled in universities is declining every year," says

He says the challenge facing the engineering profession is the shortage of engineers, budgets, human resources and finances.

However, he says Tanzania has been promoting the prosperity of giving more than 60 percent of students compared to Kenya and Rwanda.

Given these challenges, he says the government's policy of the sixth phase of industrialization is in dire need of engineers for the nation to achieve its goals and they have now launched a campaign to encourage students in schools to study science

UNESCO beefs up efforts to reduce GBV, HIV, unintended pregnancies in universities

HIGHER and tertiary education to a large number of sexually active young adults. It is frequently assumed that its students are well equipped with the education to avoid negative health outcomes such as gender based violence, early and unintended pregnancy as well as HIV/AIDS.

However, the latter are vulnerable to sexual and reproductive health and rights (SRHR) related concerns and risks. The situation is critical because while in college campuses, young people tend to navigate new responsibilities, relationships, and experiences on their

own and in an unfamiliar setting. Furthermore, students experience high levels of gender based violence. This is according to an online survey conducted by UNESCO in 2018 to enrolled university students where it indicated that 18% of female respondents in Zimbabwe and 27% in Tanzania had been forced to have sex at least once.

The disturbing findings could mean increasing vulnerability of female students to STDs, unintended pregnancy as well as HIV.

The situation has raised an alarm within rights bodies where mid this week stakeholders met for an inception meeting as part of the launch of the UNESCO - SIDA funded project titled Our Rights, Our Lives, Our Future, (O3 Plus).

The project will be implemented in 24 varsities and college campuses within the four countries including Tanzania.

UNESCO Head of Office and Representative Tirso Dos Santos mentions the main goal of the project as to reduce HIV infections, early and unintended pregnancy as well as gender based violence among young people in higher and tertiary institutions.

Dos Santos says more often than not students join higher learning institutions while mature and free from the constant guidance they received from either parents or guardians stressing that if left un-

checked, the trend could see them encounter challenges.

He stresses that if well impleinstitutions in the SADC region mented, the project will enable inclusive of Tanzania are a home students to reach their full educational potential and contribute more effectively to the development of their countries and region as graduates, professionals and young leaders.

In an immediate rejoinder, Evaristo Mtitu, Assistant Director, Higher Learning within the Ministry of Education, Science and Technology (MOEST) mentions the worrying trend based from the various statistics presented during the launch of an online course on comprehensive sexuality education supported by UNESCO at the

University of Iringa. "All statistics indicated the deterioration of health among youth on a yearly basis. The situation is caused by either poverty, lack of awareness or failure by institutions to provide opportunity to educate young people to behave well in a way that they can grow and acquire education without being infected by HIV, STDs or become victims of gender based violence and related behaviors," says Mtitu.

He hails UNESCO for its initiatives saying it helps the government efforts to ensure the education provided to youths result into production of educated and health people who will contribute to the social economic development of our community and the national at

For his part, Herman Mathias, National Programme Officer at UN-ESCO in Dar, says SRH outcomes, such as unintended pregnancies and sexually transmitted infections (STIs), immediately affect students' well-being and can cause disruptions in educational attainment.

He admits that while there has indeed been significant focus and investment in the region in recent years on increasing the provision of CSE in primary and particularly secondary schools, much less attention has been paid to the status of sexuality education and service provision within higher and tertiary education institutions.

Shocking jobless figures in South Africa make a basic income grant a social, moral and historical imperative

ppropriately funded and managed, with no wiggle room for state incompetency or corruption, a Basic Income Grant could finally lay the foundation for sustainable healing and justice in postapartheid South Africa. To those who say such a grant is unaffordable, the obvious answer is that South Africa can no longer afford not to.

A few days ago, Statistics SA announced that South Africa's unemployment rate had reached a record high of 34.4%, or a staggering 44% if we use the expanded definition of unemployment, which includes those who have given up looking for work.

More than 46% of young people under the age of 34 - and a staggering 63% of under-24s - are unem-

The simple fact is that our economy is unable to generate enough jobs to reduce and eliminate unemployment, which leaves millions of South Africans without any access to an income. It is physically impossible for any adult of employable age to live day to day, month to month and year to year without income.

Prioritising the implementation of a Basic Income Grant - or Basic Income Guarantee (BIG) - is a social, moral and historical imperative crucial to the sustainability of South Africa's constitutional democracy.

Appropriately funded and managed, with no wiggle-room for state incompetency or corruption, the BIG could finally lay the foundation for sustainable healing and justice in post-apartheid South Africa.

To those who say such a grant is unaffordable, the obvious answer is that South Africa can no longer afford not to.

Inequality was the overarching policy of apartheid and its colonial predecessors. The fact that inequality has deepened in post-apartheid South Africa is a shameful slur on the state, the governing parties, the business sector and all South Africans of social conscience and integrity.

Among the funding mechanisms that the state is duty-bound to consider are redistributive measures recommended by the Truth and Reconciliation Commission (TRC) 22 years ago.

Among the commission's key recommendations were that those to whom it did not give amnesty for apartheid-era human rights violations should be prosecuted (all being equal before the law), and that the state should implement a reparations policy.

Recognising that funding reparations were expensive - but nonetheless imperative in contributing to narrowing the "intolerable" inequality gap the commission proposed a number of redistributive measures.

None of the recommendations was implemented.

Commission chairperson Archbishop Desmond Tutu said later that the mood in the country created by its first democratically elected president. Nelson Mandela, was such that many businesses and individuals would have been happy to contribute to the reconstruction of the country. In a sense, it could also be a cathartic mechanism to pay something back in acknowledgement of the privilege they accrued under apartheid.

The archbishop referred to the unimplemented recommendations as the TRC's unfinished business.

Despite government's efforts to provide houses, security and comfort to citizens - the millions of fully subsidised homes that have been built and connections made to the water, sewerage and electricity grids - 22 years after the TRC published its recommendations, levels of poverty, joblessness and inequality have increased. Unsustainably so.

On top of deeply entrenched structural barriers to economic inclusion, the impact of the global Covid-19 pandemic has been devastating. According to the Business and Human Rights Resource Centre, social scientists from



five South African universities recently estimated Covidrelated job losses at three million, of which two million jobs were lost by women.

Nearly half the South African population is living in poverty, a burden that is disproportionately carried by women, with 74% of women-headed households living below the poverty level. Dismantling the deeply entrenched structures that created economic, social, spatial and environmental injustice will require all of our efforts. South Africa has a wellestablished social assistance programme - of cash transfers - but the programme makes no provision for able-bodied adults between 18 and 59 years, the assumed age of economic activity.

Their exclusion condemns many to live in intolerable conditions.

Section 27 of the South African Constitution guarantees every person the right to sufficient food and water and to "social security, including, if they are unable to support themselves and their dependants, appropriate social assistance".

It is in this context that the debate about the BIG must be understood. When an econo-

my is unable to provide enough jobs for people to earn an income and take care of themselves financially, then the state has a duty to provide relief.

It is not a gift or a handout; it

In response to the economic turmoil occasioned by the Covid-19 pandemic, the state introduced a temporary Covid-19 Social Relief of Distress Grant of R350 per month. Payment of this grant has been extended to March 2022. It's far from perfect, and hardly sufficient to keep the wolf from the door, but it is helping nearly seven million beneficiaries.

The first step on the road to a BIG is to continue to provide the social relief grant of R350 per person per month and expand access to whoever applies for it.

But we must recognise this grant for what it is: A commendable state response in an economic emergency wrought by a health pandemic - a Band-Aid to stem the flow of blood from a gaping wound.

The next step must be finding the means to address legitimate concerns about universality, quantum and affordability.

The benefit of the grant being universal - that is, available to every adult regardless of their personal financial circumstances - is that it reduces the barriers to access for those who need it most by reducing systemic errors. But extending the grant to all, including those who don't need it, will add to the financial burden on the state.

International Growth Center proposes that "transfers should be made universal or accessible on an opt-in basis (i.e. beneficiaries self-evaluate their eligibility), where feasible to try to reach as that meets, at the very many in need as possible". least, the upper-bound

If the new minister of finance follows through on the plan to introduce zero-based budgeting - a budgeting process aimed at reducing wastefulness and identifying absolute spending priorities - then this would free up significant cash. Correctly implemented, it would place the BIG into the budget as a non-negotiable expense and build the rest of the budget around it.

Secure access to sufficient food and water is the most basic of needs of every human being. It should be budgeted for before anything else.

According to the Institute for Economic Justice, eliminating government waste would save about R20-billion. This is a very conservative figure when you consider that State Capture is said to have cost the South African people about R500-bil-

If properly prioritising the budget falls short of the BIG funding need, tax mechanisms must be considered. It is here that the TRC's recommendations come into focus. The Institute for Economic Justice estimates that a wealth tax of 1% on the top 1% of earners in South Africa would bring an additional R63-billion in revenue.

Finally, it should go without saying economic growth that creates jobs is the pathway we are all looking for. Championing and supporting a BIG not equate to giving up on an economy that grows inclusively and gives every adult, of employment age, the opportunity to earn a decent wage and experience a life which is fulfilled by meaningful employment.

The money spent on the BIG will not be lost to the economy. It will be spent by the recipients in the economy and contribute back to our revenue through VAT and taxes.

UK's Tesco keeps ban on Kakuzi avocados

NAIROBI

Britain's largest supermarket chain, Tesco is yet to reinstate avocado supplies by Kakuzi as it presses for compressive human rights reforms by the Murang'a-based agriculture firm.

The British retailer on October 11, 2020 temporarily dropped Kakuzi as its supplier of avocados pending investigations into alleged assault and sexual misconduct by some of its employees. The ban stands nearly a year later, even as sources told the Business Daily that Tesco pressed for deeper reforms to safeguard the rights of workers and the communities living around the Kakuzi

Through its Kent-based parent Camellia Plc, Kakuzi has been sued over the alleged human rights violations by its employees- which it has denied. The UK-listed company Camellia owns 50.7 percent of Kakuzi.

Law firm Leigh Day said that 79 Kenyans had launched a legal claim in the High Court in London against Camellia for alleged human rights abuses by security guards employed by Kakuzi, its Kenyan subsidiary. The allegations, dating from 2009 to January 2020, include rapes, attacks on local villagers, and a man being beaten to death, Leigh Day said. The Nairobi Securities Exchangelisted Kakuzi this week pledged to accelerate human rights reforms to comply with international standards.

"We are taking any issues on human rights extremely seriously," Wilson Odio, the Kakuzi assistant general manager in charge of corporate affairs, told the Business Daily in an interview on Wednesday. "We are cognizant of the fact that going forward businesses will more and more have to observe human rights in the course of their operations. Kakuzi does not in any way entertain human rights abuse of any sort." Dr Odio cited some recently instituted measures to address the claims.

They include the employment of a manager in charge of human rights is-

sues, an audit by a global firm on the impact of its operations on human rights. and the establishment of a dedicated operational-level grievance reporting mechanism that will provide multiple avenues through which our employees and the community can raise issues they would like the company to ad-

Kakuzi has also appointed former Attorney-General Githu Muigai to chair the company's newly created Independent Human Rights Advisory Committee (IHRAC) that will provide technical advice to the board of directors.

"They have already started working. Their work is to advise Kakuzi on human rights issues," said Dr Odio. Camellia said earlier it would take remedial measures and undertake governance reforms, and encourage its subsidiaries to do the same with an aim of better handling potential future abuses.

The measures include funding of charcoal kilns and access to firewood, building two social centres for community meetings, and employing predominantly female safety marshalls on Kakuzi's farm "to give visible reassurance to those using access routes and particularly women." Dr Odio said Wednesday, Kakuzi has built new roads to give community residents better access to local amenities and hired some as marshalls.

"We are doing what we have to do ensure that where there are human rights issues, they are addressed," Dr Odio said. Camellia and its local subsidiary are trying to win back the confidence of customers in Europe who value ethical corporate behaviour nearly as much as the quality of produce.

The programme which targets to reach and support 50,000 farmers through at least 50 cooperatives, is informed by the fact that digital technology can improve the operation of key supply chains in the food system through greater agricultural efficiencies, improved business practices, traceability, food safety and, access to finance.

However, the use of digital tools in Africa's agriculture sector remains limited, often because of infrastructure, affordability, awareness, and regulatory issues. Agribusiness contributes about 25 percent of Africa's GDP and 70 percent of its employ-

"Microsoft 4Afrika's strategy is to invest in agri-tech to unlock Africa's vibrant potential, accelerating innovation in agri-tech to enable datadriven farming that can optimise

yields, boost farm productivity and increase profitability - all while feeding a nation," Nderitu added.

Around 155 million people were facing acute food insecurity in 2020 across 55 countries or territories, an increase of around 20 million people from 2019, according to the 2021 Global Report on Food Crises. Of the 10 countries with the highest number of people facing food insecurity, six were in Africa.

Digital technology is one way to boost agricultural production and efficiencies. The partnership will include Microsoft's KuzaBot mobile chat platform, which will speed and ease the dissemination of vital information to farmers on good agricultural and business practices.

IFC's Agribusiness Leadership Program, which will be available on the Microsoft Community Training platform, will help small businesses, aggregators, and farmer cooperatives improve their professionalism, productivity, and creditworthiness.

Eskom CEO says carbon capture being considered in SA

JOHANNESBURG

Eskom, South Africa's biggest emitter of greenhouse gases, is evaluating the use of carbon capture at power plants as part of decarbonisation plans to transform the coal-

The process that captures carbon-dioxide emissions would need to be financially viable, Chief Executive Officer Andre de Ruyter said in an interview on radio station 702 on Friday. "We need large geological structures to ensure that the CO2 is captured and stored safely so it cannot escape," De Ruyter said. Transportation of the emissions is also complex and costly, he said.

State-owned Eskom generates most of South Africa's electricity from coal. The utility, which reported a fourth straight annual loss earlier this week and is struggling to deal with a mountain of debt, is turning to renewable energy to lower emissions and potentially receive better financing terms. That shift will also affect the nation's coal mines and the communities that surround them. Manufacturing renewable-energy

components would be part of a strategy to create about 300 000 jobs, De Ruyter said in the interview, citing studies by a national business initiative.

Eskom's biggest labour group, the National Union of Mineworkers, is skeptical of the estimate. "We don't believe that," said Khangela Baloyi, energy sector coordinator for the union, in a response to questions. De Ruyter's estimate of jobs in the renewable industry would, if realised, make it bigger than South Africa's platinum and gold mining industries, which combined employ

almost 260 000 workers.

Meanwhile Private healthcare group Mediclinic International Plc said on Friday its southern Africa division had agreed to procure renewable electricity through Energy Exchange in a deal worth up to \$152 million (R2.1 billion).

Procuring renewable energy, specifically electricity, forms part of the group's strategy, which has set an ambitious target to become carbon neutral by 2030, South Africa's biggest private hospital group by market value said. South Africa, the continent's

worst polluter, emits millions of tonnes of carbon dioxide into the atmosphere each year, much of it from coal-fired power plants that still provide most of its energy.

Climate considerations have become a greater concern for investors, with some pulling out of local multibillion-dollar coalfired power plant projects and halting direct funding. Companies are also trying to curb their reliance on ailing state utility Eskom, which regularly implements electricity



to affordable and long term financing," the EABC chief said.

Rwanda, IFC ink deal to boost prospects for vaccine manufacturing

KIGALI

Rwanda says it has signed a collaboration agreement with the International Finance Centre to boost its vaccine manufacturing capacity and also contribute to expanding production on the continent.

Under the deal, IFC will support Rwanda to conduct diagnostic and feasibility studies to ensure the right technical and policy frameworks needed to establish a worldclass vaccine manufacturing supply chain in Rwanda are in place.

According to a Rwanda Development Board (RDB), the partnership follows a recent development with BioNTech and the kENUP Foundation to explore establishing end-toend manufacturing capability for mRNA vaccines.

Other potential vaccine and pharmaceutical production facilities, including a fill-and-finish facility, are expected to be co-located with BioNTech in the Kigali Special Economic Zone. Africa depends on other countries for 99 per cent of its vaccine supply.

The African Union and the Africa Centres for Disease Control and Prevention are aiming to have 60 per cent of Africa's routine vaccines produced locally by 2040. Africa CDC has identified Rwanda, Senegal, and South Africa as potential regional vaccine manufacturing hubs in Africa.

"Rwanda aims to produce highquality vaccines for the African market. A production facility like

the one envisaged in this collaboration agreement advances this objective. We are pleased to have IFC as a strategic partner," noted Zephanie Niyonkuru, the Deputy CEO of RDB.

The move, according to Samuel Dzotefe, IFC's Acting Regional Industry Director for Manufacturing, Agribusiness and Services in the Middle East and Africa, is a vital step. "A resilient Africa needs to develop and maintain its own reliable vaccine supply and health indus-

He added, "This partnership with the Rwanda Development Board is a vital step toward helping Africa build vaccine manufacturing capacity to respond to Covid-19 and future pandemics." The World Bank Group has been scaling up support

to countries to produce, acquire and deliver vaccines, particularly in Africa.

To support this work, IFC is working with governments and the private sector to support pharmaceutical and related vaccine manufacturing projects. Rwanda has recently stepped up its vaccination efforts where everyone above the age of 18 can now receive the vac-

The government plans to vaccinate 60 per cent of its 12.9 million population (or 7.8 million people) by June 2022. And according to health practitioners, based on the current pace of vaccination, 30 per cent of the population, especially from urban areas, will be vaccinated by early 2022.

WhatsApp slapped with second-largest fine over data protection

BRUSSELS

nstant messaging and VOIP service WhatsApp has been hit with a whopping .€225m fine after Ireland's privacy watchdog found it had breached EU data protection rules. The announcement wraps up an investigation that began in December 2018, after the General Data Protection Regulation (GDPR) rules. took effect.

This is the largest fine ever from the Irish Data Protection Commission, and the second-highest under EU GDPR rules. Topping the list, Amazon was fined a record €746 million fine for processing personal data in violation of GDPR rules at the end of July.

An investigation by the watchdog

found that WhatsApp broke strict regulations in relation to transparency of data shared with other companies also owned by parent firm Facebook, which bought WhatsApp in 2014 for approximately \$19bn. In addition, the Irish Data Protection Commission yesterday it was ordering WhatsApp to take "remedial actions", to ensure its processing complies with EU

The commission said the case against WhatsApp looked at whether Facebook followed GDPR requirements to be transparent for both users as well as those who didn't use its service, including how people's data is processed between WhatsApp and other Facebook companies, including Instagram. WhatsApp said it disagreed with the decision, as the fine was disproportionate, and said it planned to appeal.

The instant messenger company said it is committed to providing a secure and private service. "We have worked to ensure the information we provide is transparent and comprehensive and will continue to do so."

Ilia Kolochenko, founder of ImmuniWeb and a member of Europol Data Protection Experts Network, believes that Facebook will appeal the ruling, and the fine will be significantly reduced in court as has been seen with other major cases.

"The judicial process to get a final and enforceable decision will likely take several years. It's very unlikely any Europeans, whose privacy rights were allegedly violated by WhatsApp, will get any compensation."

He adds that privacy experts argue that GDPR does not serve its initial purpose of being a consistent pan-European privacy legislation that is capable of protecting personal data and detering privacy violations.

"Given the growing disagreement between European DPAs on GDPR enforcement priorities and imposition of penalties, these concerns become even more real today. Moreover, data subjects are reluctant to enforce their rights under GDPR as it's always time-consuming and may require a complex and costly process to litigate for penny compensation if any." Kolochenko adds that GDPR is comprehensive and balanced, but its enforcement lacks teeth, and without an overhaul, impunity for GDPR violations will become the norm.

Turkish lira slips as inflation jumps above interest rate

ANKARA

Turkey's lira fell up to 0.8% on Friday after inflation jumped more than expected and above the country's key interest rate, leaving the central bank in a tricky situation amid President Tayyip Erdogan's calls for a rate cut.

Turkish inflation hit a fresh twoyear high of 19.25% year-on-year in August, data showed, exceeding a rate of 19%. The lira retreated from near four-month highs, last trading at 8.33 to the dollar. The currency is down nearly 11% this

Danske Bank's head of EM research Iakob Christensen notes it is not all bad for the central bank, given core inflation fell slightly. The central bank will likely keep the benchmark rate unchanged at its meeting on Sept. 23 unless a substantial lira weakening forces it to hike rates, he said.

A hike in rates runs the risk of political backlash, which could prove even more detrimental to market sentiment, said Monex Europe's FX analyst Simon Harvey. Other emerging market currencies awaited U.S. non-farm payroll data due later in the day to speculate about the probable timing for stimulus tapering by the U.S. Federal Reserve.

South Africa's rand and Brazil's

as EM currencies are likely to be sold-off in the next three months amid tapering fears, a Reuters poll showed. South Africa's rand rose 0.3%, while gains Russia's rouble were capped by the country's service sector contracting for the first time this year in August.

The Chinese yuan gave up gains that sent it to one-month highs after a disappointing services activity survey, while India's poll forecast of 18.7% and pushing rupee moved further away from above the central bank's policy near three-month highs as rising COVID-19 cases clouded a return to growth in its dominant services sector in August.

Another Reuters poll showed Poland's zloty set to bridge the lag with central European peers as chances grow that Poland's central bank will catch-up with peers in lifting interest rates. EM shares inched higher towards sixweek highs as gains in most parts of Asia offset declines in China and elsewhere. Main indexes in Turkey, Russia and Poland fell between 0.2% and 0.4%.

Shares in emerging markets fund manager Ashmore Group slumped 5% despite reporting a 28% jump in full year profit before tax. The company's core earnings and net revenues fell. Mark Crouch, an analyst at multi-asset investment platform eToro, added the ongoing poor performance of EMs in the wake of the coronavirus pandemic cannot be discounted.

Secretary-General Antonio Guterres on Friday thanked several member states for helping keep UN operations in Afghanistan going as the country is facing a food insecurity and malnutrition crisis.

"I can tell you that the secretary-general is indeed very grateful for the generosity of member states, including Denmark, Kazakhstan, North Macedonia, Pakistan, Poland, Qatar, the United Arab Emirates, and the United States, which have made available facilities and arrangements in

support of continuing UN operations in Afghanistan," said Stephane Dujarric, Guterres' spokesman.

With their offers and commitments, they have made a great contribution to the safety and security, operational delivery, and overall continuity of UN activities, said the spokesman.

The UN operations in Afghanistan have suffered disruptions owing to the fast pace of political change, which resulted in the collapse of the government and the Taliban's return to power.

UN humanitarians on Friday warned that Afghanistan is facing a food insecu-

rity and malnutrition crisis.

A third of the population, or more than 12 million people, are acutely food insecure and their situation is expected to be greatly worsened by the drought, which has impacted a third of the country, said the UN Office for the Coordination of Humanitarian Affairs (OCHA).

Already, more than half of children under 5 are expected to face acute malnutrition -- a life-threatening condition requiring specialized foods and medicines to prevent death and mitigate sickness and life-long consequences, it said.

As an economic crisis looms, job opportunities also remain limited across the country.

The 2021 harvest is expected to be below average and the next lean season is expected to be more intense and arrive earlier.

Agricultural labor activities are estimated to have reduced by a third, it said. There is also a need to address water scarcity to prevent displacement and reduce hunger.

Nine million people were in need of water, sanitation, and hygiene assistance at the beginning of 2021, said OCHA.

In the first six months of the year, the United Nations and partners provided food and livelihood assistance to more than 5.5 million people, many of whom are in drought-affected areas. But much more is needed.

In certain parts of the country, the full effects of the drought are yet to be felt. In the last months, many farmers have been unable to access their fields due to conflict at critical times for planting and harvesting, it said.

Rwanda Chamber of Women Entrepreneurs has been selected to host and implement the activities of the SheTrades Hub.



According to Muinde, West Africa had been identified as a trading hub for hundreds of endangered species like snakes, parrots, scorpion, tortoise and amphibians.

"There is a need to review legal wildlife trade since it has raised major conservation and public health concerns. Africa is facing the risk of an ecological and economic crisis if wildlife trade is not regulated," said Muinde.

Statistics from International Union for Conservation of Nature (IUCN) indicate that global wildlife trade is worth about 42 billion U.S. dollars while 1.5 million live animals had been traded in the recent past.

Edith Kabesiime, Wildlife Campaigns manager at World Animal Protection, African Office said that aviation, shipping industry and social media have a responsibility to support global efforts to halt illegal trafficking of wildlife.

She said that transporting live animals in an unsanitary environment is a cruel practice that has also worsened the risk of pathogens' transmission to Xinhua humans.

Delta variant of COVID-19 in US adds hospitalisations, nips events, devours social benefits

THE raging Delta variant of COVID-19 continues to bring more people, including many children, into U.S. hospitals, and force cancellations of college enrollments and social events, in addition to disrupting Americans' daily life and eroding their long-term welfare.

Trustees for the U.S. Social Security trust fund in an annual report released on Tuesday said that the program is expected to pay benefits that exceed its income in 2021, the same as it anticipated last year at the outset of the pandemic.

While the pandemic had a significant impact on the program, the trustees said, they expect Social Security's reserves of 2.9 trillion U.S. dollars to be depleted by 2034, only one year sooner than they estimated in their April 2020 report. "Once the reserves are exhausted, benefits would be reduced automatically unless Congress steps in to shore up the program," reported The Wall Street Journal.

As COVID-19 cases surge across the United States, particularly among unvaccinated Americans, hospitals have been pushed to their limits treating the influx of patients. Five states, namely Alabama, Georgia, Texas, Florida and Arkansas, are nearly out of ICU beds, having less than 10 percent left of their ICU bed capacity, reported CNN on Tuesday.

"Hospitals around the country have been stretched as cases have picked back up, but the South, where vaccinations have been lagging, has been particularly hit. Many hospitals have been reporting oxygen shortages," said the report while quoting data from the Department of Health and Human Ser-

On Monday, data presented by a vaccine adviser from the U.S. Centers for Disease Control and Prevention (CDC) showed a hospitalization rate 16 times greater in the unvaccinated population caused by the Delta variant. The call was rolling students who have not

Last week, the CDC also highlighted the potential danger for children under the age of 12, the only group in the United States ineligible for coronavirus vaccines as the hyper-infectious Delta variant tears across the country. In the Atlanta area, thousands of positive cases were confirmed in schools with 23,000 students and staff have been quarantined. "Without concerted efforts to curb Delta's transmission, things are likely to get worse in coming

A simulation posted this month by a CDC-funded lab predicted that in elementary schools without either masks or regular testing, more than 75 percent of children might be infected with the coronavirus in the first three months," reported The Washington Post.

Study: Moderna makes twice as many virus antibodies as Pfizer

NEW YORK

MODERNA Inc.'s COVID-19 vaccine generated more than double the antibodies of a similar shot made by Pfizer Inc. and BioNTech SE in research that compared immune responses evoked by the two inoculations.

The study is one of the first to compare levels of antibodies produced by the two vaccines, which are thought to be one of the important components of the immune response.

It didn't examine whether the antibody differences led to a difference in efficacy over time between the two shots, which both were more than 90 percent effective in final-stage clinical trials.

The research looked at antibody levels against the coronavirus spike protein in about 1,600 workers at a major Belgium hospital system whose blood samples were analyzed 6 to 10 weeks after vac-

The participants hadn't been infected with the coronavirus before getting vaccinated. Levels among those who got two doses of the Moderna vaccine averaged 2,881 units per milliliter, compared with 1,108 units per milliliter among those who received two Pfizer

The results, published Monday in a letter to the Journal of the American Medical Association, suggested the differences might be explained by the higher amount of active ingredient in the Moderna vaccine – 100 micrograms, versus 30 micrograms in Pfizer-BioNTech – or the slightly longer interval between doses of the Moderna

TANZANIA's representatives at the just ended Tokyo Paralympics are set to arrive in Dar es Salaam on Thursday, Tanzania Paralympic Committee (TPC) disclosed.

And on Thursday morning, athlete Sauda gave her all and settled for the 19th position in Women's Shot Put with 4.18m.

Namkoveka revealed: "Our athletes performed badly at the Tokyo Paralympics, they will depart from Japan on Wednesday and arrive in the country on Thursday morning."

"For now, it is too early to issue the reasons for the poor performance by the two, we are waiting for the coach (Bahati Mgunda) to give us his report," he said.

France drew their fifth successive match as Anthony Martial scored his first international goal in five years to earn Didier Deschamps' side a point

The Manchester United forward, who missed Euro 2020 with a knee injury, grabbed just his second goal in 29 caps to cancel out a magnificent first-half strike by Ukraine midfielder Mykola Shaparenko.

"Once the first goal went in we played in a much more relaxed manner and produced some very good football," said Van Gaal, back for a third spell in charge of the Netherlands.

IFA last week published definitive report that stands as a comprehensive review of the last decade's international soccer transfers, and the trends and statistics revealed make for fascinating reading.

The report into account every single transfer to have taken place worldwide in the men's senior professional game in the decade between 2011 and 2020 -- 10 years during which the world transfer record increased by almost 150%.

The period in question unprecedented growth for football, especially in terms of finance as more and more clubs spent more and more money on transfers.

The report confirms that transfer market activity increased fairly consistently since 2011, when 11,890 transfers took place around the world. This swelled to a peak of 18,079 transfers in 2019. Overall, a total of 133,225 international transfers and loans have been completed during the span taken into account as part of FIFA's 10-year report.

international transfers permanent and loans between 2011 and 2020 are included in the figures, though returns from loans -while technically logged by FIFA as a separate transfer -- are excluded from the analysis so that any individual loan move is only counted once.

Here are the key things we learned from scouring through the report (in which FIFA expresses all transfer fees in U.S. dollars, so we've followed suit, using Transfermarkt for consistency).

*Overview

- **1.** A total of \$48.5 billion was spent on transfer fees between 2011 and 2020 (approximately €40.9bn/£35.1bn). 2. A grand total of 200
- FIFA member associations were involved in international transfers, which is all the impressive given that there are only 211 member associations in total. Should you be curious, the 11 member associations that did not release any players for international transfers were American Samoa, Anguilla, Bahamas, British Virgin Islands, US Virgin Islands, Montserrat, Liechtenstein, Papua New Guinea, Tonga, Cook Islands and Sao Tome & Principe -- all small territories with very small populations.
- **3.** Of the 133,225 international transfers and loans to take place, a total of 8,264 different clubs have been involved. The top 30 clubs (in terms of transfer fee expenditure) are all European and hail from just 7 FIFA member associations: England (12 clubs), Spain and Italy (five Germany (three), France and Portugal (two each),



and Russia (one). Those clubs alone spent a total of \$22.8bn (roughly £16.5bn) on transfer fees, which represents 47% of the global total over the decade in question.

*The Clubs

- 4. Manchester City have spent more money on transfer fees than any other club in the world between 2011 and 2020, spread over 130 international transfers made in that period. Kevin De Bruyne (\$83.6 million Wolfsburg), from Ruben Dias (\$74.8m from Benfica), Joao Cancelo (\$71.5m from Aymeric Juventus), Laporte (\$71.5m from Athletic Bilbao) and Rodri (\$68.9m from Madrid) Atletico the biggest international arrivals on City's books, but there are lots more nestled around the \$40-60m mark.
- **5**. Premier League rivals Chelsea are second despite having only made 95 internatransfers, of tional which Kai Havertz's \$88m arrival from Bayer Leverkusen is the most expensive, ahead of Kepa Arrizabalaga and Alvaro Morata (both \$88m, from Athletic Bilbao and Real Madrid respectively). The top 5 is fleshed out by Barcelona (79 transfers), Paris Saint-Germain (59) and Real Madrid (55).
- **6**. There are a total five Premier League clubs -- City, Chelsea, Manchester United, Arsenal and Tottenham Hotspur -- inside the top 10, with Liverpool (14th) Leicester City (20th), Southampton (21st), Wolverhampton Wanderers (25th),Everton (27th), West Ham United (28th) and Newcastle United (30th) all making the top 30.
- 7. Manchester City have also sent more players out on loan (232) than any other club in the world, narrowly ahead of Chelsea fabled and their loan army, who have allowed 207 players to leave the club on nonpermanent transfers. A whopping 19,826 international loans of professional players were conducted between 2011 and 2020, equating to an average of 14.8% of transfers in total.
- **8**. Four of the top five spending outside of Europe hail from the Chinese Super League, with Guangzhou Evergrande topping the list. Al Hilal of Saudi Arabia are the only non-Chinese club in the top 5. Evergrande outspent their CSL rivals by bringing in the likes of Paulinho (twice: \$15.4m from Tottenham

\$46.2m from and Barcelona) Jackson Martinez (\$46.2m from Atletico Madrid) with significant fees in recent years. That said, Shanghai SIPG's deals for Brazilian pair Hulk (\$61.38m from Zenit St Petersburg in 2016) and Oscar (\$66m from Chelsea in 2017) are the only two transfers involving a Chinese club that are big enough to make it into FIFA's top 70 biggest international transfer fees of the decade (more on that

- below). 9. The number of clubs prepared to spend more than \$50m on transfers per year more than trebled between 2011 and 2020, from just nine to 28. In the same period, the average number international transfers made by a club stands at roughly 4 per year (3.9 to be precise).
- **10**. The average annual international transfer fee fluctuated from a low of \$300,000 in 2010 to a record high of \$410,000 in 2018 -- the year Cristiano Ronaldo moved from Real Madrid to Juventus for \$128.7m. The average annual transfer fee paid by clubs in the top 30 (in terms of transfer fee spent) is considerably higher, ranging from a decade low of \$7.4m in 2012 to a peak of \$17.8m in 2018.
- international transfers than any other club in the Top 30, with 167 such deals struck. The Portuguese giants also recouped more money than any other club having overseen 311 outgoing international transfers and loans. Joao Felix (\$139.92m to Atletico Madrid) and Renato Sanches (\$38.5m to Bayern Munich) are the two biggest fees received by Benfica in the last decade, while Ruben Dias' move to Man City (\$74.8m) also makes the top 70. Staying in Portugal, fellow compatriots Sporting Lisbon are second on the list (226 outgoing transfers) of total fees recouped while Barcelona (106 transfers) are third despite the financial quagmire they cur-

end the decade with a positive net balance from international transfer fees paid and recouped are all Portuguese. Sporting top the list, while Benfica are second and Porto are just behind in third. The highest non-Portuguese club on the list is Ajax in fourth (thanks to the departures of

Matthijs de Ligt and Frenkie de Jong in particular), French side Lyon complete the top 5. Together, Portuguese clubs made more international transfer fee profit (\$2.95bn) in terms of positive net balance than any other country between 2011 and 2020. How much of that is directly due to the influence of Portuguese "super agent" Jorge Mendes,

13. In terms of individual FIFA member associations and their international transfer spending, nobody has spent more than clubs affiliated to the English FA. English clubs have spent \$12.4bn on players between 2011 and 2020, more than double the total outlay of the next nation on the global list -- Spain with \$6.7bn. Italy (\$5.6bn) are third, Germany (\$4.4bn) are fourth, and France (\$4bn) are fifth as Europe's "Big Five" leagues domiproceedings. However, it is perhaps

On the opposite side of the equation, some 6,500 English players were released for international transfer between 2011 and 2020 -- a total only topped by Brazil, who saw 7,300 players leave for foreign clubs.
 - **15.** Teams affiliated with the Spanish FA have recouped the most total money (\$6.2bn) from international transfer fees in the same time, a considerable wedge of which was raised

- by Neymar's worldrecord move Paris Saint-Germain in 2017, which saw Barcelona receive a \$244.2m transfer fee for the Brazilian. - (\$4.2bn). 16. The two member nations to see the highest amount of players move between them was the prolific stream between Brazil and Portugal (1.556 transfers), though only 934 players moved back the opposite way.

- 17. A grand total of 66,789 players have been involved in international transfers around the world between 2011 and 2020. The majority have been Brazilian nationals moving to foreign clubs (15,128 transfers) which represents 11.4% of the total number of players transferred over the decade. Argentine players (7,444 transfers) are second in the breakdown, while British players (5,523) are third. U.S. players are ranked 20th overall with 1,825 transfers, just below German (1,916 transfers) in 18th and Italian (1,891 transfers) in 19th. All in all, a total of 204 different nationalities are represented among the players transferred.
- **18**. FIFA have compiled a Top 70 biggest international transfers (ranked by total transfer fee) which sees Neymar lead the way thanks to his \$244.2m move between Barcelona and Paris Saint-Germain in 2017. The fee was more than double the previous world record for a transfer, set the previous year when Paul Pogba left Juventus for Manchester United, and the result has been the marked upturn in total transfer spending we saw the following summer and the years since.
- 19 . Angel Di Maria features twice in the top

10 thanks to his hefty back-to-back transfers between Real Madrid and Manchester United (\$82.5m, 2014) and Manchester United to Paris Saint Germain (\$69.3m, 2015). Several other players feature twice inside the Top 70, for instance Rodriguez James (\$49.5m from Porto to Monaco, \$82.5m from Monaco to Real Madrid), Leroy Sane (\$57.2m from Schalke to Man City, \$49.5m from Man City to Bayern Munich) and Alvaro Morata (\$72.6m from Real Madrid to Chelsea, \$38.5m from Chelsea to Atletico Madrid).

- **20.** Kepa Arrizabalaga (\$88m from Athletic Bilbao to Chelsea, 2018) is comfortably the most expensive goalkeeper in the Top 70 and ranks 16th overall, nine places above Alisson (\$68.75m from Roma to Liverpool, 2018), his closest rival. The most expensive defender on the list is Lucas Hernandez (19th) courtesy of the French left-back's \$88m transfer between Atletico Madrid and Bayern Munich in 2019.
- **21.** More cumulative transfer fees (\$7.1bn) have been spent on Brazilian players between 2011-2020 than any other nationality. Of course, Neymar (\$97.02m from Santos to Barcelona in 2013, and \$244.2m from Barca to PSG in 2017) has accrued more individual fees than any other Brazilian, though Philippe Coutinho (\$148.5m to Barcelona), Arthur (\$79.2m to Juventus) and Alisson Becker (\$68.75m to Liverpool) have all made sizeable contributions of their own. French players are second (\$4.5bn) and Spanish players are third (\$3.7bn) while British players are down in 10th with a total of \$1.3bn.
- **22.** Of the Top 70 most expensive international transfers, almost half of the transfers involved (32) were players signed by Premier League clubs. The chasing pack are as follows: Spain (18 transfers), France (7), Italy (6), Germany (4), China (2) and Turkey (1, which was Bruma's move from Sporting to Galatasaray in 2013). When it comes to clubs releasing players for international transfers, Premier League teams were only involved in 12 of the Top 70 transfers between 2011 and 2020.

On 99 with the scores level, he managed to pull off the feat with an uppercut for six over backward

Another run Shoaib subtracted from the target got Hemraj back on strike during the 14th. Despite there being no margin for error, Hemraj struck a boundary and a single to end the over on 99.

It ensured he'd be on strike at the start of the 15th over as tension continued to build in the smaller scale drama between the wickets after all life had been sucked out of the wider contest much earlier.

Hemraj sliced a full toss to short third man off Young to begin the 15th over and set off for a panicky single before being rightly sent back by Shoaib.

But all the nervous energy dissipated moments later when Young served up a short ball well outside off that Hemraj leapt off his toes to dispatch over the off side rope, cementing a thrilling individual achievement as well as putting the final nail in the coffin of a lopsided match.
