

Mkulazi Sugar plant machines: CAG questions TanRoads role

CONTROVERSY is simmering over how the Tanzania National Roads Agency (TanRoads) was awarded the tender to purchase and install the sugar plant machineries at the Mkulazi Sugar Factory project in Morogoro Re-

On the basis of the annual report tabled in the National Assembly last week by the Controller and Auditor General (CAG) this sitution has caused delays in the implementation of the project, with the tender showing a lack of transparency.

Procurement of sugar processing machinery was the key link in a loss making project financed by money from the National Social Security Fund (NSSF), which puts in peril the ability of the fund to pay eligible members if their contributions will have been put to loss making investments.

The report that has since been put to public scrutiny, CAG Charles Kichere says NSSF holds 96 per cent of stakes and the Prisons Department four per cent, with the investment involving two sugar production projects, at Mkulazi and Mbigiri areas for 250,000 tonnes of sugar annually

The Mkulazi Co. amended strategic plan for 2020/21-2025/26 shows that the Mbigiri Project was expected to start sugar production in the 2021 season with 15,234 tonnes expected by this year, the report noted.

Many dispensaries lacking equipment, staff - MPs

THE GOVERNMENT must

fully equip existing dispensaries and health centers and ensure they have workable staffing levels, members of Parliament appealed yesterday. Debating the 2022/2023 budget estimates for the President's Office (Regional Administration and Local Governments), several lawmakers said the government has to provide the health facilities with equip-

ment, enabling them to operate as intended. MPs also decried the shortage of health workers, such that the good work done in building health facilities would be stymied if the two challenges are not solved

Stanslaus Mabula (Nyamagana) demanded why the government is putting up more facilities while existing ones are not well equipped. "Why build more dispensaries and health centres while people still

have to travel in search of treatment, due to lack of equipment in health facilities nearby?" Plans to build over 300 dis-

pensaries and 100 health centres across the country might not immediately improve the provision of health services, he stated.

Neema Mgaya (Special Seats) (pictured) said a lot more needs to be done emphasised. to uplift the provision of health services, urging the government to increase health sector funding, with

more money directed to the purchase of equipment. Employment of new health workers and improvement of the welfare situation of medics and nurses was equally important, the asserted, seeking that more health facilities be constructed in Njombe Region and elsewhere. If dispensaries are well-equipped many lives will be saved, she

Mwinyi hails India for supporting Zanzibar development projects

ZANZIBAR President Dr Hussein Ali Mwinyi has hailed the Indian government for the support it has been offering to Isles in strengthening projects for availability of safe water.

Dr Mwinyi made the remarks when he led talks with Indian High Commissioner to Tanzania Binaya Srinkantan Pradhan at Zanzibar's State House.

Dr Mwinyi said in the one year of his tour of duty in the country he has managed to follow up on the implementation of various India funded projects in Zanzibar, suggesting the need for following up on the projects which are being implemented to ensure they are completed timely.

Explaining further on the implementation of the water projects Dr Mwinyi commended the steps reached so that the projects which are funded by Exim Bank of India in soft loans to the government of Zanzibar.

On the implementation of human resource management, Dr Mwinyi hailed the propgramme on scholarships for Zanzibar students which are funded by the government of India.

Dr Mwinyi told the envoy that the Zanzibar government was ready to work with the government of India in establishing an ICT college in the Isles.

Earlier, the Indian envoy told Dr Mwinyi of the progress on various projects implemented by his country since he begun tour of duty in the country in September last year.

Commissioner Pradhan said India values the cordial relationship which it has with Zanzibar saying his office will ensure all the projects undergoing are finalized on time.

"It is my hope that all the water projects which are being implemented are completed on time," he said.

The envoy said the Indian government was planning to establish vocational training in Pemba which will help in training youths in the Isles.

ary 2022, Mkulazi Co. had not completed installation of machinery at Mbigiri area.

Construction work was just 13.8 per cent complete, while at Mkulazi area installation work was going on, the CAG noted, elaborating that Mkulazi Co. had explained that the delay in installing the plant arose from the Covid-19 outbreak, hampering procurement proceedings of the machinery.

The audit exercise showed that due to delays in installing the sugar making plants, Mkulazi Co. had to sell away the harvested sugarcane, while during fiscal 2020/21 the company harvested and sold 32,121.6 tonnes of sugarcane harvested from 382 hectares, earning 1.16bn/-.

There were clear weaknesses in the machinery purchase for Mkulazi Holding Co., including the lack of basic reasons for involving TanRoads in the purchase of the plant.

The management failed to give any reasons for picking TanRoads for buying the machinery on its behalf "as it is not an institution with procurement experience for public institutions such as TEMESA or the Public Procurement Agency (PPA)."

The audit avers that Mkulazi Co. did not perform its responsibilities as to procurement as stated in the contract agreement, where TanRoads was required to conduct a purchase process until the time the tender is awarded to the winner and the signing done by Mkulazi Co.

Instead, TanRoads conducted the entire procurement process, with no evidence that Mkulazi Co. was involved in the preparation of the relevant requirements, building measurements and estimates thereof (BOQ) or other essential requirements, he stated.

No evidence was presented to auditors that the agreement was verified by the Attorney General as stipulated by Regulation 59(1) of the 2013 Public Procurement Act, he further noted.

In addition, Mkulazi Co. did not oversee the agreement, with the project being overseen by TanRoads and payment for the work done by NSSF after receiving payment docufrustrates opportunities for others ments from TanRoads, the report added.

'Buza-Kilungule-Nzasa road construction set to start soon'

CONSTRUCTION of the 9 kilometers road from Buza-Kilungule to Nzasa is set to begin under the Dar es Salaam Metropolitan Development Project (DMDP), the House heard yesterday.

The road which will be constructed at tarmac level is among the road networks that area managed by the Ministry of Works and Transport through Tanzania National Roads Agency (TANROADS).

Deputy Minister, Ministry of Works and Transport, Eng Godfrey Kasekenya told the National Assembly they are finalizing processes for construction of the road which will also serve people in Kitunda.

He said that DMDP project is implemented under the Ministry of State in the President's Office (Regional Administration and Local Government) through the Tanzania Rural and Urban Roads Agency

(TARURA).

He was responding to a question from Special Seats MP, Mariam Kisangi(CCM) who wanted to know when the government would start construction of the Buza-KilunguleNzasa road.

Earlier, when responding to a question from Buyungu Member of Parliament Aloyce Kamamba Eng Kasekenya told the legislators that the government has allocated 10m/in the 2022/2023 financial

year for maintenance of the Kakonko-Muhange road to facilitate transportation of people and goods.

He said the efforts are meant to ensure the road is passable throughout the year. He said the government will continue to improve road networks in Buyungu constituency depending on availability of funds.

He said the Kakonko road which passes through Kinonko, Ruhuru, Nyakiyobe, Gwarama, Kabane and Muhange villages is managed by both, TANROADS and TARURA.

He said the 26 kilometers road Kakonko-Kinonko-Ruhuru-Nyakiyobe-Gwarama is under TAN-ROADS while the 8 kilometers section of the road from Gwarama to Muhange is under TARURA.

Eng Kasekenya said the Gwarama-Muhange section is in good condition because it was repaired in the 2019/2020 financial year at cost of

'300 houses for health care workers for construction in financial year 2022/2023'

A TOTAL of 300 houses for health care workers will be constructed in the coming financial year 2022/2023, according to the Deputy minister for Health Dr Godwin Mollel.

"During the financial year 2021/2022 the government constructed a total of 176 houses; plans are underway for construction of 300 more houses," said Dr Mollel.

He announced the plans in the House yesterday when responding to a question by Special Seats MP, Nora Mzeru who was concerned about the shortage of housing for health workers.

In the coming financial year, the government through the Ministry of Health will construct 300 houses each with the capacity to accommodate three families," he stated.

In the current fiscal year, the government apart from constructing 170 houses also threw weight on strengthening electronic systems that aimed at distributing medicine and other medical equipment.

The ministry also continued to employ staff in the health sector in a grand effort to continue addressing the shortage in the country, said the Deputy Minis-

Recently, the government announced new jobs whereas the ministry for health has been given 10,285 workers out of which 7,612 public servants would be employed in hospitals, health centers and dispensaries which are under the President's Office, Regional Administration and Local Government (PORALG).

Also 1,650 positions are up for grabs for workers for Zonal and Regional hospitals which are under the ministry of health.

Meanwhile, the government is planning to reinstate a military vuma Region.

Minister for Defense and National Service, Dr Stergomena Tax said the move is part of efforts to strengthen security in the southern parts of the country. The government is well aware of the importance of enhancing security at all border areas; in this case, the ministry is in the process of reinstating a military camp in Tunduru.

She said: "According to her, the ministry has already requested

a budget from the ministry of finance and Planning for construction of different infrastructures at the new camp."

Dr Tax said the government is acting accordingly to ensure security in all parts of the country including border areas is maintained.

She added: "The government has taken a number of efforts and strategies to provide security in the mentioned areas, at a time of waiting for construction of the camps.

Dr Tax made the statement in the Parliament when responding to the question by Tunduru South MP Daimu Mpakate (CCM) who suggested the need to reinstate military camp in the district. In his supplementary question, Mpakate asked the government to consider establishing temporary camps to ensure security in the villages that border the neighboring country, Mozambique.

234.5bn/- collected from mobile money transactions levies in February, says govt

DEPUTY Minister for Finance and Planning Hamad Chande has said a total of 234.5bn/- has been collected from mobile money transactions levies by February this year.

Chande told the National Assembly that out of the funds, 231.5bn/were collected in the mainland part while the remaining 2.96bn/were collected in Zanzibar.

He said, the money collected in the mainland part have been channeled for construction of classrooms and health centres in the needy areasacross the country.

"The Zanzibar government will explain in detail regarding disbursement of the money being collected from obile money transactions levies," he said.

The levies were introduced during the financial year 2021/2022 to partly finance the 34tritri/- budget on constructing health centres and classrooms.

In the first four weeks since the part and Zanzibar.

government introduced the mobile money transactions levies, it had managed to fetch 48.4bn/where 37bn/- had already been distributed for the construction of 150 health centres.

However, in September last year, the government announced a 30 per cent reduction in transaction

The move was in response to public outcry that the charges were too high and would inflate the cost of living.

The cut in mobile money levies came in response to the directives of President Samia Suluhu Hassan who on July 19 last year instructed the Finance and Planning ministry together with the then ministry of Communications and Information Technology to work in the directives with immediate effect.

He was responding to a question by Chakechake MP, Ramadhani Suleiman Ramadhani who sought to know on how the money is being divided between Mainland

TARURA earns accolades

THE National Assembly is pleased with the government's increased budget allocation for the Tanzania Rural and Urban Roads Agency (TARURA). However they called upon the road agency to increase performance.

Members of Parliament yesterday expressed satisfaction with what it is doing, adding that the expectation is to intensify activities with the beefed up budget.

Debating the 2022/2023 budget estimates for office of the Ministry of State, President's Office, Regional Administration and Local Government Tanzania (PO-RALG), several MPs praised the government for increasing budget to the agency up to 800bn/-

Special Seats MP, Neema Mgaya(CCM) noted that there is upward growth of budget for TARURA. She said the organization's

budget was 278bn/-in 2020/2021, 722 bn/- in a whole. 2021/2022 and now 802 bn/- in 2022/2023.

"This is a good step in improving road network in the country" she said, adding that TARURA have the opportunity to expand its activities.

Korogwe MP, Timotheo Mzava (CCM) also observed that the agency has done a good work but should ensure that all roads in the country are passable throughout the year. At the same time, he called on the concerned authotities to ensure innovation and well use of the money.

He urged the national road agency to think of rightful technology that can help maintain village roads, noting that they wear out very

Segerea MP,Boni Kamoli(CCM) also praised the agency for the good work it is doing in her constituency and Dar es Salaam as

Special Seats MP, Ishengoma(CCM) also expressed while appreciating the budget increment also noted that the agency has a lot of work to do, terming the increased budget as a big

Nyamagana MP, Stanslaus Mabula(CCM) also praised the government for the gesture but suggested that there is need to have a four year's budget increase plan aimed at ensuring TARURA gets 1.4trl/- ultimately.

Tabling the ministerial budget estimates last week, Minister for State in the President's Office, Regional Administration and Local Government, Innocent Bashungwa said TARURA has been allocated 802.29 bn/- for the upgrading and improving 411.80 kilometers to tarmac roads, 10,666.11 others to murram level.

Unfavourable investment climate face developing countries, says CAG

THE Controller and Auditor General (CAG) has cited two issues that impede investment in the country, while Tanzania holds Number 141 position out of 190 world countries with friendly environment for investment.

In his 2020/21 Report tabled in Parliament in Dodoma last week, CAG, Charles Kichere says unsatisfactory investment environment is among the impediments that affect developing nations.

He says amendment to the system is always important in removing investment obstacles, he says, referring to the report dubbed 'Easy of Doing Business Report, 2020' issued by International Finance Corporation (IFC) in which Tanzania is listed at No 141 out of 190 world countries.

According to the report, in the last five years beginning 2015 to 2020, Tanzania dropped eight per cent in putting friendly business environment.

"This position is below the country's estimates in being above 100 positions by 2020 as it was cited in the Five Year Development Plan II (2016/17-2020/21).

"Tanzania is making various efforts to improve its investment environment. However, in my investigations at the Tanzania Investment Centre (TIC) I discovered that deficiencies that affect environment for investment in the country," CAG Kichere notes.

He found out that TIC did not fully use the digital platforms in enhancing investment opportuni-

"TIC had issued only one video article only in Kiswahili in mobilising for investment in November 2017, and it did not put online agreement in regard to customers' service at the Tanzania Investment Window to enable stakeholders to understand.

"The Centre did not publish in its website guidelines in regard to various services including permits, licences and registration conditions. I opine that better use of digital platforms has huge positive effects in enhancing investment in the country.

"I recommend to TIC to increase its use of digital platforms by involving other stakeholders to increase investment in the country, "CAG says in his report.

He cites the second issue that obstructs investment in the country as the impediments in providing motivation and attractions to strategic investors.

He explains that Sections 19 and 20 of the Tanzania Investment Act (Cap 38) as amended in 2015 permit to provide special motivation in regard to strategic investment, including huge investments and this has to be published in the Government Gazette.

"Many people who quiz statements of funds expenditure have found themselves facing trumped up cases or other made up accusations," he added.

He confessed that he once was a

but was suspended by CCM due to various claims levelled against him by village officials.

When interviewed, Ipugusa Village Executive Officer Charity Kisepe confirmed the incident but denied accusations that he was involved in the incident, adding that the village was a result of love jealousy.

"Matola is misleading that the Village Chairman Village Mkasiwa is involved, instead he was in secret love relationship with a woman at the village, and that the woman's elder son was the one who planned the attack on Matola," sad the Village official.

Two people are claimed to be held at Mlimba police station in connection with the incident.

Deputy minister stresses need for farming of certified cassava stems

THE government has expressed willingness to continue improving cassava cultivation in the country with emphasize directed on production of certified cassava stems which are drought resistant.

Deputy ninister for Agriculture, Anthony Mavunde said the ministry is taking adaptation measures in the agriculture sector because of climate change which makes the crop vulnerable to diseases.

Mayunde said the government produced and distributed 30.49 million of cassava stems in the 2019/2020 financial year and another 40.96 million of stems in 2020/2021.

"The distributed stems are likely to improve the crop's productivity as they cannot be easily attacked by diseases," said Mavunde when responding to question from Special Seats legislator, Tunza Malapo (CCM).

In her basic question, Malapo wanted to know the government plans to revive the crops' farming in the country especially in Mtwara Region.

The Deputy Minister informed the National Assembly that the government has been implementing the national cassava development strategy since 2015. He said the strategy targeted farmers in the Lake Zone regions and Coastal zone regions including Mtwara.

He said the first phase was completed early 2021. He said second phase implementation of the strategy started in December 2021 and will be completed in 2024.

Mavunde noted that through the strategy, cassava production in Mtwara region increased to 866,676 tonnes in the 2019/2020 cultivation season compared to 611,210 tonnes of the crop produced in 2016/2017.

The increase was due to improvements in production and distribution of certified cassava stems, he added.

Tanzania has over 44 million hectares of arable land with only 33 per cent under cultivation and about 65 per cent of Tanzania population depends on agriculture for food, income, health, employment and raw materials for agroprocessing industries.

The leading countries in cassava producing in the continent include Nigeria, Democratic Republic of Congo (DRC), Ghana, Angola, Mozambique and Malawi.

"The Igunga primary school is an inclusive facility that also receives children with disabilities, but is facing a number of challenges that affects development of the special group, so by completing the construction of the dormitory will provide the children with a conducive living environment for them to study comfortably," she explained.

She further said that this year's education week commemoration will also involve visiting various schools and education facilities in Igunga District as well as speaking to parents and educating them on the importance of valuing

"During the five days of the Education Week, stakeholders will also have an opportunity to showcase their education related activities and projects, learn from each other and exchange ideas aimed to improve education in the country," she said.

GAWE's chairman of the organizing committee Denish Otieno, said the completion of the dormitory will facilitate accommodation of 80 girl pupils with disabilities. He further urged the government and stakeholders to in-

vest heavily in quality and inclusive education for the country to achieve the Sustainable Development Goals (SDGs).

He hinted on the note that the presence of a friendly environment at school improves good student-teacher relationships and will help reduce truancy.

He said there are others who have devised farm implements, crops processing machines and others gadgets but due to lack of display platforms they fail to advertise them

"As you can see here, all these pieces of machinery have been created by students, we have been displaying them at Nane Nane Exhibitions and other few national events, but this festival at the university will expand our display areas." he added.

Global finance meeting focuses on war-driven food insecurity

WASHINGTON

GLOBAL finance leaders are putting the growing crisis over food insecurity and skyrocketing food prices at center stage as members of the International Monetary Fund and World Bank meet in Washington and grapple with the brutal effects of Russia's war against Ukraine.

Treasury Secretary Janet Yellen was convening a Tuesday morning meeting with leaders from the IMF, World Bank, Group of Seven and Group of 20 global organizations to "call on international financial institutions to accelerate and deepen their response" to countries affected by food issues exacerbated by Russia's aggression, the Treasury Department said.

Russia and Ukraine produce 14% of the world's wheat supply, according to the United Nations, and the loss of commodities due to the war has resulted in soaring food prices and uncertainty about the future of food security globally, especially in impoverished countries.

The UN's Food and Agriculture Organization Food Price Index has made its biggest jump since its inception in 1990, reflecting an all-time high in the cost of vegetable oils, cereals and meat, according to the organization.

A late March report from the organization stated that the global number of undernourished people could increase by 8 million to 13 million people into 2023, "with the most pronounced increases taking place in Asia-Pacific, followed by sub-Saharan Africa, and the Near East and North Africa. If the war lasts, impacts will go well beyond 2022/23."

Anna Nagurney, a crisis management specialist at the University of Massachusetts Amherst, said Tuesday's meeting of global leaders was significant and "speaks to the growing fear and the increasing understanding that the world may be on the verge of a hunger catastrophe."

Nagurney predicted that countries that have not yet provided clear support for Ukraine – such as China and India – will come to realize that the food insecurity from a prolonged war in Ukraine will affect their own national stability and the welfare of their citizens.


"This may help to further isolate Russia both morally and economically," she said.

Deputy Treasury Secretary Wally Adeyemo said Monday that the international coalition of countries imposing sanctions on Russia and its allies takes the food security threat seriously.

"One of the things we have to do is take practical steps to demonstrate that this system is helping the people who need it the most" he said, which includes a "focus on those countries that are struggling to pay for things like bread for their people in light of the increase in commodities prices."

Africa can adopt integrated approach to malaria control

THE Malaria progress report 2021 by Africa Union has said Africa did not achieve its target of reducing malaria incidence and mortality by 40 per cent by 2020, and is not on track to eliminate malaria by 2030. However, Tanzania has been cited as one of the African countries to have set up a strategy to eliminate malaria by the end of 2030.

According to the AU report released recently between 2015 and 2020, malaria incidence slightly declined by only 1 per cent. There were an estimated 232 million malaria cases (96 per cent of global total) and 611,802 malaria deaths (98 per cent of global total) in Africa in

This is an increase of 68,953 malaria deaths compared to 2019 (49,000 of deaths attributed to disruptions to malaria programmes and broader health services caused by the COVID-19 pandemic).

According to revised World Health Organisation (WHO) estimates, the number of malaria deaths is significantly higher than previously understood such as 693,617 additional malaria deaths since 2015), increasing the urgency of controlling and eliminating ma-

World Malaria Day is an international observance commemorated every year on 25 April and recognises global efforts to control malaria. Globally, 3.3 billion people in 106 countries are at risk of malaria.

Malaria is a mosquito-borne infectious disease that affects humans and other animals.

Malaria causes symptoms that typically include fever, tiredness, vomiting, and headaches. In severe cases it can cause yellow skin, seizures, coma, or death. Symptoms usually begin ten to fifteen days after being bitten by an infect-

ed mosquito.

Malaria is a life-threatening disease caused by parasites that are transmitted to people through the bites of infected female Anopheles mosquitoes. It is preventable and curable. In 2018, there were an estimated 228 million cases of malaria worldwide.

The estimated number of malaria deaths stood at 405, 000 in 2018. Children aged under 5 years are the most vulnerable group affected by malaria; in 2018, they accounted for 67 per cent (272 000) of all malaria deaths worldwide.

The WHO African Region carries a disproportionately high share of the global malaria burden. In most cases, malaria is transmitted through the bites of female Anopheles mosquitoes.

There are more than 400 different species of Anopheles mosquito; around 30 are malaria vectors of major importance. All of the important vector species bite between dusk and dawn. The intensity of transmission depends on factors related to the parasite, the vector, the human host, and the environment.

Transmission also depends on climatic conditions that may affect the number and survival of mosquitoes, such as rainfall patterns, temperature and humidity. In many places, transmission is seasonal, with the peak during and just after the rainy season. Malaria epidemics can occur when climate and other conditions suddenly favour transmission in areas where people have little or no immunity to malaria.

They can also occur when people with low immunity move into areas with intense malaria transmission, for instance to find work, or as refugees.

Organic farming could be answer to food insecurity

COMMERCIAL farmers sometimes fail at organic farming because they switch over too quickly, ditching all chemicals, which is as traumatic for the soil as 'a drug addict going cold turkey'.

Organic farming is an agricultural system that uses fertilisers of organic origin such as compost manure, green manure, and bone meal and places emphasis on techniques such as crop rotation and companion planting. It originated early in the 20th century in reaction to rapidly changing farming practices. Certified organic agriculture accounts for 70 million hectares globally, with over half of that total in Australia. Organic farming continues to be developed by various organisations today. Biological pest control, mixed cropping and the fostering of insect predators are encouraged. Organic standards are designed to allow the use of naturally-occurring substances while prohibiting or strictly limiting synthetic substances. For instance, naturally-occurring pesticides such as pyrethrin are permitted, while synthetic fertilisers and pesticides are generally prohibited. Synthetic substances that are allowed include, for example, copper sulfate, elemental sulfur and Ivermectin. Genetically modified organisms, nanomaterials, human sewage sludge, plant growth regulators, hormones, and antibiotic use in livestock husbandry are prohibited. Organic farming advocates claim advantages in sustainability, openness, self-sufficiency, autonomy and independence, health, food security, and food

Organic agricultural methods are internationally regulated and legal-

in large part on the standards set by the International Federation of Organic Agriculture Movements (IFOAM), an international umbrella organization for organic farming organisations established in 1972. Organic agriculture can be defined as "an integrated farming system that strives for sustainability, the enhancement of soil fertility and biological diversity while, with rare exceptions, prohibiting synthetic pesticides, antibiotics, synthetic fertilisers, genetically modified organisms, and growth hormones".

Sustainable agriculture is farming in sustainable ways meeting society's present food and textile needs, without compromising the ability for current or future generations to meet their needs. It can be based on an understanding of ecosystem services. There are many methods to increase the sustainability of agriculture. When developing agriculture within sustainable food systems, it is important to develop flexible business process and farming practices.

Agriculture has an enormous environmental footprint, playing a significant role in causing climate change, water scarcity, water pollution, land degradation, deforestation and other processes; it is simultaneously causing environmental changes and being impacted by these changes.

Sustainable agriculture consists of environment friendly methods of farming that allow the production of crops or livestock without damage to human or natural systems. It involves preventing adverse effects to soil, water, biodiversity, surrounding or downstream resources-as well as to those working or living on the farm ly enforced by many nations, based or in neighboring areas.



Connecting the dots for the UN Transforming Education Summit

LOOK around the world at this very moment. Whether we look at it in stark numbers and statistics, whether we look at it as a generational loss of basic human rights, including the right to an education, or whether we look inwardly and feel the unspeakable human suffering and devastation taking place, we all agree: we are at a historically low point in our collective humanity.

The UN Secretary-General has launched several multilateral calls in the name of the UN Charter, the Universal Declaration of Human Rights and the Sustainable Development Goals to change this and to mobilize the international financing and action needed to do so.

Among these, three are of immediate relevance to the delivery of an inclusive quality education to children and youth left furthest behind in emergencies and protracted crises: armed conflicts, forced displacement and climate-induced disasters.

The first call to action refers to the UN Reform, whereby we must end silos and competition, and work together through joint programming, humanitarian-development coherence and local empowerment - with a focus on those left furthest behind.

In this vein, Education Cannot Wait was operationalized in 2017. At the time, an estimated 75 million children and youth were left behind as their education had been disrupted in crisis-affected and refugee-hosting countries.

Since then, Education Cannot Wait has transformed from a new start-up fund to a matured United Nations global fund (hosted by UNICEF), with the design and agility to advance UN Reform in how we deliver education in emergencies and protracted crises to those left furthest behind.

The second call to action refers to Our Common Agenda. Once more, the top-priority for the United Nations' 193 Member States is to leave no one behind and to reinforce the quality of their education and learning outcomes. Due to COVID-19, the number of children and youth left furthest behind in brutal conflict, forced displacement and climate-induced disasters has sky-rocketed

to nearly 130 million. We must remember them as we prepare for the third relevant call for action: the UN Secretary-General's Transforming Education Summit, to be held during the UN General Assembly week in September. This is our opportunity to focus international financing and multilateral action on these 130 million vulnerable children and

vouth. Without an inclusive quality education, these crisis-affected girls and boys will be prevented from claiming their human rights and disempowered from rebuilding peace in their own lives and in their countries. Tragically, they will be reduced only to representing the staggering gap in reaching all the Sustainable Development Goals, not least, SDG4.

By connecting the dots between the UN Secretary-General's UN Reform, Our Common Agenda and the Transforming Education Summit, we have a unique, historic opportunity to finally reach the millions of children and youth who

are today left furthest behind. As Norway's Minister of International Development Anne Beathe Tvinnereim, states in her interview of this month's ECW Newsletter: "UN Member States have committed to leave no one behind in their implementation of the Sustainable Development Goals." In doing so, she concludes: "The success of this work depends on close collaboration between states, multilateral organizations, civil society organizations, organizations of persons with disabilities, and a wide range of partners."

This is how the United Nations

works. This is how Education Cannot Wait - the UN global fund for education in emergencies and protracted crises - works to reach those left furthest behind, together with other major financing mechanisms, such as the International Financing Facility for Education (IFFED) and the Global Partnership for Education.

Leonardo da Vinci once said: "Learn how to see. Realize that everything connects to everything else." Indeed, every vision, every call for action, every effort for change, is conditioned by our ability - not only to see, but how we see - by connecting the dots. Only then can we hit the real target and produce scaled up results.

Today, we see 130 million vulnerable children and youth without an education struggling simply to survive in armed conflicts, forced displacement and climateinduced disasters - none of their own making.

Now is the time to connect the dots between UN Reform, Our Common Agenda and the Transforming Education Summit, by squarely placing the focus and financing on those left furthest be-

Mloganzila readying human milk bank to save preterm newborns

HE Muhimbili National Hospital (MNH)-Mloganzila is set to establish a human milk bank to feed children born premature and separated from their mothers.

Dr Mwanaidi Amiri, Head of Department of Paediatric and Child health at Mloganzila says 60 per cent of deliveries at the national hospital are preterm; hence a need for human milk bank for the babies.

She says a baseline survey to establish mothers' readiness to donate has shown that 86 per cent of lactating mothers are ready to be donors to ensure the neonates are fed immediately after being born.

Dr Amiri says that globally, between 15 and 40 per cent of vulnerable babies in neonatal units lack access to their own mothers' milk, often because of maternal illnesses, death or abandonment.

Similar situation is likely to face majority of neonates in the country's hospitals including those pregnant mothers who deliver at MNH-Mloganzila.

Speaking at a recent interview, the expert said that the plan is very important to provide sufficient pasteurized donor milk to neonates who need it while their mothers are in intensive care.

"We have to act urgently because neonates whose mothers face shortage of milk after delivery become so weak," she said.

"It is our hope that the new plan is going to solve all these challenges by supplying neonates with sufficient milk to protect them against infections."

She said that healthy mothers of hospitalized neonates who stay long in hospitals can be donors in the ongoing initiative through access to breast pumps to express their milk. Also, mothers who have enough milk above the needs of their own infants can be voluntary donors.

According to her, soon after being collected from lactating mothers, the milk is screened, tested and pasteurized to kill germs before being stored in the centre for future use. If stored as per recommended standards, human milk can last up to six months.

"Our future plan is to offer a lifesaving alternative to ensure timely access to human milk from lactating mothers and provide the same to infants in need while ensuring that even if babies cannot breastfeed, they can receive readily available human milk," she

The pediatrician noted that all beneficiaries of the project will be all neonates born at the hospital and those admitted for special cases. For infants, not being breastfed is associated with an increased incidence of infectious morbidity including otitis media, gastroenteritis, and pneumonia as well as elevated risks of childhood leukemia and sudden infant death

The expert advised mothers not to forget to feed their newborns colostrum (the first milk which is thick and rich in nutrients) in the first two to five days.

Tanzania Food and Nutrition Centre (TFNC), said that breast milk is the best milk for newborns because it is easily digestible.

She said that the nutrients in breast milk are unmatched by any other first food a newborn can receive, adding that it helps to boost the baby's immune system and has strong illness-inhibiting power.

"I commend the initiative to establish the human milk bank as an effort to feed children born prematurely at MNH-Mloganila,"she said.

- are not put to the breast within an hour of birth, depriving them of the essential nutrients, antibodies and skin-to- skin contact with their mother that protect them from disease and death.

UNICEF data show that globally, progress in getting more newborns breastfed within the first hour of life has been slow over the past 15 years.

In sub-Saharan Africa, for example, where under five mortality rates are the highest worldwide, early breastfeeding rates increased by just 10 percentage points since 2000 in East and Southern Africa but have remained unchanged in West and Central Africa.

Moreover, around the world, only 43 per cent of in-

fants under six months old are exclusively breastfed. Babies who are not breastfed at all are 14 times more likely to die than those who are fed only breast milk.

Both the World Health Organization (WHO) and UNICEF recommend that children initiate breastfeeding within the first hour of birth and be exclusively breastfed for the first 6 months of life.

Continuing to breastfeed exclusively - without any other food - for the first six months promotes sensory and cognitive development, and protects babies against infectious and chronic diseases.

Tanzania joins other countries in the World to commemorate the World Breastfeeding Week (WBW) every 1st to 7th of august. WBW is a global campaign to raise awareness and galvanize action on themes related to breastfeeding to promote, protect and support breast-

Migration in a time of war: A tiny bird's mighty trek through Ukraine battle zones

URING late April and May, Curlew Sandpipers, and lots of other migrant waders, will be migrating through Ukraine. They will be joined by many passerine migrants, such as the warblers. There will also be some of the migrant raptors, such as Steppe Buzzard, and the big eagles (such as the Lesser Spotted Eagle), and the small falcons (such as the Lesser Kestrel). They will be on their way to breeding grounds in the Russian tundra, the taiga and the

But this article focuses on the Curlew Sandpiper. This is because the information for this wader is readily available (as you will see below), and because it has all been neatly assembled into one monograph, in International Wader Studies, a publication of the International Wader Study

Most Curlew Sandpipers breed in a relatively small area in northern Asia, the tundra zone of northern Siberia. They don't spend long on their breeding grounds. They arrive near the beginning of the thaw, in June and they leave at the end of July/beginning of August, when cold and snow re-

Once on the breeding grounds, there is quite a lot of variability in the start of egg-laving due to inter-year fluctuations in the timing of the thaw. The incubation period is 20 days, and the fledging period is an incredibly short 15 days. So the period from laying eggs to independent young is little more than a month.

Males play no role in incubation and chickrearing, so they leave on southwards migration around the end of June. Females leave as soon as their chicks have fledged.

These immature birds head south a week or two later, without parental guidance! This ordering of migration is observed at bird-ringing stations on the migration route: males first, then females, and finally the juveniles.

After the breeding season, arrival on migration at the southern end of Africa starts near the end of September, and numbers at wetlands build up in October-November.

The average weight of a Curlew Sandpiper at the non-breeding site at Langebaan Lagoon in South Africa's West Coast National Park from arrival until February is 57g. After this they gradually increase

in weight. When they depart on migration, they weigh 80g to 90g. Most of this additional mass is fat, fuel for migration. But this is not enough fuel for the entire journey to the tundra. Far from enough!

The mean departure date on northwards migration from Langebaan Lagoon is estimated to be 24 April. The mean arrival date on the breeding grounds in Siberia is estimated to be 10 June.

That is 42 days. Mean flight speed is 65km/h. The distance from Langebaan Lagoon to the breeding grounds on the tundra of the Taimyr Peninsula is about 13,000km. At 65km/hour, flying 24 hours per day, a Curlew Sandpiper can cover 1,560km/day.

Finally, 13,000/1,560 = eight days to fly thedistance. The remaining 42-8=34 days is used for refuelling. This can only be done at highquality wetlands where food is abundant.

According to flight-range formulae obtained during experiments in which birds flew in wind tunnels, a Curlew Sandpiper needs 132g of fuel to travel from Langebaan Lagoon to the breeding grounds - 99g must be obtained on the journey during the 34 non-fly days: 99/34=2.7g per day. This is well within their capabilities, so it is a believable number. (This information is sourced from this paper).

Not all Curlew Sandpipers migrating from their non-breeding grounds in Africa to the breeding areas in Siberia follow the same route. But the total number of really good wetlands for refuelling is small.

One of the best is the Sivash, in the western edge of the Sea of Azov, which in turn is in the northeastern part of the Black Sea, in the disputed territory of the Crimean Peninsula:

Researchers at the Azov-Black Sea Ornithological Station estimate that about 66,000 Curlew Sandpipers refuel in the Sivash on northwards migration (and 160,000 on autumn migration).

Most refuelling sites for Curlew Sandpipers (and other waders on migration) are tidal. This results in extensive areas of mud and sand becoming available at every low tide for feeding. But the Black Sea is too small to have any tides at all, and this applies also to the Sea of Azov, and especially the Sivash.

So how come the Sivash a great refuelling site? The answer is the wind. It is a complex area of shallow lagoons.

As the wind blows in one direction, it pushes water along with it, and this results in some mudflats being exposed for a while.

Then it blows in a different direction, and another set of mudflats are exposed. The refuelling waders continuously redistribute themselves opportunistically to use the best areas under any one set of wind conditions.

In studies which started in 1974, it is known that northward passage of Curlew Sandpipers through the Sivash starts in mid-April. Peak migration is in the period 11 to 20 May, and it tapers off by the end of the month.

So in the next few weeks, Curlew Sandpipers, and many other birds, probably counted in millions, are going to migrate through the battle zones of the eastern half of Ukraine. It will be migration in a time of war. We simply have no idea of whether the habitats they will use have been impacted by military activity.

From the Ukrainian perspective, their Curlew Sandpipers are linked with a remarkable number of countries: Norway, Finland, Poland, Swede, Germany, UK, France, Spain, Hungary, Italy, Bulgaria, Russia, Greece, Tunisia, Morocco, Senegal, Benin, Mali, Sudan, Chad, Namibia and South Africa - that is 22 countries that have shared individual Curlew Sandpipers with Ukraine via bird rings. In reality, there are many more.

The media coverage of armed conflict and war rightly tends to focus on the humanitarian impacts. But it is important to grasp that war also has impacts on biodiversity.

The land over which the war is fought is frequently degraded (think defoliants, bomb craters, soil compaction and chemical contamination from weapons such as tanks), so that important habitats are damaged and species loss accelerated.

Conservation initiatives fall by the wayside. Research, and especially the type of research that provided the data used in this blog, stops. In some parts of the world, war leads to increases in wildlife poaching and human encroachment on protected

The establishment of the Agricultural Commodity Exchange Centre is part of the implementation of the 2021-2031 Alliance for Commodity Trade in East and Southern Africa (ACTESA) strategy.

"The centre shall link small-scale farmers to national, regional and international markets within Comesa, the East African Community (EAC and the Southern Africa Development Community (SADC) tripartite framework and later the African Continental Free Trade Area (AfCFTA)," said Comesa in a statement.

According to ACTESA chief executive officer, Dr John Mukuka, the centre will provide a platform for buyers and sellers to conduct business of their agricultural products through a team of brokers.

Once established, it is hoped that the commodity exchange will reduce transaction costs by accommodating people actively involved in the production, trade, processing and consumption of commodities.

"A physical venue involves brokers meeting for trading sessions in a room or 'exchange floor', and trading by 'open outcry'.

"A virtual venue is where brokers use remote computer terminals to trade through a central exchange facility to which they are linked electronically," Dr Mukuka was quoted as saying this during a meeting with the Alliance for a Green Revolution in Africa (AGRA) deputy president in charge of policy and state capability Apollos Nwafor, who was on a visit to Comesa recently.

The commodity exchange is expected to improve agricultural productivity which the ACTESA says has gone down and needed a boost by providing access to regional agricultural markets.

"This entails support and training to existing national commodity exchanges and strengthening their systems and improving their operations, then linking them virtually or to the spot market where necessary. This shall be included in the working with AGRA in their new 2022-2027 strategy," said Dr Mukuka.

Other key areas of ACTESA interventions include support to seed companies using Comesa regional seed labels in seed trade, annual renewal of Comesa varieties on the Comesa Variety Catalogue and harmonisation of fertilizer policies/ regulations, standards, quality assurance and market development in the bloc's member States.

Thereafter, a finance mechanism will be established for bulk manufacturing and procurement of fertilizers and distribution in the Comesa coun-

Women's venture in Zimbabwe's aquamarine mining sector unique

THE first of its kind in Africa, Zimbabwe's Zimbaqua mine is uniquely employing an entirely female work-

Located near Karoi, a town 200 km northwest of the capital Harare, Zimbaqua is changing the lives of women in the region.

Zimbaqua provides relief to the plight of women in the region, most of them unemployed. "My family suffered a great deal before I joined the mine," said Sylvia Mugova, a miner and mother of five. "My children were consistently suspended from school due to lack of fees. My husband does not work. We also take care of my mother-in-law. All I wanted was an opportunity to provide for my family, and mining has given me that."

Like many other women with little or no formal education, Mugova is one of 35 women employed by Zimbaqua. However, the workforce can go up to 60, with other women taken in as contractors. These are significant figures because only 15% of Zimbabwe's 7,6 million women work as artisanal and small-scale miners.

The miners dig the 50-hectare surface for deposits of aquamarine. This is the name used for gem-quality specimens of the mineral beryl, a blue-hued stone highly prized by international wholesalers and jewellery designers.

The task is not easy as women use hammers weighing between 12 and 16 kilograms. They are equally trained to manage chisels, drills and rock crushers to free the precious stones. The workers receive a stable monthly salary of just under \$300 in

In this male dominated industry, until recently, the stones were shipped to Bangkok for cutting and polishing. However, the firm has begun training some women to take on these duties on-site - another empowering move.

According to the Mine manager Rumbidzai Gwinji said Zimbaqua is setting a new standard for mining. "The project is elevating the community by providing solutions for

The ladies no longer wait and hope that the husband will put a meal on the table. For single mothers, there is no better security than a reliable source of income.

They can now take care of the children, send them to school and feed them. They are now stable financially," she shared.

Zambiqua was founded in 2019 by Patrick Zindoga and Iver Rosenkrantz to create unique opportunities for women. Cofounder Zindoga said the idea initially received push-back. "Peo-

Ride-hailing service with women drivers only seen gaining popularity in Ethiopia

ADDIS ABABA

S a growing number of ride-hailing companies vie to penetrate the untapped market in Ethiopia, one company with women drivers only is recently gaining popularity in the country's male-dominated sector and making a good profit.

Meron Mengistie is one of the 150 women drivers at the Seregela Taxi Ride Service, which solely hires women drivers in its ambition to penetrate Ethiopia's ever-expanding ride-hailing service.

"I have always dreamt of driving and this job has given me the best platform to do so," Mengistie told Xinhua recently. Figures from the Ethiopian Ministry of Transport show that about 10,000 drivers are presently engaged in ride-hailing services across Addis Ababa, the


Ethiopian capital. Women, however, are insignificantly represented in the sector, contributing less than 3 per-

"I am so happy that Seregela introduced such an opportunity for women. I call on others to follow suit and hire more women drivers so that they can support their families," said Mengistie.

The Seregela company, founded in March 2020, works solely with preorders and communications with customers from a call center to track the activities of each car and ensure the safety of its female cab drivers.

"We are enjoying an increasing number of customers. Naturally, women are very caring. As a female taxi driver, I treat customers to the best of my ability amid safe driving," said Mengistie, who is a mother of

Hailu Zergaw, fleet manager at



Seregela Taxi Ride Service, said serving with only women drivers is helping to expand its business, in addition to promoting gender parity in Ethiopia's male-dominated transport sector. "We are unique in that we provide the ride-hailing service with women drivers and that helped us expand our customers' base," Zergaw told Xinhua.

Ride-hailing service is relatively a new venture in Ethiopia, Africa's second-most populous nation, with a growing number of companies vying to penetrate the untapped market, mainly in the capital of Addis Ababa and

Zergaw insisted that the company, the first of its kind by dispatching women-operated taxi services, envisaged boosting the economic participation of women and creating much-needed job opportunities.

"Women are little represented in Ethiopia's transportation industry. It is a vocation that has never existed (for women) and we are trying to create a pool of talent, right from sourcing, mobilizing and retaining. It is a challenge,"

Noting women drivers are often praised for their safety and loyalty, Zergaw emphasized that the company aspires to leverage this distinctive quality so as to attain market sustainability.

Sileshi Worku, a Seregela ride-hailing service user, singled out the maximum safety and security assurance as a distinguished quality in using women-operated taxi services.

"The female drivers never drive beyond the speed limit," Worku told Xinhua, noting that he switched to using women-operated taxi services for close to one year. Wearing neat uniforms in brand colors, the female drivers cater to commuters with 150 cabs across Addis Ababa.

"We want to boost women's income and ease their entry into the transportation industry, from which they have traditionally been excluded," Zergaw said.

The initiative to exclusively hire women drivers was, however, a major challenge for the company, mainly due to women's nearly nonexistent representation in the sector, said Zergaw, claiming that getting women drivers onboard and adequately training them has been a difficult task for the company. In addition to offering driving lessons, the company also trains its women drivers on the entire mechanism and functioning of their cars.

Blen Mehari, another driver recruited by the company, said the rare opportunity enabled her to be productive and help her family economically. "I used to spend my days sitting idle until I got a chance to work as a driver in the company six months ago. I am very grateful for having this chance to become a professional taxi driver," said Mehari, who provides taxi service for up to 10 commuters a day.

Noting that women taxi drivers relatively encounter higher psychological and physical harassment than male drivers due to the lack of women's representation in the male-dominated sector, Mehari was confident that the women-operated ride-hailing service is changing the dominance by promoting the inclusion of women in the industry.

Oil price volatile as Libya's outage fuels supply woes

NEW DELHI

OIL prices see-sawed on Tuesday as investors fretted over tight global supplies after Libya halted some exports and as factories in Shanghai prepared to reopen post a COVID-19 shutdown, easing some demand worries.

Brent crude was down 26 cents, or 0.23 percent, to \$112.90 a barrel at 0643 GMT, after rising more than \$1 to \$114.21 earlier in the session.

U.S. West Texas Intermediate crude fell 45 cents, or 0.42 percent, to \$107.76 a barrel, after rising to \$108.92 earlier.

Prices came under pressure with the dollar trading at a fresh two-year high. A firmer greenback makes commodities priced in dollars more expensive for holders of other currencies.

Both benchmarks rose more than 1 percent on Monday after hitting their highest since March 28 on political crisis in Libya. The country said it could not deliver oil from its biggest oil field and shut another field due to political protests.

The latest supply hit came just as fuel demand in China, the world's largest oil importer, was expected to pick

up as manufacturing plants prepared to reopen in Shanghai.

Oil prices, however, are still vulnerable to demand shocks as China continues to impose tough COVID-related

"For oil prices to take off on a sustainable trajectory, reopening mainland cities is necessary for translating into a sustainable economic rebound that supports oil demand," said SPI Asset Management's managing director, Stephen Innes.

OANDA analyst Jeffrey Halley noted that markets in Asia seemed content to adopt a wait-and-see approach, reluctant to chase rallying prices any higher.

"China's growth concerns are capping gains," Halley added.

In the United States, crude inventories rose by 9.4 million barrels in the week to April 8 to 421.8 million barrels, against analysts' hopes for an 863,000-barrel rise, a preliminary Reuters poll showed.

The possibility of a European Union ban on Russian oil for its invasion of Ukraine continues to keep the market

TIC registers \$787mn investment projects in the first quarter 2022

anzania Investment Centre (TIC) has so far registered 85 new projects during the first quarter of this year of which are going to stimulate growth, creating 12,191 jobs and attracts more investments through their value chain.

Speaking during a press briefing over the weekend, TIC director general Dr Maduhu Kazi said all projects registered during the first quarter of this year valued \$787.4million, higher than the value of the projects registered during the first quarter of last year amounting \$450 million.

The 2022 newly registered projects were higher than 51 projects registered during similar quarter last

these projects are on transportation, manufacturing, infrastructure, agriculture, real estate, financial services, human resources and tourism," he said.

Tanzania which is expected to build 12 stations to convert vehicles systems considering Tanzania is

seating on 57 trillion cubic feet of natural gas reserves.

According to Dr Kazi, two from fuel to natural gas use, of the planned stations will be completed this year.

"There will also be the construction of new cement factories by Alotaibnad Blak Bib and Prime Cement valued \$113million, which

will create 1,097 jobs," he said. Dr also said another project will involve the construction of Howo vehicles assembly plant, which is implemented by Saturn Corporation, a joint venture between Tanzanians and Canadian investors.

"In order to curb shortages of edible oils, we have registered a company namely Organo Africa which is expected to produce 182,000 tonnes of cooking oil per annum at an investment cost amounting \$42.68 million," he revealed.

He said during the same period, six different agreements valued \$1.1 billion were signed to expand existing projects as well as establishing new projects, which includes the construction fertilizer manufacturing factory by Intracom in Dodoma.

"TIC will continue to promote investments from both local and foreign investors to spur economic growth in time when Tanzania is gunning for industrial economic status," he

TBL earnings per share up by 76 pct in 2021

Tanzania Breweries Limited (TBL) basic earnings per share went up by 76 percent last year, when compared with 2020, the company unaudited financial results shows.

During the year 2021, the brewer's basic earnings per share was 476/against 270/- earned during the previous year, resulting into declaration of 76.2bn/- dividends.

The Dar es Salaam Stock Exchange (DSE) brewer share price closed at 10,900/- last week with a total market capitalization of 3.2trn/-, maintaining its leading position as the largest listed company in the market.

The results show the company total revenue increased by six percent to 1.01trn/- from 961.8bn/ respectively with slowdown of selling and distribution costs to 113.7bn/- from 131.2bn/ in 2020.

This improvement has increased the company's operating profit by 19 percent to 194.4b/- last year from 163.3bn/- in 2020 and grows profit amounting to 389.5bn/- last year from 264.7bn/- recorded in 2020.

"Operating profit increase contributed by volume performance and efficiencies in operating costs. Sales and marketing costs increased due to increase in sales and marketing activities in the market to drive growth compared to the same period last year," said Jose Moran, the company's country director.

He said during the year, a total of 50.8bn/- was invested in capital expenditure during the year compared with 33.7bn/- spent in 2020.

He said the group's reported cash generated from operations amounting 272.2bn/- of which 62.8bn/- was utilized to pay corporate income tax, 50.8bn/- for pay capital expenditure and 84.1bn/- used in financing activities (including payment of dividends) and the remaining were retained for future activities.

"Our performance in 2021 reinforces our confidence that our strong portfolio of brands and renovated commercial strategy can deliver

consistent growth and long-term value crease in inventories, trade and other efforts and continued support as well as creation, even in challenging year as the one we faced in 2021," Moran said.

Treasury yields set to rise slightly on newly revised coupons

TREASURY yields for the 20 year Treasury bond will slightly rise within the coming weeks as the market adjusts to the newly introduced treasury bonds with revised coupons analysts predict.

The Bank of Tanzania last week issued a revision of Treasury bond coupon rates in an effort to reduce debt servicing cost to the Government with the 20 year treasury bond revised from

15.4 per cent to 12.1 percent. The Central bank was in the market on April 13, 2022 offering 129.82bn/- to investors through issuing a 20-year Treasury bond with the auction marking new revised coupon rates.

The result of the auction continues to show increased demand for risk free securities as the auction was oversubscribed by 34.8 percent as investors tendered 175bn/- out of the offered 129.82bn/-

The minimum successful price of the auction was 100 although the Central Bank only accepted 95.55bn/- out of the 175bn/- tendered by investors.

According to the Zan Securities Chief Executive Officer Raphael Masumbuko, yields in the secondary market will rise slightly on the onset of the auction.

"As the weighted average yield for this auction was 11.6 per cent, we are going to see investors demanding a yield closer to the yield printed out in this auction. We expect yields to further fall only expecting the 364 and 182-day bills attracting subscription," he said.

Meanwhile, the yields on government securities in the secondary market slightly adjusted upwards during last

week's trading session, as investors demanded higher yields at the onset of the 20-year Treasury bond auction.

According to a report by the BoT, activities in the secondary market were moderate with the value of bonds traded slightly increasing by 13.6 per cent to 68.5bn/- from 60.3bn/- recorded in the previous week.

In a related development, the Dar es Salaam Stock Exchange (DSE) equity market plummeted by 22 per cent during last week's five-day trading session after posting an equity turnover

of 3.94bn/-.

The TBL counter dominated the market share accounting for 54.9 percent of the trading followed by Voda at 14.4 per cent, TCCL/Simba at 14 per cent and CRDB at 10.6 per cent.

Price movement was recorded on four domestic traded equities last week with the self-listed DSE appreciating the most by 5.3 per cent to end the week at 1,580/- per share.

The Swala share price on the other hand, depreciated by 8.16 per cent closing at 450/- per share while the

CRDB share price fell by 2.6 per cent to close at TZS 370 per share.

Total market capitalization dropped by 0.47 per cent to 16.0bn/- while Domestic market capitalization went down by 0.29 percent closing at TZS 10.2bn/-.

The Tanzania share index (TSI) on the other hand closed at 3,858.25 points after decreasing by 0.29 per cent while the All Share Index (DSEI) also decreased by 0.47 per cent to close at 1,924.29 points.

FAO, AUC set guidelines for agri-food systems for youth in Africa

THE Investment guidelines for youth in Agrifood Systems in Africa developed by Food and Agriculture Organisation (FAO) and Africa Union Commission have been launched.

The guidelines provides practical "how to" steps to develop youth-focused and youth-sensitive investment programmes that see them as partners in rural development, throughout all phases of the investment programme

The guidelines are for those involved in designing and implementing agrifood investment programmes: governments, financial and technical partners, the private sector, civil society, and voung women and men themselves.

"The Investment Guidelines that we are launching today are a direct response to the call to scale up investments in and with Africa's youth," said FAO Director-General Qu Dongyu at the official launch of the Guidelines during the 32nd Session of the FAO Regional Conference for Africa (ARC32), in Malabo.

"There is an urgent need to address the gaps and multiple constraints faced by Africa's young people, particularly in the rural sector. The impacts from the COVID-19 pandemic have raised this urgency even higher," he said.

The Investment Guidelines for Youth in Agrifood Systems in Africa aim to accelerate investments in and by youth in agrifood systems.

They recommend four steps to investing in youth including engage youth in the investment programme cycle; Assess and pre-design with a youth lens; Design with a youth lens; and Imple-



ment then monitor, evaluate and capitalize on what you learn.

"We make an urgent call for concrete operational action - the Investment Guidelines for Youth in Agri-Food Systems in Africa has great potential to drive this process and bring investments in youth-focused agri-food systems initiatives to scale" said Amb. Josefa Sacko, Commissioner for Agriculture, Rural Development, Blue Economy and Sustainable Environment of the African Union Commission.

"Investing in agrifood systems with a youth lens has positive impacts on youth employment and entrepreneurship and is critical to building sustainable inclusive agrifood systems," said FAO Investment Centre's Senior Rural Sociologist Pamela Pozarny.

"Youth must have an active voice and role as agents for change at

all stages of the investment programme. This requires an enabling investment environment," she said.

According to AUC, Africa has the highest percentage of youth in the world, estimated at 420 million people between the ages of 15 and 35, which are considered as enormous resource for future prosperity, but the challenges these young people face are many.

According to AUC, young people are twice as likely as adults to be unemployed, majority of working youth are poor and employed in vulnerable, low-quality jobs in the informal sector.

In 2019, almost two-thirds (63 percent) of young workers lived in poverty in Africa compared to half (51 percent) of adults. Youth are also overrepresented among the extremely poor.

Kenya coffee auction takes one-month break in May



THE coffee auction is set to go on recess next month as the main crop season comes to an end following a decline of highquality beans for trading.

Nairobi Coffee Exchange (NCE) has announced that the auction will hold its last auction on May 4 before breaking for one month.

The main crop season started in November last year with the crop sustaining the market up to this month when the ratio of high-quality beans started dwindling.

The auction will now be banking on the short-season crop from eastern and parts of westJune, which will sustain the auction up to November when the main crop coffee is expected to hit the market again.

The auction normally goes on recess around June of every year but this year is breaking early because of a shortage of quality beans to trade.

The low-quality coffee has seen the price of the commodity oscillate between highs and lows during the sales.

In the latest trading held last week, Kenya's top-grade coffee -AA declined to \$299 from \$331 in the previous sale while grade AB fetched \$284) from \$291 in the previous auction.

THE Food and Agriculture Organization of the United Nations (FAO) said has concluded a round of regional and national policy dialogues with Uganda's Dairy Development Authority (DDA) and key dairy stakeholders in a push to improve the country's dairy sector.

Uganda's dairy sector plays a vital role in

small-scale farmers with varying levels of quality and only around 20 percent of milk being processed into higher value products.

According to the DDA, Uganda's revenue from export of dairy products has risen sharply, by 63 percent in three years (2018-2020) and the sector accounts for 8 percent of total export value.

During the regional meetings, held in Mbarara and Wakiso, FAO officials presented the results of four economic and policy studies that highlight a range of issues in the dairy value chain, according to a statement issued

"The AgrInvest Project in Uganda supports existing Policy Dialogue Platforms, or at least platforms in the making, in partnership with key stakeholders. These platforms enable public and private dairy value chain stakeholders to strengthen their voice, articulate their investment needs and take the advantage of economies of scale by working together,," said Martin Maugustini, AgrInvest Uganda Project Coordinator.

"These dialogue platforms also aim to identify possible investment opportunities for investors, such as the Ugandan Development Bank (UDB) with whom AgrInvest is partnering with" he added.

The studies included analyses on price incentives for milk producers and traders, on the performance of the Milk Collection Centres (MCC), on post-harvest loss in the milk and dairy sector, and on domestic dairy consumption in Uganda.

In the East African Community, Uganda ranks third in milk consumption, behind Kenya and the United Republic of Tanzania, with each Ugandan consuming 64 litres per year on average. In comparison, the recommended intake by World Health Organization and FAO is around 200 litres.

"Milk is a vital source of nutrition and many Ugandan farming households get their income from the sale of milk and dairy products. Through this package of policy studies, stakeholder dialogues and the action plan devised today, Uganda has access to strong evidence on the reforms the dairy value chain needs and the strategic targets for future investments," said Thibault Meilland, Economist and Policy Advisor with the FAO Monitoring and Analysing Food and Agricultural Policies (MAFAP) programme.

ANZANIA has embarked on plans to ensure the Dar es Salaam Port gets International Organization for Standardization (ISO) certification on climate change adaptation as part of efforts to improve its efficiency and competitiveness.

According to the Global Risks Report 2022, ports and inland waterways are especially vulnerable to climate change, as 80 per cent of the world's volume of goods go through seaports, which in turn are exposed to storms, coastal erosion and sea-level rises.

Researchers discovered that most ports are still not even planning for climate change, leaving entire supply chains at growing risk of disruption.

"Climate change is not something that will happen in the future - it is happening now and is already too late to avoid. Countries are feeling the impacts and we need to adapt rapidly," said Doogie Black, Lead Analyst for

The World Bank Board of Executive Directors' in 2017 approved a \$345 million credit and a \$12 million grant to the new Dar es Salaam Maritime Gateway Project (DSMGP) geared towards capacity of the Port of Dar es Salaam to 25 million tons.

The investments in the Port also sought to improve waiting time to berth from 80 hours to 30 hours as well as overall productivity.

The DSMGP was part of a larger ongoing investment program for the overall development of the Port of Dar es Salaam with the support of several development partners.

The Tanzanian Government contributed about \$63 million through Tanzania Ports Authority, while Trade Mark East Africa supported improvements in the spatial and operational efficiency of the port.

According to the TPA Director General Eric Hamissi, the port's target is to handle 18 million tonnes of cargo this financial year and targets collecting 1trn/-.

European gas falls to lowest since start of Russia invasion

BERLIN

EUROPEAN natural gas extended its decline to the lowest level since the start of Russia's war in Ukraine, amid warmer weather and signs from the Kremlin that payment for the fuel in rubles isn't expected until next month.

Benchmark Dutch gas futures fell as much as 12 percent to 84 euros per megawatt hour -- the lowest level since Feb. 23, the day prior to the Russian invasion -- before paring some of those losses. The front-month contract settled 9.2 percent lower on April 14, ahead of the Easter holidays.

The market has been focused on shipments from Russia, its largest supplier, particularly following President Vladimir Putin's demand last month that "unfriendly" buyers pay for gas in rubles.

The European Union's lawyers have drafted a preliminary finding that the payment mechanism would violate the bloc's sanctions

There is still "some time" for Europe to pay for Russian gas shipments in rubles with payments for April supplies mainly "due sometime in May," Kremlin spokesman Dmitry Peskov said on Monday. He declined to comment on whether any customers have agreed to pay in rubles or set up accounts as mandated.

Above-average temperatures in southeast Europe are set to expand into the midcontinent next week, Maxar said in a report. That could relieve some pressure on demand for natural gas. Iberia will be colder than normal, the forecaster added.

Even before the war in Ukraine, Europe was dealing with an energy supply crunch and competing with Asia for cargoes of liquefied natural gas. Pandemic-related lockdowns are now weighing on demand in

Slightly weaker Asian LNG prices indicate the region's buyers currently don't need to outbid their European counterparts, analysts at consultant Engie EnergyScan said in a note.

"Gas prices have come down quite a bit as short-term fundamentals soften," said Edmund Siau, lead analyst for gas and LNG at consultants FGE. Demand destruction and fuel switching have eased pressures on European gas prices but competition from Asia looms, he said. "Traders are wondering what Asia is going to do with China's lockdowns and what the plan is to restock before winter," he said.

Still, Russian gas flows via Ukraine are expected below capacity on Tuesday, after orders for supplies dropped before Easter. Gazprom PJSC has said its shipments are in line with client requests.

While gas arriving in Ukraine from Russia's Sokhranovka network point has been relatively steady, flows from the Sudzha station have slumped in recent days. Flows via the Nord Stream link remain stable, grid data show.

Russia's military shelled southern and eastern Ukraine overnight, with President Volodymyr Zelenskiy saying Moscow had launched a new campaign focused on conquering the eastern Donbas region.

A Japanese firm blacklisted for using forged documents to win tenders floated by the Kenya Bureau of Standards (Kebs) has bid for a similar contract in Tanzania.

EAA Company Limited, which was blacklisted by the Public Procurement Regulatory Authority (PPRA) in 2021, is looking to take advantage of policy change in Tanzania to bag a lucrative tender for inspection of imported motor vehicles and spare parts.

The PPRA blacklisted EAA following an application by the Auditor General's office, which had found evidence that the Japanese firm used forged papers to bid for Kebs tenders in 2011, 2014 and 2019.

The Auditor-General, National Assembly's Public Investments Committee (PIC) and the Directorate of Criminal Investigations (DCI) all investigated EAA and another Japanese firm, Auto Terminal Japan, and concluded that the two companies used forged documents for the Kebs tenders.

EAA and Auto Terminal Japan have sued the PPRA at the High Court to quash their

pending its blacklisting, but EAA was denied any reliefs.

Auto Terminal has also thrown its hat in the ring for the Tanzanian inspection con-

The winning bidder will do inspections from countries where Tanzanians are importing vehicles and spare parts from.

Tanzania has been doing vehicle and spare parts inspections through agents in the countries of origin, following orders of former President John Pombe Magufuli.

But his successor, Samia Suluhu, last year ordered that the inspections be done at the Dar-es-Salaam port upon arrival.

Her directive has seen the Tanzania Bureau of Standards (TBS) invite companies interesting in being inspection agents to place their bids for the lucrative contract.

US will no longer enforce mask mandate on airplanes, trains

LOS ANGELES

THE Biden administration will no longer enforce a US mask mandate on public transportation, after a federal judge in Florida on Monday ruled that the 14-month-old directive was unlawful, overturning a key White House effort to reduce the spread of COVID-19.

Soon after the announcement, all major carriers including American Airlines, United Airlines and Delta Air Lines, as well as national train line Amtrak relaxed the restrictions effective immediately.

Last week, US health officials had extended the mandate to May 3 requiring travelers to wear masks on airplanes, trains, and in taxis, ride-share vehicles or transit hubs, saying they needed time to assess the impact of a recent rise in COVID-19 cases caused by the airborne coronavirus. read more

Industry groups and Republican lawmakers balked and wanted the administration to end the 14-month-old mask mandate permanently.

"The emergence and spread of new variants, like Omicron, have reinforced the need for a

strategy aimed at controlling COVID-19 worldwide," the White House said in a news release with the Group of Seven and Group of 20 na-

The announcement comes amid a surge of COVID-19 cases in parts of the United States and around the world prompted by easily transmissible variants of the virus.

Residents urged to shelter after chemical leak in US Louisiana

HOUSTON

RESIDENTS living in the Plaquemine area of southern state Louisiana were urged to shelter in place after a release of chlorine caused by a local chemical plant fire on Monday night.

Iberville Parish Sheriff Brett Stassi said the fire and chlorine leak took place at Olin Chemical, a third-party company that works at the site of the Dow Chemical Plant.

"We've set off the sirens and we've got several roads closed," Stassi said.

The fire broke out at 8:40 pm local time (0140 GMT on Tuesday) and was extinguished by 9:30 pm local time (0230 GMT), but the crew were still working to contain the chlorine spill, the sheriff said.

Parish President Mitch Ourso said the smell of chlorine was being reported in the air several miles from the facility. Authorities are asking residents living south and east of the plant to go inside, turn off air conditioners and close all doors and windows immediately.

However, the sheriff said no evacuations were being ordered since chlorine levels outside of the plant were not dangerously high.

So far there have been no reported injuries inside or outside the plant.

"A chlorine release has occurred within Olin's facility in Plaquemine ... A shelter in place has been implemented and local roads have been temporarily closed," said a statement from Olin Corporation.

"Site emergency response was immediately engaged and we are working to stop the release. Employees at the facility took immediate safety precautions while the team began working to address the situation," it said.

Louisiana Department of Environmental Quality spokesman Greg Langley said inspectors were headed to

Exposure to chlorine can irritate the eyes, upper respiratory tract and lungs, according to a fact sheet from the Environmental Protection Agency. At higher levels, it can cause chest pains and vomiting. It is extremely irritating to the skin and can cause severe burns with high enough

In 2016 and in 2017, Olin Corp.'s operations inside the Dow Hydrocarbons complex had three chlorine leaks that injured a contract worker, prompted worker evacuations and road closures though did not pose a risk to the public at the time, said a report from local media outlet The Ad-

One of the leaks, in December 2016, stemmed from a massive power outage that Entergy, Louisiana's biggest electricity provider, later said was triggered by the burning of sugar cane, while the others in September 2017 were caused after four electrical rectifiers tripped, said the report. Agencies

US, Cuba 'to hold high-level migration talks in Washington'

WASHINGTON

AMERICAN and Cuban officials are due to meet in Washington on Thursday to discuss migration concerns, people familiar with the matter said, in the highestlevel formal US talks with Havana since President Joe Biden took office last year.

The meeting comes at a time when Biden's administration is grappling with rising numbers of migrants attempting to cross the US border from Mexico, with Cubans making up a growing portion of them.

Tensions between Washington and Havana over the Cuban government's crackdown on protests, continuing American sanctions on the Communist-ruled island and other issues have made it difficult for the countries to cooperate on challenges such as irregular migration.

Leading the Cuban delegation will be Deputy Foreign Minister Carlos Fernandez de Cossio, two sources said, speaking on condition of anonymity. The delegation is expected to meet with senior officials of the US State Department and other agencies.

The United States wants Cuba among the record numbers of Cubans arriving at the US-Mexican

border, according to a US official and another source, speaking on condition of anonymity.

The Cuban government has not accepted deportation flights carrying Cubans from the United States for more than six months, a US Department of Homeland Security (DHS) spokesperson said. As of March 26, there were about 40,000 Cubans in the United States with a final deportation order from an immigration judge, according to the spokesperson.

Cuba has said it supports legal, orderly and safe migration. It blames the United States for the uptick in irregular migration, saying Cold War-era sanctions and a decision to take back more deportees from to close the American consular section in Havana encourage Cubans to seek riskier routes off the island.

The State Department last month said it would again begin processing some visas for Cubans in Havana to start reducing the backlog after a four-year hiatus, but progress has been slow.

'Significant increase'

"We have seen a significant increase in irregular Cuban migrants to the United States, both via land and maritime routes," a State Department spokesperson said.

The spokesperson, who asked firm the planned meeting but said "we regularly engage with Cuban officials on issues of importance to the US government, such as human rights and migration."

Thrsday's planned talks appear formal contacts since Biden took

office in January 2021.

The Cuban government did not immediately respond to questions seeking comment.

The talks are scheduled to be held just a day after US Secretary of State Antony Blinken and regional counterparts are due to wrap up a conference on migration in Panama. Cuba is not due to attend that

A record number of migrants attempted to cross the US-Mexican border during Biden's first year in office. American officials are preparing for even higher numbers this year.

Amid Cuba's faltering economy, after Nicaragua lifted visa requirements for Cubans in November, many dropped everything, sold their homes and took a flight for Managua, with hopes of joining the mainland "migrant highway" north through Central America to the United States.

Nicaragua, a close regional ally of Cuba, said the move was intended to promote commercial exchange, not to be named, declined to contourism and humanitarian family relations.

Initial fervor has been followed by frustration as the United States has undertaken a regional effort to curb border crossings.

US border authorities appreto be at a higher level than known hended more than 32,000 Cubans at the US-Mexico border in

March, roughly double the 16,500 caught in February, then the highest single-month total on record, according to US Customs and Border Protection data.

Even as the United States and Cuba prepare to re-engage on migration, Biden administration officials are mindful that any easing of restrictions on Cuba could lead to political fallout from conservative Cuban Americans, a key voting bloc in south Florida.

Former president Donald Trump rolled back a historic rapprochement that his predecessor Barack Obama oversaw between the United States and its old Cold War foe

Biden, who served as Obama's vice-president, promised during the 2020 US election campaign against Trump to re-engage with Cuba, and many in both countries expected he would reverse some Trump-era restrictions. Biden instead imposed fresh sanctions on Cuban officials in response to Havana's crackdown on protesters following widespread marches on the island last July.

Thousands of people took to the streets of Cuban cities, voicing anger over shortages of basic goods, curbs on civil liberties and the handling of the COVID-19 pandemic by authorities. Some called for political change.

World Bank expects debt crisis to continue to worsen in 2022

WASHINGTON

DUE to high debt and deficit levels, countries are 'under severe financial stress," and the debt crisis is expected to "continue to worsen" in 2022, World Bank Group President David Malpass said on Monday.

Noting that debt is one of the two big problems facing global growth, Malpass said at a Spring Meetings media roundtable that 60 percent of low-income countries are already in debt distress or at high risk of it.

Debt crises and currency depreciations have a burden that "falls heavily on the poor," he said. The 2022 Spring Meetings of the International Monetary Fund (IMF) and the World Bank Group are set to take place from Monday.

April 18, through Sunday, April 24. The other big problem for global growth is inflation, which is "causing immense strain," Malpass said, noting that policies need to be adjusted to enhance supply, not just increasing demand.

"Markets are forward looking so it's vital for governments and private sectors to state that supply will increase and that their policies will foster currency stability to bring down inflation and increase growth rates," said Malpass.

Amid the war in Ukraine, the World Bank chief said he is deeply concerned about developing countries, which are facing sudden price increases for energy, fertilizer and food, and the likelihood of interest rate increases.

Against the backdrop of elevated inflation, expected rate hikes, Russia-Ukraine war and slowing growth in China, the World Bank has lowered its projected 2022 global growth rate to 3.2 percent, down from 4.1 percent projected in January, according to Malpass.

The World Bank chief also noted that global trade is still facing quotas, high import tariffs, high export tariffs, expensive food price subsidies, and even export bans on food products.

Experts warn COVID-19 pandemic not yet over

IN a statement released Wednesday, the World Health Organization (WHO) announced the COVID-19 pandemic remains a "public health emergency of international concern," a day before WHO statistics showed the global caseload passed the 500-million threshold Under such circumstances, some nations

have chosen to lift their restrictions due to gloomy economic outlooks, insufficient policy implementation and general fatigue in

Experts have raised the alarm that the pandemic is far from ending, as humans have yet to completely solve the COVID-19 maze.

Since last November when the Omicron strain was first found, the world's caseload almost doubled in less than six months, with more than 1 million deaths -- roughly equivalent to the population of a medium-sized city.

This partly explained why the WHO said in the statement that the COVID-19 virus "is continuing to cause high levels of morbidity and mortality, particularly among vulnerable human populations."

In the United States, about 80 million cases have been registered and the national death toll is close to one million. India and Brazil follow behind, with confirmed cases exceeding 43 million and 30 million, respectively, according to data from the WHO.

Though recent updates indicate a decreasing trend in new cases and deaths, over 7 million cases and 22,000 deaths were reported during the week of April 4-10, causing unbearable losses to numerous families.

These trends should be interpreted with caution, the WHO particularly reminded, as several countries are adjusting their testing strategies, which has resulted in lower numbers of tests performed and cases detected. Despite a reduction in severity, the WHO

pointed out, the massive increases in Omithe subvariant is about 50-60 percent more cron-infected cases have led to a large number of hospitalizations and greater pressure on healthcare systems.

In some countries, there are similar or even higher numbers of deaths when compared to previous peaks, it added.

For countries worldwide, a shared goal is to contain the COVID-19 spread and reduce its threats to humans. But after rounds of efforts without coming by a workable solution, some have decided to drop their restrictions, including those on travel, socializing, maskwearing, testing and vaccination. COVID-19 cases and deaths, as a result, ticked up once

Anthony Fauci, the top American infectious disease expert, has recently said that he expects "an uptick in cases" over the next few weeks due to the Omicron subvariant BA.2 in the United States, where states and cities have moved to lift restrictions, and that transmissible than the first Omicron strain.

The United States is now averaging about 30,000 new cases, 500 deaths and 1,400 hospitalizations every day, according to the US Centers for Disease Control and Prevention.

Encouragingly, vaccination rates in some parts of the world keep rising and a downward trend has been observed in new infections and deaths. However, it may not yet be time to get too optimistic.

As WHO Director General Tedros Adhanom Ghebreyesus noted in a recent speech, transmission remains very high, vaccination coverage remains very low in too many countries, and the relaxation of many public health and social measures is allowing continued transmission, with the risk of new variants emerging.

"We are pleased to see a downward trend, but the pandemic is still far from over," he

Israel downs Gaza rocket, admonishes Jordan amid tension

ISRAEL shot down a rocket fired from the Gaza Strip on Monday, the Israeli military said, the first such attack in months as tensions over a flashpoint Jerusalem shrine drew angry pro-Palestinian rhetoric from Jordan and US mediation efforts.

No Gaza faction claimed responsibility for the launch, which followed warnings by the dominant Hamas Islamists of reprisals for Israeli conduct around Jerusalem's Al Aqsa

mosque compound.

Escalating the rhetoric, Jordanian Prime Minister Bisher al-Khasawneh

told parliament: "I must laud ... those throwing their stones at all of those Zionists who desecrate Al Aqsa mosque with the protection of the Israeli occupation government."

Several passengers were injured when Israeli buses they were traveling on to Jerusalem's Old City were stoned by Palestinians on Sunday, police said, adding that Al Agsa protesters have been stockpiling rocks for attacks on Jewish visitors and police.

At least 152 Palestinians and eight police were injured around Al Aqsa during Friday's confrontations,

Putin: West's 'economic blitzkrieg' against Russia fails

MOSCOW/KYIV


WESTERN countries' "ecoblitzkrieg" strategy against Russia has failed, Russian President Vladimir Putin said on Monday.

The main negative factor for the Russian economy in recent years has been Western sanctions, which were aimed at "quickly undermining the financial and economic situation in our country, provoking panic in the markets, destroying the banking system, and causing a large-scale shortage of goods in stores," Putin said at a government meeting on economic is-

Russia has withstood this "unprecedented pressure" as the ruble's value has returned to the level of the first half of February and the surplus in the current account of the balance of payments reached a record high of more than \$58 billion in the first quarter of this year, he said.

The Russian president however admitted that over the past month and a half, consumer prices in the country have increased by 9.4 percent and inflation surged to 17.5 percent in annual terms as of April 8.

However, the sanctions in turn have hurt the United States and European countries by driving up inflation and unemployment, weakening economic dynamics, reducing living standards, and devaluating savings, Putin added.

'Foreign weapons destroyed near Lviv'

Russian troops destroyed a depot of weapons supplied by Western countries near west Ukraine's Lviv on Monday morning, Russian Defense Ministry spokesman Igor Konashenkov said.

The Russian Aerospace Forces used high-precision airborne missiles to hit a logistics center of the Ukrainian Armed Forces near Lviv, destroying large consignments of weapons arrived from the United States and European countries over the past six days, Konashenkov told a brief-

Zelensky: Russian forces start battle for Donbas

Russian forces have begun the battle for the Donbas region, but Ukraine will defend itself, Ukrainian President Zelensky said in a video address on Monday.

"Now we can say that Russian troops have started the battle for Donbas, for which they have been preparing for a long time. A very large part of the entire Russian army is now focused on this offensive," Zelensky was quoted as saying by the state-run Ukrinform news agency.

"No matter how many Russian troops are driven there, we will fight."

In the east and south of Ukraine, Russian forces have recently been trying to attack more deliberately than before and looking for a weak spots in the country's defense to go there with the main forces, Zelensky said.

The same day, Secretary of Ukraine's National Security and Defense Council Oleksiy Danilov said Russian forces tried to start an active phase of the offensive in eastern Ukraine, the Interfax-Ukraine news agency reported.

On Monday morning, along almost the entire front line in Donetsk, Lugansk and Kharkiv regions, Russian forces attempted to break through Ukrainian defenses, according to Danilov.

Russian forces managed to make advances only in two

small towns, he said, stressing that the Ukrainian military is holding their grounds elsewhere in eastern Ukraine.

Russia expels Bulgarian diplomats

Russia is expelling a number of Bulgarian diplomats in response to the expulsion of 10 Russian diplomats from Sofia last month, the country's foreign ministry said in a statement on Monday.

The ministry summoned the Bulgarian ambassador on Monday and declared some employees of the Bulgarian Embassy in Moscow "personae non gratae," it said, without disclosing how many are targeted.

Earlier this month, the Russian Foreign Ministry announced the expulsion of two Bulgarian diplomats in tit-for-tat retaliation.

On March 18, the Bulgarian Foreign Ministry declared 10 Russian diplomats "personae non gratae", ordering them to leave within 72 hours due to their "activities incompatible with the Vienna Convention on Diplomatic Relations."

The US and some European countries have taken coordinated actions to expel several hundred Russian diplomats since the start of a special military operation in Ukraine.

'Pandas' arrival, a symbol of new start in US-China relations'

GIANT pandas, which first came to the United States 50 years ago, are "a symbol of a new start in US-China relations," retired US career diplomat Chas Freeman has recently told Xinhua during a virtual

Xinhua came amid the Smithson- and a research facility in Manhattan ian's National Zoo's celebration of 50 years of collaboration with China in conserving giant pandas, was director for Chinese Affairs at the US Department of State from 1979 and 1981 before becoming deputy chief of mission and charge d'affaires of the US embassy in China.

He was Richard Nixon's principal interpreter during the 37th US president's groundbreaking visit to China in February 1972, and was assigned by the State Department to serve as an escort officer for the Chinese delegation that brought a couple of giant pandas to Washington, D.C. two months after the historic visit.

"I remember it very well. I went to Dulles Airport to meet the pandas and a delegation -- I think there were four people," Freeman said. "We took them into the zoo, the National Zoo. There was a beautifully prepared case that had been made for the pandas, green color, as I recall, very nicely done up."

On April 20, 1972, first lady Patricia Nixon officially accepted female Ling-Ling and male Hsing-Hsing at the Smithsonian's National Zoo in northwest Washington, D.C., which were gifted by China to the American people as a gesture of goodwill. Freeman interpreted for her at the acceptance ceremony, in which she confidently predicted a "panda-monium" at the zoo.

"This became quite an event not because of Mrs. Nixon's presence but because of the pandas which were a great novelty. Everyone who sees pandas reacts the same way. They are cute. They are lovable. They don't seem at all dangerous. You probably want to hug them and they were very exotic," he recounted. "And that was a symbol of a new start in US-China relations."

The public debut of Ling-Ling and Hsing-Hsing alone drew 20,000 visitors. The following Sunday, 75,000 people thronged the zoo and waited in a line to catch a glimpse of them. "People were thrilled and the

National Zoo immediately became a much greater focus of attention than it had been," Freeman added.

After the giant panda pair settled in at the zoo, the young American diplomat accompanied the Chinese delegation to New York City, where they visited the Bronx Zoo -- which "was a model of some kinds of new Freeman, whose interview with habitat formation for animals" --

> "I remember this because I was interpreting throughout and of course, I didn't know the names of many of these strange animals and fish that we saw. I had to make up names.....a lot of them didn't exist in China," Freeman said, adding that his "most treasured memory of that moment probably was interacting with the Chinese delegation."

"That was a moment when very few Americans had had contact with Chinese officials or Chinese officials with Americans. I was impressed by the people from the Beijing Zoological Garden. I learned a lot about pandas. I didn't know anything about them before," he noted.

On current China-US relations, Freeman said, "there are many things we cannot accomplish without the help of the other or at least working alongside it."

"In diplomacy, sometimes you cannot cooperate directly but you may be able to coordinate activities and work in parallel side by side. This is where we are and we have difficulty working together but we can still work in parallel," Freeman explained.

"The pandas I think will remain as a symbol of the possibility of a renewed, positive relationship in the future as we rediscover the costs of separating from each other and the need to get together again," he said.

He suggested the two sides "restore the basis for a respectful dialogue, which can then take up the concrete ways of improving the relationship to mutual advantage that we should take up."

Why CECAFA region's players struggle to garner success in Europe soccer leagues?

HERE has been a long-standing cry over the shortage of players from East Africa playing football in Europe, a situation which would help the growth of the game in the region which is, in football, under the Council of East and Central Africa Football Associations (CECAFA).

Despite the presence of plenty of talented footballers in East Africa, the region still trails its North and West African counterparts when it comes to finding a breakthrough into major European soccer

So many factors account for this problem, ranging from historical, technical, social, and economic to individual players.

Most African soccer players, particularly East Africans, come from a poverty-stricken backgrounds, ghettos, malnutrition, sharing a bedroom and mattress with siblings, to playing barefoot football.

The continent lacks sufficient and wellequipped football academies which are effective channels for players' development and advancement.

Despite being talented and having an urge to excel, their career path in professional football has been marred by social, economic, and technical challenges.

Even those who excelled, their careers along the way, were erratic and fortuitous, due to plights out of their control.

For instance, 12 of 23 players in France's 2018 World Cup-winning squad originate from Africa particularly Cameroon, Guinea, the Democratic Republic of Congo, Morocco, Angola, Mali, Algeria, and

None of the East African countries has ever qualified for either the Olympics or World Cup tournament.

The East African region, however, made a great leap forward in the 2019 Africa Cup of Nations (AFCON) that was held in Cairo,

The region was, for the first time in history, represented by four member states Uganda, Kenya, Tanzania, and Burundi.

Their qualifications made fans crazy, rumbling all over. It was a moment of glory everywhere in the region.

The success of the West African and North African regions is partly thanks to colonial ties that created networks and social rapport between them and their former colonizers.

Football clubs in France, Portugal, and Belgium started to recruit players from Africa, who were regarded as cheaper and energetic, and launch transfer networks, as early as the 1940s.

Nevertheless, the situation is contrary to German and British colonies namely Kenya, Burundi, Rwanda, Uganda, Zanzibar, and Tanganyika (now Tanzania).

Specifically, the British deployed a protectionist approach that discouraged the entry of talents from their colonies. (Nigeria and Ghana, two of the former British colonies, were exceptions in this

Colonial legacy

In 1995, the European Court of Justice decreed the free movement of payers, alias Bosman ruling, within the European Union. Kudos to Belgian midfielder Jean-Marc

Bosman for a historic and well-fought battle that changed the face of football! The ruling facilitated big moves for one

of the biggest professionals in football in Edgar Davids (Ajax FC to AC Milan, 1996), Patrick Kluivert (Ajax FC to AC Milan, 1997), Brian Laudrup (Rangers to Chelsea, 1998), and Steve McManaman (Liverpool FC to Real Madrid, 1999) among many others.

Specifically, for Africa, the ruling was attributed to increased players of African origin in Europe.

However, due to existing networks

and language proficiency all emanating from colonial legacy, players from West African countries. predominantly French, Portugal, and Belgium, enjoyed this competitive advantage compared to their counterparts, particularly East African countries.

The points-based system, which favours professional players from countries ranking in the top 10 in the Fédération Internationale de Football Association (FIFA) world rankings, also hurts players from the East African region, whose countries are forced to earn their points through other set criteria which are very stringent.

These include several appearances in international club competitions, transfer fees paid, earning a 'qualifying wage,' shows the player is of significant severely hit. value.

Mbwana Samatta, Tanzania skipper now playing for Fenerbahçe S.K on loan to Belgian First Division A club, Royal Antwerp, endured all these encounters on his way to England's Aston Villa in January

If the point-based system fails, the FA exceptions panel can review and grant a working permit to players from the socalled low ranked countries in FIFA world rankings, through Governing Body Endorsement

However, in the year 2010, the Kenya international midfielder, McDonald Mariga, failed to seal his move from Italy's Parma to Manchester City through Governing Body Endorsement.

By that time, Mariga had 24 caps for Kenya and played in at least 75 percent of his games over the past two years. His country's lowly FIFA world ranking of 98 failed him.

Twisting the knife in the wound, BREXIT will negatively impact English clubs, especially ones that operate with a youth

transfer policy, like Manchester United and Manchester City.

The major changes in the United Kingdom football laws and regulations from the first day of January 2021 onwards include the prevention of clubs from signing overseas players under the age of 18 and clubs being restricted to three overseas signings under the age of 21 in the January transfer window and only six per season.

Further, the laws show that any foreign signing even those above 21 years will be obliged to pass the threshold, on a point-based system decided by a Governing Body Endorsement (GBE) panel.

These regulations adversely impact every non-UK football player, however, pondering the status quo, the a higher-than-average wage that East African players will be

Mentality issues

Another factor has to do with what the West Africans are famously known for, their 'Billy-No-Mates' mentality.

They have a unique fighting, aggressive and never-say-die approach to all walks of life.

They always dare to do, come short, again and again, striving valiantly with great devotions until they make it.

Those are stunts instilled in their minds. The path to success in Europe has never been easy with the prevalence of racial abuse often by fans, other players, and coaching staff and violent attacks on the pitch or

Once Jose Mourinho praised West African players saying: "They want to win all the time. You can see that in their tenaciousness and fighting spirit. These breed of players (Essien, Drogba, and Eto'o, etc.) could give you the extra touch, you can rely on them to win each time."

These very same mentalities expounded earlier coupled with effective structures and academies made Nigeria and Ghana, despite being the former British colonies,

Unfortunately, these mentalities, which are the bedrock to embarking on promising careers in European football, do not abound in most East African players.

Their upbringing and minds are engulfed by the fear of failure, lack of courage, and timidness.

Most of the East African players fail to cope with loneliness and isolation in Europe.

Worse enough, a big chunky of them fails prematurely during the trial. For many, alternatively, the dream is to play for their local clubs commonly Simba Sports Club (Tanzania), Yanga (Tanzania), AFC Leopards (Kenya), Azam FC (Tanzania), Gor Mahia (Kenya), SC Villa (Uganda) and URA FC (Uganda) to mention but a few.

While there are diverse whysandwhereforesfor West African players to triumph in major European leagues compared to East Africans, however, aggressiveness, perseverance, and resilience assume control.

As William Camden says: "If wishes were horses even beggars would ride." That glitz and glamour in Samuel Eto'o, Sadio Mané, Obi Mikel, Michael Essien, Nwankwo Kanu, and Yaya Touré were in the first place marred by poverty, dust, sweat, disappointments, and hate.

No wonder Samuel Eto'o loves Bongo Flava artist, Nassib Abdul, alias 'Diamond Platnumz', the poverty-stricken background has never deterred him from seeking the good life.

For instance, in Tanzania, are promising prospects in the likes of Ally Hamis Ng'anzi (Loudon United, USA) and Yohana Mkomola (Inhulets Petrove, Ukraine).

One of the greatest managers in the game, Sir Alex Ferguson, once said: "Origins should never be a barrier to success.'

A modest start in life can be a help more than a hindrance. Our greatest grandeur is not in never falling, but in rising every time we fall.

Those few who have made it, namely Mbwana Samatta, Victor Wanyama, and McDonald Mariga should, in partnership with government authorities, create synergies to establish well-equipped football academies for nurturing the upcoming talents from the East African region.

Samatta, Wanyama and Mariga did it, why not others? Let us keep daring greatly, the future is very promising.

Incredible Inaki! Williams hasn't missed a LaLiga game for Athletic Club for SIX years

MADRID

INAKI Williams passed an incredible appearance milestone for Athletic Club this past weekend after being named in the starting XI for Sunday's LaLiga game against Celta Vigo.

With his place on the teamsheet confirmed for the fixture, the winger officially passed the six-year mark since he last missed a league match for Los Leones, and he extended his own Spanish top-flight record of consecutive games to 224.

That's a full 2,191 days without skipping a single La-Liga game through injury, suspension or non-selection -- a phenomenal achievement for any player, but especially for an attacker.

Unfortunately he was unable to crown his momentous appearance with a victory to fit as his team fell to a 2-0 home defeat to Celta at San Mames which included a ridiculous long-range strike from Fran Beltran.

Williams has been the proud owner of the record for consecutive appearances made in LaLiga since he registered No. 203 in October, having started his Herculean run on April 20, 2016 with a 1-0 defeat against Atletico

His achievement is made all the more noteworthy by the fact that he's still only 27 years old, meaning he hasn't missed a single league game for Bilbao since he turned 21 during his first full season as part of the firstteam squad at the Basque club.

To put that in perspective, at that point in time Kylian Mbappe had just one senior career goal to his name, a 15-year-old Erling Haaland was still awaiting his firstteam debut at hometown club Bryne and VAR was just a twinkle in the eye of the International Football Association Board.

In starting the 1-0 win over Alaves on Oct. 1 last year, Williams officially surpassed the previous LaLiga record for consecutive appearances (202 games) which had been held by former Real Sociedad defender Juan Larranaga since 1992.

The Bilbao star is in an exclusive club of successiveappearance record-holders in Europe's top leagues, though the winger is largely rubbing shoulders with goalkeepers who played into their late 30s and beyond.

For instance, the Premier League record is held by former United States international Brad Friedel who went 310 straight games without missing a single league fixture, smashing the previous record (166 games) along the way before bringing his epic run to an end at the age of 41 by starting for Tottenham Hotspur against Manchester United in September 2012.

Likewise, the Bundesliga record is held by a goalkeeper, namely Sepp Maier. The Bayern Munich legend played 442 league games on the bounce between the 1966-67 and 1978-79 seasons, and he played in every single game in all 13 of those campaigns.

The Serie A record for consecutive appearances is held by the great Dino Zoff, who tended the nets for Juventus 332 times between 1972 and 1983.

Wayne Rooney's Derby relegated to 3rd tier of English soccer

DERBY County, managed by England and Manchester United great Wayne Rooney, was relegated to the third tier of English soccer on Monday to cap a miserable season that also saw the club docked 21 points for breaches of financial rules.

A 1-0 loss at Oueens Park Rangers left Derby 10 points from safety with three games remaining in the secondtier Championship.

Derby has been in administration – a form of bankruptcy protection - since September, with the debtladen club's sale to a new owner yet to be finalized.

It received two separate points deductions of 12 and then nine, because of accounting breaches under previous owner Mel Morris, at the start of the season.

"We know we'd be safe without the penalties we've had," said Rooney, who has been Derby's manager since November 2020, having previously been player-coach at the team from central England. "This is where we've been left by the previous owner and we've been trying to pick up the pieces from that and trying to pull off something really special. We've got close and haven't managed to do it.

"I'm sure Mr. Morris watched the game at home. He'll be disappointed himself, because we've tried to fix the mess he's left us in as best we can."

'Annoyed' Xavi blasts 'really bad week' for Barca

BARCELONA

ARCELONA coach Xavi Hernandez was annoyed with his team's lack of determination as their slim LaLiga title hopes were shattered on Monday with a 1-0 defeat to Cadiz at Camp Nou.

Lucas Perez scored the only goal of the game after 48 minutes to silence the home crowd and leave Barca 15 points behind leaders Real Madrid, who came from behind to win at Sevilla on Sunday, with just seven games left to play.

Xavi said he was angry with the nature of the Cadiz loss and his players are "pissed off" following a second defeat at Camp Nou in the space of four days after being knocked out of the Europa League by Eintracht Frankfurt on Thursday.

"We are angry, the players first, because we missed a golden chance to separate ourselves from those in the fight for the Champions League places and also to [keep] fighting for LaLiga, which we've practically said goodbye to now," Xavi conceded in a news conference.

"I am annoyed and we have to be self-critical, myself first, as the coach. We're playing to be in the Champions League, that's why I am so angry. There was a lack of desire and determination. It's been a really bad week and we have to turn things around as soon as possible.

"The players are pissed off. I've tried to encourage them after the match, but Spain qualify for the Cham-change their ticket policy, Cup in 2020, creating a man rights groups at the

"We're not in a bad situation," the coach added. 'Things have improved since we took over in November, but we have to keep improving.

"We have to look ourselves in the eye and have more desire because we cannot lose at home to Cadiz. This is Barca and we have to do more. We have improved, but we wanted to do more and fight for trophies."

pions League and Barca are currently second, level on 60 points with Sevilla and Atletico Madrid, albeit with a game in hand. Below them, Real Betis have 57 points and Real Sociedad

"To qualify for the Champions League next season, which is our main objective, we have to improve and play with more impetus," Xavi said. "We have seven finals left and we have to grit our teeth because there is a lot at stake.

"It is not an attitude [problem], the players want it. It is a question of faith and of giving everything to take advantage of an opening. Cadiz defended as if it was their last-ever game for the whole match

and we have to equal that." Monday's game was played in a strange atmosphere at Camp Nou. After around 30,000 Frankfurt fans gained entry to the home end on Thursday, prompting the club to some fans decided to stay away in protest.

The singing section behind one of the goals was left empty, with the supporters' group in charge of the section explaining ahead of the match they were boycotting because they felt "humiliated" at feeling like an away side in their own stadium against the German side.

Other fans, meanwhile, protested outside Camp Nou before the game. Around 100 supporters gathered to chant against president Joan Laporta and call for his resignation.

Meanwhile, Gerard Pique has denied any wrongdoing after audio recordings stolen from the Spanish football federation by hackers revealed the Barcelona defender helped to negotiate a €24 million (\$25.9 m) commission to take the Spanish Super Cup to Saudi Arabia.

"Final Four" and moving the competition to Saudi Arabia as part of a deal that was reportedly worth €40m per tournament for the federation.

"I have nothing to hide, everything we have done is legal," Pique said during a stream on his Twitch channel on Monday. "I will give my side of the story in terms of the conflict of interest. It's not something I will hide from, I feel proud because we have done a spectacular job.'

Pique's Kosmos group will be paid €4m per tournament by the Saudi organisers for negotiating the six-year agreement, according to El Confidencial newspaper, which released the audios on Monday.

Pique said in the audio recordings that the money would be divided between the clubs, and the federation would keep about €6m. The federation told El Confidencial there was nothing illegal in what was said in the audios or in the negotiations, and the details of the deal had already been released.

Pique had a similar message following the release of the audio.

"[The audio was] leaked with bad intentions and making news of something which two years ago was not news," he said. "The only illegal thing is leaking the audios.'

Coach head-butting referee, fans threatening players -- Can Brazilian football stop a troubling trend?

THE match in Brazil on April 10 between Desportivo Ferroviaria and Nova Venecia was not supposed to be a major national event. It was in the quarterfinals of the championship of the state of Espirito Santo, not seen as one of the hotbeds of the Brazilian game.

But, thankfully, the game

was sufficiently important

to count on the presence of TV cameras. Because what happened at halftime ended up being seen all over the world. Ferroviaria coach Rafael Soriano was outraged by the officiating. He stormed onto the field to remonstrate with the referee and his assistants. Tempers flared with Marcielly Netto, a female assistant, and Soriano clearly gave her a headbutt. It was an outrageous display of aggression -which Soriano immediately denied. If he was accused of a head-butt, he raged, the matter should be discussed to the police. He threatened to sue Netto, adding that she was trying to take advantage of being a woman, and other such incoherent nonsense. But there was no arguing with the TV images. Ferroviaria sacked him, and he faces a long suspension.

Soriano apologised for his actions. But the question remains; how could he have engaged in such delinquency? Football is a game of emotions -- in the wise words of sociologist Rogan Taylor, it is like strong beer -- some
