Bangkok SK cloth factory duplicate set for Mlandizi

Once I visited Kilonda in Bangkok, I was impressed by his investments...

A TANZANIAN businessman, Suleiman Kilonda, who operates a cloth dress making and printing enterprise geared for exports in the Thai capital of Bangkok, is seeking to duplicate the firm in the country by the end of this year.

He said in a telephone interview yesterday that the plant with capacity for 100,000 printed dresses per day will eventually employ more than 2,500 Tanzanians.

The entrepreneur who was recently presented with a creative award by

the Ministry of Minerals said the cloth making enterprise will serve as a learning centre for people wishing to do a similar business.

A ministerial delegation toured Thailand and visited his SK Export factory, earning the recognition to acknowledge his contribution in promoting sales of of Tanzanian minerals by embedding the precious stones in his

He had obtained a plot of more than 1,000 acres for factory outlays at the Mlandizi area in Kibaha District, Coast Region," he said, noting that drawings of the prospective factory have already been made.

While still mobilizing funds to start construction, he explains his satisfaction t operating the Thai clothing factory and shops as outlets for his fabrics, with more than 200 people employed in the shops.

Serengeti picked best national park in Africa

SERENGETI National Park has been voted Africa's leading national park for 2023, raising the country's profile as a premier tourist destination.

The award was given by World Travel Awards (WTA), a franchise of the World Media And Events Ltd events management firm based in London, delivered the award at a red-carpet gala ceremony at Atlantis, The Royal Dubai hotel in the UAE over the

weekend. WTA has often picked Serengeti for this ranking, staring in 2019, 2020, 2021, 2022 and now 2023, the organisers affirmed in declaring Africa's leading national park of the year 2023 as the Serengeti.

Izumbe Msindai, a top official of the Tanzania National Parks (TANAPA) who was in Dubai, said the award was delivered at the weekend, with WTA praising Serengeti National Park "for maintaining her well-

PM outlines govt moves to end agro-sector drawbacks

We are scaling-up the use of digital technology for planning, monitoring and evaluation...

PRIME Minister Kassim Majaliwa has assured the Food and Agriculture Organisation of the United Nations (FAO) and stakeholders of its intent to address challenges in agriculture, livestock and the blue economy.

He made the remarks yesterday at the World

at the FAO headquarters in the Italian capital of Rome, where FAO member states deliberated on solutions for challenges in agrifood systems as related to the sustainable development goals.

The premier said improving agrifood systems seeks to ensure food security, higher incomes, creating jobs and promoting sustainable development while safeguarding the health of the planet.

The government is investing in the livestock sector by improving access to high productivity livestock breeds, strengthening pasture and water services, along with livestock research and training service, animal health, improving extension services and value addition of livestock products

Despite ranking second in Africa in terms of

contribute 7.4 percent to Tanzania's GDP, with the sector growing at 2.6 percent per year, he said.

The sector's growth largely reflects increases in livestock numbers rather than productivity gains, while the government is working on a robust public-private partnership in the fisheries sector, he stated.

This would promote adaptive management for sustainable fisheries resources, establishing breeding programmes and centers for raising production of freshwater and marine farmed fish species, he elaborated.

"To harness potentials of the blue economy, we are promoting both catch -fish and aquaculture, building a new fishing port, while promoting joint ventures in deep sea **TURN TO PAGE 2**

TIB Bank hands out 980.7bn/loans, one third to agriculture

TIB Development Bank had up to September 30 invested a total of 980.7bn/- to finance various small and large-scale projects in agriculture, mining, transport, communications, energy, water, health and industries.

Lilian Mbassy, the bank's acting managing director, set out the bank's plans at a meeting with members of the Editors Forum in Dar es Salaam vesterday, highlighting plans to start investing heavily in strategic projects such as railways, dry ports, mining, roads and energy to further support the government's development endeavours

As the bank nears one year since being restructured at the start of the year, it is functioning not only as a corporate bank but as a development institution financing local government infrastructure projects such as land surveys, upgrading agricultural markets and development of small businesses, she said.

Its loan portfolio had disbursed a total of 334bn/- to support agriculture sector projects, with 253 projects supported in 23 regions, she said.

Envisaged strategic projects include ship rehabilitation projects, expansion of sugar factories, construction of pipe production

fishing, fish cage farming and seaweed production among coastal communities," he explained.

He affirmed that Tanzania has attained more than 100 percent grain self-sufficiency ratio for over two decades now, with the agriculture sector growing at an average of five percent annually.

The sector contributes 26.2 percent to the Gross Domestic Product (GDP) and 24 percent of export earnings, he further noted, pointing at the Agenda 10/30 roadmap to accelerate the Agriculture Sector Development Program phase two (ASDP II).

It especially involves facilitating youth and women participation in commercial agriculture to push towards raising agricultural export value from \$1.2bn at present to \$5bn at the end of the decade, he stated.

To achieve these ambitious targets, the government is investing in priority areas such as irrigation and water efficient technologies, increased access to agro inputs plus improved seeds production.

He also set out the need for research and development, concretizing application of digital technology in extension services, harnessing po-

tentials of the blue economy, storage and marketing infrastructure and agro-processing.

He told the audience that the government had increased budgetary allocations for agriculture from \$88m in 2020/2021 to \$420m in 2023/2024, affirming that Tanzania had embarked on scaling up infrastructure development including railway, road network, rural electrification and investment in agro-inputs industries such as fertilizer.

"We are scaling-up the use of digital technology for planning, monitoring and evaluation. The technologies provide business support services such as information to farmers via mobile platforms," he specified.

He bemoaned negative perception towards agriculture, limited agricultural entrepreneurial skills, poor access to land, limited accessibility to financial services, markets alongside the effects of agricultural labour saving machinery and digital technolo-

Still, the government was conducting an agro-based youth employment programme implemented via publicprivate partnership through block farming, expected to generate over 1.5m occupational openings and contributing to food system resilience.

industries and expansion of dry ports, she elaborated.

These investments help to catalyse the realisation of national economic goals as these projects create up to 10,000 job openings, as the financing includes loan capital for 12 financial institutions, 78 savings and credit cooperatives (SACCOS) and 128 companies supported through loans, she asserted.

Water sector projects accessed 14bn/- loans for a total of 66 projects, six water authorities and 60 water user associations in rural areas, she said.

Dodoma, Singida, Shinyanga, Tanga, Mtwara, Iringa, Morogoro and Ruvuma regions water projects obtained project loans for water outlays reaching 750,000 people, she said.

The bank also disbursed upwards of 12bn/- for the energy sector directed at six major projects in Dar es Salaam, Iringa, Ruvuma, Coast and Manyara regions, facilitating the generation of 8.8megawatts added to the national grid, the director specified.

Of considerable interest is the Tanzania Rural Electrification Expansion Programme (TREEP) to support access to power and collaborate with the United Nations Industrial Development Organization (UNIDO) to stimulate ethanol energy use, she said.

TIB, UNIDO and partners initiated the roll-out of 500,000 ethanol cook stoves for households in various parts of Dar es Salaam, she said, pointing at a range of strategic projects implanted by the Tanzania Petroleum Development Corporation (TPDC) and Wentworth Resources in natural gas.

TIB also supported the Tanzania Electric Supply Company (TANE-SCO) in supply of power plants in the Somanga-Fungu settlement of the National Housing Corporation (NHC) along with, Kagera Sugar Ltd sugar processing factory projects, Amiri Hamza Ltd for coffee processing, CATA Mining Co. Ltd in the gold mining and processing, Pipes Industries Co. Ltd and others, she stated, vowing supporting for government initiatives to fight poverty by enhancing financial capacity and sensitizing local entrepreneurs on the benefits of small loans.

Deodatus Balile, the chairman of the Tanzania Editors Forum (TEF) commended TIB for financing various projects to stimulate development.

BoT issues new regulations to govern foreign exchange

THE Bank of Tanzania (BoT) has issued new regulations to govern foreign exchange (Bureau de Change) business with the maximum capital to commence the trade being 1bn/-.

In a statement issued yesterday, BoT Governor Emmanuel Tutuba said the new regulations have been divided into three classes of bureau de change licenses of Class A, B and C.

He said the new changes are aimed at expanding the foreign exchange market in the country.

He said that for those (locals and foreigners) who will operate bureau de

change shops of class A, will be allowed to open new branches anywhere in the country.

Foreign-owned bureau de change shops with class A will require a minimum capital of 1bn/- while those owned by locals must have a minimum capital of 500m/-.

"Class A licence will also be allowed to engage in a wide range of financial activities which include making instant transactions, sending money and doing business as a bank agent, financial institution, insurance company, mobile money service provider, or any other financial services as approved by the central bank," he said.

Tutuba said Class B bureau shops are supposed to be owned by locals by hundred per cent and is licensed to deal with spot transactions, with a minimum capital requirement of 200m/-

Class B shops also will not be allowed to conduct instant transactions, acting as agents of banks, financial institutions, insurance companies, mobile money service provider, or any other financial services as approved by the central bank. "A person who intends to run a Class A or B foreign currency exchange shop will be required to apply for a licence by writing a letter to the Bank, and that the application needs to be signed by the director," he added.

He further noted that Class C bureau de change is a shop established in a three star hotel or above to deal with spot transactions to hotel customers only.

However, a Class C bureau de change shop establishments will not be restricted with a minimum capital requirement.

Furthermore, the applicants of Class A or B bureau de change shops will be required, within six months after the initial approval, to submit to BoT, a bank account statement containing the shop's name showing the amount allocated as capital paid in local or foreign

Speaking later during a meeting to commemorate 60 years since the establishment of Singida Region, Minister for Agriculture Hussein Bashe said the programme to distribute sunflower seedlings for free to farmers in regions of Singida and Dodoma was on track saying the ministry has already 300,000 tons of seeds to facilitate production of one million tons of edible

Minister for Water Jumaa Aweso said the ministry has reached out to more than 2,600 villages which have not received water saying the remaining two years, the government will finalize the exercise. "On the plan to reach a 95-per cent water coverage in urban areas, the ministry has already reached 80-percent and the target is that by the next two years, we will be done," he said.

TIRDO for technologies efficient in use of energy

THE Tanzania Industrial Research Development Organization (TIRDO) has urged stakeholders in the construction sector to prioritise on energy auditing efficiency in order to reduce energy consumption.

In an interview with this paper in Dar es Salaam at the weekend, TIRDO marketing manager, Burhan Daudi said if energy efficiency is well practiced, what is served can be used in other investments.

He said the target of any investor is to generate higher profit although most of them in the construction sector have been incurring huge costs in energy consumption.

Daudi said that TIRDO in collaboration with the energy efficiency project which is being implemented by the Ministry of Energy and the United Nations Development Programme (UNDP) with financial support from the European Union (EU) and UNDP, is now showing case energy management practices and providing information on energy auditing services to industries, commercial buildings and households.

The activity seeks to enhance awareness and understanding among large

energy consumers by exploring the benefits of energy management practices through energy auditing so far demonstrated at the three mentioned

"I would like to remind them when investing in industries, commercial buildings and households, to involve TIRDO as part of the energy efficiency auditing strategy to reduce energy in the above respective areas. This in return helps them to get more profit, create employment and use less energy for the better future of the country's energy," he added.

According to him, TIRDO has set short term, midterm and long-term plans to raise awareness to key stake-

Furthermore, as part of a long-term plan, TIRDO seeks to make it mandatory for every factory or industry to have an expert in energy efficiency management.

"TIRDO seeks to meet with construction stakeholders one after another and train them how to manage energy efficiency in "building designing"," he

Currently, the Ministry of Energy and UNDP are implementing Tanzania's the 1st Energy Efficiency Action Plan, with financial support from the European Union (EU) and UNDP.

The overall objective of the Action Plan is to ensure access to affordable, reliable, sustainable, and modern energy for all in Tanzania

Key milestones achieved by the project so far include a pilot energy audit conducted by TIRDO for selected three large energy users in Dar es Salaam on Energy analysis, evaluation, and implementation of energy efficiency measures or energy conservation measures.

The aim of the pilot energy audits was to demonstrate best energy management practices to enhance energy efficiency in the country.

Cashew farmers to benefit from South Korean new technologies zania will increase cashew nut production from

SOUTH Korean company–Mirae Green Chemical Co. Ltd has come up with a comprehensive strategy to support cashew nut farmers and encourage them to use modern technologies for increased yields and income.

Charles CM Lee, the company's Executive Vice President said yesterday that during implementation of the strategy, the company will assist cashew nut farmers to adopt modern practices that will increase efficiency and production.

Farmers will be assisted to look for markets of what they produce, Controlled Release Fertilizer (CRF) to increase crop yield and training so that their products meet international market stand-

According to him, the demand for Tanzania's cashew in South Korea is huge.

"We decided to embark on this strategy after conducting an in-depth feasibility study of cashew- value chain in Mtwara Region, Mkuranga District, Coast Region and other places. We discovered that farmers are producing below the capacity due to various factors including lack of funds to purchase fertilizer," said Lee.

He said they have so brought the CRF fertiliser from Nousbo Company in South Korea to the Tanzanian market and to government institutions dealing with cashew nut production, adding they are waiting for government approval.

He said if farmers use the CRF fertiliser, Tan-

300,000 tonnes per year to 1.4 million tonnes per year, making Tanzania the leading producer in the world.

Currently Tanzania's cashew production stands at 300,000 tonnes per annum while cashew nut production per one hectare is 300 kilograms. With the use of South Korean fertilizer, farmers can produce 1500 kilograms, an increase by five

Lee said they have met with Dr Fortunus Kapinga, director at TARI- Naliendele centre to discuss the fertiliser.

"Researchers at TARI were interested in our fertilizer; promising to test it at one of the cashew trees to see how it will increase production," he said, adding that CRF is an eco-friendly fertiliser with no side effects and is sold at \$1per kg.

The South Korean firm exports fertiliser to more than 50 countries around the world.

Juae Park, the company operation manager added: "As the company we will purchase raw cashew nuts from farmers and provide fertiliser to farmers without payment to ensure the crop is of the required quality."

"CRF fertiliser has excellent effect even in areas where fertilizing is difficult due to drought or heavy rainfall; it contains an ideal balance of NPK and micronutrients which prevents nutrients deficiency disorders, optimised for fruit trees and supplies plant with all nutrients until harvest by fertilising only once a year," he said.

Tanzanians called upon to guard village forests

TANZANIANS have been urged to take care of and protect village forests in their areas by avoiding human activity that contribute to forests destruction including farming, setting fires and illegal harvesting of forest

Emmanuel Msofe, chief forests officer from the Forestry and Beekeeping Department in the ministry of Natural Resources and Tourism in charge of community forests extension education made the remarks here at the weekend as he spoke to this reporter.

ORCI promises to continue investing in provision of quality palliative care

OCEAN Road Cancer Institute (ORCI) has promised to continue investing in provision of palliative care to patients which include training more staff to support and improve quality of life of the survivors.

Palliative care is specialised medical care for people living with a serious illness, such as cancer or heart failure. Speaking during the commemoration of the World Hospice and Palliative Care Day (WHPCD) 2023 at the weekend, ORCI executive director, Dr Julius Mwaiselage said the institute's core focus was to bring new hopes to patients by relieving them from illness and

This year's theme is Compassionate Communities: Together for Palliative Care. WHPCD is an annual unified day of action to celebrate and support hospice and palliative care around the

He noted that palliative care is an approach to care that addresses the person as whole, not just their disease by helping everyone affected by cancer diagnosis to achieve the best quality of

He said the palliative care section at

ORCI strives to ensure patients are provided with the quality services regardless of the cancer stage.

"Currently Ocean Road Cancer Institute provides hospital based palliative care and home-based palliative care, our special unit is responsible of coordinating care of terminally ill patient and the clinical, nursing and social services, assess pain and other distressing symptom, prepare and administer mechanism to comfort patients when are in distress or in pain at the hospital and at their home as well as counsel patients and relative on natural course of the illness and the mitigating effects of all therapies," he explained.

Last year, Ocean Road served 46, 061 patients in the Palliative care out of the total 65,000 patients who were served at the hospital, something which translates to many patients are attending hospital at late stages.

He said in order to provide quick relief to patients who undergo severe pain, the hospital is providing special medicine known as morphine which is the best to remove the pains.

He said the institute is currently implementing a number of initiatives meant to expand cancer prevention services in order for the service to be

prominent and to have a nation-wide coverage.

"Cancer prevention services are a set of strategies and activities that are taken to lower the chance of getting cancer in a community. By preventing cancer, the number of new cases of cancer in a group or population is lowered and this will translate into a lower number of deaths caused by cancer" he noted.

Dr Mwaiselage said the institute aims to reduce the burden of cancer in the communities through increasing cancer awareness and prevention by engaging in partnerships, collecting and reporting data, assuring quality data, providing and supervising public and professional education, and assuring availability of quality services for screening, early detection and prompt treatment.

Dr Faraja Kiwanga, cancer specialist at the ORCI said apart from palliative care, the hospital is providing quality cancer services including chemotherapy, surgery and pain reliever services.

She said the hospital has invested in educating the public on risk factors for cancers and preventive measures and implementing cancer screening and early detection programmes.

CSO calls for advancing of teachers' welfare for improvement of education sector performance

THE Organisation for Community Development (OCODE) has urged the government to increase investment in teachers' welfare and working conditions in order to enhance provision of quality education to students.

According to OCODE, enhancing the sector's performance should start by addressing the shortage of teaching staff in schools which is currently a great burden.

Speaking on the sidelines of the celebrations of the International Teachers' Day in Dar es Salaam over the weekend, OCODE education project manager, Digna Mushi, revealed that among the challenges impeding the development and performance of the sector is the low welfare status for teachers.

"The teaching profession is not receiving the recognition it deserves. As a result, many youth do not prefer entering into the profession because, the fact that only a handful of countries have a record of paying teachers good salaries. And if you look at it on the other hand, the working conditions are difficult and they are supposed to teach so many students in one class. These circumstances do not attract the upcoming scholars to pursue teaching as a career," she said.

Mushi said that the celebrations for this year themed: "The Teachers We Need, The Education We Want", is a part of a call for governments and nations across the globe to review the problem of the shortage of teaching staff in schools through hiring teachers and improving their welfare.

Gaudence Kapinga, country facilitator from the Regional Education Learning Initiative in East Africa (RELI) said the commemorations of the world teacher's day is not only tied to honouring teaching professionals alone but also serves as a platform for informing communities on the role of teachers in the society.

"Commemorating this day is not only for teaching associations alone or just because OCODE has ventured to do so, however, it is a day to appreciate

teachers and I would call upon other institutions to follow suit so that this day can be prioritized and expand the public's awareness and understanding on the role and position of teachers,"

Kapinga also highlighted that teaching profession stands last in the career options of many youths citing that many young scholars in universities studying teaching as a profession claim the field was their last option with some saying they pursued teaching as a faculty so as to have access to student loans.

"We also need to create more awareness in the society that teaching is a respectable career and this has to include the improvement of the welfare of the profession so as to make it attractive to the community," he emphasised.

Flora Msigwa, a teacher from Malamba Mawili primary school in Dar es Salaam expressed her gratitude for the organisation's effort to improve the education sector in which she urged the government to find means to adapt the approach and techniques in gradual stages as a means to address the challenges facing teachers in schools.

KCI conducts heart surgery on 37 children

JAKAYA Kikwete Cardiac Institute (JKCI) has conducted heart surgeries on 37 children including a one-month old infant who was born with four heart ailments including an artery that was supposed to shut up soon after birth.

The five-day medical treatment camp at the Institute has saved 950m/- that would have been spent to treat the children outside the country.

JKCI specialist on children's heart diseases, Dr Godwin Sharau explained at the closure of the special five-day camp that involved JKCI specialists and Mending Kids from the US.

He said 16 children underwent major heart surgeries by plugging holes, fixing heart valves and blood veins that were defective and added that had the children been referred to health facilities outside the country the cost would have been not less than 250m/-.

"This treatment for the first batch of 16 children done at JKCI cost 90m/- and some of the children were exempted from meeting the cost due to the parents' economic situation.

"At this camp, we have conducted major surgeries to children of different ages beginning one month to five years old," he said.

Dr Sharau added that this year is the 10th since JKCI started collaborating with the US institution which has borne fruit and every year experts from the foreign institution come to JKCI with new means of treatment and provide medical devices to children without cost. "In developing countries, heart surgery on children is very much developed, our institution is doing well to treat children with heart problems, and that is why we continue to collaborate with developing countries aimed at enhancing our skills," he added.

For her part, children's heart diseases

specialist JKCI Dr Stella Mongella said surgery on small holes using cathlab device for 21 children born with the defectives were treated at the camp.

She said minor heart surgery for the children cost under 100m/- but had they been referred to outside the country the cost would have been not less than 700m/-.

Specialist on children's heart diseases from US Mending Kids, Dr Darren Berman said doctors from the institution will continue to work together with JKCI specialists.

"Through our health camps here at JKCI we have conducted heart surgery to an eightmonth child who had a hole in his heart and have succeeded to save his life," said Dr Darren. He added that the knowledge in conducting surgeries on children with heart problems at JKCI has increased, hence now there will be no need for Tanzania children to be taken outside the country for treatment.

Samia to launch project at ASA's Kilimi Seeds farm in Tabora today

PRESIDENT Samia Suluhu Hassan is expected to launch the project for the installation of the modern irrigation scheme (Center Pivot Irrigation Machines -CPIM), at the Agricultural Seeds Agency (ASA) farm in Nzega District, Tabora Region.

The envisaged event is scheduled to take place today at the ASA's Kilimi Seeds farm based in Nzega District, Tabora Region.

Centre-pivot is a method of crop irrigation in which equipment rotates around a pivot and crops are watered with sprinklers.

ASA's Chief Executive Officer Dr Sophia Kashenge said that the 6.3bn/- worth project at the vast farm in Nzega District had already seen at least 220 hectares installed with the high-tech irrigation facilities, being its first phase.

According to her, the second phase will involve a total of 180 hectares, bringing up to a total of 400 hectares available at the farm. "Preparations for the launching of the project continues at impressive speed, and we are very thankful for the way president Samia has always been there to ensure the agency runs its activities at deserved standards and speed in order to heighten the country's seed production

sector, "she expressed. Dr. Kashenge unveiled the state-owned seed agency was also implementing the similar helpful project at its numerous seed farms

across the country. "At Arusha's Ngaramtoni seed farm the project is currently at 50 per cent, the ongoing project works to install a total of 200 hectares, as well as at the Morogoro-based Msimba farm located in Kilosa

district, "she said. She observed that the projects will cover a total of 800 hectares at the three seed farms, expecting to gobble up to 18bn/- upon completion.

Soon after President Samia launched the modern irrigation technology at the Kilimi farm, she said the facility will soon start to operate.

THE FOREIGN EXCHANGE (BUREAU DE CHANGE) **REGULATIONS, 2023**

The Bank of Tanzania wishes to notify the general public that the Foreign Exchange (Bureau de Change) Regulations, 2023 have been issued under the Foreign Exchange Act, Cap 271, through Government Notice No. 730 of 2023, published in the Government Gazette on 6th October 2023.

The Regulations, among others, have introduced three classes of Bureau de Change licences as follows: -

1. Class A

- (a) Class A bureau de change shall be a foreign owned or locally owned bureau de change allowed to open branches anywhere in the United Republic of Tanzania.
- (b) Foreign owned Class A bureau de change shall be required to have minimum capital of one billion Tanzanian Shillings.
- (c) Locally owned Class A bureau de change shall be required to have minimum capital of five hundred million Tanzanian Shillings.
- (d) Class A bureau de change shall be allowed to conduct spot buying and selling of foreign exchange, money remittance transactions, carry out business as agent of bank, insurance, mobile network operators, or any other financial related activity as may be approved by the Bank of Tanzania.

2. Class B

- (a) Class B bureau de change is a bureau de change with local shareholding. (b) Class B bureau de change shall not be allowed to open branches.
- (c) Class B bureau de change shall be required to

maintain a minimum capital of two hundred million Tanzanian Shillings.

(d) Class B bureau de change shall be allowed to conduct only spot buying and selling of foreign exchange with a single outlet, carry out business as agent of bank, insurance, mobile network operators, or any other financial related activity as may be approved by the Bank of Tanzania

3. Class C

- (a) Class C bureau de change is a bureau de change established in a hotel of a rank of three stars or
- (b) Class C bureau de Change licence shall be issued exclusively to a hotel or hotel owner.
- (c) Class C bureau de change shall not be required to maintain minimum capital.
- (d) Class C bureau de change shall consist of hotels intending to offer spot buying and selling of foreign exchange to the hotel's customers only.

China partially right on global fake news concerns at present

OR a few months top information executives in China have been mounting a charm offensive with journalists engaged in a four month training stint to get a keen grasp of the Chinese view of global affairs. One vital issue is to comprehend the Belt and Road Initiative that has directed Chinese strategic interactions since President Xi Jinping came to office in 2013 and is still relevant, though being adapted to changing conditions, Another international workshop involving African journalists at the weekend referred merely to the ancient Silk Road, not BRI per se.

A senior Communist Party of China (CPC) official with responsibility for information was making a case for African journalists to take caution in handling news as there is a galore of fake news in numerous media outlets.

The trouble in that assertion wasn;t whether that was true or not as definitely it is true, but in the capacity of journalists to distinguish between real and fake news.

The CPC official gave a particular view of global affairs and where the fake news comes in, whereas if the journalists were in a Western country they would be told that view is part of fake news, that this isn't how the world is organized; there are things not stated.

One fairly enlightening aspect of the information cadre's remarks was the need for journalists to make an effort to seek accurate information from reliable sources given the current global environment.

The earlier trap was not missing, in the idea that an African journalist or any other can credibly tell valid from fake news, and the proof is to read a fairly controversial statement and ask a group of journalists, picked at random, to decide its validity. Responses will be

OR a few months top ideologically inclined, tied to explicit information executives in perspectives of where they come from, china have been mounting or news outlets they serve.

In that case, the central committee deputy director of the Publicity Department and director of the State Council Information Office, was actually giving a specific picture of what is correct in the world today, and what is not.

Many in his audience were sympathetic and definitely in tune with his remarks, but there are numerous nuances at national and global level to be sure countries or stakeholder agencies are talking about the same thing.

There are too many changes around the world to make out what position is valid and what is not, for instance supporting economic links is not identical with taking political positions. Trade with any country is one thing, while international disputes involving this or that country is a different issue.

Another aspect the state information guru noted was that news is an established business and everyone wants to get into it even non-professionals. This occasions the spread of fake news far removed from global joint efforts of strengthening culture exchange, safeguarding peace, unity and fostering win-win economic development.

He said journalists should advocate people to people exchanges and cooperation, serving as a bridge between communities of different backgrounds. All that is valid and is indeed taking place, so his remarks helped to intensify the bond between the visiting journalists and China. It doesn't solve the wider issues.

Not even within countries and indeed within the journalism profession can one credibly draw a line between news and fake news as opinion is embedded in news.



How complaints against judges are handled needs to change

HE Judicial Commission's threaten accountability independence.

The long delays in dealing with complaints against Judge President John Hlophe and Judge Nkola Motata have shown that there are major challenges in holding judges accountable for misconduct.

Problems with the process have serious implications for public confidence in the judiciary, and for the rule of law and constitutional democracy.

Judges are vested with extensive powers, and their independence is strongly protected. If these powers are abused and errant judges cannot be removed from office, the potential repercussions are far-reaching.

Complaints are dealt with by the Judicial Service Commission (JSC). In a labyrinthine process, these complaints are received by the Judicial Conduct Committee (JCC). Complaints may be dismissed outright and less serious complaints may be dealt with via a range of sanctions short of impeachment.

For more serious complaints, which (if proved) may lead to the removal of a judge from office, the JCC will recommend to the JSC that a Judicial Conduct Tribunal (JCT) be established to conduct an inquiry. The finding of the Tribunal must then be endorsed by the JSC. If this results in a recommendation that a judge be removed from office, the matter is then sent to Parliament. If Parliament votes for removal by a two-thirds majority, the President must then formally remove a judge from office.

At the time of writing, no judge has yet been removed from office through this process. The possibility of removal is an important accountability mechanism, which is vital to securing judicial independence.

On the one hand, If judges could be removed at the whim of the executive or Parliament, this would weaken their independence.

What is required is a balanced process, one that enables accountability while securing judicial independence.

How the JSC has performed its role has been the subject of much criticism as it threatens both judicial accountability and independence.

In September, Freedom Under Law (FUL) hosted a webinar enabling civil society organisations to discuss the complaints process. We did so to begin developing civil society's suggested reforms to the complaints process. The webinar provided an opportunity for organisations to share their insights and experiences of the process.

FUL presented the findings of a recent research report, which examined the JSC's performance, and made suggestions for reforms.



Judges Matter shared insights from their research and monitoring of the complaints process, and #UniteBehind and Open Secrets shared their experiences as current complainants. Open Secrets, together with Shadow World Investigations, have lodged a complaint against retired Judges Willie Seriti and Hendrick Musi for their conduct in running the commission of inquiry into the arms deal.

#UniteBehind have lodged a complaint against Judge Tintswalo Annah Nana Makhubele for her conduct in serving as chair of the board of control of PRASA while simultaneously serving as a judge, and for her conduct while at PRASA, which is alleged to have enabled corruption.

These inputs provided a wide range of helpful insights into the functioning of the complaints process, and gave a remarkably consistent picture of its problems.

First, there is a problem with the basic institutional design. The complaints process is poorly designed, making the handling of a complaint so convoluted as to be almost unworkable. Timelines between different stages in the process can drag on interminably and each stage provides an avenue for potential litigation, with judges frequently taking the opportunity to litigate every point they can potentially on the state's dime. Many of the steps in the process appear to be unnecessary.

Second, there are issues of institutional capacity. The members of the JCC are sitting judges with busy workloads, which places a tremendous amount of strain on the processing of complaints. When deciding complaints, the JSC sits as a "small JSC" (without members of Parliament), and functions on an adhoc basis without any continuity. It has frequently been unable to complete its work due to failing to meet a quorum. The secretariat is also significantly under-capacitated.

These factors lead inexorably to a third problem, the notorious delays in deal with complaints;

the process. Complaints are dealt with extremely slowly, and the fact that so few cases have been finalised presents a fundamental problem of credibility. Without civil society organisations vigorously pursuing complaints, many complaints would likely not be at the point that they are now.

A fourth issue relates to the role of complainants in the process. Organisations that have been involved in bringing complaints describe frustrations with their role during hearings being circumscribed. They noted that it fell on them to create importus for complaints to proceed.

impetus for complaints to proceed.

A fifth issue is legal costs. There are two aspects to this. The first is the scope and responsibility of the payment of the legal costs of the judges defending themselves against complaints. For instance, the Makhubele tribunal's most recent postponement has been due to a dispute between Judge Makhubele and the state attorney regarding payment of her eightmember legal team, the costs of which are significant

are significant.

Another aspect is the costs incurred by organisations who have brought complaints and have played a significant role in the ongoing process. There is no way that these organisations are able to reclaim their substantial costs. To expect a small organisation to make such a contribution is problematic and puts complainants at a serious disadvantage.

There are further issues, such as a lack of transparency about the status and outcome of complaints, the JSC following an inconsistent practice in making recommendations to suspend judges facing serious complaints, and questionable decision-making by the JSC in determining the outcome of complaints.

Several suggestions for reform emerged from the discussions.

FUL's report highlights the need toincrease the JSC's capacity to

• introduce timelines for the resolution of complaints; provide a greater role for complainants;

provide better reporting;

• introduce a policy of default suspension for judges facing complaints of potentially impeachable conduct; and

• a greater role for retired judges, particularly on the JCC.

The role of retired judges prompted some interesting debate, with some reservations being expressed as retired judges may still be constrained by professional connections to former colleagues. And as the Open Secrets complaint showed, the conduct of retired judges themselves can be an issue.

Reform will likely need to take place in both the short and long term. In the short term, the capacity of the JSC could be improved by increasing the secretariat and staffing the JCC with more judges (retired or otherwise) to enable it to deal with complaints quicker.

The "small JSC" needs to be formalised as a permanent, working structure. In the longer term, institutional reforms need to be made, which may include re-writing the legislation to streamline the process and make it less vulnerable to litigation.

In the long term, it should be considered whether the legislation should outline a more ambitious manner to deal with judicial misconduct. Further, the desirability for judges to oversee their own misconduct processes, while acknowledging the need to balance independence and accountability, should be interrogated.

An important underlying issue was raised about the teaching of legal ethics. Some law schools do not have a self-standing course in legal ethics. Further, the legal ethics course offered by the law societies is taught in the context where students are focused on and driven by passing admission exams, leaving little room for critical engagement and careful study.

Unsurprisingly, the academic literature on legal ethics in South Africa is almost non-existent. There is a general lack of accountability in the legal profession with the Legal Practice Council exhibiting similar failings in its disciplinary processes as the JSC. This means that judges are being drawn from a profession with a lack of accountability.

The time is ripe for reform. At its October sitting, the JSC announced that it is seeking to have legislation amended to expand the composition of the JCC. This shows some recognition that the system is not functioning adequately and needs to be reformed. It is hoped that the JSC and lawmakers will embrace the further suggestions which emerged from this civil society engagement.

Kiswahili relevant for a broad range of functions at IMF, World Bank activities

enthusiasts will have jumped with excitement in the wake of ai Zanzibar cabinet minister. representing the Union authorities, asking that the World Bank and the International Monetary Fund (IMF) to make Kiswahili one of the languages of communication during its meetings. The minister said the need arises from the growth of the language and its wide use at regional and international levels. If East Africa wants language democratization at global level, they may incite project assessment or vision democratization with those agencies, whereas at present they just talk to experts.

So our language activists and policy makers need to realise that language like other instruments has two sides, one that is passive, agreeable and somewhat romantic, that diplomats will address this or that issue in Swahili.

At the same time it opens another avenue, in case local missions of the World Bank and IMF wish for it, as their offices can widen the use of the language by preparing leaflets and other write ups on projects or policies.

At present Bretton Woods missions talk to top officials rather than address themselves to public opinion, which could change if they are pushed to indigenize in relation to the language. We aren't there yet but it matters.

The minister said many of its member countries in sub-Saharan Africa speak the language, which it true to the extent that it means they understand the language.

The view was also aired that approximately 200 million people speak Kiswahili in the world, which isn't too far from adding up the population of Eastern Africa, and excluding the Democratic Republic of Congo. How far it is a global language is debatable in the least.

South Africa egg shortage: How poultry products became a hot commodity

GGS are currently South Africa's hottest commod-The country has been grappling with one of its worst outbreaks of bird flu - millions of chickens have been killed over the past few weeks, supplies of poultry meat have been threatened and supermarkets across the nation have run out of eggs.

Experts predict the egg shortage will cause the popular ingredient to jump in price - far from ideal considering it is one of the most affordable sources of protein for the millions living in poverty.

Retailers, farms and industry giants have also been hit, with the nation's largest chicken producer stating the flu had "ravaged" a sector already burdened by rising costs and an electricity crisis.

In an effort to stop the spread of Highly Pathogenic Avian Influenza - a deadly, extremely infectious type of bird flu - farmers have culled more than seven million egg-laying chickens. That amounts to 20-30% of the country's entire chicken stock, according to South African Poultry Associa-

As a result, social media sites have been inundated with pictures of bare supermarket shelves, while many shoppers found that shops still selling eggs have set limits on how many can be bought.


Online shopping sites are no better - several consumers hoping to buy eggs on the web have been met with "unavailable" or "low in stock" messages.

No more cheap eggs

Domestic worker Nomalanga Moyo buys eggs every week in order to make muffins for her children's lunchboxes. Her store of choice is a spaza shop - the term for a small informal outlet - in her township of Diepsloot. Here, she can buy any quantity of eggs - when funds are low, she is able to get just two eggs for about 2.50 rand (13 cents; 11p). However, this week, the store was totally out.

"I am now going to wait until I go to work during the week to see if I can find eggs at the normal shops. However, it will cost me more," a worried Ms Moyo said.

More than half of South Africans live below the poverty line. They already spend about 35% of their income on food and according to the Pietermaritzburg Economic Justice and Dignity research group, this share will likely increase as a result of the egg shortage.

"Not only will consumers spend more for eggs but the rising price of eggs will affect all other food products where producers use eggs and other poultry products," it said.

Businesses have also been impacted by the flu.

In a trading update at the end of last month, leading South African poultry producer Astral Foods said the outbreak had so far cost it \$11.5m. Astral said the flu has "spread at an alarming pace" and ravaged the poultry industry. The company also joined other producers in warning that South Africa could experience a shortage of chicken meat over the next few months.

Small businesses, which are less able to weather market shocks, have also voiced concerns.

"After baking scones for a client yesterday I was left with three eggs. I went shopping after to find more eggs but the price was too much for me," Zamapholoba Ngcobo, a bakery owner in the city of Pietermaritzburg said.

The shortage could not have come at a worse time, Ms Ngcobo said, as

wedding and graduation season means cake orders are at an "all-time high".

But where there are losers, it seems there are always winners. Ukulinga, a poultry farm in KwaZulu-Natal province, saw news of flu outbreaks in Brazil and Argentina earlier this year and implemented strict biosecurity measures as a precaution.

Nkululeko Ngidi, a manager at the farm, said: "When we started the farm we had to go out looking for business. Now that our farm is among the few that are free from bird flu, customers are looking for us.

"We have seen increased demand... we at the moment supply 130,000 eggs to businesses in the area on a weekly basis."

Unfamiliar strain

Farmers and industry experts estimate it will take six months for the poultry sector to replace en products on shelves are safe for consumption.

the chickens it culled - meaning any shortage of poultry products could last through the festive season and into 2024.

Paul Makube, an agriculture economist at First National Bank, told the BBC: "The outbreak has moved at a rapid pace, it is worse than what we saw during the outbreak in 2017. A further complication comes from the fact that we are dealing with a strain we have not previously dealt with."

Concern has spread beyond the border - Namibia, which imports most of its poultry from South Africa, banned poultry products from its neighbour amid the outbreak.

In an effort to reassure its consumers and businesses, South Africa's government announced that it is considering purchasing bird flu vaccines.

And for the lucky South Africans that can actually find eggs in the shops, officials have stressed chick-

Belt and Road Initiative contributes to global connectivity

RAINS loaded with Southeast Asian agricultural products such as durians and mangosteens are now frequently entering China through the Mohan railway port in southwest China's Yunnan province, along the China-Laos Railway.

Since the beginning of this year, the China-Laos Railway has transported over 14 million tons of goods to and from Laos, Thailand, Vietnam, Myanmar and other countries. The logistics vitality of the China-Laos Railway continues to rise, serving as a vivid example of the Belt and Road Initiative (BRI) promoting connectivity and fostering interconnected development.

Over the past 10 years, the BRI has taken "hard connectivity" of infrastructure as an important direction, "soft connectivity" of rules and standards as an important support, and "people-to-people connectivity" among partner countries as an important foundation. It has vitalized global connectivity and common development, improving global economic governance and promoting the healthy development of economic glo-

The essence of the BRI is to promote infrastructure development and connectivity, enhance coordination of economic policies and synergy of development strategies, foster synergetic and interconnected development, and achieve shared prosperity.

Over the past 10 years, the "hard connectivity" of infrastructure has been constantly enhanced.

Connectivity is about connecting physical structures. China's cooperation should extend to wherever roads,

railways, air routes and the Internet take it. The construction of six major international economic cooperation corridors and the development of surrounding infrastructure have been steadily advancing. Iconic projects such as the Jakarta-Bandung High-Speed Railway, the Mombasa-Nairobi Railway, the Addis Ababa-Djibouti Railway, and the Piraeus Port have been successfully completed. The China-Europe freight service now operates on 84 routes, connecting 211 cities in 25 European countries. The New International Land-Sea Trade Corridor reaches 465 ports in 120 countries and regions worldwide.

Thanks to Belt and Road cooperation, many countries have tackled long-standing infrastructure bottlenecks and integrated into the global supply, industrial and value chains.

HE devastating floods which killed thousands in eastern Libya a month ago were the result of a destructive force of nature, but BBC Arabic has uncovered evidence that mismanagement by the local authorities led to many deaths that could have been prevent-

There are three main accusations

Firstly, residents of Derna, the hardest-hit town, say they were told to stay at home rather than being evacuated even though it was known that Storm Daniel was coming.

Secondly, local and regional authorities are accused of failing to address the danger posed by the dams on the Derna riverbed, which runs through the town. Two dams spanning the Derna valley inland from the city burst on 11 September, causing the catastrophic flooding.

Finally, the authorities are accused of hindering the aid effort in the days immediately after the tragedy.

Anger in Derna escalated into protests on 18 September and the home of the mayor - who later resigned - was subsequently burned down.

The death toll remains unknown, with many bodies believed to have been washed out to sea. At least 4,000 people have been confirmed dead and another 10,000 reported missing in a town with a population of about 90,000.

Evacuation failings

Since the fall of long-time Libyan leader Muammar Gaddafi in 2011, the country has been divided between a UN-backed government in the capital, Tripoli, and a rival authority backed by military strongman General Khalifa Haftar, whose forces control eastern Libya, including Derna.

Ahead of the arrival of Storm Daniel, various bodies in the east held emergency meetings and subsequently issued instructions to the region's residents.

These generally focused on the evacuation of coastal and low-lying areas in Derna, and stay-at-home orders for other parts of the city and wider region.

But residents have told BBC Arabic that evacuation efforts were inadequate in a number of respects:

they focused on the wrong part of the city

the warnings did not reach many of the people that needed to hear them no sufficient provision was made for where evacuated people should


and there were various conflicting stay-at-home orders and curfews.

Residents of the town were generally instructed to stay indoors.

People living in specific areas on the seafront or close to the riverbed were ordered to leave their homes but there was no comprehensive or consistent list of areas to be evacuated.

Local residents told the BBC that some people who were evacuated from the seafront because of fears of

dangerous areas that were later flooded.

"There were no warnings of possible flooding, just that the sea levels might rise," a local engineer told the BBC. "Only those by the beach were asked to evacuate, but the rest of the city was asked to stay indoors.

The man, who has chosen to remain anonymous In fear of reprisal, lost his wife and two of his sons in the tragedy. He added that just a few hours before the flooding, a force from the interior ministry was going around asking people to stay indoors.

"Many of those that evacuated from the beaches went into central Derna, where they were killed by the later flooding," he said.

Preparations actually began well in advance of

On 9 September - two days before the devastating flood - the eastern government convened an emergency committee meeting and declared the following two days national holidays to encourage people to stay at home.

A curfew was declared in the region from 20:00 that evening and orders were given for the evacuation of "areas near the sea and low-lying areas located in the valleys of Benghazi and the entire eastern region".

The announcements generally called for people to move to "safe places", without specifying where they should go.

On the same day, the mayor of Derna made a similar call to evacuate various seafront and low-lying neighbourhoods.

But by 10 September, online announcements and video statements posted by the Derna police had dropped any mention of evacuation, and were focusing on the curfew and making sure people stayed at home.

Photos geolocated by the BBC show police patrols out on the roads following another official announcement which imposed a curfew "inside the rising sea levels were moved to more city as a precaution to prevent emergency, especially areas near the beach".

This proclamation came via a Facebook post, and many residents of Derna have complained that television and social media were insufficient means to alert people, especially given the disruption in the aftermath of Storm Daniel.

Red Crescent staff were also active in coastal areas in the days ahead of the flood - videos show them calling on people via megaphone to clear their homes to stay safe from Storm Daniel.

So notable efforts were made to move residents in some areas of the city, but all of these evacuations anticipated that the threat would come from rising sea levels, rather than the failure of infrastructure far inland and the Derna valley flooding.

Failure to heed dam warnings

Derna residents reported hearing a loud blast before the city was engulfed - the failure of one or both of the two dams which had until then been holding back the floodwaters in the valley.

The upper dam had a storage capacity of 1.5 million cubic metres of water, while the lower dam could hold 22.5 million cubic metres.

Each cubic metre of water weighs about one tonne (1,000kg), so the water held back by the dams weighed a total of 24 million tonnes.

As that weight moved downhill, it produced enormous power. Witnesses have said the water was nearly three metres high in places.

Public pronouncements by officials in Derna or the eastern government made no reference to the potential overflow or collapse of the two dams serving the city, focusing instead on the dangers of strong winds and potentially rising water levels.

Dr Abdulwanis Ashour, a hydrologist and lecturer at Omar Al-Mukhtar University, told the BBC he had collected data on the condition of the Derna dams for a study published last year, which showed they were not prepared to withstand a storm like Daniel.

He said he had spent years studying the Derna

dams and had discovered the presence of numerous cracks and fissures. In his research, he asserted that they would not be able to handle a large amount of rainfall and were at risk of collapse.

Dr Ashour pointed out that studies and reports had been conducted by local and international entities over the years, all of which warned about the condition of the Derna dams and their danger to nearby areas. He affirmed that successive governments were aware of these reports.

On Monday 25 September, Libya's Public Prosecutor's Office, part of the western government, ordered the arrest of 16 officials responsible for managing Libya's dams as part of investigations into negligence regarding dam maintenance and other flood-related work. But it is not clear if any of them have actually been arrested.

Delaying aid delivery

The emergency response of the Derna authorities has also been widely criticised.

In a rare sign of unity in the divided country, pleas for help from the stricken town were answered as a multitude of aid workers immediately set about delivering supplies from cities under the control of the rival government in the west. But these convoys were stopped and denied access into Derna.

BBC Arabic has been told that this was due to tight security measures invoked immediately after the disaster by the eastern authorities, which led to delays in aid for thousands of survivors for days afterwards.

"Nothing and no-one gets in without their permission," one Libyan aid worker told the BBC. This aid worker - originally from Derna lost several friends and relatives to the floods.

They work for the Libyan Red Crescent - the only aid agency allowed to work in Derna in the early days of the crisis - and so were one of few aid workers granted access to the city from day one. cific (ESCAP).

"Haftar and his troops only trust the Red Crescent, but we couldn't do much as the crisis was so big. We needed all the help we could get," said the aid worker, who spoke to the BBC on condition of anonymity, for fear of being targeted by Gen Haftar's troops.

Tuesday 17 October

"Haftar put security before rescue, and political differences before helping devastated Derna residents," the aid worker said, adding that Gen Haftar's forces denied immediate access to volunteers coming from western Libyaand halted delivery of aid supplies for days.

They say that security forces spent hours scrutinising much-needed aid supplies looking for "weapons that could be smuggled into the city".

Gen Haftar has been in control of Derna since 2018, but he only took it after Islamists linked to Islamic State had held out against his forces for three years. One local resident told the BBC he thought the city "was still getting punished" for this resistance.

Whatever the motivation, Derna's residents were left for days with no food, clean water or medical supplies, while vital aid supplies were withheld and stored for inspection. It is impossible to know how many lives were

The BBC also spoke to the leader of an aid convoy sent from the west of the country, who recounted a similar

Abdel Monem Kheresha from Tripoli said his convoy was prevented from entering Derna.

"We were stopped before Derna's entrances and we were ordered by the 'Libyan National Army' [LNA, Gen Haftar's militia] to hand over our supplies," said Mr Kheresha.

The BBC has found that aid supplies gathered from such convoys were stored in two main warehouses supervised by the LNA, one in Benghazi and the other in al-Marj.

They were carefully inspected and then distributed by the LNA, an operation that took hours and even days.

It wasn't until Thursday 14 September, when the size of the catastrophe was apparent to the whole world, that a long queue of trucks carrying aid from around the country was allowed into the city.

Derna resident Al-No'man Ali told the BBC that they finally received food and aid supplies on the Friday after the disaster, after days of wait-

After the protests began on 18 September, many local and international journalists in the city were forced to leave after coming under pressure from the authorities.

At the same time, communications in the city went down - many protesters believe they were deliberately cut to stop the demonstrations from escalating.

The lack of mobile phone signal and internet hindered the rescue and aid work in the city as the different international and local teams that were eventually allowed to operate there couldn't coordinate their work.

The BBC has approached the east Libyan authorities for comment on those allegations, but has not received a response. Economic and Social Commission for Asia and the Pa-BBC

WB to support economic empowerment for millions of girls and women in Africa

MILLIONS of girls and young women across Eastern and Southern Africa will gain greater access to education and economic empowerment opportunities thanks to the newly approved East Africa Girls' Empowerment and Resilience program (EAGER).

This new program, approved on September 28, 2023 and supported by \$832 million in International Development Association (IDA) financing, will boost girls' and women's education and earnings while strengthening institutional capacity for the implementation of gender equality policies.

EAGER brings together countries facing similar challenges hindering girls' and women's empowerment and will be deployed in phases. Madagascar and Mozambique are the first two countries to participate in the initiative, with the African Union (AU) serving as the regional institution supporting the programme.

Future phases are expected to include Burundi, Comoros, the Democratic Republic of the Congo (DRC), Lesotho, Malawi, Zambia, and Zimbabwe.

"EAGER is a groundbreaking initiative that will help to achieve impact at scale by directly reaching millions of girls, women, and stakeholders.

It also seeks to create the institutional conditions necessary to empower even more girls and women," said Boutheina Guermazi, Director for Regional Integration, Africa, and the Middle East.

In its first phase, the EAGER program will directly support over two million girls to stay in or return to school and enable 160,000 women to increase their productivity in the labor market in Mozambique and Madagascar.

It will also reach more than six million agents (FY19-FY21), with about 70 percent going to Afof change, including traditional leaders, par-rica.

ents, and boys, through behavioral change campaigns designed to shift gender norms in the two countries. It will enhance the capacity of 26,000 local administrators, community leaders, and service providers to effectively implement gender-equality reforms.

In Eastern and Southern Africa, over 40 million girls do not attend school, and a staggering 55 million girls and young women are married before the age of 18.

This lack of access to resources and decisionmaking power during adolescence often leads to a trajectory of low productivity, leaving them excluded from the labor market or relegated to low-quality jobs in adulthood, thus contributing to a significant gender gap in job earnings.

"A human-centered engagement is needed to address the deep-rooted causes of women's disempowerment.

EAGER is a multi-sectoral effort encompassing education, health, jobs, and social protection, recognizing the strong interrelation of these dimensions in women's empowerment," said Sara Troiano, the Task Team Leader on EAGER, emphasizing the need for a holistic approach.

The World Bank's International Development Association (IDA), established in 1960, helps the world's poorest countries by providing grants and low to zero-interest loans for projects and programs that boost economic growth, reduce poverty, and improve poor people's lives.

African states urged to make sustainable financing for research on health and devt

SEATTLE/DAKAR

AFRICAN governments have been called upon to step up funding to make research and development of health innovations easier and

The move according to the Bill & Melinda Gates Foundation will make the next generation of scientific and technological breakthroughs relevant and accessible to all.

Speaking at the announcement of a slate of new initiatives to support locally led innovation in Dakar yesterday, Moussa Balde, Senegal's Minister for Higher Education, Research and Innovation said over the past two decades, global investments in a pipeline of innovative solutions has helped to reduce childhood deaths to children under 5 by half.

The announcement was made by the Bill & Melinda Gates Foundation and its partners at the Grand Challenges Annual Meeting.

"But lifesaving innovations still take too long to reach those who need them and are not always designed with equity from the start. Grand Challenges Senegal continues to invest in the country's brightest scientists and innovators, and we are pleased to be part of this global network of Grand Challenges partners investing in locally led solutions to ensure innovations, including in health, education, and agriculture, benefit everyone equally," said

"New health technologies have the potential to save millions of lives, but R&D funding is going in the wrong direction," said Gates, adding that "Donors need to step up their commitments to ensure health innovations reach those who need them more quickly, so more lives can be saved."

Kedest Tesfagiorgis, Deputy Director, Global Partnerships and Grand Challenges at the foundation said: "What started as a single program funded by the Gates Foundation and its partners has grown into a family of initiatives and partnerships across national borders, fields of study, and sectors that catalyze research, products, and partnerships to save and improve the lives of the world's most vulnerable people.'

He added: "Our community of brilliant innovators is proof that a great idea can come from anywhere and be supported by the funders, policymakers, and advocates needed to move ideas into the laboratory and, ultimately, to the people who can most benefit from them."

Data shows that while overall health research and development funding is increasing, only about 2 percent is directed toward diseases that affect the world's poorest people.

In 2020, the annual funding gap for product development targeting poverty-related and neglected diseases was estimated at \$2.6 bil-

Launched in 2003, Grand Challenges, the foundation's flagship innovation program, focuses attention and funding on pressing global health and development problems that affect the world's poorest people, using open calls for proposals to crowd source potential solu-

In an address to the more than 1,400 scientists, policymakers, and donors attending the annual meeting, Bill Gates, co-chair of the Gates Foundation, called for the world to spend at least \$3 billion more every year on global health and development in order to close the critical gaps in funding for neglected

Gates announced that the foundation is investing \$30 million to support a new artificial intelligence (AI) platform in Africa. The platform will provide African scientists and innovators with the technical and operational support they need to turn promising ideas into scalable health and development solutions.

It is a step towards ensuring the benefits of AI are relevant, affordable, and accessible to everyone-particularly those in low- and middle-income countries (LMICs)-and that these critical tools are developed safely, ethically, and equitably.

The foundation also announced new investments aimed at expanding access to a novel mRNA vaccine manufacturing platform that gives countries, including Senegal and South Africa, the technology to develop and manufacture their own vaccines.

The mRNA technology is considered a potential game-changer for a range of infectious diseases, including tuberculosis, malaria, and Lassa fever, which disproportionately affect people in LMICs. This additional local vaccine manufacturing capacity will support LMICs to develop low-cost, high-quality vaccines that address their most urgent health priorities.

A weak link in Africa's defences against malaria

TURKANA County in northwestern Kenya was supposed to be the land that malaria forgot. An arid, windy region abutting Uganda, South Sudan and Ethiopia, its climate was thought to be too dry for the mosquitoes that harbor malaria-causing parasites, and thus it has been excluded from national efforts to prevent the spread of the disease.

But that assumption may have been wrong, according to a new study by malaria researchers at the Duke Global Health Institute and Moi University in Kenya. And worse, it may leave an opening for new forms of malaria that could reverse the progress East Africa has made in controlling

"These findings are game-changers for malaria control in East Africa," says Wendy Prudhomme O'Meara, Ph.D., a professor of medicine and global health at Duke who led the research.

O'Meara's team found that approximately 30 percent of the people they tested in Turkana County had malaria parasites in their blood, indicating that the disease was already endemic in the region. But even more concerning was the type of malaria: Researchers found a small but significant incidence of a parasite called Plasmodium vivax, which historically has been almost non-existent in sub-Saharan Africa. The study is the first to confirm cases of P. vivax malaria in Kenya that were likely the result of local transmission.

The parasite's appearance in Kenya may be connected to an invasive mosquito species known as Anopheles stephensi, which migrated to the Horn of Africa during the past decade and has been found in five countries in northern Africa. Its arrival in Djibouti in 2016 coincided with a 100-fold increase in malaria cases, leading the World Health Organization to issue an alert about the insect's invasion, calling it "a major potential threat to malaria control and elimination" on the continent.

"If we don't do something about it, we're going to be in trouble very soon," says Eric Ochomo, Ph.D., a medical entomologist with the Kenya Medical Research Institute who



identified the invasive species in northern Kenya in December 2022, around the same time as O'Meara's study.

Both the mosquito and the parasite it carries present significant challenges to the continent's malaria control efforts, the researchers warn. P. vivax behaves differently than the most prevalent forms of malaria in Africa, which can allow it to evade screening tests and therapies most frequently used across the continent. It can go dormant in the liver, causing relapses weeks or months after infection.

"We are worried that with the presence of the An. stephensi, cases of P. vivax malaria may very well increase," says O'Meara, who has been working on malaria prevention in Kenya since 2003. "There are no measures in place for P. vivax malaria control in Kenya, and it needs some targeted mechanisms."

Traditional justice may stem violence and assist peace-building drives in Ethiopia transition

THIOPIA has a wealth of traditional dispute-resolution mechanisms that help achieve reconcilia-tion, mend fractured relationships and preserve communal harmony. Some are inter-ethnic in nature. Even in urban settings such as Addis Ababa's Merkato, Ethiopia's largest market, elders use traditional values and procedures to help resolve commercial disputes.

While there is limited acknowledgement in the constitution of their potential use to resolve family and personal disputes, the criminal justice system has, in practice, disregarded these traditional mechanisms altogether. This stems from the 1950s and '60s when European experts overseeing the codification of Ethiopian laws purportedly omitted the traditions as incongruent with the modern le-

Ethiopia's current peacebuilding initiatives – the dual dialogue and transitional justice processes - have brought traditional justice into focus. The National Dialogue Commission (NDC) is expected to use traditional knowledge and values in dialogue processes, although it's vet to explore how to do so effectively, a senior NDC expert who requested anonymity told ISS Today.

Ethiopia's Green Paper on Transitional Justice Policy Options released in early 2023, echoes the African Union's policy on the issue in acknowledging the potential of traditional mechanisms. It calls for further investigation into how these approaches could be used.

Running de facto in parallel to the formal justice system, traditional mechanisms are the preferred means of dispute resolution for Ethiopians. A 2021 Hague Institute for Innovation of Law survey reveals that Ethiopia's formal justice system resolves about 18% of legal disputes every year. By comparison, 43% are channelled through traditional approaches involving local elders, which resolve about three million disputes a year.

A 2023 Harvard Humanitarian Initiative Population Perception survey by Phuong Pham and Patrick Vinck found that 80% of Ethiopians (with slight regional variation) believed traditional mechanisms should be used to address violence. Most of the population thought traditional actors and institutions were more in their interest, and more pertinent for peacebuilding, than the formal justice system.

Traditional justice integration

The question then isn't whether traditional mechanisms should be involved, but how they can be made an integral part of the dialogue and transitional justice processes at national and local levels.

At a national level, traditional mechanisms should be considered from a macro viewpoint - not as isolated and contradicting approaches, but as institutions with shared values and peacebuilding philosophies. This may

help identify an overarching principle, akin to South Africa's ubuntu, an indigenous concept that invokes shared humanity and a reconciliation lens to addressing past griev-

Extracting a common perspective from Ethiopia's traditional institutions is presumably not too daunting, given that the difference among the mechanisms is more procedural and ritualistic than philosophical.

Identifying common traditional thinking and presenting it in multiple languages that are less technocratic may help both the dialogue and transitional justice processes.

The NDC may use such an ubuntulike philosophy to explain the importance of participation in discussions between ethnic groups, the country's federal government and its regions, and government officials and the public.

Ethiopia needs a grassroots concept of peace and justice that transcends communities. This would help in mobilising public support for healing the nation's wounds, compensating and assisting victims to recover, truth-telling, remembering the past, and forgiving or prosecuting wrongdoers.

At the local level, traditional mechanisms can help the NDC organise or facilitate community or intra-ethnic dialogue sessions.

This may include involving elders in leading or facilitating the talks,

which would also be relevant for a courts, these customary courts could truth and reconciliation commission if one were to be established.

Regarding criminal accountability, traditional mechanisms could help deliver justice on a larger scale and in places where the formal system struggles. Since Ethiopia aims to reckon with multiple cases and periods of violence, the sheer volume of cases could overwhelm the formal justice system.

A senior official who requested anonymity said it was unlikely that any country's judicial system could handle the number of cases and issues Ethiopia would face once transitional justice started next year. He said some sort of mechanism, restorative or retributive, should be available countrywide, including at kebeles (the lowest administrative units).

One approach is to formally recognise traditional mechanisms and reconstitute them as customary courts. This is already happening in the Oromia Regional State to improve access to justice by alleviating the burden on formal courts.

The Justice Ministry is encouraging other regions to follow suit. Ethiopia's transitional justice process could leverage this development and incorporate customary courts into a process similar to gacaca courts -Rwanda's post-1994 grassroots-level justice by community elders.

Drawing lessons from both the successes and troubles of the gacaca deal with low-level perpetrators locally. This would allow the formal courts, as the Green Paper suggests, to focus on accountability for the most responsible individuals.


This dual court system would help avoid overwhelming the regular courts with thousands of cases, which could lead to suboptimal trials, as occurred in Ethiopia's post-1991 transitional justice process.

However, traditional mechanisms would need to be substantially adapted and capacitated to deal with unique challenges. For instance, they may be unable to adjudicate complex and large-scale crimes that traditional approaches are perceived not to have been designed for.

Since many mechanisms have roots in patriarchal traditions, they're not gender-inclusive. And some traditional leaders have been accused of political cooptation, leading to a disconnect between elders and youth. These are just some factors that should be remedied for traditional mechanisms to be used more widely.

The onboarding of traditional mechanisms should be done cautiously following a 'do no harm' approach. Their effectiveness for dialogue and transitional justice is closely linked to their ability to remain autonomous and true to traditional principles.

Govt urged to train women and youth on conservation farming

EXPERT in the farming sector has tasked government and private sector to scale up mobilisation and train farmers on conservation agriculture. GEORGE Mwakatobe, a researcher at the Tanzania

Agriculture Research Institute (Makutupora -Dodoma) made the call recently during a mid-year workshop to review mentorship programmes for women and youth that was convened by Agricultural Markets Development Trust (AMDT).

Mwakatobe said to promote conservation agriculture adoption and scaling-up mobilization and training to farmers, the government should engage the private sectors and ensure those trained pass on the acquired knowledge to their fellows.

He said the government should establish resource centers in each zone that will be dealing with conservation agriculture, noting that most farmers have knowledge on conservation agriculture but there is a need to encourage them to practice it because some trained farmers do not practice it.

He said conservation agriculture is practiced in some places countrywide including Babati, Kiteto and Karatu in Manyara Region. It is also practiced in Ukara in Mwanza Region, Arusha, Mbeya and Ruvuma regions. He added that farmers who practiced conservation agriculture in Dodoma Region have recorded an increase in their yields.

Mwakatobe thanked AMDT for organising the event calling upon agriculture colleges and universities to also include conservation agriculture in their curriculum.

He hailed the government for its engagement and collaboration to make conservation agriculture more successful.

The Ministry of Agriculture has been conducting various meetings with non-government organisations (NGOs) on promotion and investment in conservation agriculture, he added.

A farmer, George Masaka urged youth and women dealing with agribusiness to apply modern technology and adhere to ethics while conducting their activities, stressing that the use of modern agricultural technology plays a crucial role for the development of the sector.

Masaka said application of modern technology in planting and harvesting might result in high yields hence income to the farmers and state coffers.

The two-day event attracted more than 25 participants from Mtwara, Manyara, Dodoma Ruvuma, Lindi, Iringa, Rukwa and Njombe regions.

MDBs record climate finance of close to \$61bn for low and middle-income economies last year

CLIMATE finance by Multilateral Development Banks (MDBs) for low-income and middle-income economies reached a new record of \$60.7 billion in 2022, up 46 percent compared to 2019 volumes, a new joint report by the MDBs has found.

Of the amount, \$38.0 billion, or 63%, went into climate change mitigation finance, and \$22.7 billion or 37%, supported climate change adaptation. Mobilised private finance stood at \$16.9 billion, the report said.

The announcement comes as delegates meet in Marrakesh, the second year in a row, ex-

Morocco, for the World Bank Group and International Monetary Fund Annual Meetings, where scaling up public climate finance, particularly for low and middle-income economies, ranks high on the agenda.

In 2022, MDBs allocated \$38.8 billion to high-income economies. Of this, \$36.3 billion, or 94%, was for climate change mitigation finance and \$2.5 billion or 6%, went into climate change adaptation finance. The amount of mobilised private finance stood at \$51.9 billion.

With the record 2022 climate development banks have, for

ceeded the 2025 climate finance targets(link is external) they set themselves at the UN Secretary General's Climate Action Summit in 2019. This included delivering a cumulative \$50 billion in climate finance for low-income and middle-income economies, at least \$65 billion globally, with an expected doubling in adaptation finance to \$18 billion; and private mobilisation of \$40 bil-

Compared to 2019 volumes, MDB 2022 climate finance for low and middle-income countries increased by 46% (\$41.5 bilfinance volumes, multilateral lion) and global climate finance

by 62% (\$61.6 billion).

Development Bank's climate finance investments increased from \$2.1 billion in 2020 to \$2.4 billion in 2021 and \$3.6 billion in 2022. The Bank's allocation is almost entirely channelled to low-income and middle-income economies.

The Bank Group's Director for Climate Change and Green Growth Department, Anthony Nyong, said the institution recognizes the urgency to mobilize climate finance at scale to address climate impacts and harness climate opportunities on the continent.

He said: "As shown in the report, external climate funds.



5. Networking and Exposure: Development projects often host conferences, workshops, and knowledge-sharing events. PhD students connected with these projects find themselves in the midst of a diverse array of experts and practitioners. This exposure allows them to present their research, gain critical feedback, and expand their professional networks.

6. Policy Impact and Advocacy: PhD research conducted in tandem with development projects carries the potential to directly influence policy decisions and project implementation. The PhD researchers become advocates for positive change, working hand in hand with projects to drive policy reforms and amplify their research's real-world impact.

7. Knowledge Transfer and Capacity Building: Development projects are committed to transferring knowledge and best practices. Local researchers and PhD candidates who may be involved in these projects acquire new

skills and insights that empower them to conduct research with genuine realworld applications.

This synergy from the Global South's unyielding quest for development can exemplify that research is no longer a solitary endeavour confined to academic halls. It is an ever-evolving, dynamic force for change, intrinsically linked to the pressing needs of communities. It may bridge the gap between academic theory and practical action, elevating PhD research from an academic exercise to an instrument of tangible transformation. In a world that is grappling with intricate and pressing challenges, this synergy may present a spark of hope. It underscores the notion that knowledge, when harnessed with purpose and passion, has the power to reshape the destiny of nations and uplift the lives of people in the Global South.

As we witness the growing importance of sustainable development goals, it is imperative to foster and nurture this synergy. IMF, World Bank 'impotent' on Israel-Gaza war amid reforms

MARRAKECH, Morocco

GLOBAL finance leaders' paralysis in addressing the fallout from the Hamas attack and Israel's response last week exposed deep geopolitical divisions hampering the International Monetary Fund and World Bank, even as they advanced new funding plans aimed at easing more-frequent economic shocks.

Hamas launched its unprecedented attack on Israel on Oct 7, just as top finance officials arrived in Morocco for the IMF and World Bank annual meetings, upending the gathering's carefully crafted script calling for new resources and steps to revive flagging global

IMF Managing Director Kristalina Georgieva did not mention the new conflict at opening events. Later, as Israel's retaliatory strikes mounted, she struggled to address it, initially describing it as a human tragedy but a vague source of economic uncertainty.

In private conversations at the meetings, the Israel-Gaza conflict's implica-

tions were front and center, from a new refugee crisis to trade impacts and the threat of fighting in Lebanon and the West Bank, participants from finance groups to non-profits told Reuters.

"In the face of a major global shock like this that's human created, that's not a climate shock, these institutions are impotent to do anything about it, which is why they're not even talking about it," said Rachel Nadelman, a senior research fellow at American University's Accountability Research Center, who attended civil society and official events at the meetings.

The inability to respond extended to chair's statements issued by the Group of 20 major economies and the IMF and World Bank steering committees, which failed to mention the conflict.

These bodies were again unable to issue joint communiques, reflecting deepening geopolitical tensions, most recently over Russia's special military operation in Ukraine, which has long sparred over communique language.

A G20 official said that body has been

riven for two years by the Ukraine conflict.

"The Israeli-Palestinian conflict is even more controversial - almost impossible to reach consensus," the official said.

Accomplishments overshadowed

World Bank President Ajay Banga acknowledged on Sunday that the Israel-Gaza conflict, along with the Ukraine crisis and fighting in Africa, were "casting long shadows" over the meeting's accomplishments and adding to economic challenges.

"You know, without peace, it's hard for people to get stability, growth, look after their children, get jobs," he said.

The World Bank's governing body approved a new vision statement "to create a world free of poverty on a livable planet" to incorporate shocks - and they're trying to detach the two." its new mission to fight climate change, pan-

demics and fragile states, along with new steps to expand lending.

The IMF's steering committee agreed to boost quota funding by year-end, while a \$3 billion fundraising goal for its poor-country trust fund was met.

But conflicts remain the biggest challenge to the global economy, said Josh Lipsky, a former IMF official who directs the Atlantic Council's GeoEconomics Center.

"If these institutions are going to be legitimate and fit-for-purpose for the coming decade, they're going to have to respond to geopolitical crises in close to real time," he told

According to Nebenzya, "it is Washington that recklessly and selfishly blocked the work of the Middle East Quartet of international mediators in an effort to monopolize the peace process and limit it to imposing an economic peace with Israel on the Palestinians and other Arab countries without solving the Palestinian question." "We consistently warned against this, saying it will backfire one day, and so it did," the Russian envoy stressed.

Nebenzya added that "for years, the US blocked any reaction, any signal from the UN Security Council, claiming that its quiet regional diplomacy is more effective."

"We shouldn't ignore that the current flare-up of violence happens against the background with real systematic violations of the decisions of the UN Security Council and the General Assembly, including the illegal expansion of settlements, which is regularly condemned by the vast majority of UN member states," he said.

Nebenzya added that Russia unequivocally condemned 'extreme brutality, killings and the horrifying scale of violence." "Any killings and violence against peaceful civilians, both Israeli and Palestinian citizens, is inadmissible,' the Russian envoy stressed.

Border crossing between Gaza, Egypt to reopen for foreign

CAIRO The Rafah crossing between Gaza and Egypt will reopen for foreign national Palestinians at 9 am (local time) on Monday when humanitarian aid will also start crossing into Gaza, NBC News reported citing Palestinian embassy

representative Kamel Khatib. The Rafah crossing between Gaza and Egypt is the only remaining outlet to move people out of Gaza and send supplies into it. Notably, Israel has closed two border sites and the Rafah crossing has remained shut for much of the past week, according to NBC News report.

The US Embassy in Israel on Monday said that desperate residents hoping to move from Gaza through the Rafah crossing might receive "very little notice" if it opens, CNN reported.

The US Embassy said, "It is unclear whether, or for how long, travellers will be permitted to transit the crossing. If you assess it to be safe, you may wish to move closer to the Rafah border crossing," adding there may be "very little notice if the crossing opens and it may only open for a limited time," CNN reported.

Meanwhile, US Secretary of State Antony Blinken voiced confidence in his recent conversation with Egypt's President Abdel Fattah El-Sisi regarding the delivery of aid to people in Gaza and said that the Rafah crossing will be reopened.

He made the remarks to the press at Cairo Airport on Sunday and added that the measures are being put in place with the United Nations, Egypt, Israel, and others to get assistance in and to get it to people who need it.

"With regard to Rafah, I had a very good conversation with President El-Sisi. We have put in place - Egypt has put in place a lot of material support for people in Gaza. And Rafah will be reopened. We're putting in place with the United Nations, with Egypt, with Israel, with others, a mechanism by which to get the assistance in and to get it to people who need it," Blinken said.

Meanwhile, Israel's Energy and Infrastructure Minister Israel Katz announced Israel's decision to open the water to the south of the Gaza Strip after it was shut off following Hamas's attack on October 7.

In a statement posted on X, Katz stated, "The decision to open the water to the south of the Gaza Strip, which was agreed upon between Prime Minister Netanyahu and President Biden, will result in pushing the civilian population to the south of the Gaza Strip and will make it possible to tighten the general siege on Gaza in the areas of electricity, water and fuel, and will make it easier for the IDF to operate and destroy the Nazi Hamas infrastruc-

Six months on, Sudan's conflict still shows no signs of peaceful resolution

KHARTOUM

THE devastating conflict in Sudan entered its sixth month on Sunday without showing any signs of peaceful resolution, creating one of the worst crises the country has ever faced.

The conflict began on April 15 when the Sudanese Armed Forces (SAF) and the paramilitary Rapid Support Forces (RSF) clashed in Sudan's capital Khartoum and other regions. The violence has killed thousands of civilians, displaced millions more, and destroyed much of the country's infrastructure, especially in Khartoum.

It has also worsened Sudan's economic woes. As the war dragged on, Sudanese politicians and international humanitarian organizations warned of more suffering and violence if no political solution was reached.

"If we fail to reach a political settlement to the current military conflict, Sudan will turn into a center and source of disasters in the world and the region," Siddiq Al-Mahdi, acting chairman of the Sudanese National Umma Party and a member of the Forces of Freedom and Change Alliance (FFC), a civilian political coalition in Sudan, said in a statement.

Yasir Arman, chairman of Sudan People's Liberation Movement - SPLM Democratic Revolutionary Current and an FFC leader, expressed his concern that both sides in the Sudanese conflict lack a clear strategy to manage the crisis and arrive at a political resolution.

The war has also disrupted vital sectors such as education, as schools and universities have been closed. Also on Sunday, the United Nations Children's Fund (UNICEF) said on the X platform that "six months into the Sudan crisis, UNICEF fears disruption of basic services can cost the future of 24 million children."

It said there were 19 million children in Sudan who did not have access to education, while 14 million others did not have access to basic services. "Sudan is on the brink of becoming home to the worst education crisis in the world," said Mandeep O'Brien, UNICEF country representative in Sudan.

"Now, forced away from their classrooms, teachers, and friends, they are at risk of falling into a void that will threaten the future of an entire generation," she said. At the economic level, the war has caused severe shortages in food supplies and a spike in prices of essential goods. The Food and Agriculture Organization of the United Nations (FAO) said in a statement that the six-month-long hostilities in Sudan threatened food security across the country.

Poland election earthquake: What happens next?

A second exit poll in Poland has predicted the governing right-wing populist Law and Justice party won the most votes in Sunday's election but will lose its majority in parliament.

If the official result, expected on Tuesday, confirms the second exit poll prediction - which has a 2% margin of error - it's up to President Andrezj Duda, a former Law and Justice MP, to appoint a new prime minister to form a government.

Who gets first shot at forming a government?

It's customary - and President Duda has said he would do this - for the president to choose the leader of the largest single party, in this case Law and Justice, to have the first shot at forming a government and securing a vote of confidence in parliament.

However, Law and Justice appears to have no clear route to forming a government with a majority, whilst a diverse opposition coalition of Civic Coalition, the Third Way and the Left does seem able to form a government with a majority.

According to the second exit poll, Law and Justice would win 198 seats,

A politician from Civic Coalition - one of the opposition parties with the numbers to form a majority - grins after the exit poll

well short of the 231 needed for a majority. Its potential coalition partners are limited as even with the far-right Confederation party, they would muster only 212.

The opposition could count on **248** seats.

If President Duda lets Law and Justice have the first go and it fails, then parliament gets the second shot at forming a government, which if the

result confirms the exit polls, would give a majority to the opposition coa-

President Duda could also decline to ask Law and Justice to try to form a government given the parliamentary

What if nothing is agreed?

If that second parliamentary attempt fails, then President Duda selects another candidate for PM, and if that fails, he can call fresh elections. could be without a government into November and December - and/or heading towards fresh elections.

What do the opposition parties

If the opposition coalition is appointed and confirmed in a vote of confidence, it will not have an easy

Firstly, it's politically diverse, from the moderate conservatives of the Third Way to some hard-left MPs in the Left.

What obstacles could a coalition

The opposition block has pledged to restore the independence of the judiciary and the public media.

The country's ism and aviation officials shared their hope at the just-ended Sanganai/ Hlanganani World Tourism Expo, which took place from Thursday to Saturday in Bulawayo, the country's second-largest city.

"Aviation is an enabler, a catalyst in the development of Zimbabwe's economy, more so tourism," said Passmore Dewa, manager of Joshua Mqabuko Nkomo International Airport in Bulawayo.

During the three-day Expo, stakeholders highlighted that Zimbabwe's tourism sector was poised for further growth, following the upgrading and modernization of the country's two major airports, the Robert Gabriel Mugabe International Airport (RG-MIA) and Victoria Falls International Airport in partnership with China.

The upgrading has boosted the country's total airport passenger handling capacity to 9.5 million from 5 million, and given foreign tourists wide options of direct landing at the main airports in Harare, Bulawayo, and Victoria Falls, Tarirai Musonza, chief director for Tourism and Hospitality Management, said.

"The opening-up of the new airport which is capable of landing wide-boarded aircraft has been a game changer within the Zimbabwe destination," she as Hwange National Park and Kariba, and



said, as the upgraded RGMIA will be able to handle over 6 million passengers compared to the 1.5 million before.

The upgrading projects are already bearing fruit, with more international airlines flying in, Musonza said.

The upgraded RGMIA was officially commissioned in July by President Emmerson Mnangagwa, who hailed the new-look airport as "magnificent" and matching international standards. African budget airline Fastjet said it has managed to position Victoria Falls, the country's prime tourist destination, as a national and regional tourism hub now that the airport is mod-

Fastjet has developed new routes connecting Victoria Falls to previously unserviced domestic tourist destinations such

to South Africa and Botswana.

"As Fastject our business model is based on robust air connectivity and our focus has been on positioning Victoria Falls as a tourism hub," Vivian Ruwuya, the airline's chief commercial officer, said.

Andrew Makona, Air Zimbabwe's chief executive, said their thrust was on reviving the troubled national airline into a viable entity that can adapt to the changing environment.

He added that the airline's goal is to make RGMIA the country's business hub and Victoria Falls the tourism hub.Wengayi Nhau, president of the Tourism Business Council of Zimbabwe, emphasized the need for more airport infrastructure

UN chief calls on Hamas to 'immediately' release hostages without conditions

NEW YORK

THE Secretary General of the United Nations, Antonio Guterres has called on Hamas to "immediately" release the hostages without keeping any sort of conditions.

In a post on social media platform X, Guterres made two humanitarian appeals amid the present situation in the Middle East.

"As we are on the verge of the abyss in the Middle East, I have two humanitarian appeals: To Hamas, the hostages must be immediately released without conditions,' he posted.

"To Israel, rapid & unimpeded access for humanitarian aid must be granted for the sake of the civilians in Gaza," he added.

"Each one of these two objectives is valid in themselves. They should not become bargaining chips and they must be implemented because it is the right thing to do," Guterres said in a statement, adding that "Gaza is running out of water, electricity and other essential supplies," The Times of Israel reported.

According to the latest update, 1300 people have been killed, with over 3600 injured, reported The Jerusalem Post.

Defence Minister Gallant said that on an estimate, 150-200 Israelis are being held hostage by Hamas in the Gaza Strip, adding, "We are making every effort to locate them even in this great complexity."

Medical tourism taking a turn as prayer groups outbid one another

AN array of advertisements was being heard in the past week for different sorts of what are essentially medical visitations, where traditional hospitals were not on the wavelengths but medical tourism agencies, especially for cosmetic interventions.

The price tag was not being cited but it was likely to be high, as earlier, the placing of stomach balloons to reduce eating and weight at Mloganzila Referral Hospital, a cosmetic intervention that didn't appear to attract many. It also has adverse effects.

This was something predictable, on account of the rising prowess of prayer centers and miracle healers where the city of Dar es Salaam has them in good numbers.

Little is known how far their presence has affected hospital attendance or reference, as there isn't sufficient data on the relationship between hospital services and the rise in population.

And unavoidably there is scant or no data at all on how many people are delivered from diseases by visiting prayer centers, but word of mouth may appear to suggest that the number is considerable each week.

Yet there are specific centers where this medical tourism outreach is taking upper reaches, on account of the spreading of miracle healing services from diseases to chances of rectifying ruined aspirations in life.

This is the subject of especially intense preaching at places like Kawe and Kimara Temboni, as well as a couple of places at Ubungo Riverside, while for a couple of months least the most noticeable attention has been directed at Buza kwa Lulenge.

This suburb hosts a key prayer spot that changed the rules of the game, not just in healing but in liquidating witches. That attracted the mushrooming of

an alternative prayer center that now appears to have of witches. faded, for it was not audible most of Saturday morning when it is presumed that large numbers of potential listeners with some cash to spare would be tuned to their favourite radio channel.

Instead, there was a more traditional service provider not just promising healing from a whole range of diseases with a wonder drug whose name was of course in Arabic, but a lot more. The spokesman of the center who issued its appeals

and explanation went further on the issues than is usually the case, as he admitted too many of the hidden things on witchcraft.

It was a sort of exposition involving an explanation of jinn attacks, and their types, sorting them out.

But this exposition is also partly injurious to them as they are doing it under duress if one is aware that witches and non-apostolic traditional healers are allies. The differentiating factor in how the more mainstream prayer center, located not in Buza kwa Abiola as the one now losing steam after frantically trying to compete with the witch-buster healing center at Buza kwa Lulenge, is predictably on the treatment

The narrator went as far as promising service seekers that there is a handkerchief that enables a person to see his witch attacker, causing diseases or ruin in business, dislocation of marriage affinities, etc.

The difference is that after seeing a person's villain, it would not be up to him to administer any punishment but leave it to divinity.

This is a way of salvaging something for those found in the business of causing pain to others just as they hate their success.

9, the Egyptian national team was set to hold a training camp from October 9-17. Koller is deeply concerned that this tight

Lionel Messi remains a doubtful starter for Argentina. Neymar under fire in Brazil

SAO PAULO

LIONEL Messi's involvement in a 1-0 win over Paraguay last week doesn't necessarily mean he'll be fit for Argentina's next game in World Cup qualifying against Peru.

Messi played most of the second half against Paraguay last Thursday despite struggling with muscular pains in the weeks leading up to the game.

But there's no certainty he'll play against Peru on Tuesday despite practicing with the squad.

Meanwhile in Brazil, Neymar is under fire for his lackluster performance in a 1-1 draw against Venezuela last week that ended with some fans throwing popcorn at the Arena Pantanal in Cuiabá. He will have a tough challenge at Uruguay to show he is back in form.

The next World Cup in the United States, Mexico and Canada is expanding to a 48-team format, meaning direct entry to the top six teams in South America. The seventh-place team will contest an intercontinental playoff for a berth.

World Cup winner Argentina leads continental qualifying with 9 points, followed by Brazil (7), Colombia (5), Uruguay, Chile and Venezuela (4), Ecuador (3), Paraguay and Peru (1), and Bolivia (0).

The fourth match day in South American qualifying also features Ecuador against Colombia, Paraguay against Bolivia and Venezuela taking on Chile.

PERU vs. ARGENTINA

Argentina's practice on Sunday didn't show whether the 36-yearold Messi will play against Peru. He took part of the morning session at his national team's training ground, but has recently felt muscular pains in his right leg that have sidelined him for several MLS matches for his club, Inter Miami.

If Messi plays at Peru, coach Lionel Scaloni might have to remove either Julián Alvarez or Lautaro Martinez from the lineup that beat Paraguay. Keeping the captain in the starting lineup will likely mean Argentina playing Nico Gonzalez again in Lima.

Messi substituted Julián Álvarez in the 52nd minute against Paraguay, when Argentina was already in the lead. He hit the post twice, but had a low key performance overall at the Monumental de Nuñez Stadium in Buenos Aires.

Peru has lost its latest two qualifying matches in South American of South American qualifying. qualifying. The squad arrived in

silence shortly before dawn so no fans could be at the airport protesting after its 2-0 loss at Chile. Players and coach Juan Reynoso know they will face a much tougher challenge against the World Cup

"May this defeat today suit us for what is coming," Reynoso said in a news conference after the match in Santiago. "You don't qualify by playing beautiful soccer, you do it by playing well. For us to do that, we need to be a chamaleonic team that adapts to various cirumstanc-

URUGUAY vs. BRAZIL

Brazil fans were frustrated with the draw against Venezuela, a team that has never qualified to a World Cup. The 31-year-old Nevmar was the team's most criticized player after that encounter because of several missed passes and floppy

The Al-Hilal striker was filmed leaving the pitch in anger as some fans threw popcorn at him. Brazil's soccer tradition calls "pipoqueiro" (popcorn man) the players who fail to deliver in big matches. He is likely to face Uruguay at the Centenario Stadium in Montevideo on

Neymar is Brazil's all-time top goal scorer with 79 goals in official matches.

Brazil's new coach Fernando Diniz, who was also criticized after the draw with Venezuela, is likely to make three changes for the next round of qualifying.

Right-back Danilo is injured, and is set to be replaced by Yan Couto. Left-back Guilherme Arana is expected to be replaced with the 24-year-old Carlos Augusto, who will make his national team debut. And striker Richarlison, on a six-match goal drought for the national team, could lose his position to Gabriel Jesus.

Uruguay has not beaten Brazil in World Cup qualifying since 2001. Captain Federico Valverde is optimistic about the match after a 2-2 draw at Colombia. He said he and Real Madrid teammates Vinicius Júnior and Rodrygo of Brazil have spent weeks talking about the en-

"We could have gotten a better result, but at least we returned with one point, which always suits us," Valverde said of the draw. Uruguay has been coached by Argentine Marcelo Bielsa since the start

Spain, Scotland and Turkey lock up Euro 2024 spots

SPAIN clinched their place at Euro 2024 on Sunday after a 1-0 win away to Norway, also sending Scotland through from Group A as Turkey joined the growing ranks of qualifiers.

Barcelona midfielder Gavi scored the only goal early in the second half in Oslo, bouncing a shot into the corner to help Spain qualify for next year's finals in Germany with two games to

"We are very happy because the team has grown a lot and has a great future," said Spain coach Luis de la Fuente. "We have worked to get to this moment."

They moved top of Group A on goal difference, but the result ensured Scotland punched their ticket to the tournament as well, with Norway five points adrift going into their last match next month.

"When we qualified via the play-offs last time, we set ourselves a target of doing it automatically next time - so that's the first mission accomplished," said Scotland captain Andy Robertson.

Norway have not qualified for a major competition since Euro 2000, but a team featuring Erling Haaland and Martin Odegaard still has hope of advancing to the play-offs.

Georgia thrashed Cyprus 4-0 in the other game in that group.

Turkey capped off a momentous week in which they were announced as co-hosts of Euro 2032 with Italy, by turning on the style in the closing minutes to beat Latvia 4-0 and book their place at the finals. Yunus Akgun broke the deadlock just before the hour and former Everton forward Cenk Tosun grabbed two late goals either side of a Kerem Akturkoglu strike to complete the victory for the Group D leaders.

"I am very happy that we confirmed (qualification) tonight with this win," Turkey coach Vincenzo Montella told UEFA.com. "I am perhaps the happiest coach in the world right now. That's why I'll enjoy it first, and then we'll continue our preparations immediately."

as Harry Wilson got both goals in a 2-1 victory over last year's World Cup semifinalists in Cardiff.

Wilson outran the Croatia defence to loft in the opening goal shortly after half-time and then glanced in a Dan Iames cross for the second.

Mario Pasalic reduced the deficit but Wales now have control of their own destiny heading into the concluding rounds of qualifying games in November. Croatia find themselves at risk of missing a major tournament for the first time since the 2010 World Cup after back-to-back defeats.

Switzerland needed two late goals at home to Belarus to rescue a 3-3 draw but surrendered first place in Group I to Romania. Xherdan Shaqiri curled the Swiss ahead in St Gallen before Belarus, beaten 5-0 by the same opponents in March, levelled through Max Ebong.

Denis Polyakov nodded Belarus in front at a corner and the visitors looked on course for a shock win when Dmitri Antilevski struck a third in the 84th minute. Manuel Akanji tapped in from a Shaqiri free-kick to spark the last-ditch comeback for the hosts as substitute Zeki Amdouni saved Switzerland's blushes, scrambling in a 90thminute equaliser.

Romania eased to a 4-0 victory over Andorra to move a point clear, but the Swiss have a game in hand after Thursday's trip to Tel Aviv was postponed due to the war between Israel and Hamas.

Sunday's match between Kosovo and Israel was also called off because of the conflict. In Plzen, Tomas Soucek's 76th-minute penalty earned the Czech Republic a narrow 1-0 win over the Faroe Islands, bumping his team up to second in Group E behind

Poland struggled in the absence of injured striker Robert Lewandowski and had to come from behind to salvage a 1-1 draw against Moldova in Warsaw. The Poles are third in the section but have played a game more than the top two. They host the Czechs in a must-win game on November 17.

Seven of the 24 slots have now been filled. Germany qualified automatically as hosts while France, Portugal and Belgium all wrapped up their places on Friday.

Meanwhile, Italy return to the scene of their Euro 2020 triumph at Wembley today to face an England side enhanced by the emergence of Jude Bellingham as one of the world's best players.

Bellingham was an unused substitute when the Azzurri broke English hearts on home soil just over two years ago, winning a penalty shootout to extend the Three Lions' wait for major tournament glory. The 20-year-old Bellingham is now

central to Gareth Southgate's plans as England look to seal qualification for Euro 2024 with revenge over the Italians. Bellingham announced himself on the international stage with a series of eye-catching performances at last year's World Cup.

Despite more pain in Qatar as they exited in the quarter-finals to France, a frightening array of talent available to Southgate makes England among the favourites for next year's Euro.

Bellingham is the star attraction after scoring 10 goals in his first 10 games for Real Madrid since a 103 million euro (\$112 million) move from Borussia Dortmund. The former Birmingham midfielder has earned comparisons with Madrid greats Alfredo di Stefano and Zinedine Zidane for his blistering start in the Spanish capital.

England full-back Kieran Trippier knows the scrutiny that comes with playing in Madrid from his time with Atletico and believes Bellingham can now be the difference in delivering a major tournament for his country.

"He can be the difference. At such a young age, with the maturity, the quality and the aggression he's got, he's frightening," said Newcastle's Trippier. "It's not a surprise at all, the standards that he's set in Madrid.

"You can see he's playing with freedom and the players around him are going to make him even better. The scary thing is he's only 20 years old."

Bellingham is also far from England's only weapon as they aim to conquer Europe in Germany next year.

Bukayo Saka missed the decisive spot-kick in the Euro 2020 final but has bounced back to lead Arsenal's renaissance and become undroppable at international level.

Jack Grealish, Declan Rice and Harry Kane have also all moved clubs for more than 100 million euros over the past two years.

Grealish, Phil Foden, Kyle Walker and John Stones were treble winners with Manchester City last season, while James Maddison has flourished since his summer move to Tottenham.

Sir Jim Ratcliffe to control Man United football operations to take Glazers out of firing line

SIR Jim Ratcliffe will take immediate control of football operations at Manchester United should his 25 per cent investment be ratified by the club's board - possibly as early as this week.

The vast majority of United fans are desperate to see the back of the Glazers but Ratcliffe is hoping the prospect of him taking over the running of the sporting side of the business may go some way towards appeasing disgruntled supporters demanding a full sale only.

Telegraph Sport understands a board meeting has been scheduled for Thursday and, should the billionaire Ineos owner's plan to take a 25 per cent stake get the go-ahead, it could pave the way for significant changes on the football and performance side.

There is understood to be admiration at Ineos for manager Erik ten Hag and the job the Dutchman has done since taking the helm 17 months ago but it remains to be seen what it might mean for the futures of other senior staff, including chief executive Richard Arnold and football director John Murtough.

Ratcliffe is thought to be willing to pay up to £1.35 billion for just a quarter stake - a significant premium on United's £2.6bn market valuation - but in return he has insisted on a clause that grants him control of sporting matters at a time when Ten Hag's side are sitting 10th in the Premier League after a torrid start to the season.

His proposed deal is now moving rapidly after Qatari banker Sheikh Jassim bin Hamad Al Thani, his only realistic rival, withdrew from the negotiation process over the weekend citing frustration at the Glazers' valuation.

*Club on verge of most meaningful ownership development in 18 years

It remains to be seen if Ratcliffe can get a deal over the line this week, with well placed sources acknowledging the frequent delays in a process that first began almost 12 months ago, but United could be gearing up for the most meaningful ownership development since the Glazers took charge 18 years ago.

Under a co-ownership deal, the Glazers would still retain control of

upgrades to Old Trafford, although one well placed source said the need for investment in the stadium was being taken into account.

That could mean that not all the money offered by Ineos goes to shareholders and there is also an expectation that the Glazers' voting rights will be diluted under the terms of any agreement.

The Glazers currently own 69 per cent of the club but 96 per cent of the voting rights owing to a complicated dual share structure.

While such a deal will not provide the clean break from the Glazers so many fans want, Ratcliffe's Ineos group believe it would give them an opportunity to drive change on the pitch and in performance terms in the shorter-term.

That is why Ratcliffe was so keen to gain assurances that his proposals include "operational control of footballing matters", a key figure with knowledge of the situation said.

United have lost six of their opening 11 matches and are already facing an uphill battle to progress from their Champions League group after losing their opening two matches to Bayern Munich and Galatasaray.

The club feel a major injury crisis has been a significant factor behind their troubled start but some of the summer signings, including goalkeeper Andre Onana, are already under scrutiny and recruitment has long been considered an issue in the post Sir Alex Ferguson era. Arnold, meanwhile, faced calls to resign over his

handling of the Mason Greenwood sit-

Ineos have had mixed results in their previous ventures in football with Nice and Lausanne but feel both have been valuable learning experiences. Ratcliffe has huge trust in his Sir David Brailsford, Ineos' director of sport and British cycling's former performance director, who would likely wield significant influence at Old Trafford.

The same could apply to Jean-Claude Blanc, the former Paris Saint-Germain chief executive who joined Ineos in February. Blanc, who has also been chief executive of Juventus previously, spent 12 years at PSG and has experience of running an ambitious club.

As previously detailed by Telegraph Sport, Ratcliffe also wants clauses attached to any deal which will enable him to eventually stage a full takeover, his long-term aim.

About 69 per cent of United is owned by the American family, the rest spread among multiple stakeholders who own shares listed in New York. With complexities to overcome around the club's structure, Ratcliffe had repeatedly promised the Glazers he could be more agile than Sheikh Jassim in overcoming potential hurdles.

Ratcliffe, who was born in Failsworth, Oldham and was at the Nou Camp in 1999 for United's treble win, will rely on his local background to win over a fanbase sceptical about the Glazers remaining at the club initially while also hoping to drive change on the football

NGORONGORO Queens' cricketers have opened their campaign in the inaugural Tanzania Women's Cricket Premier League on a sound note, commanding a sevenwicket drubbing of Kilimanjaro Queens at Leaders Club ground in Dar es Salaam last weekend.

NEW Singida Fountain Gate FC head coach Ricardo Ferreira urged patience for the club's rebuilding efforts in his press unveiling.

The former Al Hilal SC and Al Merrikh SC coach was announced as the new coach of Singida Fountain Gate FC on Sunday to replace Ernst Middendorp.

Middendorp resigned immediately after leading Singida Fountain Gate FC to a narrow 1-0 victory over Egypt's Future FC in the CAF Confederation Cup Second Preliminary Round's first leg game in Dar es Salaam last month.

The incoming Ferreira is tasked with improving the club's fortunes after a dismal start to the 2023-24 campaign.

Singida Fountain Gate FC has won only one of the squad's five NBC Premier League games this

They crashed out of the CAF Confederation Cup Second Preliminary Round and also lost both games in this season's Community Shield mini tournament.

On the back of finishing in fourth position in their debut top-flight campaign last season and spending big in the three transfer windows, Singida Fountain Gate FC faces a mammoth task to quench fans' expectations as they try to break through into one of the big teams in Tanzania.

The burden of expectation has seen the club go through two coaches, making Ferreira the third appointment barely three months into the season.

After Hans van der Pluijm, Mathias Lule, Thabo Senong, Ramadhan Nsanzurwimo, and Middendorp all featured in the dugout this season, it was put to Ferreira at a press conference that he would be within reason to ask for time from the Singida Fountain Gate FC manage-

The Brazilian tactician noted: "Football is like this. When I arrived at Al Hilal in Sudan in 2005, we won the Sudan Premier League. In the second year, we won the Premier League and went a step higher by qualifying for the CAF Champions League Group Stage."

"And in the third year, we qualified for the CAF Champions League semi-finals and won the league title

The Brazilian insisted: "You are confused, you don't know what you are doing.

This is not correct for the players. Maybe it is good for the press, comfortable for the short term but for the future, it is not good."

Ferreira said: "Step-by-step, I am now talking about this season, you will see what I do. You are the judge and I do my job. I don't know about the future, God decides the next step for us."
