Night jumbos kill six, injure seven in new wildlife pains

SIX people have been killed and seven others seriously injured after being attacked by rampaging elephants in Makuyuni Village in Monduli District, Arusha Region.

Makuyuni village chairman Ngayoo Measi said at the funeral of Esther Sindiyo (55) yesterday, who is one of the villagers killed by the beast, that the jumbos are increasingly a threat to people's lives in the

Esther was killed by an elephant on December 21 while collecting firewood near the village, with the beast said to have

emerged from the Tarangire National Park.

"So far we have lost the five and others seriously injured, some with permanent disabilities. We ask the government and in particular the institutions managing wildlife to increase their pace of control," the village leader pleaded.

Elephants have been invading farms causing destruction of crops,, thus weakening food security in the past two

Measi said deaths of six villagers arose from a herd of elephants invading the village during the night, naming those killed as Janeth Silla, Mamalai Kakuyu, Lemomo

He was speaking yesterday during the burial ceremony for the late archbishop at St Anthony of Padua Church of the Catholic Diocese of Tanga. where he represented President John Magufuli.

During the burial service led by Bishop Titus Mdoe of Mtwara diocese, the premier said Archbishop Banzi gave priority to social issues such as education, health and potable water.

The late Bishop Banzi died on Sunday at the Muhimbili National Hospital (MNH)

Minister tasks TIB on SMEs lacking capital

THE Minister of State in the President's Office (Investments) Prof Kitila Mkumbo (pictured) has called on the Tanzania Investment Bank (TIB) to come up with a plan on how best to assist small and medium entrepreneurs increase their capitals and contribute to the country's economic growth.

Prof Mkumbo made the call yesterday in Dar es Salaam after visiting TIB headquarters and held discussions with bank officials, in a bid to widen opportunities for local and foreign investors.

The minister said even though TIB was supporting big development projects that are opportunities for investors,



it should also look into the possibility of assisting small and medium entrepreneurs (SMEs) to enable them to develop their businesses.

"We have a lot of money outside the formal sector, if we push them by assisting them. What happens in the streets is mainly agriculture, as 60 percent of trade involves agriculture, a situation that shows we cannot develop agriculture without these people," he

The minister cited an example of Ubungo agricultural crops market in Dar es Salaam, saying each year the market accommodates between 0.7m and 2m people.

"This shows that the market has investment potential and there is big business in there, hence needs to be supported in terms of infrastructure," he elaborated.

empowering entrepreneurs, TIB Managing Director Charles Singili said investments that can assist them is infrastructure to ease challenges to conducting business if they are located in a particular area, citing the case of furniture dealers at Keko, also in Dar es Salaam.

Zanzibar promotes Pemba tourist sites

The Zanzibar Commission for Tourism (ZCT) has embarked on a hefty promotion of tourist attractions in Pemba Island to obtain more foreign visitors as the sector picks up again following the COVID-19.

ZCT programme officer, Abdalla Omar Khalifa unveiled this plan here over the weekend when speaking to journalists on what the commission is doing to promote tourist destinations in Pembathe second largest island in the Zanzibar archipelago, lying off the port of Tanga on the Mainland.

He said that the plan is to increase the number of tourists visiting Pemba Island to 150,000 by 2025, in line with the Zanzibar government target of reaching 800,000 tourists in the next five years.

Statistics show that in 2010, Pemba recorded 14,801 tourists and in 2011 the figure was 23,283 and slowed down in 2012 to 18,757 for unclear reasons. The numbers bounced back in 2013 with 26,791 visitors, dipping in 2014 with 26,463 tourists and again in 2015 with 23,032 visitors, again in 2016 with 21,285 arrivals, rising in 2017 to 22,251 and further in 2018 to reach the peak of 29,642 tourists. In 2019 there was a mild decline to 28,530 visitors, while in 2020 the levels were nearly a third of peak arrivals, at 10,198 visitors.

Pemba Island has a wide range of tourist destinations which are yet to be explored, he said, noting that the campaign targets higher numbers of tourists. "We are bringing on board more stakeholders as possible, including journalists. We came to understand that the island has a range of tourist destinations but information is scant as many people

Kastuli Jumalei, Lenguriny, Emmanuel Leroo, and Ester Sindiyo, all Makuyuni villagers.

The injured included Lobulu Mollel, Julius Thobias, Saiguran Mika, Mnyak Lenguriny, Mjomba Soingei who was still hospitalised at the KCMC Referral Hospital, while others are Lobikyeki Sanare and Kalai Lomayani, Makuyuni residents as well.

Makuyuni Ward Councillor Elius Odupoi called on residents to take greater care in protecting themselves and stop roaming about during the night, even for socializing.

Peter Laisangai, a villager, appealed to the government to increase the amount of compensation for the victims from 500,000/- offered to the injured and 1m/- to relatives of those who died.

When contacted, Monduli District Wildlife Officer Seraphino Mawanja who attended Sindiyo's funeral said in the past two years the area has experienced an increase in elephants who shifted from Tarangire National Park following prolonged rains that flooded many areas.

The latest incident intensifies the scale of human-wildlife conflicts in key conservation areas, as reports affirm that more than 100 people die each year and more than 5,000 hectares of crop land destroyed countrywide in elephant rampages.

Mabula Nyanda, the Acting Commissioner for the Tanzania Wildlife Authority (TAWA), recently expressed fears over rising human-wildlife conflicts claiming people's lives in villages surrounding reserved areas.

Incidents of wildlife killing people and destroying crops were now serious, thus TAWA is moving to provide education to people living in the proximity of reserved

areas, he said.

"This resolve comes from the realization that the majority of people have limited education on conservation issues, hence contributing to incidents of human-wildlife conflicts, which in turn claims lives," he stated.

"We've already developed effective human-wildlife conflict mitigation strategies for wildlife control while mobilizing to provide education to people residing in peripherals of reserved areas to protect themselves from wildlife," he elaborated.

"We're determined to educate the people in concerned areas on how to avoid wild animals including lions and elephants, the main destructive species for human lives and crops respectively," he affirmed.

Elephants have been attacking and even killing people as villagers don't know how to live with the animals in cultivating elephantfriendly crops like watermelons. They also follow and shout at them whenever they sight them.

"There are people who live close to reserved area but do not know anything about wildlife. They go on with their lives ignoring the presence of elephants in their vicinity that can invade their settlements, attack them and destroy their crops," he added.

are unaware of what we have here. So, we're currently placing leaflets on these tourism potential areas to attract tourists, as ways of disseminating information and showing destination of the said attractions," he explained.

The campaign involves a number of stakeholders like tour operators, the Zanzibar Commission for Tourism and the Tanzania Tourism Board on the Mainland.

The waters around Pemba have the best sites for diving in the world, with untouched coral reefs, superb visibility, and deep channels, he stated, noting that the warm waters are the perfect place to dive into, for those seeking underwater sports. "Ample varied dive sites provide for experienced

and novice divers alike," he said. Pemba Island is the lesser

known big island in the Zanzibar Archipelago, but a popular honeymoon destination. Excursions and activities on Pemba Island include snorkeling and scuba diving, cultural village walk, plus visiting the Jambagome Ruins on a boat safari, he stated.

Other popular activities include dolphin safaris, wakeboarding, knee boarding, kayaking through the mangrove forest, sunset cruise and visiting plantations withspices, vegetables and fruit.

"That's why we're encouraging media practitioners to chip in and promote the island as a key tourist destination in the archipelago due to its diverse attractions which are yet to be explored," said Mohamed Ali Juma, the South

Pemba Regional Tourism Officer. Juma was of the view that media

has a big role to play when it comes to promote Pemba tourist destinations, particularly spice tourism, which is untapped. He however cited poor roads

and lack of speed boats to tourist sites on a regular basis as among challenges that need to be addressed for the island to enhance its visibility among local and foreign tourists.

Pemba-based ZCT senior official, Hamad Amin Ali said: "We're working hard to ensure the number of tourists visiting this area goes up and attain the target."

He however cited COVID-19 as among the new challenges that give ZCT a hard time, expressing optimism that the targets set for 2025 will be met.

THE National Institute of Transport (NIT) has launched Airport vehicle driving and operations course aimed at addressing shortage of ground handling experts facing the country's airfields.

Speaking during the launching ceremony yesterday, Tanzania Civil Aviation Authority (TCAA) manager for the Julius Nyerere International Airport (JNIA) Paulo Rwegasha said the gesture by the institute was transformative hence needed the support from all stakeholders.

Rwegasha who represented TCAA director general said for a long time the sector has been in acute shortage of experts, a move which is derailing efforts to make the sector contribute much to the

national economy.

"The coming of this course at the institute is a big step especially at this time when the fifth phase government is doing all it can to promote the sector," he said.

Rwegasha said the sector has been dominated by foreign experts, a move which makes the government employ foreigners.

The official called upon NIT to be a centre of excellence in the East African region by issuing courses which will facilitate availability of experts.

For his part, NIT Rector Prof Zacharia Mganilwa said the

institute aims at producing 400 aircraft engineers in ten years adding that this will help to bring more Tanzanians in the sector dominated mostly by foreigners.

Air transport dominated by foreigners which makes the country pay millions of monies for the services.

"We believe that this is a good beginning because there are various professions in this sector and we as an institute plan to establish more courses to train more experts," said Prof Mganilwa.

He said the Institute is planning

to increase the number of students to be enrolled in the aviation courses to complement the government efforts to develop the sector.

Some two years ago, Tanzania developed a programme to revitalise its national carrier which included purchasing six new aircraft between 2016 and 2018, payment of debts and provision of start-up capital, improvement

and modernisation of business. The aircraft is part of Air Tanzania's plan to grow its operations across Africa as well as to international destinations.

year totaled 633.37bn/-, he said, specifying on these investments as including agriculture, minerals, tourism, natural gas, electricity, education, commerce, as well as transport and communications.

He said 75 percent of the projects are based in the private sector, while 80 percent are long term projects of more than five years, meanwhile as up to late last month, TIB was managing agent for 11 mutual funds valued at 175.9bn/-.

He mentioned challenges in sponsoring long term projects as including small amounts of capital to diminish risks of

exposure of TIB funds as required by TIB up to November this by investment banking law, along with an inexperienced stock market that reduces the possibility of selling long term bonds as many securities in the banking system are short term.

The solution for these challenges includes strengthening the TIB, along with the Tanzania Agricultural Development Bank (TADB) by strengthening the capital base.

TIB has prepared a plan to sell bonds with a value totaling 300bn/- and procure a capital markets permit to raise its operating capital, but is yet to receive the go-ahead from Treasury, he added.

Africa CDC urges enhanced anti-coronavirus measures

THE Africa Centers for Disease Control and Prevention (CDC) has urged enhanced anti-coronavirus public health measures as New Year festivities have started across the continent.

The continental disease control and prevention agency said that African people who are celebrating Christmas and the imminent start of the New Year should adhere to public health measures such as avoiding indoor mass gatherings and practice social distancing.

The Africa CDC also called on the people to consistently apply hand hygiene practices to prevent the overall transmission of COVID-19 including the new variants of the virus found in Nigeria and South Africa.

The agency said that one in five Covid-19 infections in the continent are reported inside the house by people that are coming for a visit, making it all the more recovered across the continent.

urgent to strictly follow public health measures.

Speaking during a virtual press conference, Africa CDC Director John Nkengasong said people should celebrate New Year festivity with care and safety at hand. "Diligently following good public health practices can prevent a spike of Covid-19 cases in the next two months in the African continent.

"Covid-19 is also damaging African economies and posing serious harm to lives and livelihoods across the continent.

"We need to follow good public health practices at this unprecedented Nkengasong added.

In its latest update on Friday, the Africa CDC said the number of confirmed coronavirus cases in the African continent has reached 2,597,090, while the death toll stood at 61,432.

A total of 2,177,981 people infected with the virus have so far

Mbeya RUWASA manager given 14 days to complete all stalled water projects

Water Minister, DEPUTY Maryprisca Mahundi has given 14 days to the Mbeya Regional Manager of Rural and Urban Water Sanitation Agency (RUWASA) Eng Hans Patrick to complete water projects in six villages of Iwindi Ward in Mbeya Rural District to alleviate acute water shortage facing the villagers.

The Deputy Minister also gave one month to the RUWASA manager to complete water projects in two villages of Igale Ward in the District that have never been enjoyed piped water due to their geographical locations.

She gave the ultimatum at the weekend following complaints by Iwindi Ward residents over completion of three water projects each covering two villages.

She called on the RUWASA manager to ensure the residents start benefiting from the projects within the times given, adding that the government's aim was to ensure it brings the service closer to the people.

"I appeal to you, Mbeya Rural MP and the Iwindi Ward Councillor to make a close follow-up of my directives and to be given reports of their implementation. Some negligent officials were removed and the new RUWASA Manager was brought after doing a good job in Ruvuma Region, hence I trust he will also do well in this region," said Mahundi.

She said in Igale and Shongo villages the government provided

acute water shortage due to non- 20m/- for purchase of a special water pump, hence, she added, within one month the pump should be installed so that the residents start getting water.

> Earlier, Mbeya Rural PM Oran Njeza said the government provided 3.5bn/- for the implementation of the projects in eight villages of Iwindi and Igale wards but the residents still do not get water due to poor work done.

> Njeza said the first project was in respect of two villages Mwampalala and Itimu that begun in 2015, but of which the villagers thereof still are without piped water.

> He said the residents get water from the pipes only for a short time, and wait until the following day, the situation that that makes residents fight for the basic

He said the second project was in regard to Mwashiwawala and Iwindi villages that has been completed but sometimes the villagers go for three months without water due to unknown reasons and requested the Deputy Minister to intervene.

"I have visited many villages and the main problem is that even though the projects are seen to have been completed, but the villagers still complain of water woes, added MP Njeza.

Iwindi ward Councillor, Mfisile Nswila said due to water woes, the residents are forced to walk long distances in search of water, the situation that he said does not go in tandem with the requirements spelled out in the CCM 2020/25 Election Manifesto.

TUCTA embarks on refurbishing its aged buildings

THE Trade Unions Congress Tanzania (TUCTA) has said it has initiated a grand plan in collaboration with its stakeholders to refurbish its buildings countrywide to restore them to their original gleam.

This was revealed here at the weekend by TUCTA's President Tumaini Nyamhokya when launching the renovation plan for the administrative building of Mbeya's Workers College (OTTU).

He said some buildings owned by TUCTA and others owned by its stakeholders including its subsidiary - Workers Development Corporation (WDC) are lined up for refurbishment.

He said in order to ensure the task is completed effectively, they decided to enter into partnership with some of their stakeholders on explanation that it would take a long time to refurbish the buildings on their own.

"These TUCTA's buildings are public property hence when we

enter into partnership with others for their refurbishment, we must screen them to ensure the work is well done," said the TUCTA boss.

He stressed that during his tenure he will ensure all TUCTA's buildings are refurbished, the task which he currently regards as a priority.

TUCTA's stakeholders, many of who are its tenants said they have offered to revamp OTTU's administrative buildings from their own cost to enable them operate in good and safe surroundings.

OTTU College Principal, Hezron Kaaya said the college buildings were constructed very many years ago and have not been refurbished since then.

"The administrative building is the College's façade, many visitors come here including government officials, so it must reflect a good appearance," Kaaya said.

He thanked the buildings' tenants for working together in refurbishing them, stressing that they were not a private property.

Ndugulile urges govt institutions to utilise NIDC

THE Minister for Communications and Information Technology Dr Faustine Ndugulile has called on government institutions to make use of the National Internet Data Centre (NIDC) to store their data saying it was safe, with modern ICT system infrastructures and experienced experts.

Dr Ndugulile gave the remarks during his visit at NIDC in Dar es Salaam accompanied by the Deputy Minister Eng Kundo Mathew, Permanent Secretary Dr Zainab Chaula, the Director General of Tanzania telecommunications Company Ltd (TTCL) Waziri Kindamba and other ministry officials

During the visit, Dr Ndugulile discovered that only 84 government institutions out of 149 use NIDC.

He reminded government institutions to abide by President John Magufuli's directive during his 2017 visit at NIDC to launch the electronic Revenue Collection System (eRCS), the system which enabled NIDC increase its revenue from 1,4bn/- in 2019 to 76bn/- in 2020.

Eng Kundo Mathew, the ministry's Deputy Minister praised NIDC for creating various ICT systems that enable the government increase its income as well as easing people's lives including e-ticketing for passenger buses, fuel dispensing at petrol stations, paying for tickets Benjamin Mkapa Stadium and a host of other e systems.

For her part, Dr Zainab Chaula, the Permanent Secretary told NIDC officials to closely work together with the ministry's experts to ensure the government continues to serve the people via ICT in order to save time while pursuing government services.

Geoffrey Mpangals, the NIDC Manager told visiting ministry officials that customers utilizing the centre have reduced both operation and investment costs in their institutions because they do not construct their own ICT infrastructure systems.

Invest in new curriculums to produce skilled, competent graduates, government tells higher learning institutions

THE government has urged higher learning institutions in the country to be more creative, invest in new curriculums to produce competent and innovative graduates who will be able to fight employment crisis and bring changes in the country's economy.

This was said by the minister of State, President's Office-Investment Prof Kitila Mkumbo when addressing participants of the Sokoine University of Agriculture (SUA) annual general meeting.

At least 211 SUA's graduates who performed well in their exams were conferred awards during the meeting.

Prof Mkumbo said universities should establish programmes that complement the country's development priorities, market demand and development of science and technology.

"The country has high demand of experts to serve and bring changes in various sectors and big projects such as agriculture, livestock keeping, aquaculture and more others".

He said that the government has continued to prioritize education reforms in the country while expanding the scope of educational opportunities for Tanzanians from primary to university level.

"We have to change our teaching system, now the world has changed we need young people who can employ themselves even after missing the formal employment, so higher learning institutions should create programmes that equip young people with skills that promotes self-employment, we should teach them not to wait for the government's employment opportunities," Prof Mkumbo said.

The minister noted that reports show that out of ten students graduating from universities, only five could be employed while more than 10 percent of the remaining students remained on the streets with nothing to do as they do not even have self-employment skills.

For his part, SUA deputy vice chancellor Prof Maulid Mwatawala said that the college is well organized in equipping students with more practical skills, teaching them what the market needs from them.

"We have put in place the best infrastructure for practical learning to ensure that all students studying agriculture, livestock, fisheries and tourism issues become more independent, this also enables majority of the graduates to initiate their own economic projects once, this is because we focus on practical training rather than theory," he said.

Every year it is estimated that over 800,000 young men and women enter the labour market. These include school and college graduates and people who have migrated from rural areas to urban areas where the unemployment rate among youth between 15 and 34 years old hovers around 13.4 percent.

Villagers complain of water rationing despite big water projects in the area

SWAYA Ward residents in Mbeya Rural District say they are faced with acute water rationing while a number of villages lack the essential basic service due to non-completion of water projects since feasibility studies were conducted over ten years ago.

The residents told their visiting Member of Parliament Oran Njeza that their areas have many water sources but they lack piped water services despite a huge water project in the vicinity.

Fadhil Mzee, one of the residents said the area has Swaya-Lupeta water project whose feasibility study was conducted more than ten years ago but whose implementation had been going at a snail's pace without valid reasons.

He said the feasibility study was conducted following the area's population but its current implementation did not adhere to the growing population, hence many areas still lack water supply services.

He said as for now, due to water woes, the residents are forced to be contented with rationing while some villages go without water.

"We do not know why the contractors abandoned the project midway, but even if they had completed it, it would not have served all areas due to great demand," said Mzee.

Edward Mwakijale, the Lupeta village chairman said water does not reach to certain areas in the village, hence women have to walk long distances to fetch water.

He mentioned the areas as

Ibanga and Papyo including neighbouring villages Wimba and Nsenga and that if the project had considered the growing population there wouldn't have been any water woes.

He called on the government to intervene so that the project was completed to serve the area's growing population, adding that if necessary, fresh feasibility studies should be conducted.

MP Njeza said was aware of the uncompleted water projects in the area but claimed that the main reason was embezzlement funds by some government officials.

He said some of the involved officials were fired and others face court action.

He said earlier they were blaming the projects' contractors, but later they decided to be open and disclosed the officials who were embezzling projects' funds.

Mbeya Region is among the country's regions to which the government provided a lot of funds for implementing various water projects, but still many residents still complain of lack of reliable supply of piped water.

In this respect, The Electronic and Postal Communications (Electronic Communications Equipment Standards and E-Waste Management) Regulations, 2020 makes it a responsibility of whoever imports, distributes, or sells electronic communications equipment in the United Republic of Tanzania to first obtain Type Approval certification from the Authority.

Accordingly, TCRA conducts type approval of electronic communications equipment to ascertain that they conform to the specified requirements or standards for their use in Tanzania. The equipment which requires type approval includes but not limited to:

1. Terminal electronic communications equipment such as Mobile Phones, Basic Telephone Sets, Data Modems, VHF/UHF Radio, Wireless Modules, GPS tracking devices, Short-range devices, etc.

- 2. Office communication devices such as PABX that are connected to common networks.
- 3. Network communication equipment such as Switching equipment, Base stations, Routers, Servers, Transmission equipment, etc.
- 4. Broadcasting equipment such as Television, Set-Top-Box, Radios, amplifiers etc.

The main objective of the Type Approval is to ensure that electronic communications equipment intended for use in the country complies with the national and international standards and do not pose any health or safety hazards to users; minimizing the harmful electromagnetic interference in public networks thus enhance the quality of service and ensuring interoperability of customer equipment with telecommunications networks and interconnection between networks.

Taking this into account, every importer, distributor, or seller of electronic communications equipment must ensure that electronic communications equipment are approved by the Tanzania Communications Regulatory Authority before they are brought into the country. Type Approval of electronic communications equipment is performed based on the MODEL of the respective equipment through online Type Approval system accessible at https://otas.tcra.go.tz/.

Kongwa District Council reluctant to hand over Kiboriani mountain range

KONGWA District Council has expressed dissatisfaction with the proposal to hand over the Kiboriani mountain range in both Kongwa and Mpwapwa districts to the Tanzania Forest Services Agency(TFS).

Speaking at the recently concluded Regional Consultative Council (RCC) meeting in Dodoma, Kongwa district council chairperson, White Zuberi noted that the council would not rush into accepting the proposal made by TFS to acquire the mountain.

He said the authority wants to be sure of the decision since there are many challenges in areas acquired by the forest services agency. "We still witness people harvest trees for charcoal business, let TFS solve such problems before seeking new areas," he said.

For his part, Dodoma Regional Dr Binilith Commissioner, Mahenge said the decision to transfer ownership of mountain and forest reserves needs mutual agreement. He noted that there are many conflicts because of such measures, thus the need to have clear strategies before making decisions.

"There are many grazing lands for wananchi that are being nationalised, leaving animal keepers without grazing fields, and resort to invade the forest reserves", he said, adding that both TFS and Kongwa district council authorities have strong observation that can be solved through close discussions.

Earlier, Forest Conservationist

from TFS, Yohanes Sanga said the Kiboriani mountain range measures 26,788.49 hectares surrounding Kongwa Mpwapwa districts.

He said the mountain range is important for source of water and other needs for the surrounding villages in the two districts, noting that at least 27 water sources that flows to both Kongwa and Mpwapwa districts have been

"Following the importance of the mountain, conservation efforts started since the colonial era though destructive activities have continued despite efforts by the council authorities that created various by-laws to address the problems," he said

He added that there is great need to change the conservation process so that a stronger organization is given the mandate.

According to Sanga, the mountain has a lot of importance to the neighbouring communities bearing in mind that it has sources of water, it has different ecological benefits including different species of trees.

He also argued that the forestation is suitable for bee keeping as well as the needful forestation for rare animal species that are at the verge of extinction.

TFS had appealed for the RCC to approve the request to acquire forest ranges of Kiborani, Irangi aswell as bee conservation areas of Jongolo in Maganze area, Baaba in Songolo, Sanzawa in Lebbajumbe and that they be gazzetted in the government gazette as areas under TFS.

Villagers travel 20 kms for medical service to avoid high consulting fees

NGARA District residents in Kagera Region are forced to travel 20 kms to seek health services from nearby dispensaries in order to avoid paying 5,000/to consult a doctor.

The most affected are Murusagamba villagers who travel to Kakonko District in Kigoma Region to seek health services at a government dispensary while paying only 1,000/- to consult a doctor. The outcry was aired by the villagers to Ngara Member of Parliament in Kagera Region Ndaisaba Ruhoro, saying they were being charged 5,000/- to see a doctor at Murusagamba health centre.

The ward is located near the Tanzania/Burundi border and the villagers have appealed to their MP to refer their complaints to the government.

Speaking at a public rally at the village, they said they do not get health services despite being insured in the Community Health Fund (CHF).

Juma Issa, Murusagamba villager said despite the health centre, they were forced to travel to neighbouring Kakonko District for medical treatment to avoid being charged 5,000/- as doctor's consulting

"Recently one pregnant woman died while at our health centre for lack of treatment, consulting fees are high, compared with 1,000/- charged at Nyamtukuza health centre in Kakonko District," he

Responding to the complaints, Ngara district medical officer Dr Revocatus Ndyekobora confirmed the death of the pregnant mother due to lack of treatment at Murusagamba health centre and that he already dispatched a team to investigate the matter.

However, he refuted claims that the health centres had no drugs and that from their own decisions the villagers prefer to travel long distances to seek medical treatment.

Meanwhile, MP Ruhoro faulted some of Ntanga villagers in the Ward for sabotaging water projects by placing boulders at water sources.

He said the village had a water supply project that cost 312m/- but had operated only for a short time after some residents placed boulders inside the water well.

Z'bar govt vows to revoke unfaithful traders licenses

Second President Hemed Suleiman Abdulla has warned traders who have been importing substandard or fake products in the Island to stop immediately as the government will not hesitate to revoke their licenses.

In his impromptu visit at the Malindi Port, Hemed found two containers loaded with rotten rice which was imported by a trader named Sulkeiman Abdulla. The containers arrived at the port in March, 2019.

He issued three days for the authorities to ensure that the rice is removed at the port by adhering law.

Hemed said the government has always been impounding and destroying goods which do not comply with relevant standards so as to safeguard people's health and the country's revenues.

"The government is not prepared to see its citizens continue to consume expired food products, so we will continue taking stern measures to ensure that we fight this challenge and keep our people safe," he said.

According to him, there are many honest businessmen in and outside Zanzibar who are fighting for the opportunity of importing products in the Isles, so those who

According to him, the agency conducted required inspection and found the rice was expired and unfit for human consumption and directed the trader to send

back the rice to where it came from. "Despite directives from various authorities, the trader has refused to take out the rice; this is a challenge to majority of traders," he said.

He further added there are some traders who engage themselves in fraud by changing the labels on the packages of expired goods with new labels and packages, the practice that threaten the lives of consumers.

Workers at the ZPC said that the irregularities in various ports in the Isles are being contributed with several factors including arrears of their overtime pay which workers are required to be paid as per law.

Waitara gives Geita authorities two weeks to audit substandard solid waste dump project

DEPUTY Minister in the Vice President's Office (Union and Environment), Mwita Waitara has given two weeks to the Geita Regional Office to audit the solid waste dump project located in Usindakwi area in Geita which is constructed below the standard contrary to actual cost.

Waitara issued the directive yesterday when he made a visit to the project site located in Geita Town Council which has cost more than 1 billion/- while it has not yet been completed or handed over to the Town Council.

He said the government will not tolerate those who obstruct projects and cause losses while ordering that the contractor be sought and returned to the area to complete the project.

The deputy minister directed Regional Administrative Secretary (RAS) for Geita to conduct auditing in two weeks to find who is responsible for such an unlawful act.

Earlier in his statement on the project, Geita Town Environmental Officer, Albert Kashaga said there were shortcomings in the construction of one monitoring well instead of three contrary to the contract.

mentioned shortcomings were the lack of dumping machines or low scales for measuring the weight of incoming vehicles to transport and dispose of waste.

During the visit, the Deputy Minister also visited the Geita Gold Mine (GGM) and expressed satisfaction with the environmental and hazardous waste management measures followed at the mine.

"This is a mine that adheres to the government's guidelines on the whole issue of environmental protection. I am satisfied, I have seen your plan for rehabilitation

(restoring damaged land and planting trees) in accordance with the guidelines," he said.

In addition, when he visited the two gold refineries in Geita, Waitara urged the stakeholders to adhere to environmental law at all times without waiting to be visited by officials.

Tourism agencies must reinforce competition for tourists to return

home to roost in the country's tourist attraction strategies and policies, with the discovery that over 80 percent of all foreign tourists coming to Tanzania don't feel the need to return for repeated experience. Such a situation implies that tourism agencies are compelled to rely on scouting for new visitors each year, a rather difficult task contributing to insufficient numbers of tourists annually. It also means that this problem will have to be resolved so that existing tourists' visits targets are feasible.

This admission was made by none other than Dr Aloyce Nzuki, the Permanent Secretary in the Ministry of Natural Resources and Tourism, before an audience of media practitioners early this week, underlining that there is need to find out why only 20 percent of tourists visiting the country return for another take.

He said that the ministry and agencies working under it must seriously work to find out why most tourists do not want to come back, after sampling our tourist attractions. Is it just what tourism is about, for once?

What the permanent secretary appeared to say what that this situation is not typical for tourism as a whole, and indeed there are numerous stories of people travelling to some places say during the torrid mo month of August (for many European counties). Such travels become part of their lives, as their preferred tourist places become a sort of second home, for instance the way catwalk queen Naomi Campbell of the UK, who has Jamaican heritage, used to come for holidays in Kenya each year, for decades. That is what it is supposed to be, by building

HICKEN are coming effective bonds with those who home to roost in visit the country, not coming just the country's tourist once.

Tanzania was already getting up to 1.5m tourists in the last year or so before the COVID-19 pandemic, which implies that even by what the permanent secretary said was attracting tourists by 'word of mouth' it would still have been quite effective. But as he said, this base needs to be deepened by creating the right conditions for tourists to come back, as the more they tend to return, the bigger the number of tourists we shall be getting annually. When they don't return, incremental increase by scouting for new tourists shall clearly be a hard task for the ministry and tourism agencies; that is why it is a fairly disturbing discovery.

The media personnel at the meeting had some suggestions to make, for instance the idea that the ministry needs to overhaul the hospitality industry, especially service providers at airports, ground handlers, restaurants, hotels, lodges and other areas of accommodation coming into direct contact with tourists. It is unlikely that this view was shared by other participants, especially the key service providers in major conservation areas like the Ngorongoro Conservation Area. The commissioner expressed other worries for instance population increase, human wildlife conflicts and maintaining corridors, calling for change.

Chances that an internal dialogue between conservation authorities and the ministry will yield much are limited. The ministry ought to study what happens in competing countries and in what manner they may have an edge in eliciting the loyalty of tourists to return several times in a decade.

In Tanzania stunting has gone down from 42 per cent in 2010 to 32 per cent in 2018 while thinness dropped from 3.8 per cent in 2014 to 3.5 per cent in 2018, prevalence levels that are still well below

TUNTED growth is a the goals set by the World Health reduced growth rate in Organisation (WHO), official human development. statistics indicate.

Dr Honest Kessy the Director of Food Security in the Ministry of Agriculture made this observation recently in Dodoma when officiating a meeting of the task force for nutrition issues in the sector. He said that in addition to efforts by the ministry, there is need for stakeholders to work with the government in coordinating action to reduce malnutrition levels to lower stunting levels and thinness to five per cent as per WHO targets.

He said it is possible to reduce prevalence levels further, where it is vital to increase understanding of the problem and to extend education efforts on the community on how to change their dietary habits in particular, especially what kinds of food young children are fed with.

A Mid Term Review on Nutrition conducted in 2019 showed that maize production had increased owing to a great push by the government, but production of other crops and poor eating habits led to poor results in stunting and thinness, he stated.

Regions leading in maize production have also scored highly in the prevalence of stunting, on account of the habit of equating maize meal with food, leaving other things to chance, hence stunting levels are high in Njombe (53.6); Rukwa (47.9); Iringa (47.1); Songwe (43.3); Ruvuma (41) and Kigoma (42.3), which are also highly rated in maize production.

The social evil called 'instant justice'

ROM time immemorial, mob justice or 'instant justice' has been a common practice of punishing crime suspects in Ghana. In spite of concerted efforts aimed at promoting human rights worldwide, this inhumane act is still prevalent in most developing countries.

Admittedly, the spate of mob action leaves much to be desired as far as our democracy, human rights, and the rule of law are concerned. Not a single week passes without incidence of mob justice making the headlines in the media.

Mob justice, popularly referred to as instant justice, is when ordinary citizens take the law into their own hands to punish alleged criminals. This is an unlawful process of punishing suspects, and a violation of their fundamental human rights and dignity.

The modus operandi of 'street' justice can take the form of flogging or hacking suspects to death, slashing, lynching, and stoning. Sometimes female suspects are stripped publicly, pounding victims with bricks, setting people ablaze, and many more.

Quite recently, a 16-year-old boy was brutally tortured by a group of soldiers in the Northern Region. The victim, Christopher Bama, was accused of stealing a mobile phone belonging to one of the soldiers.

Subsequently, the soldiers chained the helpless boy to a mango tree and assaulted him ruthlessly until he fell unconscious. The action of the security personnel was unfortunate, and must be condemned in all uncertain

ciiis.

Causes
Instant justice has gained grounds in the Ghanaian society as a result of lack of confidence in the police and the judiciary. It is unimaginable that majority of the citizenry including well-informed persons encourage such disheartening act.

Few weeks ago, I chanced upon a horrifying video about the incidence of mob action on social media. In that amateur footage, two young men were subjected to severe beatings by an aggressive mob for allegedly stealing electric wires and car batteries in Tema.

The bloody scene was so disgusting! The crowd repeatedly struck the suspects with their bare hands, clubs, bathroom slippers and all kinds of objects. I overheard the voice of a woman urging the charged mob to carry on with the beatings.

The video caught the attention of many. Of the total 1,215 people who watched footage, more than 500 posted their comments on Facebook. However, most of the comments went in favour of instant justice with just a few condemning the act.

One Jasmine recounted how her cousin was killed in 2014 through mob action when he went out to see his girlfriend off. Unfortunately, he was mistaken for a suspected thief on the run, so the crowd lynched him on the spot.

Actually, there have been several instances where innocent people lost their lives as a result of mistaken identity. During such circumstances, suspects are not given any chance to speak or explain themselves.

Another factor that accounts for mob justice is the excessive

delay in justice delivery and the purported corruption among the elements of the Criminal Administrative System. After all Justice delayed is justice denied.

Inasmuch as the perpetrators of mob justice go unpunished, this gruesome practice is not likely cease in our communities.

Abuse of rights

The 1992 Constitution of Ghana guarantees that the dignity of all persons shall be inviolable, and that no one shall be subjected to torture or other cruel, inhuman or degrading treatment or punishment.

The Universal Declaration of Human Rights also admonishes the right to a fair trial, and the right to stand innocent of a crime until proven guilty.

Regrettably, the rights and freedoms of alleged criminals have, for too long, been trampled upon with impunity in Ghana. The enthusiasm to opt for instant justice is widely practiced across the country.

Mob action is as an affront to humanity, and must be condemned vehemently. This deadly practice is inhumane and intolerable in a democratic country like Ghana. The fundamental human right of every Ghanaian must be respected.

The rule of law

The escalating cases of mob justice in Ghana are alarming. This is a sign of moral decadence which exposes some weaknesses in the rule of law and the Criminal Justice System.

The recent exposé of investigative journalist, Anas Aremeyaw Anas, on corruption in the judiciary is not a case in isolation.

Mob action affects the laid down process of punishment for criminal offences, since the rule of law is not strictly adhered to and sometimes compromised.

The Code of Criminal Procedure spells out specific punishment for every offence, but this is sometimes compromised by corrupt officers.

For instance, in January 2015, a suspect was set ablaze for allegedly stealing a wallet in Accra. Of course, the punishment was too harsh for this minor offence. Street justice is a criminal method of punishing suspects.

It is a fact that the practice of mob justice has not reduced crime rate in any way. This has rather toughened most criminals who operate with the 'do-and-die' mentality; raping and killing their victims without any provocation.

The culture of social justice on the spot must cease in order for the rule of law to take its full course.

Public education

The Human Rights and Administrative Justice (CHRAJ) should treat mob justice with the urgency it deserves by teaming up with the National Commission for Civic Education (NCCE) and educate the public to refrain from this unlawful act.

The fight against instant justice should not be left to CHRAJ alone. It is, therefore, incumbent on the security agencies, human rights' activists, journalists, religious leaders, traditional leaders, and opinion leaders to play advocacy roles for fair justice.

In the 21st Century, the menace of instant justice is unjustified in Ghana, which is reputed as a beacon of democracy in Africa. This appalling act has negative implications on the image of Chana

Anyone found culpable of the crime should be prosecuted to serve as deterrent to others.

Its five-years plan is aligned with key national development frameworks, particularly, the Tanzania Development Vision 2025, the Ruling Party Manifesto of 2015 -2020 and the Second National Five-Year Development Plan (2016/17 - 2020/21) which

Overall, the RSOP embraces comprehensive programming and organisational development towards supporting the government's efforts to enhance inclusive and competitive economic development through world-class economic and technical regulation of the energy (electricity, down and mid-stream petroleum, natural gas) and water sectors.

Purpose of the RSOP is to implement EWURA's fifteen (15) years Strategic Perspective Plan (SPP) for 2019/20 - 2033/34.

Thus, the RSOP articulates the Authority's vision, mission, strategic objectives, targets and key performance indicators (KPIs) for 2020/21 - 2024/25.

It likewise presents the main strategic and operational activities of the Authority for the five-year period. EWURA operates in an environment characterised by fast and dynamic complexities - with static strategic plans becoming obsolete rather quickly.

As such, the Authority has adopted adaptive management style, supported by rolling strategic plans. The RSOP will be revised and updated towards the end of each of the first four years.

It should be noted that at the end of each of the first four years, only moderate reviews will be done with a major and in-depth review during the fifth year. While rolling the plan, experience of the outgoing year and new requirements for the second through sixth year will be considered.

The rolling process requires to be informed by performance review/ assessment of each outgoing year of the RSOP and rapid environmental scan conducted towards the end of the same year.

According to EWURA, during the five-year period, 2020/21 - 2024/25, the authority through the RSOP will pursue the following six (6) strategic objectives (SOs): Interventions against HIV/AIDS and Non Communicable Diseases enhanced; implementation of the National Anti-Corruption Strategy enhanced; quality, availability and affordability of regulated services improved.

Others are public knowledge, awareness and understanding of the regulatory functions in the regulated sectors enhanced; EWURA Legal and Regulatory Environment Improved; EWURA functions effectively and efficiently managed.

The RSOP has translated each strategic objective into key strategies, output targets, performance Indicators (KPIs) and strategic as well as operational activities.

Accordingly, two detailed implementation activity schedules

have been presented in the RSOP: Rolling Strategic Plan Matrix ...

The Results Framework is presented to facilitate the monitoring and evaluation of the RSOP. It presents the main expected results, monitoring plan, reviews, and evaluation and reporting arrangements.

This will allow timely identification of implementation challenges and hence facilitate remedial measures in goodtime during implementation.

It will also facilitate the evaluation of the RSOP to ascertain the extent to which the set objectives are being realised, as well as address other issues involved in the evaluation of the RSOP.

The Second National Five-Year Development Plan: 2016-2021 "Nurturing Industrialisation for Economic Transformation and Human Development", targets to improve electricity connections from 36 percent in 2015 to 60 percent of the population in 2020.

For the water sector, it is planned to increase access to water services in Dar es Salaam from 68 per cent in 2015 to 95 per cent in 2020, from 86 per cent in 2015 to 95 per cent in 2020 for Regional Centres and from 57 per cent in 2015 to 95 per cent in 2020 in district capitals, townships and national project areas.

The country also aspires to promote access in the petroleum and natural gas sub-sectors by ensuring sustainability and safety of petroleum products and natural gas supply through quality infrastructures.

During the years of its existence, EWURA has made tremendous efforts to inform and educate key stakeholders and the public on the regulator's roles and functions.

Given that, awareness creation is a continuous process, during the period of the current RSP, EWURA will strive to develop and implement a proactive information, education and communication (IEC) programme, which should cover all key stakeholders including politicians, senior government officials, and the rural population.



Recently, Meghan Markle, the Duchess of Sussex, wrote a piece sharing about her miscarriage. I knew, as I clutched my firstborn child, that I was losing my second, she wrote. She is part of a growing list of celebrities who have publicly shared their experiences with mis-

Model Chrissy Teigen also recently shared the pain she and her husband singer John Legend felt about the miscarriage of her third pregnancy. While celebrities may make news for sharing their personal grief, they are not alone in experiencing it.

Miscarriage is the most common reason for losing a baby during pregnancy. It happens for up to 15% of women who knew they were pregnant. According to World Health Organization, a baby who dies before 28 weeks of pregnancy is referred to as a miscarriage, and babies who die at or after 28 weeks are stillbirths. Most miscarriages are due to chromosomal anomalies. The risk of miscarriages increases with age.

No matter when it occurs, however, nor how old the pregnant woman is, a miscarriage exerts huge mental stress on the women and their families.

When I tweeted about Markle's piece, Abuja-based Martha Ngodoo responded to my tweet - "This is one part many women who have gone through loss are never asked or speak of. Reading hers, I remember mine. We all just learn to live with it. If I will ever write a book, I will of mine".

After reading Ngodoo's tweet, I was compelled to reach out and hear her story. She said she experienced both miscarriage and stillbirth. She is now a 40-year-old mother of three.

Her first experience was a stillbirth that happened 16 years ago during her first pregnancy when she was 24 years old. This was a case of a poorly managed preeclampsia (high blood pressure in pregnancy). She went into labor and was rushed to the hospital. She was in labour for 72 hours. The medical team

tried to induce labour using oxytocin but was unsuccessful. Her dead baby was eventually pulled out by hand in an assisted delivery.

Her second experience was a miscarriage which happened five years after. She was aged 29 years then and the miscarriage took place at her twenty-second week in pregnancy. She had a fever during this pregnancy. One night, she woke up with the urge to urinate. When she attempted, her baby came out in bits. She was then rushed to the hospital and the baby was completely expelled. It was a horrible experience, she said.

Both experiences made Ngodoo wonder what she had done to deserve such pain, twice. Though her husband was very supportive, she was worried about giving him dead babies from her pregnancies. Some cultural beliefs made this more diffi-

cult. Her husband suggested they move into his parent's home so she could get additional support. However, this turned out to be very unhelpful. For instance, her fatherin-law wanted her to continue life as if nothing happened after the stillbirth.

Ngodoo is stronger now and after many years and three successful pregnancies, she is able to talk about her experiences without feeling

she recommended for helping women deal with the pain of miscarriages and stillbirth, she shared three suggestions.

First, don't tell a woman that it is "okay" when she loses a pregnancy and dismiss what she's been through. Women undergo physical and psychological changes during pregnancy. They develop deep attachments to their unborn babies and losing one is painful. It is okay sad. When I asked her what for a woman who has lost a

pregnancy not to feel okay.

Fourteen years after, Ngodoo still wonders what her daughter would be like now if the pregnancy did not end in a stillbirth. She still does not know where her daughter was buried. These are thought that still plague her mind, even though she is not as devastated as she once was. She has learnt that talking about such experiences allows victims to exhale and then allow the healing process to begin.

Second, women that lose pregnancies need mental health support. Ngodoo wants more women to receive the kind of mental health support that would enable them to speak about their experiences. A way to achieve this is through training counsellors to lead support groups for victims.

These support groups could be at communities, health facilities or embedded within professional associations. There are lessons from the UK-based Miscarriage Association. The association has a network of support volunteers, who have been through the experience of pregnancy loss themselves and can offer real understanding and a listening ear. This is done physically or virtually, through Zoom meetings.

Third, families of victims of miscarriage should be safe havens, especially when others may not have even known about the pregnancy, let alone the loss. Sadly, this is not always the case.

Ngodoo lived with her in-laws (in the family house) after her wedding. She feels her in-laws should have understood her loss better and not attempted to get her to resume normal activities immediately. She wishes visitors to the house wouldn't have told her that she should carry on with her life because she is not the first woman to lose a pregnancy.

Ngodoo is now a mother to a daughter and two sons. Her daughter is 7 years old and her sons are 13 years and 10 years respectively. She describes her two sons as rainbow babies - born immediately after miscarriages. They are the sunshine that we are blessed with after a loss, she said.

With support, women can begin to heal after miscarriage. When women feel strong enough to share their miscarriage stories, it inspires others. The Duchess of Sussex is inspiring women by sharing her story. This should be the norm.

Tractors can change farming in good ways and bad: Lessons from four African states

GRICULTURAL mechanisation is on the rise in Africa, replacing hand hoes and animal traction across the continent.

While around 80-90% of all farmers still rely on manual labour or draught animals, this is changing, driven by falling machinery prices and rising rural wages. During the last couple of years, tractor sales grew by around 10% annually.

A look at the history of today's mechanised countries shows that a widespread replacement of manual labour with mechanical power can have large socioeconomic and environmental implications.

In our latest study, we explored how mechanisation could change the face of African farming and rural areas. It's important to ensure that mechanisation can be accompanied by policies that harness its potential and minimise potential negative effects.

To understand the effects of mechanisation, we collected data in 87 villages in Benin, Nigeria, Mali and Kenya. These villages were chosen as examples because they've already experience mechanisation. We conducted 129 focus group discussions with 1,330 rural residents. They identified various ways that mechanisation affected farming, rural life and nature.

The insights from the 87 villages revealed the great transformative power of agricultural mechanisation. Mechanisation can reduce work burden, raise prosperity and enhance diets. But there are also challenges such as soil erosion, deforestation and women's access to tractor services.

Identifying these challenges provides an opportunity to prevent them from arising, through agricultural research and appropriate policy action.

Our study focused on the use of tractors for land preparation as this was the most commonly mechanised activity across the case study countries. Preparing land is labour-intensive and is usually the first



activity to be mechanised. Participants were asked to mention positive changes directly related to mechanisation. They then identified subsequent changes. What they told us formed a picture of a chain of impacts.

Overall, we found that mechanisation has more far-reaching agronomic, environmental and socioeconomic consequences than commonly assumed.

On the upside, it frees men, women and children from heavy agricultural

work. This gives them time to do other things, like running non-agricultural businesses or going to school.

Mechanisation also helps to overcome labour bottlenecks, a well-recognised constraint to rain-fed agriculture. This allows people to cultivate more land, as 61% of the respondents reported. In Mali, one farmer said:

Using a tractor also improves the timeliness of agriculture. Farm activities can be completed at the optimal time, which raises yields. This was noted by 72% of all respondents. The overall increase in agricultural production contributes to enhancing food security and reducing pov-

On the other hand, 58% of the respondents noted that mechanisation can undermine long-term soil fertility, in particular when the disc plough is used. They said the use of heavy tractors can trigger soil erosion and compaction. In Benin, one farmer reported:

Another concern is deforestation. Cultivating more land can mean losing trees on a large scale. Even clearing trees from fields so that tractors can operate there reduces biodiversity and makes the soil more susceptible to rain and wind erosion. In Mali, one farmer reported:

Some effects are highly context-specific, such as employment effects. In Benin, where mechanisation was associated with area

expansion, this greatly raised the demand for labour to carry out the non-mechanised parts of farming. Here, no unemployment effects were reported, confirming a pattern from countries such as Zambia.

In Nigeria, where fewer farmers expanded land sizes, 48% reported job losses. Employment effects can be non-direct as well. Many rural residents reported that the rising prosperity of farmers due to mechanisation leads to positive spill-overs to nonfarmers such as blacksmiths, carpenters and hairdressers.

As with most new technologies, mechanisation has benefits for some but not for others. While other studies have found that smallholder farmers have less access to mechanisation, this was only mentioned by 15% of the respondents. But mechanisation is less accessible for women compared to men. This was reported in all countries but it varied: 71% of women in Mali shared this perception but only 5% of women in Benin.

Most negative effects are not inherent to farm mechanisation and can be addressed with complementary agronomic practices and adequate policies. Soil erosion can be reduced with conservation agriculture, which protects soils by replacing heavy disc ploughs with less soil-disturbing rippers or direct seeders and continuous soil covers.

Deforestation can be minimised with careful land-use planning, for example, by protecting land that is particularly valuable for climate change mitigation, biodiversity, and wildlife.

Entry points to ensure that women benefit from mechanisation may comprise campaigns showing women role models using tractors, supporting women's mechanisation groups and developing knowledge and skills.

With the right policies, countries can harness the potential of mechanisation and manage challenges. This can ensure that mechanisation contributes to an African agricultural transformation that is sustainable from a social, economic, and environmental perspective.

China's poverty reduction offers lessons for Africa raises critically

CHINA has declared victory over extreme poverty following painstaking implementation of carefully designed decades-long poverty reduction programs. China now holds the record as the country with the most consequential feat against penury, having lifted more than 800 million people out of poverty.

This success has not only earned Beijing admiration from around the world, but is also a powerful example of what is possible when government and people work together on a specific vision.

In many ways, China is an inspiration to the African continent as far as poverty reduction is concerned. Africa is home to the largest number of developing economies, while China is now the largest developing economy, aiming for moderately prosperous status.

With more than 30 percent of Africans still living in extreme poverty-constituting over 70 percent of the world's poor-it is not hard to understand why China's enviable milestones in poverty reduction continue to resonate with governments and citizens in Africa.

For instance, much work on eliminating poverty from the face of the Earth should be actualized in Africa to realize the United Nations Sustainable Development Goals. If nothing is done differently, the World Bank estimates that up to 90 percent of global poverty will be on the continent by 2030. This is worrisome, because the year 2030 is also the UN's deadline for eliminating poverty in all

China's poverty reduction in rural areas, anchored on agriculture modernization, offers good insights for Africa's socioeconomic transformation. Since technology. In this way, the con-



the founding of the People's Republic of China, the nation's agriculture has undergone a series of improvements spanning land reforms, agricultural cooperatives and marketization. Hoisted by modern farming methods, targeted institutions as well as progressive policies, the shift from subsistence to comprehensive agricultural production economically empowered China's rural majority and formed a key component of poverty reduction.

To feed its rapidly growing population of 1.2 billion people, Africa must move beyond traditional, one-dimensional agriculture into a multifaceted enterprise driven by science and tinent can realize higher inputs, low consumption, high quality and efficiency in its agricultural value chains.

The African Union has set the task of ending hunger on the continent by 2025-a task made more challenging by the COV-ID-19 global pandemic, which is pushing millions more African households into extreme pov-

Given that the majority of Africa's population live in rural areas, effective poverty reduction programs should target that group, and agriculture remains the strongest vehicle to deliver economic sustainability and food security.

Africa can also learn from China about the use of information technologies in marketing agricultural produce. The Taobao village model has, for example, enabled millions of farmers to reach far-away clients, thanks to the power and reach of the internet. This has not only led to more inclusive growth, but also has benefited multiplier industries, such as logistics, that are crucial to ensuring that products reach buyers.

In the wake of climate change, Africa's agriculture should also be anchored on sustainable ecological conservation practices. Despite being the least greenhouse gas emitter, the continent has borne the brunt of global warming with floods, droughts and erratic rainfall, further compounding its agricultural

prospects.

Finally, there is no doubt that infrastructure connectivity and market integration are strong factors in hoisting modern agricultural production.

Africa is currently implementing the African Continental Free Trade Area, an ambitious project that aims at integrating African economies, currently valued at \$3.4 trillion. China and the African Union have both initiated policy dialogue to fuse the aspirations of the AfCFTA and the Belt and Road Initiative. A successful AfCFTA would mean greater potential for Africa's agriculture, and China is proving to be a dependable partner to deliver on the promise.

endangered gorillas

AROUND 140 kilometres north of Congo's capital, Brazzaville, is gorilla country.

"Mr. Cyd", as he's known, is one of 40 primates living at Lesio-Louna Gorilla National Reserve. He was given the nickname by former reserve workers.

Guards regularly patrol the reserve, tracking the gorillas and watching out for poachers.

"The first mission is to find the baby gorillas, look after them, and release them into the wild so that the species does not disappear," says guard Samuel Guebou.

It's here, behind this fence, that some of the reserve's youngest gorillas are kept.

Access is prohibited, due to hygiene restrictions linked to the coronavirus outbreak. Guards that do enter are subject to strict protocols and must quarantine after returning to the reserve.

Guard Okandza Stheve, who has worked here since 1997, says they've developed a special relationship with the younger gorillas.

"Since we spent a lot of time with the gorillas, they've become like village children to us," he says.

Thirty-six gorillas were released from the reserve and into the wild between 1996 and 2017.

Fruit is kept in this storeroom, then delivered across a lake via canoe, giving the gorillas some elements of

It's quite a sight for visitors, including Raul Mateus Paula, the European Union's ambassador to Congo.

"So, this return to basics, and then these gorillas who are protected, who have sometimes undergone difficult times and who find a sanctuary where they can contribute to the preservation of nature."

The western lowland gorilla lives in the forests of Gabon, Central Africa Republic, Cameroon, Angola, Equatorial Guinea, the Democratic Republic of the Congo and the Republic of Congo.

It is the most numerous and widespread of all gorilla subspecies according to the WWF.

The subspecies was declared "critically endangered" in 2007.

Over a 25-year period, the combined threats of poaching, illegal hunting for the bushmeat trade, habitat loss, and emerging diseases such as Ebola reduced populations by 60 percent.

In certain parts of western Africa, their populations declined by as much as 90 percent.

Poaching has decimated Congo's gorillas, the central African nation's emblematic species, and remains a threat, despite the mammals being a protected species.


"On the recommendation of the National Coronavirus Command Council, and after consultation with provinces and metro mayors, Cabinet has decided to put the country on an adjusted Level 3 from Level 1 with immediate effect," Ramaphosa said.

The most significant of the new regulations are as follows:

- The nationwide curfew has now been extended from 9pm
- Non-essential establishments, including bars and restaurants, must close at 8pm;

Ramaphosa said that these regulations have been selected in the hope that the economy can largely be kept open while Covid-19 prevention measures are strengthened. He acknowledged that the ban on alcohol was likely to be controversial, noting the contribution made by the industry to the economy.

"We can confirm that we have signed off on the agreement with COVAX and the Solidarity Fund has made the initial payment of R283 million to the facility," said Ramaphosa.

Although he said South Africa is part of the "first group of countries" due to receive vaccines from COV-AX, their arrival is only expected in the second quarter of 2021.

"We are also having parallel bilateral discussions with a number of vaccine manufacturers, and will make further announcements once firm agreements are in place," Ramaphosa said.

The president at points appeared almost on the verge of tears as he begged South Africans to take responsibility for their behaviour over the festive season.

"We are at an extremely dangerous point in our fight against the pandemic," Ramaphosa said.

One of the concerning factors currently is the number of frontline health workers falling sick with Covid-19: 4,630 since the beginning of December, with over 41 000 infected since the start of the pandemic.

Ramaphosa was addressing the nation a day after South Africa passed the mark of more than one million confirmed Covid-19 cases, with more than 50 000 new cases reported since Christmas Eve.

The new restrictions announced

by the president are, however, much stricter than those known to have been recommended by the Covid-19 Ministerial Advisory Committee (MAC) less than a week ago.

A report from the MAC dated 23 December 2020, seen by Daily Maverick, stated that three factors were responsible for the rise in Covid-19 cases across the country: the increased transmissibility of the new coronavirus variant; complacency leading to reduced adherence to prevention measures; and superspreading events.

The MAC recommended that the country be moved to Level 2 restrictions "as soon as possible". It stipulated, however, that two Level 1 restrictions should remain in place: the national curfew should be maintained at 23h00 and accommodation capacity should be maintained at 100% due to the logistical nightmare of trying to reduce it now.

"At this stage, stricter lockdown measures than Level 2 are not recommended," the MAC stated.

It suggested that a further assessment be made a fortnight after moving the country to Level 2.

Opposition parties and trade unions, meanwhile, have criticised the government for not acting with greater speed and decisiveness to secure a vaccine, which the DA described as "the only solution, and the only alternative to lockdown".

In a statement responding to Ramaphosa's Monday announcement, DA leader John Steenhuisen also slammed authorities for seeking to "simply shut down certain industries without simultaneously announcing a single cent of relief programmes to bridge the economic devastation that this will wreak on the hospitality and restaurant industries".

Alarm over new wave of locusts

Kenya is staring at a possible crisis in the coming weeks as desert locusts land in the country after breeding near the Tanzania, Ethiopia and Somalia borders, where egg laying and hopper band formation has been reported.

Already, the pests have invaded farms and pastures, threatening the already distressed vegetation in Taita-Taveta, Kilifi and Tana River

In Taita-Taveta, agriculture officers have launched a campaign to combat the infestation while in Kilifi and Tana River, residents have raised concern over increasing numbers of insects in the area.

In Tana River, the most affected areas include Chara, Kilelengwani and Kitere. In Chara, farmers are camping in their farms in an attempt to keep the locusts away.

Over 3,000 acres of vegetation in the county have been ravaged, leaving more than 1,000 families in food distress. Of the 3,000 acres, an approximate 1,200 acres are farmland, with Hola irrigation scheme also in-

"The adult locusts caused a little bit of damage to the crops but we sprayed. However, we noted they were in the farm by dawn, we responded at about mid-morning. They certainly may have laid eggs, hence a possibility of the larvae emerging," said the scheme's agronomist, Johnson Muko.

The ground team and scouts, upon sighting the locusts in the field, take photos and videos and upload them onto the E-Locust app, developed by the state in collaboration with the UN agency.

The gathered information is sent in real-time to a database at the locusts control centre in Nairobi to guide in the control operations.

A large immature swarm was last week spotted at Kebri Dehar in the eastern part of the Somali region of Ethiopia.

Immature swarms continue to form within a large area in eastern Ethiopia and central Somalia and a big number of hopper bands are fledging to form new immature swarms even with intensive ground and aerial control operations underway in the two countries.

"The swarms are expected to move south anytime to southern Somalia, southern Ethiopia and then Northern Kenya," Food and Agriculture Organisation (FAO) said in a December 19 update.

Meanwhile, FAO has also warned that without additional funding, locust control efforts could slow down or halt from the end of January 2021, potentially allowing the numbers of the voracious pests to surge in some places. Also, the agency says that farmers whose livelihoods have been impacted require further support.

According to FAO, control operations have prevented the loss of an estimated 2.7 million tonnes of cereals worth nearly \$800 million (Sh89.2 billion) in countries already hard hit by acute food insecurity and poverty, food enough to feed approximately 18 million people a

While control operations are underway in the affected counties, FAO has called for intensive surveys between Mandera and Turkana counties.

There are fears the expected wave of locusts will multiply further and wreak havoc on farms and pasturelands in the arid and semi-arid counties that continue to grapple with prolonged drought.

Millions of the desert locusts have caused destruction across East Africa in what the agency has termed the worst outbreak in a quarter of a



The government faces a difficult task in dealing with the impending invasion which will cause further suffering to Kenyans adversely affected by the Covid-19 pandemic.

Breeding is ongoing on both sides of the Red Sea and adult swarms have started laying eggs on the coastal plains of Eritrea, Sudan and Saudi Arabia where control operations have been intensified.

"Extreme vigilance and preparedness is required in Kenya and close monitoring and control operations continue along both sides of the Red Sea," the agency noted.

SA's competition watchdog approves Google, Fitbit deal

JOHANNESBURG

South Africa's regulator the Competition Commission (CompCom) has conditionally approved the proposed merger whereby Google intends to acquire Fitbit. In a statement, the competition watchdog says this is a global merger, notified in several jurisdictions, including the EU, US, Australia, Canada and Japan.

It notes that Google is active in a wide range of areas, including online search, online advertising, other online services such as YouTube, Google Maps and Gmail as well as cloud computing services. In addition, says the CompCom, Google maintains and develops the Android ecosystem which includes an open source mobile operating system (OS) and a suite of mobile apps and services.

"Google's business in South Africa relates to the provision of local support and marketing services internally for Google. Google does not sell any wearable devices or hardware in South Africa. The main products and services relevant to this transaction are Wear OS, Google Fit, The Play Store, Google Search and Google Ads," the regulator

It points out that Fitbit develops, manufactures and distributes wristworn wearable devices and smart scales as well as software and services designed to give its users tools to help them reach their health and fitness goals. The main Fitbit products available in SA are fitness trackers, smartwatches and the Fitbit mobile app.

The Commission found that the proposed transaction is likely to result in a substantial prevention or lessening of competition. The Commission was concerned that as a direct result of the proposed merger, Google will exclude Fitbit's competitors in the market for wrist-worn wearable devices.

As a direct result of the proposed merger, Google will be able to exclude competing suppliers of wrist-worn wearable devices from accessing its Android operating system for smartphones, says the Commission.

It explains that Android is a dominant mobile OS and, unlike the Apple ecosystem, it is not vertically integrated into the production of wrist-worn wearable devices prior to the merger.

"This makes Android an important input for third-party smartwatch manufacturers that compete with Fitbit. Bearing in mind the integral connectivity between smartwatches, companion apps to the wrist worn wearable device as well as smartphones, and given the significant market shares enjoyed by Android, the proposed merger will give Google the ability to exclude competitors of Fitbit or frustrate the functionalities of competitors' companion apps from operating optimally on Android OS.

"This will significantly alter the market structure for the supply of wrist-worn wearable devices in SA and increase barriers to entry for potential entrants in the market," the watchdog says. The Commission was also concerned that as a direct result of the proposed merger, Google will entrench its dominance in the online advertising and online search market.

"As a direct result of the proposed merger, Google would acquire (i) the database maintained by Fitbit (about its users' health and fitness); and (ii) the technology to develop a database similar to that of Fitbit. The Commission was concerned that the acquisition of Fitbit's database may provide an important advantage in online advertising markets to Google and allow Google to entrench its dominance in the market," it says.

The Commission was also concerned that as a direct result of the proposed merger, Google will restrict access to health data collected by Fitbit. BUSINESS Livestock dealers earn windfall as sales surge by 100bn/- in Q3

IVESTOCK dealers had a field day during the third quarter of the year when sales surged by over 100bn/-, Bank of Tanzania has said.

In its Consolidated Zonal Economic report for the year ended September 2020, the Central Bank said value of livestock comprising of cattle, goats and sheep sold in registered markets increased by 31.4 percent to 475.85bn/- up from 362.23bn/made in a similar period last year.

"This outturn was largely associated with the increase in demand in the domestic market and neighbouring countries. Cattle which contributed 90 percent of the total sales, registered a 30 percent increase, driven by price increase," the BoT report said.

The report further noted that Central and Dar es Salaam zones continued to account for the largest shares of livestock sales during the period under review. The Central Zone which comprises of Dodoma, Singida and Tabora regions led the pack with sales amounting to 126.04bn/-

up from 110.34bn/-. Dar es Salaam came second on the list with sales amounting to 110.58bn/- up from 81.51bn/- last year.

The report shows that the percentage share of value of livestock sold on registered market continued to stabilize with the Central Zone leading at 27 percent while Dar es Salaam had 23 percent.

The Northern Zone nearly doubled its value of sales to 102.97bn/- from 62.44bn/- during the period while Lake Zone had incredible sales amounting to 96.91bn/- up from the 75.57bn/-.

The South Eastern and Southern Highlands Zone performed fairly with a slight increase of sales compared to last year's figures. South Eastern Zone contributed only 3.6 percent of this year's value of sales while the Southern Highlands accounted for 4.6 percent of the sales.

According to the Ministry of Livestock and Fisheries data, in total, cattle increased from 32.28 million to 33.4million; goats also increased from 20 million to 21.29 million while sheep increased to 5.65 million from 5.5 million.

Chartered flight raises tourism hope in Mombasa

MOMBASA

Hoteliers in the Coast region have expressed hope of recovery in the tourism sector despite the adverse effects of coronavirus pandemic on their businesses.

The stakeholders are holding on hope for the recovery of international tourism after the arrival of a first international charter flight operated by TUI Poland in Mombasa on Boxing Day. The aircraft flew in from Warsaw, Poland with 175 tourists for a 10-day holiday at the

The Enter Air, on lease to TUI Poland, touched down at the weekend to a water cannon salute by Kenya Airports Authority (KAA) Fire Brigade. The Kenya Tourism Federation chairman Mohamed Hersi and KAA Coast regional manager Peter Wafula received the tourists. They expressed optimism that the sector would fully recover in 2021.

"The arrival of this charter service that will be flying in every Saturday up to mid-March 2021 gives us hope that we are headed on the path to recovery, albeit the ravaging effects of Covid-19. We remain optimistic that with vaccines being found, there can be hope for at least a return to normalcy in all sectors of the economy," said Mr Hersi.

He added that tourism in Kenya would take longer to fully recover due to the recent restrictions on travel in the UK and Europe. "In fact, our optimism in Kenya is more affected by our own political environment and uncertainty but have everything going for us," he said. Kenya Coast Tourism Association chairman Victor Shitakha said even though 2020

had its fair share of challenges, the New Year may be marred by political uncertainty, which could hurt the tourism industry.

"This is the year of election campaigns. We are not having a lot of guests coming down. We are entering a highly politically charged year. This may be our undoing even as we hope for the best in 2021," he said.

Nigeria is now number two in global bitcoin market

During the police brutality protests in Nigeria in October, bitcoin saved the day when the government shut out protesters from using local payment platforms for collecting donations to support it.

The young, tech-savvy protesters quickly switched to using bitcoin, and in about a week bitcoin accounted for around 40% of the nearly \$400,000 raised. It was just one high-profile example of how young Nigerians increasingly use bitcoin to navigate a complicated and restrictive banking and monetary system.

In the last five years, Nigeria has traded 60,215 bitcoins, valued at more than \$566 million which, apart from the US, is the largest volume worldwide on Paxful, a leading peer-to-peer bitcoin marketplace. The data scraped from Coin Dance shows from the beginning of May 2015 to the middle of November this year, bitcoin trade in Nigeria have increased yearly at least 19% in volume since 2017, and the highest volume (20,504.50) was traded in 2020.

Bitcoin trade had its highest spike of 30% this year during the national

lockdown in the country and the highest volume traded during the peak of the pandemic. Between January and September, Paxful reported a 137% increase in new regis-

trations in Nigeria. Peer-to-peer (P2P) exchanges, which are decentralized platforms that directly connects buyers and sellers without third parties are the most popular way to buy bitcoin in Africa because users do not have to worry about cryptocurrency regulation by the government. Paxful is the largest platform for P2P trade in Africa and overtook LocalBitcoins in

June this year to be the Largest P2P bitcoin marketplace in the world, controlling 52% of the market share.

The company says Nigerians make up around a quarter of its customer base with 1.3 million registered accounts. "They mostly use the platform for peer-to-peer and arbitrage trading," says Nena Nwachukwu, Paxful Nigeria regional manager. "Remittances is also a popular use case." Nwachukwu says bitcoin transfers are "much cheaper and faster than using traditional money transfer operators." The growing uncertainty and instability around

the Nigerian naira, which has had increasingly divergent official and parallel exchange rates with the US dollar, has created an opportunity and practical use case for bitcoin trade in Nigeria. The divergent rates have long been a striking feature of Nigeria's economy but more so in the last half decade as the country's financial authorities have attempted to micro-manage the supply of foreign exchange and "defend" the naira.

In the last couple of years, other African countries, most prominently Zimbabwe, have seen a spike in cryptocurrency trade led by bitcoin,

due to currency fluctuations and uncertain monetary policy. In some cases limits to the trade has been prompted by a lack of reliable local platforms.

"The lack of bitcoin liquidity was the first obstacle to solve to introduce bitcoin to Africa," says Ray Youssef, co-founder of Paxful. Nigerians are often restricted on international platforms such as PayPal, which does not allow payment to Nigeria, and local banks place a cap on international transactions and charge high fees for transactions due to dollar deficiency.

Rwanda, UK to renegotiate trade deal

Rwanda and the United Kingdom (UK) will restart negotiations of a potential deal early next year, which would determine the future trade relations between the two countries, a source at the Ministry of Trade revealed. Rwanda currently trades with the UK under the protocols of the European Union, but Britain is entering into a new chapter in its relationship with the rest of the EU members.

This follows an announcement by British Prime Minister Boris Johnson last week that his country had reached a trade deal with Europe after nine months of tortuous talks. It means that countries that were trading with the UK as a member of the EU will no longer do so, instead the UK will be negotiating its own trade rules with the rest of the world.

Already, the country has been negotiating bilateral trade deals with different countries including those in Africa. Kenya, a member of the East African Community (EAC), secured a deal with the UK. The rest of EAC members haven't made any progress partly because they were opposed to Kenya's decision to go for a unilateral deal rather than negotiating as one

Currently, EAC countries do business with the UK under EU trade protocols. Under the current arrangement, Rwanda has been exporting to EU markets without paying duties on many products. This is thanks to the Generalised Scheme of Preferences (GSP).

The scheme makes it easier for

export their products to the European Union. This is done in the form of reduced tariffs for their goods when entering the EU market.

The UK government said it will introduce its GSP scheme on January 1, 2021 under which developing countries like Rwanda will continue to access duty-free markets of the UK. However,

traders from developing countries to countries are hoping to secure a trade deal that will determine the long-term relations with the UK.

> Negotiations between Rwanda and the UK for a potential trade arrangement have been ongoing, at least since March, but were halted due to Covid-19. The negotiations were happening through the EAC customs union framework.

the current chair of the EAC. Rwanda's position has been to negotiate a regional trade arrangement with the UK postbrexit and the end of the transition period for the UK.

"In this regard, Rwanda is looking forward to reengaging our partners in the UK, alongside other EAC member states to conclude on a regional trade agreement," an emailed response from the Ministry reads in part. According to a source at the Trade and Industry Ministry, the projected timeline is to restart negotiations early 2021 and conclude an agreement by December

Future relations

The current arrangement through which Rwanda trades with the UK is a unilateral market access mechanism, which can be modified at any time by the UK government. At the same time, it applies to a large extent to Least Developed Countries (LDC).

"Therefore, Rwanda's development trajectory, once we graduate from an LDC, the 'Everything but Arms' arrangement will be greatly impacted," the Ministry noted. A trade arrangement, or regional trade agreement with the UK offers more predictability, reciprocal trade arrangement, and guarantees Rwanda's Duty Free, Quota Free market access irrespective of economic classification.

Rwanda hopes a potential trade deal would ensure trade continuity for years to come, and allow for the country's nearly \$40 million of exports to continue increasing in the UK market. Total Rwandan exports to the UK averages at \$15 million.

EABL loses in suit over G4S holding of financial, board data

NAIROBI

The East African Breweries Limited (EABL) has lost a court bid to access thousands of confidential business records the brewer left under the care of security firm G4S in the wake of a contract row.

The beer maker wanted the court to issue an order compelling G4S to release the stored materials, which EABL says includes highly sensitive and confidential information like financial, bank and employment records it requires for its operations. But Justice David Majanja dismissed the brewer's petition, arguing that granting an order in favour of EABL would amount to resolving the dispute in support of the beer-maker.

The legal battle started in July last year after EABL asked the security to return 8,106 boxes following the end of three-year storage deal, but G4S said it needed eight months to release the documents and additional warehouse fees.

EABL sought the order as an interim measure, pending the outcome of arbitration proceedings. It also wanted G4S to release the stored materials within 14 days of the order being made. "Since the order would be final in nature, the court would have to make findings of fact necessary to support the order thus usurping the jurisdiction of the arbitral tribunal," said justice Majanja.

Order difficulties

He added that the difficulties in implementing the order cannot be overlooked given G4S had indicated challenges of retrieving, verifying and repackaging the documents within 14 days.

The documents linked to the court battle include EABL's financial information and records, employment contracts and records, banking information and records as well as contracts. Others are production and distribution data, procurement records as well as AGM, board and shareholding information.

G4S demanded Sh4 million for box withdrawal costs calculated at Sh500 per carton. Another Sh10.9 million for retrieval costs of 145,775 files at Sh75 each and Sh1.2 million every month for storage after the expiry of the contract.

The storage fee has hit Sh21.9 million, pushing the G4S demand to Sh36.8 million. EABL reckons that G4S refusal to release the records is malicious and willfully calculated to enable it earn and claim accrued monthly charges. At the centre of the dispute is the agreement of July 6 for the storage of records.

Storing retrieval

Under the contract, G4S agreed to provide EABL services, including storing material, retrieval, delivery and collection, archiving, indexing and racking stored material, destruction and disposal and digitising the stored material.

The three-vear agreement started on July 6. 2016 and expired on July 6, 2019. On June 10, 2019, EABL informed G4S that it would not be renewing the agreement and asked the security firm to provide the stored material for collection on the expiry date. The security firm reckoned that it required at least eight months to return the stored material.

EABL rejected the eight-month plan, arguing it would amount to renewal of the terminated agreement. The brewer said the expiry date of the pact was known and that it received regular inventory statements from G4S of the stored materials, indicating the security firm was ready to release documents at short notice.

Chinese officials join US politicians in suddenly falling out of love with big tech

BEIJING

Big Tech is falling out of favour not just in the West, but in China as well. Recent regulatory crackdowns on Ant Group, Alibaba and Tencent show that China's former tech darlings have run afoul of the all-powerful political and regulatory regime in China.

Published reports indicate that China's central bank and banking, securities and foreign-exchange regulators summoned Ant Group executives this past weekend to discuss official concerns about the

Reuters quoted central bank Vice Gov. Pan Gongsheng as saying that officials criticized Ant for poor corporate governance, defiance of regulatory demands, illegal regulatory arbitrage, the use of its market advantage to squeeze out competitors and harming consumers' legal interests.

The news agency said that while Pan stopped short of calling for Ant's breakup, officials want the firm to set up a separate holding company to ensure its capital adequacy and regulatory compliance. He also said Ant should secure a license to operate its personal credit business, offer more transparency about thirdparty payment transactions and not engage in unfair competition. Reuters quoted Ant as saying in a statement that it would establish a "rectification" working group and fully implement the government's requirements.

Will Chinese authorities force Ant to restructure?

Howard Yu, LEGO professor of management and innovation and director of IMD's signature program, Advanced Management Program (AMP), told PYMNTS CEO Karen Webster last month that regulators would soon force Ant to restructure to address such

concerns. "Any FinTech disruptor, when it becomes so big, represents systemic risk," he told Webster.

For instance, Yu noted that Ant's highly profitable microloan business involves assessing borrowers using algorithms rather than human loan officers, then repackaging and selling off loans rather than holding them. However, Yu believes the algorithms might not capture what would happen in a major economic downturn, assuming instead that China's long expansion will continue indefinitely.

He said that's exactly the combination of circumstances that led to the U.S. subprime mortgage industry's collapse and the 2007-08 Great Recession. As such, Yu believes Ant could require a restructuring to defuse systemic risk.

"The current saga as it unfolded is consistent with the values of Chinese society," he told Webster. "In the end, if Ant Group becomes the biggest financial institution in the world, from a policy maker's perspective, what does it serve

beyond the social bragging?" How big tech fell out of favour

Beijing's tough stance comes some two months after Chinese billionaire Jack Ma, who helped found Internet powerhouses Alibaba and Ant Group, raised the Chinese government's ire by slamming regulators in a public speech at a business summit. Ma criticized China's risk-averse regulators and the global financial system in general as suffering from a "disease of the elderly," arguing that they were strangling innovation.

Shortly thereafter, the Shanghai Stock Exchange shut down Ant Group's record-setting \$37 billion initial public offering just two days before it was to take place. The move reportedly came at the

insistence of top Chinese officials, possibly even President Xi himself. A day earlier, officials had summoned Ma for a face-to-face meeting, and have reportedly since told him not to leave China.

Meanwhile, the State Administration for Market Regulation last week brought in executives from Alibaba (which

owns 33 percent of Ant Group) and five other Chinese Big Techs to read them the riot act. Other tech giants brought to the session included Chinese consumer internet giant Tencent Holdings, food-delivery app Meituan, eCommerce powerhouses JD.com and Pinduoduo and ridehailing powerhouse Didi Chuxing

Technology Co. Regulators reportedly told the Big Techs that it would more closely monitor them going forward, warning against predatory pricing, misusing consumer data and selling fraudulent products.

Authorities last week also fined both Alibaba and Tencent 500,000 yuan (about \$76,400) for failing to properly report previous acquisitions. The Wall Street Journal reported that while the fines were small, they represented the first time that authorities had ever enforced such rules against foreignlisted Chinese firms. The Journal quoted observers as saying the move put tech giants such as Alibaba on notice that they're no longer immune from government oversight.

Chinese officials last month also issued draft rules aimed at preventing monopolistic behaviour by internet firms. Additionally, the Chinese Politburo recently vowed to strengthen anti-monopoly efforts during 2021, reportedly promising to fight "disorderly capital expansion."

Jon Jiang, a PhD student at Australia's Queensland University of Technology who often writes for the South China Morning Post, argued in a scholarly article for the Jamestown Foundation that "Jack Ma's good days have gone, at least for now."

Jiang said some market watchers see the crackdown as "Beijing's humbling of a powerful company and its outspoken leader, asserting the authority of the state above all." He wrote that others see the moves as "a long-awaited regulatory crackdown, arguing that Ant functioned for too long as a quasibank under the guise of a technology company to dodge the scrutiny of financial regulations.'

Either way, Jiang wrote, "the era of regulatory arbitrage appears to have ended, with China's economic leadership beginning to respond to the reality that [FinTechs] will shape the future of financial services."

Beyond just reining in powerful businesspeople like Ma, the sudden crackdown could be aimed at legitimate fears of FinTechs' growing role in China's financial system despite limited oversight. In a recent speech to a Singapore FinTech summit, Guo Shuqing, chairman of the China Banking Regulatory Commission, said authorities are "watching out for the 'too big to fail" financial firms.

Politicisation of virus reflected in failings

San Francisco

DESPITE its advanced medical research and healthcare system, the United States has been leading the world in COVID-19 fatalities and cases.

The country is now in the grip of the "third wave" of the pandemic, one which is much larger than the previous two and has hit the Midwest hardest of all.

The death toll is expected to continue rising, fueled by travel over the Christmas and New Year holidays and lax adherence to mask-wearing and other precautions.

Masks are seen globally as a key tool to contain COVID-19. In many other countries, mask mandates are becoming the norm, but the debate over masks continues in the US.

The top US health officials first told people they should not wear masks and then reversed their guidance. Public health experts have emphasized the importance of wearing masks, which US President Donald Trump has not fully supported.

Trump has long been reluctant to wear a mask in public. He also has refused to introduce a nationwide mandate, saying he wants people to have "a certain freedom".

Critics said the mask mandate in religious settings violated the free exercise of religion. The Supreme Court, with a strong 6-3 conservative majority, has sided with the religious groups against COVID-19-related restrictions in New York, Colorado and New Jersey.

Tensions over mask requirements have led to violence in some states. A store security guard in Michigan was shot dead by a customer whose family was told they needed to wear masks to enter the store.

Anti-mask protests have continued across the country for

Local health officials in California, South Dakota and other states were harassed and threatened for issuing mask mandates. Some cities had to reverse their mask orders or abruptly ended public health meetings under the pressure of anti-mask protests.

State and local governments have varied widely on implementation of mask rules. California was the first to order a statewide mask mandate in June, with many states follow-

There are still 12 states though with no statewide mask requirement such as Arizona, Florida, Mississippi and South Dakota. The Trump administration has been criticized for its inadequate response to the pandemic. The president himself repeatedly downplayed the virus and often contradicted public health experts in their grave warnings about the disease.

Experts said politicization of the pandemic is the reason behind people's resistance to public health measures such as wearing masks. Agencies

More tipped into poverty by coronavirus

THE world was already struggling to end poverty by 2030, and now the coronavirus pandemic is causing the first increase in the global scourge in decades, development fig-

"While poverty is bad, and has been established as such, the COVID-19 pandemic has made a bad situation worse," said Tijjani Muhammad-Bande, president of the 74th Session of the United Nations General Assembly.

Before the onset of the pandemic, 2.1 billion people around the world were classified as poor, with 767 million living in extreme poverty.

Muhammad-Bande tured) said the situation is getting more serious. It is estimated that by 2030, more than 100 million people would due to COVID-19 and climate cess to food, he said. change, he said.

A study released by King's College London and the Australian National University in early April painted an even grimmer picture. About 850 million are at risk of falling into poverty due to the sharp decline in economic activity, according to the UN.

Muhammad-Bande the UN, which has made poverty eradication a top priority, is making greater efforts to achieve its development goals. On June 30, he launched the Alliance for Poverty Eradication, which will serve as a fo-

rum for member states to raise awareness about the danger that poverty poses to world peace, human rights and sustainable development.

The alliance will play an important role in pulling together all the factors in poverty eradication and serving as a onestop networking, informationsharing and bridge-building center, said Muhammad-Bande, who was Nigeria's permanent representative to the UN from 2018 to 2019.

The alliance should provide a mechanism for taking on the poverty challenge from all possible, or at least, multidisciplinary, angles, he said.

"There is no amount of time and attention given to poverty eradication that is too much," Muhammad-Bande said.

It no longer comes as a surprise that globally, one in 12 people live in extreme poverty have lapsed back into poverty and that one in nine lack ac-

> The devastation and uncertainties of the pandemic have added to the challenges, Muhammad-Bande said.

> "This malady which added to the challenge of poverty eradication also opened our eyes to likely disruptions in the future, and hence the need to better prepare for them," he said during the inauguration of the alliance.

Muhammad-Bande said the emerging consensus is that the pandemic will impact heavily on the capacities of least-developed countries to eradicate poverty without external assis-



"It is my hope that the spirit which informed the establish- mad-Bande said. ment of the United Nations will also influence the choices of member states in matters pertaining to poverty eradication worldwide," he said.

"In this respect, I count on the newly inaugurated Alliance for Poverty Eradication to serve as the leading voice on poverty eradication, and to continue raising awareness about the necessity for multilateral cooperation on the matter," he said.

"We should not focus on poverty as manifestations only in the cities but also how poverty is manifested in the countryside," he said.

As the world wrestles with an unprecedented public health challenge, the UN official said it is crucial to strengthen the coordination of multilateral and multipronged interventions to eradicate poverty.

"We should continue to remind ourselves of the danger of unilateral action," Muhammad-Bande said.

"This is the way of the world, we just have to connect properly with each other. Where there are differences, we do not deny other people, we try to understand," he said.

"Respect is important, in this global village, we must respect each other. It's very fundamental to the idea of the modern

China-developed COVID-19 vaccine effective, safe, says Egyptian official

THE China-developed anti-coronavirus vaccine Egypt has received is effective, safe and easier to use, an Egyptian of-

"I am more convinced of the Chinese vaccine, which uses the recognized traditional technology of using killed virus," Osama Abdel-Hay, secretary general of the Egyptian Medical Syndicate, told Xinhua yesterday in an interview.

On Dec. 10, Egypt received the first batch of a Chinese anticoronavirus vaccine to help fight the COVID-19 epidemic. The batch of the vaccine, developed by the China National Pharmaceutical Group, or Sinopharm, came from the United Arab Emirates.

The medical staff in isolation hospitals, people with chronic diseases like cancer and kidney failure, and the elderly, will be given priority in vaccinations, according to the Egyptian Health Ministry.

Abdel-Hay noted that new vaccines using ribonucleic acid (RNA) technology developed by some other countries must be kept at a temperature of minus 70 degrees Celsius, adding that some of these vaccines need to be used within a week of manufacture, while others must be used within two weeks.

"This means that manufacturing, transporting and distributing them involve difficulties that cannot be underestimated for many countries," he said, noting that the Chinese vaccine is ideal for Egypt and its capabilities.

The Chinese vaccine is "suitable for us, and I assure all Egyptians that it is safe," Abdel-Hav said. More than 1 million medical workers at hospitals should be vaccinated to avoid infections, according to the official.

Noting that Egypt is already manufacturing many kinds of medicines for regional countries, Abdel-Hay said Egypt is able to become a regional hub for vaccine industries.

"Egypt also has a company to manufacture vaccines. This could help the country become a center for making and distributing the Chinese vaccine in Africa and the Middle East,"

Protection of Earth calls for ambition of mankind to cope with climate change

CHINESE President Xi Jinping on Dec. 12 delivered an important speech at the Climate Ambition Summit via video link. His remarks have chartered the course, enhanced confidence and boosted the power for the world to better respond to climate change.

Xi proposed to make new advances in climate governance that features cooperation and win-win, foster a new architecture of climate governance where every party does its part, and pursue a new approach to climate governance that highlights green recovery. He also announced some further commitments of China to contributing to climate governance.

Climate change concerns mankind's well-being and future, and to cope with it calls for ambition and resolution.

Five years ago, world leaders showed utmost political resolve and wisdom and adopted the Paris Agreement on climate change, which chartered the course for the world to cooperate on climate change response after 2020. The agreement's goal is to limit global warming to well below 2 degrees Celsius, preferably to 1.5 degrees Celsius, compared with pre-indus-

trial levels. According to a report released by the World Meteorological Organization (WMO) earlier this month,

global temperatures from January to October were around 1.2 degrees Celsius higher than pre-industrial levels. 2011-2020 will be the warmest decade on record, with the warmest six years all being since 2015, the WMO said.

To cope with climate change is an urgent task. At the Climate Ambition Summit, United Nations Secretary-General Antonio Guterres called on governments around the world to declare a state of climate emergency.

"In meeting the climate challenge, no one can be aloof and unilateralism will get us nowhere. Only by upholding multilateralism, unity and cooperation can we deliver shared benefits and winwin for all nations," Xi said at the summit. The reaching of the Paris Agreement was a victory of multilateralism, and the implementation of it cannot go with multilateral cooperation. Following the principle of common but differentiated responsibilities, all countries need to maximize actions in light of their respective national circumstances and capabilities. At the same time, developed countries need to scale up support for developing countries in financing, technology and capacity building.

China was among the earliest to sign the Paris Agreement, urged the G20 to release its first presidency

statement on climate change, and promoted the negotiation on the implementation guidelines of the Paris Agreement. Besides, it also established the South-South Cooperation Fund on Climate Change to help developing countries better cope with climate change. All these efforts prove China's firm support for the multilateral process on climate change.

The Paris Agreement represents the general direction of the world's transition toward green and lowcarbon development. It is a minimum requirement for the protection of the planet Earth, and must be resolutely implemented.

Xi announced in September that

China would scale up its nationally determined contributions and adopt more vigorous policies and measures, saying China will peak carbon dioxide emissions before 2030 and achieve carbon neutrality before 2060.

Andrea Guerrero García, a Senior Advisor for Mission 2020, supporting the UN Secretary General's team on the 2019 Climate Summit, called China's commitment the strongest signal ever received by the world since the inking of the Paris Agreement. China's supercomputer Tianhe is well applied to serve society

AS China's first supercomputer that ever won the title of the world's fastest supercomputer, Tianhe-1 has now become a sharp weapon that blazes the trail for China's scientific innovation. I feel proud of my choice every time I see its rank.

I joined the National Supercomputer Center in Tianjin eleven years ago, when the center just started operation. Back then, a two-bedroom apartment was the place where our team members ate, lived and worked.

When the system deployment and R&D for the Tianhe-1 was just initiated, we transformed the computer room in the daytime installing cables and cabinets, and had to work in shift at night. It was summer then, and we suffered frequent mosquito bites in the 1,000-square meter computer room, which was not air-conditioned. We slept on flattened cardboard boxes when we felt tired.

It was under such harsh conditions that we finished the job in seven months, which might take a year or longer for others.

Somebody once asked us where the motivation came from. I think it comes from the sense of responsibility, the sense of mission, and our passion for innovation. There's no expression to describe our excitement of constructing China's first national supercomputer

After the Tianhe-1 topped the list of the world's fastest supercomputers, being fast was not an target any longer. It's application that became the first priority. As the head of the application and R&D department, my team members and I developed the first large heterogeneous parallel stimulation software of fusion energy, as well as an integrated platform for oil-gas exploration data processing. Now, the Tianhe-1 is computing for over 8,000 research missions every day.

Apart from these professional missions, Tianhe supercomputers are also playing an important role in our daily life and production.

For enterprises, Tianhe supercomputers are a tool to reduce cost and improve efficiency. For instance, car and auto equipment manufacturers had to perform crash tests with real vehicles, which were not produced massively. This led to a high cost of these manufacturers. Thanks to a simulator run on Tianhe-1, tests are now simulated with digital technology, which not only reduced the development cycle of the products, but also saved cost for enterprises.

Weather forecast is an application of Tianhe supercomputers closest to the people. The forecasts we see in TV and mobile application all rely on supercomputers. Tianhe-1 is able to forecast precipitation and extreme weathers in the summer, while predict snows in the winter. After receiving data from satellites and meteorological stations, the supercomputers will project the change of weathers.

Innovation is endless. In the future, we'll keep making efforts, so as to make Tianhe supercomputers render stronger support for the country's independent innovation of information technology, as well as economic and social development.

Xi stresses key role of ties with Russia

Xi made the remarks in a phone conversation with his Russian counterpart, Vladimir Putin, in which they extended New Year's greetings to each other and the people of the two countries.

China would like to develop its comprehensive strategic partnership of coordination for a new era with Russia, pursue development and prosperity for the two sides, and make more contributions to the building of the new type of international relations and a community with a shared future for mankind, Xi said.

Xi said the COVID-19 pandemic has brought unprecedented, serious challenges to the lives and health of mankind, affected the global economy and led to world turbulence and transformation.

Hailing their bilateral ties as gold that can stand the test of fire, Xi said the special quality and great value of China-Russia relations has become more obvious in the face of danger and difficulties.

The two countries have taken the lead in international cooperation in the fight against COVID-19, promoted the alignment of the Belt and Road Initiative with the Eurasian Economic Union, and jointly celebrated the 75th anniversary of victory in the World Anti-Fascist War and the founding of the United Nations, Xi said.

Officials slam US sanctions on Xinjiang products

THE United States' sanctions on the Xinjiang Production and Construction Corps in the name of "forced labor" are groundless and won't affect the healthy development of the corps, officials said.

"More than 70 percent of the XPCC's cotton and 95 percent of its textile products have been sold domestically in the past two years," Sun Huantao, deputy director of the XPCC's Commerce Bureau, told China Daily in an exclusive interview at its headquarters in Urumqi, capital of the Xinjiang Uygur autonomous region.

"We don't have much direct trade volume with the US. The US' latest sanctions on cotton and cotton products produced by the XPCC indeed have affected our businesses, but they have only had a limited impact,"

The XPCC, also known as Bingtuan, is a special provincial-level entity entrusted by the State to cultivate and guard China's border areas in Xinjiang. It has administrative control of several cities as well as farms and industrial facilities

In 2020, China produced 5.91 million metric tons of cotton, of which 87.3 percent came from Xinjiang, according to figures released by the National Bureau of Statistics in December. In 2019, the XPCC produced more than 2 million tons of cotton, making it the key cotton producer in China.

On Dec 2, US Customs and Border Protection issued a withhold release, or detention, order that applies to all cotton and cotton products produced by the XPCC and its subordinate and affiliated entities, along with all products made in whole or in part from XPCC cotton, such as apparel, garments and textiles, because of concerns about "the risks of forced labor", the agency said.

In the days leading up to the withhold release order, Customs and Border Protection sent detailed questionnaires to US importers of apparel to obtain information on supply chains in Xinjiang.

"The sanctions have affected the exports of cotton and cotton products from the XPCC," Sun said. "It means that many foreign businesses will be unable to

Battle over \$2,000 COVID-19 aid checks shifts to US Senate

WASHINGTON

AN unusual battle in Congress over President Donald Trump's demand for \$2,000 coronavirus aid checks for Americans shifts on Tuesday to the Senate, where Republicans opposed to higher spending are under pressure to approve the additional relief.

The Democratic-led House of Representatives on Monday approved the direct payments in a 275-134 vote, and Senate Democrats plan to push Mitch McConnell, the Republican leader in the chamber, to allow a floor vote on the legislation. They have threatened to tie up Senate floor procedures until he does.

The Senate is already expected and he reasserted that demand on Tuesto take up a measure to override Trump's veto of a \$740 billion defense policy bill. The House voted to override the veto on Monday by 322-87 with most Republicans voting with a large majority of Democrats.

If the Senate seconds the House action, the bill becomes law. It would be the first veto override of Trump's presidency, which ends on Jan. 20 when Democratic President-elect Joe Biden will take office.

Senate action on the veto had been expected on Wednesday but could now be delayed by wrangling over the coronavirus aid payments.

A combined \$892 billion bipartisan coronavirus relief package and \$1.4 trillion spending bill that Trump signed into law on Sunday contains \$600 checks for individuals hit hard than 19 million Americans and killed over 333,000.

Russia, US uncover criminal network smuggling cocaine from South America to Russia, Europe

MOSCOW

THE Russian Federal Security Service (FSB) and the US Drug Enforcement Administration (DEA) under the Justice Department have conducted a special operation to uncover a criminal network that was engaged in trafficking cocaine from South America to Russia and Europe.

The FSB told TASS Tuesday that 330 kilograms of cocaine possibly worth 1 billion rubles (\$13.56 million) if sold had been seized.

"The Federal Security Service jointly with the Drug Enforcement Administration under the US Department of Justice conducted a multi-stage international special operation to stop illegal activities of a transnational criminal group specializing in trafficking cocaine from South America to Russia and other European states," the FSB reported.

According to the special service, at least 330 kg were confiscated, criminal cases were launched against the criminal network members, they were placed in custody. "The drug traffickers could have made 1 billion rubles by selling the seized drug," the FSB clarified.

The first stage of the joint operation was conducted in May this year when a drug mule was caught red-handed in St. Petersburg with 1 kilogram of cocaine. "Active members of the organized criminal network, citizens of several states. were determined in close contact with foreign partners, their roles in illegal operations with the drug prohibited in Russia were clarified," the security service stressed. In June 2020, members and one of the drug network organizers were detained when trying to sell a large batch of cocaine, 34 kilograms were seized.

UN chief calls for making 2021 'year of healing' in New Year message

UNITED NATIONS Secretary-General Antonio Guterres on Monday called on the international community to make 2021 "a year of healing" in his video message for the new year.

"Together, let's make peace among ourselves and with nature, tackle the climate crisis, stop the spread of COV-ID-19, and make 2021 a year of healing," the UN chief said.

"Healing from the impact of a deadly virus. Healing broken economies and societies. Healing divisions. And starting to heal the planet," the secretarygeneral added, noting that "that must



be our New Year's Resolution for 2021.

Noting that 2020 has been "a year of trials, tragedies and tears," Guterres said that "COVID-19 upended our lives and plunged the world into suffering and grief.

"So many loved ones have been lost -- and the pandemic rages on, creating new waves of sickness and death," he

The top UN official stressed that "poverty, inequality and hunger are rising. Jobs are disappearing and debts are mounting. Children are struggling. Violence in the home is increasing, and insecurity is everywhere."

On a positive note, the UN chief said that "a New Year lies ahead. And with it,

we see rays of hope.' "People extending a helping hand to neighbors and strangers; frontline workers giving their all; scientists developing vaccines in record time; countries making new commitments to prevent climate catastrophe," the secretary-general elaborated.

"If we work together in unity and solidarity, these rays of hope can reach around the world," he said. "That's the lesson of this most difficult year."

"Both climate change and the COV-ID-19 pandemic are crises that can only be addressed by everyone together -- as part of a transition to an inclusive and sustainable future," Guterres said.

Noting that the central ambition of the United Nations for 2021 is to build a global coalition for carbon neutrality -- net zero emissions -- by 2050, the UN chief underscored that "every government, city, business and individual can play a part in achieving this vision.'

The difficulty about the idea that Kasuku is a lady is that, fine, the lyrics appear to indicate that the one singing is not the provider in that relationship, in the sense that (he) is saying (he) will stick with Kasuku because (she) is satisfied with what (she) gets, and may God bless (her) in that reasonable outlook on life, etc.

It is entirely possible that the man (the presumed provider) is saying that the woman he is engaged or living with (in a relationship that could unravel, except apparently for these reasons of Kasuku's

outlook) is happy with the (presumed lady, Kasuku). She does not trouble him with lustful demands of no relevance.

Yet there is something of a brain teaser in that supposition, namely whether the lyrics, especially the part of wishing that God help (the key person of the song) to succeed, is directed to a dependent in a house, in that case the wife.

Being the provider means that if any blessings are said in a collective sense, wishing well for a family, they are likely to be directed at the provider, as when he is blessed then the one being provided for will also be at ease.

It would follow therefore that Kasuku, the provider, should be blessed.

That would also suggest that the songwriter was thinking in the place of a lady with affinity with the main character of the song, more or less speaking her mind, that he is not pursuing lusts and thus is balanced in his outlook.

It also means he takes up family issues candidly and sincerely as they come, as when one is balanced in the mind, such person will also be balanced in outlook, someone pursuing lusts is rarely a good family provider especially if his means are low as in this case. That view is more consummating.

Owner confronts Israeli team's racist past

JERUSALEM

AT the age of 39, Moshe Hogeg has made millions of dollars trading in cryptocurrency, bought one of Israel's most prominent soccer teams and brought in a wealthy Emirati sheikh as his new co-owner.

Now comes what may be his biggest challenge. As owner of Beitar Jerusalem, the only major Israeli soccer club never to have signed an Arab player, Hogeg says he is determined to remove the stain of racism from the team and sideline its most rabid anti-Arab fans, all while transforming Beitar into a soccer powerhouse with a diverse lineup.

"The racist image that the club had was one of the key elements that brought me to buy this club," Hogeg told The Associated Press in an interview at the team's Jerusalem training facility.

"I saw this problem that reflects bad not only on the club, but also on Israel," he said. "I love football, and I thought it was the opportunity to buy this club and to fix this racist problem. And then I could do something that is bigger than

Beitar, rooted in the same pre-state Zionist movement that inspired the ruling Likud party, is one of the country's most storied sports franchises and counts Prime Minister Benjamin Netanyahu and President Reuven Rivlin among its fans. It is seen as a potent symbol of the Israeli working class at the heart of Netanyahu's nationalist base.

But in recent years, it has drawn negative attention for its refusal to integrate. Israel's Arab minority makes up roughly 20% of the country's population, and Arab players star on rival teams and the national squad.

Club officials have in the past said their hands were tied by a hardcore base of fans who wield significant clout over personnel decisions. A small group of fans, known as "La Familia," have chanted "death to Arabs" and other profanities toward opposing Arab players.

During the team's 2013 season, a move to bring in two Muslim players from Chechnya badly misfired. La Familia led a boycott that famously left the stadium empty during a home match, several fans were charged with torching the team's offices, and the club was nearly relegated to the second division as its season fell apart.

Hogeg, a high-tech entrepreneur and cryptocurrency trader, bought Beitar two years ago and said he set out to change its culture from the "very beginning."

He said he has spoken out against racism and even filed lawsuits accusing fans of damaging the team's reputation. Last year, Beitar signed Ali Mohamed, a player of Muslim descent from the African country of Niger.

But his biggest move by far was this month's blockbuster announcement that he had sold a 50% stake in the club to Sheikh Hamad bin Khalifa Al Nahyan, a member of Abu Dhabi's ruling family. Al Nahyan has pledged to pump \$90 million into the team in the coming decade.

Hogeg said he was inspired to look for an Emirati partner after the U.S.-brokered agreement establishing diplomatic relations between Israel and the United Arab Emirates in September. He spoke to several potential investors before mutual acquaintances put him in touch with Al Nahyan.

Jewish Israelis have warmly embraced the establishment of ties with Gulf Arabs, despite continued discrimination toward Israel's Arab minority in areas like housing, jobs and government budgets. Hogeg believes that sports can provide an example for others to follow.

"I looked for a partner that will have the same vision of showing the world, showing kids, showing everyone that Muslims and Jews can work together and build beautiful things together," he said. "And I think football is the best platform for

The bearded Hogeg, wearing a sharp suit and black dress shoes, stood on a soccer field at the practice facility for the interview. He happily dribbled a soccer ball and kicked it into the goal as he discussed his love for the game he still plays

Hogeg said he and his partner plan a "carrot and stick" approach, using their expertise and deep pockets to reward the fans with a perennial soccer powerhouse, while simultaneously letting it be known that anyone who objects to their message of coexistence is unwelcome.

"Either you are for the club or you are about something else. If you are about hate and racism, you are not part of us," he said.

The team is mired at the bottom of the league this year and has few prospects for success. But Hogeg is predicting a quick turnaround next year and expects to contend for the Israeli championship through aggressive player acquisitions. In the longer term, he and his partner plan to invest heavily in young homegrown talent and aim to compete on the European stage.

With Al Nahyan as co-owner, Hogeg said that adding Arab players to the roster is a "non-issue." He said the team already is trying to recruit an Arab player who competes in Europe, though it is unclear whether his current team will release

"We are actively looking for A-class players that can upgrade the level of our team," he said. "Religion is not a factor by any means."

Avigail Sharabi, a diehard Beitar supporter who currently appears on a reality TV show, accused Hogeg of abandoning the team's traditions for money.

Lionel Messi interview: What he said and what it means for his present at Barca and future plans

LIONEL Messi's interview with Spanish TV channel La Sexta at the weekend has cast new light on his dispute with Barcelona at the belated end of last season and hinted at his intentions next month when he is free to negotiate a summer move with clubs outside Spain. James Ducker looks at what Messi said and reads between the lines of his words:

On the burofax he **sent to the club asking** to court, we would have to leave in the summer What Messi said

"It was me telling the club that I wanted to leave, I felt I'd completed a cycle and it was time to leave the club that had given me so much. I wanted to win titles and battle for the Champions League and felt it was time for change. The president then started to filter this and that to paint a negative picture of me.

Analysis

On Aug 25 Messi sent a burofax - in effect, a recorded letter - to Barcelona, serving notice of his desire to leave. The Argentina forward claimed he had been telling Josep Maria Bartomeu throughout the course of the previous season that he wanted to leave and that the then Barcelona president reneged on a promise to allow him to go.

Barcelona responded to Messi's burofax in the same format, informing the player that they wanted him to stay and insisting he was still bound to a €700 million (£620m) release clause. a separate termination

clause in his contract permitted him to walk away for nothing and effectively rendered the release clause void but Barcelona argued that the deadline for that clause to be applied had expired. Messi's relationship with Bartomeu, which was already broken beyond repair, reached its nadir.

On deciding not to take Barcelona to court to try and leave on a free transfer

What Messi said "I knew that if we went won. Not just one lawyer told me that, many did. But I didn't want to leave

Barça in that way." **Analysis**

Barcelona felt a termination clause permitting Messi to walk away for nothing in the summer had expired because he had failed to inform them of that wish before a June 10 deadline. But his legal representatives argued that the date should be put back because the season has been extended due to the coronavirus crisis. Messi opted not to turn up for pre-season training, which was consistent with his legal position in which he claimed he had effectively departed the club having triggered his unilateral escape clause. Ultimately, Messi opted against taking the matter to court out of his respect to the club that had given him so much.

On paying up Luis Suárez's contract and allowing him to join Atlético Madrid on a free

transfer What Messi said

"What happened with Luis Suárez to Atléti was Messi had argued that crazy! He left for free, paying the remaining

years of his contract and he joined a team that fight for the same objectives as us. Unbelievable.

Analysis Suárez had a year left on his contract with Barcelona but admitted to being reduced to tears during his final weeks after being frozen out and not even permitted to play in practice matches in training. The Uruguay striker scored 198 goals in 283 appe arances over six years with Barcelona, during which time he became very close with Messi, who could not believe the club would choose to cast aside one of the greatest players in their history in such a way - and sell him to a direct rival. Atlético are currently top of La Liga, eight points clear of Barcelona, and Suarez has seven goals in 10 league appearances.

On where he sees his

What Messi said

"I would like to play in the United States and experience life and the league there.... but ultimately come back to Barcelona in some capacity. I'm not thinking too far ahead in the short term

and just want to see how the season finishes.'

Analysis

With his Barcelona contract due to expire at the end of the season. Messi will be free to talk to foreign suitors on Ian 1. He has ruled out the prospect of a move next month but admits he has yet to make a decision on what he will do in the summer. Although he has expressed an interest in playing Major League Soccer in the US, he is unlikely to be considering a move to America at this stage given that he still feels he has several years left at the top of the European game. However, Manchester City - one of several clubs interested in signing Messi next summer - could exploit the Argentine's interest in playing in the US down the line. City's Abu Dhabi owners own the MLS club, New York City, as part of their City Football Group stable and are known to have been working on a longterm plan that would in-

volve offering Messi the

chance to play for New

York after a spell in the

Premier League.

On the best coaches he played under

What Messi said

"His [Pep Guardiola's] way of preparing games was exceptional and his way and the way of working that Luis Enrique worked too was excellent. I was fortunate to work with both men." **Analysis**

Messi won three La Liga titles, two Champions League, two Club World Cups, two Copa del Reys, two Uefa Super Cups and three Spanish Super Cups under Guardiola at Barcelona, during which time he won the Ballon d'Or four times in a row. The pair retain a good relationship and still talk and the prospect of working with each other again appeals, despite Guardiola often stating his belief Messi will see out his career at Barcelona.

On the club's presidential election and financial troubles

What Messi said "Let the best candidate win. Whoever does will find a very difficult situation, it is not going to be easy to turn this around. "It's a difficult moment for the club, for everyone, but those inside the club know that it's in a really bad situation, things are very bad and it's going to be difficult to return the club to where it used to be."

Analysis Barcelona's presidential elections will take place on Jan 24 when a successor to Bartomeu will be chosen. Messi lamented claims from the caretaker president Carlos Tusquets that, in financial terms, Barcelona would have been better off selling Messi in the summer but the

player is well aware of the extent of the club's financial problems. Last month, Barcelona's players agreed to wage cuts that would save the club €122m (£108m). They also agreed with their players to have about £45m of variable payments deferred over a three-year period. Barcelona's accounts for 2019-20, published in October, revealed that the club's net debt had more than doubled to €488m (£432m) as they felt the sharp impact of the Covid-19 crisis. Messi's admission that Barcelona - who have won only half of their 14 league matches this season - are going to struggle to get back on top will encourage his many suitors eager to prise him away from the Nou Camp in the summer.

On the prospect of **Neymar rejoining** What Messi said

"I speak to Luis [Suárez] every day. Last time I spoke to Neymar was after the [Champions League] round of 16 draw. The club are going through a tough period financially so it will be complicated to bring Neymar in."

Analysis

Like Suárez, Messi enjoys a good relationship with Neymar, who has been keen to return to Barcelona from Paris Saint-Germain, bought him for a world record £198m fee in 2017. But with Barcelona facing a battle just to raise the funds to sign the £15m-rated defender Eric García from City, Messi knows there is little prospect of him being reunited with Neymar next summer.

Chelsea are missing something, and they're running out of time to find it

WHILE Chelsea were far better against Aston Villa than in their limp 3-1 defeat at Arsenal, the football world is still waiting for Frank Lampard's side to return to top form.

Monday's 1-1 draw was not the result Chelsea wanted, or needed, to get their season back on track. Instead, things are stuck in a vicious cycle of wondering whether Lampard knows his best XI or, equally pressing, whether or not he knows how to get the best out of them. They answered his prematch rallying cry of improving their intensity, but the balance of matches is not yet falling in their favour, with just one win in their past six games (all competitions) to show for it.

Chelsea spent big in the summer in order to build upon last season's promise and contend for the title; heading into the new year, that £220 million figure is now an albatross around Lampard's neck. This is not to do Aston Villa a disservice -- they're a brilliantly organised team and put their remarkable work rate to good use at Stamford Bridge -- but Chelsea needed to win this match at home after three defeats in four, ultimately falling short.

"When you're in a tough moment, things don't quite go for vou -- you have to fight through it," Lampard said postmatch.

This was Chelsea's sec-

ond match in 48 hours; the festive schedule is bruising and unrelenting, and as it's being played out against the backdrop of COVID-19 logistics and stress, you can forgive players for the odd off-day. But Aston Villa are enduring the same circumstances and while Chelsea made six changes from the Boxing Day defeat at Arsenal, Villa made just one suspension-enforced change.

You could see two different approaches in play on Monday night: Dean Smith, doing a brilliant job at Villa, is content in knowing his best team and sticking with them, backing them to play through the fatigue and deliver. Lampard's squad is a bigger beast with a lot more options, but is lacking consistency. "Mentality" was the buzzword post-match, but that won't win you titles alone. And so it was the old tried and tested that got Chelsea the point.

Take the always reliable Olivier Giroud, who delivered again for Chelsea in a moment of need. His clever header gave Chelsea the first-half



expensive Chelsea side. Time's running out given the hectic fixture list and pressure to get results. (Agencies)

lead, with Ben Chilwell superb and both wingers Christian Pulisic and Callum Hudson-Odoi lively. Pulisic had two good first-half chances while Timo Werner, dropped to the bench, fired over the bar late on, and Chilwell flashed a last-gasp, beautiful volley just wide

of Emiliano Martinez's far post, but the Frenchman is their dominant presence through the middle of the field.

Chelsea lack dynamism from midfield, and herein lies the Lampard conundrum: they have envious depth and have spent big to give

themselves the talent for competing in multiple competitions, but it still looks like they need a presence like West Ham's Declan Rice in midfield to really anchor things and give assuredness in the middle of the park. Rice is on their radar, but John McGinn, Aston Villa's outstanding midfielder, offered them a close look at what they're lacking.

Lampard and Chelsea had every intention of turning this campaign into a title challenge. But when form slumps -- they seem far removed from their November best, when they rattled off six straight wins in the Premier League and Champions League -the pressure and noise increases around the squad, and the players left out seem even more glaring in their absence.

Both Kai Havertz and Timo Werner were on the bench after underwhelming vs. Arsenal, and neither made the necessary impact with 20 minutes left. Individual quality isn't enough for Chelsea at the moment as they struggle to create clear-cut chances. Tammy Abraham and Giroud are playing well and their overlapping fullbacks get plenty of crosses into the box, but they are either snaffled up at the near post and cleared or forced back to the midfield, so Chelsea have to build again. How they must hope Hakim Ziyech is back sooner rather than later; until then, we're still waiting for this Chelsea side to be defined.
