'Media freedom an opening for unity, stronger economy'

THE shift to broader media freedom in Tanzania is an opportunity to build a unified country with a strong economy, Netherlands Ambassador Wiebe de Boer (pictured) has


Exchanging views with members of Tanzania Editors Forum (TEF) at his office in Dar es Salaam on Wednesday, he praised the move, saying that media organs should not be afraid to work with opposition parties.

Even the president has shown that there is no problem in doing that, the envoy noted, expressing huge satisfaction with President Samia Suluhu Hassan for repositioning the country's media organs on the political landscape.

The change of air and extended freedom was a salutary example, he said, urging media organs to shirk from being afraid to exercise their responsibilities freely.

"She has shown the way on how the media ought to be independent," he said, affirming that journalists should use the opportunity to boost overall freedom of expression.

He similarly remarked that the president has worked to unite the people especially in cooperating with opposition parties on various issues, affirming that this is something for which President Samia must be applauded.


of opposition parties shows her great commitment to unite the country," he stated, equally commending TEF as a key media stakeholder for having shown solidarity in the fight for press freedom.

He asserted that media organs expect to have a law that strengthens the media industry, not placing hurdles that can disable the entire industry.

THE government is seeking assistance from Britain for financing the construction of the fifth-phase of standard gauge railway (SGR) from Isaka to Mwanza.

A statement by the Treasury said that Finance and Planning minister Dr Mwigulu Nchemba aired the proposal in talks with Tim Reid, the managing director for UK Exports Finance (UKEF) as part of activities of a high level delegation of the Union and Zanzibar Exchequer authorities.

He hailed UKEF for supporting the upgrade of Pemba Airport to international status, along with construction of road infrastructure in the Isles, similarly asking the agency to look for possibility to support the vital railway link in the region.

Assisting in upgrading Pemba Airport will not only facilitate businesses in the Isles, but also improve people's lives through tourism and related activities as upon completion, the facility will open up Zanzibar to enable large aircrafts to land on Pemba Island.

"Improvement of the Pemba airport will not only stimulate economic growth in the Isles but also improve economic growth through employment, markets, tourism and many others," the minister underlined

Dr Juma Malik Akil, the Finance and Planning permanent secretary in the Zanzibar President's Office, said in his remarks that the people of Zanzibar have been waiting for the project to be implemented, along with building Unguja and Pemba roads.

This will improve lives in the islands through tourism and other economic activities, he said.

The UKEF director assured the delegation that the fund for the projects will be timely disbursed as the institution is committed to injecting resources into Tanzania's strategic projects tabled by the government, including in the water and energy sectors.

UKEF has invited investors in the UK to brief them on investment opportunities available in Tanzania especially in the agriculture sector. UK Export Finance covers the UK Export Credits Guarantee Department, officials said.

MP initiates fundraiser to assist fishing communities

MUSOMA Rural MP Prof Sospeter Muhongo has launched a fundraising campaign to assist fishermen and women in his constituency whose boats were vastly damaged by a hurricane at the start of the week.

The legislator told the media at midweek that the campaign is aimed at enabling the fishermen to survive while waiting for repairs on their vessels.

Heavy rain with strong winds early this week destroyed 211 boats and 62 nets used in the fishing of sardines in various areas of the Lake Victoria coastline in Musoma Rural District, Mara Region.

The rain adversely affected fishing activity at the Busekera Village fish port in the wake

Tanzanian statesmen cited in UN Water changemakers 2023 awards

General Assembly.

The awards are presented for demonstrating high level political commitment and leadership for climate resilient water security in Africa, the UN Water agency stated.

Other sources had indicated earlier that this event marks the first United Nations conference on water since 1977, slated for March 22 to 24, which diplomats said was a watershed moment for the sustainable development community as a whole. "The UN 2023 Water Conference is about uniting the world in accelerating action towards achieving SDG 6: water and sanitation for all by 2030. The award has for the first time been presented to the six current and former Heads of State in recognition of their efforts to bring positive changes in the water sector in their respective countries," the conference secretariat declared.

African leaders who received the awards are the four co-chairs of the international high-level panel on water investments for Africa, namely Senegalese President Macky Sall, who is also the current chairman of the African Union, Namibian President Hage Geingob, Netherlands Prime Minister Mark Rutte, and ex-president Jakaya Kikwete.

Zambian President Hakainde Hichilema and President Mwinyi received the award for local country leadership following the launch of the Zambia Water Investment Program and the Zanzibar Water Investment Program respectively.

During the conference, former president Kikwete represented the other three co-chairs of the panel, mobilizing for water investments in the continent .The panel seeks to develop actionable pathways for mobilizing \$30bn annually by 2030, for implementing the

continental Africa water investment programme (AIP) and closing the current water investment gap in Africa, put at \$11bn to \$19bn.

Statistics show that over 300m Africans do not have access to clean drinking water and over 700m live without access to safe sanitation.

Approximately \$50bn annually or \$40 per African each year is required to achieve water security and sustainable sanitation in Africa by 2030, the secretariat underlined.

The panel proposed that Heads of State and government, global business leaders establish cross-sectoral leadership at the highest level, with commitment to substantially increase public finances and investments for water security and sustainable sanitation, it said.

Governments need to track progress and enhance mutual accountability for results in the mobilization of water investments and in peer review mechanisms, the guidelines indicate.

This applies at all governance levels and leaders commit to allocating at least five percent of national budgets for water and sanitation, along with 0.5 percent of GDP per annum for sanitation and hygiene programmes.

The panel urged the mobilization of new sources of funding and innovative finance by supporting matchmaking. This needs to focus on climate resilient, blended publicprivate finance alongside gender transformative approaches, it emphasised.

It also seeks to strengthen institutional regulation for water investments; create incentives and penalties for increased water efficiency across multiple industries to lead water stewardship efforts, biodiversity and ecosystem protection, the water secretariat specifies.

Marburg virus kills 20 in **Equatorial Guinea - WHO**

The World Health Organisation (WHO) said yesterday that the death toll from the Marburg virus epidemic in Equatorial Guinea has risen to 20, with Malabo reporting six more deaths in 10 days.

The cases of this haemorrhagic fever, which is almost as deadly as Ebola, have spread from the province of Kie-Ntem, where it caused the first known deaths on 7 January, to Bata, the economic capital of this small central African country, which is partly an island and partly a continent.

This expansion "suggests wider transmission of the virus" and requires "intensified response efforts to avoid a large-scale epidemic and loss of life," WHO warned in a statement.

"Between 11 and 20 March, eight cases were confirmed, six of which died," the Equatoguinean government said on its website, without establishing a total toll since the beginning of the epidemic. The last official death toll was 11 on 28 February. "To date, there are 20 probable cases and 20 deaths," the WHO said, adding that the new cases are reported response to the epidemic.

TOSCI's official seed certification standards in final approval stages

TANZANIA Official Seed Certification Institute (TOSCI) in cooperation with seed industry stakeholders have developed seed certification standards for seed/ seedlings/cuttings of tree, fruit and sugarcane crops that are currently on final approval by other authorities.

TOSCI's Director General, Dr Patrick Ngwediagi told this publication in an interview that once the standards in question are approved then the state-owned institute will immediately venture into the certification process of coffee, tea, sugarcane pawpaw, cashew and grape vine crops as the institute have registered varieties of these crops. Seed certification for avocado, mango, orange, cocoa, palm, apples and banana will start when characterization of the varieties of these crops is complete.

"We're working round the clock to ensure that all tree and fruit plant varieties for potential food as well as economic cash crops in the country are being professionally certified and registered," he said.

"While we're continuing with certification and registration of the tree, fruit and sugarcane crops, we have decided to embark on a vital exercise to train and register seed/ seedlings/cuttings multipliers and sellers of tree, fruit and sugarcane crops from across the country," Dr Ngwediagi expressed.

He added that, TOSCI was working to assure all seed varieties being certified and registered in the country are of high quality, basically in terms of yields and resistance to diseases, adding: "Seed quality attributes are expressed in terms of germination, purity, vigor and seed health. During seed certification process crop varieties are tested based on those aspects,"

However, the TOSCI Director General detailed that during variety registration, the institute normally use (VCU) where a variety is tested for its adaptability, yield, diseases and drought tolerances or any other point of merit stated by the breeder/ applicant.

In a further effort to help improve performance and standards of the seed sector across the country, Dr Ngwediagi communicated that the institute had implemented a special programme to capacitate the seed dealers across the country to deliver services in accordance with the Seed Act, 2003 and its regulations.

He noted that there were some dealers who marketed seeds that their germination validity had expired (of above 7 months), while others had embraced a negative tendency of opening seeds packages in order to re-measure and sell it in different quantities.

"After investigating and realizing over the said irregularities in seeds marketing, we had patriotically decided to take a sober initiative to educate the seed dealers so as assisting them to perform their business according to the Seeds Act and Regulations," he stated.

Moreover, he briefed that some of the seed traders have marketed seeds without official TOSCI labels or labels for the Organization for Economic Co-operation and Development (OECD).

"As per the ruling regulations, all home-based produced seeds to be marketed must possess an official label from TOSCI, whereby those from outside the country must have OECD Seed Schemes labels," he detailed.

TOSCI was established under the Seed Act No. 18 of 2003 as a successor to the Tanzania Official Seed Certification Agency (TOSCA), which is a government entity under the Ministry of Agriculture (MOA). TOSCI's headquarter is in Morogoro with four branches in Lake zone (Mwanza), Northern zone (Arusha), Southern Highland zone (Njombe) and Southern zone (Mtwara). TOSCI headquarters also caters for the central and eastern zone.

Govt to pay 11.3bn/- compensation to residents of areas bordering KIA

PRESIDENT Samia Suluhu Hassan has officially resolved the longstanding land dispute involving residents of five villages bordering Kilimanjaro International Airport (KIA) after agreeing to pay them a total of 11.3bn/- compensation to move out of the area.

Out of the money, 7.3bn/- will be paid to the residents of Hai District, Kilimanjaro Region and 4.04bn/- to the residents of Arumeru District, Arusha Region.

On Wednesday, Kilimanjaro Regional Commissioner, Nurdin Babu said the residents have thanked President Samia for her love in addressing and finalizing the issue within a short time of her presidency.

The dispute area is more than 11.4 hectares, and the villages whose residents were in dispute with Kilimanjaro Airport Development Company (KADCO) will be paid compensation including Chemka,

Rundugai, Sanya Station, Tindigani and Mtakuja.

RC Babu said the area was strategically set aside by the government with a 99-vear title deed.

He said from the evaluation conducted, it was found out that there were residents who invaded the airport area in violation of procedures, but in regard to the Kilimanjaro and Arusha regions' residents, they will all be paid compensation.

WHO-mentored emergency responders graduate in Dar

THE first ever team of 132
Multisectoral emergency
responders trained by the
World Health Organisation
(WHO) has graduated in Dar
es Salaam yesterday ready
for deployment anywhere in
Africa.

The volunteers are from the ministries in charge of Agriculture, Livestock And Fishery, Home Affairs, Defense, Community Development, Women and Special Groups, and health as well as Prime Minister' Office and health practitioners from various councils.

Speaking at the closing of Tanzania Training of African Volunteer's Health Corps on Strengthening And Utilizing Response Groups for Emergence (SURGE) in Dar es Salaam, the Minister for Health Ummy Mwalimu said the experts are ready to be deployable anywhere in the continent.

In her speech read by Prof Mohamed Janabi, the Muhimbili National Hospital (MNH) Executive Director, Mwalimu said the training has come at the right time as some countries in the continent seek for humanitarian assistance due to floods and catastrophes.

She said already five graduates have been dispatched to the Kagera region to support the emergence and response team to contain the Marburg virus disease (MVD) outbreak reported a few days ago.

Mwalimu said the five weeks training has equipped the participants with knowledge on how to handle emergencies and responses issues during eruptions plus humanitarian crises and sexual exploitations.

The ministry boss said Tanzanians corps will now be registered in the WHO database and can be requested to support other countries when emergencies break out.

"Our experts are ready to be deployable within and outside the continent to serve in places with hazards, diseases epidemic, displacement and nutrition issues," she said.

"I call on all of you to grab the opportunities to be part of the corps in other countries on the continent," she added.

WHO Representative, Dr Zabulon Yoti said that the training was timely for countries like Tanzania to build the capacity of its emergency response team.

He said build capacity training was very important to have experts who can be deployable everywhere in the African continent.

Dr Yoti said currently, in the African region about 150 public health events/ emergencies are reported every week with about 15-20 percent being humanitarian crises.

These humanitarian crises include civil war and climate-related events such as prolonged drought, destructive floods cyclones. These are often complex emergencies which require Multisectoral approach including support for provision of essential health services management of victims of gender based violence.

According to him, WHO will support nations to prevent catastrophe adding that it is about serving lives.

"WHO will continue working

with the government and other partners and stakeholders to build a strong, multidisciplinary workforce for health emergencies in the country. This includes support to teams that may be deployed to respond to emergencies within and outside the country.

"WHO is also committed to continue mobilizing resources to support the country to implement the rest of the Emergency Preparedness and Response (EPR) flagship initiatives as captured in the Roadmap that was developed in December 2022," he said.

Having completed training, the 132 participants will now have joined a roster of more than 300 adding that Tanzania was the 9th country to conduct the training and an electronic database has been created and most of the participants already have credentials to the database.

The database will be used to record and manage training and deployments whenever they occur.

USAID Heshimu Bahari Activity Request For Application Heshimu Bahari RFA 1/2023

USAID Heshimu Bahari is a five-year (2022-2027) project financed by USAID and implemented by Chemonics International and partners. The goal of the project is to strengthen the enabling environment and science-driven framework for sustainable marine protected areas (MPAs) and fisheries co-management in Tanzania Mainland and Zanzibar, by Government, communities, and the private sector, through four integrated objectives:

- 1. Collaborative network of resilient MPAs and no-take replenishment zones (NTRZs) expanded.
- 2. Community co-management of MPAs/marine capture fisheries strenathened.
- 3. Private sector investment in MPAs and marine capture fisheries co-management expanded.
- 4. Integration of relevant science-to-MPA management improved.

This announcement is a call for Request for Application (RFA) seeking to award a grant to an NGO, Civil Society Organization (CSOs) or Private firm to undertake a benthic ecological survey in nearshore waters along the northern coast of Tanzania Mainland. The objective of the activity is to generate systematic baseline data to incorporate into multi-parameter analysis for marine spatial planning to identify priority marine areas for protection and management.

Geography coverage and target.

The target area broadly covers the nine collaborative fisheries management areas (CFMAs) in nearshore waters of northern Tanzania Mainland, indicated by green-shaded areas. The area encompasses marine waters adjacent to Mkinga District, part of Tanga Municipality, Pangani District and Bagamoyo District, but excluding Tanga Coelacanth Marine Park (TACMP). The benthic ecological survey (BES) itself will be implemented between the high spring tide mark and the 50m sub-tidal depth contour within the above-mentioned

Eligible Recipients:

- Applicants must be a registered company or non-governmental organization (NGO) formally constituted, recognized by and in good standing with appropriate authorities in the country in which the entity is registered, and compliant with all applicable civil and fiscal
- · Applicants may only submit one application per prime organization under this RFA.
- Applicants must be able to demonstrate successful past performance in implementation of marine benthic and/or other marine ecological research in nearshore waters in Tanzania Mainland or Zanzibar.
- Applicants should assemble an implementation team with the following minimum requirements:
- (i) A Team Leader with: (a) a Master's degree or PhD in marine science or related discipline; (b) significant demonstrable experience leading similar marine ecological research studies in Tanzania or similar nearshore marine environments in the Western Indian Ocean (WIO); (c) at least 10 years practical

in-water field experience in marine benthic surveys and/or other nearshore marine ecological research; (d) significant demonstrable experience in marine survey data handling and analysis, and (e) significant demonstrable experience writing high-quality technical reports for international donors or organisations or other international audience:

- (ii) Field Unit Leaders (one for each field/boat team) with (a) a bachelor's degree or higher in marine science or related discipline (b) significant demonstrable practical in-water field experience in marine benthic surveys and/or other nearshore marine ecological research; and (c) significant demonstrable experience in handheld GPS navigation and/or smartphone navigation applications.

THE first major UN conference on water in 45 years got under way on Wednesday in New York with an urgent call to manage the precious resource.

In his speech, UN's secretary-general, António Guterres, stressed the importance of water as key to development.


Water is a human right – and a common development denominator to shape a better future. But water is in deep trouble.

"We've broken the water cycle, destroyed ecosystems and contaminated groundwater. Nearly three out of four natural disasters are linked to water. One in four people lives without safely managed water services or clean drinking water. And over 1.7 billion people lack basic sanitation," denounced António Guterres.

Ahead of the conference, the US ambassador at the UN announced that the United States had pledged \$49 billion towards water security at home and around the world.

"A 2022 study by the University of California, Los Angeles, estimated that almost half of the world's population will suffer severe water stress by 2030. This is a crisis, one that affects people around the globe and one that demands concrete action. That's why I am proud to announce that the United States is committing \$49 billion toward equitable, climate resilient water and sanitation investments at home and around the globe. That significant number should demonstrate just how seriously we take water security", announced Linda Thomas-Greenfield, U.S. ambassador to the United Nations.

On Tuesday the UN released the World Water Development Report 2023. Among its findings it says 26 percent of the world's population doesn't have access to safe drinking water and 46 percent lacks access to basic sanitation.

mark international water day. PBWB carried out various activities including tree planting, creating awareness on environmental protection to students at different schools and members of the community," said Mdee.

Eng Mdee said the board also supports different water user's communities to establish tree nurseries within their areas and tree planting at catchment areas to enhance protection of the sources.

He said the board faces several challenges which include villagers' encroachment at water sources. He said some villagers conduct farming activities at water catchment areas, overgrazing, tree cutting and discharging of wastes in the rivers.

PBWB Environmental Officer, Evansia Marshay said the organisation has a total of 1,392 active water sources, calling upon villagers to protect and conserve the environment surrounding the sources for sustainable water availability.

She said the Pangani River Basin Management Project (PRBMP) is generating technical information and participatory forums to strengthen integrated water resources management in the Pangani basin.

"PRBMP has four major components: environmental flow assessment, community participation in water resources management, climate change and groundwater assessment (to support the integrated water resource management development plan)," he said.

Moshi Rural District Acting District Executive Director, Peter Tungu, Ward Councillor, Ally Badi and Sango Village Chairman, Menyiasumba Tenga commended the role played by the PBWB in creating awareness to the public on the importance of environmental protection particularly at water catchment areas.

NE could safely say that ought to have the same balance political parties are back in the saddle in the country and they have promised to keep their activities tied to policy discussion for clarity among voters rather than interminable disputes on the legitimacy of the state.

With that, there is a topic they need to broach more earnestly and fully. Not that it is the only one, as politicians are more likely to sniff some scandal and let everything drop by the wayside to prove what may just be a false allegation.

While that is part of accountability, actual policy debate is what nurtures democracy, while experience shows that pursuing instability leads to fatigue with democracy as such.

Thus the main political parties could tell the public what they feel about national budgeting formats, whether we should pursue classical budgeting where there is a keen preoccupation with development expenditure, or just make that an auxiliary.

The problem is that, generally, what is fronted to the public is development expenditure or achievements thereof, while in private what is energetically pursued is recurrent expenditure.

Development expenditure is usually a matter of leadership particularly at high levels, while group demands peak recurrent expenditure.

The Treasury has recently unveiled expenditure layouts for the next financial year, the main part being a change in the ratio of the two aspects, recurrent expenditure now rising to 70 per cent.

It is a sort of New Deal for those in the civil service as relates to higher levels of employment, and gradually more relaxed internal expenditure outlooks. There is a renewed effort at recruitment as sectors like health and education, not to speak of the police or other, have acute shortages.



Geologists learn from Chernobyl, the worst nuke disaster in history

HIRTY-SEVEN years ago, on April 26 1986, the reactor of the Chernobyl nuclear power plant in the then Soviet Union suffered a catastrophic meltdown.

In the weeks that followed, the deadly event drove hundreds of thousands of people to relocate from the surrounding area, which is still a deserted "exclusion zone" today.

The Chernobyl nuclear accident was caused by an unfortunate cocktail of human error and flawed reactor design. It was the worst nuclear disaster in history, releasing more than 400 times as much radioactive material as the early August 1945 atomic bomb in in Hiroshima, Japan.

An uncontrollable chain reaction inside the reactor caused a sharp increase in temperature that ultimately resulted in the fusion of the fuel rods, a steam explosion and a fire. The melted fuel rods pooled temporarily at the bottom of the reactor chamber before making their way into the deeper levels of the power plant.

This hellish molten soup has proved an unexpected source of insight for geologists like me. In new research published in American Mineralogist. my colleagues and I show that tiny zircons formed at Chernobyl change our understanding of how these crystals behave - and what they tell us about Earth's past.

Molten reactor material is called corium, and it's a serious contender for the most dangerous substance on

Nearby radiation exposure to corium can kill within minutes - but that is not all. Corium is extremely hot and generates its own heat from radioactivity. It's very difficult to cool it down.

The corium at Chernobyl reached 2,600, almost twice as hot as the surface temperature of the space shuttle during atmosphere re-entry or half the temperature at the surface of the sun. For comparison, the temperature of natural lava from volcanoes ranges from 500 to 1,000.

Corium is so hot that it eats everything in its way. It can dissolve steel, sand and concrete, and it transforms water into radioactive steam almost instantly. The corium created at Chernobyl eventually solidified into a lump known as the 'elephant's foot'.

At Chernobyl, it was estimated 1,500 tons of corium was generated, flowing like lava and eating its way through meters of concrete in the basement of the power plant.

A second, even more devastating explosion was only just avoided by pumping the water used to extinguish the fire from the basement levels. Ultimately, the corium incorporated enough foreign building materials that it could not generate enough heat to keep its liquid state, and solidified into a lump that looks like the foot of an elephant.

Uranium fuel rods are made of enriched uranium oxide, clad in zirconium alloy. Corium dissolved sand and concrete, which have a high influence of water.

Zirconium, silicon and oxygen: all these ingredients were present in the Chernobyl melt to crystallise zircons (ZrSiO) about the width of a human

Geologists and Earth scientists love zircon because studying it can reveal the age when rocks formed and what geological process formed them. It is also very resilient to harsh geological conditions and is stable for billions of

Zircons sampled from the solidified corium at Chernobyl are special because we know a lot about the conditions in which they formed and their history.

In many ways they can be considered analogous to controlled experiments, but from an extremely dangerous setting that cannot be reproduced safely in a laboratory environment. On the contrary, zircons from natural rocks have long, convoluted histories that are hard to untangle.

Surprisingly, the zircons from Chernobyl displayed features called "re-equilibration textures", which are also found in many natural zircons. Until now, these features have been attributed to the action of water dissolving the mineral.

A zircon crystal from the Chernobyl melt shows surprising 're-equilibration textures' that geologists had previously assumed were created by contact with water. However, the Chernobyl melt contained little or no water. This tells us that the features were created by the melt directly, that is, without the

The zircons from Chernobyl taught geologists that zircons are not as resilient as previously thought -and this should be considered when studying complex rocks.

Studying the aftermath of nuclear incidents is a kind of detective work called nuclear forensics. It's not just useful for geologists.

Nuclear power plant reactor meltdowns have happened only three times in history: at Chernobyl, at Three Mile Island in the US in 1979, and at Japan's Fukushima Daiichi in 2011.

Modern nuclear power reactors have incorporated more safety features to avoid another Chernobyl disaster.

Using extremely complex instrumentation, it is possible to measure the exact composition of uranium and other radioactive elements found at the site of an incident.

By measuring the proportion of the isotopes of uranium and plutonium, information about the type of fuel used in the reactor can be determined.

This is not only useful for understanding accidents improving safety. Answering questions about the kind of fuel in use can help us draw many other conclusions as well, including the causes of the accident and how to mitigate them.

Nuclear forensics is also helpful in controlling nuclear facilities overseen by the International Atomic Energy Agency (IAEA), promoting the safe, secure and peaceful use of nuclear technologies.

Collaboration, investments pivotal in driving sustainable energy in Africa - Sahara Group

investments. collaboration to meet soaring energy needs across the continent, Sahara Group executive director Wale Ajibade has said.

Addressing top energy operators, regulators, and government functionaries at the 2023 African Refiners and Distributors Association (ARDA) Week in Cape Town, Ajibade said the current level of global investments on renewable energy was inadequate to enable Africa embrace more alternative energy sources.

Ajibade, who made a presentation on "Meeting Africa's Growing Energy Requirements in the Evolving Global Landscape", said adequate policies are vital for African countries to address foreign investors' concerns and limit investment risks exposures.

"Over the past two decades, global investment in renewable energy has grown rapidly. Yet less than three per cent of these investments come to Africa. Africa continues to receive only a small portion of the total global investment in renewable energy," he said.

He said the continent needs to work together to transform inherent risks and inefficiencies in the system into opportunities for ramping up energy supply from multiple sources.

"Our individual differences as countries within this continent only serve to strengthen the brilliant and colourful fabric of our cultures," Aiibade noted.

He elaborated: "With boots on the ground, in over 24 African countries, we as Sahara Group know more than most that what works in one location may not necessarily be what works in the other. We have always had to overcome our challenges and propel ourselves forward by ourselves and for ourselves as Africans."

He said that despite the shortage of investments, the continent could still strive towards meeting its energy needs through collaboration and the prioritising of "the African narrative for Africans by Africans". "Africa will meet its growing energy requirement in the evolving global landscape, but we will do it the African way," said the Sahara Group executive director.

He added: "This will be done by drawing on collaborations and best business practices, embracing our diversities in cultures but always steadfast in moving forward and bringing energy to life responsibly."

"As we gradually transition to renewable energy, the conditions for solar power literally shine as bright as the sun on this continent. The potential for wind energy blows through our continent ceaselessly. Africa has amongst the largest untapped potential for hydropower development in the world and, as we all know, we have just begun to scratch the surface of natural gas," added Ajibade.

He further noted that some countries on the continent are already promoting several policies and regulations to ramp up capacity for renewables in Africa.

"Case in point - solar power: Nigeria's photovoltaic power potential makes solar energy very feasible for both investors and consumers. Sahara Group is currently harnessing this potential through the implementation of large-scale and mini-grid solar projects," Ajibade stated.

On the growing importance of gas as a transition fuel, he said Africa was already witnessing remarkable progress in this regard.

"There was a time when it was unfathomable that an African company would order and build the first ever African-owned LPG vessels as well as lift gas in Africa and supply to counterparts in Africa. I'm proud to say that Sahara's

vessels MT Africa Gas, MT Sahara Gas and MT SAPET, to name but a few, have lifted African gas and supplied it within the continent of Africa," he said.

According to Ajibade, meeting Africa's growing energy needs will also require a "just transition" fuelled by developing and maximising the potential of African crude oil production in a "more sustainable manner".

"Oil will continue to be an important source of energy but needs to be cleaner to meet global standards," he said, adding: "We must ensure the sustainable development of our hydrocarbon resources while reducing methane emissions and flaring to achieve energy security and sustainability at the same time."

He said the increase in the use of CCUS (Carbon Capture, Usage and Storage) technology presents an opportunity for the industry to be fully exploited for reliability, environmental sustainability and Africa's GDP expansion.

CCUS is a technology that can capture and make effective use of the high concentrations of the carbon dioxide emitted by industrial activities. Consequently, it has a decisive role to play in decarbonisation and in addressing the challenges of global climate change generally.

Need to screen all aspects in cooking energy plan rollout

HE government is moving with some drive on energy use transition, essentially from firewood to gas, with Energy minister January Makamba announcing a national launch of the country's vision for abandoning firewood and charcoal.

Public awareness - call it public education, if you will - is relevant in the matter. However, it is clear that the pricing of alternatives and low-income families' sequencing of demands or

ability for unit purchases matter. Those involved in the gas business often see it is as little more than a matter of marketing, and that is not very correct.

For instance, plans for a drive to adopt clean energy for cooking have recently led to the holding of a convention of the ruling CCM women's wing, its executive committee along with regional and district chairpersons and secretaries.

The reason for this outstretched gathering was to make sure that the respective women's wing leaders at the regional and district levels take the message across society, to communities and even families of contrasting habits or backgrounds. It is not just a marketing strategy for cylinders; it also indicates that it needs families to make decisions.

The gas transition lag is put at 2030 and at times 2033, whereas cutting out charcoal can be done more rapidly if there is political will.

If East African Community partner states seriously compare policy notes we stand to see free access to gas cylinders, especially the smaller type, recovering the cost on pricing to ease

Extending subsidies for gas use as a whole would remove limitations for use in some families, but only coal mixture rollout enables banning the trade in charcoal more or less entirely.

more rewardingly.

Some institutions need certain levels of energy in cooking, say, in military camps, boarding schools and colleges as well as even for individual families. All these could use modified coal dust mixed with plant or wood waste. The clean energy predisposition hinders coal mixture rollout, while tree felling is the crucial issue.

Another aspect is that some interests see modified coal as interfering with absorbing the whole population into gas, however long it would take for the "operation" to be completed.

There is a risk of slow rollout of energy transition and continued use of charcoal for lack of coordination and oversight on crucial components.

Using our massive coal reserves needs to be part of the transition package to curb tree felling; families will gradually skip unclean coal mixtures for gas when incomes rise.

Using gas is too familiar to be a matter of raising awareness as refilling a gas cylinder, even if it is already available in a household, needs up to 25,000/-.

Many poor families especially in the rural areas can hardly find that kind of money each week. Instead, they buy expensive charcoal in bits so they accommodate the cost, even if it is more expensive in total sums.

When they transit to coal mixture, we save trees and they spend less, whereas gas shift will take a decade at the earliest. A two-step transition for the majority, first to coal mixtures and replacing tree cutting with more plastic furniture by more recycling would help.

The transition can't just focus on awareness relating to gas use as a longlasting solution, while coal reserves are idle or are merely exported in some quantities, and tree felling continues unabated. But the struggle must

different legal jurisdictions regarding legal status of memoranda of understanding entered between parties. It is one of the important legal documents which normally signed by parties as initial document before entering into subsequent agreements.

Enforceability of this legal document differs from country to country. Now, this article intends to examine its legal status in Tanzania so that anyone who uses that document can be aware of its legal status, implication and possible consequences.

What is a Memorandum of Understanding?

Memorandum of Understanding commonly referred as MoU is a formal document that describes issues mutually acceptable between the parties with an intention to enter into certain transactions in the future. It is the legal document which express understanding reached between the parties on certain terms and conditions with the view of moving forward on agreeable transaction. It is also known as document of intent.

Relevance of a Memorandum of Understanding

Practically, there are many reasons as to why most businesspeople prefer to use MoU in their formal transactions before signing final agreements. However, for the purposes of this article, the most important is because it provides preliminary understanding details or terms and conditions agreeable between the parties with the aim of entering into the agreement in the future upon fulfillment of the terms and conditions agreeable. Also, it allows each party to clearly state their objectives and what they expect from one an-

General legal view of

MoU in its nature falls under the category of 'an agreement'. However, one of the paramount ingredients which make the agreement to be legally enforceable is availability of the doctrine of 'intention of the parties to create legal relation'. There is no direct provision in the Law of Contract, Cap 345 R.E 2019, which deals with above paramount

It is our firm opinion that legislature left it open purposely so that the court can judiciously exercise its power to establish circumstances through facts presented to it and see whether parties really intended to enter into legal relations or not.

The aforementioned doctrine of intention to



create legal relationship has its foundation from case law. One of the landmark case law in this aspect is the case of Carlill vs Carbolic Smoke Ball Company (1893) 1 QB

The court held that compliance with the terms available in the advertisement issued to the public was sufficient indication that parties intended to enter into legally binding terms of contract. There also the case of Balfour vs Balfour (1919) 2 KB 571 which was arrangement between wife and husband on family matters. The court held that despite availability of consideration but the arrangement lacked intention to create legal relation therefore it could not be enforce-

Through case law, it is very clear that availability of circumstances in any understanding between the parties to create legal relation, then it is sufficient to be enforceable or depict that parties mutually intended to enter into legal relationship, so memorandum of understanding inclusive.

Legal status of MoU in other jurisdictions

Despite other common

law countries recognizing the above doctrine as one of the ingredients of commercial transactions, it is expressly clear that MoU is not legally binding. In South Africa, in the case of The Free State Provincial Government and others vs Firechem Free State (Pty) Ltd (2000) ZASCA 28, it was observed by court as follows:

That an agreement that parties would negotiate to conclude another agreement is not enforceable because the absolute discretion vested in the parties to agree or disagree.

The above position was also further followed in the case of Southern Port Developments (Pty) Ltd vs Transnet Limited (2004)OL 13030 (SCA).

In Indian Laws, MoU is only enforceable if it fulfills all the three essentials available in Section 10 of the In-

the case of Jai Beverages Pvt Ltd vs State of Jammu and Kashmir and Ors AIR 2006(4) SCJ 401, it was ruled by Supreme Court of India that MoU can be regarded as a legally enforceable contract if it is in a formal way and the parties profit from functioning in compliance with the provision specified in the MoU.

Further, the Supreme Court of India, in the case of State of Orissa and others vs Titagar Paper Mills Company Ltd. and another 1985 AIR 1293, 1985 SCR (3) 26 laid down that:

"It is true that the nomenclature and description given to a contract are not determinative of the real nature of the document or of the transaction thereunder. These, however, have to be determined from all the terms and MoU clause of the document and all the rights and results flowing there from and not by picking and choosing certain clauses."

Legal status of MoU in Tanzania

We are not far from Indian position. MoU is legally enforceable in Tanzania provided there is "consensus ad idem" in that transaction whereby one party makes an offer or proposal and the other party accepts it. The above legal position is well expanded

dian Contact Act, 1872. In in section 10 of the law of contact Act, Cap 345 R.E 2019.To emphasize here. there must be meeting of the minds in doing lawful transaction. That is intention of the parties to create legal relation. In one of the landmark

> cases, Civil Appeal No. 104 of 2011 between M/S Mwananchi Engineering and Construction Corporation Ltd vs Silvano Copetti. In this case, the issue of whether MoU can be enforceable or not was discussed extensively. It was ruled that the court is required to look into contents of the document itself on what terms and conditions the parties agreed and its compliance thereto rather than concentrating on mere definition of what amounts to MoU. The Court held as follows:

> "On a close reading of the entire MoU, it plainly discloses an offer and acceptance, the concurrence of intention in the two parties to be bound by it, and consideration. It was sufficiently proved that money consideration had indeed passed. The appellant was given possession of the properties in February, 2004. Nothing in the MoU suggests that the parties had contemplated negotiating a subsequent agreement in order to be bound by the sale agreement.

Way forward on legal status of the MoU in Tanzania

We are of firm opinion that MoU is legally enforceable in Tanzania provided parties to that agreement had an intention to create legal relationship after complying with section 10 of the law of Contract. Courts of law are required to go through the document itself as mere heading or title of the document cannot deprive the documents of its real nature.

Therefore, it is very important to consult your lawyer when you intend to enter into MoU so that the same can be prepared in accordance with the law if you wish to make it to be legally enforceable.

USTIN Simango (37), resident of Malota village in Iringa Region remembers sometimes in September 2021 when Lupalama River which used to flow through the village full to the banks towards the Great Ruaha River began drying up due to illegal irrigation and livestock grazing within the protected 60 metres of the river.

Simango who was born and raised in Malota village, says that to reverse the trend, Masaka reservoir was constructed in May last year to support irrigation and livestock grazing as a way of protecting and sustaining Lupalama

He serves as Lupalama River Water Users Association (WUA) secretary, and says that irrigation and pastoralism by non-registered water users in the nearby Igangidung'u and Makongati villages has dramatically reduced the volume and flow of Lupalama River waters.

The association is formed by three villages namely Malota, Sadani and Kaning'ombe hence the acronym Masaka.

The 60-kilometre Lupalama River is, ordinarily, perennial -flowing from Igangidung'u village and passes through Makongati, Kaning'ombe, Malota, Sadani and Lupalama villages. The six villages have a total population of 12,000 inhabitants according to the August 2022 National Population and Housing Census.

"The association's major role is sensitising people living along the Lupalama River on the sustainable use of water resources as well as supporting environment protection initiatives," Simango said in a recent interview.

He said the water reservoir was expected to guarantee protection of Lupalama River which flows into the Great Ruaha River by ensuring sustainability of the Rufiji basin water resources, part of the backbone of the Julius Nyerere Hydro Power Project (JNHPP) being implemented in the said basin.

According to Idrisa Nyahove, secretary of Lower Mbarali Water Users Association, known by its Kiswahili acronym JUWAMBACHI, people have been invading the protected river basin despite the fact that there are beacons clearly demarcating the area.

Mathew Marcus, councillor for Makota ward (comprising of Malota, Makongati and Kaning'ombe villages), said the reservoir located in Malota village covers 219,712 square metres and has a capacity of 439,803 cubic metres. The annual demand for the 12,000 residents of the six villages which Lupalama River traverses stands at 213,426 cubic metres.

According to Marcus, 1.7bn/- was spent on construction of the reservoir - which was between May and November 2022. The reservoir serves three main purposes: irrigation, livestock and household consumption.

"Having this reservoir in place means a lot for the protection and sustainability of the

Lupalama River and by extension the Great Ruaha River,"

He added that protection of streams helps guarantee sustainability of the Rufiji River basin which, apart from supporting JNHPP, feeds three hydro-power dams namely Mtera (80 megawatts), Kidatu (205 megawatts) and Kihansi (180 megawatts). The three dams produce 66 per cent of electricity in Tanzania.

Marcus further noted that the Lupalama water users association was formed early last year after the recommendation of the Rufiji Basin Water Board (RBWB).

Upendo Lugalla, a Social Welfare Officer with RBWB said that the association was established as per Section 80 of the Water Resources Management Act No. 11, 2009.

She said the association's role is helping ensure that there are no human activities

within 60 metres from where small rivers that feed the Rufiji River basin pass.

The association also chips in when it comes to resolving conflicts related to water resources allocation and ensuring proper use of permits extended to water users by the RBWB.

"So far, a total of 42 water user associations have been formed. The target is having 120 associations by 2025 along the whole Rufiji basin," said Lugalla.

According to her, the board is in the process of filing at least 30 environmental pollution cases against illegal wa-

Florence Mahay, Director of RBWB said that in protecting small rivers and core water catchment areas for the Rufiii basin, the board is set to recruit 50 guards from SUMA JKT in the 2023/2024 financial year.

"Of the 50 guards, 30 will be deployed to the Great Ruaha water catchment areas while the rest will be deployed along river Kilombero," said Mahay.

He said the key role of the board is to identify all water resources available along the basin, water allocation among users and preservation of water sources along the basin.

According to him, the basin was formed as per the Integrated Water Resources Management Act 1981 which was gazetted in 1987, leading to the formulation of the Pangani Water River Basin in 1991 followed by the Rufiji basin in 1993.

The Act was replaced by the Water Resources Management Act No 11, 2009 and its 2022 amendments. Mahay said the Rufiji basin contributes a maximum of 18 per cent of the country's gross domestic product through agri-

culture, livestock, energy and tourism activities permitted along the basin.

He said 62 per cent of tea produced in the country is from the farms located within the basin alongside 40 per cent of sugarcane. Also, nearly 75 per cent of the Southern Agricultural Growth Corridor in Tanzania (SAGCOT) is within the Rufiji basin.

Gallus Ndunguru, water resources engineer at RBWB said that the board is mandated with issuance of permits to water users granted through water user associations. RBWB permits are issued under Section 43 of the Water Resources Management Act No 11, 2009.

Ndunguru said along the Rufiji basin there are 384 water sources, including feeder rivers, 55 of which are demarcated with beacons to deter people from carrying out human activities within the

space of 60 metres from the water source. "There are 3,782 water

users along the Rufiji basin especially in the Usangu valley of which 1,777 have no permits of using water resources," he said.

"Most of these illegal users engage in drip irrigation farming and livestock keeping especially in Mbarali District, Mbeya

Region." Ally Diwani, hydrologist at RBWB said the board issues four kinds of permits to legitimate users namely water use permit, drilling permit, water discharge and easement permit.

He said the Rufiji water basin covers 183,791 square kilometers, accounting for a whopping 46 per cent of Tanzania's irrigated farms. The basin has 31billion cubic metres of water on the surface and 9 billion cubic metres underground.

Diwani said the basin has four sub basins namely the Great Ruaha which contributes 15 per cent of annual water runoff, Kilombero (62 per cent), Luwegu (18 per cent) and Lower Rufiji five per cent.

"However, Great Ruaha forms 47 per cent of the total basin's drainage area with 85,554 square kilometers," he said.

"It is followed by Kilombero 40,330 square kilometers (22 per cent), Lower Rufiji 32,619 square kilometers (18 per cent) and Luwegu 25,288 square kilometers (14 per

Diwani added that the sub basins pass through 11 different regions where the Rufiji basin covers.

Sylvester Myalla, head of finance unit at RBWB said on economic benefits, the board generated 1.7bn/- last year from annual water user permit fees and expects to earn 2.4bn/- from the same sources this year.

However, the board targets to earn 9.1bn/- from project proposals to independent donors. The board is allocated an average of 8bn/- on an annual basis for projects and recurrent expenditure.

"Fees for water use are the heart of our own source revenues. For example, a water user pays 61,200/- as an application fee for the permit to secure 15,768 cubic metres on flat rate and 100,000/- on volumetric rate," he said

Myalla said that hotels, lodges, motels, guest houses and bars pay 255,000/- for 15,768 cubic metres a year on flat rate and 300,000/- on volumetric rate.

Small scale irrigation projects in the basin pay 61,000/- flat rate and 150,000/- volumetric for 31,536 cubic metres. Large scale irrigation projects pay 250,000/- flat rate and 500,000/- volumetric rate for 583,416 cubic metres a year.

Livestock keepers pay 61,200/- on flat rate and 300,000/- on volumetric rate for 31,536 cubic metres a year while horticulture projects pay 255,000/- and 500,000/- for 31,536 cubic metres.

Dr Thomas Bwana Assistant Director in charge of environment in the Vice President's Office said that proper management of water catchment and feeder rivers is crucial for the sustainability of water resources in the Rufiji basin.

"Water for irrigation farming and livestock keeping should be used responsibly especially in these times of climate change," he said.

"My office is organizing a number of programmes to sensitize people residing along rivers and water catchment areas on responsible water consumption."

Research by the Sokoine University of Agriculture dubbed 'Rising irrigation Productivity and Releasing Water for Intersectional Needs (RIPARWIN) 2002-2006 shows that water consumed by paddy irrigation in the country is higher than the proposed required amount.

The findings state that only two hyromodules are needed in the paddy field to grow the food crop. The two hyromodules are equivalent to the height of two centimeters from the paddy field surface.

"To the contrary, most irrigation farmers fill their paddy fields with 20 hyromodules. This leads to 18 hyromodules wasted to evaporation," reads part of the research findings.

The National Environmental Management Act No 20, 2004 Section 6 states that "Every person living in Tanzania shall have a stake and a duty to safeguard and enhance the environment and to inform the relevant authority of any activity and phenomenon that may affect the environment significantly."

On the other hand, the Sustainable Development Goal 6 (SDG6) emphasizes on countries to ensure access to water and sanitation for all by 2030.

"Poor management, over extraction of groundwater have exacerbated water stress. Countries are facing growing challenges linked to degraded water-related ecosystems," reads part of the UN goal.

The Performance audit report on the management of conservation and protection of wetland ecosystems in Tanzania, 2020/21 by the Controller and Auditor General (CAG) states that uncontrolled human activities such as commercial farming, teak plantation, animal grazing and development of urban settlements have been the key drivers of the reduction of wetland coverage in the country.

"For example, for Kilombero Valley Ramsar Site (KVRS) alone, the wetland ecosystem has been reduced from 7,950 square kilometers to 2,193 square kilometers, an equivalent of 72 per cent in the period of 20 years," reads the CAG report.

The report adds that the reduction in wetland coverage is likely to have an impact on the decrease in water volume.

Article 27(1) of the Constitution of the United Republic of Tanzania 1977 states that "Every person has the duty to protect the natural resources of the United Republic, the property of the state authority, all property collectively owned by the people."

The Government Notice No 64 issued February 2023 prohibits human activities in the four sub basins of the Rufiii basin.

During the inaugural event to fill JNHPP dam last December, President Samia Suluhu Hassan urged the Rufiji Basin Water Board to stop issuing permits for water use until the dam is fully filled with the intended 34 billion cubic metres.

"I urge residents along the Rufiji basin not to engage in activities that put at risk the sustainability of water sources that feed the basin," she said.

Kilombero district commissioner Dunstan Kyobya said his office is already taking stern legal measures against encroachers of water catchment areas feeding the Kilombero sub basin.

"A total of 201 cattle which were found grazing along the basin have been seized so far in protection of the Kilombero wetland," he said.

He added that in 2022/23 financial year, the district allocated 60bn/- for funding clean and safe water projects.

Kyobya said access to clean and safe water for the district stands at 73 per cent.

Jumaa Aweso, Minister for Water said Tanzania's 's water resource availability is estimated at 126 billion cubic metres of which 105 billion cubic metres are on the surface while 21billion cubic metres are found underground.

The study focused on people living in poverty, who are recipients of cash transfers, and participants in inactive control groups, who received no transfers or were enrolled at a later stage, served as a comparison group. Active control groups receiving alternative interventions were not included, as this makes a causal inference about the effects of the transfers difficult.

They included conditional and unconditional cash transfer programmes (CTPs) targeted at households living in poverty in LMICs but did not apply an absolute low-income/poverty threshold, relying only on the relative threshold for grant eligibility applied by the organizations admin-

istering the transfers. "Our findings have important implications for policymakers in Africa as

they show that providing cash transfers to people living in poverty not only improves poverty indicators and school attendance, for example, but also meaningfully impacts depression and anxiety outcomes of beneficiaries. This is especially true for unconditional cash transfers," Wollburg said.

She said they analyzed cash transfer programs that were specifically targeted to low-income and/ or deprived households as indicated by, e.g., low monthly household expenditure and consumption, inability to meet basic needs, food insecurity, low educational attainment and high HIV risk.

Esenam Abra Drah, a mental health advocate in the Ghanaian capital, Accra, said, "from personal experience if you don't have money, it can be frustrating." Esenam understands this because she was diagnosed with bipolar disorder in August 2015 at the time she was studying Bachelor of Arts degree in French and Linguistics at the University of Ghana.

Currently serving as an executive member of Psychosocial Africa, a grassroots mental health support group set up by, and for people with lived experience of mental illness, Drah admitted as the study showed that her situation affected her schoolwork though she was able to graduate.

The study cautioned that policies aiming to address the poverty-mental health cycle should consider unconditional, longer-term support to populations living in poverty.

Burkina Faso: Home to almost half of the closed schools in Central and West Africa

OVER a million children in Burkina Faso are currently affected by school closures with 6,134 academic institutions shut as of February 2023, an increase of over 40 per cent since the end of the last

school year. Nearly one out of four schools country-wide are now out of service due to rampant insecurity and violence, which has forced close to two million people into displacement.

On the eve of the highlevel conference on Education in Emergencies, organised by the European Commission and the United Nations Children's Fund in Brussels, the Norwegian Refugee Council together with the Education Cluster in Burkina Faso and the FONGIH, two umbrella entities representing 87 national and international organisations operating in the country, called for increased access to education for children left behind, whether they are internally displaced or live in enclaved areas.

"Only about a quarter of the children driven outof-school have been given new classrooms. The majority are left without access to education, robbing them of their childhood and of their chance to become independent adults and citizens," said Hassane Hamadou, NRC's country director in Burkina Faso.

"The longer this situait becomes, the harder it will be to reverse this trend and protect their futures. The authorities in Burkina Faso as well as humanitarian and development organisations must urgently renew their efforts to stop this educational hemorrhage."

Out of eight schools, only two are operational in the blockaded town of Pama in the East region, one of the three regions with the highest number of school closures along with Sahel and Boucle du Mouhoun. Six teachers and a few volunteers are currently serving over 1,000 children in Pama.

Speaking during an event to inaugurate the project for the installation of the facilities at the Kilimi Seed farm in Nzega, Tabora Region, Chief Executive Officer for ASA, Dr. Sophia Kashenge observed that the development will enable the Agency to double seeds production at the vast farm.

She noted that, absence of such facilities at the Tabora -based farm was cripping seeds production

"For instance, in this cropping season alone, a total of more than 150 acres of maize have dried out at this farm due to prolonged dry spell, which is a great loss to our side," she unveiled.

Through the on- going project, Dr. Kashenge informed that the Agency will install state-of- the- art irrigation facilities at its three key farms, including the Kilimi farm in Tabora (400h), Msimba farm in Morogoro (200h) as well as the Arusha -based Ngaramtoni farm which attracts a total of 200

"As per the set schedule, we're expecting that the involved contractors will complete the project's first phase by May this year, which will cover a total of 210 hectares, and immediately venture into irrigation trials before continuing with the second phase," she detailed.

Dr.Kashenge hailed President Samia Suluhu Hassan for injecting the Agency with a friendly budget for enabling it to install Irrigation schemes at its seed

Speaking for her part during the event, Tabora Regional Commissioners (RC), Ambassador Dr. Batilda Buriani, said the development was demonstrating the high commitments that the sixth phase government embraces in elevating the agriculture sector, especially in making sure the farmers are timely supplied with enough, but improved seeds.

She added that the government in the region will stand at forefront to protect the irrigation facilities at the farm in order to ensure the farm produces intended seeds.

" All citizens residing at the vicinity of this farm must cooperate closely with ASA to protect it from any encroachment, but must also stand ready to tap and benefit from diverse working opportunities that will likely crop up at the farm," she urged.

COMORIAN traders do not import many goods from Tanzania because of high taxes, Comorian Ambassador, Ahamada Mohamed, told the Acting President of the Tanzania Chamber of Commerce, Industry and Agriculture (TCCIA) Swallah Said Swallah, here yesterday.

The envoy called for regular meetings between the TCCIA and its Comorian counterpart to sort out problems and challenges that impede trade between the two countries. Comorians, he said, want to import goods from Tanzania because of proximity but high taxes are an impediment.

"Comoro and Tanzania are very close and friendly neighbours. However, our

from Pakistan simply because tariffs on Tanzanian goods are prohibitive. I suggest the TCCIA and our Chamber should meet and sort out these problems and challenges," Dr Mohamed suggested, praising the efforts being taken by the government towards promoting Tanzania's socioeconomic development.

Swallah assured the envoy that TCCIA will do everything in its power to remove obstacles standing in the way of trade growth between the two countries. He welcomed the envoy's suggestion but added that TCCIA is largely satisfied with the trade trend been the two countries,

At Chloride Exide, bosses work with staff on the factory floor

NAIROBI

few months into his tenure as managing director, an old factory worker asked to see the boss. Guy Jack ushered the man into his office.

He must have been acting in a way that displeased the old man who went on to fearlessly relay what Jack terms as the most profound lesson he's learned to date.

"Everybody knows who the boss is. You don't have to behave like it," the old man said. From then hence, Mr Jack's approach to management changed.

Jack, a third-generation Kenyan, pursued a motor vehicle engineering course in the United Kingdom before coming back home for good.

Aged only 25, he was placed at the helm of Thomas White Batteries, a new acquisition by the Associated Battery Manufacturers (ABM) fran-

"I was thrown in at the deep end," he admits of his inexperience. He'd never seen a balance sheet or a profit and loss statement before taking the corner office.

In 1994 when he joined, the company was producing 300 batteries a month. He saw the growth potential and within a year and a half, this number had risen to over 2,000 units.

Today, the capacity is 1.5 million battery units a year, a figure he says they come pretty close to meeting.

The company he runs is largely known for its operations as Chloride Exide, a distributor of automotive batteries whose other core business is the installation of solar

At the parent company's ting down operations when

(ABM) premises on Kampala Road, Jack, now the Group CEO steers a ship of 480 peo-

"I know four hundred of them on a first-name basis," he says of his relationship with the team. He asks about their families. "People leave places because of bosses, very rarely about remuneration," he adds.

One of the things they've always been good at, he says, is involving everyone in the company's strategy - top to bottom.

Everyone has a say in what the business is trying to do, how it will be done and their role in the overall plan.

On his move to the Head Office, Mr Jack came in with a different culture. For instance, he did away with the head tables at corporate functions. "You have one table and everyone sits there," he says.

Once every quarter, every non-operations worker has to work in the factory for four hours - physical work. Mr Jack says the effects of this practice have been incredible.

"It teaches people the business," he says and that's on top of getting to interact and know his staff and them him.

On the line, while giggling in fits, the staff plots and makes a battery with the cells the wrong way around to see if the newcomers including the boss will notice. He catches the mistake every time. Or so he says.

In his estimation, ABM spends Sh87,000 per person per year on staff training and that's with a total of 970 personnel in Kenya, Uganda and Tanzania.

Threats to the business In 2022, the company was within three weeks of shut-

a moratorium on the trade in scrap metal advised by the runaway criminality in scrap metal dealings.

With 90 percent of batteries made from recycled lead, this had a big dent in operations. ABM resorted to importing pure lead from Tanzania and The Democratic Republic of Congo.

Thousands of jobs were in dire straits before the moratorium was lifted.

Jack also doesn't see the advent of the electric car as an imminent threat to his business. "The reality is, when the world switches off the last combustible engine, Africa has eight vears."

He further doesn't see lithium as a viable replacement for his lead batteries. Lead is 99.9 percent recyclable as opposed to its much more expensive alternative, not to mention lithium's detriment to the environment. He's currently sitting pretty.

Operations Fifty percent of ABM's business is in exports. Their products are shipped and trucked all over East and Central Africa, further down to Malawi, Zim-

the Kenyan government placed babwe, Zambia, Mauritius, Mozambique and Madagascar.

> They have further made forays into the West African market, seeing their products in Ghana under the Free Trade Agreement. At home, Chloride Exide enjoys 60 percent of the market, a lion's share.

Twenty-nine years ago, Chloride Exide moved into the solar power trade and has since grown the division into a multimillion-dollar business.

Jack further reveals that up to Sh2 million of his monthly power bill is catered for by their rooftop programme.

In a stroke of genius, ABM sold a 25 percent stake of the company to Metair Investments, a South African partner who owns battery plants in South Africa, Turkey and Romania.

"We share a synergy of technology and have access to some of the best research and development," Jack says of the symbiotic relationship.

He goes on to extol the inhouse talent at ABM as some of the best in the world and boasts of the most advanced battery plant in Africa in terms of "technology and equipment." Guy the Man

Almost thirty years on, Jack says he is still hungry and counts himself very lucky to hold the position he does. Each day presents a new challenge.

"Today, I'll meet guys in the factory...on Friday, I'll be at an awards ceremony or a golf event in Kisumu!" he says.

Outside the office, Mr Jack enjoys flying having acquired his pilot's license in 2017. He has a four-seater plane he uses for both work and play.

He used to be a martial artist but when age caught up, he moved to shooting and has done this at the highest level, representing Kenya in international events.

Parting Shot

"There's a perception that you have to be extremely highly educated. That couldn't be further from the truth!" Jack says of the prevailing societal attitudes towards the achievement of success.

He says, "We recruit for attitude and develop the skill."

NCC's helpdesk at Abuja airport moves telecom solution even closer to travellers

TELECOM services consumers around Nnamdi Azikwe International Airport, Abuja who are having issues with their service providers can now access help from the Nigerian Communications Commission, NCC in the airport.

This is as the Commission has established a help desk known as **Telecom Consumer Assistance, Resolution** and Enquires, TELCARE, Centre in the airport.

The TELCARE center was unveiled recently as one of the series of events by NCC to mark the 2023 International Consumers Rights Day.

The Chairman, Board of Commissioners of NCC, Prof. Adeolu Akande, who unveiled the initiative, said the launch of the TELCARE, is the beginning of the helpdesk project expected to adorn some airports and other similar public locations across the

He said: "The platform would serve as an additional channel for consumers to make enquiries on consumer issues, allowing the Commission to provide advocacy on consumer concerns as well as create awareness regarding Commission's activities.

"It is one of NCC's strategies for expanding the channels of engagement with telecom consumers.

"The project is a deliberate effort by the Commission to amplify its commitment to promoting the interest of consumers using various engagement strategies and initiatives to protect, inform, and educate telecom consumers."

He also expressed gratitude to the Management of the Federal Airport Authority Nigeria, FAAN for its support in ensuring the successful establishment of a TELCARE Desk at the airport.

He noted that the Commission, under the leadership of its Executive Vice Chairman, Prof. Umar Danbatta, has continued to re-engineer its strategies and structures to make them more effective to engage critical stakeholders to address unfair practices including but

Also, the Regional General Manager, FAAN, Kabir Mohammed, said that the Management of FAAN was delighted to partner with the NCC on the initiative, as the passengers and airport users will have the opportunity to resolve issues bothering them while in transit.

Mohammed also noted that the firsthand interface with consumers would not only expedite the feedback mechanism in addressing telecom consumer issues but also curb unfair practices within the system and further bridge any communication gap between the consumers and its regulators.

NCC's Head, Consumer Affairs Bureau, Ayanbanji Ojo, speaking through the Head, Consumer Protection and Advocacy at NCC, Clem Omife, expressed optimism about the expected success of the initiative.

Ojo noted that many consumers transiting at the airport are already taking advantage of the Desk even before the launch of the TELCARE Desk, to make enquiries or lodge complaints.

"This is a pilot project, and the Commission will ensure that the TELCARE Desk is established in more strategic locations around the nation. We believe that through adequate education, information sharing, and the provision of layers of channels for complaints and redress, we can safeguard the interest of telecom consumers and innovatively promote the prospect of more excellent consumer experience," Ojo said.

Laptrust out to weigh bids for its property fund shares

INVESTORS ested in buying into property fund Laptrust Imara I-Reit will have to negotiate a price acceptable to pension scheme Laptrust which currently owns nearly all the units (shares) in the newly listed entity.

The unique arrangement, a departure from the norm where shares transparently and freely after original shareholders sell a part of their stakes, has been approved by regulators and will remain in place for three years.

Laptrust Imara made an opening trade of 250,000 units at Sh20 apiece on Wednesday, valuing the transaction at Sh5 million which meets the minimum investment size for the real estate trust. An unnamed pension fund bought the units.

"Customers will approach us and we will agree on price and then they buy until the market is more understand-

ing of this product and that's why we are taking our time," Laptrust CEO Hosea Kili said. The pension fund is

expected to open up the Reit as a regularized mainstream listing after a three-year window allowing the commencement of normal automated trading. Even so, participants

in the trading of Imara I-Reits will be limited to persons qualifying as professional investors, restricting participation to high-net-worth individuals and institutions such as pension firms and insurers.

NSE-listed Ilam Fahari I-Reit which trades like an ordinary stock is the only property fund to embrace retail/small investors having set a minimum investment amount of Sh20,000 when it listed in November 2015.

Investors can now invest as low as Sh650 to buy 100 units of Ilam Fahari in the open market.

NSE's chief executive

Geoffrey Odundo says the bourse will be accommodative to differently structured funds with the view of growing the Reit's space.

"We expect to see more Reits coming through but we are yet to register any applications. Structures will come in any form but we want to make it as flexible as possible for the listings to come as we want to have a critical mass of Reits," he said.

The Laptrust Imara I-Reit has 346,231,413 units with the Sh20 per unit price being based on the net asset value of the scheme at the time

Properties held under the fund include CPF MetroPark, CPF House, Pension Towers and Freedom Heights Mall.

The Reit is the first to be listed by a pension fund on the Nairobi Securities Exchange.

The investment vehicle closely

resembles the Acorn Student Accommodation I-Reit by the profile of the investor and the minimum capital required.

While the Acorn property fund is not listed on the NSE, the investment vehicle trades on the over-the-counter market in transactions with a minimum of Sh5 million per trade.

Laptrust is the first pension fund to list a Reit and it is expected to be followed at the NSE with more fund managers expected to replicate the move.

scheme had locked out retail investors from its newly created real estate investment trust by setting a minimum investment of Sh5 million for each party that may want to buy into the property fund in the future.

Laptrust has received the Capital Markets Authority (CMA) approval to package its real estate assets into a fund called Laptrust Imara I-Reit and which will be listed on the Nairobi Securities Exchange.

The properties that will be held under Imara include CPF Metro Park, CPF House, Pension Towers, Freedom Heights Mall and Service Plot, Man Apartment and Nova El-

"The Laptrust Imara I-Reit will be listed as a close-ended fund at Sh20 per unit (share) based on the net asset value of the scheme as at the time of listing, with a total of 346,231,413 units," the regulator said in a statement.

"The valuation of the I-Reit, at the listing, will thus be Sh6.9 billion. The units may only be transferred to persons who qualify as professional investors and at a minimum trade size of Sh5 mil-

A closed-end fund's shares are traded on the exchange but no new units will be created and no new money will flow into the investment vehicle.

This means that Laptrust, which fully owns Imara, will decide how many units of the property fund it will sell to the high-net-worth investors who will be required to buy a minimum of 250,000 units at Sh20 each.

Laptrust's move follows Acorn Student Accommodation Income Real Estate Investment Trust (Acorn I-Reit), which also set a minimum investment of Sh14 million when it brought on board new investors in January last year. Acorn's property fund is not

aimed at restricting the offer to a relatively smaller group of "professional investors" who are deemed to be more likely to understand and handle the risks and opportunities of the fund.

NSE-listed Ilam Fahari I-Reit is the only property fund to embrace small investors, setting a minimum investment of Sh20,000 when it raised funds in November 2015.

Fahari's trading on the bourse has no restrictions, allowing minimum investments of about Sh700 for 100 units based on the current market price. It was not immediately clear when Laptrust's Imara may sell units in the fund to outside investors.

An I-Reit is a real estate trust that primarily derives its revenues from rental income. At least 80 percent of the trust's net profit from normal operations must be distributed to investors.

REITs are exempt from multiple taxes, including withholding and income taxes, making them a more efficient vehicle for holding real estate assets.

APP HASN'T SHARED US DATA WITH GOVT OF CHINA, SAYS TIKTOK CHIEF

LAGOS

HE chief executive officer of TikTok, Shou Zi Chew has said the controversial popular Chinese-owned video-sharing app has never shared the United States data with the authorities

Shou said this ahead of his testimony before the House of Representatives Energy and Commerce Committee on Thursday.

TikTok's chief will tell lawmakers who will be hearing on behalf of more than 150 million American users that the app never has, and would never, share US user data with the Chinese government amid growing national security concerns, Reuters said.

"TikTok has never shared, or received a request to share, US user data with the Chinese government. Nor would TikTok honour such a request if one were ever made," Shou posted this as part of his written testimony posted on Tuesday.

He added that TikTok's parent company ByteDance is not owned



or controlled by any government or state entity.

"Let me state this unequivocally: ByteDance is not an agent of China or any other country," Shou will tell the committee.

TikTok's critics fear that its US user data could be passed on to China's government by the app and stimulated mounting pressure to ban the app by US lawmakers.

Last week, TikTok said the President Joe Biden administration demanded that its Chinese app or it could face a US ban.

"Bans are only appropriate when there are no alternatives. But we do have an alternative," Shou's testimony said.

TikTok has said it has spent more than \$1.5 billion on what it termed rigorous data security efforts under the name "Project Texas" and has tried to convince lawmakers and the Biden administration to support the plan.

The Committee on Foreign Investment in the United States (CFIUS), a robust national secuowners deprive their stake in the rity body, had unanimously rec-

ommended in 2020 that ByteDance separate TikTok.

Under pressure from then-President Trump, ByteDance in late 2020 unsuccessfully sought to finalize a deal with Walmart and Oracle to shift TikTok's US assets into a new entity and Trump then lost court battles seeking to ban TikTok.

"Oracle has already begun inspecting TikTok's source code and will have unprecedented access to the related algorithms and data models," Shou's testi-

Shou said when the process is complete "all protected US data will be under the protection of US law and under the control of the US-led security team. Under this structure, there is no way for the Chinese government to access it or compel access to it."

The company said it had started this month to delete US user-protected data in data centres in Virginia and Singapore after it began routing new US data to the Oracle Cloud last year. Shou's testimony said it expects this process to be completed later this

Shou's testimony said 60% of ByteDance is owned by global institutional investors including Blackrock, General Atlantic, and Sequoia, about 20% by the company's founders, and about 20% owned by its employees "including thousands of Americans."

TikTok said on Monday that more than 150 million people in the United States use Tik-Tok on a monthly basis after saying in 2020 that 100 million Americans used the app. Shou's testimony says the average user today is an adult well past college age.

"While users in the United States represent 10% of our global community, their voice accounts for 25% of the total views around the world," Shou's testimony said.

IN today's digital age, the importance of robust digital governance cannot be overstated. As governments and organizations grapple with managing vast amounts of data, there is an urgent need for a clear and comprehensive framework for national data governance.

To strengthen Rwanda's progress, the Ministry of ICT and Innovation (MINICT) has partnered with the United **Nations Department of Economic** and Social Affairs (UN DESA) to organize a capacity development workshop focused on digital government and national data governance framework.

The workshop, which began on March 22 at Kigali **Convention Center and will** continue until March 23, has brought together local and international stakeholders from government and private institutions in the ICT sector.

According to Gordon Kalema, **Director General in Charge** of Digital Transformation at MINICT, the workshop is focusing on three critical areas: the digital infrastructure development index, the online service index, and the data governance framework.

The digital infrastructure development index looks at how infrastructure can be developed in the country to enhance ICT and innovation, while the online service index examines how policies can be implemented to ensure that all services are issued online. The data governance framework focuses on developing data infrastructure in a way that ensures security and privacy for citizens.

Kalema emphasized that the workshop aims to build capacity for both government and private institutions and to share best practices from other countries through expert facilitators.

"The three areas of focus for the workshop are already being implemented in Rwanda. The government has invested in 4G infrastructure and has set up a new broadband policy that prioritizes developing infrastructure for quality and affordable internet access for all citizens." Kalema said, adding that most services are now available online through Irembo, and the government is aiming to put all remaining services online by 2024.

He also mentioned that Rwanda has implemented data privacy and protection laws, which will be discussed during the workshop to explore effective implementation strategies.

Other topics for discussion include smartphone penetration, digital literacy as well as local content development in a way that is more effective.

Leila Rwagasana, Director of Partnerships at Irembo, added that the workshop will help disseminate knowledge to their agents and improve their platform's services.

She said they aim to increase digital literacy and train their staff and users to add more services and innovations, mobilizing those with internetconnected devices to help others.



"Our target is being ready for the Maroons game. In the meantime, we are going to play two test matches with StarTimes Uganda Premier league sides to test the light patterns. We intend to have about 600 to 700 lux mandated for the local

matches," said Kaddu.

According to Kaddu, the floodlights deal is catered for and installed by shirt sponsors CHiNT Electronics that joined KCCA for a three-year partnership in October last year.

CHiNT is a Chinese dealing in company provision of smart energy solutions, covering an integrated whole industry chain of power generation, storage, transmission, substation, distribution, sales, and consumption.

"We are not contributing a penny but we believe that CHiNT will invest about Shs1bn to install the floodlights. This is an expensive venture not for the faint hearted. Our stadium is under construction so we can't host international matches but upon completion, expect an assemblage of modernised floodlights," Kaddu added.

They plan to have 48 bulbs distributed on the

four lamps and an extra two bulbs stationed near the both stands to balance

visibility. Although sufficient for UPL standards, the floodlights project fades in comparison with that at Kitende which enables a capacity of 1200 lux lighting, was imported from Germany, was inspected by FIFA contractors Rabo Sport Company and is valued at Shs2bn.

Liberia gets \$3.9million ADF grant to modernise its payments infrastructure



THE African Development Fund (ADF) has approved \$3.9 million grant to finance the upgrade of Liberia's payments infrastructure and systems.

The project's primary objective is to strengthen the payments ecosystem in Liberia for increased efficiency and to foster growth and innovation.

It targets the automated cheque processing and automated clearing house and real-time gross settlement systems, which ADF says, form the backbone of payments processing in the country's financial sector.

Also, the project will see the upgrade of the Central Bank of Liberia's main data centre and disaster recov-



The ADF funding comes at

a time Liberia's financial sector is suffering from a number of challenges including inadequate ICT and last mile reach infrastructure

Existing payments infrastructure was deployed in 2016 with help from the African Development Bank, and has served the country for the last six years, but require urgent upgrading, says the ADF.

Moreover, ADF says the pro-

ject is expected to "maximise potential to strengthen the financial sector, build financial stability, bridge the financial inclusion gap and facilitate integration in the region."

According to the ADF, the planned project will also directly impact the roll-out of the proposed National Electronic Payments Switch (NEPS) system targeted at the retail where the market greatest exclusion occurs.

It says: "With the NEPS project approved by the World Bank in 2022 and its implementation underway, the proposed project is critical to efforts to improve financial inclusion in Liberia, currently standing at 44.2% (Findex 2021), and reach to disenfranchised populations including youth, women, smallholder farmers, micro small and medium enterprises, and other rural popula-

Implementation of the new project commence in June 2023 and will be executed by the Central Bank of Liberia working together with banking and nonbanking institutions. "The modernisation

of Liberia's payments infrastructure systems to improve payments efficiency not strengthen the formal financial sector, but contribute to greater financial stability and private improved sector development," says Benedict Kanu, African Development Bank country manager for Liberia.

Indian court orders Rahul Gandhi to 2 years in jail for Modi remark

AHMEDABAD, India

A court in India found opposition leader Rahul Gandhi guilty of defamation yesterday for a speech he made in 2019 in which he referred to thieves as having the surname Modi, and sentenced him to two years in prison.

Gandhi, a senior leader of the Congress party and the scion of the Nehru-Gandhi political dynasty, will appeal against the order in a higher court, his party said. The judgment was passed by a court in the city of Surat, located in Prime Minister Narendra Modi's home state of Gujarat.

An adviser to the federal government, Kanchan Gupta, said Gandhi, a member of the lower house of parliament, could face immediate disqualification as a member of parliament following the conviction in line with a 2013 order of the country's highest court.

"The court has found Rahul Gandhi's comment to be defamatory," said Ketan

Reshamwala, an advocate for complainant Purnesh Modi, a Gujarat lawmaker from the prime minister's Bharatiya Janata Party (BJP). "He has been sentenced to two years in jail."

Gandhi was present at the Surat court, which gave him bail immediately and suspended the sentence for a month.

In the speech ahead of the last general election in 2019, Gandhi referred to the prime minister and two fugitive Indian businessmen, all with the Modi surname, while talking about alleged high-level corruption in the country.

Yesterday, Gandhi told the court that his comment was not against any com-

Gandhi's party said the case against him was brought by a "cowardly and dictatorial" BJP government because he was "exposing their dark deeds".

"The Modi government is a victim of political bankruptcy", Congress president Mallikarjun Kharge said on Twitter. "We

will appeal in the higher court."

"In a democracy, nobody, absolutely nobody is above the law," Gupta said on Twitter. "All are equal. The law, therefore, equally applies to Rahul Gandhi."

Congress spokesperson Supriya Shrinate said the party had "all legal recourse available to us and we will use

"Hopefully, the law of the land will prevail," she said.

Gandhi, one of Modi's main rivals ahead of the 2024 general election, won support from the Aam Aadmi Party (AAP) that rules Delhi and two of whose top leaders are in jail on what they call trumped-up charges.

Medvedev says diplomacy doesn't always work, special op was right move

MOSCOW

THERE are situations where agreements are counterproductive and one needs to take steps like launching a special military operation, Russian Security Council Deputy Chairman Dmitry Medvedev said in an interview with Russian media outlets, including TASS, and users of the VKontakte social media network.

"In my view, it makes no sense to negotiate in certain situations. One must ignore it, and in some cases make decisions like the one that was made on February 24 last year because agreements can be counterproductive in certain cases," Medvedev pointed out, when asked if Moscow needed to

make agreements with the countries that failed to see Kiev's crimes.

According to him, Moscow tried for decades to convey some simple things to the West. "Guys, the Soviet Union collapsed. Yes, it's sad but that is what hap-

pened, both because of the Soviet leadership's incompetent policy and your external interference. The country fell apart but ties did not, and the people remained

the same. How do you imagine that? Ukraine becoming part of NATO?" he said, clarifying Russia's message. Meanwhile, Ukraine "had its own

nuclear weapons complex," Medvedev went on to say.

As a result, Russia would get a neigh-



bor "who is not only a member of an unfriendly bloc but also plans to produce nuclear weapons," he noted. "I would like to point out that Ukraine's leader spoke about this shortly before the start of the operation, in late 2021.

So do you want us to put up with

it? Particularly in a situation where we have a dispute over Crimea because we consider it part of our land and they regard it as their territory. So imagine them joining NATO and launching a large-scale operation against our country under NATO's umbrella - we cannot accept this," Medvedev stressed.

Israel ratifies law limiting conditions for a Netanyahu ouster

JERUSALEM

ISRAEL ratified a law yesterday limiting the circumstances in which a prime minister can be removed, despite worries voiced by a government jurist that it may be meant to shield the incumbent Benjamin Netanyahu from any fallout from his corruption trials.



The amended definition for the "incapacity" of national leaders is among legislative measures by the religious-nationalist coalition that have tipped Israel into crisis, with the opposition arguing that judicial independence is in

The coalition says the overhaul is aimed at pushing back against Supreme Court over-reach and restoring balance among branches of government.

By a 61-to-47 final vote, the Knesset approved the bill under which prime ministers can be deemed unfit - and compelled to step aside - either if they or three-quarters of cabinet ministers declare them so on physical or psychological grounds.

The stipulations fleshed out a quasi-constitutional "basic law" that provides the government with guidance in the event of a non-functioning prime minister - but which previously lacked details on circumstances that may give rise to such situations.

According to the non-partisan Israel Democracy Institute, the rule had earlier left Netanyahu vulnerable to a possible assertion of his incapacity by Attorney-General Gali Baharav-Miara, should she perceive an attempt by him to halt his three court cases.

The new law precludes this, IDI senior researcher Amir Fuchs said - while adding that he had considered such a finding by Bararav-Miara to be an unlikely "extreme case". Netanyahu denies all charges against him, and has cast

the trials as a politicised bid to force him from office. Baharav-Miara - who was appointed by the former, centrist Israeli government - said last month that Netanyahu must stay out of his coalition's push for a judicial overhaul because of what she deemed a conflict of interest arising from his trials.

Baharav-Miara's deputy, Gil Limon, voiced misgivings over the incapacity bill during a Knesset review session on Tuesday.

"What we see before our eyes is a cluster of legislation elements that are most troubling and are being advanced at great speed," Limon said, according to an official tran-

"They have the potential to serve the personal interests of a man regarding the outcomes of legal proceedings he is facing."

FAO secures 27m USD to scale up humanitarian support in eastern Africa

NAIROBI

THE Food and Agriculture Organization (FAO) of the United Nations on Wednesday welcomed 26.9 million U.S. dollars to provide access to food and other basic goods and services in eastern Africa.

The FAO said the funds from Germany will also be used in protecting and restoring productive livelihoods in droughtaffected communities in Ethiopia, Kenya, Somalia, and Su-

"The new funding represents a significant contribution to mitigating the impacts of drought on food security and livelihoods by increasing immediate food access in rural communities, safeguarding and restoring livelihoods, and rapidly enabling self-reliance," the FAO said in a statement reaching Xinhua here.

It said the intervention seeks to reach almost 1 million of the most vulnerable people in inaccessible and hard-to-reach rural areas, cutting across all impacted livelihoods.

Given the crops have failed, animals die, and populations are displaced across the region, the crippling drought is driving high levels of acute food insecurity across eastern Africa, with more than 22 million people in southern Ethiopia, Kenva, and Somalia in need of urgent humanitarian food assistance as of March, according to the UN food agency.

It said this figure includes 2.6 million people in Emergency in Kenya and Somalia and more than 96,000 people in Catastrophe in Somalia. According to the FAO, Ethiopia will receive 7.54 million dollars, Kenya 7 million dollars, Somalia 8.08 million dollars, and Sudan 4.31 million dollars.

The UN food agency is helping farmers across eastern Africa not just to respond to the effects of climate change, but to proactively adapt to the impacts of the climate crisis, particularly to frequent droughts, by adopting climate-smart farm-

Muted opposition: UK PM wins N. Ireland vote in parliament

LONDON

BRITISH Prime Minister Rishi Sunak won the backing of parliament on Wednesday for a key element of a reworked post-Brexit deal on Northern Ireland despite opposition from the province's biggest unionist party and some of his lawmakers.

Sunak (pictured) has tried to end years of wrangling over Brexit by revisiting one of the trickiest parts of the negotiations - to ensure smooth trade to Northern Ireland without creating a hard border with Britain or with European Union-member Ireland.



But in Wednesday's vote in the lower house of parliament, those he most wanted to win over - Northern Ireland's Democratic Unionist Party (DUP), some Conservative eurosceptics in the European Research Group (ERG) and his two predecessors, Boris Johnson and Liz Truss - rebelled by voting against the brake.

Despite the opposition, Sunak won the vote by 515 to 29, managing to contain the size of the rebellion but with a substantial number of Conservatives abstaining. Opposition parties voted in support of the brake.

Sunak's ministers welcomed the vote.

"I welcome parliament voting today to support the Windsor Framework," Britain's Northern Ireland minister Chris Heaton-Harris said on Twitter.

"This measure lies at the very heart of the Windsor Framework which offers the best deal for Northern Ireland, safeguarding its place in the Union and addressing the democratic deficit."

The brake enables Britain to prevent new EU laws applying to goods in Northern Ireland if asked to do so by a third of lawmakers in the province's devolved

The ERG has described the measure as "practically useless" and the DUP complains that it does not apply to existing EU law.

'Brake with no brake pads'

The new agreement was hammered out by Sunak, in office since October, after Johnson's former government threatened to renege on the original deal it had struck with the EU.

A hard border risked endangering the Good Friday Agreement which largely ended three decades of armed conflict in Northern Ireland involving militants seeking a united Ireland, "loyalists" wanting to remain part of the United Kingdom, and British security forces.

The United States has said that any threats to the agreement could hurt the possibility of a US-British trade.

Sunak hailed securing the deal last month as a "decisive breakthrough" but by alienating the DUP he has failed in restoring the power-sharing government in Northern Ireland.

The DUP, at odds with opinion polls suggesting 45 percent of voters in the province support the framework versus 17 percent opposed, has said the brake does little to ease its concerns over the post-Brexit trading arrangements, saying it did not deal with the fundamental issue - the imposition of EU law.

DUP leader Jeffrey Donaldson told parliament his party could not return to Northern Ireland's power-sharing government "at this stage".

Earlier, the ERG's chairman Mark Francois told reporters the group had recommended to its members to vote against the government to show their discontent over what he called an "oversold" agreement that was a "brake with no brake

UN calls for game-changing action on global water crisis

UNITED NATIONS

THE United Nations on Wednesday called for game-changing action when world leaders, businesses, youth and other stakeholders gathered at the three-day UN 2023 Water Conference to address the global wa-

"This is more than a conference on water. It is a conference on today's world seen from the perspective of its most important resource," UN Secretary-General Antonio Guterres said in his opening remarks.

The conference runs through Friday. "This conference must represent a quantum leap in the capacity of member states and the international community to recognize and act upon the vital importance of water to our world's sustainability and as a tool to foster peace and international co-operation," Guterres said.

Access to safe water, sanitation and hygiene is the most basic human need for health and well-being, and a declared human right. But some 2 billion people around the world still lack access to safe drinking water.

More people have access to mobile phones than toilets and sanitation, with 80 percent of wastewater discharged untreated into the environ-

More than 90 percent of disasters are water-related, with climate change adding to the pressure. And humanity's demand for water keeps growing, with pressure on freshwater projected to increase by more than 40 percent by 2050, according to the world body.

Despite these challenges, a breakthrough to "a water-secure planet" is still possible. But urgent action is

With this at the top of their minds, world leaders, together with over 6,000 registered civil society, business leaders, young people, and experts are attending the conference to present innovative solutions and bold commitments to accelerate transformational change for water, the world body said in a press release.

"We have today a global water crisis. To put it bluntly: the three forms of water disasters have created a human disaster. Too much water takes

human development, too dirty a water threatens our health and the nature we are part of," UN General Assembly President Csaba Korosi told the opening session of the confer-

"The solution is in our hands ... A cooperative water-secure future starts with political will, economic intelligence, and cultural tolerance and acceptance," he said. "It must be both a change of mind and heart," Korosi said. "We need to be bold. We can agree on gamechangers."

"During this conference, we want to get the water wheel spinning," stated Willem-Alexander, king of the Netherlands, in his opening statement. "We won't rest until water is given the place it rightly deserves on global agendas and policy programs. We will bring all our commitments, pledges and actions together in a Water Action Agenda."

The key outcome of the UN 2023 Water Conference will be the Water Action Agenda, a collection of commitments from member states and other stakeholders that aims to present game-changing solutions to accelerate progress on Sustainable Development Goal 6, which aims at achieving safe water and adequate sanitation for all.

To date, more than 500 commitments have been registered from governments, UN agencies, business leaders and civil society, ranging from targeting open data sources and improving education around water, to scaling effective water management practices and mobilizing funds to drive action towards water, according to the United Nations. is, as the United Nations puts it, "a once-in-a-generation opportunity" to advance the Water Action Agenda that seeks to deliver the internationally agreed water-related goals and targets, including those contained in the 2030 Agenda for Sustainable Development.

Macron stands firm on pension bill as protests escalate

PARIS

FRENCH President Emmanuel Macron on Wednesday said a deeply unpopular new law that raises the retirement age was necessary and would enter into force by the end of the year. Saving he had "no regrets." he however added that

he wanted to improve a fraught relationship with labor unions and involve them more in future reforms, on topics including retraining for those in painful jobs. "Do you think I enjoy doing this (pension) reform?

No," Macron (pictured) said in an interview with TF1 and France 2 TV. "But there are not a hundred ways to balance the accounts ... this reform is necessary."

Until the government pushed the pension bill through without a vote, the protests against a bill extending the retirement age by two years to 64 had gathered huge, peaceful crowds in rallies organized by unions.

But since the government's decision to skip a vote in parliament last week, spontaneous protests in Paris and elsewhere have seen rubbish bins and barricades set ablaze every night amid scuffles with police.

Protesters on Wednesday also blocked train stations in the southern cities of Nice and Toulouse.

This, alongside with rolling strikes that affect oil depots, public transport and garbage collection, represent the most serious challenge to the centrist president's authority since the "Yellow Vest" revolt four years ago.

Macron decries violence

Labor unions have announced another nationwide day of strikes and demonstrations on Thursday.

"We don't want this law and we'll fight until it is withdrawn," pensioner

Jacques Borensztejn said at a rally on Tuesday in Paris. Macron said what he called "extreme violence" was not acceptable, while he

respected the right to peaceful protests. "We'll make sure a life that is as normal as possible can resume in the face of

the few that block things," he said. Neither a government reshuffle nor snap elections are on the cards, but rather an attempt to regain the initiative with measures to better involve citizens and

unions in decision-making, political leaders in Macron's camp have said. While the opposition has called for Macron to fire his prime minister Elisabeth Borne, who has been at the forefront of the pension reform, Macron backed her in the interview and said that he had tasked her with further widening the ma-

Macron's camp lost its majority in the lower house of parliament in elections last year.

"She (Borne) has my trust to lead this government team" and build a legislative program to have "fewer laws, shorter, clearer texts", and "continue to widen this majority as much as it can"

Polls show a wide majority of French are opposed to the pension legislation, as well as the government's decision to push the bill through parliament last week without a vote.

But Macron said he would stand firm.

"Between the short-term polls and the general interest of the country, I choose the general interest.... we will not tolerate any misbehaviour," he said.

"We have no right to standstill or immobility," he said.

Chinese courier industry sees rapid improvement in service capability

INTERNATIONAL shipping of big live animals is one of the most difficult businesses in non-regular logistics. It is an important indicator for a logistics firm's competitiveness. Only a few transnational shipping corporations are able to complete such missions.

Recently, Japan-born giant panda Xiang Xiang returned to China on an airplane of Chinese express delivery services provider SF Express, which marked the first time for a Chinese express delivery firm to transport a big live animal between two countries. It also indicated that the industry's service capability and overall strength have reached a whole-new level.

This was not the first time for the Chinese courier industry to make a surprise.

Last August, the Qingdao Liuting International Airport in east China's Shandong province was closed and the new Qingdao Jiaodong International Airport put into operation. The move was assisted by courier enterprises, too. SF Express almost "shipped" a whole airport, from gigantic facilities to insect specimens.

So far, the shipment of aeroengines, landing gear, airfoils and other parts has become a regular business of Chinese courier firm YTO Express, which makes the company a "logistics manager" for many airlines.

The progress made by the courier industry is also felt by individual Chinese consumers. Agricultural products that need to be delivered in a very short period of time, such as waxberries, strawberries, lychee, Chinese mitten crabs and flowers, are now massively shipped with high efficiency and low loss. Consumers are able to enjoy commodities from across the world without stepping out of their houses.

The progress has led to new opportunities.

Previously, courier enterprises were engaged in fierce competition in the shipment of e-commerce commodities as the courier industry's growth slowed, and even started a "price war" that made the competition destructive.

Thanks to the enhanced service capability of the industry, more and more manufacturing enterprises are coming to courier companies today.

For instance, ZTO Express has reached cooperation with Foton Daimler Automotive, a joint venture between Chinese carmaker Foton and Daimler, which means the Chinese courier giant will provide wholeprocess supply chain services for the automaker. Besides, JD Logistics, the logistics arm of e-commerce platform JD.com has become a "storage planner" of Wafangdian Bearing Company Limited.

From offering after-sale logistics services to providing "mobile warehouses," and to becoming integrated warehousing and distribution services providers, express delivery enterprises are turning into supply chain services providers and building new growth en-

The courier sector is an important part of the service industry. Its growth not only benefits itself, but also is conducive to the development and supply-demand circulation of other industries.

On the production end, the courier sector's remarkable service capability is helping lower the logistics and warehousing cost for manufacturing enterprises. At the same time, as one of the few industries that are fully digitalized, the courier sector is also connecting sales and stock databases for manufacturing enterprises for better digital transformation.

On the consumption end, the upgraded logistics services have created new market demands and thus contributed to the expansion of domestic demand.

For instance, the retail price of fresh flowers had always been high because of the commodity's fragility, short preservation and inconvenient transportation. Thanks to the breakthroughs made by courier companies in packaging and transportation, fresh flowers from Yunnan province, a major producer in southwest China, can now reach all major Chinese cities within 24 hours. This has made possible online sales of fresh flowers. According to statistics, between 2015 and the end of 2021, the e-commerce market for fresh flowers had grown to nearly 90 billion yuan (\$13.05 billion).

The courier industry is like a bridge between the supply and consumption ends. If the bridge becomes wider and more flat, the match between supply and demand will be more efficient.

It is believed that as the Chinese courier industry continues to improve its service capability, it will further increase the efficiency of the manufacturing sector, better drive demand with supply and contribute to a virtuous circle of China's national economy.

SIMBA SC Board of Directors Chairman, Salim Abdallah, has expressed a desire to ensure the side books a place in the semi-finals of this season's CAF Champions League.

The side secured qualification for the last eight of the premier continental tournament following a resounding 7-0 victory over Guniea's Horoya Athletic Club in a Group C clash held at the former's home turf last week.

Credit Suisse collapse leaves sports sponsorships in limbo

THE takeover of Swiss bank Credit Suisse leaves many sports stars, teams and tournaments with a big question mark hanging over their lucrative sponsorship deals.

The Swiss national football team, the country's top football division, tennis great Roger Federer, golf star Sergio Garcia and Zurich's new stadium were all sponsored by the bank, which is being taken over by Swiss rival UBS.

The deal was hastily arranged on Sunday after Credit Suisse's share price plunged.

Golf and equestrian events also relied on Credit Suisse money, as did the Swiss Sport Aid Foundation, which backs talented young athletes in minority sports.

"Our sponsorships reflect our passion for excellence, sustainability, and partnership," Credit Suisse boasts.

The Neue Zurcher Zeitung newspaper said that no matter how much Credit Suisse got embroiled in scandals or rejigged its strategies, "the bank has always been a reliable partner for

"For the time being, we will continue our corresponding commitments unchanged," a Credit Suisse spokesman told AFP.

But UBS, which has its own portfolio of sports sponsorships focusing on Formula One, athletics and ice hockey, may not necessarily continue with the deals.

- Football focus -

Credit Suisse has been the main sponsor of the Swiss Football Association (SFA) governing body

The men's national team, ranked 12th in the world, has enjoyed some of its best years since the bank came on board.

Having only appeared at one World Cup between 1966 and 2006, Switzerland have qualified for the last five World Cups, reaching the last 16 in four of those tournaments.

The contract runs until June 30 next year. It is worth around five million Swiss francs (\$5.4 million) per year, according to Blick newspaper.

The Credit Suisse logo will stay on the national teams' training jackets and jerseys for as long as the bank exists, SFA spokesman Adrian Arnold said ahead of Saturday's Euro 2024 qualifier against Belarus.

"We had good discussions with our contacts at Credit Suisse, who assured us that the existing contracts would be honoured," Arnold said.

"We would like the partnership to continue thereafter, in whatever form."

Credit Suisse is also the main sponsor of Switzerland's bid to host the 2025 women's European Championships, and the takeover comes shortly before the hosting decision is due

The bank is the title sponsor of the Super League, Switzerland's 10-team top football division, including well-known clubs like Young Boys, Grasshopper, FC Zurich and FC Basel.

Blick said the contract runs until 2025 and is worth around eight million Swiss francs (\$8.7 million) per season.

Money goes into every club as well as the tournament, with the bank's name appearing on all team strips and on advertising boards around the stadiums.

In 2019, the bank won the naming rights for a proposed new football stadium in Zurich, where Grasshopper and FC Zurich are expected to play. But the planned "Credit Suisse Arena" has faced delays. It was due to open in mid-2022, but little progress has been made and its future now

seems even more uncertain. - Close ties to Federer -

Federer is by far the biggest name associated with Credit Suisse.

Although Switzerland's greatest sports star retired in September, he remains a brand ambassador for Credit Suisse.

The bank was on board for his transition into a post-tennis career, saying: "We look forward to many more years together".

Federer has a host of other sponsors he can fall back on, including Rolex, Lindt, Mercedes-Benz and Moet et Chandon.

Credit Suisse also sponsors the Federerinstigated Laver Cup, which features six top men's tennis players from Europe against six from the rest of the world, captained by Bjorn Borg and John McEnroe.

The Laver Cup did not respond when contacted by AFP.

- Sponsors leave, others arrive -

In golf, Credit Suisse sponsored the European Masters golf tournament in Crans-Montana and Spanish former world number two Garcia, who won the 2017 Masters.

European Masters tournament director Yves Mittaz said the contract runs until the 2024 tournament so the event is not at risk.

"There is no reason to panic," he told the Tribune de Geneve newspaper.

"That's the business of sport: sponsors leave, others arrive."

In equestrianism, Credit Suisse is a main sponsor of the Concours Hippique International de Geneve and White Turf in St. Moritz, a glitzy exclusive event featuring horse racing on a frozen lake.

Manchester United sale would accelerate review of Uefa's dual-ownership rules

ISCUSSIONS about potenchanges Uefa's rules governing dual ownership are likely to accelerate should Sheikh Jassim's Qatari bid or Sir Jim Ratcliffe successfully buy Manchester United, Telegraph Sport understands.

Aleksander Ceferin, the president of European football's governing body, revealed this month that it was considering amending its regulations to allow clubs with the same owner to play in the Champions League simultaneously. At present, such a scenario is prohibited.

The two leading offers for United are from own-not sure yet. ers with links to clubs in Ligue 1, France's top division.

Ratcliffe's Ineos Group owns Nice, in addition to the Swiss club Lausanne-Sport. The bid by Sheikh Jassim, the chairman of Qatar Islamic Bank and the son of the former Qatari Prime Minister, has raised concerns about links to the Qatar-owned Paris Saint-Germain, despite insistence he is funding the deal from his own private wealth.

Dual ownership is not currently on the agenda at the next meeting of Uefa's executive committee in Lisbon on April 4 or the Uefa congress the next day.

But club sources have indicated that it is likely to become a topic of serious discussion in the game's corridors of power should United be sold before the end of the season and the thorny issue comes in for much greater scrutiny given the parties bidding for the club.

If Uefa's executive committee voted to implement changes to the existing rules for next season, they would need to happen before qualifying for next season's Champions League gets underway in late June.

Qualifying for the Europa Conference League is due to commence in July and the following month for the Europa League. Various groups across Europe are believed to have been applying pressure on Uefa for the current rules to be reviewed.

Ceferin said in an interview with Gary Neville for his The Overlap YouTube channel that Uefa was "not thinking about Manchester United only" and that they have had "five or six owners of clubs who want to buy another club".

Uefa would likely first consult with the European Club Association (ECA) before they got to a point where the executive committee met to discuss the pros and cons of any changes. The ECA's chairman is Nasser Al-Khelaifi, the PSG pres-

"The options are that it stays like that or that we allow them to play in the same competition," Ceferin told Neville. "I'm

"We have to speak about these regulations and see what to do about it. There is more and more interest in multi-club ownership. We shouldn't just say no for the investments for multi-club ownership, but we have to see what kind of rules we set in that case, because the rules have to be strict."

Sources close Sheikh Jassim have dismissed suggestions his bid is effectively a state project ultimately funded by the Qatar Investment Authority, the gulf nation's sovereign wealth fund estimated to have more than £370 billion of assets and which already helps to back PSG through its subsidiary, Qatar Sports Investment (QSI).

No details have yet been provided about the specific source or scale of Sheikh Jassim's wealth but sources close to his bid have expressed some surprise at the focus on Qatar given the multiclub ownership that exists across Europe.

That includes Ratcliffe, whose Nice side are currently seventh in Ligue 1. Lausanne-Sport are third in the Swiss Challenge League, the country's second tier. Another Briton, Tony Bloom, owns Brighton and the Belgian club, Royale Union Saint-Gilloise, both of whom could qualify for Europe next season.

The Red Bull ownership group were famously able to convince a Uefa panel of club finance experts in 2017 that they had created enough separation between Leipzig and Salzburg to allow both to compete in the same European competition. The two clubs competed in the Champions League this season.

*If Qatar owns Paris St-Germain how can it buy Manchester United?

Although Sheikh Jassim is said to be financing his bid via private wealth, his close familv links to Qatar's ruling elite have raised questions about the source of funds. For years, his father had controlled the purse strings at the Qatar Investment Authority (QIA), the £370 billion fund which helps to back Paris Saint-Germain through its subsidiary Qatar Sports Investment (QSI).

However. his bid group has repeatedly claimed the funding for the club is independent of the QIA. Aides last week told United they are confident they will not fall foul of rules prohibiting clubs with the same owner playing in the same competition.

Even if state funding was proven, Uefa president Alesander Ceferin may be willing to turn the other cheek. He said this month that European football's governing body was considering a rule change that would allow clubs with the same owner to play in the Champions League simultaneously.

*How would their regime differ from the Glazers?

After scolding Manchester City for years over their Abu Dhabi ownership, some fans remain uncomfortable with the prospect of Mid-

dle East funding. Many others, however, are salivating at the prospect of a debt-free regime, more transfer backing and redevelopment promises regardless of the source. The end of the Glazers

means the end of levertotal commitment - including purchase price - is estimated at £7 billion under the Qataris' vision. At the heart of the bid is a promise to end

long-standing uncertainty over how the club would finance a new stadium and training ground, the two of which could cost up to £2 billion. United have appointed master planners for both projects but they are effectively favouring redevelopment and

expansion of their existing Old Trafford stadium although that is currently being estimated to be an eight-year project.

Whether a new stadium, built on land adjoining Old Trafford that the club mostly owns, would be more appealing for a new owner remains to be seen. The club have vowed to keep consulting closely with supporters on what is likely to be a hugely emotive issue.

The Nine Two Foundation has pledged in a press release that it will "invest in the football teams, the training centre, the stadium and wider infrastructure, the fan experience and the communities the club supports".

How Taifa Stars could line up to confront Uganda

AFTER a crushing 2-0 home loss to Algeria, which followed the promising 1-1 away draw with Niger in the 2023 Africa Cup of Nations Qualifiers, this is where the campaign starts getting serious for coach Adel Amrouche and Tanzania.

The AFCON 2023 Qualifiers' match day three and four against Uganda promises to be the sternest test of Tanzania's credentials as it bids to secure a place in Africa's biggest football spectacle for the third time in

Today, Taifa Stars, who currently occupy the third spot in Group F of qualifiers, will be entertained by a bruised Uganda side, Cranes.

Uganda is also looking for its first victory of the qualifiers following its loss to Algeria which was followed by a share of the spoils with Niger.

Uganda will host its game against Tanzania in Egypt. Failure to have an approved stadium that fits international standards meant CAF forced Uganda to host their home games in Egypt.

The Federation of Uganda Football Associations (FUFA) opted for Suez Canal Authority Stadium in Ismaily, Egypt for the Match Day Three encounter before the two teams face off again four days later in Dar es Salaam.

The back-to-back games represent Amrouche with his first challenge since his appointment. Amrouche is well aware Uganda has been a familiar thorn in Taifa Stars' record.

Amrouche has some decisions to make over who makes his starting XI for the tie. Should he maintain the same backline that played the last two games against Libya and Uganda?

What attacking blend is best suited to cause Uganda problems in defense?

Amrouche and his technical bench have assembled a good mix of youth and experience for the task, and should - hopefully - deploy the right resources on

The Belgo-Algerian knows this is not the right time to experiment so he is likely to stick with familiar faces in the starting lineup.

Between the posts, there is no doubting Aishi Manula's role in this one. Beno Kakolanya is second to Manula at Simba SC while Metacha Mnata has hardly played this year since moving from Singida Big Stars to Young Africans, alias Yanga.

In the fullback positions, the performances of David Luhende and Kibwana Shomari against Uganda and Libya make them worthy of repeat selection.

Dickson Job and Bakari Mwamnyeto are first-choice central defenders, but Ibrahim Abdallah 'Bacca' presented a strong case in his first international game for Yanga last Sunday.

The Zanzibar-born central defender was preferred ahead of Job by Yanga's head coach Nasreddine Nabi in the club's 2022/23 CAF Confederation Cup's Group D home clash against US Monastir.

Himid Mao, Mzamiru Yassin, Feisal Salum, and Novatus Dismas among others are options in midfield. The first objective for Tanzania is to control the midfield so either Mao or Mzamiru start alongside Feisal and Novatus Dismas.

The strength lies in what this team can do going forward, so the squad ought to maximize that rather than preach caution by going for two attack-minded
