Somalia and EAC team set to start membership talks

NEGOTIATIONS for the membership of Somalia in the East African Community (EAC) will be held from August 22 to September 5 in the EAC head offices.

Dr Peter Mathuki (pictured), the secretary general, made this remark here yesterday in presenting an annual address to key organs of the EAC, where the issue of admission of the Federal Republic of Somalia into the bloc was also addressed.

The EAC secretariat and the council of ministers have organised the talks, after which the relevant report will be submitted to the council for consideration.

It will then land before the summit for adoption or otherwise, thereupon giving the next direction in the quest for membership, he said.

In a presentation dominated by trade issues, he said that national level protectionism by applying non-tariff barriers (NTBs) is a key factor impeding the growth of intra-regional trade.

He said the region is working to eliminate

NTBs with 26 NTBs resolved as of June 2023, out of the 33 that were still pending at the start of the new financial year, he stated.

Seven NTBs remain outstanding at different levels of resolution, he asserted. affirming that intra-EAC trade ratio to EAC total trade stood at 15 percent in 2022.

It was inching towards 16 percent in January and 19 percent in February, thus 2023 has indicated a positive trend with recorded o growth of total EAC trade, he

"To facilitate free movement of goods, partner states have effectively eliminated NTBs as they arise and have cumulatively eliminated 184 NTBs with only a few remaining outstanding," he explained.

EAC total trade increased by 13.4 percent to \$74.1bn in 2022 from \$65.3bn in 2021, while total intra-EAC trade grew by 11.2 percent to \$10.9bn in 2022 from \$9.8bn in 2021, he elaborated.

"The increase is attributed to strong collaboration among partner states to promote trade, including admitting DRC, the timely resolution of NTBs, enhanced trade facilitation initiatives and harmonization of 2,568 East African standards," he declared.

PCCB holds three court accountants

THE Prevention and Combating of Corruption Bureau (PCCB) in Mtwara Region have detained three accountants of the High Court registry here for suspected embezzlement of more than 600m/- in family inheritance funds.

Jumbe Kaboba, the acting regional PCCB head, told journalists here yesterday that during the past three months they



received reports on inheritance money left for beneficiaries of deceased family members had been embezzled under High Court custody.

An in-depth investigation showed that the three accountants were involved in transferring the money belonging to various beneficiaries.

He said the suspects were detained for suspected embezzling of more than 600m/- of inheritance funds belonging to beneficiaries whose cases were still before the court.

PCCB has already finalised the relevant investigations on 234m/- apparently embezzled by court staff, he said, noting that seven case files had been deposited with the Director of Public Prosecutions (DPP) for approval to take the suspects to

THE National Health Insurance Fund (NHIF) has recorded insufficient revenue collections for three consecutive years, with a surge in expenditures, putting its operations under threat of bankruptcy.

Jerry Silaa, chairman of the Public Investments Committee (PIC) of the National Assembly, made this observation shortly after committee members met with the management of NHIF.

In the 2019/2020 financial year the fund had a deficit of 49bn/-, in fiscal 2020/2021 the deficit climbed to 109bn/- and in fiscal 2021/2022 it hit the worrying ceiling of 204bn/-, he stated.

"The fund's financial statement for the period ending June 2023 shows that it will record a deficit of 152bn/-," he said, affirming that NHIF assets decreased from 1.2trn/- to 1.09trn/-, while its capital has decreased from 1trn/- to less than 700bn/-.

you can see that it is likely to die," he stated, underlining that the government is working on a strategy to ensure universal health care (UHC) as a remedy for the situation.

Once the bill is passed by the National Assembly, NHIF will be responsible for implementation of the plan, he specified, noting that NHIF membership had increased from 1.05m to 1.35m during the period under review.

Its efficiency is not the same as in past years when it had fewer members, he said, explaining that committee members had a detailed discussion with the fund management on the issue.

The committee has prepared a document for presentation to the Speaker's Office, consisting of opinions and advice to the government to ensure the fund operates profitably, "with excellent performance that will ensure its sustainability."

Journalists seek full presence in accreditation board, council

MEDIA practitioners are requesting for their full presence in proposed two organs, including the accreditation board and independent media council, as part of implementation of the Media Services Act (MSA) 2016 and its amendments.

Tanzania Editors Forum (TEF) chairman Deodatus Balile gave the remarks yesterday during the virtual meeting to review the recent parliamentary amendments of the MSA 2016, suggesting the best way of implementing the law, as well as formulation of the regulations.

Balile further said: "As we are looking forward, all these media organs must be represented by practicing journalists, specifically those with commendable skills and experiences".

"I am expecting the chairman of the accreditation board to be a journalist to be a practicing journalist who is body of organs.

with much experience and skills or a accredited, we expect members of the retired journalist who has gone to the newsroom," he said.

He called for media practitioners to ensure that they suggest what types of the people they want to be included in these two organs, ahead of their formations.

"We need to suggest criteria of who we want to be in these organs, while we are learning from other countries," he said.

The MSA 2016 and its amendment, requires the formation of the accreditation board, which will deal with the registration of journalists and the media council, which will deal with all issues pertaining to ethical issues of practicing journalists.

He said on the media council, members of the media should also, through their discussions, suggest what types of people they may wish to be included.

'I expect the chairman of the council

council from universities also to be journalists as well as those coming from public and private media umbrellas," he

Explaining on the amendment of the MSA 2016, Balile said the amendments have raised hopes to media practitioners and investors, although much is needed to be worked on to ensure safe media space in Tanzania.

Jesse Kwayu, member of TEF, is worrying on how media practitioners are expected to influence and participate in the formation of these two organs.

He said journalists may have the influence in the expected media council, but he is also worrying that it is very tricky.

Kwayu has also suggested the consolidation of the media governing board to become one instead of a diverse

TFS allots 62.7bn/- to scale up forests' conservation

THE Tanzania Forest Services (TFS) is set to commence implementation of three major projects worth 62.7bn/- in the current financial year.

Prof Dos Santos Silayo, TFS Conservation Commissioner unveiled this yesterday here when speaking to journalists on the organisation's performance and its future plans.

He said the move is meant to scale up conservation and development of the forest sector in the country.

The projects, where the funds accrued from the development partners, include the 'Integrated Landscape Management in the Dry Miombo Woodlands of Tanzania (DSL-IP), Building the resilience of forest biodiversity to the threats of climate change in Tanzania's nature forest reserves and Integrated Approach to Sustainable Cooking Solution.

Prof Silayo said implementation of the projects was due to a mutual understanding and good cooperation between Tanzania and other countries, unveiling that the Integrated Landscape Management in the Dry Miombo Woodlands of Tanzania (DSL-IP) was spending a total of \$6.9million.

"The key objective of this project is to help curtail and reverse the negative trend of land degradation and loss of biodiversity in the degraded areas of the Miombo forests in western Tanzania by using an integrated landscape management approach," he said.

The Integrated Approach to Sustainable Cooking Solution, according to Prof Silayo, the project involves more than 34.3bn/-(euros12,500).

"This project aims to promote sustainable forest management and wood-fuel production in rural areas with an overall aim of enhancing environmental sustainability, in particular the sustainability of the woodfuel value chain," he explained.

Together with that, he communicated that the package includes implementation of the third project, dubbed: "Building the resilience of forest biodiversity to the threats of climate change in Tanzania's nature forest reserves. The initiative is worth around \$4.8 million.

"It focuses on carrying out activities to build the capacity of forests of nature reserves to withstand the negative effects of

climate change by building forest protection infrastructure, strengthening activities to increase income through eco-tourism, together with other activities meant to heighten incomes to the communities surrounding forests."

Informing about the TFS's achievement in developing the forest sector during the 2022/23 fiscal year, the Don stated that TFS had managed to establish one major tree farm in Makere area of Kasulu-Kigoma, occupying at least 65,000 hectare.

"Apart from establishing the tree estate, we also managed to expand two farms, including Mtibwa (12,000 hactare) and Pagale range and Longuza at 400 hactares extent," he expressed.

During the past fiscal year, he added that TFS had successfully produced 25.9 tons of tree seeds and planted a total of 32,735,653 seedlings of numerous tree varieties at different areas of the 24 public tree farms available across the country.

"Other seeds were distributed to the relevant stakeholders in the private sector in the country," he added.

He said so far, TFS has managed to plant a total of 6,909 new trees as well as replace trees at a total of 2,434 at different state-owned tree farms, noting that TFS managed to conduct a special forest inventory at a total of 42 forests (1,031,293 hectares) across the country, and later on developed the relevant management plans.

He also stated that during the period, TFS had also to upgrade 15 forests to the level of national forest parks, and other five national natural reserves forests, occupying a total of 58,216 hectares.

Last year, TFS received 4bn/- from the monies that was disbursed by President Samia Suluhu Hassan for supporting improvement of forests preservations and tourism in the country.

"With the amount, we managed to construct at least five modern entry gates at five national parks, but also, the money assisted us to construct a 97 km road, as well as a 190.5km-long tourists walking trails at 11 parks," he expressed.

He also added that through TFS's internal work plan, they have managed also to improve the country's ecology and cultural tourism attractions by rehabilitating at least 231.7km of tourist trails, and 643.54 roads within forests.

NGO provides road safety education to over 6,000 students in Tanga Region

AN international road safety non-governmental organization—AMEND has successfully implemented its road safety action plan by 90 percent which included provision road safety education to 350 pupils in Tanga Region.

The road safety action plan that aimed at improving safe and sustainable journeys in the city of Tanga was launched on November 11, 2022 by Tanga District Commissioner, Hashim Mgandilwa.

The improved road infrastructures in school areas include footpaths, pedestrian footbridges, road signs, speed humps, rumble strips, and zebra crossings.

Speaking in Tanga yesterday shortly after launching a Kids Court at Mwakizaro primary school, Manager, Amend Tanzania, Simon Kalolo said the kids' court project was purposely introduced to punish reckless drivers violating traffic rules when driving at school areas.

Kalolo said the NGO has since 2009 been working with Tanga city council in implementing and evaluating evidence-based programs to reduce incidences of road traffic injuries.

The Manager noted that Amend has been providing road safety education to students, as well as establishing road safety clubs and model courts for children, provision of training to motorcycle drivers 'bodaboda', organizing conferences for road safety stakeholders, conducting research on road accidents and preparing a road safety action plan for Tanga city.

He said they have also launched road infrastructures at Shaaban Robert, Mabawa and Majengo primary schools. He said they have provided road safety education to 3,501 pupils at Mabawa, Majengo and Shabaan Robert primary

schools as well as 3,247 students from Toledi, Kihere and Kiomoni secondary schools.

He said they have also introduced a road safety club at Usagara primary school and a bicycle safety club at Usagara secondary school, each with 20 children.

"We gave intensive road safety training to these children; they graduated and are now ambassadors. Activities of the clubs include training, road safety discussions, games, table discussions and participating in media campaigns," he said, adding a total of 950 350 motorcycle drivers have been trained on the same.

Kalolo said that in February this year, Amend distributed road safety training materials to community development officers in 22 out of 27 wards within the city. He said officers are using them to educate the public at health centres, saving and credit groups, schools, markets, and other populated areas.

The officers have so far reached approximately 6,600 people, he said

He added: "We have completed installation of pedestrian infrastructure in one area with three primary schools to reduce the speed of vehicles to less than 30km/h and give children a safe place to walk and cross.

The NGO has also conducted maintenance of damaged infrastructure facilities, especially zebra crossings in Chuma, Chuda, Kana, Masiwani and Usagara primary schools that were built in the previous phases of the project in 2019.

Since 2019, with the funding of the Foundation Botnar organization through the TangaYetu initiative, Amend organization has been working with governments, companies, development agencies, and other institutions to implement projects that target specific aspects of road traffic injury.



DC calls on members of district health centres' committees to demonstrate more accountability

MBARALI district commissioner Col Denis Mwila has called members of the District Health Centres Supervisory Committees to be accountable in their responsibilities by identifying challenges facing the sector in order to boost health services provision.

Col. Mwila made the remarks yesterday at the opening of a training seminar to Members of Health Centres Supervision Committees for Mbarali district organised by Dar es Salaam University College of Education (DUCE) of the University of Dar es Salaam (UDSM) being held here.

"You must be accountable, unless you are not appointed, you appointed yourselves. Don't be like chameleons, or the cause of creating misunderstandings among this or that person.

"Health is everything, as good health is the foundation of the nation and its human resources.

"In the world big countries like China with huge populations, US, Nigeria have developed due to the size of their populations, good health is the foundation of development," he said.

Col Mwila further said the members from his district should see the importance of the rare opportunity accorded to them, for being among 130 districts countrywide with only two provided with the training - Handeni in Tanga Region and Mbarali districts.

For his part, Prof Peter Kamuzora from UDSM Development Institute said that the aim of the training is to enhance accountability through supervision from the committee members who are there by law.

"The aim for establishing the Board and the Committee to supervise health centres and dispensaries is to involve the community on health services as they are the ones being served by them, as well as to develop skills, human resources and enhance

health services quality.

"In addition it also aims to involve the private sector after the country moved away from socialist policies," said Prof Kamuzora.

He added that at the time of independence Tanzania had a small population, of about 10 million, but every day the population keep on increasing, hence to serve these people more medical devices and drugs are needed.

For his part, Acting Mbarali District Medical Officer, Dr Jaqueline Wambaa said the training seminar will improve work performance at health centres, dispensaries and hospitals in the district as well as reducing challenges facing health service delivery.

The training is a result of research done by DUCE that identified that a large percentage do not know whether there are health supervisory committees as well as health boards.

HERBAL medical practitioner Dr Gayo Sanga has called for greater state involvement in protecting Tanzania's rare herbal plants and their use in treating patients, saying the plants are as valuable as rare minerals and gems.

Sanga said this at Sun Rise pavilion at John Mwakangale grounds here recently.

He said that Tanzania is gifted with precious medicinal plants that should be protected and the

research on their use in treating Tanzanians and foreigners.

"I am a simple Tanzanian calling for greater involvement of the state in protecting herbal plants and their use in treating our people. This kind of effort calls for exhaustive research," he said.

He said that herbal treatment of people should be part of the promotion of the tourism industry.

"Let us link the two together," he said, adding that the cardinal issue in the health sector is to save lives

state should initiate exhaustive and reduce agony and suffering.

"You see, people know me as Dr Sanga because we treat patients at our place using Tanzania's herbal plants but I am not a conventional doctor; I have never been in a classroom of a college of health sciences. The important thing in the health sector is to save lives and eliminate pain and suffering. This, we do at our place," he quipped.

He thanked the government for giving general support to alternative medicines but insisted

that the state has a special responsibility in cooperating with herbal practitioners and in protecting Tanzania's herbal plants. Some species, he said, are on the verge of extinction, saying they retain them at their botanical garden.

He said they are using ointment extracted from dendirian plant to treat bed sores, sores of diabetics and other sore linked with cancer.

He said a recent patient of public significance treated at their place is the father of Mbeya Regional Commissioner Juma Homera who lived with a stroke for seven years but now has been cured. "That the RC brought his father to us is sufficient evidence that our senior public leaders have faith in this branch of treating people" he said.

Improved agriculture is still lifeblood of Tanzania's economic development

HE swiftness with which Tanzanians have come to realise and appreciate the health, economic and other benefits of engaging in gardening and horticulture is heartening indeed.

Even the most patriotic among us will admit that, until relatively recently, the really serious horticultural business in this part of Africa was the virtual monopoly of Kenyans - and these were reaping windfalls chiefly by selling their produce in Europe and the United States.

Yet anyone who knows about Kenya and the particular spots where most commercial gardening and horticulture are conducted knows that there are numerous areas in Tanzania that could be equally important players in the lucrative business.

After all, with the advances in technology made possible in part thanks to the ingenuity, turning desert land into model vegetable and fruit gardens is no longer that much of a big deal.

But while this could run as some really big news, there has been even more heartwarming news for Tanzanian farmers in the form of promises of 'ready and waiting' foreign markets for their fruits and vegetable.

A number of banks and other financial institutions as well as agencies such as our very own Small Industries Development Organisation (SIDO) have also made pledges of financial and other assistance or support to small and medium enterprises engaged in the cultivation and processing of vegetables, flowers, fruits and other crops both for the domestic market and for export.

For instance, a specialty foods consultant from a US-based company serving as a critical link between manufacturers, importers, distributors and retailers once visited food processors in Dar es Salaam at SIDO's invitation.

assessment of Tanzania's specialty food sector including by meeting food processing firms and institutions

known to support the sector. The consultant revealed during talks with representatives of SMEs engaged in food processing that the popularity of African specialty foods in the US market - the world's largest - was rising considerably.

It was learned that the consultant warned that, though that while African specialty foods were "well supported" in the US, there were "straightforward" challenges in entering that highly competitive market. The main obstacles related to meeting quality and basic labelling and packaging requirements.

Fortunately, the US government, various local and other NGOs and private enterprises were understood to be working alongside African manufacturers to meet world market demands, embrace Africa's development efforts and show the world what Africa was really worth.

This clearly stood as a golden chance for Tanzanian farmers and entrepreneurs to seize, particularly in that ever rising numbers of local and international agencies were coming up with promises of support to those of our people engaged in various initiatives and businesses, among them horticulture.

Expert research has long shown that, properly done, serious gardening often translates into the reaping of economic, physical and mental health benefits as well as the peace of mind inherent in even merely knowing exactly where one's food comes from and having a surplus for sale.

There are strong indications that most Tanzanians now know that gardening and horticulture often pay back handsomely economically and in the various other ways mentioned and are dying to see even faster growth in the sub-sector.



HIS story walks us through the journey of one Kenyan woman who, despite facing defeat three times in her pursuit of a political seat in Nairobi's Kibera slums, remains undeterred and steadfast in her efforts to bring positive change to the neighbourhood she has called home for many years.

As the choking black smoke subsided after three days of protests in the slums, one of Kenya's biggest informal settlements, I embarked on the maiden journey in search of one resilient young woman who has emerged as a beacon of hope in her community.

She is Malasem Hamida, a indigenous popularly known by her nickname 'Mama Mazingira' (literally, Kiswahili for Environment Mother). She has vied for a Member of Parliament (MP) in Kibera three times and looks forward to vying again in the forthcoming election in 2027.

"I have so far vied for elective seats three times - in 2022 as an MP, in 2019 still as an MP during a by-election and party primary in 2017," said Hamida, adding that throughout her three trials, she has received a "wonderful experience despite the challenges".

"I have created a bigger network and the lessons I have learnt are enormous," she notes, adding: "The challenges I have faced are crosscutting. We as women come from backgrounds that don't have a lot of finance. Finance was my biggest challenge because voters are brainwashed that they must be

Hamida stood to her policies that were issues-based and at last realised that, regardless of how appealing one's policies were, one still needed money to bribe voters.

With regard to cyber-bullying, she says that it happens a lot but she has received a lot of training from different organisations that have trained her on how to respond to

"Cyber-bullying happens a lot but for me it is not a big issue. I engage in comments that I can handle and disengage immaterial things," she notes.

She said that she prepared her family well in case of any outcome: "I was both mentally, emotionally and psychologically prepared. My confidence gave them confidence

However, Hamida disagrees with the law as put in place during the last election: "The law this time was unfair to some extent because they barred anyone who went for an elective post not to be considered

'I vied three times and lost; however, I'm still hopeful'

for any nominations. I felt left out."

According to her, Kibera is an ethnic majority constituency which, to her, meant a big competition: "Coming from an indigenous minority was quite challenging for me in convincing other ethnic

majority people to vote for me." Annabel Njoki, an advocate of the High Court of Kenya, also vied for an elective post. She agrees with Hamida that finances are the biggest challenge for people vying for any political seat and even worse when it is a young person.

"The moment you announce your interest in politics in Kenya, even neighbours start looking at you as a big person. They expect handouts, they expect you to travel in big vehicles, forgetting that one needs financial support," says Njoki.

Competition from counterparts and older women is another challenge she cites as hindering young women from going for political seats.

"Young people are energetic and good at technology but are not getting the empowerment they deserve," says Njoki.

She calls upon women-led organisations to harness their networks and equip them on how to address the public that always demands handouts.

"Let these organisations back up young women with proper support and train them on how to counter cyber-bullying and how to handle the public that always demands handouts," she notes.

Njoki further reiterates that the expectation to issue handouts is, unfortunately, a demand made by about 50 to 60 per cent of fellow vouths.

"So for every ten youths I engaged with, about six to six demanded that I give them money or buy them something," she adds.

She feels that unemployment among the youths could be a reflection of systemic rot that makes a young person's quest for office much harder.

Esnahs Nyaramba, founder of Onzembe Community-Based Organisation in Kisii County and also Young Women Democrats, has been fighting for women's rights for a decade. Here are her insights on

challenges young women are facing in the political space: "Financial muscle is the biggest challenge our young women are facing when they go for these political seats. Men are always heavyweight and loaded,"

Nyaramba explains adds that when male competitors realise that a young woman is strong in the seat they are vying for, they tend to buy their spouses so as to create enmity among the youths vying for the seat.

"Sometimes these people also use a lot of threats like kidnapping one's children or selling fear when they realise that you are better than they are," she adds.

Nyaramba also noted that most party meetings are held at night, leaving women behind because in some cases most women are unable to make it at night.

"When you vie for a political seat, your life becomes a public life. The public enters your life with a couple of questions, like are you married? How many children do you have?' she savs.

Nyaramba says that one should not fear going for an elective seat no matter the circumstances: "Go for it no matter what and develop a thick lane. When it comes to threats, don't allow it to pull you down; don't let anything negative distract you."

According to UN Women's elections analyses, women in Kenya now hold 201 out of the 1,882 elective seats - representing 10.6 per cent of the elected leaders.

This is up from 172 (9.1 per cent) seats after the 2017 elections and 145 (7.7 per cent) after the 2013 national polls.

For Binah Maseno this is how she has been able to conquer her challenges while vying for a political seat. She was only 22 years old when she vied for a Member of County Assembly (MCA) seat in 2017. She vied for this seat while living in Kayole, a low-income Nairobi suburb.

She said that the violence she experienced during the campaigns was way too much for her and her parents to bear: "My parents stopped going to church because the expectations were very high."

"My mother's business was affected too because people would come and purchase goods without paying, saying that their daughter was a big person," she explained.

During her campaigns, one of her main security officers was gunned down on claims that he was a criminal. This, according to Maseno, was one of the many red flags warning her to step down since she was associating herself with him.

Maseno said so during the third African Girls and Young Women Festival organised by FEMNET that

brought together young women and girls from across Africa.

The Festival is celebrating the 20th Anniversary of the Maputo Protocol, which is geared towards redefining the rights of women and girls on the continent. According to Maseno, leadership

is not a gender role: "You don't have to be a politician to effect change, political offices are citizen offices." She explains that, owing to her

loss in the political arena, she founded Badili Africa as a civil society organisation based in the Kenyan capital, Nairobi.

The CSO boasts a digital reach in five African countries, its mandate being to cultivate and strengthen the leadership capacities of women and girls.

The organisation also encourages and supports spaces that enable grassroots women and young girls in universities and urban informal settlements to organise as leaders and participate in local development initiatives coupled with pushing for inclusion in decision-making processes.

Meanwhile, Kabarak University President Karen Cheptoo says that gender bias is the greatest challenge she is facing in her otherwise coveted position.

"I had seven male co-competitors when I was running for office, with people judging us according to our gender rather than what we put on the table," says the final-year Law

Cheptoo says that when a woman gets into the office she gets a huge following online, and if she is not careful people will bully her with all sorts of derogatory words.

"I am forced to read a lot so that I can communicate well while online. I have inspired a lot of women to run for positions next year because I tried and won," said Cheptoo, who is only five months in office.

Domestic challenges are another problem facing young women in the political arena. "Women themselves don't believe that they can lead. They would rather take the application to their husbands or brothers for the jobs and prefer to stay at home," she added.

Cheptoo, Hamida and Maseno all have one agenda: to hold other girls' hands and inspire them by making their work visible.

We need to think harder on how to develop into a giant in sports

ANZANIAN premier soccer league and various other sports clubs have time and again been embarking on the recruitment of trainers or coaches to add steam, as it were, to their chases for silverware. Very understandably so, we must say.

It is always to be hoped that the searches for and recruitment of the trainers, whether Tanzanians or foreign nationals, would genuinely help the clubs concerned realise their dreams of achieving resounding success in both local and continental competitions.Phrased little a differently, the recruitment would make sense only if it is finally seen that the appointments made were not a gamble or a trial and error matter.

There is the case of a premier soccer league club that once replaced its assistant trainer for alleged ineptitude and not having a mandatory diploma in soccer coaching.

One would have correctly wondered as to the logic behind the club's decision to appoint the assistant coach while aware that he was not qualified to occupy the post.

It would doubtless have pointed to poor leadership and the need for deliberate efforts to re-build a seriously dented image.

That ugly scenario aside, we strongly recommend that all our clubs appreciate the need to secure opportunities for home-grown trainers to attend quality advanced coaching courses because that is a must for us to grow and mature as a sporting nation. Few Tanzanian sports trainers have had the luck to attend advanced studies in any of the world soccer powerhouses, and this often explains our mediocre performances in various competitions and even

Effective promotion of any country's sports invariably calls for the training of local trainers. These should have as many chances as possible of attending quality advanced studies so that they can adapt to whatever changes occur in their respective sports and thereafter contribute more productively to the general

development of sports in the country. That some of our soccer clubs still cling to foreign coaches at the expense of local ones does not augur well for the future of our soccer, which commands a huge following.

Of late, there have been encouraging efforts to promote the sport right from the grassroots level, with Tanzanian soccer stakeholders having started a handful of soccer academies. While this is commendable, little has been done to professionally groom homegrown coaches.

It should be noted that starting soccer academies in the country will have enough impactifit goes alongside the floating of more opportunities for studies to Tanzanian coaches who will, in the end, cater for the needs of both the academies and our clubs.

With the presence of a good number of well-educated local soccer trainers, our country will likely have plenty of options when it comes to selecting head coaches for national teams and clubs, positions which largely remain the preserve of foreign coaches.

We remain convinced that it would be of little use if efforts to develop Tanzania's sports focus solely on players. The reason for this is simple and clear: the players will still need adequately qualified professionals, preferably Tanzanian nationals, to help them grow in to even better

Processes and procedures of starting a business in Tanzania

TARTING a business is a dream of many people in our society. However, dreaming and executing are different things and sometimes execution fails due to one reason or the other, including lack of useful information.

This piece seeks to guide anyone who wishes to start a business but has not yet executed their idea on some key issues for consideration or simply what to do to start a business in our country.

The first step is to register a business name in the form of a partnership or sole proprietorship which identifies you in the market. You can incorporate a limited liability company for local entity or obtain a certificate of compliance for foreign company opening a branch in Tanzania.

The registrar of the companies and business names at the Business Registration and Licensing Agency (BRELA) is the one mandated by law to register companies and business names and issue certificate of incorporation for the locally registered companies, certificate of registration for business names and certificate of compliance for foreign companies opening branches in Tanzania.

There are various advantages of incorporating a limited liability company than registering a business name which we shall point out in brief herein specifically what you need to know when you want to register a local company or business name and how to undergo the entire process.



Company formation means the process of incorporating a business in the form of limited liability company. The law recognizes that there are people who may assist another person to incorporate a company. These people are called promot-

Section 40 of the Company Act provides for a person or entity permitted by owner to established a company and complete the whole process until it starts operation. Once the incorporation and other processes are completed, then the promoter is discharged of the duty.

As a matter of practice and for the purpose of having control of duties and obligations of the promoter, only the owners or owners of the intended company are entitled to enter into binding agreement with the promoter.

Company formation is categorizes into two types: company limited by shares which are registered by the registrar of companies and company limited by guarantee depending on the objectives. Some are registered by the registrar of non-governmental organizations in the Ministry of Community Development, Gen-

der, Women and Special Groups.

Company limited by guarantee is not aimed at making profit but non-profit purposes within the community. Therefore, there are no shareholders but owners or members who jointly opted to contribute fixed amount guarantees upon either winding up or purchase of assets of the company.

Members are the guarantors of liability of the company. Most of the nonprofit organizations, clubs, and charitable organizations use this type of structure.

Company limited by shares is pure profit oriented company in whose liability is limited by share of each shareholder allocated in the company. Each shareholder's liability cannot exceed their shareholding capacity.

When a company enters into some transactions with another entity, some shareholders can stop the company from entering into transaction which exceeds the authorized share capital of the company due to the risks associated with that deal. In such a situation, the shareholders have to either to increase their shareholdings capacity or be limited within the

capacity.

In company limited by share, there are two categories: private company and public company. Private company shareholders are private individuals who agreed to trade together privately whereby transferability of shares is by agreement or arrangement between shareholders

In the public company, members should be more than seven with no limit to while in private company shareholders should be not less than two and not more than fifteen.

One of the major features of public company is that it is required to operate in a transparency manner. That is why public companies are required to publish their financial position to the public through newspapers unlike private companies.

Public companies operate through stock exchange in the sense that they are free to trade in open market. Whoever is interested in investing in a public company can do so provided terms and conditions provided are met.

deal. In such a situation, the shareholders have to either to increase their shareholdings capacity or be limited within the One important thing to note is that once a company is incorporated and issued with certificate of incorporation, its advan-

tage is that it becomes a legal entity with its own capacity either to sue or be sued or enter into contract like a human being, including paying rent or taxes and others.

Further, its liability is limited to what is found in the shareholding capacity. The only difference with human beings is that its operation or management is placed at the hands of board of director which is mandated to take care of the day to day duties of the company.

Board of directors is responsible to report to the shareholders of the company through meetings which are required to be conducted either as general meetings of the company or through extraordinary meetings.

Members of board of di-

rectors can appoint one of them or employ another person to head the company either as managing director or chief executive officer. Directors do meet on various occasions either to monitor or to oversee affairs of the company and board of directors is chaired by the board chairperson either appointed by the shareholders or from among the directors themselves.

Once the objectives of the company are known, then you are required to prepare memorandum and articles of association for the company intended to be incorporated. Memorandum of as-

sociation is a legal document which contains fundamental details of the company. One can also refer to it as the constitu-

tion of the company containing main objectives of the company, authorized share capital and shareholding structure indicating capacity or liability of each shareholder or member. It is the guiding document which manages relationship of the company with outsiders.

Articles of association are legal documents which mainly contain rules and regulations of the company. Basically, articles of association of the company contain procedures on how the company will be managed internally, the names of the first directors and what will amount to their disqualification, the meetings of the company, the quorum for such meetings in order for the resolutions to be valid to mention a few.

Once the company is incorporated, it does not automatically become operational. It has to comply with other mandatory sectorial requirements like registration of company or business name with the Tanzania Revenue Authority (TRA) for Taxpayer Identification Number (TIN) for the company and the directors or partners in the case of a business name.

After getting TIN, the next step is to acquire a business licence which depends on the type of business. Generally, companies with activities of national and international link such as real estate, tour operation, cargo handling and so on are required to process their business licences from BRELA while those intending to carry businesses of local nature such

as law firms and court brokers can obtain their licences from the nearest municipal council.

Sometimes, depending on the nature of the intended business, for example tour operators are also required to obtain tour operators licence from the Ministry of Natural Resources and Tourism before obtaining the main business licence from BRELA.

There are also other mandatory requirements like registration with the Occupational Safety and Health Agency (OSHA), National Social Security Fund (NSSF) and Workers Compensation Fund (WCF).

Currently, registration of companies is being done online and one can do it at the comfort of their home or office. However, one still needs guidance of a lawyer in matters such as drafting of memorandum and articles of association or a partnership deed in case of a business name.

ENYA'S fight for food security may have just gone 'Old School' as Egerton University dons win a grant to help bring back a pre-colonial delicacy that was gradually sliding its way off consumers' plates.

Their project, dubbed 'Exploring Potential of Togotia (Erucastrum arabicum), a forgotten African leafy vegetable for nutritional security and climate adaptation in Kenya,' won the grant in October last year in a bid to help farmers and consumers realise the importance of the crop that many, today, term as a weed.

According to the project's lead researchers, Togotia falls among the forgotten African leafy vegetable (fALVs), which have been ignored in formal research and policy and their nutritional values

The project focuses on Togotia's nutritional value and hardy nature compared to other vegetables such as cabbage, kale and spinach that are exotic to Kenya

It involved the expertise of Prof. G Mendiodo (University of Nottingham), Dr Maud Muchuweti (University of Zimbabwe), Dr Miriam Charimbu (Egerton University) and Dr Charles Kihia (Egerton University).

The grant, worth Ksh 4.9 million (about USD 37 000) was awarded to the institution by the Global Challenge Research Fund (GCRF) UK.

"Togotia and many other traditional vegetables have their roots embedded deep in the pre-colonial era, where they formed a daily delicacy for many. However, the colonial period brought exotic crops that quickly became a favourite for many, majorly due to their high market demands," Kihia told IPS.

Between 1960 and 1980, these exotic vegetables flooded the local markets, especially in towns, thus relegating Bogota and other traditional vegetables to the rural areas.

And, due to high market demand for the exotic vegetables, farmers in the villages also transitioned to cash crop farming, a move that saw Togotia gradu-

Pre-colonial delicacy could boost food security amid climate change

However, the current global changes in climate conditions have seen many farmers suffer the consequences of unpredictable weather patterns that have seen crops dwindle in the local markets.

Most food crops that serve towns come from rural areas where farmers rely heavily on weather patterns to meet the market demands.

Kenya is currently facing one of the worst drought periods in its history, making food production a burden for the farmers who town dwellers rely on for their needs. Lack of rainfall means low food production, which leads to high food prices in the market.

"The drought has led to a scarcity of many vegetables, such as kale and spinach, which have the highest demand in town. The ones that we are getting right now have tiny leaves, which customers complain about," said Nancy Mulu, a local grocer in Nairobi

"We are forced to sell them in small bunches at high prices due to the trouble we go through to get them," she explained to IPS.

"The only traditional vegetable I sell in my shop are Terere (Amaranthus), Managu (Solanum), Saga (Cleome), and Kunde (Vigna). I have never come across a fellow vendor selling Togotia in town. They are mostly found in the village areas, and even there, many still treat them as weed," she added.

Despite the rains that recently kicked off, the meteorological department warned farmers that it may not be enough to meet their agricultural demands.

Charimbu told IPS that if embraced, Togotia will be important in helping the country meet both the supply and nutritional demand of the people.

"Emergence and intensification of climate change with associated unreliable rainfall (either too much or too little) limit capacity of local farmers, not only to produce their own food but also surplus for sale, resulting in impoverishment," she explained.

"The high cost of farm inputs required for the exotic vegetable also makes them an expensive and unsustainable venture during draught seasons such as the one the country is experiencing. Being a hardy crop, Togotia easily has an edge over them."

"They flourish in marginal soils, require limited agrochemical input, are fast maturing (takes two weeks), widely occurring and are resistant to many local pests, and hence are ideal candidates for sustaining nutritional and household food security even during such draught periods, Charimbu added.

In major crop production towns like Molo and Kuresoi, known for maize, potatoes, carrots, onions, kales, and cabbages, Togotia is usually considered a weed and farmers prefer to get

rid of it or feed it to the livestock. Few people in the area consider it a food crop.

From their analysis, the dons found out that apart from being hardy, Togotia was a rich source of vitamin C, iron, zinc, protein and calcium, which are important for the human body.

Kihia believes that the project will not only help to redefine the current understanding of the use and ecology of Togotia but also identify and develop appropriate agronomic cropping protocols suitable for adoption among small-scale farmers in Kenya and elsewhere.

"For a farmer with a healthy crop of maize targeted for sale in the lucrative Nairobi market, it is a weed. But when the same farmer hires a number of locals to do weeding at his farm, they remove the weed and eat it. Similarly, when there is massive crop failure and the maise crops do poorly, this weed becomes an important survival crop for the farmer and the community," Kihia added.

In counties like Baringo, which falls among the hardest hit by the drought, Togotia is one of the residents' main vegetables to supplement their needs. If this can be incorporated in other drought-prone areas like Turkana, Marsabit and Samburu, it will go a long way in helping address the recurring food crisis in Kenya.

"Incorporation of Togotia and other fALVs into current land-use will not only increase farms agrobiodiversity and household food diversity but also provide important forage crop for bees and other pollinators that are disappearing from Kenyan landscapes," he concluded.

The project will involve setting up demonstration farms at the university and sensitising local farmers and communities around on their importance in helping supplement their nutritional needs.

They aim to produce Togotia varieties that are responsive to environmental needs in terms of resistance to pests, diseases, and drought.

UE to insufficient pressure, water does not make it up Elliot Escobar's house in the Mexican municipality of Matías Romero, where he lives on the second floor, so he pipes it up with a hose from his sister's home, located on the first floor of the house shared by the two families.

"I store it in 1,000-liter tanks, which last me about a month. We recycle water, to water the plants, for example. In the municipality people don't pay for the water because there is none, it comes out of the pipes dirty. It's a worrisome situation," said the 44-year-old

Matías Romero, with a population of just over 38,000, sits along the Interoceanic Corridor of the Isthmus of Tehuantepec (CIIT), a megaproject under the responsibility of the Ministry of the Navy and one of the three most important projects of the current government, together with the Mayan Train, in the southeastern Yucatán peninsula, and the Olmeca refinery system, in the state of Tabasco, also in the southeast.

The demand for water from the CIIT works is causing concern among the local population, already affected by water shortages, explained the lawyer, who shares the house above his sister's with the other two members of his family.

"The project will require water and electricity, and our situation is uncertain," Escobar said. "Everything has to have a methodology, be systematized, the infrastructure must be consolidated. In Salina Cruz (another stop along the megaproject) there have been complicated water problems in the neighborhoods; it's a problem that's been going on for years. There are too few wells to supply the local population."

The lawyer is a member of the nongovernmental Corriente del Pueblo Sol Rojo and spoke to IPS from his home in the state of Oaxaca, some 660 kilometers southwest of Mexico City.

In the area, the local population works, at least until now, in agriculture and cattle, pig and goat farming. The municipality is also a crossing point for thousands of undocumented Central American migrants who arrive by train or truck from the Guatemalan border en route to the United States.

Despite the fact that water is a fundamental element of the megaproject, CIIT lacks a water plan, according to responses to requests for access to information submitted by IPS.

The works are part of the Tehuantepec Isthmus Development Program that the Mexican government has been executing since 2019 with the aim of developing the south and southeast of this country of some 129 million inhabitants, the second largest Latin American economy, after Brazil.

An inter-oceanic transformation

The plan for the isthmus includes 10 industrial parks, and the renovation of the ports of Salina Cruz, on the Pacific Ocean, and Coatzacoalcos, on the AtlanMexico: Where megaproject is blamed for water scarcity

tic, connected by the Isthmus of Tehuantepec Railway, which is under reconstruction.

It also includes the modernization of the refineries of Salina Cruz, in the state of Oaxaca, and Minatitlán, in the state of Veracruz, the laying of a gas pipeline and the construction of a gas liquefaction plant off the coast of Salina Cruz.

The development program covers 46 municipalities in Oaxaca and 33 in Veracruz, over a distance of some 300 kilometers. The 10 industrial sites, called "Poles of Development for Well-Being," require 380 hectares each.

Researcher Ursula Oswald of the Regional Center for Multidisciplinary Research at the public National Autonomous University of Mexico told IPS that she proposed a comprehensive model for analyzing all aspects of the megaproject.

"The most urgent thing is to make a master plan, which must have a water plan before other

processes. It is crucial, before introducing industries. And each one must have very rigid zoning, to avoid pollution of water sources, and not to repeat the chaos we have seen in the north," she said from the city of Cuernavaca, in the state of Morelos, next to the Mexican capital.

The researcher said it is necessary to answer questions such as "which basins and aquifers (can be used), and how does the surface water interact with the groundwater?"

The government of Andrés Manuel López Obrador, in office since December 2018, is looking for companies to set up shop in the south and southeast of the country, in an attempt to attract investment and generate jobs in these areas, the country's poor-

But one obstacle to development lies in the logistics of moving the products to the U.S. market, the magnet for interested corporations. Other problems are the lack of skilled workers

and the environmental impact five are in deficit, accordin a region characterized by rich biodiversity.

Some recent cases show the difficulties of such initiatives. The U.S.-based electric car-maker Tesla chose the northern state of Nuevo León in March to build its factory in Mexico, despite López Obrador's interest in having it set up shop in the south.

Between 2020 and 2022, the CIIT's budget was 162 million dollars in the first year, 203 million dollars in 2021, and almost double that in 2022: 529 million dollars. But in 2023 it has dropped to 374 million dollars.

Independent estimates put the program is to increase total investment required for the CIIT projects at 1.4 billion dollars, although there is no precise official figure.

Water pressure

The megaproject puts greater pressure on water resources in a region where water is both abundant in some areas and overexploited.

Of the 21 aquifers in Oaxaca,

ing to figures from the National governmental Water Commission (Conagua). Among these are the aquifers of Tehuantepec and Ostuta, which have suffered a deficit since the last decade and are on the corridor route.

In Veracruz, of the 20 water tables, five suffer from excessive extraction, such as the one in the Papaloapan River basin, also in the CIIT area.

One of the five objectives of the development biodiversity and improve the quality of water, soil and air with a sustainable approach.

Meanwhile, CIIT's regional program stipulates that the Ministry of the Environment and Natural Resources must guarantee water for both the incoming companies and the local residents.

However, the Auditoría Superior de la Federación, the national comptroller, found no information on increasing biodiversity or improving water, soil and air quality by 2021. Furthermore, it did not have sufficient data to assess compliance with the five

CIIT objectives. For the provision of the necessary water, CIIT identified in its 2022 progress and results report the sale of water rights among users, the transfer from the Tehuantepec aquifer, despite its deficit, and deep wells, the use of dams, rivers or the construction of a desalination plant, in addition to the consumption of treated wastewater.

Indigenous people A May 2021 document on consultations with indigenous communities in the Oaxaca municipality of Ciudad Ixtepec, also along the corridor, seen by IPS, suggests studies on the use of recycled and treated water for some industrial processes, the promotion of the use of rainwater for green areas, and the introduction of programs to raise awareness and foment responsible water use.

The megaproject's area of influence is home to some 900,000 indigenous people from 10 different native peoples. But the consultation process, free of interference, prior to the development of the works and with sufficient and timely information, only covered less than one percent of the native

population.

The right to a healthy environment is another aspect of a context of human rights violations. At the end of July, the Civil Observation Mission, made up of representatives of non-governmental organizations, found violations of access to information, free participation and freedom of expression.

For this reason, Escobar stressed the need for federal authorities to pay close attention to the proiect.

"Water is not a commodity, its supply has to be guaranteed to the local population," the lawyer said. "We have to invest heavily in water and develop awareness about it. We do not understand their concept of modernity, they think it is only about building megaprojects. There is going to be an environmental problem in the medium term."

For her part, Oswald suggested going beyond the traditional focus on attracting investment.

"No company is going to invest if it does not have guaranteed (water) supply, land, a way to export its merchandise on the sides of both oceans, and labor," said the researcher. "It is necessary to link water, cost, social issues, and which indigenous groups are in the region. What other mechanisms do we have to provide water? Who has control in the region? That is basic to understanding the conflicts. It is a crucial sociocultural issue."

Fragility and poverty in sub-Saharan Africa: Two sides of the same coin

N 1990, about half of the population in Sub-Saharan Africa and South Asia and two-thirds in East Asia and the Pacific were living in extreme poverty (defined as living on less than what today amounts to around \$2.15 per person per day).

In the three decades that followed, these three regions have followed quite different development paths. In 2019, 35 percent of the population in Sub-Saharan Africa were estimated to be living in extreme poverty, compared to 9 percent in South Asia or 1 percent in East Asia and the Pacific.

Why has Sub-Saharan Africa been left behind? What explains the sluggish progress in poverty reduction in the region?

The role of fragility, conflict, and violence in stifling development

Fragility, conflict, and violence, or, more generally, the lack of peace and security, is one of the key barriers to poverty reduction in Sub-Saharan Africa.

The World Bank's list of fragile, conflictaffected, and violent (FCV) countries in 1998, the year with the earliest available data, indicates that 13 of the 24 FCV countries worldwide were in Sub-Saharan Africa (54%, or slightly over a half).

By 2021, the year with the latest available data, the number of FCV countries in Sub-Saharan Africa had increased by six, and the region still accounted for roughly half of all FCV countries in the world (19 of the 37 FCV

Even before Russia's invasion of Ukraine in 2022, the world had already become more violent over the years, largely driven by increasing counts of FCV countries in Sub-Saharan Africa and the Middle East and North

These two regions do not only have the most cases of fragility, conflict, and violence, but also the worst trends in extreme poverty.

Thirty out of the 48 countries in Sub-Saharan Africa (almost two-thirds) have been designated as a fragile, conflict-affected, or violent (FCV) country at least once since 1998; in the Middle East and North Africa, it is 7 out of 14 countries (or a half).

Fragility and poverty in Sub-Saharan Africa

Or could it be that the lack of peace in Sub-Saharan Africa is because of poverty (and inequality) in the region? Studies have suggested that grievance increases the risk of conflict, and grievance may occur when individuals or groups of individuals are socially, politically, or culturally deprived.

Conflicts are more likely when deprivation occurs along the lines of ethnicity, religion, or geographical location. In fact, high ethnic and cultural diversity in Sub-Saharan Africa increases the proclivity for such conflicts.

A negative relationship between income status and FCV status, supports drives conflicts. On the

tant to stress that this is not an automatic mechanism: eight countries have always been low-income countries but were not FCV countries in 2019.

Also, two of them (Rwanda and Uganda) have never been FCV over the entire period for which data are available. Overall, poverty and fragility can re-inforce each other and create a vicious cycle or a trap.

There are other factors that might jointly explain the high levels of poverty and fragility in Sub-Saharan Africa, such as low schooling attainment, high inequality in educational outcomes, and the lack of decent jobs. Improving educational outcomes for all (i.e., SDG 4) and increasing job opportunities for all (i.e., SDG 8) would therefore be priority areas in Sub-Saharan Africa that could potentially break the povertyfragility trap that the region seems to be stuck in.


A highly educated population is more likely to be tolerant, while education and employment opportunities offer the most likely route out of poverty. However, these policy actions are more long-term in perspective, and require peace and stability to be effective.

EALTH financing is one of the major challenges in developing countries, including Tanzania. This is all about financial constraints, the inefficient allocation of health sector resources and a lack of management capacity.

The health financing system suffers from segmentation, high out-of-pocket expenditures (OOPs) and inefficient use of resources, as result, this is led to poor healthcare services.

Furthermore, it is dominated by taxand donor-funded health delivery, with a modest proportion of the population enrolled in social, community, or private health insurance.

It was due to the above reasons, the Benjamin Mkapa Foundation (BMF) is now embarked on real estate investment as an alternative source of health financing.

The Health Plaza is a real estate investment innovation done by Imara Horizon Company (IHC); a sustainability arm of the Benjamin William Mkapa Foundation. It is a new addition into Tanzania's health sector.

ers will be hired to institutions for health-related issues such as mini hospitals, pharmacies, and medical supplies shops selling CT-Scan and MRI machines and laboratories.

She said that financing the healthcare system has always been a problem in many African countries just like it is in Tanzania.

Ndebagenga said established in 2006, the foundation's intention is to improve human capital development, which is a critical building block in achieving resilient and sustainable

health systems in resource-constrained settings like Tanzania.

"Our future plan is to have more sources of revenues to generate income in order to sustain health financing and people uplift in future," she said.

BMF through Imara Horizon is entitled to oversee and manage the construction of Health Plaza and the income from the investment is used in health financing.

Apart from that, the foundation collaborates

with the government to recruit health staff and employees, especially in rural areas where there is poor infrastructure.

When laving the foundation stone of the Benjamin Health Plaza recently in Dar es Salaam, Dr Mwinyi challenged both the Benjamin Mkapa Foundation and the Imara Horizon Company to find ways of creating more technological innovations and being a health solution incubator.

He said the move, among others, will strengthen research and development functions which will inform the government and other valued partners.

"It is through his vision of a sustainable and resilient institution that we, the governance board of the Mkapa Foundation, saw the need to start an investment company, the Imara Horizon." he said.

"I would like to impose a challenge to the Imara Horizon Company, to shift their focus beyond infrastructure. Invest your resources into providing solutions for the health sector in Tanzania, since this was the striving

THIS IS HOW DIGITALISATION EMPOWERS **CONSTRUCTION TO MAKE MORE WITH LESS**

here's perhaps no industry where even the tiniest inefficiencies can have a major detrimental effect on the bottom line more than in construction. A project's inherent complexity, the industry's strict regulations, as well as continued macroeconomic uncertainty make maximizing jobsite productivity paramount to construction's success.

Yet, many construction firms still haven't embraced technology to maximize project efficiency. And as a massive worker shortage continues to plague the industry. it's arguably more important than ever that construction leaders turn to digital solutions to get more done with fewer resources.

In my nearly 15 years in construction, I've witnessed the evolution the industry has embarked on with technology. I've seen firsthand as contractors moved away from paper-based workflows in favor of digital ones-and the exponential benefits that have resulted. And in my current role as a director of partnerships at construction technology company Bluebeam, I have a frontrow seat for how the continued digitalization of the industry is solving some of its most complex problems, all while evening the playing field for even the smallest contractors to compete with

some of their larger counterparts. Still, I also understand why many in the industry remain wary of adopting digitalization and new technology.

The market is flooded with solutions, making it dizzying when it comes to trying to understand what will work for a business' needs. Moreover, change is hard. When you have a tried-and-true process that has worked for your business for a long time, it can be difficult to shift course and adopt something new-especially if the new technology is something you don't fully understand.

The good news: At the same time, it's never been easier to embrace new construction technology. The competitive landscape ensures that the best, most efficient solutions are being made. And new distribution and business models for many of these new solutions ensures that you can test a new technology before a broader implementation at little to no initial upfront cost.

Here are three ways construction business leaders can approach adopting new digital tech-

Adopting technology for construction applications requires a certain amount of consideration and preparation. Still, don't delay your steps too much that you perpetuate continued inefficiencies.



The constraints on time and efficiency on your crews are most likely here to stay for the foreseeable future, as skilled tradespeople will be in high demand for some time amid an industrywide worker shortage.

The construction industry will need to attract an estimated 546,000 additional workers on top of the normal pace of hiring in 2023 to meet the demand for labor, according to a February 2023 report from Associated Builders and Contractors, an industry trade group.

These trends point to two things: (1) continued inefficiencies may lead to worse and slower outcomes-in other words, you will remain in "status quo" mode, not being able to improve output-and (2) as your teams see these inefficiencies, they may become more likely to find an employer who is more "tech ready" than their current employer. This second topic is even more detrimental, as it could lead to further workload and backlog challenges.

In short, get started. Sign up for a demo of a piece of hardware, equipment or software that you think might help your company. There might be some sort of demo software to try for a couple

weeks or a hardware or tool that Over the years, the technology allows you to borrow or rent for little to no upfront cost. This may seem counterintuitive, as there are so many other things on your plate-but, in my experience, construction managers who devote some of their time to finding more efficient ways to work through technology tend to be more able to navigate changing environments more effectively.

Not every product will work for your firm, regardless of what you hear. The challenge here for all construction management experts is to find the tech stack that will work best for their situations. Some vendors provide spectacular products for interior finishing solutions, but are weak for mechanical, electrical and plumbing (MEP) applications. Others are great for enterprise customers, whereas still more are designed with small-to-medium sized businesses (SMB) in mind.

One of the benefits of this process is that you might be able to skip some steps, as you may be able to adopt solutions that others had to figure out for them-

An example of this is reality capture (LIDAR, or Laser Scanning). Twenty years ago, this technology was largely used by surveyors and geomatics experts and required special training.

has gotten better, smaller and faster. Now, it is much easier to get started with reality capture than it was even 10 years ago. You wouldn't have to grow with the technology as others had to.

You can get started now and benefit from the many iterations that have brought things to where they are. The same holds true for many other digital construction workflows. Take some time to find the current state of a workflow that is important to you, learn whether there might be a more modern way to approach it, confirm whether that solution applies to your work situation and, if so, move forward.

Despite its reputation as a laggard, the construction industry is doing some great things with technology. Even if you feel like you're "behind," it's likely you're much farther along than you think. Every construction manager that I have met is vetting, adopting and/or using new technologies. Still, there is a long way to go to get more work done more efficiently.

In the end, it's important to give yourself, your colleagues and your project stakeholders a little bit of credit for the good work that they have been doing to improve the state of digital

US mortgage rate hits 7.16 per cent, highest since 2001

NEW YORK

The US 30-year mortgage rate rose to 7.16 percent last week, matching the highest since 2001 and crimping both sales and refinancing activity.

The contract rate on a 30-year fixed mortgage rose 7 basis points to 7.16 percent in the week ended Aug. 11, according to Mortgage Bankers Association data out Wednesday. The gauge of homepurchase applications slipped for a fifth-straight week to the second-lowest level since 1995.

The latest jump in borrowing costs presents a fresh headwind for the housing market, just as the sector had been showing signs of finding its footing. The impact from high mortgage rates is two-fold: it restrains demand and keeps many Americans who are sitting on lower mortgage rates from listing their homes.

A lack of homes listed for sale are also pushing prices higher, with recent price gains helping the US housing market erase the roughly \$3 trillion it lost in value during the past year's slowdown, according to Redfin Corp. Price

are squeezing affordability even more.

"Many households that would like to move are trapped right now," said James Knightley, ING's chief international economist. "Consequently housing supply has fallen just as rapidly as housing demand, hence why prices have stabilized and are moving higher again in several areas."

Higher rates could exacerbate inventory issues as owners seeking to move confront the prospect of giving up much lower rates. About nine in 10 owners with mortgages have interest rates under 6%, according to Red-

The Federal Reserve's efforts to tame inflation through higher interest rates led to a rapid deterioration in the sector last year, dragging down economic growth. Existing-home sales have remained tepid amid limited supply, but new-home sales have rebounded, supported by more available inventory.

The pickup in the housing market has fueled more optimism 75 percent of all retail residential

Some of Idaho's wildlife between Lucky Peak and Idaho City will soon have another way to cross State Highway 21.

The state's first wildlife overpass is under construction, with a finish date of October. Scott Rudel, Idaho Transportation Department environmental planner, said the area is a hotspot for crashes between drivers and ani-

"We have a migrating herd of deer and elk that winter back and forth between their winter range and their summer range, and

they have to cross State Highway 21," Rudel said. "But when they are crossing, they create a mobility issue between the motorists who encounter them.'

ITD data shows there have been nearly 7,000 wild animal-related crashes on Idaho roads in the last five years. About 40 of those happened along the stretch of SH 21 above Robie Creek to Lucky Peak.

Rudel said the wildlife crossing will help reduce those numbers. About 10 years ago, ITD added an underpass about a mile away from where the overpass is getting built. Since installing the underpass, there have been no re-

ported wildlife crashes and very few carcasses found on the road. He said they are aiming for a similar result with the overpass.

Once completed, Rudel said it will be the first wildlife overpass in Idaho. The state already has a variety of crossings, including the underpass.

The project costs about \$7 million. He said most of that money came from the federal government, specifically through the Bipartisan Infrastructure Act.

Since most of the land around the overpass is federal land, Rudel said it makes sense for the federal government to pitch in.

Board targets 120,000 tons sisal production by 2025/26

THE Tanzania Sisal Board (TSB) is working efforts to increase the production of the key economic cash crop with target to start producing at least 120,000 tons annually from the 2025/26 season.

The TSB's Director General (DG), Saddy Kambona yesterday told a press conference in Dodoma Capital City that the Board was currently implementing a number of initiative to push for effective production and productivity in the cultivation of the crop among the involved farmers.

He said the number of sisal farmers have keep on mounting annually, the encouraging development which communicating that the sector was heading into a bright future.

"In 2020, TSB registered a total of 6887 smallholder farmers who engaged in the sector, whereby in 2022 the number increased to 8972," he informed.

However, he said the sector attract others 22,000 farmers who have yet to register at the Board.

Despite facing diverse handicaps, the TSB's chief boss said the sector had managed to record an important stride, in which the production increased from 36,379 tons in 2020 to at least 48,352.49 in 2022.

"Currently, we're implementing a number of programs with an eye to ensure the sector attract more farmers, but also, to assure the involved farmers are cultivating in accord to the recommended agronomic practices, "he said.

Being similar efforts, Kambona expressed that TSB have managed to collect and freely distributed a total of 6,991,200 Sisal seedlings to the smallholder farmers in the 16 different districts.

The beneficiaries districts, according to him, include Korogwe ,Muheza, Tanga, Mkinga, Handeni, Kilindi, Rorya, Bunda, Butiama, bariadi, Bagamoyo(Chalinze), Kisarawe, Mkuranga, Manyoni (Itigi), Singida rural as well as Mkalama district.

Moreover, he said the sector has witnessed a potential increase in the sisal plantations, especially for the small-scale farmers.

"In order to boost cultivation of the crop, TSB had distributed to the farmers free farms. For instance, in Korogwe district a total of 983 farmers were given free plantations, whereby others 3000 growers were given the arable farms in Kilosa district of Morogoro region, "he unveiled."

He hailed President Samia Suluhu Hassan for rolling out different support meant to revive the performance of the economic sec-

"There have a significant increase in the allocation of the Board's development fund from the state coffer, from 100m/- during 2019/2020 fiscal year to 2bn/during 2022/23 financial year," he informed.

With the development, he said the Board has successfully managed to procure modern Sisal processing machines, as well as reviving the other dilapidated processing facilities at Kibaranga Sisal estate in Muheza district (Tanga), and at the state-owned TPL Sisal farm in Bwawani, Arumeru district in Arusha region.

"Installation of the ultramodem facilities is projected to play meaningful role in helping the sector to reach the Sisal production and processing targets that have been placed by the government by 2026," he assured.

Tanzania Sisal Board was established in 1997 by an Act of Parliament and is charged with the regulation and promotion of the sisal industry with the aim of making it sustainable through increased productivity and profitability.

It was not immediately clear when the incident occurred.

Moscow demands that US stop 'hunting down' Russians in third countries – envoy

WASHINGTON

RUSSIA is demanding that the US stop "hunting down" Russian nationals in third countries and is prioritizing the repatriation of all compatriots imprisoned in the US, Russian Ambassador to the US Anatoly Antonov said.

"Russia has always opposed Washington's 'hunt' for Russians in third countries. It demands that this practice stop.

However, the [US] Administration continues to live in a world of its own, built on their own rules while ignoring the interests of other countries. We will never agree with such an approach," the diplomat said on the Russian embassy's Telegram channel.

Antonov under-

scored that Moscow advocates the prompt repatriation of all Russian citizens held in American prisons.

"It is an absolute priority for us. This is why we consider speculation on this issue unacceptable. [...] We fight for these people to get [them] back to their homeland, [back to] their families as soon as possible," he noted.

"We call upon American politicians and the mass media to let the relevant retary of State Antony Blinken had a

UN World Food Programme lauds India's contribution in providing life saving food to Afghanistan

UNITED Nations World Food Programme (UNWFP) in Afghanistan thanked India for its help in providing lifesaving food to 16 million people in the country.

The generous contribution by the government of India has been acknowledged by the relevant stakeholders in Afghanistan, including UNWFP.

In their recent tweet, UNWFP stated, "For the first half of this year, 16 million people in Afghanistan received lifesaving food from WFP. We are grateful for generous donors like India who make that happen".

As per the government sources, "in view of the deteriorating humanitarian situation and urgent appeals by the UN agencies, India continues to supply humanitarian assistance, including medical and food aid for the Afghan people. In this endeavour, the Government of India has partnered with United Nations World Food Programme (UNWFP) for the internal distribution of wheat within Afghanistan.'

Under this partnership, India has supplied total of 47,500 MTs of wheat assistance to UNWFP centers in Afghanistan. The recent ongoing shipments are being sent through Chabahar Port and being handed over to UNWFP at Herat in Afghanistan.

On the medical assistance side, India has so far supplied almost 200 tons of medical assistance consisting of essential medicines, COVID vaccines, anti-TB medicines and medical/surgical items like Pediatric Stethoscope, Sphygmomanometer mobile type with pediatric BP cuff, infusion pump, drip chamber set, electro cautery, nylon sutures etc.

The same were handed over to authorities of the Indira Gandhi Children Hospital, Kabul. India has also continued its support for the Habibia School, Kabul and has sent assistance of winter clothing and stationary items for the primary students.

Recently, India also partnered with United Nations Office on Drugs and Crimes (UNODC) in Afghanistan to provide humanitarian assistance for the welfare of the Afghan drug user population, especially females. Under this partnership, they have supplied 1100 units of female hygiene kits and blankets and medical assistance to UNO-DC, Kabul. These items will be used by UNODC in their female drug rehabilitation camps across Afghanistan. India would be providing medical assistance for these rehabilitation camps.

According to UNWFP, it is the world's largest humanitarian organization saving lives in emergencies and using food assistance to build a pathway to peace, stability and prosperity, for people recovering from conflict, disasters and the impact of climate change.

Canadian wildfire threatens towns, govt orders evacuations

YELLOWKNIFE

CANADIAN officials ordered the evacuation of the Northwest Territories' capital of Yellowknife and several smaller communities on Wednesday as a massive wildfire threatened the town of Hay River overnight.

Teams were working to evacuate Hay River, a community of some 3,000 on Great Slave Lake, by bus or plane on Wednesday night as the fire approached.

"Hay River saw the fire south of their community increase, get closer to the city today," fire information officer Mike Westwick said at a news briefing on Wednesday evening. "We saw highly active fire in that area and it was moving quickly."

Westwick said the blaze could reach Yellowknife by this weekend barring rain and that residents of the capital were also being asked to leave as part of a "phased evacuation" beginning with the most threatened communities.

So far no deaths have been reported from the Yellowknife fire but several structures have been destroyed. Yellowknife has a population of around 20,000 people and lies 400 km south of the Arctic circle.

Canada is enduring its worst wildfire season with more than 1,000 active fires burning across the country, including 230 in the Northwest Territories.

Thousands of residents of the sparsely populated territory have already fled smaller communities and the hamlet of Enterprise near the Alberta border was almost entirely destroyed by a blaze that swept through on Sunday.

Northwest Territories Premier Caroline Cochrane said some Yellowknife residents were preemptively leaving the city but urged people to remain calm and warned that highways could close suddenly because of the fire risk.

"I've never seen so many vehicles leaving town," Cochrane said. "There's all kinds of rumors out there, but be ready and evacuate if necessary. Be calm. Do not panic." Agencies

China's bridge construction picks up speed

RIDGE construction across China is accelerating this year. A number of technologically reliable bridges built in various shapes, which cross rivers, lakes, seas, valleys and canyons, are vitalizing the country's economic and social development and contributing to China's vision of building a strong transportation network.

On April 28, the Lingdingyang bridge, which is part of the Shenzhen-Zhongshan link in south China's Guangdong province, got its final segments joined.

The 2,826-meter bridge, a key control project of the Shenzhen-Zhongshan link, has a main span of 1,666 meters and a main tower height of 270 meters. It is the world's longest-span steel box girder suspension bridge in the ocean and the highest sea bridge.

In east China's Jiangsu province, which is situated in the lower reaches of the Yangtze River, the Zhangjiagang-Jingjiang-Rugao Yangtze River Bridge is currently underway. The bridge is 7,859 meters long, with its main section across the Yangtze River measuring 2,300 meters. Connecting Suzhou, Taizhou and Nantong cities of Jiangsu province, it features the longest suspension bridge span in

In the middle reaches of the Yangtze River in Hubei province, the Yanji Yangtze River Bridge, the world's largest double-deck suspension bridge, is under construction. So far, the foundation of the bridge towers on the two sides

After years of learning and innovation, China now has the technologies and domestically produced equipment to design and build bridges in the mountain, over with the Ministry of Transport, adding that China is leading the world in terms of the scale and technical level of bridge con-

Behind China's achievements in building mega bridge projects are the constant breakthroughs made by the country in bridge construction technologies.

China's road bridges boast standard design, industrialized manufacturing, modular construction and informationized control, which help expand the endurance and service life of bridges, said an official with the Ministry of Transport.

Today, intelligent technologies are applied in multiple sectors of bridge construction. For instance, the Beidou Navigation Satellite System is now assisting 3D geological modeling in land survey, with a centimeter-level accuracy. A batch of intelligent equipment have been developed and put into use, including smart steel structure manufacturers, multi-functional tower builders and welding robots, which significantly improve China's capability in building bridges.

As of the end of 2022, China had 1.03 million road bridges, with a total length of 85.76 million linear meters. In particular, 8,816 were super large bridges, with a total length of 16.21 million linear meters.

Bridges can break geographical barriers by crossing rivers and seas, as well as mountains and valleys. As key transportation infrastructure, road bridges have largely improved the transport of the Chinese people, created important opportunities for bettering regional economic exchanges, flow of information and personnel exchanges, and helped increase people's income and promote economic and social development.

China, Africa make fruitful achievements in economic, trade cooperation

IWENTY-FIVE containers of fishmeal weighing 485 tons recently arrived at the Yangshan Port, one of Shanghai Port's main ports, from Gambia. It marked the first time for the fishmeal produced in the smallest country on the African continent to enter the Chinese market via a port in Shanghai.

Today, China is the largest trading partner of Gambia. The rapid development of trade and economic cooperation between the two countries is exactly a miniature of the constantly deepening China-Africa economic and

This year marks the 10th anniversary of the Belt and Road Initiative (BRI) and the principles of sincerity, real results, amity and good faith, and of pursuing the greater good and shared interests in developing China's relations with Africa.

Over the past decade, China and Africa have cooperated closely with each other and advanced a batch of major cooperation projects in an orderly manner. Both the trade volume between China and Africa and China's investment in Africa saw steady growth, and the economic and trade cooperation between the two sides has entered a new phase of high-quality development.

The third China-Africa Economic and Trade Expo was held in Changsha, central China's Hunan province between June 29 and July 2. It was joined by over 1,700 Chinese and African enterprises, chambers of commerce and financial institutions. Nearly 1,600 types of commodities from 29 African countries were displayed at the event, up 166 percent from those in the previous session, including coffee, wine and artifacts. The number of exhibitors jumped 70 percent to reach 1,500.

Mozambique brought its wood carvings to the expo, and Malawi displayed its featured agricultural products such as chilies and soybeans. In the exhibition booth of

A total of 120 projects worth \$10.3 billion were signed during the expo.

At the expo, China's General Administration of Customs released for the first time a China-Africa trade index. Between 2000 and 2022, the import and export value between China and Africa grew more than 20-fold to hit 1.88 trillion yuan (\$260 billion) from less than 100 billion yuan, with an average

annual growth of 17.7 percent. China has remained the largest trading partner of Africa for 14 consecutive years, and the areas of cooperation between the two sides have been extended to digital technology, green development, aerospace, finance and other emerging sectors.

China is the fourth largest source of investment for Africa. As of the end of 2022, the stock of direct investment by Chinese businesses in Africa exceeded \$47 billion. Currently, there are over 3,000 Chinese companies doing business in the continent.

Africa is the second largest overseas engineering market of China. Since 2013, the total value of the contracts signed by Chinese enterprises in Africa has surpassed \$700 billion, and the contracts completed exceeded \$400 billion.

China has signed civil air transport agreements with 27 African countries, built and launched com-

munication and meteorological satellites for Algeria, Nigeria and other African countries. Under the support from the China-Africa Development Fund, Chinese drone technologies have been introduced to many countries in Africa. Drones manufactured by Chinese enterprises such as DJI and XAG are bringing hopes of harvest to farmers in Mozambique, South Africa and

E-commerce platform Kilimall headquartered in Changsha is now operational in Kenya, Uganda and Nigeria. It has built a warehouse covering 10,000 square meters in Kenya's capital Nairobi. Its independently built logistics network allows it to complete same-day delivery and it also has an independently developed online payment system that supports transactions in multiple currencies.

Li Fei, China's vice-minister of commerce, said that China has inked BRI cooperation documents with 52 African countries and the African Union Commission, and established multiple special work groups focusing on promoting unimpeded trade, investment cooperation, capacity cooperation, e-commerce and other

China actively supports the development of the African Continental Free Trade Area (AfCFTA) and has set up an expert group on economic cooperation with the AfCFTA secretariat for better policy communication and experience sharing on the facilitation of China-Af-

FIFA lifts second transfer ban imposed on Tabora United

■ HE world football governing body, FIFA, has lifted a transfer ban imposed on the NBC Premier League outfit United as the outfit has paid outstanding dues to its former attacker, Rahim Osumanu.

Tanzania Football Federation (TFF) said in a statement issued on Wednesday evening the Ghanaian goal-getter had reported the outfit, formerly known as Kitayosce FC, to FIFA for unfair termination of his contract.

Tabora United had earlier been handed the second FIFA transfer ban less than a month after, once again, failing to pay the club's former attacker, Osumanu, and other two foreign professional play-

Osumanu is currently turning out for the Indian club, Gokulam Kerala, which battles it out in Kerala Premier League.

Kerala Premier League is a state-level football league organized by the Kerala Football Association and played in the state of Kerala, India.

The FIFA decision came after Tabora United had failed to pay the Ghanaian attacker and his two teammates for unfair dismissal according to the ruling by the world football governing body.

Tabora United had settled its dues with the outfit's former coach Ahmed El Faramawy Yousef Mostafa Soliman but failed to address the players' plight, something that put them in FIFA's wrong books barely a month after the initial ban was lifted.

After Osumanu and his fellow footballers had won the case at FIFA, Tabora United was supposed to have paid

them within 45 days since the decision was issued, but the squad did not adhere to the judgment.

Consequently, FIFA ruled that the Tabora club cannot register new players until the club pays the foreign players whose contracts were terminated at the end of last season.

The development was confirmed by TFF through a press release in Dar es Salaam on Wednesday morning.

The federation noted in the statement: "Kitayosce FC, a club in the NBC Premier League, is banned from registering new players until it pays the players who have made claims against

TFF noted: "The decision has

Football Federation (FIFA) after the relevant players won civil cases against the club."

"Three foreign players filed a lawsuit against Kitayosce FC, protesting the breach of contract and non-payment," the federation added.

"The club was supposed to have paid them within 45 days since the decision was made, but it did not implement those judgments," TFF pointed out.

While FIFA has banned the club from making international player transfers, TFF has extended the sanction to domestic footballers.

However, the club has already done significant transfer business and is unlikely to be af-

Australia dared to ' dream of World Cup glory, then it all slipped away

A LONG, emotional day for Australian soccer fans turned into an even longer trip home when severe delays stranded thousands on train platforms at Stadium Australia after the nation's disappointing 3-1 loss to England in the World Cup semifinal.

For many, it was a fitting end to a draining night that saw Australia's newest sporting superstars, the Matildas, fall frustratingly short of their first ever World Cup final.

After the match, a downcast Sam Kerr - Australia's talismanic superstar and captain - told reporters she was lost for words.

"Unfortunately, this World Cup hasn't gone as planned. I can't blame it all on myself, but it's hard not to feel bad right now," she said.

Before the match kicked off, Australians had lifted their heroes onto their shoulders, but when the final score gave the game to England, they weren't prepared to put them down.

"I think they played incredibly," Skye Marshall told CNN, as she stood outside Stadium Australia with her family after the match.

"They've still got the hard work to do. And they will rally, and they will make us proud on Saturday," she said, referring to Australia's clash against Sweden in the third-place playoff.

"Rose gold," added Harold Marshall. "That's what we call it."

After Wednesday's game, politicians, sports stars and supporters lined up to commend the players. Prime Minister Anthony Albanese said they had "shown incredible skill, ferocity and flair," while Foreign Minister Penny Wong said they had "made Australia so proud.'

"You played some great football and along the way you have changed the country. We're all behind you, always," Wong posted on X, formerly known as Twitter.

Olympic runner Cathy Freeman, whose 400-meter dash for gold captivated the nation at the 2000 Sydney Olympics, also added words of encourage-

"So incredibly proud of our girls! You gave it everything and inspired an entire nation! Hold your head up high and here's to the future!" she posted on X.

Emotions ran high throughout the evening as spectators perched on edge of their seats, ready to spring to their feet every time Australia had a shot

The sound of drums echoed and fans launched into songs whose lyrics were distributed online by the Matildas' dedicated supporters' group: "Come

Sam Kerr's stunning kick - arguably the goal of the tournament - to equalize the score at one goal apiece shook the stadium as fans roared their ap-

But as England pulled ahead with a second goal and then a third, the singing lost some of its volume and exuberance, and some fans sat quietly down, despair etched on their foreheads.

As the time ran out on a dream comeback, the dejected players huddled before walking around the pitch to thank their supporters.

Kerr gave Chelsea teammate Millie Bright her jersey, which the Lionesses defender wore as she told reporters that the England team had "started

"We're getting the ball in the back of the net, which is nice," she added.

Outside the stadium, the Australian flags that had been held aloft earlier in the night were wrapped around shoulders for warmth as fans attempted to

Normally, trains run frequently to the city center, but hours after the match, thousands were left stranded in long queues on the platform after officials said a nearby station was damaged by vandalism. Some people gave up and started walking.

The mother and son have completed the same journey many times to see the Matildas play in Sydney, and though her back ached after the 14hour day, Gannaway had no regrets.

"It could have gone either way quite a few times," she told CNN of the game. "I enjoyed it. I've enjoyed the whole World Cup."

Fan Mariela Pocklington said, win or lose, this Women's World Cup had shown the joys of soccer to new audiences and she expects more girls will sign up to play the Beautiful Game.

"The effect after the Lionesses won the Euros was massive. They had a lot of girls that joined. Here will be the same," she predicted.

MAINLAND Tanzania's JKT Oueens beat Zanzibar's New Generation FC 1-0 to book a semi-final spot in the ongoing CAF Women's Champions League CECAFA Zonal qualifiers in Uganda on Wednesday.

After a goalless first half, the Mainland Tanzania Women's Premier League champions came all out and found the net in the 56th minute through Esther Mabanza.

They continued to create several scoring opportunities but failed to convert them.

Esther Fredy Chaburuma, JKT Queens' coach, said she was happy with her team for securing back-to-back victories and making it to the semi-finals.

The gaffer noted: "They have remained focused and now we go back to the drawing board to plan for our last group match against Vihiga Queens."

The victory comes after the Tanzanian side began their campaign with a 2-1 comeback win over Rwanda's AS Kigali Women's FC in their opening Group B match on Sunday.

1-0 in the second Group Stage game.

Former Simba Queens striker, Bertha Omita, scored the all-important goal in the 36th minute for Vihiga Queens and despite late pressure from the Rwandese side, the Kenyan side held on for their second win of the tournament in as many games.

Ethiopia's Commercial Bank of Ethiopia (CBE) Women's FC, which has also won the squad's first two games, is the other team to have qualified for the semi-finals.

Action returns in Group A with Fad FC (Djibouti) facing South Sudan's Yei Joint Stars in the first match.

In another encounter, Uganda's Kampala Queens will face an acid test against table leaders CBE Women's FC, in the second match at the FUFA Technical Center, Njeru.

The CAF Women's Champions League CECAFA Zonal qualifiers are slated to conclude on August 30.

The winners will represent the zone in the main competition, the 2023 CAF Women's Champions League, scheduled to be held in Cote D'Ivoire later in the year.
