## Govt readies for Phase II of COVID-19 vaccinations

THE government is set to launch phase two of countrywide vaccination campaign to counter the spread of Covid-19 infections on Wednesday.

Prof Abel Makubi, the permanent secretary in the Ministry of Health, Community Development, Gender, Elderly and Children said here yesterday that the launch will be held in Arusha in pursuit of the government's inclusive, speedy vaccination effort against Covid-19.

The Health ministry in tandem with the President's Office (Regional Administration and Local Governments) shall coordinate that event, whereas by late last week a total of 1,275,795 people or about 2.21 per cent of the population had received the jab, by available

President Samia Suluhu Hassan endorsed the use of the Janssen vaccines against the disease on July 23, and later large doses of Sinopharm and Pfizer were received, he stated

The government wants to attain 60 per cent of 35m adults vaccinated, he said, noting that top officials of the two ministries will be working out how to involve health sector staff at the community level.

Health ministry and the PO-RALG have prepared guidelines for assigning community health workers in the task, from listing them at village level and ward levels, and impart some training on the exercise, to conduct a message on the importance of being vaccinated.

About 8,130 community health workers were put to training and tasked with mobilisation in Mwanza, Dodoma, Manyara, Arusha, Dar es Salaam, Mbeya, Songwe, Kilimanjaro, Geita, Ruvuma and Morogoro regions, the top civil servant noted.

The exercise is taking off in other areas, he stated, indicating that in the second phase health teams in local councils backed by regional secretariats shall seek out people in all parts of the relevant communities.

The campaign focuses on empowering

THE Tanzania Electric Supply Co. (TANESCO) expects that power outages will be minimised in this period, thanks to rising water levels in main hydropower stations and short term plans taken by the power

TANESCO director general Maharage Chande said in an interview yesterday that the situation had improved significantly, with the drought eclipsed following the start of the ongoing rains.

The situation has changed and improved, as at the Mtera and Kidatu dams, water has increased to the extent of generating electricity at installed capacity of 200 megawatts for Kidatu, and 80MW for Mtera

The situation is different at Kihansi dam where the water level hasn't improved, as it depends on rainfall and water flow from Iringa and Njombe regions which are yet to get rains, he stated.

"The recent rains have helped us to see a change in the flow of water from. There is no shortage of power and as days go by there will be no shortage at all," underlining that as of yesterday there were no power cuts.

"If there are some parts of the country which do not get power, this may arise from poles or transformers being damaged," he

### Loose zebras captured, relocated in Tarangire

NEARLY 200 zebras that were causing havoc near the Mto wa Mbu Township have been relocated in Tarangire National Park, wildlife officials say.

(pictured), the Noelia Myonga commissioner of conservation for the Lake



Manyara National Park, said at the weekend that the wildlife translocation exercise is still going on within the Tarangire-Manyara ecosystem. There are a few more zebras yet to be lifted from the Mto wa Mbu Game Controlled Area (MGCA), he stated.

Officials of the Tanzania National Parks (TANAPA) based at the Lake Manyara Park are working with the Tanzania Wildlife Research Institute in Arusha and the Tanzania Wildlife Management Authority (TWMA) in that exercise, he said.

When the relocation of zebras is over, about 300 wildebeests will be shifted from the Mtowa-Mbu area where the ungulates have also moved into areas used for campsites and human settlements.

The wild animals' usual grazing fields were flooded by overflowing Lake Manyara water,

### EAC virtual summit to examine DRC request

PRESIDENT Samia Suluhu Hassan (pictured) and five other leaders of the East African Community (EAC) are scheduled to meet virtually on Wednesday to discuss, among others, application of the Democratic Republic of Congo to join the bloc.

Simon Owaka, the EAC head of communications, said in a statement yesterday that the 18th extraordinary summit of the EAC Heads of State will be preceded by the 45th extraordinary meeting of the EAC Council of Ministers, starting today.



The summit will deliberate on a report of the council regarding the proposed admission of DRC, where a more relaxed atmosphere on the matter is expected in discussions between President Samia and Heads of State of Kenya, Rwanda, Uganda, Burundi and South Sudan.

DRC and (North) Sudan have for years been trying to join the trading bloc but an unsettled environment and simmering differences with some of the EAC member states precluded meaningful discussion of those requests.

Original EAC members were Tanzania, Kenya and Uganda, which after two decades were joined by Rwanda and Burundi, and nearly a decade later South

Sudan was added to the bloc. When the Heads of State discuss the issue of whether DRC becomes the seventh member, they will be aware of the vast size, population and contention still simmering

At Tarangire, the Zebras were released at Matete location adjacent to the famed Tarangire River, purposely so that the freshly awakening striped mammals that got darted for transport may need water. But also, the area is also frequented by other zebras in the park so the waking up newcomers could easily adapt.

At least 350 wildebeests and over 200 zebras, plus a scatter of antelopes, were displaced from their usual feeding areas following heavy rains late 2019 to early 2020 that filled the lake, causing it to widen by five kilometers.

Various wildlife species shifted to the Mto wa Mbu Game Controlled Area, raising exposing the inhabitants to danger as predators follow the roaming prey, apart from habitat impacts.

### 6 Mbeya defective passenger buses barred from travelling

TRAFFIC Police in Mbeya Region have barred six passenger buses that ply between Dodoma and Dar es Salaam regions to proceed with their journeys after they were found defective.

Police officers from the national traffic police headquarters, in collaboration with their Mbeya counterparts made an impromptu inspection of buses on Saturday morning at Mbeya Main Bus Stand.

The buses whose defects included their brake system were already loaded with passengers ready for travelling.

Mbeya Regional Traffic Officer. ACP Meloe Buzema said in the crackdown they inspected 43 buses six of which were found with various defects including their brake systems.

He said some buses were also found with worn out tyres that endangered passengers' lives and called for their replacement.

Buzena said the police will make sure the defects are worked upon before proceeding with their journeys.

He named the buses that were found to be defective as those owned by New Force Co., Nganga Express, Kimbinyiko, Rungwe Express and Zeeland

The officer in charge of the inspection exercise from the National Traffic headquarters, ACP Mukadam Mukadam said the exercise will be conducted countrywide in order to control

road accidents.

He said the police have resolved to make the inspections because experience had shown that many road accidents happen during end of the year holiday's seasons as many people travel to celebrate holidays to their home areas.

"But also there are some drivers who are found driving their buses at over 100 km/h, and I have instructed the Mbeya Regional Traffic Officer to suspend their driving licences for some period of time because these endanger the lives of passengers," Mukadam said.

For his part, Mbeya Regional Police Commander, Ulrich Matei called on bus drivers to respect road traffic laws.

He said they will continue making frequent inspections of the buses as well as educating them as part of the implementation of directives from the Inspector General of Police (IGP) Simon Sirro.

### JKCI conducts 205 open heart surgeries for children this year

The Jakaya Kikwete Cardiac Institute (JKCI) of the Muhimbili National Hospital (MNH) has during this year conducted 205 open heart surgeries for children under the age of ten years old.

The details were revealed by Prof Mohamed Janabi, JKCI executive director, at the weekend in Dar es Salaam at the closure of the volunteer medical campaign for open heart surgeries pediatrics in Tanzania by the King Salman Humanitarian Aid and Relief Centre from the Kingdom of Saudi Arabia.

According to him, the number of children who were subjected to the surgeries are beyond the set target of 200 children this year.

"This is a great milestone in the health sector as the center has made remarkable improvements in health services extended to children. The one week campaign by the King Salman Humanitarian Aid and Relief Center has realised another 34 children receiving surgeries from its doctors who have been in Dar es Salaam for almost a week," said Prof

According to him, treatment medical experts' means a lot to the

King Salman Humanitarian Aid were handed over to the JKCI to contribute to the existing facilities thus further improving service delivery. He said that this is the second time that the delegation of medical doctors from King Salman are visiting Dar es Salaam for free heart treatment and

Loyai Abdulsamid, head of pediatrics ICU at King Fasial Specialist Hospital who led the team of medical doctors from the Kingdom of Saudi Arabia, said the mission has been in Dar es Salaam for six days and during the period conducted 34 open heart surgeries.

"The center is dedicated to offering free open heart surgeries to children because heart diseases are a major killer for children as they are not treated early," said Abdulsamid.

Ahmed Jamjoom, chairman cardiovascular Department at King Fasial Specialist Hospital said that some of the doctors came from the United Arab Emirates, Jordan and

Students call for simple technology to prevent accumulated waste gasses

STUDENTS of the Arusha-based Ilboru secondary school have underscored the need for environment stakeholders to come up with simple technology that can help to absorb and prevent people from accumulated waste gasses.

Lupyana Ngota and Adib Masalu emerged winners in the Songas energy category with a project titled: Auto Waste Gasses Consumer for Automobiles, Domestic, Public places and industries for clean air and safety."

They aired their views at this year's Young Scientist Tanzania (YST) national award ceremony held recently in Dar es Salaam and awarded a trophy and certificates.

They said auto waste consumer gasses programme electronics was a device which helps in detection, absorption, and chemical conversion of waste gasses useful chemical products to be used in industries, laboratories and fresh air.

Meanwhile, increasing comfort ability workers customers generally people working at poorly ventilated environments.

"The devoice has proves to be an easy and efficient method of consuming waste gasses that are produced in places public places, automobiles and industries as it completely converts the waste gasses to clean air rather than just blowing it out into the perpetuates ozone places depletion greenhouses effect and healthy hazards to people," they said.

### 'Encroachers must leave water catchment areas'

### **By Guardian Reporter**

AUTHORITIES in areas with water catchment areas have been directed to remove all encroachers, including herders, farmers and loggers to conserve natural sources of the precious liquid.

Minister of State in the Vice President's Office (Union and Environment) Dr Selemani Jafo gave the order yesterday while visiting forest reserve and water source at Matogoro Mountains in Songea district, Ruvuma region.

During the visit, the minister expressed satisfaction with good management of the forest which is the source of water used in Songea municipality, run by Songea Urban Water and Sewerage (SOUWASA).

"Water is flowing from taps because of the conservation of these forests but in some places sources like this have been encroached leading to waters shortages," he said.

"Encroachment of water sources

cannot be tolerated because it is akin to tampering with our very own life; authorities in areas with natural water towers like this one should ensure that encroachers leave permanently."

Jafo commended the management of the forest for not allowing human activities in the area, encouraging the not to relent.

"If people were allowed to enter this forest logging, charcoal-making or any other deforestation activity, then this source would not be here and water wouldn't be flowing as it is does now," he said.

Minister Jafo urged the people to support the government's efforts in conserving the environment by planting trees in large quantities especially in water sources and conserving them to avoid water shortages.

The minister also cited the example of the Uluguru mountains in Morogoro region whose water sources have begun to dry up

due to the burning of forests for charcoal and firewood, a situation that contributes to water scarcity in those areas.

He appealed to the regional and district authorities as well as the Tanzania Forest Service (TFS) to ensure that they take strict legal action against anyone engaging in activities that endanger the security of water resources and the environment. During the visit, minister Jafo visited and inspected a modern abattoir located in Songea municipality where he expressed satisfaction with environmental management.

He inspected the sewage dams that will be used for storing waste from the abattoir without flushing the same to nearby residential areas.

Despite congratulating the leadership of the council that is implementing the abattoir project, Minister Jafo urged the authorities to take good care of the project so that there is no damage and loss.

### Let's drive to arrive alive this Xmas

once a year. We have seven days to go moving into the climax of this festive season. We also begin tallying road accidents, fatalities and injuries as more traffic will be on our roads, more drivers will be drinking and speeding, and more of them will die or kill their families or kill others using the roads. Police roadblocks help a little. They ensure drivers are licensed and are not obviously drunk and that vehicles are licensed and therefore that they are also insured. But this is about as far it goes: a quick check that reminds most drivers to be careful and then back to as it was.

Of far more value are those police speed-traps and the highway patrol vehicles that go round looking for bad driving as well as mounting quick surprise speed-traps at unexpected

places. We hope that the police will be able to use every one of the limited number of speed radars they have working this festive season, for that will at least reduce one big killer.

A second major killer is alcohol. Unfortunately, Tanzania does not test much to see if drivers are over the limit or even drunk. We have to rely on the common sense of drivers, and it is clear that many Tanzanians feel they are quite capable of controlling a car when they have downed a few beers. Statistics show they are wrong, and part of the holiday death toll comes from the higher likelihood that many drivers, being off work, are drinking during the day.

We have suggested before that equipping roadblocks with the basic breathalysers common in some countries would do a great deal to keeping our roads a lot safer, and we suspect that at least in the early stages of zero tolerance to drinking and driving, the fines would more than pay for the equipment.

The third killer is bad driving, and

HRISTMAS comes but Tanzania has a lot of bad drivers plus a lot of fairly reasonable drivers who try and drive when tired, drive long distances as quickly as possible, and

> drive too fast on dark roads. Bad driving and wrong driving kill. We have seen that over the years. Sometimes, in some places and some conditions, the speed limit is far too fast at lower speeds it is easier for two vehicles to pass, especially on curves or where the road is raised to cross a

Night driving kills more than it should, largely because so few people take the trouble to work out what is their minimum braking distance and then checking to see if their headlights will light up an obstruction in time. If not they will have a problem.

We might need to borrow the law in several countries that compels drivers to carry a spare headlight bulb. These are cheap and easy to replace and having both bulbs does give a driver a better chance of seeing obstructions.

Even roadblocks would be a useful place to be told a bulb was out and would offer protection while this was changed. The offence can be not having a spare, not having a dead light.

A final major killer is the impatience so many show on the roads. Taking a trip a little easier, going with the flow and enjoying the ride a bit more does not add much to the travel time few trips would be more than 15 per cent longer and would be a lot safer and more enjoyable.

Leaving early enough to complete a trip in daylight will boost the chances of living through that trip.

Most drivers know the rules and have heard the suggestions. What is needed now is for them to follow them and assume that sometimes the expert does know better.If we drive more safely we can demand others do the same.



### Auditors have a role to play in combating climate change

HE 26thUN Climate Change Conference of the Parties (COP26) in Glasgow held recently brought together parties to accelerate action towards the goals of the Paris Agreement and the UN Framework Convention on Climate Change. This has helped to increase awareness on matters relating to climate change.

A lot still needs to be done and I

draw this from two scenarios that I encountered recently. One was when our son asked me what we were discussing in a meeting that seemed to take longer than usual and which countries were the participants in the meeting from. This was a virtual meeting of Heads of Audit and other invitees across KPMG network to discuss how we are planning to deliver Environmental, Social and Governance ("ESG") Assurance. I had to explain to him the entire concept of ESG and climate change which he appreciated and answered his follow up question on why it would concern accountants and auditors. In the second scenario, in a meeting that we attended and provoked a discussion on what the institution was doing around matters relating to climate change, there was an initial uproar on why this would concern auditors. This didn't surprise me because it created an opportunity to build awareness at this senior governance level on why everyone needs to do something on climate change lest we all perish. We have a responsibility to do our part to build a better, more sustainable society where we actively contribute as part of our duty to the public interest.

We must all be courageous to have bold discussions at various forums we participate in, in addition to having conversations with the younger population because this concerns them more. I would think that school curriculum should have mandatory subjects on climate change to increase the level of awareness and enhance the quality of discussions into the future to keep reversing adverse effects of climate change.

It is critical for everyone including auditors to have these conversations because of the risks arising from the effects of climate change which will affect most, if not all, entities. Various entities will be impacted differently. Some may have an immediate impact, while other may be gradually impacted through their broader value chain. For example, banks do offer credit facilities to different sectors. Some of their customers are likely to be impacted heavily in the short term, while others may feel the effect in the later years. It will be good for institutions to encourage different players they interact with such as customers, suppliers among others, to have policies on ESG. We all agree that there is growing recognition that entities need to consider whether environmental and climate related matters are material to the financial statements, including potential impacts from the risks and opportunities associated with the transition to a lower-carbon economy. Auditors need to understand the potential impacts that climate-related matters may have on the entity's financial

statements and audits. It is important to recognise that climate change may not only expose an entity to risks, but it may also create opportunities. We are likely to see entities that are pro-active in decarbonisation through developing from these actions. Some of the benefits they are likely to enjoy include access to new markets, changes in consumer preferences, increased diversification operational resilience, improved energy efficiency and access to public sector incentives that reduce implementation costs. These opportunities may enable an entity to increase revenues, reduce operating costs, improve reliability of supply, reduce exposure to volatile

and implementing plans that benefit carbon or fossil fuel prices, reduce

costs of capital and increase capital availability. Having identified and assessed the risks and considered the opportunities arising from climate change, many entities are expected todevelop strategies and implement plans in response, and these strategies and plans could also have related public commitments and business risks with material financial statement implications.

In conclusion, organisations need to accelerate the policy framework around ESG and climate risk for approval at board level and follow through of the same. Regulators as well need to be at the forefront of encouraging every organisation to do something to support government efforts. Help is available for those that do not have inhouse capacity to do something around ESG and climate risk.

### **Hockey development** programmes need serious push

hockey circles had two major tournaments taking place in Ghana last month, the Africa Cup for Club Champions showpieces for both men and women held in Accra.

It is obvious failure to access funds that could have smoothly facilitated the region's hockey clubs was one of the reasons for missing out on the tournament.

The country could not field either men's or women's squads in the prestigious continental hockey

tournaments. Much as the domestic hockey sides would have liked to be part of the continental tournaments, they were reduced to mere spectators because of a variety of factors, financial difficulties turning out to be one of

This is yet another discouraging news coming out of domestic hockey

Domestic hockey players last tasted continental action way back in 2014 as women's side, Twende, battled it out in Africa Club Championship.

With the presence of strong opponents in the 2014 continental club showpiece, Twende simply used the competition to learn from more

competent squads.

It is time sports stakeholders in the country put their weight behind local hockey governing body's programs to see to it hockey sides ultimately battle it out in continental tournaments.

There is no doubt that currently, the country lacks strong domestic hockey tournaments at both regional and national levels, which take place

The presence of such tournaments would have made it easy for the country to secure strong hockey sides which could have represented the country well in continental showpieces.

The absence of such competitions boils down to a failure by the domestic hockey governing body to access sponsorship for hosting the events successfully.

The domestic hockey governing body has for many years struggled to lobby for sponsorship for various hockey programs conducted by the association. Extremely few firms have either shown willingness to be part of the sport's development program or fully backed the project. Hockey stakeholders have at times

sought to keep the game active, organizing several friendly matches. We feel both individuals of goodwill and firms have a part to play in the promotion of less popular sports,

including hockey. There is no doubt the country could not be counted as a sports powerhouse, should there be no concerted efforts to develop all sports disciplines that are active.

Sports followers in the country have for years been expressing displeasure over the country's failure to field many sportsmen and women in the Olympics and other major tournaments at continental and international levels.

### The future of an entire generation hangs in the balance


OVID-19 has world, threatening health, destroying economies and livelihoods, and deepening poverty and inequalities. It also created the single largest disruption to education systems that the world has ever seen.

The end of this year has revealed the fragility of food systems when faced with sudden disruptions such as those observed during the COVID-19 pandemic. These disruptions have increased the number of people with limited or no access to food in the world. Today, more than 811 million people suffer from hunger, according to recent studies.

128 million children and youth people whose education was already disrupted by conflict and crises have been doubly hit by COVID-19, with the pandemic creating a 'crisis upon a crisis'. The length and extent of disruption to education



systems around the world due to the pandemic has tested the very concept of education in the context of humanitarian crises.

What does it mean to be dedicated to 'education in emergencies' in a world in which 90% of schools were shut due to a global pandemic? How do we support children

get an education in countries affected by conflict and fragility when in peaceful and stable countries millions of children nous incident, a young girl had are at risk of never returning to school? Will the push to deliver reme-

dial education for the millions of children who have lost learning over the last two years stretch to helping the three million refugee children who were out of school before the pandemic?

### Breakthrough or break-

These questions underscore a stark and urgent choice. Do we push for an ambitious and inclusive breakthrough or accept that the pandemic has led to an irreversible breakdown in educational progress and will permanently deny millions of children the opportunity to go to school?

From Afghanistan to Zimbabwe conflicts, forced displacement, famines, and climatechange-induced floods, fires, and extreme heat, together with COVID-19 have combined to form a fatal cocktail that is robbing children of their education.

Last week on a visit to Cameroon, Education Cannot Wait met some of the 700,000 children there who are impacted by school closures due to violence. If this alone were not bad enough, just a few days before the visit, four students and a teacher were killed in a targeted attack, and, in a separate heiher fingers viciously chopped off just for trying to go to school.

### Education is a priority for communities caught up in cri-

The bravery and determination of the children of Cameroon is a testament to the priority that crisis-affected communities all across the world place on education. They know that education transforms lives, paving the way to better work, health, and livelihoods. They know that continuing education in a safe place provides a sense of normality, safety, and routine for children and young people whilst building the foundations for peace, recovery, and long-term development among future genera-

They tell us their education cannot wait. But delivering that quality education to these children remains a persistent chal-

ess than halfway into the 2021 Atlantic Hurricane Season, Jamaica and its Caribbean neighbours were already tallying the costs of infrastructural damage and crop losses from the passage of three tropical storms - Elsa, Grace and Ida. And after a record-breaking 2020 season, the region is on tenterhooks as the season peaks.

But while storm and hurricane damage are not new to the Caribbean, these systems' increased frequency and intensity bring new reckoning for a region where climate change is already happening. According to data, the effects are likely to worsen in the next 20 years or so, earlier than previously expected.

What is more, the launch of the Intergovernmental Panel on Climate Change (IPCC) Assessment Report (AR6) confirmed what regional scientists have said for years: the frequency and intensity of hurricanes will increase, and floods, droughts and dry spells will be more prolonged and more frequent. In addition, sea levels are rising faster, and heatwaves are more intense and are occurring more often.

AR6, the so-called 'red code for humanity', offers a frightening look at the global climate and what is to come. It also confirmed that for most small island states, climate change is already happening.

In a bid to bring home the reality of what is fast becoming the region's biggest challenge, two leading climate scientists broke down AR6 to highlight the issues that should concern leaders and citizens of the Caribbean.

In a document named Caribbean Under Threat! 10 Urgent Takeaways for the Caribbean, co-heads of the University of the West Indies Mona, Climate Studies Group (CSG), professors Tannecia Stephenson and Michael Taylor warned: "We can now say with greater certainty that climate change is making our weather worse. It is affecting the intensity of heatwaves, droughts, floods and hurricanes, all of which are impacting the Caribbean".

In a joint interview with IPS, Taylor and Stephenson noted, "Global warming has not slowed."

They reiterated the IPCC's warning that "The world will exceed 1.5 degrees between now and 2040" and urged Caribbean leaders to collectively lobby for deeper global greenhouse gas reductions at the upcoming 26th Conference of the Parties (COP26) of the UN Convention on Climate Change. The gathering of world leaders and negotiators will be held in Glasgow, Scotland, from October 31 to November 12, 2021.

While AR6 offered some hope, in that there is still time to limit global heating to between 1.5 and 2.0 degrees of pre-industrial limits, Stephenson noted that there is an urgent need for more drastic cuts

# Caribbean under threat: Report reveals enormous challenges for the region

in emissions.

That will not be easy, Taylor added, because although the Caribbean's contribution to global CO2 emissions is already low - according to some estimates below two per cent. "The region must drastically reduce its footprint even further, through greater use of renewables, the preservation of marine and land-based forests and by reducing emissions from waste and transportation."

The takeaway for the Caribbean, Stephenson said, is that the region will face multiple concurrent threats with every additional incremental increase in temperature. Atmospheric warming and more acidic seas and oceans will impact tourism and fisheries and the future of the region's Blue Economic thrust.

She added: "The Caribbean must prepare itself to deal with water shortages and increasing sea levels which has implication for low lying areas and the many small islands of the region".

The 20-country grouping of the Caribbean Community has rallied around the slogan '1.5 to stay Alive' based on the premise that viability of the territories here, is dependent on global temperatures remaining below or at 1.5 degrees above pre-industrial levels. But with global temperatures already at 1.1 of the 1.5 degrees, warming is outstripping the pace of the region's response.

"If there ever was a time to step up the global campaign for 1.5 degrees, it is now," said Stephenson, the region's only contributing writer in Working Group 1, of the AR6. According to the IPCC AR6 report,

net-zero carbon dioxide emissions by mid-century can limit global warming to 1.5 or 2.0 degrees within this century. However, the Climate Studies Group has warned that some individual years will hit 1.5 degrees even before 2040, when temperatures are expected to exceed that target.

The signs are everywhere. Last summer, the CSG reported an increase in the number of hot days and nights in the Caribbean. Forecasts also indicate that in the next ten years, the day and night-time temperatures in the region will increase by between 0.65 and 0.84 degrees.

At the same time, the CSG forecasted a 20 per cent reduction in rainfall in some places and up to 30 per cent in others. Trends are also reflecting an increase in the number of dry spells and droughts. Between 2013 and 2017, droughts have swept the Caribbean from Cuba in the North to Trinidad and Tobago in the South, and Belize, Guyana and Suriname in Central and South America.

Since AR5 in 2014, the abundance of evidence links the catastrophic changes

to humans, the scientist noted, adding that the changes from human-induced climate change are visible in the extremes of heatwaves, heavy rainfall, droughts, and tropical cyclones. This past summer, wildfires and extreme rainfall caused deaths and forced evacuations in every region of the world, and a cold snap covered Brazil in

snowfall and freezing rain. These intensity and frequency of heat extremes are quickly becoming a cause for concern for the region as the extremes are likely to impact energy use, agricultural productivity, health and water demand and availability. Stephenson urged leaders to make water security a top priority in their mitigation planning.

Three of the world's most waterscarce countries are in the Caribbean. Water scarce is the term given when a country has less than 1,000 cubic meters of freshwater resources per resident.

The region has a role in deciding how bad things will become, Taylor and Stephenson said. In their 10-point takeaway, they challenge leaders to intensify efforts to keep the current limits on global warming. They must have collective positions on mitigation, adaptation and loss and damage even as the world has already committed itself to some level of increase and impact.

In the run-up to COP26, regional

leaders are not only continuing their support for 1.5, but they have also positioned themselves behind the Five Point Plan for Solidarity, Fairness and Prosperity, which calls for the delivery of the promises made in the Paris Agreement.

If nothing else, the region will continue to be severely impacted and must invest heavily to shore up critical infrastructure, most of which are along the coast, said veteran climate scientist Dr Ulric Trotz.

Using Jamaica as an example, he pointed to the US\$65.7 million coastal protection works along a 2.5- kilometre stretch of the 14-kilometre-long Palisadoes peninsula in 2010 after the international airport was cut off from the capital city, Kingston, by back-toback extreme weather events.

"The Caribbean must be prepared for the 'new normal' of climate intensities," Stephenson said. "The stark message is that everybody has to be part of the solution".

### TOSCI commended for fighting counterfeit seeds in Tanzania

THE Tanzania Official Seed Certification Institute (TOSCI) has greatly succeeded in curbing importation and supply of counterfeit seeds in the country, according to a special research by The African Seed Access Index

The timely research suggests that reduction in the number of reported cases of fake seed and increased seed companies satisfaction are indications that the government's 

efforts to address the problem were up reliable systems to control bearing fruitful results.

In his presentation yesterday at the TASAI's Tanzania dissemination meeting here, Dr Firmin Mizabwa, a senior agricultural researcher said that seed companies surveyed by TASAI in 2020 reported five cases of counterfeit seeds, which is lower than the 18 cases reported during

"The research has discovered that the government through the Tanzania Official Seed Certification

counterfeit seed in the market," he

He informed that the systems include the aggressive inspection and monitoring of seed businesses through regular inspections in agro dealer shops, an increase in the severity of punitive measures, as well as awareness -raising among the of the effects of counterfeit seed.

"For example, the Seed Act was amended in 2014 (URT 2014) with an eye to increasing the Institute (TOSCI) has been setting punitive measures for persons who

contravene seed laws by selling counterfeit seed from a fine of 5m/to 50m/-," he stated.

Moreover, he added that TOSCI has also introduced electronic labels on seed packages, saying when activated the labels allow users to verify if the seed has been inspected and certified.

Emmanuel Mwakatobe, official seed inspector and analyst from TOSCI said the state -owned Institute has also introduced an online system to apply for seed labels, seed sampling and testing,

seed dealers' registration, DUS as well as NPT tests.

"The use of digital tools has been introduced during field inspections, and the development has seriously increased the speed of TOSCI's service delivery," he expressed.

Moreover, he said TOSCI has yet to train and authorise private inspectors.

"According to TOSCI, local seed inspectors should be made more aware of private seed inspections, which would lead more companies to demand the services," he insisted.

He added that digital solutions were useful to help improve seed inspections standards and speed, saying that seed inspectors employed by TOSCI are currently using mobile devices during field inspections to upload field inspections on site- to the head office for further processing.

"Through these services, seed companies' certification with seed inspection services has increased from 'fair' (59 percent) in 2016 to 'good' (77 percent) in 2020," he detailed.

### UK-based charitable organisation donates twenty sewing machines to entrepreneurs

### Rising need for research among institutions calls for increased funding - says coordinator

COUNTRIES in sub-Sahara Africa making significant strides in development thanks to increased uptake in research and development that seeks to raise the quality of lives through social and economic improvement.

In line with efforts to meet Sustainable Development Goals. institutions of higher learning in these countries are undertaking various research projects basing on promoting science, technology and innovation.

The aim is to design simple, but efficient technology that would enable small producers to make quality products which would fetch good prices in the market. These producers cannot high-capacity machines meant for large-scale producers most of which have to be imported. Ultimately, such projects should bring about social and economic development to the common man.

In Tanzania, institutions like Muhimbili University of Health and Allied (MUHAS), Sciences University of Dar es Salaam (UDSM), Sokoine University of Agriculture (SUA) and University of Dodoma (UDOM) are conducting research in various fields of life thanks to funding from Science Granting Councils through the

Science Granting Council Initiative (SGCI). Although the institutions have other sources of funding, the Initiative's funds are specifically directed to research that promotes science, technology and innovation.

This gives the government a shot in the arm to undertake inclusive development by taking on board small producers who would otherwise not be reached in the near future.

Initiative currently funding projects in Kenya, Rwanda, Uganda, Tanzania and Ethiopia. Others are Côte d'Ivoire, Burkina Faso, Senegal and Ghana. The list also includes Botswana, Malawi. Namibia, Mozambique, Zambia and Zimbabwe.

Beneficiaries of the Initiative which is now in its second phase acknowledge

generally funding is available, but since the demand for research is expanding the amount provided cannot meet all what is required. In some cases, the money available has not been enough to accomplish a project, raising the need to look for other sources of funding.

"However, it is clear that research funding through SGCI has increased and this has led to improved

project design and project management in general. At times the flow of funds has been fluctuating due to increased demand, but overall, research has been well-funded resulting in improved capacity, research project design and methodology," says Neema Tindamanyire, the CGCI Coordinator in Tanzania.

Dr. Sigisbert Mathias Mmasi is the principal investigator of a research in extraction of avocado oil. The project, Development and Commercialisation of a suitable avocado oil mini-extraction plant to enhance productivity and quality of avocado oil in Tanzania is implemented by TEMDO as a beneficiary of the SGCI programme. The main objective of the project is to design, develop and ued to support research commercialize suitable

in the market than we had anticipated so we have had to squeeze our activities. We are now soliciting funds from other sources to enable us to design and produce more machines to help more sunflower oil producers in the country raise their incomes," says Eng. Lyaruu who is the coprincipal investigator of the project.

There is an on-going research that focuses on the design and production of plasmer cutter machines. According to Principal Investigator Eng. Patrick Kivanda, currently these machines are imported and the prices are very high. The quality of some of the machines is also questionable. With production being done locally it will be easy to undertake quality control. "Our aim is therefore to produce them locally in order to increase efficiency and quality of the products cut by the machines. However, research requires a lot of funding and currently we are not getting enough. For example COSTECH has given us12.5m/- for this project but the actual expenditure has risen up to 19m/-. We need to look for other sources of funding from within Tanzania and beyond and one way is to get partners in the various stages of project implementation. We are fine with the design and developing stage but we need partners to put the product in the market," explains Eng. Kivanda.

### 2021 revealed the fragility of food systems

he end of this year has revealed the fragility of food systems when faced with sudden disruptions such as those observed during the COVID-19 pandemic. These disruptions have increased the number of people with limited or no access to food in the world. Today, more than 811 million people suffer from hunger, according to recent studies.

The State of Food and Agriculture (SOFA) 2021 report, published in November by the Food and Agriculture Organization of the United Nations (FAO) states that three billion people cannot afford healthy diets, and another billion could soon join these ranks if the crisis of the pandemic reduces their income by a third.

According to current projections, if an alteration in the transport routes of food products continues as it has been since the start of the pandemic, the cost of food could suffer an increase. This increase would greatly affect 845 million people.

These disruptions would impact on long-term trends in the food system, the welfare of people, their assets, their livelihoods and security, the ability to withstand future disarrays caused by extreme weather events and the heightening of diseases and pests in plants and animals.

Prior to the pandemic, difficulties in meeting the international commu-

nity's commitments and achieving the Sustainable Development Goals (SDGs) by 2030, especially the eradication of hunger and poverty, were already present. The effects of COVID-19, coupled with climate change, armed conflict and rising food prices, could continue to exacerbate these difficulties.

Global agrifood systems, related to the complex production of agricultural food and non-food products, as well as their storage, processing, transportation, distribution and consumption, produce 11 billion tons of food annually and employ billions of people, either directly or indirectly.

The recent FAO report analyzes whether lowincome countries face greater difficulties as a result of impacts of the pandemic than middleto high-income countries. After analyzing this specific situation in more than 100 countries, the report confirms the trend that low-income countries face greater difficulties; however, middle- and high-income countries are not exclud-

ed from these impacts. Such is the case of

middle-income countries like Brazil, where 60% of the value of their exports comes from a single trading partner, which reduces their options if their main counterpart is affected by the disruptions generated by COVID-19.

The same can happen in high-income countries, such as Canada or Australia, if they are exposed to transportation variants due to the long distances required to cover food distribution.

According to recent expert studies, reducing essential connections in the distribution network could cause local transport time to increase by 20% or more, thus increasing food costs and prices for consumers.

Resilience in agrifood systems by governments should be one of the main strategies to respond to current and future challenges, seeking to diversify sources of inputs, production, markets, supply chain and actors, supporting the creation of small and medium-sized companies, cooperatives, consortiums and other groups to maintain diversity in the agrifood value chains.

In addition, the resilience of vulnerable households should be improved to ensure a world without hunger, through greater access to assets, diversified sources of income and social protection programs in the event of a crisis. 

Today, family farms represent 90% of all farms in the world. FAO established a technical platform for family farming with the aim of fostering innovation and the exchange of information between regions.

According to the Director-General of FAO, QU Dongyu, when resources and knowledge are shared "innovation is accelerated", and while "this platform will allow us to think big, it will also facilitate the adoption of concrete measures" which will in turn allow for the conservation of biodiversity. This represents the first step towards rural transformation.


The relationship between agricultural nutrition and climate change is another outstanding component of the shocks that have continued to occur in 2021.

The increase in temperatures and the growing impact of radical atmospheric effects are exponentially affecting agriculture, causing an increase in the prices of raw materials as recorded by recent trends, and consequently aggravating the conditions of hunger and malnutrition.

If this trend continues, by 2050 agrifood production will decline by around 10%, at a time when there would be a strong increase in the world population.

There are also opportunities to reverse these trends related to agriculture, food and the environment, but in order for this to happen, greater investments is needed in this sector.

From precision agriculture and early warning systems, to improving the use of food waste and converting it into clean energy, to using water more efficiently, many practices are already being carried out in different countries. These solutions offer a sense of hope and show that we can reverse the present negative trends. When reflecting on the difficulties of the past year, we should continue to work towards finding concrete solutions instead of just pointing out the difficulties that the future of the agrifood industry faces.

### De Beers extends Botswana sales deal as it negotiates new contract

**GABORONE** 

De Beers Group said on Friday it has extended by six months a 10-year agreement with Botswana for the sale of rough diamonds from their jointly owned venture, giving both parties more time to negotiate a new contract.

The 2011 rough diamond sales agreement in which the venture, Debswana, sells 75% of its output to Anglo American PLC subsidiary De Beers was set to expire in 2020, but was extended for a year in December 2020 due to the pandemic. The agreement will now run until the end of June while contract negotiations continue.

A deal is necessary for Botswana as the Southern African country gets about 30% of its revenues and 70% of its foreign exchange earnings from diamonds, which make up a fifth of its GDP. For De Beers, which is 15% owned by the government of Botswana, a contract renewal would provide another long period of revenue certainty.

Both parties have declined to divulge the specific terms being negotiated but analysts have said the government is likely to want to increase its share of diamonds produced by Debswana from the 15% agreed in 2011, or to get a larger share of bigger stones. Last year, the government's share was raised to 25%. Debswana sells the balance of its output to state-owned Okavango Diamond Company (ODC), an independent channel created by the

government to sell diamonds. Botswana has a long term plan of transforming itself from just being a

producer of rough diamonds to taking a more active role in the broader industry, participating in activities such as trading, cutting and polishing and other support services such as tourism and hospitality, transport, diamond banking, gemmological functions and laboratories. President Mokgweetsi Masisi has said he wants more people employed in the industry as the country battles with relatively high unemployment, especially among youths.

# ACEX chief urges local investors to use digital platform in trading effectively

OCAL investors have been called upon to take advantage of the newly launched unified exchange platform, the African Consolidated Exchange (ACEX) that will allow people to buy and sell assets such as stocks, bonds, forex, cryptocurrencies and other traditional commodities online.

The digital infrastructure platform which was launched on Friday, will also allow investors to stake in real estate, venture capital, micro-funding, mining and exploration among other projects while earning dividends on trad-

ACEX's CEO, Peter Mucheru said during the launch that the platform intends to rewrite African history by revolutionizing the finance ecosystem through digital

Mucheru said in Nairobi that ACEX will be the first exchange where native producers from their competitive price and earn direct rewards from their efforts. He named products such as cobalt, cocoa and timber as being synthetically indexed and offered as quotes for traders to take advantage of.

"We also have a micro-financing model, which allows us to partner with local microfinance institutions and facilitate them with funds to provide as credits to micro, small and medium enterprises," he said.

Mucheru further noted that for Tanzania, ACEX is currently reviewing some few microfinance institutions - that when approved will start empowering MSMEs with capital access. "We understand there is still faint knowledge when it comes to digital economy, with many people in the region fearing scams and online fraudsters," he noted.

"The platform offers education materials and through our local franchises, we ensure that one is well informed before they start Africa can list their produce, fix trading, "the ACEX chief executive employment challenges. Fanuel

added while noting that in order to start tapping on the platform, one will need to purchase an initial investment of 100 of Temcoin (\$XTEM) which is the native cryptocurrency of ACEX. Commenting on the launch, lo-

cal digital trader, Elibariki Shilla who has three years experience with the ACEX's functioning and TE Markets, said that stakeholders and investors can take advantage of the centralized platform because it offers multiple assets trading options unlike any other consolidated market in the world.

"For those who fear the digital trading initiatives, there are experts who offer knowledge and understanding on how to properly exploit the opportunity, as one can also trade by following what the verified traders do, step by step," Shilla said.

Another digital entrepreneur, Joshua Fanuel backed Shilla by urging youth to use the platform to fully exploit the digital opportunities and overcome the unhowever said before doing so, one needs to make sure they gain enough information so that they can make informed and profitable trading decisions.

"Like in any business, before you put your money one needs to know everything there is about that business. Same for this, you need to be well informed and understand how it goes then start trading," he noted.

In the ACEX platform there will be a handful of verified people who will be known as merchants who will be allowed to engage in the business of converting \$XTEM to fiat (nationally issued currencies) and vice versa.

According to ACEX these merchants will be cast across all regions of Africa to facilitate smooth financial transactions because their fee will be minimal. These merchants will additionally be solving the issue associated with foreign remittances on the African continent.

### Jata, Jica in talks with Iringa municipal officials to recycle waste

IN a bid to help Iringa Municipality successfully reduce disposal of waste products, JATA and Japan International Cooperation Agency are in talks to invest in a recycling plant for the purpose.

In a statement o Friday, JICA said after the JATA delegation visited the municipality, they agreed on the need to make sure that increased waste products be utilized to manufacture some useful things for use in daily life.

JATA Chairman, Gregory Mlay said that among other areas, the association is now looking for better ways of recycling the waste as a way of sustainably improving liquid and solid waste in municipality. "Iringa has emerged as one of the regions that properly manages its sanitation system and has been awarded by environmental groups for that. The municipality is well supplied with large plastic containers for storing garbage but it seems that the volume is sharply rising which is an opportunity for recycling of household waste," Mlay said.

According to him, JATA which also provides sensitization to the public on waste management, wants to encourage safe disposals of waste which favours environment conservation by throwing garbage in containers.

Iringa Municipal Mayor, Ibrahim Ngwada commended JATA's move saying they have also assisted to sensitise the public on proper waste disposal instead of the popular practice of dumping wastes clan-

"The municipality faces a big shortage of garbage collecting trucks. We therefore ask the community to stop dumping hot waste in containers because they cause damage to the storage facilities," Ngwan-

He said the council plans to continue repairing the damaged garbage containers regularly while conducting sensitization to ensure that the municipality remains

During the visit in Iringa, the JATA delegation had an opportunity to visit a sewage system which was constructed with funding from JICA training alumnae who is currently Iringa District Council Environmental Health Officer, Christian Ndenga.

Ndenga suggested that there is need to engage stakeholders in dealing with solid wastes management to see how best to control before dumping. He pointed out that there is also need to sort waste material before throwing into containers or the

"The council has 18 groups which are in training of wastes collections and recycling, however, waste sorting skills remain a major challenge," he said. ### Egypt plans to manufacture \$20,000 electric vehicles in bid to go green

Egypt is joining the Middle East's push to adopt electric cars with a state-owned company contracted to build affordable vehicles with a Chinese firm, taking advantage of the country's renewable energy boom to power them.

Authorities are in contact with three potential companies as they seek a partner for El Nasr Automotive Manufacturing on the project that

will see 2 billion Egyptian pounds (\$127 million) invested, Public Enterprise Minister Hisham Tawfik said in an interview, without giving names. Production is set to begin in 2023, with output increasing to an annual 20,000 units over three

Mr Tawfik said Egypt's electric model, to be named either E70 or A70, will sell for about \$20,000, The first wave of 3,000 charging with half of buyers probably taxi or Uber drivers. That is roughly the

same price as Europe's cheapest EV, Renault's Dacia Spring, which is made in China.

The secretariat is collaborating with the International Organization for Migration (IOM) in the implementation of the water, sanitation and hygiene (WASH) project.

Water harvesting facilities have been established at Musanze, Nyagatare, Rubavu and Kihere districts in Rwanda, and hand-washing facilities have been finalized at Mutukula and Namanga border points in Tanzania.

### AfDB invests US\$170m in Nigeria's digital future

### **ABIDJAN**

The African Development Bank (AfDB) has approved a loan of US\$170-million to finance a digital and creative enterprises program in Nigeria. According to the organisation, the investment in Digital and Creative Enterprises Program (i-DICE) is a Federal Government of Nigeria initiative promoting investment in digital and creative industries.

The program targets more than 68 million Nigerians aged 15 to 35 years "who are recognised as leaders of innovative, early-

stage, technology-enabled start-ups or as leaders of creative sector micro, small and medium sized enterprises." The program is co-financed by the Agence Française de Développement (AFD) and the Islamic Development Bank (IsDB).

"Governments have a much greater role than just policy making. They need to be innovative and create an enabling environment that includes infrastructure and de-risking to harness private sector investments in key growth sectors," said African Development Bank President Akinwumi A. Adesina.

Enterprises Program will also support the leaders through enterprise support organisations - groups that support, train, and sometimes fund entrepreneurs including innovation hubs, accelerators, venture capital and private equity firms. Bank financing of i-DICE will help the Government initiative further consolidate Nigeria's position as Africa's leading startup investment destination and as a youth entrepreneurship hub.

"This program is among the latest series of our operations meant to bolster the

The investment in Digital and Creative implementation of the Bank's Jobs for Youth in Africa Strategy. Given that tech-enabled enterprises cut across all the economic growth sectors, the program's focus on the digital sector will deepen Nigeria's job creation efforts," said Beth Dunford, Bank Vice President for Agriculture, Human and Social Development.

AfDB and the Nigerian government said the initiative will stimulate investments in 226 technology and creative start-ups and provide non-financial services to 451 digital technology and small and medium

The program is also expected to create 6.1 million direct and indirect jobs, of which the Bank's financing will support the creation of about 850,000 jobs. The value added to the Nigerian economy connected to the program is estimated at US\$6.4-billion.

The program will boost Nigeria's venture capital market through independently managed funds focusing on digital and creative enterprise. These funds aim to attract an initial capitalization of \$433 million in private and public sector financing.

### The world wants more Lithium but doesn't want more mines

**NEW YORK** 

Prices for lithium, the building block of electric-vehicle batteries, shot to a record this year, amplifying concerns there won't be enough of the metal to fuel the switch away from combustion engines. In that climate, now should be a prime time to build a mine.

Rio Tinto Group is finding out otherwise. Within months of unveiling plans for a \$2.4 billion mine in western Serbia, local opponents organised a movement that's rocked the government and brought cities to a standstill as thousands of protesters march in the streets. Authorities subsequently suspended a landuse plan for the proposed mine, though they didn't reject the project completely.

"The entire Jadar project is just another way for multinational companies, with the help of our state, to make profit and cause damage to the people of Serbia," said Slavisa Miletic, an activist living near the planned mine.


The opposition Rio faces is replicating around the world, and

industry executives consider it their biggest challenge going forward. Southern Copper Corp. is struggling to get government support for a controversial \$1.4 billion project in Peru, and Lithium Americas Corp. was taken to US federal court over its planned mine in Nevada.

Historically, mining offered jobs and economic development to typically poor areas, with taxation and royalties to fill government coffers. But all too often, people living nearby paid a price for environmental degradation and occasional catastrophe.

That's changing. Locals are pushing back, deciding that the economic benefits don't outweigh the costs to their quality of life. Governments also are increasingly unwilling or unable to override those concerns. "It's become more difficult to build a mine today than it ever was before," said Ben Davis, a mining analyst at Liberum. "It's far easier to organise opposition, often in rural and isolated communities."

To placate critics, the Serbian government offered a referen-

dum on the mine, but that itself became controversial, with the opposition saying recent legal revisions tilted the balance in the government's -- and Rio's – favour.

Protesters also blasted an effort to speed up ownership changes for both state and private projects. The outrage forced President Aleksandar Vucic to send the proposal back to parliament for reworking.

"Environmental issues were long neglected in Serbia because economy and living standard dominated for years," said Bojan Klacar, director of the Belgrade-based Center for Free Elections and Democracy, or CESID. "Priorities have changed." A few thousand Serbians protested for a fourth weekend in several cities, demanding an unconditional ban on lithium exploration and mining by any company, not just Rio Tinto. At the largest rally, in the capital Belgrade, activists vowed to step up their protests if their demands are not met by next month. When Rio, the world's secondbiggest miner, announced the project in July, it seemed like a slam dunk for new Chief Executive Officer Jakob Stausholm.

Lithium is a future-facing commodity critical for global decarbonisation. The biggest automakers, from Tesla Inc. to Volkswagen AG to Toyota Motor Corp., need an ever-growing supply of battery materials to accelerate the roll out of EVs, with BloombergNEF expecting demand for the minerals in lithium-ion packs to grow fivefold by 2030. A global index of lithium prices has more than tripled this year, and BNEF forecasts that lithium-ion battery prices will increase next year for the first time since 2010. Plus, the mine would be built on farmland, not virgin forest, and be just a 10-hour drive from Germany's car-making epicenter. The project, which Rio says could create more than 2 000 jobs, is scheduled to open in 2026 and hit full production in 2029. Yet that laundry list of supposed benefits doesn't matter to many. Mining's dark past includes a plethora of deadly disasters, from cyanide

leaks to dam collapses. Just last year, Rio's CEO was forced out after the company destroyed an ancient Aboriginal site at Juukan Gorge in Australia. "We do have a history of things in our organization that we're not proud of, and Juukan is No. 1 on that list," said Sinead Kaufman, head of the Rio unit planning to build the Serbian mine.

And it's not just lithium that's becoming problematic. Copper is an essential metal for the energy transition, with demand expected to grow by almost 50% in the next decade, according to Chilean miner Antofagasta Plc. Mines typically take about 15 years to go from discovery to production.

Even so, many of the best prospects are in limbo. Rio's proposed Resolution copper mine in Arizona, which could satisfy a quarter of US demand, is being reviewed by the federal government after opposition from the San Carlos Apache tribe, whose leader refused to meet Rio's CEO earlier this year. "Despite mining's contribution to almost every aspect of modern life, the industry is still seen as one that takes more than it gives," Mark Cutifani, CEO of Anglo American Plc, said in a speech in London this month.

## Record high coal power demand in 2021 threatens net-zero targets, IEA says

**PARIS** 

Global coal-generated power demand is expected to hit record highs this year, threatening the world's net-zero targets aimed at cutting greenhouse gas emissions, the International Energy Agency

Power generation from coal globally is expected to jump by 9 per cent in 2021 to an all-time high of 10,350 terawatt-hours, driven by rapid economic recovery that has pushed up electricity demand much faster than low-carbon supplies can keep up, the IEA said in its latest annual market report.

Overall, coal demand worldincluding uses beyond power generation, such as cement and steel production - is forecast to grow six per cent this year, according to the IEA's Coal 2021 report. Depending on weather patterns and economic growth, overall coal demand could reach new all-time highs as soon as 2022 and remain at that level for the following two years, underscoring the need for "fast and strong" policy action, the agency said.

"Coal is the single largest source of global carbon emissions, and this year's historically high level of coal power generation is a worrying sign of how far off track the world is in its efforts to put emissions into decline towards net zero," Fatih Birol, executive director of IEA, said. "Without strong and immediate actions by governments to tackle coal emissions - in a way that is fair, affordable and secure for those affected - we will have little chance, if any at all, of limiting global warming to 1.5 °C." In China, where more than half of global coal-fired electricity generation takes place, coal power is expected to grow by 9 per cent in 2021, the IEA said.

In India, it is forecast to grow 12 per cent this year. This would set new all-time highs in both coun-


tries, even as they roll out significant amounts of solar and wind capacity. "The pledges to reach net zero emissions made by many countries, including China and India, should have very strong implications for coal - but these are not yet visible in our near-term forecast, reflecting the major gap between ambitions and action," Keisuke Sadamori, director of energy markets and security at IEA,

Asia is dominating the global coal market, with China and India accounting for two-thirds of overall demand, Mr Sadamori said. These two economies - dependent on coal and with a combined population of almost 3 billion people - hold the key to future coal demand, he added.

In 2020, global coal demand fell 4.4 per cent, the largest decline in decades but much smaller than the annual drop that was initially expected at the height of the lockdowns early in the pandemic, the report showed.

Coal prices have been on a rollercoaster ride over the past two years. After falling to \$50 per tonne in the second quarter of 2020, they started to climb towards the end of the year, with supply cutbacks balancing the market before rebounds in economic activity and coal demand in China started pushing prices up.

In 2021, prices were lifted further by demand outstripping supply in China - the global coal price setter - as well as by supply disruptions and higher natural gas prices globally. Coal prices reached alltime highs in early October 2021, with imported thermal coal in Europe, for example, hitting \$298 per tonne. Quick policy intervention by the Chinese government to balance the market had a fast effect on prices. As of mid-December, European prices were back below \$150 per tonne.

## Voters give scandal-hit UK PM 'a kicking' with by-election loss

LONDON

BORIS Johnson's Conservatives on Friday lost control of a parliamentary seat they have dominated for nearly 200 years, ratcheting up the pressure on Johnson from his law-makers, who are in mutinous mood after a series of crises and scandals.

The defeat was described as 'a kicking' for the Conservatives, substantiating fears expressed publicly and privately that the party's reputation and electoral prospects are now suffering under Johnson's leadership.

The centrist Liberal Democrats party candidate, Helen Morgan, won the North Shropshire seat by nearly 6,000 votes, overturning a 23,000-vote Conservative majority from 2019.

"Our country is crying out for leadership. Mr Johnson, you're no leader," Morgan said in her victory speech.

The Conservatives had won every previous election for the mostly rural area of central England since the constituency was created in its current form in 1983. Conservative lawmakers have been dominant in the region for nearly 200 years.

The huge swing comes as British Prime Minister Johnson faces criticism on several fronts, including over reports his staff held

parties last Christmas when the country was

"Voters in North Shropshire were fed up and they gave us a kicking and I think they wanted to send us a message," Conservative chairman and lawmaker Oliver Dowden told Sky News. "I want to say as chairman of the Conservative Party, we've heard that loud and clear."

Nationwide opinion polls show Conservatives falling behind their main rivals, the Labour Party, following an outcry over law-makers' second jobs, criticism of the way Johnson funded the lavish refurbishment of his flat, and a surge in COVID-19 cases.

"This has to be seen as a referendum on the prime minister's performance," Conservative lawmaker Roger Gale, a long-standing critic of Johnson, told the BBC.

"The Conservative Party has a reputation for not taking prisoners. If the prime minister fails, the prime minister goes."

### Sleaze row

The vote for the North Shropshire seat, one of 650 in Britain's parliament, was called outside of the regular election cycle because the incumbent Conservative resigned after he was found to have broken rules on paid

lobbying.

The government attempted to prevent that resignation by changing rules designed to stop corruption in parliament, but was forced to backtrack after the move provoked a backlash over integrity and trust under Johnson's leadership.

British voters often use such by-elections to punish the ruling party, but the scale of the Liberal Democrat victory suggests deep public dissatisfaction with Johnson's government.

It still holds a large majority of the seats in parliament after a comprehensive election win in 2019 built on a promise to 'Get Brexit Done' that united traditional right-leaning Conservative voters with a swathes of new supporters.

North Shropshire was a pro-Brexit, staunchly Conservative area. Analysts say yesterday's heavy defeat may further undermine Johnson's authority over lawmakers, some of whom are already in open revolt over plans to introduce COVID-19 passports.

"He needs to change now. He needs to listen to the views of his party," said a senior Conservative lawmaker, who spoke on condition of anonymity. He described Johnson as a talented communicator in need of a better team of advisers.

Any leadership challenge would require 54 of the party's elected lawmakers to formally register their lack of confidence.

For now, that does not seem an imminent threat, with most of Johnson's toughest critics stressing the need for him to improve rather than calling outright for him to go

Britain's next national election is due in 2024.

### Chinese envoy: Democracy not a one-size-fits-all product

### CANBERRA

DEMOCRACY is not a one-size-fitsall product that has only one model or configuration for the whole world, a senior Chinese envoy in Australia said.

"Whether a country is democratic or not should only be judged by its own people," Wang Xining, charge d'affaires of the Chinese Embassy in Australia, said in an article titled "Why China's 'people's democracy' is a high-quality democracy" which was published in The Canberra Times on Wednesday.

"Democracy, ultimately, is whether the people can truly be the masters of their own country," Wang said, noting that the whole-process people's democracy created by the Communist Party of China has secured extraordinary historical achievements.

In the article, Wang explained the whole-process people's democracy in China, which includes democratic elections, consultation, decision-mak-

ing, management and supervision. "It is a model of socialist democracy that covers all aspects of the democratic process and all sectors of society."

He pointed out people in some Western countries are awakened only to cast a vote but become dormant afterwards; they are offered great hopes during electoral campaigning but have no say afterwards; and they are offered fulsome promises during electoral canvassing but are left empty-handed afterwards. "That is no true democracy," he added.

"There is no best democracy, only better"

China never exports its democratic model as every country has the right to choose a democratic system that suits its own national conditions, he said, noting that history has repeatedly proven that "it is not feasible for China to copy the political system of other countries."

"We should adopt an attitude of inclusiveness, learn from the strengths of others, digest and absorb them in the light of China's national conditions, so that we can turn them into our own strength, better ensuring that the Chinese people are the true masters of the country."

### EU leaders struggle to find common ground on travel curbs

### BRUSSELS

DIVISIONS within the European Union have deepened over travel rules to curb the spread of the Omicron variant of coronavirus, after Italy and Greece followed Portugal and Ireland in announcing additional curbs on travelers from other EU states.


The EU's 27 member states have been debating for weeks how to coordinate travel policy, with the aim of containing the virus without disproportionately disrupting travel within the border-free European Schengen

However, Italy said on Tuesday that from Dec 16 until the end of January it would require all travelers from EU countries to show a negative test on arrival, even if they are vaccinated.

The unvaccinated will face a five-day quarantine.

If applied strictly, the rules - which take effect on Thursday - would effectively restore frontier checks at Italy's land borders, echoing measures adopted by EU countries at the start of the pandemic. These triggered queues at the borders and caused shortages of food and medicines around the bloc.

"I have only seen that closing borders is in any case not the solution," Luxembourg's Prime Minister Xavier Bettel told reporters as he arrived for a summit of EU leaders in Brussels. The summit conclusions say any restrictions should be coordinated, based on objective criteria, and should not "disproportionately hamper free movement between Member States".

Latvian Prime Minister Krisjanis Karins said freedom of travel inside the EU must not end.

### Certificate

An EU diplomat was more explicit: "Adding tests to vaccine certificates means undermining the value of the COVID-19 certificate."

The EU introduced its COV-ID-19 certificate in July. It allows holders to travel freely across EU borders if they have been vaccinated against the disease, have recovered or have had a recent negative test.

The European Commission proposed on November 25 a tweak to the COVID pass that would make proof of vaccination sufficient for unhindered movement across the EU for nine months after completion of the primary vaccination cycle.

The proposal has not yet been approved by member states. Portugal introduced a requirement for additional negative tests on the very day the Commission made its proposal. Ireland mirrored that move a few days later.

Greece announced the same measure on Wednesday, to take effect on Dec 19. Prime Minister Kyriakos Mitsotakis said it would apply only for the Christmas period and was meant to gain time against the spread of Omicron as Greece sped up its campaign to give a booster dose to all adults. **Agencies** 

### Russia warns EU against hindering recognition of vaccine passports – diplomat

### MOSCOW

MOSCOW has cautioned the European Union against politicizing and hindering efforts to mutually recognize vaccine certificates, Russian Deputy Foreign Minister Alexander Grushko told TASS yesterday.

"We are working on the issue, we hope that results will be achieved quite quickly. We believe that since it is about making life easier for people and ensuring freedom of movement, the EU will neither politicize the process nor create artificial obstacles," he pointed out.

Russia and the EU are in talks on mutually recognizing coronavirus vaccine passports. The European Medicines Agency has still not approved Russia's Sputnik V jab for use in the European Union.

Member states that use Sputnik V (namely Hungary) have the right to issue EU digital vaccine certificates to those inoculated with Sputnik V, but other EU nations can act at their own discretion as to whether they will accept these documents or not.

### S.Africa: Vaccines, prior infection leading to mild COVID-19 cases

### JOHANNESBURG

SOUTH Africa's health minister said yesterday that the government believed that vaccines and high levels of prior COVID-19 infection were helping to keep disease milder in a wave driven by the Omicron variant.

There have been early anecdotal accounts suggesting that the Omicron variant driving the fourth wave, which saw the country report a record number of daily infections earlier this week, is causing less severe illness than previous variants in South Africa but scientists say it is too early to draw firm conclusions.

"We believe that it might not necessarily just be that Omicron is less virulent, but ... coverage of vaccination (and) ... natural immunity of people who have already had contact with the virus is also adding to the protection," Health Minister Joe Phaahla told a news conference. "That's why we are seeing mild illness."

South Africa has given 44 percent of its adult population at least one dose of COVID-19 vaccine, more than many African countries but well short of the government's year-end target. But among the over-50s vaccination coverage levels are over 60 percent.

In another development, South Africa said it would donate roughly 2 million doses of Johnson & Johnson's

COVID-19 vaccine to other African countries.

The shots will be made available over the next year through a medical supplies platform set up by the Afri-

can Union.

"This donation embodies South Africa's solidarity with our brothers and sisters on the continent with whom we are united in fighting an unprecedented threat to public health and economic prosperity," the South African government said in a joint statement with an AU vaccine task team.

### Africa calls for addressing health challenges with new public health order

### ADDIS ABABA

COUNTRIES in Africa have called for addressing longstanding health challenges on the continent through a new public health order, officials and experts said here at a conference on Thursday.

The first international Conference on Public Health in Africa, which started on Tuesday, was co-hosted by the African Union and Africa Centers for Disease Control and Prevention.

The three-day event tackled the issue of vaccine inequity and weak health systems in Africa, as well as the impact and lessons learned from the ongoing COVID-19 pandemic. The conference was held at an important time in history, said Chairperson of the African Union Commission Moussa Faki Mahamat.

"The African continent has not been spared the devastating effects of COVID-19, pushing our health systems to the limits," Mahamat said. Mahamat said the African Union's new public health order needs continental collaboration to bolster African manufacturing capacity for vaccines, diagnostics and therapeutics.

He stressed the need to strengthen public health institutions for people-centered care, expand the public health workforce, establish partnerships and engage with the private sector.

President of Rwanda Paul Kagame, who is also the union's champion for domestic health financing, also echoed Mahamat's remarks.

"This has been a priority of the African Union for several years, but progress has not been fast enough. We cannot continue to rely on external funding for something so important to our future," said Kagame.

### Britain's race to jab millions won't prevent case surge in coming weeks - experts

### LONDON

THE British government's decision to ramp up vaccination in response to the new COVID-19 variant Omicron will take time to bring any benefit and may not prevent a surge in cases over the next

few weeks, experts have said.
"Given the very high transmissibility of the Omicron variant and its ability to, at least partially, evade immunity, it should be clear that a rapid response is needed.

Instead, we have a policy based almost entirely on increasing vaccination rates that will take weeks to bring any benefit," Martin McKee, professor of European public health at the London School of Hygiene and Tropical Medicine, told Xinhua on Tuesday.

"This is an inevitable con-

"This is an inevitable consequence of the disagreements within the ruling Conservative Party. It is a political rather than a scientific decision," the expert said.

British Prime Minister Boris Johnson recently launched the "Omicron Emergency Booster National Mission" to encourage everyone eligible to "get boosted now."

Everyone aged 18 and over in England will have the chance to get their booster vaccine before the end of the year to combat the threat of rising Omicron variant cases.

The prime minister has also announced that England will move to "Plan B" amid the rapid spread of Omicron in Britain, including a requirement for millions of people to work from home and mandatory face-mask wearing in a wider range of locations.

"The UK government has placed enormous emphasis on vaccines as the means of preventing the need to reimpose COVID restrictions. There was always a risk that a surge in cases could undermine that strategy," social policy expert Dr Stuart Wilks-Heeg from the Univer-

sity of Liverpool told Xinhua.
"The sudden emergence of
the highly transmissible Omicron variant in the run-up to
Christmas has made new restrictions inevitable.

Yet, the government's emphasis remains on vaccinations," said Wilks-Heeg. "Even with new rules on mask-wearing in public places and COVID passports for large events, it is a race that the UK's National Health Service is likely to lose," he added. "My view is that the govern-

ment, under pressure from the medical and scientific advisers, is erring on the side of caution while awaiting more extensive information on the risk from the Omicron variant," said Professor Iain Begg, an expert in politics at the London School of Economics and Political Science.

Britain reported 78,610 new cases on Wednesday, the highest daily infections since the start of the pandemic, bringing the national caseload to 11,010,286, according

Agency. Another 4,671 Omicron cases have been confirmed in Britain on the same day, the biggest daily increase since the COVID-19 variant first detected in the country, taking the country's total Omicron cases to 10,017.

### Sputnik V works better than other vaccines against Omicron strain, says Putin

### **MOSCOW**

THE Russian Sputnik V vaccine works better against the new Omicron strain than other vaccines used globally, President Vladimir Putin said at a plenary session of the 30th congress of the Russian Union of Industrialists and Entrepreneurs (RSPP) on Friday.

"It seems today that our Sputnik V works well and, probably, even better against Omicron than other vaccines used globally," he said, adding that experts would provide the final estimation on the efficiency of Sput-

nik V against the Omicron strain in the coming days.

Moscow is ready to provide the one shot vaccine Sputnik Light for other countries to use as a booster, including the European states, Putin noted. "We can even share vaccines we have with other countries, I mean as a booster, including with European countries as well," he said.

"We are ready to provide Sputnik Light to the countries that would like to use it for booster shots. We have got the sufficient volume to share it with other countries," the Russian president

### **Afghan Taliban leaders appeal for** help as migrant crisis looms

### **KABUL**

SENIOR Taliban officials appealed on Saturday for international help to combat a deepening economic crisis that has fueled fears of another refugee exodus from Afghanistan.

The comments, at a special meeting to mark the UN's international migrants day, underlined the new Taliban government's push to engage with the world community, four months after they seized power in Kabul.

The movement's deputy Foreign Minister, Sher Mohammad Abbas Stanikzai, said it was the responsibility of countries like the United States, which have blocked billions of dollars of central bank reserves, to help Afghanistan recover after decades of war.

"The impact of the frozen funds is on the common people and not Taliban authorities," he told the conference, attended by representatives of the International Organization for Migration and UNHCR, the United Nations refugee or-

UN bodies estimate that millions of Afghans could face hunger over the winter without urgent help, but aid has been hampered by international unwilling-

ness to engage directly with the Taliban,

in part because of concern over rights

for women and political inclusion.

The abrupt withdrawal of foreign aid following the Taliban victory has pushed Afghanistan's fragile economy close to collapse. Millions are without work and the banking system is only partially functional.

"If the political and economic situation doesn't change, there will be more migration," Stanikzai said.

The United States has issued guidance that would permit personal cash remittances to Afghanistan but it has not relented on its refusal to release the \$9 billion in central bank reserves or lift sanctions on a number of Taliban lead-

Taliban Foreign Minister Amir Khan Muttaqi met representatives from the International Committee of the Red Cross on Saturday in Islamabad, ahead of a meeting of foreign ministers from the Organisation of Islamic Cooperation to discuss the situation in Afghanistan.

He said the Taliban welcomed international humanitarian organizations and gave assurances that they would be allowed to work unimpeded.

### Presidential election in Libya face uncertainty as scheduled date approaches, says analysts

THE voting process in Libya will face significant challenges as the election date approaches, according to political analysts in the northern Africa

The political division that followed the technical preparations for Libya's presidential elections, according to analysts, made it a challenging process that could not be held on December 24 as planned.

More than 2.5 million Libyan citizens are expected to vote in the presidential elections on December 24, according to a roadmap set by the UNsponsored Libyan Political Dialogue Forum.

The High National Electoral Commission in Libya postponed the publication of the official list of candidates, which was due at least 15 days before the election, on December 11, saying it planned to conduct judicial and legal procedures related to the election.

The Libyan parliamentary elections, originally planned to be held on the same day as the presidential poll, have been postponed to January 2022. After the delay of presidential candidates publication, Libyan political analyst Faraj al-Dali believes that the decision to postpone the elections has already been made and would be revealed in a few days.

"The Elections Commission's failure to publish the final list of candidates would indirectly push towards the postponement of the elections," said

al-Dali. Abubakr Mahmoud, a Libvan political analyst, said that holding presidential elections on December 24 is no longer feasible, and a new date must be selected that is acceptable to all parties.

Miloud al-Haj, a Libyan law professor, believes that the controversial presidential candidates are a major cause to affect the chance of holding the elections on time.

"Since a number of controversial figures, primarily Saif al-Islam Gaddafi, announced their candidacy for the presidential elections, the electoral process has reached a clear polarizing phase," said al-Haj.

"I don't think many Libyans will accept Muammar Gaddafi's son to return to power, especially given the legal persecutions he faces both at home and abroad," he added. Saif al-Islam Gaddafi, son of the late leader Muammar Gaddafi who was toppled and killed in 2011, announced running for president in November. However, he is facing several legal issues in Libya and abroad.

The International Criminal Court issued a red notice against Saif al-Islam Gaddafi for alleged war crimes committed in Libya in 2011.

Later in November, a group of unidentified gunmen attacked a Libyan court in the southern city of Sebha, as the court was processing an appeal by Saif al-Islam Gaddafi against his presidential election campaign being rejected. Libya has been suffering insecurity and political instability since the fall of the late leader Muammar Gaddafi's regime in 2011.

### Social media threat of 'Nationwide School Shooting' proves 'uncredible' - US Authorities

DUE to the continued incidence of student-perpetrated school shootings around the United States, school officials nationwide went to heightened alert Friday in reaction to an unspecified threat of on-campus violence that was proved to be faux by the authority

The rumors circulating on social media proclaimed Friday, Dec. 17, as the grisly "National School Shooting Day."


The Los Angeles Unified School District (LAUSD), responded quickly, saying in a statement Friday that, "In recent days we have become aware of various threats of violence towards our

The safety and well-being of our students and employees is of utmost importance," the statement asserted.

"While there is no reason to believe our schools are in danger, please know we take all such threats very seriously and take any action necessary to ensure the continued safety of our school communities," the LAUSD said.

LAUSD is the largest public school system in California and the second largest public school district in the United States with over 730,000 students and employees.

The statement added that, where warranted, LAUSD school administrators would work with school site staff, LA school police, and federal and local school officials to ensure that all threats are fully investigated

"Local law enforcement continues to work with our district to support the safety of our students and staff," affirmed LBUSD spokesperson.

However, the Santa Clarita Valley Sheriff's Station was tasked with continuing to monitor the situation and assigned additional patrol checks throughout schools.

school districts in other states around the country are reported to have responded more vigorously to the rumored threat, prompting early school shutdowns on Friday in areas in Texas, Minnesota, Missouri, Montana. central New York and Connecticut, reported the New York Times.

The country's four largest school districts - New York City, Los Angeles, Chicago and Miami did not shut down.

The scare is reputed to have begun on some social media platforms, with a warning that a nationwide campaign of on-campus gun violence would start on Friday, but an unnamed source on one of the platforms discounted that assertion as only a rumour.

The U.S. Department of Homeland Security itself also announced on Friday that it has no evidence of credible threats - but urged the public to "remain alert." Or, as in the words of LAUSD's key policy regarding suspicious behavior or potential student threats, "If you see something, say something."

### China's designation of river, lake chiefs yields notable results

CHINA'S practice in the past five years has fully proven that the implementation of the system of river and lake chiefs across the board is completely in conformity with the country's national and water conditions, is a fundamental and groundbreaking policy on the protection and governance of rivers and lakes, and represents a major institutional innovation with strong vitality.

Over the past five years, China's Ministry of Water Resources (MWR), together with various regions and departments in the country, has promoted the solving of many tough problems in the protection and governance of rivers and lakes that were long on the agenda but never resolved, bringing historic changes to rivers and lakes in China.

Since 2018, China has established the system of river and lake chiefs across the country. Under the system, major leaders of the Communist Party of China (CPC) committees and governments of 31 provincial-level regions in the country have been appointed as general chiefs responsible for all rivers and lakes in the region.

By designating a total of 300,000 river and lake chiefs at provincial, municipal, county, and township levels and more than 900,000 village-level river and lake chiefs (including river patrol personnel and river rangers), China has made sure the responsibility for the management and protection of all the rivers and lakes has been assigned.

The State Council of China has initiated an inter-ministerial joint conference on the comprehensive implementation of the system, established and improved mechanisms covering the fulfill-

ment of responsibility by river and lake chiefs, supervision and inspection, evaluation and accountability as well as positive incentives to promote the implementation of the system.

Nationwide efforts have also been made to establish provincial-level joint conference mechanism for river and lake chiefs in the Yangtze River and the Yellow River basins as well as joint prevention and control mechanism for coordination and collaboration between personnel in charge of the upstream section and downstream section and the right and left banks of rivers and lakes, inter-departmental joint response mechanism, the system of river patrol personnel and rangers, the system of folk river chiefs, and joint governance mechanism for all sectors of the society, which leads to the forming of a powerful synergy for the conservation of rivers and lakes.

Local governments across the country have established archives and formulated targeted policies for each river, and clearly defined the boundaries of 1.2 million kilometers of rivers and 1,955 lakes for management and control for the first time.

Besides, local authorities have also carried out a special campaign to regulate illegal riverside occupation, mining, heap and construction and special operations to overhaul projects along the shorelines of the Yangtze River and the Yellow River, addressing 185,000 prominent problems, demolishing more than 40 million square meters of illegal construction projects and over 10,000 kilometers of illegal dikes, removing more than 40 million tons of garbage from watercourses, clearing 30,000 kilometers of illegally occupied shorelines, and seizing over 11,000 ships for illegal sand mining.

Since northern China made comprehensive efforts to stem groundwater overexploitation, groundwater levels in some regions have stopped falling and started to rise, many river courses in north China which had been cut off for years, such as Yongding River, Daqing River, Hutuo River, and Ziya River, have been fully connected, and the Baiyangdian Lake in north China's Hebei province has regained its beauty.

All cities at or above the prefecture level have basically eliminated all of their "black and odorous" water bodies.

In 2020, the proportion of water sections with excellent or good surface water (Class I to Class III) increased by nearly 16 percentage points from 2016.

By promoting the implementation of the river and lake chief system across the board, China has focused its efforts on addressing the most pressing, immediate water-related problems that concern the people the most and created a pleasant environment featuring unimpeded rivers, lucid waters, green banks, beautiful scenery, and harmony between man and nature, winning widespread recognition from the people for the results of river and lake protection and control. **People's Daily** 

### **MADRID /CAIRO**

THE risk of reinfection with the Omicron coronavirus variant is more than five times higher and it has shown no sign of being milder than Delta, a study showed, as cases soar across Europe and threaten year-end festivities.

The results of the study by Imperial College London were based on UK Health Security Agency and National Health Service data on people who tested positive for COVID-19 in a PCR test in England between Nov 29

"We find no evidence (for both risk of hospitalization attendance and symptom status)

of Omicron having different severity from Delta," the study said, although it added that data on hospitalizations remains very limited.

"Controlling for vaccine status, age, sex, ethnicity, asymptomatic status, region and specimen date, Omicron was associated with a 5.4-fold higher risk of reinfection compared with Delta," the study, which was dated Dec 16, added.

The protection afforded by past infection against reinfection with Omicron may be as low as 19 percent, Imperial College said in a statement, noting that the study had not yet been peer reviewed.

The researchers found a significantly increased risk of developing a symptomatic Omicron case compared to Delta for those who were two or more weeks past their second vaccine dose, and two or more weeks past their booster dose.

The study involved AstraZeneca and Pfizer vaccines.

Depending on the estimates used for vaccine effectiveness against symptomatic infection from the Delta variant, this translates into vaccine effectiveness of between 0 percent and

20 percent after two doses, and between 55 percent and 80 percent after a booster dose.

Study: Omicron more likely to reinfect than Delta, no milder

"This study provides further evidence of the very substantial extent to which Omicron can evade prior immunity given by both infection or vaccination," study lead Professor Neil Ferguson said in ICL's statement.

"This level of immune evasion means that Omicron poses a major, imminent threat to public

But Dr Clive Dix, former Chair of the UK Vaccine Taskforce, said it was important not to overinterpret the data.

"The conclusions made are based on making assumptions about Omicron where we still don't have sufficient data," Dr Dix said. "For example, we have no data on the cellular immune response which is now probably driving effectiveness of vac-

"This is a crucial missing assumption in the modelling."

Some of the conclusions are different to the data emerging from South Africa, where vaccines are holding up well against severe disease and death at present, he said. "There is a huge amount of uncertainty in

these modelled estimates and we can only be confident about the impact of boosters against Omicron when we have another month of real-world data on hospitalization ICU numbers and deaths," he said.

Egypt reported its first three cases of the new coronavirus variant Omicron, the health ministry said in a statement on Friday. "Two cases are not showing any symptoms, while the third suffers mild symptoms," the ministry said.

### **Xavi: Barcelona have** 'lost' club's model of play

XAVI Hernandez says Barcelona have lost their identity during the six years he's been away from the club after his side left it late to beat Elche 3-2 on Saturday.

Nico Gonzalez struck the winner in the 85th-minute as Barca recovered from squandering a twogoal lead at Camp Nou to end a run of three games without a win.

Xavi left Barca as a player in 2015 after winning the Treble under Luis Enrique and admits he's been surprised by what he's encountered since returning as coach last month.

"We've lost [Barcelona's] model of play and we have to bring it back," Xavi said in his post-game news conference.

"I have not been here for six years and there are things that have surprised me tactically. I wasn't here so I don't know who's responsible for it, but it's making [the job] hard for us.

"The large majority [of players] don't understand positional play. There are mechanisms that I understood from the age of 11 and we have players here that haven't worked on them."

The win against Elche moved Barca up to seventh in LaLiga following the disappointment of being knocked into the Europa League last week and the draw against Osasuna.

To turn things around, Xavi has turned to youth, with players still technically registered with the B team scoring all three goals against Elche.

Ferran Jutgla, 22, opened the scoring on his first start for the club with Gavi, 17, scoring the second goal and then creating the winner for Nico, 19.

"You can only take you hat off for that performance from Gavi," Xavi added. "It's spectacular how he plays. Along with Nico, Abde [Ezzalzouli], [Ronald] Araujo, [Alejandro] Balde... they're the future of the club.

"I played here when I was 18 and I was scared. These guys are bursting with personality. I'm delighted with this generation, Gavi is especially ex-

"What's most surprising about Gavi is his age, he's 17. Look at how he's competing. Today he made the difference with a goal and an assist. I don't want to compare him with anyone, just make sure he doesn't put the brakes on because he has no ceil-

Xavi said the emerging generation of talent at Barca may prove "even better" than the generation he came through and played with under Pep Guardiola a decade ago.

"We're talking about seven players at a very good level who can make the difference," he said. "When I say they are making the difference, it's not a message for the veterans, but it's the kids scoring the goals and making them."

Jutgla and Gavi's efforts were cancelled out by two goals in two second half minutes from Elche substitutes Tete Morente and Pere Milla to spark memories of Barca's collapse against Celta Vigo, when they gave up a three-goal lead to draw 3-3.

However, substitute Nico's second goal in as many games earned Barca the three points and Xavi hopes it will be a turning point ahead of Tues-

"We hope this will be a point of inflection," the coach said. "We complicated things for ourselves. Elche survived on our errors and that cannot be the case. We have to learn and be more responsible.

"I was a little angry [after they equalised] because I wasn't imagining not winning the game. We deserved much more, but in the situation we're in, these are three golden points."

### Ancelotti: Barcelona not a 'direct rival' for LaLiga title

CARLO Ancelotti has said he now does not consider Barcelona "a direct rival" for the LaLiga title, with Real Madrid top of the table and Barca 18 points behind them in eighth place.

Madrid have won 10 consecutive games in all competitions -- including against top four contenders Atletico Madrid, Real Sociedad and Sevilla -while Barca have dropped points against Real Betis and Osasuna in their last two matches under new coach Xavi Hernandez.

Xavi had insisted on Friday that his team could still compete for the league, but Ancelotti was not convinced when that claim was put to him in a news conference on Saturday.

"A direct rival? No," Ancelotti said. "They're further back than Sevilla, Atletico, Betis. But Barcelona have the quality to fight until the end. If I were coach of Barcelona, I'd say exactly the same."

Madrid have faced a challenging week, with six players -- Luka Modric, Marcelo, Marco Asensio, Rodrygo, Gareth Bale and Andriy Lunin -and Ancelotti's son and assistant Davide all testing positive for COVID-19 ahead of Sunday's game with Cadiz.

"We've had setbacks," Ancelotti said.

"But those who have tested positive are all OK... Unfortunately, we have to live with this. We never thought about postponing the game. We have a squad that can deal with it. Football and society have to carry on, while taking into account that we have to be careful and take precautions."

"Whenever a citizen wants to know anything about COVID-19 he/she can access information through his/her mobile phone via dialing the number 199. He/she will find everything and will understand," Meena stated

She said there are various groups in the community and that they have therefore resorted to using influential people in the community to provide education to those groups especially young people, mothers, and girls, to protect themselves from the infection.

The Resident Director of Wateraid Tanzania, Anna Mzinga, said at a time when the world is in the grip of the disease, there is a need to devise various ways to deal with it, including using prominent people in the community.
