

# World Bank ups population fears, sees solution in girls' education

OMPLETING quality secondary education for girls is key to fertility reduction as well as child survival, improved child nutrition outcomes and overall enhanced welfare, the World Bank has declared.

Nathan Belete, the country director, issued this recommendation at the launch of the latest Tanzania Economic Update (TEU) themed 'Overcoming Demographic Challenges while Embracing Opportunities.'

ganisations as well as other instances of decision making, he said.

He welcomed government efforts to accelerate programmes to expand access to secondary education and strengthen completion rates for girls, while not leaving boys behind.

"Second, it is critical to scale up access to high-quality, affordable family planning or reproductive health services while addressing social norms using innovative approaches, including community outreach strategies, use of mobile units, and partnerships with



Focusing on accelerating the decrease in fertility as crucial for the country to obtain a demographic dividend, he said that embracing the demographic dividend agenda requires strong multisectoral coordination.

Such effort needs to bring together crucial departments such as finance, education, health, gender and engaging civil society or-

private sector outlets," he said.

Special attention needs to be given to poor and vulnerable women and young girls who are at a disadvantage due to geographic, socioeconomic and cultural barriers, he said.

He urged the government to step up interventions to improve child survival, lowering

## **BRELA wants CSR** 'charity' label nixed

THE Law Reform Commission of Tanzania yesterday met with stakeholders including advocates from public and private institutions to discuss reviewing some articles in the Companies Act and the Business Names Act to address what some stakeholders see as loopholes. The meeting was initiated by the Business Registrations and Licensing Agency (BRELA) in submitting to the commission a proposal to review some articles on the laws, seeking to remove the idea that 'corporate social responsibility' is charity.

Isdor Nkindi, the BRELA operations director, told journalists that many countries have made big steps in taking up CSR not as charity but a legal requirement for all companies.

Interviewed on the side-lines of the meeting in Dar es Salaam yesterday, he said the two laws have no major challenges but a few loopholes which affect effective compliance.

"We sat down with our experts and found that the laws have some challenges and in one way or another, leading to ineffective implementation of the CSR policy by companies," he said.

Expected changes in the laws will also improve the cooperation environment between big businesses and stakeholders, where communities expect to be considered part of their operations and plans.

He appealed to the business community to treat customers as vital stakeholders thus needing to ensure improving the environment of those they serve, underlining that CSR needs strong supervision, thus the law needs to be improved.

### 9 dead, 78 hospitalised in Pemba 'turtle' fiasco

EIGHT children and an adult died after eating sea turtle meat on Pemba Island mid last week while 78 other people were hospitalized, the government has said.

Hassan Khamis Hafidh, the deputy Health minister, told journalists here yesterday that 160 people were reported to have suffered from eating turtle meat at Panza village in Pemba South Region.

The deceased include eight children under the age of 10 and an elderly person, still getting treatment at the Abdallah Mzee Hospital in Pemba, he said.

Due to the food poisoning incident, the Health ministry moved to ban eating sea

# 'Droughts raise HIV risks in rural Africa'

DROUGHTS driven by climate change are increasing the risk of HIV infection among rural women in Sub-Saharan Africa by driving them into sex work, according to a five-country study. Researchers at the University of Bristol

in the UK writing for the World Health Organization that women in rural areas who had been exposed to drought were more likely to acquire HIV than those who had not been exposed to drought. Adam Trickey, a research fellow, says

that across the Africa region, around 25.6m people are living with HIV, while around 380,000 people will die from AIDS-related illnesses in 2022.

The researchers linked HIV prevalence data from more than 100,000 adults surveyed in Lesotho, Eswatini, Zambia, Tanzania and Uganda between 2014 and 2016 with historical rainfall patterns.

They observed that women living in drought-stricken rural areas had a higher likelihood of contracting HIV compared to their counterparts in unaffected regions or urban settings.

"We found that women in rural areas

stunting rates "to give parents the confidence to have fewer children." The World Bank sees the focus on adolescent girls as vital, to promote the economic empowerment of women and girls to support their reproductive health and strengthen health- seeking behaviour and investments in their children, he stated.

Reiterating the institution's commitment to family planning, he said that by empowering young people to make the right decisions about reproductive health, "we can reduce the problem of early pregnancies, thereby improving the lives of young people and their newborns."

The country office is committed to collaborate with the government to ensure that Tanzania seizes the opportunity to overcome demographic challenges for sustained economic growth and development, he affirmed.

turtle meat as it has potential for high toxicity due to the jellyfish they catch and eat in the sea.

Local experts list seven types of turtles where four types are seen as dangerous or harmful and should not be eaten, while the supposed exceptions can lead to disaster as was the case last week.

"It is difficult to detect a poisonous turtle among those seven types," the cabinet official noted, highlighting that sea turtle meat is considered a delicacy by various

deaths from chelonitoxism, a type of food poisoning, where Dr Farid Mpatani, the Chief Government Chemist (CGC) said turtles are poisoned by decarbamoylsaxitoxin, a poison embedded in the leaves and corals in the sea where turtles feed.

The habit periodically results in

The poison harms the human cognitive system leading to the loss of energy, numbness, vomiting and diarrhea that leads to death, where children under 15 years of age are more vulnerable.

In pleading for tolerance over the turtle delicacy culture, he said there are some creatures in the sea munity about not eating harmful that can eat poisonous plants and not cause harm to humans.

Fatma Mohamed Kabole, the deputy director for prevention and health education at the ministry, said that those affected come from different families, expressing the worry that some affected individuals are being hidden in homes.

"That's why we still believe that it is possible that the number of victims may rise as people are hiding information on some of those who ate the meat," she said.

The ministry will intensify the provision of education to the com-

sea creatures including turtles as there is no cure for the poisons likely to be ingested from these creatures, the director affirmed.

In November 2021, seven people, including a three-year-old, died on Pemba after eating turtle meat, with three others hospitalised.

Insiders say that communities living along the coastline have different beliefs about turtle meat and soup, some claiming that it has aphrodisiac properties also commonly associated with octopus meat for a section of city residents in Dar es Salaam.

who had been exposed to drought were more likely to acquire HIV than those who had not been exposed to drought," the researcher noted.

This was not the case, however, for women in urban areas or men in either rural or urban areas, in which case droughts, which have become more frequent and intense as a result of climate change, exacerbate existing vulnerabilities, particularly in rural communities heavily reliant on subsistence farming, he elaborated.

The study, published in the journal AIDS and Behaviour and funded by Wellcome, a health and wellbeing research trust, says that this translates to increased poverty and food insecurity, factors known to contribute to the spread of HIV.

Drought-induced hardship is often disproportionately borne by women, who may engage in transactional sex, particularly with older, richer men, to secure basic necessities.

The study also notes that droughts can exacerbate mental health issues and heighten genderbased violence, both of which are linked to risky sexual behaviours and can hinder access to vital HIV prevention and treatment services.

The researchers say their findings underscore the potential for a surge in HIV transmission if left unaddressed, with approximately 15 percent of habited land in Sub-Saharan Africa regularly experiencing drought, and showing high HIV prevalence.

One in five adults on the conti-

nent have HIV and the majority of the population relies on subsistence farming, creating a perfect storm of factors, the researcher noted.

Even minor climate shifts, combined with Africa's HIV burden and drought exposure, could dramatically impact HIV transmission, he stated, asserting that even if the changes are slight, due to the large number of people with HIV living in Africa and the large percentage who will likely be affected by drought, this change could have a large effect on the number of people acquiring HIV.

"If efforts can be continued to get everybody with HIV in Sub-Saharan Africa onto stable antiretroviral therapy, then this could counteract any increases from risky sexual practices caused by climate change increasing poverty and food insecurity," he said.

Mark Lieber, HIV clinical fellow at the Los Angeles Department of Health and Human Services, says the study puts flesh on the bones of the assumed link between climate change and HIV.

Drought was only one of the many environmental consequences of increased carbon emissions worldwide, while impactful interventions need to come not only from reducing carbon emissions but also developing resilience, through multidisciplinary collaborations, he said.

"Enhancing food security in the global South and empowering women are perhaps two of the best things we can do to protect the most vulnerable from the negative health impacts of climate change," the researcher added.

WITH significant progress made in bilateral cooperation between China and Africa under the Belt and Road Initiative over the past 10 years, African experts have called for closer collaboration to deliver more benefits to the two sides.

"The African-Chinese partnership during the last 10 years is without question a great step forward which carries promise and huge potential for both sides," said Maged Refaat, a member of the Egyptian Council for Foreign Affairs, when speaking at just-ended 13th Meeting of the China-Africa Think Tanks Forum.

"We have all witnessed during the last decade how the Belt and Road Initiative grew from planning to execution."

In that time, the initiative greatly boosted infrastructure develop-

ment, connectivity and trade across promoting development and con-Africa. In Egypt, a number of infrastructure and industrial development projects have been carried out, including the Central Business District in its new administrative capital, the Suez Canal Corridor and the Suez Canal Economic Zone, Refaat said.

"The BRI is a global economic endeavour like no other, which engages some 70 percent of the world's population and accounts for more than 50 percent of global GDP."

The BRI is one of the most important and far-reaching projects in modern history, he said.

More than 150 countries, including many European ones, have been involved in the initiative, which shows its vitality and potential in

nection, Refaat said.

James Mdoe, deputy permanent secretary in the Ministry of Education, Science and Technology, said at the opening ceremony of the meeting that BRI and other platforms for collaboration such as the Forum on China-Africa Cooperation have boosted Tanzania's development in various fields.

"The government of Tanzania recognizes the significant contributions made by China through the BRI in building infrastructure, promoting trade and people-to-people exchanges." China has offered thousands of scholarships to Tanzania and stepped up collaboration in vocational training," he said.

minister of Burundi, told the meeting that relations between China and Africa are based on trust and mutual benefit and should be maintained.

"If you want to lift yourself up. lift up someone else; this is exactly what China is doing. I have a dream that some African developing countries will one day become developed countries because of the teamwork and the win-win cooperation established between China and Africa."

Nibigira described China as a friend that has been with Africa "during hard moments and good times", and suggested Chinese investment in Africa should be increased to promote industrialization in the continent.

Increased rainfall has already been recorded and there are fears of mudslides. Boats and vessels were warned by Mozambique's National Institute of Meteorology (Inam) to take precautions.

As it continues to move southsouthern westwards across Mozambique, the winds will quickly weaken so the system will get downgraded to a tropical depression over the coming hours.

Although the winds will ease, Filipo will continue to bring some heavy falls of rain across southern Mozambique, with 1cm or more in places - so Filipo will continue to threaten some flooding.

More than 525,000 people could be affected by strong winds and flooding, according to Mozambique's National Institute for Disaster Risk Management and Reduction (INGD).

### Set aside industrial parks to spur growth, councils urged

#### Morogoro

LOCAL government authorities have been urged to set aside special areas for investment activities to ease construction of factories and provide job opportunities and increase land value.

This appeal was made here yesterday by Kanuti Mosha, acting manager for promotion and investment at Export Processing Zones Authority (EPZA) while addressing Morogoro regional leaders and members of business community.

"The authority is ready to cooperate with you to provide education, experience in planning areas, issuing licenses and advertise the areas to local and foreign investors," he said.

Mosha said that despite EPZA providing various incentives for investment, especially licence and support for preparation of investment areas, very few councils and have been keen to allocate areas.

"As of December 2023. EPZA registered a total of 181 factories in Tanzania Mainland; these would not have found areas themselves

provides various services such as electricity, water and roads. Some investors want to come and see the factory infrastructure so that they just install the machines," he said.

He said that when the investors don't get areas, they decide to look for areas themselves and the government does not get revenues such as land tax, adding that Tanzania Mainland has 25 investment special zones including eight established by EPZA in Dar es Salaam, Coast, Tanga, Ruvuma, Mara, Manyara and Dodoma regions.

Mosha said there are two types of investment areas namely special investment areas for export managed by EPZA and Special Economic Zones (SEZ) established mainly to encourage economic activities aimed at promoting production of domestic products and exports which increases employment opportunities.

He said that criteria for recognition as an investor include to be registered with EPZA to benefit from various incentives, adding that new investment with starting capital of USD100, 000 for local and

Correspondent, if you had not set aside areas for USD 500,000 for foreigners and investment where the government must be in an area that is officially recognized by the government authority as an official investment area by having licence.

> Grace Njawa, acting Morogoro Regional Administrative Secretary in charge of industry, trade and investment, urged district councils to grab the opportunities and asked that measures be taken to control unscrupulous businesspeople who change or misuse EPZA licences or incentives provided by the government.

> She said that before, many district councils were unable to allocate areas because of not knowing their importance and believed that the move was a waste of land resources, time and money.

Alphonse Eugen one of the investors from Tanzania Teak Limited said despite being on tax exemption, district council officials have been disturbing them and charging them taxes whereby a piece of wood measuring one cubic metre is charged 10,000/- by the council while they have not reached three years since starting production.

"Unfriendly road infrastructure and regular power outages pose challenges to production," he said.

SPANISH maritime rescuers have said they had pulled out 38 people alive and recovered the remains of two others from a migrant boat that had left West Africa and was trying to reach the Canary Islands.

The boat was spotted by a merchant ship 140 km south of Gran Canaria on Monday evening.

Four people in critical condition were evacuated to a hospital aboard two helicopters, while 34 others were transported by boat to the port of Arguineguín, Spain's maritime rescue service said. Among the survivors are seven women.

Spanish authorities face an influx of migrants and refugees from West Africa reaching the archipelago, a

springboard to continental Europe. Nearly 12,000 people fleeing poverty, conflict and instability in West Africa arrived in the Canaries in the first two months of the year, according to the Spanish Interior Ministry, more than six times the number recorded during the same period last year.

Most migrants set out from the Mauritanian coast on artisanal fishing boats called pirogues and navigate for several days against the strong winds and currents of the Atlantic. While thousands of people survived this risky journey, many

died or disappeared along the way and the remains were sometimes washed across the Atlantic.

Last week, two canoes that had left Mauritania for Spain were found adrift hundreds of kilometres away, near the Cape Verde archipelago, after failing to reach their destination, according to the police.

Eleven survivors were rescued from one boat and five more from the second boat, but one person later died. Five bodies were also found and dozens more were believed to have been lost at sea.

THE price of beer is set to rise once again in Nigeria because of the rising cost of production, leading brewer has announced.

This is the third time in less than a year that consumers will be paying more for their refreshment. Nigeria Breweries said the new prices would take effect next weekend, seven months after the last reset.

Nigeria Breweries is the largest and oldest brewery in the country, but last year, it recorded a net loss of 106bn naira (\$66m: £53m) because the depreciation of the naira, the local currency, made importing the ingredients more expensive.

In recent months, local manufacturers in many sectors hiked product prices as the country faces the worst economic crisis in a generation.

### Kagame agrees to meet Tshisekedi over turmoil in eastern DR Congo LUANDA

RWANDA'S President, Paul Kagame, has confirmed his readiness to engage in talks with Felix Tshisekedi, President of the Democratic Republic of the Congo (DRC), in order to tackle the ongoing crisis in eastern Congo.

The announcement follows mediation efforts led by the Angolan government, with President João Lourenço serving as the African Union's mediator in the DRC crisis.

The agreement was reached after a meeting held in Luanda, Angola's capital, between President Kagame and President Lourenço. Angola's Foreign Minister, Tete Antonio, informed the press that President Kagame had agreed to meet President Tshisekedi at a time to be determined by the mediator.

Minister Antonio further revealed that both Rwanda and DRC had consented to the meeting, with ministerial delegations from both countries actively working towards facilitating the dialogue.

### Investing in children should start with cheap consumer goods in poor homes

NOTHER round of international discussions on health, food security, nutrition and children is under way in Dar es Salaam.

It is the form of a four-day international conference on early child care, upbringing and development running under the theme: 'Investing in early childhood; building human capital along the life course'.

A clarion call was given underlining the need for African countries to invest in a healthier productive workforce, a theme cultivated not so long ago, to a certain number of beneficial impressions.

All such gatherings matter, since a global and effective viewpoint on massive cross-cutting issues is complicated.

There were auxiliary issues which aren't far from the main issues for instance the whole issue of the corrupting and otherwise damaging influences when young children aged five or slightly above are exposed to 'disruptive' social media images.

At times it is cartoons of films and even school exercises intended to take their minds in a certain direction, in which case danger lurks on the children in all directions.

It may start with faulty care of pregnancy and being born with inbuilt setbacks to nutritional and eventually social exposure in growing up.

Health experts and top-level social welfare workers warn that the use of electronic devices by children requires maximum supervision.

Thus, African countries need to exhaustively ponder controls with respect to the use of technology by children - which is complicated.

This is without even focusing on children below five, as Community Development, Gender, Elderly, Women and Special Groups minister Dr Dorothy Gwajima aptly noted.

Indeed, even at an adult level, negative exposure has an impact, in which case few proper defences could

be recommended for children. Things like exposure to technology have so many levers that policy as such can't work, starting with a situation where proper parental upbringing is a problem, especially when the mother is engaged in full-time work outside home.

With the fulsome campaign to have as many women as men having independent income-generating outlets, alerting an international conference on the need to take closer care of children may sound a bit unconvincing, but it definitely has its merits.

It is evident that the liberation of women has costs to it, especially in upbringing. Still, the overriding conference theme and indeed in practice it is how a healthy workforce can be assured.

It is not just being relatively fit physically but, more intensely, being mentally fit to be an achiever.

Laying the accent on policy as such can ensure that appropriate childcare and upbringing is difficult to figure out.

Public investments in health, nutrition, learning and early stimulation, responsive nurturing, child protection and safety may be hard to attain, even as all these relate to personal and family expenditure.

For a child to grow up smart and ready to be a productive adult is both a matter of aptitude in upbringing and compulsion in life.

Much depends on a range of decisions outside one's ability or mistakenly believed to be in a particular person's favour.

But, for one thing, the health of children starts with how much a person can buy for the children, in which case the government can ensure that people invest in nutrition and hence health of children.


That is in part assuming that there are far fewer taxes than currently obtains - numerous more jobs than is now the case.

ILIAN Eze still shivers when she recalls the frequent attacks by kidnappers in the Kaduna community she once lived in, in north-central Nigeria. In February 2022, she fled with her children to Abuja, the nation's capital, to ensure their safety.

In an interview with IPS, she explained that the kidnappers would invade the community on foot and with a horde of motorbikes in the evenings with little or no resistance from security agencies.

They would indiscriminately fire gunshots into the air, instilling fear among residents, before forcibly taking their victims to remote areas in the forest, where they would be held captive until ransom was paid. But not all victimsmake it out alive.

"When it started, sometime around 2017, we thought it would subside but it became extremely

# State fails to stem kidnapping for ransom crisis in Nigeria



### Duty in the family shifting to durable friendships, tolerance

to 'break the silence' around family issues in the wake of International Women's Day celebrations, saying that duties must be fulfilled before the advocating of equality.

The militant credited with having espoused that position in a professional gathering comes from the Tanzania Women Lawyers Association (TAWLA). It wasn't part of celebrating.

What the advocate stated must have sounded anathema to militants listening to that speech, as to bona fide feminists it smacked of the old patriarchal assertions that women have to be careful when crusading for equality

The idea that women must fulfil all their 'required duties and responsibilities' at the family level is contentious because rights come before duties. Indeed, in the final analysis, it is the scope of rights that sets out fairness and the whole idea of duty

There was something accurate in what the counter-militant said - in that a number of women have been forgetting their roles when asserting their rights, thus engendering conflicts in families.

Yes, that is true, but a militant would not just ask women to take note of those responsibilities without making the demand reciprocal.

Part of the trouble lies in the fact that reciprocity is not part of what is being discussed, which is affirming or denying women's equality with men in families, irrespective of how far men fulfil their duties.

In that when the advocate says that owing to the on-going campaigns to fight for equality in the society, some women have started to misuse

OMEONE has lately decided education by claiming rights which in reality are not theirs, the issue is where this is decided.

> It can't possibly be via custom as that is the first culprit in women's oppression, and the bedrock of family as an institution. It is a litany of complications.

Surely, what basically defines a family or a conjugal relationship as a family can be split at a conjugal level and be retained in that way is a set of prohibitions rather than duties.

It is precisely in this direction that the family institution appears to be in crisis, as it demands a lot of tolerance along the way for two relatively free people to coexist in a family where there is ranking rather than command.

Conjugal unions are maintained essentially for social harmony and social respect, but wishing to avoid a breakdown might lead to violence to correct the conjugal partner, as it were. If violence is removed, the corresponding situation will be relativising the family, where one freely enters - or leaves.

There are no easy answers in accommodating women's liberation and conjugal duty, as this sense of liberation is relative and reciprocal.

The wish to separate the freedom to work, practise a profession, run a business and remain within traditional duties for everything else is a challenging equation.

It is a bit uncertain if the militant went as far as sorting this out but, then, let's just hope for the best as each woman sorts out the matter, in the castle of her skin'.

That suggests that people remain mindful of their happiness, remaining free as practicable as they were before the conjugal union and with their conscience guiding them on what to do and what direction to take.

frequent. The gunshots were terrifying; most nights, we could not sleep. After my neighbour was kidnapped, I stopped sleeping at my house. My children and I would go to a nearby community to spend the night," Eze said.

Nigeria is currently bedeviled with a widespread kidnapping for ransom crisis. It is among the highest globally. Armed gunmen snatch their victims from highways, schools, and even their homes. According to a report from Lagos-based risk consultancy SBM Intelligence spanning from July 2022 to June 2023, 3,495 individuals were abducted in 582 incidents, with over USD 18 million paid as ransom between 2011 and 2020.

The Nigerian Financial Intelligence Unit says kidnapping for ransom is one of the major sources of terrorism financing in the country. Despite several pledges by the government to bring an end to the crisis, it has continued to fester.

While the payment of ransom has been criminalised, Nigerians have no choice but to crowdfund for ransom to secure the release of their family members and relatives, as in most cases, the kidnappers would not release their victims until ransom was paid.

Trapped in Kidnappers' Den While Eze and her family were lucky to have escaped to a relatively safer location, others have not been so lucky.

Joshua Peter, 30, along with his friend Salama Ogboshun, were kidnapped last year while on their way to the farm in Kaduna. He said heavily armed men ambushed and bundled them into a bush, from where they were taken to a forest. He added that the trauma of his experience in the forest may never fade away.

"Many kidnapped victims were killed before my eyes. Women and

young girls were frequently raped in the open. I was beaten and received death threats every day," he said.

Peter said he was released after two weeks only after the ransom was paid but for days he could eat just a little food and did not talk to anyone as a result of the trauma he battled with. He wondered why the Nigerian security forces were unable to rescue them and track the location of the kidnappers despite negotiations for their release on the phone.

Nigerians have frequently raised concerns about the efficiency of the country's intelligence gathering and have voiced criticism regarding the perceived shortcomings of different security agencies in employing technology to address insecurity. Critics argue that, despite security agencies effectively monitoring and suppressing opposition activities, they have consistently fallen short in tracking down criminals. The police attribute delays in addressing kidnapping cases to a "shortage of tracking machines."

Nigeria's Failing Technological Infrastructure

For Sadiq Abdulahi, a tech expert with Fozy Global Concept based in Abuja, there is sparse collaboration between security agencies, which hampers the fight against insecurity. "There should be synergy among the various security agencies regarding data sharing," he added, emphasizing the lack of awareness about the potential use of technology to combat crime in the country.

In 2022. the Nigerian government mandated residents

their Subscriber Identification Modules (SIMs) with their National Identification Numbers (NINs) to bolster security. However, despite the policy, kidnappers continue to place untraceable calls to the families of their victims. Isa Pantami, the former Nigerian Minister of Communications and Digital Economy who spearheaded the initiative, faced criticism for seeking funds to pay ransom for certain kidnapped victims earlier this year. Pantami, however, shifted blame to security agencies, accusing them of not efficiently utilizing the policy to trace criminals.

Zainab Dabo, a Nigerian political analyst, argues that a lack of commitment and political will by the government is contributing to the crisis. According to her, the Nigerian security forces are underequipped to confront rogue nonstate actors.

"Security operatives have arms that are not as sophisticated as those of the kidnappers. While our security forces are well-trained, the lack of proper armament turns confronting terrorists into a perilous mission," she told IPS.

Dabo also alleged that there are insiders within the Nigerian security infrastructure who are aiding terrorists. "For insecurity to persist for this long, it indicates elite connivance not only among security operatives but also among politicians and traditional rulers,' she added.

Joshua Madaki, a Kaduna resident kidnapped from his home by armed gangs on the evening of December 21, 2021, shares the same view as Dabo. Madaki, who said he spent 17 days in captivity, was abducted of the country to synchronize alongside 36 others from his

community. He disclosed that while ransom negotiations were ongoing, the criminals killed six of the victims as a warning to their families.

"Insecurity in Nigeria is very complicated, but it seems the government is not ready to take action to tackle it," said Badasi Bello, whose vounger sister was kidnapped in Sokoto State, northwest Nigeria, in 2023.

Amnestv International has advised the Nigerian government to regard the kidnapping crisis in the country as an emergency and to take measures to solve the problem.

However, kidnapping continues, including the mass kidnapping of schoolchildren. Last week (Thursday, August 7, 2024), 287 children were abducted from two schools in Kaduna State. UNICEF Representative in Nigeria, Cristian Munduate, said in a statement that the act was "part of a worrying trend of attacks on educational institutions in Nigeria, particularly in the northwest, where armed groups have intensified their campaign of violence and kidnappings."

Then, on March 10, 15 pupils were abducted from the Islamic seminary in Gidan Bakuso, Sokoto State, while they slept, according to the Associated Press.

Munduate said UNICEF was coordinating with local officials and assisting parents and families with psychological support services.

"Every child deserves to grow up in an environment of peace, away from the looming shadows of threats and insecurity. Unfortunately, we are currently facing a significant deterioration in community safety, with children disproportionately suffering the consequences of this decline in security," Munduate said.

the heart of Tanzania's journalistic landscape, where stories unfold and truths are uncovered, a stark reality casts a shadow over the profession. Imagine a world where every headline comes at a cost - a cost that 50% of Tanzanian journalists willingly bear.

In the pursuit of uncovering the untold, facing threats, harassment, torture, and attacks has become an unsettling norm.

Picture this: two out of ten journalists find themselves behind bars or in the clutches of authorities, while an equal number navigate the treacherous waters of genderbased harassment and the confiscation of their indispensable work tools. Welcome to the challenging tapestry of journalism in Tanzania, where the pursuit of truth is not without its harrowing battles.Top of Form

These findings were released by Twaweza in collaboration with Media Institute of Southern Africa Tanzania Chapter (MISA-Tan), Jamii Forums, Union of Tanzanian Press Clubs (UTPC), and Tanzanian Women Journalists Association (TAMWA), in a research journal titled "Voices of Journalists: Experiences and Opinions of Tanzanian Journalists."

The journal presents statistics on the experiences and opinions of journalists in Tanzania. The opinions were gathered from 1,202 media professionals, including journalists, editors, and bloggers.

The journalists were identified through membership databases of various media associations, including UTPC, TAMWA, MISA-Tan and Jamii Forums.

The interviews were conducted via phone between September 23 and November 7, 2023. Many journalists have precarious and non-permanent employment. Two out of ten (20 percent) claim to have permanent positions, compared to six out of ten (60 percent) who describe their jobs as temporary, and two out of ten (18 percent) who are called to work only when needed.

Half (50percent) have signed contracts. A significant number of journalists (63 percent) find it difficult to earn a living wage through journalism, while a few (5 percent) do not consider it a problem. One in three journalists (36 percent) has additional income from sources other than iournalism.

Only two out of ten journalists (19 percent) would prefer their children to follow in their footsteps and become journalists. Journalists' experiences of workplace hazards are significant, with half (50 percent) reporting having been threatened, tortured, or attacked while on the job.

# **Report unveils alarming realities** of threats, attacks journalists face



Journalists largely accuse government officials as the main source of threats; more than half (56 percent) say government officials are the primary source of threats, more than any other group.

A majority of journalists (86 percent) claim corruption exists in the sector, including 36 percent who say corruption is widespread. The most prevalent forms of corruption are payment for publishing (55 percent) or not publishing (53 percent) specific stories. Almost all journalists (95 percent) admit to accepting money from individuals or institutions involved in news, with 23 percent accepting regularly and 72 percent having accepted on multiple occasions. One in ten (10 percent) reports receiving gifts or money "always" to manipulate content, and half (53 percent) say they have done so at least once.

Furthermore, journalists feel that media outlets in Tanzania have limited freedom to work without control or interference. Six out of ten journalists do not feel free to and able to thrive in an environment that report on corruption (60 percent) or issues related to law honors their dedication to truth.

In the intricate tapestry of Tanzanian journalism, the indispensable role of journalists in shaping the narrative cannot be overstated. Aidan Eyakuze, CEO of Twaweza, passionately underscores their pivotal contributions - from informing and educating citizens to entertaining and holding those in power accountable. Yet, beneath the surface of this noble endeavor lies a harsh reality.

Journalists, the unsung heroes of truth, grapple with an unfriendly working environment, facing threats and abuse in their relentless pursuit of transparency. Many endure unreliable and insufficient income, highlighting a dire need for fair and well-benefited employment contracts. It's a plight echoed in a recent study by the online media outlet, The Chanzo, revealing journalists' vulnerability to low pay, lack of contracts, and the ominous presence of brown envelopes that eclipse their professionalism, jeopardizing their very livelihoods.

The struggle extends beyond financial constraints, as The Chanzo's investigation sheds light on the disturbing prevalence of sexual abuse faced by female journalists. Senior editors exploit their positions to coerce these journalists, compromising their integrity for the sake of publishing stories.

Reinforcing this storyline, Hoyce Temu, Tanzania's Deputy Head of Mission in Geneva, Switzerland, sheds light on a troubling reality in her doctoral thesis examining gender equity in media firms. The results glaringly reveal the systematic marginalization of women based on gender within these organizations.

In championing the cause of journalists, Eyakuze's call to protect and empower them becomes even more imperative. It's a collective responsibility to fortify the pillars of journalism, ensuring that these truth-seekers are shielded, respected,

LL over the world, the frequency and intensity of devastations caused by climate change continue to increase. Countries in the Horn of Africa are particularly vulnerable to these impacts as residents deal with long-term droughts, acute hunger and ravaging floods time and again.

Although these countries have committed to ambitious action plans to cut emissions and mitigate climate-related disasters, there remains a gap in financing for adaptation efforts. Farmers, in particular, need access to funding to improve ag-



ricultural resilience in a region buckling under severe food and economic crisis.

The current state of farming in the Horn of Africa

The Horn of Africa primarily comprises four countries – Ethiopia, Eritrea, Somalia and Djibouti. Broader definitions often include parts of Kenya, South Sudan and Uganda.

Agriculture plays a key role in the population's livelihood, yet farming opportunities are limited as 70% of the area consists of un-farmable land. Continuous drought and increasing overexploitation have resulted in arid and semi-arid lands, which are incapable of sustaining healthy crop cultivation.

The prolonged shortage of water and other natural resources also makes it difficult to support large-scale livestock production.

As a result, famine has intensified in the region, plunging residents well below the poverty line and increasing the risks of climate-related health emergencies. According to the World Health Organization, an estimated 47 million people already face acute hunger, while disease outbreaks become more frequent.

In addition to the food crisis, socio-political instabilities have created an unprecedented number of displacements, fueling instances of cross-border conflicts. The dire need for adaptation funding in the region

As experts have pointed out, only by adapting to climate change can the Horn of Africa and the rest of the continent reach its potential.

However, the financing for such programs remains critically short of what is needed. In a region where agriculture plays a key role in the population's livelihood, yet farming opportunities are limited as 70 percent of the area consists of un-farmable land. Continuous drought and increasing overexploitation have resulted in arid and semi-arid lands, which are incapable of sustaining healthy crop cultivation.

The prolonged shortage of water and other natural resources also makes it difficult to support large-scale livestock production.

As a result, famine has intensified in the region, plunging residents well below the poverty line and increasing the risks of climate-related health emergencies. According to the World Health Organization, an estimated 47 million people already face acute hunger, while disease outbreaks become more frequent.

The African Development Bank (AfDB) estimates the continent will need around \$2.7 trillion in climate financing between 2020 and 2030. This funding spans various developmental projects, including agriculture resilience, especially in the Horn of Africa and other regions impacted by rainfall shortages.

According to AfDB president Akinwumi Adesina, the organization is looking to raise \$1.4bn for desalination and wastewater treatment plants, which can go a long way in improving safe water supply for residential and commercial purposes.

To further bridge the financing gap, the AfDB launched the African Adaptation Acceleration Program (AAAP) in collaboration with the Global Center on Adaptation (GCA), aiming to raise \$25bn for climate adaptation. These funds will target four priority areas - food security, nature-based solutions, job creation and adaptation financing through green bonds and private financial instruments.

Farmers in the Horn of Africa may also benefit from the \$100 billion a year fund pledged by wealthy nations to drive climate action in developing countries. While the amount

falls short of these nations' actual needs, it's a step in the right direction.

Additional financing from the private sector has been helpful, too. In 2022, the Gates Foundation pledged \$1.4 billion to help farmers address climate change.

Supplementing adaptation funding with humanitarian aid

While adaptation financing efforts are well underway, it might take years to notice their effects. In the meantime, people continue to suffer famine, displacements and other harsh impacts from climate change. For example, food shortage in Madagascar has seen 27% of the population facing life-threatening conditions, with 16.5% of children severely malnourished.

Humanitarian aid can provide respite in the short term. The UN has established four core principles guiding the efforts of these assistance programs - humanity, neutrality, impartiality and independence. Most aid efforts come in the form of in-kind goods or assistance, though individuals can also participate in day-to-day relief activities like donating

blood, volunteering and providing supplies to displacement victims.

On a broader scale, global organizations must ramp up their assistance efforts as 60 million Horn of Africa residents desperately need humanitarian aid. The response has been promising so far, with the EU recently announcing a €171 million donation to fund relief programs in the region.

Adaptation funding for farmers in the horn of Africa

Adaptation finance is sorely needed to help farmers in the Horn of Africa cope with the many challenges posed by climate change. Meeting these funding requirements can help address famine, political instabilities and displacements, as well as create more resilient agricultural infrastructures.

# Xi's 'two sessions' messages highlight China's high-quality development in crucial year

### BEIJING

HINESE President Xi Jinping has shone more light on the country's source of confidence for high-quality development by expounding on a wide range of topics at this year's "two sessions," a key political event slated to close on Monday.

Xi, also general secretary of the Communist Party of China (CPC) Central Committee and chairman of the Central Military Commission, joined national legislators in deliberations and participated in discussions with national political advisors at the event, making a raft of remarks on issues including new quality productive forces, environmental protection, overall reform and coordinated regional development.

In this crucial year for fulfilling the objectives and tasks set out in the 14th Five-Year Plan (2021-2025), Xi stressed that efforts must be made to sustain and reinforce the positive momentum of economic recovery, and boost confidence in development across society. Key messages from Xi at the sessions provided insight into the trajectory of the world's second-largest economy.

### **NEW QUALITY PRODUCTIVE FORCES**

Xi has stressed developing new quality productive forces amid the country's accelerated efforts to foster new growth drivers and promote high-quality development.

First put forward by Xi in 2023, the concept was highlighted at a key meeting on economic work last December, and became the subject of a group study session of the CPC leadership this year.

With innovation playing the leading role, new quality productive forces mean advanced productivity that is freed from the traditional economic growth mode and productivity development paths, features hightech, high efficiency and high quality, and comes in line with the new development philosophy.

Joining his fellow deputies from the delegation of Jiangsu in a deliberation on March 5, Xi underscored the importance of developing new quality productive forces based on local conditions.

Developing new quality productive forces does not mean neglecting or abandoning traditional industries, Xi said, noting that it is necessary to prevent a headlong rush into projects and the formation of industry bubbles, and avoid adopting just a single model of development.

Xi stressed the need to strengthen basic research and basic research in applied sciences, achieve breakthroughs in core technologies in key fields, and foster new drivers for developing new quality productive forces when participating in a joint group meeting attended by national political advisors on March 6.

Citing achievements in transportation as an example, he said that China is a global leader in automobile production and sales, excels in new energy vehicles, boasts the longest expressway network, and has successfully introduced high-speed railways and urban rail transit systems internationally, alongside the development of large aircraft.

He called for enabling new quality productive forces and new quality combat capabilities to effectively integrate with and boost each other.

#### **DEEPENING OVERALL REFORM**

Reform has been a key word in China over the years.At the deliberation on March 5, Xi stressed the necessity of planning major measures to further deepen reform on all fronts, so as to continuously inject strong impetus into the endeavor to promote high-quality development and advance Chinese modernization.

To build a high-level socialist market economy, it is imperative to accelerate the improvement of basic systems underpinning the market economy, such as those for property rights protection, market access, fair competition, and social credit, Xi said.

He stressed that it is essential to improve and implement the institutions and mechanisms to unswervingly consolidate and develop the public sector and unswervingly encourage, support and guide the development of the non-public sector, and facilitate the growth of the private sector and private enterprises.

The reform of systems involving science and technology, education and professional personnel should be deepened, region-specific environmental management system, so as to further consolidate the ecological foundations of high-quality development.

According to the government work report, China has set a target of reducing its energy consumption per unit of GDP by approximately 2.5 percent this year.

Xi said that efforts must be made to carry out targeted, science-based and lawful pollution control, promote green and low-carbon transition in economic and social development, strengthen conservation, efficient use and recycling of resources, explore more ways to realize the market value of ecological products, and work toward peaking carbon emissions and achieving carbon neutrality.

On the country's plan to control new pollutants following its treatment of smog and black and malodorous water bodies, Xi said that both newfound and persisting environmental problems need to be addressed.

#### **COMMON PROSPERITY**

Xi considers pursuing common prosperity for all to be an essential feature of Chinese modernization. The tale of Yonglian development paradigm and pro-Village in east China's Jiangsu Province, a legendary example of developing township enterprises during China's reform and opening up, caught his attention in the deliberation on March 5. Once a tidal flat area along the Yangtze River, this village boldly established a steel enterprise about 40 years ago and emerged as a nationally renowned prosperous community. Last year, with total industrial and agricultural revenues reaching 161.6 billion yuan (about 22.77 billion U.S. dollars) and a collective operating revenue of 335 million yuan, the village residents enjoyed an average per capita net income of 73,000 yuan.



# Ending gender inequality in farming to achieve food security, generate growth

### LILONGWE

IN central Malawi, the everyday life of Alefa Ofesa and Lloyd Phale work in their field changed two years ago when Alefa embarked on a project support and training to cope with erratic rainfall in the region.

The 42-year-old mother learnt how to plant seeds in two parallel rows, separated by rain collection channels, build terraces, contour ploughing, and construct check dams to slow down water flow and prevent soil from being washed away.

All of these methods help to maximize water efficiency. The project also encouraged the farmers to plant indigenous trees around the field which produce organic manure through composting and protect the field from floods during the rainy season.

The farming couple have been farming for over 20 years, but Alefa says the TRADE project (Transforming Agriculture through Diversification and Entrepreneurship Programme) has made a defence.

"The project has encouraged women to participate in agriculture. With the knowledge and the skills, they are sure and confident about what needs to be done to improve productivity, for example the double raw planting," Ofesa says.

The TRADE project is implemented by the government of Malawi and supported by the International Fund for Agricultural Development (IFAD).

IFAD has been investing in rural women to help them address gender inequality.

"Substantial gender gaps in productivity have arisen not because women are less efficient farmers, but because women experience inequitable access to land and to agricultural inputs", a 2019 IFAD report says.

#### Joint decision-making

#### MAUN, Botswana

EUROPE'S plans to ban the importation of trophy hunting products are unjust and pose a huge threat to conservation that centres on the people in southern African rangeland countries, wildlife ecologists say.

Prof Richard Fynn, an ecologist at the Okavango Research Institute of the University of Botswana told journalists drawn from Sadc countries that banning trophy hunting can have detrimental effects on the livelihoods of local communities and perpetuate colonial injustices.

In addition to fitness exercises, gyms in Kenya also offer nutrition and dietary advice to members so that they know what to eat to stay healthy while they work out.

"Some of the advice I give is to eat foods that are high in fiber, which helps with digestion, eat lots of fruit, avoid or reduce foods high in saturated fat, and drink plenty of water.

A good diet complements exercise," says Coleta Mutua, a nutritionist who consults at gyms. To operate a gym, one needs a license from the local county government where the business is located and another from the Music Copyright Society of Kenya since the facilities play songs during sessions.

### **Fitness enthusiasts keep** Kenya gyms in business NAIROBI

"ONE and two, one and two," the instructor shouted to a group of eight people at a fitness center in Kitengela, a suburb about 32 km south of Nairobi, the capital of Kenya. His instructions were in rhythm with the fast-paced music playing in the background to motivate the trainees as they engaged in various exercises.

After about 10 minutes, the instructor switched from jumping jacks to push-ups, striving to ensure the group engaged in as many drills as possible to keep fit. "This morning session usually lasts about two hours. In the evening, another group comes for a variety of exercises," John Okumu, the instructor, told Xinhua in a recent interview.

His gym is one of many in Nairobi and other parts of Kenya that serve hundreds of residents who have become fitness enthusiasts seeking to stay fit amid a rise in diseases such as diabetes, hypertension, and obesity due to sedentary lifestyles.

Gyms have mushroomed throughout the city's suburbs and estates, thanks to a ready market of growing middle- and upper-class residents willing to pay a premium to stay fit. Okumu, who studied commerce at university, said he turned to running a fitness business after failing to secure a good job two years after graduating.

"I was a fitness junkie even before I started my own business in 2020 when COVID-19 hit and most people were at home. I seized the opportunity to start the business after buying some used equipment with a loan," said Okumu. He started with two people and now has about 30 loyal clients. "The majority of them are women, and that is because many of them are body conscious," he explained.

Okumu charges a flat fee ranging from 300 Kenyan shillings (about 2.15 U.S. dollars) for a session to 50.1 dollars per month. Gym fees vary across Nairobi depending on location, type of client, and available equipment. "I started working out two years ago after I had my second child.

My body size increased, and I had to do something to regain my figure," said Julie Nderitu, an accountant at a government agency in

Nairobi. She pays 61 dollars a month for the workout classes that involve aerobics, which she attends every night at a facility near her home in Umoja, east of Nairobi.

Daniel Mokua, a businessman who works out at

a gym in downtown Nairobi, said he frequents the facility for better health because the sessions leave him stress-free and relaxed.

"I mainly do cardio workouts. They help me build stamina and lose excess fat." According to him, a

## Foreign investors dominate stock market activity on week's outset

#### **By Guardian Reporter**

THE Dar es Salaam Stock Exchange (DSE) indices opened the week in red, with foreign investors dominating the activities by changing hands shares valued 2.5bln/-.

The Monday's daily market report shows foreign investors dominated both sides of the market activity, after buying shares valued 2.56bln/-, which was 97.62 percent of total value of shares bought.

This has expanded their stake on the value of shares sold since the start of the current quarter to 3.79bln/- or 7.94 percent of value of shares sold, from 1.23bln/- or 2.73 percent recorded during the end of last week.

The market report shows foreign investors also sold shares valued 2.54bln/or 96.98 percent of total value of shares sold, pushing up the value of shares they have sold since the start of this quarter to 23.35bln/- or 48.89 percent during Monday's close.

The move has translated into foreign investors' net outflows of nearly 20bln/since the start of the current quarter, which is equivalent to nearly four times of the value of shares they sold during the whole first quarter of last year.

Analysts expect continuing foreign investor selloff, specifically blue chip counters, due to various economic reasons including stagnation of the share prices, increasing central banks rates in developed economies and weaker local currencies in developing markets.

However, other analysts consider the current foreign investor selloff as sea-

sonal, as many were 'holding a breath' to study the movement of the market in relation to the global economic trends.

Top mover during the opening day of the week was CRDB Bank counter, which recorded the transaction of 4.89 million shares valued 2.59bln/- traded at a price ranging from 500/- to 520/- per share in 96 deals with 4.80 million shares being transacted through block trade pre-arranged market board.

Second top mover was Tanga Cement Company Limited (TCCL) counter, which recorded the transaction of 9,058 shares valued 19.02mln/- traded at a price of 2,100/- per share in three deals, followed by DCB counter, after recording the transaction of 7,155 shares valued 1.01mln/- traded at a price ranging from 135/- to 140/- per share in nine deals.

Other active counters during the day were NICO, which transacted 6,410 shares valued 3.7mln/- traded at an average price of 575/- per share in 18 deals, followed by Swissport, which recorded the transaction of 2,800 shares valued 3.25mln/- traded at a price of 1,160/- per share in one deal.

Total market turnover amounted to 2.62 million shares, following the transaction of 4.9 million shares traded in 15 deals.

Top losers were CRDB Bank and DCB Bank counters, which recorded the shares depreciations by 1.92 percent and 6.62 percent respectively, which affected the movements of share indices, amid the increase of Swissport counter share price by 3.57 percent.

## Indian parent company sells braids maker to Kenyan subsidiary

#### NAIROBI

INDIA'S Godrej Consumer Products will sell a portion of its assets in Kenya's Style Industries Ltd to a newly incorporated entity, Hair Manufacturing Kenya Ltd.

Style Industries Ltd is the company behind the 'Darling' brand of braids, weaves, and wigs.

The transaction has been approved by the Competition Authority of Kenya (CAK) but on condition that at least 70 percent of Style Industries Limited's employees are retained on employment terms that are no less favourable than their current terms for 12 months following comple-

tion of the transaction. "This approval has been granted based on the finding that the transaction is unlikely to negatively impact competition in the market for hair extensions and wigs. However, the transaction will

elicit negative public interest concerns," said CAK in the notice without revealing the value of the deal.

"The proposed transaction involves the acquisition of certain assets - plant and machinery, office equipment and inventory - of Style Industries by Hair Manufacturing." Style Industries, a private

limited liability company incorporated in Kenya, is principally involved in the manufacture and distribution of

hair addition products such as braids, weaves, and wigs under the brand 'Darling'.

Hair Manufacturing Kenya Limited, on the other hand, is a private limited liability company incorporated in Kenya but does not have any operations in the country since it has been newly incorporated for purposes of this transaction.

According to regulatory rules, merging parties whose combined turnover or assets, whichever is higher, is over Sh1 billion are required to seek approval from CAK before implementing intended transactions.

In Kenya, the market for hair extensions and wigs is largely fragmented with local manufacturers and a significant extent of imported goods.

Some notable players include Angels Hair Collection Kenya (Sanaa Industries Ltd), Lush Hair Kenya (Tolaram Group), Fashion Idol (Rebecca

Fashion), Olivia Hair Kenya (Di Lorenzo Ltd), Africa Hair Factory Limited and Unique Beauty Salon Consultants (UBSC), among others.

According to global market research and consulting firm 6Wresearch, Kenya has increasingly been relying more on imports to meet its growing demand for human hair extensions as domestic production and supply continue to trail local demand.

### US sanctions Kenyan transport, 15 others, for alleged terror financing

#### NAIROBI

THE United States has imposed sanctions on Kenyanbased transport company Crown Bus and 15 others for allegedly aiding Al-Shabaab in generating a \$100 million annual income.

"Today's action is part of a multifaceted effort by Treasury to support the Somali government's economic offensive against al-Shabaab one of three pillars in their campaign to degrade this deadly terrorist group," Brian E. Nelson, Under Secretary of the Treasury for Terrorism and Financial Intelligence, said in a statement.

The US' Office of Foreign Assets Control (OFAC) said that Awale and Dini's designations are linked to each other, and to Haleel Group and Crown Bus Services.

The list also includes at least three other individuals linked to Haleel's operations in Kenya, Uganda, Cyprus and the UAE.

One of them, Farhan Hussein Hayder, who the US says "directs and manages Haleel Group's branches in Kenya, Uganda, Cyprus, and the UAE, and supports al-Shabaab by

generating funds", has previously been investigated by anti-terror police in Kenya, according to a Ugandan court document.

In May 2018, Uganda's Financial Intelligence Authority froze the accounts of Haleel Group's subsidiary and those of five other companies on suspicion that they were part of a terror financing network. The companies sued the authority and the freeze orders were lifted in September 2019.

### Why it Matters

The designation against companies and individuals

for financing terror mainly includes sanctions against doing business in the United States or with American companies. But its true power works similar to a global blacklist since "engaging in certain transactions with the individuals designated today entails risk of secondary sanctions."

It is likely that the designation will bring renewed interest in the Kenya and Uganda based companies from local anti-terror and anti-money laundering authorities, and complicate their relationships with lenders and financial institutions.

## Bank freezes plans for fintech subsidiary months after green light

#### NAIROBI

STANBIC Holdings has put on hold plans to set up a fintech subsidiary months after the Capital Markets Authority (CMA) granted it approval.

The lender had not given details about what it intended to do with the subsidiary but now says the board has decided to pause the idea.

"We reviewed that decision at the board level and what we have done is put it on hold at the moment. If we need to come back to it, we will, but for now, that is the position," said Joshua Oigara, CEO at Stanbic Bank Kenya and South Sudan.

Stanbic had in the financial year ended December 2022 said it was open to acquir-

network operators as an option to "exponentially grow business."

The CMA had in the quarter that ended December 2023 said it had approved a shareholder circular by Stanbic for the "incorporation of a fintech subsidiary." This would have become the fifth subsidiary.

Stanbic Holdings, which is owned by Standard Bank Group, currently has four subsidiaries–Stanbic Kenya, Stanbic South Sudan, Stanbic Bancassurance Intermediary, and SBG Securities.

The holdings company in 2021 said it was seeking partnerships with Chinese financial technology firms to boost Sino-Africa trade. The firm had said by collaborating with Chinese fintechs, Kenyan traders would be able to find suppliers of quality tions conveniently.

Standard Bank has been open to partnering with fintechs and the same strategy appears to be trickling down to its subsidiaries outside South Africa.

Nigeria's Stanbic IBTC Holdings, also part of Standard Bank Group, in 2022 started a fintech subsidiary called Zest Payments Limited which functions as a payment solution service provider.

Stanbic Holdings net profit for last year by 34 percent to Sh12.2 billion. Stanbic Bank Kenya's net earnings grew 30 percent to Sh11.5 billion while that of Stanbic South Sudan went up 50 percent to Sh460 million.

### **Fuel and shelter costs lift US** consumer prices in February

### Washington

US consumer prices increased solidly in February amid higher costs for gasoline and shelter, suggesting some stickiness in inflation that could delay an anticipated June interest rate cut from Federal Reserve.

The consumer price index (CPI) rose 0.4 percent last month after climbing 0.3 percent in January, the Labor Department's Bureau of Labor Statistics said vesterday.

Gasoline and shelter, which includes rents, contributed more than 60 percent to the monthly increase in the CPI. In the 12 months through February, the CPI increased 3.2 percent, after advancing 3.1 percent in Ianuary

Economists polled by Reuters had forecast the CPI gaining 0.4 percent on the month and increasing 3.1 percent year-on-year. The annual increase in consumer prices has slowed from a peak of 9.1 percent in June 2022, but progress has stalled in recent months.

Inflation picked up in January, largely blamed on beginning- of-year price raises by service providers, which economists said were not fully addressed by the model used by the government to strip out seasonal fluctuations from the data.

There was also a jump in owners' equivalent rent

(OER), a measure of the amount homeowners would pay to rent or would earn from renting their property, which diverged from rents. That was partly the result of some methodology changes by the government.

The BLS last week held a webinar to discuss the underlying

methodology related to the January OER and rent data.

"There is a high likelihood that OER inflation will exceed rent inflation more often moving forward," said Stephen Juneau, an economist at Bank of America Securities in New York. "However, we think that much of the 20 basis points divergence was

noise and not signal. Rent and OER inflation should continue to moderate over the course of this year. helping to drive core inflation lower as goods price deflation dissipates."

Excluding the volatile food and energy components, the CPI increased 0.4 percent last month after rising by the same margin in January. In the 12 months through February, the so-called core CPI advanced 3.8 percent. That was the smallest year-on-year increase since May 2021 and followed a 3.9 percent rise in January.

The Fed tracks the personal consumption expenditures price indexes for its 2 percent inflation target. These measures are running at rates tamer than the CPI. Though job growth accelerated in February, the unemployment rate increased to a two-year high of 3.9 percent and annual wage inflation moderated a bit.

Prior to the release of the CPI data, financial markets saw a roughly 70 percent chance of the Fed cutting rates in June. Since March 2022, the US central bank has raised its policy rate by 525 basis points to the current 5.25 percent-5.50 percent range.

# **Boeing whistleblower found dead in US**

#### By Theo Leggett

A former Boeing employee known for raising concerns about the firm's production standards has been found dead in the US.

John Barnett had worked for Boeing for 32 years, until his retirement in 2017.

In the days before his death, he had been giving evidence in a whistleblower lawsuit against the company.

Boeing said it was saddened to hear of Mr Barnett's passing. The Charleston County coroner confirmed his death to the BBC on Monday.

It said the 62-year-old had died from a "self-inflicted" wound on 9 March and police were investigating.

Barnett had worked for the US plane giant for 32 years, until his retirement in 2017 on health grounds.

From 2010, he worked as a quality manager at the North Charleston plant making the 787 Dreamliner, a state-of-theart airliner used mainly on long-haul routes.

In 2019, Mr Barnett told the BBC that under-pressure workers had been deliberately fitting sub-standard parts to aircraft on the production line.

He also said he had uncovered serious problems with oxygen systems, which could mean one in four breathing masks would not work in an emergency.

He said soon after starting work in South Carolina he had become concerned that the push to get new aircraft built meant the assembly process was rushed and safety was compromised, something the company denied.

He later told the BBC that workers had failed to follow procedures intended to track components through the factory, allowing defective components to go missing.

He said in some cases, sub-standard parts had even been removed from scrap bins and fitted to planes that were being built to prevent delays on the production line.

He also claimed that tests on emergency oxygen systems due to be fitted to the 787 showed a failure rate of 25 percent, meaning that one in four could fail to deploy in a reallife emergency.

Barnett said he had alerted managers to his concerns, but no action had been taken.

Boeing denied his assertions. However, a 2017 review by the US regulator, the Federal Aviation Administration (FAA), did uphold some of Mr Barnett's concerns.



### **Stocks rise with traders** braced for CPI volatility

#### **NEW YORK**

US equity futures gained with European stocks ahead of keenly awaited US inflation data that will help determine when the Federal Reserve finally pivots to monetary easing.

Futures on the S&P 500 and Nasdaq 100 rose 0.2 percent and 0.4 percent respectively. US Treasury yields were steady and a gauge of the dollar was flat. The advance in

On the oxygen cylinders issue, the company said that in 2017 it had "identified some oxygen bottles received from the supplier that were not deploying properly". But it denied that any of them were actually fitted on aircraft.

After retiring, he embarked on a long-running legal action against the company.

He accused it of denigrating his character and hampering his career because of the issues he pointed out - charges rejected by Boeing.

At the time of his death, Mr Barnett had been in Charleston for legal interviews linked to that case.

Last week, he gave a formal deposition in which he was questioned by Boeing's lawyers, before being cross-examined by his own counsel.

He had been due to undergo further questioning on Saturday. When he did not appear, enquiries were made at his hotel.

He was subsequently found dead in his truck in the hotel car park.

Speaking to the BBC, his lawyer described his death as "tragic".

In a statement Boeing said: "We are saddened by Mr. Barnett's passing, and our thoughts are with his family and friends."

His death comes at a time when production standards at both Boeing and its key supplier Spirit Aerosystems are under intense scrutiny.

This follows an incident in early January when an unused emergency exit door blew off a brand-new Boeing 737 Max shortly after take-off from Portland International Airport.

A preliminary report from the US National Transportation Safety Board suggested that four key bolts, designed to hold the door securely in place, were not fitted.

Last week, the FAA said a six-week audit of the company had found "multiple instances where the company allegedly failed to comply with manufacturing quality control requirements".



European equities was headed by basic resources and banks.

The options market is more concerned about a big S&P 500 move after the inflation report than it is about the Fed's interest rate decision next week, according to Citigroup Inc. Traders are hedging for moves of 0.9 percent in either direction, the biggest implied shift ahead of a consumer price index report since April 2023.

"Today is another CPI day, we'll have a lot of volatility around the data," Claudia Panseri, UBS Global Wealth Management's chief investment officer for France, said in an interview with Bloomberg TV. "What is important is the market has normalized expectations about interest rate cuts. We still expect inflation coming down, we still expect that the Fed cuts its rate in June."

Headline CPI is likely to accelerate, while the core gauge should slow slightly, according to Bloomberg Economics. A monthly rate of below 0.4 percent would be seen as a positive catalyst, according to Panseri.

"Ultimately, we don't expect the February CPI report to provide clear enough evidence of disinflation to boost the Fed's confidence to cut rates," Bloomberg economists Anna Wong and Stuart Paul wrote in a note. "However, they could have enough confidence as soon as May."

Elsewhere, UK stocks outperformed and the British pound dropped after data showed an unexpected increase in the unemployment rate and a slowing in the pace of pay increases, tempering concerns at the Bank of England about inflationary forces. The benchmark FTSE 100 climbed 0.9% and gilt yields fell.

The yen weakened for the first time in six days after Bank of Japan Governor Kazuo Ueda pointed to some weakness in consumption of nondurable goods, while also signaling the central bank remains on track to end its negative-interest-rate policy. The BOJ makes it next policy decision on March 19.

Japan's 10-year bond yield climbed to the highest level in three months following a Jiji report that said the BOJ will end negative interest rates at next week's meeting if wage data comes out strong.

In commodities, oil edged higher as traders awaited OPEC's monthly report and industry figures on US stockpiles. Gold eased from a record high. Bitcoin held just above \$72,000 after surpassing that level for the first time on Monday.

KATE, Britain's Princess of Wales, issued an apology on social media on Monday for "any confusion" caused by an edited photograph which had been issued by her office Kensington Palace the previous day.

Several leading news organizations including Reuters withdrew the picture of Kate, 42, posing with her three children after post-publication analysis showed it did not meet their editorial standards.

"Like many amateur photographers, I do occasionally experiment with editing," the message on X said, signed with a "C" meaning it was sent by Kate. "I wanted to express my apologies for any confusion the family photograph we shared yesterday caused."

In the picture a smiling Kate, 42, was shown posing with her beaming children Princes George and Louis and Princess Charlotte in Windsor, where the family live. Kensington Palace said the photo had been taken by her husband, heir to the throne Prince William, last week.

The picture had already attracted huge media attention as it was the first official photograph of Kate since she spent two weeks in hospital after undergoing abdominal surgery in January for a non-cancerous but unspecified condition.

LAWMAKERS, community leaders and dozens of members from local groups organized protests outside the Consulate General of the United States in Hong Kong on Monday, slamming some US politicians' baseless accusations against Hong Kong's efforts to safeguard national security.

On Monday morning, more than 30 people, including legislators Bill Tang Ka-piu and Michael Luk Chung-hung, from the city's largest labor union - the Hong Kong Federation of Trade Unions - protested outside the consulate general, criticizing the US for interfering in Hong Kong affairs and even blatantly impeding the legislation related to Article 23 of the Basic Law.

Since January, Western politicians such as Gregory May, US consul general to Hong Kong and Macao; Nancy Pelosi, former speaker of the US House of Representatives; and David Cameron, the British foreign secretary, have made a series of groundless defamatory attacks, attempting to undermine Hong Kong's efforts to strengthen the mechanism of safeguarding national security. Their irresponsible speeches have triggered citywide focus on developing its economy and improving people's livelihoods. The federation has warned the US gov-

ernment to give up its attempt to use anti-China activists, agents and organizations to endanger national security and social stability in the city, Tang added.

Luk said the actions taken by the US government and some of its officials blatantly violate international practices and diplomatic norms, deserving condemnation from all over the world.

The Article 23 legislation strikes a very good balance between safeguarding national security, protecting human rights and freedoms, and promoting economic development.

The city's proposed legislation has drawn upon the experience of other common law jurisdictions, Luk said, adding it not only comprehensively protects residents, but also benefits Hong Kong's economic development and foreign investors

Also on Monday, members of the Democratic Alliance for the Betterment and Progress of Hong Kong – the city's largest political party – staged a protest outside the consulate general, condemning the US and some other Western politicians' obstruction of Hong Kong's national security legislation and interference in Hong Kong's judicial independence.

The alliance said the US' tricks will definitely be unable to shake Hong Kong peo-

### China takes people's wellbeing as fundamental goal of development

The per capita disposable income of Chinese residents increased by 6.1 percent in real terms last year, outpacing the GDP growth during the same period. China created 12.44 million new urban jobs, maintaining overall stability in employment. Additionally, with price reductions and medical insurance reimbursement, negotiated drug prices in 2023 saved over 200 billion yuan (\$27.78 billion) for patients.

These tangible improvements in livelihoods have continuously enhanced the Chinese people's sense of fulfillment, happiness, and security.

"In recent years, our village has vigorously developed collective economy, which created job opportunities and increased villagers' income," said Xu Chuanjiang, Party head of Yuejia Village community in Chengyang neighborhood, Juxian county, Rizhao, east China's Shandong province.

Yuejia Village has made a success in running supermarkets and hotels, and now its collective assets have exceeded 1 billion yuan, with a collective economic income of 65 million yuan.

"In the future, we will continue to expand the village's collective economy and explore new paths to prosperity," said Xu.

To meet the housing needs of people is an important goal for improving people's livelihoods and directly concerns their wellbeing, said Shangguan Jian, secretary of the Communist Youth League Shanghai Committee.

Shanghai is increasing the supply of affordable rental housing for new residents and young people, accelerating the development of a multi-level and tiered rental housing supply system, Shangguan noted. The city is also optimizing the spatial layout of affordable housing for young people to alleviate the housing difficulties they face.

Equal education is an important foundation for social equity. "In our school, there are over 3,500 students from ethnic minority groups. With the support from governments at various levels, there have been significant improvements in infrastructure, and students have achieved balanced and comprehensive overall development," said Yulong,

a teacher at the First Primary School in Menghai county, Xishuangbanna Dai autonomous prefecture, southwest China's Yunnan province.

According to her, 20 schools were built or expanded in Xishuangbanna last year, providing an additional 9,680 school places and introducing high-quality educational resources. As a re-

sult, teaching quality in the prefecture has been on continuous improvement.

In recent years, various issues concerning people's livelihoods, ranging from strengthening food safety supervision to reducing students' academic burden, and from the "toilet revolution" to garbage sorting, have been effectively addressed.

The various demands and needs of the people are being addressed and satisfied, highlighting the image and unique strengths of Chinese modernization.

To provide people with easier access to high-quality medical resources, China has implemented a series of policies and measures, such as establishing urban medical groups and county-level medical consortia, said Yang Zhenglin, an academician of the

Chinese Academy of Sciences and president of the Sichuan Provincial People's Hospital.

Sichuan Provincial People's Hospital has established a medical alliance with 12 county-level public hospitals through a trusteeship model, to bring highquality medical resources to lower-tier regions, thus expanding people's access to medical services, Yang noted.

With steady progress in various reforms and gradual improvement of supporting measures, significant achievements have been made in ensuring people's access to childcare. The enrollment rate for preschool education has reached 91.1 percent, and the number of affordable kindergartens has reached 236,400. A comprehensive and quality public service system for preschool education, which en-

sures wide coverage and basic access, is continuously being established. "In recent years, China has accelerated the improvement of its elderly care service system, greatly enhancing the sense of fulfillment, happiness, and security for the elderly," said Xiong Shuilong with the Guangdong Provincial Committee of the Chinese People's Political Consultative Conference. As one of the pilot cities for

the long-term care insurance system, Guangzhou, capital of Guangdong province, has issued trial measures on long-term care insurance.

Currently, the long-term care insurance system covers nearly 8.97 million employees and over 2.54 million residents in the city. A total of 83,000 people have been benefited. Xiong suggested further ex-

panding the pilot scope. "By further expanding the coverage, we can ensure that elderly people in need of long-term care receive proper assistance, relieving more families of their worries."

In 2023, the Department of Civil Affairs of Hunan Province, in collaboration with relevant departments, carried out a special campaign to ensure the well-being of 9,000 orphans and 29,000 children without parental care, safeguarding their healthy growth, said Huang Donghong, head of the Department of Civil Affairs of Hunan Province.

This year, Hunan province will continue to expand the care for vulnerable children, including raising the minimum living guarantee standards for orphans and children without parental care as a key priority in the province's livelihood projects. More care will be extended to those in need of assistance, she added.

### US intelligence report raises concerns over Netanyahu's political 'viability' as leader of Israel

### WASHINGTON

US intelligence community has highlighted concerns over the political future of Israeli Prime Minister Benjamin Netanyahu, indicating that his "viability as a leader" is "in jeopardy," CNN reported.

The annual report from the US intelligence community, presented to Congress, suggests that "distrust of Netanyahu's ability to rule has deepened and broadened across the public from its already high levels before the war, and we expect large protests demanding his resignation and new elections."

"A different, more moderate government is a possibility," it also said.

The report also underscores criticism within Israel directed at Netanyahu's government for failing to anticipate the October 7 attack by Hamas, resulting in significant casualties and hostages. Public opinion questions the efficacy of Netanyahu's prolonged military response, which has caused extensive destruction in Gaza and raised doubts about its effectiveness in rescuing hostages, as reported by CNN.

Despite widespread support in Israel for dismantling Hamas, the intelligence assessment delivers a stark outlook on Netanyahu's political standing, signaling a possible shift towards a more

moderate government. This assessment is notable given President Joe Biden's previous positive sentiments towards Netanyahu.

Tensions between the US and Israeli leaders have escalated, particularly regarding the civilian toll in Gaza. The Biden administration has urged Israel to allow more aid into the Palestinian enclave, with Biden warning that Netanyahu is "hurting Israel more than helping Israel."

To which Netanyahu hit back in a separate interview that if Biden was suggesting "that I'm pursuing private policies against the wish of the majority of Israelis, and that this is hurting the interests of Israel then he's wrong on both counts."

The intelligence report further warns that Israel may face ongoing armed resistance from Hamas, with difficulties in neutralising the group's underground infrastructure. Military experts echo these concerns, cautioning that Israel's aggressive approach may inspire future generations of terrorists, as evidenced by the influence of Hamas on groups like al-Qaeda and ISIS.

The report indicates a heightened terrorism threat within the US since the October 7 attack, with FBI Director Chris Wray emphasizing the increased risk from various extremist groups.

"Even before October 7th, I would have told this committee that we were at a heightened threat level from a terrorism perspective, in the sense that it's the first time I've seen in a long, long time the threats from homegrown violent extremists, that is jihadist-inspired extremists, domestic violent extremists, foreign terrorist organizations and state sponsored terrorist organizations all being elevated at one time," Wray said.

The Annual Threat Assessment, a comprehensive overview of global security threats, took an unusual turn during a Congressional hearing, with Republican lawmakers focusing on security issues related to the US southern border. This deviation prompted a brief exchange between Democrat Sen Mark Warner and Republican Sen Jim Risch about the politicisation of the panel.

"One of the things I think that we have always taken some pride [in on this committee] is that we can agree without questioning each other's patriotism, questioning each other's motives," Warner said, adding, "And I hope that tenor will be maintained."

Risch fired back, referring to Warner and another Democratic senator who condemned the Republican line of questioning: "I've been on this committee for 15 years and we do a really good job until politics do creep in -- and that's what's happened here this afternoon with the last two speakers," according to CNN.

Testimonies from Director of National Intelligence Avril Haines and CIA Director Bill Burns highlighted the precarious situation in Ukraine. Russia's resurgence and Ukraine's ammunition shortages pose significant challenges, with the CIA urging additional US assistance to prevent further territorial losses

Burns said that without additional assistance from the US, Ukraine "is likely to lose ground and probably significant ground in 2024." A USD 60 billion aid package to Ukraine has been delayed in the House amid Republican opposition to additional funding.

### UN chief calls for action as women's rights face backsliding, violence

### UNITED NATIONS

UN Secretary-General Antonio Guterres on Monday underscored the critical urgency of protecting women's rights, now endangered by regressing achievements, escalating violence, and a widening digital gender divide.

Addressing the opening of the Commission on the Status of Women (CSW), the pivotal forum dedicated to promoting and safeguarding the rights of women and girls worldwide, the UN chief stressed the disproportionate impact of wars on women.

"In conflict zones around the globe, women and girls are suffering most from wars waged by men," he said, urging immediate ceasefires and humanitarian aid.

He highlighted the dire circumstances in Gaza, where reportedly more than two-thirds of casualties and injuries during Israel's military actions involve women and girls, and pointed out alarming reports of sexual violence against Palestinian women during detentions, house raids.

ation faced by women in other countries, including Afghanistan and Sudan.

The secretary-general stressed that despite evidence that women's full participation makes peacebuilding much more effective, the number of women in decision-making roles is falling.

"The facts are clear: Women lead to peace," he said, calling for more funding and new policies to boost women's participation and investment in women peacebuilders.

The UN chief also emphasized a growing digital gender divide, noting the dominance of men in digital technologies, particularly in artificial intelligence. He cautioned that algorithms controlled by men might embed disparities across multiple life facets, observing that the design of systems by male leaders and technologists frequently neglects women's needs, bodies, and essential rights.

"It's time for governments, civil society and the Silicon Valleys of the world to join a massive effort



nology at all levels," he urged.

Guterres also drew attention to the pressing need for women to hold leadership roles, particularly in financial institutions.He highlighted the stark gender disparity in finance, with over eight of ten finance ministers and more than nine out of ten central bank governors being men.

The top UN official emphasized that dismantling structural barriers is crucial for achieving gender parity in leadership roles. "Overwhelmingly male-dominated financial institutions need to dismantle the structural barriers

successful achievement of full gender parity among senior management and leaders worldwide, he urged governments, banks and businesses to replicate these efforts, emphasizing that change does not happen by accident.

In concluding his speech, the secretary-general called on the global community to rally together for gender equality, highlighting the role of the CSW as a driving force for transformative change.

He advocated for joint actions to eradicate poverty in all its forms."Let's do it by investing in women and girls, betting on women and girls, and pushing for peace and dignity for women and girls everywhere," Guterres said. The president of the General Assembly, Dennis Francis, continued the call to action, highlighting the urgency of intensifying efforts to achieve Sustainable Development Goals (SDGs).

With the world currently lagging attaining the goals, particularly the goal to eradicate extreme poverty, Francis revealed women.'

Highlighting the necessity of a comprehensive strategy, Francis emphasized the importance of ensuring equal access to resources, implementing social protection policies sensitive to gender, and adopting measures to eliminate gender-based discrimination that restricts women's participation in leadership and decision-making positions.

The 68th session of the CSW is taking place from March 11 to 22 at the UN headquarters in New York, under the priority theme of "Accelerating the achievement of gender equality and the empowerment of all women and girls by addressing poverty and strengthening institutions and financing with a gender perspective."



### Dar boxer still searching for Paris Olympics qualification

TANZANIA Olympic Committee (TOC) says it is contemplating securing the country's boxer Lucas Changalawe's participation in another Paris Olympics qualifying event.

Changalawe, fighting in the Heavyweight division, bowed out of the Paris 2024 Qualification Tournament that is taking place in Busto Arsizio, Italy, having lost to Norway's Mindaugas Gedminas by points.

The Tanzanian pugilist lost 3-2 to Gedminas in the round of 32 of the Olympic Qualifiers.

He was among the five African boxers who won their fights in the round of 64 held on the second day of the qualifiers.

In an interview, TOC vice president Henry Tandau- who accompanied the boxer to Italysaid once he arrives in the country this week, the committee's leaders will meet to discuss the way forward.

"TOC is an institution- we will meet to see what we should do, there are still more Paris Olympics qualifying events," Tandau pointed out.

"Before we come up with a final decision there are many aspects which we will look into, those include availability of funding," he said.

A total of 602 players from the National Olympic Committees of 113 countries are participating in the Italy competition, competing for 49 places in 13 different weight categories.

To reach the round of 32, Changalawethe 2022 Commonwealth Games and Africa Championships bronze medalist- twice knocked down Venezuela's Diego Pereira in the first round before referee Peter Olanda from Sweden waved it off in one minute 36 seconds of the first round.

Meanwhile, Boxing Federation (BFT) secretary-general Makore Mashaga said Changalawewe is expected to join the Ghanabound national boxing team tomorrow.

He also disclosed that the federation plans to send nine boxers to the Paris Olympics Qualifiers which will be held in Bangkok, Thailand in May.

Makore said there are 28 places for men and 21 for women in the Paris Olympics boxing showdown, with each weight category having four places, except for the 57kg women's weight category- which has two positions, and the 60kg women's weight category which has three positions.

The BFT leader noted: "The first Olympics Qualifier is being held in North Italy, Busto Arsizio, our boxer Lucas Changalawe was last Friday knocked out of the qualifiers."

"There were 49 quotas competed for (21 for women and 28 for men). Changalawe was sponsored by Tanzania Olympic Committee (TOC) but there is a second World Olympic Boxing Qualifier which will be held in Thailand's capital, Bangkok, in May," Mashaga noted.

"The remaining 51 quotas will be competed for, six female pugilists and seven male pugilists will qualify for the Paris Olympics, we plan to send nine boxers (four women and five men)," he said. Complex Stadium in Dar es Salaam on Monday.

He remarked: "In their area, Ihefu SC adopt a low block strategy, but we are well-versed in countering such tactics through diligent practice."

### **Tehran football derby** ignites passions in Iran

#### TEHERAN

EXCITEMENT is running high among fans of Tehran's two football giants before today's derby between Persepolis and Esteghlal whose long-running rivalry has ignited passions in sports and politics for decades.

The Azadi stadium, which is home to both teams, is one of the largest in the world, and will see its seats packed for the 103rd Tehran Derby.

"It's the most important match. There's a crazy atmosphere, incredible to experience," Kevin Yamga, the only Frenchman playing in Iran, told AFP. "Half of the stands are all blue, the other all red," said Yamga, who has played in five derbies since joining the blues of Esteghlal in 2021.

Fans travel hundreds of kilometres to reach the capital before spending the night near the stadium to secure a seat.

"It's a very, very strong rivalry, comparable to that between the clubs of Manchester - United and City - or of Glasgow - Celtic and Rangers," Yamga said.

The Frenchman, however, will not be playing on Wednesday due to injury.

Both teams are competing in the Iranian top-tier football league, the Persian Gulf Pro League.

Esteghlal are top of the table, three points ahead of title holders Persepolis, with 11 games to play.

This year, for the first time in Iran, a woman will join the refereeing team for a men's match. Though not on the field, 34-year-old Mahsa Ghorbani will observe the match with two others as video assistant referees.

Ghorbani's assignment is a mark of a new era in a closed-off world of Iranian men's football that has rarely seen women in the stadiums.

Last year, 3,000 Iranian women, after decades of fighting to get into stadiums, were able to attend their first derby, a move welcomed by FIFA.

"Iranian women have proven that they can obtain their rights, despite the patriarchal management of football," said Ebrahim Afshar, one of the country's bestknown sports journalists. "And one day, one of them will become the main referee."

The Islamic republic's two most popular clubs have also left their footprints in the country's politics over the decades.

Esteghlal, Persian for "independence", considered to be the club of the elite close to power, was founded in 1945 by an influential military officer under the name Taj, or "crown", of Tehran.

The club was associated with the Pahlavi dynasty which ruled Iran until 1979, when it was toppled by the Islamic Revolution.

In contrast, Persepolis aimed to be the people's club, after its founding in 1967 by a boxing champion.

"But in truth, Persepolis had players who were proud to be members of the shah's secret police, while some Taj players were from the left," which opposed the Iranian monarchy, Afshar said.

Both clubs managed to survive the Islamic Revolution, whose initiators considered football a pastime promoted by the ancien regime to distract the population's attention from "serious issues".

Forty-five years later, politics remains a pillar of fan bases on both sides, who accuse each other of benefiting from government financial support.

Their intense rivalry has forced public personalities to hide their allegiances to avoid criticism by supporters of the opposing team.

Out of 102 matches, 49 have ended in draws so far, with Persepolis winning 27 and Esteghlal 26.

"The history of the derby has shown that the pressure is such that the result is often decided on an act of play, a throw of the dice, rather than on the quality of the teams," said Afshar.

It is unlikely to see a repeat of the 6-0 defeat inflicted by Persepolis on Esteghlal in 1973, the memory of which is cultivated with pride by supporters of Iran's most successful club.

## An era ends for Jurgen Klopp and Pep Guardiola but now they enter something new in the title race

AS a beaming Jurgen Klopp sat down with the press after a 1-1 that got everyone off their seats, he was asked whether this made him want to stay.

The Liverpool manager reasserted his reason for leaving at the end of the season, but there is maybe some slight sense of regret - if also completeness - that his team produced what he described as one of their best performances against Manchester City in his last league game against them.

Klopp can be given to hyperbole in such situations, but there was logic to his claim. It was also for more reasons than the context of the performance and, as the German said, "the squad situation".

It was also about the approach and resolve. In Klopp's previous landmark performances against City, particularly in 2017-18, there was an element of Liverpool exploiting the rare gaps left by Pep Guardiola's side.

Those performances had the sense of being fully commanding, but they weren't quite that. As Klopp said himself, they usually won through counter-attacks.

This was different. It was one of Liverpool's more complete displays against this City side in how they dominated the ball and space. The spell after half-time was remarkable, with Guardiola's side unusually spooked.

It was a rare game where it felt like the champions got away with one, even though they themselves went so close with Jeremy Doku's shot off

the post. That might normally foster the sense that Liverpool will rue this draw, but there was no sense of that after the game.

"How we played in midfield was some of the best moments of my coaching career," Klopp said. "That we are able to do that against them... the boys really wanted it, massive heart, sensational atmosphere, one point, let's keep going".

The big question, of course, is how far they can go. Is it just a title challenge, or are we really talking about Liverpool becoming champions again in Klopp's final season?

The German, perhaps predictably, sidestepped that question. "All that matters is where we are from a performance point of view - and today we saw that."

This is actually the real significance of a fixture that had been built up as another seismic Liverpool-City game but ended somewhat unsatis-

factorily. There was no climax. Rather than settling anything, though, it set a pace.

After months where Liverpool looked so promising but questions persisted over how good they actually were, we now have a definitive answer. They were able to come back against City and dominate the game with many senior players missing. That is a big step.

They have become the team to beat... except for the fact that Arsethis duel between two great rivals was out of the way, thoughts properly turned to the fact that this really looks like the Premier League's first proper three-way race in a decade. Both managers were asked about the prospect, with neither having experienced it before.

It is something new even for them. That creates even more excitement from a sense of uncertainty. They

Where both managers were relaying exactly the same message, though, was in effusive praise of the other challenger. Both were glowing about Arsenal.

Guardiola enthused about how Mikel Arteta's side "need 25 minutes to go 3-0 up", in reference to the way they've just blown sides away of late. Klopp picked up that theme, talking about how Arsenal are 'firing on all cvlinders".

He then added "City is City", which is a simple three words but is maybe the most relevant point in all of this.

What he meant is that it's known Guardiola's side can get over 85 points at will - usually more - so this is the standard the other two have to reach. That's the decisive factor in the entire race. That is also why Klopp took such satisfaction from this result, but particularly the performance. It was an assertion of quality. ### **Pochettino calls for Chelsea** unity after Newcastle win

#### LONDON

MAURICIO Pochettino called for the Chelsea fans to trust his players after a 3-2 win over Newcastle on Monday propelled the Blues back into contention for European football next season.

Pochettino had faced open revolt from among his own support during last weekend's 2-2 draw at Brentford.

The former Tottenham boss has suffered a difficult first season at Stamford Bridge, which included losing the League Cup final to a severely depleted Liverpool last month.

Chelsea remain 11th in the Premier League table, but closed to within four points of West Ham in seventh, which should at least secure a place in the Europa Conference League.

"We need to stick together," said Pochettino, whose side face Leicester in the FA Cup quarter-finals on Sunday.

"Until the end we are going to fight to try to give our fans the best things. It helped a little bit today we scored from the beginning, the fans were good and behind us. They need to trust in us."

Newcastle's 12th defeat of the season leaves the Magpies just one point better off than Chelsea in 10th.

The pressure is also rising on Eddie Howe as Saudi-backed Newcastle have failed to build on finishing fourth last season to qualify for the Champions League for the first time in 20 years.

"All three goals are similar in their characteristics. We didn't defend those situations well enough and if you do that you are going to lose games," said Howe. "I know we can hit the heights of previously, but we are not doing it anywhere near often enough."

There were promising signs for Pochettino as some of his much-criticised expensive young recruits showed glimpses of their potential.

Nicolas Jackson is now up to 12 goals in his debut season as he cleverly flicked in Palmer's shot after less than six minutes.

However, it was the story of Chelsea's season that they failed to build on that flying start and allowed Newcastle to go onto control the rest of the first half.

The visitors were dealt an injury blow midway through the first period when Anthony Gordon was forced off.

But Alexander Isak produced a quality finish, fired low into the far corner, to bring Newcastle level two minutes before half-time.

The one new signing Chelsea have been able to rely on all season is Cole Palmer and the England international restored his side's lead in emphatic fashion just before the hour mark.

Palmer collected Enzo Fernandez's pass, cut inside and unleashed a powerful effort for his 11th Premier League goal of the season.

Mykhailo Mudryk, by contrast, has been a constant frustration for a number of Chelsea managers since joining for £88 million (\$113 million) just over a vear ago.

The Ukrainian had been on the pitch only five minutes when showed his blistering pace to burst through the heart of the Newcastle defence and turn in just his sixth goal in 46 Chelsea appearances. AFP

The French forward missed four games since, of which Atletico have won only once, but has returned to training and Spanish media say he is set to feature in the second leg.

Perhaps with one eye -- or even two -- on the Champions League, Atletico fell to a dismal 2-0 defeat at lowly Cadiz on Saturday.

It was the Andalucians' first victory in 17 matches and first in La Liga since September.

Despite the woeful performance Simeone backed his men ahead of the Inter clash.

"I feel that the team is giving everything and it's me that is not finding the right way," said the coach. "I'll go to the death with the players because I know what they can give, I know they can do big things, and I will keep working with them."

Simeone's last chance of silverware this season lies in Europe and the coach will be grateful for Griezmann's potential return.

The 32-year-old forward has 18 goals in 36 appearances across all competitions this season.

Atletico are also boosted by their strong home record. At the Metropolitano stadium they have won 18 of 20 matches this season across all competitions, tumbling just once -against Athletic in the cup.



Their fans usually create a raucous atmosphere on big nights and the game is tipped to set a new record attendance at the 70,000 seater stadium. Simeone has doubts in defence as none of his regulars are in good form with the exception of Axel Witsel.

New arrival Gabriel Paulista made errors against Cadiz, while Reinildo Mandava has not been at his best after a long injury lay-off.

"We have to reset and prepare well for the game against Inter on Wednesday," said Witsel after the humbling by the Yellow Submarine. "There is no time for words, we have to focus on our work and play well against Inter."

Meanwhile, in Dortmund, Borussia Dortmund coach Edin Terzic will know his job is on the line against PSV Eindhoven in today's last-16 second leg at home. A 1-1 draw in the Netherlands makes the assignment simple: the winner in Dortmund will progress to the last eight.

Born and raised on Dortmund's outskirts, Terzic's story of the childhood BVB fan whose first head coaching job was at his favourite club is the stuff of fairytales.

Winning the German Cup as interim boss in 2021 before getting Dortmund closer to a league title last season than anyone since Jurgen Klopp, losing out on goal difference, had Terzic living an increasingly rare modern football story.

But a poor domestic season, which has Dortmund out of the German Cup and fighting for a spot in next year's Champions League, has Terzic on thin ice. After a 2-1 win at Werder Bremen on Saturday despite playing half the match with 10 men, Dortmund sporting director Sebastian Kehl acknowledged his team's struggles but said they were improving at the right time.

"We know we need to win to get to the next round. I see us as fully capable of beating a strong Eindhoven side, particularly at home.

"We will prepare for it well. It's a final. In the past few weeks, the team has put ourselves more and more into a situation which gives us a chance to win games like this.'

Jadon Sancho scored what would become the winner on Saturday, his first goal since returning to Germany on loan after a troubled time at Manchester United.

Dortmund will hope there is more to come from a player whose performances had him standing shoulder to shoulder with then teammates and now superstars Erling Haaland and Jude Bellingham.

Speaking with Dortmund's website on Sunday, Sancho said: "The last time I was here, I had a goal or an assist in every game. I can understand the fans expect a lot of me -- I expect a lot of myself."

# Gamondi: It is too early to say NBC PL title race is over

YOUNG Africans SC head coach Miguel Gamondi believes it is far too early to declare the NBC Premier League title race over.

The league's defending champions already find themselves five points clear at the top of the NBC Premier League, despite having two games in hand over second-placed Azam FC.

They are also ten points ahead of third-placed Simba SC who have one game in hand.

Imperious in the NBC Premier League and with a CAF Champions League quarterfinal ticket, Young Africans SC, alias Yanga, sealed a sixth straight league win with a 5-0 triumph over Ihefu SC at Azam Complex Stadium in Dar es Salaam on Monday evening.

Gamondi told reporters he is more than satisfied with his team's performance against Ihefu SC who had beaten them when the two sides met earlier this season at Highlands Estate Stadium, Mbarali.

The Argentine disclosed: "I am very happy with the performance of the team. In the beginning, it was a tough game for us because Ihefu SC is a team that plays a nice kind of football but I think we were perfect."

"We dominated, created chances, and put the ball in the net which is the most important," Gamondi stated.

"I can't ask for more than five goals. It is fantastic. Last time they told me you don't score many goals, you lose too many chances but today we did not lose many chances," he noted.

He insisted: "We are very realistic, we missed three or four chances but we scored five. I think we are the best offensive team in the league and we are defending well as well. I am more than satisfied."

When asked if he thought the title race was over, the Yanga boss said it was way too soon to tell while calling on his side to keep their winning momentum for the next five games.

It means that Tanzanian side Simba Sports Club will not be able to meet its Group B opponents ASEC Mimosas at this stage. Each knockout tie is played at both teams' home stadium - as long as it meets CAF requirements - whilst extra time and penalties are used if the tie is level after 180 minutes.

The group winners are Al Ahly (Egypt), ASEC Mimosas (Cote d'Ivoire), Mamelodi Sundowns (South Africa), and Atletico Petroleos (Angola).

The runners-up are TP Mazembe (DR Congo), Simba SC (Tanzania), Esperance Sportive de Tunis (Tunisia), and Young Africans SC (Tanzania).

According to organizers, the draw was conducted in Cairo, Egypt starting with the CAF Confederation Cup at 14h00 Cairo winners playing the first leg away from home. The draw will also determine the semi-final pairings and the road to the final.

In the draws for the semi-finals, there will be no seedings, and teams from the same group or the same association could be drawn against each other.

As the draws for the quarterfinals and semi-finals were held together before the quarterfinals were played, the identity of the quarterfinal winners will not be known at the time of the semi-final draw.

The winners of the title will qualify for the brand new 2024 FIFA Intercontinental Cup and the expanded 2025 FIFA Club World Cup in the United States of America.

Exciting fixtures are also on the cards in the 2023/24 CAF Confederation Cup quarterfinals, given the defending champion USM Alger of Algeria will lock horns with the tournament's previous season quarterfinalist, Nigeria's Rivers United FC.

Abu Salim of Libya will take on the 2022 CAF Confederation Cup winner, RS Berkane of Morocco in the last-eight phase, and the phase will moreover see Stade Malien of Mali confront Ghanaian club Dreams FC.
