Harbinder Sethi freed on 26bn/liability accord

Court satisfied that 200m/- already deposited

BUSINESSMAN Harbinder Singh Sethi yesterday regained his freedom after nearly four years in custody, following the payment of 200m/- out of 26bn/- he was ordered to compensate the state.

Earlier, the Kisutu Resident Magistrate's Court found the owner of Independent Power (T) Ltd (IPTL) guilty by his own admission, of fraudulently obtaining money in the economic sabotage case.

The decision was handed down by the Chief Resident Magistrate Huruma Shaidi when the case of Economic Sabotage No. 27/2017 was summoned to court for registering the prearranged agreement.

The court was satisfied that the businessman had deposited 200m/with a further condition that he will pay the reminder in instalments within 12 months, upon which the businessman was told that he was free to go, thus walked out of the court and was joined by his family.

Sethi was facing an economic crimes case alongside James Rugemalira and the two have been behind bars since 2017, but in 2019 he wrote to the Director of Public Prosecutions (DPP) to negotiate his release under the plea bargaining formula set out by fifth phase president, the late Dr John Magufuli.

The two businessmen were arrested in connection with the Tegeta escrow account saga and first appeared at the Kisutu Resident Magistrate's Court on June 19, 2017 facing 12 charges, which included money laundering.

The two were accused of dealing with criminal networks, forgery, submission of false documents, obtaining money through fraudulent means, occasioning the government a loss of \$22,198,544 and Sh309 billion.

The prosecution says Rugemalira and Sethi committed the said crimes in Dar es Salaam, South Africa, Kenya and India.



Detained clerics set free in Dar flown to Zanzibar

the two were about to be set free. Awadhi Hadi Ahmed, Sheikh Ahmed's younger brother said the

Ahmed's younger brother said the family was traumatized and lived in fear for the entire period the cleric was incarcerated.

"We heard a knock on the door at 9pm and upon answering we were pleasantly surprised to see Farid," he said.

The younger Ahmed said the family was hugely relieved and thankful to those who facilitated the release as well as all Tanzanians who have for years been agitating for justice to be done.

Sheikh Farid's son Muaadh said he missed his father a lot because he was only 12 when he was arrested and is now 21 years—an adult. He said he did not have the guidance of a father which every child deserved.

"It is the best birthday gift ever; I've turned 21 today and my father is back home a free man," he said.

Speaking of their release, Sheikh Mselem said they were set free at 7pm and taken to the Julius Nyerere International Airport and put on a chartered plane to Zanzibar.

Upon touching down, he said they were taken to the VIP Lounge of the Abeid Amani Karume International Airport.

From the airport, he said they were put to additional VIP treatment with each being chauffeured in a separate SUV "to the destination of their choice."

"The driver asked whether I wanted to be taken to my first or second wife but I chose to be

driven to my mother's house," he said.

The cleric thanked Union President Samia Suluhu Hassan and Zanzibar President Dr Hussein Ali Mwinyi for making efforts that led to their release.

Sheikh Ahmed, leader of Uamsho (awakening) movement and his 35 colleagues have been in remand prison since 2012 facing terrorism charges. Apart from him and Mselem, 16 others were also set free yesterday and the fate of remaining others has not been clarified.

Last month, lawyers representing the clerics won over prosecution appeal against the decision of the court drop 14 of 25 charges leveled against them.

The Court of Appeal dismissed the prosecution's objection to dropping charges, where prosecutors said the Director of Public Prosecutions (DPP) has the authority to appeal the decision of the High Court or lower courts with additional jurisdiction, citing technical issues of opposing penalty or in acquittal.

On April 23, the High Court dropped 14 charges after agreeing to arguments of defence lawyers, Daimu Halfani, Juma Nassoro, Jeremiah Mtobesya and Abubakar Salum that the court has no jurisdiction to hear the charges as the alleged crimes were committed in Zanzibar.

The DPP set out an objection to the Court of Appeal but during the hearing of the appeal the defendants' lawyers raised objections against the government's appeal and prevailed.

Justice for children, youth crucial, says ACHPR judge

Primary School yesterday, Justice Aboud made this assertion when answering questions raised by some pupils on the role the court plays in safeguarding the rights of children.

The court can and will hear all matters related to child rights abuse, she stated, pointing out that children cannot come to the court directly, as they need to involve their parents, guardians or elders in their community in reporting issues or filing cases.

Young people should speak up against all injustices experienced in their communities or families, she emphasised, saying that the world marks the Day of the African Child "because there were children who many years ago dared to stand up against all odds, in opposing the oppressive system in apartheid South Africa."

"As it happens also, the recently launched African Court's five-year strategic plan, 2021-2025 intends to actively address and seek out new ways to strengthen the complementary nature of the court's human rights protection mandate, including the Rights and Welfare of the Child," she told the gathering.

Getting the work done will involve closer engagement with national human rights stakeholders such as national courts, human rights institutions and non-governmental organizations, including those operating at the regional and continental level, along with bar associations, academia and the

media fraternity, she elaborated.

Victor Lowilla, the CHPR Legal Officer, had earlier said that African children still suffer human rights abuses, including forced labour in mines as in the Congo, being drafted into fighting groups in Central Africa, assimilated in rebel causes, while being compelled to beg or trade in the streets, in Tanzania.

"And we still have many children being denied the right to attend school," he specified.

Through its newly launched strategy, the court plans closer cooperation with the African Committee of Experts on the Rights and Welfare of the Child, the African Governance Architecture Platform members, notably the African Commission on Human and Peoples' Rights, along with courts of regional economic communities.

"And we also envisage enhancing our collaboration with international partners, such as United Nations human rights bodies. European and Inter-American human rights courts and institutions," the court president stated.

"It is therefore expected that in five years' time the African Court will be transformed into a continental legal entity which can present tangible evidence of its increased efficiency and effectiveness, which will in turn have led to greater credibility in the capacity of the AU human rights system to make a positive difference in the lives of African individuals and peoples," she added.

principal, Prof Honest Ngowi said that overall, the government had done well.

He praised it for coming up with what he termed as the poor man's budget, asserting that more revenue sources would enable the government accomplish ongoing flagship projects and start new ones.

Despite the fact that the national debt remains within sustainable levels, there is a need for the government to look for new revenue sources so as to swiftly service the national debt which has reached 29 per cent of the 2021/22 budget expenditure commitments, he stated.

He commended the government for improving relations with development partners as this will facilitate obtaining more funds to support the budget, along with concessional loans that have more generous terms than market-based loans.

On the collection of property tax be conducted on a prepaid format as with electricity, Utouh said that in order to avoid discretional decisions on who is supposed to pay what amount, the government needs to set uniform payment scaled to expenses.

It also needs to reinforce the security of ICT systems, to ensure that database servers are manned and owned by public institutions, similarly underlining the need to amend the Public-Private Partnership (PPP) Act of 2010 to help achieve objectives of the proposed budget.

"As it is now, the one who finances the feasibility study gets into the competition, something that might jeopardize the execution of the project if the one who financed the study fails to secure the tender," he argued.

Reports on the performance of public institutions like the Prevention and Combating of Corruption Bureau (PCCB), the Office of the Treasury Registrar and the Ethics Secretariat should be made public and presented to the National Assembly, while also being opened to the public, he

emphasised.

The Wajibu assessment also suggested that the Tanzania Revenue Authority (TRA), the Bank of Tanzania and the Tanzania Communications Regulatory Authority (TCRA) invest heavily in building capacity on identifying and tax online business, which he said is booming in the country.

CAG reports known as 'management letters for public entities' should also be public, and the legislature make effective management of implementation of the approved budget, so that it achieves intended objectives, he said.

This can be done by ensuring it reviews quarterly budget implementation reports that are provided by the Treasury, he affirmed, while advising the government to initiate discussions with neighboring countries on extending services to those countries when strategic projects like the Julius Nyerere Hydro Power Project (JNHPP) and the Standard Gauge Railway (SGR) are completed.

Such a link would improve foreign currency flows so as to cover huge debts arising from the projects, he elaborated

"The government should ensure that it increases financial capacity, staffing and infrastructure of tax arbitration tribunals so as to hear and decide tax cases as currently 360.08bn/- and \$181.43m cases need to be arbitrated," he said.

The government also needs to reduce the number of projects planned for the year to give it a chance to allocate more funds in implementing a few projects that will be completed on time, the retired administrator intoned.

"Generally, we commend the government for the 2021/22 budget estimates as well as coming up with new sources of revenue such as telephone line tax, municipal bonds as well as property tax through prepaid metering," he added on the budget where the government proposes to spend 36.329trn/- where 63 percent targets recurrent expenditure and 37 percent caters for development projects.

THE government is yet to decide whether to lift or not the temporary ban on exports of live animals which has been in place since 2016.

Deputy minister for Natural Resources and Tourism Mary Masanja said in a response to a question by Muheza legislator Hamis Mwinjuma who wanted to know when the government will lift the ban of export of butterflies and other lives animals.

In response the deputy minister said the government was conducting a verification of the losses and profits of the businesses and that after the exercise the decision will be made.

"The government noticed that there were irregularities in the way the business was being conducted including transporting

of some protected animals they only export pet species abroad," she said.

Exporters of the live animals have several times carried behind the scene discussions with officials from the ministry of Natural Resources and Tourism to find a lasting solution to the problem to no avail.

They have recently said they were seeking an audience with President Samia Suluhu Hassan for her intervention on the matter saying their families are suffering economically following the ban.

Through their umbrella body the Tanzania Wildlife Exporters Association (TWEA) argued that available in open areas which is two third of the total area of the country and not from protected areas which covers one third of the Tanzanian total area.

TWEA has on several occasions complained of incurring losses amounting to billions which included battling lawsuits in foreign courts from their clients who decided to go the legal way after an agreement between the two sides to deliver the animals in time was not honored.

The government banned transportation of all live animals outside the country in March 2016

until proper procedures were made to ensure only approved animals were transported.

The decision sparked anger from exporters who complained that the ban was a surprise decision to them as it was made a month or so after they were handed licenses to operate.

The traders claimed that Tanzania has painted a bad image in a business full of competition that involves various countries including the Democratic Republic of Congo (DRC), Zambia and many others saying it will take time to restore the trust from customers.

Amendments for Finance Bill 2021 tabled for first reading

THE Finance Bill 2021 which proposes for amendment of key tax laws to facilitate implementation of the 2021/22 national budget was tabled for first reading in Parliament on Tuesday evening.

The bill which is divided into twenty parts whereby part one deals with preliminary provisions which includes the title of the Bill and the date of which the Act shall come into operation.

Deputy minister for Finance and Planning Hamad Masauni presented the bill in Parliament where among other things the bill proposes to amend the Income Tax Act, Cap. 332 whereby section 10 is amended so as to empower the Minister to grant exemption in respect of projects funded by donors or through nonconcessional loans without prior approval of the Cabinet with a view to fast track implementation of the projects.

"Part III of the Bill proposes to amend the Electronic and Postal Communications Act, Cap. 306 by imposing a levy on airtime depending on the consumer's ability to top up in order to raise funds for implementation of development and strategic projects," the minister said.

On another note, Section 124 of the Act is proposed to be amended by imposing excise duty at the rate of 10percent on imported used motorcycles aged more than three years in order to discourage importation of used motorcycles with a view to protect the environment.

This section is further proposed to be amended in order to add to the list money transfer and payment service providers licensed under the National Payment Systems Act.

Part of the Bill proposes to amend the Government Loans,

Grants and Guarantees Act, Cap 134. Section 13 is amended to enable the Government to issue a guarantee to institutions or companies to borrow an amount of money not exceeding the value of shares of the Government in the respective institution or company undertaking the project upon approval of the Cabinet.

The Finance Act 46 Part VI of the Bill proposes to amend the Gaming Act, Cap. 41 whereby section 31A is amended to reduce gaming tax on winnings with a view to encourage players to opt for local gaming activities instead of offshore gaming activities.

Further, the Second Schedule is amended by increasing gaming tax on sports betting and introducing a tax rate for virtual games and other gaming products licensed under section 51 of the Gaming Act in order to increase Government revenue.

Part VII of the Bill proposes to amend the Higher Education Students Loans Board Act, Cap 178 whereby section 7 is amended by imposing a requirement of seeking approval of the Minister and publication in the Gazette before the Board exercises its powers of setting criteria and conditions for granting of student's loans and issuing grants, bursaries and scholarships.

The aim of the proposed amendment is to regulate the Board's powers of imposing conditions on the loans issued to students.

TANAPA in five-year strategy to increase number of tourists

TANZANIA National Parks (TANAPA) Authority embarked on a five-year strategic plan to be implemented in seven areas that includes innovation and expansion the scope of tourists' products and other goods and aimed to increase the number of tourists in the country.

The remarks were made here yesterday by the Senior Assistant Conservation Commissioner, Paschal Shelutete at a seminar organised by the authority for journalists.

Shelutete said the authority was implementing conservation and tourism activities in accordance with the five-year (2018/19 - 2022/23) strategic plan that has been revised and replaced by another five-year strategic plan beginning 2021/22 to 2025/26.

He said the strategy aims to implement government directives in the country's tourism sector.

He mentioned the strategy's other priority area as including the strengthening infrastructures for tourists, specifically road infrastructures, airport, national parks'entrances, accommodation, communications, water and electricity.

"Other areas include boosting of tourist areas advertising via television including the TBC's Tanzania Safari Channel, radio programmes and in the social networks," he said.

The Commissioner added other strategies as including offering opportunities to the private sector to develop tourism in the national parks, putting in place an enabling environment in the public and private sectors to woo investment in the national parks areas.

He said in the coming five years, the Authority plans to increase accommodation capacity in the national parks from 3,429 beds to 5,000.

Citing various achievements attained, Shelutete said these include the installation of a hotair balloon in Serengeti, Tarangire and Ruaha national parks and canopy walkway tourism in the Lake Manyara and Kitulo national parks.

ongoing feasibilities include investment on cable cars from the Machame gate to the Shira Plateau in the Kilimanjaro National Park, as well as continuing with strategic projects to boost tourism in Rubondo, Burigi-Chato and Serengeti national parks," he added.

Earlier, opening the seminar, Senior Dodoma Assistant Conservation Commissioner, Ahmed Mbugi called on the journalists to use their pens to advertise tourists' attractions in the country to mobilise Tanzanians to visit their national parks.

For his part, TANAPA's chief conservation Officer july lyimo said tourism helps to develop the country's economy and boost national income, introduce the country to the world and increase job opportunities.

He appealed to the journalists to write news that mobilises Tanzanians to visit their national parks.

TANZANIA has declined by 35 per cent from an average 162 patients per every 1000 in 2015 to 106 per 1000 in 2020, the National Assembly was told yesterday.

The country has also declined in regions with high malaria prevalence from 11 in 2017 to seven in 2020 thanks to the Tanzania Biotech Products Limited (TBPL) which has proved to an efficient national biological arsenal aimed at eliminating malaria through the production of biolarvicide.

Minister of Health, Community Development, Gender, Elderly and Children Dr Dorothy Gwajima

'The incidence rate of malaria declines'

said in a written response to a question by opposition Special Seats legislator Halima Mdee.

The MP wanted to know the contribution of the factory in fight against malaria in the country.

The minister said in response that since TBPL-the subsidiary company of National Development Corporation (NDC)-started production in 2016 a total of 340,520 litres of biolarvicide have been bought by the government from the factory at a cost of 4.5bn/- which is an average of 13,200/- per litre.

The chemicals have been distributed to 28 regions and 185 district and municipal councils across the country.

"The efforts includes implementation of other ways of controlling the spread of the disease such the use of treated

THE government has signed five agreements for building new ships in the Indian Ocean, Lake Victoria and Lake Tanganyika valued at 438.8bn/-.

The signing event was witnessed here on Tuesday by President Samia Suluhu Hassan and officials of Marine Services Corporation Limited (MSCL) at Mwanza south port in Mwanza City.

The signing involved by MSCL acting managing director Philemon Bagambilana on behalf of the government and two foreign firms.

While at the Port, President Samia inaugurated the 'New MV Victoria HAPA KAZI TU' and 'MV Butiama' that underwent massive refurbishment to begin sailing in Lake Victoria.

In the first agreement a ship will be built for Lake Victoria that will have the capacity to carry 3,000 tonnes of cargo and 600 passengers.

President Samia said she would like to make Mwanza city a commercial centre for the Lake zone regions since there are many opportunities.

She further said the government will revive technical colleges to provide opportunities to the youth to receive ship building education and called upon the contractors to work professionally.

"The work done in the ships' refurbishment and dry dock is good, I am greatly pleased as cargo transport has now been made easy," she added.

For his part, the Works and Transport Minister Leonard Chamuriho said the vessels will open up the economies for

Climate-smart agriculture, new way of farming that makes farmers smile in the face of climate change

from climate-smart agriculture (CSA), which proved to be effective in curtailing stress that are caused by climate change as well as increasing yields per acre.

"I like this farming a lot, especially the use of tied ridges technology because even with little rains, one can manage to get a good harvest compared to our traditional farming where we sometimes used to lose all the crops when the rains failed," says Monica Meshack, a farmer in Kilosa District, Morogoro Region.

Meshack is amongst a group of farmers that are beneficiaries of a project sharing knowledge on how to implement climate-smart agriculture (CSA) practices and technologies in the country.

CSA is an approach to increase food productivity and farmers' income while reducing greenhouse gas emissions and building resilience to shocks and stresses from climate change.

The project, Building Capacity for Resilient Food Security, is funded by the United States Government through the United States Agency for International Development (USAID) with the government of Tanzania as a main partner. The lead government partners are the Ministry of Agriculture, Ministry of Livestock and Fisheries and the President's Office Regional Administration and Local Government (PO-RALG) from the mainland and their counterparts in Zanzibar at the Ministry of Agriculture, Irrigation, Natural Resources and Livestock (MAINRL).

The project has brought together various experts to equip farmers on climatesmart agriculture practices and technologies suitable to their agricultural zones and in line with climate/weather forecasts.

Technical support is provided by the United States Department of Agriculture (USDA). The

International Institute of Tropical localized and demonstrate the best-production activities. "In the past, I relied on guesswork to determine when to plant, and many times I had to manually water my banana field if I got the season wrong.

"But now, I follow the weather forecast keenly as I know it has a large bearing on my farming activities," said Hassan Fumu, a banana farmer in Mahonda, who is among the beneficiaries of the project.

Developing current future extension workers the project has also been working with the Training and Extension Department at the Ministry of Agriculture to review the certificate and diploma programs of the Ministry's Agriculture Training Institutes (MATI) to ensure topics on Climate Smart Agriculture (CSA) are addressed.

50 grape farmers in Dodoma secures contract with the brewer company

EFFORTS by grape farmers in Dodoma region to seek for cultivation support and assured markets have finally fetch fruitful results following a move by some key stakeholders to start extending investment footholds towards the economic sub-sector.

To start with, the Tanzania Breweries Limited (TBL Plc) have entered into the contract with at least 50 farmers for the cultivation of grapes wine varieties needed for the production of diverse wine brands.

Under the sector's maiden contract, the beneficiary farmers are provided with the needed seedling varieties, fertilizers, pesticides as well as extension services and after harvesting, the company will purchase the grapes at rewarding prices.

TBL Plc Agriculture Manager, Joel Msechu, informed The Guardian during an exclusive interview that the farmers have already received special training from a high- profile grapevine expert from South Africa.

"The training based on recommended agronomic practices necessary in growing grapes more successful," he explained.

He added that the company have also imported and supplied to the farmers three best wine grapes varieties from South Africa.

"The target is to have best wine grapes with needed sugar content to enable TBL Plc to bottle best wine brands," he said.

According to him, the company will annually keep on increasing the number of farmers.

"Apart from targeting raw material, the vision is also to assist the farmers to improve their livelihoods," he stated.

On his part, Dr Cornel Masawe, Head of the Tanzania Agriculture Research Institute Makutupora) expressed that the development will play major role in advancing performance of the

He said the grape farmers in the

region were working tirelessly but their cultivating morale have been diluted by a number of setbacks, including lack of reliable markets and friendly prices.

He said the institute was also in process to introduce into the country at least 13 new wine grape varieties from South Africa in a move aimed to improve the sector.

He disclosed the seed varieties to be imported from South Africa which is a mixture of red and white grafted scions, as well as root stocks are Pinotage, Cabinet Saviugnon, Syrah, Merlot, Durif and Carignan.

Others are Chardonnay, Chenin Black, Semillon, Ramsey, R99, R110 and S04.

"Statistically, Tanzania is placed second after South Africa for brewing best wines within the continent, but there are only two wine grape varieties grown in the country, Makutupora Red and Chenin White, a situation which limits production of wider varieties of wines," he observed.

Researches has proved that Tanzania has potential whether to produce grapes with high sugar contents, which is useful in processing wines of high alcoholic percent (from 12 to 14 percent), in surpass to the rest countries in the world where the crops is cultivated.

"Tanzania is the only country in the globe with friendly weather which supports grapes to grow in two seasons within a year, an advantage which must be exploited accordingly," he briefed.

She said stone crushing plants near people's residential areas affect the environment as well as the health of the people near them and their farms.

She said despite government

Z'bar govt suspends stone crushing business near residential areas calls to the people to invest in by oppressing others, saying former procedures of making

economic activities, they should not be left to adversely affect the environment and pose health hazards to the people.

She added that the exercise will be sustainable to see whether all factories engaged in stone crushing business do so by adhering to safety regulations, to both the environment and human beings.

Dr Mkuya explained that there are some investors who have been providing essential services to the community including digging wells for safe and clean water and other services.

She called upon these investors not to use the excuse brick making factories to follow

everyone has the right to live in the country peacefully without botheration.

However she called upon these investors and the citizens in general to abide by the country's laws, regulations and guidelines governing environmental preservation.

She said in so doing it will enhance the health of the people as well as job opportunities and other activities that spur economic growth.

For his part, the Director General of Zanzibar Environmental Protection Authority, Sheha Mjaja Juma said it would be better for all bricks without aggregate since the availability of sand for building is not problematic.

Mjaja said if the people want to engage in stone crushing business, they should shift their plants at stone quarries sites to remove inconveniences subjected to other people.

For his part, the Acting Director of the Energy and Minerals Department, Omar Mohammed, said as for now they were making amendments to some regulations governing natural resources, and when the amendments are ready they will come up with appropriate directives.

Sexual violence against children up by 26 per cent, says TAMWA

SEXUAL violence against children has increased by 26 per cent in 2020 and remains one of major violation of children's rights in the country, according to the Tanzania Media Woman Association (TAMWA).

Speaking yesterday during the commemoration of the International Day of the African Child, TAMWA Executive Director Rose Reuben said that sexual violence against children is still a major concern in the country, calling for more players to chip in and address it.

Citing police report, Rose said sexual violence against children cases have increased whereas in 2020, 7263 cases were reported which is an increase of 26 per cent compared to 2015 where 5803 cases were recorded equivalent to 615 cases per month which is said to be endangering the future welfare of children in the country.

With these cases, the activist said despite existing legal and policy frameworks, children in Tanzania continue to experience high rates of sexual violence in their homes, schools and communities and children continue to feel that not enough is being done to ensure they are safe from abuses, she added.

Further, efforts to fight such barbaric behaviors against children the government in collaboration with partners through its National Plan of Action against Violence against Women and Children (NPA-VAWC) 2017/18-2021/22 aimed at reducing violence against women children by 50% in reaching 2022, she commented.

"Although there are different plans in action the government must keep on striving to continue improving their fight against child abuse because the children lives are being threatened by these abuses," she said.

"In celebrating this day and looking at our government's efforts to reduce and eliminate child abuse, we call on communities, civil society organisations to see that it is everyone's responsibility to put an end to child abuse because these abuses starts at a family level," she added.

One of the Dar es Salaambased parents, Secelela Balisidya said parents need to set time for children as well so that they can be able to talk to them and get the chance to know what is going on with them on a daily basis.

"As parents, we need to look at our children closely and not leave everything to our house help so that our children can be able to confide in us on every little detail that is happening to them in the course of their everyday lives be it at school or at home," she said.

Esther Dogani, a form four student from Magoza Secondary School called upon students and children to be more open to their parents, when facing abuses because only through them they will be able to get the help needed.

Scrapping levies daunting for Treasury, MPs, public

been applauding measures eliminate tariffs and scores of levies in various areas, it is not an easy day for the Ministry of Finance and Planning to have the whole legislature and even less so, members of the public to agree on the rationality of each step. Naturally each group of stakeholders praises what helps their part of industry, like reducing costs of bringing goods to the market or importing finished goods or raw materials, but other measures are painful. A list that was given by the Confederation of Tanzania Industries was an example; praising some cuts, but lamented similar levy cuts.

The tax cuts that CTI lamented are those relating to imports not all of them but those which reduce what is known as 'effective protection' of local producers. A CTI analysis even broached the possibility of factories being closed for that reason, as duty on printed fabrics (cotton and polyester) usually known as 'kitenge' were reduced as well. It is clear that a level playing field for local producers and importers makes business more vibrant while 'effective protection' permits cost indulgence, reduces incentive for efficiency on the part of local producers, a situation that was so glaring on the part of the sugar

When looking at contributions of MPs, one gets a glimpse of areas where big reforms are still needed, and also a measure of how difficult it will be for the government to go as far as that demand, or technical projection to arrive at a competitive economy. Anthony Mavunde, Dodoma Urban MP, said in a pivotal contribution that the government should review fiscal policy by removing VAT on

THILE the breadth tourism, noting that East African countries competing with us for tourist arrivals do not charge VAT on tourism. It was a sort of discovery, as over the past year questions were rising why tourists don't come back after the first visit.

> The MP emphasised that if we are to adequately compete in the tourism sector, we need to ensure that we sort out all the issues that make tourists not return when they visit, which means that their visits are rather highly priced, so they don't have the comfort to return and feel at ease. He cited corporate tax as another area, where he said Tanzania needs to come down to at least 26-percent from the 30percent charged by most African countries, to attract investors. In other words the government isn't charging too highly, but in so doing makes Destination Tanzania relatively uncompetitive, but does Treasury have room for that?

> There is another observation the MP made which takes the issue nearer to the crux of the matter, when he said that the government should also form a policy forum to involve the Diaspora which is potentially a source of large remittances. He cited the Kenyan case as having more inducing investment incentives, noting that the Diaspora brings home about \$2bn per year in remittances as "there is a good environment for them to participate in local economic building." What the MP may not have struggled to remember is that Kenyans abroad retain the right to remain Kenyan citizens in spite of accessing a foreign passport

We need to conserve biodiversity in basins highly impacted by humans

new assessment of frames this lost biodiversity-the fisheries has found that freshwater fish under threat, with as many as a third of global populations in danger of extinction. The report by 16 global conservation organisations, called The World's Forgotten Fisheries, says that global populations of freshwater fish are declining rapidly.

Problems include pollution, overfishing and destructive fishing practices, the introduction of invasive species, climate change and the disruption of river ecologies. Most of the world's rivers are now dammed in parts, have water extracted for irrigation or have their natural flows disrupted,

further disrupting freshwater fish. Two recent assessments of the world's freshwater ecosystems catalogue the scope and severity of human impact on these oncebountiful, biodiverse habitats that contain a quarter of the globe's known vertebrate species.

Humanity's ever-expanding footprint has slashed biodiversity in more than half of Earth's freshwater river basins, with only 14 per cent remaining pristine, according to new research published last week in the journal Science.

This most recent assessment. titled: 'The World's Forgotten Fishes', also finds that the biggest fishes-species weighing more than 60 pounds-have undergone a particularly calamitous decline, with their numbers plummeting by 94 percent over the past half

The World's Forgotten Fishes

80 species declared extinct, 16 disappearing in 2020 aloneas not just a tragic draining of our planet's natural beauty and evolutionary grandeur, but levies a heavy human cost. Some 200 million people are fed by protein from freshwater fishes and 60 million people depend on hauling in that essential catch to support themselves and their families.

Perhaps unsurprisingly, the researchers behind the paper in Science observed that the river basins surrounded by heavy human presences were the most severely degraded.

In contrast, the rivers that were mostly spared this fate were primarily in Africa and Australia, he adds, speculating that this is probably due to slower industrialization in Africa and sparse human populations around rivers in Australia. Prior attempts to study the extent of human impact on the world's river ecosystems have focused only on changes in the number of species. But the new effort also incorporates the ecological roles and evolutionary relationships of the freshwater species, he says.

Overfishing and climate change are the most significant and pervasive drivers of the global decline in freshwater biodiversity, but the blockages created by dams and the introduction of nonnative species have also played significant roles.



TATE capture is a type of systemic political corruption in which private interests significantly influence a state's decision-making processes to their own advantage.

The term was first used by the World Bank, around the year 2000, to describe the situation in certain central Asian countries making the transition from Soviet communism. Specifically, it was applied to situations where small corrupt groups used their influence over government officials appropriate government decision-making in order to strengthen their own economic positions; these groups' members would later become known as oligarchs.

The classical definition of state capture refers to the way formal procedures (such as laws and social norms) and government bureaucracy are manipulated by government officials, state-backed companies, private companies and/or private individuals, so as to influence state policies and laws in their favour. private individuals and firms so as to influence state policies and laws in their favour.

State capture seeks to influence the formation of laws, in order to protect and promote influential actors and their interests. In this way it differs from most other forms of corruption which instead seek selective enforcement of already existing laws.

Allegations of state capture have led to protests against the government in Bulgaria in 2013-2014 and in 2020-2021 and Romania in 2017, and have caused an ongoing controversy in South Africa beginning in 2016.

President Cyril Ramaphosa is acutely aware of the need to put a stop to the grand corruption and attendant looting by the racketeers at work in South Africa both in recent years and at present.

And those who are corrupt, who have pursued corrupt ways, will continue to fight and fight to the end because their life revolves around corruption. But we will end it and they will go where they belong."

NationalCouncilofProvinces on 10 June 2021 that "we want to remove the temptation for corruption. We want to remove corruption completely and therefore we want all levels of government to work transparently, to be accountable".

Removing the temptation for corruption involves both deterrence and the application of the law of diminishing returns. Corruption is a calculated and greedy form of crime. Those who calculate that they can get away with it let their greed run riot on the funds of the public. These are invariably funds better spent on combating the pandemic, alleviating poverty, promoting equality and ensuring the enjoyment of the various rights and freedoms guaranteed to all in the Bill of Rights.

The state is obliged respect, protect, promote and fulfil everyone's rights as set out in Chapter Two of the Constitution. Corruption has been characterised as a human rights issue in the Glenister litigation because the loot extracted by the corrupt diminishes the capacity of the state to deliver services to the public in the effective and efficient manner contemplated the Constitution. The judgment in question, penned jointly by Deputy Chief Justice Dikgang Moseneke and Justice Edwin Cameron (both now retired) informs the attitude of the president in making the utterances quoted above:

"There can be no gainsaying that corruption threatens to fell at the knees virtually everything we hold dear and precious in our hard-won constitutional order. It blatantly undermines the democratic ethos, the institutions of democracy, the rule of law and the foundational values of our nascent constitutional project. It fuels maladministration and public fraudulence, and imperils the capacity of the state to fulfil its obligations to respect, protect, promote and fulfil all the rights enshrined in the bill of rights. When corruption and organised crime flourish, sustainable development and economic growth are stunted. And in turn, the stability and security of society is put at risk."

Now that more than half of SAA has effectively been privatised and electricity generation of less than 100MW has also been opened to the private sector, it is time to consider the options of the state in relation to the objectives so clearly spelt out by the president in recent weeks, as quoted above.

It has long been the stance of Accountability Now that the bestpractice way of implementing the

Glenister decisions is to establish a new Chapter 9 Institution to prevent, combat, investigate and prosecute corruption. Whether the mandate of the new body should be all corruption (as desired by the NEC of the ANC), or only grand corruption, is a matter for Parliament to decide in the course of the necessary legislative process which will, as is usual, include public participation.

In the meantime, and as a short-term solution to the racketeering with impunity that is impoverishing the public purse, urgent consideration should be given to the civil recovery of loot, wherever it may be in the world, using the services of the privatesector lawyers who are registered with the Legal Practice Council (LPC) in SA. The expertise needed available, the opportunity for entering into contingency fee agreements approved by the LPC exists and the prospect of recovery of the loot of State Capture is tantalising.

An evidence leader in the Zondo Commission, Matthew Chaskalson SC, has let it be known that there are 17 corporates in the same position as the international management consultants, McKinsey, which has volunteered to disgorge its loot. None of the others has done so yet. With swift civil recovery procedures available worldwide, harnessing of lawyers in private practice to supplement the efforts of the Special Investigating Unit ought to have a back-straightening effect on those who are currently backsliding or taking their time about repaying the loot that they have accumulated during the State Capture activities in which they have been involved.

The big corporates are sitting ducks for a well-briefed and highly motivated team of SA lawyers in private practice who have the necessary expertise in international debt collection that is related to racketeering. The possibility exists of a competitive process in respect of the recovery of the loot of all 17 recalcitrant corporations who are retaining their loot instead of following the precedent set by McKinsey.

It needs to be noted that many firms of attorneys and counsel will be willing to act on a contingency fee basis to restore the country to fiscal health via the civil recovery

This means that a great deal of legal work can be put in hand in a short period of time leading to an inflow of looted funds that will enable the state to make an informed decision about the necessary reform of the criminal justice administration.

The reformed corruptionbusters will be able to take criminal action against those from whom loot has been successfully recovered. The racketeers will be suitably discouraged when the war to recover loot swings into action, as it could within a matter of weeks, if the right political will can be mustered and converted into nimble action against the

It is apparent that the president does have the necessary political will. The resolution of the NEC of the ANC in August 2020 is to the same effect. In that resolution, the national Cabinet is instructed urgently to establish a standalone permanent entity to deal with corruption independently and on a multi-disciplinary basis. The funds raised by roping in the private sector legal firms will stand the new body in good stead.

It is laudable that the NEC has taken the Glenister decisions to heart and has instructed Cabinet to set up a body that complies with the STIRS criteria that the courts have set in binding terms that were never properly honoured during the Zuma era for reasons that become more and more obvious as the evidence presented to the Zondo Commission unfolds.

As far as the looting of SOEs is concerned, it has long been a problem that junior staff tasked with recovering loot are fearful of their lives and apprehensive of their careers should they be identified by the (still powerful) looters and racketeers they are required to sue. The creation of a Special Purpose Vehicle to take cession of the claims to loot is a means of allaying these fears and apprehensions. It could be part of the civil recovery process that is long overdue and readily achievable, if the president is taken at his word.

The inflow of recovered loot can make a real difference to the proper financing of anticorruption efforts in SA. The civil debt recovery processes available internationally are swift and sure. Very often the looters do not even oppose the cases brought against them as they realise their game is up and that deposing to false affidavits to oppose their disgorging of the loot only makes matters worse for them.

The Hawks have plenty of other priority crimes to attend to and the NPA does not have the necessary specialised skills available to it to tackle corruption as extensive and as grand as that which SA now has to counter. Using the recovered loot to set up the new STIRS compliant Chapter 9 Institution has a measure of poetic justice to it.

Prison was horrible but I will still do my work as journalist - Jeffrey Moyo upon prison release

BULAWAYO

TERNATIONAL correspondent Jeffrey Moyo, who was a released from detention today after being arrested for breaching Zimbabwe's Immigration Act by helping two foreign journalists work in the country, says press freedom is undermined when journalists cannot work undeterred.

"I feel relieved as it was so horrible inside for 21 days without my freedom," Moyo told IPS upon his release from Bulawayo Prison today, Jun. 16. "The detention is a complete infringement of press freedom in Zimbabwe.'

Moyo (37), a correspondent for Inter Press Service (IPS), the New York Times and other media, was arrested in Harare on May 26 and detained at Bulawayo Prison. He was released after 21 days when he was granted ZWL5000 bail unopposed by the state, which admitted to erring in finding him a threat to national secu-

In May, Bulawayo Magistrate, Rachel Mkanga denied Moyo bail on the grounds that the journalist was a threat to national security and the county's sovereignty. Moyo has been charged with violating Section 36 of the Immigration Act, based on an allegation that he made a false representation to immigration officials. This pertains to the accreditation of two of his colleagues, Christina Goldbaum and Joao Silva from the New York Times.

Fight for press freedom

The accreditation of journalists should not offend any-

one or any authority in the country, Moyo said, arguing that the accreditation of journalists in Zimbabwe should be a right and not a difficulty.

"Iournalists are not dangerous and do not cause any harm to any particular individual or government," said Moyo, who was welcomed by his wife, Purity, and son outside Bulawayo Prison. "I am scared about what happened but I will not stop my work. ...I am committed to doing my job as journalist no matter what the authorities say to me as long as I tow the line in terms of the law. I will continue to do my job."

Moyo was granted bail on Jun. 14 and was set to be released on Jun. 15 but an error with his release papers at the Bulawayo prison resulted in him spending another night in jail. "I am just happy that he has been released, I am relieved," Purity Moyo, Jeffery's wife, told IPS. She was prevented from seeing her journalist husband in prison and had communicated with him via letters.

"I thank my wife who brought me something to eat every day," Moyo told IPS. "The letters my wife communicated to me gave me hope as did visits from colleagues from the media. I thank God that I am out and united with my family."

Moyo was arrested in May 26 and detained in Central Police Station in Harare. He was later moved to the city of Bulawayo, 400km from Harare, and detained at the Bulawayo Central Police Station under

Moyo was arrested on May 26 on charges relating to the accreditation of his New York Times colleagues.

"I was detained overnight at the Bulawayo Central Police Station under horrible conditions; no bedding, no blankets and I was sleeping on the concrete floor and there was no food at the police station."

"Health wise I am okay but the food in prison is horrible," he said explaining that he was served porridge with no sugar or salt, plain sadza (a type of maize or cassava porridge) and dried vegetables and beans without cooking oil.

Violated rights

Moyo's lawyer Doug Coltart told IPS that his client's detention was a series of appalling violations of his human rights. The state, after three weeks of opposing bail, made a turn around to say it had no case against Moyo and that the grounds it cited for opposing his bail were baseless.

This demonstrates precisely

how the denial of bail at the magistrate's court is being used to punish innocent people, Coltart said. He also noted that in being denied the right to see his wife and relatives as well as his extended detention, despite being granted bail, were all violations of Moyo's rights. "The prison officials continue to refuse to

show us the purported error

in the warrant of liberation and this raises our strong suspicion that it was all a lie and an abuse of the detention process to keep him for an extra night," Coltart told IPS.

Moyo is set to appear in court on Jun. 24 in preparation for trial. If convicted he could face 10 years in jail. Media rights organisations have welcomed Moyo's release. **IPS**

The government should explain plans in wake of Johnson and Johnson vaccine setback

OVID-19 was high on President Cyril da at the just-completed G7 summit in Cornwall in the UK. As it should be. With a third wave of infections sweeping through a number of provinces, the country's vaccination rates are still disturbingly low. Ensuring that more people are vaccinated quicker should arguably be the President's top priority for at least the next six months.

South Africa is currently procuring two safe and highly effective vaccines for its Covid-19 vaccination programme - a two-dose vaccine made by Pfizer/BioN-Tech and a single-dose one from J&J. For now, though, it is only the Pfizer/BioNTech jab that is being administered.

This is not what was planned.

The envisaged scale-up of South Africa's vaccination programme in June was premised on the expectation that we would have at least two million doses of the J&J vaccine ready to go into arms from early June.

Those plans were first delayed while the US Food and Drug Administration investigated the possible contamination of those two million doses - an investigation that arguably took too long.

Those plans were then virtually torn up when it emerged over the weekend that we will not be able to use any of those doses because of possible contamination. The contamination occurred at a factory in the US before the vaccines were shipped to South Africa.

Depressing as these developments are, the public can take some comfort in that over the next two

the fact that regulators are taking potential contamination very seriously and will not allow the use of vaccines Ramaphosa's agen- that are at risk of having been contaminated. As an aside, it is worth stressing that the J&J vaccines used in the Sisonke research trial came from a different factory and were not contami-

Where does this leave

As yet the government has not provided a detailed account of its revised vaccination plans - nor any meaningful details of plans to boost supply in the short term. The most recent planning documents we've seen still assumed a significant supply of the J&J vaccine in early June.

A total of 300,000 J&J vaccines (that are not contaminated) have reportedly been secured for the vaccination of teachers in the coming weeks. While the government has confirmed these plans, it has provided relatively little detail and much of what we know is from circulars sent out to provinces rather than from government statements.

J&J will, of course, continue to supply new batches of vaccine for fill and finish at Aspen Pharmacare's factory in Gqeberha in the Eastern Cape. Ramaphosa said at the weekend that Aspen has already begun work on new batches of the J&J vac-

Aspen then said on Monday it expects to release J&J vaccines manufactured from drug substance that has not been affected by the contamination issues within a week and that they should have further doses ready in July. Aspen CEO Stephen Saad told eNCA



Ramaphosa also said over the weekend that US President Joe Biden has agreed to donate doses of the Pfizer/ BioNTech vaccine to South Africa - in addition to what we are already procuring from Pfizer. There are, however, no details yet on when the doses will arrive and in what quantities.

As it is, it appears the government had hardly any contingency planning. After the AstraZeneca setback,

communicated by a private company and not by the government.

The government should now step up.

The President or the acting health minister should urgently provide the public with a briefing on its updated vaccination plans given the J&J setback. This should include details of when we will be getting a vaccine into the system, as well as which vaccine and how much of it, along with a detailed account of what steps the government is taking to procure this Plan B have so far been additional vaccines faster.

And, of course, we should also be told what our Plan B and C is if any of the new plans don't work out.

If the information provided by Saad is correct, then the acceleration of our vaccination programme is back on - albeit three or so weeks behind the original schedule. That three-week delay is likely to cost lives, as people who might otherwise have been vaccinated fall sick with Covid-19 when South Africa's third wave of infections takes its toll.

We simply cannot afford any more such setbacks.

Activists want govt to reinstate fare system for court witnesses

EARLY last year Tanzania was hit by COVID-19 epidemic, which has affected various economic sectors in Zanzibar, Tanzania and the world

When the disease broke out, the government was forced to close down various social and economic activities to save people's lives from the silent killer disease.

Despite the government allowing some of the activities to take place after the decline of the disease, but still so far there are various side effects

caused by the disease. Among those implications is the lack of fare for witnesses who are re-

quired to testify in different courts, especially in GBV cases. The fare for the case and the criminal case is in accordance with the law of the court where witnesses, who are required to testify in court are

required to be given the money. Magistrate of the Unguja South Region court, Kahmis Ali Simai said according to the rules witnesses who appear in court to testify are required to be paid a fare, but the money has not been paid since the outbreak of

the Coronavirus epidemic early last year. "It is true that according to the rule of law, a witness who is required to appear in court to give evidence in criminal cases should be given a fare

witnesses are not given fare," he said. He said the reason for the not paying them was due to the little amount of money the court was given.

"This was caused by the economic crisis due to COVID-19," he said. Before COVID-19, witnesses were given money for transport from where they lived to the court, which increased the motivation of the witnesses to go to court to give evidence.

He urged witnesses especially in GBV cases not to be discouraged to come to the court to give evidence despite the fact that there is currently no fare for them because the case without evidence, the accused cannot

Sabra Ali, gender officer in Unguja West A District said many cases of abuse are dismissed due to various reasons including the suspect's failure to convict due to lack of evidence.

She said the cases could not be found guilty because the witnesses failed to appear in court due to various reasons including lack of fare to and from the court.

Gender official also cited a culture of secrecy as one of the causes of GBV cases fail to convict the suspects.

According to her, many GBV victims are helpless and do not have the ability to pay fare for witnesses to go to court and the witnesses are forced to pay their own fares and other services to get to court.

Sabra said sometimes witnesses are called more than once to testify in court so when they do not have a fare they fail to arrive, calling on the government to set up a special fund to help the community so that they could go to court to give evidence when needed.

A mother whose child was sodomized (name withheld) said her case is still pending in court and has already submitted witnesses for evidence and the next step is now to be tried.



The woman was required to appear in court to present three witnesses, at which point she had to pay for their transport to the court.

"If I had no fare for my witnesses they would not have been able to come to court to give evidence because they told me they wanted to go and give evidence but they do not have the fare and I had to take money out of my pocket to give them," she said.

She asked the government to make an effort to enable witnesses to get to the court and testify.

Human rights activist from Unguja North Region Hadia Ali Makame said that witnesses in GBV cases need to be given fare to testify against

She urged the government to reinstate the fare system so that those cases proceed smoothly and the justice is obtained and perpetuators are

She said when a witness is summoned to the court and he/she is forced to suspend some of his/her economic activities for the day, so it is advisable for the government to restore the fare system.

She explained that the witnesses are currently paying their own way to get to the court and some of them live far from the court so they are forced to pay the fare to get to the court and that level due to the distance

the witness lives where there are those who pay to pay 3,000 / - for fares. "For a rural resident most of whom are helpless 3,000/- to give it is too big to enable him/her to come to the court to give evidence," she said.

Time Asaa Khamis, from Zanzibar Female Lawyers Association (ZAFE-LA) said it is a good thing for witnesses in the GBV cases to be given money for transport for them to give evidences.

She said that a case without evidence the accused could not be convicted, advising that the witnesses should not be given only their own fare or subsistence allowance for the whole day that he/she is required to appear in court.

She said: "When you call a witness in court you are disturbing his/her economic activities. So, I think it is important to give them subsistence allowances."

Two new bird species identified in Tanzania

ORNITHOLOGISTS and aniidentified and named two new bird species in Tanzania, a laborious task that required the use of museum specimens collected half a century ago.

According to a recent report released in the international journal of avian science Ibis, two previously "undescribed" warblers of the Cisticola genus known to have inhabited central Tanzania since the 1980s have been formally named by a dedicated group of researchers who went so far as to consult museum artifacts from 1961 to make their discovery.

"These putative new species have been illustrated in field guides on African birds, although with no formal name," the journal entry notes. "We use these [museum] specimens to provide formal descriptions of each form and, using DNA sequence data extracted from these specimens, we place them in a broad phylogenetic framework for the genus Cisticola."

A report from the outlet Sci-News explained the Cisticola genus is known for "small insect-eating birds" that have existed since the Old World. German naturalist Jakob Kaup originally recognized the "Cisticolidae" bird family in 1829, and since his ornithology work over 50 species of warblers have been recognized worldwide.

"Cisticola warblers primarily inhabit wetlands, savannah, broadleaved woodlands and upland habitats, almost exclusively in Africa," University of Copenhagen researcher Lars Dinesen and his international colleagues who assisted on the Ibis journal entry told Sci-News in a statement.

"Their identification and



classification have been problematic for both professional and amateur ornithologists because of their cryptic coloration, seasonal variation in plumage and the patchy geographical distributions of many of the currently recognized species."

Indeed, Sci-News noted only two members of the Cisticola genus are found in populations outside of Africa: the Madagascan cisticola and the golden-headed warbler, which is found in Australia and several countries within Asia.

These particular species of warbler, called the Kilombero cisticola and the white-tailed cisticola, inhabit the floodplains in southwestern and central Tanzania, respectively.

"The presence of two undescribed Cisticola warblers in the marshes of the Kilombero floodplain in central Tanzania has been known since the 1980s and these putative new species have been illustrated in field guides on African birds, although with no for-

mal name," Dinesen and his team told Sci-News. "Based on the combined evidence from genetics, morphology and bioacoustics, we conclude that these two cisticolas represent independent species."

Researchers concluded both bird families diverged somewhere between 2.5 and 3.5 million years ago, according to the Ibis report.

"We use our own and public recordings to characterize the vocal repertoire of each of these new species and compare song characteristics with other members of their respective clades," the report said. "Dating of nodes in the molecular phylogeny suggests that both cisticolas endemic to the Kilombero became isolated and diverged from their sister-species between 2.5 and 3.5 million years ago, long after the formation of the Eastern Arc Mountains and the Malawi

Dinesen and research team also used the scientific paper to implore to the larger animal

conservation community to move both species to a critically endangered status, given environmental issues with the floodplain.

"The Kilombero floodplain was once connected with the vast wetland habitats of the ancient Zambian Luangwa drainage system," the team told Sci-News. "However, this connection was broken in the Late Miocene, with the formation of the Malawi Rift."

"We propose that both species should be classified as globally endangered, owing to immense anthropogenic pressures on the floodplain, as documented in several publications and by a recent Ramsar Advisory Mission," the paper noted.

This is not the only scientific bird news in recent weeks. A recently discovered extinct dwarf emu egg was found almost in its entirety, and has offered the global scientific community valuable information into the deceased species.

How the CPC sustains Chinese people's support

OING over the history of the Communist Party of China (CPC), it is an unassailable fact that the Party always has the support of the people.

International polls have indicated over and again that Chinese people's approval ratings of the CPC and the government rank the highest worldwide.

Last year, a report by Harvard University based on its survey in China spanning 13 years shows that the Chinese people's overall satisfaction toward the central government exceeds 93 percent.

So how does the CPC sustain this widespread support over a century?

EVERYTHING IS FOR THE PEOPLE

Xi Jinping, general secretary of the CPC Central Committee, said the Party has won the people's wholehearted support because it has always served the people with heart and soul and strived for the well-being of all ethnic groups.

It is enshrined in the CPC Constitution that the Party has no special interests of its own. "In its own work, the Party shall follow the mass line, seeing that everything is for the people and everything relies on the people."

Passing down generations of Chinese leaders and CPC members, this people-oriented philosophy has been the underlying dynamic for the CPC to lead the Chinese people fighting for national independence and striving for socialist modernization.

Since the start of the reform and opening-up in the late 1970s, more than 770 million people had been lifted out of poverty in continuous poverty relief efforts led by the CPC. In early 2021, Xi declared that China had eliminated absolute poverty.

"The leadership of the CPC clearly has the support of the people of China," said Stephen Perry, chairman of Britain's 48 Group Club, who spoke to friends in China about Wuhan's lockdown. "The basic position of the CPC has been, is, and will continue to be all about the people, hear the people, and get the policies right to meet the needs of the people."

Recalling his meeting with Xi years ago, Perry said, in remote areas and shouldered "I looked into his eyes as he was talking. I could see a man who'd experienced poverty, who'd experienced the life of the peasants of China."

Many Chinese leaders started their careers from the grassroots, going through the difficulties ordinary people face and understanding their needs, which laid a solid foundation for their practical and people-oriented approach in formulating national policies.

"Meat would not grace our tables for months at a time," Xi once said, referring to the days when he was sent to Liangjiahe Village in northwest China's Shaanxi Province as a farmer some five decades ago. "How I wished to treat my fellow villagers to meat at least

From a junior local official to China's top leader, Xi has always held dear the wish he had made. Ensuring the rural poor improve their lot has been his motivation all along.

Many senior officials share similar experiences. They have worked grave tasks. They have proved their capability in promoting regional and national development in various positions.

Laurence J. Brahm, a senior international fellow at the Center for China and Globalization, studied this unique characteristic of the CPC leadership and concluded: "They know the entire structure of the economy and the psychology of people in being able to address their needs and respond accordingly." In just decades, the Party led the country's massive transformation, bringing huge economic and social benefits to the people.

China's per capita disposable income reached 32,189 yuan (about 5,024 U.S. dollars) in 2020, more than double the level in 2010, with 400 million middle-income earners of its total population of over 1.4 billion.

The country has the largest social security system globally, with basic medical insurance covering over 1.3 billion people and basic old-age insurance covering about 1 billion. The average life expectancy of the Chinese has risen to 77.3 years.

British scholar and political commentator Martin Jacques said he believed the reason why the CPC enjoys a lot of support is that it managed to deliver a tremendous transformation for the Chinese people.

RESOLUTELY FIGHTING CORRUPTION

Corruption, a common problem faced by all political parties, is a disease people hate most. And it is precisely what the CPC is determined to address thoroughly. Since 2012, the Party has investigated and punished corrupt officials -- including some high-ranking officials -- on a scale unseen in decades.

Xi said: "We will strike both the 'tigers' (high-ranking corrupt officials) and swat the 'flies' (low-ranking corrupt officials), and advance the system under which officials don't dare to, are unable to, and have no desire to

commit acts of corruption as a whole." Ahmed Bahaa El-Din Shaaban, secretary-general of the Egyptian Socialist Party, believes that a significant factor behind the CPC's success is its ability to keep itself clean through continuous anti-corruption campaigns.

Moreover, the Party has combined internal supervision with state and public scrutiny, coordinating it with legal, democratic, auditing, and judicial supervision and also scrutiny by public opinion. Together, they create a powerful synergy for conducting oversight. The resolute fight against corruption has resulted in surging public support. According to a survey conducted by the National Bureau of Statistics, 97.3 percent of the respondents expressed satisfaction with the improvement of Party conduct, the working practices of government officials, and social morality.

"History has provided ample proof that the state is the people, and the people are the state," Xi said. "With the people's trust and support, the Party can overcome all hardships and remain invincible.'

Tira director touts 50pc insurance penetration by 2034 while singling out CRDB Bank

LANS by the government to ensure that by 2034 at least 50 percent of Tanzanians have some form of insurance cover, can only be realised if financial institutions such as CRDB Bank Plc play a key role.

Central bank digital currencies a useful tool for emerging markets, but with risks

EMERGING market countries have been frontrunners in the adoption of digital currency projects, which could boost financial inclusion, according to a new report.

However, countries adopting digital currencies face risks, such as increasing digital dollarisation as they gain access to other countries and a potential rise in local inflation rates, according to BofA Securities.

"Central banks representing a fifth of the world's population are likely to issue a general purpose CBDC in the next three years, according to the latest Bank of International Settlements survey. Eighty-six per cent of global central banks are exploring the benefits and drawbacks of CBDCs. About 60 per cent are conducting experiments or proof-of-concept," the bank said in a research note.

"The most advanced central bank digital currency projects are currently run in China, [South] Korea, Singapore, South Africa, Thailand and the UAE." CBDCs are digital forms of national currencies such as the dollar, the euro or the dirham, backed by a country's central bank.

A growing number of nations are trialling CBDCs and central bankers and finance ministers from the Group of Seven nations last week pledged to work together to understand "their wider public policy implications." "Our objective is to ensure that CBDCs are grounded in long-standing public sector commitments to transparency, the rule of law and sound economic governance," the policymakers said in a joint communique.

The UAE has already completed Project Aber, a CBDC proof-of-concept trial with Saudi Arabia last year, which confirmed blockchain technology could be used to "reimagine both domestic and cross-border payment systems in new ways."

In February, the UAE Central Bank also joined a multi-nation project with the Bank of Thailand, the Hong Kong Monetary Authority and the Digital Currency Institute of the People's Bank of China to examine the business use cases for using blockchain for real-time, cross-border payments in both domestic and foreign currencies.

CBK, World Bank start bonds market reforms

NAIROBI

THE Central Bank of Kenya (CBK) has embarked on reforms aimed at cutting dominance of large commercial banks in government securities, lower cost of borrowing and boost cash flow for investors who exit.

This is part of the conditions in a deal between Kenya and the World Bank Group for disbursement of \$750 million (Sh81 billion) under the Development Policy Operations (DPO) expected by end of the month.

The CBK in January published updated auction rules for Treasury bonds and bills as part of the reforms to reduce domestic debt costs and risks by promoting transparency and market confidence, thus "preserving the integrity of the auction process."

The bank backs the refreshed rules, which give more clarity on operation of government debt auctions, to "potentially helping to enlarge participation and improve auction bidding behaviour, which is currently dominated by large commercial banks."

The share of banks in domestic debt has reduced slightly this year in what analysts have partly attributed to issuance of long-dated bonds by the CBK, and accounted for 51.4 percent of the Sh3.67 trillion portfolio as at June 4 compared with 53.29 percent at the end of December.

"In the secondary market, the CBK is seeking to implement a benchmark bond programme to strengthen secondary market liquidity and reduce domestic debt costs, whilst also supporting broader domestic bond market de-

velopment," World Bank analysts said

The programme will see the CBK

-Treasury's agent in debt markets

- restructure Kenya's debt maturity profile by prioritising benchmark bonds which will set standards for the performance of other bonds.

The World Bank said the CBK has committed to develop a bond reopening calendar, identify candidate bonds and provide justification for the choice and adopt a benchmark bond size limit.

It also pledged to reduce refinancing risk and increase concentration in the benchmark issues by coming up with a refinancing programme through strategies such as buying back the bonds when interest rates are lower and also asking investors to invest in other bonds rather than redeem their cash.

PwC to add 100k jobs in \$12bn strategic revamp with South African unit adding 2 500

PRICEWATERHOUSECOOPERS is investing \$12 billion across its global business in an overhaul targeting better audits, digitisation of services and greener operations.

The professional-services provider will hire 100 000 employees and develop the skills of existing staff over the next five years as it seeks to respond to the post-pandemic operating environment, it said in an emailed statement on Tuesday.

"We will continue to evolve our ways of working, and expand our capabilities in the areas that matter most for the future, while remaining steadfast in our commitment to quality," PwC Chairman Bob Moritz said. "We want our people to be the most sought after in the market."

Auditors are grappling with managing quality amid a shift in ways of working introduced by the Covid-19 pandemic. The International Auditing and Assurance Standards Board has revised standards for auditors, coming into effect in 2022, to boost technology use, help manage new risks, and improve quality management.

PwC is also seeking ways to address growing calls for trans-

stakeholders after several accounting scandals among the Big Four auditing firms knocked public trust. In South Africa, for example, KPMG has put in place a variety of reforms after it came under fire in 2017 for work done for a politically connected family accused of plundering the government's coffers.

The South African unit of PwC will add at least 2 500 new employees over the next five years, chief executive officer in the region Dion Shango told reporters in parency in the profession from a conference call. Across Africa, where it

has a presence in 34 countries, the firm plans to bulk up its operations with a \$400 million investment.

The company is also interviewing for non-executive directors to strengthen audit oversight.

PwC has also set aside \$3 billion of its total global investment to help double the scale of its Asia-Pacific operations, it said. The firm's spending will also focus on responding to environmental, social and governance trends across its opera-

Acwa Power raises \$746m through sukuk issuance to fund growth

RIYADH

THE issuance was the first the company has completed in the Saudi Arabian market and benefited from "significant interest from fund managers, government funds and insurance companies", the company said in a statement on Monday evening. The offer was 1.8-times oversubscribed.

"The success of the issuance is proof of the wider market's faith in KSA's bond market and Acwa Power's strong credit fundamentals, which have attracted a diverse pool of sophisticated investors," Paddy Padmanathan, president and chief executive of Acwa Power, said. "The issuance is also a vote of confidence from investors in our ability to capture large opportunities in Saudi Arabia and other growth markets."

Companies in the Gulf have been taking advantage of low rates to raise debt as the region emerges from an economic downturn caused by the Covid-19 pandemic and last year's oil price plunge. Emerging markets specialist Franklin Templeton said this week it expects debt market issuance in the Gulf this year to be in line with last year's total of \$250bn, but for a greater proportion of this to be issued by the corporate sector.

Acwa Power operates in 13 countries in the Middle East, Africa and South-East Asia. It has a portfolio of 64 assets with a total investment of \$66bn, producing 42 gigawatts of power and 6.4 million cubic metres per day of desalinated water. The transaction is also Acwa Power's first since Saudi's sovereign wealth fund, the Public Investment Fund, became a 50 per cent shareholder in the company last year.

The sukuk issuance "marks a new phase in diversifying our company's funding sources to cater for future growth, reinforcing our strong track record in delivering power and desalinated water ... to communities in the kingdom and around the world", Kashif Rana, chief financial officer at Acwa Power, said. HSBC Saudi Arabia and Samba Capital acted as joint lead managers and bookrunners for the sukuk, while Norton Rose Fulbright provided

Earlier this year, Acwa Power secured financing for a \$1bn power project it is developing in Uzbekistan as part of its strategy to boost its renewable energy portfolio in the Central Asian republic. The company also signed an agreement with Dubai-based Neutral Fuels to supply net-zero biofuel - a clean form of fuel that lowers emissions - to power the kingdom's Red Sea tourism project on the coast.

Money talks, money walks, change the attitude

WE are currently in mid-June and yes it was just yesterday when we celebrated the New Year. The coronavirus global pandemic has changed a lot in the way we earn, spend and save money. Our income streams have been adversely affected by this pandemic. Some of our colleagues have lost their jobs and businesses. Amidst all these challenges, there is one thing that we have learnt and that is change is inevitable and planning is a necessity.

Budgeting is a process of planning how to spend earned income on expenditures. Income can be considered as incoming money as a result of various business activities including sale of products and services. While expenditure is the outgoing money as a result of paying expenses, bills and related aspects over a specific period. Now comes the next question. How do we budget? Or rather, do we budget right?

Step 1: Set your goals; your

budgeting journey starts with setting a financial goal. Your financial goal could be purchasing a piece of land by December, 2021 or starting a business in three months. You need to set both a short- and long-term financial goal.

Step 2: Make a plan; once you set a SMART financial goal, you need a plan. Your plan is a roadmap that will enable you to achieve your financial goals. The act of planning how much of your earned income will be spent and saved is budgeting. There is a famous saying that indicates 'if you fail to plan, you plan to fail'.

This saying is applicable to budgeting. If you don't plan how to spend your earned money eventually you will lose it. Money talks and mostly it says goodbye. Imagine if you have 20,000/- at 9:00am and you begin to buy various unplanned items, before you realise it you will have run out of cash and not be able to account for your expenditure.

Step 3: Know your net in-



come; the first step in creating a budget is to identify the amount of in-coming money after all statutory deductions and taxes. For example, if you are employed, your net income is the amount of money that is credited to your account after tax deductions. If you are an entrepreneur, the net income is money earned after various deductions.

Step 4: Track your expenditure; once you know your income streams, you need to identify and track your expenditure. You need to document your expenses in either an application or notebook. If you track for three consecutive months, you should be able to identify an expenditure pattern. This pattern will help you to improve your budgeting as you will have accurate estimates of your anticipated expenditures.

Step 5: Save to attain your financial goal; you know your income and expenses. Now you need to save some of your earned income. Your savings is a result of deducting expenses from your income. You need to save for a purpose which could either be emergency funds, vacation or investment. Remember those financial goals that you initially set? Your accumulated savings will enable you to draw closer to these goals.

Step 6: Keep checking in; you need to create a habit of constantly reviewing your budget. It is important to constantly check your budget so that you can explore opportunities for lowering your expenses and increasing your income and savings.

The Jobo effect; banks perspective of accounting for climate risk

OVER a month ago, Tanzania braced for the much-spoken cyclone Jobo which was expected to make landfall along the coastal zone. Among others, the cyclone was expected to bring heavier than usual rainfall and flooding.

You can imagine the effects that could arise should Jobo have succeeded! As food for thought, who would have suffered most from Jobo? Any ideas of the Joborelated losses that could have occurred from a banking sector outlook? Most literatures and studies have seemed to

embark on the impact of climate change on the economy, and how countries and regions are impacted by related loss events, with a little focus on the impact of such events on banks.

Notwithstanding, and mostly in the current arena of heightened climate change, it is important for banks to incorporate climate related risks to their traditional financial risks. The available bank-related studies have sought to analyse how climate risk drivers give rise to financial risks, and this is what banks in Tanzania should aim at.

In that light, the Basel Committee

on Banking Supervision, in April 2021. issued two analytical reports on climate related risk drivers and their transmission channels as well as climate related financial risks - measuring methodology.

The former report highlights the effects of climate-related financial risks and how they can translate into bank's financial risks by expounding some key components. For starters, banks need to consider "climate risk drivers." Climate risk drivers represent all sorts of climaterelated changes that could give rise to financial risks i.e. the traditional market, credit, operational, reputational, liquidity

and even currency risks.

Climate risk drivers could be physical risks arising from the changes in weather and climate that impact economies or they could be transition risks arising from transitioning an economy that is reliant on fossil fuels to a low-carbon economy. For the case of Tanzania, such physical risks could result into damage to properties, infrastructure and agriculture which could potentially generate financial losses to the banking sector.

From a credit risk perspective, much higher impairments would be expected for customer in specific geographical locations or sectors that may be directly impacted by such physical risks which may reduce the borrower's ability to repay or hinder the bank to fully recover the asset in the event of a default. This remains an area of management judgment to ascertain and assess the magnitude and timing of the climate risk drivers on their business.

On top of that, "transmission channels" is also a key component to consider. As explained by the Basel Committee, transmission channels could either be micro or macro-economic transmissions. Microeconomic transmission channels could impact the bank's credit risk through its counterparties; market risk could be heightened due to diminishing value of financial assets whereby calamities could trigger prices reduction and increase market volatility in traded asses.

At times, liquidity risk could increase as banks' access to funding is reduced due to changes in market conditions. Climate risk drivers may also cause banks' counterparties to draw down deposits and credit lines. There could also be an increase in reputational risk due to changing market or consumer sentiments resulting from climate risk. Generally, transition risk drivers are likely to affect the income of banks' counterparties, which, in aggregate, could have massive macroeconomic effects.

Again, it is important for banks to understand that the impact of climate risk drivers can be affected by the geographical heterogeneity of their portfolios, amplifiers such as interactions and interdependencies between transmission channels as well as mitigants that reduce or offset impacts through both reactive and proactive actions.

Having navigated through the risks, banks are now called upon to establish and/or incorporate into their current structures, methodologies to adequately measure climate risk and properly account for it while also dealing with the related challenges such as data gaps and the uncertainties of predicting climate change. It's time to gather pace!

US Justice Dept rebuffed Donald Trump bid to overturn election

WASHINGTON

FORMER President Donald Trump pressed the Justice Department during his waning weeks in office to join his failed effort to overturn his election defeat based on his false claims of voting fraud, but its leaders refused, with one decrying the "pure insanity" of the claims, documents released on Tuesday showed.

The records, obtained by the House of Representatives Oversight and Reform Committee, provided new insight into the actions of the Republican former president in trying to enlist the department to act on his claims. The documents showed a series of overtures made by Trump, then-White House Chief of Staff Mark Meadows and an outside private attorney, Kurt Olsen.

The department ultimately did not join the effort and numerous courts rejected lawsuits seeking to overturn election results in various states.

Conress also is investigating the deadly Jan 6 assault on the US Capitol by a mob of Trump supporters trying to stop the formal certification of Democratic President Joe Biden's election victory.

"These documents show that President Trump tried to corrupt our nation's chief law enforcement agency in a brazen at-

tempt to overturn an election that he lost," said Committee Chairwoman Carolyn Maloney, a Democrat.

These actions were separate from the revelations that the Trump-era Justice Department secretly sought the phone records of at least two Democratic lawmakers, a move that led Biden's Attorney General Merrick Garland on Monday to vow to strengthen policies aiming to protect the department from political influence. The department under outgoing Attorney General William Barr, who left his post on Dec 23, and his short-term replacement Jeffrey Rosen decided not to act on the false claims of voting fraud. Biden took office on Jan 20.

The emails showed that Meadows asked Justice Department officials to investigate an unfounded conspiracy theory called "Italygate" alleging that US electoral data was changed in Italian facilities with the knowledge of the CIA.

On Jan 1, Meadows sent Rosen a link to a YouTube video detailing the theory. Rosen forwarded the email to then-acting Deputy Attorney General Richard Donoghue, who replied: "Pure insanity."

The documents also showed that Trump pressured Rosen when he was deputy attorney general to have the department take up the election fraud

claims.

'Flatly refused'

The emails showed Rosen declined to arrange a meeting between Justice Department officials and Trump's personal lawyer Rudy Giuliani about his false claims that the November election was stolen. Meadows had asked Rosen to help arrange the proposed meeting with Giuliani, the emails showed.

"I flatly refused, said I would not be giving any special treatment to Giuliani or any of his 'witnesses,' and re-affirmed yet again that I will not talk to Giuliani about any of this," Rosen wrote to a Justice Department colleague on Jan 1.

Giuliani had played a prominent role in promoting Trump's false election claims.

Trump, through an assistant, sent Rosen a Dec 14 email with documents purporting to show evidence of election fraud in northern Michigan - a debunked allegation that a federal judge had already rejected.

Two weeks later, on Dec 29, Trump's White House assistant emailed Rosen, who by then was the acting attorney general, and other Justice Department lawyers a draft legal brief that they were urged to file at the US Supreme Court.

The department never filed the brief. leaders.

Emails released by the House committee showed that Olsen, a Maryland lawyer involved in writing Trump's draft brief, repeatedly tried to meet with Rosen but was unsuccessful. The draft brief backed by Trump argued that changes made by the states of Georgia, Michigan, Wisconsin, Arizona, Nevada and Pennsylvania to voting procedures amid the COVID-19 pandemic to expand mail-in voting were unlawful. Biden won all those states.

Similar arguments were made in a lawsuit filed by Ken Paxton, the Republican attorney general of Texas and a Trump ally. The US Supreme Court rejected that long-shot lawsuit in December.

Representatives for Trump did not immediately respond to a request for comment.

The document release came ahead of a House Oversight Committee hearing on the Jan. 6 attack, which will include testimony from FBI director Christopher Wray and General Charles Flynn, a high-ranking Pentagon official involved in a key mid-riot phone call with police

Sputnik V is more effective against Indian strain of COVID than other vaccines - RDIF

MOSCOW

THE Sputnik V vaccine is more effective against the Indian strain of the coronavirus than any other vaccine that published results on that strain, the Russian Direct Investment Fund said in a statement on the vaccine's Twitter ac-

"Sputnik V is more efficient against the Delta variant of coronavirus, first detected in India, than any other vaccine that published results on this strain so far - the Gamaleya Center study submitted for publication in an international peer-reviewed journal," according to the statement.

In late April, Alexander Gintsburg, head of the Gamaleya National Research Center for Epidemiology and Microbiology, which developed the vaccine, said that Sputnik V produces enough antibodies to battle the Indian strain of the coronavirus.

Russia was the world's first to register an anti-coronavirus vaccine on August 11, 2020. It also applied for registration of this drug in the EU, as well as with the World Health Or-

The Sputnik V is now registered in about 60 countries with a total population of more than 1.5 billion people. More than 30 countries have begun mass vaccination with Sput-

In early February, The Lancet, a world-acclaimed medical journal, published the results of the third phase of Sputnik V's clinical tests. The jab has proved to be among the world's safest and most efficient. Thus, its efficacy is estimated at

DPRK's Kim says food situation 'tense' due to typhoons

PYONGYANG

KIM Jong-un, the top leader of the Democratic People's Republic of Korea (DPRK), presided over a party plenary meeting Tuesday to review the execution of major state policies for the first half of this year under current international situation, the official Korean Central News Agency reported Wednesday. Kim, General Secretary of the Workers' Party of Korea (WPK), said at the third Plenary Meeting of the 8th Central Committee of WPK that he highly appreciated the positive achievements by the party and the state work over the past six months.

He said that the country's economy has shown improvement as a whole by implementing its first half-year plan, as its total industrial output and the amount of goods increased largely from a year ago.

The food situation is getting tense as the agricultural sector failed to fulfill its grain production plan due to the damage by typhoon last year, he said, urging the plenary meeting to take a positive measure for settling the food shortage problem.

Israel-Gaza violence erupts for 1st time since last month's fighting

ISRAEL mounted air strikes in the Gaza Strip yesterday, the first since the end of 11 days of cross-border fighting last month, in response to incendiary balloons launched from the Palestinian territory.

The flare-up, a first test for Israel's new government, followed a march in East Jerusalem on Tuesday by Jewish nationalists that had drawn threats of action by Hamas, the ruling militant group in Gaza.

The Israeli military said its aircraft attacked Hamas armed compounds in Gaza City and the southern town of Khan Younis and was "ready for all scenarios, including renewed fighting in the face of continued terrorist acts emanating from Gaza".

The strikes, the military said, came in response to the launching of the balloons, which the Israeli fire brigade reported caused 20 blazes in open fields in communities near the Gaza border.

A Hamas spokesman, confirming the Israeli attacks, said Palestinians would continue to pursue their "brave resistance and defend their rights and sacred sites" in Jerusa-

Hours earlier, thousands of flag-waving Israelis congregated around the Damascus Gate of Jerusalem's Old City before heading to Judaism's holy Western Wall, drawing Palestinian anger and condemnation.

Israel, which occupied East Jerusalem in a 1967 war and later annexed it in a move that has not won international recognition, regards the entire city as its capital. Palestinians want East Jerusalem to be the capital of a future state

that would include the West Bank and Gaza. Prior to Tuesday's march, Israel beefed up its deployment of the Iron Dome anti-missile system in anticipation of possible rocket attacks from Gaza.

But as the marchers began to disperse after nightfall in Jerusalem, there was no sign of rocket fire from the en-

The procession was originally scheduled for May 10 as part of "Jerusalem Day" festivities that celebrate Israel's capture of East Jerusalem.

Russia, China negotiate with many partners on lunar station project'

RUSSIA and China are negotiating participation in the international scientific lunar station project with many partners, Roscosmos Director General Dmitry Rogozin told reporters during the Global Space Exploration Conference-2021 (GLEX-2021).

"We are actively negotiating with many participants. This is what we are doing, along with the Chinese colleagues," Rogozin said.

In his words, the European Space Agency (ESA) is the largest partner engaged in these talks.

On March 9, Russia's State Space Corporation Roscosmos and the China National Space Administration (CNSA) announced that they had signed a memorandum of mutual understanding on behalf of their governments on cooperation in creating an international scientific lunar station (ISLS). The signing ceremony was held via a video conference.

Russia and China are planning to use their joint experience and scientific technologies to create a roadmap for building a station on the Moon.

Bilateral cooperation in this sphere envisages both studying the lunar surface and implementing joint projects in the orbit of the Earth's natural satellite.

Biden and Putin look for detente in summit after rising tensions

JOE Biden and Vladimir Putin kicked off what could be more than four hours of meetings yesterday afternoon in Geneva, with officials from both countries keeping expectations low for any breakthrough agree-

The meeting with Putin, the first of Biden's presidency, is intended for the two leaders to set expectations in what's become an adversarial relationship, and to take each other's measure.

They'll look to reach agreement on starting a new round of arms-control talks and perhaps on steps toward restoring diplomatic channels severed as relations plunged over the last several years.

The two men last met in 2011, when Biden was vice president and Putin had not yet cemented his grip on power in Russia. Since then, the US has imposed round after round of sanctions in retaliation for acts including Russia's annexation of Crimea, interference in US elections, cyberattacks and the killings of opposition leaders and journalists.

Putin has been undeterred, remaining an obstacle to US foreign policy in eastern Europe, the Middle East and elsewhere.

"I'm not looking for conflict with Russia," Biden said at a news conference following a NATO summit on Monday. But he said he'll convey to Putin that the US will respond "if Russia continues these harmful activities. And we will not fail to defend the transatlantic alliance or stand up for democratic values.

Putin and Biden will first meet accompanied only by their top diplomats, Sergei Lavrov and Antony Blinken. A larger meeting with more staff will follow.

They are expected to discuss a renewal of the New START nuclear arms pact that is set to expire in 2026, according to White House officials who briefed reporters traveling with Biden on Tuesday.

The US president believes human rights and Putin's crack down on jailed opposition leader Alexey Navalny's political movement are on the table for talks, though Putin has said they are internal issues.

The two leaders aren't planning to share a meal. Ahead of the meeting, Biden dined Tuesday evening in Geneva with Blinken and National Security Advisor Jake Sullivan.

"I'm looking at this meeting with practical, but not much, optimism," Putin foreign policy aide Yuri Ushakov told reporters this week. "This is the first meeting under such strained conditions that have developed in bilateral relations, and I think that both sides understand they need to clean up the rubble."

They plan to hold separate news conferences after the summit rather than appearing on stage together, as Putin and former President Donald Trump did in Helsinki in 2018 -- a strong indication of how little expectation there is for any kind of breakthrough in the relationship.

Trump's joint news conference with Putin in 2018 led to a US embarrassment after he said he accepted the Russian leader's word that he hadn't interfered in the 2016 election, dismissing the conclusion of US intelligence agencies. US politicians in both parties excoriated Trump for the incident, which was seen as a major victory for Putin.

Biden has fended off criticism that he's rewarding Putin by proposing a meeting so early in his presidency, with aides arguing the relationship is best managed face-to-face due to the Russian leader's singular authority in his country.

Nonetheless, the summit also represents a win for Putin, as it shows that however grudgingly, the Kremlin remains a priority for the new US president.

The summit with Putin was purposefully scheduled to follow Biden's meetings with Group of Seven nations in the UK as well as NATO and EU leaders in Brussels, where the US president said he consulted allies on his agenda for the Russian leader.

All of them, Biden said, thanked him for planning the Geneva meeting.

Ghanaian innovator contributes to affordable houses through recycled plastic waste

AS a teenager, Nelson Boateng, a resident of Ashaiman near Ghana's capital Accra, needed to earn some income to support his education as well as aid his underprivileged parents to cater for his siblings in school.

Boateng, therefore, found a job with Zenith Plastics, a Chinese plastic recycling company in Tema, Ghana's eastern port city, and was attached to the recycling department where he learned to operate, repair, and build extruders.

"These Chinese managers saw my potentials, even though I was still young, anytime they went out to repair broken machines, they made me carry the tools, be with them as they repaired, and they taught me how to fix and build extruders and other equipment," he told Xinhua.

After working with the Chinese firm for 18 years, Boateng established Nelplast Eco Ghana Ltd, a plastic recycling plant at Katamanso, a community near the Ghanaian capital in 2019.

With the skills and experience acquired over the years from the Chinese company, he builds extruders that his company uses to produce sand and plastic-based paving blocks and interlocking bricks for housing.

"We crush, wash and semi-dry the plastic waste and mix it with sand at the proportion of 70 percent of sand and 30 percent of plastic, and feed them into an extruder to make pastes, then feed the paste into molds to produce paving blocks or interlocking bricks under hydraulic pressure," he said in an interview at his company's plastic waste recycling site.

Boateng said what motivated him to venture into plastic waste recycling was his passion to help Ghana to solve its plastic waste problems by using plastic waste as a solution to the shortage of housing units, schools under trees, and unemployment in the country.

According to official data, Ghana generates over one million tons of plastic waste annually, but only five percent is recycled, making landfill sites continually choked and the streets besieged by plastic waste.

"So, we are turning this plastic waste into building materials that the ordinary Ghanaians can afford. We also want to use recycled plastic waste to build homes for those who cannot afford the expensive houses," he told

"Using this kind of bricks for affordable housing has great potentials to help Ghana to bridge its housing deficit and at the same time rid the towns and cities of the menace of plastic waste and create more jobs," he said.

"This is our prototype plastic house built this year from 13,400 kilos of plastic waste, retrieved from our gutters and beaches. With 11,000 U.S. dollars you can afford a one-bedroom house like this, which is more durable but more affordable than building with cement blocks,"

he added.

The base and the columns of the onebedroom apartment are made of the normal mortar concreting. But the walls are built with dark-brown bricks made from sand with plastic waste acting as the binding material.

The bricks are interlocked horizontally and vertically by the plugs and sockets designed at their edges, eliminating the use of mortar as the binding material in erect-

The compound is also tiled with colorful pavement blocks made from sand and plastic waste.

Looking at the increasing cost of cement and other building materials in Ghana and a housing deficit of two million housing units, having affordable houses becomes a mere dream, but the innovator said plastic waste becomes the

sure way of making affordable housing a dream come true for the underprivileged and low-income earners.

Compared to brick and mortar build-

ings, Boateng suggested that houses built

with the sand-plastic interlocking bricks

had a great advantage, as "these bricks

will never crack, and dampness is avoid-"When there is an earthquake or shakes and cracks on the earth, these bricks can expand, and contract when the earth be-

comes stable, unlike concrete blocks that either crack or collapse," he added. In addition to the cost-efficiency, Boateng said the sand-plastic brick houses are also energy-efficient as the rooms cool naturally due to the hollows in the bricks to prevent heat transfer from out-

side into the rooms, reducing the cost of

power consumption.

Nelplast currently employs 64 persons directly and 300 indirectly, 98 percent of whom are females who collect 20,000 kilos of plastic waste daily, "but the company can only recycle 3,000 kilos of the plastic waste collected in a day, leaving 17,000 kilos unused, so we need support to scale up production."

Besides the need for collaboration from both the state and private sector to scale up the production, Boateng also underscored the need for some subsidy in electricity charges which constitute about 70 percent of the company's

China plans to bring back samples from Mars around 2030

CHINA plans to launch a mission munication over a distance of around 2030 to bring back samples from Mars, according to a press conference held by the China National Space Administration (CNSA) on June 12 in Beijing following the complete success of China's first Mars exploration mission of orbiting, landing, and roving the red planet in one mission by Tianwen-1.

Besides, the country intends to launch a mission around 2025 to send a probe to fly around, land on, collect and return samples from a near-Earth asteroid and then orbit a main-belt comet for exploration. A Jovian system exploration mission and interplanetary exploration mission will also be launched in the near future, said officials from the CNSA.

The success of Tianwen-1 represents a symbolic achievement in the independent innovation and leapfrog development of China's space exploration cause, and marks six firsts in the history of the country's aerospace industry, said Xu Hongliang, spokesperson of the CNSA, at the press conference.

According to Xu, the Tianwen-1 probe symbolizes the first time China sent a probe into an Earth-Mars transfer orbit, the country's first interplanetary flight, the first time China's probe realized soft landing on a planet other than Earth, the first time China had a probe rove on the surface of an extraterrestrial planet for exploration, the first time China realized data measurement and control as well as com400 million kilometers, and the first time China obtained firsthand scientific data from Mars.

Tianwen-1 not only left China's footprints on Mars for the first time, but completed orbiting, landing and roving on the red planet in one mission, which fully demonstrated the wisdom of Chinese aerospace engineers and indicated that the country has come to the forefront of the world in planetary exploration,

Featuring a high starting point, great difficulty, and a multitude of challenges, China's first Mars exploration mission has faced many problems since the demonstration stage, such as new environment, long distance, long time delay and a huge number of links in the mission, Xu noted.

The probe's descent from its parking orbit to the surface of Mars is the link with the highest risk in the Tianwen-1 mission, said Sun Zezhou, chief designer of the Tianwen-1 probe, who explained that during the link, the spacecraft not only had to deal with the unfamiliar and capricious atmospheric environment of the red planet, but needed to complete a dozen of key operations independently.

The CNSA also unveiled key plans of China's aerospace industry during the country's 14th FiveYear Plan period (2021-2025) and the next years at the press confer-

According to decisions and arrangements made for building China's strength in aerospace, the country will advance comprehensive development of space technology, space science, and space application, in a bid to mainly enhance aerospace science and technology's role in driving innovation and supporting economic and social development, and actively carry out more extensive international exchanges and cooperation, said the CNSA.

China's planetary exploration missions will adhere to the basic principle of overall planning, step-by-step implementation, and continuous development, and give overall consideration to the development of engineering technologies and needs of research on hot-spot scientific problems, said Zhang Rongqiao, chief designer of China's first Mars exploration mission.

The country will, with Mars exploration as the focus and main line, push forward with its planetary exploration missions along the path designed to realize orbiting, landing, and roving in step one, and complete collection and return of samples in step two by 2030, Zhang added.

Sydney records first local virus case in more than a month

AUSTRALIA'S most populous city Sydney has recorded its first locally acquired case of COVID-19 in more than a month, stoking concerns of a fresh wave of infections yes-

New South Wales (NSW) state said it is not clear how the unnamed man in his 60s acquired the virus, but he was a driver who occasionally transported overseas airline

While authorities urgently try and determine the source of the infection, NSW warned the unnamed man went to the cinema and more than a dozen cafes and shops in Sydnev's eastern suburbs, which include Bondi Beach, while potentially infectious.

Australia's second largest city will allow its five millions residents to travel more than 25 kms from home and end mandatory masks wearing outdoors from Friday, despite the city fighting a stubborn COVID-19 outbreak. Melbourne exited a two-week hard lockdown late last week, its fourth since the pandemic began, after an outbreak that has seen about 100 cases since May 24.

"Victoria is at its best when we are all together ... the state will come back together from tomorrow night", Victoria state Acting Premier James Merlino told reporters

Although cases linked to a fresh cluster in a residential townhouse complex rose slightly on Wednesday, Melbourne will gradually ease restrictions.

Public gatherings will increased to 20 people while the ban on home gatherings will be lifted. Gyms can open across Melbourne but must comply to strict distancing rules and salon services can operate without masks dur-

Victoria reported five new local cases on Wednesday, all linked to the townhouse cluster, taking total infections there to eight. Wednesday's data includes two cases announced on Tuesday which were recorded after the midnight cut-off deadline.

Fiji reported the fifth death from COVID-19 while the Ministry of Health Wednesday pleaded with the public to adhere to the protocols as the country moves into day 59 of the second COVID-19 wave.

The deceased was a 73-year-old patient who tested positive 12 days ago after he was admitted at the Colonial War Memorial Hospital in Suva, capital of Fiji, for almost a month for a severe non-COVID related illness.

A total of 116 new COVID-19 cases with one death were recorded in the last 24 hours. Of the 116 new cases, 93 are connected to existing clusters.

India's COVID-19 tally rose to 29,633,105 on Wednesday, with as many as 62,224 new cases recorded in the past 24 hours, said the health ministry. Besides, 2,542 COVID-19 patients died since Tuesday morning, taking the death toll to 379,573. This was the ninth consecutive day when less than 100,000 cases were registered across the country, after peaking to over 400,000 for several days in April-May which is the pandemic's second wave in India.

Yanga's complicated goalkeeper situation

WE are about to enter an important offseason leading into a crucial 2021/22 season, there are plenty of areas to address for Yanga.

Whether it is contract extensions, freeagent targets, or statement purchases, the Yanga front office has a lot of things on its tray.

Big decisions are coming for the Green and Yellow. One area that is going to be bolstered is the goalkeeping department as we head to the pre-season.

In football, most clubs follow a formula with their three goalkeepers.

There will be the first choice, then usually an older but very capable backup, and then there will either be a much older player or a youth player.

However, for Yanga, this formula has remained more or less broken in the past

They have three goalkeepers, Metacha Mnata, Faroukh Shikalo, and Ramadhan Kabwili.

Neither Mnata nor Shikalo can claim to be the outright number one amid a strange rotation policy.

In two years, Shikalo has made 31 appearances for Yanga, including nine this season while his rival has 48 games under his belt.

Youngster Kabwili has not played a match this season and that is unlikely to change.

The season is almost at an end and the Yanga goalkeeping situation remains unresolved.

Perhaps one of the more confusing elements of Yanga's next season plans is what they choose to do with the goalkeepers.

Both Metacha Mnata and Farouk Shikalo are out of contract at the end of this campaign.

Like the team in general, both have not enjoyed the best 2020/21 season and there are lingering doubts over their future at the club.

Yanga will have one of two options on the table. They can retain both goalkeepers, a highly unlikely situation.

The other option is to buy a new goalkeeper who can challenge Mnata more directly as Shikalo is allowed to go as a

ee agent

Each goalkeeper has a status and a salary that demands they are recognized as number one.

Mnata is a national team player for Tanzania while Shikalo feels he did not cross the border from Kenya to come and be a cover-up for a local player.

Common sense suggested that Mnata would be the best bet to be given a new deal, given he is a local player and has made more appearances than Shikalo.

The expectation was for Shikalo to be the first choice when both were signed in the 2019/20 season but many fans remain unconvinced by the Kenyan goalkeeper and have seen Mnata perform at levels that have him considered by some as the best at the club.

For now, the chances of Mnata leaving are slim, so Shikalo will have to look elsewhere.

It is easy to imagine Yanga has started looking for potential replacements.

Mnata might have the upper hand on Shikalo but he also has a significant number of doubters which means the club could be realistically looking for a new high-profile option that can be relied on long-term.

There is a strong feeling, though, that any signing of a goalkeeper would not be for huge money, as they would be keen to open up funds for positions further up the field

The verdict here is that there is evidence to suggest Yanga will sign a new goalkeeper to replace or challenge Mnata who is likely to stay or in the unlikely scenario, Shikalo is retained.

However it pans out, it is clear Yanga are facing many questions and uncertainties in the coming transfer window, but perhaps none are as complicated as those regarding their goalkeeping situation.

Yanga needs one goalkeeper and perhaps two, depending on who they retain among the three choices in that position.

Their recruitment plans for the position are not simple either.

Academies offer athletes specialized training over a long period, while also taking care of their educational, psychological, and nutrition needs.

The coming of the government-owned academies will greatly help sports development as, apart from Azam FC academy, many other local academies are not in the standard.

The centers do not have all the requirements like qualified teaching staff, equipment, and other essentials.

Academies help in producing great players for elite league teams. Others go to play for the national football team.

They are attributed to immensely contributing to the development of sports in any country as it is believed that sports success at the top level does not come on a silver platter as there is a need for serious investment at the grassroots level.

WHILE office bearers for the Tanzania Football Federation (TFF)'s next term of office are about to go through the final rites of having been elected, a section of stakeholders was expressing doubts as to the validity of the forthcoming polls, on account of some strong contenders failing to return nomination forms.

Some contributors to the discussion on the issue over some FM radios were saying they had not heard of the 'endorsement' element earlier, and it in a sense remained somewhat troubling that a strong candidate like the Kinondoni MP, Abbas Tarimba, could not return forms.

The issue that arises is whether this was a personal problem or it was systemic as some maintain.

One such individual, and he ought to know as he served as TFF secretary general for years is Angetile Osiah, a veteran editor with top-level experience in TFF, who went as far as saying that the polls have been impaired, virtually ruling that they will be held as invalid.

Even serving secretary general Wilfred Kidau went as far as cautioning those in charge of organizing the polls to beware that the international federation (FIFA) could intervene and invalidate the polls afterward.

It is thus hard to ignore voices expressing deep concern on what is happening, but at the same time, it does not show the polls' invalidity.

It is unclear how far those who failed to obtain endorsement from eligible regional leaders forming part of the football organization apex, like membership of its general meeting or electoral conclave make a difference in how the polls are being organized.

For once, of those who failed to return forms, there is only Abbas Tarimba as the notable absence, and in the discussions, this name topped the list of those who most commentators appeared to be concerned about.

The others who returned forms and are also looking for the top post did not

seem to elicit much interest, outside incumbent, Wallace Karia, and ex-Yanga midfielder, Ally Mayay, who is well known in broadcasting circles as a top analyst of the game, at present.

Based on a write-up available online, four other contenders returned forms to seek for the president slot, including former MP, Ally Saleh, who is also a veteran journalist and current affairs analyst.

He was not as much involved in sports in a professional capacity as Ally Mayay but there is an aspect of the organization where he may have more to show off, to the public or the electoral body when it convenes.

The other three who also seek the top post aren't familiar at least to this reviewer, which may indicate not being media savvy, acknowledged public personalities but get solid followings, constituency.

Still, Ally Saleh faced hardship as a Zanzibari, who have their association, another league, separately.

That is how one begins to pierce into some weaknesses of the camp that says the polls risk becoming sort of invalid, as there is only one significant case of failing to return forms because those who are expected to sign are seemingly obedient to the incumbent.

That may explain the lack of endorsements in the sense that of the two those who were asked to endorse think that the current holder is more suited to the office, and in any case, that argument is easy to prolong without being a stakeholder in the TFF polls.

In a routine way of putting it, the Kinondoni MP is blessed as a businessman and politician, he does not need the post.

It is this very sufficiency of the

contender which both raises a furor as well as resolve a priori, since there was no movement on the part of the incumbent or organizing committee to stop him picking forms, saying for instance that he is an elected MP and could mix 'politics with sports.'

Nor is there a running battle with the incumbent at an organizational level, way for instance there is a battle between Yanga and TFF on account of some differences on pinpricks like Bernard Morrison and rescheduling of the city rivals' duel at which Yanga refused to field the team.

Still, it is not the club as a whole that is mindful of the tensions but portions of it, so Ally Mayay picked forms and returned them, Tarimba poses a different sort of issue.

As none of those talking on one or two FM radios ventured to say why Tarimba did not get endorsement votes - and then proceeded to question the very need for those votes, ignoring the fact that nobody else failed the test, as it were - it cannot be speculated what TFF contentions relate to the businessman at present.

But plenty of water has passed under the TFF bridge in the two last years, and if this bridge is extended to include wider national issues, universal disdain for the TFF contender may arise not just from friends of the TFF incumbent but from wider society.

He may be representing an aspect of electoral contentions that many in soccer organizations do not like, or he may be overly identified with such issues.

If he is the face of what they dislike, those who gained by heavy-handedness, he encounters stony faces.

No action needed over Rudiger 'nibble' - Pogba

PAUL Pogba accused Antonio Rudiger of "nibbling" him on the shoulder during France's 1-0 win on Tuesday, but said he was not looking for the Germany defender to face punishment.

The two players clashed towards the end of the first half, with Rudiger caught on camera putting his face close to Pogba's back before reaching his arms around the Frenchman's chest.

"I'm not crying for cards, yellow, red cards because of such actions," Pogba said after the match. "He nibbled, I think, a little bit on me. But we have known each other for a long time.

"I told the referee and he takes decisions and he took a decision.

"It was a great match for us ... and I didn't want him to be suspended because of such a situation. It was towards the end of the match. We hugged each other and that's it."

France coach Didier Deschamps was happy with his team's commitment in the win but said the world champions must look to retain possession better through the rest of the tournament.

France handed a sluggish-looking Germany their first openinggame defeat in the Euros, courtesy of an own goal by Mats Hummels in the 20th minute.

Stats showed that France had just over 40% possession and only four attempts on goal but Deschamps said they were more clinical than Joachim Loew's side.

"I wouldn't say that we did dominate them because we played against a good team in Germany who caused us problems," Deschamps said.

"They had a lot of ball possession, more than us. We were defending very well. It was a match played on a very high level, two titans facing each other.

"We could have done things better, especially in ball possession, and looking at the attitude to show this dominance, to suffer all together, when we showed this commitment on the pitch today against the very strong German side.'

Germany must 'crank it up' against Portugal, says Loew

GERMANY head coach Joachim Loew says his side must "crank things up" ahead of Saturday's Euro 2020 clash against Cristiano Ronaldo's Portugal after an opening defeat against France.

The Germans lost 1-0 to the world champions in their Group F opener in Munich on Tuesday, courtesy of a Mats Hummels own goal.

The scoreline flattered the home side as Kylian Mbappe and Karim Benzema had second-half goals disallowed, while Adrien Rabiot hit the post for the French.

Germany's defence showed signs of improvement, having leaked 20 goals in their previous 13 games, but the main concern is up front, where Thomas Mueller, Serge Gnabry and Kai Havertz mustered just one shot between them.

"It's up to us to crank things up in the next two or three days," said Loew. "We have to look to improve, because we need a goal or two."

Hummels said on Instagram the defeat "hurts us a lot and me especially, because my own goal decided the game," but the centre-back said the focus was now on beating holders Portugal in Munich.

Despite having more possession, running four kilometres more than the French as a team and completing nearly twice as many passes, Germany came up short.

The second-half introduction of Timo Werner and Leroy Sane was not enough to turn the tide.

"The substitutes didn't get into the game as well as we had hoped," said Loew. "But France are strong. They

France start Euro 2020 with tactical masterclass

HOW some things change in football. Back at the 2014 World Cup when Germany knocked out France in the quarterfinals, Mats Hummels was the game's lone goal scorer. On that night in Rio de Janeiro, it was the German defender who broke French hearts despite Les Bleus dominating the game and creating the best chances.

Seven years later in Munich, the German centre-back scored again, this time in his own goal, gifting France the 1-0 win this time in the two countries' Euro 2020 opener on Tuesday.

However, some things stay the same in football, too. To start, this 2021 France side looks very much like the World Cup-winning one from 2018. And this performance against Germany was a very similar display to their semifinal win against Die Mannschaft at Euro 2016 in Marseille.

While this time the scoreline was just 1-0 compared to 2-0 in Marseille, as they were in 2016 and 2018, this French side is so disciplined tactically and defensively (kudos to Antoine Griezmann for practically finishing this game at right-back), controls matches with a dominant midfield, and as they did in 2018, has the ultimate X factor in forward Kylian Mbappe, who consistently ripped open Joachim Low's side on Tuesday night.

If we didn't really know what to expect from this Germany before kick-off, we knew what France would deliver. They did exactly what's written on the tin. They suffered at times, and make no mistake, this is a good German team, but they never broke. In fact, they never even looked like breaking. The world champions are like a predator waiting for their prey, and

as we have seen over the past few years, the predator knows precisely when to attack.

"This was such a strong performance," said Didier Deschamps after the game. "We fought hard. We could have done better with the ball, in our buildup, but it was a very solid display." Deschamps was ecstatic in the dressing room afterward, warmly congratulating his players for an impressive win, which will make France even bigger favourites to win this tournament.

Delivering performances like this are so much easier when you have a midfield like France's. There has been much talk, and rightfully so, about France's front three of Mbappe, Karim Benzema and Griezmann, which is undoubtedly a scary proposition for any defence. But what about the trio of Paul Pogba-N'Golo Kante-Adrien Rabiot? There has not been a better midfield so far in this competition. They are so good at everything they do, complement each other so well, and each plays his part so perfectly.

France also got a big helping hand

from Germany. Deschamps was hoping that Low would play Joshua Kimmich at right wing-back and not in midfield because it would be easier then for his players to control the game like they did. The French could not believe that the best holding midfielder in the world was not playing as a holding midfielder for his country at the Euros!

So the midfield belonged to France, and that's where they won this game. Kante was everywhere again. Rabiot so astute and intelligent tactically, and precious under pressure. And then, you have Pogba. This was vintage Pogba, 2018 Pogba, or maybe even a better Pogba. What a performance!

'This is such a strong collective victory. We are so focused and so efficient. We all work hard for each other. We are humble on the pitch and we suffer together," said the Manchester United star, who complained to the referee after it appeared he was bitten in the back by defender Antonio Rudiger at the end of the first half.

Pogba was rightly so named man

of his exceptional involvement in the goal. We have seen fantastic moments so far in this tournament -- England midfielder Kalvin Phillips' run ahead of Raheem Sterling's goal, Czech Republic's Patrik Schick scoring a wonder goal from midfield against Scotland -- and we have now seen the pass of the tournament so far from Pogba. An incredible moment of inspiration and genius with a half toe-poke/half outside-of-thefoot switch from right to left for Lucas Hernandez, whose subsequent cross was deflected in his own net by Hummels. It was part of a complete performance from Pogba, who made 12 ball recoveries, won 13 duels, drew four fouls, was also robbed of an assist because of an offside ruling and later of a "hockey assist" ahead of the goal Benzema had ruled out for offsides.

The one goal that stood was such a great collective goal because it is exactly what France aimed to do. Meanwhile, Kimmich struggled against Mbappe all game long. The Frenchman was in top form, despite touching the ball only 35 times, the lowest tally of the 22 starters. If you thought that the incident with Olivier Giroud would affect him, we saw tonight that the answer was clearly

His threatening run behind Hummels was a large reason for the own goal; he later scored a fabulous goal that was disallowed for offside, and then he was offside again, this time by the narrowest of margins, ahead of setting up Karim Benzema for a goal ruled out by VAR.

Netherlands captain Wijnaldum is the type of player every team needs

AS the madness of the Netherlands' opening Euro 2020 match against Ukraine played out on Sunday, Georginio Wijnaldum was one of the Dutch players trying to bring some order to the wonderful chaos. He put in a captain's performance, too, scoring their opener with a wonderfully taken strike 15 yards out and later, as the match looked to be slipping away from them as Ukraine came back from two goals down to draw the game level, he slowed the play down, helped refocus his team and was in the thick of the action before Denzel Dumfries headed in the game-winning goal.

Wijnaldum looked exhausted after the 3-2 win, but he'd put in the sort of performance that showed why Barcelona and Bayern Munich inquired about signing the midfielder before he announced he'd join another super-club, Paris Saint-Germain, after his Liverpool contract expires this summer.

Wijnaldum is an understated captain. He leads by example with a relentless workrate, an incredible ability to read passes and a quiet, consistent leadership. But he's also the sort of player every successful team needs: he's the glue who can cover all three facets of the modern central midfielder, comfortable as the holder, the presser or the attacking No.10. That's why Liverpool desperately wanted to keep him and why, for all the hype over his future, it wouldn't have affected his focus on Oranje duties at all.

If you looked at Frank de Boer's inbox before the Euros, any concerns over Wijnaldum weren't high on his pre-tournament panic list. Instead, he dealt with Matthijs de Ligt's groin injury suffered in training, the absence of Virgil van Dijk and the criticism of his preferred 5-3-2 formation over the traditional Dutch 4-3-3. There were question marks over who'd start in goal and what combination of forwards would be used up front, but the ever-dependable Wijnaldum was never a concern. His importance is further told through his stats: in his last eight Netherlands matches, he's scored five and has two assists.

Wijnaldum has already bid farewell to Liverpool, too, receiving a guard of honour in their final home match against Crystal Palace on

May 23 and a plaque recognising his success with the Reds, including the Champions League and Premier League title he helped win in his five-year spell at the club.

"It was very emotional," Wijnaldum told ESPN. "I didn't think I would get this kind of goodbye. Players that left before me did not get something like this.

"Of course, it's a pity I left Liverpool. I had a lot of beautiful memories with the team. My relationship with the fans is really good. It is what it is. One day I'll tell my story about how it all went. In that way, the fans will understand why I left the club.'

Wijnaldum, 30, was unwilling to expand further, but in an interview with Voetbal International, he said "things happen behind the scenes that are beyond your control as a player." That can wait.

Growing up, Wijnaldum wanted to be an acrobat, but it was in football where he found his calling. Having come through Sparta Rotterdam's system, he moved to Feyenoord's academy in 2004. He still

holds the record as the youngest-ever Feyenoord player, debuting aged 16 years old and 148 days in their Eredivisie match against Groningen on April 8, 2007. He was named Man of the Match.

From talking to those who have watched Wijnaldum develop, the consensus is that he was never one to cause controversy, instead staying close to his grandmother, Francina, who raised him.

Gertjan Verbeek managed Feyenoord for part of the 2008-09 season, and remembers Wijnaldum at

"It was early in his career," Verbeek tells ESPN. "He was a great talent. He was always smiling, even in the hardest training sessions. He was so young, but he already had a lot of responsibility.

The influence of his grandmother was very important for him, too. He took care of his grandmother, and his grandmother took care of him and his brothers."

Verbeek remembers what Wijnaldum was like around the older pros in a Feyenoord team that had re-

spected Dutch internationals. "He was very stable in thinking and in what he wanted to achieve, and how to do it. We had big names in that squad like Roy Makaay and Giovanni van Bronckhorst, but even though he was 17, when he spoke, they listened. Great players understand the young talented players as they respect each other."

At Fevenoord he was used both as an attacking midfielder and a makeshift striker. He eventually settled into central midfield, where his performances led to PSV securing a £5m transfer in 2011.

There, he helped them to the 2015 Eredivisie title, forming a wonderful understanding with Memphis Depay; the pair will hopefully lead the Dutch to success this summer. When he won the Golden Boot in 2015, the prize given award for the Dutch Player of the Year, he tearfully paid tribute to his grandma, who presented him with the trophy.

In July 2015, he made the switch to Newcastle United for £14.5m. After an impressive individual season in which Newcastle were relegated, Liverpool brought him in the following summer for £23m. He quickly became a key cog in the Reds' midfield under Jurgen Klopp, scoring two essential goals from the bench in their remarkable Champions League semifinal win over Barcelona in 2019.

Like all of Wijnaldum's coaches through the years, Klopp trusted him in the big occasions: he started their 2018 Champions League final which ended in defeat against Real Madrid, but made up for it when he was again in the starting XI in their 2-0 win over Tottenham Hotspur in

Yanga is expected to prioritize the signing of forwards after Fiston Abdul Razak and Michael Sarpong failed to live up to expectations. Sarpong was signed before the season began and so far does not feature among the top five best scorers.

Razak came during the mid-season transfer window but has been unable to successfully challenge compatriot, Said Ntibazonkiza, and Burkinabe Yacouba Sogne for a starting berth.
