AIR Tanzania Co. Ltd (ATCL) has announced plans to start direct flights from Dar es Salaam to London using a Boeing 787-8 Dreamliner early next year.

Ladislaus Matindi, the ATCL director general said at the launch of Air Tanzania online application platform that the firm is set to increase the number of flights to Mumbai, the Indian commercial capital, and the Chinese business hub of Guangzhou, while starting new flights to Dubai, Muscat, Lagos, Kinshasa and Goma, the eastern provincial capital in the DRC..

The online App is a service accessible from various types of phones, whether "android" or "ios" systems, providing travelers with "a unique experience of privacy and freedom of choice," he said.

Through the Air Tanzania App, the customer will be able to choose the day of the trip, the travel class, the seat, or buying an extra bag when traveling to any place inside and outside the country with the airline, he said.

In addition, customers will be able to get travel tickets online, instead of being served at 15 domestic and 11 foreign stations, he stat-

ATCL stations will be set up in Pemba, Tanga, Mafia, Nachingwea and Musoma, along with restoring trips to Iringa and Mtwara, so that more businesspeople and other stakeholders can benefit from the presence of Air

### Burundian refugees: 166,000 quit camps, leaving 155,000

TANZANIA and Burundi have agreed to accelerate efforts for voluntary repatriation of refugees to the neighbouring country in line with the terms of the tripartite agreement of May 2001.

Home Affairs minister Hamad Yusuf Masauni signed a joint communiqué for voluntary repatriation, affirming that between since September 2017 more than 166,000 Burundian refugees opted to return to Burundi, while 155,000 are yet to agree to repatriation.

This assessment was affirmed in Dar es Salaam on Thursday evening as the parties, namely governments of Tanzania and Burundi plus the United Nations High Commission for Refugees (UNHCR) met for the 24th meeting of the tripartite commission for the voluntary repatriation of Burundian refugees living in Tanzania.

The joint communiqué hailed the government for its role in hosting Burundian refugees for several decades, seeking to draw a line under that situation soon, for refugees to "go back home and contribute to the development of their homeland."

The minister said the process will be guided by a well-defined roadmap set out at the two day technical working group meeting earlier in the week, focused on improved infrastructure, expansion of reception facilities for the returnees,

It also seeks to enhance capacities for appreciating progress in conditions if return, counselling, and registration for repatriation, he said, adding that this will enable

the refugees to make informed decisions for voluntary repatriation.

He reiterated the government's commitment to the principle of voluntary repatriation of refugees as provided for by international refugee law, thus the ongoing voluntary repatriation exercise strictly observes the terms of the tripartite agreement.

While voluntary repatriation is being pursued, Burundian refugees will remain in position, protected by international protocols as at present, he said.

He emphasised the government's goodwill towards the presence of the refugees, underlining that the country keeps its doors open to genuine and credible asylum

This includes refugees fleeing persecution, instability and wars, thus in need of international protection as asvlum seekers, he stated.

Martin Niteretse, his Burundin counterpart, said the government and the Burundian people welcome with open arms all Burundian refugees who wish to return.

"I personally call on those who remain in countries of asylum to make the right decision to return and contribute to the country's development, working alongside other citizens," he said.

Among other key recommendations, all parties agreed to facilitate the recognition of school certificates and vocational training obtained by refugees in the country of asylum, upon return.

They also agreed on the need for review of the costeffectiveness of administering Burundian examinations in camps across the border, while UNHCR agreed to redouble efforts in resource mobilization to support the repatriation and reintegration of returnees.

Mamadou Dian Balde, the regional bureau director for East Africa, Horn of Africa and the Great Lakes said that the agency is committed to supporting governments to find durable solutions for refugees.

It intends to support people to return home once conditions allow, appealing to the international community to support Burundi's efforts to provide essential services, extend support to returnees and their commu-

This will allow for sustainable returning as well as supporting voluntary repatriation efforts, he asserted, elaborating that since voluntary repatriation started in September 2017, more than 230,000 refugees have taken up the offer to repatriate, with over 161,000 hailing camps in Western Tanzania.

By late October, around 248,000 Burundian refugees were hosted in the Democratic Republic of Congo, Rwanda, Tanzania and Uganda. Of these, around 155,000 refugees reside in the Nduta and Nyarugusu camps in Tanzania, officials noted.

### Tanzania loses 3pc of GDP in climate upsets'

WO to three percent of the country's gross domestic product  $(GDP)\,is\,being\,lost\,due\,to\,climate$ change, President Samia Suluhu Hassan declared yesterday. Addressing conference delegated for the global climate change jamboree at Dubai, in the United Arab Emirates (UAE) the president appealed to developed nations to meet their pledges in financing adaptation efforts.

She said that despite minimal contribution to global warming, Tanzania was mobilizing support for increased use of clean and affordable cooking fuels and technologies for women across Africa. All nations need to play their part, she emphasised.

Honouring commitments to climate solutions was the only way to meet the challenges regarding climate change adaptation, now less a matter of choice but vital for sustained economic capacity, thus requiring collaborative efforts, she stated.

Developed countries need to meet their pledges, she said, pointing at the \$100bn a year to developing nations to help adapt to climate change "and mitigate further rise in tempera-

She referred to assertions by the Intergovernmental Panel on Climate Change (IPCC) that efforts to adopt precautions will be constrained and made less effective in the near future, underlining that the world "needs to choose to adhere to science or face the consequences."

The Paris and Copenhagen

climate change conferences saw promises being made to reduce temperatures to within 1.5 degrees Celsius from preindustrial levels, but the current rate of global warming was alarming.

It has detrimental effects on economies of least developed countries, the president noted at the COP 28 jamboree.

She said that Tanzania was attending the meeting to push the need for the conference to approve the formulation of a special fund to address climate change destruction.

"Tanzania is working to ensure that efforts to enhance clean cooking are inclusive but also focuses on women in rural areas, as we push for higher levels of collaboration," she said.

Ensuring that debate on

gender equality considers national values and women are accorded priority in addressing climate change effects was equally vital, she said.

The jamboree kicked off on Thursday and is projected to close business on December 12, attended by more than 70,000 participants from upwards of 190 countries and territories worldwide.

The president leads a delegation comprising several cabinet ministers, permanent secretaries, envoys to foreign countries, ministerial experts and select members of the media, among others.

Under the theme 'Unite, Act and Deliver!' the conference is expected to push the goal of limiting long-term global temperature rises to within 1.5 degree Celsius.

On the sidelines of the conference, Tanzania prepared to host three high level side events on clean energy, sustainable farming and the blue economy, officials said.

President Samia is set to lead leaders of various countries to launch the African Women Clean Cooking Support Programme (AWCCSP), focused on the use of clean cooking energy to address health, environmental, economic and social effects upon women and children when unclean energy

She will also witness the signing of a bilateral cooperation agreement with the UAE for cooperation between the Salim Ahmed Salim Centre for Foreign Relations and the Dr Anwar Gargash Centre for International Relations.

fected, with 0.24 percent of women and 0.11 percent of men being newly in-

This year's theme, 'Let communities lead,' makes the celebration an opportunity to reflect on the progress made to raise awareness about the challenges that remain to achieve the goals of ending AIDS by 2030.

It also reflects on mobilising all stakeholders to jointly redouble efforts to ensure the success of the HIV response, he said, elaborating that the government resolved to conduct a survey on the current HIV/Aids infection situation.

The findings have shown that Tanzania has made remarkable strides in the fight against the disease, he said, noting that the HIV Indicators Survey 2022/23 measured HIV prevalence among youth aged 15.

It aims at understanding the rate of the spread of the disease and those on antiretroviral treatment in the various regions, an indicator that is important because those diagnosed with HIV are healthy, not suffering from AIDS and opportunistic diseases.

With treatment, when one reaches the level where the virus is not visible in the laboratory, then such a person will not be able to infect others, he said.

Regarding the prevalence of HIV for ages 15 and above, the report indicates that research has shown that it ranges from 1.7 percent in Kigoma region to 12.7 percent in Njombe, Mbeya and Iringa re-

"Njombe Region has a rate of more than 9 percent, twice the national level,

the premier noted, affirming that in the case of Zanzibar. AIDS prevalence shows that it ranges from 0.2 percent in the North Pemba Region to 0.8-percent in the South Unguja Region. Young people need to value their lives

by protecting themselves from new HIV infections, while stakeholders need to prioritise this important group to save it from the threat of infections. He also urged people living with HIV

to ensure using ARV drugs with due adherence in order to improve their health, affirming that the nation depends on the The government ensures that ARV ser-

vices in the country are readily available, he stated, directing regions and districts countrywide to implement instructions to mark the World AIDS Day. This should go in tandem with providing appropriate services to those in need, he said.

"Each region should prepare a commemorative notice that will classify various social services and submit it to the Office of the Prime Minister," he speco-

Jenista Mhagama, the Policy, Parliament and Coordination state minister in the Prime Minister's Office said that the ministry, in collaboration with the Ministry of Health, will organise to foster the protection of the youth to withstand the AIDS pandemic.

Health minister Ummy Mwalimu said the rapid spread of HIV infections demands that a programme be developed to harmonise HIV, other sexually transmitted diseases and hepatitis as there are similarities in how they are transmitted.

### Deputy Prime Minister for closer cooperation in war on HIV/AIDS

**DEPUTY Prime Minister and Minis**ter for Energy, Doto Biteko has called upon stakeholders involved in the fight against HIV/Aids to collaborate with the Tanzania Commission for AIDS (TACAIDS) to ensure sufficient allocation of funds in fighting the dis-

Biteko made the remarks during special stakeholders' conference on November 30th, 2023 in Morogoro Region that involved government leaders, development stakeholders and people living with HIV/Aids.

"Tanzania has made great strides in the fight against Aids; I want TA-CAIDS and stakeholders to cooperate in fighting against the disease by enhancing people's participation," said

He said the government has continued to take various efforts in the fight against HIV/Aids which has led to a decrease in new infections, a decrease in the number of HIV related deaths and increased number of people on antiretroviral (ARV) treatment," he said, adding that transmission of the disease from mother-to-child has also decreased while the goal is to have zero AIDS-related deaths by 2030.

He added: "We have also witnessed the reduction of stigma against people living with HIV, all this is happening with the cooperation from stake-

He said despite the various efforts taken by the government and stakeholders, the disease has not vet been fully controlled, a situation that could lead to an increase in new infections.

He asked stakeholders to continue with efforts in providing interventions aimed at ending HIV/Aids.

TACAIDS Acting Executive Director, Dr Jerome Kamwela said the meeting aimed to provide an opportunity for discussions between the government and stakeholders for purposes of enhancing the fight against HIV.

He said the conference was crucial as Tanzania is moving towards achieving the global goal of ending Aids by the year 2030 where there should be no new infections, HIV related deaths and stigma.

He said that the meeting discussed how the management, government and stakeholders can responsibly work together and ensure financial sustainability in fighting HIV/Aids. He said that it was also an opportunity for stakeholders to discuss achievement and challenges.

### Tanzania's mining sector realises increase in growth in local content

EFFORTS by the government to ensure increased local content in the country's mining sector have started to bears fruit, thanks to the Mining Commission.

March this year the government through the Mining Commission launched a special digital system to help attract more Tanzanians to take part in the mining sector and to ensure the involved mining companies are rolling out diverse social services through Social Corporate Responsibility (SCR) regulations.

As a result, it has been unveiled that currently, at least 86 percent of indigenous companies are providing services and products in mines, while the remaining 14 percent are provided by foreign companies through a special permit issued by the Mining Commission.

In an interview with the Guardian yesterday, Executive Secretary of the Mining Commission, Eng Yahya Samamba said the number of employment of locals (Tanzanians) in the mining sector has currently reached 97 percent while foreign nationals are three percent.

mission continues to work on a series of strategy to heighten the participation of Tanzanians in the mining sector.

He added: "The vision is to ensure the mining sector pays a great contribution to the growth of the country's economy and the citizens to benefit from the available mineral resources."

Eng Samamba said the government through the commission has so far made various improvements to the mining law and its regulations with the aim of ensuring that there is potential increase in the participation of Tanzanians in the sector while the government is receiving its statutory various taxes along with generating more jobs.

"One of the improvements includes formulation of regulations for the participation of Tanzanians in the Mining Sector (local content) which have brought benefits to mining stakeholders, especially citizens living in the vicinity of mining mines," he expressed.

Engr Samamba said through the regulations, no company is allowed to import goods or services from abroad without obtaining permission from the Min-

He expressed that the coming Commission, the goal being to ensure every Tanzanian benefits from the sector.

> He added that in the management of the principles of the participation of Tanzanians in the mining sector, the commission through the committee for the participation of Tanzanians has continued with its primary responsibility of analysing the plans submitted by all companies engaged in mining and exploration of minerals, and service providers in the mining sector as required by the Mining Law of 2010 which was amended in 2017 and the Regulations for the Participation of Tanzanians in 2018 as well as its amendments.

> He said during the quarter of the fiscal year 2023/2024, the commission received a total of 234 plans for the participation of Tanzanians in the mining sector, presented for the first time for analysis and approval in accordance with the principles of participation of Tanzanians.

> He added that among the 234 companies that submitted their plans for the participations of the Tanzanian in their sides, three companies own a license for large mining, five companies own/apply for a license for me

dium mining, seven companies own/apply for an exploration license and 219 companies are the service providers (Contractors & Subcontractors) for mining license holders.

"We're continue running a series of initiatives to ensure for the increased participation of the Tanzanians in the sector, these include providing education to companies that own mining licenses, organizing various forums and workshops regarding the implementation of the policy for the participation of Tanzanians in the sector as well as staging numerous exhibitions

related to mining technology," he emphasized.

According to relevant reports, employment for Tanzanians in large mines has increased from 6,668 in 2018 to 15,341 in 2022 with Tanzanians getting various training to build the capacity to work professionally in the sector, the works that were previously handled by foreigners.

Moreover, there has been an impressive increase in domestic purchases, whereby in 2022, a total of \$2.22, equal to 97.4 percent of all purchases by mining companies were made using Tanzanian companies, compared to

the \$238.71 (46 percent) of all purchases made in 2018.

Contributions of the mining sector to the county's Gross Domestic Product (GDP) have increased to 9.1 percent from 7.2 between 2021 and 2022 as the sector registered an impressive growth, from 9.6 percent to at least 10.9 percent during the pe-

During the 2022/23 fiscal year revenues collections accrued from the mining sector has reached at 678bn/-, whereby the mining market points managed to raise at least 154.4bn/- during the period.

### Graduates urged to do research to address obstacles facing the public

FORMER Minister for Finance Janeth Mbene has challenged newly graduates of the Hubert Kairuki Memorial University (HKMU) to use the knowledge they have acquired to conduct various research to address challenges facing the general public.

Speaking during convocation ahead of the 21st graduation ceremony which is expected to take place today, the former minister urged the graduates to continue looking for opportunities including entrepreneurship after completing their studies.

She called upon the graduates to be innovative as the job market was minimal, saying it was only through innovation that they could employ themselves.

"Graduates should be creative and provide solutions to these challenges by starting various activities that will bring solutions to the challenges that the country is facing," she said.

She also asked them to develop themselves technologically by introducing modern services that are often not available especially in rural areas, especially in health services.

"If you are a doctor, a nurse, you can use your skills by using technology to serve the people there and be ready to commit yourself because these services are a calling, not just a job, you should be eager to serve the people," she

Mbene praised HKMU for introducing incubation program to help graduates start and develop their businesses instead of relying only on their professions

She said that the graduates should use the available opportunities and collaborate with their colleagues to do something together because by doing so they can see good results earlier than everyone being on their own.

"You have heard these complaints, so what I can say is that the government should be careful so that those who get it are really those who deserve to get it, because if they get those who are capable, it becomes meaningless," he said.

### Govt making reforms to ensure predictable tax policies, says PS

THE government has said that it will continue to make tax reforms every three years to have a predictable tax policy and motivate investors to establish more projects.

Deputy Permanent Secretary of the Ministry of Finance, Elijah Mwandumbya made the statement during a conference to collect opinions on taxes that was held in Mbeya City.

The meeting was part of on-going sessions taking place in various zones in the country with objectives to improve the country's tax policy for the 2024/2025 financial year.

He said the current procedure is to make tax amendments in the coming three years, noting no changes will be made until 2024/2025.

"We previously had a procedure that caused people to complain that the budget depends on taxes from alcohol, cigarettes and soft drinks. Such statements were drawn from the fact that every year the government would change tax rates imposed on the abovementioned commodities. This will no longer be a practice,"

said Mwandumbya. Concerning the already executed tax improvements, Mwandumbya said the government has increased capital goods produced in the country in the scope of postponement of the Value Added Tax (VAT) starting from July 01, 2023 and the removal from the scope capital goods from abroad commencing on July 01, 2026.

He underscored the need to add value to products from the agriculture sector for Tanzanians to sell them at competitive prices, adding farmers need to be provided with machines for processing of the agricultural goods. He explained that the government has exempted value added tax from a special procedure on machines that are used for value addition to boost the income of the people and economy in general.

Other improvements according to the PS include exemption of value added tax on tools used for changing vehicles' operating system from using fuel to gas or electricity.

Service Manager, Tax Information and Grievance Redressal Institute (TOST), Godwin Barongo said it is important to ensure governance in the tax system for taxpayers to pay

taxes rightfully.

He said taxpayers with complaints file them through TOST. He said the institute will consult the Tanzania Revenue Authority (TRA) as it always does in finding solutions to such chal-

lenges. He said the institution is not there to create conflicts between the government and TRA but it is there to help taxpayers and TRA to facilitate

smooth payment of taxes. Chairperson of the Tanzania Chamber of Commerce, Industry and Agriculture, Eric Sichinga lauded the Ministry of Finance for coming up with the approach that involves traders in respective zones.

A team of experts on tax policy analysis from the Ministry of Finance is continuing with zonal conferences aimed to collect views on improvement of financial policies. The meetings are held in Arusha, Mwanza, Kigoma and Mbeya

for establishment of fruit processing industries.


Soraga said the major work currently going on at the area is setting-up of important infrastructures including clean and safe water as well as electricity services.

### NGO embarks on training to push for the rights of domestic workers

DOMESTIC workers from Morogoro, Mwanza, Dar es Salaam and Coast regions have hailed the special training offered by the Tanzania Domestic Workers Network (TDWN) which has helped them to recognise and access

TDWN coordinator Demitila Faustine said yesterday that they are very happy to see what has been achieved so far as the training has brought positive changes to the group.

Right now, more than 387 domestic workers have been able to acquire employment contracts from their employers while 198 have received legal aid

He said domestic workers are now aware of their rights saying they can report the challenges they face in the workplace to TDWN, police and other authorities, something that was not the case in the past.

This has been possible through a 12 months project dubbed: 'Sauti Yangu Nguzo ya Mabadiliko project' that is being implemented by TDWN with funding from Women Fund Tanzania Trust (WFTT).

"In 2022 and 2023, we received 60m/- from WFTT for the implementation of the Sauti Yangu Nguzo ya Mabadiliko project.

The main goal of the project was to provide capacity building for members on human resources and finance, and how to handle domestic workers complaints and cases.

The other goal was to make advocacy and train domestic workers on laws and guidelines that protect domestic workers and promote good governance. The programme also involved monitoring and evaluation, organizing TV

and radio programs, print brochures for public awareness and members. Through the knowledge and skills gained from TDWN so far 198 domestic workers have been able to receive legal aid service, psychological

### El Niño floods cause a million to flee their homes in Somalia

#### **MOGADISHU**

THE Somali authorities say more than a million people have now been forced to abandon their homes in the country because of floods caused by the El Niño weather phenomenon.

The heaviest rains in more than two decades have caused widespread destruction, displacement and death across the Horn of Africa.

It comes as world leaders gather in Dubai to discuss the climate crisis at the COP28 summit.

At least 270 people are reported to have died in Somalia, Kenya and southern Ethiopia as the continental region, which is just coming out of prolonged drought, braces for further torrential rains.

Whole towns have been submerged forcing nearly their entire population to seek shelter elsewhere. President Hassan Sheikh Mohamud has said the country is in a critical state.

Neighbouring Ethiopia and Kenya are also dealing with widespread floods.

The situation is expected to get direr as heavy rains are predicted to continue to early next year.

The World Food Programme says the situation compounds the food security crisis in the region.

There are also fears of disease outbreaks.

Humanitarian organisations are calling on world leaders meeting at COP28, to remember countries - like those in the Horn of Africa - which are vulnerable to the effects of climate change while contributing the least to it.

### COP28: EU, IMF, Zambia call for more ambitious, widespread carbon pricing

#### **OVIEDO**, Spain

ON the sidelines of the UN climate change conference COP28 on Friday, leaders of the European Union, the International Monetary Fund, Zambia, and the World Bank argued for the urgent need to implement more carbon pricing.

"There is a way to cut emissions while fostering innovation and growth - put a price on carbon," said European Commission President Ursula von der Leyen in her opening remarks to the meeting. "The message is very clear: If you are polluting, you must pay a price; if you want to avoid the payment, then innovate and decarbonize."

Just 23 percent of global emissions are currently covered by carbon pricing, according to a 2023 World Bank report.

Spanish Prime Minister Pedro Sanchez said that the aim was to get at least 60 percent covered as soon as possible.

Kristalina Georgieva, IMF managing director, said she could not think of a more important topic than carbon pricing.

"Is it possible for us to decarbonize fast enough without pricing carbon? The answer is no," she said frankly, explaining that without the extra revenue it raises, countries would be forced to take on an unsustainable amount of debt to fund the climate action needed to keep warming below 1.5 degrees Celsius (2.7 degrees Fahrenheit).

She also said that the price of emitting carbon needs to increase quickly. Of the 23 percent of carbon emissions currently covered

by a pricing scheme, the average price to emit a ton of CO2 is \$20. She said that needs to increase to \$80 per ton to reach 2030 climate targets.

She acknowledged that carbon taxes, while efficient, are often not viable politically. She said the IMF now recommends making carbon pollution more expensive through trade, like the EU, or through regulations that make it more expensive for industries or consumers.

The EU implemented its carbon emissions trading system in 2005. Von der Leyen said that in those 18 years, the bloc has reduced emissions by 40 percent and raised €175 billion (\$190.5 billion) in extra revenue that goes exclusively to climate action, innovation, and supporting developing countries.

Georgieva of the IMF said developed countries should be paying more, while nations with fewer resources could be exempt from mandatory markets.

They also spoke about the importance of carbon credits, which can reward countries for protecting biodiversity or vast forests.

Zambian President Hakainde Hichilema advocated for clear international standards and regulations around the credits to avoid forcing countries to have to "reinvent the wheel" and "waste time."

He also praised the carbon credit system as a way for less developed countries to get a "fair share" of the capital being used to make the green transition.

Zambia is in the advanced stages of developing a framework to regulate carbon credit

"Finance is not neutral. And signals are needed. We call on stakeholders to join us and help us send a strong political signal to tell the world that carbon markets work for the economy, the people and the planet," said Spain's Sanchez during the opening remarks.

According to the World Bank report, carbon pricing has been increasing in recent years. In 2010, just 5 percent of emissions were covered by a carbon pricing scheme, after major nations like China, Japan and South Korea implemented plans. In September, Indonesia also began trading Co2 emissions credits.

It will enhance preparation for negotiations by providing a tool to assist Member States representatives to create and edit offers that are of a high technical quality efficiently.

It will also facilitate negotiation of sector specific commitments digitally to complement physical negotiations and minimise delays and better coordina-

### **Ghana and Tanzania expect closer ties** with China in minerals co-development

SOME African countries are ready to deepen cooperation with China in the mineral exploration sector, based on their abundant natural reserves and the advancing industrial chain of Chinese companies, to foster mutual

The revelation was made recently by Ambassadors of Ghana and Tanzania to China.

Tanzania's ambassador to China, Khamis Mussa Omar, told the Global Times that China is one of its major cooperation partners, and both sides have investment cooperation in multiple sectors including mining, agriculture, and manufacturing, and all of them are going well.

"Tanzania has abundant untapped minerals including nickel, cobalt, manganese, copper, and graphite, which underscore huge potential for mineral cooperation with Chinese companies," said the ambassador.

In 2022, the China-Tanzania trade volume was recorded at \$8.31 billion, an increase of 23.7 percent year-onyear, and Chinese companies' investment stock in Tanzania reached \$1.44 billion, according to data from China's Ministry of Commerce.

"China has provided what African

countries need in the past several decades, such as infrastructure, without interference in the governance of the countries, and with huge respect for local laws, culture, and people," said Omar, noting that these factors are the most important competitive advantages of China compared with Western countries.

Omar encouraged Chinese companies to make full use of Tanzania's raw materials to facilitate local industrialization, and to establish more China-Tanzania direct flights to boost bilateral communication. Hammond said Ghana is eager to collaborate with more Chinese investors to realize mutual benefits in future cooperation under the BRI.

Ghana has maintained a close relationship with China over the past decade, including cooperation in the mineral sector and the Belt and Road Initiative (BRI) partnership, Winfred Nii Okai Hammond, Ghana's ambassador to China said during the 2023 Global Mining Business Development

"Minerals are one of the economic backbones of Ghana, and we have established the Ghana Investment Promotion Council to attract investors to Ghana's mineral sector, especially Chinese investors," said Hammond.

### Concern as 70 young people contract HIV/Aids daily in Uganda

AS the country marked the World Aids Day 2023, experts have raised concerns that intergenerational and transactional sex is frustrating the fight against the disease.

About 68 young people below 25 years have acquired HIV/Aids on a daily basis in the country in the last two years, a trend which casts a shadow on the country's ambition of ending the virus by 2030.

According to analysis of the Uganda AIDS Commission (UAC) statistics, more than 50,000 new HIV infections in the last two years were among young people aged 15-24 and children aged 0-14.

According to the UAC statistics, the young people contributed three-quarters of the new infections (39,000 out of 50,900 HIV infections) in 2021 and 2022.

Children aged 0-14, who acquired infections through mother-to-child transmission (MTCT), were 11,900. The 50,900 infections in the age group were part of a total of 106,000 new HIV infections for the general population in the two years.

"We are off target to ending Aids by 2030," said Dr Cordelia Katureebe, the national coordinator of HIV Care

and Treatment at the Health minis-

"Currently as we speak, we still have new infections among children and we still have a burden of children and adolescents living with HIV," he adds.

Dr Katureebe explains that although the country has seen a 52 percent reduction in new HIV infections over the years, the new infections registered annually are still unacceptably high.

"The decline we expected to see for new infections is also off-track. We still see that the maternal antiretroviral therapy (ART) coverage is still low (at 72 percent) and that explains the cracks we continue to see. There still remains treatment inequity among children and adolescents,"

she says. According to UAC figures, a total of 47,000 new infections were registered among children and young people below 25 years in 2010, a figure which is about two times higher than the 24,900 new infections registered in the same age group in 2022.

"There still remains treatment inequity among children and adolescents. That said, a lot of strides have been made, we may not be there but we know all the strategic interventions and all the initiatives that worked in the past," she adds.

The Health ministry, in a move to curb new HIV infections, last week launched the Global Alliance to End Aids in Children by 2030, an initiative hinged on four pillars; early testing and comprehensive treatment and care, as well as closing the treatment gap and optimising the continuity of treatment for pregnant and breastfeeding women living with HIV.

The initiative also seeks to prevent new HIV infections among pregnant and breastfeeding women and address rights, gender equality, and the social and structural barriers that

hinder access to services. Dr Nelson Musoba, the UAC director general, says ending Aids by 2030 is feasible.

He noted that this would involve embracing the strategies the government has come up with and taking personal responsibility in the fight would see the country achieve the target of ending Aids.

"Our goal of ending Aids by 2030 means zero new infections, zero Aids-related deaths and zero stigma and discrimination. It is seven years to go and we believe we can hit that target if we get everyone involved," he says.

#### With greater transparency, options for accountants, auditors narrowing

tors are making efforts to bring into line habits in accounting, to which auditing is tied.

The idea is to ensure that all concerned, in playing their role, bring conformity to what they do individually and as members of a profession - both ways earning public trust.

Accounting generally, and auditing in particular, used to be secretive spheres of public life - and, for most of the period since independence, reports by the Controller and Auditor General were intended as purely advisory to the president and not really to the government as a whole. Now it is tabled and extensively debated.

This feature alone shows that there is plenty of transparency at present compared to the past even while, judging by government measures and pronouncements from time to time, plenty remains to be done.

One difficult area is how far it is actually accountants and auditors that are to blame, or they are basically merely facilitators of what some other people having institutional ability to order them around.

This goes in line with the famous aphorism, "the buck stops here", as to who is the accounting authority - and, unavoidably, it is accountants who keep the books it is presumed that they are the ones best placed to offer professional advice.

The Minister of State charged with overseeing conduct in the public service recently made remarks in that direction. It is that accountants and auditors have to shape up more so that their profession goes in tandem with the changing digital technology atmosphere.

It was an auspicious occasion where members of the profession met for three days to look into what they are doing at present and the challenges they face as members of the National Board of Accountants and Auditors.

The minister was emphatic that being equipped with professional skills was not good enough in the absence of efficiency and integrity,

HIGHLY placed public administra- meaning taking into account profes sional and other values and being responsible for technical decisions.

One issue bedevilling not just the profession but the public service or stakeholders at large is the precise environment in which being accountable and standing for ethics makes a difference.

It often so happens that people are implored to emulate truly exemplary people, but the social reality is that people seek to emulate only "successful" people, where there is a different book of key rules.

It means that accountants are under enormous pressure to let things pass when the situation looks orderly enough and presentable, to a reasonable extent, even if not really so.

So we can say this is where the shoe pinches, to expect that accountants will stand their ground on professionally and legally proper use of public funds when they are under collective pressure to sign on.

At times charges relating to particular anomalies are raised against executive directors - who are the decision makers, not accountants. It is collective action, usually.

That is why it is a bit difficult to say what precisely accountants and auditors meeting in the nationwide conclave will really have learned at their recent conference.

The idea that they themselves need to be moral goes without saying, as all those doing the wrong thing on their own accord will likely suffer the consequences. However, when groups of powerful or empowered individuals engineer some crafty use of public funds, should anyone expect accountants and auditors to give opinion to the contrary?

And if these professionals stop short of telling senior public officials what the moral and other rules are supposed to be, can anyone frankly say they it was dereliction of duty on their part?

The fact is that they are there to serve rather than to save; if the world has heaped praise on failed heroes, let's consider that more than enough.



### Is there any single drug to treat cancer alongside cardiovascular disease?

WHAT would you guess are the two biggest killers in the world? Based on media coverage, maybe you guessed gun violence, accidents or Covid-19.

However, the top two killers are actually cardiovascular disease and cancer. These two diseases combined account for nearly 50 per cent of deaths in the United States.

Cardiovascular disease and cancer share many parallels in their origins and how they develop. Nanoparticles offer one potential way to effectively treat both with reduced side-effects.

Cardiovascular disease and cancer seem to be quite different on the surface. But newly discovered parallels between the origins and development of these two diseases mean that some treatments may be effective against both.

I am a biomedical engineer who has spent two decades studying and developing ways to improve how drugs travel through the body. It turns out that tiny, engineered nanoparticles that can target specific immune cells may be a way to treat both cancer and cardiovascular

#### Cardiovascular disease and cancer

Atherosclerosis is the most deadly form of cardiovascular disease. It results from inflammation and the buildup of fat, cholesterol and other lipids in the blood vessel wall, forming a plaque.

Lipids are fatty compounds that perform a variety of functions in your body. They are part of your cell membranes and help control what goes in and out of your cells.

Lipids help with moving and storing energy, absorbing vitamins and making hormones. However, having too much of some lipids is harmful.


Most heart attacks are caused by plaque rupture. The body's attempt to heal the wound can form a blood clot that blocks blood vessels and result in a heart attack.

On the other hand, cancer usually arises from genetic mutations that make cells divide uncontrollably. If untreated, rapid cell growth can be destructive because it is difficult to stop without harming healthy organs. Cancer can start from and occur in any organ of the body.

Although cardiovascular disease and cancer appear to have different origins and causes, they share many risk factors. For example, obesity, smoking, chronic stress and certain lifestyle choices like poor diet are linked to both diseases.

Why might these two diseases share similar risk factors? Many of the similarities between cardiovascular disease and cancer can be traced to inflammation.

Chronic inflammation is a primary cause of atherosclerosis by damaging the cells lining the blood vessels and progressively worsening plaques.

Likewise, chronic inflammation can initiate cancer by increasing mutations and support cancer cell survival and spread by increasing the growth of the blood vessels that feed them nutrients and suppressing the body's immune response.

#### Treating two conditions at once

Research hints that therapies designed for cancer can also help treat atherosclerosis. One example is drugs that target immune cells called macrophages in tumours and cause them to eat cancer cells. It turns out that a similar drug can cause macrophages to clear dead and dying cells in atherosclerosis, which shrinks plagues.

Another example is antiglycolytic therapies that prevent the breakdown of glucose. Glucose, or sugar, is the body's main source of energy.

These drugs can make diseased tumour blood vessels and atherosclerotic blood vessels look more "normal", essentially reversing the disease process in those vessels. They can also reduce inflammation in atherosclerosis.

Although currently marketed treatments like statins and fibrates can lower lipid levels and blood clotting in atherosclerosis, these drugs have not sufficiently addressed the risk of death from cardiovascular disease.

To improve outcomes, clinicians are increasingly using multiple drugs directed against different targets. One intriguing class of treatments is sodium glucose cotransporter-2 inhibitors, which are traditionally used to treat diabetes.

Researchers have shown that these drugs both provide significant protection from cardiovascular disease and treat cancer.

Clinical trials on statins and so-

dium glucose cotransporter-2 inhibitors indicate a close overlap between inflammation, metabolism and cardiovascular disease that suggests new treatment opportunities.

One example is immunotherapies that "inhibit the inhibition" of immunity - that is, they take off the brakes that tumours place on the immune system. This approach to treat cancer also reduced atherosclerotic plaques in animal studies and reduced vascular inflammation in a small study in people.

#### A nanomedical Trojan horse

A recent discovery showed that nanotubes - a very small particle made of carbon that is over 10,000 times thinner than a human hair can go into specific immune cells, travel through the bloodstream and enter tumours as a Trojan horse.

These nanotubes can carry anything that researchers put on them, including drugs and imaging contrast agents.

The immune cells carrying the nanotubes naturally home in on tumours through the inflammatory response. Since cancer and atherosclerosis are both inflammatory diseases, my research team and I have been studying whether nanotubeloaded immune cells may also serve as delivery vehicles to plaques.

Nanotubes can be loaded with a therapy that stimulates immune cells to "eat" plaque debris and thus reduce plaque size.

Moreover, restricting drug delivery specifically to those immune cells reduces the risk of off-target side-effects. These nanotubes can also be used to improve diagnosis of cardiovascular disease by highlighting plaques.

Another way nanoparticles can enter tumours is by squeezing through openings in new blood vessels grown in inflammatory condi-

This is known as the enhanced permeation and retention effect, where larger molecules and nanoparticles accumulate in tissues with leaky blood vessels and remain there for some time because of their

Researchers are applying this effect, first discovered in cancer, to improve drug delivery for cardiovascular disease - which can also involve leaky blood vessels.

#### Improving drug development

The molecular pathways which cancer and cardiovascular disease share have important regulatory implications. The costs involved in getting drugs into the clinic are enor-

The possibility of applying the same drug to two different patient populations offers big financial and risk-reduction incentives. It also offers the potential for simultaneous treatment for patients with both dis-

Nanoparticle-based cancer drugs first entered the clinic in 1995, and researchers have developed many others since.

However, there is currently only one cardiovascular nanodrug approved by the US Food and Drug Administration. This suggests opportunity for new nanotherapy approaches to improve cardiovascular drug efficacy and reduce side-

Because of the parallels between cancer and cardiovascular disease, cancer nanodrugs may be strong drug candidates to treat cardiovascular disease - and vice versa.

As basic science discovers other molecular parallels between these diseases, patients will be the beneficiaries of better therapies that can treat both cancer and cardiovascular disease.

### One wishes initiatives by Africa-led IPU will see peace resume in the ME

ONCE again African diplomats and their leaders are grappling with a global devastating issue that is not within the grasp of Africa as a zone or individual diplomats wishing to make notable contribution.

Mid-year saw South African President Cyril Ramaphosa, whose country is active in the BRICS diplomatic alliance, lead a mission to Ukraine and Russia wielding ideas

That was unlikely to tie things up, but some accords were sought on food security for African states as the situation was taxing after supply chains were disrupted, etc.

Another taxing matter is the outbreak of war between Israel and the Palestinian enclave of Gaza, in the wake of a rush into southern Israel of militants usually identified as resistance fighters.

This amounted to lighting a raging fire the world is trying to put it down, with a patchy accord for a humanitarian truce stuck.

National Assembly Speaker Dr Tulia Ackson, in her recently "added" capacity as president of the Inter-Parliamentary Union (IPU), has broken the wall of silence that Africa has observed since the outbreak of war, with exception of measures by South Africa to recall its envoy in Tel Aviv in the wake of the deaths and suffering in the Gaza Strip.

The world is torn between acknowledging Israel's right to defend itself, and thrusting efforts behind United Nations agencies and nearby states that demand major powers to talk Israel into peace

The Speaker's effort arises in the latter context, to add a voice of concern on the matter, even if IPU and indeed any specific legislature, does not wield enough influence to

really get anything done. One wonders what sort of diplomacy can get the two parties to agree about basics, without which it is not easy to find workable peace. In 2018 the Abraham Accords worked elaborately by the then US government prepared the way for Israel to be accepted in the

Middle East as a dignified member. However, there are those who are not satisfied with only enclaves like Gaza and the West Bank ruling themselves.

That is why statesmen and women around the world who keep reminding global public opinion on the need to implement the UN Security Council resolution 242 of June 1967, after the Six-Day War, have to consider talking all con-

cerned into accept peace. IPU is an international organisation of national parliaments, its primary purpose being to promote democratic governance, accountability, and cooperation among its

Its other initiatives include facilitating the development of international law and institutions, strengthening the foundations and enhancing the vision for peace and the common good.

In the circumstances, having its top leader strive to add to international efforts to ensure peace in the Middle East is commendable inter-

### Lack of strong evidence, proper procedure can favour criminals


ODAY, I invite you to briefly look at the ingredients of the offence of rape. The idea is that sometimes a girl or a woman may be raped, but because she doesn't know what rape is and how it has to be proved in court according to the laws of Tanzania, then the perpetrator of rape may be left free for lack of cogent evidence.

This could be very painful to the victim of rape and even to relatives, friends and neighbours who are sure that the victim was raped by the person mentioned. It may also make people lose trust in the administration of justice, thinking that there is no justice.

Yet, the court cannot convict a person of any criminal offence if there is no clear evidence to show that the offence complained of was committed by the person who is suspected of committing it. Mind you, there is a legal maxim which says that:

"Not only must justice be done, it must also be seen to be done." This is the problem many people face. Something bad may happen to a person, but the person himself or herself may not testify to the satisfaction of the court that something bad has happened to him or her and the court cannot do it for that person.

Rape as we have seen in previous articles is committed contrary to section 130 of the Penal Code (R.E. 2022). When a girl or woman is raped there must be evidence to implicate the person accused of rape. Without that even if the person has committed the offence, the person will be let free for lack of evidence.





In the case of Victor Goodluck Munuo (appellant) vs the Republic (respondent), which was an appeal from the decision of the High Court of Tanzania in Moshi, Munuo appealled against the decision of the High Court of Tanzania, which upheld the decision of the District Court of Siha (the trial court).

The appellant was arraigned before the trial court charged with the offence of rape contrary to sections 130(1)&(2)(e) and 131 of the Penal Code (R.E.2002) now R.E. 2022 in 2018. He was accused of raping an 11-year old girl. The trial court found that the accused person was guilty of the offence and he was convicted of it and sentenced to 30 years' imprisonment.

Aggrieved by the trial court judgment, he unsuccessfully appealed to the High Court of Tanzania. The story was that the girl left home for school, but she did not return home as usual. When she was taken to hospital it was discovered that she had been raped because her private parts had bruises and bad smell, suggesting that she had been sexually penetrated. When the alleged perpetrator of rape was arrested and taken to court he denied to have raped

the girl.

Yet, the trial court was satisfied with the evidence which led him to be convicted of the offence and sentenced to 30 years' imprisonment. The accused appealed to the High Court, which also found that he was guilty of the offence of rape and so it upheld the judgment of the trial court.

Aggrieved by the decision, he appealed to the Court of Appeal of Tanzania. The charge showed that the accused was identified by only one name Victor, which in the eyes of the Court of Appeal was not sufficient to identify him. In this way, an identification parade was needed, but was not done. This raised doubt whether the prosecution had properly identified the accused person. The Court of Appeal said that the charge of rape was proved where penetration of a male organ into the female organ was established and the identity of the perpetrator was proved.

The Court of Appeal cited the case of Seleman Makumba vs Republic [2006] which had established that: "True evidence of rape has to come from the victim, if an adult, that there was penetration and no consent, and in case of any other woman

where consent is irrelevant, that there was penetration." The Court said that "in the instant case, where the victim was aged below 18 years at the material time, the issue of consent was irrelevant. What the prosecution ought to have proved is penetration."

Having been established by a medical doctor that the girl had been sexually penetrated, the Court of Appeal asked itself whether the appellant was the perpetrator. It said that it had gone through the evidence, but found that "the appellant was not properly identified as the one who had sexual intercourse with the girl".

The Court of Appeal said that while the victim named his assailant as "Victor", the charge mentioned him as "Victor Goodiuck Munuo" and during his defence, the appellant mentioned his name as "Goodiuck Munuo" and that there was no any eyewitness who came to harmonise these three names. The Court of Appeal said that following the uncertainties regarding the identity of the appellant, the evidence on record was not sufficient to prove his identity.

and taken to court he denied to have raped consent, and in case of any other woman "We, therefore, find that the doubt **gobe@gmail.com** 

favour of the appellant." The Court of Appeal said the prosecution evidence was not sufficient to establish that the appellant was properly identified as the perpetrator of rape. It followed, therefore, that the charge was not proved beyond reasonable doubt against the appellant. Consequently, the Court of Appeal allowed the appeal, quashed the conviction and set aside the sentence imposed on the appellant.

It also ordered him to be released from prison unless he was held for other lawful cause. This case shows that the girl might have known the person who raped her, but since he was not properly identified by the girl herself, court could not have done

that on her behalf. This might have left the girl, parents, relatives, friends and neighbours puzzled. To avoid such disappointment, when a case is brought before any court it must be accompanied by clear evidence to substantiate the commission of the offence. Otherwise, the court won't help anything because what is brought before it must manifestly show the criminal offence was truly committed.

### COP28: It's time to think of farmers hit hard by climate change impact

LIMATE change's pressing urgency and its profound impact on both human and environment is irrefutable. Food and agriculture sector, major contributors to global greenhouse gas emissions, stands at the heart of this global challenge. These emissions, largely from industrial agricultural practices, are unsustainable and drive biodiversity loss at an alarming rate.

Historically overlooked in climate talks, food systems are finally gaining the attention they merit, as evidenced at the recent COP27 summit. There is an emerging consensus: transforming food systems is indispensable to effective climate action.

The world is tackling climate change on how to address it. And the world needs solutions to climate change which address the problem without further harming the ecosystem or destroying the livelihoods of people's lives and that solution is agro-ecology.

According to the UN Food and Agriculture Organization (FAO), climate change threatens the ability to ensure global food security, eradicate poverty and achieve sustainable development. In 2016, SOME 32 percent of global emissions originated from human activity came from agri-food

systems including deforestation, livestock production, soil and nutrient management, and food loss and waste. Also, the increasing concentration of greenhouse gases is trapping more heat in the atmosphere which causes global warming.

Climate change has both direct and indirect impacts on agri-food systems due to the shifting and unpredictable rainfall patterns and temperatures, a higher incidence of extreme weather events and disasters such as drought, floods, outbreaks of pests and disease As well as ocean acidification.

As the world gathers for COP28 2023 in the United Arab Emirates from November 30 2023 to December 12 this year for United Nations Framework Convention for Climate Change (UNFCC), climate change remains a challenge to many countries especially farmers in rural areas who depend entirely on agriculture for food and earn income to survive. Tanzania, where performance of the agriculture sector, which has historically been the backbone of economy, is projected to drop as a result of negative effects of ongoing global climate change.

The country's main economic activity is agriculture, a fragile climate change activity that employs about 80 percent of the total population. Like many other Less Developed Countries (LCD's), Tanzania's economy is more vulnerable to climate change adverse impact due to its dependency on climate change sensitive activity (agriculture).

Despite climate change being one of the threats for agriculture in Tanzania, yet a solid solution for it seems to have not been realized as most farmers in rural areas are struggling for food and money to sustain their livelihoods. This is because climate change poses significant risks of prolonged drought and unpredictable weather, threatening the livelihoods of subsistence farmers in Tanzania.

Ameer Emiru, 28 years old small-scale farmer, husband and a father of one child at Mvuha ward in Morogoro District says the weather is increasingly unpredictable and very challenging to farmers around the area.

Emiru grows various crops such as cassava and sunflower, but he decided to try paddy (rice) for his household consumption, as well as earning a living, but things turned-out to be unpredictable.

With his single acre rice farm, Emiru expected to reap a minimum of 16 sacks of rice, but managed only six sacks due to the long draught as well as long periods of rain which caused the huge loss for his entire family.

"This year has been bad for farmers, but it's worse on my side as I did not expect what I have earned. From what I invested, I expected to earn a lot but things turned out to be negative" he said.

Emiru said that unexpected long scorching sun and rains stopped quickly, something which confused many



farmers in his area. By the time they were preparing to plant seeds, they were assured and duly advised by extension officers but things didn't go as planned.

"This is something not normal. They (extension officers) assured us that at the end of the season, we would harvest a maximum of eight sacks of rice per half an acre but that didn't happen." said Emiru, adding that they followed all procedures before preparing a farm.

He added that last year it was announced by authorities that rain seasons would start in September, but they had to wait until October and November in some areas.

For him, he claimed that it was something unusual because after a short period of rain, then they stopped and sun started where by those farmers who planted rice, yield were burnt due to drought caused by too much sunshine.

"Drought caused by climate change has affected us a lot. Imagine a small-scale farmer who depends only on agriculture and loses a lot. This issue should be addressed at national or continental level to help farmers like me."

Emiru suggests that apart from awareness on weather forecasts, the government should look for the best solutions for climate change impact and best agricultural practices which will be a solution for small scale farmers in Tanzania so that they can earn food for home use and grow their economy.

Dorothea Laiser, is a 35-years-old small scale farmer and mother of three who grows vegetables especially green papers, broccoli and cauliflower in Arusha Region. She said that for vegetable farmers, climate change impact is the worst threat because of the perishable nature of the crops they produce.

Like Emiru, she depends on agriculture only to earn a living and pay for her children's school fees and other necessities. She explained that vegetable farming needs water from the scratch so that yields can come out fresh but climate change effects like drought and floods can cause harm to produce.

"You can lose your life saving capital just in a blink of an eye due to climate change impact. We need collective efforts to find a lasting solution for this challenge" she said.

Laiser has a little knowledge on agro-ecology and that can be one of the solutions for climate change and food security. She added that agroecology may provide a light in solving different agriculture challenges occasioned by climate

According to her, agro-ecology is viable for small-scale farmers and suggested that the government can invest more in conducting research, advocacy and come up with a solution so that many people can practise agro-ecology in Tanzania.

"More research to improve effectiveness of agro-ecology and technology to expand it can be practised in intervals and larger scale so that farmers can reach their targets and harvest surplus crops for cash," she said.

Various agriculture organizations in Tanzania have been advocating for agro-ecology as one of the best ways to address climate change impact by fostering biodiversity through agro-ecological principles, building on best practices, and creating an enabling environment.

zations in Tanzania advocating for agroecology as the possible solution for climate change impact because it makes communities resilient to unpredictable rainfall among others.

Hassan Tema, Information Technology

and Communications Coordinator at ActionAid Tanzania, said that the real meaning of agro-ecology is the cheapest means of earning food at the family level and how that warrants food security as well as climate change impact mitigation.

Tema said that conventional farming deprives the poorest nations of financial resources through expensive fertilizers, seeds and pesticides which in turn give farming outputs which still compromise health and hence medical costs.

"As the world's climate change organs assemble for COP28, and since we are in the midst of climate change challenges, agroecology should be addressed as the best and easiest possible way for food security," he said.

Sustainable Agriculture in Tanzania (SAT) has been at the forefront in community sensitization on how the power of agro-ecology has transformed Tanzania's agriculture sector.

Through innovative approach, SAT has emerged as a key player in promoting sustainable farming practices. SAT believes that agro-ecology is a holistic and sustainable approach that integrates ecological principles and social dynamics in farming systems, also its potential to enhance productivity, livelihoods and protect the environment.

Janet Maro, SAT chief executive officer said that planting trees is one strategy to tackle challenges brought about by climate change. She argued that agro-ecology and climate change are related issues because communities diversify their farming systems by applying agrological approaches in soil fertility management, water management and soil erosion control.

"These practices use resources more efficiently, allowing nutrients and biomass to circulate within the system and they are less dependent on seasonal external inputs. Recovery of forest cover and the structure and health of the soil allows more water to be available and stored," she said.

### This dedicated doctor helps women ward off cervical cancer

HILE working as a doctor in the initial months of his medical career in southern India, a telephone call from his home in the Ladakh Himalayas convinced Nordan Otzer to involve himself with cervical cancer awareness.

"While I was working in a hospital in rural Tamil Nadu (in 2007), one day I received a distressing call from my family informing me that my mother's health had deteriorated and she urgently needed my presence back home," says Otzer, an ENT surgeon who is now in his mid-40s and works as a medical practitioner and social worker in Ladakh, a cold desert in the Himalayan Pla-

"When I saw my mother lying on the bed, she was hardly recognizable. It was only at that point that she disclosed to me that she had been experiencing persistent spotting and occasional abdominal pain that had worsened over time," Otzer tells IPS. "Unfortunately, she only sought medical assistance when her pain (because of cervical cancer) became intolerable."

According to the WHO, a large majority of cervical cancers (more than 95%) are caused by human papillomavirus (HPV), which is the most common viral infection of the reproductive tract.

"Although most HPV infections clear up on their own and most pre-cancerous lesions resolve spontaneously, there is a risk for all women that HPV infection may become chronic and pre-cancerous lesions progress to invasive cervical cancer," reads a segment of a fact sheet about cervical cancer on the WHO website.

"When screening detects an HPV infection or precancerous lesions, these can easily be treated, and cancer can be avoided. Screening can also detect cancer at an early stage where treatment has a high potential for cure," the WHO fact sheet says and urges the countries that screening (of women for HPV infection) "should start from 30 years of age in the general population of women, with regular screening with a validated HPV test every 5 to 10 years, and from 25 years of age for women living with HIV."

Cervical cancer is the fourth most common cancer among women globally, with 90 percent of an estimated 604,000 new cases and deaths worldwide in 2020 occurring in low- and middle-income countries, according to the WHO.

Otzer says his mother was flown to the All India Institute of Medical Sciences (AIIMS) in New Delhi for treatment, but her condition deteriorated, and she succumbed to the disease within days.

"Throughout the journey from my home to Delhi, she held my hand, perhaps also hoping that her doctor son would save her life. But unfortunately, I couldn't do anything except watch helplessly while she slowly faded away," Otzer recalls ruefully.

As someone who has studied medical sciences, says Otzer, "I knew my mother's life could have been saved if she was aware of cervical cancer and its preventable

"My mother's death due to cancer altered the course of my career, leading me to make the choice to remain and contribute to my own community." Since those days, Otzer says that he started making efforts to launch an awareness campaign about cervical cancer and screening of women for HPV infection in Ladakh, a remote mountainous region more than 14.000 feet above sea level in the Tibetan Plateau, which remains cut off from the rest of the world in winters.

Since 2009, Otzer, with the help of his local supporter, Stanzin Dawa, and visiting doctors from Singapore led by Swee Chong Quek, has organized over 140 awareness and screening events for women across Ladakh, where villages are spread out across the terrain and not easily

"We have conducted screenings for 12.400 women thus far, among whom one out of every 10 women has precancerous lesions. This implies that without timely treatment, these lesions could progress into full-blown cancer," Otzer says.

Besides the logistical challenges, such as travelling long distances and traversing tough terrain, other challenges, according to Otzer, included women being too shy and reti-

be reticent about discussing women's health matters openly, not even with their own family members. Therefore, when I initially launched a cervical cancer screening program, there was a noticeable reluctance among them to undergo checkups," he says, adding that initially, women would avoid making eye contact and refrain from asking any questions.

"However, with the passage of time, they gradually became more receptive and started attending our screening camps for examinations."

Cervical cancer awareness and India

In India, cervical cancer is the second most common cancer in women, and India contributes the largest proportion of the global cervical cancer burden. In December last "Women in Ladakh tend to year, the federal government in India urged the state governments to create awareness and take steps to prevent cervical cancer.

According to an article published by Lancet in March 2023, the Indian Ministry of Health and Family Welfare plans to vaccinate 68 million girls across India against human papillomavirus (HPV) by the end of 2025, which will be followed by vaccination of a further 11,2 million girls aged 9 years and older each year.

Cervical cancer accounted for 9.4 percent of all cancers

new cases in 2020 in India, says this December 2021 Springer study, adding that cervical cancer is still among the most common cancers in India and a leading cause of cancer-related

middle-income countries.

According to the Springer study, cervical cancer is the second leading cause of cancer deaths for females in 12 Indian states. "The situation is more alarming in rural areas where the majority of women are illiterate and ignorant about the hazards of cervical cancer and healthcare resources are

Research has established that awareness and the availability of medical infrastructure play a significant role in preventing cervical cancer. Results of a study published in the Asian

and 18.3 percent (123,907) of Pacific Journal of Cancer Prevention have confirmed that stages (of cervical cancer) "are strongly correlated with survival outcome, and early stages of the disease are associated with an exceptionally favourable deaths in women in low- and prognosis provided they are adequately treated, whereas survival for stage III and IV can-

> cers was dismally low." A study published by Lancet in October 2023 found heterogeneity in cervical cancer survival across India, with higher survival rates in urban areas where healthcare facilities are much better than predominantly rural and mountainous north and northeastern regions.

"The disparity in survival between the populations could explain the overall effectiveness of the health care system. This informs policymakers to identify and address inequities in the health care system," the study says, emphasizing the "importance of promoting awareness, early detection, and improving the health care system."

### Climate crisis is a 'substantial risk' in fight against malaria, says WHO

THE climate crisis poses a major threat to the fight against malaria, according to the World Health Organization (WHO), with evidence suggesting extreme weather events and rising temperatures have already led to spikes in cases.

Mosquitoes, the carriers of the disease, thrive in warm, damp and humid conditions, which are increasing with global heating.

"The changing climate poses a substantial risk to progress against malaria, particularly in vulnerable regions," said the WHO director general Dr Tedros Adhanom Ghebreyesus. "Sustainable and resilient malaria responses are needed now more than ever, coupled with urgent actions to slow the pace of global warming and reduce its ef-

Although data on the long-term impact of the climate crisis is scarce, the WHO's world malaria report, published on Thursday, said rising temperatures have contributed to malaria transmission in African highland areas that were previously free of the disease. This is the first time the annual report has had an entire chapter dedicated to the climate crisis and its links to malaria.

It said Pakistan saw a five-fold increase in cases after severe flooding last year - from 500,000 reported cases in 2021 to 2.6 million in 2022. Standing water became an ideal breeding ground for mosquitoes.

Peter Sands, the executive director of the Global Fund to Fight Aids, Tuberculosis and Malaria,

said: "I would put climate change right up there as the thing that is changing the game on malaria in ways that we can see happening, but we don't know fully the magnitude and how it's going to un-

Sands added that other factors related to the climate crisis - including displacement, the de-

malaria report is conservative," he said. "We could well be seeing more dramatic consequences, partly because of the second and third-order things.

Dr Photini Sinnis, the deputy director of the malaria institute at the Johns Hopkins Bloomberg School of public health, said the climate crisis "is going to have an impact", but that it would be hard

### Loss and damage fund approved at UN's COP28 climate summit in Dubai

**DUBAI** 

UNITED Arab Emirates (UAE)'s Sultan Al Jaber has called for 'proactively engagement' of fossil fuel companies as part of the solution to climate challenges.

The United Nation's annual climate summit is under way in Dubai, with world leaders approving a climate disaster fund that will help vulnerable nations cope with the impact of drought, floods and rising seawater.

The agreement marked a "positive signal of momentum" at the start of the 2023 conference - known as COP28 - its host UAE's Sultan al-Jaber said in the opening ceremony on Thursday.

Al-Jaber, who is the UAE's minister of industry and also heads the national oil company, is chairing the summit for its 28th meeting. His leading role has drawn backlash from critics who believe his oil ties should disqualify him from the climate

In opening remarks, al-Jaber made the case that the world must "proactively engage" fossil fuel companies in phasing out emissions, pointing to progress by some national oil companies in adopting net-zero targets for

"I am grateful that they have stepped up to join this gamechanging journey," al-Jaber said in opening remarks. "But, I must say, it is not enough, and I know that they can do much

The UN's climate chief, Simon Stiell, gave a more stark assessment, saying there must be a "terminal decline" to the fossil fuel era if we want to stop "our own terminal decline".

With more than 70,000 attendees, the two-week-long affair is billed as the largest-ever

climate gathering.

Among tts expected attendees are dozens of world leaders, including the heads of state of France, Japan, the UK, Egypt, Saudi Arabia, Qatar, Jordan, and Brazil. Also represented are crowds of activists, lobbvists, and business leaders, including billionaire Bill Gates.

However, the presidents of the world's two biggest polluters – the US and China – are not attending. The summit comes at a pivotal time, with global emissions still climbing and 2023 projected to be the hottest year on record. Scientists warn the world must commit to accelerating climate action or risk the worst impacts of a warming planet.

UN Secretary-General An-

tonio Guterres said leaders should aim for a complete "phase-out" of fossil fuels, a proposal opposed by some powerful nations that has dogged past negotiations.

On Thursday, nations formally approved the launch of a "loss and damage" fund to compensate climate-vulnerable countries after a year of hardfought negotiations over how it would work.

Later in the summit attendees are due to review and calibrate the implementation of the United Nations Framework Convention on Climate Change's (UN-FCC's) terms, Paris Agreement, and Kyoto Protocol, a binding treaty agreed in 1997 for industrialised nations to reduce greenhouse gas emissions. This

year, UNFCC members will also face their first Global Stocktake (GST) - a scorecard analysing countries' progress towards the Paris Agreement - so they can adapt their next climate action plans which are due in 2025.

At the same time, host UAE aims to marshal an agreement on the tripling of renewable energy and doubling the annual rate of energy efficiency improvements by 2030.

Rallying a common position on these points will be challenging, as COP requires all nations - whether dependent on oil, sinking beneath rising seas or locked in geopolitical rivalry - to act unanimously.

The UAE sees itself as a bridge between the rich developed nations most responsible for

historic emissions and the rest of the world, which has contributed less to global warming but suffers its worst consequences. But the decision for it to host

has attracted a firestorm of criticism, particularly as the man appointed to steer the talks, al-Jaber, is also head of UAE state oil giant ADNOC. Al-Jaber, who also chairs a

clean energy company, has defended his record, and strenuously denied this week that he used the COP presidency to pursue new fossil fuel deals after allegations reported by the

On Thursday, al-Jaber said the "role of fossil fuels" must be considered in any deal at the climate talks, saying "it is essential that no issue is left off the table."

### South Africa absolutely cannot afford proposed cuts to HIV funding

N November this year, National Treasury proposed a R1-billion cut to HIV funding. This has come about because - rather than seeing the reduced price of antiretroviral treatment as an opportunity to scale up treatment coverage and strengthen other interventions to address the HIV epidemic – the Department of Health has seen it as an opportunity for cost-containment.

However, savings made by any cost reduction on HIV treatment should not simply be returned to Treasury. Such savings provide an opportunity to put in place additional programmes and measures to both prevent and treat HIV to allow more people with HIV to live fuller lives and overcome this epidemic.

This cut is being proposed at the same time as an additional 11.5% cut to the already underfunded HIV/Aids (Life Skills Education) Grant, which is supposed to support the government's HIV prevention strategy through providing learners with comprehensive sex education and access to sexual and reproductive health services. In other words, cuts are being proposed to both the treatment and prevention of HIV, without any evidence that the government has considered or evaluated the effect this will have on the constitutional rights, health, or lives of those affected, particularly womxn and vulnerable groups.

#### **Funding South Africa's response to HIV**

South Africa's HIV response has come a long way from the shameful years of denialism and stigma that resulted in hundreds of thousands of preventable deaths due to delays in making life-saving treatment available. Financing interventions to increase testing, curb infection and scale-up treatment has translated into life expectancy improving by nine years from its low point in the early 2000s and pronounced reductions in infant and child mortality

In 2004 government very slowly started rolling out treatment at public health facilities – the pace only really picked up from around 2008. Today over 5.7 million of the 7.8 million people living with HIV in the country are benefitting from treatment. These efforts have also resulted in reduced infection rates – at 164,000 in 2022 from just over half a million new infections in 2004.

However, South Africa still accounts for 20% of new HIV infections globally, and our rate of new infections has not been decreasing swiftly enough in recent years to meet the government's own targets. While the response to the HIV epidemic has improved, the epidemic has still not

District Health Programmes Grant which enables provinces to provide HIV testing, the treatment programme, condom distribution, post-exposure prophylaxis (PEP), prevention of mother-to-child transmission, and HIV counselling as well as other interventions.

A UNAids report credits HIV funding for saving millions of lives as well as strengthening the public health systems of affected countries, including our own. However, UNAids notes that increased investment Our HIV response is largely funded by the ring-fenced is still needed to end the HIV epidemic. Under a fully-funded HIV re-

sponse, South Africa would be able to reduce new infections by 65% by 2030, meaning an additional 1,35 million new HIV infections could be prevented.

Treasury's proposal in the recent Medium Term Budget Policy Statement (MTBPS) to cut R1-billion from the HIV component of the District Health Programmes Grant translates to a 4% cut from the Main Budget's R23.9-billion to R22.9-billion for the 2023/24 financial year. This is not the first budget cut to HIV funding this year; a 0.4% cut was already made towards this grant in February.

#### The wider context

This budget cut comes in the context of potential reduced external funding from our developmental partners for our HIV response and is occurring despite notable struggles to get enough people living with HIV on treatment. The cut also occurs in the context of other massive reductions to healthcare that further constrain resources available to effectively address HIV through the public health system. For example, funding for healthcare infrastructure has been cut by R440-million (a 5.2% nominal cut from R8.54-billion to R8.10-billion) in spite of infrastructure backlogs (quantified at R200-billion). As the foundation for quality healthcare, health infrastructure is a prerequisite for effective delivery of HIV care.

Additionally, HIV funding cuts are not restricted to the public healthcare system. The budget for the HIV/ Aids Life Skills Grant, which is used to provide sexual education (particularly on HIV), also has a proposed cut. This most recent proposal forms part of a trend of dramatic slashes to the grant since 2020.

Considering the demonstrable impact that exposure to comprehensive sexual education has on reducing HIV infection risk, coupled with the concerns of the re-emergence of HIV misinformation that threatens HIV prevention efforts and entrench stigma, further cutting the grant threatens the hard-won gains we have made and can make toward overcoming this epidemic. The situation is particularly concerning in light of low condom use amongst people aged 15 to 24.

The gendered impacts of budget

Though these budget cuts impact the health system's ability to provide quality HIV care to all of the estimated 7.8 million people living with HIV, unequal gender relations have resulted in young womxn in the country - particularly those in rural and underserved communities – bearing the greatest HIV burden. Indeed, even at the current funding level, according to the government, 1,300 womxn between the ages of 15 and 24 are newly infected with HIV every week.

Socio-economic factors such as brutal cycles of poverty and sexual abuse worsen this risk. Gender inequality has been found to increase infection rates while also weakening the ability of womxn to cope with HIV. This inequality further worsens the barriers young womxn face to negotiate safe sex. The cuts to HIV education in schools wholly undermine efforts to strengthen the prevention of HIV infection of womxn and girls, further aggravating their vulnerability. The prevalence of sexual violence also exacerbates the risk of HIV transmission.

A well-resourced HIV response is a powerful intervention to protect the most vulnerable womxn and girls in the country. Without considered regard for the gender implications of these proposed budget cuts, our government risks entrenching and worsening the strife that many womxn in this country face.

#### What to do


These budget cuts are attributed to fiscal consolidation and cost containment that has, according to the Minister of Health, been made possible by the reduced price of antiretrovirals.

However, any cost savings achieved in funding HIV interventions need to be redirected towards strengthening our health system's ability to scale-up HIV treatment coverage and other HIV interventions, which are clearly set out in the National Strategic Plan on HIV, TB and STIs 2023-2028.


Investment could be made in robust health information systems, improved treatment literacy, and providing comprehensive support to people on HIV treatment to help more people start and stay on treatment.

Moreover, researchers from the University of the Witwatersrand have proposed extending support to target medication-related issues, psychosocial support and socioeconomic support as a powerful intervention to strengthen retention on treatment. These interventions require adequate financial support and the government's savings made, owing to the reduced price of antiretrovirals could be redirected to these efforts.


Against the backdrop of South Africa's disastrous initial response to the HIV epidemic, deprioritising HIV funding at this point in time is not a price we can afford to pay.

### **Cement firm mulling** paying dividend from Sh12bn Uganda deal

Bamburi Cement has signaled that it expects to pay its shareholders a special dividend from the sale of its 70 percent stake in its Uganda subsidiary Hima Cement for \$84 million (Sh12.86 billion), backing investor expectations of a payout that has spurred its shares to a gain of 55 percent in the last two

The Nairobi Securities Exchange (NSE)- listed cement maker told shareholders in a circular that the proceeds of the sale could either be reinvested in the Kenyan unit or distributed to its owners, subject to capital allocation plans by its board and management.

Bamburi announced on November 15 that it would team up with its sister company Cementia Holding AG to sell their entire ownership in Hima Cement to a consortium of Sarrai Group and Rwimi Holdings for \$120 million (Sh18.4 billion). From the proceeds, Bamburi is entitled to a 70 percent share, while Cementia will bank 30 percent.

The deal is part of a strategy by Bamburi's parent firm Holcim to divest from fragmented markets and concentrate in countries where it is among the biggest players.

"The proceeds received from this transaction... (provide) ability for Bamburi to pay a special dividend to its shareholders, subject to Bamburi's dividend strategy and receipt of relevant approvals," said the company in the circular.

"Historically, there has been a limited dividend distribution record from Hima (the last two dividend distributions were in 2023 and 2016), and this transaction presents an opportunity for Bamburi to get a distribution from

Companies sometimes pay special dividends from the proceeds of the sale of major assets or subsidiaries.

Recently, Jubilee Holdings paid two special dividends following the sale of majority stakes in its general insurance businesses to Allianz SE, while WPP Scangroup also paid a special dividend

of Sh8 per share after the sale of its subsidiary Kantar Africa.

Anticipation of such dividends tends to boost the share price of the concerned company.

For Bamburi, the share price has gone up by 55.6 percent to Sh35 a unit since the announcement of the deal on November 15, having traded at Sh22.50 on the day before the disclosure.

The market capitalisation of the company has thus gone up by Sh4.54 billion to Sh12.7 billion in the period. The traded volumes on the counter have also risen significantly since the deal was announced.

On average, the volume of shares traded per session has stood at 188,863 since November 15, compared to an average of 53,042 per session in the two months leading up to the disclosure

The total volume of shares traded in the last two weeks stands at 2.08 million, which is more than the 1.86 million units traded in the previous two

In April it was reported that Bamburi Cement net profit for the year ended December 2022 had dropped by 86.9 percent to Sh181 million on the back of reduced sales and increased costs.

The Nairobi Securities Exchange-listed firm's net earnings retreated from Sh1.38 billion posted in the previous year as sales dropped by six percent to Sh38.99 billion.

Total operating costs stood at Sh38 billion from Sh39.2 billion, nearly matching the sales for the period.

Bamburi said the slowdown in economic growth cut cement sales while the heightened inflationary pressures increased power, fuel, transport and raw materials costs.

"The soaring inflation impacted building materials cost, thereby adversely impacting cement demand. The conflict in Eastern Europe impacted global supply chains, consequently leading to significant increase in sea freight and cost of raw materials," said the firm.

# Grants by TASAF transforming lives, but pace raising concerns

he Tanzania Social Action Fund during the third quarter of financial year 2022/23 reached only 467 beneficiary households through the livelihood productive grants (LPG) of the targeted 50,000 households intended to be reached with the grants in the whole financial year that ended on June 30,

According to the third quarter implementation progress report of the Fund's second productive social safety net (PSSN II) program, TASAF had set a target of reaching 25,000 beneficiary household through LPG from the old eight project area of authorities (PAAs) and another 25,000 beneficiary households from the impact evaluation project area of authorities (IE-PAAs).

"The programme also targeted at reaching three new PAAs. Beneficiaries have continued to receive mentorship and coaching as well as training to ensure that the grants are used according to their business plans," reads part of the report.

According to the report, one of the major challenges that face the program implementation is beneficiaries' fear of being left out from the program and the fear of what life will be like after they have been exited from the program.

The report states that beneficiaries' fears lead some households to provide incorrect information about their improvements in terms of TASAF selected welfare indicators.

"Mitigation measures conducting continuous awareness sessions on the need for beneficiaries to engage in productive activities that will increase their income even after their departure from the programme," states the report.

During the third quarter under review (January to March 2023), the report states that financiers have committed a total amount equivalent to \$678,402,654.32 (1.706trillion/-) for PSSN II activities out of the program total budget of \$883,310,000 (2.222trillion/-) ing a financing gap of \$204,907,345.68 (516.10bil-

financing gap The has been reduced by \$6,130,000 (15.414billion/-) after receiving a new commitment from the British Embassy (FCDO). Out of the committed amount, \$486,963,394.59 (1.225trillion/-) was absorbed by the end of the reporting period.

The report clarifies that

the overall rate of absorption as of 31st March, 2023 stood at 71.78 percent.

It adds that the total amount received for PSSN II rolling-out activities was equivalent to \$31,132,223.76 (78.218billion/-).

The amounts were received from the government was \$216,315.37 (544.25million/-), UN Agencies UNICEF in particular \$119,737.05 (301.33million/-), OFID \$3,082,011.26 (7.756billion/-) and the World Bank \$27,714,160.08 (69.504billion/-).

"A total amount of 85,807,382,067.84/- was spent during this period under review to finance various program activities.

The amount makes the cumulative annual program spending of 361,854,966,211.22/the cumulative program spending of 1,043,444,650,061.17/- up to the 31st March, 2023," reads the report.

The report states that formation of savings groups was conducted in 13 PAAs under Tanzania Poverty Reduction Proby the Fund have been ject (TPRP IV) in order to enhance livelihoods and increase incomes through community savings. A total of 3,867 savings groups were formed in the 13 PAAs of Njombe and Arusha regions.

On September 6, 2023, The Guardian published a special report that explained in detail how TASAF program has failed to end rural poverty 23 years after the inception of its implementation in the

year 2000. This is the case when only two years have remained until the accomplishment of the implementation of the National Development Vision 2025 that targets at reducing abject poverty.

The vision 2025 aims at achieving a high quality livelihood for the people by developing a strong competitive economy among other targets.

A quality livelihood for all Tanzanians is expected to be attained through strategies which ensure the realization of several

goals that includes: Food self-sufficiency

and security; achieving gender equality, the empowerment of women in all socio-economic and political relations and culture and absence of abject poverty.

A strong and competitive economy as per the development vision is designed to be realized through a number of initiatives that are characterized into: macroeconomic stability manifested by a low inflation economy and basic macroeconomic balances.

To achieve an economy growth rate of eight percent per annum or more, to make Tanzania become an active and competitive player in the regional and world markets, with the capacity to articulate and promote national interests and to adjust quickly to regional and global market shifts.

As for economic growth, the Economic Bulletin for the quarter ending September 2023 by the Bank of Tanzania (BoT), states that inflation remained within the country target and regional benchmarks.

The bulletin considers food price variations on the local market as a key tool in defining inflation versus the purchasing power of basic needs by people among other indicators as it is also stated in the National Development Vision 2025.

In that regard, the bulletin states that during the quarter under review, headline inflation averaged 3.3 percent, a decline from 4.6 percent recorded in the corresponding quarter in 2022.

The slowdown in inflation was mainly driven by moderation in prices of food and energy items.

However, the bulletin shows that there was a slight increase in average wholesale prices of major food crops. For instance, a 100 kilogram bag of maize was sold at 97,949/- in September 2023 up from 90,785/- in September 2022 an increase of 7.9 per-

in September 2023 up from 216,071/- in September 2022. The increase is equivalent to 16.9 percent. A 100 kilogram bag of beans was sold at 261,255/-

A 100 kilogram bag of

rice was sold at 252,589/-

up from 210,417/- of the two corresponding periods, an increase of 24.2 percent. Samson Otieno (38) Kimara resident in Dar es Salaam told the reporter that he now pays 3,300/- for a kilogram of rice up from

2,200/- he paid in Novem-

ber 2022. To him, food self-

sufficiency and security is still a challenge. "Purchasing power depends on personal earnings. For me 3,300/- per kilogram of rice is too expensive in relation to what

I earn on a daily basis; But I do believe that people with huge incomes don't even feel the same pinch as low-income earners do," said Otieno who works as a butcher.

Presenting TASAF programme implementation report for 2022 in Dodoma on Thursday, George Simbachawene, the Public Service Management and Good Governance state minister in the President's Office, said daily spending by most of the beneficiaries is still below the poverty line benchmark.

He said the poverty alleviation programme report shows that average daily spending for targeted households in 2022 stood at 1.149/-, well below the poverty line of 1,859/- for the Mainland Tanzania.

According to him, the findings shows the average spending for a single household per month was 152,621/- in which food took the most share with 113,256/- equivalent to 74.2percent of household spending.

"The monthly spending for targeted households is down compared to monthly household spending in the mainland," he affirmed, noting that most households spend the money given to them through the programme on food instead of investing in income generating activities.

The government will now focus on offering education so that the money given to them is invested in income generating activities, he said, pointing out that 50-percent of the targeted families are involved in farming, 22 percent in paid activity and 15 percent are self-employed.

Upwards of 57 percent of food consumed in beneficiary households is home-grown or given as gifts from relatives while 43 percent of the food is purchased, he said.

"With these results, I would like to encourage the beneficiaries of the TASAF programme to ensure that they produce food by using opportunities provided by the government or other stakeholders where they live," he appealed.

But the minister of state planning and investment, Prof Kitila Mkumbo said that a research report on the analysis of the implementation of the National Development Vision 2025 has outlined achievements realized so far towards poverty alleviation and suggests the areas of improvement on the way forward.

According to him, the research report to be launched by President Samia Suluhu Hassan on this year's independence day states that since the Vision's commencement in 2000, gross domestic product -GDP per capita income of an individual have grown to \$1,200 an equivalent of 2,880,000/in 2022 up from \$399.5 an equivalent of 322,597/- recorded in the year 2000.

"Tanzania has also achieved 124 percent in food security compared to the target goal of 140 percent by 2025. The achievement complements the government's capability in fighting hunger across the 184 country's district councils," said Prof Mkumbo.

Article 8-(1) (b) of the Constitution of the United Republic of Tanzania 1977 states that 'the primary objective of the government shall be setting economic policies that contribute to harmonizing and easing the welfare of the people;

Section {c} of the same article states that: 'the government shall be accountable to the people; while section (d) reads: 'the people shall participate in the affairs of their government in accordance with the provision of this Constitution.'

In spite of these constitutional commitments by the government on people's welfare, things are opposite on the ground as the government has failed to alleviate rural poverty through different programs including TASAF.

will contribute to changing the lives for better.

Mafuru said that the nation's economy is booming but only a small number of people are seeing the fruits of progress in reality, hence the government's drive to invest in sectors that inclusive enough to allow everyone to be part of the value chain hence attaining an inclusive growth which is strides are made to have plans that reflect the present reality.

### Highlights in Rwanda central bank report

KIGALI

he financial year 2022/2023 was characterised by an increase in prices of services and goods, particularly foodstuff and fuel, which contributed to an increase in import bills and the cost of living, overall, according to the National Bank of Rwanda (NBR)'s annual report.

The 2022/2023 central bank report was presented by NBR Governor John Rwangombwa to a joint session of Parliament, on November 27.

Here are six key highlights from

the report:

#### A rise in inflation

According to the report, in the financial year 2022/2023, NBR conducted its monetary policy in a challenging environment characterised by inflationary pressures rising from both global and domestic shocks.

These include the Russia-Ukraine war that led to disruptions in global supply chains, aggravating the already increasing international commodity prices due to the mismatch between demand and supply during the post-Covid-19 period.

Additionally, Rwanda, like most East African Community (EAC) member countries, faced domestic weather shocks that negatively impacted the performance of agriculture and led to an increase in food prices.

On average, headline inflation (total inflation in the economy) increased from 4.6 per cent in 2021/22 to 18.2 per cent in 2022/23. Specifically, fresh food inflation soared from 1.5 per cent to 41.8 per cent, while energy inflation increased to 14.7 per cent from the previous year's 9.2 per cent.

Rwangombwa said higher food prices were among the main drivers of inflation, and poor agricultural yields caused by climate change (mainly drought) were the cause.

MPs proposed that greater effort should be put into increasing farm output, such as through resilience to climate change by means including irrigation, and supporting farmers to get the required finance, including loans.

The main risks to the inflation outlook remain, such as weather-related challenges, geopolitical tensions, and reduced oil supply by the Organization of the Petroleum Exporting Countries (OPEC) and Saudi Arabia.

The publication indicated that NBR is committed to continuing to monitor global and domestic economic developments and stands ready to take appropriate actions to keep inflation low and stable.

Trade deficit widened as a result of higher import bill

Though exports grew by 29.8 per cent to more than \$2.4 billion (approx. Rwf3 trillion) from more than \$1.8 billion in the previous financial year, trade imbalance widened as

import bill outweighed export earnings

During the same period, imports grew by 28.0 per cent, to more than \$5.1 billion (approx. Rwf6.3 trillion) from \$3.9 billion. As a result, the trade deficit expanded by 29.7 per cent to over \$2.2 million from more than \$1.7 billion, which put pressure on the Rwandan Franc.

In 2022/23, the Rwandan Franc depreciated significantly by 8.76 per cent against the US Dollar, a significant decline compared to the 3.78 per cent in 2021/22.

"This depreciation can be explained by the widening trade deficit, but also by the strengthening of the dollar following the US Federal Reserve's monetary policy tightening," the report reads in part.

Financial sector recorded 18.3 per cent growth

Amidst challenging global and domestic economic conditions, the financial sector continued to perform well, with the total assets growing by 18.3 per cent to more than Rwf9.6 trillion from Rwf8.1 trillion as of June 2022.

Banking - the largest financial subsector - grew by 18.1 per cent, driven by retained earnings and growth in deposits. The pension sector, both public and private, increased by 16.2 percent, due to rising pension contributions and investment income.

Similarly, the microfinance sector experienced a 26.5 per cent asset growth, on the back of increased deposits and capital.

Meanwhile, the insurance sector's

assets expanded by 17.2 per cent, powered by retained earnings and capital injections.

Loans from financial institutions increased despite monetary policy tightening

As per the report, NBR tightened its monetary policy to curb inflationary pressures, including increasing the Central Bank Rate (CBR) - the interest rate at which the central bank lends money to other banks in the country - from 5 per cent in June 2022 to 7 per cent in June 2023.

Despite monetary policy tightening, the report exposed that new Authorized Loans (NALs) experienced significant growth of 37.2 per cent in 2022/23, compared to a decline of 1 per cent in the previous fiscal year, reaching more than Rwfl.6 trillion. This was attributed to the good performance of the economy, it pointed out.

The sectors with a big share in the total loans were commerce (10.6 per cent), services (9.2 per cent), public works and buildings (6.4 per cent), personal loans (5.9 per cent), and manufacturing industries (4.2 per cent).

### Economic growth registered a slight decrease

In line with the high economic financing, Rwanda's economy remained resilient, despite various economic challenges such as the slowdown in global demand, increasing inflation, and climate shocks, the report showed.

It indicated that the real gross domestic product (GDP) growth remained robust at approximately 8.1 per cent during 2022/23, slightly lower than the 8.9 per cent achieved in the previous year. This growth was mainly supported by a robust performance in the services sector, it added.

Performance of national reserves In terms of reserve adequacy, the report showed that NBR maintained an adequate level of foreign exchange reserves to ensure resilience against external shocks.

As of the end of June 2023, the level of the bank's foreign exchange reserves stood at more than \$1.8 billion, enough to cover 4.4 months of prospective imports in terms of global shocks or disruption in access to the foreign currency needed for the country to meet its import needs.

However, the amount of reserve is lower than \$1.9 billion recorded as of the end of June 2022. The report explained that the overall decrease in the level of reserves resulted from the delay in inflows from different partners that were expected during 2022/23.

Rwangombwa told parliamentarians that the country's foreign reserves were safe and performing well, indicating that about 90 per cent of them are held in the US Dollar, which is a stronger currency compared to others globally, as of now.

# MTN Nigeria promoting 5G in energy, education sectors

Oil firms and educational institutions in Nigeria, Africa's largest economy, are among the early users of MTN's 5G network deployment, which is boosting the mobile operator in its largest market.

Partnerships with Seplat Oil and Gas, as well as Huawei and Baze University in Abuja, were cited as encouraging adoption of 5G by the pan-African telecom operator

A collaboration with Seplat will give 5G connectivity, which will aid in the digitalisation of business processes.

Also, MTN has collaborated with Huawei and Baze University to provide 5G connection across campus, which is required for education technology (Ed-Tech).

"These are some examples of organisations from various industries that have used our 5G network to advance their operations," stated Funso Aina, senior manager for external relations at MTN Nigeria.

The executive was speaking to ITWeb Africa in an exclusive interview.

Last August, MTN Nigeria, Africa's top mobile network operator, built a 5G networks in 20 additional cities.

The South African-based mobile network provider has covered more than 80% of Nigeria's population with its 4G network and has promised to enhance its 5G network coverage.

"The innovators and early adopters have responded very well to our 5G network and to date we have received feedback that suggests that a number of our subscribers are satisfied with the performance and reliability of our 5G network across various use cases which include e-learning, work-from-home (WFH), digital entertainment, home security and surveillance, smart homes, augmented reality (AR)/virtual reality (VR), online business," Aina said.

He bemoaned the fact that some subscribers did not have 5G enabled equipment, such as compatible smartphones, preventing them from taking advantage of the improved network.

"At the individual level, one of the gaps we have identified is that some of our



subscribers do not have a 5G-enabled device," Ainsa stated.

As a result, MTN has teamed with device finance services like Intelligra and M-KOPA to help Nigerians by offering the Buy Now, Pay Later option.

The operator has also worked with smartphone manufacturers Infinix, Sam-

sung, and Tecno to create 5G-enabled devices, with the goal that these collaborations will help expand smartphone adoption in Nigeria to 60% by 2025.

"We will continue to partner with other relevant platforms and organisations to make smartphones affordable for Nigerians," Aina said.

### KRA wants regulator to suspend SportPesa licence

The Kenya Revenue Authority (KRA) has asked the Betting Control and Licensing Board (BCLB) to suspend trading licences and paybill numbers of SportPesa and Finix Casino in the latest escalation of the battle between the firms and the taxman

The KRA on November 8 wrote to BCLB, weeks after the High Court in Kakamega directed the firms not to deduct the 12.5 percent tax on betting stakes.

The court's decision gave temporary relief to punters on the SportPesa and Finix Casino platforms but placed the two firms on a collision course with the taxman.

The KRA says it challenged the Kakamega High Court order, adding that further orders were made requiring the companies to make provisions for the excise tax for August.

"Both taxpayers have not complied to the court order despite our reminders dated September 29, 2023," Weldon Ngeno, Commissioner for Domestic Taxes, said in the letter to BCLB's chairperson Jane Makau.

"We hereby request you to kindly but urgently suspend all trading licences and pay bill numbers for SportPesa and Finix

Casino until further notice."

BCLB has, however, not enforced KRA's wish, with punters still making deposits to their accounts using the paybill numbers



of the two firms.

SportPesa had in October 2019 temporarily exited the Kenyan market following a prolonged court fight with the KRA over claims of unpaid taxes.

The firm also cited an unfair tax regime but made a comeback in 2020 after Milestone Games Limited acquired the SportPesa brand name from Pevans East Africa that pioneered sports betting in the country.

Finix Casino is the other gaming firm that was served with the High Court's ruling in August to stop deducting 12.5 percent on betting stakes of punters on their sites.

The 12.5 percent excise tax means that for every Sh100 wagered, the KRA takes Sh12.50. This is in addition to a 20 percent withholding tax on every winning bet slip.

In September the High Court has stopped the use of the SportPesa brand in Kenya's gaming business amid shareholder fights in a ruling that deals a blow to Milestone Games Ltd that had been allowed to run the popular brand.

Justice Anthony Ndung'u issued the temporary order suspending the licence issued to Milestone Games last month by the Betting Control and Licensing Board (BCLB) to use the SportPesa brand for the year to June 2023.

The freeze followed a petition from businesswoman Asenath Wachera Maina who has a 21 percent stake in Pevans East Africa that pioneered the sports gaming business in the country with the Sport-Pesa brand.

Pevans East Africa ceased operations after losing its licence in 2019, partly due to allegations of non-payment of taxes that the Kenya Revenue Authority last computed at Sh95 billion.

The SportPesa brand returned on October 30, 2020, through Milestone Games, which is owned by some of the shareholders of Pevans, including Ronald Karauri, amid opposition from the regulator.

But the brand got its first approval from BCLB last month, triggering the court fight for the key assets of the gaming firm, including the trademark and web do-

Ms Maina and tycoon Paul Wanderi Ndung'u, who has a 17 percent stake in Pevans East Africa, have accused Milestone Games of procuring the licence under circumstances shrouded in mystery while the country was focused on the August 9 elections.

She has faulted the BCLB for allowing Milestone to use the SportPesa brand, saying it acted unreasonably and in breach of laws governing betting.

She added that Milestone Games was previously licensed to trade as Milestone Bet and that a deal of May 26, 2022, that allowed the current use of SportPesa brand was not backed by Pevans East Africa's board.

"From the disclosed facts, I am satisfied that an arguable case is established that requires ventilation at an inter-partes hearing. The leave sought is thus merited and is hereby granted," Justice Ndung'u said.

The judge said it was prudent to suspend the licence pending the determination of the court fight over the ownership of SportPesa. The judgment, he said, might be rendered useless because Ms Maina may not recoup earnings made by Milestone Games for using the brand should her case be successful.

"It is hereby ordered that leave so granted do operate as a stay of implementation and thereby suspend the operation and use of the impugned bookmakers name licence number 0000448 issued to Milestone Games Limited to trade as SportPesa pending the hearing and determination of the substantive judicial review application," the judge said.

### Public transport changes as govt sinks in Rwf20bn

**KIGALI** 

government has injected up to Rwf20 billion in public transport as one of the interventions meant to fix the shortage of buses and long queues at bus stations in the City of Kigali.

The changes include the government's move to buy 200 buses from Chinese manufacturers and provide them at a subsidised price for potential investors in public transport.

#### 1. Govt orders new buses

Out of 300 buses needed in Kigali, the government has bought 200. Half of them will be available by the end of the week, Minister of Infrastructure Jimmy Gasore said, adding that the remainder will be available before the end of February 2024.

"Currently, we have about 400 buses countrywide. And we found that asking investors to buy 200 more buses at once would be very hard for them, so we decided to buy them, so the investors can buy them at an affordable price," explained the State Minister in charge of National Treasure in the Ministry of Finance and Economic Planning, Richard Tusabe.

The government has also waived the tax required to buy, and lobbied commercial banks



to offer the investors loans at lower interest rates, Tusabe said, adding that the new buses will cost around Rwf20 billion.

The Business Development Fund (BDF) has also agreed to sponsor up to 70 per cent of the value of the collateral required by the banks.

Minister of Infrastructure Jimmy Gasore said the government has ordered up to 200 new buses, which interested investors will be able to buy at a subsidised price.

2. Public transport opened

The new regulations have opened up the public transport sector to anyone with a bus that meets the required standards.

Previously, the City of Kigali would call for investors or companies to bid for the provision of public transport.

The buses that are allowed to carry passengers in the city should have at least 29 seats.

Bigger buses that carry 70 or more passengers will be given priority on main roads in the city to ensure adequate passenger service.

All operators are required

to have cashless payment sys-

#### 3. No more monopolised

tems in place.

As more stakeholders have been encouraged to invest in the public transport sector, Gasore said no company or operator would monopolise a

"Any individual who will express interest in investing in transport will find a route to operate on. The City of Kigali needs a lot of buses and there will no longer be routes served by one operator or company,"

There are at least two or more transport operators per route in order to allow competition and motivate them to deliver good service to passengers, Gasore said.

Investors can also identify underserved routes and request the authorities the licence to operate in them, he

#### 4. Unlicensed seven-seater vehicles no longer allowed

The government has terminated a directive that allowed owners of seven-seater vehi-

cles to use them to ferry passengers without a transport operator licence after introducing new changes in Kigali's public transport.

The move, which was announced in early October allowed the owners of unlicensed seven-seater cars to carry passengers at a negotiated fare and without paying

Minister Gasore said it was a temporary measure introduced to deal with the shortage of buses and long queues at bus stations, but the government has now taken further long-term measures to fix the issues in public transport in the City of Kigali.

#### 5. Subsidies to bus companies to stop

After the new buses have been deployed to the roads, government subsidies will stop. The subsidies were introduced to cushion bus companies from the impacts of the Covid-19 pandemic.

"We believe the subsidy has helped a lot since the Covid pandemic, but we need to have a sustainable solution," Tusabe said.

"Once we have provided sufficient buses at an affordable price, there won't be any need for subsidies, and we will continue to support investors in this sector in more ways

In July five state-of-the-art buses arrived as part of the measures to address the issues faced by commuters in public transportation and ensure the smooth functioning of the system. Public transportation has always been a crucial mode of

The buses have been acquired by the Jali Transport Company, whose fleets normally operate from Nyabugogo Bus Park to Kimironko Bus Park, Downtown Bus Park to Kimironko Bus Park, Kimironko Bus Park to Batsinda, and other areas in Kigali, have been added, a nlocal news outlet reported.

Additionally, the company is expecting 20 more Yutong buses- a Chinese manufacturer of commercial vehicles, especially electric buses, headquartered in Zhengzhou, Henan, with the intent to reduce the queues during peak hours, particularly in the evening.

Innocent Twahirwa, Managing Director of Jali Transport, said, "They are new models that closely resemble the older ones. However, they are incorporating updates and improvements in various aspects such as aesthetics, safety features, comfort and performance."



### New book reignites British royal race row

ALMOST three years after Prince Harry and his wife Meghan's interview with Oprah Winfrey sent shockwaves through the British monarchy, their most sensational claim which provoked a royal race row has been reignited by a new book

In the dramatic interview with the US talk show host in 2021, Meghan, whose mother is Black and father is white, said while she was pregnant with son Archie there were "concerns and conversations about how dark his skin might be when he's born".

The couple declined to say which unnamed royal had made the remarks, although Winfrey later clarified it was neither the late Queen Elizabeth nor her husband Prince Philip.

The furore led Buckingham Palace to issue a statement on behalf of the queen which pointedly said "recollections may vary", and a denial the family were racist from now heir Prince William. Harry, the younger son of King Charles, said in a subsequent 2023 TV interview, neither he nor Meghan had accused anyone in their family of racism.

But a new book about the royals written by journalist Omid Scobie has brought the issue back to the fore, making front page news again Britain this week. In his book Endgame, Scobie says the names of two figures involved were identified in private letters between Charles and Meghan following the Winfrey interview, but said he was prevented from naming them by UK laws.

However, on Tuesday, Xander Uitgevers, the Dutch publisher said it had temporarily removed the book from sale because of "an error" in the country's edition in which the two royals were indeed named, although that particular paragraph does not appear at all in the English version.

"I edited and wrote the English version, there's never been a version that I produced that has names in it," Scobie told Dutch broadcaster RTL Boulevard this week.

#### King in Dubai

In his TalkTV show on Wednesday, the royals allegedly involved were also named by British broadcaster Piers Morgan, a vocal critic of Harry and

He described Scobie, who earlier this year referred to the former tabloid editor when he appeared as a witness for Harry in a phone-hacking court case, as the couple's "lickspittle".

Charles, who has campaigned on climate change and sustainability for more than 50 years, made no reference to the row when he kicked off a visit to Dubai where he is meeting world leaders and will be delivering the opening address to the COP 28 UN summit.

"I'm all right thank you very much, just about, having had a rather ancient birthday recently, recovering from the shock of that," the monarch, who celebrated his 75th birthday earlier this month, joked when he met Nigeria's President Bola Tinubu.

A spokesperson for Harry and Meghan declined to comment.

Neither Buckingham Palace nor any of the royal family's offices have commented on the book, but the Daily Mail said officials were considering all options, including legal action.

"However the key thing for them is his majesty responding in the most eloquent way possible by getting on with business and not letting it distract from vastly more important issues regarding the future on the planet and bilaterals with other world leaders," the paper quoted an unnamed source as saying.

### Bulgaria's refusal to open airspace doesn't stop Russian delegation doing its job – MFA

MOSCOW

BULGARIA'S refusal to open its airspace to a Russian plane carrying Foreign Ministry Spokeswoman Maria Zakharova did not stop the Russian delegation from taking part in the OSCE ministerial meeting.

Asked what impact the Bulgarian airspace ban had on the Russian delegation, Zakharova told Rossiya-24 TV: "Well, only the route."

The spokeswoman said that the Bulgarian authorities had no legal grounds to ban her from being on board the plane, which was flying non-stop across the country's airspace. "There is no logic or law behind this, none. But once again I say, what will happen next? I mean, they



have to ask themselves that question. Well, apparently, in the heat of this Russophobia it is no longer about asking questions," she said.

Earlier, Russian Foreign Minister Sergey Lavrov arrived in North Macedonia's capital of Skopje for an Organization for Security and Cooperation in Europe (OSCE) meeting. His plane traveled through Greece even though the flight had initially been expected to pass through Bulgaria's

However, Sofia refused to open its airspace to the top Russian diplomat's aircraft because Zakharova was onboard.

The Russian Foreign Ministry spokeswoman slammed Bulgaria's decision as "dangerous stupidity." According to her, for the first time in history, a government banned a person onboard a plane instead of the plane, because according to the Bulgarian Foreign Ministry's statement, the aircraft had permission to cross the country's airspace. #### Republican DeSantis, Democrat Newsom clash in debate

US presidential candidate Ron De-Santis clashed with California's Democratic Governor Gavin Newsom in an acrimonious debate on Thursday night, making a last-ditch pitch to Republican voters that he is the best option to take on President Joe Biden in next year's election.

The square-off with Newsom, a prominent Biden ally who is widely expected to pursue a future White House bid, quickly turned to insults.

DeSantis (pictured) frequently called Newsom a liar in charge of a failing state, while Newsom ridiculed his Florida counterpart as a bully badly trailing Republican presidential rival Donald Trump in presidential polls.

"When are you going to drop out and at least give Nikki Haley a shot to take down Donald Trump," said Newsom, 56, referring to the former South Carolina governor who has been surpassing DeSantis in some polls as the top Trump alternative.

DeSantis, 45, gazed at Newsom in silence for a few seconds, before repeating several times: "You wish."

DeSantis was once viewed as Trump's most formidable challenger, but now trails frontrunner Trump in the race for the Republican White House nomination by over 40 points and has seen donor and media attention shift to Haley.

"This is a slick, slippery politician whose state is failing," DeSantis shot at Newsom. "People are leaving California in droves.

To emphasize his view that leftleaning California was misgoverned, DeSantis brought a map of what he said showed the quantity of human feces found on the streets of San

DeSantis held his own and had a strong showing against Newsom, a skilled debater, but it was likely insufficient to revive his stuttering campaign.

The Trump campaign said in an email to supporters before the debate that DeSantis' face-off with Newsom was a "desperate" attempt to gain attention as his campaign struggles with infighting and shifts in

John Feehery, a Republican strategist not affiliated with any of the campaigns, said the debate was a good chance for DeSantis to highlight his conservative governance in Florida but was unlikely to alter the trajectory of the Republican nominating race.

"Newsom is very slick, slicker than DeSantis," Feehery said.

DeSantis' aides say Newsom could be a presidential contender as early as next year, though the governor has pledged to stand behind Biden's bid. He strongly backed Biden again on Thursday.

"I will take Joe Biden at 100 versus Ron DeSantis any day of the week at any age," Newsom said, when pressed on whether Biden, 81, is too old to be president.

Abortion was another flash-point between the two governors. Newsom called DeSantis's six-week abortion ban in Florida "extreme", amid polls that show the issue of abortion restrictions has become a political problem for Republicans. DeSantis said: "I believe in a culture of life."

### World to hit 1.4 C of warming in record hot 2023

**DUBAI** 

WITH a month to run, 2023 will reach global warming of about 1.4 degrees Celsius above preindustrial levels, adding to "a deafening cacophony" of broken climate records, the World Meteorological Organization (WMO) said on Thursday.

The WMO's provisional State of the Global Climate report confirms that 2023 will be the warmest year on record by a large margin, replacing the previous record-holder 2016, when the world was around 1.2C warmer than the preindustrial average.

It adds to the urgency world leaders face as they wrestle with phasing out fossil fuels at the United Nations annual climate summit COP28, which begins on Thursday in Dubai.

"Greenhouse gas levels are record high. Global temperatures are record high. Sea level rise is record high. Antarctic sea ice record low," WMO Secretary General Peterri Taalas said.

The report's finding, however, does not mean the world is about to cross the long-term warming threshold of 1.5C that scientists say is the ceiling for avoiding catastrophic climate change under the 2015 Paris Agreement.



### 'West determined to dismember Russia, eliminate its peoples'

**MOSCOW** 

THE strategic aim of the Anglo-Saxons, for the sake of which they are imposing neo-Nazism on Europe, is to dismember Russia and eliminate the Russian world, the secretary of Russia's Security Council Nikolay Patrushev believes.

"The West has entered a new phase of confrontation with Russia. The Anglo-Sax-



Patrushev (pictured) pointed out that the ideas of the Nazis were picked up by the masterminds of color revolutions, who impose xenophobia for the violent displacement of legitimate governments and for creating chaos in once stable regions.

"For justifying global inequality and for perpetuating the unipolar world, the Atlanticists do not hesitate to use the ideas of racial, ethnic, cultural and economic superiority, depriving entire peoples of opportunities for independent socioeconomic and cultural-civilizational development," he stated.

#### **Eradication of Nazi ideas**

According to Patrushev, by fueling interethnic discord, nurturing and fully supporting the proponents of extremism, chauvinism and all forms of radicalism, the West is creating a real threat to democratic and universal values, security, social stability and the unity of society.

"The approach being promoted by Russia is based on intolerance to any forms of discrimination and the prevention of attempts to excuse and exonerate the Nazis and whitewash their atrocities," he said.

As Patrushev noted, Shchipkov's book confirms the importance of continuing research aimed at "eradicating the ideas of neo-Nazism and at developing critical thinking that rejects any attempts to spread anti-human views and manipulate ethnic myths."

#### Palestine's Abbas advocates full Gaza ceasefire at meeting with Blinken

**CAIRO** 

PALESTINIAN President Mahmoud Abbas held a meeting with US Secretary of State Antony Blinken in the city of Ramallah, during which he spoke in favor of strengthening the current truce and achieving a full ceasefire in the Gaza Strip, the WAFA news agency reported.

During the talks, the Palestinian leader "pointed to the need to strengthen the current truce in the Gaza Strip in order to achieve a complete ceasefire and end the Israeli aggression against the Palestinian people," the statement said.

Abbas pointed to the importance of significantly increasing the supply of humanitarian aid to the Palestinian enclave, especially medicine, food, water and fuel, as well as "support for the reopening of hospitals in the Gaza Strip to treat thousands of wounded."

The Palestinian president expressed his rejection of Israeli policies and called on the US to intervene to "prevent the expulsion of the Palestinian people from their land."

The Palestinian leader also pointed to the impossibility of accepting any plans by the Israeli authorities "to separate the Gaza Strip [from the West Bank], which is an integral part of the Palestinian state.'

Abbas advocated for the state of Palestine to become a full member of the United Nations and to hold an international peace conference, stressing that "peace can only be achieved through the implementation of the decision to establish two independent states, including the Palestinian state."

### Black Mermaid: I was always the only black person on the boat

ZANDILE Ndhlovu grew up in Soweto, a black township in South Africa on the edge of Johannesburg, where no-one ever dreamed of travelling hundreds of miles to swim in the ocean. There wasn't even a swimming pool.

"And there was this narrative of, 'Black people don't swim, we don't do that stuff," she says.

So she wasn't prepared for her first snorkelling trip, in Bali, at the age of 28.

"The captain told everybody to kit up," she recalls.

"I didn't even know what 'kit up' means. I didn't even know what a snorkel did. When I jumped into the water, I started freaking out. I thought I was drowning.'

But Ndhlovu says that once she became settled, she felt at

"I told myself to calm down. I looked beneath the surface of the water and couldn't believe the overwhelming blue, the yellow fish, and the sun rays on the coral reef. It was the most beautiful thing I had ever seen in my

The experience prompted her to take a diving course, and three years ago she became South Africa's first black female

freediving instructor.

It wasn't always an easy jour-

"I was always the only black person on the boat," she says.

"It was interesting because you go through various things, whether it's language, and everybody is speaking, Afrikaans... or whether it's your wetsuit not fitting, or someone asking: 'Are you gonna dive with all of that hair?"

### BRICS countries speak up for justice, peace on Palestinian-Israeli issue

CHINESE President Xi Jinping on Nov. 21 attended the BRICS extraordinary virtual summit on the Palestinian-Israeli issue and delivered an important speech.

Explaining China's position on the Palestinian-Israeli issue, he pointed out that it's urgent and imperative to end hostilities and achieve a ceasefire immediately, keep humanitarian corridors secure and unimpeded and prevent the conflict from spilling over. He stressed that the only viable way to break the cycle of Palestinian-Israeli conflict lies in the twostate solution.

His remarks addressed both immediate and long-term priorities and identifies the direction of effectively solving the Palestinian-Israeli issue.

The virtual summit was the first summit since the enlargement of BRICS, and an important meeting convened by the BRICS countries at a critical moment of

escalation of the Palestinian-Israeli issue. The BRICS cooperation mechanism is an important platform for emerging markets and developing countries to strengthen solidarity and cooperation and safeguard common interests. It always focuses on promoting world peace and development and addresses major international issues based on their merits, making fair remarks and taking fair

actions, and bringing to the world more

certainty, stability and positive energy. As Xi pointed out, given the current circumstances, it is very timely and very important that BRICS countries meet and speak up for justice and for peace on the Palestinian-Israeli issue.

Xi noted that the parties to the conflict must end hostilities and achieve a ceasefire immediately, stop all violence and attacks against civilians, release civilians held captive, and act to prevent loss of more lives and spare people from more

He stressed that humanitarian corridors must be kept secure and unimpeded, and more humanitarian assistance should be provided to the population in Gaza. The collective punishment of people in Gaza in the form of forced transfer or water, electricity and fuel deprivation must stop.

Besides, the international community must act with practical measures to prevent the conflict from spilling over and endangering stability in the Middle East as a whole, he added.

These Chinese proposals are highly targeted and constructive, aligning with the common aspirations of the majority of countries and reflecting the unanimous call of peace-loving people world-

The Palestinian issue has always been at the core of the Middle East problem. Without a just resolution to the Palestinian issue, there would be no lasting peace and stability in the Middle East.

Xi has emphasized on many occasions that the only viable way to break the cycle of Palestinian-Israeli conflict lies in the two-state solution, in the restoration of the legitimate national rights of Palestine, and in the establishment of an independent State of Palestine.

The root cause of the Palestinian-Israeli situation is the fact that the right of the Pal-

estinian people to statehood, their right to existence, and their right of return have long been ignored. The historical injustices done to the Palestinian people should not be left unattended indefinitely. The legitimate rights and interests of a nation are not up for trade, and the demand to establish an independent state shall not be denied.

China calls for early convening of an international peace conference that is more authoritative to build international consensus for peace and work toward an early solution to the question of Palestine that is comprehensive, just and sustainable.

Since the outbreak of the latest Palestinian-Israeli conflict, China has been working actively to promote peace talks and a ceasefire. The fact that the delegation of Arab-Islamic foreign ministers made China its first stop for international mediation reflected thqeir trust in China and the tradition of mutual understanding and support between the two sides.

At the UN Security Council, China has acted in its capacity as president to facilitate the adoption of the resolution, which calls for extended humanitarian pauses and corridors, the protection of civilians, and the provision of humani-

The international community highly praised China for consistently upholding a fair position on the Palestinian issue and commended China's role as the rotating president of the UN Security Council in pushing for the adoption of the first resolution since the outbreak of the latest Palestinian-Israeli conflict.

China has provided humanitarian assistance to help ease the humanitarian plight in Gaza. This includes \$2 million of emergency humanitarian assistance provided through the Palestinian National Authority and UN agencies, and emergency humanitarian supplies worth 15 million yuan (\$2.11 million), such as food and medicine, to the Gaza Strip with the help of Egypt. China will provide more supplies and assistance according to the needs of the people in Gaza.

The BRICS virtual meeting to coordinate positions and actions on the Palestinian-Israeli conflict marked a good start for greater BRICS cooperation following its enlargement. As a permanent member of the UN Security Council and a responsible major country, China will continue to maintain close communication with relevant parties, and make utmost efforts to protect civilians, ease tensions, restart negotiations, and strive People's Daily for peace.

It does not mean Ten Hag was wrong to bring in a new goalkeeper and the sudden revisionism over De Gea serves no purpose. United's rather botched handling of his departure was unfortunate and the Spaniard deserved better after such service.

But there was hardly an army of United fans arguing demonstrably against his exit and plenty who felt a change was required between the posts for Ten Hag to evolve the team's buildup play from the back.

At the same time, De Gea's departure necessitated the arrival of an upgrade and, while these are still early days for Onana, he has so far fallen well short of the standards required.


