Magufuli: Dewji kidnap case was poorly handled

PRESIDENT John Magufuli yesterday read the riot act to the police force for not conclusively handling some cases, including the kidnapping of billionaire businessman Mohammed Dewji last year.

Speaking at the State House in Dar es Salaam during the swearing-in of newly-appointed leaders and promotion of five senior police officers to the rank of Commissioner of Police (CP), the Head of State said there are more questions than answers on the way the police handled the Dewji case.

From the abduction and later release of the businessman, details emerged of the house where he was kept and the person who oversaw the act but police did not pursue the matter conclusively

to provide answers to Tanzanians, he said.

"We later saw the person who was kidnapped (Dewji) drinking tea with (Lazaro) Mambosasa (Dar es Salaam Zone Police Commander) but there was no information on the case," he said.

He further stated: "We were shown the house where he (Dewji) was kept and the person who was in charge of the kidnappers; that person ought to have been arrested and interrogated."

Following his release in October last year, 10 days after he was snatched outside a posh Dar es Salaam hotel where he went for a regular early morning exercise, Inspector General of Police (IGP) Simon Sirro said the kidnappers dumped Dewji popularly known as Mo, at the Gymkhana Golf Club grounds in Dar es Salaam at around 2am

Pilot and four US nationals in chopper crash horror

FOUR American tourists and their Kenyan pilot were killed when their helicopter crashed shortly after takeoff from a remote island in a lake in northwest Kenya, officials said Monday.

"There were five people on board, four of them were US citizens and the pilot, Capt. Marious Magonga," the Kenyan Civil Aviation Authority said in a statement.

The US Embassy identified three of the



dead Americans as Anders Asher Jesiah Burke, Brandon Howe Stapper and Kyle John Forti.

The helicopter "lost contact and crashed" shortly after taking off from Lake Turkana's Central Island National Park along with a second chopper about 8 p.m. Sunday, the statement said.

They were headed for Lobolo Camp on the mainland.

Magonga, who owned the Bell 505 chopper, also flew for Kenya's deputy president, William Ruto.

The cause of the crash remains under investigation.

Known as the Jade Sea, Lake Turkana is the most saline lake in East Africa and the largest desert lake on earth. Its central island comprises three active volcanoes, according to the Kenya Wildlife Service.

Last month, three Americans were among five people killed when their plane crashed as they were heading to Lodwar near Lake Turkana.

EAC states in lake fish protection drive

EAST African Community (EAC) partner states yesterday signed an agreement to conduct a joint operation to save the fish stock and curb illegal fishing in Lake Victoria.

The initiative to protect marine resources was signed at the EAC headquarters in Arusha where ministers responsible for the fishing sector from riparian countries held a meeting.

Luhaga Mpina, the vice chairman of the EAC fisheries sector ministers, said the decision to conduct the operation will increase amounts and variety of fish in the lake and boost economic growth in the respective countries.

"Countries surrounding Lake Victoria should not import fish. They should instead export various marine resources to other African countries," said Mpina, insisting that if well managed, Lake Victoria

Various intervention by EAC governments in curbing illegal fishing had increased fish reproduction in Lake Victoria from 62.8 to 96.3 percent annually.

Mpina noted that the stock of fish has increased to 32 percent optimal fish volume from 3.3 percent following a one year operation. Fish stock measuring 80 to 85 centimeters had increased to 5.2 percent from the previous 0.4 percent level, he pointed out.

In Tanzania authorities seized illegal fishing gears totalling 45,000 kilometers during the operation last year, he said, applauding Uganda and Kenya for a job well done in combating illegal fishing in their portions of lake waters.

Historical sites to be run as tourist attractions

THE government has begun handing over historical sites that were under the Department of Antiquities in the Ministry of Natural Resources and Tourism to national conservation authorities for better utilisation.

Speaking here yesterday during his tour of the Mikindani town historical site in the Mikindani-Mtwara municipality in Mtwara region, the Deputy Minister for natural resources and tourism Constantine Kanyasu said that 16 sites and buildings have already been given to conservation bodies so that they can be properly maintained and marketed as tourist attractions.

The move followed a review of national antiquities policy and the need to promote cultural tourism in the country, hence the necessity to shift the mandate over the sites to better placed entities.

An audit conducted last year found that 85 historical buildings all over the country were on the brink of collapse and consequent disappearance if not rehabilitated, he said.

The decision has also been informed by the fact that the Department of Antiquities is cash-strapped

expectation that the historical sites and buildings will be well maintained and marketed as cultural tourism sites," the deputy minister affirmed.

To that end, the Mikindani town historical site, which includes a fort that was once the administrative centre in German East Africa built 1895 and known as the Old Boma, has already been handed over to the National Museum.


"The authorities handed these sites have been tasked to administer, rehabilitate, protect and promote the same," he elaborated.

Kanyasu also unveiled the promotion strategy for the sites, saying that they will be marketed in packages whereby tourists visiting one region for instance, visit as many historical sites found there as possible.

The Deputy Director in Antiquities appealed to all district town councils in the country to protect historical sites and buildings so that the same can be used as source of tourist revenues as well as history for future generations.

REGIONAL speakers have launched the East African Parliamentary Institute (EAPI) which is expected to harness capacities and narrow the skills gap of parliamentarians and staff in the quest to further strengthen the integration

East Africa Legislative Assembly (EALA) Speaker, Ngoga Martin said during the launch last Friday that the institute's presence in the region will catapult the integration process and provide a valuable link between people within the EAC and beyond.

He said EAPI would provide an adequate base of knowledge on legislative matters to Members of Parliament and staff who at times come from different background when they join parliaments.

"The launch of the EAPI is definitely

The launch of EAPI follows the enactment of the East African Parliamentary Institute Bill, 2011, which anchors and provides for the legal framework of its establishment.

The EAPI Act inter alia establishes a mechanism for capacity and skills development to promote professionalism through establishment of the institute thus giving effect to article 5 (1) of the Treaty.

LVFO is a specialized institution of the EAC with a mandate to coordinate the management of fisheries resources in Lake Victoria for sustainable development and utilization. It was established in 1994 by a convention signed by the riparian states.

Its objectives are to foster cooperation among the contracting parties, harmonize national measures for the sustainable utilization of the living resources of the Lake and to develop and adopt conservation and management measures.

Meanwhile, Uganda's Minister for Agriculture, Animal Industry and Fisheries (MAAIF), Vincent Ssempija has said that Uganda is currently implementing a number of initiatives to curb illegal fishing and protect marine resources.

Secretary in the Kenyan Ministry of Agriculture, Livestock, Fisheries and Irrigation said President Uhuru 350,000 tonnes.

Kenyatta has launched a special task force comprising of police officers that will work to curb illegal fishing in the lake.

Data by the Ministry of Livestock and Fisheries indicates that there is approximately one million tonnes of fish in the lake, mostly the Nile perch valued at between \$ 300 and \$ 500 million in total.

Current estimates show that in 2017, Prof Micheni Ntiba, Permanent Tanzania harvested an estimated 300,000 tonnes of Nile perch, Kenya about 50,000 tonnes and Uganda

FALL armyworm (FAW) have destyroyed hundreds of maize farms in Mbeva Region, forcing some farmers to shift from cultivating maize crop to other crops such as Irish potatoes.

The farmers at Inyala, Igurusi and Chimala wards say, so far no any pesticide that has worked out effectively and efficiently to smoke out the pests and other associated diseases, despite buying the pesticides at higher prices.

According to agriculture researchers and scientists, the FAW also known as Spodoptera frugiperda is native to America, and was firstly observed in Nkhasi District, Rukwa Region in southern highlands in

The pest feeds on more than 80 host plants and crops including cereals, pulses and horticultural crops that are important staple food and cash crops

It is reported to have spread in more than 15 regions including the major maize growing areas in the southern highlands, northern,

Fall armyworms destroy maize farms in Mbeya

According to the farmers at Invala ward

in Mbeya rural district, the FAW had caused huge destruction for the consecutive third year discouraging some of them who had now decided to abandon growing maize, instead they have shifted to growing Irish potatoes as an alternative crop for food, cash and income.

One of the farmers at Inyala ward, Fidelis Mabena said that he cultivated five acres of maize but two acres had been destroyed by FAW. He said he had applied several pesticides which he bought at 5,000/ per bottle but all in vain.

"I have decided to grow Irish potatoes on part of the farm I used to grow maize because I am not sure of the maize harvest. I have spent much money for maize but FAW had destroyed two acres of my maize," he

This year, Frola Mwanzepene and Tausi Mwalyoyo said their farms had also been

half each but half of their maize had been destroyed. They said they will not now get any produce. "Here we call the disease as Mbenya, but our experience show that in the past we used to kill them by spraying we apply the pesticide, after some time, they return to the fields," said Frola

They said that unlike other pests and diseases, the FAW multiply rapidly when there is no rain, but when the rains come, their number decrease.

Acting village executive officer for Inyala village Furaha Mwalongo said the farmers supply of food and incomes had been reduced because FAW had affected almost every farmer in the ward.

The VEO said she has grown maize but half of the crop had been destroyed by pests.

"I planted the maize in December last year, but after two weeks half of the farm

Commenting on rapid spreading of crop diseases and pests recently, Minister for Agriculture Japhet Hasunga said that the pests and diseases pose a big challenge, so the government has directed extension officers to make sure that the pesticides to smoke them out reach the farmers in prone had been destroyed by FAW. IT expert advocates women's involvement in data analysis as crucial development agent

ABILITY for employed women to analyse data for economic and social purposes can lead them to individual development and naional prosperity generally, according to a Dar es Salaambased IT expert.

Co-founder of Tanzania Data Lab and Director for capacity development, Mahadia Tunga made the remarks vesterday when wrapping up a five-day training session by Tanzania Data Lab under the College of Information and Communication Technology (CoICT) of the University of Dar es Salaam.

The tailor-made data training program dubbed; 'Data4Her', involved 29 women who are employed in different institutions in Dar es Salaam and aimed at increasing the percentage of women who use data in their day to day routine to contribute to global agenda of 50/50 percent participation in all sphere of life. The training has organized in line with the celebration of this year's International Women's

Tunga said that early career employees especially women are lucking skills on utilizing data for better delivery at their jobs.

"We wanted to do something special this year so as to celebrate the International women day under the theme 'Balance for Better'. These programs will help both women and young girls since they aim to enrich their potentials by social development and engage them in entrepreneurship, sciences and technologies," the IT expert said.

She added that the secondary objective is for better understand and explore ways to mitigate and ultimately alleviate the under participation of women in the aforementioned careers.

According to her, Data4Her program targeting young women employed at

early career positions. The program acts as a bridge to managerial positions. The program also aims at empowering women to make informed decisions, scale up career growth, create female data champions, and to establish a tech women database.

"We believe that without data there is no visibility and without visibility there is no priority as Data can shade light in hidden issues which can lead to changes in laws, policies, budget and decisions - especially when it comes to Education and Health," said Mahadia.

She added: "This is why through a program of this nature, the aims of dLab of bridging the gender gap in data manipulation and usage amongst young women in Tanzania to help them make informed decisions and influence policy, will eventually be reached."

This year dLab in collaboration with like-minded partners also plan to conduct another workshop special for International Youth Day in August. The target is to reach 50 women.

Leah Mushi, Senior Program Officer Internews, who participated as a trainee said she learnt about pitching on different data driven topics hence write proposals that can enable them get grants for development or community based programs.

DLab is a centre of excellence for data and data driven innovation that brings together critical components of the ecosystem that needs to be in place for evidence-based decisions.

DLab started as a project in March 2016 under the Data Collaboratives for Local Impact program (DCLI) which was funded by PEPFAR and implemented by MCC at the University Dar Es Salaam Computing Center (UCC) and later in February 2018, dLab was registered as an NGO which is affiliated with the University of Dar Es Salaam, College of ICT.

Tanzanians urged to register their businesses' trademarks

TANZANIANS have been challenged to register for trademarks of their businesses and products because it plays an essential role in protecting businesses, consumers and the promoting national economic growth.

It was said recently in Dar es Salaam during the cooperate dinner for raising awareness on the importance of trademarks, branding and intellectual properties, organised by International Trademark Association (INTA) and NexLaw Advocates.

Speaking during the event, Tat-Tienne Louembe, the INTA representative of Africa Middle East and Inter Government Organization said "We believe that, through trademarks and intellectual property the country will have the opportunity to achieve sustainable economic development because they are helping to increase value addition".

He added that, trademarks and related intellectual property encourage vibrant competition for the benefit of consumers, workers, brand owners and society at large.

Louembe encourage Tanzanians to register for trademarks saying that it enable consumers to make quick, confident, safe purchasing decisions and promoting freedom of choice.

Trademarks play an important role in the marketing process, enabling consumers to identify product/services of a particular company and enabling them to distinguish the products (goods/services) from others.

Added that through trademarks, businesses and consumers can easily be protected making them an important part of running a successful company.

"It is a good idea to register the name of vour business as a trademark, in the event that another business tries to use the same or similar name, you will have

legal recourse to stop it," he said. To maintain a good reputation, trademarked companies will often work harder to provide quality services and products.

Speaking during the event, Dr. Saudin Mwakaje an expert from Nexlaw Advocates said that they are assisting companies and the trademark owners to register it so that they can benefit more from it.

"We focus on the client's needs and provide them with services that would assist them in doing their businesses in a fast changing, competitive and complex businesses environment", he said. He added that "having trademarks is an important component in this fifth phase government which focuses on industrial economy because branding increases and protect value of the products and make the industry more competitive".

Dr. Mwakaje said it is time for Tanzania to make sure that there is good system for protecting intellectual property in order to win competitive markets.

On his part, Business Registration and Licensing Authority (Brela), senior officer Raphael Mtalima said low understanding on the importance of intellectual property was the main factor that hinders Tanzanians to register their trademarks.

Mtalima added that, in order to increase awareness on the importance of intellectual property, Brela had continued to provide awareness education and there is good reaction about it.

500 people in Kisarawe benefit from free medical screening and treatment

OVER 500 people from all corners of Kisarawe District have benefited from free medical screening and treatment offered by a team of medical specialists who are members of Medical Association of Tanzania (MAT).

The seven-day medical screening camp is part of MAT's move to mark the first 'Tanzania Medical Specialist Day'. President of MAT, Dr Elisha Osati said the camp involved 157 medical doctors and nurses from different hospitals across the country.

Diseases at the medical screening and treatment camp, include hydrocele, hernia, cervical cancer, breast cancer, and orthopedic.

Dr Osati made a request to the government to find them diathermyan electrically induced heat or the use of high-frequency electromagnetic currents as a form of physical therapy and in surgical procedures.

According to him, the medical equipment worth between 4m/- and 6m/- is very important in operation as it stops bleeding during surgeries.

Kisarawe District Executive Director (DED) Mussa Gama commended MAT for organizing the camp in the district, saying: "This move has helped people in the district who cannot afford to go into major hospitals due to distance and financial challenges."

Minister of State, President's Office, Regional Administration and Local Government, Selemani Jafo also lauded the role played by the medical specialists in assisting people in the area who are overwhelmed with a number of health-related challenges.

He, however, said that the government was determined to bring health facilities closer to people in the

Jafo who is the MP in the district, cited hydrocele as one of the health challenges facing the area, hence the need to bring health facilities closer to people remain important.

"We're working hard to ensure hydrocele surgeries are carried out within the district," he said, when responding to the request by a patient, a Boga-based villager, Sungura Masiwa who asked the government to bring health services in their villages.

Introduction of opinion boxes help villagers to enhance transparency and accountability

THE introduction of opinion boxes in different villages and wards in Kilombero district, Morogoro region, have helped to enhance transparency and accountability among the government leaders in the district.

Community Development Officer for Kilombero district Council, Rafael Mwesongo said that through the opinion boxes, the villagers and the entire community have found forums to express their views freely through the opinion boxes.

"These opinion boxes if well monitored are better, I wish this project could be extended to many villages and wards because the leaders are reminded of their noble role and responsibilities," he said.

John Adam Limahela, a resident of Mkula village, in Mang'ula, said that the opinion boxes have helped to enhance social accountability and monitoring (SAM) among the villagers and some of their leaders are currently working hard to ensure they fulfill their duties and responsibilities

He said after capacity building, he was able to monitor one of the projects that did not materialize in his village and reported to the district authorities so that measures could be taken against the culprits.

The Director for Kilombero Organization for Community Development

(KOCD), Christina Dominic said that the locals have been equipped with knowledge and skills to track the progress of public projects. They can collect information, analyse and monitor to ensure different governments projects run successfully.

"So far, KOCD implemented the project on Improving Agriculture Service Delivery through SAM to local Villagers in Kilombero District in Chisano, Kalengakelu and Ching'anda wards with the purposes of ensuring Local Government Authorities (LGAs) deliver improved quality services in agriculture sector," she said.

According to Dominic, another objective of the project was to ensure local communities are capacitated to

be able to make follow up on different and disclose misconduct of different project by the government to realize the value for the money.

There were follow-up meetings to 60 agriculture sector stakeholders on SAM in Kilombero DC. They include LGAs leaders, Government Officials, CSOs representatives, influential peoples, Corporate representatives, Agriculture groups, Women groups, Youth Groups and group of people disability from different locations in Kilombero district participated awareness meeting.

Explaining the impact of the project to the local communities, she said a good number of them have received training on TOT, they have been able to monitor different government projects leaders.

Citing an example, she said some village chairmen and village executives had monopolized and leased the power tiller without the knowledge of the villagers, but the villagers were able to disclose them and the power tillers were returned into the hands of the villagers.

Establishment of opinion boxes, has helped the local communities who cannot speak out in public especially during village meetings to air their views

The project has also changed and enhanced efficiency to some leaders after learning that the local communities were monitoring them.

Dominic recommends that the project has done a lot in terms of capacity building but there are still some wards and districts not reached, therefore, the project should be extended to reach out the remote rural communities.

"We are also recommending that the budget should be increased to allow many hamlets and village leaders to attend the capacity building training to get knowledge and make correct and fair decisions in their respective areas,

Govt promises more support for people with rare diseases

THE government has pledged to provide more support to ensure better health and effective treatment for patients suffering from rare disease as the world commemorated Rare Diseases Day.

diseases refer to conditions that affect few people in the society; sometimes called orphan diseases. According to World Health Organization (WHO) there are about 6,000 rare diseases which affect about 300 million people worldwide, Tanzania included. Manny rare diseases appear in early childhood, and 30 percent of the victims die before they turn 5.

Deputy Minister for Community Development, Gender, Elderly and Children, Dr Faustine Ndugulile made the pledge when speaking at this year's Rare Diseases Day, held in Dar es Salaam on February 28, with the theme 'Bridging health and social care'.

He said that the government is aware of the challenges faced by victims and has taken measures to enhance availability of orphan drugs with affordable price.

Dr Ndugulile asserted that since the medicine needed for rare diseases faces a challenge of low demand due

to the fact that very few people in the country suffer from the disease, the government has removed all the tariffs for importation of the orphan drugs. The move is to ensure sufficient supply of medical services to rare diseases suf-

"As the government we acknowledge the existence of the diseases in the country and we keep on improving our health system. There is a challenge of diagnosis; there are more than 6,000 every stakeholder should join effort to rare diseases while some of them are uncured. Most of people are not aware of their existence hence pose challenge of isolation and maltreatment people living with rare diseases especially children," said Dr Ndugulile.

"Normally there is a long procedure for importation of drugs which has cost implications. For someone who wants to import orphan drugs for rare diseases; which you may find that there are only 100 people in the county who need them, thus the government has removed all tariffs for orphan drugs so they are now imported for free," He

He urged organizers and other stakeholders to discuss and submit their proposal to the government for improvement of the health system in bid to address challenges of rare diseases.

The minister applauded organizers of the Rare Diseases Day, Sharifa Mbarak and Baome Baruani who are also the parents to rare diseases victims Ali Kimara (7) and Jamoud Muneer (2) for making the event a success, urging them to go a step farther and start a movement to recognize the victims.

Earlier, one of the organizers of the Rare Diseases Day, Mbarak said that raise more awareness among the society about rare diseases, explained that number of victims should not be the factor for isolation.

"The fact that a disease affects a small number of people does not make it irrelevant or less important than diseases that affect millions. No one should be left behind when we think of providing better and sustainable health services, including people who suffer from rare disease," she said.

"Our own experience has triggered us to mobilize parents, patients with rare diseases and other like-minded citizens aiming at creating awareness and call the community to action. We are certain there are a number of children in the country living with rare diseases but most of them are undertreated. she added.

Elders in Coast region called upon govt to strengthen health service provision

ELDERLY people in Coast Region have called upon the government to strengthen health service provision and make sure that it implements practically the country's policy of issuing free medical services to the group.

They were speaking here during the conference organised by a non-profit organization, Good Samaritan Social Service Trust Tanzania (GSSST) to discuss various challenges facing the group when accessing health services.

According to them, despite government's plans and efforts to improve health services in the country, medical services to elders were still in a languish situation.

"The National Ageing Policy of 2003 provides a clear framework for elderly rights including access to free medical services, but the implementation of this policy has been grabbed by an number challenges...lack of drugs is the major challenge to us," said Blandina Mbaji, one of the elders in the region.

Another elder, Michael Nkoma said that insufficient drugs and medical equipment had been leading to a number of elderly end up getting pain killers when they visit various public health centres and hospital something which do not cure their diseases.

"The government should make sure that it conducts regular follow-ups to find out major diseases facing the elderly so as to bring enough and drugs, we also recommend medical doctors serving the group in various hospitals should be engaged in the whole process for them to recommend the most wanted drugs," he said.

For her part, director of medical services, Ministry of Health, Community Development, Gender, Children and Elders Dr Grace Magembe acknowledged the presence of the challenges assuring that the government was working to make sure that medical services to the elderly become more easier and quality. She wanted authorities to ensure that every hospital, health Centre or dispensary had special window to serve senior citizens.

According to her, the aim of the national health policy is to provide free health services to elders from dispensary level to national hospital. "Medical servants should treat this group with respect and polite language...we have been receiving some claims that there were some dishonest workers who have been serving this group with rude language whenever they visit in health centres, this is unethical and totally intolerable...elders who find any hurdle in accessing health services should report this in upper level in the centres or

hospitals they visit," she added. Executive director of Good Samaritan Social Service Trust Tanzania Elisha Mwamkinga said the major aim of the conference was to hear more from the elderly about various challenges they face in accessing health care so as to find durable solutions of the prob-

OUTH Africa seems to be at a moment when it is almost impossible to find a good, clean, honest, and trustworthy politician. With the exception of the DA's Mmusi Maimane, can the public really trust any of the leaders in the ANC and EFF. Would you buy a used car from any one of them?

There was a poster doing the rounds, during the 1960 United States Presidential election adorned with Richard Nixon's face. A slogan below the picture was simple and effective. "Would you buy a used car from this man?" I'm not sure whether this was the first time the slogan was used, but it summed up almost perfectly the general antipathy towards Nixon at the time. He lost to John F Kennedy.

Whatever people thought about Nixon in 1960, they elected him eight years later. Nixon would run again, in 1968, was elected and served as president until 1974.... And when he did get to the highest office, Nixon would go on to debase the presidency. It would never be the same again after Nixon left office. It is worth stating the following, a somewhat lengthy passage for a more complete sense of the damage Nixon caused to the presidency of the US.

"For most of American history, that office conveyed authority, dignity, and some measure of majesty upon its occupant. The great presidents-Washington, Jefferson, Lincoln, the Roosevelts - came to be viewed not merely as capable executives but as figures of myth: They were heroic, selfless, noble, godlike.... as late as the middle of the last century, Americans were inclined to view even incumbent presidents with reverence. Faith in the presidency may have reached its apogee soon after World War ll. The public generally trusted Harry Truman and Dwight Eisenhower to be honest and well-intentioned and to put the interests of the nation above their

Nixon's conduct during the Vietnam war, destroyed his presidency and eroded faith in the office, and none of the post-Vietnam War presidents have managed to fully restore that faith. The most powerful lesson of the Nixon presidency was "that the duty of citizens in a democracy is to be sceptical not to worship our leaders, who have always been fallible, but to question their decisions, challenge their policies, and hold them accountable for their

failures".

EFF's manifesto the luxury election shopping list

What has all of this to do with South Africa's general election in May? Well, a lot, if you consider (first) the damage that Jacob Zuma has done to the Presidency, and (second) the increasingly narrow pool of trustworthy candidates among the three main parties, the ANC, the EFF and the DA. That is probably not fair to Mmusi Maimane, as he does seem like a clean-cut politician.

Where have all the good women and men gone?

South Africa seems to be at a moment when it is almost impossible to find a good, clean, honest, and trustworthy politician. With the exception of the DA's Mmusi Maimane, can the public really trust any of the leaders in the ANC and EFF. Would you buy a used car from any one of them? Let us start with the DA. Whatever you may think of the DA's policies, their racial make-up, their lack of unambiguously pro-poor policies, the presence of Tony Leon types, and a smattering of reactionaries, Maimane is far and away the most trustworthy of political leaders. Maimane, should he emerge as the unchallenged national leader of the party, would, arguably, be the "cleanest" of the main candidates. The key is, of course, that South Africans

They will vote for the EFF even if Malema cusses and yells at opponents, calls people names, insults people who disagree with him, threatens to cut the throat of whiteness, has journalists thrown out of press conferences.... They will vote for the EFF even if Shivambu physically attacks journalists, calls them names or starts pogroms for people of Indian heritage. And even if he is found to have benefited from questionable financial

dealings in the VBS Scandal. They will vote for the EFF notwithstanding recurrent claims of claims of sexual harassment by the party's most senior leaders. Like the Pan Africanist Congress in the 1950s, the EFF's main reason for being is

the politics of revenge, and it does not matter whether EFF leaders are clean and sober. "Whataboutery" means that there are always outsiders who are easier targets. Speaking of sexual harassment.... As if the ANC does not (already) have a monopoly, of sorts, over corpulent cadres who would make Mr Creosote look like a starving orphan. It was reported over the weekend that the ANC's acting spokesperson, Zizi Kodwa, had allegedly drugged and raped a woman. This, while a string of ANC cadres and deployees are being lined up to testify at the Judicial Commission of Inquiry to Inquire Into Allegations of State Capture, Corruption and Fraud in the Public Sector Including Organs of State. At the same time, former premier and North West leader Supra Mahumapelo is reported to be on a collision course with the party's leader, Cyril Ramaphosa. Now take a pick from any of the Zuma Cabinet and other appointees, and the problem is compounded. We should probably give any and all of the initiatives that Ramaphosa (as President of South Africa) has put in place to start cleaning up the state, and as leader of the ANC, cleaning up of the ruling party. Already the ANC have started a process of weeding the bad characters from its ranks. What remains a cause for concern is that between internal vetting of candidates, and external inquiries (like the Zondo Commission) will there be any clean candidates left? Would you buy a used car from any of them? What we have not seen (not yet, anyway) is a woman leader at the front of the EFF or ANC election machinery. Here, again, the DA comes out ahead with Phumzile Van Damme, Natasha Mazzone and, of course, Helen Zille, driving the party's agenda. It's probably not fair to compare them with Bathabile Dlamini, Nomvula Mokonyane or Lindiwe Zulu.

For the ANC Naledi Pandor is without peers in the party. All things considered, though, like Nixon, who debased the US presidency, we will probably look at the Zuma years as the worst that could happen to South African political leadership. cannot support women as workers or entrepreneurs if we do not first invest in their basic health, rights, and wellbeing. On one hand, it is encouraging to see women's economic empowerment gaining prominence as a smart investment for countries. The issue has been featured at the World Economic Forum, and the G20 group of nations has made important commitments.

But on the other hand, many of these conversations-including some in respected news outlets-are shortsighted, limiting, and yes, even dangerous. They assume that helping women thrive depends primarily on labour market or economic solutions such as incentivizing women-led

If countries are truly committed to empowering women, we should comprehensive, multiprioritize faceted investments.

For many girls and women, basic reproductive health eludes themmaking conversations about womenowned businesses feel like a distant luxury. Worldwide, 225 million girls and women want the option to plan their next pregnancy, yet lack access to safe, stigma-free services to do so-and therefore the ability to plan their futures. A shamefully high 830 women die every day from preventable complications during pregnancy or childbirth, and one in three women experience gender-based violence in their lifetime.

Improving childcare services is a positive step for women's economic empowerment, but insufficient if women are unable to choose whether to have a child in the first place.

Removing systemic barriers to education is also crucial for supporting girls and women to achieve their full economic potential, including addressing safety concerns, and ensuring accessible and safe water and sanitation.

The G7 countries can take immediate steps to shore up support for global maternal health, family planning and girls' education; they can also help women who have who have been displaced escaping violent conflict. Refugees, especially women, need quality health care, starting with maternal and reproductive health

Only if countries simultaneously invest in all of these areas can we close the gender gap in economic empowerment and reap a massive return. In Canada, where G7 leaders will meet in 2018, gender equality has received the comprehensive attention it deserves. In the face of global attacks on female rights, Canada committed to invest nearly US \$500 million in sexual and reproductive health and rights

Countries beyond the G7 have also risen to the challenge. The Netherlands is spearheading a new global initiative that has already raised \$200 million to finance access to sexual and reproductive health services, with Norway, Denmark and Sweden as core partners. Indonesia is working to mainstream gender equality in leadership by striving for at least 30 per cent women in parliament.

The evidence is irrefutable: to power progress for all, comprehensive investments in girls and women's health, rights and empowerment must be at the heart of every political agenda, not an afterthought. This is the mark of real gender equality champions-and we are watching to see whether G7 leaders pass the test.

Public servants' interests must be safeguarded

ANZANIA'S socio-economic political development have always been dynamic and had never been static or stagnant: therefore, the United Republic of Tanzania is likely to catch up and attain a middle income status before 2025 if, every citizen and public servant shall conduct himself or herself with integrity, empirically and honestly under the draconian style of iconic leadership of CCM with its current 5th phase government administered by vivacious Dr.

JPJ Magufuli, the President of the United Republic of Tanzania and his courageous and industrious colleagues; predominantly Madam Samia Suluhu Hassan, Vice-President and Honourable Majaliwa Kassim Majaliwa, Prime Minister.

This paper discusses the concepts of ethics, accountability, transparency, integrity and professionalism in the public service. It further attempts to discuss some practices and behaviours which undermine the ethical behaviours of public servants by putting special emphasis on corruption, conflict of interest and human resource management malpractices.

It also discusses the measures which can be taken to reduce the malpractices. Specifically, the paper discusses the Tanzania situation with regard to ethics, accountability, transparency, integrity and professionalism in the country's public service.

It noted that although the current Tanzania government has already attempted to put in place a number of institutional measures to combat evils like corruption, the success of such measures will largely depend on the serious implementation and enforcement mechanisms which the government must put in place.

Administration - Law makers in corrupt systems use their powers to help rent - seekers, not citizenry as a whole.



Bureaucrats are not held accountable for their performance and actually have incentives to delay services in order to extract bribes.

Exacerbated poverty - Corruption lowers the income potential of the poor because there are fewer private sector opportunities. It also limits their access to quality public services such corruption threatens the economic and political fortunes of developing countries the most.

Bribery, conflict of interest, and illegal deals impose heavy costs on the economy while distorting development policies and undermining confidence in public institutions.

Broadly defined, corruption is the abuse of entrusted power for personal gain. However, three specific conditions must apply for an act to be consid-The arm's - length principle is violated. The

two parties in a transaction display bias for working with each other that is inconsistent with impartial

The bias or conflict of interest must be inii. tentional. There must be some advantage for both

parties to commit this violation.

This advantage need not be monetary in nature; it could involve favouritism or non - monetary gifts. Corruption is one of the most serious unethical practices that undermine trust and confidence of public

Public confidence can only be reclaimed by establishing a reputation of integrity. Both business and society bear the costs of corruption through:

Resource Misallocation- Resources that could be put to productive uses are instead devoted to corruption. Firms waste time and resources on rent seeking - cultivating relationships with officials and spending on bribes, Officials make biased decisions (e.g. in investment) that do not serve the public interest, and taxpayers swallow the cost.

Lower investment- Foreign and domestic investors are scared off by unpredictable costs. Rampant corruption signals to potential investors that the rule of law, and thus property rights, are very weak in the country, making an investment there a risky proposition, Lower investment means lower growth.

Reduction in competition, efficiency and innovation - Rent - seeking means that favoured companies do not compete on market signals alone, while new firms face high barriers to entry. Consumers end up paying in terms of higher prices, lower quality, and limited product offerings.

Corruption lowers the income potential of the poor because there are fewer private sector opportunities. It also limits their access to quality public services such as health care and education

Such reforms are crucial to protecting public resources, enhancing public sector performance, and strengthening the government's role in orchestrating development and providing basic services, indeed there is a greater awareness of the need for ethics, accountability, transparency, integrity and professionalism in public life today.

The impact of unethical and criminal practices in the public service is unsupportable in the development of nations, resulting in the loss of confidence in public institutions and the erosion of the rule of law itself.

Furthermore, the notions of ethics and accountability have become more critical in public administration, because of the continued public sector institutional failing that are attributed to public servants' lack of moral values, which in turn, are associated with weak values and weak administrative systems.

It is now a general reality that the quest of the public for responsibility and accountability in government has been stimulated in most democratic states. Some of these have been triggered by events involving politicians and bureaucrats.

Accountability as the "responsibility of government and its agents towards the public to achieve previously set objectives and to account for them in public" It is also regarded as a commitment required from public officials individually and collectively to accept public responsibility for their own action and inaction.

In this case, the burden of accountability rests on each public functionary to act in the public interest and according to his/her conscience, with solutions for every matter based on professionalism and participa-

Lack of transparency and accountabilitywhen deals are made behind closed doors, it becomes impossible to assess the criteria

behind decisions, whether they serve public interest and respect the law. If violators on both the public and private sides conceal their transactions, they escape being accountable.

Low public service salaries - when officials cannot meet what they perceive as their daily needs through their salaries, they resort to corruption to supplement their income. However, simply raising the wages of officials will not curb corruption so long as opportunities to abuse the system persist.

Inadequate, inconsistent, and unfair enforcement of laws and regulations -

Even if laws to combat corruption are on the books, lax enforcement can invite abuse. A weak justice system, low penalties, and high cost of compliance will render laws ineffective

Every honest person should be allowed to give empirical and honest advice to his or her member of parliament. As the case may be, to the Prime Minister, to the head of a department or his Supervisor without fear or favour and shall make all information relevant for decision available to them.

A citizen or public servant shall not conduct himself or herself in a way which:- (a) is illegal (b) is improper (c) is unethical (d) is in breach of constitutional convention or a Professional Code of Ethics and Conduct; (e) is inconsistent with the Public Service Leadership Code of Ethics and Conduct (f) involves possible maladministration.

It is imperative and insisted that citizens or public servants shall conduct themselves in accordance with the provisions of (a) the Public Service Codes of Ethics and Conduct (b) the Public Service Leadership Code of Ethics and Conduct (c) various Professional Codes of Ethics and Conduct; (d) the public service Regulations, the Administrative Directives or Instructions and Orders.

Every citizen or public servant who is aware of any breaches or who has been required by any other public servant and citizen alike, whether senior or junior, to act in a way which raise a fundamental issue of conscience for that public servant, may report that breach to the service or of his employer as the case may be.

Roots of Nigeria's election violence

RESIDENT Muhammadu Buhari has been elected for a second term. Nigerians have also elected new members of the National Assembly, and on 9 March, elections will be held for governors and State Assembly members in 29 of the country's 36 states.

The presidential contest, which featured more than 70 candidates, was largely a straight fight between Buhari of the All Progressives Congress (APC) and former vice president Atiku Abubakar of the main opposition People's Democratic Party (PDP).

The National Peace Committee led a campaign before the polls to stave off a repeat of the deadly pre- and post-election violence of 2011 and 2015.

Inflammatory political rhetoric, opposition parties' allegations of intimidation and partisanship by security forces, partiality of the Independent National Electoral Commission (INEC), and planned illegal voting and results rigging raised the potential for violence.

National security adviser Babagana Monguno said the government had uncovered plots by politicians - ostensibly the opposition - to stockpile weapons and hire thugs and cults to scuttle the polls with violence. A last-minute postponement of the vote by INEC on grounds of logistical constraints inflamed tensions between the APC and

The campaign by the peace committee, a group of eminent Nigerians comprising two senior Muslim and Christian leaders and two former military and political leaders, culminated in political parties including the APC signing the Abuja Accord 2018. A final National Peace Accord was signed by Buhari and Atiku on 13 February.

The signing of peace accords has tended to precede recent Nigerian elections. In January 2015, then president and are bankrolled with oil money. The Goodluck Jonathan and candidate Bu- ability to win contracts depends on

hari signed two agreements before the election, including one at a ceremony attended by representatives of the international community.

However commitments to peace around election time by political parties and candidates isn't enough to bring stability.

In 2011, about 800 were killed in postelection attacks on minorities across northern cities. In 2015 about 100 deaths were recorded. While the commitment promised in peace accords is important, the structural drivers of violence must also be tackled.

Two such drivers are particularly important. One is the state control of productive resources and domination of economic life in Nigeria, which creates the perception of state office as an easy avenue for accumulating wealth.

The other is the politicisation of security and law enforcement institutions and questions about their neutrality.

The 1999 Constitution, the Land Use Act and the Petroleum Act give complete ownership and control of the oil and gas sector to the state. The sector, managed by the Nigerian National Petroleum Corporation (NNPC) through joint ventures with foreign firms, is the mainstay of the economy.

It accounts for more than 50% of government revenue, placing considerable resources at the state's disposal.

The federal government is the sole receiver, divider and dispenser of oil revenue based on a complex formula between itself and the 36 states.

As such, much of the country's economic activity is politically controlled and many private sector players depend on political patronage.

Public works and procurement, whether federal or state, are major sources of business and employment,

For many political candidates, politics has become the only way to improve their lot. For others it is a matter of personal prestige or simply being in control of people and resources. For those seeking economic gain, winning elections is the endgame.

It is common belief that candidates - and their financial backers - invest heavily in elections in order to harvest returns on their 'investments' if and when they win. The stakes become high and the signing of peace accords, although important to reduce the political temperature, are not enough to forestall violence.

Compounding the situation are long-standing religious and ethno-regional tensions that make elections the battleground for political supremacy and resource control among Nigeria's complex

As a campaign strategy, candidates have often used inflammatory rhetoric between rival groups and Christians and Muslims to stoke violence.

To promote future peaceful elections, Nigeria needs constitutional and legal reforms that lessen the political monopolisation of resources. The allure of political power must be reduced, making political office less of an avenue for wealth accumulation.

Inflammatory rhetoric and intimidation should be criminalised. The political control of law enforcement agencies also needs to be minimised to build neutral and professional security services that inspire public trust and

Modern-day slavery rated world's largest single crime industry

Agadez, Niger

GROUP of women are squeezed into a modest room, ready to take their class in a popular dis-**L**trict of Agadez, the largest city in centralNiger.

A blackboard hangs on the wall and Mahaman Alkassoum, chalk in hand, is ready to begin.

A former people smuggler, he is an unusual professor.

His round face and shy expression clash with the image of the ruthless trafficker.

"We're here to help you organise your savings, so that your activities will become profitable," Alkassoum tells the women, before drawing a timeline to illustrate the different stages of starting a

Until mid-2016, both he and the women in the room were employed in Agadez's huge migration market, which offered economic opportunities for thousands of people in an immense desert region, bordering with Algeria, Libya and Chad.

Alkassoum used to pack his pick-up truck with up to 25 migrants at once, driving them across the Sahara from Agadez to the southern Libyan city of Sebha, earning up to 1,500 euros (\$1,706) a month - five times the salary of a local policeman.

The women, his current students, were employed as cooks in the ghettos and yards where migrants were hosted during their stay in town.

At times, they fed 100 people a day and earned about 200 euros (\$227) a month.

For decades, the passage of western African migrants heading to Libya, and eventually to Italian shores, happened in daylight, in full view - and in most cases with the complicity of Niger security

According to a 2016 study by the International Organization for Migration (IOM), migrants in transit had injected about 100 million euros (\$113.8m) into the local economy,

But the "golden age" of migration through Agadez ended abruptly in the summer of 2016 when the government of Niger launched a crackdown on people smuggling.

More than 300 drivers, middlemen and managers of ghettos, have been arrested since then, convincing other col-



leagues - like Alkassoum and his students to abandon their activity.

The driver's new career as a community organiser began right after, when most locals involved in the smuggling business realised they had to somehow reinvent their lives.

At first, a few hundred men, former drivers or managers of ghettos, decided to set up an informal association, with the idea of raising funds between members to launch small commercial activi-

But the project didn't really work, Alkassoum recounts. In early 2018, the leader of the group, a renowned smuggler, disappeared with some of the funds.

Alkassoum, at the time the association's secretary, got discouraged. That was the moment when their fe-

male colleagues showed up.

Most of them were wives or sisters of smugglers, who were cooking for the migrants inside ghettos and, all of a sudden, had also seen their source of income dis-

Resorting to an old experience as a youth leader, Alkassoum decided to help them launch new businesses, through lessons on community participation and bookkeeping.

As of mid-2018, more than 70 women had joined.

"At first we met to share our common suffering after losing our jobs, but soon we realised we needed to do more," says Fatoumata Adiguini at the end of the class.

They decided to launch small businesses, dividing themselves into subgroups, each one developing a specific idea.

Habi Amaloze, a thin Tuareg woman, heads one of the groups: 17 women that called themselves "banda badantchi" - meaning "no difference" in Hausa - to share their common situation.

The banda badantchi started with the cheapest possible activity,

shelling and toasting peanuts to sell on the streets. Other groups collected small sums to buy a sheep, chicks or a sewing machine.

"We started with what we had, which was almost nothing, but we dream to be able one day to open up a restaurant or a small farming activity," explains Amaloze.

While most men left Agadez to find opportunities elsewhere, the women never stopped meeting and built relations of trust.

Besides raising their children, they have another motivation: working with migrants has freed them from marital control, something they are not willing or ready to lose.

According to Rhissa Feltou, the mayor of Agadez, the crackdown on northbound migration responded to European requests more than to local needs.

Among the projects, the creation of a police investigative unit, where French and Spanish policemen helped their Nigerien counterparts to track and arrest smugglers.

Another project, known under its acronym Paiera, aimed at relieving the effect of the migration crackdown in Agadez, included a compensation scheme for smugglers who left their old job. The eight million-euro (\$9.2m) fund was managed by the High Authority for the Consolidation of Peace, a state office tasked with reducing conflicts in border areas.

After endless negotiations between local authorities, EU representatives and a committee representing smugglers, a list of 6,550 smuggling actors operating in the region of Agadez, was finalised in 2017.

But two years after the project's launch, only 371 of them received small sums, about 2,300 euros (\$2,616) per person, to start new activities.

The High Authority for the Consolidation of Peace told Al Jazeera that an additional eight millioneuro fund is available for a second phase of the project, to be launched in March 2019, allowing at least 600 more ex-smugglers to be funded.

But Feltou, the city's mayor, isn't optimistic.

"We waited too much and it's still unclear when and how these new provisions will be delivered," he explains.

Finding viable job opportunities for thousands of drivers, managers of ghettos, middlemen, cooks or water can sellers, who lost their main source of income in a country the United Nations dubbed as the last in its human development index in 2018, is not an easy task.

With seven children, ranging from five to 13 years old, and a sick mother, they settled in a makeshift space used to store building material. Among piles of bricks, they built two shacks out of sticks, paperboard and plastic bags, to keep them safe from sand storms.

"This is all we have now," Amaloze says, pointing to a few burned pots and a mat.

In seven years of work as a cook in her brother's ghetto, she fed tens of thousands of migrants. Now she can hardly feed her family.

"At that time I earned at least 35,000 [West African franc] a week [about \$60], now it can be as low as 2,000 [\$3.4], enough to cook macaroni once a day for the kids, but no sauce," she says, her voice breaking. Only one of her children still at-

tends school. Her experience is familiar among the women she meets weekly. "All of us suffered with the end of migra-

tion in Agadez," she says. Through their groups, they found hope and solidarity. But their future

is still uncertain. "We're toasting peanuts every day and thinking of new ways to earn something," Hamaloze says with a mix of bitterness and deter-

mination. "But, like all our former colleagues, we need real opportunities otherwise migration through Agadez and the Sahara will resume, in a more violent and painful way than before."

Paralegals halt discrimination against woman with disability

A 50-year-old Mwashi Bedo is a disabled woman who lives in Serengeti village, Bunda District.

Like many other people with disabilities in the country, Mwashi lives in severe poverty due to the challenge of securing a steady income for individual upkeep and taking care of the family.

Luckily, Mwashi is blessed with a boy, Michael Mathayo aged 14 who at the tender age had to support her family through small money he gets from petty businesses and farm works at the village.

As a strategy to speed up implementation of development projects in the village, local authorities had set up some rules and regulations, which among other things, require all members to contribute—either labour power or cash money, for every development project..

Two years ago, village authorities set a development priority, construction of a secondary school, asking every villager to contribute 10, 000/- for the project. The whole village was made aware of the project through villagepublic meetings and other platforms

Most of the villagers turned up, con-

tributed money as well as labour power to make sure the project is completed on time, as effectively and efficiently as possible. Due to abject poverty and other factors associated with her disability, Mwashi did not manage to contribute 10,000/- required by the village authorities.

In what could be termed as absolute disregard of disabled rights, local executives went to Mwashi's home and took all her properties—chairs, tables and other domestic appliances, which they planned to sell in order to get the money as her contribution for the construction of a secondary-school project.

She tried unsuccessfully to claim back her properties, as both village chairman and ward executive officer rejected her requests for "exemption" from the community development-fund contribution.

Annoyed by local executives' actions, some fellow villagers advised Mwashi to consult Bunda paralegal organization, who assisted the disabled woman by taking her to Bunda district social welfare and district commissioner offices for further support.

The local district commissioner and social welfare offices issued a letter directing Serengeti village authorities to exempt Mwashi from community development fund contributions.

Paralegal took the letter to Serengeti village authorities, and Mwashiwas immediately erased from the list of potential contributors to the community developments project. Serengeti village executives also returned all Mwashi properties to her home. "I feel happy that paralegals helped me to recover my properties and for ending the hussle I was going through.

Annoyed by local executives' actions, some fellow sillagers advised Mwashi to consult Bunda paralegal any development contribution." says Mwashi.

Having recovered her properties, she is now proceeding with her normal life (of course with great support from her boy) Michael, who works as casual labour in people's farms and engage in other economic activities--earning them income to support themselves.

"People with disabilities and their families are confronted with numerous challenges on a daily basis. Paralegals and other stakeholders should join hands and extend necessary assistance to alleviate these obstacles, improve quality of life and empower people with disabilities to fulfill their potential."- commented one independent social welfare expert, Anna Vitoio

TAMWA in drive to empower Zanzibar children living in difficult environment

THE SOS Children's Villages in collaboration with the Tanzania Media Women's Association (TAMWA) is implementing a project—Community Action on Quality Alternative Care and protection, which aims at empowering economically some poor families in Tumbatu Island in North Unguja region, Zanzibar

More than 10 families living under difficult conditions have been economically empowered to be able to take care of their children. Tumbatu Island has a population of more than 20,000 people of which most of them engage in fishing activities.

The project coordinator from SOS, Nyezuma Simai Iddi said they supporting the residents so that children are taken care at their families instead of orphanage centers.

"We encourage people to take care of their blood children and those who have lost their parents. It is better that children are taken care at home where they can also be taught to live in accordance with our Tanzanian moral", said Nyezuma.

Jongowe Shehia leader, Miza Ali Sharif said they have been educating the community on the importance of raising their own children instead of taking them to government owned orphanage centers.

Sharif said since most of the residents in Tumbatu Island are poor, some men have been dumping their families over live difficulties. He said some of them engage in fishing activities.

"Some fishermen have been left their families for months in search of job in Tanzania mainland", he said adding some of the children have not seen their parents for over six months.

One of the project beneficiaries, Rahma Ali Khamis (35) said; "I can now take care of all the children whose parents died years ago. I commend SOS for giving money to establish a business as well as constructing a house for us".

Miza Mabrouk Jecha, said that what SOS and Tamwa are doing is commendable and have improved the lives of many



people.

Jecha is also taking care of an eight-month infant whose mother has died. She has been empowered to establish a business where she can raise money to properly take care of the

hida Maabad called upon Isle residents to build a culture of taking care of their families by ensuring provision of necessary requirements.

Maabad said that orphanage centres should the last solution, because children can be raised better when they grew up together with other family members.

Vodafone foundation announces global plans for app to help those experiencing domestic abuse

VODAFONE Foundation, Vodafone's philanthropic arm, has announced the international expansion of Bright Sky, a free app which connects victims of domestic violence and abuse to advice and support services.

and support services. Bright Sky, created in partnership with the UK-basedcrisis support charity Hestia, enables users to locate their nearest support centre by searching their area, postcode or current location. A short questionnaire also helps users assess the safety of a relationship and provides information about different forms of abuse, the types of support available, steps to consider if leaving an abusive relationship, and how to help a friend affected by domestic

The app is also designed to log incidents of domestic abuse without any content being saved on the device itself. It enables users to record incidents in a secure digital journal, using a text, audio, video or photo function. Evidence collated through this function will enable police to intervene and can help secure prosecutions.

The first countries outside the UK to launch the app will be the Czech Republic, Ireland, Italy, Malta, Portugal, and Romania. Vodafone Foundation will work with local partners to adapt the content and technology and to integrate it with domestic violence and abuse support infrastructure. Bright Sky has been available in the UK since April 2018 where it has been downloaded more than 10,000 times.

The international roll-out of Bright Sky builds on more than a decade's work by Vodafone Foundation to develop mobile services to support victims of domestic violence and abuse, including the Tec-SOS technology which has helped more 100,000 high risk victims of domestic violence in five countries, Easy Rescue which has supported over 300,000 women in Turkey, and gender based violence hotlines in South Africa and Kenya which have connected over 300,000 women to help during crisis.

Building on Vodafone Foundation's work with the Employers' Initiative on Domestic Abuse in the UK, the Foundation commissioned a study by Opinium, a market research consultancy, to assess the impact of domestic violence and abuse on peo-

ple's work-life and career. The study surveyed4,715working women and men across nine countries(UK, Germany, Ireland, Turkey, South Africa, Kenya, India, Italy and Spain).

The research found that 37 percent of respondents had experienced domestic violence and abuse in some form, 67 percent of respondents that had experienced domestic violence and abuse said that the abuse affected their career progression and 51 percent of respondents that had experienced domestic violence and abuse felt too ashamed to discuss their abuse at work.

It also found that when employees do discuss their abuse at work, 53% said that positive things happened as a consequence and 33 percent said that an app that people can download to access help and support would help reduce the impact of domestic violence on the work lives of employees.

Inspired by the work of Vodafone Foundation, Vodafone Group is announcing today its intention to implement a new HR policy specifically for victims of domestic violence and abuse in 25 of its operating companies. Alongside the research, Vodafone Foundation has worked with domestic violence and abuse expert Dr Jane Pillinger to develop a toolkit for all employers. The toolkit can be downloaded here.

Chinese democracy puts Western illusion in dust

VERY year, just before China's annual two sessions, there are voices in the West declaring that China's democracy cannot truly represent the people. But the Chinese people disagree.

Nearly 3,000 lawmakers and more than 2,000 political advisors are gathering in Beijing to forge consensus and pool wisdom for the building of a moderately prosperous society in all respects, the first of the country's two centenary goals.

This is the mission of the annual sessions of the National People's Congress (NPC), and the National Committee of the Chinese People's Political Consultative Conference (CPPCC), two important platforms for China's own style of democracy. Democracy is not a decoration, but a means of solving problems.

The true meaning of people's democracy is finding the best way to coordinate the aspirations and demands of the whole of society and making decisions that conform to the long-term interest of the people.

It is different from a system where some here-today-gone-tomorrow politicians obtain power in turn, often failing to keep their pre-elections prom-

To govern, in China, also means to serve.While parties in the West increasingly represent special interest groups, Chinese democracy sees people, not capital, as the most important factor in society.

Chinese leaders are listening attentively to the people and responding to their demands. The priorities of the Chinese government are how to keep the economy growing, provide better education, housing, environment, employment and healthcare for almost 1.4 billion people and maintaining social cohesion and peace and while achieving greater prosperity for all the people.

Over the past decades, China has been improving dramatically, not only economically but also ecologically, socially and culturally. China's independence, sovereignty, security and safeguarded.

China's GDP has grown to 90 trillion yuan (13.4 trillion U.S. dollars), contributing about 30 percent of the world's economic growth.

Now the country has the world's largest middle-income population. By 2020, there will be no extreme poverty in China. If this is not a proof of Chinese democracy at work, then what is?China is a large country.

Choosing the right path for its political progress is a fundamental and vital issue. The country began to learn about democracy a century ago, but soon found Western politics did not

Decades of turmoil and civil war followed.It was after the founding of the People's Republic of China that the country developed its own style of democracy.

The first session of the first CPPCC National Committee was held in 1949. The first NPC, the highest organ of state power, was convened in 1954. The two platforms have been witnessing the vitality of Chinese democracy under the leadership of the Communist Party of China.



Sri Lankans risk it all to seek asylum on tiny island near Africa

REUNION

EFORE he decided to undertake a perilous 22-day journey by sea to Reunion, 35-year-old Balapu Waduge Prasad Indika Dilan Mendis had never heard of the tiny French island off the eastern coast of Af-

On March 21 last year, two days after being set adrift on a raft without food or water following a boat mishap, six Sri Lankans including Mendis arrived.

"If we had not been seen by the tourists it would be over for us," he said of the ordeal; Reunion's waters are notorious for

The six men had traversed 4,000km across the Indian Ocean that stretches between South Asia and Africa, crossing the equator along the way.

They came in search of Europe. More would follow.

It was the first of five boats that have brought 145 Sri Lankans to Reunion in less than a year.

On February 5 this year, the latest and largest boatload arrived with 72 people on board, including eight women and five children.

On February 14, 64 were deported after their asylum appeals were rejected.

Reunion, a former French colony which neighbours Mauritius, became an overseas department of France in 1946.

There is a steady trickle of asylum seekers from nearby African islands but its new-found appeal for Sri Lankan asylum seekers has caught French authorities

From 2016 to 2018, the island received 105 asylum applications. Sri Lankans accounted for most requests, followed by Indians and Comorians, according to the prefecture of Reunion.

In public comments, French and Sri Lankan authorities have said that the influx shows that Reunion is now on a human-trafficking route that was earlier taking migrantseastwards.

"Classically immigration was happening towards the east; Indonesia, Malaysia and Australia," said Anthony Goreau, a geographer at the University of Bordeaux.



Reunion, a fraction of the size of Sri Lanka, hosts fewer than one million peo-

But it is not chance that has brought the Sri Lankans to the remote island, according to Goreau.

"You cannot put your fate in the hands of luck when you are going to be on a boat for over two weeks and navigating cyclones," Goreau said.

Four of the five boats arrived in the middle of cyclone season.

Mendis said he was introduced to Reunion by an agent, who showed him a video about the island and promised to arrange passage for a sum of 5,00,000 Sri Lankan rupees, about \$2,800. Others in his group paid between \$1,500 and

He was later taken under the wing of a Catholic priest in Negombo, a major port city north of the capital Colombo, which is predominantly Christian.

cross around his neck, he now lives at a Hindu ashram in Reunion under the care of Swami Advayananda Sarasvati.

The choice of Reunion does not surprise Sarasvati. It is not his first brush with asylum seekers.

"It is the only developed region in the Indian Ocean, they will not go to Seychelles or Mauritius because they know they will be turned back," Sarasvati said. "From the first boat, we knew that more boats will come."

Reunion was settled and colonised by the French in the 17th century and remained largely in French hands with a brief spell of British rule.

Coffee plantations were established after colonisation, soon to be overtaken by sugar plantations that continue to be the mainstay of the economy.

When slavery was abolished in 1848, wage labour was imported from India, China and Africa to work on the plantations. Christianity is the predominant religion but Hindus and Muslims abound.

"There are groups in Sri Lanka that believe that to be Sri Lankan means to be Buddhist," Sarasvati said. "In Reunion all religions live peacefully. They (the asylum seekers) think it is paradise here."

This promise of harmonious existence seems to have attracted not just Sri Lankans, but Indians, as well.

Two Indian Muslims are currently seeking asylum on the grounds that an increasingly assertive Hindu

nationalism poses a threat to them. Most of the labourers from French colonies in south India are of Tamil origin.

The presence of a strong Sri Lankan Tamil community in France,

dhists and most Tamils are Hindus, and particularly in Paris, could also explain the choice of Reunion, experts said.

> However, determining which of the asylum seekers face a genuine threat in their homeland and who are seeking better economic opportunities will be a challenge for French authorities.

The frequency of the arrivals and the relative well-being of the seafarers after almost three weeks on a boat has also raised doubts about the veracity of their stories. However, Sri Lankan asylum seekers are no strangers to long arduous sea

"We were well prepared with food and water and everything was taken care of by the agent," said one Sri Lankan man, who did want to be identified for fear of jeopardising his asylum request.

Until a few years ago, Australia, another distant country, was the destination of choice, but migration to there fell after the country adopted astricter immigration policy - including processing asylum seekers who arrive by boat at offshore facilities in island-nations of Nauru and Papua New Guinea, denying them entry into Australia.

It has also turned back boats to deter those arriving by sea. But Sri Lankans coming to Reunion are risking more than deporta-

A boat bound for the French territory was intercepted by the Sri

Lankan navy in September with 90 people onboard. They are now facing charges because leaving the island without permission is a crime under Sri

Lankan law. Mendis's asylum plea has already been rejected once but he has filed an appeal.

On February 12, he celebrated his first birthday in Reunion, but whether he will be able to start over on the island remains uncertain.

First wind-generated 100 megawatts from Miambo Hewani's project to feed into national grid 2021

HE first wind power generated 100 megawatts will feed into the national grid at Makambako in Wanging'ombe district of Njombe region by mid 2021.

Windlab Development Tanzania Limited's Managing Director, Katherine Persson said constriction work of the project is due to start mid this year with completion of phase one after 15 months. Persson said the 100MW will be generated in the first phase of the U\$250m project.

"We are happy to offer Tanzanians a world-class wind power project which will benefit local communities from Wanging'ombe district upon completion of this project," said Persson.

She further noted that the proposed Mi-

ombo Hewani Wind Farm project will be implemented in three phases and will benefit up to a million people connected to the national grid for up to 30 years.

Persson said, Miombo Hewani has been approved for up to 300MW of generation capacity. The project will be implemented in three phases. "The construction of the first 100MW facility will include up to 34 wind turbines as well as electrical infrastructure connecting the wind farm to the national electricity grid at the Makambako substation," Persson added.

At the completion of the three phases, enough power will be generated to supply up to three million households, based on current per capita usage of the country and will be sold to state owned Tanesco at an affordable price.

In May last year, the project received an

Windlab's assets in East Africa currently consist of a pipeline of development projects totaling around 1,650MW of potential capacity, ranging in status from early-stage projects to the approved 300MW Miombo Hewani Wind Farm in the country which has been short-listed in a government-sponsored off take process.

In Kenya, Windlab has partnered with the Meru County Government in the development of a hybrid renewable energy project consisting of wind, solar, and battery storage for up to 166MW of generation under a public private partnership scheme.

The Next Billion Prize was created to shine a light on those gifted entrepreneurs that are not only ingenious, but also bold and persistent enough to bring forward the revolutionary ideas that are desperately needed to transform education in those parts of the world where there is limited access to high quality teaching," said Vikas Pota, CEO of Tmrw Digital, which runs the Next Billion

tral part of its story telling approach. Mtabe is an artificial intelligence (AI) pow-

ered platform providing personalised instant learning content and answers from a virtual tutor via SMS, using AI to deliver this to students without internet access.

As 70 percent of Africans have no internet access, this particularly impacts secondary school students in rural villages who also do not have access to textbooks (in Tanzania, the textbook-student ratio is 1:10 and teacher-student ratio is 1:55, with an average school having at least 1,500 students).

A flood of Chinese screws, nuts and bolts has hit South **Africa hard**

JOHANNESBURG

THE government has confirmed that a surge in Chinese imports of bolts, nuts and screws is inflicting serious injury on local producers.

After launching an investigation last year, the International Trade Administration Commission of South Africa (Itac) is now satisfied that imports of iron and steel Chinese fasteners is posing a real problem.

In a notice in the government gazette on Friday, Itac - the government body responsible for import and export control - says there is enough evidence of a significant sharp surge in imports, and that it is causing serious harm to local producers.

Next, the commission will decide whether a "safeguard" is needed. This is usually an emergency measure that restricts imports through a quota or extra import duties. (Stainless steel bolts, nuts and screws won't be affected.)

Itac considered evidence from T&I Chalmers Engineering in Johannesburg, which produces more than 70% of the bolt ends and screw studs in South Africa, and from other companies that manufacture hexagon nuts including Transvaal Pressed Nuts, Bolts & Rivets, CBC Fasteners and SA Bolt Manufacturers, which together deliver more than 90% of total output.

Itac heard that there is currently a large oversupply of fasteners worldwide, which has caused a surge in imports to South Africa.

A slowdown in the Chinese economy has contributed to a large amount of unused stock, resulting in largerthan-usual cheap exports. Canada and the US have already taken action against Chinese imports.

The South African government has imposed and scrapped anti-dumping duties on Chinese nuts and bolts at various times since 1999.

In 2016, it removed anti-dumping duties of up to 122% on Chinese fastener imports. More than R2 billion worth of fasteners are imported to South Africa a year.

US keeps air pollution standard established under Obama

NEW YORK

US environmental regulators have announced they are leaving intact an air quality standard for power plant pollution that can worsen asthma in children, despite calls by health advocates

for a tougher rule. The move keeps in place a threshold for sulfur dioxide pollution established in 2010 by the US Environmental Protection Agency under then US President Barack Obama (pictured). Sulfur

dioxide comes from burning coal to produce electricity and from other industrial sources.

Advocacy groups including the American Lung Association had urged EPA to lower the amount of the pollution it allows, from 75 parts per billion of sulfur dioxide in ambient air to 50 parts per billion. The existing standard puts millions of people at increased risk of asthma attacks, said Janice Nolen, the association's vice



385,000 worldwide died prematurely in 2015 from air pollution caused by vehicle exhaust emissions, a US study has found. Diesel engines were singled out as the main culprit. On the other side of the issue, the American Petroleum Institute contended the Obama-era rules were overly stringent and wanted them relaxed.

EPA regulators rejected the calls for change, saying a lengthy review confirmed the existing

and sufficient to protect public health.

Studies show people with asthma can experience problems following just five minutes of exposure to air with elevated sulfur dioxide levels, the EPA concluded. But the agency said the 2010 air quality threshold provided "an adequate margin of safety" from the pollutant's damaging health effects.

people standard was both necessary dropped sharply in recent decades due to industry regulations and the declining use of coal among electric utilities. Between 2010 and 2016, sulfur dioxide emissions nationwide dropped 64%, according to the EPA.

> Nevertheless, areas of 17 states and two US territories remained out of compliance with the 2010 standard as of last month, according to EPA records. More than 3 million people live in those areas, Nolen said.


A main reason it's taking so long to get full compliance is the heavy workload involved, said Janet McCabe, a former senior official at EPA under Obama. Government officials first must figure out which power plants are causing the pollution, and then work with companies on plans to reduce it.

"It takes years," McCabe, said. "Recognising that all that time, people are exposed to levels of sulfur dioxide that the EPA has deemed not to be healthy."



Gold on course for worst week since November as dollar rises

- * Gold down 1.4 percent so far this week
- * SPDR gold holdings fall to lowest since December
- * Dollar hits 10-week high vs yen

LONDON, March 1 (Reuters) -Gold slipped to two-week lows and was set for its biggest weekly fall in nearly four months on Friday, pressured by a reviving dollar and rising stocks.

Spot gold is down about 1.4 percent so far this week, which could be its biggest weekly decline since the week ending November 9. It was down 0.3 percent at \$1,309.13 an ounce at 1103 GMT, having touched its lowest since Feb. 14 at \$1,305.53.

U.S. gold futures shed 0.4 percent to \$1,310.40.

"The news on jobs and Gross Domestic Product (GDP) was more favourable for the dollar, which has been gaining value. Because of that we are continuing to see some long liquidations," Afshin Nabavi, senior vice president at MKS SA, said.

"We have breached \$1,315 and \$1,310, which are very important support levels. Won't be surprised even if we see a test of \$1,300 later today.

The dollar, which gained impetus from better than expected fourth quarter U.S. GDP

data, hit a 10-week high against the yen. "Rallies in the dollar are taking their toll on gold much more than they were a few weeks ago which is a clear sign that senti-

Gold rose to a 10-month peak of \$1,346.73 last week, helped by expectations that the U.S. central bank will pause interest rate increases, but has lost ground since as the dollar regained momentum.

"After it (gold) failed last week to rise above \$1,350, the gold price is nearing the psychologically important \$1,300 per troy ounce mark again today," Commerzbank

Holdings of the SPDR Gold Trust, the world's largest gold-backed exchange-traded fund, fell 0.52 percent to 784.22 tonnes on Thursday, falling to their lowest level since late December.

Among other precious metals, spot palladium fell 0.6 percent to \$1,534.31 per ounce, retreating from its all-time peak of \$1,565.09 scaled earlier in the week. The metal is on course for a fourth consecutive week of gains.



In 2020 battleground state, looming Mueller report could hold dangers for Democrats

REEDSBURG, WIS

INSIDE the Touchdown Tavern in the presidential battleground state of Wisconsin, voter Aric Nowicki worries over how the impending release of Special Counsel Robert Mueller's Russia investigation could affect the 2020 election for president.

Nowicki (pictured) is not concerned about potential harm to President Donald Trump if Mueller accuses the Republican's campaign of working with Russia to influence the 2016 election. Instead, the heating and air-conditioning business owner fears the report could prove a political landmine for overzealous Democrats trying to take down a president they despise.


"They absolutely run the risk of overhyping it and overblowing it,"

Nowicki, 41, who voted for Democrat Hillary Clinton in 2016, said in Reedsburg, in southwest Wisconson. "If they take the report and spin it too far, they could end up helping Trump."

At first glance, the long-awaited Mueller report might seem a political gift for Democrats aiming to reclaim the White House next year.

If Mueller finds Trump played a role in a conspiracy with Moscow to boost his chances of winning the election or committed obstruction of justice to try to impede the probe - allegations Trump denies - the Democratic-led U.S. House of Representatives could launch impeachment proceedings against the president.

lican, Democratic and independent strategists and analysts.

The top U.S. Democrat, House Speaker Nancy Pelosi, has tried to temper talk about impeaching Trump, noting the process is "divisive."

Mueller is widely expected to finish the investigation in the coming weeks. Strategists said candidates who focus too intently on the findings run the risk of appearing shrill and partisan. That could alienate general election voters in key battlegrounds including Wisconsin, Michigan and Pennsylvania, which went for Democratic former President Barack Obama in 2012 but for Trump in 2016.

Yet delivering a reaction that is too muted or measured might lose votes during the party's nominating battle, where the Russia investigation and attacking Trump animate the base.

"There is a case to prosecute against Trump with regard to his record in office. That is where I would focus," said Karen Finney, a Democratic clusions will be a delicate dance for strategist not affiliated with any presidential

Finney, who worked inside the Bill Clinton White House during the Monica Lewinsky scandal, said Democrats should bear in mind how Republicans overplayed their hand 20 years ago. Their impeachment of Clinton and focus on the scandal backfired with voters, allowing Clinton to regain the political momentum and costing Republicans congressional seats.

Strategists in both major parties said Democratic candidates should be wary about talk of impeaching Trump or putting too much emphasis on the report in general.

"We should not be gambling our future prospects of winning back the White House on what is in the Mueller report," said Maria Cardona, a Democratic strategist who worked for Hillary Clinton and Obama's presidential campaigns. "Voters want candidates to focus on issues important to them, such as healthcare and goodpaying jobs."

Strategists interviewed by Reuters said Trump likely would not suffer badly even if Mueller finds evidence damaging to him. His supporters, who are fiercely loyal, will probably see claims of wrongdoing as proof there is an FBI conspiracy against Trump, energizing them further.

According to a January Reuters/Ipsos poll, more than two-thirds of Republicans believe the FBI and Department of Justice "are working to delegitimize President Trump through politically motivated investigations."

'SO SICK OF IT'

The complexities and ramifications of the Russia investigation, while an obsession in Washington, barely registered for many voters who spoke to Reuters in the past week in snowy southwest Wisconsin.

Somali women leaders urge Parliament to pass electoral bill

MOGADISHU

SOMALI women leaders have called on lawmakers to approve a pending electoral reform bill that would enshrine the principle of a 30 percent gender quota in future national legislatures.

Speaking at a roundtable forum which brought together more than 30 women representing parliament, civil society, the National Independent Electoral Commission (NIEC), diaspora communities, political parties and academia, the women also reviewed the challenges still facing them as they prepare for one-person, one-vote elections scheduled to take place in 2020.

"The electoral law which provides for the 30 percent quota on women representation has not been passed, and it is our hope



that it is passed by both the House of the People and the Senate and the draft constitution will also be amended to reflect that,"

Asha Abdulle Siyad (pictured), chairperson of the Somali Women's Leadership Initiative, said according to a statement issued by the UN Assistance Mission in Somalia (UNSOM) on Sunday evening.

A joint communique on the way forward will be issued at a three-day Somali Women's Convention, which kicked off in Mogadishu yesterday. Halima Ismail Ibrahim, NIEC chairperson noted that the discussions will help Somali women overcome the obstacles that surface during elections.

"This conference is about the rights of the Somali women and coincides with the events to mark the International Women's

Day," said Ibrahim. She added that the electoral commission will work closely with civil society to educate the public about the electoral reforms being undertaken ahead of the country's next round of elections.

The women leaders discussed a variety of topics ranging from the constitutional review process and affirmative action to electoral and political party processes and barriers to women's participation in politics.

The roundtable was supported by the UN mission and is one in a series of events organized by Somali women leaders ahead of the International Women's Day celebrations that will be held on Friday.

During the 2016 electoral process, female representation in the federal parliament rose from 14 percent in the outgoing legislature to 24 percent. However, the increase fell short of the 30 percent quota goal. which women leaders are planning to endorse for the 2020 elections. **Xinhua**

China sees stepped up economic, trade talks with US

BEIJING

CHINA and the United States should step up economic and trade consultations to reach a mutually beneficial agreement, a spokesperson for the annual session of China's national legislature said yesterday.

Economic and trade teams from both sides have recently carried out intensive and productive consultations and made important progress on many issues of common concern, Zhang Yesui, spokesperson for the second session of the 13th National People's Congress, said at a press conference.

Both countries and the international community have responded positively to the progress, he said. Cooperation is the best option for China and the US while a confrontational relationship would serve neither side's interests, the spokesperson said.

"We believe the China-US economic and trade relations are mutually beneficial in essence, so we hope the two sides can continue to step up consultations to reach a win-win agreement," Zhang said.

While the national defense spending in some major developed countries accounted for more than 2 percent of their GDP, the ratio was only about 1.3 percent for China in 2018, according to Zhang.

"China maintains a reasonable and appropriate growth rate in its defense expenditure to meet its demand in safeguarding national security and military reform with Chinese characteristics," he said.

Double standards 'not fair'

Zhang said the tendency of some US officials to play up security risks in Chinese products was nothing but interference in economic activities by political means, the spokesperson said.

He said it was against the rules of the World Trade Organization, and disrupted the international market order based on fair

tendency as a typical practice of double standards that was neither fair nor moral.

Hope for continued DPRK-US

At the press conference, Zhang said China hopes the Democratic People's Republic of Korea (DPRK) and the US will continue talks and stick to political solution which is key to resolving the Korean Peninsular issue.

The spokesperson described the recent meeting between the DPRK and US leaders in Hanoi as "constructive"

Zhang hoped the DPRK and the US would keep good faith, remain patient, and continue to engage in talks.

152 Belt and Road deals clinched

Diplomat warns 'Skripal saga' will be brought to logical conclusion

MOSCOW

RUSSIA will not put the story involving the poisoning of former Russian intelligence officer Sergei Skripal and his



daughter Yulia on the back burner, Russian Foreign Ministry Spokeswoman Maria Zakharova said in an interview with the Komsomolskaya Pravda daily published yesterday.

She pointed to the absurdity of Britain's attempts to conceal the details of the Skripals' poisoning, stressing that Russian diplomats cannot receive answers to "the simplest questions."

"The absurdity is the absence of the chronology of events of that day or those days, what time and what happened, and who was where," the diplomat said.

Zakharova warned that Moscow would do its utmost to get information on what happened to the Skripals. "If someone in the UK. Washington or Brussels believes that Russia will put the issue on the back burner, they are grossly mistaken.

We are polite and patient people. The combination of these two factors can be fatal for some skeptics. I believe this story will be brought to its logical conclusion."

The diplomat also raised the issue of impunity of those who were convicted by Russian courts and who are currently in the UK.

"Over the past decade, dozens of requests to extradite those people who were convicted by Russian courts (and previously accused of illegal financial or economic activities) have been forwarded to Britain. <...> Most of these requests have remained unanswered. Brit-

ain has created comfortable conditions for people who violate laws in their own countries (not only in Russia), take dirty money [out of the country] and make it clean in London and its environs.

However, in those cases, the British government for some reason does not impose sanctions on itself for encouraging dirty financial schemes, money and bank accounts,' Zakharova stressed. **Agencies**

S. Korean president calls for continued DPRK-US talks to strike deal on Korean Peninsula denuclearisation

SEOUL

SOUTH Korean President Moon Jaein expressed hope on Monday that the Democratic People's Republic of Korea (DPRK) and the United States could continue their talks to strike a deal on denuclearization of the Korean Peninsula "in

the end." Moon made the remarks during a plenary session of the National Security Council (NSC), according to the presidential Blue House.

The NSC meeting was chaired by Moon in about nine months since he presided it over on June 14 2018, two

days after the first summit between top DPRK leader Kim Jong Un and U.S. President Donald Trump in Singapore.

Kim and Trump ended their second meeting in the Vietnamese capital of Hanoi last week without any agreement. "We wish the two countries continue

talks. (We) anticipate the two leaders meet again as soon as possible to strike the delayed deal," said Moon. Moon said it would never be desirable for Pyongyang and Washington to halt dialogue for long, and he believed that the two sides

would reach an agreement "in the end." He said South Korea could play a significant role in helping the two sides strike a deal, indicating his willingness to broker a compromise between the DPRK and the United States.

The president instructed the NSC to make efforts for the rapid resumption of working-level talks between Pyongyang and Washington, and try their best to find measures contributing to the DPRK-U.S. dialogue resumption through the development of inter-Korean relations without violating international

The NSC meeting was attended by prime minister, ministers of foreign affairs, unification and defense, intelligence agency chief, presidential chief of staff, top national security advisor and secretaries for security and foreign af-

Moon said the second DPRK-U.S. summit confirmed "very important fruits" that the two sides bore through dialogue, noting that Kim and Trump discussed the dismantlement of the DPRK's Yongbyon nuclear complex.

He said the verifiable dismantlement of the Yongbyon nuclear facility, which he said is a core of the DPRK's nuclear programme, was within a possible

If all the plutonium-reprocessing and

uranium-enrichment facilities in Yongbyon are completely dismantled, it will mark an irreversible phase for the peninsula's denuclearization, Moon noted.

Moon said relief from sanctions against Pyongyang was also discussed at the Hanoi summit, which he called a great progress as it meant the two sides entering a phase of trading denuclearization and corresponding measures.

During the Hanoi summit, Kim and Trump discussed the establishment of U.S. liaison office in Pyongyang that has a "great meaning" in the process going toward normalized relations between the DPRK and the United States, the

South Korean leader noted.

What is different from the past, Moon said there has been neither condemnation from either side nor tensions raised even after the DPRK and the United States ended their talks without any

Moon said the leaders of the DPRK and the United States expressed their unwavering trust to each other and made clear their willingness to continue talks to strike a deal. It indicated the second Kim-Trump summit was in the process of going toward a greater agreement, though it takes time, Moon added.

When music producers are accused of being predators

JESSIE Woo just wanted to sing. So when the budding vocalist met a successful music producer who told her he wanted to help her with her music, she believed him.

Then, one night seven years ago, the producer raped her, she said.

It was not the only time she was preyed upon by male producers early in her career, said Woo, a cast member of VH1 s "Love & Hip Hop Miami" and host of several programs for BET Networks.

"With these producers, they're putting you in rooms that you've dreamed of. You're in the studio with artists like ... Lil Wayne, you're seeing T-Pain, you're seeing Beyonce.

You're just seeing all these people stop by," she said. "So, you're like, 'OK, this person is a little creepy, but I have to be here ... I'm in the right place, I just got to maneuver around this person's creepiness. I got to figure out how to dodge the bullet.' And you're dodging somebody who is set out to abuse you."

Other women navigating the pop music industry have started to speak out about similar experiences, after the #MeToo movement has toppled powerful men in Hollywood, politics, business and more. As in those arenas, women can often find themselves being abused, sometimes sexually, by powerful men who hold the keys to success.

In 2017, Jessie Reyez, the singer who co-wrote the recent Calvin Harris hits "One Kiss" (with Dua Lipa) and "Promises" (with Sam Smith), released a powerful short film for her song "Gatekeeper." In it, she described how she was harassed by a producer: "Oh I'm the gatekeeper/Spread vour legs/Open up/You could be famous/If you come up anywhere else, I'll erase you."

Last year, she identified her tormentor as music producer Noel "Detail" Fisher, who won a Grammy for co-writing the Beyonce and Jay-Z hit "Drunk in Love." Reyez said he had tried to belittle and demean her for not having sex with him, and for not having sex to advance her

Attempts to reach Fisher - who has also produced hits for Lil Wayne, Nicki Minai, Wiz Khalifa and more – for comment about her allegation and others that followed were unsuccessful. Calls to phone numbers linked to him and to his relatives went unanswered.

Reyez's accusations were echoed by others who painted Fisher as a serial abuser.

#METOO No wonder why I connected with your song GateKeepers @jessiereyez," singer Bebe Rexha, 29, wrote on Instagram in May 2018. "He tried the same thing with me. I was just 19. I ran out of the studio crying. Awful Human."

Another singer, Tinashe, commented on Rexha's post: "The only session I've been in to this day where I left due to being soooo uncomfortable. Glad he's being exposed for the

(expletive) creep he is. Disgusting." Janae Knox filed a lawsuit against Fisher in June 2018, claiming that after she was hired as his assistant, she experienced "severe and pervasive sexual harassment and sexual assault by Fisher," according to court documents. The suit claims Fisher asked Knox to shower with him and demanded sexual favors while she performed her job.

"Detail is a sexual predator and it is troubling that I was one of his victims. I want to encourage other victims to come forward because by doing so, they will begin to heal," Knox said in a statement to The Associated Press.

Isabella Mack, another Fisher assistant, filed a complaint against him when Knox did, claiming she was forcefully held against her will while he masturbated. The suit said Fisher also demanded she pose for nude pictures and videos, and that Mack suffered extreme emotional distress as a result.

"Detail has to be held accountable for his actions. I also hope that other music industry victims come forward because it is time to expose the system that enables men to abuse women in this business," Mack said in a statement to the AP.

Another suit against Fisher was filed in December by aspiring musician and model Kristina Buch.

Fisher has yet to enter a legal response to either of the cases filed last year, and attempts to find a lawyer representing him were unsuccessful.

Attorney Genie Harrison, representing Knox and Mack, said her clients "chose to hold Detail accountable" and are letting "other victims know they are not alone."

"Whether it's in music, or film, or corporate America, the abuse of power to coerce sex must end. The brave #MeTooInMusic victims who come forward will help accomplish this goal," Harrison continued in a statement.

Some such allegations were made long before the #MeToo movement, which started in the wake of reports of sexual misconduct by the Hollywood producer Harvey Weinstein. Lady Gaga, 32, said she was sexually assaulted by a music producer when she was 19 – before she released her debut album in 2008 and became a multiplatinum, Grammy- and Oscar-winning

"It's something in my life that's always really kind of defined me up until this point," Gaga, told the AP in 2016.

For years, pop singer Kesha has been battling her former producer, Dr. Luke, in court after she claimed he drugged, sexually abused and psychologically tormented her - allegations that Dr. Luke, who has crafted hits for Katy Perry, Kelly Clarkson, Britney Spears and more, has denied. (Kesha voluntarily dismissed her case in 2016; Dr. Luke's defamation case against her is ongoing).

And of course, R. Kelly - a multiplatinum R&B superstar who also has created smashes for Michael Jackson, Celine Dion, Maxwell and many more - has pleaded innocent to charges with aggravated sexual abuse involving four victims, including at least three between the ages of 13 and 17.

For Kelly, the charges are just the latest in a long line of accusations against him; he was accused of child pornography for allegedly having sex with a preteen but was acquitted in

He also secretly married his then protege, the late R&B superstar Aaliyah, when she was just 15; the marriage was later annulled. Kelly has been accused of luring women with promises of helping their music careers, then abusing them; some women have accused him of keeping them as virtual slaves. He has denied all allegations abuse, and his lawyer called him an "innocent man."

Others continue to come forward with new allegations against powerful men in the industry. Last month, in a New York Times report, several women claimed Ryan Adams - the critically acclaimed, Grammy-nominated singersongwriter who also worked as a producer for Willie Nelson, Jenny Lewis and more - offered to help them with their music careers but then turned things sexual, and he sometimes became emotional and verbally abusive.

In response, Adams acknowledged he was not "a perfect man" and had made mistakes but called the report inaccurate and said it contained exaggerated stories and falsehoods.

Following the report, more female musicians opened up about bad experiences with the rocker, including Nashville-based singersongwriter Ruby Amanfu, who said she was emotionally abused by Adams in a lengthy Facebook post.

'How to Train Your Dragon 3' stays victorious, 'Madea Family Funeral' scores strong debut

LOS ANGELES

AFTER a close race for the top spot in North America, Universal and DreamWorks' "How to Train Your Dragon: The Hidden World" pulled ahead to secure the domestic box of-

fice crown. The final installment in the "Dragon" trilogy stayed strong, adding another \$30 million in its second weekend of release. The animated adventure is just shy of the \$100 million mark in North America with its domestic tally currently sitting at \$97.6 million.

"The Hidden World" is performing in line with the first two entries in the franchise, which ended their domestic box office runs with \$217 million and \$177 million, respectively.

While "How to Train Your Dragon 3" fended off newcomers to repeat No. 1, Tyler Perry's "A Madea Family Funeral" still had a solid start of its own. Perry bid a farewell to his long-running Madea character in the 11th and final installment in the 15-year franchise. It opened ahead of expectations, pocketing \$27 million from 2,442 theaters.

"Madea Family Funeral," which Perry directs, stars in, and produces, marks the end of his partnership with Lionsgate. Like previous "Madea" entries, audiences were more receptive to the eccentric character than critics were. The film nabbed a promising A-CinemaScore, while its Rotten Tomato score is a less-enthusiastic 25 percent. Moviegoers over the age of 25 accounted for 78 percent of its opening weekend, while 67 percent of crowds were female.

"Madea" had the best showing by far among new offerings. Focus Features' "Greta," a psychological thriller film starring Chloe Grace Moretz and Isabelle Huppert, launched below projections. Directed by Neil Jordan, "Greta" bowed in seventh place with a tepid \$4.5 million from 2,411 venues. Meanwhile, Universal's "Green

The film expanded back to 2,600 screens after nabbing the Academy Award for best picture. It secured fifth place in its 16th weekend of release, amassing \$4.7 million.

The road-trip drama had a slow start when it first debuted in November, but "Green Book" has been chugging along in theaters and saw a sizable bump in ticket sales after getting some awards love. Now that it claimed the entertainment industry's top prize, the movie got a 121 percent boost in revenue. "Green Book" has earned \$75 million in North America and \$74 million overseas.

Also cashing in on Oscar glory was Sony's "Spider-Man: Into the Spider-Verse." The comic-book adventure was awarded best animated feature last Sunday, and brought in \$2.1 million after the studio re-released it in 2,404 locations. The movie has grossed over \$360 million globally, including \$187 million at the domestic box office.

Likewise, Warner Bros. set a limited re-release for its Oscar-winning "A Star Is Born" with an added 12 minutes of footage. It saw a 209 percent increase

Book" benefitted from Oscar glory. in ticket sales, pocketing \$1.8 million from 1,150 screens. That's a nice chunk of change, considering the musical drama starring Bradley Cooper and Lady Gaga first debuted in October and is already available on home entertainment. "A Star Is Born" has grossed \$212 million at the domestic box office and \$214 million internationally.

Otherwise, a number of holdovers rounded out the top five. Third place went to Fox's "Alita: Battle Angel," which earned \$7 million in its third weekend of release. Produced by James Cameron and directed by Robert Rodriguez, the sci-fi adventure has pocketed \$72.5 million at the domestic

box office. The cyborg heroine is resonating overseas, where "Alita" has generated \$278 million. That's a good sign for Fox as its possible final film before merging with Disney cost \$170 million to produce and millions more in marketing and distribution. All that CGI doesn't come cheap, and executives at rival studios estimate that "Alita: Battle Angel" will need to gross \$500 million before it can turn a profit. Fox insiders,

however, claim the break-even number is closer to \$350 million, meaning "Alita" might already be climbing out of the red.

Warner Bros.' "The Lego Movie 2: The Second Part" landed at No. 4 with \$6 million, bringing its North American haul to \$91 million. Despite positive reviews, the animated sequel has continued to pace well behind its predecessors. "The Lego Movie" opened in 2014 and ended its theatrical run with a massive \$469 million worldwide, including \$257 million at the domestic box office.

With the sequel's current global sum hovering around \$152 million, it's unlikely "The Lego Movie 2" will reach the level of the original movie. Industry analysts suggest that's partially because the studio waited five years before releasing a direct sequel and instead dropped two spinoffs -"The Lego Batman Movie" and "The Lego Ninjago Movie" - in 2017. The back-to-back offshoots in the same year already experienced diminishing returns, signaling there can indeed be too much of a good thing.

At the specialty box office, Neon and CNN Film's documentary "Apollo 11" made \$1.65 million when it launched on 120 Imax screens for a theater average of \$13,750. Directed by Todd Douglas Miller, the non-fiction film about Neil Armstrong and Buzz Aldrin's historic moon landing expands nationwide on March 8.

The domestic box office continues to fall well behind 2018's record year. According to Comscore, ticket sales have seen a 26 percent drop compared to this time last year, when "Black Panther" was still dominating multiplexes. Box office watchers are hopeful that Disney-Marvel's first female-led superhero adventure could turn things around when "Captain Marvel" debuts next weekend.

The two dropped points means Manchester City are now outright leaders by a point with nine matches remaining for each side in the Premier League run-in. Klopp's team have now won only two of their past six league matches.

In the second half at Goodison Park the manager brought on two attack-minded players - Roberto Firmino and Adam Lallana - plus a midfielder in James Milner. Asked if he should have gone for the jugular by bringing on three attackers, Klopp made clear his unhappiness with the query.

"Do you think we didn't take enough risks today? That's a really disappointing question - do you think it's PlayStation? Bring an extra attacker, and everything change? Football is not like that. We don't lose our nerve," he said.

Klopp added there was no need players. "We are not little boys any more. I believe 100% in our chances," he said before making a joke about whether there will be more twists and turns in the title race. "At

least one," the manager said.

"But we have Burnley [next] so how can I say about what will happen - that would be disrespectful. I already know what the pundits will say in the studio - situations like today you have to finish it off.

"I'm completely fine with chasing [City]. Who wants to be top of the table at the beginning of March? It is nice but there are lots of games to play. I watched Match of the Day last night and saw the celebrations of Man City, they had 900 chances and scored one goal [in a 1-0 win at Bournemouth], a shot with the wrong foot. You have to be ready for these chances.

"We do not think about City when they are a point behind us, now we are behind them but not too far. They have to win, we have to win and let's see who wins more at the end." Klopp, who laughed off an exchange with an Everton ballboy who appeared to mock him with applause towards the end of the game, also pointed to the weather as having an impact on the contest. "The wind does not help and there was a lot today," he said.

"You have to be ready for the fight for a "don't panic" message to his of the second ball. It is OK [the result] - a difficult game for different reasons and a wild opponent. The wind was coming from all directions and did not help anybody.

Chelsea's Sarri praises recalled Kepa as keeper shines

LONDON

CHELSEA manager Maurizio Sarri was in the mood to forgive and forget after his recalled goalkeeper Kepa Arrizabalaga produced a fine display in their 2-1 win at Fulham in the Premier League on Sunday.

Just a week after Arrizabalaga's now infamous refusal to be substituted in Chelsea's League Cup final defeat by Manchester City had enraged Sarri, the young keeper was left to bathe in the Italian's praise for his excellence at Craven Cottage.

"He played very well, it was a normal decision (to bring him back)," Sarri told Sky Sports as Chelsea moved within aimed at midfield lynchpin Jorginho, two points of fourth spot in the race who had not previously found the net for Champions League football.

"He paid with the club and the team, now the situation is closed. There wasn't another way but I think that Kepa is a man. He understood and reacted really very well."

As a punishment for his Wembley defiance, Sarri had dropped Arrizabalaga for the midweek defeat of Tottenham Hotspur and the Spaniard, who apologised to the club and his team mates for his actions, was also fined a week's wages.

"I spoke with him during the week, he understood," Sarri added. "His training was really very good, the reaction today was very good. I know the man, he is very good. He made a mistake, but now that is enough."

Having drafted Arrizabalaga back into the lineup for the west London derby after Willy Caballero had filled in for him expertly in the 2-0 win over Spurs, Sarri was rewarded with a top performance after one early, careless handling error.

With Chelsea 1-0 up, the Spaniard made a brilliant, acrobatic save to keep out Aleksandar Mitrovic and also repelled efforts from Tom Cairney and Joe Bryan as his side recorded a second straight win with goals by Gonzalo Higuain and Jorginho.

Sarri was delighted for his first-half scorers, especially after the criticism from open play for Chelsea and who has been seen as an underwhelming

"My opinion about Jorginho is the same," said Sarri. "He is a great player, one of the most important in Europe in that position. It is not easy in a first season in this team."

After Higuain notched his third Chelsea goal since joining the club on loan from Juventus, Sarri added: "He is one of the best strikers in Europe. He is not at his top level physically but could have scored three times today.

"He is improving and in a couple of weeks he will be able to be at his top."

Barca hailed as championselect after beating Madrid

BARCELONA

BARCELONA were hailed as La Liga champions-elect in the Catalan media after their 1-0 win at Real Madrid on Saturday, while the capital's press called for sweeping changes at Real after another domestic failure.

Ivan Rakitic's cool strike in the first half was enough to see off Real and send Barca 12 points clear of their historic rivals, as well as giving them a 10-point cushion over nearest challengers Atletico Madrid.

"They are like champions," said the cover of Barcelona-based newspaper Sport, describing the win, which came three days after a 3-0 victory over Madrid in the Copa del Rey semi-finals, as "another assault on the Santiago Bernabeu".

Mundo Deportivo, another Barcelona daily, likened the victory and the team's jubilant celebrations to "a dance", adding: "Barca can almost touch the title after killing off Ma-

Barca became the first team in the history of La Liga to win four league games in a row at Real Madrid,

prompting Sport to gloat about the Catalan side's hegemony on enemy territory.

"Barca can now take the keys to the Bernabeu, a stadium which they have made their home and where they feel no fear at all, only pleasure," said the newspaper's editor.

"Barca strike another blow, leaving Real without the Cup or La Liga in the space of three days," said Madrid-based newspaper Marca.

Fellow Madrid daily AS said: "Madrid give up" on its front page, and also spoke of it being the end of an era for many of the club's players who appear to be beyond their best, such as Sergio Ramos, Gareth Bale, Toni Kroos and Marcelo.

"This is a crisis which obliges the club to reinvent itself in the summer in a profound way after a turbulent year," said the newspaper.

"Changes need to be made in the dugout, as coach Santiago Solari has run out of credit, and above all in the squad, where players with huge salaries and inflated statuses are being shown up."

Title-chasing Liverpool frustrated in goalless derby draw at Goodson Park

LIVERPOOL were left a point behind Premier League leaders Manchester City after they were held 0-0 by Everton in Sunday's Merseyside derby – the fourth draw in six games for Juergen Klopp's side.

City, who won 1-0 at Bournemouth on Saturday, have 71 points while Liverpool are on 70, with both teams having nine games to play

It promises to be a tense and thrilling finale to the season but Liverpool, who have frittered away a seven-point lead, will need to regain their momentum quickly if they are to push for their first league title since 1990.

"I'm completely fine with chasing," said Klopp.

"Who wants to be top of the table at the beginning of March? It is nice but there are lots of games to play."

The result of a typically frantic derby on its own is no cause for alarm for Klopp, but the eight-point swing to City since Jan. 30 is a trend they simply have to end.

There were few chances for either team, with Liverpool's forward line failing to sparkle and Everton's impressive industry not matched by craft in the final third.

Everton were desperate to stop their rivals picking up maximum points with manager Marco Silva adjusting his team accordingly as Morgan Schneiderlin was preferred to the more creative Andre Gomes. It proved a smart move with Liverpool's Georginio Wijnaldum having limited impact in a crowded midfield.

The home crowd created an intense and passionate atmosphere at Goodison Park, something of a rare occurrence in another disappointing season for Merseyside's

were amazing and they pushed the team from the first minute," said Silva.

Mohamed Salah had the two best openings for Liverpool before the break but his soft 15th minute shot barely troubled Jordan Pickford and then the Everton keeper was swift off his line to foil the Egyptian as he raced goalwards.

Everton harried and disrupted Liverpool well but struggled to create opportunities with Theo Walcott unable to capitalise on a rare opening, screwing his shot wide, and Alisson keeping out a Dominic Calvert-Lewin header.

Salah threatened again in the 57th

minute as he bore down on Pickford but Everton defender Michael Keane stopped a near certain goal with a perfectly timed last-ditch sliding tackle.

Fabinho, who delivered a masterclass in the modern holding midfielder role, was too slow to react to a nod down from Virgil van Dijk in the box, allowing Everton to scurry the ball clear.

Klopp threw on Roberto Firmino in the 63rd minute but the striker was unable to open up an Everton defence that raised their game to deal a blow to their local rivals' title hopes.

"I don't think anyone wants their rivals

to win the title," said the outstanding

Everton fans taunted their rivals at the end, suggesting that Liverpool were not going to win any trophies this season, but Klopp insisted there was no panic in his

Madrid wracked by goalscoring struggles as Ajax visit

AFTER their domestic season was left in tatters by back-to-back defeats to Barcelona, Real Madrid have been left to focus yet again on winning the Champions League as the only way to salvage a turbulent campaign.

Yet as the triple European Cup holders prepare to host Ajax Amsterdam on Tuesday in the second leg of their last-16 tie, they are suffering from a goalscoring crisis, having only netted once from open play in their last four

Real hold a 2-1 lead in the tie after riding their luck in Amsterdam, meaning a draw or even a 1-0 defeat would see them into the quarter-finals, but their inability to put the ball in the net is becoming a concern.

Ajax meanwhile have been in imperious form since losing the first leg, scoring 13 goals and conceding one in three games.

They will also be feeling refreshed after the Dutch federation postponed their game this weekend against PEC Zwolle in order to give them more rest time ahead of their trip to the Berna-

Madrid were wasteful in last Wednesday's 3-0 defeat to Barca in the Copa del Rey semi-final second leg, repeatedly missing the target from inside the area.

They had even more shots in their 1-0 defeat to the Catalans in La Liga on Saturday, but kept having their attempts blocked by Barca's defenders, with goalkeeper Marc-Andre ter Stegen rarely called upon.

Both goals in last week's 2-1 win over Levante came from the penalty spot, while their last goal from open play was a header from Casemiro in their 2-1 defeat at home to Girona on Feb. 17.

Coach Santiago Solari does not appear to be overly concerned by the team's struggle for goals. "These things go in spells. Sometimes everything flies into the net, sometimes it doesn't," the Argentine said after the 1-0 defeat to Barca. "We will try everything so that what did not go in today, or on Wednesday, does in our next game. We will keep trying."

Yet on the team's current form, it is difficult to see where goals against Ajax will come from, as none of the club's players have managed to go close to filling the void left by all-time top scorer Cristiano Ronaldo, who joined Juventus in July.

Karim Benzema, the team's leading scorer with 15 strikes in the league and
