# World TB Day observed in sombre mood

THE fight against tuberculosis (TB) in Mbeya region is not yielding the desired results as it stands amongst 10 regions with the highest prevalence, with more than half of the cases being related to HIV/ Aids.

Mbeya Regional Medical Officer, Dr Salum Manyata said that 69 percent of TB patients in the region are infected with HIV/Aids. Dr Manyata was speaking over the weekend during commemorations of the World TB Day (WTBD) jointly organized by Mbeya city council and the Mbeya Medical Research Programme (MMRP) under the National Institute for Medical Research (NIMR).

This year's global theme for the World TB Day was-"It's time" targeting global leaders to put the accent on the urgency to act on commitments to scale up access to prevention and treatment of the disease.



**Health Minister Ummy** Mwalimu said on Saturday that at least 70 people die every day from TB in Tanzania, implying about three people per hour


The government through MMRP set a target of reaching 4,835 TB patients in Mbeya between January and December last year, enrolling them for medication to enhance prevention.

"We had our own targets to end TB in Mbeya; the 3,325 cases diagnosed last year are equivalent to 69 percent of the target. We will scale up efforts to identify more patients this year," the RMO said.

Explaining, he said that new patients were diagnosed at various hospitals and health centers, with 14 percent being diagnosed at home. A team of medical assistants equipped with TB testing kits are visiting families in rural areas where diagnosis is conducted at their homes.

"Researches indicate that a TB patient who is not under medication can infect between 10 and 20 people per year. In Mbeya region, we have identified and treated around 40 percent of the

# Road Safety Act up for overhaul

THE government is set to amend the Road Safety Act to give the National Road Safety Council sweeping powers including ability to prosecute motorists who violate rules.

The bill for the new law is awaiting cabinet approval before being taken to the National Assembly after finalization of all legal issues, according to Deputy Home Affairs Minister Hamad Yusuf Masauni.

Masauni who is also the council chairman was speaking over the weekend when he chaired the first forum on road safety this year, that brought together various stakeholders in

the transportation sector.

Among other changes that the law envisaged to bring about include making the council a leading agency in road safety issues, establishing a mandatory vehicle inspection exercise, indicate permanent sources of funds for the council and establish hefty fines and strict laws against reckless driving.

The meeting was also aimed at giving an opportunity to stakeholders to air their views on what they wish should be included in the law.

"Currently the council offers advice on what should be done. We want to make the current council more powerful by having own sources

# One dies in Monduli fight over forest land

THREE villages in Monduli District are fighting over a forest standing between them and the battle has just turned lethal, killing one person and injuring five.

The acting Regional Police Commander, James Manyama has confirmed the incident naming the dead victim as Simell Oltialulu, a resident

of Lendikinya Village, who was allegedly killed when irate residents started fighting using traditional weapons such as machetes, spears and clubs.

"We have also arrested four people in connection with the incident," said the RPC.

The three villages of Emairete, Lendikinya and Arkalia have been caught up in territorial

TANZANIA and Egypt yesterday signed a joint venture agreement for the construction of a massive leather and meat processing plant in the country.

Ruvu Integrated Industry, with capacity to slaughter 1,500 cattle and 4,500 goats per day will be run jointly by the National Ranching Co. Ltd (NARCO) and an Egyptian firm, NECAI. Speaking after witnessing the signing of the

agreement in Dar es Salaam, the minister for Livestock and Fisheries, Luhaga Mpina said the plant to be located at NARCO's Ruvu Ranch in Bagamoyo district in Coast region, will also manufacture leather products such as shoes, belts, bags as well as animal

Once completed, the factory is expected to furnish 5,000 jobs and targets to sell processed meat to local outlets as well as the regional market and further afield, the minister said.

Mpina directed the joint team of Tanzanian and Egyptian experts working on the feasibility study of the project to complete it urgently so that an investment agreement is signed within three months for construction to kick off.

Tanzanian experts in the team come from the ministries of Livestock and Fisheries, Foreign Affairs and East African Cooperation. Industry and Trade as well as the Attorney General's Chambers.

Mpina appealed for more investments from Egypt since Tanzania has an Exclusive Economic Zone (EEZ) covering an area of 223,000 square kilometres. It is rich in tuna fish whose demand is high in the international market.

"Egypt can also invest in the fish processing industry, fish farming as well as deep sea fishing in Tanzanian international waters," he said.

Egyptian Ambassador to Tanzania, Mohamed Gaber Abulwafa who also witnessed the signing said his country has decided to invest in the sector after ascertaining that Tanzania has enough quality livestock to meet the demand for a mega plant.

He said the agreement is a culmination of a preliminary accord reached in talks between President John Magufuli and Egyptian President Abdel Fattah al-Sisi in Dar es Salaam back in 2017.

During the talks, President al-Sisi had committed to help construct a mega-meat processing plant in the

The construction of the meat plant is set to provide big relief to livestock keepers who will be sure of selling their livestock at better prices.

# Dr Shein underlines need for education on tourism

ZANZIBAR President Dr Ali Mohamed Shein has underscored the need for Zanzibar commission for tourism (ZCT) to educate people on the history of the Isle's tourism as well as measures taken to enhance the sector.

He made the statement at the State House yesterday during when he held talks with officials from ZCT and Ministry of Information, Information, Tourism and Archives. The meeting was attended by Zanzibar Second Vice President, Ambassador Seif Ali Idd and several government officials.

Dr Shein stressed that it was important for Isles residents to understand the tourism sector and progresses made so far. He said the residents should also be informed on how the tourism performed in the previous years in comparison with current situation.

He said the Isles government resolved to invest more on tourism after the value of cloves dropped internally and at the international markets.

"Our tourism sector is currently performing better due to a number of factors including review of the laws and the Zanzibar tourism regulations of 2012 under the ZCT", said Dr Shein insisting on commission officials to abide by the regulations to further improve the sector.

The President was optimistic that yesterday's talks will help ZTC towards improving the tourism sector which is among the major contributors to the Isle's economy.

In his address, Zanzibar Second Vice President, Ambassador Seif Ali Idd said the tourism sector is important

for the economic growth. He said it was important to continue improving it and develop new tourist attractions especially those along the Indian Ocean.

Information, Tourism and Archives Minister, Mahmoud Thabit Kombo said the government in Zanzibar has been benefiting a lot from the tourism sector following a good number of visitors received each year.

Commissioners from commended President Shein's efforts in improving the tourism sector. They were concerned that since Dr Shein took over powers the number of tourists visiting Zanzibar had been increasing annually.

The ZTC officials attributed the successes achieved in the tourism sector with the successful implementation of Chama cha Mapinduzi (CCM) 2015/2020 election manifesto.

## SA govt condemns xenophobic attacks

## **JOHANNESBURG**

The South African government has condemned attacks against immigrants after a spate of assaults this week that raised fears of a resurgence of deadly xenophobic attacks.

"Government is concerned about the reported attacks on foreign nationals in KwaZulu-Natal and Limpopo," the state communications department said in a statement issued on Thursday, March 28.

"We urge law enforcement agencies to ensure that perpetrators of these violent acts are brought to book".

It called on community leaders to stop and discourage attacks on migrants reported in Limpopo and KwaZulu-Natal provinces.

Police in the coastal province of KwaZulu-Natal confirmed incidents of attacks by dozens of people which started on Sunday night targeting foreign-owned shops.

Attacks were also reported over the next two days and by Tuesday, police spokesman Thulani Zwane said, a group of protesters "were forcing the foreign nationals out of their homes. No one was injured or assaulted".

He told AFP that police intervened, but "no serious incidents were reported".

By Wednesday around 300 foreign

nationals had sought refuge at a mosque in Durban, according to an AFP photographer. Attacks against foreigners and

foreign-run businesses have erupted regularly in recent years in South Africa - the most developed sub-Saharan economy. Immigrants are often the focus for

anger among South Africans hit by a chronic job shortage and the limited progress made by many poor blacks since white-minority rule ended in

South Africa is host to millions of foreign nationals - many of them economic and political refugees from across Africa including Mozambique, Zimbabwe, Somalia, Ethiopia and Malawi. An unknown number of the migrants are undocumented.

The main opposition Democratic Alliance is campaigning for the May 8 election on an illegal migration card, accusing the ruling ANC party of failing to protect the country's borders.

conflicts for quite some time now, with the pawn of the battle being the Lendikinya Forest reserve area, which each of the three parties claims ownership.

Dr Debora Karega, medical officer In-charge at the Monduli District Hospital admitted to have received six injured patients at the facility over the weekend.

So far one of the injured villagers had been discharged, while two others had to be referred to the regional Mount Meru Hospital in Arusha City, where one lost his life.

"One of the two patients that we referred to Mount Meru Hospital reportedly died on Sunday," said Dr Karega.

The Moduli-Juu Ward Councillor, Bariki Sumuni is one of the four suspects who were arrested in connection with the fighting. However, other villagers are protesting the move, arguing that Sumuni was actually the one who reported the incident to the

The injured villagers admitted at Monduli Hospital include Tingidosoto

Sima (60), who hails from Sepeko Ward. "Fellow elders and I went to try and hatch peace talks with other villagers, but were surprised when irate men from Emairate Village attacked us," he

There is also Lekishoy Mbasia also from Lendikinya who expressed concern that it was mostly the youth from the other village who attacked the elders. "It is an abomination in Maasai culture to attack, let alone injure and kill an elder. A curse will befall them," he warned.

Following the conflict, the Monduli

District Council has halted all agricultural and grazing activities in the three villages that are at loggerheads over the land they are using.

The District Council chairman, Isaack Joseph explained that the three villages are located around the forest which stands in the middle and apparently, each one feels the reserve belongs to them.

The Area MP, Julius Kalanga (CCM) said the land conflict is a long-festering issue and the only way to solve it was for the local leaders to sit and address the issue together.

# TIB, SNV sign pact to take power to remotest areas

THE TIB Development Bank Ltd and the Netherlands Development Organisation SNV yesterday signed in Dar es Salaam 1.5 Euro million fund pact, committing the former to managing a result-based fund that seeks to motivate solar energy agents to take electricity to rural lake and central zones.

The pact was signed by TIB acting managing director, Patrick Mongella and the Deputy Country Director, Lucy Fulgence Silas.

Silas said that the signing ceremony whose core aim of the project, the second in the series, is to help rural people access electricity in the two zones. She also praised cooperation between SNV and TIB.

"We are focusing on the lake zone because various research results show that there is a critical shortage of electricity in that zone. From there we shall get into the central zone," she said, adding that SNV has 800 agents and that the project is working with 11 power distributing companies.

Mongella said the bank is ready to cooperate

with Dutch partners in enhancing Tanzania's development goals.

This project, he said, aims to facilitate introduction of and sustained use of solar power solutions, particularly pico-solar and small solar home systems in target rural remote areas within the lake and central zones.

"TIB Development Bank undertakes this role towards fulfilment of its mandate as a national development financing institution (DFI) which requires the bank to facilitate economic growth of our nation. Ensuring access to clean and sustainable sources of energy is one of the efforts to accomplish this," he said in a statement after signing the pact.

He appealed to public and development partners in need of fund management services to make use of services offered by the TIB.

SNV project manager John Kundael Mlay said the money will go to firms truly committed to taking electricity to rural remote applicants.

SNV Tanzania is involved in three renewable energy sub-sectors that include domestic biogas, improved cook stoves and solar energy. SNV has been operating in Tanzania since 1963.

# TFA to reclaim silos suspiciously sold by former officials

THE Tanganyika Farmers Association has appealed to the government so that the state may assist TFA to reclaim back granaries that were dubiously sold away by former officials of the association.

The association chairman, Peter Ezra Sirikwa said TFA has already reported the matter to the government and they are glad that, the matter is being worked upon by state organs.

"We used to have large silos to store farm inputs, such as tools and fertilisers as well as grain harvest, but most of these facilities were sold off by greedy officials and some converted into supermarkets, residential and commercial entities," Sirikwa pointed out.

In addition to snatching the 'privatised,' silos, the TFA also wants to build new granaries to ensure that crop produce are well stored to offset shortages during famine or drought

The chairman revealed that in Arusha, during the annual general meeting (AGM) for members and stakeholders of the Tanganyika Farmers Association (TFA) over the weekend.

Meanwhile, the government is planning to start issuing special Identity Cards to all farmers in the country.

It is estimated that the land tilling and crop production faming directly employs at least 65 per cent of all Tanzanians, while nearly 20 percent others, indirectly depend on agricultural activities their economic mainstay.

"Overall, we are speaking of more than 80 per cent of the country's population relying on agriculture, making it Tanzania's most important industry, yet it does not receive the respect it deserves," said the Minister of Agriculture Japhet Hasunga

explained that the government's next move is to enrol all farmers in special databases, then provide them all with official identity cards for recognition. "The documents will also help the growers to secure loans

Speaking at the opening of the TFA-AGM, Hasunga

and other assistance from institutions like banks, insurance and security companies," the Minister added.

But the Tanganvika Farmers Association (TFA) has already started issuing its members with electronic Identity Cards (ecards), according to the association chairman, Peter Ezra Sirikwa, who showed to the minister a prototype of the digital document, size of the ATM card.

"The TFA has over 5000 members countrywide enrolled at our more than 16 branches operating in sixteen regions of the mainland,"disclosed Ezra Sirikwa, adding that the association intend to establish more branches in the Lake zone and southern highlands.

The TFA Chairman, Sirikwa, lauded the fifth phase government for ensuring that farming activities and local growers are recognized as important contributors of the country's economy.

Based in Arusha, but operating countrywide, the Tanganyika Farmers Association, with 5000 members, was founded over 80 years ago, in 1935 and still going strong.

As of now, Tanzania is estimated to have a population of 50 million residents, with at least 30 million of them are involved in crop production through Agriculture.

The state is planning to start special insurance to cover farming activities, safeguarding local peasants from seasons of less productivity, diseases and drought, according to the Minister of Agriculture, Japhet Hasunga.



WHILE the Land Act No 4 of 1999 establishes a number of principles that provide legal safeguards for women's rights to land, Singida residents have called upon the government to enforce the land Act.

The law, among other things requires equitable distribution and access to land, participatory decision making, and spouse involvement in land issues such as sale of land, transfer of land or any other related land issue.

Ester Sekunde, a resident of Mwankoko village in Singida Region said that many women in Singida rural communities have no rights to land compared to men who tend to sideline women and sell family land without their knowledge.

Narrating the story, she said four years ago, at Isomia hamlet, Mwankoko vllage, the family had 18.5 acres of land but it was sold by her brothers at 1.85m/- without her knowledge

Ester had been divorced by her husband who abandoned her with five children, three boys and two girls. Then her husband married another woman and decided to sale the land and other properties without the participation of his first wife Ester.

"I lost everything and lived in abject

# Singida residents demand enforcement of Land Act

Another victim of land issue is Zainabu Ali Ghuliko, a resident of Mungaa village, Mungaa division in Singida. She said that she had no right to the family land except her brothers.

"In rural areas, women have nothing. My young sister was divorced by her husband and returned home. She managed to build a small house in the familv's land, but our brothers forced her out of the land," she said.

Singida IR-VICOBA Network is running a project on women's rights to land accessibility, utilisation and ownership. The project officials reported the women complaints to the ward tribunals where the land cases were resolved.

The coordinator for Mwankoko ward tribunal, David Amos Mbua confirmed to have received land cases and said that women had their rights just like men. He said the women whose land had been taken away by their brothers and husbands have been returned.

"They agreed to return the land and it was redistributed equally with their brothers and husbands. We have of land accessibility and ownership in warned other men to understand that several villages and wards.

poverty with my five children," said women have equal rights. If women complain about land, we shall take appropriate measures," he said.

# Go for further education, **OUT VC tells Tanzanians**

DEPUTY Vice Chancellor for academic at the Open University of Tanzania (OUT) Prof Deus Ngaruko has called on Tanzanians to go for further education courses for them to contribute to the country's development endeavours.

Speaking during the opening of a three-day workshop on quality assurance for teachers and professionals development this week in Dar es Salaam Prof Ngaruko cited that low education level in Tanzania was limiting people from making use of various economic opportunities available in the country.

The workshop brought on board more than 50 participants including heads of African Council for Distance Education, heads of quality assurance department in the universities, professors and lecturers from within and outside the country.

He noted that as compared to Kenya, the number of people who have reached the education of at bachelor degrees in Tanzania was still low. Kenya has more elite people.

"It is recommended that, economic opportunities available in the country can be well utilised for development if the number of people having education at the level of bachelor degree reached 15 per cent," he added.

Prof Ngaruko insisted in order for country to achieve industrial revolution, there is a need for efforts to strengthening education to people at degree level.

He said the workshop was meant to support evidence based quality assurance practice in teacher training and professional development in the digital age.

"But also to assess the quality of education being provided in the distance education as well as the competency of students being

produced in the university if they match in the job market," he Ngaruko detailed

For his part Professor Rotimi Ogidan **Executive Director African Council for** Open and Distance Learning (ACODL) said that the OUT among other institutions, played an important role in producing the quality assurance for Africa Council on Distance Education Toolkit that is going to be used for training

"We are optimistic that the workshop will afford the participants the opportunity to understand the principles of quality assurance and accreditation and be able to use the ACDE QA Toolkit to promote quality ODL delivery services in teaching profession," Prof said.

# We should support children with autism, pleads Kikwete

FORMER President Jakaya Kikwete has called on stakeholders in the public and private sector to invest on infrastructures and community awareness to supportt children with autism spectrum disorder (ASD).

ASD is a neurological and developmental disorder that begins early in childhood and lasts throughout a person's life. It is characterized by challenges with social skills, repetitive behaviors, speech and nonverbal communication.

Kikwete made the call yesterday after a one-kilometre autism walk awareness that was organised by the Al- Muntazir secondary schools with a theme: "Let's protect and love them".

He also called them to come up with a strategy that aimed at assisting children with autism such as protecting them from the stigma.

Referring to his grandson, the former president said to take care of a child with autism has social, education and economic impacts.

"Taking care of children with autism need patience. I have my grandson who is autistic so I know what it means," he

"It is paining sometimes especially when I compare with other grandsons in my family," he lamented.

He said the responsible ministries for Health, Education in collaboration with associations have a big role of educating the public saying there was still a possibility of assisting them.

He thanked the management for recognising and established Al-Muntazir Special Education Needs to Children with Autism (AMSEN) and urged other stakeholders to boost efforts achieved so far.

For his part, the central board chairman of the Al-Muntazir secondary schools Imtiaz Halji hinted that the aim of conducting the walk was to increase

the awareness to the public about the

The chairman appealed to the government and private sector to volunteer supporting children with autism in terms of fees in education.

He said the cost of taking care a single child with autism at AMSEN is 6m/annually, adding that the management charges only 3m/-.

"We call on other stakeholders to support us so that we can offer them the best and quality services while they are at school like we do to those who are not autistic," he said.

Children with autism are normal, they are trainable and manageable. We therefore need to support them," she

The National Association for People with Autism Tanzania (NAPA-T) Dr Stella Rwezaura said low awareness about ASD was still big challenge because it hinders efforts to diagnose and reach many children.

"It is evident that there is serious deficiency in the awareness about the problem in the country, a situation that hinders efforts to diagnose and reach many children," he said.

He said with public awareness, more people could be reached and diagnosed to enable them embark on behaviour therapy.

Social stigma is the disapproval of, or discrimination against, a person based on perceivable social characteristics that serve to distinguish them from other members of a society. Social stigmas are commonly related to culture, gender, race, intelligence and

# Rescue operations on Mount Kilimanjaro help out 250 'needy' people in 10 months

RESCUE operations by using helicopters on Mount Kilimanjaro have for the past ten months, served at least 250 people including tourists who suffered altitude sickness and other problems when climbing the longest mountain in Africa, a senior official of the rescue team has said.

According to the chief executive officer of the Kilimanjaro Search and Rescue (KSAR) Ivan Brown the evacuations were possible following continued investments by the company to ensure that people climbing the mountain were safe all the time.

"Our mission is to make Mount sickness. Kilimaniaro the safest tourist destination in Africa". We have enough rescue choppers which specialise in high altitude flights," he said

Speaking during an operation to rescue climbers from the mountain yesterday, Brown said that since the company became operational in June as year, it has made rescue services in the mountain easier and safe.

He said that to further improve safety, Kilimanjaro SAR also has a medical clinic in the campus of St. Joseph Hospital in Moshi where rescued climbers can be treated by the recorded successes in rescue doctors who specialise in altitude operations, the World HRD Congress

"We invested over \$3 million in the establishment of the clinic, which is now serving hundreds of tourists annually. The company is also planning to bring four more helicopters to strengthen rescue operations on the mountain," he said.

He said that Tanzania is a naturally rich-resourceful country, struggling to maintain conservation initiatives and develop local communities, safety within the national parks was also vital.

# FA Cup run enigmatic here as well as abroad

Young Africans at the weekend inched through to the semifinals of the Azam Sports Federation Cup tournament, with a win n penalties against a gallant Mwanza-based Alliance FC, another near upset that is characteristic of FA tournaments here and beyond. The most audacious results occur in these competitions while the premier league run is usually more predictable, not just on the basis of local scores but when one looks at established and well publicised tournaments abroad. It is not unfortunate to make broader comparisons since the soccer field is now globally integrated, with hybrid Kiswahili, Sportpesa a global brand.

As hundreds if not thousands of youths seek to make a buck or two predicting results of matches in various tournaments regionally and abroad, it is interesting to figure out if some of them have noticed that FA Cup contests are less amenable to rational predictions as compared to premier league matches. As soccer isn't a sphere where academics seek to set out composite interpretations, usually known as philosophies, in relation to how it works, dynamics if one would say so, it is not easy to say if there is any literature on that matter. Still it can be interpreted from other sources, for instance in economics, as here there is a galore of philosophers to do it.

The most notable reflection that seems to apply to the soccer sphere and especially to the manner that chance works in non-league competitions is a vital formulation from Adam Smith. the Scottish

OCCER giants Dar es linguist-philosopher who created foundations of modern economic ideas. He didn't limit comprehension of the market to competition alone (or in more modern terms, strategies, etc) but tied it to "the hidden hand of Providence" that permeates through and through in the workings of the market. It goes without saying that many of his less religious and more sceptical successors did not have much use of that concept, and thus it isn't known how it works in soccer.

> In Tanzania as in many other African countries the trend towards scientific soccer that isn't riddled out and out in sorcery and more scientifically, match fixing is picking up, as we noticed with the last round of matches in the African Nations Cup group stage. An obvious opportunity to set the stage for either Lesotho or Cape Verde qualification went unused, as international football authorities (after the United States organized a witchhunt that nailed former FIFA president Joseph Sepp Blatter) started showing zero tolerance for corruption. Sorcery is another variation of match fixing efforts but it cuts both ways, as it may harm the perpetrator, so we are wiser.

In that case enigmatic results where powerful sides fail to show their true worth with less noticeable teams in FA Cup contests but usually realise the logical outcomes in league football plays down to Adam Smith, that there is a hidden hand of Providence that enables weaker teams to shine in auxiliary competitions. It smacks of human equality being at issue, that powerful are at times cut down. It is benevolence for small teams but caprice as well.

# Wanted: Global awareness about people with autism

Awareness Day internationally recognized day on 2 April every year, encouraging member states of the United Nations to take measures to raise awareness about people with Autism Spectrum Disorder (ASD) throughout the world. It was designated by the United Nations General Assembly resolution.

The resolution was passed and adopted without a vote in the UN General Assembly, mainly as a supplement to previous UN initiatives to improve human rights.

World Autism Day is one of only seven official health-specific UN Days. The day itself brings individual autism organisations together all around the world to aid in things like research, diagnoses, treatment, and overall acceptance for those affected by this developmental disorder.

Autism is associated with a combination of genetic and environmental factors. factors during pregnancy include certain infections, such as rubella, toxins including valproic acid, alcohol, cocaine, pesticides and air pollution, fetal growth restriction, and autoimmune diseases.[15][16] [17] Controversies surround other proposed environmental causes; for example, the vaccine hypothesis, which has been disproven. Autism affects information processing in the brain by altering connections and organization of nerve cells and their

Early speech therapy or behavioral interventions can help children with autism gain self-care, social, and communication skills. Although there is no known cure, there have been cases of children who recovered. Not many children with autism live independently after reaching adulthood, though some are successful. An autistic culture has developed, with some individuals seeking a cure and others believing autism should be accepted as a difference and not treated as a disorder.

Globally, autism is estimated to affect 24.8 million people as of 2015. In the 2000s, the number of people affected was estimated at 1-2 per 1,000 people worldwide. In the developed countries, about 1.5 per cent of children are diagnosed with autism. It occurs four-to-five times more often in males than females. The number of people diagnosed has increased dramatically since the 1960s, partly due to changes in diagnostic practice. The question of whether actual rates have increased is unresolved.

Autism is a highly variable neurodevelopmental disorder that first appears during infancy or childhood, and generally follows a steady course without remission. People with autism may be severely impaired in some respects but normal, or even superior, in others. Overt symptoms gradually begin after the age of six months, become established by age two or three years and tend to continue through adulthood, although often in more muted form. It is distinguished not by a single symptom but by a characteristic triad of symptoms: impairments in social interaction; impairments in communication; and restricted interests and repetitive behavior. Other aspects, such as atypical eating, are also common but are not essential for diagnosis. ] Individual symptoms of autism occur in the general population and appear not to associate highly, without a sharp line separating pathologically severe from common traits. People with autism have social impairments and often lack the intuition about others that many people take for granted.

# CSOs commend govt efforts to engage stakeholders in preparation of the Voluntary National Review report

ivil Society Organizations (CSO's) in the country have commended efforts being taken by the government to engage different stakeholders in the preparation of the Voluntary National Review (VNR) report but advised that there is a need for more initiatives to be made to attract marginalized groups in the process, ahead of the UN's High-Level Political Forum (HLPF) on SDG's to be held in July in New York where the report will be presented.

Programme coordinator at FORUMCC Fazal Issa said that it is good that the government has involved CSOs and other stakeholders in the report preparing team saying such zeal and commitment are applauded.

FORUMCC through the Tanzania Sustainable Development Platform is part of the team and looks forward to provide valuable contribution to the report which its key messages will come out in May this year and the final report to be presented at the UN's High-Level Political Forum (HLPF) in July in New York.

FORUMCC is conducting the CSOs consultation with support from PACJA on SDG 6, SDG 12, SDG 13, SDG 14 and SDG 15.

I advise the government to continue such engagement of stakeholders because this is a national report, so, we encourage them to conduct consultations and take on board inputs and comments from independent consultations of CSO's, private sector and other stakeholders in the report is crucial, be said

He said that the government should take further steps to include CSOs as part of the presentation of the report.

We have seen a number of countries also sharing podium with CSOs in presenting the report. CSOs are good in sharing stories and case studies. The government could share the progress and CSO's could bring in the community voice, he explained.

After the consultations, comprehensive report will be prepared to get the status of implementation, to identify the opportunities, and challenges that exist, this will provide a clear picture of how do we move forward.

The Coordinator of the Tanzania Sustain-

able Development Platform Stuwart Kitila said that currently they are in the VNR process and it is an open consultation process of the CSOs, the government and other stakeholders who are engaged in the SDGs process. During the process, they are collecting feedbacks and inputs from different actors on how best they have been engaging in the implementation, monitoring and evaluation of SDGs in Tanzania.

"We have been receiving overwhelming response from stakeholders, the government has been real responsive in engaging the civic space in the process," he said.

Secretary General of United Nations Association of Tanzania (UNA Tanzania) Reynald Maeda said that implementation of SDGs in Tanzania need to be inclusive, it should not be business as usual, every Tanzania individually and in groups should fully participate and provide inputs because this agenda is for everyone.

"The SDGs calls for collectiveness, it is not a top down approach, it is an approach that takes everyone on board, be it youth, women, men, the CSOs, the private sector and the government, all have a role to play.

However, Maeda said that many youth are not aware of the SDGs, so there is a need to create more programs that will bring many youth on board.

TPSF Executive Director, Godfrey Simbeye said it is understood that in July this year, Tanzania will submit its first Voluntary National Review (VNR) on Tanzania's progress in implementing the Sustainable Development Goals (SDGs) with priority goals for this year being SDG 4, SDG 8, SDG 10, SDG 13, SDG 16 and SDG 17 to the UN's high-level political forum in New York.

The VNR provides an opportunity to highlight Tanzania's achievement, priorities and challenges both domestically and internationally in advancing the 2030 agenda adding that the road show has come at a right time.

# WWF and partners help to restore near extinct medicinal erythrina plants in Kilwa

ray of hope has spark in the Southern Tanzania after the Erythrina schliebenii, one of the unique, rare, medicinal and lucrative coastal tree species have been restored.

The coral species are found not elsewhere in the world except in Tanzania ,has been restored in Mchakama village, some 98-kilometers from Kilwa Masoko town, Lindi region.

Characterized by jagged ferocious spines along its stem, this coral tree is widely known as "Mnungunungu" in Swahili and "Mlindimila" to the local communities. For many years the barks of this tree, which thrives in rocky areas has been used for medicinal purposes.

According to Dr Lawrence Mbwambo, in 2008 Erythrina schliebenii tree was one of the declared near extinct species by International Union for Conservation of Nature (IUCN). During the 2012 botanical exploration in south-east dry coastal forests of Tanzania, a group of scientists reported in the Journal of East African History the rediscovery of about 50 Erythrina

"After discovering shrinking number of Erythrina species, WWF began pioneering its restoration in 2016 in collaboration with WWF German with funds from Germany Cosmetic Company (Kneipp) .On the ground WWF partnered with Kilwa District Council, Mpingo Conservation and Development Initiative (MCDI) and began restoration at Uchungwa Forest at Mchakama Village. Our overall objective is to restore the tree in its natural environment by planting approximately 30,000 seedlings thus in order to increase the species population and contribute to conserving natural biodiversity," explained Dr Mbwambo.

According to Salum Ally Mususa, Mchakama Village Chairman, Erythrina restoration has been done at

Uchungwa Village Land Forest Reserve approximately 34km from the village.

"For local communities this WWF initiative is considered of great importance because Erythrina is one of our oldest source of medicine. Its barks are widely used to cure fever in children, women use it during postpartum period, as well as sexual and reproductive health to mention a few. Secondly, the restoration processes have enhanced knowledge and commitment towards forest conservation. Last but not least economic welfare of individuals have improved as a result of engaging in the entire restoration process from seeds collection, to planting, to forest patrol, said Msusa.


I frequently join my people to patrol the forest and I can attest to this by 98 percent of the Erythrina seedlings we planted in Uchungwa have survived, this has contributed to the increase number of Erythrina trees, thus forest

Speaking on the restoration journey, MCDI Forest Officer Jonas Timothy said the process began with gathering of seeds around July and August, 2016 followed by preparation of nurseries which started from October, then planting of seeds that started around January or February. After 3-months the Erythrina seedlings were ready to be transferred to the forest.

"Restoring a near extinct species is not an easy task but we have succeeded with Erythrina. From 2016 to date approximately 20,000 seedlings have been planted in Uchungwa Forest.

Despite the success, Erythrina restoration faces some major challenges too. According to Mr. Salum, Uchungwa forest is not accessible during rainy season, due to poor access roads. Such a hiccup hinders their effort to monitor the progress of the trees. On the other hand, Erythrina is a delicacy to monkeys noted, Jonas.

"One thing we did notice early in the process is that monkeys love to feed on Erythrina seedlings. Thus, the first week is very crucial for the seedling survival. Together with the

local communities we have came up with an innovative way to keep the

monkeys away. We use a local deterrent locally called "Sifa" which is made of fish remains.

We sprinkle the powder on the seedlings, its smell keeps the monkey away thus the seedling thrives. This has been one of our biggest win so far before we used our patrol people to chase the monkeys away which was neither a sustainable nor effective way to address the challenge" said Jonas

Used as medicine for people and

Speaking on Erythrinas' medical values, Hadija Abdallah Masambala, a member of the village council said that the powder from the trees barks is considered a first aid service by major ity of the villagers.

"We are a rural community, we do not always have timely access to health services. Therefore, Erythrina is our first medicine we use before seeking further medical attention, I remember one time my son had high fever we used Erythrina and his condition improved, it has saved a lot of lives.,"

According to Hassan Ally Stambuli, who is poultry keeper, Erythrina has kept his flock from seasonal Newcastle

"When we first began collecting seeds I remember I took some seeds with me home. Having a bigger compound I just threw the seeds around the house and went on my business. After sometimes I noticed my chicken eating the seedling I didn't mind. Then we had an outbreak of Newcastle disease in the village. It was sad people lost their flocks but mine remained

That's when I discovered it is because they fed on Erythrina seedlings. Therefore I shared my discovery with others and we have since then maintained health chickens," says Mr

Erythrina schliebenii restoration efforts contributes to good governance

According to the secretary of the Village Natural Resource Committee Ahamadi Abdallah Ligambe, the trainings and conservation campaigns

carried out by WWF, the District Council and MCDI on the importance of forest conservation and Erythrina schliebenii in particular, have invoked them a sense of commitment and responsibility. As a result, the villagers understand the value of their forest and play key role in protecting them, include through patrols.

Good governance trainings have enabled the Natural Resources Committee to effectively play their role in managing the forest and facilitated benefit sharing. On the same note, women engagement has improved with now six women holding position in the committee

"We have benefited a lot from Erythrina schliebenii restoration. The Village Natural Resource Committee and the Village Council have been trained, acquired conservation knowledge and skills that are used in day to day decision making," he explained.

The future of Erythrina schliebenii

Fatuma Said Umande explained that Mchakama villagers are very lucky for having the support of WWF, the District Council and MCDI saying it is now the duty and responsibility of the villagers to honor and respect the support on the forest conservation.

However, Fatuma who is a member of the Village Natural Resource Committee cautioned "the Erythrina schliebenii will be well protected and conserved if the villagers will see more benefits and incentives trickling down to the ordinary villagers.

"In the near future we believe the tree will improve our livelihood. We hope we can sell the seeds to other part of the world and even the tree itself to make development happen from the earnings. Apart from Erythrina restoration, WWF also funds on-going Community Based Forest Management (CBFM) which generates both individual and communal income and spurs the village economy.

We are happy our forest is thriving and we are benefiting from the harvesting of other trees in the forest.

# National dialogues are key to peace in the Horn

he countries in the Horn of Africa have entered a new phase of domestic instability. Political protests in Ethiopia and Sudan and armed insurrections in South Sudan and Somalia have dredged up old causes of conflict.

Ethiopia has been facing political and security crises since 2016. The country has shown signs of heading towards stability, in part due to political reforms it is undertaking, but internal violence remains acute. Sudan is wrapped in turmoil with protesters demanding political change. South Sudan has the daunting task of implementing a fragile peace agreement, against a backdrop of communal violence and atrocities occurring since December 2013.

Apart from the terror threat posed by al-Shabaab, Somalia is struggling with inter-communal conflicts and political disputes between the federal government and its member states. The region is dealing with clashes based on ethnicity, religion and other identity markers. Demands are being made for more just, equitable and democratic governance, as well as remedies to various forms of socio-economic disfranchisement.

These factors work against the fragile state of national unity in the region's countries. They show that now more than ever, genuine and inclusive national dialogues are needed. Despite their potential to complement existing conflict prevention and peacebuilding efforts, they are underutilised in the region. National, regional and global peacebuilding actors should support national dialogues to help avert domestic political crises and internal armed

The overriding goal of national dialogue processes is to promote peace, unity, reconciliation and a shared sense of identity - all critical elements of sustainable peace, but all in short supply in the Horn of Africa. Having wide-ranging mandates including political reforms, constitution making and peacebuilding, national dialogues are political processes that aim to reach a new social contract between interest groups and communities in a country.

Such dialogues have recently gained traction as vital instruments of peaceful transformations. According to the Berghof Foundation's National Dialogue Handbook, they have been implemented with varying degrees of success in Morocco, Libya, Tunisia, Egypt, Lebanon, Jordan, Bahrain and Yemen.

In Tunisia, national dialogue has been credited for breaking the political deadlock and for building enough political consensus to lead to constitutional and institutional reforms. In such cases, national dialogues have numerous inherent advantages. They effectively respond to local actors' demands for national ownership, inclusion and wider par-

In the Horn of Africa, however, national dialogues have not always been well implemented; and at other times citizens have wanted them, but governments haven't recognised their importance.

In the years before the political upheavals leading up to the current political transition in Ethiopia, there were calls for national dialogue, especially by the opposition and civil society. These were not taken up, and the need for national reconciliation and unity was downplayed as issues conclusively addressed by the country's constitution and its federalist form of governance.

South Sudan's government initiated a national dialogue process in 2017 in the absence of any viable peace agreement on the civil war. The process was heavily contested, largely because of its myriad challenges - for example the exclusion of key stakeholders to the conflict (not least the opposition parties

The region's deep political crises and post-conflict situations have made governments realise the limits of securitised approaches used in the past. States are recognising the need for political solutions. Al-Bashir recently said that national dialogue was the only way to resolve his country's ongoing crisis.

ers have recently taken concrete steps towards dialogue processes, tional reconciliation commission this year. In Somalia, there is an increasing recognition that focusing on military interventions has failed to bring about sustainable peace in the country.

National and international actors vested in sustainable peace in the region need to capitalise on these new opportunities to find politically rooted solutions to crises. But there is also a need to go back to the drawing board to ensure the dialogues are genuine, inclusive, as well as owned and driven by national and local players. Unlike in the past, those supporting such dialogues

must ensure proper representation, agenda setting, clarity of decision making procedures, and support structures.

The United Nations, African Union and Intergovernmental Authority on Development in particular must rethink their approaches on conflict prevention and peacebuilding in the region. They need to ensure that genuine and inclusive national dialogues are at the centre of conflict prevention, management and resolution efforts. Without this, the current window of opportunity for convening real dialogues may close, and the fragile peace and security climate in the region will remain.

A man who was denied asylum by the United States and deported back has been killed by a roadside bomb in Mogadishu.

Ahmed Salah had sought refuge, arguing that Mogadishu was not safe enough for him and his family, but the immigration judge declined his plea and ordered him back.

which Al-Shabab militants have mounted targeted attacks killing and maiming hundreds of people.

President Donald Trump's reversal of long-standing immigration policies was bound to impact the Somalis, one of the largest African immigrant communities in the US. Over the last few years, Somalis in the US have become the microcosm of the debate surrounding immigration, refugee resettlement, and national security.

During the presidential elections, Trump also singled out Somalis multiple times, accusing them of coming from "dangerous territories," fraying social nets, and blamed faulty vetting processes for allowing a large number of Somalis to come to states like Minnesota, Maine, and Ohio.

Meanwhile, the U.N. refugee agency has warned that a largescale return of refugees from Kenya's Dadaab camp could exacerbate the humanitarian crisis in parts of

UNHCR said it was aware of Kenya's recently renewed call to close the Dadaab refugee camp, which houses 230,000 people. Dana Hughes, the agency's senior regional spokesperson for East Africa, noted that this had happened before.

As in the past, she said, the UNHCR continues to work with the Kenyan government to implement a long-term, sustainable solution for the refugees. These steps include resettlement in third countries, family reunification, and relocation of some refugees in other parts of the country.

She said returns could occur relatively safely in some areas of Somalia. But, speaking by phone from Uganda, she told VOA that in most cases, repatriation is too dangerous to consider now.

"Most of the areas that the refugees from Dadaab come from cannot be considered stable for any kind of large-scale returns, and in fact it could exacerbate the humanitarian crisis that exists in those parts of Somalia," Hughes said.

Hughes said African Union and

other forces had largely established peace in 12 areas in Somalia, and that UNHCR continued to assist people who voluntarily wanted to return there. She noted that more than 82,000 refugees from Dadaab had gone back since 2014.

But in general, she said, large parts of Somalia are not ready for the massive return of refugees.

"While Somalia has made some progress in development over the last few years, it still is a country that has had decades of war, which means decades of a lack of infrastructure, and still is rebuilding itself," Hughes said. "And so, of course, any large-scale returns would not aid the stability that Somalia is trying to build."

Hughes said the UNHCR was thankful to Kenya for its generosity in hosting the Somali refugees for decades despite the toll it has taken on the environment and other aspects of life. She said her agency was having discussions with Kenyan authorities about the possible closure of the Dadaab camp.

# NEMC: Money due to us must be paid electronically

ing that sometimes money was lost on the way.

The new system eliminates all the risks and inconveniences payers used to get because of physical money payment procedures, he said, explaining that money due to the council will now

reach the council in time.

He called on NEMC stakeholders to pay fees and levies in time and as stipulated in the Environment Management Act 2004.

# Transforming informal sector key to spurring of Tanzania's socio-economic development

IT is high time for Tanzania to come up with new approach that will help to transform the country's informal sector into formal ones, experts on entrepreneurship have suggested.

They were speaking during the Policy Forum's monthly breakfast debate held over the weekend in Dar es Salaam. The debate was themed: "Transforming trade and industry in Tanzania: Facilitating the formalization of micro enterprises."

Chief Executive Officer with the Institute of Management and Entrepreneurship Development, Dr Donath Olomi said that informal sector is a huge and important part of the

economy.

He said: "It needed an alternative way to manage it rather than rushing at transforming it into formal, because it employs larger part of the Tanzanian population."

Dr Olomi said the informal sector contributes to about 40 per cent of the national growth domestic product (GDP). It employs between 66 per cent and 80 per cent of the urban population. Of which 40-50 percent are youth and 48-54 percent are women.

Dr Olomi cautioned "If this part of the economy is not well managed will create great problem in future."

The informal sector is a second (economy) a unique segment, with low/poor skills, technology, productivity, ability to comply with the standards of the "modern" economy.

However, it's the only option, and a safety net for the poor to secure their livelihoods.

He suggested that since managing street vending remains a major challenge, the guiding principle is that cities should be designed for all groups and that authorized vendors create jobs and enhance the economy.

He revealed that Tanzania

has piloted a number of approaches (pilots) to formalization of the micro enterprises, but failed. He urged that it was high time to take stock and lessons and use them to design a policy/regulatory framework for managing/transforming the informal economy.

Dr Olomi concurs with President John Magufuli's vision - doing business is everyone's right - and not just for some. He however, called for an institutional mechanism that matches the vision.

According to Dr Olomi some countries have policy and regulatory and institutional framework for managing street vendors. Citing examples, Dr Olomi

said India is one of very few countries to have developed a National Policy on Urban Street Vendors. Adopted in 2004, its objective is to promote a supportive environment for street vendors to earn their livelihoods, while reducing congestion and maintaining sanitary conditions in public spaces.

For his part, a discussant at the breakfast debate, Faraji Mbulalina from the President's Office Regional Administration and Local Government (PORALG), said that their ministry has been working tirelessly to allocate special land plots for small scale businesses.

scale businesses.

He said that they have also directed all their 184 district councils across the country to allocate lands for that purpose. Meanwhile, he revealed that they have set aside around 102 hectares for that purpose.

Mbulalina said that the purpose of doing so was to improve those special areas for small businesses so as to enable them trade profitably and productively.

He has revealed that informal sector guidelines draft was at the top management level of the ministry for decision. When it matures, among others would ensure small business traders are recognized, supported and hence graduate and become big business people. Thus, be able to contribute to the national GDP.

Recognition according to him, includes identification, classifying and registering of the small businesses.

The coming into force of the guidelines will help to get the correct statistics of the number of these small businesses, and hence have good planning for their development.

He, however, said: "Before coming into force, the private sector and other key stakeholders will be involved to give their views and come up with a guideline agreed by all sides."

The Danish Ambassador to Tanzania, Einar Jensen who was also one of the participants to the breakfast debate, commended the government of Tanzania for allowing petty traders to make businesses without disturbance.

He said that in order for any country to grow it needs to create good business environment, jobs and income.

Jensen further advised that for the informal sector to graduate and become big taxpayers, country builders and grow to one name, should be put together in groups for training...that can be the start-up of businesses.

Chairperson of community of small-scale traders (Vibindo Society), Gaston Kikuwi said that when the informal sector is formalized would increase more revenues and employments.

"Formalisation is crucial for the growth of the national economy and em-

**Title:** Working class must change the world for all of the humanity - Part 7

he section discusses the issue of radical education: "Radical, critical, and continued education is needed. It will not only help to put our lives and actions into context, but it also will give us a better understanding of what needs to be done in the future."

In countries, irrespective of hemisphere, hundreds and thousands of organizations claiming to be of the working class are ignoring the task of radical education. Michael Yates finds the same fact: "Most unions in the United States have little or no member education, much less radical education." A strange reality with contradictory elements: an economy gripping highest achievements in the areas of natural and social sciences while its workforce is forced into ignorance related to their life! It's a powerful act by capital!

However, the US is not an exceptional case. Hundreds of Bangladesh unions, many associated with political parties propagating revolution and, claiming to be standing for radical change have not organized a single class for political education over the years. Politicians with postures of radical-change are of the same category - no effort to carry on political education, neither for self nor for the members of the organizations the persons lead. What's found: These persons turn busy with self-promotion, posting those photos with messages "Now, I'm on a Moscow avenue", "I'm riding a car rushing to the Red Square", "We're sitting in a five-star hotel lounge in [a city in Europe]" while enjoying foreign tours in the name of international conferences. It's almost impossible to find a single discussion meeting for briefing fellow members about the conference or debate held or declaration and resolutions adopted in the conference the "comrade" attended. But, news and photos of "labor" leaders making statements in hearings of House/Senate sub-committees are there. This is going on for years, and the story is long. How many copies of a May Day 13-page Baanglaa booklet - an interview of Monthly Review editor John Bellamy Foster, and his comrades, Fred Magdoff and Michael D. Yates, on three questions important in today's labor struggle - did unions ask for in Bangladesh? The publisher of the booklet with a price tag of Taka 10 (around Taka 80 now makes a US dollar) for general buyers and Taka 5 for workers, peasants, students, and their organizers, knows best. It's not even a thousand copies. The oth-

er facts are Bangladesh is a country with more than 160 million persons:

with private banks making profits in the year of the Great Financial Crisis, when their big brothers in Europe and the US were collapsing, and were begging for bailing them out with tax payers' money;

with the 2nd largest foreign reserve in South Asia, the result of labor appropriated in home and abroad;

with an increasing number of workers now numbering millions in factories, in the manufacturing, processing and construction sectors.

Consequently, there are propagation of ideas upholding exploiters' interests, serving imperialist designs, entering into alliance with political forces equipped with medieval ideas, the shameful and despicable acts from the standpoint of the working class. The results of these acts are in the open: These "crusaders" find friends among oppositionists serving medieval-imperialist design while imperialism and medieval forces build up an axis of exploitation/intervention; all acts

of "opposition" appear "crusades for democracy", with space given to medieval forces while ideas upholding working class interests are denied space. This, a forceful trend, is shamefully happening after the working class gained experiences over long years of struggle, and Marx, Lenin and their comrades scientifically theorized the struggles of the working class.

So, the labor educator writes: "[E] very entity seeking radical change must have an education component integral to its operation. Labor unions and peasant organizations need to set aside time and resources for this."

Why no initiative for political education? A group of "union officers", borrowing from Michael Yates, "fear an educated membership [...] might decide to replace them."

Michael Yates mentions specifically: "Political parties and formations, Occupy Wall Street-types of movements, antiwar organizations, antiracist and anti-patriarchy movements need education efforts as well, ones that become permanently built into their structures."

The professor taking political classes for labor suggests:

"Planning actions, carrying them out, assessing successes and failures - all are vital subjects of education for members and participants."

On the question of the education of workers, Kalinin's words are worthy to recall. Kalinin, a factory worker turned communist revolutionary turned president of the Soviet Union, referred to their studies in underground circles: "[W]hile we studied the basic principles of Marxism we also covered a course of general education, beginning with the Russian classics - fiction writers, historians, critics - in a word, the whole range of knowledge to be found in books. While working in a plant, we at the same time got an all-round education in literature, science, etc." (On Communist Education, Selected Speeches and Articles, Foreign Languages Publishing House, 1950, Moscow, erstwhile USSR, the speech was delivered in 1926) He suggested acquiring political knowledge "based on those branches of general education and knowledge that are considered the necessary attributes of every more or less developed person. This development, this knowledge, should not be ignored." (ibid.)

The chapter, longest in the book, covers issues of relation between agriculture, peasants, farm workers, the environment, and class struggle around agriculture. It also discusses food. But, it again makes a statement, not endearing to slogan-mongers: "If unions mirror corporations in their structures, which all too many do, there isn't much hope that they will confront capital. And this is all the more the case if they have entered into a compact with employers that views the two sides as cooperators interested primarily in the profitability of the owners' businesses."

Michael Yates writes: "Since it is unlikely that current leaders will seek to do either of these things, the only way forward is to get rid of the leadership."

He informs about the US: There "have been frequent attempts by rank-and-file activists to take control of their unions and put them on a democratic and militant path."

However, he writes, "[a] few have been successful, most have not. [....] Those in power seldom want to relinquish control, and they will be as ruthless as necessary to beat back rivals. Still, labor rebellions have been successful, at all levels of unions."

The Niyogi-example, discussed in part 6 of this series, is there in India. There are similar examples in other countries. This fact demands dissec-

tion and analysis if similar future attempts are to be made successful.

Michael Yates emphasizes education if democratization of unions is to be achieved: "[E]ducation must be a priority. Compulsory classes should greet new members, teaching them about the union's history and that of the labor movement as a whole. And regular short courses, summer schools, and longer learning experiences should be made available, with at least some courses required to maintain membership. In these classes, the construction of a broader array of principles and aspirations can be developed."

He mentions a few cases from the Global South, which the working class has to resolve:


"There, wage laborers need to consider the needs and actions of peasants. In Brazil, for example, unions felt they should lead the way in land reform issues, rather than the Landless Workers Movement. However, 'Many in large Brazilian labor unions believed the fight for agrarian reform should take place within union ranks - but unions didn't accept landless farmers as members.' Even if one were to argue that this was shortsighted, it still didn't preclude active union support for what the farmers and peasants were doing. In India, labor unions have failed to offer full-throated support for the Maoist rebellions in the countryside. A worker-peasant alliance is essential for the working class to change the world, and until wage laborers embrace it, such change will not happen."

He brings to notice another aspect missing in many countries, but present in the US - union-like groups that take up the cause of the working class. He proposes: "[c]ooperation between unions and worker centers could be a strategy to rebuild labor movements." Such cooperation not only broadens the scope for organizing struggle of the working class, but also unites allies, helps fight out bourgeois ideas and bad elements ruffians, hoodlums, hirelings, and NGO- and capitalist-employees engaged to take away initiative from the revolutionary working class leadership in favor of capitalists.

On the question of labor and politics, Michael Yates, the economist with working class origin, says:

with working class origin, says: "What has been said about unions can be applied with equal force to labor's political path, so just a few points can be made here. First, substantive equality must prevail in political entities, just as it must in labor unions. This means that social democratic parties will have to be replaced by democratic workingclass parties. Here too, democracy is more than voting. Those in the party must run it. It must have radical principles and have radical goals. It must be built from the ground up, with those at the top responsible to those at the bottom. [....] Local assemblies seize the political initiative and then the assemblies begin to consolidate in larger geographical areas, culminating in a national party. These could then ally themselves with similar parties in other countries. At each level, the forming groups would commit to a set of principles. Second, working-class political parties can contend for state power, but in most cases this isn't likely to result in electoral victory. Education could then be the modus operandi of the party. In any case, radical pressure on the existing state should be exerted at all times. If special circumstances allow electoral victory, radical goals should be enunciated and movement toward achieving them should begin immediately. The collective power of the working class should be the weapon

employed to do this - mass demon-



and most of its officers must be demobilized. There could be cases in which a party has a military wing, in parts of the Global South, for example, and then revolutionary warfare can be considered, as in Nepal in the early part of this century or in the Indian countryside, which has been happening over the past several decades. [....] [T]here is no reason for a working-class political project to exist unless its aim is the defeat of capital. Demands should be radical and principled, and they should be adhered to. Tactical compromise might sometimes be necessary, but this can never be a strategy."

The paragraph cited above is significant, especially in terms of politics. It also challenges many existences with Red Flag.

As an example of political moves by the working class, Michael Yates cites Venezuela and the Richmond Progressive Alliance (RPA), a laborcommunity coalition in the city of Richmond, California.

The chapter makes significant statements challenging many ideas in vogue:

"It is an unworthy argument that says race and gender are mere identities, whereas class is a social relationship. [....] 'Class is a social relationship that is structured by race, gender, sexuality, nationality, and a whole range of other determinations.' [....] With respect to social policies, a narrow class-first approach will be similarly unable to dismantle racist and patriarchal structures."

Michael Yates writes:

"It takes boldness and courage to attack capital. But attack we must.

"If unions, peasant associations, and political entities are to work together to change the world, to bring an unalienating society into existence, then the motto of Brazil's Landless Workers' Movement must become the rallying cry for everyone: 'Occupy, Resist, Produce.' [....]

"Rather than waste time voting for traditional political parties, believing that they can be pressured to the left, workers must confront the state directly. [....]

"Occupation is a direct action that can take various forms, but it typically involves efforts to retake the commons or convert private property into common property."

"The unstated implication of everything said in this book is that the working class must change the world. There is really no choice. The long rule of capital has created profoundly alienated conditions for nearly all of humanity." (emphasis in the original)

He calls on us to:

"Fight landlords, disrupt classrooms, take on bosses, write, nothing is unimportant. And as we do this, remember that those who have suffered the most - workers and peasants in the Global South, minorities in the Global North, working-class women everywhere - are going to lead struggles or they are likely to fail."

He cites Bhagat Singh, the revolutionary leader in India executed by the British colonialists in 1931 when he was twenty-three years old: "The real revolutionary armies are in the villages and in factories, the peasantry and the labourers."

He says Bhagat Singh's hope on the peasantry and laborers is still true today. Michael Yates concludes the book by saying: "With humility, I offer them my solidarity. I hope we all do."

# ICT expert advocates for more data centres in Africa

There is a need to increase capacity for Africa to be able to have more data centres and host more of its data, Didier Nkurikiyimfura, an expert in ICT has said.

Nkurikiyimfura is the Chief Technology and Innovation Officer at Smart Africa Secretariat, an alliance which aims at leading Africa into a knowledge economy through Information and Communications Technologies (ICT).

Today, only one percent of data centres are in Africa, while 99 percent of them are hosted outside the continent, he revealed, pointing out that most of the continent's data is stored abroad. A data center is a repository consisting of a large group of networked computer servers and other facilities including routers, network switches and firewalls, and it is used for the remote storage, processing, or distribution of large amounts of data.

He was speaking during a "Cloud and Security Summit" which concluded in Kigali on Fri-

day, and serves as a platform where IT leaders from both supply and demand side can meet and interact in order to take measures and provide response to cyber security threats.

The two-day regional conference is organised by the Ministry of ICT and Innovation (MINICT) through Rwanda Information Society Authority (RISA). He said that Africa needs to build its data capacity to catch up with other continents in the world.

Sometimes, he said, because the foreign companies keeping data for African government and private sector are subject to their own laws and regulations, it might result in improper access to data, which might intrude on privacy.

"So, that is why we would like to advocate to have competing capacity in Africa," he said. Power, internet [connectivity] buildings, as well as regulation, are some of the infrastructures that are needed to operate data centres.

As of now, he said, it is difficult for the continent to develop its data storage capacity as it does not have enough infrastructure in place.

"So, it's a movement in both sides. One way we need to work and make sure that we have more and more physical infrastructures in place, but on the other side we need to put in place regulation to ensure that we protect data that are hosted, and once that data protected, our consumers are protected," he observed.

Meanwhile, it emerged from the conference that hosting data in some parts of Africa is expensive as one pays like five to six times of what they should pay to host it in foreign data centres such as Microsoft.

On the high cost of data hosting in Africa, Nkurikiyimfura said, "the fundamental problem here is that we don't have economies of scale - the cost advantage experienced when the amount of produced goods or services increases." In countries like the US where there are large data centres managed is because they have been able to host data for billions of people in the world, he indicated. "We need to get a mechanism to make it (data hosting) more affordable," he said.

# South African dagga industry could be worth R27 billion within four years

By 2023, just four years from now, the South African domestic market for cannabis and related products - excluding consumer CBD products, will be worth around R27 billion, says pro-marijuana consultancy Prohibition Partners in a new report.

But how much of the export market SA, and the continent as a whole, manages to secure may depend on water and irrigation infrastructure, the pro-cannabis consultancy says in its African Cannabis Report.

By United Nations estimates the African continent as a whole already produces some 38,000 tonnes of cannabis per year despite it being illegal to grow and possess just about everywhere. Farmers in various regions, including South Africa, have the knowledge and skill to grow cannabis successfully, Prohibition Partners says. And as demand for tobacco declines, poligrowing while farmers will likely be attracted by a hardy crop with better cash yields than most oth-

ups and foreign companies looking to expand," the consultancy says. S. Africa eyes green shoots in lo-

alcohol is aged, the post-harvest processing of cannabis could tell a compelling story to the consumer that helps establish brand identity and command a price premium. In this way, Africa could play a key role in boosting the cost per gram of cannabis in the recreational market amongst cannabis connoisseurs," says Prohibition Partners.

That is in reference to the way the popular Malawi Gold and Swazi Gold cannabis is wrapped in banana leaves and buried to cure, adding a unique colour and flavour.

The R27 billion calculation for the South African cannabis market is based on growth in markets that have legalised marijuana for both medicinal and recreational use, such as Uruguay and Canada, and some American states. It excludes cannabinol (CBD) because there is not yet enough data on sales to predict the size of the CBD market, Prohibition Partners says.

CBD is a non-psychoactive compound extracted from marijuana, and products from beer to doggy treats containing it are already widely available in SA, suggesting it could add significantly to the total cannabis industry.

## **Mozambique plans** sovereign wealth fund to manage gas revenue

**MAPUTO** 

Mozambique's government plans to establish a sovereign wealth fund to manage income from future gas production, President Filipe Nyusi said.

The state will also allocate a fixed portion of revenue to the state budget to fund infrastructure development, poverty reduction and economic diversification, Nyusi said in a speech on Wednesday in the capital, Maputo.

Companies including Eni SpA and Anadarko Petroleum Corp. are developing gas discovered nine years ago in deep waters off the coast of Mozambique, one of the world's poorest countries. The southeast African nation holds 100 trillion cubic feet of proven natural-gas reserves, the third-biggest in Africa, according to the Energy Information Ad-

"Savings will serve as a cushion when gas prices are low," Nyusi said. The state should manage the funds to avoid effects like Dutch Disease, he said, referring to the phenomenon in which a commodity boom makes a country's currency more expensive and its other goods less competitive.

Nvusi said it's estimated that the Rovuma basin, where Anadarko and other operators are present, may contain 270 trillion cubic feet of natural gas. If confirmed, the deposit would be the biggest in Africa.

Anadarko is planning to make a final investment decision on a \$20 billion project in Mozambique, including an onshore liquefied natural gas processing facility, by June. Exxon Mobil Corp. plans to make a decision on an even bigger LNG project in the same area by the end of the year.

# New fuel taxes take petrol price to all-time high in SA

All grades of petrol and diesel will climb by up to R1.34c/l come Wednesday April, 3, the department of energy announced late on Saturday. Motorists will be paying close to R15/l of petrol for the first time this year.

Energy Minister Jeff Radebe noted that April is an important month in the fuel price calendar to revise road and pipelines tariffs as well as fuel and Road Accident Fund levies, to be implemented into the price structures of petrol, diesel and Illuminating paraffin (IP).

"Their total contributions to the fuel price increase is about 26.00c/l in Gauteng whilst the international factors amounted to about 106.00c/l on petrol and 56.00c/l on diesel and IP." South Africa's fuel prices are adjusted on a monthly basis, informed by international and local factors.

Domestically, the increase in the Fuel and Road Accident Fund Levies by 15.0cpl and 5.0cpl, respectively, as announced by the Finance Minister Tito Mboweni in his Budget Speech in February has been included in the new fuel price adjustment.

# EMEA smartphone market, digital transformation gives Huawei a boost

urope, the Middle East and Africa (EMEA) generated CNY204,536-million (approximately US\$32-million) for Chinese multinational ICT and telecommunications firm Huawei.

This is according to the company's 2018 Annual Report released today, in which the company attributed the 24.5% year-on-year increase in EMEA revenue to growing sales of its high-end and mid-range smartphones, an increased share of the smartphone market, along with faster digital transformation of its enterprise business.

According to the report, the company's sales revenue rounded off at CNY721.2-billion, up 19.5% vear-on-year; its net profit reached CNY59.3-billion, up 25.1% year-on-year. In

March 2019 the company unveiled its new P-Series smartphones, the P30 and P30 Pro, in Paris. They represent Huawei's latest flagship models, to follow the P20 and P20 Pro launched in 2018. The company has also attributed growth to its investment in R&D. "In 2018, Huawei invested

CNY101.5 billion (14.1% of its sales revenue) in R&D, ranking fifth globally in The 2018 EU Industrial R&D Investment Scoreboard. Over the last ten vears, Huawei's R&D expenditure has reached more than CNY480 billion. According to official data released by the World Intellectual Property Organisation (WIPO), Huawei filed 5,405 patent applications to this organisation in 2018, ranking first among all companies globally," the company stated in its report.

Guo Ping, Huawei's Rotating Chairman, said, "Through

5G innovation, alongside largescale commercial deployment, Huawei is committed to building the world's best network connections. ### **Global scrutiny**

The company has made global headlines, particularly because of the arrest of the founder's daughter in Canada for extradition to the US, as well as international scrutiny of the company and its products, and security concerns related to its close ties to the Chinese government.

An ITWeb report noted that in August 2018, US president Donald Trump banned the US government use of equipment made by the Chinese company.

"The US is pushing allies to follow suit and keep Huawei out of planned 5G networks, and it seems to be working.'

"Japan has already excluded Huawei from public procurement, and Australia and New Zealand effectively blocked Huawei from involvement in the rollout of their 5G network infrastructure. The UK, Canada, Germany, Poland, Norway and the Czech Republic are also assessing whether to exclude Huawei from forthcoming infrastructure rollouts," according to ITWeb.

# Apple comes up with apology to MacBook owners who are still experiencing keyboard issues

NEW YORK

Customers that own Apple's MacBook laptops - specifically those with butterfly keyboard designs - have been experiencing issues ever since Apple decided to reinvent its keyboards to be thinner around 2015.

And on Wednesday, Apple finally released a statement apologizing to customers who are still affected.

"We are aware that a small number of users are having issues with their third-generation butterfly keyboard and for that we are sorry," an Apple spokesperson tells Business Insider. "The vast majority of Mac notebook customers are having a positive experience with the new keyboard."

The spokesperson added that people who are still having keyboard issues should get in contact with Apple Support, the company's customer service hotline. Apple's continuing keyboard issues were first spotlighted by the Wall Street Journal on Wednesday.

Apple has been trying to improve its keyboards ever since it released the 12-inch MacBook with the first butterfly keyboard in 2015. At first, people complained that keyboards were too thin, and not satisfying to type on. So Apple released a second-generation keyboard a year later, and put that new keyboard in the new MacBook Pro, but people continued to encounter issues. People would complain about the keyboard not registering, or over-registering, certain common keys, like "E" and "R."

Apple launched a repair program for MacBook and Mac-Book Pro computers in June 2018. The following month, Apple released a new MacBook Pro with a redesigned keyboard - the third design in three years, mind you - that would apparently fix the issues. The new MacBook Air from late last year has the same keyboard.

Unfortunately for Apple, some of these keyboard issues, like repeating or missing keys, appear to be persisting among a handful of customers with the third-generation designs. including The Wall Street Journal's Joanna Stern. For what it's worth, there are multiple class-action lawsuits being filed against Apple for these keyboards that are "prone to failure," as one complaint put it. Over 35,000 people have also signed a Change.org petition asking for Apple to recall its defective keyboards.

While this may be Apple's first apology about the thirdgeneration keyboards, and how they don't appear to solve some of the problems that plague the butterfly keyboard design, it will be interesting to see how Apple proceeds.

The company keeps saying only a "small number" of people are affected, but lots of people are buying Apple's latest MacBook Pro and MacBook Air laptops, and lots of people appear to be complaining about them. Hopefully there's a proper hardware fix for these computers (aside from buying cans of compressed air and hoping for the best), and that Apple considers another hardware iteration for future key-







### Gold faces worst month since Aug; palladium eyes biggest weekly dip in 3 yrs

- \* Gold on course for 2nd straight quarterly rise

LONDON, March 29 (Reuters) - Gold slipped on Friday and was headed for its worst month since August 2018 on a stronger dollar and equities, while palladium rose after three straight sessions of sharp declines, but was on course for its biggest weekly fall in more than three years.

Spot gold was down 0.1 percent at \$1,288.56 per ounce by 0804 GMT, after declining about 1.5 percent in the previous session, the most in over seven months.

The metal is set for its first weekly fall in four and has lost about 1.9 percent this month. But on a quarterly basis, gold is en route to a second straight rise, due to a dovish U.S. Federal Reserve and concerns about a glob-

al economic slowdown.

The dollar was poised for its strongest monthly gain in five, while Asian shares rose on hopes that Washington and Beijing are making progress in trade talks.

The world's two largest economies started the new round of talks on Thursday to end the year-long tit-for-tat tariffs war.

"If we have a positive outcome from the trade talks, gold will be under pressure as investors will rotate out into more risk seeking assets," said Jeffrey Halley, a senior market analyst with OANDA.

"But, if we have disappointing outcome then stocks will go down and people will move into safe-haven assets like gold. The market is very much in a wait and see mode.'





## Oil set for biggest quarterly rise since 2009 amid OPEC cuts, sanctions

LONDON 29 (Reuters) - Oil prices rose on Friday (\$65 WTI), and \$70 for the year". amid OPEC-led supply cuts and U.S. sanctions against Iran and Venezuela, putting crude markets on track for their biggest quarterly rise since 2009.

"Production cuts from the OPEC+ group of producers have been the main reason for the dramatic recovery since the 38 percent price slump seen during the final quarter of last year," said Ole Hansen, head of commodity strategy at Saxo Bank.

Prices shrugged off a tweet from U.S. President Donald Trump on Thursday calling for OPEC to boost crude production.

"While OPEC, and above all Saudi Arabia, appeared in November to be obeying U.S. President Trump's repeated demands to increase oil production, his tweets now are more likely to fall on deaf ears," Commerzbank said in a note.

OPEC and its allies are scheduled to meet in June to set policy, but some cracks in the union are emerging

OPEC's de facto leader Saudi Arabia favors cuts for the full year while Russia, which joined the agreement reluctantly, is seen as less keen to restrict supply beyond September.

U.S. sanctions on OPEC members Iran and Venezuela are also buoying prices.

Washington is exerting further pressure on oil traders to cut oil dealing with Venezuela or face sanctions themselves.

Bank of America said it expected oil to rise in the short term with Brent forecast to average \$74 per barrel in the second quarter.

A monthly Reuters survey of economists and analysts forecast Brent would average \$67.12 a barrel in 2019, about 1 percent high

# What now for Britain's troubled Brexit?

**LONDON** 

BRITISH Prime Minister Theresa May's Brexit deal is all but dead, after lawmakers voted to reject it for a third time on Friday – the day Britain had long been scheduled to leave the European Union.

The UK now faces a deadline of April 12 to present the EU with a new plan, or crash out of the bloc without an agreement.

Here's a look at what could happen

### **NO DEAL**

The EU has given Britain until April 12 - two weeks away - to decide whether it wants to ask for another postponement to Brexit. The bloc has called an emergency Brexit summit for April 10 to deal with a British request, or prepare for a no-deal Brexit.

Without a delay, Britain will leave the bloc at 11 pm UK time (6 pm EDT) on April 12 without a divorce agreement to smooth the way. Most politicians, economists and business groups think

such a no-deal scenario would be disastrous, erecting customs checks, tariffs and other barriers between Britain and its biggest trading partner.

Parliament has voted repeatedly to rule out a no-deal Brexit – but it remains the default position unless a deal is approved, Brexit is canceled or the EU grants Britain another exten-

### **DELAY AND SOFTEN**

The alternative to "no-deal" is to delay Brexit for at least several months while Britain tries to sort out the

The bloc is reluctant to have a departing Britain participate in European Parliament elections in late May, as it would have to do if Brexit is delaved.

But EU Council President Donald Tusk has urged the bloc to give Britain the extension if it plans to change course and seek a softer Brexit that keeps close economic ties between Britain and the bloc.

May has always ruled that out, because sticking to EU trade rules would limit Britain's ability to forge new trade deals around the world.

But a customs union would ensure UK businesses can continue to trade with the EU, and would solve many of the problems that bedevil May's deal. In particular it would remove the need for customs posts and border checks between Ireland and Northern Ireland.

There's a good chance a withdrawal agreement that included a customs union pledge would be approved by Parliament, and welcomed by the EU.

### **ELECTION GAMBLE**

Britain is not scheduled to hold a national election until 2022, but the gridlock in Parliament makes a snap vote more likely.

Opposition politicians think the only way forward is an early election that could rearrange Parliament and break the political deadlock. They could try to bring down the government in a no-confidence vote, triggering a general election.

Or the government could pull the trigger itself if it thinks it has nothing to lose.

May promised to quit if her Brexit deal was approved and Britain left the EU in May. Even though it was defeated she will still face huge pressure to resign, paving the way for a Conservative Party leadership contest.

**NEW REFERENDUM** 

Another option considered by lawmakers this week called for any deal to be put to public vote in a "confirmatory referendum." The idea has significant support from opposition parties, plus some members of the Conservatives.

The government has ruled out holding another referendum on Britain's EU membership, but could change its mind if there appeared no other way to pass a Brexit deal.

Britain voted by 52 percent to 48 percent to leave the EU in 2016. Since then, polls suggest the "remain" side has gained in strength, but it's far from clear who would win a new referendum. It could leave Britain just as divided over Europe as it is now.

# Trump cuts aid to Central American countries as migrant crisis

WASHINGTON/EL PASO, Texas

THE U.S. government cut aid to El Salvador, Guatemala and Honduras on Saturday after President Donald Trump blasted the Central American countries for sending migrants to the United States and threatened to shutter the U.S.-Mexico border.

A surge of asylum seekers from the three countries have sought to enter the United States across the southern border in recent days. On Friday, Trump accused the nations of having "set up" migrant caravans and sent them north.

Trump said there was a "very good likelihood" he would close the border this week if Mexico did not stop immigrants from reaching the United States. Frequent crossers of the border, including workers and students, worried about the disruption to their lives the president's threatened shutdown could cause.

At a rally on the border in El Paso, Texas, Democratic presidential hopeful Beto O'Rourke denounced Trump's immigration policies as the politics of "fear and division."

A State Department spokesman said in a statement it was carrying out Trump's directive by ending aid programs to the three Central American nations, known as the Northern Triangle.

The department said it would "engage Congress in the process," an apparent acknowledgement that it will need lawmakers' approval to end funding that a Congressional aide estimated would total about \$700 million.

New Jersey Senator Bob Menendez, the top Democrat on the Senate Foreign Relations Committee, called Trump's order a "reckless announcement" and urged Democrats and Republicans alike to reject it.

Trump told reporters at his Mar-a-Lago resort in Florida on Friday that the United States was paying the three countries "tremendous amounts of money," but received nothing in return.

Mario Garcia, a 45-year-old bricklayer in El Sal-



vador, said he was setting off for the United States regardless of the president's threat to close the

"There is no work here and we want to improve (our lives), to get ahead for our families, for our children. I don't give a damn (what Trump says), I'm determined," Garcia said.

Garcia was one of a group of at least 90 people who left the capital San Salvador over the weekend on buses heading north, in what locals said was the tenth so-called caravan to depart for the United States since October.

The government of El Salvador has said it has tried to stem the flow of migrants.

The Honduran Foreign Ministry on Saturday called the U.S. policies "contradictory" but stressed that its relationship with the United States was "solid, close and positive."

Trump, who launched his presidential campaign in 2015 with a promise to build a border wall and crack down on illegal immigration, has repeatedly threatened to close the frontier during his two years in office but has not followed

This time, Homeland Security Secretary Kirstien Nielsen and other U.S. officials say border patrol officers have been overwhelmed by a sharp increase asylum seekers, many of them children and families who arrive in groups. fleeing violence and economic hardship in the Northern Triangle.

March is on track for 100,000 border apprehensions, Homeland Security officials said, which would be the highest monthly number in more than a decade. Most of those people can remain in the United States while their asylum claims are processed, which can take years because of ballooning immigration court backlogs.

Nielsen warned Congress on Thursday that the government faces a "system-wide meltdown" as it tries to care for more than 1,200 unaccompanied children and 6,600 migrant families in its Agencies

# Israel reopens Gaza commercial crossing in sign of easing tensions fence, a frequent flashpoint.

ISRAEL reopened its commercial crossing with the Gaza Strip yesterday but kept military reinforcements deployed on the volatile frontier, a day after a smaller than expected Palestinian protest along the border.

Gaza medical officials said four Palestinians were killed by Israeli fire during demonstrations on Saturday marking the first anniversary of the "Great March of Return" protests.

Around 200 Gazans have been killed by Israeli troops since the protests started on March 30 last year, according to Palestinian Health Ministry figures. An Israeli soldier was also killed by a Palestinian sniper in July.

But while around 40,000 protesters, some hurling grenades and explosives, turned out on Saturday, according to the Israeli pullback from wider confrontation amid Egyptian efforts to reach a long-term ceasefire that would also ease blockaded Gaza's economic plight.

An Israeli military spokesman ple from going near Israel's border

noted that there had been "significantly less violence" during Saturday's protest, which organizers had billed a "million person military, several signs pointed to march", than in past weekly demonstrations.

# No request for phone call with Putin from US yet - Kremlin

**MOSCOW** 

THE Kremlin has not yet received any requests for a phone call with Russian President Vladimir Putin from the Trump administration, Presidential Spokesman Dmitry Peskov (pictured) said when asked by TASS to comment on the US president's statement on the possibility of discussing the situation in Venezuela with his Russian counterpart.

"No, there have been no such requests [for a phone call with Putin from US representatives] yet," he said.

On Friday, US National Security Adviser John Bolton said that Trump so far had no plans to hold phone calls with the Russian leader.

Meanwhile, the US president himself admitted that he could discuss the situation in Venezuela with Putin and Chinese President Xi Jinping in the near



future. The situation in Venezuela was one of the issues discussed

at Putin's meeting with the permanent members of the Russian Security Council on Friday

The participants in the meeting stressed that statements on plans to meddle in Venezuela's domestic affairs made by some countries hindered efforts aimed at overcoming the crisis in the Latin American country.

Juan Guaido, Venezuelan opposition leader and parliament speaker, whose appointment to that position had been cancelled by the country's Supreme Court, declared himself interim president at a rally in the country's

capital of Caracas on January 23.

Several countries, including the United States, Lima Group members (excluding Mexico), as well as the Organization of American States, recognized him as president. In contrast, Russia, Belarus, Bolivia, Iran, China, Cuba, Nicaragua, El Salvador, Syria and Turkey voiced support for Maduro.

Commenting on reports on Russian military servicemen's presence in Venezuela, Russian

Foreign Ministry Spokeswoman Maria Zakharova said in a statement on March 26 that Russian specialists had arrived in Venezuela in strict compliance with that Latin American country's Constitution.

The diplomat stressed that their presence in Venezuela was stipulated by the 2001 agreement on military-technical cooperation reached by the Russian and Venezuelan govern-

# **LeBron James to sit out last** 6 games of Lakers' season

**LOS ANGELES** 

LeBRON James' first season with the Los Angeles Lakers is over.

James will sit out the final six games of the Lakers' sixth consecutive losing season, the team announced Saturday. In a statement, President of Basketball Operations Magic Johnson and General Manager Rob Pelinka claimed the decision will provide James with a head start on offseason healing for a three-monthold groin strain, the first significant injury of his career.

"After consulting with our team doctors and medical staff, we have decided to hold LeBron out of games for the remainder of the season," the statement said. "This decision will allow his groin to fully heal, and is best for the future success of both LeBron and the Lakers."

James is the NBA's fifthleading scorer at 27.4 points per game, and he averaged 8.5 rebounds and 8.3 assists in his first season on the West Coast. He will accompany the Lakers on their upcoming trip to New Orleans and Oklahoma City, but the 16year NBA veteran won't plav again in his first non-playoff season since 2005, his second year in the league.

James appeared in the past eight NBA Finals with Miami

and Cleveland, but he will finish this year playing in a career-low 55 games and a career-low 35.2 minutes per game for the Lakers. Despite James' ballyhooed arrival along with Rajon Rondo and JaVale McGee to lead the Lakers' talented young core, Los Angeles failed to overcome several major injuries and a midseason crisis of team confidence when the Lakers attempted to land superstar Anthony Davis in a multi-player trade.

"It's challenging, but I kind of knew what I was getting myself into," James said earlier this month.

Los Angeles is 34-42 after beating Charlotte 129-115 on Friday night, with James scoring 27 points in what turned out to be his final appearance.

The Lakers have won three of four since being eliminated from playoff contention last week with a loss to Brooklyn, their 10th in 11 games and their 28th in 42 games since Christmas.

Los Angeles entered Saturday's games with the NBA's 10th-worst record. While a strong finish to the season could be a boost for the future, it could also damage the Lakers' hopes of landing an elite talent in the draft.

"We picked a hell of a time to have a great rhythm," James said after the Lakers

beat the Hornets. "We're having fun. We're playing the way we wanted to play all year, but obviously because of injuries, multiple lineup changes and things of that nature, that would affect it. But we've kind of known who's going to be in the lineup over these last few games, and it's allowed us to have our rotations down, and guys have been playing well."

Although James' first season with Los Angeles was a failure, it showed promise before injuries changed everything.

The Lakers were 20-14 and in fourth place in the Western Conference when James strained his groin during a stunning 26-point road victory over Golden State on Christmas. He sat out their next 17 games in the longest injury absence of his career.

James returned to the lineup for good in early February, but the injuryplagued Lakers were unable to recover and make the playoffs.

Along with James, the Lakers are finishing the season without three key players in their young core. Brandon Ingram has been out since March 2 due to a blood clotting issue, while Lonzo Ball hasn't played since Jan. 19 because of an ankle injury, and Josh Hart was ruled out for the season this week with a knee injury.

# Giniki: My victory in Tigo Kili Half Marathon is dedicated to all Tanzanians

OR the past four years, Tigo Company has been the patron of the 21km race in the annual Kilimanjaro Marathon. The race, popularly known as the Tigo Kili Half Marathon, covers 21km stretch that meanders through the scenic slopes Mt. Kilimanjaro, Africa's tallest peak.

As it is customary, this year's Tigo Kili Half Marathon was held in Moshi, the northern Tanzania city that lies strategically on the slopes of the mountain that is an epitome of legends, myths and folklore among the locals.

It offers the enthusiasts the rare opportunity of savouring the snow-capped tip with all its majesty, splendour and glory.

In this year's race, Tanzania's Emmanuel Giniki won the home crowd applause at the Tigo Kili Half Marathon 2019 held in Moshi after many years of being dominated by foreigners particularly Kenyans.

Giniki swept out competent Kenyans to win the Tigo Kilimanjaro Half Marathon men's category, while in the women's discipline, Tanzanian Failuna Matanga crossed the finishing point at Moshi Cooperation University (MoCU) ground in second

Thousands of runners from different countries competed in the prestigious event, sanctioned by the International Association of Athletics Federations (IAAF).

Giniki won a heroic welcome at fully-packed finish ground, after recording one hour, three minutes and 34 seconds to win the gold medal as nine Kenyans followed him.

"I feel proud of my home victory, it was a tough race. The Last 100 meters before the finish line was the hardest to me because my opponents were closely running after me, but I pulled up to make sure that I beat them all," Giniki who also won the 2017 Tigo Kili Half Marathon, said.

Commenting further on his victory, Giniki, who is an athlete from Tanzania People's Defense Forces (TPDF), said that it was through exercise and solid commitment to win that he made it.

"It was not easy, I trained very hard and I said to myself - I must win and I indeed won the race. If you are doing something with serious commitment and you direct all your efforts towards it, the chances of doing well are higher," Giniki said with a light smile on his face.

His victory, according to him, is dedicated to all Tanzanians as they gave him the strength he needed to proceed even at the time when he was too tired.

He said; "For those who were at the Ushirika grounds, they can recall the encouragement I received from Tanzanians when I was about to finish and the joy they had when I finished first.

This is why I say, this is victory for all Tanzanians."

In the race's women's discipline, Grace Kimanzi of Kenya continued her prowess, winning the race for the fourth time in a row since 2015. She clocked at 01:11:45 to bag home gold medal.

She said; "I trained very hard while in Kenya, thank God I made it again."

"My coach, Paul Muthui, always tells me to aim high for medals and that is what I did," the athlete from Machakos Club disclosed.

Failuna clocked at 01:14:01 to win the second place but was bemoaned down at the starting point that denied her full strength to win the first spot.

Now in its 17th year, the Kilimanjaro Marathon, has gradually evolved over years, morphing into the global sporting behemoth that it is today, gathering thousands of local, regional and international participants and enthusiasts, who throng the venue for the grand annual sports extravaganza.

Recognized by the Runners' World Magazine as the Second Wonder of the World Marathons and by the famous Forbes Magazine as the Best International Adventure Marathon.

Tanzania's most renowned athletics meet has today acquired a life of its own, drawing over 9000 participants from across the world every year.

Ranging from a 5km family fun run, the 21km road race, and the actual 42km race whose course meanders through the picturesque view of Mt. # Aguero fitness could be key to Man City's quadruple bid

**LONDON** 

NYONE seeking definitive clues as to the destination of this season's Premier League title could probably have taken the afternoon off, for Manchester City will not enjoy a more comfortable assignment than their 2-0 win vs. Fulham over the next six weeks.

Had the mood taken them on a sun-drenched day by the River Thames, they could have added handsomely to their goal difference, but it was hardly an occasion on which to operate at full throttle. What matters is that, with the season's final lap underway, Pep Guardiola's side are back in the driving seat, one point clear of Liverpool at the top.

If there is a flicker of concern, it will stem from the fact Sergio Aguero, who put the game beyond Fulham with City's second goal in the 27th minute, left the pitch before an hour had been played.

"He said he felt something but not injured," Guardiola said. "For precaution he decided not to continue. We will see tomorrow."

With Aguero's track record of sustaining muscle injuries, those of a City persuasion can be excused a few jitters amid hope that it was a safety-first measure on the Argentine striker's part. Wednesday's match against Cardiff should be the kind in which Gabriel Jesus comfortably deputises, ahead of tougher tests later in April.

Aguero (and Guardiola) will be well attuned to the fact that next weekend's FA Cup semifinal with Brighton holds no guarantees and is followed three days later a Champions League quarterfinal first leg away to Tottenham. At 30, he knows his body well enough to minimise the risk of adding to the eight games he has missed in all competitions this term

His goal, clipped inside the far

post sublimely from a tight angle after Fulham's Joe Bryan had gifted possession, was a reminder that Aguero turns half-chances into clear openings and it is a facet City will require against sterner opposition than Scott Parker's relegation-bound Fulham.

If questions remain about City's title bid then there is also the debate about whether, in all honesty, games such as this are good for anyone. From the moment Guardiola's men went 2-0 in front, it was played with the pace and intent of a preseason friendly.

City had no need to go all out, given their battle on three fronts and inevitable post-international break ring rust, while Fulham, who continue to give an object lesson in how not to go about a Premier League season after earning promotion, were simply unequipped to lay a glove on their

Even the home fans' protest against high admission prices -- a small demonstration took place in the 55th minute to match the day's cheapest adult ticket of £55 (\$71) -- seemed muted, although it is hard to see how anyone got value for money

The loudest cheers erupted upon moments of mild farce, like the series of passes Fulham managed to string together around the quarter-hour mark after barely completing one before then and the shot that City's Nicolas Otamendi skied over the Putney End in the 53rd minute.

City were ruthless in exploiting mistakes early and Fulham's near-constant concessions of the ball around their own penalty area beggared belief; Bernardo Silva's low, inch-perfect curler in the fifth minute arrived after sloppy

play from Timothy Fosu-Mensah and the undercooked ball from Bryan that set Aguero away was also entirely characteristic of their display.

Fulham did not register a shot on target in a home fixture for the first time in nine years; couple that with Bournemouth's failure to have any kind of goal attempt against City when they met at the Vitality Stadium earlier this month and it is not a good look for the league, even if Guardiola's men can hardly be blamed for that.

The Aguero concern aside, City's only other regret on such a serene day might be that they could not add further gloss to the scoreline. Kyle Walker struck the post late on while Raheem Sterling, so clinical of late for club and country, was off-key with his finishing and had one of his less

"The game was under control, that is the truth," Guardiola said. "We missed maybe one more goal, but that's OK. [It was the] international break and people told me they were tired. I'm sure in the next game our pace will be a little bit better."

If that is the case, Cardiff should surely be brushed aside at the Etihad during what is, effectively, City's game in hand.

"We have to win every game," Guardiola said. "We have tough opponents; that is the challenge." City's only real opponents on Saturday were themselves and, with the hurdle duly cleared, attention turns to Anfield. For Liverpool, who will surely be tested more by Tottenham than were City by Fulham, the pressure has been ratcheted up further before

their own run-in has begun.

# Messi hits 40-goal mark for 10th straight season

LIONEL Messi scored twice to earn Barcelona a 2-0 derby win over Espanyol and keep them 10 points clear at the top of La Liga on Saturday.

A dull match was decided by Barcelona's No. 10, who lofted home a free kick after 71 minutes and slotted in from substitute Malcom's cross towards the end.

Messi, who now has 40 goals in all competitions this season, suffered criticism in his native Argentina after withdrawing from a friendly against Morocco because of a groin problem, but was hailed by Barcelona fans after taking them one step closer to retaining

"The important thing is that [Messi's] on our side, he scored a great free kick and without doubt having him is always an advantage for us," said midfielder Sergio Busquets.

"Espanyol were ultra-defensive and it made it hard to find spaces. We had opportunities but they didn't go in.

"We had to work for it but in the end. we took our chances and the result was justice for what happened in the game."

Ernesto Valverde started Messi along with Luis Suarez, who had recovered

from an ankle sprain.

But the duo and Philippe Coutinho were kept quiet in a tight first half, with Espanyol's five-man defence not giving the South American trio any space.

The Brazilian winger had a crossshot tipped wide by Diego Lopez, with Coutinho firing over the bar as Barcelona pushed for a winner.

Barcelona were far below their fluid best but two moments of skill from talisman Messi secured three points from an otherwise forgettable game.

# Zidane talks up interest in United star Pogba

MADRID

REAL Madrid coach Zinedine Zidane has said he likes Paul Pogba "a lot" and suggested the midfielder could move to the Bernabeu when he leaves Manchester

Speaking at a news conference ahead of Sunday's home game against Huesca, Zidane said Pogba was a "different" player and had few equals.

France international Pogba said earlier this month that "all players dream of playing for Real Madrid," sparking speculation about a potential move.

"I like him a lot -- that is nothing new," Zidane said. "I know him personally. He is a truly different player -- few players can do what he can. He is a midfielder who can defend, attack, do everything.

"But he is not my player, he is at Manchester. He has always said that, after Manchester, Madrid has always interested him. So when his experience at Manches-

ter ends, why not come here to Madrid?" Zidane was asked whether any player could be worth the €280 million mooted as the price for Paris Saint-Germain's France forward Kylian Mbappe.

"You cannot say these days what a player is worth -- €100m, €20m, €300m," he said. "It is up to the clubs.

"When I came here they said the price of €72 million was crazy, and in the end look what happened. We know the player that he is. He is not my player, so I will not speak out of respect for him and his club PSG, and above all respect for my own

Since returning to Madrid, Zidane has talked about "changes" in the summer,

with speculation surrounding the future of Wales winger Gareth Bale.

"Gareth is an important member of the squad," Zidane said. "We know what he has done here, even in Champions League finals.

"Nobody can take away what he has done. We know he can bring a lot to the team, and we will count on him. "We are going to play these 10 games

[the last 10 of the season], and then we will see. That does not mean that, afterwards, there will be changes.

Recent reports suggested defender Raphael Varane was considering leaving, but Zidane said: "There is always a lot of talk here, and people can write whatever

"The important thing is what the player thinks, and I can tell you he is very happy here. He has been here eight years and has done phenomenally well so far.

"I don't see him as people have said recently. To me, he looks happy and committed in what he is doing."

Goalkeeper Thibaut Courtois, who lost his place to Keylor Navas when Zidane returned, suffered a thigh injury on international duty with Belgium last week.

"The doctors will look at it and see how long he will be out," Zidane said. "I will not take risks on any player with a problem, even more with Thibaut who has played a lot, with his national team too.

"It is not a long time, just days, but he will not play tomorrow."

Toni Kroos, Luka Modric and Varane also missed out on Madrid's squad, rested after training without issues on Saturday morning.

# Solskjaer: Man Utd 'almost in driving seat' for top four

Solskjaer described the FA Cup defeat to Wolves before the international break as the worst performance of his reign, but suggested it had been trumped by what he saw against Watford.

"After PSG, that was a mental challenge after the high of that," he said. "We went to Arsenal, played really well and lost, and then we had the chance to get to the semifinal. That was a poorer performance than when we lost to Wolves.'

One highlight for Solskjaer was the performance of Luke Shaw, who set up Rashford's goal with a wonderful pass through the Watford defence.

But it was not a productive afternoon for Paul Pogba, and Solskjaer said he may have made a mistake by deploying the France international in a deeper role.

"Luke has got so much in his locker," the manager said. "He is exceptional going forward and I can't wait to see him blossom. I thought he was total class today until he got cramp.

"Paul is important for us, but we couldn't keep the ball today. We had 50-50 possession at home, you are a bit disappointed with that. "Paul has been away, played two games with France. He was a bit deeper, so that is something we may have to think about, to get him more involved."

# Kean, 19, scores again as Juventus edge Empoli

Juventus, missing Cristiano Ronaldo after he suffered a thigh injury in Portugal's 1-1 draw with Serbia on Monday and Paulo Dybala after he pulled up during the warm-up, struggled to break down the visitors until Kean struck in the 72nd minute.

Giorgio Chiellini played a long ball out of his own half and Mario Mandzukic headed it into the path of Kean who fired past Bartlomiej Dragowski.

Juventus have 78 points, 18 clear of second-placed Napoli who visit AS Roma on Sunday. Empoli are 17th with 25 points, one point and one place above the relegation zone.

Juventus coach Massimiliano Allegri tried to keep Kean's feet firmly on the ground.

"Kean has quality but he has to im-

prove in lots of areas and his willingness to make sacrifices will make the difference," Allegri said. "So many players have lost their way along the road."

He added that Kean was not ready to start the match after his week with the national team.

"He scored two goals for Italy in as many games and having all that attention uses up a lot of energy both physically and mentally," he said. "He returned from the international break and looked like he barely knew where he was."

Empoli had enjoyed the better of the first half, angering the home crowd, and Rade Krunic was twice close to giving them a shock lead.

"The crowd were right because we didn't play well," said Allegri, referring to the fans' reaction.

Juventus, who lost their unbeaten league record in their previous outing when they were beaten 2-0 at Genoa, showed more signs of life after halftime as Federico Bernardeschi crashed an acrobatic volley against the crossbar.

Kean's entrance in the 69th minute got the biggest cheer of the evening up to that point and he could have had a second goal when he got clear of the Empoli defence but was foiled by Dragowski.

# COSAFA 2019 senior championship venue undecided

ZIFA management committed to presenting to COSAFA written confirmation of this decision no later than March 25th 2019.

Unfortunately they failed to deliver on the nominated deadline which has left COSAFA with no recourse other than to enforce their disciplinary procedures which process calls for ZIFA to attend a disciplinary hearing scheduled for April 4 in Johannesburg.

The hearing will be handled by COSAFA's independent judicial body, and the outcome and punitive action will be handed down within 48 hours of the

COSAFA is particularly disturbed by the management of the process by ZIFA by 2019 is a critically pivotal year for football in the Sub Saharan region.

For the first time in 21 years, five COSAFA member countries have qualified to participate in the continental showpiece, including Zimbabwe's celebrated Warriors.

The COSAFA Senior Tournament has consistently proved to be a vibrant platform of opportunity for all competing countries.

In 2019 has become a key factor in pre-AFCON preparation for the successful qualifiers, with coaches and team management planning to use the COSAFA tournament to fine tune their training prior to the AFCON June 21 kick off.

COSAFA remain hopeful that ZIFA will remedy the current situation prior to the disciplinary committee hearing on April 4.
