



#### TARI sets plans for 1m tonnes of wheat By Guardian Correspondent, Morogoro

OVER 400,000 hectares of farms in various regions are in the next few years to be devoted to growing wheat to produce more than one million tonnes of the grain and do away with import dependence.

Dr Geoffrey Mkamilo (pictured), the Tanzania Agricultural Research Institute (TARI) executive director, made this observation in an interview here yesterday, in the wake of government appeals for increased wheat production aired during the recent Nanenane celebrations held nationally in Mbeya.

TARI has drawn up strategies to transform wheat farming as the country imports over 900,000 tonnes of the grain each year to meet domestic demand that stands at one million tonnes, he said.

TARI will initially produce 2,500 tonnes of seeds, which will in turn produce 50,000 TURN TO PAGE 2

# FCC: 20.8bn/- imports in trademark violation

INSPECTIONS at the port of Dar es Salaam and the Kwala dry port in Kibaha unveiled that 3.4 per cent of containers valued at 20.8bn/- had goods violating trademark law during the past year, the Fair Competition Commission (FCC) has stated.

William Erio, the director general, made this affirmation here yesterday in a briefing on commission activities and the direction of its performance at the start of fiscal 2023/24.

During fiscal 2022/23 the war against counterfeit goods included inspections at the Dar es Salaam port and the dry port, he said, noting that impromptu inspection showed goods valued at 4.7bn/- that violated trademark laws, where the goods were seized and appropriate steps taken.

Inspections were conducted in Dar es Salaam, Mtwara, Lindi, Ruvuma, Songwe, Kilimanjaro, Coast, Mwanza, Arusha, Katavi and Mbeya entry points, he said.

FCC destroyed seized goods in Mbeya, Iringa and Ruvuma regions, namely 432 cartons of printing ink and 1,302 kgs of packing bags, he said, underlining that consumers are supposed to know that manufacturers of these goods produce them under trademarks, thus selling them as genuine goods.

He urged that consumers learn to use various ways to recognize such goods, in part by comparing the prices with those issued by the genuine owners of the trademarks. FCC, in collaboration with other authorities,

# Transporters seek cut in gas use conversion costs

TRANSPORT stakeholders have urged the government to reduce the conversion price for public use vehicles to gas as it is too expensive at the moment.

Sabri Mabrouk, the chairman of the Dar es Salaam Commuter Bus Owners Association (DACOBOA), made this appeal in an interview, in reaction to the review of fuel prices for August, projecting a series of losses for bus operators using the new prices and charging the same fares.

He said the current rise in fuel prices could be cushioned by massive use of gas vehicles which can be taken up more rapidly if its conversion costs are lowered, as the shift will prevent the need to review fares for commuter and upcountry buses in view of the rising fuel prices.

The regulatory authorities referred to the shortage of key foreign currency in oil importation for the price markup, which he said was unfortunate that the commuter bus transport business "is engulfed by the dollar economy."

A bus earlier sold at 50m/- now sells at 60m/- with appreciation of the dollar against other currencies worldwide, which has a further impact as all spare parts for buses are imported using the US currency, he said.

Commuter bus operators are the first victims of the new fuel prices, as daily collections will decrease with more money being spent on fuel, he said, underlining that converting one commuter bus to gas costs 4m/- at

#### present.

The money cannot be recovered by current fares and raising fuel prices makes the situation worse, he stated, underlining that a review of bus fares will be necessary with the fuel price trend.

Petrol imported through Mtwara port will now be sold at 3, 271/- a litre, up from Sh2, 809/- a litre in July, while diesel remained stable at 3,008/- from 3,000/-earlier, and kerosene price declined to 2,714/- a litre from 2, 901/-.

Petrol imported through Tanga port will now be sold at 3, 245/- a litre up from 2, 724/- a litre in July, while diesel was in slight markup at 2, 981/- from 2,760/-earlier, similar to kerosene now being sold at 2, 740/- a litre from 2, 875/-. Taking urgent measures to cushion the impact of rising fuel prices is vital to save businesses from collapsing.

New cap prices for August released by the Energy and Water Utilities Regulatory Authority (EWURA) indicated a 17percent average increase in fuel prices, explaining that the situation is linked with the scarcity of the US currency.

Joseph Priscus, the secretary general of the Tanzania Bus Owners Association (TABOA), said the increase will negatively affect their business since fuel accounts for upwards of 75 percent of daily operational costs.

Petrol imported through the port of Dar es Salaam will be sold at 3,199/- per litre compared to 2,736/- per litre last month, with petrol showing a significant rise in price while diesel, the main commuter bus fuel, remained stable.

fuel subsidy set mid last year at 100bn/- per import consignment depending on needs, to cushion the public from the price spiral arising from higher fuel prices.

Diesel rose from 2, 544/- a litre in July to 2, 935/- a litre while kerosene was in slight decrease from 2, 829/to 2, 668/- a litre.

Dr James Mwainyekule, the EWURA director general, said the changes in prices of petroleum products this month are mainly due to challenges in the availability of the US dollar, as well as higher fuel levy, prices of petroleum products in the world market and premiums in importing petroleum products.

SadockTuya, the Yaate Investment Co. Ltd logistics manager, said the scarcity of the dollar has led to decrease in transportation costs which is affecting their businesses.

The firm was getting \$5,000 for transporting goods from Dar es Salaam to Kasumbalesa at the border with Zambia and the Democratic Republic of Congo (DRC), but that will now translate to \$4,400 on the same fuel used, making the transport operation unprofitable.

The payment mode for transport business is being affected as bargaining is done in US dollar premise and payment is conducted in the local currency as dollar supply has narrowed, he added.

# CCM Women's wing called upon to push for Marriage Act amendment

THE ruling CCM's Women's wing has been called to join the crusade to advocate for the amendment of the Marriage Act of 1971 to protect young girls from child marriage.

Women in Law and Development in Africa (WILDAF) board chairperson Monica Mhoja made the call in Dar es Salaam recently during her speech at a conference to mark the Pan African Women's Day.

She made an appeal for the government to finalise the amendment of the Marriage Act to protect girls whose rights are denied adding denying women's rights is denying the same to half of

faith as a very controversial issue age as the court had declared 18 when it comes to social issues, saying when it comes to marriage there are some mixed views with Christians believing in maturity amid contradiction from other religions.

He wondered how one could tell a girl child under 18 about marriage saying it affected them in all ways.

"Activists and the government should come with an awareness creation method to address marriage issues so that clerics can all move with the same perception. When it comes to age, there is a difference in understanding and faith," said the reverend.

Tanganyika Law Society (TLS) Harold president advocate Sungusia said the Marriage Act of 1971 was controversial in terms of years as the appropriate age yet it had not been amended.

"We must balance and we must not use God to embrace violence against other beings," cautioned the TLS president.

According to Sungusia, it was odd that the contract law and elections law deny a child under 18 to enter into a contract or to vote yet see another law allow a child below the age to enter into marriage and wondered which role was more critical.

"The Marriage Act is very important for the national and best interest of the society. If you want to destroy society, destroy the family. The government should not take lightly but rather speed up the amendment for the best interest of the country," said Sungusia

The Marriage Act of 1971 remains to be contradictory with other laws in the country in terms of age. The Constitution of the United Republic of Tanzania under its Article 5 provides the right to vote for a person of 18 years.

On the other hand, the Law of the Child Act 2009, under section 4(1) terms any person below 18 as a child.

Meanwhile, the Elections Act under section 342 provides the right to vote to a person from 18 years of age where section 292 forbids any person below that age from voting.

The Bill to amend the Marriage Act of 1971, according to the government, was slated for tabling anytime this year.

# Only four nations doing enough to stub out smoking, says WHO

#### GENEVA

ONLY four countries Brazil, Mauritius, the Netherlands and Turkey have adopted all the antitobacco measures recommended in the fight against the 'deadly scourge' of smoking, the World Health Organisation said Monday.

In a fresh report, the UN health agency urged countries to scale up their use of recognised measures to reduce tobacco use, including enforcing advertising bans, plastering health warnings on cigarette packages, raising tobacco taxes and providing assistance to those who want to quit.

It said Mauritius and the Netherlands had now joined Brazil and Turkey in implementing all of its recommended measures.

WHO said 5.6 billion people, or 71 per cent of the world's population, were now protected by at least one tobacco control measure -- five times more than in 2007.

The health agency said the global rate of the prevalence of smoking had dropped from 22.8 per cent in 2007 to 17.0 percent in 2021.

Without this decline, there would have been 300 million additional smokers now, the WHO said.

"Slowly but surely, more and more people are being protected from the harms of tobacco," WHO chief Tedros Adhanom Ghebreyesus said, adding that his organisation was eager to

support national efforts to "protect their people from this deadly scourge". Smoking remains the leading cause of preventable death, killing 8.7 million people each year, including 1.3 million who die from inhaling second-hand smoke.

According to the organisation, eight countries are one policy step away from joining the leaders in tobacco control: Ethiopia, Iran, Ireland, Jordan, Madagascar, Mexico, New Zealand and Spain.

However, 2.3 billion people in 44 countries remain unprotected by any WHO anti-tobacco measures.

And a full 53 states still do not have complete smoking bans in healthcare facilities -- something Ruediger Krech, the WHO's health promotion director, called "completely unacceptable."

The WHO report also decried far too little regulation of e-cigarettes.

Globally, 121 countries have adopted some measure addressing e-cigarettes. But 74 countries -- home to almost one third of the global population -- have no regulations in place addressing such products, meaning no bans on use in public places, no labelling requirements and no bans on advertising.

"Astonishingly, very few countries have measures in place to protect children," the report said, noting that 88 countries, covering 2.3 billion people, have no minimum age for buying e-cigarettes.



MORE than 4,000 children below five years of age from the Hadzabe community in Eshkesh Ward, Mbulu District, Manyara Region have received free vaccination against measles while those above five years of age received free treatment after contracting the disease.

"The children were suffering from the disease a few months ago but we have vaccinated more than 4,000 children against measles including treatment to others over 14 years of age," said Mahoza.

He said another reason for the Hadzabe community not receiving vaccination is their shifting culture looking for food that includes roots, fruits and honey, the practice that hindered the provision of health vaccination against measles and

He further said the vaccination department has a procedure of using prominent community leaders to look for the Hadzabe in forest years to be vaccinated.

For his part, Dr Florian Tinuga, manager of the national vaccination programme told reporters on June 7 this year said he had asked village officials to have details of Hadzabe people who move to other villages so as to follow them there for

other diseases, especially in regard to children under five years of age.

According to the UNICEF report issued in 2019, nearly 169 million children worldwide missed the first vaccination dose against measles between 2010 and 2017, equivalent to 21.1 children per year.

Fabian Sulle, Babati resident said the Hadzabe do not believe in modern medicines including vaccination because they entirely live in forest throughout most of their lives.



## Natural gas vehicles seen gaining traction in Africa

NATURAL gas-powered vehicles are becoming increasingly popular across Africa thanks to supportive policies, infrastructure development and heightened investor appeal.

Several African nations are taking advantage of their ample natural gas reserves to introduce gas-powered fourwheel vehicles to the roads.

Nigeria, with substantial natural gas reserves, has approved the widespread use of vehicles powered by compressed natural gas (CNG).

Vice-president Kashim Shettima disclosed after the National Economic Council meeting on 20 July that, "We will also pursue vigorously the mass deployment of CNGpowered vehicles and establishment of autogas conversion plants/kits in all States in the short-term."

The announcement came just weeks after a Nigerian automobile manufacturer, Innoson Vehicle Manufacturing, began commissioning vehicles to run on CNG including intra-city buses, heavy-duty trucks and passenger cars.

The developments point to both policylevel and private-sector commitments in Nigeria leveraging its more than 200 trillion cubic feet of natural gas base to cut carbon emissions and air pollution from the transport sector.

This is not exclusively happening in Nigeria, with the latest transportation sector trends showing a similar shift in major natural gas-producing countries in Africa.

Egypt leads the charge with its Clean Fuels Initiative, launched in 1995 to combat air pollution and which pointed to natural gas as a solution. Today Egypt boasts over 260,000 CNG-powered vehicles, with ongoing efforts to grow that number. The North African country added 61 refuelling stations between July 2022 and March 2023, with plans for up to 1,000.

Down south, Tanzania concluded talks with investors in a \$42 billion liquid natural gas (LNG) project in May and is keen to apply natural gas to the transport sector.

According to works and transport minister Makame Mbarawa, the government is considering a subsidy programme for CNG vehicles. In remarks featured in The Citizen, Mbarawa said this will "attract more people 

to convert their cars to CNG."

This is alongside an ongoing project valued at US\$65 million that seeks to power 8,000 cars and rapid transit buses and supply 30,000 households in Dar es Salaam with CNG for cooking, by 2025

The Tanzania Petroleum Development Corporation in March licensed 20 companies to build CNG stations. Nine of those are expected to be operational by 2025.

Beyond the major natural gas-producing regions, other net natural gas-importing countries are witnessing a buzz of activity that could see more CNG-powered vehicles converted for use.

In Kenya, private sector initiatives are capitalising on the new market niche. Proto Gas (popularly known as Pro Gas) is one such company that has been undertaking CNG conversions in Nairobi since 2020.

Elijah Karuri, the technical lead at the company's CNG conversions unit, talked up the competitive advantage of CNG-powered vehicles, due to lower maintenance costs and technical efficiencies over regular ICE (internal combustion engine) vehicles.



# Serious thought needed to beat livestock influxes

Philip Mpango has reminded key regional administrators of their responsibility to work together in controlling the influx of livestock in the Southern Highlands zone. It is an observation that has often been made at higher levels of policy making, on account of the fact that cattle migration are laden with conflicts as herders habitually let cattle feed on crops. It is hard to say that legislators from the main cattle drivers' groups have worked to check that habit.

The occasion was inaugurating Nanenane the international agricultural exhibition in Mbeya the VP similarly noted that the influx of livestock was putting pressure on wildlife. Interestingly, the call as to what to do was on the civilian side, to find means of regulating or administratively bending movement of livestock. The pressure on wildlife is less pronounced as any herd of cattle ramped up within a national park is confiscated; little happens if it is a farm.

Elephants being pushed to move from their natural habitats and thus destroying crops or trampling on people is less due to cattle migration. Herders may invade wildlife corridors but it is settled farmers who shift to farm there or build as its legal cadre is mixed, as 'game protected areas.' With population expansion, people seek new farmlands.

Halfway through the stately instruction on working together to sort out the recurring threat of large herds of migratory livestock, a problem surfaces. It is the clearly stated need for regional authorities to educate farmers on profitable livestock keeping so that numbers of animals match the land available. Education primarily means it is

President Dr optional, that they may alter what they do if the alternative being given is useful, to their liking.

One would thus pose the question of who has responsibility for educating not farmers but livestock keepers, but some conservationists, always sympathetic with natural livestock keeping, may opt for the term 'livestock farmers.' This way a structural conflict of crop destruction by migrant herders is dissolved into intermittent squabbling between two groups of 'farmers.' Regional officials need a law cadre to stop migrations, not a code of advisory ethics on land use.

The usual reference point about migratory livestock habits is land use plans, but this isn't public information, and as policy it is equally advisory. What is needed is a set of regulations, on what is known as trespassing, not awareness of what the district council says of this land patch, etc. Little of that is happening. The difficult part about the policy mood on migratory livestock keeping is that this habit is highly injurious to farmers and wish it is prohibited altogether. But the holders of public office are supposed

to work for all groups, not selecting whom to favour. Cattle herders need to have own lands and then dig ponds or make dams for watering holes, grass harvesting or farming, entrepreneurship.

Hundreds of dams are being built all over the country to farm irrespective of reliable rains, thus thousands of ponds need to be built for watering animals in stable territory. They would use the land to harvest grass by using sprinkle irrigation to have grass irrespective of rainfall levels. Migration of cattle can be ended if they are registered on specified lands and also empowered to graze.



The Sustainable Development Goals, which took over from the MDGs, also suggest how to grow good jobs. Goal 9 of the SDGs sets as an objective to "by 2030, significantly raise industry's share of employment and gross domestic product".

Industry is singled out because it is a high productivity sector capable of absorbing large numbers of moderately skilled workers. Between 1950 and 2006, about half of the catch-up by developing countries to advanced-economy levels of output per worker was explained by labour moving out of agriculture and into manufacturing, combined with rising productivity within industry. In Africa, manufacturing output per worker is six times that in agriculture.

The international community has a new set of development goals. They reflect Africa's aspirations much more closely than the Sustainable Development Goals (SDGs). In addition to a maintained focus on the eradication of poverty, their single most important contribution is to recognise that sustainable development, especially in Africa, means creating good jobs - jobs that pay living wages and offer a chance to develop new skills.

For more than 40 years Africa's industrial development has been disappointing. In 2013 the average share of manufacturing in GDP in sub-Saharan Africa was about 10 per cent - the same as in the 1970s. Africa's share of global manufacturing has fallen from about 3 per cent in 1970 to less than 2 per

'N Africa today, only one in five cent in 2013. Manufacturing output per person is about a third of the average for all developing countries and manufactured exports per person, a key measure of success in global markets, are about 10 per cent of the global average for low-income countries. Clearly, Africa needs more industry to create more good jobs.

> Most of the heavy lifting in terms of public action will need to be done by African governments. To industrialise successfully, Africa will need to revisit the policy orthodoxy and break new ground. The "investment climate reforms" of the World Bank, supported by some bilateral donors, have not and will not bring industry to Africa on their own. Industrialisation cannot succeed without the development "basics" that include infrastructure, skills and institutions. But these building blocks, while necessary, are not enough.

> Three closely related drivers of firm-level productivity - exports, agglomeration and firm capabilities have been largely responsible for East Asia's industrial success, and their absence also helps to explain Africa's lack of industrial dynamism. These three drivers of productivity and industrial location are fundamentally interrelated.

Progress in one area cannot succeed in the absence of progress in the others. In short, a strategy for industrial development is needed, and an active and committed government to implement it is indispensable. To compete in the global market for manufacturers, African governments need to develop new policies to promote industrial exports, build the capabilities of domestic firms and foster industrial clusters. These policy initiatives need to be coordinated and contemporaneous.

the key selling point hence the term 'premium comfort cabin' used by some airlines like Air France KLM. The customer needs to see the value in the extra money they are paying for the air ticket.

More importantly, airlines have to respond to the rising demand from business and leisure travelers for a unique, authentic and compelling flying experience.

## Namibia's ACC stands for anti-corruption cover-up

AMIBIA'S top corruption fighter Paulus Noa is either hopelessly incompetent or knows only too well he was placed in the post to defend politicians and bigwigs - or he's a dangerous cocktail of both.

We'll bet on Noa being a tool to sweep corruption under the carpet for the ruling elite rather than believe he is irredeemably incompetent.

There would be no logic in Swapo retaining the loyal party member as director general of the Anti-Corruption Commission (ACC) for 20 years if he was unable to do a "good job" for them?

Twice this month, Noa has once again shown why Swapo appointed him in 2006 despite the recruitment panel stating that he and his deputy Erna van der Merwe were not fit to lead the anti-corruption fight.

The ruling party has time and again used its majority in parliament to bulldoze Noa's appointment through despite not following procedures as happened

#### again in 2021.

Two weeks ago, Noa was quick to brush aside reports that higher education minister Itah Kandjii-Murangi crossed good governance boundaries and may have corruptly benefited by taking travel allowances from institutions she is supposed to oversee.

"Unless there is a hidden agenda between the minister and those accusing her, the ACC finds no reason why she should be vilified, persecuted and judged in [a] public kangaroo court," said Noa, despite stating that the investigations were ongoing.

This week, Noa went overboard and accused the Namcor board of overzealously gunning for the state oil company's MD, Immanuel Mulunga, who defied a board decision to pay US\$6,7 million (N\$100m in 2021) to Angolan state oil company Sonangol.

Noa went as far as defending Mulunga, saying the MD "found himself between the rock and a hard object" [sic] when he decided to make the unauthorised payment in order to "save" Namibia's "reputation and image" in doing business with Angola.

Noa seemed to focus the ACC investigation into Mulunga's decision to bypass the directors' authority on a narrow approach - that the MD did not act with criminal or malicious intent.

In his memo, Noa does not lay out how diligently he arrived at his conclusion despite determining that Mulunga was dishonest in using a board resolution purporting to give him powers to take any action in the Angola transaction.

By focusing on obvious criminal action, Noa ignored the ACC's broader mandate.

The ACC law states that acting "corruptly" means "contravention of or against the spirit of any law, provision, rule, procedure, process, system, policy, practice, directive, order or any other term or condition pertaining to - (a) any employment relationship; (b) any agreement; or (c) the performance of any function in whatever capacity".

By that definition, the spirit of the anti-corruption law and good governance may have been breached as Mulunga defied the board by paying funds without authorisation, not to mention potential recklessness.

Good governance rules dictate that boards of public entities should have a majority of independent non-executive directors. All three directors of Sungura Energy, which landed Mulunga in trouble, were not independent.

Noa has made a mockery of the ACC and has most of the time correctly been criticised for targeting "small fish" while often defending or outrightly exonerating political elites and their cronies as happened in the Fishrot scandal until he was put to shame by the preponderance of evidence.

The state ought to strengthen the anti-corruption fight by avoiding incompetent people and stooges.

To safeguard the independence and ward off abuse of the institution, a director general like Noa cannot be the alpha and omega of investigations and decisionmaking.

A board of independent and diverse commissioners will be key to moderate bias and the blatant inappropriate conduct of an ACC director general such as Noa being active in Swapo with the same people he is supposed to watch over.




## Case for not rushing the ongoing new curriculum writing process

DUCATION curriculum of a country and its economic ideology should be inseparable. The two go together as changes take place from time to time due to creation of new ideas and their subsequent practice, making some adjustments necessary to incorporate new ideas.

From history, we learn about independence, Arusha declaration, Structural Adjustment Programmes and reintroduction of multi-party system among others. This shows that history is very rich if we want to learn and hence be able to bring positive and meaningful changes to our society. The opportunity to bring those positive changes is the ongoing crafting of the new curriculum which has attracted attention of many.

Among the issues debated by experts and commentators is the question of which economic ideology our country follows. For, the 1960s, 70s and early 80s, it was clear that the country followed socialist economic ideology but since mid-80s, it has remained unclear but certainly a mixed economy.





curriculum. Sometimes when political leaders make some declarations public, not all citizens understand hence unnecessary grievances in some cases.

The new curriculum must be the result of analysis of ideologies and practices of the past and their consequences as well as lessons from the current economic trend so as to establish a new base from which economic expectations of the country can rest. We need to have a theoretical and philosophical foundation in our education for us to be comfortable in our socioeconomic undertakings.

From history, we can learn a lot that can guide us in crafting a new and better curriculum. First is the objective of socialism. After attaining independence, our leaders embarked on a tall order of creating a classless society.

The government was against all forms of what it regarded as exploitation. This was due to the conviction that colonialists created classes and exploited the locals. The idea was that it was wrong to declare independence while there was exploitation and classes in the society. This was phase one in the quest for development which is ongoing.

Second is looking at the results of socialism. The efforts to create a base for socialism in Tanzania took a form which some critics saw as war against capitalism. Unlike in a football match where a draw can be registered, the case is different in an economic war where it is easy to see the winner and the loser.

Despite much determination and struggle the country's strength in socialism could not go beyond mid-80s when we accepted the SAPs which was considered by some analysts as accepting capitalism. Privatization and its hitches is a story for another day. Third is understanding the implica-

tions of socialism policy on the current economic nature of our country and the world. We need to conduct an honest cost-benefit analysis if Ujamaa worked in our favour or against us. Yes, we are a united peaceful people but other indicators of or success or failure of socialism should be put clear to people or through their representatives who have been tasked to craft the new curriculum.

We should strive to create our own model as copying and pasting the what has not been tested and passed normally leads to failure in some considerations even by the pioneers of socialism in Africa themselves. Should we repeat the mistakes?

It is from mid-80 up to the present where our experts find difficult to see the objective of our education and hence prolonged debates. The hesitancy in declaring the economic ideology of our country is probably due to different understanding among sections of our society the fact that a new curriculum gives us an opportunity to correct where we erred.

Analysis of the objective of socialism and its results should aid in creating a theoretical and philosophical base from which our economic decisions should root. After understanding the cause and effect of socialism policy in our country and its implications from the current global economic arrangements, our policy-makers can come up with a curriculum which provides answers to the problems that we face as a nation.

A quick economic stride starts with education. Let us take enough time to come up with a good curriculum. Importantly, we should not write and approve a new curriculum as a matter of emergency. We better be late but arrive safely.

AST week, I wrote a piece to mark a decade since the death of the legendary figure of Nelson Mandela. Towards the end, I quoted Amb. Ami Mpungwe on what Julius Nyerere had advised Mandela about his relationship with fellow Africans and what to do if there is an African crisis.

I ask myself one question: what would Nyerere have done if the crisis was on Tanzanian soil - as was the case in Zanzibar in 1995 - and South Africa felt the urge to 'take leadership?'

In today's article, I'll share a few lead-

descended in the big hall; it was one of the few occasions that Mandela interrupted someone while speaking.

"Mandela waited for Mugabe to be seated and then launched into an off-the-cuff speech of about twenty minutes about being disrespectful and wasting other people's time,

The first is humility. I happened to witness an act of sheer humility from Mandela on the day of the signing ceremony of the Burundi Peace Accord in Arusha. This special moment had also in attendance the then-US president Bill Clinton. Mandela without doubt was most determined to mobilise as much international support for then fragile country.

On this, I remember it was shortly after taking on his new responsibility that a video conference was held between himself and Bill Clinton as well as the late US Secretary of State, Madeleine Albright, in Arusha and in the full glare of the Burundian representatives.

Now fast forward to the big day itself and I'll just add that it wasn't plain sailing as a few Burundian political groups were not ready to sign the accord for reasons that Mandela dismissed in his speech as self-serving.

Prior to the speeches though, when efforts were in hurried motion to tie everything together in the hall, a lone Mandela on the podium, stood up and walked down the few steps, making his way towards the front row where the Burundian representatives were seated. All of them that numbered approximately 20, stood up in unison.

It was all spontaneous and Mandela in turn made a reflexive left hand gesture to them to sit down. It prompted some amusement but evidently, Mandela was not enthralled by all the open deference on display for him. That was exceptional display of humility.

Another illustration of his humility is found in a lengthy speech delivered on the 6th of April 2000 at the London School of Economics and Political Science, entitled 'Africa and Its Position In the World Today', in which he says: "But I do want to point out that some of us have not really made the contribution which the world thinks we have. There are many men and women who have made a greater contribution, for exam-

ple, in the leadership of the African National Congress than myself. There were people in jail who were more inspiring to their colleagues than I was able to be."

It is equally useful to refer to the afterword of Mandela's authorised biography by Anthony Sampson, which quotes Madiba: "I would like to be remembered as part of a team, and I would like my contribution to be assessed as somebody who carried out decisions taken by that collective."

It is a tragedy indeed that in many parts of Africa, various people made great contributions to liberating their countries only for an individual to virtually eclipse them and be seen as a messiah.

Even in Tanzania, many of the individuals who worked with Nyerere pre-independence and even helped identify him as a leader are atmosphere grew tense as silence

hardly known to the public. Somebody should have done a better job of bringing to the fore these liberation heroes. Consequently, it is a tall order to ask Tanzanians today to identify political heroes. This situation paves the way easily for political charlatans.

Looking at another quality of Mandela that is even more pronounced and is so tied to humility, is how he could brook no nonsense for leaders failing to keep time. In September 1998, a SADC meeting of heads of state was held in Mauritius and of which according to a book by his former personal assistant, Zelda La Grange, Mandela put Zimbabwe's Robert Mugabe on the spot for lateness.

"President Mandela interrupted him and asked he stop his address. This was unusual for him and the

and that 'some heads of state' considered themselves more important and therefore thought it was acceptable to arrive late. He didn't mention Mugabe's name once, but we all knew. He subsequently used words that never left me: 'If you are late you show that you have no respect for another person's time and therefore no respect for other people because you consider yourself to be more important than others'."

Another example was within South Africa itself as captured by Anthony Sampson's book: "On occasion Mbeki arrived forty-five minutes late for a gala evening held in Mandela's honour, shortly after his retirement in 1999. Addressing the audience, Mandela talked of a former ANC president from the 1930s (Alfred Xuma) who used to say that he was 'the black prime minister' and needed to come late to meetings so that everyone could see him. Mbeki knew that was coming and looked up to the ceiling in his characteristic way of saying: here we go again. Mandela, aware that his public remarks were being recorded on the BBC television cameras, then gestured in the direction of Mbeki and said: 'I think that this president here has taken after that president of the ANC'."

It is instructive also reading from Ali Hassan Mwinyi's autobiography that even Nyerere exhibited impatience at President Mobutu Sese Seko at a continental leaders' gathering in June 1994 in Tunisia where he would stare at him and ask, "Wazabanga, don't you have a watch?"

On a final note, one matter that makes Mandela stand tall on the continent was his presidential succession. As it were, Madiba wasn't interested in becoming president. This was revealed by himself on CNN's Larry King show.

That aside, Sampson summed it up aptly when he wrote: "But he was totally committed to democracy, and was determined - unlike most African leaders - to appoint a democratically

# Nepal poised to start HPV vaccination to prevent cervical cancer

S Dipak Subedi was organizing a vaccination programme against the human papillomavirus (HPV) in the city of Bharatpur in Chitwan district of southern Nepal he was getting phone calls from neighbouring districts asking if he had extra doses available – people were willing to travel for hours to get their girls vaccinated against HPV, which causes cervical cancer, the deadliest form of cancer for women in Nepal.

Callers had heard about the campaign, which started in 2022, after the city posted the news on its Facebook page, says Subedi, senior public health officer and chief of the Bharatpur public health promotion section. Unfortunately he had no extra doses to meet the demand. "With such demand if the HPV vaccine was to be included in our regular vaccination programme we could get more than 90% coverage," he adds in an interview in his office in Bharatpur, a city of 370,000 people best known for its location near Chitwan National Park.

Most people approached for this article who were connected to the Bharatpur campaign, or to previous small-scale pilot projects in Nepal, noted similar high demand. In recent years the Nepal Government has pledged repeatedly to provide the HPV vaccine for national distribution but has yet to do so.

#### Awaiting GAVI response

Earlier this month a national campaign moved a step closer when the child health and immunization section of the health department submitted a request to the global vaccine alliance GAVI for 1.6 million doses. The response should be known by September; if positive, vaccination could start in 2024.

Asked what she has learned from the campaign, Rana savs she would do all phases through schools next time to ensure participation. "That would be a more appropriate way to follow up those girls... rather than at the health facilities."

The second learning is that raising awareness ahead of time is key, says Rana. "From my experience I can say that if we do an awareness programme ahead of time – tell them something about the vaccine, about HPV, and the effectiveness of the vaccine for preventing cancer, then they will be quite positive and participating."

Even if people are initially sceptical, "gradually when we explain to them that it's a very good vaccine, it's free of cost – although it's expensive if you have to buy it – and will prevent your daughter from getting cervical

done pilot projects. It's surprising to hear that vaccine hesitancy hasn't been a minor issue in the campaign. One school did refuse to participate, says Rana, after they were told that parents had to sign consent forms. "They were thinking 'it's like a new Covid vaccine and it's being tested via our girls'; they were not aware that the vaccine had been approved years before. I tried so hard to convince them but they would not come."

School nurse Sudeepa Poudel also faced some resistance, but says she overcame it after talking to doubting parents. "They say 'we were never vaccinated but we are fine till now – why do our kids need to be vaccinated'?... Some parents are easy to convince but many are not because they're illiterate, so I have to take time to explain carefully to them; sometimes it takes two sessions. After that explanation they easily accept it."

Poudel works at a secondary school in Bharatpur from where 25 girls were vaccinated earlier this year. Beforehand she spent one hour explaining the process to students. "I conducted classes for those students who were going to be vaccinated as well as those younger students (9-11) who might receive the vaccine in the future, explaining the purpose of the vaccine, where it comes from, how it's managed, possible side-effects, etc."

Just down the hall from Rana's office at the hospital is the room where the one recent morning girls

#### Three reasons for support

"We're doing this for three reasons," adds another: to prevent genital problems, or issues having children, and because getting cervical cancer would interfere with menstruation.'

The father of one of the girls says he learned about the vaccine from his daughter, via news reports and social media before being contacted by the school. "I talked to the school nurse... Yes, I'm positive - both my wife and I are positive - because there is news about this vaccine being very good. I don't know much about the technical part," he adds, "but I feel good doing this for my child."

HPV is spread through sexual contact, but Rana says that most Nepalis don't interpret that to mean their daughters should be vaccinated before they become sexually active, which might be one reason there is little resistance to campaigns. "Their understanding is that it's early marriage that would expose girls to HPV rather than premarital sex, because that was the experience of women who are now developing cervical cancer, who are around 40-45 years of

age," she says. "Sometimes people do ask explicitly about the impact of premarital sex, but they do not resist having their girls vaccinated when we explain," she adds.

#### 1st time under federal system

A trial phase is needed, adds Gautam, because the health system was reorganized after Nepal enacted federalism in 2017. "We haven't conducted such a campaign at the local area... so this is a new concept for us," he says. "The district recording and reporting system is also quite different now ... at the operational level we have to be sure that the system will work, so we'll be piloting first."

The same system will be used for the national programme, if GAVI approves the request. "We are hopeful that we'll get the vaccines," says Gautam. "What we do know is that whenever we operate a vaccine programme GAVI provides some vaccines to Nepal. We submitted our application - now the ball is in their court."

In response to a query, GAVI said that it does not comment on current applications.

The planned programme will include girls ages 10-14, in classes 6-10, rather than the 9-14 age group recommended by WHO. Gautam says this is to conserve limited resources. "Our national immunization advisory committee recommended 10-14 based on the country situation: if we go to 9-14 our operational costs will almost double."

15,000/- per kilo up from 14,000/-. He said Grade II will be sold at 13,500/instead of 13,000/- per kilo, Grade II at

Regarding the system of payment, the

transactions, even though cash will be paid for small quantities of cloves sold, less than one bag.

"The payment system has been adopted for the money's safety," he said, and added that due to the crop's importance to the people and Isles economy in general, the government calls on farmers to sell all their produce to the Zanzibar state Trading Corporation (ZSTC) after drying the cloves

on mats to get cloves of Grade I.

He also called on clove farmers to abide by the drying procedures, including its cleanliness before taking it to the buying centres as well having registered mobile phone numbers for payment, or bank account numbers in case of payment through banks.

"Farmers should avoid clove smuggling

and the government will take stern legal measures against whoever will be found to engage in smuggling of the crop," he said.

He also conveyed ZSTC thanks to all stakeholders in the cloves sector including clove farmers, Cloves Anti-Smuggling Unit, PBZ, Tigo/Zantel mobile phones operators and others involved in the clove buying activities.

# hold nation's founding leaders in high esteem

TANZANIANS have been called to hold in high esteem the nation's founder leaders, those who were at the forefront during Tanganyika's liberation struggles, by being patriotic and of moral ethics for the benefit of the current and future generations.

The remarks were made by Stephen yesterday Mwakangale, the first son of late John Mwakangale, founders of Tanganyika African National Union (TANU) that fought for the country's independence at John Mwakangale Memorial Pavilion at the ongoing 2023 Nanenane Agricultural Exhibition at John Mwakangale Exhibition Grounds in Mbeya.

"John Mwakangale and Mwalimu Nyerere were very close to each other. There was a time when Mwalimu Nyerere was studying in Scotland he met with my father who was also studying in UK, they agreed to come back to engage in the country's liberation struggles," Stephen said.

He added: "When we received our independence in 1961 my father (John Mwakangale) was a Member of Parliament, however in the following year, 1962 he appointed him Regional Commissioner for Mbeya, then called Southern Highlands Region that encompassed present Songwe, Njombe, Iringa, and Rukwa regions."

He added that the aim for displaying John Mwakangale memoirs at the exhibition is to show his history since liberation struggles days under TANU and CCM.

"The aim is to mobilise the community to understand all the good done by the founding leaders, by recognising their contributions before and after independence in regard to agriculture and the economy in general.

"My late father has also been recognised by prominent leaders. In his book 'Long Walk to Freedom', Nelson Mandela described John Mwakangale on how he received him in Mbeya in 1962 before the South African freedom fighter proceeded to Addis Ababa, Ethiopia at the Pan African Freedom Movement for East and Central Africa (PAFMECA) conference," said John Mwakangale.

He added that before independence, his late father was a government employee, a veterinary expert after which he left public service and engaged in politics, joining TANU in 1956 and became regional party secretary.

He said that through PAFMECA, he later participated in the liberation struggles in Southern Africa and from his contribution he became a Member of the Legislative Council (LEGCO) in 1957.

The 2023 Nanenane Agricultural Exhibition is being held in Mbeya at the national level at John Mwakangale exhibition grounds and was opened by the Vice President, Dr Philip Mpango on Tuesday this week.

# Top ten banks uptake 656bn/- combined net profit in H1

anzanian banking industry profitability is continuing to rise after top ten banks, in terms of total assets, reported a substantial combined net income after income tax amounting to 656bn/- during the first six months of this year ended in June, compared with 540bn/- earned during the first half of last year.

However, more than two-third of the combined profit, amounting to 441bn/- was recorded by two largest banks in terms of total assets, including CRDB Bank Plc and NMB Bank Plc, which are both listed at the Dar es Salaam Stock Exchange (DSE).


Speaking on reasons that spurred banking profitability, Tanzania Bankers Association (TBA) chairman Theobald Sabi told the Guardian yesterday that in the outgoing financial year, the government continued to implement various policy reforms as part of implementing the Blueprint for regulatory reforms to improve the business environment.

"There is an increasing investors' confidence on the business environment - the same has translated into growth of business and profitability of the banking sector," he said.

"The notable investors' confidence has been largely driven by the current drive by President Samia Suluhu Hassan on ensuring better business and investment environment for the private sector."

The TBA chairman further said the economic recovery from COVID 19 has continued to influence more investment, less non-performing loans and increased demand for financial services

products to consumers has also contributed to increased demand for banking services," he said.

"Conducive and sound macro-economic and trade policies implemented by the Government by specifically ensuring supportive fiscal and monetary policies for the economy."

He went on saying that the positive performance experienced by the banking industry in the first half of the year 2023, has translated into the significant socioeconomic impact and contribution to the country.


The areas of contribution made by the banking industry are but not limited to the participation in national economic empowerment initiatives through formalization and capacity building initiatives particularly for women and youths.

Giving examples, he mentioned those products as the Stanbic Biashara Incubator, provision of women centric products such as the Johari Product by NBC, Malikia proposition by CRDB, NMB on the other hand has Fanikiwa Account, TCB has Tabasamu Account and Equity bank has Mafanikio Account.

According to him, number of banks in Tanzania have established not- for- profit Corporate Social Investment initiatives (foundations) focused on serving the social economic challenges.

He also said SMEs development is also supported by commercial banks through Business development Services (advisory on starting business, investment, risk management, performance and growth)

The banking industry also continues to

support the country long term economic agenda by financing major public infrastructure project for example - the US\$1.6 billion Loan facility to the Standard Gauge Railway made by Standard Chartered Bank (SCB), he said.

He added that banks have also participated in building social infrastructures in the education and health sector through their Corporate Social Responsibility programmes.

The quarterly financial statements for the second quarter of this year show the highest profitability recorded by NMB Bank Plc, after earning a net profit of 262bn/- during the first six months of this year, compared to 207bn/- earned during similar period of last year.

CRDB Group Plc, became second as its earnings amounted to 179.99bn/- compared to 174bn/- respectively.

According to the CRDB Group's unaudited financial statement for the second quarter of this year shows that the net profit of CRDB Bank, the main subsidiary of the group, grew to 179.28bn/- compared to 166.90bn/- respectively.

The statements shows NBC Bank, the oldest and third largest, earned a net profit of 42.5bn/- during the first half of this year, compared to 34.1bn/- recorded during the first six months of last year, while Exim Group profitability grew to 36.6bn/- compared to 31.2bn/- respectively.

According to the statement, the DTB Bank profitability, slightly slowed to 5.6bn/compared with 6.7bn/- respectively due to decline of operating income and bad debts write off.

The DTB Bank's unaudited financial statement for the second quarter shows, both interest and non-interest income grew during the reported period, although there was also an increase of other operating expenses. The bank added one branch during the period to 29 from 28.

The statements show Stanbic Bank half year's net profit more than doubled to 39bn/- by the end of June, compared to 14bn/- recorded during similar period of last year, with the number of branches increased by one to 14 from 13.

Standard Chartered Bank, which recently announced the plan to sale its consumer, private and business banking to Access Group, saw its net profit declining to 40bn/- compared with 52bn/- respectively, while KCB Bank net profit jumping to 17.8bn/- in the first half of this year, from 10.7bn/- recorded during the first half of last year.

Absa Bank Tanzania net profit nearly doubled to 23.3bn/- compared with 12.5bn/-, while Equity Bank, one of the fastest growing, its net profit slightly went up to 10.9bn/- compared to 8.4bn/- respectively.

## Commercial bankers tighten lending terms as defaults increase

The Absa Bank Tanzania's profit after income tax nearly doubled to 23.37bn/- during the first six months of this year, compared to 12.53bn/recorded during a similar period of last year.

The achievements resulted from strong growths of interest and non-interest incomes, which pushed the operating income to 32.7bn/- compared to 17.9bn/- the same period last year.

The bank's acting chief financial officer Bernard Tesha told the Guardian that "the profitability growth was mainly contributed by the growth of the balance sheet and increased transaction volumes".

The statement shows the bank total assets expanded to 1.31trn/- during the second quarter of this year, compared with 1.26trn/- during the first quarter of this year ended in March.


The increase of total assets resulted from growth in cash, balance with Bank of Tanzania (BoT), investments in government debt instruments, as well as loans and advances to customers.

"We continued to support our clients and managed to extend credit facilities and issued loans in different key sectors and clients in different segments, including retail business, SMEs, and corporate, we recorded strong growth, as a result of expanded customer base as well as improved service and customer experience," he said.

"We managed to retain our relationship with existing customers while continuing to onboard new ones, as a result of improved confidence in our service."

On the side of corporate investment banking, Tesha said the sector focus remains to be the key for sustainable growth of their business.

According to the statement, loans, advances and overdrafts grew to 698.2bn/- during the second quarter, compared to 656bn/- in the



first quarter. The statement shows net interest income grew to 45.7bn/- during the first half of this year, compared to 35.6bn/- during the similar period of last year, while non-interest income expanded to 38.1bn/- compared to 29bn/- respectively.

Despite all the challenges seen in the market, Tesha said the bank managed to get alternative channels to grow revenues through offering various range of products especially in the global markets space.

He said besides rising interest income, the bank earned much on nonfunded incomes, which goes hand in hand with the growth of deposits.

Customer deposits grew to 969.7bn/- in the second quarter of this year, compared to 878.2bn/- recorded in the first quarter of this year.

"On the side of digital, we have strengthened our systems, to give confidence to our customers by simplifying services for easy transactions and at the end of the day, the transaction volumes grew and this enabled us to collect fees through our digital platforms for services we offer to our clients," he said.

"We are continuing to strengthen up to ensure that we grow our brand, as well as improve our services and align our objectives with those of our stakeholders."

The achievement has also increased the bank's income tax provision to the government amounting to 9.3bn/during the first half of this year, from 5.4bn/- paid during the six months of last year.

The bank also managed to create new jobs during the first half of this year, as the number of employees reached 501, compared with 465 recorded during the first six months of 2022 in its 15 branches across the country.

Total liabilities also increased to 1.1tm/- during the second quarter

from 1trn/- during the first quarter of this year mainly due to increase of customer deposits.

The bank capital reached 193.2bn/in Q2, 2023, higher than 179.9bn/- recorded during Q1, 2023 as a result of organic growth in profitability.

The rate of NPLs to total gross loans to 5.8 percent in Q2, compared to 6.4 percent in Q1.

Speaking on the outlook, Tesha said that he expects sustained growth of the bank's performance at the current position, with an ambition to grow better than what it is today.

"Our growth strategies are sustainable; we expect the market will continue to build confidence on us and our clients will continue to support our business," he said

He said the bank is expected to grow more and achieve better results than what has been seen during the first half, despite the prevailing challenges.

#### NAIROBI

Banks have been tipped to slow down new lending by tightening credit standards to deal with the heightened risk of defaults in a rising interest rate environment.

According to analysts, the tightening of terms will likely slow the momentum of private-sector credit growth.

"Over the same period (second quarter of 2023), commercial banks noted a surge in the industry's nonperforming loan ratio which clocked 14.9 percent as of May 2023. We expect lenders to tighten credit standards over the medium term," analysts at Genghis Capital said. In the opening quarter to

March 2023, banks retained credit standards for facilities in all 11 sectors, as surveyed by the Central Bank of Kenya (CBK).

"In the quarter ended March 31, 2023, seven factors had little impact on credit standards whereas Covid-19 and expectations regarding general economic activity led to tightening of credit standards, especially in building and construction sectors," the CBK said in its quarterly credit survey report to March.

Other factors shaping credit standards, according to the CBK, include banks' cost of funds, their capital positions, competition and other financial institutions such as saccos and micro-lenders, an increase of the Central Bank Rate and investment in government securities. The growth in private sector credit stood at 13.2 percent in both April and May 2023. A strong credit growth was observed in manufacturing, transport and communication, trade and consumer durables.

The number of loan applications and approvals remained strong, reflecting increased demand and resilient economic activities, according to the CBK.

The escalation of nonperforming loans has been noted in manufacturing, trade, real estate, transport and communication.

May's non-performing loans ratio mirrored the highest rate of loan defaults during the Covid-19 crisis.

However, the CBK maintains that the banking sector remains stable and resilient, with strong liquidity and capital adequacy ratios.

"Banks have continued to make adequate provisions for the NPLs," it said in an emailed statement.

In Ql'2023, the asset quality for listed banks deteriorated marginally, with the weighted average Gross Non-Performing Loan ratio (NPL) increasing by 0.1 per cent points to 12.6 per cent, from 12.5 per cent recorded in Ql'2022.

The ratio of bad debt at Kenya's lenders may climb by 100 to 200 basis points by the end of the third quarter amid delayed government payments and a challenging economic environment, according to EFG Hermes.

# TCB, Airtel set up digital group savings, credits platform

n a bid to spur financial inclusion, specifically women and youths, Tanzania Commercial Bank (TCB) and Airtel Tanzania have partnered to set up a digital community-based savings and credit platform.

The move will ensure that financial services are moving closer to customers, through the use of mobile phones.

Jema Msuya, TCB's director of technology and operations said according to 2023 Finscope survey, mobile money usage has increased up to 72 percent, the trend which has enhanced financial inclusions

Msuya said besides being flexible in loan issuance, the new agreement will also ensure that security and transparency for member funds are granted.

This will also ensure expansion of the rate of financial inclusion among many Tanzanians, considering that only 22 percent of the population is banked.

## Bank of England caught between inflation fight and recession risk

#### LONDON

The Bank of England, which looks set to raise interest rates again on Thursday, must weigh up the need to fight an inflation rate running at more than four times its target against the hit to the economy from 13 back-to-back rate hikes so far.

Analysts and investors are mostly expecting a quarter-point increase in Bank Rate, taking it to a 15-year high of 5.25%. They will also be watching for the signals the BoE sends about further increases in the coming months.

Governor Andrew Bailey and his colleagues say the economic impact of their run of rate hikes stretching back to late 2021 has yet to be felt fully. But they also say



they must quash an inflation rate that is the highest among major economies.

Below is a summary of key data that the BoE will be watching before its announcement on interest rates at 1100 GMT on Thursday which will be followed by a news conference given by Bailey and other top Group of Seven economies.

The most obvious impact of the increase in the BoE's Bank Rate from 0.1% in December 2021 to the current 5.0% has been in the housing market.

House prices as measured by mortgage lenders Nationwide and Halifax have fallen by their most in annual terms in more than a decade as interest rates on mortgages rise quickly on expectations of further increases to borrowing costs.

The BoE says much of the impact on the

housing market from its rate hikes has yet to be felt because most mortgages in Britain are short-term fixed-rate deals which protect homeowners from swings in borrowing costs but are renewing at higher rates.

Of nearly 7 million fixed-rate mortgages, which account for 80% of residential home loan deals, around 800,000 end in the second half of 2023 and a further 1.6 million deals end in 2024.

## Small US banks not ready to borrow from Fed in an emergency

#### **CALIFORNIA**

The lightning-fast collapse of Silicon Valley Bank this spring laid bare an inconvenient truth: Some US banks are not prepared to borrow from the Federal Reserve if they need to, and a Reuters analysis shows that problem is most acute among the nation's smallest banks.

SVB, a top-20 bank with over \$210 billion in assets at the time it failed, had an insufficient stash of collateral and in the year before it went down had not tested its access to the "dis-



some regularity, I don't know how you can assure yourself that it's going to be there if you need it.'

Among the biggest banks -- there are 33 currently with more than \$100 billion in assets -regular testing is not universal. Just over half tapped the discount window on a quarterly or yearly basis during the 11 years of data examined, generally in amounts of \$1 million or less that suggests they were tests. Others ran lessfrequent tests, and seven borrowed just once or not at all.

SVB went to the window just one time, borrowing \$200 million for a day in August 2018.

It's a vulnerability that has come into stark relief since SVB's failure unleashed record demand for emergency credit from the Fed, raising concerns at both headquarters in Washington and across the 12 Fed districts stretched across the country.

Fed Chair Jerome Powell last Wednesday acknowledged that the banking stress earlier this year revealed that using the discount window "can be a little bit clunky."

"So why not be in a situation where you're just much more ready in case vou...need to access this discount window?" he said in news conference after the central bank's policy meeting.

Indeed, the Fed and other bank regulators amplified that message on Friday with updated guidance saying "the agencies encourage depository institutions to incorporate the discount window as part of their contingency funding arrangements" and banks should maintain "operational readiness" to tap into it in a pinch.

While California-based SVB was unusual among its peers -- a majority of banks with \$100 billion or more in assets have run frequent tests of their discount-window access -- many smaller ones have not and may not be prepared to borrow at all, the data suggests.

"I was very, very surprised. I've been involved in monetary policy implementation for over two decades, and I was surprised by this most recent banking stress, the number of banks that are not fully set up for the discount window," Dallas Fed President Lorie Logan said in July.

Every bank in Texas and in the nation should establish access and "test the plumbing," she said.

#### MISSION CRITICAL

center-stage role in setting interest rates for the U.S. and beyond, its most critical mission is far more basic: Lend when no one else will.

Created in the early 20th century to bring a halt to the cycles of bank panics that had crippled the economy with alarming frequency since the birth of the republic, the Fed has a virtually boundless capacity to provide credit to banks in moments of crisis and thus ensure the wider stability of the financial system.

There's a catch, of course. Banks must be willing to ask for that lifeline in their hour of need, and they have to be set up to do so. While borrowing at the Fed may sound simple, it does require filing the paperwork, posting the collateral and, ideally, conducting regular test runs.

The Fed won't reveal which banks, or even how many, have done the work to gain access, a process that it has said can take weeks. But central bank data shows there are many banks which have not stepped up to the discount window, either to borrow money for real need, or to test it.

#### SIZE MATTERS

In general, the smaller the bank, the less likely it has dipped into the discount window.

From July 2010 to June 2021, nearly all banks with more than \$50 billion in assets, and about 70% of banks with \$1 billion or more in assets, borrowed at least once For all the focus the Fed draws for its from the discount window, either in small

amounts that suggest a test, or in larger amounts that point to actual need.

But only about 40% of the approximately 1,800 banks with between \$250 million and \$1 billion in assets in communities across the nation touched the discount window during that time, the data shows.

In Logan's district - Texas and parts of New Mexico and Louisiana - the figure for such small banks was about 20%

For the tiniest banks, those with less than \$250 million in assets, less than a fifth nationwide had tapped the window.

The data records details on more than 40,000 transactions, from thousands of \$1,000 test loans to the \$5 billion Goldman Sachs borrowed during the COVID-19 government-mandated shutdowns in 2020.

All told, about 3,800 banks borrowed from the discount window during the 11vear period detailed in the central bank data. That's just over 40% of the more than 9,000 depository institutions, including credit unions and branches of foreign banks, currently entitled to borrow from the Fed.

There are limits to what the data tells us. It doesn't include banks that filed the proper paperwork, and even posted collateral, but for whatever reason did not try out the discount window during that time frame.

And it doesn't capture any banks that have newly set up access or tested since 2021, and particularly since SVB's collapse in March focused fresh attention on the need for liquidity. The Fed publishes discount window transactions two years after the fact.

Even so, says Richmond Fed economist Huberto Ennis, based on the data "it seems safe to assume a meaningful proportion of banks still did not have ready access to the discount window, at least until recently."

Reuters reached out to the 10 biggest banks with no public record of borrowing from the discount window. Most of them indicate in public filings that they have pledged collateral at the Fed. Several told Reuters they had tested their access, without specifying a date. One said its test took place prior to 2010.

The National Credit Union Association requires members with \$250 million or more in assets to have discount window or other emergency liquidity access. Only 1,100 of its 4,700 members meet that threshold. But some 1,366 were signed up to use the discount window as of December, the NCUA said.

Banks are not subject to any such requirement, and the Fed declined to provide a count of those with access. But Fed Governor Michelle Bowman said in May that "a number" of banks had not registered.

VeraBank, a \$4.5 billion bank in Henderson, Texas, has done testing for years: each July it borrows \$100,000 from the Fed, and repays it the next day, the data shows.

"I think you should always have the access -- you just never know," CEO Brad Tidwell says. "If you are not testing it with

#### PRUDENT PLANNING

For much of its history, the Fed actively discouraged banks from discount-window borrowing, requiring them for example to exhaust other funding sources first, or, more recently, by charging above-market interest rates.

When the COVID-19 pandemic hit, the Fed reversed course. It slashed that so-called penalty rate, and joined with other bank regulators to encourage banks to borrow as part of broader efforts to stave off market and credit dislocation. The biggest banks also stepped up to borrow so as to reduce discount window stigma.

After the SVB collapse this past March set off a new round of market turmoil, the Fed expanded its emergency lending further, opening a new one-year lending facility that unlike the long-established window does not impose a "discount" on pledged collateral but instead lends at the security's full face-value.

And now it and other regulators are officially encouraging banks to sign up and test at the window, part of what Chicago Fed President Austan Goolsbee told Reuters is a "big push to try to get operational readiness, of everyone that we can.'

A recent "Ask the Fed" webinar for bank executives included detailed guidance on onboarding for its emergency-lending facilities, and offered assurances that establishing and testing access would be seen by supervisors as prudent planning rather than as a red flag signaling liquidity concerns.

Richmond Fed's Ennis says not all small banks actually need access. They may keep large stashes of cash on hand, or have a correspondent relationship with a bigger bank. Most banks are members of their local Federal Home Loan Bank, sometimes called the nation's lender of second-last resort, where they can call on liquidity in a pinch.

But his research suggests that banks with riskier, less-liquid books may find themselves in need of the discount window in times of financial market stress.

Minneapolis Fed President Neel Kashkari said small banks should think of the discount window as a backup.

"We point out, hey, there might come a time when the Home Loan Bank isn't able to meet your needs," he told Reuters in May. "It's an ongoing discussion. I mean, banks historically always think they're fine, until they are not."

#### Trump indicted by grand jury over efforts to overturn 2020 elections

#### WASHINGTON

President FORMER Donald Trump has been indicted on Wednesday (local time) for his efforts to overturn the 2020 US Presidential polls which resulted in the Jan. 6, 2021, attack on the Capitol, The Hill reported.



The indictment comes after Trump (pictured) stated that he received a target letter alerting him that he is the focus of the investigation, a move that is frequently followed by the filing of charges. Trump has been indicted as part of special counsel Jack Smith's investigation into the matter.

A federal grand jury in Washington, D.C., has notably been hearing evidence in the case when it typically meets Tuesdays and Thursdays, reported The Hill.

According to the docket of the United States District Court for the District of Columbia, Trump's case has been assigned to US District Judge Tanya Chutkan.

According to the court's website, she was appointed in 2014.

As part of special counsel Jack Smith's investigation, Trump was charged with: Conspiracy to defraud the United States; conspiracy to obstruct an official proceeding; obstruction of and attempt to obstruct an official proceeding; and conspiracy against rights, a CNN report said.

Trump will make his first court appearance in the case on Thursday in federal court in Washington, D.C, as per the Court filings.

Prior to the announcement of his indictment, Donald Trump had said that he is expected to be indicted "any time" today as part of special counsel Jack Smith's probe of his behaviour following the 2020 election.

"I hear that Deranged Jack Smith, in order to interfere with the Presidential Election of 2024, will be putting out yet another Fake Indictment of your favorite President, me, at 5:00 P.M.", Trump wrote on media platform Truth Social, according to The Hill.

"Why didn't they do this 2.5 years ago? Why did they wait so long? Because they wanted to put it right in the middle of my campaign. Prosecutorial Misconduct!" Trump added. ANI

## US condemns suicide attack in Pakistan in 'strongest terms'

#### WASHINGTON

THE United States condemn in the strongest terms the attack in northwestern Pakistan on Sunday during a political rally, States Department official spokesperson Matthew Miller said on Tuesday (local time).

He added that the Pakistani people have suffered greatly at the hands of terrorists through this deadly attack that killed 54 people and left nearly 200 wounded. "We condemn in the strongest terms the attack in northwestern Pakistan on Sunday during

a political rally. We are deeply saddened by the loss of life and injuries sustained from the explosion and share our heartfelt condolences with those affected by the attack. The Pakistani people have suffered greatly at the hands of terrorists," Miller said while addressing a regular States Department press briefing on Tuesday.

The Islamic State group on Monday claimed responsibility for the Bajaur suicide blast in Pakistan. The bombing targeted an election rally in Pakistan's border district of

Bajaur on Sunday in which 54 people lost lives, including 23 children.

"A suicide attacker from the Islamic State [ISIL] ... detonated his explosive jacket in the middle of a crowd" in the town of Khar, the armed group's news arm Amaq said in a statement, according to Al Jazeera.

A bomber detonated an explosives-packed vest near the platform as some 400 members of the Jamiat Ulema-e-Islam (JUI-F) party, a significant government coalition partner led by hardline politician Fazlur Rehman, await-

ed the start of the speeches.

The gathering was hosted near a market beneath a huge tent, but Rehman chose not to go. Rehman has previously escaped at least two explosions that occurred at political rallies in 2011 and 2014, Al Jazeera reported.

Police took testimony from some of the injured on Monday at a hospital in Khar, the biggest town in Bajaur. The provincial minister of information, Feroz Jamal, stated that police were "investigating this attack in all aspects." ANI

#### Young travelers make up majority of Chinese outbound tourists THE restart of outbound tour-

ism just ignited the passion of Chinese tourists. Nowadays, Chinese travelers are seen in almost every popular tourist destination across the world. Among them, young people make up the majority. What are their features? What are the most popular attractions with them and what do they usually do during their outbound trips?

According to a report recently issued by online tourism platform Mafengwo, people born in 1990s accounted for 57 percent of the first batch of outbound tourists from China after the country optimized COVID-19 response measures.

Backpackers who used to trav-

el alone now favor traveling in groups, and 77.7 percent of outbound tourists prefer trips with families, friends and partners, the report said.

About 57.4 percent of Chinese young outbound tourists stayed over a week at their destinations, and 24.6 percent extended the period to 15 days or above. Nearly half of this group's per capita consumption exceeded 10,000 yuan (\$1,444), who were potential consumers of higher-quality tourism

products and experiences. Countries in Southeast Asia remained the first stop of most young outbound travelers from China, with Thailand being one of the hottest destinations. The operation of the China-

Laos Railway further enriched the choices of young travelers in terms of transport. The hashtag "a railway trip to Laos" became a hot topic on Mafengwo, which made Laos' Luang Prabang, a station along the China-Laos Railway, one of the overseas destinations that saw the highest growth in search volume.

Young Chinese are crazy about seaside destinations, and islands no doubt became top destinations for many young travelers from China. Phuket, Pattaya, Sin-

gapore, Maldives and other destinations were extremely popular among them.

Li Mengran, media public relation manager of travel agency company UTour, told People's Daily that young tourists today prefer joining tour groups after arriving at their destinations. They usually make travel plans in advance and then purchase tour services at destinations, Li said.

According to online travel platform Fliggy, self-guided trips were chosen by over half of Chinese outbound tourists. The number of orders for one-day tour packages, which are more flexible, surged 15-fold year on year. One-day trips to Phuket and Similan Islands of Thailand as well as Malaysia's Kota Kinabalu and Kapalai were hot among Chinese tourists.

An executive from Tuniu, a Chinese online travel agency, told People's Daily that the agency has launched glacier hike, helicopter tour, and stargazing activities in the Mount Cook National Park of New Zealand, to cater to young tourists who love thrilling experiences.

According to the executive, hotels of these tour packages

are mostly located in the national park so that young tourists would get better experiences. The agency also launched novel tour services for young

tourists going to the United Arab Emirates, such as desert offroad adventures, visits to the Museum of the Future in Dubai and the Ferrari World Abu Dhabi.

Quality, experience and entertainment have become the major factors that affect young tourists' choices, and this is also true when it comes to outbound tourism. A long-term stay in Thailand's Chiang Mai, motorboat rides around Phuket Island or the Camino de Santiago in Europe, the outbound trips of Chinese young tourists are becoming more and more interest-driven.

Apart from exit & entry policies, visa policies, transport and hotel information, emerging entertainment programs and internet-famous attractions are also receiving high attention from young outbound tourists from China.

An employee with Mafengwo told People's Daily that timely, precise and complete information is just the basics of a good travel plan for many young people, what really attracts them is fresh, niche and individualized experience.

## **Expanded war games of Aussie, US militaries draw concerns**

#### SYDNEY

TOMOROW the curtain will come down on one of the biggest military exercises held in the southern hemisphere - Talisman Sabre.

Some 30,000 troops including observers from 13 countries took part in the "war games" which began on July 22. It served as a curtain raiser to the AUSMin (Australia-United States Ministers) talks between defense ministers Richard Marles of Australia and Lloyd Austin of the US, Australia's foreign minister Penny Wong, and US Secretary of State Anthony Blinken.

Very little has been made public from the AUSMin talks apart from a US commitment to defend military bases in northern Australia where the US plans to rotate long-range, nuclear-capable B-52 bombers and the proposal to jointly manufacture medium-range missiles in Australia.

But the talks underscore just how committed the Australian Labor government has become to the US military build-up in the region, which some analysts have warned against.

Talisman Sabre is part of

a bigger story, said La Trobe University, Melbourne, emeritus professor Joseph Camilleri OAM and fellow of the Academy of the Social Sciences in Australia.

"Joining Australia and the United States are South Korea, Japan, New Zealand, Canada, the UK, France and Germany. As US allies, they are all contributing, with varying degrees of enthusiasm to a multi-layered USled 'Indo-Pacific strategy' whose clear aim is to contain China and preserve US regional and global dominance," he told China Daily. "Talisman Sabre has a sobering message for the Asia-Pacific community. We are on a slippery slope which can only lead to the increasingly dangerous militarisation of the region.

"We need to steer the ship in a different direction. The Asia-Pacific community, its governments, and its peoples must call for both the

Pacific and Indian Oceans to be declared Zones of Peace, and for existing nuclear weapons-free zones to be strengthened and new ones to be established.

"Importantly, it is time for increasingly provocative displays of firepower to be replaced by innovative and sustained confidence-

Ukraine's military loses over 20,800 troops, 2,200 armaments over past month, says Shoigu

#### MOSCOW

THE Ukrainian military lost over 20,800 troops and more than 2,200 items of military hardware, including 10 Leopard tanks over the past month, Russian Defense Minister Sergey Shoigu (pictured) told a conference call with military commanders on Monday.

"Over the past month, the enemy's losses amounted to over 20,800 troops, to be exact, 20,824 personnel, and 2,227 items of various armament, including 10 Leopard tanks, 11 American Bradley infantry fighting vehicles, 40 US-made M777 artillery systems and 50 self-propelled artillery guns from Great Britain, the United States, Germany, France and Poland," the defense chief said.

The defense minister thanked the entire Russian military personnel participating in the special military operation in Ukraine for their service, courage and heroism.

"Earlier, we spoke about some instances of feats, whereas today we have tens and hundreds of worthy servicemen, soldiers, officers and sergeants who do not only perform their duty with honor but also do it highly professionally.

The fighters display truly highest examples of courage, heroism and, let me repeat it, professionalism," Shoigu pointed out.

As the Russian Defense Ministry reported, the Ukrainian army has been making unsuccessful offensive attempts since June 4.

Russian Defense Minister Shoigu reported on July 11 that the Ukrainian army's losses had exceeded 26,000 since Kiev launched its counter-offensive. Russian President Vladimir Putin stressed that Ukrainian troops had failed to achieve any success in any of the frontline areas. Agencies



## 4 Nigerians, rescued in Brazil, survived 14 days on ship rudder

#### **SAO PAULO**

ON their tenth day at sea, the four Nigerian stowaways crossing the Atlantic in a tiny space above the rudder of a cargo ship ran out of food and drink

They survived another four days, according to their account, by drinking the sea water crashing just meters below them, before being rescued by Brazilian federal police in the southeastern port of Vitoria.

Their remarkable, deathdefying journey across some

5,600 kilometers (3,500 miles) of ocean underlines the risks some migrants are prepared to take for a shot at a better life.

"It was a terrible experience for me," said 38-year-old Thankgod Opemipo Matthew Yeye, one of the four Nigerians, in an interview at a Sao Paulo church shelter. "On board it is not easy. I was shaking, so scared. But I'm here.'

Their relief at being rescued soon gave way to surprise.

The four men said they

had hoped to reach Europe and were shocked to learn they had in fact landed on the other side of the Atlantic, in Brazil. Two of the men have since been returned to Nige-

ria upon their request, while Yeye and Roman Ebimene Friday, a 35-year-old from Bayelsa state, have applied for asylum in Brazil.

"I pray the government of Brazil will have pity on me," said Friday, who had already attempted to flee Nigeria by ship once before but was arrested by authorities there. Both men said economic

hardship, political instability and crime had left them with little option but to abandon their native Nigeria. Africa's most populous country has longstanding issues of violence and poverty, and kidnappings are endemic.

## 'Hope to see President restored to leadership of country'

#### WASHINGTON

SPEAKING on the current situation in coup-hit Niger and the ouster of the President of the West African nation, Mohamed Bazoum, the United States on Tuesday (local time) said that he is a democratically elected leader and all of the work at present is to see him "restored".

During a regular State Department press briefing, spokesperson Matthew Miller said, "I don't want to go into hypotheticals because that is an outcome that we hope is not fulfilled. We hope to see the President restored to the leadership of the country. He's the democratically elected President, and all of our work right now is to see him restored."

He also underlined how the US aid to Niger is also at risk due to the military coup in the country and added by saying, "As Secretary Blinken has made clear, however, there are hundreds of millions of dollars in aid from the United States that are at stake.

I don't want to talk about what specifically we might do if President Bazoum is not restored to authority, but certainly our aid, our assistance is at stake. But again, I think it's premature to speculate what that might look like at this point."

Responding to a question on recent evacuations carried out by France and other European nations from Niger, Miller said that the US is monitoring the efforts.

"Our Embassy is open today, operating on a normal schedule. We're monitoring the efforts by France and other Europeans to evacuate their citizens. We urge Nigerien authorities to facilitate an orderly, safe evacuation.

At this time, we do not have indications of threats to US citizens or facilities, but we are continually re-evaluating our posture to ensure the safety of our citizens," he said.

"We're continuing to have conversations with other leaders in Niger. We've

spoken with the former President and continue to press for the security leaders who are attempting to seize power, to press for them to restore President Basoum to his rightful place as the democratically elected leader of the country. We will pursue that for as long as that possibility remains open," the State Department spokesperson added.

On being asked by one of the reporters during the presser if Russia is involved in any way in the coup in Niger, Miller said,

"We have not seen any evidence that Russia was behind this coup, but certainly it would not be out of character for Russia or for the Wagner group to try to take advantage of instability in this country or any other in Africa."

Recently over the weekend, pictures from Niger showed protesters waving Russian flags, chanting Putin's name.

French Foreign Ministry on Tuesday announced that it is preparing to evacuate its citizens and people of European nations who wish to leave Niger, days after President Mohamed Bazoum was overthrown by members of his presidential guard.

In a statement released on its website, French Foreign Ministry said, "Given the situation in Niamey, the violence that took place against our embassy the day before yesterday and the closure of airspace which leaves our compatriots without the possibility of leaving the country by their own means, France is preparing the evacuation of its nationals and of European nationals wishing to leave the country."

French Foreign Ministry's statement comes after the supporters of the coup in Niger on Sunday burned French flags and attacked the French embassy in Niger's capital, Niamey, Al Jazeera reported.

At least four European countries announced that plans to evacuate their citizens are underway in Niger.

### **USA look far from World Cup** favourites after limping into last 16

THE United States came into the Women's World Cup as favourites to win a third title in a row but they head into the last 16 looking anything but champions after limping through the group stage.

There were already doubts about Vlatko Andonovski's side after an unimpressive 3-0 win over Vietnam in their opening game was followed by a 1-1 draw with the Netherlands.

Andonovski and his players put a positive spin on those displays but there were very few redeeming features about their performance on Tuesday, when they held on for a 0-0 draw with World Cup debutants Portugal to scrape through to the knockout phase.

Ana Capeta's shot that hit the post in injury time very nearly won the game for Portugal, which would have condemned the holders to an unthinkable group-stage exit.

But aside from surviving that scare, the underlying numbers are concerning for the Americans.

They had less of the possession at Eden Park and failed to score for the first time in 15 World Cup games, since a 0-0 draw with Sweden in the 2015 group phase.

They also had less of the possession in their draw with the Dutch, while their finishing has been poor since the tournament started.

"I don't think that was a good performance all together, starting from the back," admitted Andonovski.

"I don't think we were able to solve the problems that the opponents presented. There were moments where we did and it looked good, but those moments were very few and not enough to be able to walk out of here with several goals.'

- Has the world caught up? -

The 46-year-old Andonovski is in the firing line.

It was always going to be a huge task for him to succeed Jill Ellis, who led the team to back-to-back World Cup triumphs in 2015 and 2019 before stepping down.

Andonovski brought a 23-player squad to New Zealand that featured 14 World Cup debutants, with injuries and retirement ruling out several veterans of recent successful campaigns.

There were high hopes placed in many of the novices, and the likes of Sophia Smith, Andi Sullivan and Trinity Rodman have impressed in moments.

But it is hard to escape the feeling that the rest of the world is catching up with the US fast.

The best women's club football these days is surely being played in Europe, where Barcelona have taken over from Lyon as the dominant force in the Champions League.

Yet captain Lindsey Horan, at Lyon, is the only member of the US team currently playing in Europe

# South Africa stun Italy to reach Women's World Cup last 16

OUTH Africa won a Women's World Cup match for the first time with a stunning 3-2 victory over Italy to reach the last 16 in a thriller yesterday.

Captain Thembi Kgatlana scored the winner in the 92nd minute to make history for South Africa and set up a meeting with the Netherlands -- sending Italy home.

Arianna Caruso scored twice for Italy and thought she had salvaged the draw they needed to go through with 16 minutes left, before Kgatlana's stunning late intervention.

The Italians were in tears at the end as their opponents celebrated a famous win.

"Over the last two weeks, I've lost three family members. I could have gone home but I chose to stay with my girls," said Kgatlana, who plays for Racing Louisville in the United States. "Because that's how

much it means." Coach Desiree Ellis, whose side were beaten 2-1 in the last minute in their opener against Sweden and then drew 2-2 with Argentina, added: "This is just amazing. I thought they were incredible. I said we were going to fight for every ball. We said we're not going to give up and they were absolutely magnificent.

Meanwhile, Sweden set up a Women's World Cup last-16 showdown with the United States after a Rebecka Blomqvist header and an Elin Rubensson penalty gave them a 2-0 win over Argentina on Wednesday.

Blomqvist headed home in the 66th minute on a cold and wet night in Hamilton and substitute Rubensson added a lastminute spot kick as Sweden made it three wins out of three to finish top of Group G.

The result also confirmed Argentina's elimination, as South Africa's 3-2 win over Italy took the African champions through in second place and handed them a last-16 tie against the Netherlands.

Sweden, who had already beaten the South Africans 2-1 with a last-minute winner and then hammered Italy 5-0, will play holders the USA in Melbourne on Sunday.

They were already through to the last 16 before this game, so Sweden coach Peter Gerhardsson decided to make nine changes to his line-up.

Key forwards Fridolina Rolfo and Stina Blackstenius were among the players rested, with the centre-back pairing of Magdalena Eriksson and Amanda Ilestedt the only starters from the Italy game to keep their places.

Argentina had to claim a first ever Women's World Cup win in 12 attempts to stand a chance of progressing but the world's 28th-ranked team lacked the quality to break down the Swedish defence.

Olivia Schough had Sweden's best chances in the first half, initially from a free kick that was saved and then with a header off target from a Sofia Jakobsson cross.

As wind and rain buffeted the crowd of almost 18,000 after half time, Sweden got the breakthrough midway through the second half.

Jakobsson, who plays in the USA for San Diego Wave, delivered an inviting ball in from the right and Blomqvist simply could not miss.

BARCELONA boss Xavi Hernandez confirmed on Tuesday that Ousmane Dembele is poised to leave the Spanish giants after receiving an offer from Paris Saint-Germain.

Dembele, 26, was left on the bench on Tuesday as Barcelona wrapped up their North American pre-season tour with a 1-0 win over AC Milan in Las Vegas.

Afterward, Xavi told Spanish television that French international Dembele -- who scored in last weekend's victory over Real Madrid in Dallas -- had been left out after informing Barcelona he wanted to leave.

The fourth edition of the Commonwealth Youth Games was held in Isle of Man from September 7-13 2011. A total of 811 athletes from 64 Commonwealth nations competed at the 2011 Commonwealth Youth Games.

Richards Bay was looking for a strong defender to come in immediately, as the club was short of numbers at the back following the departure of Ntsikelelo Nyauza at the end of last season.

Club head coach Kaitano Tembo spoke about the need for being defensively sound, given they will play against SuperSport United in their first game of the season at Lucas Moripe Stadium this coming weekend.

Hunt is known to play 'percentage football', relying on strong deliveries from set-plays, which need someone to repel them.

Banda, who has played for Baroka FC and Highlands Park respectively, will become the second defender signed by Richards Bay following the acquisition of Thabani Dube from Kaizer Chiefs.

Last season, Richards Bay made a wonderful start to what turned out to be their debut season and finished second in the DStv Premiership standings at the turn of the year.

The Commonwealth Youth Games are an invaluable springboard for the stars and leaders of tomorrow, contributing to the further development of youth sports throughout the Commonwealth.

The Games have traditionally taken place every four years with the first event being hosted in Edinburgh, Scotland in 2000.

Trinidad and Tobago were initially awarded the 2021 Commonwealth Youth Games in June 2019 but the Games were postponed due to the impact of the pandemic on the international sport calendar.

The Games will take place across Trinidad and Tobago, bringing a diverse perspective of the twin island country to the nations of the Commonwealth, as well as showcasing a festival of the country's activities.

The Commonwealth Youth Games (CYG) is an international multi-sport event organized by the Commonwealth Games Federation. The games were held in the years, mid-way be-

They continued to be held every four years, but in the year after the Commonwealth Games are held, from 2011 to 2015.

Since 2017, they have been held in the year before the Commonwealth Games are held. The first edition was held in Edinburgh, Scotland from 10-14 August 2000. The age limitation of the athletes is from 14 to 18.

The first edition of the Commonwealth Youth Games was held in Edinburgh, Scotland from August 10-14 2000. Fifteen countries contested 483 medals over three days of competition in eight sports.

A total of 773 athletes, 280 Technical Officials, and around 500 volunteers participated in the event. Eight sports were contested.

These included athletics, fencing, gymnastics, hockey, lawn tennis, squash, swimming, and weightlifting.

The second edition of the Commonwealth Youth Games was held in Bendigo, Australia from November 30 to December 4, 2004, 22 countries participated and contested in 10 sports events spread over three days.

The fifth edition of the Commonwealth Youth Games was held in Apia from 5 to 11 September 2015, the capital of Samoa. Samoa was the only bidder for the Games.

Around 807 athletes from 65 nations and territories participated in the nine sports: aquatics, archery, athletics, boxing, lawn bowls, rugby sevens, squash, tennis, and weightlifting.

The sixth edition of the Commonwealth Youth Games was held in Nassau, Bahamas. The games were held from 18 to 23 July 2017.

The sports contested at the Bahamas 2017 were athletics, swimming, beach soccer, boxing, cycling (road), judo, rugby sevens, tennis, and beach volleyball. It was the first time judo, beach soccer, and beach volleyball have been presented at a Commonwealth Youth Games.

The seventh edition of the Commonwealth Youth Games was scheduled to be held in Port of Spain, Trinidad and Tobago from August 1-7 2021. However, it was postponed due to the COVID-19 pandemic. It will now be held from August 4-11 2023.
