## 10.7bn/- justice access drive: EU, Belgian agency, LSF tie

THE Legal Services Facility (LSF) and Enabel, the Belgian development agency, yesterday signed a 10.7 bn/- grant agreement for Improved Access to Justice for Women through Legal Aid (IMPAWLA) project.

The collaborative project funded by the European Union (EU) comes under its flagship initiative, "Gender Transformative Action: Breaking the Glass Ceiling."

The project is intended to reduce inequalities in access to justice for women and girls by enhancing their access to quality legal aid services. It also targets strengthening the organizational capacity for LSF to enhance its mission.

Under the pact, LSF and Enabel will collaborate to build a comprehensive legal aid programme for women and marginalized groups. This programme will focus on improving the provision of quality legal aid for women, fostering legal empowerment, and promoting a conducive environment for access to justice.

It will leverage the LSF network of paralegals and legal aid providers, enhancing their capacity to deliver crucial services, where the primary focus of this initiative is directed at combating gender based violence.

### Minister attracts tourism investors at Berlin 24 Expo

INTERNATIONAL tour operators have expressed interest in investing world-class accommodation, transportation and tourism promotion in Tanzania.

Angellah Kairuki, the Natural Resources and Tourism minister, made this observation after a series of meetings tied up with the on-going ITB Berlin 2024 tourism and travel exposition.

The minister met with a notable German tour company, TUI Group, which operates more than 400 hotels around the world, along with 16 cruise ships, five air charter companies, working with more than 1,200 travel agencies.

So far the tour company is building a world class hotel in Zanzibar and by June this year inaugurate the hotel, while on the Mainland, the tour operator is setting up flights to bring more tourists to the various national parks.

She said in the meetings that major tourism operators will find room to invest in the country's hospitality industry, plus aviation initiatives to bring more tourists from around the world.

"We've asked them to promote Tanzanian tourist destinations in passenger planes and

### **Amani Nature Forest Reserve** finds niche in Yoga tourism

A NEW meditation-oriented type of tourism attracts visitors from all over the world to the Amani Nature Forest Reserve located in Muheza District, Tanga Region.

Gabriel Ponera, a tour guide at the reserve. told this paper in an interview recently that Yoga tourism is thriving in the largest forested block within the East Usambara Mountains, where a total of five dedicated spots have been cleared for mediation.

"People want to directly connect with nature while meditating and performing Yoga," he said, adding that this is the latest and most popular type of tourism emerging in Northern Tanzania.

"Yoga tourism in pristine natural surroundings is only practised here at Amani Nature Forest Reserve with other hotspots in Tanzania offering wildlife, heritage, beach and other types of tourism," he said.

The word Yoga is derived from the Sanskrit root 'Yuj', meaning 'to join' or 'to yoke' or 'to unite'. As per Yogic scriptures, the practice of Yoga leads to the union of individual consciousness with that of the universal consciousness, indicating a perfect harmony be-

### Amani Nature Forest Reserve finds niche in Yoga tourism

tween the mind and body, human and nature.

Tourists visiting Amani Nature Forest Reserve recently discovered the spiritual value of many of its natural hotspots that have now been dedicated to meditation.

Members of the Journalists' Environment Association of Tanzania (JET) on a study trip organized under the USAID Tuhifadhi Maliasili activity came across this new type of tourism said to be beneficial to both the environment and economic development of surrounding communities.

Alphonce Nyululu, senior conservator who is acting conservator in-charge at Amani Nature Forest Reserve, said that the forest is home to most of the species of African violet Saint-Paulia, named after Baron Walter von Saint Paulia Illaire who was German administrator of Tanga Province in the 1890s.

Yogis consider violet Saint-Paulia as a plant of spiritual significance with supernatural powers to heal and grant wishes to anybody who

supplicates to the pink flowery shrub, endemic to the eastern Usambara Mountains.

"The Amani Botanical Garden, established in 1902, is one of the oldest botanical gardens in Africa, covering 340 hectares and containing more than 1,000 species of plants taken from all over the world," said Nyululu, adding that the legendary garden is used for conservation, education and research.

Aloyce Mkongewa, assistant researcher in the precinct who also serves as tour guide, said that other tourists love to swim or take natural showers at several waterfalls dotting the forest, an activity also believed to have some spiritual values by enthusiasts.

The natural forest cover is internationally recognized for the high number of endemism, with species found nowhere else in the world. More than a quarter of the 30 species of amphibian and reptiles in East Usambara are found nowhere else in the world. Among plants, the sub montane forests are especially rich in endemic species.

A US court has absolved five major technology companies accused of aiding the use of child labour in cobalt mines in the Democratic Republic of Congo.

The case filed by former child miners and their representatives, Google parent company Alphabet, Apple, Dell Technologies, Microsoft and Tesla stood accused of facilitating child labour in their supply chains for cobalt.

### 'Four contentious Union issues remain unresolved'

THE government has resolved 21 contentious union issues out of the 25 that were raised, with four remaining pending, it has been said.

Dr Selemani Jafo, Minister of State in the Vice-President's office (Union and Environment) said this here yesterday when speaking at a meeting which involved officials from Tanzania Mainland and Zanzibar to discuss union issues.

He said that the leaders of both sides sat together to discuss the remaining four matters of the union and looked at how to resolve them.

According to the minister, the remaining four issues being worked upon are distribution of revenue from the Zanzibar shares in the East African Currency Board and the Bank of Tanzania profit, recommendations of the Ioint Finance Commission, motor vehicles registration and importation of sugar produced in Zanzibar into the Mainland market.

He said the process of resolving the challenges started in 2000 whereby until 2010 two challenges were resolved. Also, in 2020 five snags of the union were resolved.

Iafo commended President Samia Suluhu Hassan and Zanzibar President Dr Hussein Ali Mwinyi for the efforts made in addressing these challenges.

Hamza Hassan Juma, Zanzibar Minister of State in the Second Vice President Office, said the aim of the meeting was to discuss challenges hindering performance of government activities.

Juma said that during the tenure of former President Jakava Kikwete, he urged public leaders from the two sides to sit together and address the challenges.

"But I wonder why these issues remain unresolved despite the fact that we've started discussing them for more than two decades," he queried.

THE Gaming Board of Tanzania (GBT) is set to reintroduce national lottery that was dissolved in 2003 by the end of this

Daniel Olesumayan, GBT Director of Corporate Services told journalists in Dar es Salaam yesterday that the board was finalising the process of reintroducing the lottery, adding that private players will compete to run lottery that will cover the whole country.

"Before the lottery was dissolved, the government used to run it solely. But with the new arrangement the gaming board will be the regulators to oversee the competent investor who wins a fairly floated tender," he said.

National lottery to return with participation of private sector

According to him, with the antici- sub-categories namely casinos, slot machines, pated national lottery, bidding investors must meet the lowest investment capital amounting \$20 billion (51trn/-).

He said that in Tanzania, there are two categories of lotteries namely commercial and non-commercial. He pointed out that the commercial lottery is divided into five

sports betting, SMS lotteries and forty machine sites.

There are three sub-categories of non-commercial lotteries namely promotional lotteries public lotteries fete and pool table.

"Tanzanians who wish to establish a lottery business need a minimum investment capital of \$300,000 while foreign direct investors need a minimum of \$500, 000," he said.

He said that between July and December 2023, the first half of the current financial year, the board collected 108bn/- in gross revenues.

The board expects to have a total gross revenue collection amounting to 200bn/- by June this year.

Speaking of the board's success recorded so far, GBT Director General James Mbalwe said that tax revenues from the gaming industry had increased to 170.4bn/- in the 2022/23 financial year up from 33.6bn/- in 2016/17.

"The gaming industry has so far created 25,000 direct and indirect employment opportunities. GBT has so far licensed 91 companies in the gaming sector," he said.

He explained that between 2018 and 2022,

the board confiscated unlicensed slot machines amounting 1,846 countrywide. He clarified that if the slot machines were not confiscated, the government would have lost 2.44bn/- on yearly basis.

According to him, Tanzania leads other East African countries in responsible gaming. The board looks forward to establishing zonal offices too, he said.

The board is currently working on capacity building for its staff to enhance regulation of online betting where the many children under

### Introduction

USAID Heshimu Bahari (Respect the Ocean) project has awarded WWF a grant to address Blast fishing issues in the southern coast of Tanzania mainland. Blast fishing is a highly destructive, illegal method of catching fish that uses explosives to send shock waves through the water, stunning or killing fish which are then collected and sold. Blast fishing can be lucrative: both from the sale of the fish caught and also from the trade of illegal explosives. Improvised explosive devices may explode prematurely and have been known to injure or kill the person using them, or innocent bystanders. Government enforcement resulted in a substantial drop in blast fishing during the period 2016-2018, and since mid-2018 blast fishing levels in Tanzania have been at their lowest for decades. Gathering data on the location, timing and number of explosions over time is essential to be able to understand exactly when and where blasting occurs

The overall goal is to reactivate, and update as needed, the TBMN mobile phone app and web-based data management platform to re-enable monitoring of blast fishing in the coastline of Tanzania.

Tanzania Health Promotion Support (THPS) is an indigenous non-governmental organization (NGO) established under the NGO Act No. 24 of 2002 in 2011. THPS works in partnership with the Government of Tanzania through Ministries of Health (MOH) in Mainland and Zanzibar; Ministry of Gender, Youth, Elderly and Special groups; Ministry of Community Development, Gender, Elderly and Children in Zanzibar (MOCDGEC); Regional Administration and Local Government (PORALG), and the Ministry of Home Affairs (MOHA) with a goal of ensuring accessible high-quality health care services to Tanzanians; through strengthening of health and community systems. Currently, THPS works to address the following public health burdens: HIV/AIDS; Tuberculosis; prevention of gender-based violence (GBV) and violence against children; reproductive, maternal, neonatal, child, and adolescent health (RMNHCAH) services; laboratory and health management information systems (HIMS), COVID-19 prevention, research and public health evaluations. THPS has evolved through a participatory approach, reflected in its second strategic plan (2021-2025). ## Firm launches agricultural knowledge centre in Iringa

FERTILISER manufacturer Yara Tanzania vesterdav launched a knowledge centre to raise farmers' productivity and contribute to sustainable agriculture in Iringa Region.

The centre launched in collaboration with Farm For the Future (FFF) and Seed Company Limited is hosted on a 350-hectare maize seed farm run by FFF at Ilula area in Kilolo District.

The idea is thereafter to have the officials responsible with respect to the various issues emerging from the "consultations" take appropriate in a positive manner and without delay.

One reason calls to administrators to provide prompt solutions to various challenges come to little or no effect is that some public officials commonly live by the grace of others within their ranks or higher up in the governance hierarchy.

Such public servants are not proactive in intervening to effectively handle someone else's wrongdoing as often it is visible who intervened, and the matter is taken as a personal affront - which is unhealthy.

Public officials usually prefer seeing issues resolved through bureaucratic or official mechanisms rather than through personalised intervention.

How far people given an opportunity to meet the president will be able to open up on challenges they commonly encounter is one thing, as institutional prerogatives will have to be respected.



### How can I stop overthinking everything?

S a clinical psychologist, I often have clients saying they are having trouble with thoughts "on a loop" in their head, which they find difficult to manage.

While rumination overthinking are often considered the same thing, they are slightly though different Rumination is having thoughts on repeat in our minds. This can lead to overthinking - which is analysing those thoughts without finding solutions or solving the problem.

It is like a vinyl record playing the same part of the song over and over. With a record, this is usually because of a scratch, while why we overthink is a little more complicated.

### We're on the lookout for threats

Our brains are hardwired to look for threats, to make a plan to address those threats and keep us safe. Those perceived threats may be based on long gone experiences, or may be the "what ifs" we imagine could happen in the future.

Our "what ifs" are usually negative outcomes. These are what we call "hot thoughts" in that they bring up a lot of emotion, particularly sadness, worry or anger, which means that we can easily get stuck on those thoughts and keep going over them.

However, because they are about things that have either already happened or might happen in the future but are not happening now, we cannot fix the problem, and so we keep going over the same thoughts.


### Who overthinks?

Most people find themselves in situations at one time or another when they overthink. Some people are more likely to ruminate. People who have had prior challenges or experienced trauma may have come to expect threats and look for them more than people who have not had adversities.

Deep thinkers, people who are prone to anxiety or low mood and those who are sensitive or feel emotions deeply are also more likely to ruminate and overthink.

Also, when we are stressed, our emotions tend to be stronger and last longer - and our thoughts can be less accurate, which means that we can get stuck on thoughts more than we would usually do.

Being run down or physically unwell can also mean that our thoughts are harder to tackle and manage.



We all overthink from time to time.

### Acknowledge your feelings

When thoughts go on repeat, it is helpful to use both emotion-focused and problem-focused strategies.

Being emotion-focused means figuring out how we feel about something and then addressing those feelings. For example, we might feel regret, anger or sadness about something that has happened, or worry about something that might happen.

Acknowledging those emotions, using self-care techniques and accessing social support to talk about and manage your feelings will be helpful.

The second part is being problemfocused. Looking at what you would do differently - if the thoughts are about something from your past and making a plan for dealing with future possibilities your thoughts are raising.

But it is difficult to plan for all eventualities, so this strategy has limited usefulness. What is more helpful is to make a plan for one or two of the more likely possibilities and accept that there may be things that happen which you haven't thought of.

### Think about why thoughts are showing up

Our feelings and experiences are information, so it is important to ask what this information is telling you and why these thoughts are showing up now.

For example, university has just

started again. Parents of high school leavers might be lying awake at night, which is when rumination and overthinking are common, worrying about their young persons.

Knowing how you would respond to some more likely possibilities, such as they will need money or they might be lonely or homesick, might be helpful.

But overthinking is also a sign of a new stage in both your lives and needing to accept less control over your child's choices and lives, while wanting the best for them. Recognising this means that you can also talk about those feelings with others.

### Let the thoughts go

A useful way to manage rumination or overthinking is "change, accept, and let go".

You need to challenge and change aspects of your thoughts where you can. For example, the chance that it is unlikely that your young person will run out of money and have no food and starve. Fact: Overthinking tends to lead your brain into coming up with catastrophic outcomes.

You could plan to check in with your children regularly about how they are coping financially and encourage them to access budgeting support from university services.

Your thoughts are just ideas. They are not necessarily true or accurate, but when we overthink and have them on repeat, they can start to feel true because they become

familiar. Coming up with a more realistic thought can help stop the loop of the unhelpful thought.

Accepting your emotions and finding ways to manage those good self-care, social support, communication with those close to you - will also be helpful. This will be much like accepting that life inevitably involves a lack of complete control over outcomes and possibilities which life may throw at us. What we do have control over are our reactions and behaviours.

Remember, you would have a 100 per cent success rate of getting through challenges up until this point. You might have wanted to do things differently - and, in fact, can plan to do that - but, nevertheless, you coped and got through.

So, the last part is letting go of the need to know exactly how things will turn out, and believing in your ability - and sometimes others' ability - to cope.

### What else can you do?

A stressed out and tired brain will be more likely to overthink, leading to more stress and creating a cycle that can affect your wellbeing.

So it is important to manage your stress levels by eating and sleeping well, moving your body, doing things you enjoy, seeing people you care about, and doing things that fuel your soul and spirit.

Distraction - with pleasurable activities and people who bring you joy - can also get your thoughts off repeat.

If you do find that overthinking is affecting your life, and your levels of anxiety are rising or your mood is dropping, it might be time to talk to someone and get some strategies to manage. This will be, for instance, when your sleep, appetite and enjoyment of life and people are being negatively affected.

When things become too difficult for you to manage on your own, or even with the help of those close to you, a therapist can provide tools that have been proven to be helpful.

When you find yourself overthinking, think about why you are having "hot thoughts", acknowledge your feelings and do some future-focused problem solving. But, also, you need to accept the fact that life can be unpredictable and therefore focus on having faith in your ability to

### Haiti is difficult test of African identity, governance capacities A T times events in grew tired of their armed forces

history appear to repeat themselves. But there also times when the original heroes have no successors and, even if they are aware of the dire necessity for action, they would be tied up elsewhere.

That appears to be the case for Haiti, which in March 1983 welcomed Pope John Paul II on a final stop of a whirlwind tour of eight Central American countries.

The call the pope gave is even more applicable today than it was then, for he said 'this place must change' - and it soon changed.

The current situation in that country is mind-boggling. And it concerns us as Africans, since Haiti was the first country among the few former Spanish and French colonies in the western

hemisphere to free themselves. There has always been some pride in talking of Haiti as the first Black slave rebellion that became successful and created a new country, but well over 200 years later it is in a horrendously sad state.

Haitian acting prime minister Ariel Henry has been in the Kenyan capital, Nairobi, pursuing a United Nations plan to dispatch a multinational police force to his country. The idea was to help put down the rule of drug trafficking gangs that have largely taken over the country. But while he was on the foreign "peace mission", presumed gangsters encircled the main prison in Port au Prince, the capital, and freed most inmates, including numerous violent traffickers.

At the start of the week they had surrounded the airport, with their leader demanding that the premier stay away. It isn't like a normal chaotic but narco-anarchy, largely unparalleled.

Some observers have been wondering why the army does not step in, but a check shows that Haitians following numerous coups and cases of infighting.

They went on to disband the military in 1995 at the time of President Jean-Bertrand Aristide.

Seeing the worsening situation, President Jovenel Moise in 2017 sought to restore military capability after a UN peacekeeping mission was terminated. He was assassinated in 2021 - and the chaos has deepened.

When Pope John Paul II flew there in 1983 what he said still rings true up to today, as he condemned what he described as excessive inequality and misery, hunger and fear suffered by many people in Haiti.

He said there was a legitimate desire in the media and in politics for free expression, demanding that all those with power and wealth 'understand their serious and urgent responsibility with respect to their brothers and sisters'. It is as if all this has been forgotten.

To be sure, most of South America has serious drug trafficking problems which in countries like Colombia or Mexico had often assumed the

parameters of civil war. In Haiti this has led to a generalised collapse of the state, for which there is little chance that outside forces may wish to intervene.

Neighbouring Surinam is solidly against the opening of refugee camps for fleeing, terrorised Haitians, and the United States just reminded its citizens that they need to ship out.

As in the Sudan right now, the people of Haiti will have no option but to gather in army camps, police stations or even schools for basic military training to fight the narco-terrorists taking over the country.

It is the result of generalised corruption when everyone looks aside as someone makes a buck the wrong way, until the entire civil order lies in



### Freedom of speech is silenced in Nicaragua

**MANAGUA** 

lmost six years after the outbreak of the April 2018 protests, there are no signs left in Nicaragua of the violence that reigned in those days. There is no graffiti on walls or banners with demands or opinions against the leftist regime that has ruled the country since

Nor are there newspapers or opinion programs or debates on radio and television, let alone press conferences or public rallies.

The city of Managua, the capital, is always bustling and active, with markets and shopping malls open at all hours; traffic is usually disorderly and police patrols roam the streets and avenues at all times.

At noon every day, on all radio and television stations, the tired, quiet voice of Vice President Rosario Murillo is heard giving the government's news, social achievements and propaganda messages such as phrases of love and praise to God.

The program, which has no specific name, is broadcast from Channel 4, the historical property of the Sandinista National Liberation Front (FSLN), the ruling party, to which the other state media are linked. The private media outlets controlled by the presidential family are also connected, together with dozens of radio stations and portals on social networks.

It first emerged in 2007 as "a message from comrade Rosario, from the Communication and Citizenship Council of the People's Presi-

"Here we are, on Valentine's Day, with love, friendship, and for us, love and peace, because it is with love and in peace that we can walk ahead, move forward, building the future of all, a fraternal future," she said on Feb. 13.

Murillo has been Nicaragua's vice president since she was appointed in 2016 by her husband, President Daniel Ortega, the veteran former guerrilla who has been in office since November 2006.

Murillo is also the regime's spokesperson and the only authorized voice, among the population of 6.7 million inhabitants of this Central American country, who can speak publicly and freely about anything. No one else can do so.

Freedom of expression in Nicaragua is one of the most repressed and abused rights, said journalist Abigail Hernández, director of the Galería News platform.

Her opinion, tellingly sent via an encrypted messaging application,



"The media and journalists are a good thermometer for measuring the quality of freedom of expression," Hernández told IPS.

"When we have less and less access to sources of information, when they limit us from reporting from the streets, when we can't take photos or videos freely, when we can't do our work inside the country, it reveals that there is no freedom of expression," she said.

She is part of a generation of 242 journalists who have had to go into exile since the 2018 protests, which began against Social Security reforms and ended in a bloodbath provoked by military and police forces, with more than 355 civilian deaths, according to the Inter-American Commission on Human Rights (IACHR).

Journalist Martha Irene Sánchez, director of the República 18 platform, holds similar views, also expressed from exile.

"The scenarios for exercising freedom of the press and freedom of expression in Nicaragua have not improved since 2018; on the contrary, we are encountering more and more hostility," she told IPS.

She is also a member of Independent Journalists and Communicators of Nicaragua (PCIN), a union organization that emerged after the protests and all of whose members went into exile.

"The Ortega and Murillo regime's repressive mechanisms have escalated to dramatic and unimaginable levels. A simple opinion issued on social networks or a criticism of the regime could land you in jail or exile," Sánchez said.

She cited the example of Victor Ticay, a local journalist in Nandaime, a municipality in the northwestern department of Granada, who went out one day to cover a procession during the Catholic Holy Week of 2023.

The event had not been authorized by the police, whose agents interrupted the religious ceremony and Ticay filmed the parishioners

is based on experience: three years' running away from the patrol cars through the streets of the town.

He was arrested, charged with treason and spreading false news and sentenced to eight years in prison.

Guillermo Medrano, director of the Foundation for Freedom of Expression and Democracy (FLED), explained to IPS that between 2020 and 2021, the Nicaraguan regime passed a series of laws criminalizing the practice of journalism and freedom of expression.

A study that FLED released in September 2023 in San José, Costa Rica, a country bordering Nicaragua and the center of the country's exile community, documented 1329 press freedom violations, mostly perpetrated by state agents in the 2018-2023 five-year period.

The actions were taken against 338 Nicaraguan journalists and 78 media outlets, between April 2018 and April 2023.

They included the police intervention of several media outlets such as 100% Noticias, Confidencial, Trinchera de la Noticia, Radio Darío and La Prensa, the last newspaper circulating in Nicaragua until August 2022.

According to Medrano, the Special Law on Cybercrime, passed in October 2020, provides for prison sentences for the use of information "which in normal democracies should be freely accessible to citizens and the public."

In theory, the main objective of this legislation is the prevention, investigation, prosecution and punishment of crimes committed by means of information and communication technologies to the detriment of natural or legal persons.

The press freedom advocate also pointed out that the Ortega-Murillo administration, which controls all state institutions and branches of power, as well as the security forces, established the Law for the Defense of the Rights of the People to Independence, Sovereignty and Self-Determination for Peace, effective since Dec. 22, 2020.

N the moments when she is not in the tent caring for the children, Zouahra looks out at the sea that forms the western border of her world. On this sunny day it is blue and when the sun sets, gold and red shades will colour the horizon.

It is the same sea that washes the beaches of Tel Aviv to the north, and ebbs and floods along all the coasts of the Mediterranean. And it is the sea from which, Zouahra says, a shell from an Israeli gunboat brought death to her hus-

"He was on his way to the seaside where there were cars and an aid convoy... It was crowded, and the military boats started firing at people. My husband was hit in the head," she says

That was on 9 February - but Zouahra, who now lives in a section of a camp housing widows and orphans, did not find out immediately.

The 26-year-old mother had just given birth to her fourth child.

At first, the young men who had been at the scene and knew the truth wanted to keep the news from Zouahra. Mahmoud was just late they said.

But she knew something was wrong. Her brother-in-law arrived crying and shouting that Mahmoud was dead. Desperate for the truth, she went to the hospital or, as she puts it, "to the end of the world" - a phrase loaded with foreboding - to find him.

Zouahra leans forward, lowers her head and sobs. Seeing her mother's distress, three-year-old Lana gently touches her arm. Then she softly pats the body of her baby brother Mohammed sleeping on her mum's lap. Zouahra starts to speak again. "His en-

tire body was connected to machines, and he felt freezing cold. I couldn't talk to him. I tried, but he wasn't responding.

"He was sleeping... He went to get food for his children and came back in a cof-

The family were scattered by war. They lived in Gaza City before the fighting and after it began they fled to the

refugee camp at Al-Nusseirat in the centre of the Gaza Strip. That was the end of Mahmoud's job working as a labourer for the Pioneer Food Company in Gaza.

From Al-Nusseirat, they were again uprooted; fleeing south to Rafah after the Israel Defense Forces told them it was a safe zone.

Zouahra lives with other widows in a section of the Al-Mawasi refugee camp set aside for unaccompanied women and children. Her neighbour Amina lost her husband and three children in an Israeli air strike on their home near Khan

Amina and her five-year-old son, Ibrahim - who is also disabled - were pulled alive from the rubble that buried the rest of the family.

Another widow, Amani Jasser Al-Khawr, 32, lost her husband, a policeman, and five of her children in an air strike in Central Gaza in October - and now lives in a shelter made of zinc panels.

The wind rattles the panels, just as it whips the plastic sheeting and cloth that covers Zouahra and her children.

They can see how she struggles. But although her shelter is flimsy and flies constantly settle on the children, the ground has been swept and the family's clothes flap on a washing line outside.

Zouahra shows photographs of her late husband - a handsome man, protective of his family.

"I don't know what to do without him. He was the one providing for me and my children. He never made me need anyone... No-one cares about us now,"

This life piles indignities on the widows. Zouahra needs nappies for the baby and for her disabled boy, Mustafa. She speaks of his constant anxiety.

"He sees something and I can't get it for him. He keeps crying and hitting himself on the ground, asking for it, but I can't provide it.

"Mustafa has many needs that I can't afford. He keeps peeing himself and asks for things that I can't give him. He asks for food, for juice, apples, and fruits, and I can't provide."

A few days ago, another family nearby managed, somehow, to find a chicken. Zouahra's children looked on. They were beside themselves with longing.

Then, three-year-old Lana began to cry. But there was nothing to be done. The other people were lucky, or maybe had some money, and their children could eat.

The widows of Al-Mawasi are waiting for a new camp for unaccompanied women and their children to be completed. There they hope for food, a place to shelter out of the wind - the same way they hope that the killing might stop so that no more will be taken from them.

## Fertiliser industry registering steady growth under the Samia leadership

THE Tanzania fertiliser industry has shown tremendous growth in the past three years of President Samia Suluhu Hassan leadership driven by government subsidy and increased demand of food

The country has seen the emergence of opportunities in the fertiliser market with the construction of new factories to manufacture inorganic nitrogenous and phosphatic fertilisers which have played an important role in increasing efficiency of agricultural output.

Like elsewhere in the world, in Tanzania fertilisers have been food for plants as they help farmers feed the country's growing population since plants require 17 essential nutrients in the soil to survive and grow.

Experts from the staterun Tanzania Fertiliser Regulatory Authority (TFRA) say the fertiliser industry in this East African nation of more than 62 million people presents market prospects and future growth opportunities taking into account the country's exploding population growth and the need for food security.

TFRA is the state-run institution created more than a decade ago to regulate the manufacturing, importation, marketing and use of quality fertilizer and fertilizer supplements in the country.

Louis Kasera, TFRA Acting Director of Domestic Manufacturing and Bulk Procurement, admits that the fertiliser sub sector has seen its remarkable growth under the push of the President Samia Sixth Phase Government in the last three years.

"The government has created an enabling environment for every key sector of the economy, including the fertiliser sector, to attract prospective local and foreign investors to grab the existing opportunities in the fertiliser industry," Kasera

Currently, Kasera says 90 per cent of the fertilizer consumed in the country is imported and less than 10 per cent is manufactured locally by 15 fertilizer and fertilizer supplements (FFS) manufacturers.

manufacturers range from large to micro-scale with the largest manufacturer being the Minjingu Mines and Fertilizers Company Limited in Manyara region, which manufactures about 80 per cent of all of the domestically-produced fertiliser and fertiliser supplements.

manufactures include ABM Equipment and Dodoma Cement which manufacture fertilizer supplements (lime dolomite and gypsum), Kahela Traders, Keen Feeders Company Limited, Sianga Agro Trade



The aim of the Sixth Phase Government in taking these bold measures, Bolle says, is to increase food production, strengthen food security and to ensure availability of raw materials for the local industries

Company, Mtali Agrotraders and Amka Feeder's which manufacture liquid

However, since the local manufacturing of fertilisers cannot meet the home demand, President Samia's government has been insisting investment in different types and scales of industries, including fertilizer industries, by creating an enabling environment for investors, Kasera says.

His view is supported by Elizabeth Bolle, a senior TFRA economist and acting bulk procurement manager, who says in showing the seriousness of reforming the agriculture sector, the government has increased the Agriculture Ministry budget from 294bn/in the 2021/2022 fiscal year to 971bn/- in the 2023/2024 financial year, equivalent to an increase of 230 per cent.

"The investment in financial sources is aimed at increasing the contribution of the agriculture sector to the national economy," she emphasizes.

President Samia's push for agricultural transformation lies with the fact that the technology being used to cultivate food and cash crops calls for a complex of inputs to achieve large yield increases as agriculture's capital needs rise with the need for fertiliser; pesticides, irrigation facilities; energy; marketing, storage and transportation infrastruc-

The widespread use of fertilizers has to date made more food accessible and available in every corner of Tanzania more than ever before. Yet the country's food security remains a top agenda, and with the population projected to reach 77.5 million by 2030, encouragement of innovation in agriculture and education about farming techniques are crucial for the future of nutrition.

President Samia's ambition is to create new lasting partnerships that will deliver more investment, jobs and growth to the economy.

She believes that Tanzania in the current economic global arrangement can restore robust growth

through trade changing the way business is done in the country. Bolle says under the on-going fertiliser subsidy programme in the 2023/2024 farming season, use of fertiliser had reached 490,858 tonnes by January 31 this year.


#### Q: How did you get in the banking industry?



### Q: As a Business Manager, how do vou inspire inclusion in your role and the entire organiza-



## Agribusinesses shun loans over high borrowing costs

OST of agribusinesses opted to secure funding from friends, families and their own savings to run businesses than commercial banks and financial institutions over the last three years, due to exorbitant costs of borrowing.

This was revealed by the 3rd edition of the 'African Agribusiness Outlook Report' which sheds light on the impact of the "Triple Crisis" - Covid-19 pandemic, climate change, and the Russia-Ukraine conflict - on small and medium-sized agribusinesses in Tanzania, Nigeria and Zambia.

The report, which is jointly produced by AGRA and IPSOS, surveyed 1,623 small and agribusinesses in the rice, maize and tomato value chains in Tanzania, Nigeria and Zambia, and the soybean, maize and tomato value chains in Zambia.

The study which examined the impact of various measures taken to support SMEs' performance during the triple crisis reveals that a substantial proportion of agribusinesses experienced severe declines in revenue during the period, with only some managing to recover.

The report therefore recommends the adoption of policies that encourage the development

of financial products specifically tailored to the agricultural sector and improving financial policies to enhance access to affordable

"While loan uptake grew over the past few years, only a minority of SMEs took out loans to cope with the crisis, citing perceived affordability as a barrier," says the

Currently, the highest loan uptake by businesses is Zambia (15 per cent) followed by Nigeria (12 percent) and Tanzania being in bottom with 10 percent.

Affordable credits was seen as a major strategy that agribusinesses used to survive, and it continues to be core to business operation with less than 15 percent taking on commercial credit finance over the last 3 years due to the cost of

"There has been progress made in improving access to finance through several blended facilities and capacity building of businesses to improve the bankability of agribusinesses, the report says.

"But agribusinesses opted not to access the finance due to its high cost unless there are incentives discounting the strategic minimum reserve requirements of commercial banks that are lending to the sector to drive higher uptake, an example from Tan-

The Bank of Tanzania (BoT) reports show that the growth of credits to agriculture sector jumped to 43.5 percent at the end of 2023, from the contraction of 5 percent recorded during the end of 2020.

However, during the end of 2019, the annual growth was as high as 91 percent.

In terms of share of credit, the central bank reports show it reached at 10.2 percent during the end of 2023, an increase from 8.7 percent during the end of 2020.

To compliment agricultural financing ecosystem in Tanzania, the Tanzania Agricultural Development Bank (TADB), specific lender, has also launched its Five-Year Mid - Term Strategic Plan (2023-2027) along with new financial products to improve agriculture lending.

Further, the AGRA report went on nize the incredible potential saying while supply, demand, and operational costs were significant challenges during the peak of the Covid -19 pandemic, businesses continue to grapple with soaring operational expenses in the wake of climate-related impacts and the ongoing conflict in Ukraine.

The report discloses that 58 percent of SMEs surveyed have experienced substantial revenue declines of 20 percent or more throughout the "triple crisis" period.

Furthermore, the report reveals some of the strategies employed by businesses to stay afloat during these challenging times including injecting additional capital, cost reduction measures, and streamlining their product lines.

Dr. Agnes Kalibata, President of AGRA, noted that Agribusinesses have exhibited remarkable adaptability, innovation, and determination, on the one hand, but continue to struggle amidst business disruptions through lockdowns, supply chain disruptions, productivity decreases and reduced consumer demand.

Dr. Kalibata remarked, "We are all aware of the challenges they are facing, however not much has been done to look at the cumulative impact of the triple crisis and the specifics of severity that the agribusinesses are grappling with. As we reflect on the impact of the triple crisis on Agribusinesses in Africa, we must also recogthese enterprises possess."

She noted that as drivers of farmer resilience, job creation, economic development, and poverty alleviation, African Agribusinesses hold the promise of fostering greater social inclusion and reducing inequality across the continent.

"There is an urgent need for measures to effectively address and alleviate the impacts of these crisis on the sector that serves as the primary employer, engaging over 70 percent of Africa's population in economic activities and contributing more than 30 percent to the continent's economies," Dr Kalibata emphasized.

# GBT urges amendment to protect coin quality

THE Gaming Board of Tanzania (GBT), underscores that if there exists a necessity to curb the utilization of 200/- coin denomination as tokens in gaming slot machines, then a compelling case for amending the Gaming Act 2003 emerges, given that the current legislation condones this practice.

The decision arrives amidst a wave of public concern regarding the coin's quality, with some advocating for protective measures such as banning its use in gaming machines, currently, gambling laws permit the insertion of coins as tokens in slot machines.

The matter has been subject to ongoing discussions with the central bank (BoT), since early 2022 in search of a lasting resolution, with GBT now taking a definitive stance.

GTB's director general James Mbalwe, acknowledged the issue to The Guardian on Monday, indicating potential amendments to the law as a means of addressing it.

Mbalwe disclosed that in January When questioned about the Bank of this year, the board convened with the Bank of Tanzania's (BoT) coins department, proposing either an enhancement in the quality of the 200/coin or an amendment to the law to disallow its use in gambling.

The integration of the coin into gambling slot machines has resulted in a dual impact, deteriorating the coin's quality and drawing opposition from certain consumers, leading to a shortage in market supply, as reported by BoT.

The reporter uncovered that according to Section 53 (4) (a) of the Gaming Act, 2003, gambling machine owners are granted the right to utilize coins in gambling activities. However, Section 73 (2) (a) outlines conditions and penalties for violations of this granted right.

"Coins have been a staple in gambling for the past decade. The demand for the 200/- denomination has steadily increased over the years, leading to a noticeable scarcity in circulation," remarked Mbalwe.

of Tanzania's stance on the matter, Ilulu Said, the manager of BoT's currency department, hesitated to provide a comment, stating, "The issue falls outside my jurisdiction. I am not authorized to speak on behalf of the central bank. I recommend directing your inquiry to the governor himself."

In response, Emmanuel Tutuba, the Governor of the Bank of Tanzania, acknowledged that gambling slot machines have been accelerating the deterioration of coins through friction, consequently contributing to a shortage in the market supply.

"We are currently deliberating on the matter, and when the time is right, we will make our stance known. We are vet to determine whether to amend the law or enhance the quality of the coins. This decision hinges on consultations with various stakeholders in the financial sector," stated Tutuba.

He highlighted that the shortage of coins has become a concern for consumers who rely on them for change.

Tutuba noted that since the notice was issued in December last year, individuals have been returning the coins they had hoarded at home.

"We, for example, received coins worth 400,000/- from one citizen who heeded our notice. Many people have been holding onto significant amounts of coins for various purposes, such as giving them to their children for school expenses and church offerings," Tutuba explained.

He emphasized that residents of Dar es Salaam, Mwanza, Arusha, and Dodoma regions have been at the forefront of returning coins at BoT branches.

However, during a meeting with business editors organized by the BoT on January 09 of this year, Said highlighted the detrimental impact of using the 200/- coin denomination in gambling, which has consistently led to scarcity in circulation.

Said pointed out that gambling machines are exacerbating the deterioration of coins, particularly the 200/- denomination, by damaging the tail and head images, resulting in rejection by some consumers and affecting its circulation in the market.

Said was of the view that the use of coins in gambling machines instead of tokens is quickening its dilapidation contrary to the central bank's recommended period of 30 years on market circulation.

He noted that coins used in gambling machines struggle to maintain their quality beyond five years.

"We have observed that gambling is primarily responsible for the short lifespan of coins in circulation, as the images on their tails and heads quickly fade away, leading to rejection by a majority of consumers." stated Said.

He further explained that a single gaming machine can accommodate up to 100,000 coins of 200/denomination at once.

Said proposed that moving forward, it would be beneficial for the business community in the gambling sector to transition to digital platforms that eliminate the need for physical coins.

In a recent interview, Mbalwe disclosed that gambling activities had generated estimated annual revenue of 170 billion/- as of October 2023. He highlighted the significant growth in gambling tax revenues, which increased from 2.8 billion/-in 2006/7 to 170.4 billion/- in 2022/23. Additionally, employment opportunities in the sector surged from 600 to 25,000 during the same period.

"Investments in the gambling sector by licensed companies rose to 91 last month, from nine companies in 2003. Furthermore, the variety of gambling games expanded from three to seven. The initial capital for local investor is \$300,000 while foreigners would need to have \$500,000," Mbalwe added.

BoT introduced the 200/- coin denomination into the market circulation in 1998. However, the 100/coin denomination was introduced in 1994, followed by the 50/- coin denomination in 1996.

### US dollar's strength to persist as markets eye cautious Fed

A strong US dollar will maintain the status quo in the near term, as markets brace for a risk the Federal Reserve's first interest rate cut gets delayed to the second half of this year, according to a Reuters poll of foreign exchange strategists.

Shrugging off a weakening trend late last year, the dollar has gained against nearly every currency tracked by traders and investors, and is up nearly 2.5 percent for the

Much of the greenback's recent strength is based on stronger-thanexpected U.S. economic performance and receding calls for early Fed rate cuts. The timing of the latter is likely to have a bigger say on the currency's moves in the near-

"Over the next three months, I think we're probably going to see the dollar hold in the ranges we've been seeing since the start of the year," said Shaun Osborne, chief currency strategist at Scotiabank.

"If we're in a situation where instead of the soft landing, it's a nolanding scenario, that potentially reduces rate cut opportunities for the Fed quite significantly over the balance of this year, in which case the dollar probably stays relatively strong."

Despite trader positioning data showing speculators increasing their net long dollar bets to the highest since last November, analysts in a Reuters March 1-6 poll were somewhat divided on how positioning will look over the next

After failing to make any headway against the greenback in 2023, the Aussie and Kiwi dollars were predicted to gain around 7.3 percent and 5.0 percent respectively, recouping their 2024 losses and trading higher against the U.S. dollar in coming months.

The Australian dollar and the New Zealand dollars - last trading around \$0.65 and \$0.61, respectively, on Wednesday - were forecast to rise to \$0.70 and \$0.64 by end-Feb.

### Tanzania's credit bureau sector faces challenges amid strides forward

ESPITE strides forward, Tanzania's credit bureau sector grapples with formidable challenges, chief among them the pervasive issue of limited credit information coverage, particularly in rural locales.

In addition, the high cost of credit reporting and the lack of awareness among consumers about the benefits of credit bureaus pose challenges to their widespread adoption.

In an exclusive interview with The Guardian, Dr. Mwanaidi Jumaa, an independent banking consultant, highlighted the persistent nature of such obstacle, noting its hindrance to the overarching goal of expanding credit access nationwide.

However, Dr. Mwanaidi acknowledged significant advancements in data infrastructure, technological innovation, and regulatory reforms.

Moreover, she underscored that challenges still persist in ensuring widespread access to credit and safeguarding consumer rights.

"By addressing these challenges and seizing opportunities for collaboration and innovation, Tanzania's credit bureau sector can continue to wield its pivotal role in fostering financial inclusion, fueling economic growth, and empowering individuals and businesses across the nation," she affirmed.

She emphasized the importance of partnerships between credit bureaus, financial institutions, and government agencies in bridging data coverage gaps and advancing financial literacy among consum-

Furthermore, she highlighted the potential of leveraging emerging technologies such as blockchain and artificial intelligence to bolster the efficiency and efficacy of credit bureau operations, thereby driving greater financial inclusion.

Dr. Adolph Joel, a banker, proposed several measures, including conducting financial literacy workshops and seminars in rural areas, as well as forging partnerships with Microfinance Institutions (MFIs) that possess a strong presence in these regions.



"Credit bureaus must prioritize strict adherence to regulatory guidelines and best practices to uphold trust and credibility within the financial ecosystem," he emphasized.

He added, "Furthermore, proactive engagement with regulatory authorities is essential to stay abreast of evolving regulations and standards. Implementing robust compliance frameworks is crucial to safeguard consumer rights and uphold data privacy."

Jumanne Mashauri, a local trader,

shared insights with this reporter, acknowledging the challenges faced.

However, he highlighted that the introduction of the system has unlocked opportunities for individuals and businesses to more fully engage in the formal economy and pursue their aspirations for a better

Expressing satisfaction with the system, Mashauri remarked, "Access to credit is being democratized, financial inclusion is being championed, and risk management and market efficiency are reaching new heights."

The trader highlighted how, prior to the introduction of the credit bureau system, lenders heavily relied on collateral and personal connections to assess loan applications. This often led to the exclusion of individuals and businesses lacking substantial assets or influential connections.

"However," he noted, "with the advent of credit bureaus, lenders now have access to comprehensive credit reports and scores. This enables them to evaluate creditworthiness based on historical borrowing behavior rather than solely relying on collateral."

He emphasized that this shift has democratized access to credit, empowering a broader spectrum of individuals and businesses to secure financing for various purposes, ranging from launching small enterprises to funding substantial investments across sectors.

"By furnishing lenders with accurate and dependable credit information," he explained, "credit bureaus play a crucial role in mitigating risks associated with lending to underserved populations, including low-income earners and rural residents."

"As a result," he emphasized, "financial institutions are now more inclined to extend credit to segments of society that were previously excluded. This broadens the accessibility of formal financial services and diminishes reliance on informal and often exploitative lending channels."

Mashauri asserted that this heightened access to credit not only empowers individuals and businesses to pursue their financial objectives but also fuels economic development and diminishes poverty by facilitating productive investments and entrepreneurship.

As of 2024, Tanzania is served by two primary credit bureaus, including Dun & Bradstreet Tanzania and Creditinfo Tanzania.

The duo gathers and manage credit information on individuals and businesses, equipping lenders with valuable insights to assess creditworthiness and make wellinformed lending decisions.

## **Investors in China** sticking to bargains as fiscal bazooka now proves elusive

### **SINGAPORE**

Foreign investors returning to China's recuperating stock markets say spending plans announced on Tuesday are not enough to turn battered sentiment around, and the main reason to keep buying shares for now is because they

Money managers hunting for bargains have been trickling back into mainland stocks since February, after China replaced its stock market regulator and tightened rules around speculation, leading to a sharp but fragile recovery in the market.

Few had held out hopes the National People's Congress (NPC), China's rubber-stamp parliament, would unleash a torrent of cash big enough to buoy markets and the mood right away.

But those expecting solid spending plans to reach a growth target of 5% were disappointed as authorities stuck to a familiar script about managing risks in the property sector and municipal debt and spurring "worry-free consumption".

China plans to run a budget deficit of 3 percent of economic output, down from a revised 3.8 percent last year, belying the fiscal shot-in-the-arm some had hoped for to fuel a recovery.

"Investors need to see policies that could improve governance and final demand, but neither seem to be on offer so far at the NPC," Ken Peng, head of investment strategy in Asia at Citi Global Wealth, said in an email to Reuters.

Mainland equities were steady on Tuesday, helped by signs of state-backed buying, and Hong Kong's Hang Seng fell 2.6 percent. The yuan held its ground.

Mainland China stockmarkets lost about \$2 trillion in market value in the year to Jan. 31, with foreign investors' net selling of 112 billion yuan (\$15.6 billion) over the period drawing down exposures of global money managers to the lowest levels for years.

They have since bought stocks worth 48.3 billion yuan and China's blue-chip CSI300 Index has bounced nearly 15 percent off the five-year lows it hit last

But where global investors were once happy to park slabs of their portfolios in China for the long term, many are running smaller and nimbler "tactical" books offering exposure to short-term bounces while holding back on larger strategic stakes.

"There is a degree of anticipation as to when all of these collective measures will start making a lot of sense and moving markets and moving asset prices," said Niraj Athavle, J.P. Morgan's head of sales and marketing in Singapore.



Investors, both foreign and domestic, are being selective buying stocks but only in sectors such as electric vehicles and technology, says Winnie Chiu, senior director and investment adviser at Indosuez Wealth Management.

Mainland markets are also cheap. The 12-month forward price-to-earnings ratio, a widely used valuation measure, is just around 10 for the CSI 300, half the levels for S&P 500 and Japan's Nikkei.

### CEOs reluctant to change business models despite economic challenges'

**NAIROBI** 

EAST African CEOs express confidence in their current business models' resilience to endure economic challenges and remain viable for the next decade, as per the PwC East African CEOs survey.

The CEOs indicated that their revenues increased by 19 per cent, along with an 18 per cent boost in profit margins.

They also said their return on assets or return on equity rose by a notable 14 per cent. Over half (53 per cent) of CEOs reported a significant market share increase of 5 per cent or more over the past three years.

When asked about prospects for growth in external markets, Kenya (26 per cent) and China (21 per cent) continue to top the list as the most favourable countries for CEOs' companies' revenue growth prospects over

the next 12 months.

They also identified neighbouring countries that are members of the East African Community (EAC) as territories for future revenue growth.

Intra-EAC trade reached US\$10 billion in September 2022, up from US\$7.1 billion in 2019. The regional bloc aims to increase intra-EAC trade from 20 per cent to 40 per cent over the next five years, which could unlock future revenue growth opportu-

According to Africa's Macroeconomic Performance and Outlook January 2024, growth in East Africa (2024: 5.1 per cent; 2025: 5.7 per cent) will be aided by deeper regional integration alongside strategic public spending to improve infrastructure investment, ongoing efforts to modernise agricultural production systems and boost productivity in the

Medium-term Challenges 45 per cent of respondents identified the regulatory environment as a significant obstacle, indicating the potential impact of compliance requirements on operational flexibility.

Limited financial resources also pose a constraint, with 35 per cent of CEOs citing financial constraints as inhibiting factors. Additionally, concerns were raised about the lack of skills within the company's workforce (29 per cent) and competing operational priorities (26 per cent).

Infrastructure challenges (24 per cent) and a shortage of technological capabilities (23 per cent) added further pressure on operations. Supply chain instability (22 per cent) and bureaucratic processes within the company (14 per cent) were also cited as barriers to value creation.

Kenya Bankers Association (KBA) says the banked population prefer digital channels, with mobile banking being the most sought-after channel among customers.

Internet banking is the second most preferred channel at 24.6 per cent, a slight uptick compared to the 23.3 per cent preference in 2022.

The umbrella body further noted that bank customers least prefer the cash deposit machines in what is perhaps attributed to their limited penetration.

"Due to higher digital adoption, customers are visiting branches less with its preference coming third at 19.6 per cent, compared to 17.6 per cent in 2022. Preference for ATM stood at 17.7 per cent," said KBA in its Banking Industry Customer Satisfaction Survey

As banks pursue digital adoption (mobile banking) to improve efficiency and customer experience, they must navigate evolving customer preferences to different channels for different needs.

### Investment strategist warns middle class decline, **American** dream fading

IN a recent segment on Fox News's 'The big money show,' investment strategist Luke Lloyd issued a stark warning about the erosion of the American dream, attributing the decline to the current economic policies and advocating for increased taxation on the wealthy

Lloyd's insights highlight a growing concern among Americans about the viability of achieving financial freedom and stability in today's economic climate.

Lloyd emphasized the widening gap between the economic classes in the United States, noting, "You don't have to be a rocket scientist or a stock analyst to realize everyone who doesn't own millions in stock in the stock market is getting left behind and the middle class is on a sinking ship while the top couple percent are on rocket ships going to the moon."

This metaphor captures the escalating disparity and the diminishing middle class's struggle to keep pace with the affluent.

Reflecting on his upbringing in a small town in Ohio, Lloyd reminisced about a time when earning \$100,000 per year was considered a significant achievement, sufficient for a comfortable lifestyle and potentially owning a home. However, the current reality greatly contrasts this once-attainable dream, with a \$100,000 salary now barely covering the essentials in many parts of the country.

The American dream of living freely, once a cornerstone of national identity, appears to be "dying," with almost 70 percent of Gen Z doubtful about their ability to retire, and approximately 40 percent of Americans burdened with more credit card debt than emergency savings.

The discussion then shifted to the Federal Reserve's role in this economic environment, with the host suggesting that the Fed might prefer a scenario where job losses occur to slow the economy. This perspective introduces a complex debate about the Federal Reserve's monetary policies and their impact on everyday Americans.

Lloyd also critiqued the current administration's economic policies, dubbed Bidenomics, challenging the notion that these policies are fostering a healthy stock market and economic stability.

### **BoU** raises interest rates by 0.5 pc to stem shilling's slide

Kampala

THE Bank of Uganda (BoU) raised its key interest rate at an emergency meeting on Wednesday to stem a "sharp depreciation" investor outflows and in the wake of resurgent inflation.

The bank raised the rate to 10 per cent from 9.5 per cent, citing the "unfolding of some of the risks mentioned in the monetary policy statement of February 2024, which includes the depreciation of the shilling exchange rate." The shilling fell to a record low last month, trading at 3,957.50 against the dollar on 26 February, according to Bloomberg.

The shilling rallied in anticipation of the decision, rising the most in seven months, according to Bloomberg. It rose 0.8 per cent against the dollar to as high as 3,884.63, its biggest one-day jump since August 25. By midday, it was trading at 3,888.88/3,898.88 against the dollar, after opening at 3,909.96/3,919.96, according to

central bank data.

"The exchange rate depreciation since November 2023, with sharp depreciation in February 2024, was in part caused by the outflow of some offshore investor of the shilling caused by offshore funds from the domestic market pursuing more attractive vields available in other markets, strong domestic demand partly as a hedging mechanism against further depreciation, and seasonal factors," the bank said in its statement explaining the decision.

It also pointed to the recent rise in inflation, with both the headline and core rates rising to 3.4 percent in February from 2.8 percent and 2.4 percent respectively in the previous month.

The bank said that although the rise in core consumer prices was largely due to an increase in services costs and energy prices, it could still combine with the weakening shilling to cause a general increase in consumer prices if not contained.

these shafts. Premier Modi took the first underwater metro ride joined by several school students on Wednesday as he arrived in West Bengal to campaign for the upcoming general

elections. A video from inside the rail coach showed Modi interacting with the school children seated next to him. "This will speed up the communication system and reduce traffic congestion," Modi said, calling it a "proud moment" for the country.

He subsequently shared numerous photos on his official X account, recounting, "The Metro tour left a lasting impression on all involved in the project and the delightful company of these young individuals. We even ventured through the tunnel beneath the river Hooghly.

## Trump, Biden dominate Super Tuesday races, closer to rematch

HUNTINGTON BEACH, California/PALM **BEACH**, Florida

- PRESIDENT Joe Biden and former president Donald Trump swept to victory in statewide nominating contests across the country on Tuesday, setting up a historic rematch in November's general election despite low approval ratings for both can-

Trump won the Republican votes in a dozen states - including delegate-rich California and Texas - brushing aside former UN ambassador Nikki Haley, his lone remaining rival, who no longer has a viable path to the nomination. Her only win of the night thus far came in Vermont, Edison Research projected.

After a commanding performance across 15 states where more than one-third of Republican delegates were up for grabs on Super Tuesday, Trump had all but clinched his third consecutive presidential nomination, despite facing a litany of criminal charges.

Trump and Biden trained their focus on each other as the results became clear. In a victory speech delivered at his Mar-A-Lago estate in Florida, Trump focused on Biden's immigration policies and called him the "worst president" in history.

"Our cities are being overrun with migrant crime," he said, though crime data does not support that assertion.

In a statement, Biden again cast Trump as a threat to American democracy.

"Tonight's results leave the American people with a clear choice: Are we going to keep moving forward or will we allow Donald Trump to drag us backwards into the chaos, division, and darkness that defined his term in office?" Biden said.

Biden had been expected to sail through the Democratic contests, though a protest vote in Minnesota organized by activists opposed to his forceful support of Israel attracted unexpectedly strong results.

The "uncommitted" vote in Minnesota stood at nearly 20 percent with more than half the estimated vote counted, according to Edison, higher even than the 13 percent that a similar effort in Michigan drew last week. Biden nevertheless won Minnesota and 14 other states, including a mail-in vote in Iowa that ended on Tuesday.

He did suffer one loss, in the US territory of American Samoa's caucus, where entrepreneur Jason Palmer won 51 votes to Biden's 40, according to the American Samoa Democratic Party.

Another campaign between Trump, 77, and Biden, 81 - the first repeat US presidential matchup since 1956 - is one few Americans seem to want. Opinion polls show both Biden and Trump have low approval ratings among voters.

Immigration and the economy were leading concerns for Republican voters, Edison exit polls in California, North Carolina and Virginia showed.

A majority of Republican voters in those states said they backed deporting illegal

immigrants. Trump, who frequently denigrates migrants, has promised to mount the largest deportation effort in US history if elected.

Katherine Meredith, a 65-yearold homemaker, voted for Trump in California's Huntington Beach.

"The border is a complete catastrophe," she said.

Tuesday's results will only intensify the pressure on Haley to drop out of the race. She did not make a public appearance on Tuesday, and her campaign has not scheduled any events going forward.

In a statement, her spokesperson said the vote showed "there remains a large block of Republican primary voters who are expressing deep concerns about Donald Trump."

#### Biden, Trump both show weaknesses

Voters were also casting ballots in down-ticket races.

In California, Democratic US Representative Adam Schiff, the lead prosecutor in Trump's first impeachment trial, advanced to the general election to succeed the late Democratic US Senator Dianne Feinstein. His opponent will be former baseball player Steve Garvey, a Republican who finished ahead of Democratic US Representative Katie Porter.

California's electoral system, in which the top two candidates advance regardless of party, prompted Schiff's campaign to employ an unusual strategy: he ran advertisements designed to boost Garvey among Republican voters, figuring that Garvey would likely be a weaker opponent in November than Porter would be in the Democratic-leaning state.

In North Carolina, Trump-endorsed Lieutenant Governor Mark Robinson won the Republican nomination for governor. Robinson, who would be the state's first Black executive, has drawn criticism for harsh comments about LGBTQ people, women and Muslims.

He will face Democratic Attorney General Josh Stein in what will be one of the most hotly contested governor races in the country.

Pop megastar Taylor Swift encouraged her fans to vote in a post on Instagram, though she did not endorse specific candidates. Biden's campaign is hopeful Swift will eventually back his candidacy, as she did in 2020.

### Lavrov to discuss trade ties, handling of crises with Nigerian colleague

**MOSCOW** 

Russian Foreign Minister Sergey Lavrov will hold talks in Moscow with his Nigerian counterpart Yusuf Tuggar who is paying a working visit to the Russian capital from March 5 to 7.



The Russian Foreign Ministry's spokeswoman Maria Zakharova told a briefing earlier that it is planned that the two officials will review a wide range of pressing issues of the Russian-Nigerian relations and discuss the possible ways of bolstering bilateral interaction, including activating political dialogue and expanding trade, economic and humanitarian ties.

Moscow expects Tuggar's visit to facilitate an increase in mutually beneficial cooperation between Moscow and Abuja in various areas, the Russian foreign ministry stressed.

The sides will also exchange detailed opinions on the international and regional agenda with an emphasis on settling crisis situations on the African continent and especially in the Sahara-Sahel region, the ministry said. Lavrov stressed earlier that Russia was ready to continue providing help to countries in the Sahara-Sahel zone for handling the existing regional issues.

Moreover, Moscow together with African countries is developing the possibility of holding a meeting of heads of foreign ministries in the Russia-Africa format this fall. The issue of the upcoming third Russia-Africa summit that is to take place in one of African countries in 2026, will most probably be discussed at the meeting on Wednesday.

### **INDI Alliance leaders tense sensing** the return of NDA govt, says PM Modi **BARASAT**

PRIME Minister Narendra Modi yesterday asserted that the leaders of the INDI alliance are tense after sensing the return of the NDA to power.

Work will be done to appropriately expand fiscal expenditure to ensure sufficient funding for major national strategic tasks, markedly increase government bonds to promote social investment, and continue structural tax and fee reduction policies with priority given to supporting scientific and technological innovation and the development of the manufacturing sector, he

### US makes second airdrop of humanitarian aid into Gaza

Amid the ongoing war between Israel and Hamas, the US for the second time, airdropped humanitarian aid into the Gaza Strip on Tuesday, The

New York Times reported. US Air Force cargo planes, in a joint operation with the Jordanian Air Force dropped 36,800 ready-to-eat meals "to provide essential relief to civilians affected by the ongoing conflict," according to US Central Command statement.

In a statement, US Central Command said that army troops trained in aerial delivery were part of the airdrop. The US forces further said that they were planning more such misTuesday that the US did not intend to send its troops into Gaza to strengthen the aid distribution process.

While addressing a news conference, Pentagon spokesperson Major General Patrick Ryder said, "At this time, there are no plans to put U.S. forces on the ground in Gaza," The New York Times reported.

The US' operation on Tuesday comes days after the first round of airdrops on Saturday. US airdropped the first round of humanitarian aid into Gaza, two days after more than 100 Palestinians were killed as Israeli forces opened fire around a convoy of aid trucks in northern Gaza. Doctors

sions. However, the Pentagon said on at Gaza hospitals said the majority of casualties were from gunfire.

The Israeli military said the majority of the victims were trampled as they attempted to take control of the cargo. Israeli officials, however, admitted that troops had fired on some people who they said had threatened them, according to The New York Times report.

Following the convoy casualties in Gaza, US President Joe Biden said the US would find new ways to provide aid to Palestinians in desperate need due to Israel's counter-offensive against Hamas, which began after the terrorist group's attack on October 7. On Sunday, US Vice President Kamala Harris called for an "immediate ceasefire" in Gaza, which she stressed must last for at least the next six weeks. Terming the conditions in Gaza as "inhumane," Harris said that people in the region were "starving."

Harris, who was in Alabama's Selma, to commemorate the 59th anniversary of Bloody Sunday, said, "The threat of Hamas poses to the people of Israel must be eliminated. And given the immense scale of suffering in Gaza, there must be an immediate ceasefire for at least the next six weeks, which is what is currently on the table."

The US Vice President noted

that the ceasefire will allow the release of hostages and aid will enter Gaza. She stressed that Hamas needs to agree to that deal.

"This will get the hostages out and get a significant amount of aid in. This would allow us to build something more enduring to ensure Israel is more secure and to respect the right of the Palestinian people to dignity, freedom, and self-determination," Harris said.

"Hamas claims it wants a ceasefire. Well, there is a deal on the table. And as we have said, Hamas needs to agree to that deal. Let's get a ceasefire. Let's reunite the hostages with their families. And let's provide

immediate relief to the people of Gaza," she added.

She stated that Hamas cannot control Gaza and added that the threat Hamas poses to the people of Israel must be eliminated. She further said, "Hamas is a brutal terrorist organization that has vowed to repeat October 7th again and again until Israel is annihilated."

Terming the situation in Gaza "devastating," Harris said that they have seen reports of families eating leaves or animal feed, women giving birth to malnourished babies with little or no medical care, and children dying from malnutrition and dehydration.

### Jaishankar, South Korean counterpart hold talks on expanding bilateral ties in Seoul

EXTERNAL Affairs Minister S Jaishankar and his South Korean counterpart Cho Tae-yul chaired the 10th India-South Korea Joint Commission Meeting in Seoul yesterday.

The two leaders held talks on expanding bilateral ties, cooperation in defence, science and technology, business and trade sectors.

During the meeting, Jaishankar (pictured) and Cho Tae-yul held discussions on developments in the Indo-Pacific and the convergences of India and South Korea to challenges in the region. Both sides also spoke on advancing trilateral cooperation.

In a post on X, Jaishankar stated, "Co-chaired with @FMChoTae\_yul a comprehensive and productive 10th India-South Korea Joint Commission Meeting in Seoul today. Conversations covered our expanded bilateral ties, cooperation in the field of defence, science & technology, business & trade, people to people exchange and cultural cooperation.

Also spoke of advancing trilateral cooperation. Exchanged views on the developments in the Indo-Pacific, our convergences to challenges in the region and regional & global issues of mutual interest."

In his opening remarks at the 10th India-South Korea Joint Commission Meeting, Jaishankar said that the ties between the two nations have grown from "strength to strength." Calling the two nations "important" partners for each other, he stressed that India and South Korea have witnessed steady growth in trade, investments

He said, "Last year, as you noted, we celebrated the 50th anniversary of the establishment of our diplomatic ties. During our Prime Minister's visit in 2015, our relations were elevated to a special strategic partnership.

"It is important that we live up to that. We have grown from strength to strength in the years that have passed. We have become truly important partners for each other.

And our bilateral exchanges - trade, investments, defence, and S&T cooperation have all seen a steady growth," he added.

EAM Jaishankar noted that India is interested in expanding ties with South Korea to new areas like human resource mobility, nuclear cooperation, green hydrogen supply chain resilience, critical and emerging tech-

In his remarks, Jaishankar said, "While keeping up the momentum in the traditional areas of cooperation, we would be very much interested now in expanding it to new areas, such as critical and emerging technologies, semiconductors, green hydrogen, human resource mobility, nuclear cooperation, supply chain resilience, etc, to make our ties more contemporary."

He further said, "We have also noted the growing convergence of our views in the international forum. Your focus on the Indo-Pacific region is a good case to point, and we both have stakes in its stability, security, and prosper-

Jaishankar, who is on a two-day visit to South Korea, on Tuesday, said that ties between India and South Korea



has expanded in different sectors and the benefits are visible to both nations. He said that India's partnership with South Korea is acquiring "great salience" in a "more uncertain and volatile world."

Highlighting ties between the two countries, Jaishankar said, "Its a great pleasure to speak to you today about India's partnership with Republic of Korea, one that is acquiring great salience in a more uncertain and volatile world. Our ties have been described as a special strategic partnership since

This is not just a phrase but an assessment to which we have tried to live up to since then. In different domains, cooperation has expanded and benefits are visible. Yet, this is also a time to introspect and strategise how we could be doing more by doing differently."

The external affairs minister recalled Prime Minister Narendra Modi's visit to South Korea in 2015 and 2019. Terming trade as metric of judgement of ties between two nations, Jaishankar stressed that the bilateral trade has touched roughly around USD 25

"The frequency and intensity of contacts is one way of judging any relationship. In recent years, Prime Minister Narendra Modi and President Yoon have met twice as I did with my previous counterpart. Many of you will be aware that Prime Minister Modi has infact been to Republic of Korea himself twice, once in 2015 and once in 2019," Jaishankar said.

"Trade is another metric of judgement and this today between us is roughly around USD 25 billion plus minus level. Companies of both countries have made significant investments in the other. We note that your economic cooperation in development fund has committed to two significant infrastructure projects in India.

The sovereign wealth fund KIC has opened its office in our country. Our defence cooperation recorded a success in the joint efforts of Hanwha and Larsen and Toubro and we each have a community in other countries about 15000 in our case and some what less in yours," he said.

### Moscow sees growing attempts to disrupt voting in Russian presidential election abroad

MOSCOW is seeing increasing attempts to disrupt voting in the Russian presidential election at embassies abroad as attempts are being made to exert psychological pressure on Russian nationals there, Russian Foreign Ministry Spokeswoman Maria Zakharova said on the sidelines of the World Youth Festival.

Work is ongoing at Russia's foreign embassies "to enhance the security of polling stations. We have been registering increasing calls to disrupt the vote. Also, attempts are being made to put psychological pressure on Russians," the diplomat said.

Zakharova lambasted the democracy in Estonia where she said the authorities unambiguously threaten consequences for voting in the coming election. "Why don't they (the Office for Democratic Institutions and Human Rights (ODIHR) and the Organization for Security and Cooperation in Europe (OSCE) - TASS) react to direct warnings and threats from those governments?"

Russia will hold its presidential election on March 17 with voting taking place over three days from March 15-17 for the first time ever.

### 'Mobile courts' bring convenience to herders in xinjiang

IN Fuhai County, Altay prefecture, northwest China's Xinjiang Uygur autonomous region, local herders live in scattered settlements and often move from pasture to pasture for grazing their livestock following the changes

To provide convenient and efficient judicial services to the herders, the People's Court of Fuhai has established "mobile courts" - judges visiting yurts, going to pastures, driving cars, and riding horses to help the herders.

In September last year, as the chill of winter began to set in, the herders at a summer pasture were preparing to move. Judge Aray Bahetbiek and clerk Dosjan Dawkien from the People's Court of Fuhai visited the pasture to mediate a dispute.

"There was a dispute over a livestock leasing contract, and all parties involved were at the pasture. In order to save them from traveling, we decided to handle the case in the pasture," said Aray Bahetbiek.

According to her, the plaintiff had entrusted over 200 sheep to the defendant for grazing, but the defendant unilaterally disposed 130 of them. After coordination by the village committee, the defendant wrote a promissory note, but has yet to actually provide compensation.

Early in the morning, Aray Bahetbiek and Dosjan Dawkien set off, driving a car. After nearly four hours, they reached a point where there was no road ahead. They parked the car, borrowed horses from herders nearby, and continued their journey. Both parties involved in the case were present in the pasture as they had been notified in advance.

It was learned that the two parties are relatives, which was why the lawsuit was delayed. The defendant's child fell seriously ill, and in order to afford medical treatment, he sold the plaintiff's sheep. Due to financial difficulties in recent years, he was unable to repay the debt on time.

"You both know how the thing is, and there is no dispute regarding the compensation. The only disagreement is about the repayment period. If the court makes a ruling, you will have a maximum of two to three months to repay the debt. If you are unable to do so, the enforcement procedure will be initiated, and you may have to sell all your sheep and cows.

Moreover, others will lose trust in you, and not letting you help them with livestock herding. How will you manage your life in the future? Can you repay a portion of the debt now and then make installment payments to settle the remaining?" Aray Bahetbiek asked the defendant. "Okay, I promise

know his situation. He definitely can't repay the money all at once. Since you are relatives, it would be great if you help

to repay it over five years," the defendant agreed. "You



in full over a period of five years. What do you think?" Aray Bahetbiek tried to persuade the plaintiff.

"I understand his difficulties, which is why I've been patient until now. But what if he can't repay as agreed after five years?" The plaintiff still had doubts. "If you agree, I can draft a mediation agreement right now.

If he fails to repay you as promised, you can apply for enforcement using the agreement," Aray Bahetbiek told the plaintiff. Seeing the two pressing their fingerprints on the mediation agreement and shaking hands, Aray Bahetbiek breathed a sigh of relief.

"We try our best to resolve the issue at hand, which can save the parties involved a lot of costs," she told People's Daily. In a place where there were many yurts, People's Daily reporters encountered judge Zhang Peiyu, who was surrounded by a dozen herders. "My three cows were eaten by a bear, who should compensate me?" "What should I do if I bought fake goods online?"

"The land transfer fee has increased, can I renegotiate the contract?" Zhang patiently answered each of the herders' questions, and the herders bid farewell to him holding a legal knowledge brochures.

"Since the herders live in scattered areas, we carry materials and brochures in our cars and stop wherever there are many people to hold 'rule of law classes' like this, so as to raise their legal awareness," Zhang explained.

"We have developed a model combining mobile court hearings, legal education and legal services. By providing door-to-door legal services, we have successfully mediated 50 percent of the disputes, and for complex cases, we proceed with court hearings, "said an official with the People's Court of Fuhai.

In addition to mobile courts, the People's Court of Fuhai also offers online court hearings for cases where the parties are not present locally, which helps reduce litigation costs for the parties, the official added.

Resolving conflicts on the spot is not an easy task for judges. The pastoral areas are vast, and it takes a long time on the way. It is common for the judges to encounter muddy roads and spend the night on the grassland.

"When the car can't go any further, we ride motorcycles or horses. And if even horses can't reach certain places, we walk. It's definitely hard work. But the law is not just cold and rigid rules.

Through our efforts, we make the parties involved feel the warmth of the rule of law, and that makes our efforts worthwhile," said Aray Bahetbiek, adding that many herders now know her and affectionately call her "daughter."

"This is also a recognition of my efforts," she said.

### **Xabi Alonso: Rising** star catches eye of Liverpool, Bayern

LONDON

XABI Alonso has taken Bayer Leverkusen to the brink of their first Bundesliga title, but the rising star of European coaching could soon be on the move to Liverpool or Bayern Munich.

The 42-year-old played for both European giants either side of a five-year spell at Real Madrid during a glittering career in which he also won two European Championships and a World Cup with Spain.

On top of hoovering up medals with three of Europe's top clubs, the midfielder picked up plenty of knowledge that has shaped his coaching phi-

Pep Guardiola, Jose Mourinho, Carlo Ancelotti, Rafael Benitez and Vicente del Bosque are among the stellar array of coaches under whom Alonso

His shock departure from Madrid for Bayern in 2014 was largely motivated by the chance to witness Guardiola's methods at first hand.

Guardiola's purist principles are most evident in the eye-catching way Alonso's Leverkusen have taken Germany by storm.

But he credits Ancelotti's supreme man-management as having the biggest impact on his coaching style.

"I've always tried to be close to them, to understand how and why they make decisions," Alonso told the BBC, speaking about his former managers. "You learn from that but you need to build your own personality -- it's not a copy and paste thing, this manager's job.

"You need to build your own ideas and believe in them to be able to transmit that idea and that's what I'm trying to do.'

Alonso, whose team face Qarabag in the last 16 of the Europa League today, took his time before going into management after hanging up his boots

He began coaching in the youth ranks at Real Madrid and Real Sociedad before the call came from Leverkusen in October 2022, with the club sitting second bottom of the Bundesliga.

They recovered to finish sixth and reach the semi-finals of the Europa League, losing narrowly to Roma over two legs.

But few could have imagined the leap forward in Alonso's first full season in charge, with Bayern's 11-year reign as German champions seemingly coming to an end.

Leverkusen are 10 points clear of Bayern at the top of the table with 10 games to go and unbeaten in 34 matches in all competitions this season as they eye a Bundesliga, German Cup and Europa League treble.

### Messi's promised Barca contract, on a napkin, up for auction

**NEW YORK** 

TO the untrained eye, it might look like just another used napkin.

But the serviette, expected to fetch up to \$635,000, was actually soccer legend Lionel Messi's springboard to greatness at FC Barcelona, and records the promise of a contract made to him at the tender age of 13.

The napkin has gone on show in New York to drum up interest, ahead of the start of bidding on March 18, against a backdrop of soaring interest in soccer memorabilia.

Though officially estimated to go for between \$380,000 and \$635,000. Ian Ehling, the head of fine books and manuscripts at Bonhams New York, said "I do expect it to sell for much more."

Last December, a set of six shirts worn by the number 10 during Argentina's victorious Qatar World Cup campaign in 2022 sold for \$7.8 million at auction at Sotheby's, exceeding estimates.

The story of the napkin has already been told many times in profiles of "Leo" Messi, one of the greatest players in soccer history, who now plays for Inter Miami.

Born in 1987 into a working class family in Rosario, about 300 kilometers (186 miles) north of Buenos Aires, Messi was 13 when he was spotted by

But not everyone there was convinced, and the deal dragged on and on, making Messi's father im-

That was until a fateful meeting on December 14, 2000, at a Barcelona tennis club, between the club's sporting director Carles Rexach and agents Josep Minguella and Horacio Gaggioli.

To confirm the club's interest, Rexach reached for the napkin and wrote on it in blue ink that he agreed "under his responsibility and regardless of any dissenting opinions, to sign the player Lionel Messi, provided that we keep to the amounts agreed upon."

Kane recognised the manner of Tuchel's exit was "unusual" but said "nights like this can change the season. I'm proud of the boys -- we just have to keep this momentum

Mueller, a two-time Champions League winner, said: 'We're going to make sure everyone enjoys this feeling, nevermind what is in the newspaper yesterday or tomorrow."

"We're very happy because we know the importance of progressing further today."
