ISITING German President Frank-Walter Steinmeier has hailed reforms in trade and investment in Tanzania alongside human rights and democracy, expressing the wish to cooperate with Tanzania by supporting its development endeavours.

The German Head of State, who is in the country for a three-day state visit, aired this sentiment at a joint press conference with President Samia Suluhu Hassan at the Magogoni State House in Dar es Salaam yesterday.

Germany was committed to work with the Tanzanian authorities to address various social and economic needs and encourage private firms in Germany to initiate more investment projects, he said.

He expressed confidence in President Sa-

mia's leadership, underlining that the country has taken vibrant measures helping to improve business and investment conditions, alongside human rights and democ-

"We have witnessed how the Tanzanian government is committed to improving democracy, the rule of law, investments and trade," he said, stressing partnership to maintain the friendship that has existed for

The two countries agreed to strengthen ties in health, education, tourism, water supply as well as trade and investment, plus fighting impacts of climate change, he stated.

President Samia lauded the German statesman for agreeing to an invitation to visit Tanzania, reiterating the two leaders' concord to explore widening social and economic cooperation, strengthen cultural ties

Japan hands UNHCR 1.2bn/for budget gap, new refugees

JAPAN has handed \$0.5m (1.2bn/-) to the United Nations High Commissioner for Refugees (UNHCR) for the provision of safe shelter, water, sanitation and hygiene plus essential items especially for Congolese new arrivals in Kigoma Region refugee camps.

UNHCR country representative Mahoua Parums said at the presentation ceremony in Dar es Salaam yesterday that with Japanese funding covering March to December 2023, UNHCR has built 1,300

emergency family shelters and provided

for 12,000 new arrivals. The items required include sleeping mats, blankets, soap, kitchen sets, mosquito nets and buckets, while building 10 new water collection points, improving the water supply network at reception, transit centers and in the camps, she

Since the start of this year, over 14,000 asylum seekers from the Democratic Republic of Congo (DRC) have crossed the border, she said, elaborating that UNHCR needs \$8m to adequately respond to the

DRC refugee outflows, urging more humanitarian support as needs are rising.

As of 30 September the country was hosting around 250,000 refugees mainly from Burundi and DRC, while UNHCR had received 32 per cent (\$37.3m) of the resources needed for this year, affecting the smooth implementation of projects including repatriation of refugees exiting their current sanctuaries, she stated.

UNHCR is facing a huge funding gap of \$78.64m, over 60 percent of total needs of \$115.9m, with Japanese Ambassador TURN TO PAGE 2

Parliament adopts renewable energy agency statute

THE National Assembly has passed a resolution to endorse the statute of International Renewable Energy Agency-(IRENA), an intergovernmental agency based in the United Arab Emirates, with observer status in the United Nations.

Dr Doto Biteko, the deputy prime minister and Energy minister, tabled the statute in the National Assembly yesterday, saying that it will strengthen expertise, technology, research and understanding on renewable energy issues among policy makers and other stakeholders.

Adherence to the statute will help speed up investments to facilitate the development of renewable energy resources, he said, noting that the statute will enable the country to access key information on renewable energy, while allowing Tanzanians to make such investments in other countries.

The statute will also strengthen availability of investment capital, technical advisory on the development of renewable energy sources and access to affordable energy, vital

while addressing historical contentions over colonial era relics.

Discussions will be held to set out the return of the remains of resisting chiefs killed when fighting German troops in the 1880s and during the Maji Maji war for their descendants to see them.

President Samia hailed the contribution of the Frankfurt Zoological Society, a key stakeholder in northern tourist zone conservation efforts, as a key contributor to conserving tourist attractions.

"We have instructed our teams of experts to conduct regular dialogues and seek advice in various areas of cooperation, while initiating other areas of cooperation," she said, hinting that Tanzania was ready to host negotiations on the dialogue on development cooperation slated for next year.

to economic development and poverty alleviation, he stated.

Other benefits include controlling the use of environmentally unfriendly sources of energy, thus mitigating the pace of climate change and promoting the use of environmentally friendly energy sources in line with global needs, he said.

Membership with IRENA will promote adoption and sustainable use of all forms of renewable energy on the basis of domestic priorities derived from a combined approach of renewable energy and energy efficiency measures, he said.

Adopting the statute will also facilitate increased contribution of renewable energy to environmental conservation by limiting pressure on natural resources, he said, pointing at reducing deforestation of tropical species, desertification and biodiversity loss.

This will help in climate protection, economic growth and social cohesion via poverty alleviation and sustainable development, security of energy supply access, plus regional development and enhancing inter-generational responsibility, the minister declared.

Kilumbe Nge'nda (Kigoma Urban), chairman of the standing committee on Energy and Minerals, said endorsing the statute should not bar the country from using energy sources such as coal, gas and heavy petroleum gas.

He said the ministry should work with higher learning institutions like the Mbeya University of Science and Technology to train more technicians in renewable energy.

"The committee advises the government to work with various stakeholders in the private sector to attract renewable energy investments," he added.

The President of Somalia, Hassan Sheikh, has appointed Ali Jeyte Osman as the president's office for the coordination of community fighters [Ma'wisley].

The appointment was announced in a brief statement broadcasted by the state media. This coincides with the government's plans to launch the second phase of the anti-Al-Shabaab offensive.

Ali Jeyte, a self-appointed Hiiraan State president remained silent on the appointment of the new position, which if he accepts will remove the existence of his administration based in Beledweyne city, 350 kilometers north of Mogadishu.

Jeyte shined in the first phase of

Parliament ratifies treaty for establishment of AMA

PARLIAMENT has ratified the Treaty for the establishment of the African Medicines Agency (AMA), which seeks to assure government's commitment to guarantee quality-assured, safe and efficacious medical products that are fundamental to the health and safety of consumers.

The regional agency aspires to provide support for the improvement of weak regulatory systems and build on the efforts of the African Medicines Regulatory Harmonization (AMRH) initiative (2009), which is led by the Africa Union Development Agency - the New Partnership for Africa's Development (AUDA-NEPAD).

The endorsement of the treaty follows the government's decision to sign the Treaty that was adopted by Heads of States and government during their 32nd Ordinary Session of the African Union (AU) General Assembly on 11 February 2019 in Addis Ababa, Ethiopia.

The AMRH initiative provides guidance to AU recognized Regional Economic Communities (RECs) and Regional Health Organisations (RHOs), to facilitate harmonization of regulatory requirements and practice among the national medicines authorities (NMRAs) of the AU Member

Tanzania became the 22nd AU member state to sign the Treaty on August 10, 2021, at well as help in seizing products smuggled in the AU Commission in Addis Ababa, Ethiopia. the country illegally.

Presenting the treat in the National Assembly, Health Ummy minister Mwalimu said implementation of the AMA would help the country to promote cooperation, partnership and recognition of regulatory decisions, as well as providing regulatory guidance, scientific opinions and a common framework for regulatory actions on medical products.

The African Union Commission has continuously been encouraging all its member states to sign and ratify the Treaty for the establishment of the agency.

According to the minister, as of July 2023, about 30 countries had signed the Treaty for the establishment of AMA out of which only 23 of them had ratified it. They include the neighbouring Uganda and Rwanda.

The minister said that by ratifying the Treaty, the Tanzania Medicines and Medical Devices Authority (TMDA) will receive yet another boost in control of public health, safety and security.

"Despite the success that TMDA has recorded, still, there are several challenges in the control of medical equipment. Others are lack of enough experts, presence of unofficial loopholes especially at border posts and ports that are used to infiltrate substandard products," she said.

The minister said that with the ratification of the Treaty, the country would strengthen systems for control of counterfeit products as

THE Tanzania Meteorological Authority (TMA) has said residents of 15 regions in the country should get prepared to receive heavy rains in the coming few weeks.

According to the TMA's climate outlook for the months of November 2023 to April 2024, the rains will be mainly above normal over most areas in the country.

Addressing journalists in Dar es Salaam yesterday, TMA acting director general Dr Ladislaus Chang'a said the coming rains, also known as seasonal rains were likely to be enhanced by El-Niño TMA: Heavy rain imminent in 15 regions during the month of November, year.

Dr Chang'a said that the expected impacts of the changes in climate during this period will include the emergence of sufficient soil moisture levels which favour cropping in regions like Kigoma, Rukwa, Katavi, Tabora, Singida, Dodoma, Rukwa, Songwe, Mbeya, Iringa, Njombe, Lindi, Mtwara, Ruvuma and southern Morogoro.

He said rains are expected to start during the fourth week of October, 2023 over the western areas and spread in other areas 2023 where the first half of the season (November, 2023- January, 2024) is expected to be wetter than the second half (February-April, 2024).

Seasonal rains are specific for the western, central, southwestern highlands, southern region, southern coast and southern parts of Morogoro Region. These regions experience a unimodal rainfall regime, which starts in November and ends between April and May of the following

He however said that areas of Kigoma, northern part of Katavi, and Tabora regions are expected to feature mainly normal to above normal rains.

He called for extra precautions to be taken in activities related to various weather-sensitive sectors such as agriculture and food security, livestock and wildlife, natural resources and tourism, transport and communications, energy and water, among others.

"Periods of heavy rains may

flooding leading to destruction of infrastructure and loss of lives, authorities have to take precautions over this," he said.

Dr Chang'a said relevant authorities concerned public health and individuals are advised to take appropriate health measures such as water purification, prevention and destruction of mosquito breeding zones, and others so as to minimize the expected negative impacts on health.

Amiri Haidar Mshenga, ZAFICO operation director unveiled yesterday when addressing journalists about the direction of implementation of the blue economy plan through marine resources launched by Zanzibar President Dr Hussein Ali Mwinyi shortly after getting into office in

He said that the idea is to strengthen the fishing sector in the Indian Ocean archipelago.

He said the Zanzi Fresh Inc. has

international experience in deep sea fishing and will contribute to a large extent to bring about the reform of modern fishing and attract other investors from different countries to invest in the sector.

"ZAFICO's board of directors has approved the privatisation plan for the Zanzi Fresh inc contracts that have already been approved after the government approved the privatisation plan," he said.

He said experts from ZAFICO and the Zanzibar Maritime Transport Authority (ZMA) expect to leave this month to inspect the first Fishing Vessel MV CUTETA after the completion of the inspection of the vessel's permit documents before the company is registered in Zanzibar.

"The inspection will take place in Senegal, but the company itself comes from the United States before being registered in Zanzibar and after the inspection is completed it will be handed over the flag of Zanzibar by ZMA and the aim of the ship is to arrive in Zanzibar in December this year," Mshenga said.

He said that the ship is big and has a fish processing factory on board and ZAFICO will benefit from many things including the experience and skills of the workers apart from the jobs that will emerge after the company officially starts work.

According to him, fish factory is expected to be established in the ZAFICO building in Malindi and permission to do major repairs of the building has been submitted to the old town conservation authority before the action begins.

He said that the act of privatisation will help ZAFICO employees to gain knowledge and experience in deep sea fishing for international companies that have long experience in deep sea fishing activities.

"Until now, the ZAFICO company has two fishing vessels, a big challenge for the workers in terms of deep sea fishing. I remember we

once lost one trap worth 110 million shillings in the sea, we could not find it, but the government has bought new traps and the main reason is knowledge and experience," he said.

He also stated that the government has decided to bring about major changes in the fishing industry in collaboration with the private sector and has already allocated 34 billion shillings to strengthen the infrastructure, including building factories for the processing of seafood and processing fish fillets.

He said that the government is already building a modern seafood and fish fillet processing plant in the Kama District of Magharibi A Unguja, which will benefit fishermen from the areas of the district which will have 48 shops, banking services, affordable houses for entrepreneurs and construction has reached a major stage.

He said another seafood processing plant is expected to be built in Fungu Refu, North Unguja Region, along with a fish processing plant that will be built in collaboration with the government of the Union Republic of Tanzania in the Mkokotoni area through the international agricultural development project (IFAD).

"In collaboration with the government of Norway and Oman, the ZAFICO company intends to establish fish farming in ponds in the sea and on land and plans have already been prepared to achieve the intended goals," he said.

He said fish production has reached 61,794 tons worth 391.37 billion shillings per year.

Mwanakheri Muhammed Hilal, head of the finance, investment and marketing in the fisheries development department, said that the existing seafood processing plant project is expected to benefit 10,000 people including fishermen, transporters, vendors and finishers, a project that intends to spend 23 billion shillings including building a fishermen in the area as well as business services, auction market and shops.

She said that the pilot station for drying seafood has already started working in the Kizimbani area where until now two types of seafood have started to be dried including dried and cooked using special plants that use gas to dry as well as making other products derived from marine resources.

John Ntwale, project manager said that the project is being built by the Zanzibar Economic Development Force (JKU) and there has been no problem since its implementation began.

'Government set to complete review of disabilities policy'

THE government is set to complete review of the National Policy, 2004 in this financial year and subsequently review the Persons with Disability Act, 2010 in 2024/25, the the National Assembly heard yesterday.

Katambi, Patrobas Deputy Minister of State in the Prime Minister's Office (Labour, Youth, Employment and People with Disabilities), said the plan is to review laws, policies and regulations governing persons with disabilities to resolve challenges facing them.

He noted that the Persons with Disabilities Act, No. 9 of 2010 clearly stipulates the rights of persons with disabilities, adding that there are some sections deserve repealing.

Katambi made the statement in response to a question from Special Seats MP, Stella Ikupa (CCM), who had wanted to know when the envisioned reviews would take place.

In a question asked on her behalf by the Special Seats MP, Mariam Kisangi (CCM), the lawmaker also wanted to know what the government was doing to ensure people with disabilities are well conversant with their rights."

"There are many people with disabilities in the country who still do not understand their rights and even the government's efforts to empower them" she said.

In response, the deputy minister explained that the government has embarked review of the policy and to complete it before review of the act.

" Policy comes before the law and it is in that spirit that the government is doing everything to review the National Policy on Disabilities this year and complete the review of Persons with Disabilities Act. 2010 in 2024/25", said Katambi.

On the awareness of their rights, he noted that the government has been working with different stakeholders to educate people with disabilities on how they can be empowered.

He said following the review on district council's loans to women, youth and the disabled, people with disabilities can now access the financial support individually unlike in the past where the money was disbursed to them in groups.

The deputy minister added that an individual person with disability can now access up to 50, 000m/-, terming it one of the great reforms by the government to support them.

On the other hand, said, President Samia Suluhu Hassan has directed relevant authorities to do what needs to be done to help solve challenges facing persons with disabilities across the country.

THE government is working out to fill in the gaps of more than 9,000 biomedical devices and appliances for engineers and technicians to cope with the increasing medical equipment in various public hospitals in the country.

Currently, the country has 350 medical engineers and technicians as the government has been working around the clock to improve health service delivery by ensuring the hospitals have the needed medical equipment.

The sentiments were issued here yesterday by Head of the Biomedical Services and technicians, Eng. Suniva Haule during the training of the biomedical devices engineers and technicians funded by the Kotra Foundation for International Healthcare (KOFIH)

He said the government in collaborationwithKOFIHarestaging the training aimed at equipping the engineers with technical know-how and management of the devices as the government is injecting a lot

improved health services.

Eng. Haule said there has been an increasing number of the medical devices and appliances in district, regional, zonal and specialized hospitals, thus, the need to have engineers and technicians with the need to manage them so that total of 249 trainees. they last long is of paramount importance.

He said the government ensures that every council has at least one specialist and will keep on setting aside a budget for employment of the cadres.

Last year, Eng. Haule said, the government employed 147 biomedical devices specialists and this year, 100 have been employed.

Reported rise in search for DNA paternity proof tests noteworthy

Chemist Laboratory Agency (GCLA) was set up to test diseases and arrest dangers when they appear, it appears to have a more urgent load of applications nearly each passing day. It is numerous individuals seeking to find out if the DNA of children they are supposed to have fathered reflect their proper genetic build, as many relationships lack the trust it takes to believe this or that claim of paternity. Yet this is also a syndrome of sickness in society, moral turmoil. Senior officials in GCLA southern

highlands zone speak of obtaining ten to 15 applications each month from parents seeking to know the DNA link between the father and a child in question, or more of them. A laboratory technician made this affirmation at an exhibition organized by the Small Industries Development Corporation (SIDO) in Niombe Region, where a technical outlook was given both on those applications and issues of what impedes fathering children. It was not clear how many such applications come out to be founded, or the fears confirmed.

While there is an eerie calm about the issue, and why such problems come up, what lies below is more acute in terms of what it says of broad based mistrust and levels of child neglect. This is one of those issues where a neat division of sentiments come up, as many see the men as victims from infidelity and lies on parentage, activists will point at even greater suffering on the part women in relation to raising children, even when parentage isn't at issue. When a couple does not

the live together proof of parentage is G o v e r n m e n t often a non-issue, and reciprocally, when the couple live together contentions over parentage is what leads to seeking DNA tests,

> For similar reasons as in the SIDO exhibition and the presentation of the GCLA, there will be no scientific survey on how far men are actually the victims of intentionally false attribution of parentage. Nor will there be research on how many men knowingly refuse to support co-parents when not in wedlock, as both these situations appear normal and left that way. Indeed that is also largely what is taken for granted in gender narratives; we hear of women educating their children, etc more or less as a matter of course, or starting own income generating projects, etc.

> In that manner the GCLA report is just what there is on the surface, and beneath it is a series of undecided situations on family stability or child support. Yet part of the problem has been solved by the public authorities in making schools free most of the period. Thus even single mothers or negligent households where couples live together will go to school even with deficiencies; society makes up for families.

So the good news is that whatever the result of GCLA tests, and even in the confines of wilful neglect where parentage as such is not at issue, this doesn't entirely determine the fate of the children, the possibility of their schooling or making it in life. The GCLA tests are in a sense a storm in a teacup because it is wider social policy that decides schooling for children and even ability of mothers to take care of children outside wedlock. It isn't easy but it is the price of freedom.

Bravo, Speaker, for win in IPU presidency poll

Dodoma were mired in confetti on Monday when receiving House Speaker Dr Tulia Ackson, returning from an Inter-Parliamentary Union (IPU) meeting in the Angolan capital of Luanda. She won a hard fought poll for the presidency of that organisation, reputedly the first time the post goes to a lady speaker

It isn't quite different from the recent event at the Jawaharlal Nehru University in New Delhi where President Samia Suluhu Hassan became the third foreign dignitary and quite simply the first woman, to win a doctorate citation (honoris causa) from the university. It speaks well of the country.

Addressing a large audience of enthusiasts and admirers, the lawyer turned politician narrated ups and downs of how the voting went, with special mention of how social media outlets were used to put in question the suitability of her candidacy.

She talked of 'fellow Tanzanians joining with our enemies to fight our nation instead of bonding together, refuse to fight each other,' which was entirely valid but somewhat misplaced. In inter-parliamentary unions, loyalty is less to countries than to support in a political character, so she loses some home

Taking some examples, everyone knows that ideological support groups cut across borders, often flimsy in character but they serve some purpose. The ruling party in Tanzania is allied with ruling parties in South Africa, Namibia, Angola, Zimbabwe and Mozambique principally, due to the Frontline States alliance of old. At the same time it isn't an accident that the IPU meeting was held in Luanda, as it is

in Cold War outlooks, which still survives.

In actual fact, the Speaker's assertion that blurbs in social media were the main contentious issue in the run to winning the poll shows that there was little of ideological contentions. That implies those who gathered for the IPU meeting are already of a particular camp, looking more or less like the Frontline States, and in that manner also it was surprising to hear those attacks from her own camp - if one sees Tanzania singularly as a leader of the Frontline States. Yet that was only fair, and back home we have seen 'social media' attacks during nomination polls, etc.

In that case it was slightly inaccurate to say that since other countries desisted from placing candidates against her as a Tanzanian candidate, all Tanzanians ought to have supported her. It would definitely be better that way but politics is a more complicated matter, and what took place was 'politics as usual,' part of the same freedom of expression that IPU is also expected to honour. Unanimity of opinion or sentiments isn't politics, nor is it true that it is struck if foreigners are there, as even at that point there are international ideological affinities that constitute the breath of politics itself. These are values that people stand for, not just nationality.

So there is every reason to congratulate the Speaker for fellow confidence that parliamentarians have shown for her as a diligent and lucid, competent leader of parliamentary business. She has won lots of admirers but as it is true of all political affinities, there are those who see issues quite differently. Most likely, Tanzanians.



China's BRI and Africa's infrastructure development ambitions

VER the last decades, China has been at the forefront of championing multiple global initiatives, including the Global Development Initiative, the Global Security Initiative, and the Global Civilisation Initiative, amongst others. One of such global initiatives is

the Belt and Road Initiative, which has become known shortly as 'BRI'. Launched in 2013 by President Xi Jinping, China's Belt and Road Initiative (BRI) is one of the most ambitious infrastructure projects ever conceived in the history of our

The BRI is earmarked to recreate the historic Silk Road trade route in order to open up the world market and establish a trade and investment network spanning the three continents of Africa, Asia, and Europe to facilitate greater global growth and development.

For the Chinese leadership, they aspire to maintain an open world economic system and achieve diversified, independent, balanced, and sustainable development with a shared future. The BRI is now not simply an economic initiative but also a global public good instrument, where they're rallying resources to achieve this ambitious plan.

BRI MATTERS TO DEVELOPING COUNTRIES

It's key to mention that the BRI is not a China-only story. The primary goal of the initiative is to address the vast infrastructure demand in developing countries.

As of August 2023, 155 countries were listed as having signed up to the BRI. The participating countries represent more than half of the world's GDP and nearly 75 per cent of its population.

Beyond the numerous global discussions surrounding viability and relevance of the BRI, the initiative is active, with a number of projects already finished or in progress and contributing to economic growth and creating unlimited job opportunities.

As at October 2023, there has been over 3000 projects completed under the BRI generating over 420,000 jobs.

BRI member countries in the global south are aiming to maintain and increase their involvement in the BRI. To these receiving states, where infrastructure financing is desperately needed, geopolitical externalities are of secondary concern.

BRI & AFRICA'S CONNECTIVITY AMBITIONS



It's imperative to ask questions and sustainable and inclusive that border on the significance of the BRI for Africa's own development future. How does the BRI fit into Africa's infrastructure development agenda? - It's outright significant.

The primary infrastructure bottlenecks for the continent have long been identified as energy, water, sanitation, telecoms, and transportation. With 30 countries regularly facing power outages and slightly more than a third of Africans having access to electricity,

By 2025, the African Development Bank estimates that the African continent will need to spend up to \$170 billion annually to upgrade its infrastructure, with two-thirds of that amount going toward brand-new infrastructure and the remaining one-third going toward maintenance.

In Africa, demand for electricity will increase by 93 per cent by 2035, around 47 per cent of roads will need to be paved, ports must increase their average container handling performance from 20 to 25 to 30 moves per hour, and an additional 300 million people must have access to the Internet to keep up with the continent's economic growth.

The World Bank estimates that in order to achieve universal Internet access throughout Africa, \$100 billion will need to be invested in infrastructure, such as 4G stations, and at least 250,000 kilometers of fiber will be required to build and maintain broadband networks.

For Africa to experience economic success and sustained growth, the infrastructure gap must be filled. Improved infrastructure would make it easier to conduct more intraregional and international trade, lower business costs, increase Africa's competitiveness both domestically and internationally, and act as a catalyst for the continent's economic transformation diversification through

growth.

BRI is delivering infrastructure development across Africa, and the continent has a more positive view of the Belt and Road Initiative (BRI) than anywhere else outside China.

As of August 2022, 50 of the 55 countries in Africa had signed some sort of memorandum of understanding or other agreement on the BRI.

The African Union has also signed a Memorandum of Understanding (MoU) on BRI cooperation with China.

Some countries, such as Kenya, Tanzania, and Somalia (on the shores of the Indian Ocean), as well as Egypt and Djibouti (on the shores of the Mediterranean Sea), have strategic locations that make them natural BRI partners because they link Africa, Asia, and Europe.

For the rest of the many countries on the continent that have joined the BRI countries list, it's to help them meet their urgent infrastructural development needs.

BOOSTING INTRA-AFRICAN TRADE

Africa has an ambitious plan for a common and single market through the African Continental Free Trade Area (AfCFTA).

Transporting goods between nations has been a hindrance to intercontinental trade because the continent is made up of several small landlocked nations without access to ports.

The primary cause of this is a lack of streamlined and effective transportation routes throughout the continent, which leads to high expenses from shoddy infrastructure.

remove integration bottlenecks, it is essential to invest in telecommunications infrastructure, ports, generation, and roadway and railroad infrastructure.

China has aggressively been industrialisation, value addition, at the forefront of infrastructure & Advisory

financing across the continent, helping African countries build a large number of infrastructure projects over the years.

According to research by the Center for Global Development, a US think tank, China's two foreign development major banks invested \$23 billion in infrastructure projects on the continent between 2007 and 2020.

That amounts to \$8 billion more than the combined contributions of the other top eight lenders, which include the World Bank, the African Development Bank, and the US and European development

AFRICA'S AGENDA 2063 AND **BRI VISION**

In January 2015, in Addis Ababa, Ethiopia, at the 24th African Union (AU) Assembly of Heads of State and Government, Africans adopted a shared strategic framework for inclusive growth and sustainable development called Agenda 2063.

It's meant to be a strategic guide to Africa's development in the next fifty years. The goal of Agenda 2063 is to fulfill seven aspirations, each with specific objectives that, if met, will bring Africa one step closer to realising its vision for 2063.

The Agenda 2063 states category aspiration number two of Africa's quest to build a connected continent in all shapes and forms within the next 50 years.

Africans aspire to build "an integrated continent, politically united, and based on the ideals of Pan-Africanism and the vision of Africa's Renaissance."

This, according to the goals of these aspirations, would entail developing a world-class infrastructure crisscrossing Africa--"improving connectivity through newer and bolder initiatives to link the continent by rail, road, sea, and air; and developing regional and continental power pools, as well as ICT."

is already delivering infrastructure development across Africa, and the continent has a more positive view of the Belt and Road Initiative (BRI).

African infrastructure and economic growth may be unified and expedited as a result of China's participation in infrastructure projects on the continent, and the Belt and Road Initiative's goal of enhancing connectivity among member nations resonates directly with Africa's own ambitions for the next 50 years.

Health misinformation: Another 'epidemic' that must be fought tirelessly

ECAUSE health facilities normally do not advertise their services for ethical reasons, their popularity mostly relies on testimonies of patients who have been treated there before as well as referrals. As a result, only those with outstanding service become the destination of choice for patients.

Mugana Designated District Hospital (DDH) in Missenyi District, Kagera Region has earned itself a name not only in the district it is supposed to serve but the entire region and the Lake Zone, especially when it comes to maternal health. Records here show that the facility receives patients from all corners of Kagera Region as well as the neighbouring ones such as Shinyanga, Geita and Mwanza, Simiyu Kigoma and Mara.

Started in 1956 by the Roman Catholic Diocese of Bukoba as a dispensary for local community, it has since expanded its services and elevated by authorities to a health centre and finally a DDH status which it accomplished in 2010.

Maternal and child health department at the hospital is proud of having a clean record as there wasn't any mothers who died there during and after delivery in the whole of 2022, and as of September 2023. There were four stillbirths during that entire period and six children who died before mothers arrived at the facil-

There were 962 deliveries in 2022 out of which 661were normal and 301 through cesarean section. From January to September 2013, there were 630 deliveries, 424 normal and 206 through C-section.

Dawson Muhindi, assistant nursing officer at the maternal ward said some mothers delay reporting to hospital which results in birth defects, adding that a pregnant woman should start attending clinic as early as possible, especially from six to eight weeks so as to give caregivers enough time to learn a lot of things about the pregnancy and carry some recommended

"This is important because antenatal care attendance plays a major role in early detection and treatment of maternal health problems." He said.

Patricia Anatory, a midwife at the facility said reports from their department as well as other health facilities show that there is rumour mongering pregnant among mothers which derail critical interventions

such as taking a folic acid.

"Many expectant mothers believe the misinformation that taking folic acid causes excessive bleeding," she said.

"There should be a way of dealing people who spread such lies because they do not only endanger lives of mothers but also derail national maternal health targets."

The midwife said there is need to increase awareness and debunk lies on key interventions such as folic acid which helps prevent birth defects associated with babies' brain and spinal cord development.

"Without enough folic acid in the body, the baby's neural tube may not close completely and they could develop health problems called neural tube defects such as spina bifida which is an incomplete development of the spinal cord or the vertebrae as well as anencephaly which is incomplete development of major parts of the brain,' she

She added that babies with anencephaly usually do not live long while those with spina bifida may be perma-

nently disabled. Although such serious health complications are easily avoidable, they are still prevalent, thanks to misinformation and hearsay.

Asked about yet another rumour in the community that many expectant mothers prefer C-section to normal delivery and health workers also play to the tune, Muhindi said that is not the

He said they are obliged to go for Csection when it can't be avoided and mostly it is for those with too small

pelvis to allow the baby move easily through the birth canal as well as those who have given birth by surgery more than once.

"Some people think it is a walk in the park to perform surgeries compared to natural birth. It is vice versa. Performing surgeries requirers time and preparations which involve running here and there. It is a long process that one cannot opt for without a strong reason," he

Mugana DDH has medical, paediatric, surgical and maternity wards, outpatient department, reproductive and child health, laboratory, ultasonography, computer technology solutions as well as X-ray departments.

It has received a number of certificates and trophies from various institutions for outstanding performance. In 2016, it received an award from Ministry of Health for reaching first stage of excellent performance in delivering emergency services to mothers and babies. And recently, it was awarded a safe care certificate from Ministry of Health for safe and quality care to patients.

The Demographic and Heath Survey and Malaria Indicator Survey 2022 shows decrease of under-5 mortality from 147 per 1,000 live births in 1999 to 43 deaths in 2022 and neonatal mortality rate stands at 24 deaths per 1,000 live births. The survey further shows that 81 per cent if women took any iron containing supplements during pregnancy.

The Sustainable Development Goals (SDGs) target to accelerate the decline of maternal mortality by 2030. SDG 3 ambitiously targets to reduce the global maternal mortality rate to less than 70 per 100 000 births, expecting that no country will have a maternal mortality rate of more than twice the global aver-

The UN's 78th birthday: Revisiting its operational credibility

THANK the United Nations Asia Network for Diversity and Inclusion (UN-ANDI) for inviting me to present the keynote speech on this special occasion for the observance of the United Nations

I commend wholeheartedly the UN-ANDI and its dedicated team for their work, particularly its recent survey report on racism and racial discrimination despite the constraints of the global Covid pandemic of last few years. I am proud to be associated with the conceptualization of UN-ANDI in late 2019.

As the first ever effort to bring together the diverse group of personnel from Asia and the Pacific in the UN system, UN-ANDI needs all our support and encour-

In my decades of work for the United Nations, both representing my country as well as representing the organization, I have seen many faces of the world body - positive and not so positive, spirit-uplifting and also frustrating, focused and determined and also confused and politicized.

But the most enduring experience for me about the work of the United Nations in its 78 years of existence has been its contribution to making a positive difference in the lives of the millions of people of our planet.

Over the years, the United Nations has been tested time and again by conflicts, humanitarian crises and poverty and deprivation, but has always risen to live up to the challenges in a determined and inclusive way. It has been rightly called the "indispensable common house of the entire human family." Respected global peace leader and philosopher Daisaku Ikeda describes it as the "Parliament of the World."

It is worth reminding us that without attracting attention, the United Nations and its family of agencies and entities are engaged in a continuing gigantic endeavour against enormous odds to improve every aspect of people's lives around the world. It is also worth remembering that the UN's inspirational norm-setting role covers a very broad range of areas.

In my personal association with the application of my country, Bangladesh for membership of the United Nations in 1972 and since then, in my fifty-one years of collaborative involvement with the UN, I can affirm with great pride that all major aspects of Bangladesh's development architecture reflect the stamp of the UN.

Last Tuesday, as we observed the UN Day, I received many "Happy UN Day" text messages. I did not have the intellectual and moral energy to join them. So, reflecting the current realities, I responded by saying "A not-so-happy UN Day in a conflict-ridden world where the UN is found to be helpless." That helplessness pains me immensely.

The progressive British newspaper Guardian in its editorial on 26 October echoed that perception by saving that "The United Nations marked its 78th birthday on Tuesday but had little cause for celebration." It went on to say that "On the same day, Israel called for António Guterres to resign over his remarks on the Israel-Hamas war, and accused him of 'blood libel'."

The well-meaning peoples of the world should not be cocooned in our own isolation without recognizing and understanding the reality where we are at this

of time. In the most unbecoming manner and forsaking all diplomatic decency, the Israeli Permanent Representative to the UN turned on the Secretary-General at the open session of the Security Council is inconceivable and totally unacceptable.

The earlier Guardian editorial appropriately wrote that "But 10 years ago, it would have been hard to imagine the contempt radiating from the Israeli Ambassador's announcement that UN representatives would be refused visas because 'the time has come to teach them a lesson'. That surely reflects the UN's reduced status."

The conservative Wall Street Journal went even further the day before on 25 October in its editorial board's opinion to say that "This is how the UN makes itself a fellow traveler in the advancing march of global disorder."

We need to revisit the operational credibility of our much-cherished world body. What was needed in 1945 to be enshrined in the UN Charter is to be judged in the light of current realities. If the Charter needs to be amended to live up to the

challenges of global complexities and paralyzing intergovernmental politicization, let us do that. It is high time to focus on that direction. Blindly treating the words of the Charter as sacrosanct may be selfdefeating and irresponsible. The UN could be buried under its own rubble unless we set our house in order now.

I am often asked, during 'questions and answers' segment following my public speaking, if I want to recommend one thing that would make the UN perform better, what would it be. My clear and emphatic answer always has been "Abolish the Veto!" Veto is undemocratic, irrational and against the true spirit of the principle of sovereign equality of the United Na-

In an opinion piece in the IPS Journal in March 2022, I wrote that "Believe me, the veto power influences not only the decisions of the Security Council but also all work of the UN, including importantly the choice of the Secretary-General."

The same opinion piece asserted that "I believe the abolition of veto requires a greater priority attention in the reforms process than the enlargement of the Security Council membership with additional permanent ones. Such permanency is simply undemocratic. I also believe that the veto power is not 'the cornerstone of the United Nations' but in reality, its tombstone."

Abolishing the veto would also release the election of the Secretary-General from the manipulating control of the vetowielding permanent members of the Security Council.

I would also recommend that in future the Secretary-General would have only one term of seven years, as opposed to current practice of automatically renewing the Secretary-General's tenure for a second five-year term, without even evaluating his performance.

After choosing nine men successively to be the world's topmost diplomat, I strongly believe that it is incumbent on the United Nations to have the sanity and sagacity of electing a woman as the next Secretary-General.

Also, I am of the opinion that a formalized and mandated involvement of and genuine consultation with the civil society would enhance the UN's credibility. The UN leadership and Member States should work diligently on that without fail for a decision by the on-going session of the General Assembly.

Transparency and accountability are essential in the budget processes of the UN and personnel recruitments at all levels. Two other areas which need more scrutiny are extra-budgetary resources received from Member States and consultancy practices including budgetary allocations for that by the organization. Special attention in these areas is needed to restore the UN's credibility and thereby effectiveness and efficiency for the benefit of the humanity as a whole.

The international community has reached a fork in the road. One path is to resign ourselves to the idea that an effective multilateral system is beyond our grasp, with the potential for reversion to the dangerous, anarchic world order that the United Nations was set up to improve upon. The other path, also rocky but considerably more hopeful, leads to global solidarity based on shared principles, objectives, and commitments, on oneness of humanity and on a global security architecture that has a chance of commanding the genuine respect as well as the true acceptance and adherence of all States.

Let me conclude by asserting that, all said, I continue to hold on to my deep faith in multilateralism and, my belief and trust in the United Nations as the most universal organization for the people and the planet is renewed and reaffirmed!

Community solutions combat water shortages in Peru's highlands

HE shortage of water is so severe in Peru's highlands that farming families are forced to sell their livestock because they cannot feed them. "There is no grass or fodder to feed them," says Fermina Ouispe, a Ouechua farmer from a rural community located at 4,200 meters above sea

Llarapi Chico, the name of her community, belongs to the district of Arapa in the southern Andean department of Puno, one of the 14 that the government declared in emergency on Oct. 23 due to the water deficit caused by the combined impacts of climate change and the El Niño phenomenon.

Arapa is home to 9,600 people in its district capital and villages, most of whom are Quechua indigenous people, as in other districts of the Puna highlands.

With a projected population of more than 1.2 million inhabitants, less than four percent of the estimated national population of over 33 million, Puno has high levels of poverty and extreme poverty, especially in rural areas.

According to official figures, in 2022 the poverty rate in the department stood at 43 percent, compared to 40 percent and 46 percent in 2020 and 2021, respectively - years marked by the impact of the COVID-19 pandemic. The recession of the Peruvian economy could drive up the poverty rate this year.

In addition, Puno was shaken by the impunity surrounding nearly 20 deaths during the social protests that broke out in December 2022 demanding the resignation of interim President Dina Boluarte, who succeeded President Pedro Castillo, currently on trial for attempting to "breach the constitutional order".

The United Nations issued a report on Oct. 19 stating that human rights violations were committed during the crackdown on the protests, one of whose epicenters was Puno.

Fermina Quispe is president of the Women's Association of Huerto de Nueva Esperanza, which is made up of 22 women farmers who, like her, are getting involved in agroecological vegetable production with the support of the non-governmental organization Cedepas Centro.

The 41-year-old community leader spoke to IPS in Chosica, on the outskirts of Lima, while she participated in the Encuentro Feminismos Diversos por el Buen Vivir (Meeting of Diverse Feminisms for Good Living), held Oct. 13-15.

With a soft voice and a face lit up with a permanent smile, Quispe shared her life story, which was full of difficulties that far from breaking her down have strengthened her spirit and will, and have helped her to face challenges such as food security.

As a child she witnessed the kidnapping of her father, then lieutenant governor (the local political authority) of the community of Esmeralda, where she was born, also located in Arapa. Her father and her older brother were dragged away by members of the Maoist guerrilla group Sendero Luminoso (Shining Path), which unleashed terror in the country between 1980 and 2000.

"A month later we found my father, they had tortured him and gouged out his eyes. My mother, at the age of 40, was left alone with 12 children and raised us on her own. I finished primary and secondary school but I couldn't continue studying because we couldn't afford it, we had nowhere to get the money," she recalls calmly. Her brother was never heard from again.

She did not have the opportunity to go to university where she wanted to be trained as an early childhood education teacher, but she developed her entrepreneurial skills.

After she married Ciro Concepción Quispe - "he is not my relative, he is from another community," she clarifies- they dedicated themselves to family farming and managed to acquire several cattle and small livestock such as chickens and guinea pigs, which ensured their daily food.

Her husband is a construction worker in Arapa and earns a sporadic income, and in his free time he helps out on the farm and in community works.

Their eldest daughter, Danitza, 18, is studying education at the public Universidad Nacional del Altiplano in Puno, the departmental capital, where she rents

a room. And the youngest, 13-year-old Franco, will finish the first year of secondary school in December. His school is in the town of Arapa, a 20-minute walk from their

Fermina managed to build "my own little house" on a piece of land she acquired on her own and outside of her husband's land, in order to have more autonomy and a place of her own "if we have conflicts," she says.

She also began to look for information about support for farming families, bringing together her neighbors along the way. This is how the association she now presides over came into being.

However, the drought, which has not let up since 2021, is causing changes and wreaking havoc in their lives, ruining years of efforts of families such as Fermina's.

"We have a water crisis and the families are very worried. We are not going to have any production and the cattle are getting thin, we have no choice but to sell. A bull that cost 2,000 soles (519 dollars) we are selling off for 500 (129 dollars). The middlemen are the ones who profit from our pain," she says.

Solar water pumps

In the face of adversity, "proposals and action" seems to be Quispe's mantra. She wants to strengthen her vegetable production for self-consumption and is thinking about growing aromatic herbs and flowers for sale. To do so, she needs to ensure irrigation in her sixby-thirteen-meter highland greenhouse where she uses

agroecological methods.

During her participation in Cedepas Centro's training activities, she learned about solar water pumps, which make it possible to pump water collected in rustic wells called "cochas" to gardens and fields. She has knocked on many doors to raise funds to set up solar water pumps in her community.

"Fermina's gardens and those of 14 other farmers in her community now have solar pumps for irrigation and living fences made of Spanish broom (Cytisus racemosus)," José Egoavil, one of the experts in charge of the institution's projects, told IPS.

"They are small pumps that run on 120- to 180-watt solar panels," he says in a telephone interview from Arapa.

He explains that the solar

panel is connected to the pump, which sucks the water stored in the wells that the families have dug, or in the "ojos de agua" - small natural pools of springwater - present on some farms. Thus, they can irrigate the vegetable crops in their greenhouses, and the living fences.

"It is a sustainable technology, it does not pollute because it uses renewable energy and maintenance is not very expensive. In addition, the families give something in return, which makes them value it more. Of the total cost of materials, which is about 900 soles (230 dollars), they contribute 20 percent, in addition to their labor," he says.

Egoavil, a 45-year-old anthropologist, has lived in Arapa for three years. He is from Junín, a department in the center of the country where Cedepas Centro, an organization dedicated to promoting food security and sustainable development in the Andes highlands of central and southern Peru, is based.

"The focus of our work is on food security and a fundamental issue is water for human consumption and production. There have already been two agricultural seasons in which we have harvested much less and we are about to start a new one, but without rain the forecasts are not encouraging," he says.

Given the water shortage, they have promoted the community participation of families in emergency projects such as solar pumps, which help to ensure their food supply.

In addition, long-range water seeding and harvesting works are underway, such as the construction of infiltration ditches at the headwaters of river basins.

The participation of small farming families is the driving force behind the works and they are responsible for identifying the natural water sources for their conservation and the construction of the ditches that will prevent the water from flowing down the hills when it rains.

"The ditch is like a sponge that retains water, but if it doesn't rain, we don't know what will happen," says Egoavil.

Learning to harvest water

Jesusa Calapuja, a 27-year-old veterinarian born in Arapa, is one of the people in charge of technical assistance in agroecological production, planting and water harvesting at Cedepas Centro.

Using the Escuela de Campo (countryside school) methodology, she travels by motorcycle to the different communities where she interacts with farming families. She came with Fermina Quispe to the feminist meeting in Chosica, where IPS inter-

Calapuja also notes changes in the dynamics of the population due to water scarcity. For example, their production no longer generates surpluses to be sold at the Sunday markets; it is barely enough for their own sustenance.

"They don't have the income to buy what they need," she says.

She also notices that at training meetings, women and men no longer bring their boiled potatoes or soup made with the oca tuber, or roasted corn for snacks, but only chuño (dehydrated potatoes) or dried beans. The scarcity of their tuber and grain production is evident in their diets.

But Fermina Quispe hastn't lost her smile in the face of adversity and is confident that her new skills will help the women in her community.

"Our great-great-grandparents harvested water, made terraces and dams; we have only been harvesting, collecting and using. But it won't be like that anymore and we are taking advantage of the streams so the water won't be lost. We only hope that the wind does not carry away the rain clouds," she says hopefully.

Leaders in the Congo to protect forests, combat climate change

BRAZZAVILLE

BRAZZAVILLE, the capital of the Republic of the Congo, had the privilege of hosting the summit of the three major tropical forest basins on the planet from October 26 to 28: the Amazon, Congo, and Borneo-Mekong basins.

These basins represent 80 per cent of the world's forest cover and approximately three-quarters of its biodiversity. Over 3,000 participants, including government representatives, international organizations, NGOs, civil society, scientists, researchers, environmentalists, and indigenous populations, took part in this event.

At least ten Heads of State from the continent, including Congo, DR Congo, Burundi, Central African Republic, Comoros, Gabon, Guinea-Bissau, Kenya, Sao Tome and Principe, were in attendance. However, no President from the Amazon or Borneo made the journey to Brazzaville. Colombia and Venezuela sent their respective Ministers of Foreign Affairs.

The primary objectives of the summit included building a global coalition to accelerate the energy transition and strengthening collaboration between these basins, recognized as the world's major ecological lungs, to go further. In the declaration following the discussions, the participants reaffirmed their commitment to lay the groundwork for a roadmap towards establishing a common framework for cooperation among the three basins.

During the summit, President Félix Tshisekedi of the DR Congo, a country that alone covers 62 per cent of the forests in the Congo Basin, expressed concern about the destruction of ecosystems by a neighbouring country, specifically Rwanda: "Currently, in the Virunga Park (Eastern DR Congo), one of the world's most significant natural reserves in terms of forests and biodiversity, armed activities are jeopardizing this ecosystem, destroying it. And this decision wasn't made in Washington, Brussels, London, or Paris. It was decided in Africa, specifically in Kigali,"

UN Secretary-General Antonio Guterres, as well as French President Emmanuel Macron and former Brazilian President Lula, participated via video conference to applaud the initiative. President of the Republic of Congo, Denis Sassou Nguesso, provided the essence of the meeting: "This summit will primarily focus on, among other things, defining a governance framework within the scope of a new multilateralism through a cooperation agreement, aiming for a global alliance of the three basins," he stated.

'Africa faces lack of experts to evaluate medical devices'

LACK of expertise to assess medical devices including those for maternal, newborn and child health has been cited as one of the challenges facing the African continent in ensuring quality, safety and performance of the devices circulating in the market.

This was revealed during a three-day workshop of the Africa Medical Devices Forum (AMDF) in Dar es Salaam yesterday aiming at enhancing the quality, safety and performance of medical devices critical to the health and well-being of mothers, newborns and children.

Kissa Mwamwitwa, director of medical devices and diagnostics control from TMDA said: "This workshop is a major milestone in overcoming this challenge as the training will produce a pool of experts for assessing the medical devices before being authorised for market-

The capacity building workshop geared and aimed at facilitating, supporting and ensuring that regulators from across Africa understand the need to have medical devices.

"The regulators will be looking at the requirements as per guidelines and ISO standards and be learning how to assess submitted data and use that information to make an informed decision regarding registration of a particular device," she added.

Paulyne Wairimu, AMDF chairperson applauded TMDA for capacitate National Regulatory Authorities (NRAs) in the areas of MNCH Medical devices which it's regulation has been and continues to be ragging behind other commodities in health sector and yet medical devices are crucial and essential part of health system.

"Maternal, newborn and child health medical devices have never been given adequate time or resources in terms of being reviewed by regulators, it is important because regulators are gatekeepers where the products are coming in. If regulators will not be well equipped with information will not be able to dispense this and therefore to protect the health," Wairimu said.

Innovative financial services transform agricultural entrepreneurship in Africa

MALLHOLDER agricultural enterprises in Africa face a lot of challenges getting loans from financial institutions like banks due to the stringent requirements they can hardly fulfil. Investor confidence is usually lacking, given the risks involved in this sector of the economy.

Climate change has not helped matters either. Prolonged droughts and unreliable rainfall patterns have made them less resilient. And since a paltry 1.7 percent of climate finance goes to small-scale agriculture (according to the Climate Policy Initiative), small-scale farmers are left particularly vulnerable.

However, innovative financial solutions targeted at these farmers are transforming the sector in tangible ways in Africa. Organisations like Root Capital are working with small-scale agricultural enterprises using a financial model that is accommodative to their unique needs while addressing the climate change component on the ground.

Root Capital is a nonprofit that supports agricultural enterprises working directly with small-scale farmers. On the other hand, Mercy Corp - an international NGO - through its venture capital arm, supports entrepreneurs who are developing transformative technologies, innovative business models and effective climate adaptation resilience solutions which are usually tech-

Users of these technologies are in 35 most climate vulnerable countries, according to Scott Onder, the chief investment officer at Mercy Corp. In Kenya, for example, the NGO has partnered with Safaricom, the largest mobile network operator in the country through its DigiFarm product.


The product bundles together a range of solutions for smallholder farmers, helping them become more productive, increase their yields and grow their income.

Batian Nuts Ltd, an edible nuts processing enterprise based in Meru County in central Kenya has seen its operations expand, ever since it started working with Root Capital. This enterprise exports macadamia nuts internationally but also deals in peanuts processing for the local market. It has a base of 8,000 small-scale farmers.

"We chose to work with Root Capital because their interest rates are below what you would normally get from the financial market, plus their terms are very accommodative to a start-up like ours," says James Gichanga







He explains that commercial banks require considerable collateral, such as parcels of land or other assets, which they do not have.

On the other hand, Root Capital will provide the finances they need, based on the commitment made by the overseas buyer of their produce. The buyer need only provide a letter of intent, committing to purchase macadamia nuts from Batian Nuts Ltd, and "Root Capital will give us money based on that alone," says Gichanga.

In other words, the buyer of farm produce based in the US, Europe or Asia and the borrower (it could be a coffee cooperative in, say, Rwanda) - or Batian Nuts Ltd in this case - signs an agreement with Root Capital. And when the time comes for payment, the buyer pays Root Capital directly.

"We take our principal interest and then pass the rest of the payment to the coffee cooperative," explains Elizabeth Teague, the senior director of Climate Resilience at Root Capital.

Even though this type of financing

has existed before, their innovation involves applying it to the smallholder agricultural context. This, explains Teague, is a way of mitigating risk without requiring collateral from smallholder farmers.

In addition, they provide small and medium sized agricultural enterprises with technical assistance through a programme known as "agronomic and climate reliance advisory."

Prior to its partnership with Root Capital, Batian Nuts Ltd used to handle between 300-400 tonnes of produce per year. However, since 2017 when the collaboration begun, the business has more than doubled this capacity to 1,000 tonnes, and its workforce has grown from 26 permanent employees to 55 currently. Its seasonal workforce has increased as well from a couple dozen to 160, who are engaged seven months in a year.

Investors have traditionally shied away from putting their monies in small-scale farmers in sub-Saharan Africa, due in large part to higher cost and risk involved. thus creating an estimated USD 65 billion financing gap for small businesses in the region, according to Teague.

"And then climate change exacerbates that and makes it even riskier for investors," she adds.

Root Capital works with a network of 200 businesses and 500.000 farmers in Africa, Latin America, and Indonesia.

NCBA Bank posts 16.5bn/- net profit in three quarters, 2023

NCBA Bank Tanzania posted a cumulative net profit of 16.1bn/- in nine months of the current year, compared to a loss of 22.8bn/- recorded during the first three quarters of last year.

Unaudited financial statement for the third quarter of this year shows the cut of losses resulted from recovery of written off bad debt, reduced impairment losses, increased interest and non-interest income.

The statement shows the bank managed to recover 7.7bn/- written bad debt during the period of nine months of which 3.9bn/- were recovered during the third quarter of this year, while impairment losses on loans and advanced shrunk to 8.9bn/- during the first three quarters of this year, from 19.1bn/- during comparative period of last year.

Cumulative net interest income grew to 28.3bn/- during nine months of current year, compared to 21.5bn/- during comparative period, while non-interest income went up to 9.4bn/- compared to 7.3bn/- respectively.

The increase of interest and noninterest income as well as asset recovery resulted into an operating profit amounting to 9.2bn/- during three quarters of this year, of which 3.7bn/recorded during the third quarter, from an operating loss of 21.7bn/- during nine months of last year.

Basic earnings per share also gained to a profit of 121/- during the first nine months of this year from a loss of 210/recorded during nine months of last year, while number of employees in none existing branches went up to 182 from 166 respectively.

its balance sheet to a total assets amounting to 513.8bn/- during the third quarter of this year, from 478bn/- during the second quarter of this year due to increase of balance with Bank of Tanzania (BoT), sharp increase of balance with other banks and financial institutions, lending and investment in government debt instruments.

Balance with BoT increased to 34.6bn/- dur-The bank also managed to grow ing the third quarter of this year, compared to

30.6bn/- during the second quarter, while balance with other banks and financial institutions sharply increased to 25.1bn/- compared to 3.5bn/respectively.

Investments in government debt instruments slightly increased to 86.2bn/- during the third quarter of this year, compared to 85.7bn/- during the second quarter, while lending to various sectors of the economy grew to 275bn/- compared to 237bn/- respectively.

The bank also managed to mobilize customer deposits amounting to 270bn/- as at the end of the third quarter from 239bn/- during the second quarter, while special deposits amounted to 113.9bn/- in 03, 2023, higher than 83.3bn/- during the previous quarter.

The rate is lower that Ethiopia, where domestic consumption of coffee is more than 60 percent.

Prof Kamuzora further ex-

plained that, coffee is number one drink in the world after

"Tanzania is among the countries worldwide that produce high quality varieties of coffees, so, more efforts ids needed to promote its local market instead of depending on foreign markets," she said.

She appealed to Tanzanians to have a tendency of drinking coffee for a sustainable local market.

The Director General of TCB, Primus Kimaryo said that his board in collaboration with other coffee stakeholders is struggling to make

sure that Tanzania is increasing its production by producing high quality coffee that is suitable in both local and international markets.

"I'm happy that today, we have different coffee stakeholders in this Kahawa Festival event from Kagera region which produces almost a half of all coffees produced in the country," the TCB DG explained.

For his part, Moshi DC Kisari Makori applauded TCB for the good role they played by promoting coffee market, arguing more promotions of domestic consumption of cof-

"TCB and the Tanzania Coffee Research Institute (TaCRI) have done a very laudable work in the promotions of production of coffee, but more effort sin the promotion of local consumption of coffee consumption of coffee is highly needed," the Moshi DC further explained.

For his part, the Chairman of the Tanzania Coffee Association (TCA), Dennis Mahulu explained that, the Tanzania Coffee Board (TCB) in collaboration with crop stakeholders has formed a joint committee with a task

of organizing the best way to celebrate the event.

"The committee is composed of an individual from almost every actor in the coffee value chain. He added that, the Barista Competition has been organized specifically as a platform to advance the barista profession, recognize hundreds of baristas in the country and to encourage youth engagement in the Barista field," Mahulu explained.

"The competition will be conducted for three days during the festival and it will involve more than 40 contest-

The TCA Chairperson further explained that, apart from barista competitions indicated in the Kahawa Festival Program, Cupping Competition will be one of the organized activities.

According to him, this will be the third ever official cupping competition in the country whereby all the cuppers across the nation participated and demonstrate their ability, speed, and accuracy in identifying different coffees basing on cupping attributes such as Aroma, Acidity, Body, Aftertaste, and Flavor.

China's gold appetite will stay strong through 2023

next year.

CHINA'S appetite for gold will stay strong through the rest of 2023, the World Gold Council said, just as domestic prices for the safe-haven soared to a record amid the strongest investment demand in more than two years.

Demand for gold bars and coins in China rose 16 percent year-on-year in the third quarter and will "remain robust" in the final three months, the council said in its latest outlook. Economic and political uncertainties, currency volatility and central-bank stockpiling have all fueled a buying binge.

"The fragility of the domestic economic recovery, along with intensifying global geopolitical risk, could continue to support Chinese investors' safe-haven demand for gold," the producer-funded association said. The Shanghai Gold Exchange's benchmark contract rallied on Tuesday to its highest ever, heading for a near-7 percent gain in October.

China's demand has also been propelled by a patchy and uncertain economic recovery that's made other assets from property to stocks less attractive.

Data released yesterday showed the country's factory activity back in contraction for October, suggesting that the economy remains fragile.

Global gold prices last week jumped past \$2,000 an ounce for the first time since May amid growing concerns over conflict in the Middle East.

The precious metal, traditionally a harbor for money in times of turmoil, reached a record in mid-2020 when the Covid-19 pandemic was wreaking economic havoc world-

"Gold demand has been resilient throughout this year, performing well against the headwinds of high interest rates and a strong US dollar," the council said of the global market. "Looking forward, with geopolitical tensions on the

rise and an expectation for continued robust central bank buying, gold demand may surprise to the upside." Gold's allure in China will be boosted further if the People's Bank of China continues to build reserves in what's already one of its longest buying sprees, the report added. Still, it noted that a slightly later-than-usual Lunar New Year in 2024 might delay some demand into the first quarter of

Airtel Africa records 147m customers by Sept 2023

LAGOS

Airtel Africa's total customer base grew by 9.7 percent to 147.7 million by September this year, as the penetration of mobile data and mobile money services continued to rise. According to the company's results for half year ended 30th September 2023, data customers increased by 23.0 percent to 59.8 million while mobile money customers increased by 23.1 percent to 36.5 million.

Constant currency Average Revenue Per User (ARPU) grew by 9.8 percent was driven by increased usage across voice, data and mobile money, the results show.

Mobile money transactions value increased by 45.3 percent in constant currency, with Q2, 24 annualised transaction value of \$116bn in reported currency.

Olusegun Ogunsanya, Group chief executive officer states; "I am pleased to report a strong operating performance for the Group despite foreign exchange headwinds in many of our markets and specifically in Nigeria".

The CEO explained that the resilient growth in voice, data and mobile money usage levels reflects the inherent demand for these essential services across the company's footprint, and six-pillar 'win-with' strategy.

Whilst the changes are required for the long-term benefit of the Nigerian economy, the immediate impact of the naira devaluation continues to weigh on the company's reported financial performance in the period, he noted.

"Our focus remains to enhance long term value by continuing to drive sustained and efficient growth. Over the last five years we have delivered constant currency revenue and EBITDA CAGR of 17.1 percent and 20.7 percent respectively, allowing us to further de-risk the balance sheet and improve profitability across the Group," he said.

Looking forward, he said delivery of affordable and reliable telecom and mobile money services across the markets remains the key focus.

"Our strong operating performance continues to make

"Despite the challenges of rising diesel prices in Nigeria, we aim to limit the impact with continued operational leverage and further cost efficiencies to deliver an improved EBITDA margin in FY'24 versus FY'23.'

Revenue in constant currency grew by 19.7 percent, with reported currency revenues up by 2.3 percent to \$2,623m.

According to the result, in Q2'24, reported currency revenues declined by 4.7 percent, reflecting a full quarter's impact of the Nigerian naira devaluation in June 2023.

Across the Group mobile services revenue grew by 18.3 percent in constant currency, driven by voice revenue growth of 11.5 percent and data revenue growth of 28.1

Mobile money revenue grew by 30.9 percent in constant currency.

EBITDA increased by 21.2 percent in constant currency, and 3.7 percent in reported currency to \$1,302m, with an EBITDA margin of 49.6 percent, reflecting a 70bps margin improvement over the prior period despite inflationary cost pressures and foreign exchange headwinds.

Reported currency EBITDA declined by 3.3 percent in Q2'24 as the full impact of the Nigerian naira devaluation in June 2023 was incorporated.

Loss after tax was \$13m driven largely by a foreign exchange loss of \$471m recorded in finance cost before tax and \$317m after tax because of the devaluation of the Nigerian naira in June 2023.

Cheap loans dry up as **Hustler Fund budget cut**

THE Treasury has signalled a reduction in the disbursement of cheap State-backed mobile loans with a cut in the budget for the Hustler Fund by almost half to Sh5 billion in the latest budgetary changes.

This is from the Sh10 billion that the Treasury Cabinet Secretary, Njuguna Ndung'u, initially set aside for the Hustler Fund, officially known as the Financial Inclusion Fund, in June for 2023/24.

The Fund is designed in line with the Kenya Kwanza coalition's Bottom-Up election campaign promise of facilitating low-income earners and small businesses to access cheap

In the previous financial year ended June, the Hustler Fund, one of President William Ruto's campaign promises, was allocated Sh20 billion.

The budget cut came at a time Dr Ruto launched new product lines, including the Hustler Fund for groups which seek to provide cash mainly to informal traders who must register as a group to qualify for the loans.

"I think it is just in line with the austerity measures that the government is taking," said Elizabeth Nkukuu, the Acting CEO of the Hustler Fund, adding that the move might also have been taken to re-balance the portfolio.

John Mutua, a programme coordinator at the Institute of Economic Affairs, a think tank, reckons that the cut on the Fund, like many other items under development spending, is always a low-hanging fruit for a government tight on the fiscal space.

"For budget cuts, the first culprit is always development," said Mr Mutua, noting that such spending can always be deferred while recurrent spending like wages and debt repayments cannot wait.

The budget cut follows a turbulent period characterised by defaults of the micro-loans borrowed by individuals and small and medium enterprises under the Hustler Fund, a central plank of the government's Bottom-Up Economic Transformation Agenda (BETA).

With a default rate of 29 percent as of August, this is higher than those at commercial banks, saccos and microfinance banks, mirroring the headache mobile lenders face when advancing unsecured loans to the informal sector.

King Charles visits Kenya with colonialism's scars in focus

BRITAIN'S tarnished colonial past took centre stage in Kenya yesterday as King Charles began a four-day state visit, poised to acknowledge "painful aspects" of the countries' long shared history as local leaders press demands for reparations.

Accompanied by Queen Camilla on his first visit as monarch to a former colony, Charles arrived in the capital Nairobi overnight.

On a rainy morning, he was welcomed to the Presidential Palace by a 21-gun salute and a guard of honour and, accompanied by President William Ruto, planted trees in the palace grounds. The royal couple then laid a wreath at the Tomb of the Unknown Warrior in Uhuru Gardens, where Kenyan declared independence in December 1963.

Charles' visit comes at a time when former colonies are demanding that Britain do more to recognise the abuses of its colonial past. Some - notably Barbados and Jamaica - have been reevaluating their ties to the monarchy.

While still heir to the throne, Charles surprised many at last year's summit of the Commonwealth - a voluntary association of countries that evolved from the British Empire - by acknowledging slavery's role in the organisation's roots.

Many citizens of former British colonies - including leaders of Kenya's Nandi people - want Charles to go further by directly apologising and endorsing reparations for colonial-era abuses, including torture, killings and widespread expropriation of land, much of which remains in British hands.

Buckingham Palace said the visit would "acknowledge the more painful aspects of the UK and Kenya's shared history, including the Emergency (1952-1960). His Majesty will take time ... to deepen his understanding of the wrongs suffered in this period by the people of Kenya."

'AFTER APOLOGIES... REPARA-

During the 1952-1960 Mau Mau revolt in central Kenya, some 90,000 Kenyans were killed or maimed and 160,000 detained, the Kenya Human Rights Commission (KHRC) has esti-

The UK government has previously expressed regret for those abuses and agreed a 20 million pound (\$24 million) settlement in 2013.

Nandi King Koitalel Arap Samoei led a decade-long rebellion until he was assassinated by a British colonel in 1905. In the ensuing years, the British confiscated most of his people's land and cattle.

Samoei's great-grandson Kipchoge araap Chomu credited the British with contributions to Kenya like education and public health systems but said historical injustices must be rem-

"We have to demand public apology from the government of the British...,' he told Reuters. "After apologies, we also expect a reparation."

Charles also plans to meet entrepreneurs from Kenya's bustling tech scene, tour wildlife facilities and travel to the southeastern port city of

World Youth Development Forum opens in Beijing

THE World Youth Development Forum opened in Beijing on Monday. with 100 projects related to the global youth development action plan released.

US' attempts to undermine Russia's constitutional order doomed to fail – envoy

WASHINGTON

THE US' attempts to undermine Russia's constitutional order as well as its interethnic and interreligious accord are doomed to failure, Russian Ambassador to the US Anatoly Antonov said.

"We consider the bilious reaction of the Administration and local media to the incidents in Makhachkala as nothing other than an attempt to undermine the ethno-confessional unity of the Russian Federation.

Here, apparently, they were disappointed that the Russian law enforcement agencies were able to neutralize the risks of destabilization inspired from outside," the embassy press service quoted him as saying, commenting on events in Dagestan.

"It's time for Washington to cut its teeth: any attempts aimed at undermining the constitutional order in our country, as well as the interethnic and interreligious harmony that Russia has been for ages famous for, are doomed to failure," the envoy noted.

According to him, "local so-called strategists would do well to be concerned about the safety of their own citizens, who, among other things, are suffering from an epidemic of gun violence in the United States, including those motivated by racial hatred."

Earlier, Russian President Vladimir Putin said that the unrest in Dagestan had been instigated via social networks by Western intelligence. He added that the Kiev regime, guided by its Western handlers, was trying to ignite pogroms in Russia.

Several hundred people gathered at the Makhachkala airport in Russia's Dagestan Region on the evening of October 29 to protest against the Palestinian-Israeli conflict. They broke into the airport's building and landing area.

Africa sees renewed hope in malaria fight

NAIROBI

THE prevention and control of malaria in Africa is set to get a major boost from a new drug that is not only more effective, but also easier to administer than previous medicines, with the number of deaths attributed to the infectious disease expected to fall sharply as a result.

In case studies conducted in Kenya, second-generation artesunate for injection, developed by Chinese pharmaceutical company Fosun Pharma, has proved highly effective in treating severe malaria in children, Kenyan health experts said.

In addition, the new drug - produced under the brand name Argesun – can be easier and faster to prepare, and safer to inject, than its predecessor, which is produced under the name Artesun, and has been widely used in dozens of countries for more than 10 years.

Unlike Artesun, which requires a two-step reconstitution before use, Argesun only requires a one-step dilution before injection, which makes it more user-friendly for doctors and nurses and improves its accessibility. said Walter Otieno, a pediatrician and researcher with the Kenya Medical Research Institute.

"We think that this is a very good development. It is really going to cut our rate of deaths and also the complications caused by malaria," Otieno

In Kenya, the malaria transmission rate can be as high as 30 to 50 percent during the rainy season in some places near Lake Victoria, he said, adding that children under 5 face the highest risk of malaria in the country.

Through the use of the drug and other methods, including malaria vaccines and mosquito prevention and control, the transmission of malaria in Kenya is likely to be significantly reduced,

Argesun was pre-qualified by the World Health Organization in June and has been registered in 18 African countries, according to Fosun Pharma.

Both Artesun and Argesun are innovative antimalarial drugs based on artemisinin, which was discovered by Nobel laureate Tu Youyou in the 1970s, and which has made significant contributions to global malaria control and prevention during the past two decades.

Wu Yifang, chairman of Fosun Pharma, said the company recognized the strategic value of antimalarial drugs based on artemisinin and restructured its subsidiary Guilin Pharmaceutical in 2004, to start introducing the drugs to the global market. Its first antimalarial drug entered Africa in 2007, and the company launched a training program for frontline medical workers in Africa Ministry of Health, emphasized

"Through continuous innovation, Fosun Pharma has become a global leader in antimalarial drugs and one of the most influential Chinese brands in Africa," he said.

Malaria is prevalent in many African countries, and around 95 percent of all new malaria cases globally were reported in Africa, resulting in more than 600,000 deaths, according to the World Health Organization.

Taliban must immediately release women human rights defenders, say UN experts

UN experts yesterday demanded the immediate release of women human rights defenders Neda Parwan and Zholia Parsi, who have been detained by Afghanistan's de facto authorities for over a month.

The two human rights defenders are affiliated with the Women's Spontaneous Movement. Neda Parwan's husband and Zholia Parsi's adult son have also been placed in custody. No reasons have been provided for their

COP28 President says world must unite on climate action

ABU DHABI

SULTAN bin Ahmed Al Jaber, UAE's Minister of Industry and Advanced Technology and COP28 President, addressed a record number of ministers and delegations from around the world at the opening session of Pre-COP, declaring that the international community needs to unite on climate action and that "we have to come through. We must unite. We must act. And we must deliver in Dubai."

Pre-COP, which is being held from October 30-31 in Abu Dhabi, is a preparatory meeting of

ministers and negotiators ahead of COP28. This year's event has seen record attendance, with 70 ministers and over 100 delegations coming together in the UAE capital, more than double the normal number of participants for a Pre-COP.

Acknowledging that "there are too many things out there dividing our world at this moment," the COP28 President declared, "Now more than ever we need to unite on climate and deliver a clear message of hope, solidary, stability and prosperity. We need to show that the international community can deliver and send a clear signal that keeps 1.5 within reach."

Al Jaber pointed out that before the Paris Agreement, the world was heading for more than four degrees of warming but is now on course for warming of two to three degrees, according to the latest reports, "We are heading in the right direction, but nowhere near fast enough,"

Parties "must do better" in formulating agreements on issues

than they had done at previous conferences, Al Jaber stated. "We have no time to waste on disunity," he warned. "We must look beyond short-term thinking; we must end the excuses and delays, and redefine our self-interest as a common interest."

"Let this process prove that multilateralism still works. I believe we can fulfil our responsibility. I know that we must."

The COP28 President reiterated the need to deliver a robust response to the Global Stocktake and put the world back on track

on delivering the goals of the Paris Climate Agreement. He highlighted key areas of focus, including a strong mitigation outcome, a comprehensive adaptation agreement, and "groundbreaking solutions" on finance.

"That includes delivering on the fund and funding arrangements for loss and damage," he added. "What was promised in Sharm el Sheikh must be delivered in Dubai."

"We need solid solutions for a 43 per cent cut in emissions by 2030 because that is exactly

what the science tells us," Al Jaber said.

On the issue of fossil fuels, he said, "I know there are strong views about the idea of including language on fossil fuels and renewables in the negotiated text. I need you to work together to come forward with solutions that can achieve alignment, common ground and consensus between all parties. We must be responsible. We must be pragmatic. And we must leave no one

behind." Updating the meeting on pol-

icy, the COP28 President said, "More than 20 oil and gas companies have answered COP28's call to end methane emissions by 2030.

And I see positive momentum as more are joining. And we are engaging with all high-emitting sectors, like heavy transportation, aluminium, steel and cement, to lay out credible decarbonisation plans.'

On finance, Dr Al Jaber emphasised the importance of ensuring capital flows to where it is most needed, notably the Global South and of rebuilding trust in developing nations.

Large migrant caravan sets off for US from southern Mexico

MEXICO CITY

A large migrant caravan comprising many Central Americans and Venezuelans left southern Mexico on Monday for the United States, organizers and officials said, as Washington grapples with renewed pressure on its southern border.

Officials in the southern state of Chiapas said some 3,500 people set off on foot from the city of Tapachula near the Guatemalan border, while one of the caravan's organizers, Irineo Mujica, said there were around 5,000 in the group.

US President Joe Biden, who is seeking reelection next year, is under pressure to curb the number of people crossing illegally into the United States from Mexico.

Most of the latest caravan are from Cuba, El Salvador, Guatemala, Haiti, Honduras and Venezuela, according to Mujica.

Escorted by civil protection officials and ambulances, the migrants

were walking on a coastal highway around north of where they started. midday, planning to spend the night in the

Mujica said the migrants opted to leave municipality of Huehuetan, about 25 km Tapachula due to frustration about not

being able to obtain humanitarian visas. Some migrants even offered to help recovery efforts in the port of Acapulco, which was devastated by a hurricane last week, but did not get a response from the authorities, he added.

The government's National Migration Institute did not immediately reply to a request for comment.

Many migrants are fleeing poverty and political instability in their homelands, and this year has seen record numbers crossing the Darien Gap region connecting Panama and Colombia.

Millions of Venezuelans have left home due to the economic crisis plaguing the once-prosperous oil producing

"In Venezuela things are very tough, we can't live with the money we get, it's not enough for us, and that's why we're going to the United States," said Oscar Gutierrez, a Venezuelan migrant traveling with his wife and two daughters.

Tropical storm Pilar formed off Central America in the Pacific on Monday, and threatens to dump heavy rain on the region and parts of southern Mexico.

Israel-Hamas conflict: China calls for cessation of hostilities

A Chinese envoy on Monday called for an immediate cessation of hostilities in the Israeli-Palestinian conflict.

The UN General Assembly on Friday adopted by an overwhelming majority a resolution calling for an immediate and durable humanitarian truce, which has pointed in the right direction, said Zhang Jun, China's permanent representative to the United

China solemnly calls on the parties to the conflict to cease all hostilities, disengage immediately, put in place a humanitarian truce, and make every effort to prevent the situation from escalating further, he said

China solemnly calls on Israel, as the occupying power, to fulfill its obligations under international humanitarian law, lift its full siege on Gaza, immediately rescind its emergency evacuation order, and expeditiously restore the supply of basic necessities so as to prevent an even larger humanitarian disaster, the envoy added. China also calls for greater diplomatic efforts to facilitate the release of hostages without delay and to work on this basis to open up space for dialogue, so as to return to the track of a political settlement, he said.

Malawi's Climate Change Minister praises UAE's COP28 preparations

Minister Osei said that it is necessary to be open with each other to discuss the root causes of the challenges surrounding climate finance, with a focus on financing adaptation to climate change as the main issue. Achieving food security, energy transition instrumental to realise SDGs in Africa -UNECA **ADDIS ABABA**

THE United Nations Economic Commission for Africa (UN-ECA) said on Monday that achieving food security and energy transition is instrumental to realizing the Sustainable Development Goals (SDGs) in Africa.

The UNECA said in a statement that with the global economy still grappling with the repercussions of the COVID-19 pandemic and the effects of the Russia-Ukrain conflict on food and energy prices, achieving food security and energy transition is of paramount importance for African countries, particularly the North and West African regions.

According to the UNECA, the combined effects of the COV-ID-19 pandemic and the Russia-Ukrain conflict are increasing borrowing costs and debt service in Africa, which is further exacerbated by the disproportionate impact of climate change which costs African countries 2 to 9 percent of state

It said amid the cascading crises, the food and energy security in North and West Africa experienced major setbacks. Figures from the UNECA show that between 2019 and 2022, almost 25 million additional people suffered from undernourishment in both regions combined.

The UNECA made the call ahead of its upcoming meeting of the joint Intergovernmental Committee of Senior Officials and Experts (ICSOE) for North and West Africa, slated to be held on Nov. 1-3 in the Ghanian capital of Accra.

The joint meeting is expected to bring together representatives of 22 North and West African countries, along with representatives from regional economic communities from the two regions.

Gaza conflict key driver behind Türkiye's move to unblock Sweden's NATO accession

ANKARA

TÜRKIYE has unblocked Sweden's NATO accession protocol after more than a year of delays, a move that analysts say is driven by the ongoing Israeli-Palestinian conflict and Ankara's efforts to secure a fighter jet deal with the United States.

Turkish President Recep Tayyip Erdogan submitted the protocol to parliament for ratification on Oct. 23, with the parliament's foreign relations committee set to review it before a final vote at the Grand National Assembly, where Erdogan's ruling coalition has the majority.

In July, during a NATO summit in Vilnius, Lithuania, Erdogan was committed to presenting Sweden's NATO membership bid to the parliament, but no progress had been made until recently.

Sweden abandoned its long-standing policy of non-alignment and applied to join NATO last year following the Russia-Ukraine conflict. Türkiye and Hungary are the only NATO mem-

bers yet to ratify its accession. A source in parliament, who spoke on the condition of anonymity, told

Xinhua that the protocol could be voted on in 15 days "if everything goes according to plan," but warned of possible "complications" that could delay the ratification.

Analysts point out that the Gaza conflict is a significant factor in Erdogan's decision to push forward the ratification process, noting that the Turkish leader is trying to balance his support for Palestine, popular among his ruling party's base, with Western capitals' views of his government. "Erdogan is very keen on a mediator role in the conflict.

U.S. Secretary of State Antony Blinken skipped Ankara in his recent Middle East trips, and the U.S. has signaled its willingness to involve Türkiye in issues concerning Gaza only if Sweden's NATO entry is ratified," said Soner Cagaptay, an expert on Türkiye at the Washington Institute.

Serkan Demirtas, an Ankara-based analyst and journalist, also noted this decision to ratify Sweden's NATO accession can be seen as a way to balance relations with the West at a time when Erdogan is openly critical of Israel's military actions. Erdogan has repeatedly accused the West of failing

to stop the Israeli offensive in Gaza and criticized Israel's attacks on Gaza since the conflict broke out on Oct. 7. Erdogan also opposed the U.S. deployment of two aircraft carriers to the eastern Mediterranean and said the NATO ally has no role in the conflict.

The Turkish leader's public criticism of Israel and Western countries has found favor among many in Türkiye but has faced opposition from the Israeli government, setting the country apart from the positions of most NATO members.

Moreover, Türkiye also tries to link its request to buy 40 new F-16s from the U.S. with the advancement of Sweden's NATO membership.

Cagaptay said if the Biden administration requested to sell F-16s to Türkiye soon, the Turkish parliament would likely ratify Sweden's NATO membership quickly.

But he said it was unclear whether this would secure the 20-billion-dollar deal for the 40 new F-16s that Tür-

The situation is complicated by several key U.S. lawmakers who have raised concerns about authorizing the sale of fighter jets to Türkiye over issues unrelated to Sweden's NATO accession.

In addition to the NATO accession of Sweden and the Israel-Hamas conflict, Ankara and Washington face other challenges, particularly in Syria, where Türkiye considers Kurdish fighters, supported by the U.S. in the battle against the Islamic State, as terrorists. Tensions escalated on Oct. 5 when a U.S. F-16 downed a Turkish drone approaching U.S. forces in northern Syria.

FOOTBALL Kenya Federation Premier League giants, Gor Mahia, are on the brink of a groundbreaking sponsorship deal with a renowned kit manufacturer in East Africa, Tanzania's GSM Group.

This seismic shift comes as Gor Mahia's current partnership with Umbro, initiated in 2020 with a stipulated three-year term, nears its end.

"The deal will see GSM Group distribute replica jerseys throughout the country and kit our team gallantly. Hersi Said is the CEO of GSM Group and he's happy to be associated with the most successful club in the region, Gor Mahia FC," the official pointed out

GSM Group, a company that already outfits Tanzania's record champions, Yanga, has several other clubs in the Mainland Tanzania Premier League adorned with the firm's label.

In a similar deal inked with Yanga in September 2022, the sponsorship was valued at a staggering 10.9bn/- (Ksh 655 million).

Hersi Said, GSM Group's CEO, shed light on the specifics of the Yanga agreement, revealing it was divided into two parts.

"The contract, which is divided into two parts, involves the first contract for the production and distribution of jerseys as well as various club products, in which every year GSM Group will pay Yanga 1.5bn/- (Ksh 90 million), which will increase by 10% and make the total value 1.915bn/- (Ksh 541 million) within five years," Hersi revealed during the unveiling.

The agreements promise a substantial windfall for Yanga, with an estimated return of approximately 10.9bn/- (Ksh 655 million), a monumental blessing for the club that continues to strengthen its position in the football landscape. As the ink on this thrilling partnership which is now in its second season dries, football fans are eagerly awaiting the official financial details and the unique features of the collaboration that will shape the future of Gor Mahia.

Oliveira pointed out: "It is true that we have been conceding goals, which we are not happy about and it is not good for us, especially with the objective we have set for ourselves."

"Every day in training we have been working on it but these mistakes keep emerging. I have a new backline, a young goalie so we expect things like these at times."

"At the moment we have limited time before our next game, we will do our best to work on the defensive area to ensure that those mistakes are reduced," Oliveira revealed. "I label them as minimal mistakes made by the players,

credits where it's due, they have been doing a great job to make sure we are safe," Oliveira noted. The Brazilian insisted: "I think it's not the time to blame

them because they have been more productive on our ball progression."

Simba SC has converted 16 goals from six NBC Premier League games while allowing five goals, and their rival has conceded four goals in the process.

Messi not thinking about long-term future after claiming eighth Ballon d'Or

LIONEL Messi said Monday he was not thinking about his long-term future as he sought to enjoy winning the eighth Ballon d'Or of his storied

Messi, 36, succeeded Karim Benzema as winner of the prize, awarded on the back of his performances last season, when he inspired Argentina to glory at the World Cup in Qatar.

"The last one I won was also thanks to what we achieved with the Argentine national team in the Copa America (in 2021), but this one is much more special because it comes after we won the World Cup," Messi told various media including AFP after collecting his award at a ceremony in Paris.

"That is the trophy everyone wants to win the most, and it was a dream come true for me, my teammates and my country."

He dragged Argentina to a victory in Qatar that crowned his remarkable career and allowed him to see off stiff competition for the Ballon d'Or from Kylian Mbappe and Erling Haaland in particular.

Haaland came second in the final voting, with Mbappe third and Kevin De Bruyne in fourth place.

Former Barcelona superstar Messi scored seven times at the

World Cup and was named the tournament's best player after Argentina beat France on penalties in the final

Yet Messi, who won his first Ballon d'Or in 2009, also had an underwhelming final season at Paris Saint-Germain, before leaving to play for Inter Miami in Major League Soccer.

He played down suggestions he could come back for another Ballon d'Or, possibly after the next World Cup in 2026, when he will be 39.

"I am not thinking about the longterm future. I am just enjoying the day to day at the moment," he said.

"We have a Copa America coming up in the United States, where I am now, in which we are the holders, so I am looking forward to coming into that in good shape and then just see how I am getting on from there."

Messi admitted on his return to the French capital that his two-year stint at PSG had not turned out the way he imagined upon signing from Barcelona in 2021.

"Things didn't turn out as I hoped but I enjoyed the city a lot, and my kids liked it a lot and found it hard to

"It is a spectacular city and I was lucky to live here. Football-wise it did not go the way I hoped but I prefer to remember the many good things."

Messi wins eighth Ballon d'Or as Bonmati claims women's award

LIONEL Messi won the eighth Ballon d'Or of his remarkable career at a glittering ceremony in Paris on Monday, while Spain's World Cup-winning star Aitana Bonmati took the women's prize.

For Messi, the trophy rewards, above all else, his inspirational performances at last year's World Cup in Qatar, when he dragged Argentina to victory, scoring seven goals and being named the tournament's best player.

It was the crowning moment of his astonishing career, and it allowed him to see off stiff competition, in particular from Erling Haaland and Kylian Mbappe, to take the award on the stage of the Chatelet Theatre in Paris.

It was a return to the French capital after his departure from Paris Saint-Germain in June and his subsequent move to Inter Miami in Major League Soccer.

"This is a gift to the whole Argentina team for what we achieved." said Messi on stage after receiving his award from David Beckham, the co-owner of Inter Miami.

Messi dedicated the trophy to late Argentina legend Diego Maradona, who would have celebrated his 63rd birthday on Monday.

"Happy birthday Diego. This is for you too," he said.

Messi benefits from a recent change which means the award is based on a player's record over the last season, rather than over the calendar year.

He won despite an underwhelming final season at PSG, even if he was a Ligue 1 title winner.

Putellas had won the Ballon d'Or in each of the previous two campaigns. Norway's Ada Hegerberg won the inaugural award in 2018 and USA star Megan Rapinoe succeeded her a year later.

Bellingham won the Kopa Trophy for the best player of last season aged under 21.

The 20-year-old has started his Madrid career with 13 goals in 13 games, although the prize rewards his performances in his final campaign with Borussia Dortmund.

Bellingham's Madrid teammate, the Brazil forward Vinicius Junior, won the Socrates prize in recognition of his off-pitch work.

French football under microscope after Lyon team bus attack

PARIS

FRENCH football clubs on Monday came under intense pressure to bring their supporters under control after Lyon coach Fabio Grosso suffered cuts to his face when his team's bus was pelted with stones near Marseille's stadium.

Sunday's Ligue 1 match between Marseille and Lyon was postponed after the attack on the bus on its way to the Velodrome.

Grosso's face was left bloodied and his assistant Raffaele Longo was also injured. A club source said Grosso had also been experiencing dizzy

TV pictures showed Grosso with a bandage on his head as he emerged from the stadium's medical room. A photo circulating on X, formerly known as Twitter, appeared to

show Grosso lying on a stretcher with a cut above his left eye. The match was postponed at Lyon's request despite even though the

stadium was already half full. It was the latest incident in an already trouble-scarred season in

Sports Minister Amelie Oudea-Castera said the incidents were "unac-

ceptable" and called on the clubs to take firm and swift action. "If it is proved that supporters were involved... then clubs cannot re-

main on the sidelines of that," she told France 2 television. "All the authorities in sport must be made responsible," she added.

Interior Minister Gerald Darmanin said nine people had been arrested as a result of the incidents.

He said 500 officers had been on duty for the match between two of French football's best-supported clubs and so "there was no fault" on the part of the police.

"It is up to the club to manage its supporters," he said.

As the incidents took place outside the stadium, the clubs are not, in

The French league's director general Arnaud Rouger said: "This is not our responsibility, but as with any incident we stand side by side with the government and I fully support the words of Gerald Darmanin who has called for a stronger penalties for the perpetrators of these particularly serious incidents.'

In a related incident, Lyon fans were said to have aimed racist chants at their Marseille counterparts on the approach to the stadium, which could be punishable under the French league's rules.

The alleged taunts lead the Marseille public prosecutor to announce on Monday he was opening an investigation into "incitement to racial hatred and racial insults", offences punishable by up to five years in

"Some of the Lyon supporters made a number of Nazi salutes and made monkey noises at the Marseille supporters," public prosecutor Nicolas Bessone told a press conference.

Marseille club president Pablo Longoria said he was disgusted by the attack on the Lyon bus.

"These are completely unacceptable circumstances," he said. "My first thought is for Fabio Grosso, someone I respect and have known for a long time. I went to see him as soon as I arrived at the stadium, I saw how he was."

The timing of the incidents is highly damaging for French football authorities who are trying to negotiate a new deal TV rights deal.

Earlier this month, a match between Montpellier and Clermont was abandoned after a firecracker was thrown on the pitch and four men were arrested for attacking the Rodez goalkeeper at a Ligue 2 game in Bordeaux.

The French league also took action against Paris Saint-Germain for homophobic chants by their supporters in the home match against Marseille on September 24.

Last season, Nice were docked a point after their home game against Marseille was abandoned because of fan violence, there was a pitch invasion when Lille visited Lens and battles in the stands when Marseille visited Angers.

In January, Paris FC and Lyon were both thrown out of the French Cup after violence forced their tie to be called off at half-time.

With global stars Lionel Messi and Neymar having left Paris Saint-Germain, the images of a bloodied Grosso and a postponed match as a result of supporters' violence will do little for the game's marketability in France, where the league is aiming to drive the rights sale up beyond one billion euros (\$1.06 billion).

Kidnapping of footballer's father in Colombia: What we know

A MASSIVE search is under way for Liverpool winger Luis Diaz's father, kidnapped in Colombia Saturday along with his wife, who has since been released.

Police have been tightlipped about details of the investigation, but here is what we know:

*- The kidnapping -

Colombian media has reported that Luis Manuel Diaz and Cilenis Marulanda were kidnapped Saturday by armed men with motorcycles at a gas station in the Indigenous family's home town of Barrancas, near the border with Venezuela.

Footage from a security camera, the location of which AFP has verified, showed a high-end pickup truck in the vicinity, followed by a motorbike.

Hours after the kidnapping, President Gustavo Petro said the footballer's mother had been rescued, but her husband was still unaccounted for.

The search involves at least 200 police, soldiers, commando members, cartographers, judicial police and pilots of special search and rescue aircraft.

At a press conference Sunday, Attorney General Francisco Barbosa said the missing man "could be" in Venezuela, without providing further details.

*- The investigation -

Police chief General William Salamanca said Monday his officers were doing a sweep "house by house," collecting information. Police have offered a reward

equivalent to \$48,000 leading to information on Diaz's whereabouts. "We have information on people

who may have been linked to the event. There was planning," deputy police director General Nicolas Zapata told reporters.

Colonel Giovanni Montanez, director of the elite military unit against kidnapping and extortion, told Blu Radio that "so far no demands have been made... no calls have been received" for ransom.

Colombia is coordinating the search in collaboration with the Interpol office in Venezuela, said Salamanca.

Barrancas with its 38,000 inhabitants is in a northern part of Colombia where criminal groups as well as rightwing paramilitary fighters, dissidents of the now-defunct FARC armed group and ELN guerrillas, are known to operate.

After being rescued, Diaz's mother could not reveal "anything in particular" about her captors, said Montanez.

In six decades of civil conflict, Colombia has registered some 38,000 kidnappings, mainly by armed groups funding their operations through ran-

The senior Diaz used to be an amateur coach at the only football school in Barrancas, where his son showed promise from a very young age. He is credited with aiding the meteoric rise of the Liverpool and Colom-

bia striker known as "Lucho" -- the first Indigenous Colombian to make it to world football's top echelons. In his hometown, resident Leon-

ardo Diaz, 41 (no relation), told AFP he was "sad and dismayed" by the kidnapping of a man he described as "a humble person of the people."

The younger Diaz has played for his country 43 times and arrived at Liverpool last year from Portuguese club Porto.

He has played 11 games with Liverpool and scored three goals.

After seven matches in the books, the visitors from Chamazi find themselves sitting third in the table- five points behind leaders Young Africans SC, alias Yanga, and second-placed Simba SC.

It might be early into the season, but the NC Premier League title race is unforgiving, and there is no room for complacency.

The last week has been disastrous for Azam FC's technical bench led by head coach Youssouph Dabo.

With consecutive losses, the most recent being a defeat at the hands of Namungo FC, pressure is mounting, and a strong performance against Mashujaa FC is not just desired- it is essential.

Senegalese coach Dabo will be aware that his team's defensive deficiencies cannot continue if they are to challenge Simba SC and Yanga this term, and they have now conceded three goals in each of their last two league matches.

With diminished confidence, starts could therefore be handed to fringe players such as forward Ayoub Lyanga, fullback Nathaniel Chilambo, backup goalkeeper Ali Ahamada, and winger Kipre Junior.

Despite Azam FC's recent slump, the outfit is still the third-highest scorer in the division, having netted 13 goals in seven outings (1.9 goals per game).

Midfielder Feisal Salum, striker Prince Dube, and winger Iddy Selemani have been their go-to men for goals this season.

Meanwhile, Mashujaa FC suffered a 2-0 defeat to Coastal Union in Tanga last time out, conceding 16 shots while failing to keep the home attack at bay.

The Kigoma club has now managed to win just one of the outfit's previous five league encounters, recording two draws and two losses in the process.

In terms of the bigger picture, Mashujaa FC, coached by Mohamed Abdallah 'Baresi', has taken eight points from a possible 21 this term, leaving the club in the bottom half of the table and only two points clear of the relegation zone.

With a measly four goals to their name, Mashujaa FC has scored the fewest NBC Premier League goals this season.

They have not found the back of the net in their past three games. That said, they possess the best defensive records in the division, as no other side has conceded fewer goals in 2023-24 than the three they have let in.

Far more positive for Baresi is that Mashujaa FC is unbeaten in the club's three home games, with 2-0 wins against Kagera Sugar and Ihefu SC and a 0-0 draw with Geita Gold FC.

In head-to-head records, this is the firstever competitive meeting between Azam FC and Mashujaa FC.

Coastal Union, Namungo FC aim for consistency

COASTAL Union will be looking to make it two wins in a row in the NBC Premier League when they host Namungo FC at Mkwakwani Stadium in Tanga this evening, with kick-off slated for 7 p.m.

The tie will see Coastal Union once again battle to push away from the Premier League's relegation zone.

Both teams have been struggling to perform well so far in the season. They have amassed six points apiece and are only separated by goal difference in the bottom half of the standings.

Coastal Union claimed a 2-0 victory over Mashujaa FC last week, courtesy of goals netted by Khamis Bakari and Lucas Kikoti. It was their first win of the season having played seven matches.

'Wagosi wa Kaya', as Coastal Union is affectionately known, is occupying the second bottom spot in the NBC Premier League standings.

The squad is a point behind 12thplaced Tanzania Prisons and stands to move away from the relegation zone with a win over Namungo FC.

The early struggles have pushed out the Tanga squad's head coach Mwinyi Zahera. This will be the club's first assignment without the former head coach as Fikirini Mahiza takes over from the Congolese gaffer. Interim head coach Mahiza has

taken encouragement from their last performance and acknowledges the difference against most of the teams they have faced came down to a lack of goals. As much as changes are to be ex-

pected, goalkeeper Ley Matampi is one player who should keep his number. The veteran Congolese goalkeeper was outstanding in the most

recent clashes against Ihefu SC and Mashujaa FC, keeping his back-toback clean sheets. Coastal Union's goal came under siege and Matampi was the differ-

ence between one point and none

against Ihefu SC as he pulled off a string of fine saves to keep the latter, alias 'Mbogo Maji', at bay. There are no suspension concerns and the Tanga-based side is yet to report any injuries coming

into this encounter. Taking charge of his first official game, it would not be a surprise to see Mahiza make a few alterations to the squad that started against

Mashujaa FC. Meanwhile, Namungo breathed a sigh of relief when they defeated Azam FC 3-1 in their last game, snapping a six-match winless

Following a tough start to the season under Burundian gaffer Cedric Kaze, in which they went six games without victory, Namungo FC, popularly known as 'Southern Killers', turned to their former coach Dennis Kitambi to take over.

After thumping Azam FC on Saturday, Kitambi will be targeting to inspire victory in his first two league games at the helm.

In head-to-head records, this will be the ninth league meeting since 2020/21. Namungo FC has been more successful historically with three wins, three draws, and just two losses in the last eight league clashes against Coastal Union.

The Lindi-based squad picked a draw when the outfit last visited Mkwakwani Stadium in January this
