scholarships for teachers

FRANCE has announced two separate language scholarship programmes for Tanzanians beginning next financial year for teachers and diplomats, aimed at fostering the penetration of the language in the country. Frederic Clavier, the ambassador of France to Tanzania, made this announcement at the launch of celebrations to mark 'La Francophonie 2021,' a cultural festival of French speaking countries and communities around the world, to be marked from March 17 to end of the month. He said the first programme will run for three years, from the 2021/22 financial year onwards, to train primary and secondary school teachers in various colleges.

"We intend to train 300 teachers both in French and teaching skills so that they can be utilized to train other teachers in the districts where they will be deployed," he

"After that, the programme will run for another seven years to bring the total time to 10 years," the envoy noted.

France will similarly work with ministries handling education and foreign affairs respectively to pick potential diplomats for training in various French-speaking countries with missions in Tanzania. About 20 to 30 diplomats will be picked per annum, he declared. The scholarships are being coorganised by six diplomatic missions, namely the embassies of France, Belgium, Canada, Morocco,

Switzerland and Vietnam.

"As of today, approximately 1.5 million Tanzanians are proficient in French, the only foreign language other than English to be offered as an option throughout the school curriculum, he stated; In Kigoma region, Francophones account for about six percent of the population, while the national average is two percent, he said, underlining that there is need to deploy new initiatives to fasten penetration of French literacy. Worldwide, around 59 percent of French language speakers live in Africa, with the number expected to rise to 80 percent by 2050, the envoy affirmed, noting further

Govt extends 3.6bn/- to special school

THE first secondary school with friendly infrastructure and equipment for ablebodied and disabled students has opened its doors after the government pumped 3.6bn/into its construction.

Constructed under the Education Programme for Results (EP4R) across two years, Patandi Secondary School has admitted 143 form one students this year; with 93 being a special needs selection.

Gerald Mweli, the Deputy Permanent Secretary in the President's Office (Regional Administration and Local Governments), said the school is unique since it offers

comfort to able-bodied and learners living with various forms of disabilities.

"We admitted the special needs students from all over the country and so far so good," she said.

The school has capacity to admit 600

Minister warns transporters on contracts for long-route drivers

FAILURE to provide formal contracts for bus and lorry drivers on long routes risks to bring unrest and mar the country's economic activities, the government has stated.

The Minister of State in the Prime Minister's Office (Policy, Parliamentary Affairs, Labour, Youth, Employment and Disabled), Jenista Mhagama registered these fears at a consultative meeting on the various challenges facing long route drivers, bringing together stakeholders in the transport sector

We have been taking a number of measures to improve drivers' working conditions, but most of them still work without formal contracts

and the Registrar of Trade Unions.

She said that the government was concerned that the transport sector, as one of the crucial areas in the country's economy; needs to ensure it operates in accordance with the laws, especially the Tanzania Employment and Labour Relations Act of 2004.

She said that any situation of unrest in the transportation sector would affect economic growth as drivers carry cargo as well



as passengers.

"We have been taking a number of measures to improve drivers' working conditions, but most of them still work without formal contracts," the minister noted, directing the regulatory authorities to convene a meeting with bus and lorry owners to seek a consensus on drivers' contracts.

Such agreement needs to be reached during the meeting and be the framework of punishing any transporters violating the set regulations, the minister underlined.

"We only need to know who is delaying the formalization of drivers' jobs so that we can take appropriate legal measures against them. Employers should adhere to the set operational standards, regulations, laws and international conventions," she specified.

The minister directed employers to stop barring workers from introducing workers' unions at work places,, noting that the unions are vital bridges between employers and employees.

Employers must build a culture of meeting workers regularly to discuss various issues related to their daily operations, she said, affirming that the move would reduce conflicts at work places.

"We need to ensure smooth operation in each of the sectors to maintain the country's growth pace. The government is determined to maintain the middle-income status and facilitate further growth," she told the gathering.

Pendo Berege, the Deputy Registrar of Trade Unions at the ministry, said the meeting was meant to discuss various challenges facing transporters and drivers.

A reporter who arrived at the Mbeya terminal at 06:15 departure time saw buses plying other routes were leaving but.those plying Mbeya-Iringa-Dodoma-Singida and Mbeya-Shinyanga-Mwanza routes were nowhere to be

Juma Mohamed, the manager of Isamilo, one of the bus operators, said he grounded tools after receiving a phone call from his bosses directing him to do just that.

"The bone of contention is electronic ticketing which the government wants us to use; we will be waiting for guidance from our bosses on the way forward," he elaborated.

Ndamo Jidaha, a Lake Zonebound stranded passenger from Chunya district was among those who were left with no option but to wait at the terminal.

The passenger said that would-be travellers passengers were told that would be put on Isamilo bus but when they went to the Isamilo office, they found it locked and no passengers were allowed

to enter.

LATRA launched e-ticketing last week, requiring bus operators to use Point of Sale (PoS) machines in paying fares and passengers with smart phones purchase tickets electronically.

Aday after its launch TABO-RA members held a meeting which resolved that members ground their vehicles if issues they raised with regard to eticketing are not addressed.

TABOA leaders are particularly irate with PoS machines which require them to deposit some amount of money into its functioning, saying the system works to their disadvan-

"The instant chemistry between students and teachers is amazing; they eat and play together as if they

have been living together for years," the headmistress enthused.

The United Nations Educational, Scientific and Cultural Organization (Unesco) says inclusive education is the most effective way to give all children a fair chance to go to school, learn and develop the skills they need to thrive.

"It means all children in the same classrooms, in the same schools. It creates real learning opportunities for groups who have traditionally been excluded - not only children with disabilities, but speakers of minority languages too," it affirms in a recent report..

"Nearly 50 per cent of

children with disabilities are not in school, compared to 13 per cent of their peers without disabilities. Robbed of their right to learn, children with disabilities are often denied the chance to take part in community activities, in the workforce or contribute to decisions that mostly affect them," the agency elaborates.

An estimated 93 million children worldwide live with disabilities. "Like all children, children with disabilities have ambitions and dreams for their future. Like all children, they need quality education to develop their skills and realize their full potential," the report underlined.

The French embassy affirms that French is the fifth most spoken language in the world. with over 300 million speakers worldwide, expected to climb by 100 million by 2070 with most speakers being Africans. It is an official language in 32 countries and features in most international organizations, including the African Union, SADC and several other regional bodies.

French is a language of learning for more than 132 million people in 36 countries and the fourth principalo language used on the internet. It is the second international language most used in the media, the third most important business language and the second most used language in interactive activities in international institutions.

480 pupils sit on the floor due to shortage of desks

UVINZA special education primary school in Uvinza District, Kigoma Region is facing a shortage of desks, teachers and poor infrastructure affecting pupil's academic performance.

The schools infrastructure including classrooms dormitories are in bad condition forcing pupils to share beds and sit on the floor during learning

The school's head teacher, Goma Kamani said this when briefing Education, Science and Technology Minister, Prof Joyce Ndalichako who visited the school yesterday. He said the school has a total of 480 pupils, among them, 197 are

According to Kamani, the school has six teachers who teach special education adding the actual

demand is 20 teachers. "We need more teachers for special education; we are facing a shortage of desks, this affects pupils' performance academically because they do sit on the floor during learning sessions," he added noting the dormitories are in bad condition with a limited number of beds.

The head teacher informed that construction of two dormitories has stopped over lack of funds. He said they had earlier received 150m/- form the Tanzania Education Authority (TEA) as well as 12m/- form the office of the district director in Uvinza, but they structures have not been

He called upon the government to continue supporting the schools effort to improve infrastructures as well as learning facilities.

One of the teachers, Bahatisha Bisongwa said: "The standard teacher-pupil ratio for mentally challenged children is 1:5, but a single class at the school accommodates a big number of pupils, and most of sit on the floor."

Minister for Education, Science and Technology, Prof Joyce Ndalichako said the school should be given priority and ensure it receives all the needed equipment. She said the district director must prioritize funding for the school's infrastructure improvement.

"The district authority should invest at the school to ensure pupils do better in the final examinations," said Minister Ndalichako.

He instructed the director to find solution to the challenges facing the school including the shortage of desks as well as construction of dormitories. He directed authorities to immediately disburse the 15m/- required for completion of the dormitories project.

treatment from abroad from 164 patients in 2014/15 to 5 ion 2019/20.

Dr Mwaeselage said the new infrastructures and equipment enabled the government to save 10.4bn/by not referring 206 cancer patients abroad, while patients from neighbouring countries who came for treatment at the institute increased from 12 in 2014/15 to 73 in 2019/20 increasing thereby government revenues.

Submitting his report for Muhimbili Orthopedic Institute (MOI), Dr Onaji Vivian said in the period of for years the institute conducted 43,200 specialized surgeries that cost 16.5bn/- in local currency and if they had been referred abroad the cost would have reached 54.9bn, thereby saving the government 38.4bn/-.

government has provided 7.9bn/- for the construction of a modern Angio-Suite vascular surgery.

Iringa Region residents laud govt for completion of water projects

RESIDENTS in various localities within Iringa District in Iringa Region have commended the government for successful construction of various water projects.

The villagers claimed that they were previously forced to walk for long distances in search of the precious liquid.

Speaking during a visit by CCM regional political committee, the residents said they have been experiencing woes for many years, the situation which contributed to the outbreak of waterborne diseases including cholera.

Barika Issa, a resident of Izazi village in the district thanked the government through the Rural Water and Sanitation (RUWASA) Agency completing a water project, thus they are now accessing clean and safe water.

She said: "We spending hours in search of water; some of our girls could not go to school to help their parents to fetch water."

Tumaini Mpogola said that they were drinking water from unsafe sources and sometimes sharing it with animals including cattle, goats and donkeys.

Richard Luhala, Chairman of Mfyome village in Kiwere ward, thanked the government for completing renovation of a water project in their village.

He said they can now access clean and safe water throughout the day. He said the project had stopped functioning since 2010. He said previously, the villagers $were\,buying\,a\,20\,litres\,bucket$

of water at 1,000/-. Iringa regional political committee chaired by CCM regional chairman Dr Abel Nyamahanaga visited the villages to inspect implementation of various projects as per the 2020-2025 CCM election manifesto.

RUWASA Manager in Iringa District, Eng Masoud Samila said that 96 percent of Izazi villages have access to clean and safe water. He said they are working to complete the remaining four percent.

He said construction of the Izazi-Mnadani water project started in December 2014 through the Water Sector Development Programme (WSDP) and the Water and Sanitation Sub-Programme (RWSSP).

Engineer Samila added that the Pawaga-Mlenge water project implemented through WSDP and WSSP will benefit about 30,258 government residents from Ilolompya, Mboliboli, Itunundi, and

Mlenge wards. He said the agency is also repairing water projects at Mfyome village in Kiwere ward. RUWASA manager in Iringa Region, Eng Joyce Bahati said that many water projects have been inherited from the council after the establishment of the agency.

The ruling party's chairman in the region, Dr Abel Nyamahanga called upon water users to protect the projects since they have been implemented by the

government at higher costs. "The government spent billions of money to ensure you have access to clean water. Let us protect the projects so that they last longer and benefit many people," he said.



GIZ, GIAE and IITA target job creation and increase in productivity of maize, cassava in Nigeria

LAGOS

THE Green Innovation Centers for the Agriculture and Food Sector Program (GIAE) - Nigeria funded by the Federal Ministry for Economic Cooperation and Development (BMZ) implemented by German International Cooperation (GIZ) have launched an eighteen months project to boost maize and cassava production and create job opportunities for youth and women in the value chains.

The new project will be implemented by the International Institute of Tropical Agriculture (IITA) in the four selected states, Kano, Kaduna for maize, and Oyo, Ogun state for cassava value chain.

The project will build capacities of smallholder farmers on productivity and farm safety technologies. And create job opportunities for women and youths through the establishment of commercial seed enterprises for retailing of disease-free improved stems, marketing of aflasafe and purdue improved crop storage (PICS) bags an improved agricultural storage bag.

According to the Project Manager, Godwin Atser, the grant addresses three major activity areas which are: (I) integrated pest management (IPM) with a special focus on tackling the presence of the invasive arthropod pest, Fall Army Worm (FAW); (II) aflatoxin and food safety with special focus on training of female maize growers, household caregivers and other actors on food safety and pre-/post-harvest management; and (III) building a cassava seed system where farmers will be involved in the production and sale of quality cassava stems to generate additional income."

"The geographic coverage of the maize value chain is Kaduna and Kano; and for the cassava value chain is Ogun and Oyo," he added.

The grant will also increase the capacity of farmers and extension agents in modern maize and cassava production using digitalized solutions on good agricultural practices (GAP), Six Steps to Cassava Weed Management and Best Planting Practices, and other IITA digital tools like the herbicide calculator, AKILIMO, Seed Tracker, and cassava e-market.

Sanne Chipeta, Head of Project, Green Innovation Center for the Agriculture and Food Sector-Nigeria, GIZ noted that the collaboration with IITA will help to further improve productivity and food safety in the value chains, contributing to food and nutritional security. In addition, the individual activities will help to create new employment and livelihood opportunities, especially for young men and women. She expressed optimism that the collaboration with IITA would overall add value and create positive results in the maize and cassava

Adoption of fingerling production technologies transforms livelihoods in Kenya

NAIROBI

Zinath Deen, a fish farmer from Vihiga County in Western Kenya. She has been practicing fish farming since 2012 in her farm called Tigoi Fish Farm. What began as a hobby for her later transformed into full-fledged business.

Over the years, Zinath has been struggling to produce fingerlings due to inadequate information and technology. She however experienced a turnaround upon her participation in a training on production of tilapia fingerlings.

Organized by the Aquacultural Association of Kenya in collaboration with the Aquaculture Compact (TAC) of Technologies for African Agricultural Transformation (TAAT), Zinath's eyes practically opened to a world of opportunities through best practices in fish farming.

"I realized that I was doing the production of fingerlings the wrong way and resolved to do things the right way henceforth," Zinath said.

Sponsored by the African Development Bank as part of its Feed Africa Initiative, TAAT's main objective is to improve the business of agriculture across Africa by raising agricultural productivity, mitigating risks and promoting diversification and processing in 18 agricultural value chains within eight priority intervention

The programme increases agricultural productivity through the deployment of proven and high-performance agricultural technologies at scale along selected nine commodity compacts which include aquaculture.

The bank, through the TAAT Aquaculture Compact (TAC) disseminates aquaculture technologies at scale by increasing aquaculture value chain actors' productivity, increasing fish protein consumption and enhancing sustainability across the value chain.

Led by the WorldFish Centre, TAC responds to emerging opportunities for partnerships, influence and impact in fisheries and aquaculture across Africa.

Through its collaboration with the Kenyan Aquacultural Association, the compact was able to train fish farmers and breeders including Zinath on several technologies which included production of fingerlings in hapas, smoking of catfish in modern smoking kiln, value addition and production of affordable fish feed using locally available ingredients. Women and youth were the prime targets of the training with a view

to creating jobs while assuring food security. Following the training in 2019, Zinath and her fellow fish farmers, by the fourth quarter of 2020, were able to increase their production tenfold. Their annual production increased from 120,000 to 360,000 mono sex tilapia. Annual income also increased from \$16,649 to \$49,440.

With increased income through her fish farm production, Zinath was able to increase her number of employees from 2 to 5. She was also able to transfer the technology to 38 farmers who participated in the training sessions she organised in her farm.

Zinath's experience as well as that of her colleagues, further accentuates the fact that with right technology, fish farmers are able to graduate from subsistence to commercial producers of fish hence improving their livelihoods through increased income.

The TAC team will therefore continue on this trajectory of disseminating technology to more farmers so as to integrate it with the other methods of fingerling production.

International Women's Day 2021: A post-COVID world needs amplified women's voices in politics, climate change

he following opinion piece is part of series to mark the upcoming International Women's Day, March 8.

The UN says young women remain particularly underrepresented in politics and disproportionately excluded from consultation on issues that affect them such as climate change. This IPS International Women's Day article features 2 young Saint Lucian women; one in her first year as a senator and the other, a champion for sustainable living and environmental pro-

The theme for International Women's Day 2021, 'Women in Leadership: Achieving an Equal Future in the COVID-19 World,' is grounded in the reality that this women's day is unlike any other.

It is being observed against the devastating health, social and economic impacts of the pandemic. As vaccination campaigns bring hope for recovery, United Nations Women says that shift must include women 'at every table where decisions are being made." "Women's full and effective participation and leadership in all areas of life drives progress for everyone. Yet, women are still underrepresented in public life and decision-making," the agency said.

According to the most recent UN Economic and Social Council's Commission on the Status of Women, progress towards gender parity in public life and decisionmaking has been too slow. The report encourages countries to remove the barriers that prevent women from entering public life, to help tackle the COVID-19 and climate change crises.

It also calls for urgent action to facilitate women in the 'political pipeline,' noting

that young women are particularly underrepresented in politics. IPS spoke to Lisa Jawahir, a young communications professional who was appointed by the Saint Lucia Labour Party to the Senate in August 2020, about her experience, goals and vision for women in politics.

"The reality is that in Saint Lucia, young women in leadership, particularly political positions are very rare. While we had a young woman run for political office at the age of 21 in 1997, since then, there hasn't been a bold step by administrations to have young women serve at the highest order of the land. For me, at the age of 31, being appointed as the youngest Parliamentarian in the House of Assembly means that women and young girls can believe again that anything is possible," Jawahir told IPS.

UN Women says while women have been influential in political decision-making, they often face push-back, both online and offline. It is something that Jawahir says she has experienced.

"I once participated in a political forum, representing young women interested in politics. In an interview with a print journalist. I shared my desire to run for political office and the article made the cover page. While this felt like a remarkable step in the right direction, a few days later, I lost my biggest client who shared concerns that I was now politically affiliated.

"Unfortunately, in my country, victimisation based on political affiliation is rampant, especially for women. It's become a challenge to operate my small business, but I'm driven by the desire that one day I will be in a position on the governing side, to ensure that no young person, woman or vulnerable group will be unjustly treated due to their political interests," she told IPS. Voices like Jawahir's, according to UN Women, must be multiplied and amplified. As the world pivots to pandemic recovery, the agency says women and girls will be key leaders and change agents, particularly in areas like climate change mitigation and adaptation.

Saint Lucia's Snaliah Mahal is a recognised personality in sustainable living, environmental protection and climate change education. As an undergraduate student in Mexico, she interned with the UN Information Centre and volunteered in relief efforts post-flooding in Mexico and following the 2010 earthquake in Haiti. She completed a post-graduate degree in Climate Change and International Development and volunteers with the Caribbean Youth Environment Network. She also runs 7K's, a small business that produces zero waste and eco-friendly home and personal care products.

"I believe that citizens from Small Island Developing States, because of their inherent disadvantages and vulnerabilities, must do whatever they can to ensure that our voices are heard not only internationally which sometimes is the focus, but locally and regionally and be part of the discourse no matter how small you may consider your contribution,' she told IPS.

Mahal's contribution is part of what UN Women describes as the critical role that women play in climate action and natural resources management. The agency says in many countries, women also serve as energy managers in the home. As entrepreneurs, they continue to offer innovative solutions to climate change impacts.

Mahal says women and girls who want to be part of the movement for a more sustainable future can start small; wherever they are, with whatever resources are available.

"Find a cause that you believe in and focus on it. It does not have to be something big. It can be as simple as deciding to share your knowledge with friends and family, or something a little more challenging such as starting a backyard garden or a compost heap. These are important first steps," she said. This International Women's Day, an important message by UN Women is that 'when women lead, we see positive results.' As women lead campaigns for social justice, environmental justice and a sustainable future and as they seek to amplify their voices, the agency is calling for countries to make space for women and encourage their participation in public life, private sector leadership and parliaments.

As the world focuses on building back better, the role of women as caregivers, lawmakers, community organisers and innovators is being celebrated - even as calls for increased representation in decisionmaking continue. Mahal and Jawahir say women and girls can continue to make positive change in their communities.

"You can join an organisation that advocates climate change and other environmental issues and implements projects. Most importantly, individuals especially women already in the field, who have the knowledge and skills should not hesitate to share their experiences with other women and girls, to ensure that there is continuity in action." Mahal says.

Jawahir's message to young women is "if you were to remember anything after reading this article, remember that there is absolutely nothing stopping you from reaching your goals whether you decide to enter politics or become an entrepreneur. Not your age, not your gender. You decide what it is that you want. Stay focused, and go after it."

Wanted: Successful evaluation strategies of honey value chain

orest and honeybee resources in many countries in the world are the main sources of goods are the main sources of goods and services to the surrounding communities. The benefits provided by forest ecosystems include goods such as timber, food, fuel and bio products; and ecological functions such as carbon storage, nutrient cycling, water and air purification, and maintenance of wildlife habitat.

Stakeholders in the forestry and beekeeping sector have expressed their determination to invest heavily and accelerate the use of the sector's products so as to ensure that they become an important source of economic growth in the country.

They were speaking during the closure of the three-day international scientific conference on forest and honeybee products value chains for development of sustainable livelihoods and industrial economy, held in Dar es Salaam last week.

Reports show that Tanzania is endowed with between 33.7 and 48.1 million hectares of forest and woodlands which 55 per cent of the total land area of Tanzania.

Dr Sima Bakengesa, chairman of the conference's organising committee said in order to achieve this, the stakeholders have agreed to put more effort to support value chain development in forest and honey products. He said the stakeholders agreed that much effort will be directed to the promotion of factories establishment, research, value addition and marketing.

He said the country's development of sustainable value chains for forest-based products is critical to ensure social, economic and environmental benefits.

According to him, during the meeting, the stakeholders also agreed together to invest heavily in research, modern factories, value addition, tree planting and a number of works so as to bring transformation of

Dr Bakengesa further said if communities could see the potential available in the forest reserves and invest efforts to conserve them, then they could reap big and thus stimulate development.

Tanzania is going to invest heavily to implement its strategies aimed to transform the forest and honey-bee sectors.

The Tanzania Forest Service in collaboration with various stakeholders is well prepared to increase production of value added forest and honey-bee products.

It is our hope that TFS will continue to intensify efforts and plant more trees but also fight against deforestation as the county is currently witnessing environmental burdens due to excessive tree cutting.

When it comes to cultivating roles for women in the tech industry, the first step is to highlight this path as an option. We can't - and shouldn't - force anyone into a STEM career, but we should do more to ensure it is more frequently considered by young women. The education sector has a vital role to play in helping young women understand that they have a choice.

For women in tech unconscious bias is real: Here's how to fix it

That may come in the form of mentorship, STEM programs designed to reach young women, or just a continued normalization and exposure of the women in leadership roles. They can choose to focus on a career, or, if they prefer, to raise a family. Or they can choose to do both. We should celebrate and publicise the fact that young women today really should and do have that choice.

Unfortunately as the past vear has demonstrated, highlighting the option to pursue a career like mine is something we need to strive for in the best of times - and desperately hold on to in the worst. One of the most challenging parts of the current pandemic for women has been the loss of practical choice. When it comes to opportunities in the workplace, women are disproportionately bearing

the pandemic burden, and mothers are feeling it even more substantially.

U.S. Census Bureau data shows that 3.5 million mothers living with school-age children left the active workforce during the early months of the pandemic. In some cases, that meant shifting to paid or unpaid leave, losing jobs, or leaving the workforce all together as the challenges stemming from virtual school and a lack of adequate child care options piled up. Those of us with kids at home can particularly empathize and relate to increased stress relating to the changes in routine and loss of community.

When the global economy eventually begins to bounce back, we need to use this re-start as a chance to push women forward and give them opportunities.

In the tech community, we can open doors for women by exposing them to options and offering flexible work environments. And for those of us who speak from within 'women in tech', I hope we will continue to amplify our actions and our voices, showing others that I have done it - and you can too.

How can the media in Africa take back the pen from western outlets?

Africa No Filter recently gathered a group of media experts and funders to unpack findings from the 'How African Media Covers Africa' report, the focus being on why African media outlets struggle to cover more African news.

"Until we have much stronger and more vibrant new media platforms that speak to these audiences in language and context that makes sense to them, it's very difficult to drive a new African narrative," said Tomiwa Aladekomo.

Aladekomo is the CEO of Zikoko Media, which gets six million hits everv month on their website and social media. He was one of six panelists at the recent 'Africa No Filter Presents: A Conversation About Who is Telling Africa's Story' webinar.

He was joined by Rosenthal, Jonathan Africa Editor at The Economist; Dapo Olorunyomi, publisher & editor-in-chief of Premium Times Nigeria; Thebe Ikalafeng, Brand Leadership Group CEO; Vasantha Angamuthu, African News Agency (ANA) CEO; and Aguil Deng,

programme manager with Bloomberg Media Initiative Africa and Africa Corporate Philanthropy, Bloomberg.

They were unpacking findings from the groundbreaking Africa No Filter report, 'How African Media Covers Africa'. While some findings were expected, like the fact that the BBC and AFP were responsible for a quarter of the African news that African media outlets tell about the continent, others were startling.

Consider this: less than 1 per cent of stories in African media outlets were from African news agencies, and newsgathering sources on African countries resulted in content that continues to feed old stereotypes.

Furthermore, quality of local journalism didn't allow for nuanced or appealingly complex and contextualised storytelling that is critical for telling stories about the 54 countries in Africa.

Even though 87 per cent of the editors surveyed in the research said they were interested in covering African news, Angamuthu said one of the most consistent challenges faced by ANA was getting buy-in



African media outlets.

"African content comes up often in our discussions with potential partners. The kind of responses we get leads us to believe that African content is that 70 per cent of mea nice-to-have rather than a must-have," she Africans are not Afrisaid, citing affordability as one of the biggest stumbling blocks in taking Africa's pen back from the hands of the western media.

African women discuss ways to better agriculture and food systems in Africa

Having digital giants pay for content is good news, but will it help local media?

THAT the internet has all but destroyed the business model that has always supported journalism is not news. But what has made the news around the world recently is that the Australian government has attempted to do something about it.

It has passed a new law forcing organisations such as Facebook and Google, which make a great deal of money out of carrying news material on their platforms, to share their advertising revenue with media organisations.

Facebook incurred a worldwide backlash by temporarily blocking all news sites for users in Aus-

tralia. Google, meanwhile, just reduce funding for protook the opposite tack by signing early agreements with the country's key media players.

Facebook has now also pledged to strike deals with Australia's leading news companies in return for allowing its users to post their content on its pages.

But if the purpose of the new law is to serve democracy by supporting public interest journalism, how well will it work?

The wholesale movement of revenue from media outlets employing professional journalists to content platforms which produce no original stories is a major international problem.

The social media don't

fessional journalism but also enables the spread of fake news that rapidly fills the gap left behind.

It's a problem that has been obscured by the social media's many other issues: bullying, use by criminal groups, and disturbing, exploitative, violent and pornographic content. But, in fact, how advertising income breaks down has much deeper implications.

Digital advertising spend is continuously increasing, but about 40 per cent goes to Google, with Facebook in second place at about 22 per cent - and closing the

has disappeared to Rightmove and their classified advertisements to Ebay and Facebook.

As for job advertisements, which were such good money spinners for local and national newspapers, they have migrated mainly to CV upload sites such as LinkedIn.

To maintain visibility in the new digital world, news organisations have to be present on social media platforms - which simply means more eyeballs for the likes of Facebook and Twitter.

Deprived of advertising revenue, traditional news organisations are in seemingly unstoppable decline - not just in the UK but around the world. In the UK, 265 titles have closed since 2005 - with Covid-19 proving the final nail in the coffin for some.

The Australian initiative attempts to mitigate against technology giants siphoning off all digital revenue, but a major and valid criticism is that the deal appears to be skewed in favour of large media organisations. Funds also need to be made available to support independent local news organisations. The imbalance is already

Google pre-empted the new law by reaching agreements to pay seven Australian media organisations, including Rupert Murdoch's considerable newspaper and TV empire. But there's concern that the grassroots organisations that provide most public service news are unlikely to benefit without the massive influence of the nationals.

Google has also agreed to pay for the use of news snippets in Google News search results from some publishers in France - but so far only to a handful of major national organisations as well as the international news agency Reu-

Again, the agreement looks set to benefit the biggest players the most, since one of the criteria is monthly traffic. Reuters' French rival AFP has already complained.

But why does this matter? Research has shown clear links between a loss of journalism - particularly at local level - and a loss of public participation and trust in democracy. The watchdog role of the local press drives up standards in many other unexpected

In the US, members of Congress in areas not covered by a local newspaper do less to represent their

communities in the absence of local watchdogs they are more likely to toe the party to line than rebel, and do less constituency work, while their areas get less federal funding. Where local newsrooms have had severe staff cuts, there's also less competition in mayoral elections.

There's evidence from Norway and Japan that councils in areas with high local paper circulations are more efficient. The decline in the number of local newspapers and reduced coverage of local politics have even been blamed for political polarisation, particularly in poorer areas.

And it's not just about politics. The Index on Censorship has reported on the problems of reduced local newsrooms trying to report accurately while public bodies, including health and education trusts, employ highly paid marketing teams to protect their image; and local social media groups share information that often turns out to be false.

Having fewer local journalists means seeing less coverage of court cases and inquests. In my own research into coverage of coroners' courts, we found evidence of "news deserts": areas where inquests were never reported owing to staff cuts and patchy infor-

mation from courts. Editors told me that it was increasingly difficult to contact the police directly, as contacts were funnelled through police "newsrooms" - previously press offices - which now seek to prioritise good news stories about police successes.

This has serious consequences. The importance of the reporting of public inquests has been highlighted by the work of George Julian, who livetweets inquests of people with learning difficulties and autism.

These typically die two decades earlier than people without these special needs, often owing to poorly managed care which is only highlighted during the inquest process. But if there is no one there to cover the inquest, there is little public pressure for change.

The moves by the Australian government are a step in the right direction but there is a risk that the negotiating system will let the big players grab the newly released revenue, leaving high-quality, professional local journalism high and dry again.

This is actually in nobody's interests. National news organisations have long relied on the local press to act as a grassroots army of reporters. Many national stories began as a local paper's front page, and many great reporters started out on the local press.

Self-interest actually should dictate that they use their power to help their smaller colleagues. But it seems likely that, without a keen oversight by the reviewing body a year from now, short-termism will ensure that they continue to carve out the biggest slice of the pie.

AfDB purchases temporary bridges to replace infrastructure destroyed during cyclones in Mozambique

HE African Development Bank (AfDB) has finalized purchase of 26 modular steel bridges to replace infrastructure that was destroyed in weather disasters in Mozambique.

The modular bridges are due to be installed in coming months after the appointment of local contractors. The goal is to restore transport connections to the isolated regions of Manica, Sofala, Nampula and Cabo Delgado. An estimated 500,000 people are expected to benefit.

With a service lifespan of up to 100 years, the bridges will provide a temporary solution in areas that are vulnerable to extreme weather while

the government invests in climatesmart permanent bridges.

"We are delighted to be able to deliver this important contribution to Mozambique and respond to the recent climate disasters while investing to building back better," said Pietro Toigo, the African Development Bank's country manager for Mozambique. "The Bank will remain at the forefront of the fight to mobilize climate finance for adaptation and contribute to climate justice for the African continent."

The bridges are funded under the Post Cyclone Idai and Kenneth Emergency Recovery and Resilience Program, which was approved in the wake of these two cyclones that struck Mozambique, Zimbabwe and

Malawi in 2019 and affected around 3 million people in the three countries.

The program is being implemented over four years, ending in December 2023, at a total cost of UA 70.86 million (\$100 million) of which UA 66.01 million is to be paid by the Bank and the remainder by the affected governments. The funding was provided by the African Development Fund, the concessional arm of the African Development Bank Group.

João Osvaldo Machatine, Minister of Public Works, Housing and Water Resources, said: "The government of Mozambique is delighted to be working with the African Development Bank to help build resilience to climate and disaster risk management in the country."

Central Mozambique has been hit by extreme climate events in recent years. Cyclones Idai and Kenneth passed through the same region of the country in March and April 2019, also affecting neighboring countries. Disaster struck again with Tropical Storm Chalane in December 2020 and Cyclone Eloise in January 2021.

Mozambique is regarded as one of the world's most climate-stressed countries. In its 2018-2022 Country Strategy Paper for Mozambique, the African Development Bank identifies climate change as a key development challenge, and has directed roughly \$120 million to strengthening the country's climate resilience.

Tabora village brings ray of hope for lepers

AZIZA Mgaya does not remember how she ended up at a homeless shelter after she was diagnosed with leprosy, which changed her life forever.

With her lips twisted to the side, left eye swallowed by a fallen facial muscle, fingers truncated, she is in misery.

Mgaya, 46, who speaks with difficulty, was barely 16 when the skin around her hands started to peel and subsequently withered. Her palms turned grey and were numb to the touch.

"I was taken to the hospital then, where I was given some pills and a cream to rub on my hands," she said.

Four months later, a deep wound appeared in her

"It was very painful and it wouldn't heal," said Mgaya who woke up to the grim reality that she had leprosy.

"I was too young. It was not easy to accept the condition given the existing social stigma against lepers," she said. Like others suffering from leprosy, which ravages the skin and nerves and causes painful deformities, the diagnosis for Mgaya meant a life sentence of social isolation.

"I could barely do anything. I was a burden to the family that's why I decided to come here," she said angrily.

Perched impoverished neighborhood six kilometers (4 miles) from Tabora in western Tanzania, the village is home to lepers and other marginalized people who are shunned by their families because of the mistaken belief that they are cursed.

Leprosy is curable but it can mutilate body organs and cause terrible disfigurement.

While its devastating physical effects can be avoided when a patient is treated in the early stages, in many cases the diagnosis is identified too late.

As part of its broader push to dispel Neglected Tropical Diseases (NTDs) Tanzania has recognized leprosy in its policy, paving the way for sufficient budget resources to fight and eliminate the social malady which has pushed many to the edge of

Upendo Mwingira, NTD Programme Manager at Tanzania's Ministry of Health Community Development, Elderly Gender, Children said the nation has significantly reduced cases of leprosy in the past 30 years.

"We have multiple policy interventions at our disposal to eliminate not just leprosy but also other neglected diseases," she told Anadolu

She said the government is determined to defeat the malady by strengthening community-based leprosy elimination campaigns and the integration of leprosy care in health facilities.

Despite the progress Tanzania has made in taming the disease, experts say the East African country's final push to eliminate the disease requires community involvement, innovation and a coordinated response with global partners.

Deusdedit Kamara. coordinator of Leprosy and Tuberculosis care and Prevention (NTLP) said preventive treatment to those who have had contact with leprosy patients necessary to reduce transmissions

"Fighting leprosy requires a changing mind-set toward those who are suffering. This disease is not a source of shame and prejudice. All barriers to those seeking medical care should be removed," he said.

Sitting on a squeaking wooden bench, the Kidawa Shamte, 61, is unflinchingly determined to kill a menacing bed bug scuttling on the edge of her head shawl using her twisted palms.

"I am alive today because of the grace of God," she said. "Some people don't give us the respect we deserve as fellow humans."

As a disease with a long history of misery and neglect, many lepers in Tanzania often become street beggars in major cities to avoid discrimination in their families.

"They are miserable members of the society," said Harold Kilungu, a social worker at Tabora Advocacy Centre for Development. "Some of their family members believe they're sinners who brought the

illness among themselves," Kilungu said most lepers in Tabora face acute depression and anxiety because of blatant discrimination and the negative perception of the disease.

"We are trying our very best to raise community awareness," he said.

Government data and World Health Organization (WHO) statistics show the disease is no longer a public health problem since the country attained leprosy elimination level with less than 10 patients in every 100,000 people.

Moreover, infection rates have been reduced from 43 patients in every 1 million people in 2019, according to data from the Tanzania National Bureau of Statistics.

Globally, millions of poor people are affected by preventable neglected tropical diseases. In 2015, the UN formally recognized NTD as a target for global action toward the Sustainable

Poverty has many faces, but in Tanzania, one of the most tragic has been its close link with neglected diseases. According to WHO data, from 2015, more than 60% of 1.5 billion people suffering from NTDs, including leprosy and elephantiasis, received treatment.

In remote areas of Tanzania, where prejudice against lepers persists, human rights activists say families often abandon victims to starve and die in squalid conditions.

Although leprosy can be treated with multi-drug therapies, those affected in Tanzania still face significant stigma. Kessy Lusumo, 56, was

21 when he was diagnosed. Sitting on a wooden bench, his hands twisted by the disease, he clutches a torn bible as he ponders his predicament.

"My parents died when I was young and I lived with my uncle," he said. "When I found out I had leprosy he expelled me. I had nowhere to go and felt that my future was spoilt."

Distraught, Lusumo sought help at a local shelter run by sisters of charity in Tabora.

"Nobody would help you, if they know you've leprosy, we suffer in silence," he said.

Malaria data opened up to combat drug resistance

A HUGE trove of aggregated data on malaria parasites from around the globe is unlocking genetic secrets on the organism's evolution and could assist in the mounting battle against drug resistance, experts say.

analysed Scientists genetic variations of 7,000 Plasmodium falciparum parasites from 28 countries, and curated the data to make it accessible to other researchers, including those without expertise in genetics.

The open access dataset, analysed in a study that is currently undergoing peer review in the journal Wellcome Open Research, represents the world's largest resource of genomic data on malaria parasite evolution drug resistance, according to the Wellcome Sanger Institute, Cambridge,

Richard Pearson, coauthor and data scientist at the Wellcome Sanger

Institute, told SciDev.Net the data could help in the search for new drugs and vaccines, and the development of surveillance tools needed to control and eliminate malaria.

Plasmodium falciparum parasite, which is transmitted to people via mosquito bites, is the deadliest malaria parasite globally and the most prevalent species in Africa, where it accounted for almost 100 per cent of malaria cases in 2018, according to World Health Organization (WHO) estimates.

Malaria is preventable and curable, yet remains a major global health problem, with an estimated 229 million cases and 409,000 deaths in 2019, according to the WHO.

The WHO African region is disproportionately affected, accounting for 94 per cent of malaria cases and deaths in 2019, though people in South-East Asia, the Eastern Mediterranean. Western Pacific, and the Americas are

Deep concern over internet disruptions in Senegal

DIGITAL rights advocacy group Paradigm Initiative has expressed deep concern over what it described as "disturbances of the internet and social networks" in Senegal.

According to a statement released by the organisation, the West African country recorded disruptions to the internet and social networks on Friday March 5, 2020 as evidenced in a report by NetBlocks.org.

Paradigm Initiative also cited alerts from internet users that revealed disruptions on social media platforms such as Facebook, YouTube, WhatsApp and some Telegram servers.

It added that prior to these disturbances, "clashes and other demonstrations shook several cities in the country after the arrest of the political leader and opposition leader, Ousmane Sonko; came third in the last presidential election in 2019.'

The organisation stated: "Disturbances of the internet and social networks are a violation of digital user rights, and a violation of certain Internet rights according to the Senegal constitution Article 8, which guarantees its "citizens fundamental individual freedoms including freedom of opinion, expression, the press, association, assembly, travel, and demonstration". "

"As a reminder, Senegal had recorded similar disturbances of internet servers a few days before the presidential election of February 24, 2019," the statement continued.

The organisation said it was deeply concerned over disturbances of internet networks and said these were aimed at suppressing demonstrations and the expression of online freedom of opinion in Senegal.

"Paradigm Initiative urges and requests the Senegalese government on its responsibilities and calls for respect for international human rights obligations, and to make a lasting contribution to actions to protect digital rights in the country, in accordance with the resolution of the African Commission on Human and Peoples' Rights (ACHPR) adopted in 2016 on the right to freedom of information and expression for the internet in Africa, ACHPR / Res.362 (LIX)," the organisation added.

A principled approach to avoiding common pitfalls in management of tax risks

NE of the key resources in any organisation is funds. It is the objective of every organisation to channel its resources for best usage. In many cases, organizations have suffered financial losses due to unforeseen tax risks, resulting into divergence of resource usage from the original course.

Tax risks could be substantial depending on several factors such as the base value or principal amount involved, time delayed to identify and resolve the risk, the type of tax in question, or the nature of the risk (deliberate or an error). In addition to tax risks emanating from organisations' day to day operations, there is also uncertainty on how tax systems will respond to continued effects of globalization on businesses - and this exacerbates the problem.

The concept of tax risks is familiar to many organizations, as witnessed by the large number that have in place tax compliance strategies. However, there is still a significant number of cases of financial losses resulting from tax risks. This begs the question; why do organisations suffer from substantial tax risks if they have tax compliance strategies? The possible answer lies in the three principles as elaborated here under.

Our experience has shown that most tax strategies designed by organisations are not comprehensive enough to cater for common tax

tax strategies are set to monitor tax potential impact of tax risks reaches compliance in the narrow spaces of payment of taxes and filing of tax returns to meet due dates.

second is collective responsibility where organizations have historically considered tax issues to be within the purview of tax specialists and therefore they are not embraced across the board. This compromises the evaluation of tax in various far beyond the tax department or tax specialists, highlighting the need for tax issues to be handled collectively

Timeliness come o the third position as in several circumstances, organisations have become aware of tax risks upon TRA audits or other internal or external reviews. At such point in time, the risk of a financial loss has far materialized as such audits or reviews are usually based

to self-assess their taxes upon computation of respective taxes for purposes of meeting the taxman's deadlines. These assessments are based on already-booked transactions and mayattract additional tax liabilities in cases where all applicable taxes were not taken to account when the transactions were undertaken. For instance, there is a risk when any new business activity is carried out without being evaluated from tax perspective. Specifically, the risk here could be incorrect alignment of applicable taxes hence leading into over or under payment of tax. Many organizations suffer financial losses simply because a tax specialist is not involved in reviewing activities at their initial stages.

Additional tax liabilities may further translate into deterioration of shareholders' returns, organisations' investment plans and staff bonuses, among other things. Tax risks may also result into reputational risks depending on how they are handled. It is against this backdrop that organisations need a shift in their tax compliance strategies to tax risk management systems that evaluate business processes with a 360degrees' view.Organisations must also frequently review their tax risk management systems in order to maintain their relevance in this fast-paced world.

NAIROBI

GLOBAL Air cargo demand returned to pre-Covid levels in January, showing recovery for the first time since the outbreak of the Covid-19 pandemic a year ago. This comes as a relief to airlines that have been struggling for the last one year.

The International Air Transport Association (IATA) said January demand also showed strong monthto-month growth over December 2020 levels, buoyed by Africa and Asia robust growth in trade.

The upturn in air cargo comes at a time when local airlines such as Kenya Airways and Astral Aviation have increased their freight capacity in order to capitalise on freight demand following a dip in passenger

Passenger numbers remain low as the demand for flying is still subdued amid new travel restrictions and lockdowns by different countries.

"Global demand, measured in cargo tonne-kilometers, was up 1.1 percent compared to January 2019 and three percent up compared



to December 2020. All regions saw month-on-month improvement in air cargo demand, and North America and Africa were the performers," said strongest Alexandre de Juniac, IATA's director general and chief executive.

"Air cargo traffic is back to precrisis levels and that is some much needed good news for the global economy. But while there is a strong demand to ship goods, our ability is capped by the shortage of belly capacity normally provided by passenger aircraft," he said, noting that in normal times, a third of world trade by value moves by air and "that this high value commerce is vital to

helping restore Covid-19 damaged economies".

African airlines' cargo demand in January soared 22.4 percent compared to the same month in 2019, eclipsing the 6.3 percent yearover-year increase for December

IATA said a robust expansion on the Asia-Africa trade lanes contributed to the strong growth in the review period.

European carriers' international cargo demand slipped 0.6 percent in January compared to the same month in 2019. This was an improvement from the 5.6 percent fall in December 2020 over the

year-ago period. International capacity decreased 19.5 percent, a deterioration from the 18.4 percent vear-to-vear decline recorded for December.

On the other hand, IATA announced that passenger traffic fell in January 2021, compared to pre-Covid levels (January 2019) and compared to the immediate month prior (December 2020).

Total demand in January 2021 measured in revenue passenger kilometres or RPKs – was down 72.0 percent compared to January 2019. That was worse than the 69.7 percent year-over-year decline recorded in December 2020.

Total domestic demand was down 47.4 percent versus pre-crisis (January 2019) levels. In December it was down 42.9 percent on the previous year.

International passenger demand in January was 85.6 percent below January 2019, a further drop compared to the 85.3 percent year-to-year decline recorded in December.

Digital customs system set for full rollout June

Full implementation of a digital customs system will significantly increase efficiencies at the Port of Mombasa and along the Northern Corridor, Ministry of East African Community Affairs Principal Secretary Dr Kevit Desai has said.

The integrated Customs Management System (iCMS) which is 90 percent complete is expected to be rolled out fully in June.

"With full implementation of iCMS, we expect Kenya's ranking at the World trade index to go up by 20 position. In the system, we have integrated 41 modules and we expect the remaining four to be completed by June this year," said Dr Desai.

iCMS will enable revenue authorities to receive declarations of goods before ships dock at the port, reducing the time taken to clear goods.

Kenyan has implemented a number of programmes in the past decade which has seen the time to import and to export goods fall in the EAC by 54 percent and 92 percent. For the same period, the turnaround truck time between Mombasa and Kampala has fallen from 18 days to four days while costs to import and export have fallen, in the same period, have redcued by 45 percent and 66 percent respectively, according to TMEA report released this year.

Data and fintech subscriptions lift MTN to stronger full year results

ACCRA

MTN Group recorded improved topline performance in the year ended December, driven by a surge in active data and Mobile Money (MoMo) subscriptions, despite turbulent market conditions ushered in by the COVID-19 pandemic.

The telco, which has been seeking to reposition itself and push into new sources of revenue, recorded increased uptake of its fintech business, which includes MoMo, insurance, airtime lending and e-commerce.

The Pan-Africa mobile operator says driven by its focus on furthering digital and financial inclusion, it added 19 million active data users and 11.7 million MoMo users, to reach 114.3 million and 46.4 million

In addition, MTN, which presented its financial results today, says the number of active merchants accepting its MoMo propositions increased 115% to 440 000.

In Nigeria, MTN signed up more than 280 000 additional agents, to end the financial year with more than 395 000 registered agents for its fintech business. In the year 2020, MTN's data revenue expanded

by 31%, with a 110% increase in traffic brought about by higher levels of online demand resulting from the effects of COVID-19, including an increase in learnfrom-home and work-from-home.

MTN says it surpassed the breakthrough 100 million mark in the first half of the year as it continued to work towards its ambition of connecting 200 million data users to its networks in the medium-term.

"Anchored in our intent of driving the industryleading connectivity operations in our markets, we sustained our efforts to bridge the digital divide,' says MTN.

"We expanded our 3G and 4G coverage footprint, adding 16.3 million and 55 million people respectively; invested in 5G in SA; recorded 140 million smartphones on our network; and reduced the effective rate per megabyte by 32.9%. Average data usage rose by 60% to 4.4GB per month.'

Turning to fintech, MTN says revenue rose by 23.9% and the value of MoMo transactions was \$152 billion and the mobile operator processed 12 400 transactions per minute (up 35% from 9 200 in 2019).

"While COVID-19 accelerated the adoption of mobile financial services, growth in fintech revenue was moderated by reductions in transaction fees to support our customers, lockdown restrictions on agents and a slowdown in economic activity."

At the end of December 2020, MTN's aYo insurance joint venture had 11 million registered policy-holders and six million active policies. In total, aYo generated \$6.4 million (R106 million) in service revenue and \$10.5 million (R172 million) premium income.

CEO Ralph Mupita says despite the challenging trading conditions, MTN continued to demonstrate strong operational execution and resilience in delivering a solid performance for the year in its key commercial and financial metrics.

In the year, MTN added 28.8 million customers to its networks, to end with a subscriber base of 279.6 million, as at December 2020.

"We continued to perform favourably against our medium-term targets, with service revenue growth of 11.9% and EBITDA growth of 13.4%, maintaining our strong operating leverage," says Mupita.

"The solid operational result was supported by the pleasing growth in our larger operations as well as a broad-based improvement across all our regions. In the larger operations, MTN South Africa sustained the turnaround in its core business units, while MTN Nigeria and MTN Ghana continued to deliver solid overall performances with double-digit service revenue growth in both markets."

Mupita says 2020 was characterised by the COVID-19 pandemic and its impacts, including volatility in global commodities and capital markets, as well as the implementation of varying degrees of restrictions. These, he says, were most severe in April 2020, after which they began to ease.

"The pandemic has brought about unprecedented socio- and macro-economic challenges globally that have impacted lives and livelihoods across our footprint. The health and safety of our people across our markets has been our key priority.

"To the end of February 2021, we have reported 1 404 COVID-19 infections and mourned the loss of 10 MTN employees across our markets. We continue to apply health measures to safeguard the wellbeing of our people, who have also been empowered to work

MTN also made a \$25 million donation in support of the African Union's programme to secure much-

Key treasury auction could determine direction of yields

NEW YORK

INVESTORS concerned about demand for U.S. Treasury debt will be watching Wednesday's 10-year auction for clues to where yields in the recently volatile market may be headed.

The U.S. Treasury Department has increased debt issuance dramatically in the last year to fund coronavirus stimulus endeavors. Roughly \$3.6 trillion of new government paper was issued in 2020 versus \$2.9 trillion the year prior, according to SIFMA. With President Joe Biden's \$1.9 trillion fiscal package on the docket, issuance in 2021 is slated to rise to \$4 trillion this year, according to ING.

Ballooning supply and weak demand at an auction of seven-year notes in late February helped send the 10-year yield more than 20 basis points higher, with spillover volatility in the equity market. That has put investors on watch for Wednesday's auction of \$38 billion in 10-year notes at 1 p.m. EST.

"I think (the 10-year) auction will have a significant impact on sentiment over the next few weeks," said Gregory Whiteley, portfolio manager at DoubleLine.

Analysts at NatWest wrote in a note that the 10-year and subsequent 30-year auction - scheduled on Thursday - could cause "another mid-week surge in yields."


An auction on Tuesday of \$58 billion in U.S. three-year notes went "not so well as to warrant any rethink" on the 10-year auction, said NatWest.

A move higher in yields could also prompt a comment from the Federal Reserve, which holds its next policysetting meeting on March 16-17.

"If the market runs too far ahead of itself, I would expect (the Fed) to have to say something ... to cap rates from going too much higher," said David Norris, head of U.S. credit at TwentyFour Asset Management.

Whiteley said another 20-basispoint move higher in the 10-year yield is possible in the next week or two if demand at auction is weak.

Among the tools the Fed has at its disposal are an increase in its Treasury purchases and an extension of a regulatory break on

a rule called the supplementary leverage ratio, which would allow banks to maintain current holdings of Treasuries. Still, Fed Chair Jerome Powell in an interview with the Wall

Street Journal brushed off concerns about higher yields.

"If the auctions go well, this could be a sign to the Fed that rates are increasing for all the right reasons," said Meghan Swiber, U.S. rates strategist at Bank of America, adding that with a fair amount of demand at auctions the Fed might not "necessarily need to tep in."

Key to the performance of Wednesday's auction is demand from investors in Japan - the largest foreign holder of U.S. government debt securities, according Treasury to Department data - as investors square away positions ahead of the March 31 year end. Some of the weak demand at the sevenyear auction was due to less buying from Japan, said Ben Jeffery, U.S. rates strategist at BMO Capital Markets.

"The same dynamic holds this week for the 10-year auction this week," he said.

But a further rise in yields following the auction could ultimately entice those investors back into the market and cap the rise in rates.

"We think that as rates increase we could actually have Japanese investors and pension funds step in at these levels because Treasury yields do look really attractive relative to their local alternatives," Swiber said.



U\$1,400 stimulus checks set for bank balances

NEW YORK

A CHUNK of President Joe Biden's coronavirus relief package is poised to end up in the stock market and could provide a boost for GameStop and other stocks embraced by individual investors active in online social media forums.

The relief package, which is on track to be signed into law later this week, is set to provide \$400 billion in direct payments of \$1,400 per person, helping individuals earning less than \$80,000 annually and couples making less than \$160,000. The government should be able to start delivering checks almost immediately once Congress finalizes the bill and Biden signs it.

"I do think that you will find a lot of that stimulus money will end up in the market, and I think if anything it's a bullish catalyst," said Randy Frederick, vice president of trading and derivatives for Charles Schwab.

A Deutsche Bank survey of 430 retail investors last month found that on average they plan to put 37 percent of any stimulus checks directly into equities.

At that rate, the amount from the latest package that could go into stocks ranges from \$25 billion, if only traders with online accounts spend money on stocks, to as much as \$150 billion, if all stimulus recipients spend their checks in the

market in the same proportion, according to Deutsche Bank strategist Parag Thatte.

U.S. equity funds have been seeing near-record inflows of about \$15 billion a month, "so incremental flows stemming from stimulus payments can be sizable, especially if deployed quickly," Thatte said in an email.

Despite a recent pullback in stocks, including a 10 percent correction in the tech-heavy Nasdaq, the benchmark S&P 500 is near record highs and has climbed more than 70 percent from lows during the throes of the pandemic in March 2020.

If stimulus payments do flow into the stock market, they could end up disproportionately going to GameStop or other stocks favored by retail investors active on social media platforms.

Frederick said that younger adults tend to be on the lower end of income brackets, and therefore more likely to be eligible to receive stimulus payments, and that younger investors are more inclined to invest in so-called "meme stocks."

Shares of GameStop were soaring to start the week, following news about the video game chain's e-commerce strategy, while other stocks favored by retail investors on forums such as Reddit's WallStreetBets also were rallying.

There was some evidence of stimulus excitement among investors on social media platforms. On the popular

WallStreetBets forum, an account called "IwantSpaceX" posted: "Lets get our Stimmy checks IN!"

The stimulus payments could add fuel to interest from individual investors that has already been rising, with the COVID-19 pandemic leaving Americans with more time in front of their computers or on their smartphones.

Goldman Sachs strategists recently raised their 2021 net equity demand estimate from households from \$100 billion to \$350 billion, reflecting "faster economic growth and higher interest rates than we had assumed previously, additional stimulus payments to individuals, and increased retail activity in early 2021."

"We expect Households will be the largest source of equity demand this year," Goldman strategists said in a note.

Brokerage TD Ameritrade saw nearly 1.76 million retail accounts opened during January through September of 2020, a record amount for the company for the first nine months of a year.

"People have time, people have interest and now they are actually starting to understand what it is they are investing in," said JJ Kinahan, chief market strategist at TD Ameritrade. "You have really started to see an interest from the individual investor in a way that we have never seen before."

Stocks rise after wild tech reboot yields inch higher

LONDON

WORLD share markets inched higher on Wednesday after a stunning reboot in U.S. tech stocks, while the dollar and benchmark government yields both ticked up ahead of a key U.S. Treasury auction and inflation reading later.

But gains were subdued after Tuesday's 20 percent surge in electric car doyen Tesla, 4 percent jump in the Nasdaq and biggest one-day gain for global heavy-weights Amazon and Microsoft in well over a month.

Asia had bounced back from a two-month low as China's markets shrugged off their recent central bank policy tightening worries and Europe was helped early on by a new all-time high for Germany's DAX.

The dollar and bond yields ticked up too. Traders were focused on the U.S. bond auction and inflation data later, as well as Thursday's European Central Bank meeting where it is expected to respond to the recent jump in borrowing costs.

Mikhail Zverev, head of global equities at Aviva Investors, said Tuesday's wild moves in big U.S. tech underscored how volatile markets, which are increasingly dominated by super-sized passive funds, are likely to be this year as the world tries to reset after the COVID-19 pandemic.

"The winds are blowing harder now. The world isn't a more dangerous place, a mild increase in interest rates is not a cataclysmic event... but there is now the bigherd mentality with a greater propensity for rotations," he said.

"They are moving more frequently, they are moving faster and they are leaving a trail of inefficiency," leaving markets vulnerable to big swings, he added.

Gains in Asian stocks overnight came after Chinese shares had fallen to their lowest levels since mid-December the previous day on the prospect of tighter policy and a slowing economic recovery.

News that a \$1.9 trillion U.S. coronavirus relief package was nearing final approval had sparked a global spike in bond yields on Monday. That had pushed the Nasdaq more than 10 percent below its Feb. 12 closing high, confirming a correction for the index.

The yield on benchmark 10-year notes was at 1.540 percent, having peaked at 1.626 percent on Friday, after Tuesday's auction of \$58 billion in U.S. 3-year notes was well received.

Yet, many market investors remained on edge, with the next tests of investor appetite for government debt due later this week in the form of 10-year and 30-year auctions. "Although the bond market has steadied a bit, pressures will remain," said Naokazu Koshimizu, senior rates strategist at Nomura Securities.

"It has priced in future normalisation of the Fed's monetary policy, the Fed's policy becoming eventually neutral. But it has not yet priced in the chance of its policy becoming tighter."

Some investors see a real risk of an overheated U.S. economy and higher inflation on the back of the planned government spending boom.

U.S. consumer price data due at 1330 GMT is expected to show a slight acceleration in the overall inflation in February, with analysts expecting further gains in coming months due to base effects from a severe economic downturn in early 2020.

The speedier rollout of COVID-19 vaccines in some countries and the planned U.S. stimulus package helped underpin a brighter global economic outlook, the Organisation for Economic Cooperation and Development said on Tuesday, as it raised its 2021 growth forecast.

Adidas predicts strong rebound despite Reebok hit

BERLIN

GERMAN sportswear maker Adidas AG expects a strong Chinaled recovery in sales this year, though profit will be trimmed by costs associated with divesting its Reebok brand.

Preparing to presenting its 2021 outlook on Wednesday as part of its five-year strategy, Adidas said it has reopened 95 percent of its

stores after coronavirus lockdowns and expects 2021 sales growth rate in the mid-to-high teens, rising to as much as 30 percent in greater China, the rest of Asia and Latin America.

Adidas shares rose 3.5 percent by 0853 GMT, making them the strongest gainer on the German blue-chip index.

"The 2021 outlook appears broadly consistent with consensus

estimates once Reebok stranded costs are added back," said Jefferies analyst James Grzinic.

Rival Puma last month said it expects the financial impact from lockdowns to last well into the second quarter but that pandemic-driven growth in running should help to support a strong improvement after that.

Adidas reported fourth-quarter sales up by a currency-neutral 1

percent at 5.55 billion euros (\$6.59 billion) while operating profit slipped slightly to 225 million euros, ahead of the 5.47 billion and 202 million euros expected by analysts.

million euros expected by analysts. About half of its stores were closed in Europe in the period, but online sales grew 43 percent.

As part of its new strategy, Adidas will manage greater China as a separate market from the rest of Asia and it has integrated Europe,

For EMEA, Adidas expects sales growth in the mid-to-high teens, but only a high single-digit percentage in North America.

Net income from continuing operations is projected to rise to between 1.25 billion and 1.45 billion euros.

However, Adidas expects a hit

of about 250 million euros to operating profit from costs to make Reebok a standalone company, with a third of that in 2022 but none in 2023.

Adidas last month said that it plans to sell or spin-off the underperforming brand, 15 years after it bought the U.S. fitness label to help it compete with arch-rival Nike Inc.

Saddened Queen Elizabeth will address Harry and Meghan's racism accusation

LONDON

QUEEN Elizabeth said on Tuesday the British royals were saddened by the challenging experiences of her grandson Prince Harry and his wife Meghan and promised to privately address revelations about a racist remark about their son.

Meghan and Harry's tell-all TV interview with Oprah Winfrey aired on U.S. television on Sunday has plunged the monarchy into its biggest crisis since the 1997 death of Harry's mother Diana.

In the two-hour show, Meghan accused Britain's royal family of raising concerns about how dark their son Archie's skin might be and ignoring her pleas for help while she felt suicidal.

Harry also said his father, heir-to-thethrone Prince Charles, had let him down and that he had felt trapped in his royal

"The whole family is saddened to learn the full extent of how challenging the last few years have been for Harry and Meghan," Buckingham Palace said in a statement issued on behalf of Elizabeth.

"The issues raised, particularly that of race, are concerning. Whilst some recollections may vary, they are taken very seriously and will be addressed by the family privately. Harry, Meghan and Archie will always be much loved family members."

The Palace considered that this was a family matter, a royal source said, adding the royals should be given the opportunity to discuss the issues raised privately as a family.

The interview was watched by 12.4 million viewers in Britain and 171 million in

the United States, triggering a crisis to which the monarchy had to respond, me-

It has proved divisive among the British public, with some believing it showed how outdated and intolerant the institution was, while others decried it as a selfserving assault that neither Elizabeth nor her family deserved.

"It could hardly be more damaging to the royal family, not least because there is little it can do to defend itself," The Times said in a lead article under the title "Royal Attack".

"The key to the monarchy's survival over the centuries has been its ability to adapt to the needs of the times. It needs to adapt again," The Times said.

Earlier on Tuesday, Charles made no comment when asked by a reporter what he thought of the interview while visiting a COVID-19 vaccine pop-up clinic in Lon-

A royal source had said Elizabeth, 94, who has been on the throne for 69 years, wanted to take some time before the Palace issued a response, saying it needed careful consideration.

A former senior royal aide said it was likely that the three most senior royals the queen, Charles and Prince William, second in line to the throne and Harry's elder brother, would have held meetings with their private secretaries and communications chiefs to decide on their response.

"This is pretty important and they've got to judge it right," said the former aide, adding the queen would have had the fi-

British Prime Minister Boris Johnson watched the interview, his spokesman said, but would not be making further comment on it.

Johnson said on Monday he had the highest admiration for the queen but that he did not want to speak about the interview. New Zealand's Prime Minister Jacinda Ardern said her nation was unlikely to stop having the queen as head of state soon.

'TRAPPED'

Opponents of the monarchy said the allegations made by Meghan and Harry showed how rotten the institution was and that the Palace's public relations machine had created a distorted image of the royals.

"Now people are getting a much clearer picture of what the monarchy is really like. And it doesn't look good," said Graham Smith, head of Republic, a campaign group which seeks to abolish the monarchy.

Royal supporters cast Meghan, 39, an American former actor, as a publicity seeker with an eye on Hollywood stardom.

A YouGov poll found a majority of young people thought the royals' treatment of the couple was unfair, while half of older people said the opposite.

The gravity of the claims has raised questions about how the British monarchy, which survived centuries of revolution that toppled their cousins across Europe, could function in a meritocratic world.

Meghan, whose mother is Black and father is white, said her son Archie, who turns two in May, had been denied the title of prince because there were concerns within the royal family "about how dark his skin might be when he's **Agencies**

WHO: 1 in 3 women endure physical or sexual violence

GENEVA

NEARLY one in three women worldwide is subjected to physical or sexual violence during her lifetime, pervasive criminal behavior that has increased during the pandemic, the World Health Organization (WHO) said on Tuesday.

The UN agency urged governments to prevent violence, improve services for victims and tackle economic inequalities that often leave women and girls trapped in abusive relationships.

Boys should be taught in school about the need for mutual respect in relationships and mutual consent in sex, WHO officials said.

"Violence against women is endemic in every country and culture, causing harm to millions of women and their families, and has been exacerbated by the COVID-19 pandemic," WHO director-general Tedros Adhanom Ghebreyesus said.

Some 31 percent of women aged 15-49, or up to 852 million women, have experienced physical or sexual violence, the WHO said in what it called the largest-ever such study, encompassing national data and surveys from 2000-2018.

A husband or intimate partner is the most common perpetrator and a disproportionate number of victims are in the poorest countries, it said. True figures are likely far higher due to under-reporting of sexual abuse, a heavilystigmatized crime.

"These numbers are very shocking and really are sort of a wake-up call for governments to be doing much more to prevent this violence," report author Claudia Garcia-Moreno said. In some regions, more than half of women face violence at some point, she told Reuters, citing Oceania, sub-Saharan Africa and southern Asia.

Countries with the highest prevalence include Kiribati, Fiji, Papua New Guinea, Bangladesh, the Democratic Republic of Congo, and Afghanistan, WHO data show.

The lowest rates are in Europe, up to 23 percent, over a lifetime.

Violence starts at an "alarmingly young" age, the WHO said. One in four adolescent girls aged 15-19 who have had a relationship have been subjected to either physical or sexual violence, Garcia-Moreno said.

"This is a very important and formative time in life. And we know that the impacts of this violence can be long-lasting and can affect physical and mental health and lead to unwanted pregnancies and other complications," she said.

Germany has repeatedly stated that on the whole, it is ready to use vaccines produced outside of the EU, namely Sputnik V. German Chancellor Angela Merkel and Health Minister Jens Spahn named the main condition for using the vaccine: it must be certified by the European regulatory body.

All prefectures, counties in Tibet Autonomous Region connected to State grid

CHINA on Feb. 25 held a grand gathering at the Great Hall of the People in Beijing to mark the country's accomplishments in poverty eradication and commend role models in that cause. The rural electricity department of the State Grid Tibet Electric Power Company was rewarded for its outstanding contribution to the poverty alleviation fight.

Since 2016, the State Grid Tibet Electric Power Company has invested a total of 49.4 billion yuan (\$7.64 billion) in power grid construction in southwest China's Tibet Autonomous Region, where over 100,000 constructors overcame harsh conditions and com-

pleted the construction of four major grid projects - the Qinghai-Tibet power grid interconnection, Sichuan-Tibet power grid interconnection, central region of Tibet power grid interconnection project and Ngari power grid interconnection. The efforts have connected Tibetan households to safe electricity and offered strong support for the autonomous region to shake off poverty.

Local workers in Tibet were employed more than 1.47 million times in total in the construction of power grid projects, which helped them increase income by nearly 1.32 billion yuan. The company expanded the income for the group by 293 million yuan in 2020 alone. At the end of the last year, the Ngari power grid interconnection, a project with an investment of 7.4 billion yuan, was put into service, connecting Ngari Prefecture to the country's state grid. By then, all 74 counties and prefectures of the autonomous region had been connected to the state grid, which largely boosted the livelihood improvement and development of nearly 380,000 farmers and herdsmen in 16 counties along the

As the final region connected to the state grid in Tibet Autonomous Region, Ngari used to be trapped by power shortage, which limited the development of the prefecture that boasts rich tourism and industrial resources.

The director of the rural electricity department of the State Grid Tibet Electric Power Company He Longshou introduced that he was once reminded by the front desk of a hotel in Ngari to charge his devices during the daytime, as the power would go off at night, during a business trip to the prefecture.

"The frequent blackouts not only led to high operation cost of hotels, but also prevented them from expanding their business," said Dawa Putri, manager of a hotel in Saga County, Shigatse.

As an important transit along the National Highway 219, Saga enjoys prospering tourism, and there are many hotels in the township. However, all the hotels must prepare backup generators in the county that relied solely on hydro-

As a result, they had to suffer not only unstable voltage, but also a fuel cost that might run up to one or two thousand yuan per day.

As the Ngari power grid interconnection project came into service, power supply is no longer a problem, and the cost of hotels dropped drastically. Many owners of hotels in the county are now planning to expand their business.

In a factory that processes tsampa, a Tibetan staple foodstuff made from roasted barley flour in Rutog village, Ngari, all production procedures are now powered by electricity, including cleaning, frying, grinding and packaging.

"Being connected to the state grid, our factory now has more stable production and a lower cost," said Phuntsog Tsering, head of the factory.

At present, over 30 local people with physical disabilities and from impoverished households are working for tsampa, Tibetan incense and wool processing factories in the village.

John Kerry in Brussels to renew **US-EU climate cooperation**

JOHN KERRY, the United States' Special Presidential Envoy for Climate, on Tuesday underlined the cooperation between the US and European Union (EU) on the fight against the climate crisis during his visit to

Kerry (pictured) stressed that the world is facing not only a climate crisis but also "a moment of the greatest opportunity that we've had since perhaps the industrial revolution to build better to renew ourselves and our economies.

He described the United Nations climate summit in Glasgow, Scotland in November this year as the last opportunity for the world to come together and "build on Paris (Agreement)."

Frans Timmermans, Executive Vice-President of the European Commission in charge of the European Green Deal and Commissioner for Climate Action Policy, hailed the comeback of the US climate action.

He said the EU and the US would be working to make a success of Glasgow, though it will be quite an effort to



"convince other major players in the world to do the right thing.

Kerry attended the weekly European Commission College meeting, where the commission's president Ursula von der Leyen recalled that Joe Biden, on his first day in office, announced the US return to the Paris Agreement.The EU member states agreed in December to cut the bloc's greenhouse gas emissions by at least 55 percent by 2030 from 1990 levels.

So far, half of the G20 members, such as Japan, China, South Korea or South Africa, are already committed to achieving climate- or at least carbon neutrality by 2050 or soon after.

Rwanda begins vaccinating inmates against COVID-19

KIGALI

THE Rwanda Biomedical Center (RBC) and Rwanda Correctional Services has began inoculating elderly inmates and those with underlying diseases against

The vaccination started on Tuesday at Nyarugenge prison in the capital city of Kigali, where 2,077 inmates are set to be inoculated, and the authorities plans to extend the vaccination to all inmates aged 60 and above and those with underlying health conditions in prisons across the country, Commissioner General of Rwanda Correctional Services George Rwigamba told journalists at Nyarugenge

A total of about 12,000 inmates are expected to be inoculated in the coming days, Rwigamba said, adding that the vaccination for inmates was a welcome move as ensuring social distancing measures in prisons is a challenge. The RBC on Tuesday said the vaccination among commercial motorcyclists and cyclists, as well as local security guards in Kigali has also started.

Rwanda Last Friday launched countrywide inoculation against COVID-19 of priority groups, including health personnel, frontline workers and those older than 65 years or with underlying health conditions, after receiving AstraZeneca-Oxford and Pfizer vaccines through COVAX Wednesday. It later extended elderly people eligible for inoculation to those older than 60-year-old as more vaccines become available.

More than 200,000 people regarded as priority have been vaccinated, according to Monday's figures from RBC. As of late Monday, Rwanda has recorded a total of 19,659 cases, with 17,911 recoveries and 268 deaths.

Egyptian president says inauguration of new capital to mark 'birth of new state'

EGYPTIAN President Abdel-Fattah al-Sisi said on Tuesday that the inauguration of the New Administrative Capital (NAC) and the relocation of the government's headquarters to the new city will mark the "birth of a new state" of Egypt.

Sisi's remarks came during a symposium in Cairo honoring the martyrs of the armed forces."There will be a birth of a new state by inaugurating the new capital," said the Egyptian president, reiterating that the inauguration will mark "a declaration of a new republic."Sisi hoped that the inauguration will be done later this year if no delay would be caused due to the fight against COVID-19.

Being built some 45 km east of the traditional capital Cairo since 2015, on an area of 714 square km, the new capital is planned to accommodate 6.5 million people, starting with half a million in the first stage, making some space in the congested and overpopulated Cairo that is home to about one fifth of the country's 100 million population.

It will also be home to most government buildings including the cabinet headquarters and ministries, in addition to the parliament, and is



expected to accommodate in the first stage from 40,000 to 50,000 government employees that are planned to be increased to 100,000 three years after inauguration.

The government also expects the NAC to create around 2 million job opportunities. China State Construction Engineering Corporation (CSCEC) is currently building a 20-tower business district in the NAC, including the 385-meter-high Iconic Tower that is expected to be the tallest building in Africa upon

Egyptian Prime Minister Mostafa Madbouly said on Monday that trial operation of government buildings in the new capital will start in August through gradual relocation of employees, expecting the inauguration of the NAC to be held by the end of Xinhua the year.

UK envoy summoned for 'didactic arrogance'

CAROLINE Elizabeth Wilson, the United Kingdom's ambassador to China, was summoned by a chief official with the Chinese Foreign Ministry's Department of European Affairs on Tuesday to receive a solemn protest about her recent improper signed article published on social media.

She was asked to thoroughly reflect on her duties and responsibilities, put her position in the proper place and do more things that are conducive to the development of bilateral relations, the ministry said in a state-

In her article, Wilson (pictured) said foreign media organizations, instead of targeting China only, are overseeing both their own governments and the Chinese government.

After some foreign media had been sanctioned for groundless reporting, Wilson issued the article to defend them, deliberately confused slander in news with supervision on news and she, on a selective basis, turned a blind eye to foreign suppression of Chinese media, the Chinese official

The article is full of didactic arrogance and ideology-related prejudice, it subverts black and white and adopts double standards, the official



It drifts away from the duties of diplomats and the mission of diplomatic agencies, and the article triggered great discontent among the Chinese public, the official noted.

The Chinese government and its people never oppose foreign media themselves but those erroneous moves of producing fake news and viciously attacking China, the Communist Party of China and the Chinese political system with excuses of "freedom of the press" and "freedom of speech", the official said.

In another development, renowned filmmakers John Pilger, Oliver Stone and Ken Loach have signed an open letter calling for Britain to reverse a decision last month to revoke the license for Chinese broadcaster CGTN

Russian media watchdog demands **Facebook restore** access to Russian media posts

MOSCOW

RUSSIA'S Federal Service for Supervision of Communications, Information Technology, and Mass Media (Roscomnadzor) has demanded Facebook restore access to TASS, RBC, and Vzglyad materials.

"Roscomnadzor has issued a letter to Facebook administration demanding access be restored to information posted on official accounts of the Russian mass media Vzglyad, RBC, and TASS," the watchdog said on its Telegram channel.

It also stressed that Facebook's actions "violate key principles of free dissemination of information, unimpeded access to it and can be described as an act of censorship."

The watchdog reminded that infringement on the right to free access to information is punishable by an administrative fine of up to one million rubles (13,450 US dollars) and of up to three million rubles (40,350 US dollars) in case of recurrent offence.

According to earlier reports, Facebook blocked a TASS post about the detention of supporters of a Ukrainian radical youth group in Russia's Voronezh as "fake" news. The post was written on the basis of an official press statement from the Federal Security Service (FSB) and the Investigative Committee. TASS insists that it put the information correctly and plans to request Facebook explanations on the matter.

'Shoot till they are dead' - Some Myanmar police say fled to India after refusing orders

CHAMPHAI, India

WHEN Tha Peng was ordered to shoot at protesters with his submachine gun to disperse them in the Myanmar town of Khampat on Feb. 27, the police lance corporal said he refused.

"The next day, an officer called to ask me if I will shoot," he said. The 27-year-old refused again, and then resigned from the force.

On March 1, he said he left his home and family behind in Khampat and travelled for three days, mostly at night to avoid

detection, before crossing into India's northeastern Mizoram

"I had no choice," Tha Peng told Reuters in an interview on Tuesday, speaking via a translator. He gave only part of his name to protect his identity. Reuters saw his police and national ID cards which confirmed the

Tha Peng said he and six colleagues all disobeyed the Feb. 27 order from a superior officer, whom he did not name.

Reuters could not independently verify his or other accounts gathered near the Myanmar-India border.

The description of events was similar to that given to police in Mizoram on March 1 by another Myanmar police lance corporal and three constables who crossed into India, according to a classified internal police document seen by Reuters.

The document was written by Mizoram police officials and gives biographical details of the four individuals and their account of why they fled. It was not addressed to specific people.

"As the Civil disobedience movement is gaining momentum and protest(s) held by anti-

coup protesters at different places we are instructed to shoot at the protesters," they said in a joint statement to Mizoram po-

"In such a scenario, we don't have the guts to shoot at our own people who are peaceful demonstrators," they said.

Myanmar's military junta, which staged a coup on Feb. 1 and deposed the country's civilian government, did not respond to a Reuters request for

The junta has said it is acting with utmost restraint in handling what it has described

as demonstrations by "riotous protesters" whom it accuses of attacking police and harming national security and stability.

Tha Peng's is among the first cases reported by the media of police fleeing Myanmar after disobeying orders from the military junta's security forces.

Daily protests against the coup are being staged across the country and security forces have cracked down. More than 60 protesters have been killed and more than 1,800 detained, the Assistance Association for Political Prisoners, an advocacy group, has said.

Reuters has not been able to confirm the figures indepen-

Among the detainees is Nobel laureate Aung San Suu Kyi, who led the civilian government.

DOZENS FLEE

Around 100 people from Myanmar, mostly policemen and their families, have crossed over a porous border into India since the protests began, according to a senior Indian official.

Several have taken shelter in Mizoram's Champhai district bordering Myanmar, where Reuters interviewed three Myanmar nationals who said they had served with the police.

As well as his ID cards, Tha Peng showed an undated photograph of him wearing a Myanmar police uniform. He said he joined the force nine years ago.

Tha Peng said that, according to police rules, protesters should either be stopped by rubber bullets or shot below the knees. Reuters could not verify police policies.

But he was given orders by his superiors to "shoot till they are dead," he added.

Yanga leadership to clamp down on inefficient players

AFTER parting ways with head coach Cedric Kaze and entire technical bench, Yanga's leadership has vowed to dismiss any of the outfit's players whose performance will be unconvincing.

The Burundian tactician was shown the exit door on Sunday alongside his backroom staff after their Vodacom Premier League match against Polisi Tanzania held in Arusha, which ended in a 1-1 draw.

Immediately after the match which took place at Sheikh Amri Abeid Kaluta Memorial Stadium, Yanga released a assistants.

Other members of the technical bench who have been relieved of their duties are assistant coach Nizar Khalfan, fitness coach Edem Mortotsi, goalkeeping coach Vladimir Niyonkuru and the club's security officer Mussa

According to the club's Chairman of the Technical Committee Dominick Albinus, the draw with Polisi Tanzania, coupled with the team's first defeat of the season to Coastal Union last Thursday, forced the team's management to crack the whip by offloading the entire technical bench.

He disclosed: "As you have seen, results stamped by the team were not convincing and the technical bench is the responsible department to deal with that, as such, the concerned sides came up with decision to let go the whole technical staff."

"We expect to have new technical bench within one to two weeks and I believe that the incoming coach will have a bit of time to oversee his squad as the league is due to be paused to give way for the FIFA international break," he said.

He said that they have communicated with players and informed them why the leadership took the decision to fire the technical bench.

"We told them (players) why we took the decision to fire the bench and it came about because the results were not good and if the trend continues, then the players will also be held accountable," he said.

Albinus insisted that letting go of the coach and members of technical bench was one of the ways to solve

challenges facing the club. "It was an agreement amongst public notice saying they have gone ourselves and everyone knew we separate ways with Kaze and his needed to get good results but what

we have been getting recently is discouraging," Albinus said. Kaze, who had only handled Yanga for five months, having replaced fired Serbian Zlatko Krmpotic, has taken to his social media pages to voice his pride in leaving the team in the first

position on the top flight table. He wrote: "It was a pleasure to work with you during these five months. Patience is virtue. 18 league games, 10 wins, seven draws and one loss.'

He stated: "Four games in Mapinduzi Cup tournament and we were the event's winners. I leave Yanga on the first place and that is my pride. Wishing you all the best. This is just a goodbye."

Kaze called on the Yanga management to have patience in their pursuit of the top flight title.

He left the team top of the table with 50 points from 23 games.

However, four draws and a defeat from last six games has seen them fail to widen the gap with age-old rivals Simba SC, who are second with 45 points from 19 games.

Man Utd face AC Milan in Europa League battle of recovering giants

MANCHESTER United and AC Milan meet in the Europa League last 16 on Thursday in a battle of European royalty, with both clubs showing signs of revival.

With 10 Champions League titles between them, United and Milan were once feared across Europe for their swashbuckling play and financial muscle.

But both clubs have lost their lustre in recent years, making their first meeting since 2010 an intriguing affair.

In a sign of the drop in standards at Old Trafford and the San Siro, the 11th encounter between two of the world's most historic teams will be their first outside the Champions League knockout stages.

United, 20-time English champions, have not won the Premier League since Alex Ferguson's last season in charge in 2013. Ole Gunnar Solskjaer's side are unlikely to end

that drought this season as they trail leaders Manchester City by 11 points with 10 games left. Sunday's impressive 2-0 win at City was a sign

United are at least heading in the right direction at last after losing their way under several of Ferguson's successors.

Calling for United to build on that success, Solskjaer praised his side's energy levels.

"We are going to do everything we can to keep the performance levels up every day," he said.

"I feel we are a better team to 12, 16, 18 months ago. We have improved massively. We are more robust, resilient and there is more personality in the team. That is what I like.

The most recent of Milan's 18 Serie A titles came in 2011, with a sixth-place finish last term earning a return to Europe after a one-season absence.

That was a small step in the right direction for Milan, who have not played in the Champions League since 2014.

Pirlo: Juventus project continues after UCL exit

TURIN, Italy

JUVENTUS coach Andrea Pirlo insists his project in Turin is still in its early days and will continue despite his side crashing out of the UEFA Champions League at the last-16 stage on away goals against 10-man Porto on Tuesday.

Juventus won 3-2 after extra-time on the night, but they were knocked out of the Champions League at the same stage as last season after a 4-4 aggregate draw. That was despite playing against 10 men for much of the game after Porto's Mehdi Taremi was sent off in the 54th minute.

Their failure to reach the quarterfinals was remarkably similar to last season's away-goals exit to Lyon, with manager Maurizio Sarri sacked at the end of the campaign despite winning a ninth straight Serie A title for Iuve.

For all their domestic dominance, Juve have won just two European Cups compared with Italian rivals AC Milan's seven.

Champions League glory is what the club craves, but Pirlo is adamant his journey as coach is just be-

"I don't know if Sarri was sacked for being eliminated from the Champions League," Pirlo told Sky Sport Italia.

"I am the Juventus manager at the moment and I will work for a larger project, which goes beyond

"This season is only the beginning of this project. We have young players who are growing game after game. The young players have played with desire and self-denial. We cannot say anything to them,

they have given their all." After falling behind in the first half to a Sergio Oliveira strike, a double from Federico Chiesa, either side of Taremi's dismissal, seemed to set Juve on their way to victory but they could not find a crucial third goal, leaving the sides all square after

Pirlo's side continued to press in extra-time, but one free-kick, through the wall, from Oliveira condemned Juve to their fate, despite Adrien Rabiot scoring a third for the Italian side soon after.

The blow leaves Juve just Serie A glory to play for -- and they trail leaders Internazionale by 10 points.

"I'm not happy to have to work with full weeks without European games, I preferred to go on in the Champions League," Pirlo said.

"To forget this elimination will take a few days but then we will have to look forward and try to move up the [Serie A] rankings.

"We are still in March."

What Laporta being elected means for Messi, Barcelona's debt, squad rebuild

IONEL Messi is scoring goals for fun, Ronald Koeman is successfully reconstructing FC Barcelona's first team, the Blaugrana dramatically overturned a 2-0 deficit against Sevilla in early March to reach this season's Copa del Rey final and so, as Joan Laporta starts his first week as Camp Nou president since he vacated the role in 2010, there's little wonder he's surrounded by a temporary state of heady euphoria.

But during that first full week (back) in the job, Messi, Koeman & Co. will be eliminated from the Champions League in the round of 16 for the first time since 2007; the Dutchman still doesn't know whether he'll be asked to fulfill the second year of his coaching contract; Messi may not declare whether he's leaving or staying until the season is over; the club's previous president, Josep Maria Bartomeu, appeared in court last week after a night in prison, pending corruption charges, and the club is suffering under the crushing weight of massive short-, midand long-term debt.


Therefore, that euphoria is likely to be as durable as friendships quickly made when you win a few thousand euros on the lottery -- effervescent and fun in the moment, but evaporating the moment that reality bites.

So what lies ahead of Joan Laporta Estruch, a which there are many. 58-year-old lawyer who, nix-like resuscitation of his club from the ashes of what he inherited in 2003, is a period of the most intense, threatening, demanding and no doubt entertaining, dealing, statesmanship, corporate aggression, debt renegotiation and football empire rebuilding imaginable. And simply because the Catalan is a messianic character whose every breath exudes a heady tonic of confidence and bravado, the words "potential failure" shouldn't automatically be excluded from that list of what's in store for the new Caesar of Camp Nou.

Who is Laporta, and

how did he get here? If you let Laporta tell it his way, he's the kid who fell in love with Johan Cruyff when the Dutchman moved to Camp Nou from Ajax in 1973, an era in history where Spain was still a dictatorship and Catalunya (where Barcelona exist) felt like an unloved, oppressed north-eastern province. Laporta will talk about how Cruyff choosing Barca over Madrid instilled pride and brought international ing roll-call.



must make you bilious with anger. When, in 1996, President Josep Nunez and Vice President Joan Gaspart combined to let imbecility reign, summarily sacking Cruyff as Barcelona coach (with one match remaining that season), Laporta, then 33 years old, was so furious and so energised by the injustice, that he formed an active protest group ("Elefant Blau," or "Blue Elephant").

But consider this for "fan power." Within seven years, his activist opposition had earned him the Camp Nou Presidency and precisely nine years, 364 days after Cruyff was sacked, Laporta, as president, sat in the Stade de France watching the team he and his board had assembled, with Cruyff "Professor of Football," win only the club's second Champions League trophy via a 2-1 defeat of Arsenal. He went from zero to hero, quite literally, in unbelievably rapid time.

What followed after 2006 was a constant, compressed, explosion of boom and bust, the pendulum swinging crazily from one extreme to

another. Ronaldinho and Frank Rijkaard, the principle architects of the first Laporta "boom" era, lost their way, both professionally and privately. Messi, Andres Iniesta and Xavi flowered and began to mark out their places in the club's alltime pantheon as, under the influence of Txiki Begiristain, Pep Guardiola was appointed and Barcelona's first 'Treble' was won.

Meanwhile, former friends and allies deserted Laporta's board in

droves, a motion of noconfidence went against him and was ignored so that the "golden era" from 2003 to 2010 ended with a feeling of greatness on grass, but division and debauchery in the boardroom. So much so that Laporta's sworn enemy, anti-Cruvff fanatic Sandro Rosell, immediately won a landslide victory to replace Laporta as president. Laporta had given "the people" a historic measure of glory in a magnificent seven-year era, but once his mandate was up, the voters screeched disapproval at him by electing an outright enemy who stood on diametrically opposed principles. It was a truly remarkable

Why is this election win significant for Laporta, and why should we care?

Notwithstanding all aforementioned that euphoria, reality will bite soon enough. Even though the club's finances were a mess when Laporta first came to the presidency 18 years ago, it's still true that acting as their unpaid FC Barcelona's financial situation has never been worse than it is now. And irrespective of the fact that Koeman has discovered that the cupplayers" is not in fact requires some serious restorative surgery.

> Koeman has discovered true greatness in the shape of young Pedri and has galvanised by far the best Barcelona have seen of France forward Ousmane Dembele (signed from Borussia Dortmund in 2017) and Dutch midfielder Frenkie De Jong (signed from Ajax in 2019). He has restored Antoine Griezmann's glow after endless speculation as to his future at the club. Koeman's also teased impactful performances out of Trincao, a speculative long-term signing, and showed that Ronald Araujo, Ilaix Moriba and Oscar Mingueza -- all products of the club's

once-revered "La Masia" youth academy -- are ready for action.

Yet the aggregate 10-2 home thrashings by Real Madrid, Juventus and PSG in the Champions League this season, on top of the brutal humiliation by Bayern Munich in last year's Champions League quarterfinal, indicate that astute, highly specific purchases of established quality, experience, athleticism and power are paramount. They need direct reinforcements in defence, at centre-forward, at the tricky "pivote" role in midfield (the deep-lying playmaker) and left-back at bare minimum -- perhaps also at centre-half, too.

Laporta is now the man charged with steering Barcelona away from their calamitous €1.1bn (\$1.3bn) global debt, paying or delaying the short-term debts of some €750m (\$890m), and doing it while simultaneously renewing the (expensive) contracts of Dembele, Ilaix Moriba and Mingueza, buying a clutch of four or five top talents - including his dream ticket of Erling Braut Haaland -- and also both convincing and paying Messi to stay.

On paper, it's an impossible, Herculean task, but impossible isn't a word in Laporta's vocabulary. If you don't want to see one of the fan-owned, non Petro-dollar clubs on its knees for a generation, you need to care about whether Laporta does or doesn't prove to be the right president amid a profound crisis.

What does Laporta's win mean for Messi and the squad?

For the squad, there will be improvements no matter what. Howboard marked "talented ever he manages it -- and I'd not be at all bare, the first team still surprised if Laporta has a pre-arranged, ninefigure credit line aimed at staunching immediate existing debt repayments, renewing crucial contracts and making star signings -- Laporta will treat it as a primary task to make Barcelona competitive in Europe again. And, based on the green shoots this season, Spanish champions by

2022 at latest. Messi's future, however, is a different ball game. Sunday's jigsaw of media images and soundbites -- Barcelona's captain taking his son to the Camp Nou to vote in the presidential elections, Laporta's preelection promise that a vote for anyone else was likely to reduce the

chances of Messi staying, and the new president's claim that Barcelona's superstar then called to congratulate him on Sunday night -- all hint that it's not going to be "adios, then" to their magical Number 10.

But, of course, it's not that simple. There's no question that both Manchester City and PSG still want to acquire Messi, and they'll produce persuasive, lucrative offers. If you've been watching the greatest player in Barcelona's history over the past few months, certainly since December/January, you can't fail to have noticed that he's energised, happy, involved and scampering around again. His interplay with Griezmann, Dembele, Martin Braithwaite, De Jong, Jordi Alba and, most particularly, Pedri, whom he treats somewhere between a little brother and a winning lottery ticket, has been superb.

Perhaps most startling of all is the fact that Koeman, not a man known for his diplomacy or love of "star player" culture, has unquestionably won respect and a good training attitude from the best player he's ever coached or played with. Which is quite a list. If Koeman's staying with Laporta as president, there are well-selected new talents on the way and a decent financial offer available (thanks to new credit) that Laporta has brokered, then almost all the criteria needed to make Messi happy and ambitious will be fulfilled. Draw your own conclusions.

What is the biggest the job?

The list is long. But whether you, personally, think the biggest issue is Barcelona's debt, Messi's future, rebuilding a tired team, choosing whether it's time to retain Koeman as manager or bring Xavi back to the club from Qatar, rebuilding or renovating the slightly crumbling Camp Nou... here's my take. Laporta is the man

who put the hutz In chutzpah and the "swag" in swagger. Even when he stripped to his underpants in Barcelona airport to protest at the security guards insisting on him going through the scanners over and over again (something he now admits to regretting), Laporta is Mr. Charisma. He's bright, persuasive, connected and handsome, and his resume reads well. He's enormously ambitious,

Paralympic athlete heads to Tunisia

TANZANIA's Paralympic athlete Sauda Njopeka departs for Tunisia today, where she will compete at the World Para Grand Prix athletics meet slated for next week.

Tanzania Paralympic Committee (TPC) president Tuma Dandi said the Para athlete will be accompanied by her coach, Bahati Mgunda, to the event which gets underway on March 21.

He said before battling it out in the qualifying event, Njopeka will attend classification.

The trip to Tunisia, Dandi stated, has been sponsored by the government of Japan through Nippon University, while Tanzania's government, through National Sports Council (NSC), has paid for the visa, COVID-19 test and uniform for the athlete and the coach.

"Our athlete departs today for Tunisia where she will compete at the 2021 World Grand Prix which will be used as qualification tournament for Tokyo Paralympics, we thank the government through NSC and the government of Japan through Nippon University for paying air ticket, accomodation and other expenses for the athlete and the coach," he said.

The Acting NSC Secretary General, George Msonde, described Njopeka as an athlete with a vision and he said the council is confident that the athlete will qualify for the Tokyo Paralympics slated for August 24-September 5.

He also affirmed the government's commitment to sports for all people.

"We are very delighted that our athlete is going to Tunisia to attend the event which will be used as qualification for Tokyo Paralympics, it is our hope that Njopeka will perform well and earn qualification for the Paralympics," he said.

Previously, TPC through the committee's Secretary General Ramadhan Namkomveka told The Guardian that they have selected athletes who will attend qualification tournaments for Tokyo Paralympics.

The athletes are drawn from Para athletics, Para Powerlifting and Para swimming.

Namkoveka said Ignatus Mtweve, who was accompanied by coach Saleh Hussein from Zanzibar, competed at the just ended Dubai 2021 World Para Athletics Grand Prix 12th Fazza International Athletic last month but he failed to reach the qualifying time.

He also disclosed that there are other five events which will be used as Tokyo Paralympics' qualification tournaments.

They will be held in Colombia, England, Thailand, Georgia and United Arab Emirates.

However, TPC has opted for Dubai where the committee will send three power lifters and coach for the qualification event which is expected to take place from June 16-21.

The committee stated it is looking for sponsors to help them financially and materially to see to it the three power lifters head to Dubai.

He said the sponsorship will cater for air fare to and from Dubai, accommodation and COVID-19 test-

Namkoveka said three Para swimmers will attend classification and qualification. He said there are two events, one of which will be held in Sheffield, United Kingdom from April 8-11, and four days later there will be a two-day event in Lewisville, Dallas, USA.

He said TPC is waiting for confirmation from IPC on the World Para Swimming Championships, which will take place in Australia.

The TPC official, however, lamented on lack of resources to enable domestic athletes to attend the qualifying and classification events.

He noted: "Our aim is to see to it that we are sending our qualified Paralympic athletes to Tokyo Paralympics, we don't want to depend on wildcard, but the challenge is that we don't have financial power to send our athletes to qualifying and classification events."

"We are appealing to companies, organizations, stakeholders and individuals of goodwill to support us so as we can realize our dream of having many Para athletes at the Tokyo Paralympics on qualification card, not wildcard," he said.
