



# TMA: November-April rains will be enough for most farmers

THE coming November to April rains will be enough for crop production in most parts of the country that receive rainfall once a year, the Tanzania Meteorological Authority (TMA) has declared.

Speaking in Dar es Salaam yesterday, TMA director general Dr Agnes Kijazi said that during the period soil moisture is expected to be sufficient for farming in most areas.

The November-April rains also known as seasonal rains are specific for the western,

OREIGN Affairs and East African Cooperation minister Prof Palamagamba Kabudi yesterday flatly denied that the government has any intention of extending the presidential term limit.

Speaking in Dar es Salaam at the Mwalimu Nyerere Commemorative Conference 20 years after his death, the minister said respect for the constitution which currently allows two fiveyear terms is a national virtue that cannot be played around with. Prof Kabudi also sought to distance the government from voices that have in the past two years been agitating for changing the constitution to extend the presidential term limit.

Other periods of the year are expected to have low rainfall probability due to progressive warming over the Central Indian Ocean, the director noted.

# Local contractors get delayed tender margin of preference

TANZANIAN contractors will now enjoy a 15 per cent margin of preference–reduction of price margin during tendering–a legal right they were denied despite being stipulated in the Public Procurement Act 2011.

This shift follows eight years of pressure from the Tanzania Private Sector Foundation (TPSF), wOrking with the Public Procurement Regulatory Authority (PPRA) to lately inform the business community that contractors can now make bids in tenders where the 15 percent margin will be taken into account, with minimum threshold being 10bn/-.

The margin of preference is expected to make local construction companies

more competitive vis a vis their foreign counterparts when it comes to tendering for construction projects.

With the 15 per cent margin of preference

it means that from now, a local contractor submitting a tender request worth 11.5bn/and puts in a bid of 10bn/- and a foreign contractor submits a request of the right amount of money, the two bids shall be evaluated in equal fashion.

Dhruv Joy, a TPSF Board member and head of the construction sector at the foundation, told reporters yesterday that denied implementation of the legal right for margin of preference made local contractors uncompetitive.

They had no tolerable space to set prices that were lower but competing with foreign companies in tendering, he asserted. Local contractors were denied entrance

Rugemalira silent as Sethi formally seeks 'clemency'

ENERGY sector investor Harbinder Singh Sethi who is facing an economic crimes case has written to the Director of Public Prosecutions (DPP) seeking to use the presidential plea and payment engagement agreement to secure his freedom.

Sethi's advocate, Michael Ngalo, asked the Kisutu Resident Magistrate's court yesterday to help facilitate the process so that his client is released.

But nothing came from Sethi's co-accused, an associate at the IPTL independent power outfit, James Rugemarira (pictured). The two



were involved in the Tegeta escrow account saga, first appearing at the Kisutu Resident t Magistrate's Court on June 19, 2017 facing 12 r charges.

These included money laundering, but investigations into the case are yet to be completed and they remain in remand since the charges involved preclude bail.

Prof Anna Tibaijuka, who at the time the issue rocked Parliament was minister for Lands, Housing and Human Settlements Development, was recently quoted saying she was returning to the government the 1.6bn/- donation that her school, Barbro Johnson Model Girls' School, received from Rugemalira.

Observers said that this offer to return the money was made in a bid to secure his release.

Advocate Ngalo told Resident Magistrate Huruma Shaidi that the DPP was yet to respond to his client's request to negotiate his freedom, which involves confessing to the alleged crime and paying the state for the incurred losses.

The lawyer lamented that investigations into the case had dragged on for too long, urging prosecution to name the date when they are likely to complete the probe.

# Zanzibar to buy new boats to serve offshore islands

ZANZIBAR is set to buy new boats to ease transport problems facing islanders including elders living in small islands around Unguja and Pemba.

RESIDENTS in Katavi Region have been assured of improvement to the road infrastructure and provision of electricity and water in their areas in recognition of their huge efforts in the production of food crops.

The assurance was given Wednesday by President John Magufuli as he spoke to wananchi at a rally in Kibaoni, Mlele District. The president was in last stage of his 9-day official visit to three regions in South West of the country. Earlier the President inaugurated the 76.6 km Kanazi-Kizi-Kibaoni road and 85.3 km long Kavuu Bridge along

Majimoto-Inyonga road. The construction of Kanazi-Kizi-Kibaoni road is part

of the 245 km main Sumbawanga-Namanyere-Mpanda highway costing 102.4b/- wholly funded by the Tanzania government.

The construction of the Kavuu Bridge that connects Mpimbwe District Council headquarters and Mlele in Rukwa Region has cost 3.6b/- wholly funded by the Tanzania government.

President Magufuli said he has directed the Ministry of Works, Transport and Communications to start preparatory work for the construction of the 71 km Kibaoni-Sitalike stretch which remains to be tarmacked and which will eventually connect Rukwa and Katavi regions through Katavi National Park.

He explained that the government has resolved to ensure the Mpanda-Uvinza-Kanazi main highways at tarmac level is completed so that the southern highlands region that joins Tanzania with Zambia, Malawi up to South Africa is connected to western regions that connect Tanzania with Rwanda, Burundi, DRC and Uganda.

# NEC stresses need for citizens to register for November civic polls

### **By Guardian Reporter**

THE National Electoral Commission (NEC) has said the voters' identity cards issued by the commission will not be used in the next month's civic polls insisting on people to separately register for the exercise at local government's offices.

Speaking in Dar es Salaam yesterday, NEC Director Dr Wilson Mahera insisted that registration for the civic polls started on October 8th this year and is supervised by the President's Office, Regional Administration and Local Government. The civic polls will be conducted on November 24th, 2019.

"We are not supervising the polls, but we insist on eligible Tanzanians to register since unregistered residents will not be allowed to vote," said the Director calling upon Tanzanians to massively register for the November polls.

Dr Mahera said Section 74 (6) of the country's Constitution directs NEC to register and supervise General Elections where citizens in both, Tanzania mainland and Zanzibar vote for the President, legislators and councilors.

"The ongoing registration at local gov-

ernments is different from NEC's ongoing update of permanent voter register currently going on at various regions across the country. We are registering voters for the 2020 General Elections," he said.

Dr Mahera said NEC is now preparing to update the voter's permanent register in Tabora, Katavi and Uvinza district in Kigoma region. He said the exercise will take place between October 14th and 20th this year.

He said NEC will conduct a similar exercise in Songwe, Dodoma and Singida regions from October 26th to November 1st, 2019.

Last week, Minister of State in the President's Office responsible for Regional Administration and Local Government, Selemani Jafo, said the civic polls will be held on November 24th 2019.

He also announced names of 184 public officers who will oversee civic polls.

He said regulations demanded that candidates should be sponsored by political parties with permanent registration.

The minister added that only eligible citizens will contest in the elections and they will be required to collect and fill in nomination forms 26 days before the polls.

# Fighting mental diseases will be long, arduous national mission

ber of people with mental disturbances in the country is on the increase - with Dar es Salaam Region leading the pack, accounting for 20 per cent of all cases.

Hospital records show that the number of patients with mental health problems rose from 301,000 in 2016 to 356,000 last year countrywide, an increase of slightly over 25,000 new patients each year.

Some experts in a recent workshop to discuss a World Health Organisation report on the same on occasion of World Health Day all the same noted that there were some centres whose data were not fully taken into account, implying that the situation is much worse.

In any case, even without having exact numbers, it is enough to take account of the breadth of post-college unemployment to see how acute the situation is likely to be.

And there are no easy answers in this context, outside a certain amount of advice and facilities for screening, etc. This figure is however seen as conservative as it excludes current data from the Muhimbili National Hospital (MNH) in Dar es Salaam, Mirembe Hospital in Dodoma and various specialised centres.

It was not however altogether remarkable that out of this figure, Dar es Salaam region has 20 per cent of the cases, while the breakdown for other major urban centres is more accidental

Indeed, it is not evident that the number of cases for Dar es Salaam is per capita wise the highest, as Kilimanjaro Region has slightly below 50 per

XPERTS say that the num- cent of its cases, whereas population wise it scarcely squares up with half of the Dar es Salaam population, which by some estimates stands at around five million people. It implies that major urban centres around the country are tougher places to live in for youth than Dar es Salaam.

The other mental disturbance major centres are Kilimanjaro (9 per cent of total), Tanga (7 per cent), Morogoro (5 per cent) and Mwanza (4 per cent).

Surprisingly, Katavi had the fewest cases at 0.1 per cent of the national total, which also needs to be explained. One explanation for this is that less urbanised than the rest, which means that rural areas offer greater scope of adaptation even for its small towns.

The observation was helpful to picture how we would shape up when we joined the rest of the world in marking World Mental Health Day yesterday.

A top-level expert at the Mental Health and Substance Abuse Unit under the Health ministry explained that the sharp rises in mental ill health were tied to economic hardship and substance abuse.

Still, the wider scope of associating mental illnesses with hereditary factors, biological disposition, disasters, injuries and some diseases like malaria and HIV/Aids that also have side-effects on the brain is likely to account for marginal numbers of mental disturbances. Such factors are fairly well distributed countrywide, and still urban centres with better medical facilities have higher levels than vast rural zones. That's why the battle against mental illnesses will be long and hard as it is in fact a matter of restoring hope from childhood to adulthood.

# When returning home is deadly, and shame is the returnees' worst enemy

he six-day journey to Spain's Canary Islands from Dakar, Senegal's capital, on an agitated sea did not break Moustapha. Nor did hearing what happened to the other five boats departing with his: none of them made it, nor did the hundreds of people they carried.

"I was lucky enough to succeed, despite all the difficulties: the wind, the cold, the 20-meter waves, all of it," he

# Hacking into HESLB loans allocation database is case of economic sabotage

EPORTS that there have been close to 2,700 attempts to hack the Higher Education Students' Loans Board (HESLB) online loans application and allocation database as the new academic year starts are unsettling.

This wave of criminality falls squarely into the cyber crime category, and its perpetrators ought not to think that they are being clever. Even if it takes time, hacking can be tracked to source.

The key reason for hacking into the higher education students' facility is the wish to irregularly release money to applicants, that is, add names in a fraudulent manner to approved loan applicants.

That expectation shows something close to gross naivety, as it first presumes that the hacking would not be noticed, and thus the list for eligible beneficiaries will be taken casually. Neither of the two end points of the hacking frame of mind suggests rational planning in it.

Still, as top HESLB officials have remarked, those attempts were blocked thanks to improved data and systems security, meanwhile as the board is connecting the database with systems of kindred organisations such that obtaining a permit to operate any of its wings or endpoints is more difficult.

A back-up site has been established at the National Data Centre in Dar es Salaam and four ICT experts have been recruited, boosting its ICT strength.

This ought to improve system resilience in the face of sustained attacks from persons taking a brush with the law, thinking they are clever and can simply and safely insert names.

More directly, the board has developed an online Student Individual Permanent Account, a students online correction facility and an online appeal facility, which HESLB says have already been completed and tested. It means some waiting queues will be cut short. When the database and allocation system are connected with the National Council for Technical Education (NACTE), the Tanzania Commission for Universities (TCU) and other key stakeholders, the sabotage agents will find it more difficult to operate.

Even being able to break into the database is a massive problem, although no irregular allocations were noticed which would then occasion such an induiry. So, the system is working properly but is being strengthened.

There is also an issue that has just surfaced where the board says it is contemplating making the application window open throughout the year.

Yet, on the basis of its current operational format, it will not have much to do for the rest of the year outside managing in a continuous manner what had already been decided at the time of starting a new academic year.

The point is that the board only considers the applications of those who have obtained admission into universities, not applying to such institutions, to eliminate or drastically cut cases of double allocation if someone obtains into two academic institutions.

There were other issues that a leader of the Tanzania Higher Learning Institutions Students Organisation (TAHL-ISO) touched on. One is that many students fail to get loans for failing to properly fill in the forms as they are challenged in technology use.

Similarly, students who studied in private schools are denied loans as their families are supposed to be well off, which the student leader questioned.

Still, even if such worry comes around, it is no basis for hacking the HESLB database to falsely raise the number of beneficiaries, so the applicants or their parents, guardians or sponsors should stop playing with fire.

says in his home in the fishing town of Thiaroye-sur-Mer on the outskirts of the Senegalese capital.

But if the journey didn't break Moustapha, something else almost did: returning home empty-handed. Back in Thiaroye in 2006, Moustapha faced the contempt of his neighbours. Family members refused to put him up. He was a "failure".

"Here in Senegal, it is not in our culture to accept someone who tried to migrate and failed," the young man explains. He was discouraged, alone and ashamed at having failed his family, to whom he had promised a better future. "If at the time I could have killed myself, I would have," he notes.

In Senegal, many returnees come home after traumatic journeys, only to find themselves excluded from their families and communities. With little to no social or psychological support, some end up taking their lives.

Researchers and local returnee support groups point to a handful such cases in recent years. For each migrant who took their life, dozens more suffer in silence, like Moustapha did.

A Health ministry official says mental health services are few in Senegal, a country with around 30 psychiatrists for 14 million people.

"Returning 'home' can be mistakenly seen as an easy and unproblematic process as migrants reintegrate and resettle in their hometown and within their communities and families," said Gaia Quaranta, a Dakar-based psychologist for the International Organisation for Migration (IOM) Regional Office for West and Central Africa.

"This assumption does not consider the emotional, social and cultural complexity and the readjustment challenges the returnees might face," she notes.

"Upon their return, some migrants can face negative psychological reactions like shame and guilt, self-perception to be a failure, hopelessness, low self-esteem, frustration or anger," Quarant explained.

She elaborated: "It is important to

psychiatric care and psychological support might be needed.

Sometimes, the best one can do to help returnees is to talk to them. To avoid having others slip into the kind of despair he experienced, Moustapha created a support group in Thiaroye for migrant returnees.

"If someone has 'failed', we have to take a step in their direction, talk to them, and tell them: 'This is not the end of the world'," he explained, adding: "We can stay here, make money here, and feed our families here."

On most days, Thiaroye's young men gather around Moustapha at the local carpenter's shop, kept in the shade by freshly painted doors set outside to

dry. Over a few small glasses of attaya, the local tea, those who came back talk to those others who still dream of going. Challenges, failures and fears are all discussed, and the debates sometimes become heated. But the men are no longer alone in dealing with the suffering and the shame.

Statistics on the suicide of returnees are hard to come by. In a country whose religious observers are 95 per cent Muslim, suicide is a taboo, and many such deaths go unreported by families or undetected by the authorities.

Nor are there official statistics on suicide in Senegal, generally. "In Dakar, deaths by suicide are uncommon and their number is probably under-estimated because of socio-cultural, religious and economic obstacles as well as the failures of the legal system," university professor Mohamed Maniboliot Soubah concluded in a 2013 study. "In these cases of suicide, these are people who were having a hard time dealing with the return," says Aly Tandian, the president of the Saint Louis-based Study and Research Group on Gender, Environment, Religion and Migration. Through his research on migration, he has documented suicides of Senegalese migrants in the country's east as well as in Niger.

As vice president of Migration and Development Yaraax, an NGO returnee support group located in another fishing town on the outskirts of Senegal for its high rates of departures, Dioum now tries to replicate the support when others come home to the town of Yaraax-Hann.

"When an individual in this state comes back, you have to know how to welcome him, how to handle him, how to help him get through this tough time. Otherwise he can become withdrawn, and get negative thoughts leading to suicide or alcohol," the group's president, Magath Diop, said.

Since 2017, the IOM has provided psychosocial support to over 6,000 returnees in West and Central Africa in the framework of the EU-IOM Joint Initiative for Migrant Protection and Assistance funded by the EU Emergency Trust Fund for Africa and implemented by the UN agency in 26 African countries.

"We must work at family and community levels to decrease the risks of social marginalisation and exclusion - which constitute risk factors to their psychosocial wellbeing. At the same time, given the difficulty of accessing psychosocial support, we must facilitate the reactivation of social support mechanisms, such as peer support groups," IOM's Quaranta noted.

In order to address the multiple psychosocial needs of returnees better, IOM seeks synergies with various governmental and non-governmental actors to protect and promote their psychosocial well-being.

In Senegal, IOM provides mental health and psychosocial support to returnees in the main regions of high returns, particularly Tambacounda, Kolda, Seidhou and Ziguinchor.

IOM psychosocial support is provided through a range of activities, including psychological first aid, individual counselling sessions, identification and referrals to specialised mental health care, family mediation, and psychosocial support groups.

Among the other activities are integration of psychosocial support in livelihood activities and during business-skills trainings, and capacitybuilding aiming at strengthening the technical capacity of identified governmental, non-governmental and civil society partners to respond to the psychosocial needs of returnees and their families.

wo decades into the 21st century, all too many people still associate being 'overweight' with prosperity, health and wellbeing, mainly because being thin has long been associated with being emaciated due to hunger, undernourishment and malnutrition.

Overweight and obesity can easily be assessed by anthropometric measures, including the body mass index (BMI) and waist circumference. But BMI thresholds for overweight and obesity may differ by ethnic group or country.

The standard World Health Organization (WHO) BMI cutoff for overweight is 25, while the threshold for obesity is 30, understood as an abnormally high percentage of fat, which can be either generalized or localized.

### **Obesity pandemic**

In 2014, McKinsey Global Institute estimated 2.1 billion overweight people, including the obese, then almost 30% of the world's population. The related economic burden was estimated to be over US\$2 trillion, a close third to civil conflicts and smoking.

By 2016, an estimated 1.97 billion adults and over 338 million children and adolescents worldwide were categorized as overweight or obese, following



the rapid increase in overweight, including obesity, in recent decades.

An estimated 6% of children under 5 years of age were overweight in 2016, up from 5.3% in 2005. Similarly, the prevalence of overweight and obesity among adults rose by 27% between 1980 and 2013.

The situation in many middle-income developing countries is especially dire as higher incomes and more food consumption have reduced hunger while

worsening other forms of malnutrition, including 'hidden hunger' or micronutrient deficiencies. The resulting health condition of much of the population generally imposes heavy costs for themselves, their families and their nations, while reducing their incomes.

**Role of the brain** Obesity is typically due to nutrient imbalances where food ingested is stored as fat, instead of being utilized for energy and metabolism. Epidemiological evidence suggests 'high fat' and carbohydrate diets contribute to obesity, and the relationship between

of obesity.

Although there is now a near consensus that unhealthy diets worsen obesity and health, less is known about neurological changes to the brain due to such diets. Recent research finds that high-fat diets – specifically those with considerable fats and dietary fat and the degree carbohydrates – contribute to irregularities in parts of the brain regulating body weight.

A recent study found that high-fat diets stimulate inflammation in the brains of mice, triggering physical changes in such cells, and encouraging the mice to eat more and become obese. As this happens before the body displays signs of obesity and body weight changes, it implies that high-fat diets induce the brain to want to eat more. Thus, it is possible that

high-fat diets may not just affect humans physically, but also alter food intake neurologically. Hence, it is detrimental when food rich in fat and carbohydrates is easily available, encouraging even more eating.

### Health threats

Many factors contribute to obesity, including lifestyle, diet, individual genetics and gut bacteria. Besides high fat and carbohydrate diets, immune system activity can also contribute to obesity, although details remain unclear.

The presence of large numbers of fat cells changes micro-biomes inside the body, causing the body to respond negatively. Worryingly, obesity has been closely linked to various chronic diseases including cardiovascular disease, diabetes and other metabolic disorders.

Recent research also clarifies how they affect various diseases of the brain, including Alzheimer's, a neurological disorder associated with changes in brain cells more prevalent among the obese.

Such evidence continues to grow. Therefore, high fat diets have not only contributed to the developing world's overweight and obesity pandemic, but may also have caused damage to brains and brain functioning.

### Prevention better than cure

Changing diets, food consumption and human behaviour have all contributed to the nutrition transition and obesity pandemic.

While the developing world makes slow progress in overcoming hunger, or dietary energy undernourishment, much more needs to be done to educate the public about problems of malnutrition besides macronutrient deficiencies.

Micronutrient deficiencies, or 'hidden hunger', as well as diet-related noncommunicable diseases also need to be addressed. Already, those associated with overweight and obesity have been growing rapidly to pandemic proportions in recent decades, mainly due to dietary and other behavioural changes. IPS

# Libya's war becomes a tech battleground

ibya's current conflict is emerging as a very different one to what has been fought before in the country, or the world. Fleets of long-range drones carry out strikes, cyber-attacks proclaim the end of governments, and social media propaganda has become all-consuming. The war has devolved into a bloody stalemate, with over 1 000 fighters dead and thousands wounded in grinding urban conflict. Khalifa Haftar's Libyan Arab Armed Forces (LAAF), a militia coalition based in the east of the country, have been on a mission to seize Tripoli since April. The capital is held by the internationally recognised Government of National Accord (GNA), supported by militias from across western Libya. But while it is Libyans who are fighting and dying, foreign actors have largely been driving this war. Turkey and Qatar support the GNA, while the United Arab Emirates (UAE), Egypt, Russia and France are behind the LAAF. These foreign backers have contributed diplomatic support, military equipment, mercenaries and military personnel, and direct military action to the two sides.



# Women in Kenya's Nyeri County gain from breast cancer testing campaign

# NYERI, Kenya

THE Kenyan government, the Health ministry's National Cancer Control Programme (NCCP) and GE Healthcare have launched a mammography screening campaign across Nyeri County to promote early detection of breast cancer.

The one-month campaign will target over 10,000 women aged 40 years and above, which is the recommended age for such tests. Over 50 Community Healthcare Volunteers and 30 healthcare professionals have been specifically

### has seen some 900 missions flown by drones fielded by the two sides, and this has increased steeply in recent weeks. Both sides use them for surveillance, longrange strategic strikes on arms depots and airports, and close-air support to units enmeshed in urban combat.

The GNA and LAAF rely on foreign actors for their drones. Since May, Turkey has supplied the GNA with more than a dozen Bayraktar TB2 craft, as well as ground control units. The UAE has provided the LAAF with the Chinese Wing Loong II drones. Both Turkey and the UAE are rumoured to have deployed personnel to Libya to operate the drones. Armed drones are ubiquitous in Libya, and will be on future battlefields, both due to the relatively high-precision attacks they can undertake and because they are far cheaper than traditional attack aircraft. A Wing Loong II costs US\$1-2 million, and even the pricier Bayraktar is just less than US\$6 million.

Militaries can therefore more easily purchase and field large numbers of drones, and replace those lost in combat. Other countries - such as the UAE and Turkey - can also provide foreign proxy forces and militias with effective airpower at little cost and limited risk to their own personnel. Recent use by GNA drones of roads, rather than airstrips, for take-off and landing, shows the ruggedness of the craft, and the potential for their use even in austere conditions.

Alongside drones, hacking and cyberattacks have been weaponised in Libya's conflict. The most publicised incident Libya, the current conflict occurred in August when the GNA Twitter

account was hacked, and a false statement of this has been disseminated through posted proclaiming the GNA had stepped down and security was to be left to the LAAF.

In another incident, a hacker culled information from Facebook users after setting up a series of false pages detailing Turkish activity in Libya or spoofing LAAF recruitment sites. The hacker later published secret LAAF documents and the passport information of government officials that had been collected.

Similar to drones, cyber-attacks offer a low-cost means of achieving conflict goals. The hacking of the GNA Twitter account led to little more than public confusion, but given the increasing importance of social media for government's public communications - in both Libya and globally - the risk of a future incident achieving greater goals is real.

Libya's conflict has also seen a wave of propaganda and disinformation as the GNA and LAAF, and their foreign backers, seek to shape public opinion to their advantage. Haftar's initial attempt to seize Tripoli rested as much on the narrative of the LAAF's might and inevitable victory as it did on raw military power.

With this narrative shredded by the LAAF's failure, propagandists on both sides have tried to reshape public attitudes and support. Social media posts proclaim their side's seizure of territory or inevitable victory, or their rivals' brutality against civilians and foreign connections.

A lot of the propaganda is foreign generated, with nearly a third of content around Haftar posted over the past six months coming from Saudi Arabia. Much

social media, showing that sites such as Facebook and Twitter are go-to sources for news and information for many Libvans.

Propaganda has long played an important role in conflict. But what Libyan propogandists and their backers have shown is the speed through which new narratives and disinformation can be spread, how social media can be used for this, and how easily foreign actors can influence and engage in public debates in Libya in real time.

Each of these factors - drones, cyberattacks and social media propaganda - have been used to varying degrees individually in different countries over the past two decades. Drones in particular are evolving rapidly into a versatile threat to even highly advanced militaries.

However Libya's uniqueness - and its value as an example of what future conflicts will look like - arises because all these factors are currently being employed together in large amounts, in a conflict being prosecuted primarily by non-state armed groups.

It is important to closely watch Libya's conflict to predict future wars. Understanding the contours of future battles, and how foreign actors can intervene, will help prevent and address conflicts. In Libya's case, the country needs international support to surmount these conflict dynamics. The successes and challenges it faces will offer valuable lessons for peacebuilding in future.

armed conflict. The carnage of First World War battlefields is a stark example of what happens when advances in weaponry outpace the normative frameworks around its use.

Today, we are experiencing a technological revolution that holds incredible promise for human development and welfare. From genome editing to quantum computing and artificial intelligence, emerging technologies offer us powerful new ways to achieve our shared commitments, including the Sustainable Development Goals.

Our networked society is promoting a "democratization" of technological dissemination. Ease of understanding and using technology is greater than ever before. Yet these benefits also bring with them clear risks for international peace and security.

Before I address the trends and consequences of the current technological context, I want to add my usual caveat: it is important not to be alarmist about the ramifications of technology, but at the same time not dismissive either.

With that, let me share with you some of the major trends in conflict risk as I see them and the implications they carry for international peace and security.

First, the application of technology to new means and methods of warfare is aggravating an arms-racing dynamic in both conventional and nuclear weapons. This dynamic is evident in the eyewatering amounts of money spent on weapons - some 1.8 trillion dollars last year, according to SIPRI - and the nu-



clear modernization campaigns that are, in effect, a qualitative nuclear arms race.

This is both exacerbated by, and in turn exacerbates, the absence of transparency and confidence in international relations. As States strive to develop newer and better weapons, it threatens to undermine stability and increase the prospects for unintended and potentially uncontrollable escalation.

This dynamic is not limited to States with advanced technological bases. The democratic characteristics of technological innovation provide for creative asymmetric responses - the digital IEDs, if you will.

The second trend I want to highlight is how technology is opening new potential domains for the conduct of hostilities.

Military operations using emerging technologies and in new domains can involve actions that are not easily classifiable or fall below traditional thresholds for an armed attack or an act of aggression.

This creates challenges for in-

ternational peace and stability, as even non- permanent means of disrupting or disabling a military capability can prompt a conventional armed response.

Take, for example, what is commonly referred to as "cyber warfare".

The frequency of malicious cyber incidents is growing, along with their severity. Such acts are contributing to diminishing trust and confidence among States and encouraging them to adopt offensive postures for the hostile use of these technologies.

The difficulty of attributing responsibility for cyber-attacks could result in unwarranted armed responses and escalation. Constraints agr the case of cyberattacks that do not cause physical damage and are not lethal.

New domains and methods of warfare will also change the impact on civilians in ways that are less kinetic but equally damaging. For example, "casualties" in a cyber conflict could include millions of people who have had their bank accounts wiped out by an offensive cyberattack.

Put differently, some of these new technologies could not only change the size and speed of destruction in conflict, but also the character and nature of destruction in war.

A third and related trend is how certain new technologies, in particular armed uncrewed aerial vehicles, are undermining civilian protections. Lower risks to armed forces and comparatively lower levels of physical violence risk lowering the threshold on the use of armed force in situations where it would not otherwise have been

contemplated. Such actions not only endanger civilians, but risk escalating conflict. The fourth and final trend I want to draw attention to is the emerging nature of warfare enabled by networked militaries, autonomy, uncrewed vehicles, advanced sensors, and weapons that can attack at hypersonic speeds.

This form of warfare is not yet fully realized, but technological innovation, coupled with evolving military thinking, is trending the world in this diduce decision-making times while also adding ambiguities

related to the nature of their targets and their own payloads, whether conventional or nuclear. Increased adoption of Artificial Intelligence (AI) may lead to decision-making processes faster than human cognition and concern has been expressed about the potential for unpredictable and nontransparent behaviour by AI in armed conflict.

Increasing autonomy in the critical functions of weapons systems raises serious ethical and legal questions for existing frameworks and how to ensure human accountability for the use of force. The growing use of UAVs and increased autonomy could lead to perceptions of casualty-free warfare.

The possibility of third parties with malicious intent interfering in control systems to incite conflict cannot be discounted. The potential for such advances to exacerbate political divisions and global tensions would be alarming even in the most benign of international environments.

However, we are currently mired in a geostrategic context defined by distrust, the militarization of international relations and a dearth of dialogue. Relations between the so- called "great powers" are eroding as the rules-based international order - including the disarmament and non-proliferation regime - is being challenged.

Other global issues - climate change, mass migration and social unrest - will also continue to affect the nature and conduct of armed conflict.

In this unsettling environment, where brakes on warfare are being removed, the utmost caution should be exercised in

much harder task to elaborate solutions.

I would like to suggest today what might be some of the key elements, from the United Nations' perspective, for our joint work ahead to elaborate possible solutions. Some of them relate to substance, others to the process and partnerships we must forge.

First, a few points related to the development of norms and their operationalization or im-

plementation. One of the most prominent debates in the governance of emerging technologies has been whether international frameworks can adequately contain new risks and concerns. There is divergence over whether existing law is sufficient or whether new legal instruments are required.

Some new technologies, such as armed drones, have prompted concerns about how they can tempt some to reinterpret international law.

What we need is an honest debate about how international law applies to any possible use of emerging technologies as weapons, how any such uses are constrained or prohibited by existing international law and where new approaches, including new law, is needed to mitigate foreseeable risks. Increased transparency and accountability in the use of

new technologies could help increase confidence in adherence to international law. When it comes to the weaponization of new technologies, broadened use and transparency of weapons reviews those required under article 36 of Additional Protocol I to the 1949 Geneva Conventions - would build confidence about the legality of those weapons

to be a central concern when addressing the means and methods of warfare.

This is a tenet that we cannot lose sight of as States rush to utilize technological innovations in armed conflict.

We must reinforce mechanisms for the protection of civilians, including respect for and compliance at all times with applicable international law, including international humanitarian law.

While Member States will continue to have primary responsibility in matters of international peace and security, twenty-first century norm-making cannot be just straightforward treaty negotiations between States.

Much of the technology we have been discussing today is either dual-use or even enabling. Its creators need to be brought into the fold.

The importance of developing effective multi-stakeholder platforms that can bring together experts from Member States, industry, academia and civil society should be a priority.

This is important not only to ensure that intergovernmental deliberations are adequately informed, but also that technical communities are aware of the context and possible consequences of their work.

Modern norm-making should consider a broad spectrum of responses, from self-regulation such as code of conducts, to political initiatives such as transparency confidence-building and measures, to comprehensive and multifaceted efforts in the traditional intergovernmental negotiations.

# Mwalimu Nyerere's wisdom as relates to freedom, development and democracy

AS we mark the 20th anniversary of the passing of Father of the Nation Mwalimu Julius Kambarage Nyerere, it is of fundamental importance and immensely relevant that we 'flash back' to his wisdom so as a nation we continue to be judiciously guided towards prosperity.

Today, 20 years after his death, the nation still sobs as it remembers the great leader who assured peace and protection for everyone regardless of their religious beliefs, tribes or ideological inclinations. He was a true fortress and truss for the poor and disadvantaged majority.

Today we continue to honour Mwalimu in part because of his time-tested wisdom and love for his people. Let us always uphold his good vision, hopes and optimism on leadership, freedom, democracy and development to inspire, nurture and keep our unity as a nation and as a people alive.

Mwalimu's wisdom with respect to freedom and development was guided by his belief in a kind of democracy that gives space to the citizenry to develop their nation



in general and Tanzania in particular to embrace a democracy that ensures governments of national unity, in which freedom and development are intertwined to unite the people to work harder and more productively for the country's development

He firmly believed that just as real freedom for the people requires development, so does real development of the people require freedom.

In this chronicle we treatise Mwalimu's wisdom as entrusted to us through his 1967 book entitled "Freedom and Development". In this book he defines the role of leadership, freedom and democracy in bringing development to the people. He also gives two essentials of democracy that ensures Freedom of participation in the democratic decisions towards sustainable development serving the people's interests.

Commenting on the role of leadership and democracy in ensuring sustainable development, he once wrote: "There are thus two factors which are essential in the development of people. The first is leadership through education, and the second is democracy in decision-



"For leadership does not mean shouting at people; it does not mean abusing individuals or groups of people you disagree with; even less does it mean ordering people to do this or that. "Leadership means talking and discussing with the people, explaining and persuading. It means making constructive suggestions, and working with the people to show by actions what it is that you are urging them to do. It means being one of the people, and recognizing your equality with them."

Mwalimu insisted that giving leadership authority does not mean appropriating the role of the people, once declaring: "The people must make the decisions about their own future through democratic procedures. Leadership cannot replace democracy; it must be part of democracy.

"If the decision relates to national affairs, then the people make it through the (ruling party's) National Executive Committee, and Parliament, and through the National Conference....

"If it is a question of purely local interest - for example whether to undertake a particular self-help scheme - then the people directly concerned must make the decision following a free debate. There is no other way in which real development can take place." Mwalimu believed in the fundamental principles of democracy that would promote freedom and unity of a nation. He described two essentials of democracy, the first being freedom to speak and the second being the discipline to uphold the decisions made under a democratic processes.

He wrote: "There are, however, two essentials of democracy of without which it

(democracy) cannot work. ... everyone must be allowed to speak freely, and everyone must be listened to. It does not matter how unpopular a man's ideas, or how mistaken the majority think (of) him. It does not make any difference whether he is liked or disliked for his personal quali-

Mwalimu Nyerere continued to describe this first indispensable attribute of democracy by writing: "Every Tanzanian, every member of a community, every member of a district council, every Member of Parliament, and so on, must have the freedom to speak without fear of intimidation – either inside or outside the meeting place."

He also wrote on the rights of the minority in a democracy: "The minority in any debate must have the right to speak without fear of persecution; it must be defeated in argument, not by threat of force. The debates leading to a decision must be free debates. And even after a decision has been made, free discussion about it should be allowed to continue. For the minority must know that if it has a good case, and if it argues properly and correctly,

it will be able to convert the majority."

He also wrote on the rights of the majority in a democracy: "Similarly, the majority must be willing to maintain the argument until the minority has been convinced of the correctness of the decision which has been made. Free debate must continue. It is an essential element of personal freedom."

Mwalimu's wisdom further directs that in the case of an adequate discussion and every point of view has been expressed, a decision must be reached, and the majority must be allowed to prevail. He recaps that the minority have a right to be heard, and the majority have the right to be obeyed. The second essential of de-

mocracy, according to Mwalimu Nyerere, is the ability to uphold the decision made in a democratic debate. He wrote: "Once a decision is reached, it must be accepted as the decision of all. And everyone -including those who were in opposition must cooperate in carrying out that decision... For democratic decision-making must be followed by discipline in carying out the decisions.

"The minority must be allowed to campaign for a change in the law or the de-

cision. But until they have succeeded in getting majority support for a change, they must obey the law or the rule which has been laid down. Without this kind of discipline no development of any kind is possible.'

In conclusion, it is safe to say that Mwalimu's wisdom exceeded common knowledge; that it is a repository of knowledge that illuminates our way forward.

That wisdom should continue to guide Tanzania well into the future. His spirit should be allowed room to hover and breathe knowledge and understanding to the people and its leaders so that all may work for the country's development and ensure prosperity to the nation. We thank God for having entrusted this abundantly blessed country to such a saintly leader who could foretell the future with enviable accuracy and illustrate the way for the people to follow towards a bright future of sufficiency.

**Mboweni's influence put to the test**

The next few weeks are crucial for South Africa's economy as Minister of Finance Tito Mboweni attempts to shape the message of his 30 October Medium-Term Budget Policy State-

these plans almost immediately met with fierce opposition from the Congress of

South African Trade Unions. The ruling African National Congress (ANC) has given Mboweni only partial approval for his blueprint. Much of its response has dodged the hard issues such as dealing with Eskom, until the Medium-Term Budget Policy Statement is delivered. On labour market reform, the ANC has said the minimum wage needs to be discussed at the National Economic Development and Labour Council again. Interestingly, despite the aversion to selling off coalpowered stations, the ANC has acceded that an energy mix based on the lowest cost option is imperative. That will force renewables into the country's energy mix in a far more robust way. The implications for Eskom are obvious. Economics is also about politics and so Mboweni's speech will be closely watched as an indicator of what the ANC's stance is on these hard-fought economic matters. It will also be a test of Mboweni's influence over his cabinet colleagues, for those stand-offs are crucial too. If Minister of Public Enterprises Pravin Gordhan requests a bailout for state-owned enterprises, can Mboweni deny him and proceed with selling some of them off? It's hard to see how this could happen without decisive intervention from their boss, the president. Therein lies the rub. In previous, more stable post-apartheid years, the Medium-Term Budget Policy Statement was largely an understated affair with a few tweaks made to the national budget. The entire process is aimed at ensuring maximum budget transparency (something South Africa is renowned for) and provides

President Cyril Ramaphosa for his part has appointed an Economic Advisory Council to ensure that both government and society are equipped to respond to changing economic circumstances. This was a promise he made in his State of the Nation Address, and according to the Presidency's statement, 'the council will advise the president and government more broadly, facilitating the development and implementation of economic policies that spur inclusive growth.'

The council comprises local and international experts. Doubtless its work will traverse the nine wasted years under former president Jacob Zuma and the corruption and state capture that period brought. Understanding the depth of the rot in government and then dealing with it will take time. Ramaphosa is also grappling with a state so weakened by corruption that delivering on the many promises he has made will be difficult.

In Mboweni the country has a finance minister who is unafraid to take on the holy cows of retrenchment and state-owned entity bailouts. He tells it like it is. Mboweni has famously said he is not the 'minister of bailouts.'

His economic blueprint released in late August received a mixed response. It includes a nod to privatisation, ease of doing business regulations and an attempt to increase growth to 3% while creating a million jobs. It also suggests selling off power utility Eskom's coalpowered stations. Of course, an overview of income and

expenditure over the next three with this, and crucially, where will need to provide some inforyears. It was a process built on painstaking number-crunching within the National Treasury.

Any finance minister needs credibility, a strong revenue collection service and an equally reliable Treasury. Both the South African Revenue Service (SARS) and Treasury have been severely weakened. New SARS Commissioner Edward Kieswetter has been working feverishly to rebuild the institution, but again, that will take time. Moody's has forecast economic growth at 0.7% down from its original forecast of 1.3% for 2019. It remains concerned about the debt-to-GDP ratio.

This Medium-Term Budget Policy Statement will be delivered against a backdrop of political unease and a citizenry increasingly frustrated with the economic and political crises. Mboweni will reveal what the revenue shortfall will be. It is estimated to be at around R50 billion given how sluggish the economy is. How will he deal

will Mboweni cut expenditure? His statement must also deal with wasteful expenditure in government as a matter of urgency.

Mboweni is not the minister of bailouts, yet how will Eskom be fixed? The ANC's response has been unclear, even with its proposal to restructure Eskom into three units. But Eskom isn't the only drain on the fiscus.

South African Airways is in immediate crisis with strikes threatened in late September. Then there is the state-owned aerospace and military technology conglomerate Denel, the South African Broadcasting Corporation, the Passenger Rail Agency of South Africa and a laundry list of corruption and maladministration. The state has also been slow and ineffective in paying its suppliers, thus creating a choke on small business development.

Government's new plans on a National Health Insurance will need to be funded too. Mboweni

data is five months out of date when it reaches the public. When crime levels increase (as they have this year), headlines lament. When any decreases are seen, these are linked to strategic efforts by the police.

Nationally, murders have risen by 3.4% since 2017-18 and are 35% higher than in 2011-12. The 21 022 murders average out to 58 killings every day across the country. However, these murders are not evenly spread across time and space. Over half (56%) of murders happen on the weekend. Spatially, a small number of police stations bear a disproportionate share of violent crime. In the latest statistics, the 30 police stations reporting the highest numbers of murders (roughly 3% of all stations) account for 21% of the total. As one example among these, the Greater Khayelitsha area (comprising three police stations - Khayelitsha, Harare and Lingelethu West) experienced an annual murder increase of 20%.

Yet even station-level figures mask critically important patterns of crime that can only be studied through accurate point-level crime data. This data records each crime by type, exact geographic location and exact date and time of the incident.

Internationally, spatial-temporal crime analysis has revealed crime hotspots and temporal patterns that have aided efforts to prevent and reduce crime. This is central to many evidence-based policing practices.

In Trinidad and Tobago, a country with a high level of violent crime, hotspot analysis enabled smarter police patrols and a 50% decrease in murders. The possibilities for data-driven policing (and interventions by those outside the police) to pinpoint and alter violent crime patterns in South Africa are genuine, if not a dire imperative.

In South Africa, access to point-level crime data has been highly restricted in the past, with only a handful of researchers able to use it. A new Institute for Security Studies report on point-level crime data for Khayelitsha is among the first to publish and interrogate such data.

The report shows a general dispersion of crimes across the Greater Khayelitsha area with much higher concentrations near intersections, medical facilities, train stations and even police stations. In the map below, murders in Greater Khayelitsha over the 10-year period are aggregated into 267 m2 blocks, roughly equivalent to a standard city block, and their totals are shown alongside key geographic features. The blocks are colour-coded from blue to red showing increasing murder levels.

Some of these high concentrations may be the result of crimes registered at landmarks rather than their actual locations. All crime records have location data, but in some cases the exact position is unknown (e.g. when a body is delivered to a hospital). If the software used to capture the crime requires a geolocation, input must occur, and landmarks are then used.

This requirement to fill in geolocation data, regardless of its validity, could account for concentrations near medical facilities and police stations. It could also explain the apparent dispersion of unrelated incidents along perfect grid patterns, affecting as much as 10% of all crime data over the 10-year period.

This could result in specific locations being misidentified as crime hotspots and given inappropriate police resource allocations while other actual hotspots (particularly in informal settlement areas where precise geolocation is difficult) may not be identified at all. As a result, SAPS pointlevel crime data may be too inaccurate and unreliable to be used for hotspot analysis or the development and monitoring of an effective violence prevention strategy.

N a bid to meet growing market demand for its beers and implement government's industrialization drive, Serengeti Breweries Limited is investing 10 million British pounds (over 28.1bn/-) in expanding its Dar es Salaam and Moshi brewing plants. Newly appointed SBL Managing Director, Mark Ocitti said in Dar es Salaam this week that expansion work has already begun in Dar es Salaam, the company's first of three breweries established in 1996. The other breweries are located in Moshi and Mwanza

"This expansion not only means getting additional beer production capacity for us, but it also brings more job opportunities to Tanzanians and creates further demand for barley, maize and sorghum which the company sources from local farmers," Ocitti said.

SBL currently employs over 800 people both directly and indirectly at all its brewing facilities and thousands of other beneficiaries including distributors, transporters, farmers, bar outlet owners and staff who depend on the brewer's products for their livelihoods.

The SBL Managing Director further noted that the beer brewer sources barley, maize and sorghum for its raw materials locally and until end of last year, the company had grown its cereals uptake from zero to 15,000 metric tonnes of grain.

"This is equivalent to 60 per cent of SBL's total raw materials requirement for beer production per year," he added while stressing that SBL remains committed to serving the domestic market with world class beer brands.

With its flagship brand Serengeti Premium Lager, which was the first beer in to be made of 100 malt in the local market, the brewer consolidated its

grip of the market with the launch of Serengeti Premium Lite recently which again was the first lite beer introduced to the market in 2017.

"Our customers asked for a Tanzanian lite beer and that is why we launched Serengeti Premium Lite two years ago. Tanzanians have responded very positively to this new product which has been doing very well in the market," Ocitti said while thanking loyal customers for supporting SBL brands.

SBL was founded by Tanzanian entrepreneurs in 1996 with one brewery located in Dar es Salaam. Between 2010 and 2013 the company's ownership structure changed with the coming on board of regional alcohol manufacturer, East African Breweries Limited and a global beverage producer, Diageo, which has since injected further investments by opening two additional breweries in Mwanza and Moshi.

The company in parallel has expanded its product portfolio with additional new leading beer brands such as Pilsner Lager, Tusker Lager, Guinness and Senator and of late - Serengeti Premium Lite.

SBL also distributes in the Tanzanian market some of Diageo's International Premium Spirits brands such as Johnnie Walker, Gordons, Smirnoff, Black and While among others.

# Tanzania and Zambia's new \$6 million border post to boost trade

In a bid to develop trade between member states of the Southern African Development Community (SADC) and East African Community (EAC), Tanzania and Zambia have launched their new one-stop border post - Tunduma-Nakonde.

The launch hosted by Tanzanian president John Magufuli and his Zambian counterpart Edgar Lungu saw the opening of the \$6 million border post, which will reduce waiting time

from four days to just one.

The construction of the state-ofthe-art border post at Tunduma in Tanzania and Nakonde in Zambia was financed by TradeMark East Africa, an organisation that aims to improve trade competitiveness in East Africa by reducing transport time and costs, and improving the trade environment.

Trade volume between Tanzania and Zambia surged from \$89 million in 2010 to \$265 billion last year. Magufuli said he hoped for more growth,

with 965 large- and medium-scale enterprises from Tanzania investing in Zambia, while eight Zambian companies have created 312 jobs, investing more than \$10 million in Tanzania. However, the situation is a little different for the once-thriving Tazara (Tanzania-Zambia Railway Authority), with little to no effort in the maintenance of the line damaging prospects for another mode of transporting cargo between the two nations. "Tazama (Tanzania Zambia Oil

Pipeline) oil pipeline is performing well but there are some issues with Tazara which need to be addressed to make the railway line operate profitably," Maguful said, as reported by FTW Online.

"There is a need for Tanzania and Zambia to continue the cooperation for the betterment of the people in the two countries. Tazara and Tazama are examples of perfect partnerships between our two countries," he added.

in August 2019. Capacity growth has now outstripped demand growth for the 16th consecutive month. Air cargo continues to face strong headwinds from the intensifying trade war between the US and China, as well as weakness in some of the key economic indicators and rising political uncertainties worldwide. Global trade volumes are 1 percent lower than a year ago.

Asia-Pacific airlines saw demand for air freight contract by 5 percent in August 2019, compared to the same period in 2018. The US-China trade war along with the slowdown in the Chinese economy has significantly impacted this region. The temporary shutdown of Hong Kong International Airport - the largest cargo hub in the world added additional pressure. With the region accounting for more than 35 percent of total FTKs, this performance is the major contributor to the weak industry-wide outcome. Airfreight capacity increased by 2.3 percent over the past year.

North American airlines saw demand decrease by 2.4 percent in August 2019, compared to the same period a year earlier. Capacity increased by 1.3 percent. The US-China trade war and falling business confidence continue to weigh on the region's carriers. Freight demand has contracted for the largest routes between Asia and North America, where seasonallyadjusted volumes are down almost 5 percent compared to their level in July 2018.

European airlines posted a 3.3 percent decrease in freight demand in August 2019 compared to the same period a year earlier. Weaker manufacturing conditions for exporters in Germany, softer regional economies, and ongoing uncertainty over Brexit have impacted the recent performance. Capacity increased by 3.3 percent year-on-year.

GENEVA

The International Air Transport Association (IATA) released data for global air freight markets showing that demand, measured in freight tonnekilometers (FTKs) contracted by 3.9 percent in August 2019, compared to the same period in 2018. This marks the tenth consecutive month of year-on-year decline in freight volumes, the longest period since the global financial crisis in 2008.

African carriers posted the fastest growth of any region in August 2019, with an increase in demand of 8 percent compared to the same period a year earlier. This continues the upward trend in FTKs that has been evident since mid-2018 and makes Africa the strongest performer for the sixth consecutive month. Capacity grew 17.1 percent yearon-year. Strong trade and investment linkages with Asia have underpinned a double-digit increase in air freight volumes between the two regions over the past year. China recently confirmed a further \$60 billion investment into the continent.

Freight capacity, measured in available freight tonne kilometres (AFTKs), rose by 2 percent year-on-year

# E-toll accounts could be used to pay for parking, licence renewals

Floating in Port Hercules the other week – ensigns fluttering, halyards singing – was one of the most spectacular displays of seagoing craft ever seen: 125 supervachts with a combined value of \$4.4 billion.

The mine's-bigger-thanyours lineup at the Monaco Yacht Show was yet another sign of how the wealth of today's ultrarich is remaking the world in ways that might make many ordinary people cringe. Six hundred million dollars? For a boat?

Even Henk de Vries, one of the world's foremost superyacht builders, has conceded that no one needs one. "I make the most unnecessary product that you can want, and I make it so nice that you still want it," he said a decade ago.

Even at a time of worrying inequality and anxiety over climate change, an astonishing number of the superwealthy want

superyachts-so many, in fact, that the de Vries family and their chief yachtbuilding rivals, the Lurssen and Vitelli clans, have become fabulously rich themselves.

"You're essentially building a small skyscraper that floats on the water," said Martin Redmayne, chairman of the Supervacht Group, a London-based media company. To be successful, these shipyard owners must have "patience, time and passionabsolute passion." "It's a very long game," he said. The business of building

ocean-going palaces really got going in the Gilded Age when robber barons and their descendants traded up from schooners. The Vanderbilts owned a 332foot steam-fuelled vessel for getaways to Europe, while the JP Morgan clan built multiple yachts called Corsair, each bigger and better than the last. The 343-foot Corsair IV was launched in 1930 to sail the family up and down the East Coast and across the Atlantic until it was given to the British navy at the start of World

"Looking ahead, we expect activity levels and price growth to remain subdued while the current period of economic uncertainty persists," said Mr Galley.

"If high street shops use only traditional marketing I don't think they have a future," MD Hays said. "Our point of differentiation is that we integrate with digital channels. Our staff will say the web is their friend, while Thomas Cook retail staff would have said the web is their enemy."

Thomas Cook's collapse on September 23 under a mountain of debt led to 9 000 job losses in the UK and left 150 000 people stuck overseas, with the holiday plans of thousands more ruined. Hays struck the deal for its shops with a court-appointed official receiver and special managers from KPMG.

The company, which describes itself as Britain's largest independent travel agent, was founded four decades ago and had sales of more than 1 billion pounds (\$1.2 billion) last year, directly employing 1 900 people. Hays said that as Thomas Cook's largest third-party agent he met with executives from the doomed company a week before it went under and left "feeling reassured" that it would survive.

About 5,000 residential units and 500,000 square metres of retail and commercial space were transferred into the new vehicle, along with Dh6bn of existing debt.

The wholly-owned asset management arm of Aldar Properties also subsequently took full ownership of Etihad Plaza and Etihad Airways Centre in a Dh1.2bn deal in February and took possession of the Al Jimi Mall extension in Murjan mixed-use tower at Danet Abu Dhabi. The company's portfolio currently has an occupancy rate of about 90 per cent.

Aldar Investments is rated Baa1 by Moody's. The sukuk market is expected to witness its fourth consecutive annual increase this year, with total issuance reaching about \$130bn, ratings agency Moody's Investors Service predicted in August. It said that total sukuk volumes grew to \$87.4bn in the first half of the year, from \$64bn in the same period of 2018.

However, the former vice president, during an event in January 2018 at the Council on Foreign Relations, bragged about how he in 2016 successfully persuaded the Ukrainian authorities to sack the country's then prosecutor general, Viktor Shokin, who was investigating Burisma Holdings at the time.

Biden threatened to withhold some 1 billion U.S. dollars in loan guarantees from Ukraine if Shokin was not removed. Shokin, in turn, was fired.

# **Russia may give asymmetrical** response to US withdrawal from Treaty on Open Skies - senator

# MOSCOW

MOSCOW won't take any decisive action until reports about Washington's plans to pull out of the Treaty on Open Skies are confirmed, but may provide an asymmetrical response in case of US withdrawal, Chairman of the Russian Federation Council (the upper house of parliament) Defense and Security Committee Viktor Bondarev told TASS.

"These reports haven't been confirmed yet and the US hasn't yet moved from words to action, so Russia won't take any decisive steps for now. If these reports are not fake news, they will be confirmed soon and it will be reasonable for us to provide an asymmetrical response," the senator said. "We gave a tit-for-tat response to US withdrawal from the Intermediate-Range Nuclear Forces Treaty because it was a bilateral document, but the Treaty on Open Skies was signed by 23 countries, so we won't succumb to Washington's trolling and will sacrifice neither regional nor global stability nor our friendly relations with constructive partners to American instigators," Bondarev added.

He pointed out that a short while back, Moscow had conducted observation flights over NATO countries in accordance with the Treaty, providing NATO members with an opportunity to fly over Russia.

On Tuesday, CNN reported that Washington would soon announce plans to withdraw from the Treaty on Open Skies. House Foreign Affairs Committee Chairman Eliot Engel in a letter to White House National Security Adviser Robert O'Brien earlier condemned the Trump administration's alleged plans.

"Withdrawal risks dividing the transatlantic alliance and would further undermine America's reliability as a stable and predictable partner when it comes to European security," Engel pointed out. Meanwhile, senior Democratic lawmakers called on US Secretary of State Michael Pompeo and Secretary of Defense Mark Esper to abandon withdrawal plans.

### **Treaty on Open Skies**

The Treaty on Open Skies was signed in Helsinki on March 24, 1992, by the member-states of the Organization for Security and Cooperation in Europe, and went into force on January 1, 2002.

The accord includes 34 countries, among them, most NATO members, Russia, Belarus, Ukraine, Georgia, Bosnia and Herzegovina, Sweden and Finland. Russia ratified the Treaty on May 26, 2001.

The purpose of the deal is to help build confidence between countries through the improvement of mechanisms to control military activities and compliance with arms control agreements. Agencies

# Super typhoon on track to drench Japan's main island

### TOKYO

JAPAN is bracing for a super typhoon on track to hit central and eastern regions over the three-day weekend with potential damage from torrential rains and strong winds.

Typhoon Hagibis has already caused cancellations of two Rugby World Cup matches that were to be played Saturday. Organizers canceled the England-France match planned in Yokohama, near Tokyo, and New Zealand-Italy game in Toyota, in central Japan.

Organizers also called off a marathon in Sendai and other northern coastal towns. Formula One auto racing in Suzuka in central Japan may also be affected.

Hagibis, which means speed in Filipino, had maximum sustained winds of up to 270 kilometers and stronger gusts at noon Thursday near Chichi island in the Pacific, about 1,000 kilometers off Tokyo's southern coast. It was

moving north at the speed of 20 kph and is expected to weaken over cooler waters as it nears Japan's main island. It's the equivalent of a Category 5 hurricane.

The Japan Meteorological Agency says the typhoon is forecast to hit ashore in the Tokyo area late Saturday and urged people to take precautions to avoid potentially life-threatening danger. Japan's central Pacific coast may see torrential rains beginning Friday while high waves and tides may cause flooding.

Airlines and train services anticipate cancellations affecting holidaymakers traveling over the three-day weekend that includes Sports Day holiday on Monday.

The approaching typhoon is spreading fear especially in Chiba, near Tokyo, which was hit by Typhoon Faxai last month and many residents are still recovering from damage to their homes. The typhoon tore many electri-



cal poles and snapped cables, triggering extensive outages that lasted for weeks, contributing to heat illnesses and other health problems among elderly people.

Chief Cabinet Secretary Yoshihide Suga, at a regular news conference, said the government will do the utmost for the people's safety, and urged residents near the typhoon route to take precautions early.

In some places, preparations have started.

Local offices in Chiba city started distributing free sandbags to shield against flooding. The city also cautioned against power outages from potential typhoon damage and urged residents to make sure they have enough food, water and their phones are charged.

In Chofu in Tokyo's western suburbs, workers at the city hall

renovation site reinforced scaffolding and placed protective nets to prevent equipment and construction materials from being blown off.

At a winery in Yamanashi, north of Tokyo, workers picked grapes Thursday to save them from the typhoon, Japan's NHK television said.

East Japan Railway Co. said it may suspend services on most local lines and bullet trains around Tokyo before the typhoon arrives.

Japan Airlines and All Nippon Airways said they may ground flights as early as Friday depending on the typhoon's movement. Japan is regularly hit by Pacific storms, including Faxai in September. Typhoon Jebi flooded a terminal and a runway at

Kansai International Airport last year.

South Africa registered "remarkable progress" in regard to institutional quality, such as in restored balance of powers across different states' entities, enhanced administrative efficiency of the public sector and corporate governance, said the report.

South Africa also achieved a score of 100 for its "well-developed equity, insurance and credit markets," and ranked 19th globally as a regional financial hub, it said.

The report also scores the country highly for having "one of the most advanced transport infrastructures in the region" and being "among the top countries in Africa" for market size.

"Whilst we note there are areas for improvement, the report cites security and insufficient labor market flexibility as some of the constraints to growth. This improved ranking gives us added impetus to remain firmly on course with our economic reform agenda," Ramaphosa said. Xinhua

# Ecuador's protesters march, clashes break out in Quito

### QUITO, Ecuador

THOUSANDS of protesters staged anti-government rallies Wednesday, seeking to intensify pressure on Ecuador's president after a week of unrest sparked by fuel price hikes.

Stone-throwing demonstrators clashed with police using tear gas to fend off crowds, including around the empty government headquarters in the capital of Quito.

Demonstrators struggled to get close to the headquarters in the colonial-era Carondelet palace, sealed off by police barricades in the narrow surrounding streets.

In one chaotic scene, protesters swarmed onto the top of a riot control vehicle that stopped in an alley. They pounded on its armored plating and reinforced windows with clubs and stones until the occupants accelerated away through clouds of smoke and tear gas.

Protesters included youths who burned tires and confronted security forces, labor union members and indigenous people who mobilized and marched, for the most part peacefully. In a separate demonstration, thousands gathered in the port city of Guayaquil to condemn days of street violence that have shocked many Ec-

uadorians. Some wore white clothing and carried white flags.

Ecuador's Red Cross said it was suspending paramedic and ambulance services because of security concerns. Red Cross volunteers had been attacked in several locations in recent days and people threw stones at an ambulance in Quito on Monday, the aid group said.

The military earlier warned people against violence during Wednesday's protests, following unrest that led President Lenín Moreno to move government operations from Quito to Guayaquil.

In a statement, the military ap-

pealed to Ecuadorians to denounce anyone who uses the cover of the protest to carry out vandalism and other crimes

The military's backing is key for Moreno, who said late Tuesday that his government is negotiating with indigenous groups. The president said the dialogue is difficult because so many indigenous groups are involved. He also said he will not resign despite widespread discontent in the South American nation of 17 million.

Moreno was returning to Quito from his temporary base in Guayaquil to monitor government handling of the protests on Wednesday, Interior Min-

ister María Paula Romo said.

José Briones, secretary general of the president's office, said topics in an initial discussion with indigenous groups include aid for farmers, such as debt refinancing, irrigation and other technical assistance.

Still, the political crisis shows no immediate signs of abating. While labor leaders called the strike Wednesday, economic activity in much of the country has already been stalled by clashes, looting, blockades and other disruptions.

Ecuador's main oil pipeline, which runs from the Amazon region to Balao port on the Pacific ocean, has stopped

operating because mainly indigenous protesters disrupted production facilities, the energy ministry said.

Violence started last week after Moreno ended fuel subsidies, leading to price increases. The government says at least 700 people have been arrested.

The disturbances have spread from transport workers to students and then to indigenous demonstrators, an ominous turn for the government. Indigenous protesters played a major role in the 2005 resignation of Ecuador's president at the time, Lucio Gutiérrez, though the military's tacit approval was key to his removal.

# **Jewish leader says** German synagogue attacked by gunman inadequately protected

### BERLIN

A prominent Jewish community leader accused German authorities yesterday of providing inadequate security at a synagogue that was attacked by a far-right gunman as dozens prayed inside.

Though the gunman did not get into the building in Wednesday's attack, he killed two bystanders in a subsequent live-streamed rampage, which appeared to be modeled on last year's gun attack on a New Zealand mosque.

"If police had been stationed outside the synagogue, then this man could have been disarmed before he could attack the others," Josef Schuster, president of the council of Germany's Jewish community, told Deutschlandfunk public radio.

Most Jewish institutions in Germany's large cities have a near-permanent police guard due to occasional anti-Semitic attacks by both far-right activists and Islamist militants.

In a video of more than 30 minutes that the attacker livestreamed from a helmet camera, the perpetrator was heard cursing his failure to enter the synagogue in the eastern German city of Halle before shooting dead a woman passer-by in the street and a man inside a nearby kebab restaurant.

Two other people were injured but regional broadcaster MDR said their condition was not critical.

Police said they had detained

one person, identified by the magazines Spiegel and Focus Online as a 27-year-old German, Stephan B. His full name cannot be published under German privacy laws.

Schuster said that while it was normal practice in his experience for all synagogues to have police guards while services were being conducted inside, this appeared not to be the case in the state of Saxony-Anhalt, where Halle is located.

However, the head of Germany's police union was skeptical about the feasibility of providing that level of protection.

"We'd have to guard every synagogue, every church, every mosque, every holy place in Germany around the clock, so I don't know if this was a mistake or if this really couldn't have been foreseen," Oliver Malchow told public television.

In the event, the synagogue's solid locked gates and high walls provided ample protection against the attacker's seemingly improvised weapons.

Malchow also defended police in Halle who took 15 minutes to reach the synagogue, saying they could only respond after receiving reports about the incident, and that armored units often had to come from greater distances.

"This shows how thin the level of police coverage is," he said. "Nobody is holding back ... it probably wasn't possible to be quicker."

# S. Africa calls for peaceful dialogue with disgruntled foreign nationals

### **CAPE TOWN**

THE South African government has called for peaceful dialogue with disgruntled foreign nationals seeking protection from possible xenophobic attacks.

"The government remains resolute to the peaceful dialogue as the first option of resolving any form of dispute," Phumla William, Acting Director General of the Government Communication and Information System (GCIS) said on Wednesday.

William said South Africa is known internationally for using dialogue to solve differences and problems. "As a peace-loving and law-abiding nation, we must use this noble approach to deal with our problems," said William. She was speaking after dozens of asylum seekers staged a sit-in at the office of the United Nations High Commission for Refugees (UNHCR) in Cape



Town on Tuesday. The refugees accused the South African government of ignoring their plight, not only in Johannesburg where recent xenophobic attacks occurred but also in Cape Town.

The asylum seekers, mostly from the Democratic Republic of Congo (DRC), Burundi, Nigeria, Somalia and Pakistan, asked the UNHCR to help them leave South Africa for fear of xenophobic attacks. According to William, the Western Cape Refugee and Migrant Forum had

distanced itself from this sit-in protest. South Africans and those within the South African border are expected to adhere to the law and rules of the country, William said

The government "remains committed to building a society based on democratic values of social justice, human dignity, equality, non-racialism, non-sexism and the advancement of human rights," said William. South Africa has a high number of foreign nationals who are integrated into communities across the country and the government calls on all South Africans and foreign nationals to live in

According to the UNHCR, South Africa hosts about 240,000 foreigners, many of them refugees from other African countries. South Africa is a signatory to international instruments which have also been incorporated into the country's domestic law, William said.

# Turkish forces seize targets in northeast Syria offensive - ministry

# ISTANBUL

TURKEY said its forces seized designated targets on the second day of an offensive against a Kurdish militia in Syria, after a withdrawal by U.S. forces opened up a dangerous new phase in the region's eight-year-old conflict.

Senior members of U.S. President Donald Trump's own Republican Party condemned him for making way for the incursion and abandoning Syrian Kurds, who have been loyal allies of Washington in the fight against Islamic State in Syria.

NATO-ally Turkey has said it intends to create a "safe zone" for the return of millions of refugees to Syria. But world powers fear Turkey's action could deepen the conflict, and runs the risk of Islamic State prisoners escaping from camps amid the chaos.

The Kurdish-led authority in northern Syria said a prison struck by Turkish shelling holds "the most dangerous criminals from more than 60 nationalities" and Turkey's attacks on its prisons risked "a catastrophe".

The Kurdish-led Syrian Democratic Forces (SDF) holds thousands of Islamic State fighters and tens of thousands of their relatives in detention. Turkey said its offensive was making

# Egypt's PM accuses Ethiopia of violating Nile dam Declaration of Principles

# CAIRO

EGYPT'S Prime Minister Mostafa Madbouli has accused Ethiopia of violating previous agreements related to the Nile water, official news agency MENA reported.

Addressing a general session of the House of Representatives, Madbouli said on Wednesday that Ethiopia took a unilateral decision in 2011 to build the Grand Ethiopian Renaissance Dam (GERD).

He added that Ethiopia has rejected all proposals submitted by Egypt to solve the difference in the latest round of negotiations held in Khartoum.

Stressing the negotiations have reached "a deadlock," the prime minister noted that "it is quite clear that Ethiopia wants to impose the status quo on Egypt, and so we find that it has become very difficult to reach agreements with Ethiopia."

Meanwhile, Madbouli added that the dialogue is still open for reaching a solution to the issue of the GERD in a way that will not harm the Egyptian rights to the Nile water.

When Egypt asked for an international mediator, Ethiopia called for more negotiations with the consultancy houses, he added.

Ethiopia has declared that an experimental operation of the dam will take place in early 2020, said Madbouli.

# **Russia to send letter to US Speaker Pelosi** after MP questioning in New York

### MOSCOW

SPEAKER of the Russian State Duma (parliament's lower chamber) Vyacheslav Volodin will send a letter addressed to Speaker of the US House of Representatives Nancy Pelosi (Democrat, California) following Russian MP Inga Yumasheva's detention and questioning at a New York airport, Chairperson of the State Duma's Foreign Affairs Committee Leonid Slutsky told a meeting of the committee vesterdav

# **Media events now canceled in China for NBA preseason game**

N response to the NBA defending Daryl Morey's freedom of speech, Chinese officials took it away from the Los Angeles Lakers and Brooklyn Nets.

All of the usual media sessions surrounding the Lakers-Nets preseason game in Shanghai on Thursday - including a scheduled news conference from NBA Commissioner Adam Silver and postgame news conferences with the teams – have been canceled. It's the latest salvo in the rift between the league and China stemming from a sincedeleted tweet posted last week by Morey, the general manager of the Houston Rockets.

"There will be no media availabilities for tonight's game between the Brooklyn Nets and Los Angeles Lakers," the NBA said in a statement Thursday, released a few hours before the game.

The game was held as scheduled, with Lakers forward LeBron James and Nets guard Kyrie Irving getting loud ovations when they were introduced as starters. But neither national anthem was played before the game, and no players addressed the crowd before tip-off in a departure from tradition before such international games. Fans arriving at the arena to watch

jerseys – were handed small Chinese flags to carry with them inside, and at least one person carried a sign critical of Silver.

"I understand that there are consequences from that exercise of, in essence, his freedom of speech," Silver said at a news conference in Tokyo earlier this week. "We will have to live with those consequences."

# Amid rift with China, will the NBA be forced to apologize?

WHEN major corporations have done something to anger Chinese authorities in recent years, the playbook has called for one thing: an apology.

Marriott issued one. So did Delta. Mercedes-Benz, too.

The NBA, embroiled in a rift caused by a tweet expressing support for pro-democracy demonstrators in Hong Kong, has avoided going that route – for now. But with billions at stake from things like merchandise sales and media rights, some experts are wondering if anything other than an apology from NBA Commissioner Adam Silver will mend this fence, especially with the Chinese indicating that is what they want.

"I think that Commissioner Silver might have to do what everyone in our country doesn't want him to have to do," said Windy Dees, a sports marketing expert at the University of Miami. "He may have to say, 'I understand that your government, your political system, your culture, your ideologies are different than ours and we shouldn't push our beliefs on you."

"And that's exactly what

Americans and NBA fans don't want to see their commissioner say," Dees added.

Silver has chosen his words carefully to this point. defending the right of Houston Rockets general manager Daryl Morey – who sent the tweet, now deleted yet still causing major problems – to freedom of expression.

Silver also said the league is apologetic over the disharmony caused by Morey's tweet but stopped well short of apologizing for the tweet itself. Morey attempted to clarify his position in subsequent tweets, which some, including Brooklyn Nets owner Joe Tsai, the Taiwanese-Canadian co-founder of Chinese e-commerce giant Alibaba, considered an apology.

But the only true apology so far came from Rockets star James Harden, the 2017-18 NBA MVP who tried to fix things by insisting, "We love China." Clearly, that wasn't enough.

"The hurt that this incident has caused will take a long time to repair," Tsai said in an open letter to fans in which he tried to shed light on the Chinese perspective when it comes to Hong Kong.

The question is, how long?

in Shanghai, then again Saturday in Shenzhen. For now, those games are expected to be played.

But China state broadcaster CCTV is not going to air the games as previously planned and said it is examining other aspects of its relationship with the NBA.

Tencent, the Chinese conglomerate that has a \$1.5 billion streaming deal spanning the next five seasons with the league, has said it will not show Rockets games and pulled some planned preseason coverage from NBA arenas. And Chinese companies like apparel giant Li-Ning and Vivo, a smartphone maker that was going to be a sponsor of the Lakers-Nets games, have suspended their business dealings with the NBA.

"If you have CCTV and Tencent saying, 'We're not airing the NBA,' that is a huge red flag," Dees said. "It's almost like a Chinese lockout. If China does not broadcast games, this is a major financial problem for the NBA. And I'm thinking this is going to go on for a while. This is not getting resolved right away. The one thing that you don't mess with is Chinese government, and unfortunately not everyone in the U.S. understands the global power

In the meantime, Silver is "upholding the values of the two countries where the NBA is based," the U.S. and Canada, said Heather Dichter, a professor of sport management and sport history at De Montfort University in Leicester, England.

"If he had gone the other way, that to me becomes more damaging for the league financially," she said. "China puts in money, but they're not the core of your business. The teams can survive without their money. They can't survive if they have no ticketholders."

The NBA's ties to China go back at least 30 years, from then-Commissioner when David Stern opened a fledgling office in Hong Kong with a barebones staff and struck a deal to show games to Chinese viewers on a tape-delay basis.

The game's popularity in China has soared since. Many top NBA players visit every summer to promote footwear and apparel, usually greeted by huge crowds of adoring fans. The typically cited numbers are that 300 million Chinese play basketball and 500 million watch the NBA.

Now those carefully cultivated and highly lucrative ties have been thrown into jeopardy.

"As to what the NBA should say and do next, I believe it knows better than anyone else," Chinese Foreign Ministry spokesman Geng Shuang said.

BERNARDO Silva has been granted an extension until October 21 to respond to the Football Association (FA) charge relating to his racially insensitive tweet to Manchester City team-mate Benjamin Mendy.

Silva last month tweeted - and subsequently deleted - a photo of a young Mendy and a dated image from Conguitos, a Spanish confectionary brand that has been criticised for having racist connotations. The post was captioned "Guess who?".

A week ago, the FA charged the 25-year-old playmaker with an alleged breach of FA Rule E3 on account of the post being "insulting and/or improper and/or [bringing] the game into disrepute".

BARCELONA forward Lionel Messi has said he misses his rivalry with Cristiano Ronaldo and would have liked his fellow five-time Ballon d'Or winner to have continued in La Liga.

Ronaldo left Real Madrid as the club's all-time top scorer to join Juventus in a €100 million transfer in the summer of 2018. Since his departure to Turin, the two superstars have not faced each other.

"Yes, I would have liked for Cristiano to continue in the Spanish league, at Madrid," Messi said in an interview with Catalan radio RAC 1. "I think it gave an extra impetus to our rivalry, to the Clasico and to La Liga overall.

"I remember I said earlier this year that Madrid would notice Cristiano's departure, just as any other team would, but even so, they have enough players to be at the top and fighting for everything. It's Madrid and they have a lot of history."

Messi and Ronaldo have always contended for major individual honours, however the Argentina forward said this has never been his priority.

"I've never thought about finishing my career with more Ballon d'Or awards than Cristiano," he said.

Messi also said he considered leaving Barcelona and moving overseas during the years he was investigated by the Spanish tax authorities. In the summer of 2016, the Argentina captain and his father were found guilty of defrauding the tax authorities of €4.1m between 2007 and 2009.

"I've had several [difficult] periods, especially in 2013 and 2014 when I started having a problem with the Spanish tax authority and everything that came out," Messi added. "It was difficult for me and for my family.

"I think I was the first one [to be investigated by the tax authorities] and that is why everything was so hard. From then on, they showed they were going all out with me and proved that they would target all sports and footballers.

"During that time, I considered leaving Barca. Not because I wanted to leave Barca but because I wanted to leave Spain. I felt I was being mistreated and I didn't want to spend

much time there. "I think I had the door open to many teams although I have never had an official offer because everyone knew of my wish and eagerness to continue at Barca. That, however, was beyond any situation that I felt for this home, this club, it was what I felt at a personal level. The only positive was that my children were young and didn't notice it but we had a hard time.'

Messi, 32, has said he intends to retire at Barca even though he has a clause in his contract which allows him to leave at the end of each season

"If they want me, I would obviously be delighted to remain at Barca," he said. "I reiterate that my aim has always been to stay here.

"Nothing has changed; it is as it has always been. Each time it becomes clearer that my aim and that of my family is to finish [my career] here. First because of how I am at the club, how I feel at the club, and secondly, for my family. We are very settled in this city. Of course, anything can happen but the idea is to continue living here.'

Messi has extended his contract eight times since 2005 but has yet to be offered a new deal and his contract expires in June 2021.

"I don't think there is anything yet



from what I know from my father [Messi's agent]," the Barca captain said. "I have always stayed out of all negotiations.

LEGENDARY goalkeeper Edwin van der Sar has attributed Manchester United's struggles to the disappearance of strong characters in the dressing room, and said the situation at Old Trafford is "a long way" from the club he left eight years ago.

"So it's a long way from the position where they are in now," van der Sar said. "And of course they have changed managers a couple times now and the real progress is not seen yet, only the thing that they bought in the summer. Everton more than matched the asking price to loan defender Marcos Rojo on deadline day, but the deal was canned at the last minute over fears that Marco Silva already had a stronger squad. Chris Smalling was told he could not move to Goodison Park but was allowed to join Roma.

Privately, Silva accused United of sabotaging Everton's season before it had started by leaving him with just two senior centre-backs, one of whom (Yerry Mina) only managed 10 league starts in 2018-19 because of injury. Executive vice-chairman Ed Woodward and the Glazers would ultimately be wrong about Everton -- they're 17th after eight games -- but they were right about United.

Ole Gunnar Solskjaer's team are 12th in the table, two points above the relegation places, after Sunday's 1-0 defeat at Newcastle. Woodward has promised Solskjaer time to complete a rebuild that only began in the summer and not allow himself to be influenced by "short-term distractions" but after such a poor start, the question is simple. How much more can he take?

Squad depth is only partially Solskjaer's fault

There's an acceptance within the club that Solskjaer has been left with a squad seriously short in midfield and up front. He decided to jettison Romelu Lukaku and Alexis Sanchez for the good of the dressing room because both had made it clear they wanted to leave, becoming increasingly distant and withdrawn from the rest of the group. Money was available for a replacement for Lukaku, but Solskjaer decided against bringing in a short-term fix even as long-term targets were unavailable.

The current injury crisis is another mitigating factor. Of the team that beat Chelsea 4-0 on the opening weekend of the season, six were

absent against Newcastle. Paul Pogba has missed five of the past seven games with an ankle injury. Anthony Martial, identified during preseason as the first-choice centre-forward, has been sidelined since August with a thigh problem.

Behind the scenes, Woodward has spoken of "fine margins" like penalty misses against Wolves and Crystal Palace, and penalties that weren't given against Arsenal and AZ Alkmaar. The fact remains, however, that in two weeks' time, United could find themselves in the bottom three.

The 2019-20 campaign already marks their worst start to a season for

season without Champions League over the line. Discussions for players football would see the annual payment from kit supplier, Adidas, reduce by 30 percent to around £20 million.

Solskjaer is aware he has gambled on the goodwill of Woodward and the Glazers. "We'll certainly explain that to them and they'll have seen it as well. We'll try and convince them as much as we can, but we cannot enforce anything. Hopefully, they've changed by seeing this series be so successful.

"The crowd has been the same as 30 years ago; it hasn't changed," Ratnayake, who played seven Tests and 16 ODIs in Pakistan over the course of his career, said. But Lahore saw a remarkable turnaround, with the supposedly weakened hosts putting Pakistan to the sword in all three games, and sealing their firstever 3-0 T20I whitewash in the process. Ratnayake said calling them a weak unit would be inaccurate.
