ANZANIA has been listed along with Sudan, Angola, Ghana and Kenya as having high levels of vulnerability to a coronavirus epidemic in case of importation of the virus from China.

A study led by a French researcher and academician said that these countries have high and comparable importation risks of the coronavirus on account of intensity of trade interactions, varying levels of preparedness to face the threat of an outbreak and high levels of vulnerability.

A study led by Dr Vittorio Colliza of INSERM

reach 10 per cent by 2025.

Majaliwa launched Tanzania's certificate of origin for the export of the minerals at the conference, where he said attainment of the 10 per cent target is now more assured than it was the case earlier.

A statement released by Prime Minister's Office said the launch of the certificate now puts Tanzania at the centre of implementation of the protocol against the illegal exploitation of natural resources.

The premier expressed hope that things will go well considering the role played by mineral markets and sale centres located in key regions, he said, pointing out that at present there is a sale centre and market for each of the Mainland

Rukwa unveils reversal plan on pregnancy, dropout rates

RUKWA Region has unveiled a fivevear strategy meant to reverse alarming rates of pregnancy amongst primary and secondary school pupils as recent statistics show that between 2017 and 2019, a total of 722 learners got pregnant and dropped out.

During his visit to the region last October, President John Magufuli expressed his shock at the pupil pregnancy and consequent dropout rates, directing authorities there to swing into action and reverse the trend.

The strategy was prepared by liaison

effort between the regional authorities and Plan International via its Safe Motherhood Project, officials said.

The strategy was unveiled at the weekend at Namanyere in Nkasi District, in a ceremony attended by various officials including district commissioners, executive directors, district council chairmen, legislators from the region and education stakeholders.

Speaking at the event, Regional Medical Officer Dr Boniface Kasululu said secondary schools were leading in school pregnancies as there were 551 in the two year period, or 76 percent increase in cases TURN TO PAGE 2

Coast Region cited for 40bn/- gas tank plant

A MULTIPURPOSE gas tank manufacturing factory is to be set up in Mkuranga District in Coast Region at an estimated cost of USD25 million (over 40bn/-).

Angellah Kairuki (pictured), the Minister of State in the Prime Minister's Office (Investment) said in Dar es Salaam at the weekend that Egyptian firm, Supreme Holdings chief executive officer Dr Moharram Helal is set to start building the plant. and 30 kilogrammes daily, she said, The move is expected to end

reliance on imported tanks when the plant became operational, but the minister did not give the time frame for the construction of the plant and start of production.

It is expected to employ about 300 local staff and up to 30 expatriate managers and technicians from Egypt when it starts production, she stated.

The plant will produce 1,000 tanks daily and fill with gas 3,000 tanks with capacity ranging between 15 pointing out that the government



has asked the investor to consider producing tanks with capacity below 15kgs

"We consider a plant of this nature a vital strategic investment. Once it becomes operational we shall no longer import such tanks. So this

is an important area of investment for issues like land allocation and in our agenda to make Tanzania a middle-income industrial country by 2025," she said.

"We have assured him Tanzania is the right place for rewarding investments and I have encouraged him to deal directly with the TIC," she further asserted.

The Tanzania Investment Centre (TIC) ought to give the investor all the necessary help, the minister underlined, using the occasion to ask all investors to deal directly with the TIC, instead of using middlemen issuance of various clearances.

Dr Helal thanked the minister for the cooperation accorded to him, saying Tanzania was a good place for investment, pledging to build the plant speedily.

"We have come to Tanzania because we have a wealth of experience in this area. Once the procedures are completed, we shall built the plant in a short period and roll out tanks," he declared, flanked by Intergas general manager, Dr Hatem Ahmed.

of pregnancy, while primary schools had 171 instances of pregnancy.

"Demographic data for 2015 and 2016 shows that a significant portion of girls aged 15 to 19 in the region become pregnant or already had babies despite that at this age the girls need to be at school," Dr Kasululu said. The cause for this situation includes poor accountability by parents and guardians, local leaders and society in general on issues of guardianship of young girls who are especially vulnerable.

He mentioned other reasons as little knowledge among the society on laws concerning child care, gender based violence (GBV), adolescence pressures as well as insufficient space in boarding schools.

Speaking on the issue, Rukwa Regional Commissioner Joachim Wangabo thanked Plan International for their role in the preparation of the plan which he said will help to significantly reduce school pregnancies by 2025.

The strategy aims to defend the rights and interests of children including the right to education and other basic rights without discrimination, he said.

The main cause of school pregnancies is that student walk long distances to schools especially in villages and wards that have no schools, he stated.

The region has 339 villages, with 59 having primary schools, compelling pupils to walk five kms to school in nearby villages, hence making them prey to wayward young men along that route.

"But we also have 97 wards, where 25 wards have no secondary schools, an environment that is hazardous for our children," he said, noting that it is the responsibility of leaders to ensure that all villages have primary schools and all wards have secondary schools.

He urged officials in wards lacking secondary schools to embark on work to building dormitories for girl students to reduce the risks tied with walking to school.

Aida Khenan (Special Seats, Chadema) urged that girls becoming pregnant at school should not to lose hope, pointing out that many senior public officials were once victims of such a situation, including herself when she was in Form III.

Rukwa residents need to work with the government and other stakeholders to tackle child pregnancies as such incidents are hazardous to the life of the student especially during delivery, she added.

Minister blames waterlogged crater roads on above normal rainfall

NATURAL Resources and Tourism, minister Dr Hamisi Kigwangalla has blamed sorry state of roads within the Ngorongoro Crater on above normal rains.

Speaking here at the weekend during his inspection tour of the repair works, the minister said the tourism hotspot received three times of water it gets annually, leading to the ponds that caused some difficulty to tourist recently. "The area usually receives 1000

millimetres of rain per year, but the precipitation that started drenching Ngorongoro from last September recorded a whopping 3000 millimetres of rain within just seven months," said the tourism Minister.

He added: "The rains may have damaged most of the infrastructures in conservation areas where everything is in their pristine original state, but for the tourists that is a living evidence of how Tanzania maintain the natural settings of its tourism sites," added Dr Kigwangalla (pictured).

He noted that efforts to repair the rain-damaged roads in the Ngorongoro crater have born fruits with major sections of the tracks now in better conditions and the tourist flow on the rise just as another season kicks in. Kigwangalla was also treated to rare sighting of the continent's oldest Rhino, Vicky.

At 46 years, Vicky is the oldest listed Rhino to date, but the queen of crater is also the largest ferocious mammal on record and can be distinguished by its deeper black colour. Mama Vicky usually loves to graze alone.



Dr Kigwangalla who was accompanied by the Commissioner of Conservation at the Ngorongoro Conservation Area Authority, Dr Freddy Manongi, was forced to stop his Land-cruiser so that he could get a glimpse of the rare Rhino which was grazing some distance away from the track.

Faru Vicky, a female Black Rhino living in the Ngorongoro Crater is currently reigning as oldest; replacing the previously oldest known Rhino, Faru Fausta that died in late December 2019 aged 57. She was also a resident of the Caldera albeit the one that was kept in special cage due to her extreme old age.

So far, the Ngorongoro Crater is the only place where free roaming Rhinos can be spotted; the endangered species are usually kept in special cages elsewhere on the continent.

Tanzania is also said to have the highest number of black Rhinos on the continent but the official tally of such species, found in Maswa, Serengeti, Mkomazi and Ngorongoro, is kept secret to protect the animals from illegal hunters craving for their horns.

Mbeya police hold four suspects for allegedly killing 'bodaboda' drivers

POLICE in Mbeya Region are holding four people allegedly for involvement of attacking, abducting and killing drivers of motorcycle popularly known as 'bodaboda' after which they robbed them of their machines.

Speaking to reporters, Mbeya **Regional Police Commander SACP** Ulrich Matei named the arrested suspects Masikitiko Pastoni aka 'Mbuzi' (34), Ezekia Sinkala (26) and Huruma Mwasile (36) all residents of Mtakuja, and Amani Mswima (21) a resident of Mlima Reli in Mbalizi town.

Villagers call for improvement of health facilities in Rungwe and Ileje districts

VILLAGERS in three wards of Mbeya, Rungwe and Ileje districts in Mbeya and Songwe regions are forced to carry patients and dead bodies in stretchers due to poor road infrastructure in their localities.

Speaking to journalists during the weekend, the villagers called on the government to extend its support to the areas

so as to rescue lives of people especially patients who sometimes died on the way to health facilities

According to them, much of the affected wards include those located at borders of all three districts which are Ngulilo ward, Ileje; Santilia of Mbeya district council and Mkunga located in Rungwe.

"We have decided to join our efforts to repair the road by us-

ing hoes to serve us for at least some time as we are waiting for the government to construct it. The situation of the roads in the areas are pathetic. This also thwarts smooth provision of other social services," said Mawazo Mwambwiga, a resident at Sanje village in Santilia

ward According to him, the road serves both Mbeya DC and Ileje residents but it hasn't been rehabilitated by the government for many years.

"This road is a very important link as it helps us when going to Mbalizi mini-town and Mbeya city to get various social services. We are appealing for the responsible minister to help us as our local leaders have failed to do so," he added.

Sapanda Asha Mwawa, villager in Ngulilo ward, Ileie said that the road has been a night mare for pregnant mothers as they are worried about their lives when it comes to delivery


"There is no car that goes on this road during rainy season, due to this pregnant women suffer a lot and sometime can lose their lives on the way to hospital, this is a very serious challenge," she said. forces villagers sell their pro-

Another resident, Petro Lyamaba said that the poor infrastructure has also affected economic development of the people in the areas.

"We cannot transport our produce or other products to town. In this area people engage much in the cultivation of pyrethrum, maize and timber with our major market being in Mbalizi town...the situation

Sapanda village chairman, Samwel Lusubilo said: "We have done all our efforts to present the challenges to the districts' leadership but nothing had been done, but we have been seeing them collecting crop levies for traders who use the same road."

Kanyasu issued the directive at the weekend when he was speaking to members of the defence and security committee during his official visit at the offices of the Nyamagana District Commissioner in Mwanza region.

He said when tourists come into the country they need two things foremost - security and hospitality, and added that his directive will involve all tourism stakeholders in the game reserves including owners of hotels and tented camps.

He added that if not observed, the incidents whereby guards run away when tourists come into trouble instead of assisting will kill the tourism sector.

He said trained guards know how to tackle attacking wild animals but also are well, conversant in serving tourists as they know their commitment to the country.

Minister Jafo demands swift registration of Chiwondo Primary School in Dodoma

MINISTER of State in the President's Office (Regional Administration and Local Government -RALG) Selemani Jafo has directed for the registration of the still unregistered Chiwondo school in Dodoma city to save students from having to walk about 20 kms everyday to attend classes at Chihoni primary school.

As of now the school has 169 students of elementary classes - Std 1 to III while those in Std IV to VII are forced to walk the distance to attend the school.

Jafo issued the directive at the weekend when inaugurating two Chiwondo School classrooms built by the constituency's Member of Parliament Anthony Mavunde in partnership with the City Council to solve the classroom shortage.

Jafo said it was dangerous for very young

pupils to continue long distances to get education as it makes many of them perform poorly in their studies while others run away.

"I direct the City's Director to complete the ongoing classroom construction and I equally direct the Director of Education of the Ministry to increase two more classes before the start of the coming Parliamentary Budget session, and this should be the end for the students to walk long distances, as the Chiwondo School registration has to be finalized next year to enable Std IV and VII students to sit for their exams at the school which has to be registered as 'Mavunde Primary School," said Jafo.

On the issue of the shortage of teachers at the school, Jafo said he had directed that when permission for employment is issued, more teachers have to be employed at the school.

On his part Mavunde who is also Deputy Minister in the Prime Minister's Office, Labour, Employment and Youth said in 2015 when he was seeking votes in the constituency, the wananchi asked for a school in the area to save their children from walking long distances to the school the request which he has fulfilled.

Earlier, reading the school's report, the Head Teacher of Chihoni Primary School said Emanuel Enock said the school has reduced truancy by 95 percent as well as increasing enrolment from 15 to 63 percent.

He appealed for more teachers including teachers' houses as the available teachers have also to walk 20 to the school.

On his part, the Director of Dodoma City Council Godwin Kunambi said in the period of three years a total of 188 classrooms have been constructed for schools in the city to alleviate classrooms shortage.

So far, four classrooms, three science labs and sanitation facilities have been built and the school got registration in May last year.

Mwanza Regional Education Officer, Busheja Josephat encouraged owners of private schools in the country to stick to quality education to meet the needs of society.

One of the missionaries, Erick Frank said that in 2012, we found that the school had only two classrooms, we decided to involve different stakeholders and after eight years, this came a reality and it's our hope that many students will benefit from this initiative."

Norway has consistently been on the forefront of caring for the sustained upkeep and plausible managerial capacity of some forgotten spheres of development needs, out of the broader donor community. It greatly assisted in wildlife zones conservation, and is playing a key role in refugee zones development.

One reason why the international community, with clear exception of Norway and some other international agencies appears to have given up or forgotten about this zone is the time frame. Usually refugees are people who are temporarily displaced and after a definite time framework has eclipsed, they are integrated where they live and become part of the wider development process. This has only been partially realized in the northwestern zone, prolonging the problem.

Many among the 1972 extensive massacres in Burundi were absorbed in a gradual manner, while many others have trickled back to their home country. The situation with Rwanda originating refugees is rather different as their time scale is newer than the first wave of Burundi refugees, but much older than the more recent wave from the same country, as late as 2015. Many are trickling back, similarly.

One problem is that the status of the refugees has remained a personal issue for each of them, and many factors intermingle as they agonize about making decisions on their future. In countries enmeshed in civil war, finding one's original village and portion of land still remaining is virtually im-

Those who grew up in refugee camps have a lesser expectations of making such claims so they have to figure out if they go back to seek for occupations like petty trade in the home country of seek to integrate in the country of displacement.

Here they are confronted with being non-citizens, whereas it would greatly help if there was capital allocation to purchase idle portions of land and ease into the community. UN agencies can examine that aspect too.

In a sense it would help to make the surrounding communities more dynamic as resettling people purchasing idle land portions add capital in the community, and thus it is a win-win situation.

So far the government donor countries along with UN agencies have focused on the social and economic infrastructure in the zone, but without property movement taking place, no investment in the future can be made. The idea that refugees will simply be absorbed into their original villages is impractical, so they up being a pattern of living in dependency for too long, unfair for themselves and a burden to the wider environment. This can be tackled with greater plans, definitely.

Since we are already moving not just into the East African Common Market but into a more systematic Southern Africa Development Community (SADC) and the Continental African Free Trade Area (CAFTA) the issue of refugees should be integrated into this wider space. They should be formally assisted to resettle and the citizenship issue be deferred; it is easier to sort out if they are settled.

With coronavirus further spreading, it makes sense shelving China trips

OP officials of the World Health Organisation (WHO) meeting in Vienna recently had a heated debate on the extent to which the outbreak of the coronavirus in China - which has effectively isolated its Wuhan city epicenter - is a global crisis. They agreed that at the moment it isn't a crisis of global proportions but it is a crisis in China, in which case preventive measures are needed everywhere. Isolated cases had already been noticed in the United States and other places.

They also agreed that a lot of things are still not sufficiently known at the moment, for instance the precise anatomy of the virus and how it broke out among domestic animals and spread to humans. Nor have its precise symptoms and ranges of the symptoms like temperature of the potential patient been set out clearly especially for screening purposes in airport checkpoints. In short there are various lacunae in handy information about the manner of outbreak, needing that those who wish to travel to China hold back business for a while.

There is an effective 'quarantine' around the city of Wuhan where the virus outbreak occurred, but with people having mixed for a while to and from other places, such that a patient even descended from a plane from China in the United States, it can't be said what will be the manner of its spread.

No one knows if it will be rapidly contained or cause an avalanche of deaths before something is done to effectively stop its spread. For instance it is unclear if there are ready preventive drugs for such an outbreak, and whether we in Africa

have those stocks, or how much it would cost to order supplies, and how soon...

Put differently, it isn't a question of avoiding the city of Wuhan as even the regulatory authorities won't allow anyone in there until further notice but to look at the situation more broadly. It is the fact that minor outbreaks could be lying low in Chinese cities where those from Wuhan would have travelled with a minimal infection in place but not yet showing symptoms of the disease. That is an assessment that agencies like WHO will take time to make up the full scenario of the strength of initial wave of infections, before the Wuhan isolation was put in place. Fortunately as well the People's Republic of China has effective regulatory bodies, so the quarantine is likely to be as effective as it should be, but other cities are relatively unprepared.

Even within China, the urge to make everything appear normal and that there is little to worry about overcame the sense of precaution, which signals that all may not go well.

The Wuhan city authorities announced the series of controls on movement after facing criticism for going ahead with an annual public banquet for 40,000 families at the weekend, despite the fact that the virus had started to spread.

The mayor told state broadcaster CCTV that they didn't then fully understand how the virus was spread and the decision to go ahead was based on a judgment that the spread was limited. While he was right to say they were constantly learning more about the epidemic, we ought not join the queue of learning on coronavirus the hard way. cally advanced countries around the world are aging.

The average age in Tanzania is 17 years. Isn't this to suggest that in the future it will be our opportunity to be the workforce of the world and make hefty profits from our endeavours?

The average age in Japan is 27, in China it is well past 40, in Europe it is 46, and in the US it is 40. I repeat: in Tanzania it is 17.

One only wishes this young blood of ours made the most of the fact that it is expected to be productive, dynamic and ready to work and transform the world - the precise role, say, China

played in the last generation. While many countries will be working with a serious deficit in terms of human capital, Tanzania will be a go-to "gold mine" for all manner of needs. For instance, it is estimated that the US will have a shortage of 17 million of working age.

We in Tanzania do have the people and the ability to equip them to take advantage of this, that is, to stand as the workforce even the world's economic giants would be forced into seeking.

If we get this right by properly or appropriately educating and training our young men and women, we will really transform not just our own economy and our society but the whole world. However, if we get it wrong, the demographic dividend that I am talking about will translate into a demographic disaster. We will also be left with an unemployed, frustrated, undereducated youth vulnerable to becoming a prey to guns and bullets or, to put it differently, uneducated slaves of sorts.

This is where then 17 global Sustainable Development Goals (SDGs) come in, particularly with respect to the need to focus on Quality Education as set out by

the United Nations.

These are a series of goals which range from zero poverty to peace and justice and which are expected to be achieved by 2030, and Tanzania's young men and women have the duty and responsibility of helping with efforts to ensure that they are achieved.

I am already playing my part. I have taken up a project to help in the construction of a library in a school for children with disabilities and to donate books. This, I must admit, was only possible with the assistance of friends who helped me execute this idea.

The school I have been working at was Dar es Salaam's Salvation Army Public School for children with various disabilities. This was my target audience since I have been working with this school for the past three years - purely as a community service.

I set out determined to learn about business management,

this followed by my passion of helping physically, mentally and otherwise challenged children.

I was also meanwhile working on the SDG directly related to the pursuit of quality education, this particularly by collecting money to invest in the building of a library for the Salvation Army Public School in Dar es Salaam.

My inspiration for this product relates to a project I had heard about previously, where a student had donated sewing machines to housekeeping women to have them boosts their family earnings. The reason behind gifting the sewing machines was that these were self-perpetuating assets, as it were.

This was an incredible idea since the cost of the sewing machine was given back to the student - as a refund - after the women group started making profit from their new business.

This idea sent me thinking about the importance of appreciating one's own social responsibility and how small economic decisions can have such a big impact in society.

My research involved studying multiple stories, one being that of the donation of sewing machines - and all had a role in helping me get to the root of the impact small economic decisions can have in a community.

Although my project didn't involve any terribly hard tasks or any heavy investment in the form of injection of money investment, it ended up having a big impact on the social life of the students at the Salvation Army school.

I sincerely believe that in seeking to achieve the SDGs we don't have to have an abundance of financial and other resources as "start-up" or "seed" capital but, rather, of most importance is deciding to move in the right direction.

My story testifies to this. My investment in the Salvation Army school project was nothing intensive, for any investment I made was not even in the education of the students but rather in their motivation.

This slight motivation in children can grow into interest in fighting to help them to learn on their own free will, and this would trigger the same reaction in their peers. As this grows "catches on" to other people, they would no longer have to rely on donations or handouts but would learn how to learn themselves, independently, which was indeed my project's primary goal.

The moral I see here is that it is a lot better to teach someone how to learn rather than to teach them a particular subject.


You are great at many things, that does not mean you should do all of it.

VEN though the Council on Higher Education recruits independent academic experts for its doctoral review, there is a compelling need for the CHE to be accountable to an external authority rather than self-referentially to itself. Concerns about the pending National

review in the first place. From the manual, we know that the NRF needed assurance that the doctorate was an instrument fit for its own mandate for Human Capital Development (HCD).

In imputing a human capital orientation, the op-ed critique was certainly offering a judgement that is arguable. It's an interpretive judgement. However, in the absence of clarity from the manual and the SER template, it is a plausible interpretation. After all, most readers of the "Preamble and rationale", will probably find that it resonates more readily with the development of human capital than it does with the development of human beings, such as in Plato's Academy where the search for truth was directed at the development of humankind as rational and moral beings in harmonious societies. In its response, the CHE refutes a human capital orientation in the Qualification Standard. More importantly, it removes the ground for debate about whether there is. or whether there is not such an orientation: "This section of the standard is intentionally descriptive. It does not form part of the normative section of the standard." Well, one could be forgiven for thinking it does. While we can't be too sure of what the CHE means by "normative" here, the "Preamble and rationale" is incontestably an integral component of the Qualification Standard. After its introduction, the standard proper begins thus:

terms of its own mandate, that includes value for money. The NRF was adamant from the start that the primary focus should be on the quality and ultimate value of research production, not on any extraneous factor such as quantity of produce or orchestrated utility.

Review of Doctoral Degrees were raised by me in a Daily Maverick Op-Ed ("The Council on Higher Education's review of PhD degrees reveals worrying trends"), published on 10 February 2020. With reference to the three CHE documents central to the review, this Op-Ed concludes that the doctoral review is on course for an outcome that is likely to undermine its own noble intentions of assuring and developing quality.

In a "Right of Reply" contribution, Professor Narend Baijnath, CEO of the CHE, offers a point-by-point counter to my critique ("The Council on Higher Education's review of doctoral qualifications: It's the attributes that count", 13 February 2020). This response concludes by assuring the public that "the council is confident that the forthcoming national review will be of high academic quality". This claim rests mainly on the three key CHE national review documents having been "developed and endorsed, in the first instance, not by the CHE but by an independent group of academic experts".

So, following the CHE's response, should we no longer be concerned about the quality of the review documentation after all? The account that follows is based on two areas of major concern.

First, the purposefulness and usefulness of documents cannot be assured only by their respectable origins "in the first instance". We can know if review documentation is fit for purpose only by interrogating it from the perspective of institutions and peer reviewers whose judgements will be directed and framed by it.

From this perspective, the National Review Manual and the Institutional Self-Evaluation Report (SER) Template do not pass muster. It is the standard that underpins everything: it specifies the key concepts that constitute the essence of what a doctorate is. The function of the manual and the SER template is to enable and facilitate a review process based on the standard. This entails a responsibility to guide universities in respect of the nature of evidence re-



quired under the prescribed template headings.

Sadly, the manual and the SER template do not saddle themselves with this responsibility. They present the same headings as the standard. But by limiting their scope to the technicalities of formatting and review processes, the manual and the SER template offer no support to universities in their crucial task of packaging valid and meaningful representation of their doctorates - visà-vis the standard's concepts - into the prescribed, standardised format.

Review processes are meant to be evidence-based. In the doctoral review, universities are left to fall back on their own interpretations, perhaps even best-guesses, regarding the nature of evidence required under the SER template headings.

In short, the manual and the SER template do a good job of supporting the CHE's bureaucratic line of reporting; they do a poor job of supporting the academic project.

Second, the CHE's "Right of Reply" contribution shows that its grasp of its own review documents is somewhat shaky.

These two uncomfortable judgements are made clearer in the two illustrative cases presented below. These cases represent the first and third of the four most important analytical sections in the SER tem-

ate; Graduate attributes; Context and conditions for supervision and assessment). Here we see how CHE suppositions can differ from perfectly reasonable possible interpretations universities may make when deciding on the nature of evidence required under respective SER template headings. Case 1. 'The Preamble and Rationale of the Qualification Standard for Doctoral Degrees'

The op-ed critique drew attention to a human capital orientation in the standard's "Preamble and rationale". In this regard, there seemed to be a link with the role of plate (the four are: Preamble and the National Research Foundation rationale; Purpose of the doctor- (NRF), the proposer of the national

Consistent with this, the first part of the SER Template to which universities must respond, begins: "With reference to the Preamble and Rationale in the Qualification Standard for Doctoral Degrees, briefly (a) describe (b) explain ... (c) describe and evaluate ..." the

institution's doctoral offerings. The role of the NRF is also relevant to one's interpretation of the "Preamble and rationale". In its rebuttal of the op-ed, the CHE states that: "It is true that the NRF has a vested interest in the outcome, in

manual and SER template entirely in the hands of the CHE."

This account is at odds with what the CHE told universities when advising them of the commencement of the national review in June 2019: "The necessary review instruments have been developed and approved with the support and close involvement of the National Research Foundation" (writer's emphasis).

If one accepts the latter account of the NRF's role, one will be more readily inclined to infer that the CHE expects doctorates to be mindful of Human Capital Development. Will writers of SERs feel that it would be strategically wise to foreground examples of doctoral studies that fall into the ambit of HCD - thereby endowing themselves with "quality"? We'll have to wait to find out.

Case 2. Graduate Attributes

The op-ed critique pointed out a disjunction between the standard and the SER template in respect of how institutions are expected to demonstrate compliance with the standard's specification of Graduate Attributes. The former specifies nine areas of knowledge and skills, each beginning with an achievement-based statement such as: "The graduate demonstrates ...", or, "shows evidence of ...". On the other hand, the SER template says: "Describe and evaluate how your institution prepares candidates to attain the graduate attributes...".

Outcomes are related to but analytically distinct from the means by which they are achieved.

In justifying its position, the CHE now writes: "It is correct that the former [the standard] focuses on what the graduate can do, and the latter [the SER template] on institutional policies and procedures for ensuring the attainment of the attributes. ... It was agreed that institutional policies and procedures would serve as proxy for the qual-

Revisiting the corruption theory of a departed journalist

N understanding of Jason's Law of Corruption... teaches that to tackle official and unofficial corruption and earn us an honourable place in the league of nations, we must halt the graft competition sparked by a government that runs an insular philosophy. The decibel of an average Nigerian's public outcry (against government incompetence and corruption) is directly proportional to his distance from the opportunity to do exactly what he condemns. - Pini Jason Onyegbaduo (1948-2013), late Nigerian renowned newspaper columnist.

When one of Nigeria's most celebrated columnists, Pini Jason, died on Saturday, May 4, 2013, at 65, he was mourned as a writer who emblazoned our journalism with a rarity of language that surprised the reader with a simplicity of presentation. Pini Jason would pick a hot button issue. Turning it inside out, he would lay its entrails bare to reveal a promising feast. Then as you wondered where all this seemingly complex exposition of innards would take you, Pini Jason would build back the dismembered components into a new frame. He would have succeeded in giving you a delicacy, a diet of words, in just a couple of minutes.

This astonishing command of language wasn't the only strength of our illustrious columnist. He also possessed the ability to refrain from interpreting events of the day merely from his own point-of-view. That's to say, he wasn't afflicted with the plague that is the bane of most of us. We would attempt to force, by subtle means, our stand on others. Pini Jason wouldn't. He might guide you to arrive at your own independent position on any given matter, even if it flew off at a tangent. It was a strange form of reticence that enabled Pini Jason to undertake a shrewd, lifelong study of his country's problems. He wasn't afraid to declare his findings and



convictions, most of which were considered unpopular by those in power.

As such, if we hail the departed columnist for the power of his pen and intrepidity, we must salute him more for bequeathing to us a badly needed Law of Corruption to help us exorcise the imp threatening to destroy us, if we don't kill it.

He propounded it in 1988,

in his column in a now rested weekly magazine. Jason wrote: "The decibel of an average Nigerian's public outcry is directly proportional to his distance from the opportunity to do exactly what he condemns... The difference between many a vociferous, sanctimonious and pontificating Nigerian and the villainous, itchy-fingered kleptomaniac is probably the absence

of the opportunity to steal... In all probability, should the opportunity occur, yesterday's moral crusader is likely to crumble and disappear under the weight of corruption."

Twenty four years after the columnist gave his country the theory, he discovered nothing had changed under a civilian government. Therefore he came again in his Vanguard newspaper column of July 7, 2012. Under the title, "Corruption and Nigerian Hypocrisy," Pini Jason wrote: "... I have hinted at what I call the ambivalence of Nigerians about corruption. Indeed, what I mean is that we are all hypocrites about our concern over corruption. Otherwise how is it that very often those who are ostensibly in pursuit of transparency or those fighting corruption are invariably caught in the very act of corruption? What I see most times are people who are incensed that someone else is doing the stealing, and not them. Given half a chance, they out-steal the people they were criticizing yesterday."

It was a disliked proposition. It remains so. However, with graft, nepotism, cronyism and other variants of corruption on the rise to warrant a dismal outing for Nigeria in the just published Corruption Perception Index (CPI) issued by Transparency International (TI), there is an exigent need to draw on all fronts, popular or unorthodox, to rescue the country from its perennial nether ranking in the global log of probity. For their part, some concerned Nigerian journalists, Bisi Abidoye, Olugbenga Odulaja and a third compatriot, have in the recent past been drawing our attention to Pini Jason's Law on Corruption. They have retrieved the columnist and his theory from his grave to be part of the conversation on how to outlaw corruption. The social media is brimming with their messages.

We all must be interested in this conjecture from a man who held his own as an unflagging journalist and an uncompromising patriot till he breathed his last. His hypothesis addresses the sociology of corruption, albeit at an empirically verifiable plane.

Conversely, when we are placed far away from the scene of prosperity, "the decibel of our outcry" outmatches that of the loudest disco music.

Corruption is a form of dishonesty or criminal offense undertaken by a person or organiSation entrusted with a position of authority, to acquire illicit benefit or abuse power for one's private gain. Corruption may include many activities including bribery and embezzlement, though it may also involve practices that are legal in many countries. Political corruption occurs when an office-holder or other governmental employee acts in an official capacity for personal gain. Corruption is most commonplace in kleptocracies, oligarchies, narco-states and mafia states.

Corruption can occur on different scales. Who has the most to gain from destroying commuter rail networks?

ET us suppose that the burning of commuter trains is pure vandalism and criminality. It really is difficult to see what the motive would be: there seems to be little pecuniary gain from burning train carriages.

In last year's State of the Nation Address (SONA), President Cyril Ramaphosa singled out the repair of "commuter rail" as a "key priority".


"A key priority this year is to fix commuter rail, which is vital to our economy and to the quality of life of our people... our rail network daily transports over a million commuters to and from work. We are modernising Prasa's rail network. The Central Line in the Western Cape and the Mabopane Line in Pretoria have been closed for essential refurbishment and upgrades. We are investing R1.4-billion in each of these lines to provide a safe, reliable and affordable service," Ramaphosa said.

He was, of course, correct. It's almost passé to repeat that the railway network forms the basis of all economic expansion, growth, distribution, consumption and general mobility. It gets people to their homes and places of work, it gets raw materials to production facilities, and consumer products, from food to clothing, to and from markets.

But that is the big picture. This big political economic picture has little meaning to the atomistic individual taxi driver, who has no interest in mass commuter transportation. The fewer commuter trains - or public transport in general - there are, the more people are forced to use taxis.

On another level, building rail transportation networks - to move heavy loads of goods from roads, which are expensive to build and maintain, to rail - is of no interest to individual truck owners or operators.

This is the problem with the belief that free enterprise necessitates a greedy individual, interested only in utility maximisation (narrow selfinterest). This "free enterprise" was unleashed in the minibus taxi industry, and there is little to no chance of it being brought into an area such as the provision of public goods and services - or that most abstract of ideas, "the national interest".



Soga based modern meat factory to commence operation in April

By Guardian Reporter

A modern meet processing factory worth U\$15 million (over 34.5bn/-) will start operations at Soga in Coast Region in April this vear.

The Tan Choice Tanzania plant which is a an Export Processing Zones Authority (EPZA) project will have capacity to slaughter and process 1,000 herds of cattle and 4,500 goats and sheep per day using high tech equipment. It is expected to create over 500 jobs both directly and indirectly once it starts operating.

"We are currently finalizing some logistics for the project to kick start," said Dr Bonaventure Mtei, Tan Choice Project Coordinator," Dr Bonaventure Mtei when briefing Industry and Trade

Swissport allegedly had no grounding licence at time of SAA tender bid

JOHANNESBURG

The commission of inquiry into state capture heard on Friday that Swissport SA allegedly did not have a grounding licence at the time of its submission for a tender at SAA.

The tender in question indicated a critical criterion where the bidder must have a valid Airports Company South Africa (ACSA) licence to qualify.

"What we saw was the Swis-

sport SA at the time that the tender closed, they did not have a licence from ACSA to provide services. The closing date was July 1, 2008," Polani Sokombela, a business executive at the Auditor-General South Africa (AGSA), told the commission.

"[In addition], upon my team inspecting an email from an official from ACSA dated June 4, 2008 - it was noted that at the time of submission of Swissport SA's bid, they were not in posses-

sion of a grounding licence," he added. According to Sokombela, a letter - dated July 14, 2018, from the Swissport president that was addressed to SAA - indicated it had been awarded the third ramp - effective from September

1,2008 - for a period of five years. The commission is continuing with aviation-related evidence by zooming into the AGSA audit report that delves into the role private firms played when they were conducting a joint audit of SAA as well as what the AGSA found following the five years of audit work, from 2012 to 2016, during which the entity was given clean audits.

The AGSA took over the SAA audit in the 2016/17 financial year after the entity had received consecutive clean audits for five years from private firms PricewaterhouseCoopers (PwC) and Nkonki. According to Sokombela, a third bidder - Menzies Aviation felt disadvantaged in the bidding

process due to the other bidders who were already doing groundwork for SAA.

As a result, they applied for an extension on June 30, 2018, which was subsequently denied by the airline. "SAA did not grant that extension and that ended up with Menzies taking SAA to court. On December 4, 2009, the High Court ruled in favour of Menzies. "The tender process was set aside as it was found to be unconstitutional and unlawful," Sokombela

said. Despite the High Court ruling, the AGSA found the airline awarded the contract. "So, they just disregarded a court order?" the chairperson of the commission, Deputy Chief Justice Raymond Zondo, asked. "That is what appears here," Sokombela responded.

This tender was one of the "transactions" the AGSA included when it was evaluating risk assessment at the airline. "We identified this tender as we [needed] to ensure that we test it. There was a lot of media attention on it, and challenges reflected there. It formed part of our specific selection.

"One of the concerns with the tender is that it took four years between the closing date of the award and the date that it was awarded by the board of directors [to be awarded]. Why would a tender take so long to be awarded?" Sokombela said. The inquiry continues.

OPTIMISM IMF sees V-shaped virus impact on China with 'moderate' fall out for global economy

RIYADH

The outbreak of the coronavirus is likely to force a sharp drop in the Chinese economy, which will make its recovery equally rapid and help in keeping the overall impact on global growth at a moderate level, the International Monetary Fund managing director Kristalina Georgieva said.

There is no definitive data to make an accurate projection and the IMF is working with a scenario and "not with a precise number," she said in Riyadh where G20 finance and central bank governors are meeting. The IMF also recognises other scenarios, where the impact of the outbreak could be significantly more, she noted.

CONFRONTATION

"The most likely scenario is a V-shaped impact of the virus, in which a very abrupt, significant drop in China will be followed by very rapid recovery and the impact on the rest of the world growth will be moderate," she said. The quicker the spread of the epidemic is contained the softer the impact will be on the global economy, she also said in a blog post on the IMF website on Tuesday.

The deadly coronavirus has so far claimed more than 2,200 lives and infected more than 75,500 people on mainland China alone. The Chinese economy grew at the slowest pace in three decades last year on the back of a trade

Broad-based support powers Sanders to big win in Nevada **Democratic vote**

LAS VEGAS

BROAD-BASED support across age, racial and ideological groups propelled Bernie Sanders to a dominant victory in Nevada's Democratic caucuses, tightening his grip on the frontrunner spot in the race to find a challenger to President Donald Trump.

Joe Biden, the former vice president, appeared headed to a badly needed second-place finish in Nevada after poor showings earlier this month in the first two nominating contests in the Democratic presidential race ahead of the Nov. 3 election.

Sanders' triumph on Saturday in the first racially diverse state in the campaign suggested he was reaching a broader coalition of Democratic voters with his unapologetic message of social and economic justice, including his signature pledge to provide universal healthcare for all Americans.

For Biden and other moderates who argue Sanders is too liberal to beat Trump and who have been trying to blunt his momentum, however, the

Nevada results made the job much harder.

"We have put together a multi-generational, multiracial coalition that is going to not only win in Nevada, it's going to sweep the country," Sanders, a U.S. senator from Vermont and selfdescribed democratic socialist, told cheering supporters in San Antonio, Texas

With 50% of the precincts reporting, Sanders had 47% of the county convention delegates in Nevada. Biden was a distant second to Sanders with 19%, but ahead of former Mayor Pete Buttigieg of South Bend, Indiana, in third with 15%.

"The press is ready to declare people dead quickly, but we're alive and we're coming back and we're gonna win," Biden told supporters in Las Vegas on Saturday night.

Buttigieg cautioned Democrats about nominating Sanders, portraying him as an ideologue who would divide the country and lose to Trump.

"We can prioritize either ideological purity or inclusive victory. We can either call people names online or we can call them into our movement. We can either tighten a narrow and hardcore base or open the tent to a new, broad, big-hearted American coalition," Buttigieg told supporters in Las Vegas.

BROADENING RACE

The race now begins to broaden across the country, with the next primary on Saturday in South Carolina, followed closely by the Super Tuesday contests in 14 states on March 3 that pick more than one-third of the pledged delegates who will help select a Democratic nominee.

Bernie Sanders

The Super Tuesday states will be the first nominating contests for former New York Mayor Michael Bloomberg, who has not been competing in the four early voting states but had been rising in opinion polls.

"The Nevada results reinforce the reality that this fragmented field is putting Bernie Sanders on pace to amass an insurmountable delegate lead," Bloomberg campaign manager Kevin Sheekey said in a statement.

Voters poured into more than 250 caucus sites around Nevada, where Sanders was aided by strong support from the six in 10 voters who said they backed a government-run Medicare for All, the Edison entrance poll showed.

The entrance poll showed Sanders led in Nevada across all age groups except for those older than 65. Around 54% of Latino voters said they backed him, while 24% of college-educated white women and 34% of those who have a union member in their families supported him.

He also won with college graduates, and was the top pick of voters who consider themselves independents. He also was favored over Biden among voters whose top priority is defeating Trump in the November election.

US's allegations about Russia's spreading misinformation about coronavirus seen as fake MOSCOW

The United States' allegations about Russia's indulging in misinformation campaign concerning the novel coronavirus origin are a deliberate fake, Russian Foreign Ministry Spokeswoman Maria Zakharova told TASS on Saturday.



"It is a deliberate fake," she said, commenting on media reports that the US Department of State thinks that Russia is behind proliferation of misinformation about the coronavirus outbreak.

France Presse said earlier on Saturday citing unnamed US Department of State officials that US diplomats had been tasked to offset a misinformation campaign allegedly unleashed in Twitter, Facebook and Instagram social networks.

The agency's sources claimed that corresponding posts appear on accounts of users "linked with Russia."

Commenting on these reports, US Acting Assistant Secretary of State Philip Reeker claimed that some "Russian malign actors" were allegedly behind the misinformation campaign fueling coronavirus fears and threatening "public safety by distracting from the global health response."

A pneumonia outbreak caused by the COVID-19 virus (previously known as 2019-nCoV) was reported in China's city of Wuhan, a large trade and industrial center with a population of 12 million, in late December.

The World Health Organization (WHO) declared the coronavirus outbreak in China a global health emergency, characterizing it as an epidemic with multiple foci.

Cases of the new coronavirus have also been reported from 27 other countries, including Russia. According to the latest update, the number of confirmed cases of the disease has exceeded 76,200, with 2,345 people killed by this coronavirus. More than 20,000 have recovered.

Prince Harry and his wife will stop using 'Sussex Royal' brand

BRITAIN'S Prince Harry and his wife Meghan have decided not to use the word "royal" in their branding after they start a new life in Canada follow-



ing their decision to step back from royal duties.

The decision follows weeks of talks between the couple and the British royal family about how they will present themselves to the world in the future.

The couple agreed last month with Harry's grandmother, Queen Elizabeth, that they would no longer work as rovals after their surprise announcement that they wanted to carve out a "progressive new role" which they hope to finance themselves.

AU health ministers meet over precautions against COVID-19

ADDIS ABABA

AFRICAN ministers of health met on Saturday at the African Union (AU) Headquarters in Ethiopia's capital Addis Ababa to discuss a continental strategy for preparedness and response to COVID-19 outbreak.

The meeting of health ministers of AU member states is expected to discuss and agree on a continental strategy to better prepare and respond to any new cases of the virus on the continent.

The Africa Center for Disease Control and Prevention (Africa CDC) of AU last week told a press conference that enhanced efforts are underway to prepare for any possible outbreak of COVID-19.

As one of the major steps, AU has established continental taskforce on COVID-19 to enable Africa to be prepared for and capable of responding to the disease if any

Chinese and China-made products are themselves the virus. Some of them are trying to establish that the coronavirus is made in China.


The West is doing its utmost to create panic in China and to demonize Chinese people. They would like to hamper trade and business in China, thereby isolating the second-largest economy from the rest of the world.

Though the West has been overreacting to the coronavirus outbreak, they have remained silent about just how deadly common influenza is in the US. The Centers for Disease Control and Prevention, leading national public health institute of the US, estimates that so far there have been at least 22 million flu illnesses, 210,000 hospitalizations and 12,000 deaths from flu during the 2019-20 season.

China, S. Korea and Japan deepen ties amid epidemic

SOUTH Korea and Japan have both shown great support for China amid the ongoing novel coronavirus pneumonia outbreak, which many Chinese citizens hailed as a sign of the deepening friendship of the three East Asian countries.

The government of Seoul, capital of South Korea, said on Tuesday, February 11, it would donate medical supplies and equipment worth around 3.5 million yuan (\$506,000) to dozens of Chinese cities including Beijing, to help China combat the pneumonia epidemic.

Yonhap News Agency reported that medical supplies to China include 1,000 protective outfits, 500 pairs of medical goggles, and 30 thermal imaging cameras, and the country's Korea Federation of SMEs (small and medium-sized enterprise) also participated in the donation.

A batch of materials are expected to leave Incheon International Airport and arrive in Seoul's Chinese sister cities, including Beijing and some other cities in Northeast China's Heilongjiang, Jilin and Liaoning provinces, on Wednesday, it reported.

Seoul mayor Park Won-soon also extended his gratitude toward Beijing's previous assistance of special assistance teams to Seoul during the MERS outbreak, and wished China a rapid easing of the current difficulties.

Additionally, the Korean Embassy displayed a banner which read, "China's difficulties are also ours." The embassy wrote in a post on China's Twitter-like platform Sina Weibo, including a picture of the banner that read "South Korean Embassy is with you," with the hashtag "because we are family."

Japan also showed sincerity amid the outbreak.

Lawmakers of the Japanese ruling party, the Liberal Democratic Party of Japan (LDP), would each donate around 320 yuan to China, Toshihiro Nikai, the party secretary general told the media on Monday, February 10.

Japan is ready to mobilize the whole country and provide all assistance possible to China in combating the novel coronavirus pneumonia outbreak, heavyweights of the ruling camp, including Toshihiro Nikai, said on Friday.

A friend in need is a friend indeed, said Nikai, adding that the Japanese side is ready to spare no effort to provide all possible assistance to China and work with China to combat the epidemic.

Japan has collected 120,000 sets of protective outfits and will send them to medical institutions in Hubei, Zhejiang and Guangdong provinces as well as other places as soon as possible, Nikai said.

The epidemic has proved who are true friends, and China will remember, Chinese netizens said.

"Come to Harbin [capital of Heilongjiang Province] and the local cuisine will be my treat, dear friend," wrote one Weibo user, welcoming friends from Japan and South Korea.

Stage all set in India for **Trump's visit**

NEW DELHI

THE stage is all set in India for the two-day visit of U.S. President Donald Trump on Feb. 24-25.

The 36-hour visit is Trump's first to India as the U.S. president. He visited the South Asian country as a businessman before.

Trump's Air Force One airplane is expected to touch down at the airport in Ahmedabad, a city in western coastal state of Gujarat, before noon today, and he will depart back to Washington the tomorrow evening.

The highlights of Trump's visit are the massive road show to welcome him in Ahmedabad which will culminate in a huge reception by nearly 100,000 Indians, the sunset visit to the world heritage site the "Taj Mahal," and his high-level deliberations and industry meetings in Delhi tomorrow.

The visit assumes significance even as it comes in the election year in the United States.

Zorawar Daulet Singh, Adjunct Fellow at the Delhi-based Institute of Chinese Studies (ICS), said that with the U.S. entering a new election cycle, it is unlikely any major outcomes will be possible on trade or regional security issues, "where differences on market access and Afghanistan are still very much on the minds of policymakers."

Though Trump has categorically mentioned that a trade deal was not possible, but anticipation remains high in India ahead of his visit.

Considering what has appeared in the Indian media over the past few days in the run-up to the visit, focus remains on trade, defence and Afghanistan. U.S. Trade Representative Robert Lighthizer, who has been negotiating with Indian Commerce and Industry Minister Piyush Goyal, is not a part of Trump's delegation, but U.S. Commerce Secretary Wilbur Ross would be in New Delhi.

It is anticipated that the Generalised System of Preferences (GSP), a reduced tariff system which has been withdrawn by the United States from India, would be among the subjects to be discussed on the table.

A number of agreements and MoUs, including on counter-terrorism, intellectual property rights, space and medical cooperation, are also likely to be exchanged during Trump's visit, of-

South Sudan leaders in show of unity as unity govt formed

SOUTH Sudan leaders vowed to unite the country as the new transitional unity government was formed on Saturday.

President Salva Kiir and First Vice-President Riek Machar called on South Sudanese to forgive one another and join efforts to unite the country and rebuild the war-torn country ravaged by more than six years of conflict.

"This [swearing-in] action signifies the official end of the war and we can now declare a new dawn in South Sudan. Peace has come to stay, not to be shaken ever again in this nation," Kiir said after the swearingin ceremony of four vice-presidents administered by the Chief Justice, Chan Reech Madut in Juba.

Machar was sworn in as the First Vice President along with Taban Deng Gai, James Wani Igga and Rebecca Nyandeng De Mabior as vicepresidents.

"I do hereby swear that I shall be faithful and bear diligence to the Republic of South Sudan," Machar said in his oath in a ceremony which was attended by representatives from the international community.

One slot of vice president from the South Sudan Opposition Alliance and cabinet members of the unity government are yet to be announced due to differences within the group.

Kiir said the formation of the transitional unity government means that peace has come to South Sudan and is "irreversible".

THE United States and the Taliban will sign an agreement on Feb 29 at the end of a week long period of violence reduction in Afghanistan, US Secretary of State Mike Pompeo and the Taliban said on Friday.

Afghan, international and Taliban forces will observe the reduced violence period beginning at midnight (1930 GMT), an Afghan official and Taliban leaders said earlier.

"Following lengthy negotiations between the Islamic Emirate of Afghanistan and the United States of America, both parties agreed to sign the finalised accord in the presence of international observers," a Taliban spokesman said in a statement. Both sides would also make arrangements for the release of prisoners, spokesman Zabihullah Mujahid said.

Separately, Pompeo said in a statement that the United States and the Taliban have been engaged in talks to facilitate a political settlement in Afghanistan and to reduce the US presence in the region.

The agreement will be signed upon the successful implementation of an understanding with the Taliban on a significant and nationwide reduction in violence, Pompeo added. The agreement could represent a chance for peace in the country after years of war and a US troop presence that dates back to 2001.

US and Taliban negotiators have been meeting in Doha since 2018 even though fighting has raged in Afghanistan and thousands of civilians and combatants have been killed as the insurgents have expanded their territorial control. **Agencies**

Fury wins in stunning stoppage of Wilder in heavyweight tilt

TYSON Fury reinvented himself once again, and once again he's a heavyweight champion.

The Gypsy King dropped Deontay Wilder twice Saturday night in their heavyweight title rematch, turning from boxer to puncher to win the title when Wilder's corner threw in the towel as he was taking a beating in the seventh round.

It was a stunning turnaround for a fighter who came back from drug and alcohol abuse to win the title for a second time, made even more surprising because Wilder was the devastating puncher in their first fight 14 months ago.

"The king has returned to his throne," proclaimed Fury, who fought to a draw with Wilder in their first fight.

Fury dropped Wilder in the third round with a right hand that seemed to take the legs out of the champion. He put him down again in the fifth round, this time with a left hand to the body.

He also bloodied Wilder's ear, and seemed to lick the blood off his shoulder in a bizarre scene in the sixth round. If that wasn't enough fun for the night, he tried

to lead the crowd in a singalong of "American Pie" after the fight. Fury knew all the words

The end came at 1:39 of the seventh round when referee Kenny Bayless stopped the fight after Wilder's corner threw in the towel as he was getting pummeled in a neutral corner. Blood was pouring out of Wilder's ear for several rounds before Fury went in for the shoulder lick.

It was the first loss for Wilder in 44 fights, and it came in the 11th defense of the title he won in 2015.

"Even the greatest have lost and come back," Wilder said. "I make no excuses. This is what big-time boxing is all about."

The two fighters are under contract for a third fight, though Wilder could opt out of it as the loser. If the fight happens, Fury would get the better part of a 60-40 purse bid.

Fury stalked Wilder almost from the opening bell, using his jab to control the early rounds. He won every round on the scorecard of the Associated Press and was in total command of the fight when it ended.

Ringside punch stats demonstrated Fury's dominance, show-

ing him out landing Wilder 82-34 in total punches. Fury landed 58 power punches in less than seven rounds of the rematch after landing just 38 in the first fight Wilder landed just 34 punches all fight

and just 18 power shots. Wilder briefly protested the stoppage, as a pro-Fury crowd of 15,816 at the MGM Grand hotel roared in delight. The highly anticipated fight drew a heavyweight record \$16.9 million gate and promoters believe it sold well on pay-per-view, too.

"I wish my corner would have let me go out on my shield," Wilder said. "He did what he did. There's no excuses.

Wilder, who at 6-foot-7 and 231 pounds was the smaller man in the ring to the 6-foot-9 British giant, was backpedaling the entire fight, trying to catch Fury coming in with a right hand. But he was never able to throw it effectively, and unable to deal with Fury's jab either

Two judges had Fury winning every round, while the third gave Wilder one round. Fury had a point deducted for grabbing and pushing in the fifth round.

"He manned up and he really did show the heart of a champion," Fury said. "He's a warrior, he will be back, he will be a champion again. But the king has returned.'

Fury had bulked up to 273 pounds for the rematch, vowing to change tactics and become the big puncher. He was true to his word, dominating early with a jab that stopped Wilder in his tracks and then landing combinations to the head and body.

Fury (30-0-1, 21 KO) came into the ring carried aloft on a throne with a crown on his head. Then he showed he was really the Gypsy King as he made it an easy night against a fighter who had gone 12 years without losing as a pro.

For Wilder it was a stunning end to an unbeaten mark that had seen him knock out 41 of his previous 43 opponents. But his devastating right hand was never a factor, and Fury seemed to walk through it. That was unlike the first fight 14 months ago when Wilder knocked Fury down twice on his way to a draw.

Both fighters were guaranteed \$5 million in the rematch but could make \$40 million apiece.

CHELSEA strengthened their grip on a Premier League top-four place on Saturday by beating London rivals Tottenham 2-1 as Manchester City edged past Leicester despite another attack of the penalty jitters

Sheffield United will rue missing out on the chance to clamber above Tottenham into fifth place after drawing at home to struggling Brighton.

Liverpool's staggering 19-point lead over second-placed Manchester City means the title race is effectively over, with much of the focus turning to the scramble to qualify for next season's Champions League.

Frank Lampard's fourth-placed Chelsea went into their match against Jose Mourinho's Spurs at Stamford Bridge without a win in their past four Premier League matches and just one point clear of Spurs.

Fringe players Olivier Giroud and Marcos Alonso were recalled by Lampard and both rewarded their manager's confidence by scoring in the home win.

The result means Lampard has completed a league double against his former boss this season after their 2-0 victory at the Tottenham Hotspur Stadium in December.

But the match was overshadowed by a VAR controversy, with officials ruling that Tottenham midfielder Giovani Lo Celso did not deserve to be sent off for a "leg breaker" stamp on Cesar Azpilicueta.

World Cup winner Giroud put Chelsea ahead in the 15th minute when he reacted quickest to finish beyond Hugo Lloris after Ross Barklev had struck a post.

Chelsea doubled their advantage three minutes into the second half. Alonso drilling in a first-time shot after being set up by Barkley.

Alonso's free-kick hit the bar before Antonio Rudiger deflected Erik Lamela's shot into his own net in the 89th minute to give Spurs late

Jamie Vardy will rue hitting the post early in the match and Leicester had two penalty appeals turned down in an engaging contest.

"We have missed four penalties in a row but maybe we will shoot a penalty when we need it to win something," Man City coach Pep Guardiola told the BBC. "The keepers are good too, but the next one we are going to score."

Sheffield United had a chance to steal a march on their rivals for a Champions League place next season, with Manchester United, Wolves, Arsenal and Everton not in action until Sunday.

They took the lead at home against Brighton through Enda Stevens but Neal Maupay equalised for the south coast club on the halfhour. The 1-1 draw leaves Sheffield United in sixth place on 40 points, level with Tottenham.

Sheffield manager Chris Wilder said he was proud of his team's efforts in tough conditions.

"There was just a relentless nature of our game, we were knocking on the door and if it don't open, it don't open, but not for want of trying and not for want of an attitude that's exceptional and has been all season," he said.

Burnley beat Bournemouth 3-0 to win for the fourth time in five Premier League matches and lift themselves to eighth in the table while Southampton won 2-0 at home to Aston Villa to move 10 points clear of the drop zone.

Runaway league leaders Liverpool host struggling West Ham on Monday.

"The ovation was really special," Braithwaite said. "It's something that I saw on television when I was little, how they treat the new players [here], and suddenly to be here and experience that from the fans is incredible. I am really proud.

"I feel really good here, surrounded by fantastic players. I tried to run and move, which is what I have to do, and my teammates found me. It's been amazing. I am really happy."

Barcelona coach Quique Setien was impressed with what he saw from his new signing and tipped him to make a contribution in the final phase of the campaign.

"Braithwaite did more than I expected, much more," Setien said



in a news conference. "Honestly, I think we have made an extraordinary signing. He's going to adapt perfectly to what we need.

"We've seen he has good movement this afternoon, but beyond the goals he was involved in, he's good in space and he understands the game so well. He is an extraordinary player and he's going to help us a lot.'

While Braithwaite impressed on his debut, Messi once again stole the show. The Barca captain had gone four league games without scoring, but his four-goal haul against Eibar took his season tally to 23 in all competitions.

With this win, Barca went them two points clear of Madrid at the top of La Liga, although Zinedine Zidane's side can reclaim the lead when they meet Levante later on Saturday.

Setien said the win was "just what was needed" ahead of a testing week, in which his side visits Napoli for the first leg of their Champions League last-16 tie on Tuesday, then face Real Madrid at the Santiago Bernabeu five days later. (Agencies)

Messi scores four as Barcelona jump above defeated Madrid before Clasico

LIONEL Messi scored four goals and Barcelona reclaimed top spot in La Liga as Real Madrid suffered a surprise defeat by Levante on Saturday, a week before the Clasico.

Madrid's nightmare afternoon was made worse by another injury to Eden psychological blow, especially given the Hazard, who was forced off in the second half of their 1-0 defeat in Valencia and is now doubtful to face Manchester City on Wednesday in the Champions League.


