## **Brigade revisits** school fires in 2020 report on disasters, rescue

#### **By Guardian Reporter**

THE Fire Brigade and Rescue Force said yesterday that a total of 557 people died in various disasters including fire incidents in 2020.

Among those rescued during disasters, 818 suffered injuries, 570 being men and 247 women.

During the particular period, the total number of fire incidents was 1,925 causing deaths of 62 people noted as 45 men and 17 women. Fire incidents caused injuries to 74 people, of whom 52 are men and 22 women.

In its report circulated to the media in Dar es Salaam yesterday, the force said that it has continued to make precautionary inspections against fire disasters, educating the public as well as investigating the causes of fire disasters.

The fire brigade was also engaged in rescue operations in various areas including road accidents, floods, mining areas, pit latrine immersion, sweeping of people by rivers, dams, the sea and in other

situations, the report noted. The force has been taking measures to investigate causes of disasters and educate the public on how to avoid mishaps and reacting to such incidents, it said


"We have been engaging in provision of education to the public on how to minimize the repetition of disasters. The public is also instructed on how to handle fire outbreaks in particular," the statement noted.

During the year there were many incidents of fire in schools, with outbreaks occurring at about 44 schools resulting in deaths of pupils and destruction of school infrastructures and other personal properties.

Investigations by the Fire Brigade and Rescue Force revealed that most of the fire incidents, especially those in schools were caused by negligence and sabotage leading to electrical faults, the statement indicated.

"However, in regard to boarding schools we have discovered that students secretly charge their cellphones using live electric wires in dormitory ceilings, using






## Chinese foreign minister working visit starts Jan 7

TRADE and industrial growth are expected to be the main discussion topics during the working visit of Chinese Foreign Affairs Minister Wang Yi in the country early next

### Seed, grain initiative will benefit 100,000 farmers

OVER 100,600 smallholder farmers in 25 districts will be receiving grain and vegetable seed grants worth nearly \$400,000 (one trillion/-) to assist them combat the effects of the Covid-19 pandemic.

Through its new "Better Farms, Better Lives" initiative, Bayer, a life-science oriented multinational company will complement its current commitment to support smallholder farmers in Africa, by providing them with free hybrid corn and vegetable

"Smallholder farmers are essential to providing food security to billions of people, but the on-going COVID pandemic is placing extra challenges

### 'Fertiliser body must use SGR to cut selling price'

THE Deputy Minister for Agriculture Hussein Bashe (pictured) has directed the Tanzania Fertilizer Regulatory Authority (TFRA) to explore opportunities available with the Standard Gauge Railway (SGR) to reduce cost of fertiliser when it reaches smallholder farmers.

Bashe issued this directive in Dar es Salaam yesterday when visiting TFRA offices, citing high transport



cost as among factors for hiking the price of fertiliser.

"And one of the challenges is that we've been relying too much on road transport which is costly, despite that we have railway lines," he said, noting that when fertiliser reaches the Dar es Salaam port, the maximum cost of a bag is 38,000/-, but a smallholder farmer upcountry gets it at 64,000/-, an increase of 26,000/- per bag.

"This price has been contributed by transport costs and other handling charges. To farmers, this increases the cost of production, that's why it is high time for TFRA to come up with a solution that will make farmers get

# Fifth batch of asylum seekers from Libya arrives in Rwanda

A group of 130 refugees and asylum seekers from Libya arrived in Rwanda on the night of Tuesday, December 29, becoming the fifth batch from the northern African country to be temporarily hosted in Rwanda.

The asylum seekers will eventually be resettled in other countries, according to an existing arrangement.

According to UNHCR, the global refugee body, the group is composed of 67 Eritreans, 48 Sudanese, 12 Somalians, two

Nigerians, and one Libyan. Visibly, majority of the latest

arrivals are youth, and a few couples who were with their little children.

Upon arrival at Kigali International Airport on Tuesday night, they were tested for COVID-19 and later accompanied to La Palisse Hotel Nyamata in Bugesera district from where they will wait for their results.

They will then proceed to the Gashora Emergency Transit Mechanism located in the same district, where they will be accomodated.

Since 2019, Rwanda has been receiving refugees and asylum seekers who were evacuated from Libya, after being stranded there,

The move is in line with the framework established through a tripartite agreement between the Government of Rwanda, UNHCR, and the African Union.

Under the agreement, Rwanda made a commitment to host African refugees trapped in Libya after their desperate efforts to make it to European countries were cut short.

In total, 515 refugees and asylum seekers have so far been evacuated to Rwanda and of these, over 200 got resettled in other

countries - mainly in Europe. According to the Ministry of Emergency Management, 131 were

resettled in Sweden, 23 in Canada, 46 in Norway, and 5 in France.

Observers noted that scaling up the post-Covid-19 recovery effort for Tanzania and arrangements for supply of the Sinovac anti-coronavirus vaccine now authorized for use after being tested in various foreign countries will be key issues during the minister's tour of African countries.

The high cost of supplying fertilizer to farmers is among setbacks thwarting development of the agricultural sector since the price of fertiliser remains high,, he added.

## PM directs director to motivate people to join community fund

universal health coverage for all which will allow Tanzanians to receive services at affordable cost throughout the year.

"I direct you to ensure that the funds collected within CHF fund are well utilised and used as required because this is the gateway affordable services," he

The PM also directed the district medical officer to make a follow up to the provision of services because there were reports of some workers issuing insulting remarks to patients.

He said the aim of the fifth

phase government is to expand health insurance coverage to at least 50 per cent in the efforts to achieve the Universal Health Coverage (CHF).

The PM also addressed a public rally at Nachingwea in Ruangwa District where he promised to continue working with them develop the district.

PM Majaliwa said the government priorities were to ensure the availability of services such as water and health saying already there are many plans in place.

Apart from provision of

services the PM said the other area of concentration was to ensure improvement of economic prospects for the youth including establishing special funds for loans through constituency funds as well as agriculture.

The PM motivated the residents to involve themselves in activities that will generate income for their wellbeing.

"I will continue to administer the current system of loan issuance in local governments so that it benefits the youth by funding them.

#### Govt purchases mobile sawmill machines worth about 200m/-

THE government has purchased two mobile sawmill machines worth over 200m/- to reduce loss of forest products and ensure value addition.

The machines have been bought through the Forestry and Value Chains Development Programme (FORVAC), a five year project which started in 2018 with funding support from the Ministry of Foreign Affairs of Finland to a tune of 25bn/-.

The project is implemented by Ministry of Natural Resources and

Speaking recently in Ruvuma Region during the visit to the project, forest expert from the FORVAC programme, Alex Njahani said the machines will help to reduce loss of forest products such as timber and others.

The mobile sawmill machines imported from Norway, will be taken to Lindi and Ruvuma regions where the project for value addition to forest products is being implemented.

"We have decided to purchase the machines because they are capable enough to produce quality woods that add values in the market, contrary to other machines like chainsaw," he said.

National coordinator of the programme in the Ministry of Natural Resources and Tourism, Emmanuel Msofe said: "With the machines we are likely to further develop the industry and create jobs for young Tanzanians."

Msofe added that once the technology is extended across the country, forest products will have more value and loss of woods and other forest products will be reduced. "We have three clusters including Tanga, Ruvuma and Lindi, the first machines will be allocated to Ruangwa, Liwale, Nachingwea districts in Lindi

Region," he said adding machines will be allocated to Namtumbo and Songea in Ruvuma.

Other clusters include, Nyasa, Tunduru, Kilindi, Mbinga, Handeni, Mpwapwa and Kiteto.

FORVAC is designed to stimulate forest value chain development on production of timber, charcoal and non-wood forest products.

According to Msoffe, the machines will reduce the loss of forests which is now 469,000 ha per year.

Project coordinator for Ruvuma cluster, Marcel Mutunda said the machines will help to replace uncertified tools used to cut down trees like chainsaw that destroy the growth of the tree.

He said the mobile sawmill machines will ensure availability of best and quality woods.

A tree officer at Sautimoja village in Tunduru District, Ruvuma Region, Yusuph Kiangio said the mobile machines can produce many woods at a required standard and within a short time.

The mobile machines will reduce loss of wood by 63 per cent, and the expectations are to get 80 per cent of woods from a single log.

Kiangio further said that in Kilwa and Tunduru districts, the use of machines have resulted in increased revenue collections from 26m/- to 125m/- per year.

"Here at Sautimoja village, we have doubled the revenue collections to 85m/- from 40m/-", he added.

He said the machines can produce 250 pieces of woods per day compared to 25 pieces which were produced previously.

Sautimoja village executive officer, Philemon Dastan said the mobile machine has created a good number of job opportunities for the youth in the village and enhanced forest conservation activities.

This will provide participants with a broad context for this year's proceedings and motivate analysis and discussion on impacts of various proposals in depth.

The fiscal policy measures aim at improving business environment in order to attract investments and facilitating growth of small and medium business for sustainable economic growth; enhancing voluntary tax compliance; broadening the tax base; mainstreaming the use of ICT System in tax administration; strengthening enforcement of tax laws in order to address tax evasion challenges and minimize revenue leakages; and streamlining levies and fees in order to improve business and investment environment.

The Task Force invites the participation of officials from the Government, private sector, civil society, religious organizations, academia, research institutions and other specialists in public finance.

The submissions from interested parties should be in writing, stating clearly:-

- firm(s) organization(s) or association(s) being represented; • The proposed changes in tax or non-tax revenue, including analysis of the sectors, regions or types(s) of taxpayers that
- The projected impact on the economy and Government revenues in the year of implementation and outer years;
- The rationale and justification for the proposed revenue policy changes and, in particular, analysis of the means by which the proposal will help the Government achieve its overarching economic, fiscal and poverty-reduction objectives; and
- · Where proposals entail a reduction in Government revenues (even in the short term only), there must be alternative proposals which set out explicit and credible measures consistent with the overall thrust of the Government's fiscal policies to offset the proposed revenue shortfall.

## Clerics praise JPM for ethics enforcement procedures

DODOMA based Makedonia Missions Centre Church under Calvary Assemblies of God has congratulated President John Magufuli for his step calling on public officials to submit ethics forms that include statements of their assets and liabilities in accordance to Public Leadership Code of Ethics Act (No 13 of 1995).

The Church also called on public officials some of whom are in churches and mosques not to use their positions to conceal their properties in the shadows of their houses of prayer.

The praise was given here by the Church's founder, Rev Vincent

Malenda when speaking to the media as part of his New Year message.

"The issue of filling ethics forms was not new but it was forgotten by many public officials and continued enriching themselves illegally," he said.

"There are also some public officials who are in various houses of worship and have been using houses of prayer to oppress people who demand their rights."

He added that public servants give general outlines of how they should behave, as well as specific guidance for handling issues like harassment, safety, and conflicts of interest.

He further said there are also religious leaders who use some of their followers in high government positions to harass some of church followers who demand their rights.

"I would like to appeal to religious leaders against using followers in high government positions in suppressing their rights, these should be pressured to ensure they maintain ethics in their positions," stressed Rev Malenda.

A representative of Dodoma Regional Commissioner, Dr Suleiman Serera said that the region has already put in place strategies and will supervise them to ensure that it improves performance as directed by the minister

Earlier, the Dodoma City executive director Joseph Mafuru said that the council received a total of 706m/- in the 2018/19 fiscal year for the construction of the Model School.

"The council also added 241.9m/- to ensure that the school is completed well to serve better the pupils, it has now been registered and in June this year it had 660 pupils from nursery to Standard Six who came from five best schools of Ipagala B, Chaduru, Igahala, Mlimwa C and Medeli," he elaborated.

Mafuru said that by next year, the school will have the capacity to accommodate 725 pupils.

YOUTH from 22 African countries are waiting with bated breath as the final round of judging in the inaugural AfriCAN Code Challenge 2 takes place.

"Despite the pandemic disrupting schooling for hundreds of millions of kids across Africa, the continent's youth have stepped up to share their vision for the future of education. While there can ultimately be only one winner, the quality of entries at the inaugural AfriCAN Code Challenge inspire hope and optimism about Africa's future, one shaped by the largest youth population in the world."

Launched by SAP Africa Code Week [4] for the first time this year, the AfriCAN Code Challenge is a pan-African coding competition where youth aged 8 to 16 were tasked with coding a game using the Scratch programming language to answer the question: "How will your tech change the future of education?"

Youth were able to enter alone or in teams of up to five people, tapping into a wide range of essential skills from problem-solving and coding all the way to teamwork and communications. Each entry had to include a two-minute YouTube video showing how the game works and why it should win.

In total, 40 countries participated, with over 100 project videos submitted. The top three entries from 36 countries made it into the continental final, with 22 countries making it to the final judging stage. The winner will be announced in January 2021.

#### East Africa seeking to revive port operations on Lake Victoria

TANZANIA. Kenva and Uganda are seeking to revive connected ports and maritime operations on the shared waters of Lake Victoria. Experts say the three East African neighbours could generate up to \$60 billion in trade annually.

A water bus is seen cruising on Lake Victoria. It is the main mode of transport for those who live on the Islands. It transports hundreds of people and their property on a daily basis.

"This thing is so nice and the reason is one; it doesn't have a lot of accidents like the road; secondly, it is cheaper," says Elisha Otieno, a passenger.

It carries people from Luanda K'otieno to Rusinga Island and back again every 2 to 3 hours.

Water buses help keep the wheels of the regional economy turning. "According to the people we have spoken to, there are many opportunities that Lake Victoria dishes out in terms of water transport but are yet to be tapped by the three African countries."

Otieno adds: "These people would have put something that walk to all the three East African countries.

Even though there are many motorboats in the lake, ships are almost non - existent. And few that can be spotted are considered permanently docked. For people like 60-year-old Tom Mboya, such

pictures serve as a reminder of the old good days. Until the late 80s, ships carrying cargo would arrive at the then vibrant Kisumu port.

"It was really, really blossoming. All the stuff from Uganda like cows, mangos and fish from Tanzania were ferried," says Tom Mboya, Naturalist.

Produce was destined for local markets and beyond to Asia, Europe and America.

"Cargo from abroad, imported things, all the way from Kenya into Uganda and Tanzania headed for places like Rwanda and other places. It was serving much more than the three countries,"Mboya adds.

But for years, ships that docked along the Kisumu

port have been dormant. Chairperson for Kisumu Branch, Kenya National Chamber of Commerce Israel Agina submits: "The biggest blow came when Kenya Railways stopped operating and that affected business at the port. Many people started to opt for the road transport via Busia and Malaba border."

# JKT in partnership with TARI produce at least 300,000 cashew nut seedlings

THE National Service (JKT) in partnership with the Tanzania Agriculture Research Institute (TARI) has produced at least 300,000 cashew nut seedlings in efforts to assist farmers in Singida Region to cultivate the strategic economic cash crop.

Inaugurating the event to sell cashew nut seedlings to the farmers yesterday in Manyoni District, the head of Makutupora JKT, Lt Col Festo Mbanga said the national service has well prepared to ensure for vast cultivation of the crop in the country.

He said the National Service already established 500 demonstration farms of cashew nuts within the district as part to sensitise the farmers to adopt cultivating of the crop.

"Since when the government made public its quest to revive and improve the production of cashew nuts in the country, we (JKT), decided to join the effort through the production of relevant seedlings," he said, adding that the National Service will continue strategising and implementing diverse interventions to advance mass cultivation of the prestigious crop in all regions where it is flourishing.

Currently, Tanzania produces 315,000 tonnes of cashew nuts in a year, which is very low.

So far, already 20 regions have been selected for the major cashew nuts production with the aim being to sensitise farmers to start cultivating in special groups, under larger block farms.

In Singida Region two districts of Manyoni and Itigi and in Kongwa District (Dodoma) farmers have already formed

> "The block farming system is more effective in allowing the government to smoothly and timely provide the farmers with much-needed inputs and other vital extension services, including training over recommended cashew nuts agronomic practices," according to national coordinator for cashew nuts Geladina Mzena.

She expressed that the major focus is to ensure Tanzania bounces back and compete highly in the world cashew nuts market, against giant producers like India, Vietnam, Brazil, and Ivory Coast.

"Through cooperation with TARI - Naliendele the Cashew Board of Tanzania (CBT) we opened more than 35-hectares of cashew nut plantation in Manyoni District, Singida Region.


According to the director of crop development, Nyasebwa Chimagu, the development was part of a series of plans by the government to initiate large block farms for all strategic - economic crops across the country.

## Kalemani cautions dishonest officials

ENERGY Minister Dr Medard Kalemani has threatened to fire officials of the Tanzania Electric Supply Company Limited (TANESCO) who are said to demand for more payments to connect customers with electricity.

Dr Kalemani insisted that customers are only required to pay 27,000/- for power connections.

He was speaking here recently during his meeting with TANESCO officials and employees based in Mwanza city. The meeting was aimed at discussing on how to further improve services as well as ensuring that all customers requesting for the service are connected on time.

"There have been complaints from customers who have been told to pay extra cash apart from the indicative price set by the government. I also informed some unfaithful officials who have been selling poles or charging extra costs to customers staying 30 meters from the poles; this is unacceptable, all customers must get the services at similar cost," he noted.

He said the government is determined to connect all the villages that are still in the dark starting early February next year whereas contractors under the Rural Energy Agency (REA) will soon be dispatched across the country to start executing the power projects which see all the villages countrywide connected to the main grid.

The minister directed all TANESCO zonal, regional and district managers to make sure that all the villagers in Mwanza Region are connected with electricity within 18 months. He added that power connection to villagers would boost help to reduce poverty as they will be capable of establishing income generating activities.

He urged the managers to cut power services to all the customers with unpaid monthly bills regardless of being government institutions. He insisted that power should only be restored to institutions that have settled their bills.

"No one will blame you for cutting electricity services to these institutions, they have not paid their monthly bills for long," he said cautioning some dishonest workers from pocketing some power payments from city customers.

Dr Kalemani wondered as to why the city has a total of 150,000 registered customers only while the company receives new power connection requests

He added: "You must also train your service providers especially those in the customer care department to ensure improved services.

TANESCO Manager in Mwanza Region, Eng Felix Olang said they have improved power services although they still owe their customers over 2bn/-.

Inaugurating the Parliament in the country's capital in November this year, President John Magufuli boasted to have facilitated power connection to some 9, 570 villages in the past five years, saying only 2,018 out of 12,228 total villages had access to electricity when he took over the presidency.

However, the number of customers connected to the main grid has reached over 2.766 million, up from 1.473 million, an increase of 1.293 million new connections.

THE UN Security Council reached a decision this week to wind up the African Union -United Nations Hybrid Operation in Darfur (UNAMID) in Darfur,

UNAMID is currently the biggest peacekeeping Mission in the history of UN peacekeeping.

Eissa, the Dr Ashraf spokesperson of UNAMID, where Rwanda has more than 1,000 peacekeepers said that the UN Security Council unanimously passed Resolution 2559 on the situation in Darfur and instructed UNAMID to cease its operations in Darfur by December 31 2020.

"The Council gave a period until 30th June (2021) to enable the Mission to repatriate its troops and personnel followed by a liquidation period where a small team can dispose of assets and complete the closure of the Mission," he said.

**UNAMID's** means last patrol will go out on 31st December and after that there are no mandated activities other than drawdown followed by closure."

According to the spokesperson, details on the drawdown are yet to be set by the UN but they are in the pipeline.

UNAMID troops came from Rwanda, Bangladesh, China, Ethiopia, Gambia, Indonesia, Kenya, Nepal, Nigeria, Pakistan, Senegal and Tanzania.

When, in August 2004, just 10 years after the 1994 Genocide against the Tutsi, Rwanda deployed it's first contingency to a peacekeeping mission, it was under the auspices of the then

African Union Mission in Sudan (AMIS). The latter was mandated to curtail the humanitarian catastrophe that was boiling in Darfur. Rwanda's first contingent of 155 troops was also the first boots on the ground for the new peacekeeping mission.

Later, a new hybrid AU-UN peacekeeping mission was formally approved by the Security Council Resolution 1769 on July 31, 2007, to bring stability to the wartorn Darfur region of Sudan while peace talks continued.

The Security Council has the primary responsibility of maintaining international peace and security.

Currently, Rwanda is the third largest UN troop-contributing country in the world.

Rwanda has deployed more than 6,000 military and police personnel to different peacekeeping missions in the

## Africa selected to pilot UN - funded project to reduce illicit financial flows

AFRICA has been selected to pilot a United Nations-funded project to reduce illicit financial flows. The pilot by the United Nation Conference on Trade and Development (UNCTAD) and the United Nations Office on Drugs and Crime (UNODC) support the project, which is aimed at helping the region achieve the Sustainable Development Goals (SDGs) in the next decade.

UNCTAD and UNODC said the framework, adopted this week, was arrived at through collaborations with international organisations and national tax, customs and statistics experts.

The framework identifies four main types of activities that can generate IFFs - illicit tax and commercial activities, illegal markets, corruption and financing of crime and terrorism.

The measures will also be extended to Asia and the Pacific from next year, as part of a global war against IFFs to promote peace, justice and strong institutions, as reflected in target 16.4 of the SDGs. According to UNCTAD's Economic Development in Africa Report 2020, stopping illicit capital flight would cut in half the annual financing gap of \$200 billion with an estimated \$88.6 billion reported to leave the continent illegally.

"This is a major achievement in the work to combat illicit financial flows and a big step towards better transparency. We cannot tackle IFFs without statistics that help us understand the magnitude, channels and types of IFFs," said UNCTAD chief statistician Steve MacFeely in a statement.

He added: "Now, for the first time, we have an agreed upon definition of illicit financial flows for statistical measurement. Next,

we will prepare guidance for pilot countries to help them assess the types of IFFs relevant in their context, review data availability and select best methods to measure IFFs in line with the conceptual framework,"

Lack of consistent statistics on IFFs causes uncertainty about the size and trends in illicit flows, how and where they originate and their impact on development. IFFs can markedly differ across countries and regions, and lack of a common framework makes their measurement impossible.

Every year, organised crime, trade in illegal goods, and illegal or illicit tax and commercial practices generate billions of dollars in illicit flows. This includes proceeds of crime that are channelled abroad, often to safe havens. These funds may also be laundered and reinvested in legal markets, or they may originate in the legal economy and be illicitly transferred abroad.

UNODC's chief of research and trend analysis Angela Me underscored inter-agency collaboration when addressing tricky development challenges like IFFs.

"Illicit funds that are moved across countries secretly divert significant amounts of resources with harmful effects. These funds are a drain on measures to improve living conditions and tackle poverty," said Me.

#### TIB can aid institutions loan SMEs, with risk fund facility

Minister of State in the President's Office (Investments) Prof Kitila Mkumbo has embarked on the difficult task of mobilizing funds to assist small and medium enterprises to obtain working capital. He has lately called on the Tanzania Investment Bank (TIB) to come up with a plan on how best to assist small and medium entrepreneurs increase their capitals as a way to boost their potential contribution to economic growth. He discussed with experts there but ready formulas weren't that clear.

The minister was on a familiarization and brain storming at TIB headquarters, to widen opportunities for local and foreign investors, definitely aware of the burden that the bank has been carrying to assist public sector investments short of capital. And even for the small scale investors that the minister seeks to find assistance, there is already a large number of banks and other financial institutions, the problem being the need for collateral as a basis for loans. The minister gave examples of collective enterprises like large urban markets, where obviously the land can't be owned by an individual, so other formulas are needed.

One incontestable point that the minister raised was that 'there is a lot of money outside the formal sector,' but that it demands a push by some sort of capital infusion, especially at the level of targeted agricultural activity. He mentioned that 'what happens in the streets is mainly agriculture, as 60 percent of trade involves agriculture, a situation that shows we cannot develop agriculture

appointed without these people,' that is, traders. That is where he cited an example of Ubungo agricultural crops market in the city, which year accommodates each hundreds of thousands of traders, momentarily and in a more habitual manner, that is.

> From what the minister said and what his hosts remarked later, it is unclear if they were on the same wavelength as to the potential of significant investment potential in such areas, though he was convinced that 'there is big business in there,' referring to the need for infrastructure, while the whole issue of capital remained in place. TIB Managing Director Charles Singili said investments that can assist them are those focused on infrastructure, to ease challenges to conducting business if they are located in a particular area. Here another case came up, that of furniture dealers at Keko area, also in Dar es Salaam.

If the impression that TIB officials will have remained with is that investments in infrastructure is all that can be done for small entrepreneurs and especially in the crop sector is infrastructure, the minister's visit would not really have yielded fruits. It appears a meeting point is needed between infrastructure (which is a general issue and not just for investors), and obtaining capital that obviates direct presentation of collateral. That is why TIB can move in that direction not with individual small entrepreneurs as that would not suit its business model; but if various financial institutions make arrangements with TIB for back up capital relating to risks involved in a special facility, probably with Treasury margins and say so.

## Why transforming our food systems is a feminist issue

equality, also known as sexual requality or equality of the sexes, is the state of equal ease of access to resources and opportunities regardless of gender, including economic participation and decisionmaking; and the state of valuing different behaviors, aspirations and needs equally, regardless of gender.

UNICEF says gender equality "means that women and men, and girls and boys, enjoy the same rights, resources, opportunities and protections. It does not require that girls and boys, or women and men, be the same, or that they be treated exactly alike."

On a global scale, achieving gender equality also requires eliminating harmful practices against women and girls, including sex trafficking, femicide, wartime sexual violence, gender wage gap, and other oppression tactics. UNFPA stated that, "despite many international agreements affirming their human rights, women are still much more likely than men to be poor and illiterate. They have less access to property ownership, credit, training and employment. They are far less likely than men to be politically active and far more likely to be victims of domestic violence."

As of 2017, gender equality is the fifth of seventeen sustainable development goals (SDG 5) of the United Nations. Gender inequality is measured annually by the United Nations Development Programme's Human Development Reports.

In countries where women are most marginalised, discriminated under the law and where gendered norms prevent women from owning property and resources, people are also the hungriest. This is because gender equality and food systems are intertwined.

However, too often, we only focus on the roles that women play in production, processing, trading of food and in making decisions about consumption and purchase of food at household level.

A just and equitable food system will require the recognition of women as farmers, with rights to the land they cultivate, technologies that reduce the drudgery of agriculture and policies that ensure women can make a living wage from agriculture

And while this is important, we must also focus on whether the food system as organised is just and equitable and whether it promotes the empowerment and livelihoods and health of women and girls.



recent poll finds that only 14 per cent of African Americans and 24 per cent of Hispanics trust that a COVID-19 vaccination will be safe and effective.

The remainder, who constitute more than 20 per cent of the U.S. population, harbor uncertainty or distrust about the shots. Many other Americans share the same doubts, a dangerous situation as the new vaccines represent our clearest path out of the deadly pandemic.

Anti-vaccination activists also have tried to spread misinformation through social media.To counter these misgivings, the Ad Council has partnered with an organisation of universities, philanthropies and government agencies known as the COVID Collaborative to raise \$50 million for a public education campaign -- one of the largest on record -- aimed at overcoming fears and doubts about COVID-19 vaccination.

Distrust of the vaccines also must be addressed by their makers and the Food and Drug Administration, which needs to be completely transparent with the data from the drug trials. That way, medical professionals can reassure themselves that no corners were cut during the rapid development process, and they can learn exactly what the expected efficacy and side effects will be for each vaccine.

To stop the spread of COVID-19 by vaccination, epidemiologists say a vaccine should be taken by

80% of the population. With some polls indicating that more than half of the population is doubtful that a vaccine will be safe and effective, that goal is going to be out of reach unless the Ad Council and related efforts are successful in changing minds.

That will not be easy. There is a natural tendency in the black community, with good historical reasons, to distrust authority. As University of London researcher Rob Brotherton, author of "Suspicious Minds," has said: "Given that most conspiracy theories allege that authorities and institutions like the government or the medical establishment are not to be trusted, it is entirely understandable that such theories resonate among communities with long histories of being marginalized and mistreated by those very institutions."

It will not be enough to have a few prominent African Americans, such as professional athletes, do public service ads. There also must be outreach to trusted figures in each black community, such as ministers and elected officials. U.S. Rep. Jim Clyburn, D-S.C., would be a natural leader of any such effort, given his prominence and credibility. The organizers of the planned campaign, particularly in South Carolina, should seek his advice.

The effort to build confidence in the vaccines got a boost last week when former Presidents Barack Obama, George W. Bush and Bill Clinton said they would take a vaccine when it becomes available and are willing to be filmed doing it. Their example could help allay some fears.

The most recent poll that revealed the scope of distrust or uncertainty among black and Hispanic Americans was conducted by Langer Research for the COVID Collaborative, the NAACP and Unidos US, a leading Hispanic advocacy group. Similar Pew Research Center polls also found blacks far more wary of a vaccine, but in an optimistic sign, people of all races are growing more comfortable with the idea

than they were two months ago. "It's not having a vaccine that saves lives, it's actually people getting vaccinated," Harvard School of Public Health Dean Michelle Williams told The Washington Post.

Professor Howard Koh of the Harvard School added that doctors need to know more about the development process for the vaccines, which work differently than traditional vaccines. "A doctor who can't commit to a vaccine personally may find it difficult, if not impossible, to advise their patients to do so," Dr. Koh told the Post. It's crucial, he said, for companies developing vaccines to publish full results from clinical trials as soon as possible to persuade physicians that the vaccine is safe.

Those words ring particularly true after drugmaker AstraZeneca recently acknowledged a mistake in the vaccine dosage received by some of its study participants.

Building trust in the safety and efficacy of the new vaccines will be critical to the success of any COVID-19 vaccination campaign.

s the year 2020 comes to a close, the world is still struggling to handle the ravaging COVID-19 pandemic as well as the deep economic recession caused by massive lockdown measures.

With more positive news from vaccine trials, WHO Director-General Tedros Adhanom Ghebreyesus said "the light at the end of this long, dark tunnel is growing brighter." Facing the pandemic, one key lesson the human race has learned is that the only way to beat the virus is to have a rational attitude, take decisive and science-based measures and stand together as closely as they can. Compared with the panic and disorder at the beginning of the outbreak, countries across the world have gradually established scientific pandemic prevention systems. With the public gaining a deeper understanding of the pathogen, the foundation for the anti-COVID-19 war is expected to grow more solid.

From the World Health Assembly to the G20 Extraordinary Leaders' Summit on COVID-19, countries around the world, with the coordination of the WHO, have also committed themselves to forging a joint line of defense against the virus to better share knowledge, experience and resources, a vivid manifestation of the fact that people are increasingly interdependent and share a common destiny.

China, the first country to put the novel coronavirus under control, has launched its largest global humanitarian aid since 1949 and promised that Chinese COVID-19 vaccines will be provided as global public goods. Having been playing a key role in the global pandemic fight, China will offer more help to the world in the new year.

#### **NEW OPPORTUNITIES FOR GLOB-AL GROWTH**

Under a strict national lockdown, the shopping carnival, which was expected to come with the Christmas and New Year holiday, did not appear in Germany as the coronavirus continued spreading in the European country. Flights were suspended, businesses closed, supply chains disrupted... With an estimated 4.4-percent plunge in 2020, the global economy is experiencing what might be the worst recession since the 1930s Great Depression. However "dismal" as the year is, Ben May, director of Global Macroeconomic Research at Oxford Economics, still looks forward to "new lease of life for the world economy."

Amid the raging pandemic, various countries have launched unprecedented fiscal and monetary stimulus plans to prevent a more serious crisis, which offers opportunities for job creation and economic transformation. "The worst has been avoided, most of the economic fabric has been preserved and could revive quickly," Organization for Economic Co-operation and Development said in its latest economic outlook. Meanwhile, the pandemic has accelerated the process of digital globalization by advancing scientific and technological innovation and facilitating the transformation of production and business models, which is widely seen as a boon to productivity.

After the downturn, the global economy will rebound strongly by 5.2 percent in 2021, the International Monetary Fund has predicted. As the only major economy that achieved positive growth this year, China, the world's second largest economy, has entered a phrase of high-quality development and will maintain its firm commitment to opening its market wider and being actively engaged in global cooperation. "The deepest economic crises are also crucibles for new economic thinking," a report of the Financial Times said. #### NEW JOURNEY FOR MULTILATERAL-

In the face of the common challenges in the post-pandemic era, there are growing hopes that countries worldwide will forge a stronger partnership to strengthen win-win cooperation, promote economic integration and keep the global supply chains running well so that the world economy will be brought back to the track of robust growth as soon as possible.

As called for by UN Secretary-General Antonio Guterres, there is a need for an inclusive and networked multilateralism, in which the United Nations family, international financial institutions, regional organizations, trading blocs and others work together more closely and more effectively. The world has arrived at another crossroads, and China will, as always, continue to be a builder of world peace, a contributor to global development and a defender of the international order. No matter how dark the night is, the sun will always rise. As long as countries around the world join their hands in good faith, an even brighter future could be within reach. XINHUA 

## 2020 in review, China pursues green growth despite COVID-19

he year 2020 witnessed a series of remarkable moves in China's history, including a 10-year fishing ban along the Yangtze River, a total ban on importing solid waste, and the conclusion of a three-year action plan on fighting against air pollution.

China has put ecological protection at the heart of its policy considerations and made notable achievements in pursuing green growth this year, even in the face of the great pressure of navigating the COVID-19 slump.

These efforts indicate an evolving landscape of environmental conservation and regulation in China, as the world's second-largest economy explores a sustainable development path in which economic growth and environmental protection can move forward hand-in-hand.

With environmental issues emphasized in the tone-setting annual economic meeting in mid-December, as well as Chinese leadership's proposals for formulating the 14th Five-Year Plan (2021-2025) for National Economic and Social Development and the Long-Range Objectives Through the Year 2035, efforts on green economic growth are expected to secure an important position in China in 2021 and beyond.

#### YANGTZE RIVER FISHING BAN

In January, China started a 10-year fishing ban in key areas along the Yangtze River, a move that is widely regarded as a major step for the country in fighting the depletion of biological resources and the degrading of biodiversity in its "mother river."

Starting from 2020, the ban will be observed in 332 conservation areas in the Yangtze River basin and will be expanded to all natural waterways of the river and its major tributaries from no later than Jan. 1, 2021.

Fishing will also be prohibited on the natural waterways of large lakes connected to the Yangtze, such as the Dongting Lake and Poyang Lake, for 10 years starting from no later than Jan. 1,



The ban is estimated to affect more than 110,000 fishing boats and nearly 280,000 fishermen in 10 provinciallevel regions along the river. The Chinese government has promised to provide social security services, financial support and vocational training for fishermen to help them find a new way of earning a living after bidding farewell to boats and nets.

China also passed a law on Saturday to strengthen its protection of the Yangtze River. The Yangtze River Protection law, China's first legislation on a specific river basin, will take effect on March 1, 2021.

#### SOLID-WASTE **IMPORT BAN**

Once the world's biggest recipient of overseas trash, China announced in November that it would institute a sweeping ban on all

imports of solid waste starting on the first day of 2021, with the dumping, stacking and disposal of waste products from overseas on Chinese territory also banned.

China began importing solid waste as a source of raw materials in the 1980s, and for years it has been the world's largest importer. With a growing public awareness of environmental protection and the country's transition to greener economic growth, China started phasing out imports of solid waste in 2017.

The country's continuous efforts at reducing imported solid waste have achieved tangible results, with the amount imported plunging 41 percent year on year to 7.18 million tonnes by mid-November. Last year's imports stood at 13.48 million tonnes, down from 22.63 million tonnes in 2018.

Statistics from a white paper on China's energy development show that by 2019, carbon emission intensity in China had decreased by 48.1 percent compared with 2005, exceeding the target of reductions in carbon emission intensity by 40 to 45 percent between 2005 and 2020.

During the Climate Ambition Summit, China announced new goals on addressing climate change, namely, lowering its carbon dioxide emissions per unit of GDP by over 65 percent from 2030 and achieving carbon neutrality before 2060.

The country global fight against climate will formulate an action plan for peaking carbon dioxide emissions before 2030, and offer support to areas with favorable conditions to enable them peak the emissions ahead of schedule, according to the annual Central Economic Work Conference recently concluded in Beijing.

#### **BOOSTING NON-FOSSIL FUELS**

As the world's largest energy producer and consumer, China has made great efforts to cap its coal consumption and reshape its energy consumption structure, shifting it to a low-carbon and ecofriendly economy.

Preliminary calculations show that in 2019, the consumption of the 2005 level, peaking carbon clean energy accounted for 23.4 dioxide emissions before percent of total energy consumption, an increase of 8.9 percentage points over 2012. Coal consump-To that end, controlling tion accounted for 57.7 percent of carbon emissions has been the total, down 10.8 percentage

points from that in 2012.

China looks to further improve its energy structure by tapping the potential of various types of renewable energy, including solar energy, wind energy, biomass, geothermal and ocean energy.

It has promised to increase the share of non-fossil fuels in primary energy consumption to around 25 percent and bring its total installed capacity of wind and solar power to over 1.2 billion kilowatts by 2030.

#### WAR ON AIR POLLUTION

The Chinese government declared a war on air pollution and formulated a three-year action plan in 2018 aiming at bringing back blue skies, listing a series of specific goals for the country to reach by 2020.

This "battle for blue skies" has yielded encouraging results. Official data show that, after three years of continuous efforts, the average PM 2.5 concentration in the Beijing-Tianjin-Hebei region and surrounding areas in autumn and winter was reduced by 32.7 percent, while the number of heavy air pollution days plunged by 62 percent from 37.4 to 14.1.

The progress on addressing air pollution resulted from a slew of tough measures. Residents in northern China have been encouraged to give up their stoves and switch to natural gas or electricity for winter heating. Many steel mills and coal-fired power plants, major emitters of air pollutants, were closed or underwent renovations to ensure low-pollution emissions.

The country also led the world in promoting the use of new-energy vehicles. China owns the largest number of buses powered by clean energy worldwide, with more than 1.6 million tonnes of fuel saved every year. The number of new-energy buses in China has more than tripled over the years, rising from 116,300 in 2015 to 409,700 in 2019.

## 2020 in Hong Kong, a year of hardship and hope

big homemade meal, a quick shopping tour replete with face masks, and a long video call with his family in Italy, Fabrizio Goldoni's Christmas was prudent but pleasant in Hong Kong amid the COVID-19 epidemic.

But Goldoni could hardly remember how he spent the festivities last year. "I can't recall any celebrations. As violent incidents became a daily routine at that time, I don't think I was in the mood," the Italian expatriate, 59, said.

The global financial hub known for safety and freedom was gripped by social unrest in 2019 and continued to witness sporadic but still serious violence in the first half of 2020. For many, the memories were still fresh: huge crowds of rioters lighting subway entrances on fire and vandalizing shops, Molotov cocktails being hurled in the air, and innocent residents being beaten up.

Not only did ordinary people live in fear but the economy was severely battered due to the disturbances.

In popular shopping districts including Causeway Bay and Mong Kok, shops and restaurants were often forced to close in fear of being trashed by rioters, Tsoi Chung-kin, chairman of the Retail & Wholesale Trades Employees Association, said.

"When rioters went on the rampage on the streets, people dared not leave their homes, let alone go shopping," Tsoi recalled, adding that tourists also opted against Hong Kong in case they were caught up in the upheaval.

Hong Kong's GDP registered the sharpest-ever decline of 9.1 percent



in the first quarter of this year, and jobs were lost at a worrying pace in a wide range of sectors from catering to aviation.

To make matters worse, the COVID-19 epidemic broke out and dealt another heavy blow to

As pessimism was beginning to prevail, a turning point came in the form of the national security legislation being introduced mid-year.

The Standing Committee of the National People's Congress, China's top legislature, passed the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (HKSAR) on June 30.

The law takes aim at acts and activities endangering national security and has had a strong deterrent effect on violence and vandalism.

"You could almost feel on the day it (the law) was implemented that there was a sense of calm and restoration brought back to the city... and it (Hong Kong) has become more peaceful," Daniel Szuc, an Australian national living in Hong Kong for 22 years, said.

Szuc said it was a huge relief for him to see "very limited, almost zero, violence or disruption to the day today" and know that "people can get on and enjoy their lives again in Hong Kong without such troubles."

A safe and calm life gradually resumed.

"In this long-awaited peace, people can do business, go to work and go shopping without fear," Tsoi said, adding that although retailers still bore the brunt of COVID-19, the society has been put back on track and local consumption is gradually

recovering.

The economic recession improved significantly during the July-Sept. period, with the GDP decline narrowing to 3.5 per-

As long as the epidemic is under control and Hong Kong remains safe and stable, the economy will hopefully regain traction next year, Paul Chan, financial secretary of the HKSAR government, said earlier this month.

That traction will largely come from the Chinese mainland, the only major economy expected to register positive growth this year.

Thanks to the mainland's support, Hong Kong succeeded in retaining its competitiveness under "one country, two systems" and continued to thrive as an attractive global financial hub in 2020.

Nucleic testing professionals and medical materials from the mainland assisted in containing the spread of the novel coronavirus in Hong Kong. Mainland businesses made a major contribution to the Hong Kong stock exchange setting a new record in IPO fund-raising since 2010. In spite of travel curbs, burgeoning livestreaming e-commerce brought more Hong Kong products to mainland consumers.

When delivering the 2020 policy address in November, HKSAR Chief Executive Carrie Lam unveiled even more favorable measures from the central government to help Hong Kong's revival from the economic downturn, in particular the support for the Guangdong-Hong Kong-Macao Greater Bay Area development.

By further integrating into the broader landscape of the national development, Hong Kong will have a more stable environment, embrace enormous opportunities, and gain sustainable growth impetus, analysts said.

Eric Ching, 39, has a dream to realize in the Greater Bay Area, one of the most open and economically vibrant regions in the country.

As the president of the Hong Kong Youth E-commerce Advancement Association, Ching aims to help 10,000 Hong Kong e-commerce businesses tap into the Greater Bay Area market in the next five years.

His team has trained hun-

dreds of young people under his e-commerce incubator program this year. One of the trainees has accumulated 140,000 followers on video-sharing app Douvin, which is also known for livestreaming e-commerce.

The e-commerce sector will be a practical and reliable starting point for the tech-savvy youth to stretch their wings in the Greater Bay Area, Ching said.

Goldoni also believes that Hong Kong has a vital role to play in the Greater Bay Area and has remained confident in Hong Kong's future.

Before the COVID-19 outbreak, the businessman traveled between Hong Kong and the mainland almost every week to visit factories and meet partners. After nearly a year stranded here, he cannot wait to restrengthen business links and seek new opportunities in the mainland's rapidly-evolving markets.

Starting a career here in trade and finance 28 years ago, Goldoni experienced Hong Kong's return to the motherland in 1997 and witnessed its continued prosperity over the past two decades. After all these years, it is the freedom, stability and opportunities that have made him decide to stay in Hong Kong.

"If Hong Kong had continued to see riots, I would have left for sure. But as peace returned, now I can see a future for this city," he said.

lhe Covid-19 second wave crashed like a tsunami into South Africa just as the country exhaled into the holiday's annual festive season. As a cumulative one million people were tested and diagnosed this week, doctors, nurses and other health workers reported that the system risked being overwhelmed.

In key metrics the second wave is higher than the first, with test rates climbing to one in three positives of swabs taken. The government acted last night (December 28) as President Cyril Ramaphosa announced an Advanced Level 3 lockdown as the wave becomes generalised and deaths rise.

Here are your frequently asked questions following a Cabinet briefing led by Minister of Cooperative Governance and Traditional Affairs Nkosazana Dlamini Zuma.

#### Can I travel? Can I get home from the holidays?

You can travel internationally except to the countries that have banned South Africans after identifying the new Covid-19 variant (501Y.V2). You have to have a valid test (not older than 72 hours) showing you do not have Covid-19 and adhere to other restrictions in the country you are visiting. There is no restriction on interprovincial travel but you can't travel during the curfew between 9pm and 6am. Curfews are used to make law enforcement easier, and you will need a permit as an essential-service worker to travel between these

#### Can I get together with family and friends?

This is very confusing. Dlamini-Zuma says no: When asked on December 29 she said all social gatherings, including family gatherings, are prohibited. According to the regulations, cinemas, theatres, casinos, museums, galleries, archives, gyms and fitness centres, restaurants, auctions and professional sports venues are allowed to have gatherings. These rules do not say you have to attend only with members of your immediate household. For venues that continue trading there is a limit of 50 guests inside and 100 outside, regardless, it seems, of the size of the venue.

Gyms, for example, appear to have

negotiated a Level 1 agreement where the number of members is based on the size of the facility, but now the general limit for indoor venues is 50 people. If it's a small casino, museum, gallery or other place the size will determine how many people get in since it is likely to be fewer than 50. Best to call ahead and check.

#### What can't I do?

A helluva lot.

The addendum to the regulations specifically excludes night vigils, after-funeral gatherings, social gatherings, nightclubs, bars, taverns, shebeens and similar establishments, along with beaches, dams, rivers and lakes in hotspots. Here's the full list

Public parks, including public and recreational facilities, and public swimming pools are included here. You or a family member can't be initiated or attend a post-initiation practice (such as imigidi) or attend a

sporting event, although there are a few exemptions.

#### Can I drink?

Of course - anything non-alcoholic and only if you stocked up on alcohol or know your way around a fermented pineapple. Alcohol sales and on-site consumption sales are prohibited. Data show hospitals and clinics in hotspots are crowded with alcohol-related trauma cases when every bed and oxygen mask or ventilator is needed for Covid-19 patients.

This covers wineries, micromanufacturers, wine farms and the like.

You can't transport alcohol unless it is pure alcohol to produce sanitisers, disinfectants or soaps, for export purposes or from manufacturing plants to storage facilities, or from licensed premises for safekeeping. Police Minister Bheki Cele warned restaurants and cafés

that he was onto dop being served in teapots, and advised owners to stick to rooibos tea or risk losing their licences.

In effect, alcohol sales are banned again, although there is a lacuna in the regulations about whether this also applies to licensed resorts or hotels or B&Bs.

#### What does mandatory masking mean for me?

Just wear the mask! If you want to know why the new law

"The wearing of a face mask is mandatory for every person when in a public place, and any person who fails to comply with a verbal instruction by an enforcement officer to wear a face mask commits an offence and is, on conviction, liable to a fine or a period of imprisonment not exceeding six months, or to both such fine and impris-

Justice Minister Ronald Lamola said magistrates are meeting to set the fine amount.

"If you don't [wear a mask] you will definitely be arrested," said Cele. And he means it - South Africa arrested more people than most other nations during the first hard lockdown. "Most of you will have criminal records. If you don't respect this there will be consequences," said the minister, who always sounds like he was born for a police state rather than a democracy. Someone, please tell the minister it's a health emergency not a state of emergency.

This is the only time you are allowed not to wear a mask when you are outside your home:

"... a person who undertakes vigorous exercise in a public place, provided that the person maintains a distance of at least one and a half metres from any other person, and subject to directions on what is consid-

health," say the regulations. Luckily, Health Minister Zweli Mkhize did not enter the arena of

ered to be vigorous, issued by the Cabinet member responsible for

"roast-chicken and open-toed micro-management" and said he will leave the definition of "vigorous exercise" to you, although he added that a walk is probably not "vigorous exercise". You have to do exercise physically strenuous enough to leave you a little breathless to take off vour mask when outside vour home. Otherwise, mask on.

For the next two weeks, from December 29, you also may not go to a church, mosque, synagogue or temple or other religious gatherings, according to Dlamini Zuma.

Can I be evicted if I don't pay rent or have my home demolished?

No. But if your landlord is angry he or she can approach the Rental Housing Tribunal. The Red Ants cannot rip up your shack in the next two weeks.

What about the people who use public transport who must return from holiday or go back to work?

Transport Minister Fikile Mbalula will have to issue directives to ensure this is done safely, with longdistance taxis and buses restricted to no more than 70% capacity. Trips under 200km can fill to 100% provided everybody on board is masked.

(Good luck with that - my investigative tally reveals zero masked taxi drivers spotted in 2020 so far.)

Airlines were packed to the rafters during the early holiday season (or you had to pay a king's ransom to keep a free seat next to you), so Mbalula could issue directives about this too, although the regulations don't say anything about planes and trains.

It's going to a hellish two weeks a suitable end to the unprecedented challenges of 2020 and a bumpy landing into 2021. By December 29, Mkhize reported there were 11,256 people in hospital with Covid-19, with 3,543 on oxygen and 604 on ventilators. He said the majority of South Africa's districts are in Covid response phase, which is defined as an increase of 20% in cases compared with the previous seven days.

Advanced Level 3 applies for the next two weeks after which the national Coronavirus Command Council will review the Covid-19 status. It is now regarded as an exponential and exploding outbreak.

# Mwakabungu: A female leader who kept things going despite the pandemic outbreak

■IKA Mwakabungu is the director of curriculum training at the Tanzania Institute of Education (TIE) who managed to maintain her work performance during the outbreak of COVID-19 IN the country.

Telling her story, Mwakabungu says that during the months from March 16, when the first patient was confirmed to end of June 2020, she struggled to ensure continued operations.

Early July 2020, Tanzania declared a coronavirus free state, making it first in

"I used to conduct online meetings and make frequent calls to the over 20 staff in my department. The pandemic outbreak did not affect my job although it was a bit challenging due to technological problems," she narrates.

According to her, most workers were worried of being infected with the respiratory disease, the thing that reduced their working morale.

"I faced difficulties in encouraging my staff to continue working and maintain their morale. I was always insisting on them to adhere to the protocols of hygiene as well as guidelines provided by the World Health Organisation (WHO), says Mwakabungu.

The director reveals that the COVID-19 pandemic has given massive insights into how the role of technology can radically shift to adapt working processes in chal-

"Not everyone was competent of using the internet for online meetings, some experienced difficulties to 'log in' while others had poor network coverage in their



areas, thus failing to effectively follow up the meetings," Mwakabungu adds.

#### **Testing** positive for **COVID-19**

According to Mwakabungu, some institute employees including her were tested positive for the disease.

The situation led to TIE management resolving to reduce working hours and ordered some staff to work from home to control new infections.

"When told by the doctor that I was infected with coronavirus, I was not shocked, but my biggest worry was what if I infect my staff and family members. I isolated myself for two weeks and by wearing face masks, adhered to all the medical

treatment as instructed by the doctor," she says.

At the office, all the staff were issued with guidelines to protect themselves from contracting the new virus washing hands with soap

and running water or using alcohol-based hand rubs

A report by the Women Journalists Support Fund (IWMF) states that women faced economic and psychological consequences during the pandemic outbreak.

It said that despite all the challenges that women faces during Covid-19, their presentation in the media is still limited.

African malaria deaths set to dwarf COVID-19

fatalities as pandemic hits

EXCESS malaria deaths caused by pandemic driven shortfalls in prevention and treatment efforts will probably dwarf direct deaths from covid-19 in sub-Saharan Africa, the World Health Organization has

Progress against malaria-dramatic in the first decade of this century-had already stalled since 2016 as foreign donors drifted away. But 2020 is likely to be the first year in decades to see an increase in deaths, WHO warned in its 2020 World Malaria Report.

About 1.5 billion malaria cases and 7.6 million deaths have been averted since 2000, WHO estimates. But annual case numbers in sub-Saharan Africa have been unchanged since 2016 at about 230 million, and this year the region will fall far short of milestones set by the World Health Assembly in 2015.

"It's likely that excess malaria mortality is larger than direct covid-19 mortality," said Pedro Alonso, director of WHO's malaria programme. Malaria killed 409 000 people in 2019 and 411 000 in 2018, most of them babies and toddlers in sub-Saharan Africa. A 10% disruption in access to antimalarial treatment could lead to 19000 additional deaths there this year, WHO warned. More plausible disruptions of 25% or 50% in the region could result in an additional 46 000 or 100 000 deaths, respectively. The total number of covid-19 deaths recorded so far in sub-Saharan Africa is just under 30 000, of which more than two thirds occurred in South Africa.

Peter Sands, executive director of the Global Fund to Fight AIDS, Tuberculosis, and Malaria, said at a meeting presenting the new WHO report, "The global health world, the media, and politics are all transfixed by covid-19 and yet we pay little attention to a disease that is still killing over 400 000 people every year, mainly children. This is a disease we know how to get rid of-so it is a choice that we don't."

Aid agencies fear that sub-Saharan African children, the people least likely to be killed by covid-19, will be those most harmed by it in the long term. Many African governments have imposed stringent restrictions

The pandemic caused the first economic recession in modern African history–usually continent posts high growth ratesand most of the 50 million people it has driven into extreme poverty are aged under 18. While the average G20 citizen has had \$1652 (£1238; €1371) in coronavirus relief, the average sub-Saharan African has received \$38.

Africa's relative youth and inaccessibility continues to protect it from the pandemic's worst direct effects. "It's clear the second wave is here on the continent," said

John Nkengasong, director of the Africa Centers for Disease Control and Prevention, last week. But, he added, "We're not seeing hospitals being overwhelmed."

Africa CDC hopes to begin vaccinations in the second quarter of 2021, said Nkengasong, although the cold storage requirements pose a special challenge. Vaccinating 60% of the population would cost about \$12bn, he estimated.

"Africa is neglected when drugs are available," he said. "The worst thing for the continent is for covid-19 to become an endemic

### **UN finds Netherlands** violated human rights of stateless child

THE Netherlands violated a child's rights by failing to acknowledge that he was stateless and eligible for international protection, a UN committee has found, urging the country to change its legisla-

In its first ever decision on the right of children to acquire nationality, the UN Human Rights Committee determined on Tuesday that by registering the child as "nationality unknown", the Dutch authorities had violated his right to international protection and also to seek a nationality.

The case involves a boy named Denny, born in the Dutch city of Utrecht in 2010 to a Chinese mother who was trafficked to the Netherlands in 2004 at the age of 15 and forced into prostitution.

She escaped four years later, but since she herself had been abandoned at birth, she was not recorded in the civil registry in China and has been unable to obtain Chinese citizenship for herself and unable to provide proof of Denny's nationality.

She was also unable to provide proof that her son

was without a nationality, as required by Dutch law to be registered as stateless and apply for international protection. So he was registered as "nationality unknown". With no hope of getting further support from the

Dutch authorities, Denny and his mother filed a petition to the UN committee in 2016.

They are living in a centre for refused asylum seekers with young children, under a permanent threat of deportation, the committee said in a state-

"States have the responsibility to ensure that stateless children under their jurisdiction who have no possibility to acquire any other nationality are not left without legal protection," a committee member, Shuichi Furuya, said in the statement.

"The right to nationality ensures concrete protection for individuals, in particular children.'

The committee pointed to official Dutch statistics showing that as of September 2016, 13,169 children under 10 were registered in the country as having unknown nationality - many of them born in the Netherlands.

The committee called on the Netherlands to review its decision of Denny's application to be registered as stateless, and his application to be recognised as a Dutch citizen.

It also called on the country to provide Denny with compensation, and to review its legislation on the matter, and asked for details on what measures had been taken within 180 days.



#### Bill Freund (6 July 1944 - 17 Au**gust 2020**)

Described as one of the grandmasters of South African economic historiography, William (Bill) Freund he was a remarkable and prolific scholar. He was a professor emeritus of economic history at the University of KwaZulu-Natal and his research interests included African urban history and African and South African political economy and economic history. He had just finished work on his autobiography, Bill Freund: An historian's passage to Africa, which is due to be published in May 2021 by Wits Univer-

#### Bill Withers (4 July 1938 - 30 March 2020)

Three-time Grammy winner Bill Withers released just eight albums before walking away from the spotlight in 1985, but he left an indelible mark on the music community and the world at large. Songs like "Lean On Me", "Grandma's Hands", "Use Me", "Ain't No Sunshine" and "Lovely Day" are part of Western popular culture and have been covered many times, by musicians such as Adam Levine and Shawn Mendes, among others. While many of his biggest hits were first recorded in the 1970s, they have proven to be timeless favourites.

#### **CT Vivian (30 July 1974 - 17 July**


Reverend Cordy Tindell (CT) Vivian was an American civil rights activist. He worked alongside Martin Luther King Jr and later led the Southern Christian Leadership Conference. Vivian was active in sitin protests in Peoria, Illinois, in the 1940s and met King during the 1955 Montgomery bus boycott – a demonstration spurred by Rosa Parks's refusal to give up her seat to a white passenger. Vivian became an active early member of the group that eventually became the Southern Christian Leadership Conference.

#### Carl Reiner (20 March 1922 - 29 **June 2020**)

Carl Reiner was an American writer, producer, director and actor who was part of Sid Caesar's legendary team and went on to create The Dick van Dyke Show on television Reiner, the father of filmmaker and activist Rob Reiner, won nine Emmy awards, including five for The Dick van Dyke Show. His most popular films as a director included Oh God, starring George Burns, in 1977; The

from 1994 to 2004, and then again Jerk, with Steve Martin, in 1979; and All of Me, with Martin and Lily Tomlin, in 1984. In later years, Reiner was an elder statesman of comedy, revered and respected for his versatility as a performer.

#### Daniel arap Moi (2 September **1924 - 4 February 2020**)



Former Kenyan president Daniel arap Moi was an autocratic leader who ruled for more than 20 years. He succeeded in keeping Kenya relatively stable compared with many of its neighbouring countries at the time, working for regional peace. However, the economy regressed under his watch and he failed to tackle intensifying poverty and widespread corruption.

#### Chadwick Boseman (29 November 1976 - 28 August 2020)

Actor Chadwick Boseman came to prominence playing real-life figures - baseball great Jackie Robinson in 2013's 42 and soul singer James Brown in 2014's Get on Up. However, his leading role in the Marvel superhero movie Black Panther is what he will be most remembered for. Boseman's untimely death shocked the world. The impact Black Panther and Boseman had on culture cannot be overstated. The film was the first superhero movie to be nominated by the US Motion Picture Academy for its Best Picture Award – and earned six other nominations and won three. Boseman presented to the world an image of a powerful and thoughtful black man, the leader of a thriving African nation and a superhero willing to race into whatever battle he felt was worth fighting, no matter the odds. Accepting a Screen Actors' Guild Award in 2019, Boseman said the film had changed what it meant to be "young, gifted and black".

#### **David Dinkins (10 July 1927 - 23** November 2020)

The first African-American mayor of New York City, David Dinkins was elected in 1989 after two highprofile racially charged cases had played out under the previous mayoral stint of Ed Koch. Early in Dinkins's administration, a newly freed Nelson Mandela made New York City his first stop in the US, in 1990. Dinkins had been a long-time outspoken critic of apartheid in South Africa.

#### Benjamin Mkapa (12 November 1938 - 24 July 2020)



A former president of Tanzania, Benjamin Mkapa was committed to fighting AIDS and is credited with much of the country's success in its response to HIV. In 1999, he declared HIV a national disaster and spearheaded the country's national response by establishing the Tanzania Commission for AIDS. He also formed the Tanzania Parliamentarians AIDS Coalition (TAPAC) in 2001, which united high-level politicians in responding to the disease.

#### Dawn Lindberg (14 April 1945

**7 December 2020**) Dawn Lindberg was founder and chief executive of the Naledi Theatre Awards, one of the biggest and most prestigious theatre awards in South Africa. With a career spanning over five decades as a singer, actress and theatre director, Lindberg started out in show business after graduating in fine arts from Wits University in the early 1960s. In 1962 she met her husband and long-time partner in music and theatre, Des, and they formed the folk duo Des & Dawn. In 1973 the couple staged the musical Godspell, a groundbreaking multiracial show in South Africa.

#### Denis Goldberg (11 April 1933 -**29 April 2020**)

Denis Goldberg was a lifelong supporter of the ANC and became a member of the armed wing, Umkhonto we Sizwe, when it was formed in 1961. Goldberg was the only white defendant to be convicted alongside Nelson Mandela and others

in 1964 for resisting apartheid. He spent 22 years in prison. On his release in 1985, he went into exile in the UK, but returned home to South Africa after the abolition of apartheid. In later years, he was a critic of the corruption that came to define much of Jacob Zuma's presidency of South Africa.

#### Diego Armando Maradona (30 October 1960 - 25 November

Argentinian soccer player Diego Maradona is generally regarded as the top footballer of the 1980s and one of the greatest of all time. Renowned for his ability to control the ball and create scoring opportunities for himself and his team, he led club teams to championships in Argentina, Italy and Spain and he starred in the Argentine national team that won the 1986 World Cup.

#### Dr Victor Bernard Holland (28 March 1943 - 19 April 2020)

South African physician Dr Victor Holland grew up in the years just before the start of National Party rule and apartheid. Mark Heywood writes that "his life and profession as a doctor was blighted by racism and inequality but it also forged a life-long approach to equality in medicine and health". Holland was rejected by Wits University's medical school as he was classified as "non-white" and completed a BSc degree at Bellville College (now the University of the Western Cape), the institute of higher learning set aside for "coloured" people. In 1963, he was accepted at the medical faculty of the otherwise largely racially segregated University of Natal (now the Nelson Mandela School of Medicine). As a physician, Holland spent many decades as head of general medicine wards at Coronation Hospital and Helen Joseph Hospital. He developed a specialisation in gastroenterology.

#### Eddie Van Halen (26 January 1955 - 6 October 2020)

Pioneering guitar player Eddie Van Halen's hard-rock band emerged from the Sunset Strip music scene in Los Angeles in the early 1970s to stand at the top of rock 'n' roll for a decade. Van Halen was born in Amsterdam in the Netherlands on 26 January 1955 and studied classical piano after moving to the US in the 1960s. After switching to guitar, he and his older brother Alex, who took up the drums, formed bands that would eventually become Van Halen in the mid-1970s, with lead singer Roth and bassist Michael Anthony.

#### Emir Sheikh Sabah al-Ahmad al-Sabah (16 June 1929 - 28 September 2020)



Emir Sheikh Sabah al-Ahmad al-Sabah ruled the oil-rich Gulf Arab state Kuwait from 2006 and oversaw its foreign policy for more than 50 years. He was dubbed "The dean of Arab diplomacy" for his efforts to restore relations with states that backed Iraq during the 1990-1991 Gulf War, when Kuwait was invaded by Iraqi forces. The emir also often acted as a mediator in regional disputes, including the ongoing diplomatic stand-off between Saudi Arabia and its allies and Qatar.

#### Fikile Ntshangase (1955 - 22 Oc-


tober 2020) South African environmental and anti-mining activist Fikile Ntshangase was the vice-chairperson of a sub-committee of the Mfolozi

Community Environmental Justice Organisation (MCEJO). MCEJO has been challenging in court the further expansion of a large coal mine at Somkhele in KwaZulu-Natal by Tendele Coal Mining. It has been alleged that Ntshangashe was assassinated because of her ongoing fight against the mining activities.

#### Fred Willard (18 September 1933 - 15 May 2020)

Prolific comic actor and master of mockumentaries, Fred Willard starred in Modern Family, Everybody Loves Raymond, Waiting for Guffman and This Is Spinal Tap. Willard was nominated four times for Emmy Awards, three of them (in 2003, 2004 and 2005) for playing Hank in the television series Everybody Loves Raymond and the fourth in 2010 for his recurring role as Frank Dunphy in Modern Family. Willard's character received a loving send-off during Modern Family's final season with a January 2020 episode that revealed his death.

#### George Bizos (14 November 1927 - 9 September 2020)



South African lawyer George Bizos played a critical role through the years of Nelson Mandela's incarceration, both professionally and as a family friend. The Nelson Mandela Foundation reported that Mandela said Bizos had "behaved like a brother" to him while he was in jail. "He looked after my family, after my children, advised my children and he made me feel that, although I'm in prison, my affairs are being looked after by a man I know and trust." Bizos was also a vital conduit for messages between Mandela and the external ANC leadership.

#### George Hallett (30 December 1942 - 1 July 2020)

Acclaimed Cape Town photographer George Hallett spent considerable time in self-imposed exile from 1970, mostly in Europe, before returning to South Africa in 1995. Before his official return, he followed and documented Nelson Mandela on the presidential campaign trail of the country's first democratic elections in 1994. Hallett was born in District Six, but his and many other families were forcibly removed before the infamous demolition of the suburb. He received acclaim for his images of the destruction of District Six, as bulldozers razed a vibrant community whose presence had been deemed illegal under apartheid's Group Areas Act. Hallett also designed the covers and took the photographs for the African Writers Series.

#### Gita Ramjee (8 April 1956 - 31 March 2020)

Professor Gita Ramjee was a renowned HIV researcher who specialised in HIV prevention for women. Ramjee joined the South African Medical Research Council (SAMRC) in 1996, where she was at the forefront of HIV prevention research. She rose to become chief specialist scientist and director of SAMRC's HIV Prevention Research Unit, where she managed large-scale phase 3 trials in HIV prevention. She also oversaw the development of SAMRC's clinical trial unit.

#### Hosni Mubarak (4 May 1928 - 25 **February 2020**)

Former president of Egypt Hosni Mubarak spent three decades in office before a popular uprising swept the country. His legacy is marked with corruption, poverty and unemployment. In 2012, Mubarak was sentenced to life imprisonment over the deaths of some of the 900 protesters who were killed by security forces during the 2011 uprising. The conviction was overturned and he was freed in March 2017.

## Capital markets regulator endorses Rabobank's share transfer in NMB Bank

record 174,500,000 or 34.9 percent of shares owned by Netherlands based Robobank in NMB Bank Plc have been officially transferred to Arise B.V.

Capital Market and Securities Authority on Monday this week approved the transfer to Arise B.V. which is an investment platform and leading African investment company (holding company), backed by reputable cornerstone

Commenting on the share transfer, NMB's CEO, Ruth Zaipuna said the successful completion of the share transfer is a testament of investors' confidence on the institution and the country at large. "The collaborative partnership between Arise and NMB is envisaged to deliver substantial operational, commercial, organizational and financial benefits with long-term market returns that go beyond stakeholders' expectations," Zaipuna said.

Arise is an investment consortium established in 2016 by Norway's state-owned private equity

company, Norfund, Dutch development bank, FMO and Dutch multinational financial services company, Rabobank.

The CMSA approval means that Rabobank is still part of NMB Bank Plc ownership through Arise. It aims at growing sustainably locally

owned financial institutions and markets with strong potential, with NMB and Tanzania being one of the preferred investment destinations in Sub Saharan Africa.

"The CMSA approval comes after Rabobank had lodged its share transfer request and received necessary regulatory approvals from responsible regulatory authorities in the country," Zaipuna noted.

NMB is Tanzania's largest bank by assets and profitability according to third quarter results of this year with total assets reaching a record 7trn/- up from 6.1trn/- for a corre-

sponding period of 2019. It is also the most profitable bank in the market having recorded an impressive 145bn/- net profit in the year ended 30 September 2020, which was up from 82bn/- registered in third quarter of 2019.

"Undoubtedly this long-term investment by Arise will support NMB's future growth aspirations and spur economic growth and the prosperity of Tanzanians through increased financial inclusion, and the growth of retail. small and medium size enterprises and the agriculture sector," the bank's chief executive

NMB has 225 branches, over 8,000 agents (Wakala) and more than 700 ATMs across the country and is represented in all districts of Tanzania backed by over four million customers who are served by over 3,400 staff members. The bank is listed at Dar es Salaam Stock Exchange with its other shareholders being Treasury with 31.8 percent and minority shareholders who include individuals who share the remainder.

Mr Achola, also a Kenyan, will take the reins at BAT on January 1, 2021, replacing Beverley Spencer-Obatoyinbo. The appointment marks a comeback for Mr Achola who had previously worked at the cigarette manu-

facturer for 19 years before exiting in 2017.

Greatest challenge

Mr Kilavuka was confirmed as Kenya Airway's chief executive on February 27, filling a vacancy left by his predecessor Sebastian Mikosz who resigned ahead of his contract expiry and later took an appointment at the International Air Transport Association (IATA) as senior vice president for member and external relations.

Mr Kilavuka faces the greatest challenge of any CEO of the national carrier, with the Covid-19 pandemic adding to the company's problems including underfunding, strategic missteps and labour un-

Mr Wairegi is leaving Britam after 40 years, ending one of the longest tenures among Nairobi Securities Exchange-listed firms. He is credited with the listing of the firm on the NSE in July 2011, helping its founders, including Jimnah Mbaru and Peter Munga to reduce their stake, earning hundreds of millions of shillings from the disposals.

## **Intra Energy fundraising** for gold project in Mozambique spurs 85per cent share rise

Intra Energy (IEC) shares have spiked 100 per cent this morning as the explorer commences fundraising efforts for its gold project in Mozambique. IEC will offer up shares in its unlisted Mauritian subsidiary, Intrafrican, via a private placement to support the Minas do Lurio Gold project.

An accompanying investor presentation reports the smallcap is pursuing US\$2.5 (approximately A\$3.3 million) to advance exploration activities in the relatively untouched Lúrio Belt and upgrade to a production licence.

More specifically, IML anticipates funds will be used for aero-magnetic survey work, drilling, sampling, a survey of dredging locations and a geological resource report to support the eventual licence appli-

There are hopes to source a further US\$3.5 million (around A\$4.7 million) via a second tranche, with an upcoming third tranche for an unconfirmed amount. Initial trenching and sampling has been completed at Savanne, with additional gold-bearing areas identified in close proximity, according to the company.

Company structure and ownership is set to undergo a reshuffle as a result of the private placement. Intrafrican's interest in the Minas Do Lurio Gold Project is currently held via another unlisted Mauritian company, Intra Minerals.

Intrafrican will lose its status as a wholly-owned subsidiary of IEC following the placement, however IEC is expected to retain its controlling interest. Further details can be found in the company's investor presentation. Shares have rocketed up 85.7 per cent following the announcement and are trading at 1.3 cents apiece at 11:13 am

## New US administration could cast a keener eye over Bitcoin

**NEW YORK** 

It's been a tough year by all accounts. But for Bitcoin, 2020 has been marvellous. The cryptocurrency almost quadrupled, surpassing \$20,000 for the first time as it notched record after record.

The diehards cheered it as an inflation hedge in an era of unprecedented central bank largesse. Wall Street veterans from Paul Tudor Jones to Stanley Druckenmiller blessed it as an alternative asset, adding to the rally. And companies like MicroStrategy and Square moved cash reserves into crypto in search of better returns than nearzero interest rates deliver.

While none of those reasons for buying Bitcoin align with its origins as an alternative to fiat currencies, they do point to a growing acceptance of crypto as an asset class of its own. And that has the zealot-

like community taking yet another victory lap in their quest for legiti-

"What's happening now - and it's happening faster than anyone could ever imagine - is that Bitcoin is moving from a fringe esoteric asset to the mainstream," said Matt Hougan, chief investment officer of Bitwise Asset Management. "If it's going mainstream, there is just so much money on the sidelines that is going to have to come in and establish a position that it leaves me very bullish for 2021."

But with Bitcoin capturing greater attention, it could also garner further scrutiny from regulators, for the US at online trading platform eToro. "Despite this meteoric rise, there are some storm clouds on the horizon," he said, including the fallout from several last-minute actions by the outgoing Trump administration, among others.

Devotees say that in some ways, the pandemic-ravaged year proved the perfect environment for the digital coin. Warnings of rampant money-printing by global central banks - some of which started to reveal their own interests in digital assets - sparked fears of eventual inflation, while interest rates dipped to rock-bottom lows. That's thrust some investors to chase returns and hedge with cryptocurrencies, pushing its price past \$28,000 from around \$7,200 at the start of Janu-

says Guy Hirsch, managing director ed in a crash the following year, a stretch of time sometimes referred to as the "crypto winter". But it's surged more than 300 per cent in 2020 and many investors say it could continue to gain next year. A Deutsche Bank survey found a majority see it ending 2021 higher, with 41 per cent of participants projecting a target between \$20,000-\$49,999 and 12 per cent seeing it crossing above \$100,000, according to Jim Reid, a strategist at the

What else is on the radar? To Meltem Demirors, chief strategy officer at digital-asset manager Coin-Shares, there are some concerns about what the incoming Joe Biden administration might mean for the

crypto space. "Generally, I think we have had challenges with the Dems - they prefer more regulation, more oversight," Ms Demirors said. "I am a bit worried about the direction things are trending", especially around antitrust lawsuits and an erosion in internet privacy. Still, the industry has some allies, said Ms Demirors, including North Carolina's Patrick McHenry and Ohio's Warren Davidson, who she says have been advocates for the preservation of consumer financial privacy. Going forward, many strategists and investors say the industry could see more scrutiny and tighter regulation with Mr Biden in the White House.

Of course, a lot will depend on who fills key positions within the administration. Janet Yellen, who's been nominated to serve as Treasury secretary in Mr Biden's administration, has in recent years cautioned investors over Bitcoin, saying it was a "highly speculative asset" and "not a stable store of value". ## Rwanda's green investments have generated 150,000 green jobs

There are multiple business opportunities in environmental conservation which have so far created more than 144,000 green jobs from the 44 green projects funded by Rwanda Green Fund (FONERWA) with thousands of other green jobs created by other green investments over the past eight years.

In 2008, Rwanda banned plastic bags and in 2011, Rwanda introduced the national Green Growth and Climate Resilience Strategy (GGCRS). This was followed by the establishment of a green fund, in 2012 with aim to mobilize domestic and international climate finance, and secure sustainable financing to support projects toward the implementation of the green growth strategy.

These measures that started 10 years ago have played a role in creating green jobs and as more investments are made. Teddy Mugabo Mpinganzima, The CEO of Rwanda Green Fund explained that over the past eight years, the fund has mobilized \$188 Million from both domestic and foreign financing sources.

"The funded projects are implemented by public institutions, private sector and Civil Society Organizations/NGOs," she said. The higher portion of the funding, she said, went to conservation and sustainable management of natural resources and has created many jobs.

This includes jobs in ecosystem rehabilitation, sustainable land management, integrated water resources management, sustainable mining and quarrying, sustainable forest management as well as promotion and protection of biodiversity.

The other two funding windows, she said, include research and development and technology transfer and implementation as well as environment and climate change mainstreaming. "These mainly focus on renewable energy, pollution management, water storage, conservation and irrigation technologies, agro-forestry, waste, urban planning and others," she

The green investments have established 21,964 hectares of land against soil erosion and protected 27,889 hectares of watershed and water bodies. "112,295 people were supported to cope with the effects of climate change and 73,651 households accessed offgrid clean energy," she noted adding that the initiatives reduced 93,604 tons of carbon dioxide emissions.

Plastic bags ban and green job creation

Telesphore Mugwiza, The Director of Industry at the Ministry of Trade and Industry said that there are over 10 paper packaging industries and over five plastic waste recycling companies across the country. Doing Business has learnt that each of the companies has created over 200 green jobs in direct and indirect jobs along the value chain.

"We have about 60 permanent employees and over 45 casual workers. We have more than 10 firms that supply raw materials across the country and these employ many others from waste collection to supply. Many jobs have also been created in the supply chain of products we produce from plastic bags recycling," said Denise Mukarutete, the Human Resources Manager at Eco-Plastic Company in Nyarugenge district.

Amon Ndarifite, The Recycling Department Manager at Electromax Industry in Huye District said that they employ more than 50 workers and others who are casual workers. "There are workers in the collection and supply of plastic waste. The jobs are also in the supply chain of finished products," he said.

Leon Nduwayeze, The Managing Director of Agro-Plast that recycles plastics in Kicukiro District said with between Rwf400 million and Rwf500 million investment, over 50 permanent green jobs have been created.

"We have another 100 workers that we employ depending on when there is a lot of work. We also work with 11 youth companies who collect the plastic waste that we recycle and each employs at least five people. There are many workers in the collection and supply chain. We buy a Kilograme of plastic waste at between

## The stock market has a solution for Simba, Yanga financial woes

SOCCER goes down to the roots of Tanzania's history. Through the soccer fields in Jangwani and Kariakoo, the late Mwalimu Nyerere and the Tanganyika African National Union comrades converged with locals during the freedom fighting days.

In Tanzania, whether you are a sports fan or not, you are somehow expected to support either Simba or Yanga. A friend of mine once joked that we are first Tanzanians, then we mention our tribes, followed by our support for either of the two teams. I see no lie. Each club is estimated to enjoy a fan base of between 15-20 million followers, one of Africa's biggest.

However, with all their mighty brand prowess and lucrative fan bases, Simba and Yanga are still living in a world of financial dependency and relying heavily on funds from sponsors and donors in exchange for advertisements and endorsements.

Leveraging on their brands' equity, they are undoubtedly the, 'adverting heavens' to most local businesses. Perhaps that is their blessings in disguise. As a result, the clubs have developed a tendency of overreliance on sponsors and individual benefactors, with minimal revenue alternatives, a recipe for the rise of a solo voice, with financial muscles, to take the helm. It is not an entirely bad situation as it has worked perfectly

A few months back, Simba's main sponsor pressed the panic buttons when he tweeted a decision to quit the club, following a stint of bad results. Though the decision was reverted afterward, the fans had already feared the worse.

Lack of sustainable revenue streams that act as shock absorbers leaves the clubs vulnerable in any mishaps. History has shown that over and over again. The government has instructed the two clubs to embark on the ownership model where shares are distributed into 51 to 49 percent with the majority ordinary fans owning 59 percent and a strategic investor(s) holding the remainder.

This opens up doors for the clubs to start trading shares at Dar es Salaam Stock Exchange and generate instant capital to fund operations and growth. Apart from investing in squad and training facilities, the clubs could also venture into income-generating tributaries like bonds or short-term fixed instruments to guarantee working capital.

The move will also amplify the fan bases as many will jump at the opportunity to own a part of their beloved clubs. Furthermore, as a publicly listed company with mandatory transparency practices, the clubs will win many supporters' trust to turn them into active members, hence garner annual membership fees.

Merchandise, TV rights and kit sponsorship are football clubs' major cash-cows. With unbalanced books and a desperate need for funds, the clubs naturally lose ground negotiating deals with advertisers. Nevertheless, becoming financially stable, the clubs will have the upper hand and detect terms.

For instance, the clubs could opt the modern way of kit sponsorship, where multiple advertisers are accommodated. Recently, English Premier League club, Arsenal, signed with Rwanda a three year kit sponsorship deal worth USD39 million to have a 'Visit Rwanda' ad on their sleeves.

Mind you, Arsenal already had five years kit deal with Emirates Airline worth £200m (USD 280m) for the front part of the jersey and around £300 million five years deal with Adidas for the company's logo on the top left corner, of the same


It should be clearly stated that floating shares is one thing, but inspiring investors' confidence is an entirely different ball game. To achieve that, the clubs will have to be appropriately structured and professionally managed. The clubs also need to invest smartly in the playing squads to get favourable results; game results are an essential driver of the share prices.

In England, for instance, where most Premier League clubs are listed, studies have revealed that share prices react asymmetrically to game results. The negative effect being greater and quicker for losers than the positive impact for winners. This is because losing is a stronger predictor of future losing (and hence lower financial performance) and vice versa.

The optimal point is, if the two clubs, which command the support of close to 30 million Tanzanians, are to make a significant leap forward, financial independence is of the essence. ## **World's richest banker made** \$16bn after a brush with death

#### **MUMBAI**

If it weren't for a cricket accident Uday Kotak probably wouldn't be where he is today. If it weren't for a cricket accident that almost killed him. Uday Kotak probably wouldn't be the world's richest banker.

A ball that hit him in the head and led to an emergency surgery pushed a 20-year-old Kotak to abandon his dream of becoming a professional player. After a brief stint at the family's cotton-trading business, he went on to pursue his MBA at the prestigious Jamnalal Bajaj Institute of Management Studies in Mumbai before starting out in finance in 1985 at the age of 26. Kotak, now 61, has a fortune estimated at \$16 billion, according to the Bloomberg Billionaires Index.

While India has been grappling with a shadow-lending crisis, his Kotak Mahindra Bank Ltd. has been able to rise through the crowd, gaining investors' trust by starting to slow lending to riskier sectors more than two years ago and keeping good corporate governance. When the coronavirus pandemic added to the industry's woes by eroding borrowers' ability to repay, the firm was one of the first to raise capital to fortify its balance sheet, helping boost investors' confidence that it will

be among the biggest winners as the nation emerges from its Covid-induced recession.

The strategy paid off: As lenders have plunged globally, Kotak Mahindra Bank shares are up 17% this year, the most among Indian peers, and Kotak just gained an extension to his chief executive officer term for another three years. A representative at the firm didn't respond to requests for comment.

"As far as I'm concerned, becoming the world's richest banker is only a proxy for Uday being one of the world's smartest bankers," said Anand Mahindra, the chairman of Mahindra Group in Mumbai, whose tie up with Kotak back in 1986 led to the firm's name. "More importantly, he's understood that what makes a bank sustainable and durable is not just smart strategies but unassailable governance."

Kotak's company stands out in a country where lenders have some of the worst bad-loan ratios in the world. Trouble for the firms started brewing in 2015, when India's regulator initiated a massive audit that unearthed hidden souring loans. That led to a shadow-banking crisis that constrained the broader economy and further hurt assetquality scores and profits.

of a Kotak Mahindra Bank Ltd. branch in Mumbai, India, on Saturday, April 21, 2018. Kotak Mahindra is scheduled to announce fourth-quarter earnings on April 30. Kotak Mahindra Bank, though, was able to adapt. It reduced lending to small and medium companies and unsecured individuals. Its shares rallied more than 24% in each of the past three years.

While its bad-loan ratio has risen in 2020, it ranked as the second lowest among peers, with its capital-adequacy score being the highest. The nation's second-largest lender by market value reported an unexpected 27% profit surge in the quarter ended Sept. 30.

The firm got another boost last month, when the central bank proposed increasing the ownership limit for founders, effectively reducing the risk that Kotak will be forced to dilute his 26% stake in the lender as previously demanded by the Reserve Bank of India.

Kotak, a native of the western state of Gujarat, set up an investment company in 1985 with a 3 million rupee loan (\$41,000) from family and friends and partnered with Mahindra the following year. The firm, which started off discounting bills, later expanded its loan portfolio, got into stock brokering, investment Pedestrians stand in front banking, insurance and mutual funds. It converted into a lender in 2003 after getting the RBI's nod.

The financier has been Kotak Mahindra Bank's CEO since its beginning and gained more control of it in 2006 by ending a partnership of more than a decade with Goldman Sachs Group Inc. He rose through the ranks by keeping strong underwriting practices and avoiding lending to riskier sectors, focusing instead on expanding collateral-backed loans for farm equipment, mortgages and vehicles, according to Deepak Jasani, head of retail research at HDFC Securities Ltd.

While the RBI just approved the extension of Kotak's CEO term – despite earlier proposing to put a cap on the tenure of top executives at private banks – investors are starting to wonder what will happen after he hands over the reins.

Unlike many family-owned enterprises in India, Kotak has avoided enrolling family members into the lender's board or at top executive positions. That helped maintain investors' and depositors' confidence in a country where the lack of corporate governance and transparency has already brought down three banks and pushed two shadow lenders to bankruptcy in less than two

### **Coinbase suspends trading** of XRP cryptocurrency amid US probe into Ripple

**NEW YORK** 

The world's third-biggest cryptocurrency XRP plunged in value by more than 25 per cent on Tuesday after a major exchange suspended trading in the digital asset.

Coinbase, the world's secondbiggest crypto exchange by volume, said on Tuesday it will suspend trading of XRP after the US Securities and Exchange Commission last week accused Ripple Labs and its top executives of conducting an unregistered securities offering. The US regulator effectively classified XRP as a security, subjecting it to a much stricter set of regulations governing how it is sold and traded. The move potentially has implications for other cryptocurrencies.

"We will continue to monitor legal developments related to XRP and update our customers as more information becomes available," Paul Grewal, Coinbase's chief legal officer, wrote in a blog post announcing the suspension. "Trading will ... be fully suspended on Tuesday, January 19, 2021, at 10am Pacific Standard Time." The cryptocurrency trading platform said the suspension will not affect customers' access to XRP wallets, which will remain available for deposits and withdrawals after trading is suspended.

XRP dropped in value by 27.7 per cent to \$0.21821 on the Luxembourg-based Bitstamp exchange by 2.25pm on Tuesday. The thirdbiggest cryptocurrency by market capitalisation has fallen in value by 66 per cent since its most recent high on November 24. Bitstamp has suspended trading in XRP for US-based customers, as have the OKCoin and Beaxy exchange, among others.

"Coinbase and OKCoin are suspending trading and custody given the SEC news. This situation is not likely to be sorted out any time soon and exchanges want to be on the safe side, asking customers to redeem borrowed value," said

Charles-Henry Monchau, chief investment officer of Geneva-based online bank Flowbank. "Other exchanges might follow suit, but some such as [Luxembourg-based] Bitstamp might suspend XRP only in the US. This explains the massive pullback as investors are forced to deleverage," he added.

Arshad Khan, co-founder and chief executive of the Abu Dhabibased Arabian Bourse cryptocurrency exchange, said decisions on whether to suspend trading are governed by the rules and regulatory authorities in locations where bourses operate.

"Suspension of trading also has a negative effect on investors who are holding open positions. Market integrity and investor protection are two important verticals for any exchange and a perfect balance is required to be maintained between these two verticals," Mr Khan told The National. According to the lawsuit filed by the SEC last week, Ripple raised \$1.3 billion from investors and traders in cryptocurrency markets over seven years through the sale of XRP, without submitting the proper documentation required for such

The SEC's complaint also alleged that Chris Larsen, Ripple's cofounder, and chief executive Brad Garlinghouse personally profited to the tune of \$600 million by selling their XRP coins during price upswings. The complaint alleged that the pair failed to register their offers and sales of XRP or satisfy any exemption from registration.

In his response via a blog post, Mr Garlinghouse called the SEC suit "an assault on crypto at large". "In this case, XRP is a proxy for every other 'alt-coin' in the space. From there, you have a snowball effect; this isn't good news for any market maker, exchanges like Coinbase etc. This sets a terrible industry-wide precedent for any company working with a digital asset," he wrote.

## Africa's virus capital risks becoming vaccine laggard

South Africa, which has Africa's worst recorded coronavirus outbreak, may have to wait months to receive its first vaccines even as other countries race to roll out the

The government only expects vaccines that it paid a deposit to secure from the World Health Organization's Covax program to arrive in the second quarter of 2021, according to President Cyril Ramaphosa. The wait bodes ill for a country that's confronting a new more virulent strain of the virus. record new infections and a populace that's increasingly eschewed social distancing.

Talks with drug companies about supplementing South Africa's Covax allocation are ongoing, Ramaphosa said in an address Monday night, in which he announced the re-imposition of several restrictions aimed at curbing the pandemic's spread. It's unclear when or whether those shots will be made available, with several wealthy nations having already prepaid to pin down most of the initial production.

"With a lot of advanced purchasing of vaccines, it will be hard to jump the queues in trying to secure earlier vaccine doses," said Stavros Nicolaou, an executive at Aspen Pharmacare Holdings Ltd. and head of the health work group at Business for South Africa, an alliance of the nation's biggest business groups that's known as B4SA.

The Solidarity Fund, which was established to support the government's pandemic response and is backed by some of the country's biggest companies and richest individuals, paid the initial 283 million rand (US\$19.3 million) Covax deposit. It will cost a total of 2.7 billion rand for South Africa to secure its full allocation of six million doses from the facility -- sufficient to cover about 10 percent of the population.

South Africa's biggest labor group said the government's vaccine roll-out program does not inspire confidence. "More so when other countries across Europe and the Americas have begun mass vaccinations, the Congress of South African Trade Unions said in a statement. "We cannot afford to allow South Africans to die because of state lethargy.'

It has called on the government and the private sector to produce a plan to ensure all South Africans are vaccinated during

While the government wants to secure alternate supplies immediately, affordability remains a major constraint, and the efficacy of a number of potential shots remains unproven, Health Minister Zweli Mkhize said in an online briefing on Tuesday. The pandemic has exacerbated state funding constraints, with the central bank expecting the economy to contract 8% this year.

The Democratic Alliance, the main oppo-

sition party, called on the government to reprioritize its spending and redirect a 10.5 billion rand bailout earmarked for the bankrupt national airline toward paying for vaccines. The money could be used to inoculate as many as 23 million people based on current costs and exchange rates, it said in a statement.

Discovery Health, the nation's biggest medical insurer, said it's in talks with the government to secure access to vaccines and funds have been ring-fenced to provide the shots to its members when they become available.

#### 'Reasonable Expectation'

"Given there are only two vaccines that have received emergencyuse approval at this stage and the time required to ramp-up vaccine manufacturing, it is difficult to accurately project timelines at this stage," Ronald Whelan, Discovery Health's chief commercial officer, said in an emailed response to questions. "Some time in the second quarter of 2021 would likely be a reasonable expectation."

More than 5.1 million vaccine doses have been administered in 22 countries, according to data collected by Bloomberg. South Africa, which has recorded more than 1 million Covid-19 infections so far, needs to join their ranks as soon as possible, according to B4SA.

"We will do whatever is needed to ensure that the requisite vaccine supplies are secured and distributed as a matter of extreme urgency," said Martin Kingston, who heads the group's steering

#### EU looks to new chapter in ties with UK as Brexit deal is signed **BRUSSELS**

WITH a call for both sides to look forward to a new chapter in their relationship, European Union (EU) chiefs signed the Brexit trade deal agreed with Britain and sent the text off to London yesterday for Prime Minister Boris Johnson to add his signature.

Against a backdrop of EU flags, top EU officials signed the treaties struck on Dec 24 to preserve Britain's tariffand quota-free access to the bloc's 450 million consumers.

"It is of the utmost importance for the EU and the United Kingdom to look forward, in view of opening a new chapter in their relations," the bloc said in a statement, calling for joint action on climate change and internation-

A British Royal Air Force plane was due to take the documents to Johnson before returning one copy to Brussels with a signed copy bearing the bloc's golden stars on the blue leather folder.

The UK formally left the EU nearly a year ago and the new partnership agreement will regulate ties from Jan 1 on everything from trade to transport, energy links and fishing.

After both sides have signed, the deal will be in place until the end of February, pending final approval by the European Parliament that would make it permanent.

EU lawmakers are to debate the treaty - the result of months of negotiations that often came close to collapse - later yesterday. The British parliament will also debate, and is expected to pass, the deal. **Agencies**

#### FBI report indicates Beirut blasts caused by 500 tons of ammonium nitrate - PM

#### **BEIRUT**

LEBANESE caretaker Prime Minister Hassan Diab revealed on Tuesday that the U.S. Federal Bureau of Investigation (FBI) indicated in a report that Beirut's blasts were caused by 500 tons of ammonium nitrate, instead of 2,750 tons as stated in previous reports.

"Where have the 2,250 tons of ammonium nitrate gone?" Diab asked during a discussion held at the Grand Serail with reporters. "Who is the owner of the ship that brought the nitrates, how did it enter Lebanon and who allowed it to enter Lebanon?

Did security services know about it?" Diab kept asking. Diab said that the Higher Defense Council held 20 sessions this year, and none of the security agencies informed him of the presence of the ammonium nitrate at the port, where two huge explosions on Aug. 4 caused at least 200 deaths and around 6,000 injuries while leaving 300,000 homeless.

A team of FBI and French investigators participated in the initial investigations into the explosions, which the Lebanese authorities announced were caused by 2,750 tons of ammonium nitrate stored in one of the port's warehouses since 2013.

Diab noted that if there is an indictment against him in the case, it should be sent by the judicial investigator through the parliament, according to the constitution.

He said that he was first informed of the presence of TNT, which was highly explosive, then a report followed stating that chemical fertilizers were stored in the warehouse for about 7 years. He assured that when he received a final report on July 22, he forwarded it to the relevant ministers to deal with the matter.

Fadi Sawan, the judicial investigator in the Beirut's port explosions, has formally charged Diab and former ministers Ali Hassan Khalil, Ghazi Zeaiter and Youssef Fenianos over negligence in the case.

Khalil and Zeaiter requested the dismissal of Sawan due to a breach of the constitution, claiming that they have a parliamentary immunity that requires the approval of parliament before taking any judicial action against them.

The Public Prosecutor's Office suspended on Dec. 17 the investigations into the port's explosions pending a decision on the dismissal request. Lebanese authorities have arrested 25 people related to the explosions after the investigations, including senior officials at the port and cus-Xinhua

"It is up to the States to distribute the vaccines once brought to the designated areas by the Federal Government. We have not only developed the vaccines, including putting up money to move the process along quickly, but gotten them to the states," he said on Twit-

Trump, who contracted COVID-19 in October, has often played down the severity of the

pandemic and overseen a response many health experts say was disorganized and cavalier and sometimes ignored the science behind disease transmis-

Earlier in the day, Vice President-elect Kamala Harris received a COVID-19 vaccination on live television in a bid to boost public confidence in immunizations. Biden, 78, did so last week.

Harris, the first Black person and first Asian-American elected vice president, received the Moderna Inc vaccine at a medical center in predominantly Black southeast Washington.

The Biden team has stressed the importance of inoculation in non-white communities especially hard hit by the coronavirus and more highly skeptical about vaccine safety.

To date, the respiratory virus has infected more than 19 million people and killed over 334,000 in the United States.

One of the latest casualties of the pandemic was U.S. Representative-elect Luke Letlow, a Louisiana Republican, who died on Tuesday of COVID-19, his campaign said. Letlow, 41, announced on Dec. 18 that he had tested positive for virus.

### Chang'e-5 lands in North China, concludes epic lunar round trip

The CNSA will hold a hand-over ceremony to pass on the lunar samples to the ground application system, kicking off relevant work on storage, analysis and research of samples from

China has now become the third country to successfully bring lunar materials back to Earth after the US and the Soviet Union.

Song Zhongping, an aerospace expert and TV commentator, told the Global Times that the mission "has paved the way for the next stage of exploration: application-oriented space pro-

"Now that China's moon exploration project has come to a perfect ending and gained plenty of experiences, China can focus its energy on making use of the resources on the moon,"

BUILDING on a major victory in poverty alleviation, China is ready for a new stage in agricultural and rural development. The country is shifting its focus of rural work to all-round rural vitalization.

Solving issues related to agriculture, rural areas and farmers is the top priority for the Communist Party of China (CPC), Chinese President Xi Jinping has

Xi, also general secretary of the CPC Central Committee and chairman of the Central Military Commission, made the remarks at the two-day annual central rural work conference, which closed here on Tuesday.

#### A HISTORIC SHIFT

Efforts must be made to promote the efficiency and quality of the agricultural sector, make rural areas suitable to live and work in, and ensure that farmers are affluent and well-off, he told the

With China at a historical juncture of marching toward its second centenary goal, the task of consolidating and extending the achievements of poverty

alleviation, pushing forward all-round rural vitalization and accelerating the modernization of the agricultural sector and rural areas is a major issue essential to the overall situation that deserves the high attention of the whole Party, Xi noted.

Consolidating the foundation for agriculture, rural areas, and work relating to farmers is "the ballast" for the country to tackle the changing situations and open up new prospects, he said.

After a victory in poverty alleviation is scored, China should push forward the rural vitalization in an all-round way as "a historic shift" of the focus in its work concerning agriculture, rural areas and farmers, Xi stressed.

The CPC Central Committee has decided to set a five-year transition period for counties that have shaken off poverty, and gradually shift the policy focus toward comprehensively promoting rural vitalization, Xi said.

Efforts should be made to ensure food security and strengthen food production year by year, he said, emphasizing that the country must retain a "red line" of 1.8 billion mu (120 million hectares) of arable land.

#### Russia set to work out new 'security equation' with US, says Lavrov

**MOSCOW** 

MOSCOW is ready to work out a new 'security equation' in talks with Washington, which will take into account all



strategic stability factors, Russian Foreign Minister Sergey Lavrov said in an interview with TASS.

"When the global situation continues to deteriorate, we want Russia and the US, [as countries] bearing special responsibility for maintaining international security, to sit down at the negotiating table to come up with a new 'security equation' that will take into account all strategic stability factors and modern military technologies," he underscored.

Lavrov underlined that Russia is waiting for the next US administration to determine its approach to the future of the Treaty on Measures for the Further Reduction and Limitation of Strategic Offensive Arms (New START) and the arms control negotiations in general.

"New START remains the last international law instrument to mutually limit the nuclear missile potential of the two largest nuclear powers and make activities in this sphere predictable and verifiable," the minister highlighted.

"I remind you that it expires in February next year. We have repeatedly expressed readiness to extend this treaty without any preconditions, leaving it as is, by up to five years.

It would make it possible to maintain the current level of transparency in the strategic ties with the United States."

### **Argentina Senate votes to legalise abortion**

ARGENTINA became the first major country in Latin America to legalize abortion when the Senate voted early on Wednesday to allow it through the 14th week of pregnancy, in the face of opposition from the influential Catholic Church.

The fiercely contentious vote passed with 38 in favor, 29 against and one abstention - came after a marathon debate that began at 4 pm (1900 GMT) on Tuesday.

As the result was read out, a crowd of thousands erupted in cheers outside the Senate building in Buenos Aires, waving the green flags that represented their campaign as green smoke rose above the crowd.

"We did it sisters. We made history. We did it together. There are no words for this moment, it passes through the body and the soul," tweeted Monica Macha, a lawmaker with President Alberto Fernandez' centre-left ruling coalition which supported the law.

The ruling could set the tone for a wider shift in conservative Latin America where there are growing calls for greater reproductive rights for women.

Across the region, abortions are available on demand only in Communist Cuba, comparatively tiny Uruguay and some parts of Mexico.

"Adopting a law that legalizes abortion in a Catholic country as big as Argentina will energize the struggle to ensure women's rights in Latin America," said Juan Pappier, a se-

### Take virus as wake-up call, experts tell world

**TORONTO** 

Experts from the World Health Organization and public health schools warned on Monday that the world has more to learn on countering the prospect of COVID-19 persisting as a health threat, let alone on how to cope with the next pandemic.

David Heymann, a professor at the London School of Hygiene & Tropical Medicine in the United Kingdom, said the novel coronavirus may remain as endemic in the future. No matter what people do today, it will continue to spread despite vaccines, therapeutics and diagnostics, he said.

"We have to learn to live with this and use the tools we have in the best ways possible," he said at a virtual press briefing by the WHO.

Bruce Avlward, a senior adviser to WHO Director-General Tedros Adhanom Ghebrevesus, said "the virus is telling us that we are not prepared", citing the fact that second and third waves of infections are spreading in different regions of the world.

"While we are better prepared, the real question is, are we prepared for the next one?" he said. "We are not fully prepared for this one, let alone the next one.'

Mike Ryan, executive director of the WHO's Health Emergencies Programme, said that the pandemic has been very severe as it spreads around the world quickly.

"But this is not necessarily the big one," he said. "This is a wake-up call ... We need to get ready for something that will be even more severe in the future."

Maria Van Kerkhove, the WHO's technical lead on COVID-19, noted that countries that had traumatic experiences with similar pathogens such as those causing SARS (severe acute respiratory syndrome), MERS (Middle East respiratory syndrome) and Ebola have used that experience to build a public health infrastructure.

She said these countries, which may not all have been high-income ones, have acted "aggressively, comprehensively, using an all-of-government, all-of-society approach and really tackling

Tedros said it was important that authorities step up genomic sequencing worldwide to ensure that new variants of the coronavirus are detected as the pandemic takes its toll.

#### **Travel restrictions**

New variants detected in Britain and South Africa that appear to be more infectious have caused concern and triggered a fresh round of travel restrictions this month.

Tedros said: "There will be setbacks and new challenges in the year ahead for example, new variants of COVID-19 and helping people who are tired of the pandemic continue to combat it."

Globally, there were more than 81.3 million confirmed cases and more than 1.77 million deaths as of Tuesday, according to a tally kept by Johns Hopkins University in the United States.

Four cases of a coronavirus variant first reported in the UK have been found in Canada, raising concerns across the country. After the first two cases of the variant were found in Ontario on Saturday, two more were discovered in British Columbia and Ottawa.

The Public Health Agency of Canada said all the cases have been connected to travelers from Britain. Officials first reported that the two cases were linked to community spread, but after further investigation, they announced on Sunday that a couple had been in contact with someone who had recently returned from the UK.

#### China's retail sales to grow 4-5 percent in 2021 - blue paper

CHINA released a blue paper on economic outlook for 2021 on Monday, saying the total retail sales of consumer goods are expected to grow 4 to 5 percent in 2021 on a yearly basis. Meanwhile, the Chinese Academy of Social Sciences estimates that China's economic growth will be about 7.8 percent next year.

In 2021, China's major economic indicators will continue to recover with the growth of products and industries expanding, and industrial and supply chains will be basically

The blue book was jointly released by three research institutes under the Chinese Academy of Social Sciences and Social Sciences Academic

It is expected total retail sales of consumer goods in the fourth quarter of 2020 will achieve a growth rate of around 3 percent year-on-year, and the annual consumption scale will be close to the level of the same period last year.

Deng Yu, senior analyst at Bank of Communications, is optimistic about consumption growth. "It's expected that the growth rate of consumption will rebound to around 13 percent year-on-year in 2021, and industries severely affected

The blue book points to a further recovery in Chinese economy in 2021. International organizations have recently raised their forecasts for global economic growth in 2021, with expectations for China's

economic performance significantly better than the global average. The GDP growth forecast for

China in 2021 is 8.2 percent, according to the International Monetary Fund. The World bank forecasts 6.9 percent and the Organization for Economic Cooperation and Development pegged its forecast at 6.8 percent for China's growth.

"China's economic growth will be significantly faster than that of the global economy. In particular, China's economic growth will reach double digits in the first half of 2021, and China will continue to be the world's leading economy," said Deng. **Global Times**

#### Laporta believes he can **convince Messi to stay**

BARCELONA, Spain

FORMER Barcelona club president Joan Laporta has a simple pitch in his attempt to get reelected to the post. According to Laporta, he is the best chance Barcelona has of convincing Lionel Messi to stay put at Camp Nou.

Laporta is one of a handful of candidates vying to become Barcelona's next president in an election by club members called for Jan. 24.

Besides having successfully led Barcelona a decade ago, Laporta's strongest asset to win over voters is his relationship with Messi, whose future with the club is in serious doubt.

"I hope to convince Messi to stay a few more years with us so that this beautiful story he has at Barca can continue," Laporta told The Associated Press in a recent interview.

"I have the honor to have the credibility of the player," Laporta said. "When we meet, Messi always is telling me that 'you always did what you said you would,' and this is something that I am very proud of and I don't want to lose.'

Laporta knows Messi from when he took over the club as its young president in 2003. A teenage Messi had recently joined the Spanish club after leaving Argentina with his family.

At the start of his stint as president, Laporta chose the equally inexperienced Frank Rijkaard as his first coach, and brought in Ronaldinho, Samuel Eto'o and Deco to team up with in-house talents Carles Puyol and Xavi Hernandez. Messi quickly moved up through Barcelona's youth teams and joined the top squad in 2004. The team took off and won two Spanish leagues and the club's second European Cup in 2006.

When that team began to falter, Laporta made another bold move by replacing Rijkaard with the untested Pep Guardiola and selling Ronaldinho. Guardiola retooled the team around Messi, Xavi and Andres Iniesta, sparking the most glorious period in club history.

Laporta could not run for a third consecutive term in 2010. He tried to unseat Josep Bartomeu in a 2015 election, but Bartomeu won with the team coming off a triple sweep of the Champions League, Spanish league and Copa del Rey - the last peak of greatness for the club.

Bartomeu resigned in October when faced with the possibility of being ousted in a no-confidence motion supported by thousands of club members furious after the team's poor performances and the club's bad financial situation. Barcelona suffered a historic 8-2 loss to Bayern Munich in the Champions League quarterfinals in August, and its soaring debt forced the club to practically give away veteran stars like Luis Suarez to slash its salary burden.

The big worry, however, is what Messi will do

Messi stunned Barcelona in August when he said that he wanted out. The club, however, resisted, and he backed down - at least for the time being. He has played as hard as ever these past months with the team still having ups and downs as new coach Ronald Koeman tries to work in younger players to rejuvenate the side.

Messi's contract expires next June, meaning he is free to negotiate with other clubs as of Jan. 1. However, Messi said on Sunday that he won't make a decision on his future until the end of the

Barcelona will remain under a caretaker board, which lacks powers to sign contracts, until February when the newly elected board takes over.

Laporta said that despite having maintained what he called "informal" talks with Messi over the years, he has yet to make the player a formal

"I would like to be president of football club Barcelona, look at the accounts, know perfectly what the possibilities are that we have to give him an economic proposal," Laporta said. "But for me the economic proposal with Messi is not the most relevant thing. (.) The most important thing is to propose him a very competitive team because Leo wants to win championships.'

There are seven other declared candidates, but the field will be narrowed down by a signaturegathering process. Just over 2,250 signatures are needed to get one's name on the ballot. Around 110,00 club members will have the right to vote.

Since leaving the club, Laporta has maintained his work as a lawyer, but also dabbled in politics. He spent 2010-12 as a member of Catalonia's regional parliament, supporting the independence of the wealthy northeast region.

The Catalan separatist movement Laporta backs has generated deep political and social divisions in Spain. Still, Laporta said he would ensure that Barcelona would "integrate different ideas and ways of thinking" for its fans who do not agree with his politics.

Now, at age 58, Laporta is convinced that his record of having guided the team through thorough overhauls not once, but twice, should be enough to put him back in power.

"I can bring back the joy to Barcelona's fans because I have the experience of having already done so," he said. "I have the commitment and preparation required to take the decisions the club needs.'

Seventeen years since he first celebrated becoming president by spraying Cava on his cohorts, Laporta has some gray hairs, but he still knows how to make Barca fans snicker by poking fun at their top rival.

## Looking back on a year in soccer unlike any other

has been, well, a year. Soccer was disrupted more significantly than at any time since World War II as a pandemic shook the sport's shaky economic foundations. The European Championship was postponed. We lost Diego Maradona and a raft of other luminaries. And chances are fans won't fill stadiums fully in most parts of the world until the summer, if not later.

But soccer happened nevertheless. And some had better years than others. Normally, we would declare winners and losers in a piece like this, but everybody is a winner for getting through this foul year, and there are no losers.

Besides, the biggest winner of all is Marcus Rashford anyway. The Manchester United striker not only blossomed into one of the world's best forwards but twice shamed the British government into extending free meal programs for school children, becoming the face of the fight to eradicate hunger in kids. But that had little to do with the game itself.

So here are Yahoo Soccer's 10 gainers and alsorans of 2020 for things that actually involved soccer.

Gainer: Bayern Mu-

At the start of the year, Bayern was in crisis. It looked old and sated and had sunk as low as seventh place in its campaign to win an eighth straight Bundesliga title. But by Aug. 23, Bayern hadn't lost in 30 straight games under new manager Hansi Flick, claimed the second Champions League-Bundesliga-DFB Pokal treble in its history and rejuvenated its side. As a new year dawns, Bayern once again sits firmly atop its perch, looking ahead to future years of dominance.

Also-ran: The sport as a whole

It was no great secret that most soccer clubs lived close to the financial abyss. As it got ever more expensive to compete, teams began taking bigger risks, spending more and more of their revenue on transfer fees and salaries. When, suddenly, matchday income evaporated for months on end due to the pandemic, the financial shock was such that it put a host of clubs in existential danger. Even the richest teams like Barcelona had to ask players to forgo or defer salary while laying off or furloughing staff. The income lost this year will be counted not in millions but billions and the repercussions will reverberate.

Gainer: Liverpool For a while, there was talk of abandoning the 2019-20 season altogether, even though the Reds had the Premier League title more or less sewn up for months already. They were champions all but mathematically. And now it looked like a once-in-a-century pandemic could rob them of their first title in three decades. But the season was restarted and although its record-setting pace slowed, Liverpool still posted one of the

all time. Also-ran: The fans

In dribs and drabs, fans have returned to stadiums around the world. A few thousand here. A few hundred there. In some countries, they had to be barred again as cases spiked in the fall. Even with some of them

back, it isn't the same. We've become accustomed to seeing empty stadiums, empty stands covered with tarps or filled with cutouts or awkward CGI fans. It's going to be a long time. And that's to the detriment of the people who love the game and want, above all else, to see it in person. Soccer is diminished as both an experience and a TV product without them.

Gainer: Jose Mourinho

When the once-special Mourinho took over Tottenham Hotspur in November of 2019, he was seen as a manager past his prime joining a team in slow decline. But by the summer, he had lifted Spurs from 12th place to sixth in spite of a series of a catastrophic injuries to its star forwards. An Amazon docuseries renewed Mourinho stardom and the ongoing season has even seen Tottenham flirt with competing for the title, including a thumping 6-1 victory over the last club to fire Mourinho in 2018, Man-

chester United.

him, the world's greatestever player was ready for a new challenge. He had certainly done plenty for Barcelona. And he believed that he was free to go, even with a year left on his contract. After all, he had an out clause after the season. So, following Barca's humiliating 8-2 elimination at the hands of Bayern in the Champions League quarterfinals, he exercised it. Ah, but the clause expired at the end of May and it was now August, Barca said, forcing Messi to stay even if it might have violated the spirit of his contract. He opted against a costly and lengthy legal tussle. But the entire thing left a bad taste in his mouth as he has caught on to the club's ongoing chaos in the last years of his ca-

Gainer: USMNT Yes, OK, sure, the U.S. men only played four times all year. But they went undefeated? And that's not the point anyway. The point is that a raft of national teamers continued to climb the ladder in the European club game. Sergiño Dest earned a transfer from Ajax to Barcelona. Weston McKennie escaped Schalke for Juventus. Gio Reyna broke into the first team at Borussia Dortmund. Christian Pulisic firmed up his place with Chelsea and earned the No. 10 jersey. Tyler Adams made the Champions League semifinals with RB Leipzig. All of this accrues nicely to the national team. Also-ran: Barcelona

The 2019-20 season was the club's first campaign since 2007-08 that it won no trophies at all, punctuated by that aforementioned 8-2 loss to Bayern. Things only

got worse from there. Messi wanted out. Club president Iosep Maria Bartomeu was ousted. The club turned out to be broke. And the squad is broken beyond repair. It's little wonder that under new manager Ronald Koeman, who pushed out pricey veterans but wasn't given the money to replace them, Barca already appears to be out of the title race. Gainer: Christine Sin-

It was at the start of the year, on Jan. 29, but in an Olympic qualifier against Saint Kitts and Nevis that day, Sinclair scored her 184th and 185th international goals. That tied and then surpassed the USA's Abby Wambach and her world record for international goals – among women and men. It took Sinclair 35 more games than Wambach got, but then the Canadian striker never had anything close to the same supporting cast and team dominance.

Also-ran: Arsenal

Briefly, there was a revival under new manager Mikel Arteta. But the eighth-place finish in 2019-20 was still the club's worst since 1994-95. The Gunners did win the FA Cup, but then they were also ignominiously bounced from the Europa League in the round of 32. And eighth place would feel pretty good right about now. as Arsenal slums it in 15th with a team that can't defend, attack or really do anything else you would expect from a Premier League juggernaut.

"His allegations are currently being investigated and he will be called to respond to them."

Simba SC will be seeking to get the better of FC Platinum in the CAF Champions League's first round's second leg, slated for January 6 at Benjamin Mkapa Stadium in Dar es Salaam, and progress to the competition's group stage.

Qualification for the group stage of the premier continental club competition will be sealed by

Simba SC, should the outfit beat FC Platinum by more than two goals next week.
