Concern as wildebeest numbers drop by 72pc in Selous, Mikumi



A glimpse of the Great Wildebeest Migration, the annual movement of giant herds of grazers across Northern Tanzania and Kenya. THE number of wildebeests in the Selous-Mikumi ecosystem has fallen by record 72- per cent in the last two decades, a recent census shows.

Speaking during the launch of the findings of the Selous-Mikumi national parks partial census conducted in 2018, the Minister for Natural Resources and Tourism, Dr Hamisi Kigwangalla said a further study needs to be conducted to find out reasons behind the sharp decline.

"The study that was conducted dwelt on numbers and not on the cause of the decline. That is what now needs to be studied," he said.

The study, which covered 104.14 square kilometers recorded 27 wildlife species, mostly mammals, one reptile and one avian species.

The report cautions that there is

need for close monitoring following the wildebeest decline as the average population estimate from 1994 to 2006 was around 69,000 wildebeest.

But from 2009 to 2018 the average population estimated declined to around 19,000 which represents a 72-percent decline, which merits

The decline of the wildebeest is a concern for conservationists as the animal sustains wildlife tourism pullers among carnivorous animals such as lions, leopards and cheetahs.

The largest number of animals in the ecosystem was buffalos which numbered 66,546 followed by hippo (31,086) larger antelope (23,250) and wildebeest (22,740).

Others include zebra (22,690), impala (19,296), warthog (17,475) and elephant (15,500). On the other hand,

THE government has formed a 12-man team to carry out research on grapes, whether the crop is beneficial to the farmers and in terms of government


The team will take 10 days to do its work, as it is directed to find out the extent of diseases that afflict the crop.

JPM: Valley dwellers not eligible for any flood aid

PRESIDENT John Magufuli yesterday warned people living in valleys all over the country to move to elevated areas, saying that the government will not give humanitarian assistance in case of floods.

Speaking while opening the offices of Kigamboni District in Dar es Salaam, he said there are people who are not willing to leave flood-prone areas despite knowing that the places are dangerous during rainy seasons.

Those areas can only be used for temporary economic activities like horticulture but not permanent settlement as is the case with the Msimbazi Valley where obdurate residents need to be rescued when it rains heavily.

"Now that you have been warned, I do not expect

any complaints when you don't receive assistance from the government...Stop constructing in valleys," he said.

The president also urged people to start harvesting rain water for later use.

He also fired Kilosa District Council trade officer Daniel Maleki who was recently arrested for tearing and burning pages of the Quran.

"We cannot live with such people in the government. I commended minister Jafo for the measures he took but I announce today that the official has been sacked," he declared.

On the new Kigamboni District, the president commended those who supervised the construction of the buildings.

He, however, directed them to reinvigorate

VP appeals for clarity on climate change financing

VICE President Samia Suluhu Hassan has called on developed nations to honour their promise for funding to mitigate effects of climate change in

Speaking in Addis Ababa at the 33rd African Union (AU) Ordinary Conference for Heads of State and Government early this week, the VP also urged African countries to seek alternate sources of finance to contain effects of climate change.

At the global climate change conference in Paris in 2015 where the current framework was negotiated, developed countries reaffirmed the commitment to mobilize USD100 billion a year in climate finance by 2020, and continue mobilizing

finance at the level of USD100 billion a year until 2025.

The VP said African countries contribute less to greenhouse gas emissions but they are suffering from the consequences of climate change while the promise of funding for mitigation by big polluters was not forthcoming.

Effects of climate change are seen in pulling back development efforts in African countries due to destruction of infrastructures from hurricanes, floods and drought, she said, urging the setting up of a special fund and alternative sources in that regard.

PM directs NHC to collect all debts

PRIME Minister Kassim Majaliwa has directed the board of directors of the National Housing Corporation (NHC) to ensure that it collects all the debts from its tenants before June, this year.

He gave the directives in Dar es Salaam yesterday in a meeting with the NHC's management and board members.

The Prime Minister wanted all the tenants including government entities to ensure that they pay their outstanding renting charges.

"I have a very long list here of all the debtors, and others are seen being already moved out of the houses without paying the rents, all of them corporation to venture into building unnecessary inconveniences to Residence (Kawe) and Regent Estate.

the least abundant species were bush pig (1,208) and lesser antelope (1,579).

The study shows lesser antelope species declined rapidly in number in the ecosystem by 97percent from 50,000 in 1998.

Positive results came up whereby no fresh carcasses (less than one-yearold) were recorded and the carcass ratio dropped from 39-percent in 2014 to 16-percent in 2018, indicating significant management intervention of curbing poaching.

Conservationists say that more efforts and time is needed to reach eight percent carcass frequency which represents natural mortality.

The survey was conducted from the 21st October to 24th November 2018 with considerable funding from the German Development Bank (KfW) through the Frankfurt Zoological Society (FZS).

The census was intended to establish the population status and geographical distribution of large animals and human activities in the Selous -Mikumi ecosystem.

"The census is an outcome of the cooperation between Tanzania and Germany, who have jointly made it possible to carry out this important work. Having good data is a crucial basis for decision making," said Regine Hess, Ambassador of the Federal Republic of Germany in Tanzania.

The inaugurated building cost 6.8bn/- in total, where the municipal council footed 5.2bn/-and the District Commissioner's office put in 1.6bn/-.

Minister Jafo said that the completion of the two office buildings will improve public service provision in the district.

The Paris Agreement is based on the United Nations Framework Convention on Climate Change (UNFCCC) relating to greenhouse-gas-emissions mitigation, adaptation and finance that was signed in 2016.

Representatives of 196 state parties at the 21st Conference of the Parties of the UNFCCC in Le Bourget, near the French capital of Paris reached the framework accord and it was adopted by consensus on 12 December 2015.

As of November 2019, all UNFCCC members had signed the agreement, with 188 having become party to it and the only significant emitters which are not parties are Iran and Turkey, observers noted.

agreement's long-term temperature goal is to keep the increase in global average temperature to well below 2 °C above pre-industrial levels, and to pursue efforts to limit the increase to 1.5 °C.

This would substantially reduce the risks and impacts of climate change, through the peaking of emissions as

soon as possible, in order to achieve a balance between anthropogenic emissions by sources and removals by sinks of greenhouse gases.

The balance is meant to be achieved in the second half of the 21st century, as it also aims to increase the ability of parties to adapt to the adverse impacts of climate change.

They also need to make financial flows consistent with a pathway towards low greenhouse gas emissions and climate-resilient development, a conference brochure intoned. The issue of education was also

heritage and fossil natural resources in Tanzania as well as promote domestic and foreign tourism.

It is an important opportunity for Tanzanians and foreign visitors to learn in detail about the dinosaur, the animals that have lived on the planet and also in Tanzania over 100 million years ago.

At this exhibition, the German conditions of Tanzania. partners will be responsible for producing an original cast of the Brachiosaurus brancai famous (Giraffatitan), importing, constructing and developing the exhibition with digital elements, and ensuring that the materials used to produce the exhibition are in line with the climate

Similarly, the exhibition aims to promote local tourism and attract more tourists from abroad so that they can see the places where these historic animals were found in our country.

The remains of these animals were first discovered in the Tendaguru area of the Lindi region, and were recently

also discovered in the Ruhuhu basin in Ruvuma Region, and the Rukwa valley in Songwe.

The exhibition will also be useful for training, research and educational opportunities for staff who will participate in the care and maintenance aspects of various collections, including the fossil remains of the animals.

Tanzania is one of the few countries in the world that has large remains of Dinosaurs that make a significant contribution to better understanding the ecology and natural heritage of the world. The discovery of Dinosaur fossils in Tendaguru in the Lindi region led to archaeological and paleontological studies from various universities and institutions around the world to conduct research in the country.

As a consequence of the good results of these studies, the remains of the Dinosaurs have also been found in other regions such as Songwe and Ruvuma region, and can lead to many more discoveries of important fossil remains in the country.

Zanzibar unveils drive to fight plastic waste in Indian Ocean

ZANZIBAR government has unveiled new programme aimed at curbing plastic and other environmental pollution generated by manufacturing and prevent it entering the Indian

Deputy minister in the Office of the Second Vice President, Mihayo Juma Nh'unga, made the statement yesterday in the House of Representatives when responding to a question by Paje MP, Jaku Hashim Ayoub who had wanted to know government's strategy to address the increasing plastic waste in the Indian Ocean, which in turn pose a serious challenge to marine resources.

"As government we're fully aware of the challenge, which poses many threats to the health of ocean, including the scourge of marine plastic pollution. And we've taken several initiatives

including building modern dumpsite a plastic recycle factory in order to waste including plastics," he said

He also revealed that his office has been working to come up with a national strategy on waste management and control which is to be presented at the top government level for approval in this fiscal year.

The deputy minister said, they have been providing community awareness on waste management through various channels including meetings and running sanitation campaigns in the beaches.

"The government in its public education programs asked public to reduce the use of plastic materials to necessities of establishing a factory that reduce the production of plastic waste"

Fire Brigade revenue collection to be made via GePG - Masunga

FIRE Brigade and Rescue Services Commissioner General John Masunga has directed that all revenue collection is effected electronically.

He also expressed his surprise on how come the Brigade is not well known by the wananchi despite its huge work in saving lives of people and their property.

He explained that revenue collection via GePG system simplifies the task of knowing all collected revenue as well being certain of its safe keeping.

On discipline Masunga stressed the need for all workers in the Brigade, both fire workers and civilians to maintain discipline of the highest standard for better performance.

He also informed that some of the problems in the Brigade will be dealt within a short time, and revealed these to include lack of modern fire fighting and rescue services equipment.

On workers monetary claims, he said "these have already been verifies and will be paid out any time from now when the Treasury is ready."

On his part, the Brigade's Commissioner for Administration and Finance Mbaraka Semwanza said he will ensure there would not be any7 collection of revenue that will be done outside the procedure set down by the government and whoever will go against the procedure will be dealt with accordingly.

Guterres appoints Judge Iain Bonomy of UK and Northern Ireland to serve as Mechanism Judge

THE Secretary-General of the Nations, António Guterres has appointed Lord Iain Bonomy of the United Kingdom of Great Britain and Northern Ireland to the roster of Judges of the International Residual Mechanism for Criminal Tribunals ("Mechanism") with immediate effect.

Judge Bonomy was educated in Scotland, graduating from Glasgow University. He practised as a solicitor from 1970 until 1983. In 1984, he was admitted to the Scottish Bar and, in 1993, was appointed Queen's Counsel.

From 1990 to 1996, he served as a criminal prosecutor (Advocate Depute and Home Advocate Depute) and, in 1997, was appointed as Senator of the

Session and the High Court of Justiciary, the highest court in Scotland).

From 2004 to 2009, Judge Bonomy served as a Judge of the International Criminal Tribunal for the former Yugoslavia ("ICTY"), where he sat on many high-profile cases and presided over the trial of former Serbian President Milan Milutinovi. Following his departure from the ICTY, Judge Bonomy was appointed as a Judge of the Court of Appeal in Scotland, and subsequently served as a Surveillance Commissioner for the United Kingdom and later a Judicial Commissioner in the Office of the Investigatory Powers Commissioner.

Judge Bonomy was appointed to the Mechanism's roster of Judges following

Among other things, Hasunga said that, IFAD has become an important partner in construction and financing programs and projects that aim to fight poverty in rural areas and increase the possibility of ending hunger completely.

"IFAD has been at the frontline in modernizing agricultural activities in many developing countries including Tanzania", the Minister said.

The minister has also has expressed Tanzania's acknowledgement to IFAD for the various projects that have been implemented in Tanzania, stressing that the government will not wait until 2030 to end hunger but will make it as soon as possible.

He said the effort intended to address the challenges of rural poverty through introduced development strategies and economic growth plans.

Hasunga explained that, the Tanzanians economy continues to improve through the agriculture which contributes 28.7 percent of the national income, 30 percent of the foreign domestic income, employment for 65.5 and industrial equipments 66 percent and 100 per cent of the national food demand.

Speaking about economic growth in Tanzania the Minister said that the national economy is growing for 7percent in mainland and 6.6 percent on Zanzibar.

Minister promises heavy punishment to all importers of banned plastic bags

MINISTER of State in the Vice-President's Office (Union and Environment) Mussa Zungu has promised dishonest traders who are importing banned plastic carrier bags colluding with counterparts in neighbouring countries very heavy punishment as economic saboteurs.

Minister Zungu said in Dar es Salaam on Monday that the government was aware of the illegal trade of banned plastic bags between local and foreign traders, adding that harsh punishment awaits the dishonest traders who he described as crude saboteurs of government revenue.

"Our investigations have revealed that deceitful traders in neighbouring countries are colluding with local counterparts bringing banned plastic bags in our country. They are sabotaging crudely government revenue in this illegal trade because we know what they are doing. We are putting our things right. We shall punish these sabotouers of the national economy," he warned.

To make matters worse, the minister said, the traders were importing substandard carriers that were littering the environment and were promoting

illegal and unfair competition with local industries. He also said some of the bags in circulation were locally and illegally produced.

Zungu called on Tanzanians to be wary of bags, saying that carriers that have not been cleared by the Tanzania Bureau of Standards (TBS) could endanger health of users. "These carries do not have TBS logo and do not meet the GSM 70 benchmark. We shall be forced to take stern measures to protect local industries and environment."

The minister said personally he would not accept to be part of a group that undermines the government of President John Magufuli because, he said, unfit plastic bags were banned since June last year. "The ban created opportunity for making alternative bags. This opportunity is being abused. Culprits will be punished severely."

THE government has spent 90bn/for training education experts, tutors in teachers training colleges as well as procuring teaching and learning facilities in those colleges.

This was said here yesterday by Permanent Secretary in the Ministry of Education, Science and Technology, Dr Leonard Akwilapo when speaking at the stakeholders meeting under the Teacher Education Support Programme (TESP).

Dr Akwilapo said the amount was spent for building and revamping teaching and learning infrastructure in public teachers' training colleges, special primary and secondary schools as well as training tutors and teachers in those colleges and schools.

The programme work with the Ministry of Education as well as the government Teacher Training College management teams, to provide technical services, capacity development, coaching, mentoring and advice to improve the quality of teachers entering the profession, thereby improving the quality of basic

for girls and boys in primary and secondary schools across Tanzania.

He further said that apart from training and refurbishing colleges, through the project "we've started building a new Kabanga Teachers' Training College which will be completed in June, this year."

LAKE Victoria's island of Sizu is in a serious shortage of health personnel the situation that put thousands of residents at risk.

The island has more than 6,000 people without reliable healthcare services the situation that puts more women and children at serious risks.

Amos added that drug availability at the centre has improved for 80 percent, as a total number of 13 women give birth every month at the dispensary.

"The biggest challenge is shortage

of health workers, patients building, address the existing shortage. electricity, ambulance service, poor use of national health insurance service and the habit of some women to give birth at their homes," she explained.

For his part, Ukerewe District Medical Officer (DMO) Dr Raphael Mhana said the government continues to employ new health workers to

We ought to promote full and equal access to participation of women and girls in science

Women and Girls in Science is the 11th day of February, by resolution of the United Nations General Assembly on 22 December, 2015. The day recognises the critical role women and girls play in science and technology.

The International Day of Women and Girls in Science is implemented by UNESCO and UN Women, in collaboration with intergovernmental agencies and institutions, as well as civil society partners, that aim to promote women and girls in science. The day's purpose is to promote full and equal access to participation in science for women and girls.

Science (from the Latin word scientia, meaning knowledge) is a systematic enterprise that builds and organizes knowledge in the form of testable explanations and predictions about the universe.

Modern science is typically divided into three major branches that consist of the natural sciences (e.g., biology, chemistry, and physics), which study nature in the broadest sense; the social sciences (e.g., economics, psychology, and sociology), which study individuals and societies; and the formal sciences (e.g., logic, mathematics, and theoretical computer science), which study abstract concepts.

There is disagreement, however, on whether the formal sciences actually constitute a science as they do not rely on empirical evidence. Disciplines that use existing scientific knowledge for practical purposes, such as engineering and medicine, are described as applied

Science is based on research, which is commonly conducted in academic and research institutions as well as in government agencies and companies. The practical impact of scientific research has led to the emergence of science policies that seek to influence the development of commercial products, armaments, health care, and their study of astrology.

Science in a broad sense existed before the modern era and in many historical civilizations. Modern science is distinct in its approach and successful in its results, so it now defines what science is in the strictest sense of the

Science in its original sense was a word for a type of knowledge, rather than a specialized word for the pursuit of such knowledge. In particular, it was the type of knowledge which people can communicate to each other and share. For example, knowledge about the working of natural things was gathered long before recorded history and led to the development of complex abstract thought.

This is shown by the construction of complex calendars, techniques for making poisonous plants edible, public works at national scale, such as those which harnessed the floodplain of the Yangtse with reservoirs, dams, and dikes, and buildings such as the Pyramids.

However, no consistent conscious distinction was made between knowledge of such things, which are true in every community, and other types of communal knowledge, such as mythologies and legal systems. AU summit African leaders' call for action to end malnutrition by 2025 indeed laudable

HE United Nations recently the number people going hungry has increased for the third year running. A report from the UN Food and Agriculture Organisation, the International Fund for Agricultural Development, the UN Children's Fund, the World Food Programme and the World Health Organisation said reaching the target of zero hunger by 2030 is an immense challenge.

The new edition of the state of food security and nutrition in the world indicates annual report released that more than 820 million people worldwide are not getting enough food, with the situation most alarming

Africa has the highest rates of hunger in the world and the rates are rising in some of the continent's sub-regions. The report says that in East Africa more than three in 10 of the population are undernourished.

The annual UN report also found that income inequality is rising in many of the countries where hunger is on the rise, making it even more difficult for the poor, vulnerable or marginalized to cope with economic slowdowns and downturns

Since 2011, almost half the countries where rising hunger occurred due to economic slowdowns or stagnation were in Africa.

The last year's report introduces a new indicator for measuring food insecurity at different levels of severity and monitoring progress towards SDG 2: the prevalence of moderate or severe food insecurity.

This indicator is based on data obtained directly from people in surveys about their access to food in the last 12 months, using the Food

Insecurity Experience Scale (FIES). African countries have made progress toward eradicating malnutrition and stunting but need to do more to hit United Nations malnutrition targets by 2025. This was the main message of a meeting that took place during the 33rd African Union Summit.

Speakers at a meeting of the African Leaders for Nutrition (ALN) included the heads of state of Madagascar, Cote d'Ivoire and Sierra Leone, national ministers of health as well as African (AfDB.org) Development Bank President Akinwumi Adesina, head of the African Development Bank.

Leaders acknowledged the scope of the challenge but sounded a note of optimism. "We can conquer hunger in Africa," said Madagascar's President Andry Rajoelina, one of five African Leaders for Nutrition champions. "I call on all our partners to continue to work with us to address hunger and malnutrition."

Ivorian President Alassane Ouattara said leaders should take it a step further. "I have proposed for the AU to focus on tackling malnutrition as a theme for 2021," he said.

Stunting has declined by eight percentage points across Africa since 2000, an advance on one of the UN's 2025 targets. African countries have also shown strong progress toward achieving the target of 50% of the world's children being exclusively breastfed for the first six months of life. The other targets are: halting the epidemic of obesity; reducing anemia in women of reproductive age; reducing low birth weight and reducing wasting.

The ALN, a partnership of the African Union and African Development Bank, brings together heads of state, Finance Ministers and other leaders to raise awareness and accountability, and reinforce investment by African governments to end malnutrition among children.

F you asked a typical American about conspiracy theories, he or she probably wouldn't have any trouble rattling off an extensive list of theories ranging from the Kennedy assassination to 9/11. But if there's one potential conspiracy that most Americans are totally unaware of, it's the supposed CIA plot to kill UN Secretary General Dag Hammarskjöld.

Dag had been the Secretary General for eight years, but died in an accidental plane crash in 1961, while en route to a cease-fire negotiation in the British protectorate of Northern Rhodesia. But, over the years, there have been multiple claims that the plane was shot down, and that he was actually killed in an assassination plot that involved some combination of the CIA, a Belgian Mining Company, a South African paramilitary unit, and British intelligence. Why? Because he was pushing for Congo's independence, which would have hurt the interests of any of those forces.

Adding fuel to the theories, was a copy of a secret government document that surfaced in South Africa 18 years ago, which suggested that the CIA, MI5, and the South African government were in on Dag's death. They presented statements from CIA director Allen Dulles, saying that "Dag is becoming troublesome ... and should be removed." Unfortunately the original documents couldn't be found, so there was no way to verify the copies.

But last year the South African government claimed to have found the original document, which has led the UN to reopen their investigation into Hammarskjöld's death. The CIA has, of course, dismissed these claims as "absurd and without foundation."

Dag Secretary-General Hammarskjöld was one of only four people to have been posthumously awarded a Nobel Prize (for Peace), and was described by the then-US president, John F Kennedy, as 'the greatest statesman of our century'. His death in 1961 has sparked many theories, among them that a South African right-wing paramilitary organisation, or South African mercenaries, were responsible.

Shortly after midnight on 18 September 1961, a plane crashed when approaching Ndola, a mining town in Northern Rhodesia (today Zambia) bordering the Congo. On board were UN Secretary-General Dag Hammarskjöld and 15 other people. They were on their way to meet Moïse Tshombe, leader of the secessionist Katanga Province, to find a solution to the conflict in the Congo.

All but one of those on board died in the wreckage. The bodyguard Harold Julien succumbed to his injuries six days later in a local hospital. He could have been saved if treated properly. His eyewitness report of the crash was also neglected.

South Africa must investigate death of Dag Hammarskjöld

Foul play was not ruled out. The inquiry by a United Nations Commission noted that "the Rhodesian inquiry... had reached the conclusion that the probable cause of the crash was pilot error. The Commission, while it cannot exclude this possibility, has found no indication that this was the probable cause of the crash."

UN Resolution 1759 (XVII) of 26 October 1962 therefore tasked the secretary-general "to inform the General Assembly of any new evidence which may come to his attention". This left the door open for a return to the

Fifty years later, Susan Williams published a book which pointed to omissions, flaws and failures of the earlier investigations. It triggered a new inquiry conducted by an independent commission of jurists. It submitted its report in 2013.

As a result, official investigations by the United Nations were resumed. The United Nations Association Westminster Branch in London has since then provided regular updates on developments.

In 2017, the former Chief Justice of Tanzania, Mohamed Chande Othman, was appointed as Eminent Person, tasked with further investigations. He concluded in his first report that an aerial attack "would have been possible using resources existing in the area at the time" and "that there is likely to be much relevant material that remains undisclosed".

Othman identified "the continued non-disclosure of potentially relevant new information in the intelligence, security and defence archives of Member States" as "the biggest barrier to understanding the full truth". He on reports of the "independent high-

stressed that "the burden of proof has now shifted to Member States to show that they have conducted a full review of records and archives in their custody or possession, including those that remain classified, for potentially relevant information".

In support of Othman's report, UN Secretary-General António Guterres recommended "that relevant Member States appoint an independent and high-ranking official to conduct a dedicated and internal review of their archives, in particular their intelligence, security and defence archives, to determine whether they hold relevant information".

Following a Swedish draft resolution co-sponsored by 70 member states, the General Assembly extended Othman's mandate. He presented his second report in September 2019.

Newinformation, Othman concluded, "highlights the fact that there were many more foreign mercenaries in and around Katanga, including pilots, than had been considered by earlier inquiries". These had the logistics and necessary conditions (suitable planes and airfields) to intercept the plane. For Othman, "it remains plausible that an external attack or threat was a cause of the crash".

New information also confirmed that the crash site was discovered much earlier than officially reported - and testifies to the deliberate neglect of the only survivor. As Othman notes, this "calls into question the acts of various Governments directly after the crash and leaves open the issue of why the earlier crash discovery time was not

Othman based his conclusions partly

ranking officials" appointed by several member states. However, states where most discoveries could be expected did not comply. South Africa finally assigned a high-ranking official at Dirco in May 2019 with the task. But no report has so far been submitted.

Othman therefore recommended: That an independent person

be appointed to continue the work; That key member states be

again urged to (re)appoint independent high-ranking officials to determine whether relevant information exists within their security, intelligence and defence archives;

That a conclusion be reached as to whether member states have complied with this process; and

That key documents be made public.

In December 2019, another Swedish draft resolution was adopted with a record number of 128 co-sponsoring countries (including South Africa, but as before without the support of the US and the UK). It extended Othman's

This has a significant symbolic meaning. The Westminster Branch of the UK's UN Association considers "a record number of co-sponsoring Member States to be a clear indication to those few states which have failed to cooperate". It should be a strong reminder that it is time for South Africa to deliver.

It is one thing if the US and the UK are unwilling to assess and disclose classified material. The assumption that they want to avoid embarrassment by not sharing what they know is not too far-fetched. But South Africa has long since eschewed the traditions of the apartheid regime.

Concerned about apartheid, Hammarskjöld had visited South Africa in early 1961.

His death was celebrated in the white settler-minority communities. It is inconceivable that local archives contain no information on what happened at Ndola. South African agencies and individuals played an active role in the region. This needs to be closely investigated.

Democratic South Africa should deal with such skeletons in its closet. It must come to terms with a past which is not one of today's government. As Guterres stated in his letter to the General Assembly:

"It remains our shared responsibility to pursue the full truth of what happened on that fateful night in 1961. We owe this to Dag Hammarskjöld and to the members of the party accompanying him. However, we also owe this to the United Nations."

China's Belt and Road Initiative and Africa's development

rom the G20 Summit 2017 to the EU-Africa Business Summit 2019, Africa remains relevant in the international arena. The current interest of the rising economic giant (China), in Africa has stirred international attention as it solidifies a path for the 'New Scramble for Africa'. Preoccupied with her past and possible 'worst-case scenarios' painted by the West, Africa could possibly be missing out on a worthwhile opportunity to support its own development through the Belt and Road Initiative.

China's Belt and Road Initiative (BRI), engineered and revered by Chinese President Xi Jinping, is an effort focused on the development of infrastructure and the construction of an economic belt, which will consequently connect Asia, Europe and Africa. Its intent is to boost the world's economy, especially international trade, finance and tourism. Critics, however, have summed it up to be nothing more than "an effort to mask the strategic expansion of Chinese power".

Nevertheless, the "threat" caused by the BRI can be viewed as exaggerated. Subsequently, there are equal benefits and drawbacks to the BRI, or African development. Irrespective of the investor, Africa must learn from its colonial past.

Various authors have purported that it is through large scale "commitments" that China is leveraging the massive loans it holds over

small states worldwide to snatch assets and increase its military footprint. The British and the Dutch empires were the poster children of strategic, and economic imperialism, having milked the African continent for all it's worth, leaving it high and dry. This was done in the name of "trade and aid". In 2012, the vice president of China Exim Bank, Zhu Hongjie, called for an "expansion of foreign aid", including "concessional lending", to improve the efficiency with which China's aid can promote China's export

ing reputable Chinese enterprise to increase the development capacity of developing countries.

In 2015, China loaned \$12-billion to African countries, and in the same year, a further \$3-billion, allowing us to witness the force of Chinese globalisation. Moreover, the share of African workers in Chinese infrastructure projects on the continent is often perceived to be too low. In Nigeria, politicians worrying about jobs for locals recently discussed a loan offered by China Exim Bank, companies without the oblito strengthen our ties," said

with the condition that the local company. In 2012, there projects must be done by Chinese workers. What is more worrisome is that "of an estimated 10,000 Chinese businesses in Africa, 90% are privately owned, rather than state-run, therefore indicative of the fact that private Chinese industry is taking hold of Africa".

A similar scenario is seen in Kenya, where direct investments by foreigners are facilitated by the Investment Promotion Authority, which grants licenses to foreign while at the same time help- which supposedly came gation of partnership with a Tony Dong, the Head of the colonial buildings and dilapi-

were reportedly 67 Chinese companies registered in Kenya, including 25 in the building and construction sector and nine in real estate.

The argument therefore is: In the likelihood of a "masked Chinese agenda" disguised within this new Sino-Africa relation, the responsibility is left to African leaders to be vigilant in securing the continent's interests having learnt from colonial predecessors. "China needs Africa and Africa needs China, we need Federation of Sino-European Entrepreneurs. China has the skill set, tech-

nology and financial capacity to assemble Africa through the BRI. This also comes at a time when Africa needs to improve its infrastructure, particularly energy, roads and railways. For instance, countries such as Gabon are a prime example of this as its partnership with China makes provision for growth.

For years, Gabon, a central African country, had wanted to improve the transport network of its crumbling French

dated roads. On the surface, this (Sino-Africa relations), appears as a simple mutual trade. Although a more primitive look at this partnership implores the question of whether this is truly an authentic common trading agreement, or a repackaged colonialistic strategy. This is not to say the BRI undertaking is a bad initiative since it will spur development across the African continent if it's successfully implemented. However, one must not easily dismiss the negative implications behind supporting the BRI. Support means boosting China's political and economic power across much of the world. This could be easily achieved by exploring ways to best utilise the BRI's immense offerings and grow Africa's interests.

Therefore, China or another investor supports colonialism in the name of development, a tougher and goaloriented approach should always be used by African towards governments implementation sustainable development, says one analyst.

In conclusion, there are advantages to be shared between countries involved in the BRI. Of course, like any other large-scale initiative, there are risks. If these risks are properly managed, they will not hamper the progress of continental upgrading. Consequently, although China claims to come in peace bearing gifts, a cautionary tale for Africans to remember is that "clean gloves hide dirty hands".

Do I need permission to breathe? - A migrant woman's story


NEW YORK

66 I soiled my pants, I could feel the wetness seeping into my waistband, my eyes started to become blurry. Only the sound of the blaring television assured me that I was still alive. I tried to stop thinking and make my mind go completely blank. Over the years I have adapted and now I can make my mind go numb. But the only nagging question ringing on my mind during the last 45 seconds was: will this stain the carpet? Should I clean myself first or should I clean the carpet first? Which one is safer? Did he notice the stain?

I laid there without a word hoping and praying that he does not notice the wetness. I am pretty sure he will start to bash me noticing the stain. We just bought the carpet two years back and it is messed now for me. I laid down holding my breath.

His grip started to get loose. I saw him examining the wet spot on his jeans and his eyes change to a different color of red. A little later he moved his foot that was firmly digging on my chest. His mother scrunched her nose and tucked a portion of her garment to block the smell. She held my son by his arm and pulled him out of the closet. I saw my son being dragged to the kitchen. Although the blood on my eyes was making it hard to see, still I was relieved that my 6-year-old did not have to see his mother soiling her garments and her face red with blood. I laid there for roughly five minutes until

He is a good man, he buys me food, he gave money for laundry but sometimes he loses his patience. He is not a bad man." She nods her head and forces a faint smile. He holds my hands and gestures me begging to stay

This story is of a girl named Selina, who is a regular at the Asian store down the road.

Selina was only 16 years old when a family came to meet her as she came back home from school one day. All she knew was: the family lives in America and

is affluent. She was married that evening. After a year, her husband brought her to the United States. For the last 7 years, she has never been permitted to meet anyone from her family or go back home. She does not have access to a telephone nor is she permitted to go out of the house alone. The only surrounding she knew was the house she lives in, the grocery store and the route to her son's school. Coming from the same country as me, she speaks to me every chance she gets when her mother in law is not with her. I have seen her many times in the shop, hesitant, perplexed and with bruises. Today she came fully covering her face, limping

for her carpet.

Domestic abuse and

violence are the willful intimidation, physical assault, battery, sexual assault, and/ or other abusive behavior as part of a systematic pattern of power and control perpetrated by one intimate partner against another. It includes physical violence, sexual violence, psychological violence, and emotional abuse. The frequency and severity of domestic violence can vary dramatically; however, the one constant component of domestic violence is one partner's consistent efforts to maintain power and control over the other. (2) Sometimes in the early stages of a relationship, it cannot be determined if one person will become abusive and to what extent that might lead to. Domestic violence intensified overtime. Outwardly an abuser seems like a wonderful person, liked by his colleagues and friends but gradually may become aggressive and controlling. Also, an abuser may have episodes of being violent and being loving or caring moments later. The abused might stay in a constant state of denial hoping for the episode to pass and then get back to normality.

The question comes in relation as to why the abuser does not voice her concerns or reach out for help. Also why they do not break the cycle of abuse? In the majority of countries with available data, less than 40 percent of the women who experience violence actually speak up and seek help of any sort. Among women who do, most look to family and friends and very few

I finally picked up my phone look to formal institutions itself to the invisibility imfamilies to keep the families' and mechanisms, such as migrant women experience personal identification docpolice and health services. Less than 10 percent of those women seeking help for the experience of violence sought help by appealing to the police or other organizations. (3) Between 960,000 and 3,000,000 incidents of domestic violence are reported each year, while many other incidents go unreported. (4) It is estimated that more than ten million people experience domestic violence in the U.S. each year. (5) In many cases, it has been seen that there is a massive gap between the number of abused women reaching out for help than

the actual number of women facing abuse. The victim's reasons for staying with their abusers are extremely complex and, in most cases, are based on the reality that their abuser will follow through with the threats they have used to keep them trapped: the abuser will hurt or kill them, they will hurt or kill the children, they will win custody of the children, they will harm or kill pets or others and will ruin their victim financially. The victim in violent relationships knows their abuser best and fully knows the extent to which they will go to make sure they have and can maintain control over the victim. (6)

There is a growing body of research data demonstrating that immigrant women are a particularly vulnerable group of victims of domestic violence., where a widely utilized technique to dominate the abused is isolation. It is an important factor in mariimmigrant families. It lends tions and second-generation

based on their gender status in the United States. Drawn from unstructured interviews with abused South Asian immigrant women, three different levels of isolation are explained. The first level involves the quality of a woman's relationship with her spouse; the second is related to the frequency and quality of social interaction with friends, relatives, and coworkers; and the third is explained in terms of the level of access to and participation in the ethnic community and other formal institutions. (5). This group of women tends to have fewer resources, stay longer in the relationship, and sustain more severe physical and emotional abuse. It has been seen many times that abusers of immigrant domestic violence victims actively use their power to control their wife's and children's immigration status and threats of deportation as tools that play upon victim's fears so as to keep their abused spouses and children from seeking help or from calling the police to report the abuse. Due to the language bar-

rier, the immigrant women who have limited speaking ability of the language spoken in the foreign country get sidelined by default. During their doctor's visits, children's school visits and other social interactions they remain highly dependent on their spouses or upon family for getting their point across. So, if they want to voice out their concerns they are barred and monitored. It is a well-known common practal abuse among South Asian tice of many first generauments like passports, birth certificates, health insurance cards, social security cards and financial documents under the control of the male of the house. The women are always under constant surveillance and monitoring. Another interesting factor adding to the muted voice of abused women is financial dependency. Following traditions and cultural norms, regardless of educational background or social standing, a major portion of the immigrant women are required to put their earnings or savings into a joint account that she and her partner share. And in most cases, she holds no access or decision-making ability of her own money even if she is earning.

An update to Selina's story: One phone call made by her neighbor 2 years back, changed her life for the better. It took her 2 months to heal physically in a hospital, took 23 sessions of physical therapy to walk properly and hours of counseling to get back her mental health and stability. She now works in a bakery and can speak basic English after a year of training offered by her local shelter. She is living in a one-bedroom apartment with her son and she recently sent \$50 to her ailing mother back home from her paycheck. Every time her cell phone rings, she smiles and pauses before answering. She loves the fact that she can breathe without taking permission from anyone and can speak with anyone she wishes to.

The coronavirus will not cripple China's economy

ust five days before the Chinese New Year, the authorities in Beijing finally declared coronavirus epidemic that originated in Wuhan to be a major public health emergency.

Because Wuhan's municipal government initially withheld information and failed to control the virus effectively, about five million residents and temporary workers left the city for the Lunar New Year holidays before the city was officially closed off on January 23. As a result, the virus spread rapidly throughout China and beyond, leading to the current high-profile health international emergency.

Unsurprisingly, economy is slowing down. The services sector, which includes retail, tourism, hotels and transportation, and accounts for more than half of the country's GDP, is suffering severely.

Disruption in sector will in turn affect manufacturing. And growing international concern at the continued spread of the virus might further strain trade and limit the movement of people. But the key question is whether we believe it will last longer.

My answer is no. The coronavirus epidemic is very unlikely to last long. Despite all its problems,



China undoubtedly still has an unparalleled ability to mobilise resources in response to a largescale emergency. During the past two weeks, for example, official efforts aimed at controlling panic have been first-rate.

In addition to ordering a nationwide mobilisation of medical personnel and resources (including from the military), the authorities have been assessing major hospitals' capabilities to diagnose and treat coronavirus patients. More important, as part of a national disease-control campaign announced on January 20, officials are identifying and observing any citizens who had travelled to and from Wuhan since the outbreak began.

Meanwhile, urban communities and rural villages alike have tightened access restrictions in order to reduce unnecessary movements and aggregations of people, even establishing temporary rationing systems to distribute face masks to families and individuals. In addition, holidays have been extended and schools remain closed. By helping to minimize

the public's exposure to the peak of the epidemic, these steps are playing an effective role in curbing the spread of infection. There is a higher probability that the increase in the number of infections will slow in the coming weeks.

It is still too early to assess the full economic impact of the coronavirus outbreak. However, the key factor will not be the epidemic's range or severity, but rather its duration. The sooner the epidemic is over, the quicker China's economy will recover, coronavirus storm passes, given its trend growth. Although

severe control measures will weaken current economic performance, they might help to end the outbreak earlier.

In any case, as both a theoretical and empirical matter, epidemics can cause only short-term economic slowdowns. Having said that, external shocks will significantly alter the Chinese economy's medium- and long-term growth trend. Once the

bounce back and return to its previous course.

Back in 2003, for example, most economists and researchers estimated that the SARS outbreak would lower China's secondquarter GDP growth by about one-fifth, but shave less than 0.5 percentage points off the full-year figure. These forecasts reflected the limited number of regions and sectors affected by SARS, as well as the expectation that the outbreak would last no more than three months.

In the event, secondquarter GDP growth fell by two percentage points, much as expected. At the time, China's economy was expanding by about 10% annually, and the SARSinduced slowdown was quickly offset by subsequent strong growth. So, on a graph of Chinese growth from 2002 to 2007, the impact of the SARS outbreak is not even visible.

Although the scope of the coronavirus outbreak now exceeds that of SARS, its duration is still the key factor for assessing the size of the impact on the economy. Current data suggest that the epidemic will likely reach a turning point in the next two weeks. That would mean China might conquer the virus in the first quarter, which is essential to mitigating the epidemic's impact on overall growth in 2020.

True, China's annual GDP therefore, the economy will growth of just over 6% in the past several years is much slower than at the time of the SARS outbreak. But the Chinese authorities can still ensure a robust recovery through targeted fiscal- and monetary-policy adjustments that support small and medium-sized enterprises and servicesector businesses affected by the coronavirus epidemic.

According to my preliminary estimates, the worst-case scenario is that the epidemic lowers GDP growth in the first quarter by a third or half, leaving the figure 2-3 percentage points lower than in the first quarter of 2019 But if things start to look up in the second quarter, the ensuing rebound will partly offset that drop. And with the necessary macroeconomic policy adjustments in place, economic growth will accelerate again during the second half of the year.

Provided there are no further external shocks, continued policy loosening should limit the full-year decline in GDP growth to 0.5-1 percentage point. That would imply a 5-5.5% fullyear economic expansion in 2020, which is still largely in line with China's current growth trend. But it is not yet clear whether the Chinese government, currently preoccupied with tackling the epidemic, will cut its GDP growth target for this year accordingly.

Indonesia challenges deeply entrenched patriarchal attitudes - due to cultural or religious beliefs - to a lack of government support for legislation that can guarantee their rights and protect them from various forms of violence.

Indonesia, the world's most populous Muslimmajority country, was ranked 85 out of 153 countries in the World Economic Forum's 2020 Gender Gap Index after scoring poorly on economic participation, education and political empowerment.

In a country where conservative values are still widely held, issues around gender inequality, sexuality and related rights are almost never discussed in the public sphere. Media outlets focused on women often only position them as objects and commodities, with content focused on lifestyle, fashion and beauty, without discussing the

issues that empower them. But a Jakarta-based online magazine, Magdalene, is changing the game. The feminist magazine publishes articles in two languages - English and Indonesian - offering new values and perspectives on women and raising a range of issues including religion, politics and social conditions.

"We want to provide quality content and represent women's experiences that are more authentic and inclusive with a gender-based approach," said Magdalene co-founder Devi Asmarani, adding: "We criticize all the practices that have been taken for granted, which perpetuate various

injustices and inequalities." Articles written by Magdalene's journalists and contributors will hardly be encountered in conventional media, such as 'I Like Women and My Mother Wants Me to Suffer Because of It', '6 Feminist Influencers That Will Change The Way You See Yourself and Others' and 'New and Important Sex-Ed Film Shatters

Stereotypes'. They also have a

podcast and even a book, which

was published last year.

Magdalene was co-founded by Asmarani alongside fellow journalists Hera Diani and Karima Anjani in 2013, primarily with a view to promoting gender equality, women's empowerment, pluralism and tolerance. They claim to channel the voices of feminists, pluralists and progressives - or just those who are not afraid to be different in terms of their gender, colour

or sexual preferences. Even though the issues Magdalene's journalists discuss seem heavy, their delivery is light, with language that's easy for ordinary people to understand. Most of their readers are women aged between 18 and 30, but they don't all fall in that demographic.

Magdalene has also attracted some male readers, who make up about 30 per cent of their audience. One of those men is Riza Akbar, who said Magdalene helped him understand gender relations and how he should position himself as a man:

"Magdalene opened my horizons about many things, and it makes me grateful that they exist."

As is common among independent media organisations, Magdalene's most difficult challenge is related to funding. For the first five years, Asmarani and Diani paid their employees' salaries with money from their own pockets. They don't even have a physical

"If it weren't for passion, maybe we would have stopped," said Asmarani, who also works Magdalene's editor-inchief. There are now 12 staff members at the organisation, among them the editorial team,

journalists and apprentices. "The point is that we really lack human resources and funds," said Asmarani, who has been a journalist for more than 20 years.

Magdalene's business model includes merchandise and holding events. They also created a creative agency called Working Room, which writers, editors and designers to create and produce content for individuals and companies. This revenue stream delivers the most funding to Magdalene.

"It's difficult for media like us to survive if we don't have a diverse and strong business model. If we rely on advertising, it certainly won't be able to support us because our traffic is not as much as is the case with other mainstream media." Asmarani said.

Even though the team still struggles to find reliable funding, Magdalene's performance over the past six years of operation did not disappoint. Traffic is around 500,000 users per month. In the past year, since they have been able to work full-time to produce more content, the increase in traffic is almost 200 per cent.

"We can survive because we offer something different: quality. We have loyalists, but that is not enough," said Asmarani, adding: "We must have a good business so that we can be sustainable."

A Magdalene reader, Yani Susanti, said the online magazine has opened her eyes to feminism and gender-related issues. "The issues raised so far by Magdalene cannot be freely discussed in my family and environment. This has become a kind of guidance for me," she noted.

ow effective is the African Union's (AU) policy of choosing a theme each year to drive its agenda across the continent? In 2019 the theme was refugees and finding durable solutions to forced displacement. This year it's about 'Silencing the Guns' and creating conditions that enable development.

Is this exercise merely a question of hosting a range of meetings across the continent, or is there real impact on the ground? Given the vast scope of these themes, it's difficult to see what can realistically be achieved in only one year. Looking back at the 2019 focus provides useful lessons that could help deliver more concrete results on the current and future themes.

Last year's theme of refugees, returnees and internally displaced people achieved results in five areas. A strong

the United Nations (UN) was key to these achievements.

First, it strengthened normative frameworks on forced displacement. South Sudan, Equatorial Guinea and Somalia ratified the AU's Convention for the Protection and Assistance

partnership between the AU and of Internally Displaced Persons in Africa (the Kampala Convention). Although still way behind the goal of achieving universal ratification, it is welcomed. Ratifying treaties doesn't guarantee implementation but it plays an important role in reminding state parties about their respon-

Second, there was a renewed political commitment by some African states. Rwanda and Niger for example have facilitated humanitarian evacuation of 5 506

Fourth, the 2019 theme secretariat was run jointly by the AU and the UN Refugee Agency (UNHCR). It was effective at supporting the coordination of activities, drafting communiqués, and making contact with stakeholders.

stranded African refugees forced displacement in Africa was enhanced. Four continental meetings highlighted the importance of implementing the 1969 Organisation of African Unity Refugee Convention and the Kampala Convention, and called for solidarity and responsibility sharing. Another meeting with the Pan-African Parliament helped

galvanise support.

Gender and youth issues were also emphasised. A dialogue with refugee women was held in June and the 2019 AU Humanitarian Summit focused on gender aspects of forced displacement. Youth consultations were conducted in December 2019.

The effectiveness of the Fifth, awareness about 2019 theme was limited by

two major challenges. First, forced displacement wasn't among Egypt's six priority areas of its chairmanship for 2019. Although it hosted various meetings on the topic, Egypt could have contributed more by allocating resources, designating a focal person in the secretariat, and working more closely with the theme's champion, President Obiang Nguema of Equatorial Guinea.

The second problem was that the theme didn't make a significant contribution to durable solutions, which means local integration, repatriation and resettlement.

Except for the 5 506 humanitarian evacuations by Rwanda and Niger and 48 000 migrant voluntary returnees through the AU-EU-UN Tripartite Task Force, Africa hasn't made any significant move to deal with the 25.2 million displaced people comprising 7.4 million refugees and 17.8 million internally displaced people.

Peddling hope between a rock and a hard place

'n a low growth, low tax revenue, high unemployment economy, further dampened by governing ANC policy flip-flops, delivering a State of the Nation Address lacksquare (Sona) is daunting. It's unclear if on Thursday night President Cyril Ramaphosa will do more than spin hope.

Cosatu's recent, if controversial, push to make government workers' pensions and social savings available to slash Eskom's R450-billion debt (Reporter's Notebook: Cosatu's proposal for PIC-funded R250bn bailout and Eskom's municipal debt take centre stage) may well be mentioned in President Cyril Ramaphosa's State of the Nation Address (Sona), if for no other reason than in support of social compacting.

Social compacts between labour, business and government have been a theme throughout Ramaphosa's speeches over the past two years or so, although more elusive in real-

ity beyond the optics of an investment conference. Yet social compacts, and the municipal district development model are the mainstay of the current five-year Medium-Term Strategic Framework (MTSF), the overarching plan of government to coordinate, implement and account for its actions, plans and programmes to 2024.

State-owned enterprises (SOEs) should definitely get a mention in Thursday's Sona.

But it gets tricky beyond saying SOEs are receiving attention. Unless it's announced, the grapevine has it right: the Unemployment Insurance Fund (UIF), which is running a healthy surplus, could also be tapped to finance struggling

Eskom's rolling power outages have, again, become a daily norm at an estimated cost of R2-billion a day to South Africa's already battered economy that's unlikely to hit even 1%

The Post Office appears in turmoil again, potentially undermining social grant payments, while Denel is struggling to get out of its difficulties. The Passenger Rail Agency of South Africa (Prasa) with its dire audit isn't exactly keeping trains rolling safely and on time.

SAA best illustrates how Ramaphosa's hands are tied - by the factional battles in the governing ANC he leads, by the tripartite alliance politicking and by lack of government balls to stay the course of its decisions.

On 5 December 2019, the government announced that SAA was in business rescue. Since June 2017, the national flag carrier had received at least R15.7-billion in taxpayer-funded bailouts without being able to climb out of its financial and governance turmoil.

"This is the optimal mechanism to restore confidence in SAA and to safeguard the good assets of SAA and help to restructure and reposition the entity into one that is stronger, more sustainable and able to grow and attract an equity partner," said Public Enterprises Minister Pravin Gordhan.

"Our desire is that the restructured airline will mark the beginning of a new era in South African aviation and must be able to bring in millions more tourists into SA, help create more jobs in tourism and related sectors of the economy..."

The ANC National Executive Committee (NEC) lekgotla of January 2020 seemed to be on the same page.

"SAA should be retained as a national airline, which will require substantial restructuring. Cabinet should take the operational decisions needed to achieve that aim," said the official ANC statement of 22 January 2020. It added later: "We must avoid political interference in operational matters, other than interventions in the case of mismanagement and possible company failure."

There was a twist. The government guaranteed the R2billion SAA raised from commercial banks, but did not come to the table with a further R2-billion that the December statement had indicated would be made. Another plan was made.

On 28 January 2020, the Development Bank of Southern Africa (DBSA), another SOE, stepped up with R3.5-billion. DBSA board chairperson Enoch Godongwana, wearing his hat as ANC economic transformation chief at the ANC NEC lekgotla briefing, had hinted at a solution which would be announced later at the appropriate forum.

AngloGold picks Harmony to buy S.African assets

JOHANNESBURG

AngloGold Ashanti picked Harmony Gold as the buyer for its last remaining South African operations, according to people familiar with the matter. The two companies are finalising the exact terms of the deal for the Mponeng mine and surface facilities, said the people, who asked not to be identified because the information is private.

AngloGold is selling the assets as Chief Executive Officer Kelvin Dushnisky focuses on more profitable mines in Ghana, Australia and the Americas. Harmony - backed by billionaire Patrice Motsepe's African Rainbow Minerals - is hunting for deals to replenish declining reserves in South Africa. Harmony paid \$300m for AngloGold's Moab Khotsong mine in 2017. AngloGold spokesperson Chris Nthite declined to comment.

Harmony is looking at potential acquisitions in South Africa and has a plan to finance the deals, Chief Executive Officer Peter Steenkamp said on a conference call Tuesday to discuss the company's half-year results. The company is looking at assets with at least 1 million ounces of reserves and a 10-year life span, he said.

AngloGold's mines could be used as "criteria if we are to evaluate any assets" in South Africa, Steenkamp said. "We understand and we do have the ability and expertise to run underground mines," he said. "We will not necessarily shy away from underground mines."

AngloGold's Mponeng mine, the world's deepest, produced 265 000

ounces of gold in 2018, while output from its surface operations, which extract the precious metal from ore dumps, totaled 171 000 ounces. Those South African assets accounted for about 13% of AngloGold's production

AngloGold said last week it plans to provide an update on the asset sale on February 21. In November, AngloGold narrowed the list of bidders for its South African assets to Harmony and Sibanye Gold, people familiar with the matter said at the time.

The strategic rationale to find a buyer "trumps a straight valuation call" for the operations, said James Bell, an analyst at RBC Capital Markets in London. AngloGold needs to sell the assets before it can move its primary listing from Johannesburg to London, "something that we think could drive a material re-rating in time."

US revokes WTO subsidy preferences for South Africa, other countries

WASHINGTON

Trump administration is changing a key exemption to America's trade-remedy laws to make it easier to penalise about two dozen so-called developing countries including China, India and South

The US on Monday narrowed its internal list of developing and leastdeveloped countries in order to reduce the threshold for triggering a US investigation into whether nations are harming US industries with unfairly subsidised exports, according to a US Trade Representative notice.

In doing so, the US eliminated its special preferences for a list of self-declared developing countries that includes: Albania; Argentina; Armenia; Brazil; Bulgaria; China; Colombia; Costa Rica; Georgia; Hong Kong; India; Indonesia; Kazakhstan; the Kyrgyz Republic; Malaysia; Moldova; Montenegro; North Macedonia; Romania; Singapore; South Africa; South Korea; Thailand; Ukraine; and Vietnam.

USTR said the decision to revise its developing country methodology for countervailing duty investigations was necessary because America's previous guidance - which dates back to 1998 - "is now obsolete."

The development marks a noteworthy departure from two decades of American trade policy regarding developing nations that could result in more stringent penalties for some of the world's top exporters.

The move also reflects President Donald Trump's frustration that large economies like China and India are permitted to receive preferential trade benefits as developing nations at the World Trade Organization.

During his visit to Davos, Switzerland, last month Trump said the WTO hasn't treated America fairly. "China is viewed as a developing nation. India is viewed as a developing nation. We're not viewed as a developing nation. As far as I'm concerned, we're a developing nation, too."

The goal of the WTO's special preferences for developing nations is to help poorer countries reduce poverty, generate employment and integrate themselves into the global trading system. Under WTO rules, governments are required to terminate their countervailing duty investigations if the amount of foreign subsidy is de minimis, which is normally defined as less than 1% ad

But WTO rules provide a different standard for so-called developing nations that requires investigators to terminate duty investigation if the amount of subsidy is less than 2% ad valorem. The Trump administration has sought to end these special preferences for nations that fall under certain categories, like those who are members of global economic clubs like the Group of 20, the OECD or who are classified as high-income nations by the World Bank.

Last July, Trump issued an executive memo that asked US Trade Representative Robert Lighthizer to determine whether there's been "substantial progress" toward limiting the number of countries considered developing nations.

The US may act unilaterally if not, Trump said. Several of the de-listed countries in the USTR notice have already agreed to relinquish their developing-country rights in future trade negotiations, including Brazil, Singapore and South Korea.

SA negotiator is appointed sec general of Africa **Continental** Free Trade Area

ADDIS ABABA

South Africa clinch a massive victory at the African Union's (AU) summit in Ethiopia on Monday after Wamkele Mene was installed as the new secretary-general of the Africa Continental Free Trade Area (AfCFTA).

Mene, who served as the country's chief negotiator at AfCFTA, bested Nigeria's preferred candidate, Cecelia Akintomide, and will be stationed in Accra, Ghana. International Relations and Cooperation Minister Naledi Pandor welcomed Mene's appointment.

The AfCFTA forms part of broader efforts to remove tariffs on up to 90% of exports to foster more trade among countries on the continent as Western countries usually trade more with African nations individually than the latter do with each other.

In October last year, Business Day reported on Mene's criticism of attacks on foreign nationals in South Africa, saying the violence would put South Africa on the backfoot of negotiations around the AfCFTA which the South African economy stood to benefit from.

Mene holds a BA in law from Rhodes University, an LLM in banking law and financial regulation from the London School of Economics and Political Science as well as a Master's of arts in international studies and diplomacy from the School of Oriental and African Studies at the University of London.

Reigniting industrialisation

Speaking at the AU's ordinary session on Sunday, President Cyril Ramaphosa said the AfCFTA would enable the continent to work together through intra-Africa trade and reignite industrialisation and pave the way for Africa's integration into the global economy as a player of considerable scale.

"It is a realisation of a dream of our forebears to see the rich resources of Africa being marshalled for the collective benefit of Africans." Ramaphosa told heads of state the colonial era of Africa being a pit stop for assembly was over.

Speaking on Ghana's readiness to host the headquarters of the AfCFTA, President Akufo Addo said \$3m had been advanced by his government for the establishment and operation of the secretariat. He reiterated Ghana's determination to establish a world class secretariat by the end of March as mandated by the AU's assembly.

Scarcity of abattoirs hurts Rwandan pig farmers

KIGALI

Local farmers have cited the insufficient number of quality pig slaughterhouses as one of the major obstacles to penetrate the local and regional markets

Rwanda has only two standard pig slaughter houses, located in Rubavu and Kicukiro districts, which farmers say are inadequate to handle the growing population of pigs in the country.

Jean Claude Shirimpumpu, the Chairperson of Rwanda Pig Farmers Association (RPFA), revealed that most of the pork sold on the local market comes from pigs that are slaughtered through poor conditions, mainly in banana plantations.

This leads to the production of low quality pork, which can be harmful to people's lives. "Two pig slaughterhouses are not enough to serve the big number of pig farmers," he noted. DR Congo is currently Rwanda's biggest pork market with over 90 per cent of national produce being exported to the country, according to figures National Agriculture from Export Board.

"Pig farmers encounter losses as we export live pigs which we should have processed. Our wish is to export pork as

it is believed to be lucrative," Shirimpumpu said. He went on to request the Government to establish standard abattoirs countrywide.

"It will subsequently boost pork exports and improve the quality of pork that is consumed locally." Rwanda has a population of 1.7 million pigs, and with the number of pigs growing at a rate of 239 per cent, Shirimpumu said, pork production could increase from 20,000 tonnes to 67,000

tonnes every year. **RDB** interventions

John Gatete Kalanze, Sector Capacity Building Analyst at the Rwanda Development Board (RDB), assured that through its five-year strategic plan the Board plans to build standard pig slaughterhouses across the country.

China says Huawei is victim of 'witch -hunt'

LONDON

China just ramped up its rhetoric over Huawei's involvement in Europe's 5G networks. Speaking to the BBC on Sunday, China's ambassador to the UK described British politicians voicing concerns about Huawei's role in the country's 5G network as a "witch hunt.'

A group of six senior Conservative party politicians wrote a letter on Saturday protesting the UK's decision last month to allow Huawei to build "non-core" parts of its 5G network, citing cybersecurity fears.

Sir Iain Duncan Smith, former Conservative party leader and one of the authors of the letter, said: "You have an organisation from a country that is an aggressor in terms of cyber warfare and a company that is clearly totally and utterly in the hands of the Chinese government who demand absolute obedience on these matters.'

Ambassador Liu Xiaoming said the group litical reasons. "Huawei is a private-owned company, nothing to do with the Chinese government. The only problem they have is they are a Chinese company." Liu responded.

The UK's decision to partially include blow to the Trump administration, which

has been lobbying its allies to freeze Huawei out of their 5G equipment entirely on the grounds that the company provides technological "backdoors" for Chinese government espionage. Huawei has repeatedly denied

Boris Johnson and Donald Trump do not see eye-to-eye over Huawei. Multiple US lawmakers including Vice President Mike Pence voiced their outrage at the decision, and President Trump was reportedly "apoplectic" in a phone call with Prime Minister Boris Johnson, at the end of which the US President slammed down the phone. The UK isn't the only European country where Huawei is fighting for recognition. On Sunday the Chinese embassy in Paris warned France against freezing out Huawei in the wake of reports that several French cities might place restrictions on the company.

The embassy appeared to make a veiled threat that any persecution of Huawei could lead to a trade war with major European 5G was unfairly persecuting Huawei for geopo- competitors like Nokia and Ericsson. Turkish Airlines posts increase in load factor, passengers in January

ISTANBUL

Turkish Airlines, which has recently announced the passenger and cargo traffic results for January, recorded 80.6% load factor in this month while its number of international passengers increased with double-digit of 10 percent.

Commenting on the announced numbers, Turkish Airlines Chairman of the Board and the Executive Committee, M. lker Aycı stated, "Our performance during January indicates that we are on point to reach our 2020 goals. The increase in our international passenger numbers once again demonstrates that we are successfully maintaining the course on our goal to be the preferred brand of the globe."

According to January 2020 Traffic Results; International load factor increased by 1,6 percentage points to around 80% and domestic load factor decreased by 0.3 percentage points to around 87% compared to the same month of the last year.

International-to-international transfer passen-

gers (transit passengers) increased by nearly 4% and international passengers excluding international to international transit passengers increased by around 19% compared to the same period of last year. The total number of international passengers increased by 10% in January compared to same month of last year.

In January, we realized increases in the number of passengers in Far East, Africa, Europe, North America and Middle East, by 13.6%, 11.8%, 8.7%, 7.1% and 3.2%, re-

spectively. In January, cargo/ mail volume increased by 8.4%, compared to the same period of 2019. Main contributors to the growth in Cargo/ mail volume are Far East with 19.6 %, Domestic with 12%, Europe with 6.4% and North America with 4.3% increase.



"The virus came at an unexpected moment. Our embassy proposed to take us back to our country but I decided to stay here in Wuhan. I have been here for many years and Wuhan became my second home. I shared with its people happy moments and I am willing to be with them in this difficult situation," Walid said, adding that he has faith in the Chinese government as he knows that they are doing their best to solve the problem.

Hanane Thamik, a Moroccan student in Wuhan University said she decided to stay for many reasons, although many of her compatriots have left.

"By staying here, I want to show to those who think badly about China that I'm not afraid of staying with Chinese people. I'm sure that they will take care of me the same as they take care of Chinese citizens."

Thamik said the university provided her free masks, treatment and three meals a day and the teachers cared a lot about her safety.

Having spent eight years in Wuhan, Sadi Makangila Patrick, a doctoral student majoring in English language and literature at Central China Normal University, also chose to stay.

Africa stands with China to defeat coronavirus

CHINA'S response to the coronavirus has earned praise from the World Health Organization, as well as many countries. The response has also strengthened Africa's solidarity with



The symptoms of coronavirus infection are so common that it took some time to realize that we are dealing with a new virus. But once the new virus was identified, China's response set new standards for the world. Newspaper reports in Africa are praising the scale and speed of the response.

Wuhan's new 1000-bed Huoshenshan hospital covering 60,000 square meters has been built in just 10 days by 7,000 people working 'round the clock. It is now operational. A second hospital with 1,600 beds will open its doors by this coming weekend.

The scale and speed are unmatched anywhere in the world.

To many Africans, what is even more awe inspiring is what is not visible. Translating the idea of a dedicated hospital into blueprints for thousands of components, assembling them into a model, agreeing on specifications and standards, contracting different entities to make or build the components, preparing the site and erecting the hospital about one month after the enemy was identified is a feat in which every citizen of China can take pride.

Equally compelling is convening 1,400 medical specialists to handle intensive care, diagnosis and infection control units with a unity of purpose. The specialists bring skills gained from past battles: fighting SARS, a relative of the new coronavirus, or Ebola virus in Africa. This large team appears to be working with the precision of a military operation.

The Enemy

But coronavirus is also awakening racism. Africans are recalling other global health emergencies.

The 1918 flu pandemic, first detected in the US heartland, affected nearly a third of the world's population. No country or region was blamed for the emergency. No stigma was attached to US citizens. But the 1957 flu that was first identified in Singapore and Hong Kong was quickly labelled "Asian Flu." We must guard against compounding the tragedy of coronavirus with racism or bigotry. The virus is the enemy.

While no cases have been reported in Africa, countries are screening people coming from China. At the same time, China is helping African governments by monitoring Africans in China. So far, there does not appear to be a need to evacuate Africans although a few countries have done so. Moreover, there does not appear to be a necessity for general quarantine of everyone coming from China.

African media is also reporting signs of hope, even as the people of Hubei Province and the city of Wuhan bear the pain of quarantine.

For example, we know that although there are over 20,000 identified cases worldwide and over 400 people have died, near 1,000 have recovered and the rate of recovery is steadily growing. Clearly the medical and health professionals on the frontline, supported by scientists in China and the world are starting to understand the new enemy.

They are inching their way towards a strategy, a set of protocols or procedures for tackling either the coronavirus or associated infections.

Africans are hanging on to this ray of hope. The African continent, country after country, stands in solidarity with China, confident that China has the scientific knowhow and technical capacity to manage this health emergency.

Those like Egypt or South Africa that manufacture medical supplies and equipment have delivered their assistance to China. But for African countries that cannot extend such assistance, goodwill towards China runs deep in Africa - a continent that has pinned its hope for genuine development on the partnership with

Launch of multi-million USD initiative to benefit African women

ADDIS ABABA

AFRICAN leaders are putting women first in efforts to drive the continent's economic growth through the launch of a women-empowerment initiative, dubbed the African Women

Leadership Fund. The ground-breaking partnership, formally signed between the United Nations Economic Commission of Africa (ECA) and the Standard Bank Group in the Ethiopian capital, Addis Ababa, over the weekend, "will be transformational in breaking down structural barriers to inclusive invest-

ing in Africa," the ECA said on Monday. "The launch of the African Women Leadership Fund will provide capital

to both first time and experienced fund managers in support of UN Sustainable Development Goals 5 (Gender Equality) and 8 (Decent Work and Economic Growth), and the African Union Agenda 2063," an ECA statement said.

Over 20 million U.S. dollars was raised for the fund on Saturday toward a goal of 100 million dollars. President Paul Kagame of Rwanda was instrumental in leading the way, pledging 500,000 dollars.

Senegal's President Macky Sall also committed 500,000 dollars. South African President Cyril Ramaphosa also pledged to contribute to the fund. Private sector participants pledged the

Among the world leaders who witnessed the official launch of fund were United Nations Secretary-General Antonio Guterres, AU Commission Chairperson Moussa Faki Mahamat, Ethiopian President Sahle-Work Zewde, and former Liberian President Ellen Johnson Sirleaf.

"We are turning the tables and making women the decision-makers of investable money in Africa," ECA Executive Secretary Vera Songwe said. "We want women to be on the supply side of money, not only on the demand

"The goal here is to give women-led financial investment activities a huge injection of jet fuel to bear out the proven positive correlation between

gender balance, higher financial returns and developmental impact," Songwe said.

The African Women Leadership Fund, among other things, envisages empowering women financial leaders who will drive economic growth, job creation, and create prosperity.

Noting that women-owned funds and businesses in Africa struggle due largely to lack of successful fundraising, insufficient exposure to systems and procedures, and lack of track records, the ECA also stressed that women-owned funds and businesses also contend with "gender-based social expectation, resistance to women in leadership roles and lack of a support network."

"The fund will empower Africa's women by giving them access to financial resources and investment management expertise," the ECA

Sola David-Borha, chief executive of Africa regions at Standard Bank Group, said the fund aligns with the Bank's purpose to drive Africa's growth and "presents an opportunity for Standard Bank to leverage our footprint and expertise on the continent, and the relevant experience of our asset management arms... to

build Africa's economies." "Africa is our home. We drive her growth," David-Borha said.Women fund managers will receive a deployment of capital, and subsequently

AU delays plan to start using fund for security operations

ADDIS ABABA

THE African Union has agreed not to start financing security operations from a new fund until 2023 because it has received fewer contributions than hoped.

The AU, which groups 55 African countries, had hoped to start tapping the fund this year for peacekeeping missions, mediation and conflict prevention on a continent facing severe threats of violence and

But at the end of a summit in the Ethiopian capital Addis Ababa, it decided not to start using the fund yet after it emerged it had less than half of the US\$400 million it had targeted.

The failure to secure as much funding as planned is a new setback to security hopes in Africa following an increase in attacks by Islamist militants in the vast Sahel region of western and north-central

It also follows a drawdown of AU peacekeepers in Somalia as external donors reduce funding, aiming to transfer responsibility to Somali forces.

AU nations have so far raised only US\$164 million, said Donald Kaberuka, the AU's special envoy for the fund.

Fewer than 30 member states have paid their full contributions and five have never paid their annual dues, according to an internal document seen by Reuters.

North African states, including Egypt and Algeria, are challenging their yearly contributions and want Central African states such as Cameroon and Central African Republic to pay more, five AU officials told Reuters on condition of anonymity.

Kaberuka said the decision on how much each country would pay had been postponed until later this year.

"Most countries do agree about the financing mechanism," he said, adding that "for those who disagree we have until July 2020 to find a solution."

FURTHER DELAYS AHEAD?

Prolonged disagreements on how much each member state provides could cause further delays for the fund in the

"The AU is trying to be more self-sufficient, less reliant on donors," said Elissa Jobson, Director of Africa Regional Advocacy for the International Crisis Group think tank. "This delays that process."

But a senior AU official told reporters the huge threat posed to Africa by violence and terrorism, and governments' inadequate resources to tackle them, means more international support is needed.

"We still need first for the United Nations Security Council to take its responsibilities and the rest of the international community not to let down Africa," said Smail Chergui, commissioner of the AU's Peace and Security Council. Xinhua

2019-nCoV outbreak in China only poses temporary economic difficulty - expert

RIO DE JANEIRO

THE novel coronavirus outbreak in China is only a temporary difficulty, and China will find a solution, said Hsia Hua Sheng, Associate Professor of Finance at São Paulo School of Business Administration.

"Even with this temporary difficulty, China is still one of the most competitive countries in the world, "Hsia told People's Daily.

"On the one hand, we can see the effort and determination of the government into financial services. For

example, the Chinese central bank injected 1.7 trillion yuan (\$244.12 billion) through reverse repos into the market earlier this week, demonstrating its determination to stabilize market expectations and boost market confidence."

He added, "on the other hand, the collaboration of all the Chinese people to overcome this temporary virus is very positive," noting that the creativity of China's skilled workers helps to create a digital solution to combat the coronavirus with the Chinese government.

He said that the role of China in the

global economy is very important. "The temporary slowdown of Chinese consumption in and out of China (for example, tourism) will affect the GDP negatively of major tourism oriented countries.'

"This problem will also affect global production activities, like the automotive industry," said Hsia, adding many multinational firms have to stop their production outside of China because of the lack of components made in China as China has a huge relevance in the global supply chain.

Trump says call for 7-9 years prison term for adviser Stone is 'horrible'

WASHINGTON

U.S. President Donald Trump described a demand by prosecutors on Monday for a federal judge to sentence his longtime adviser Roger Stone to 7-9 years in prison as "horrible and very unfair" and said such a "miscarriage of justice" should not be allowed.

Stone (pictured) is due to face sentencing by U.S. District Court Judge Amy Berman Jackson on Feb. 20, after a jury in November found the self-proclaimed "dirty trickster" guilty on seven counts of lying to Congress, obstruction and witness tampering.

The government said that under U.S. sentencing guidelines, he faces a range of seven years and three months to up to nine years, and told Jackson he "should be punished in accord" with those. Such a term would "accurately reflect the seriousness of his crimes and promote respect for the law".

Stone is one of several people close to Trump who faced charges stemming from then-Special Counsel Robert Mueller's investigation into Russian interference in the 2016 presidential election.

"This is a horrible and very unfair situation. The real crimes were on the other side, as nothing happens to them. Cannot allow this miscarriage of justice!" Trump said on Twitter here after midnight on Monday.

Trump has the power to pardon people for federal crimes, although he has yet to use it in the cases of other former aides convicted in the wake of the Mueller investigations.

During the trial, prosecutors pressed their case that Stone lied to lawmakers about his outreach to WikiLeaks - the website that disclosed many hacked Democratic emails ahead of the 2016 U.S. election that proved embarrassing to Trump's Democratic opponent Hillary Clinton - to protect Trump from looking bad.

Stone, who has labeled himself an "agent provocateur" and has the face of former President Richard Nixon tattooed on his back, was charged with obstructing justice, witness tampering and lying to the U.S. House of Representatives' Intelligence Committee during its investigation into Russian election interference.

Stone's colorful trial featured references to the film "The Godfather Part II." an impression of Senator Bernie Sanders by prosecution witness Randy Credico, and testimony by political heavyweights including former Trump campaign chief executive Steve Bannon and former Trump deputy campaign chairman Rick Gates.

Those witnesses said they believed Stone had inside information about when WikiLeaks might release more damaging emails about Clinton. In truth, he had no such information.

Stone was also accused of tampering with Credico's testimony, when Credico was summoned to testify before Congress and speak with the FBI. In emails and texts, Stone told Credico among other things: "Prepare to die," "You're a rat. A stoolie," and "Stonewall it."

Trump's US\$4.8t budget gets chilly reception from Congress

WASHINGTON

US President Donald Trump's US\$4.8 trillion budget plan for the coming fiscal year drew a prompt rejection on Monday from congressional Democrats, who said it betrayed his promise to protect popular health and safety-net programs.

The White House presented the budget as a blueprint for the president's policy priorities. It includes funding to build a wall on the US border with Mexico and fight the opioid crisis, but cuts billions of dollars from safety net programs under the banner of welfare reform.

The budget is largely a political document that serves as a starting point for negotiations with Congress. With an eye toward reducing debt and deficits, Trump once again proposed steep cuts to housing, environmental, transportation and other programs that have been rejected by lawmakers in past years.

"We're going to keep proposing these types of budgets and hope that at some point Congress will have some sense of fiscal sanity and join us in trying to tackle our debt and deficits," Russ Vought, acting director of the White House Office of Management and Budget, told reporters.

Democrats said Trump's proposal upended his promise in last week's State of the Union speech to "always protect" the popular Social Security pension plan and the Medicare health plan for seniors.

"Americans' quality, affordable health care will never be safe with President Trump," said House Speaker Nancy Pelosi.

"Everyone knows the latest Trump budget is dead on arrival in Congress," said Sheldon Whitehouse, a Democrat on the Senate Budget Committee.

Trump's budget would reduce Medicare spending by lowering drug costs and tightening eligibility requirements for Social Security's disability program.

It also would enact new work requirements for people who get food stamps or use the Medicaid health plan for the poor.



Last year Trump signed a two-year Vought said those figures were based budget deal with Congress that increased federal spending on defense and several other domestic programs, adding to a growing government debt.

Trump's proposed military spending adheres to that plan. But his proposed spending for domestic agencies, like the Education Department and the Environmental Protection Agency, is 6 percent below the US\$635 billion outlined in that agreement.

Senate Budget Committee Chairman Mike Enzi, a Republican, said earlier this year that he intends to stick to the spending levels in the congressional budget deal, which would in effect ignore Trump's proposed domestic spending cuts.

GROWTH PROJECTIONS

Trump's proposed budget for fiscal 2021 includes US\$2 billion to fund further construction on the border wall with Mexico, a project that is especially popular with his political base, and funding for an infrastructure bill that is unlikely to be passed by Democrats and Republicans in Congress.

It forecasts US\$4.6 trillion in deficit reduction over 10 years and assumes economic growth at an annual rate of roughly 3 percent for years to come.

The economic projections are optimistic. The Congressional Budget Office predicts the US economy will grow 2.2 percent in the current fiscal year, which ends Sept. 30, and grow less than 2.0 percent in future years.

The economy grew 2.3 percent in calendar year 2019.

Trump has taken credit for the strength of the US economy thanks in part to tax cuts he championed and Congress passed earlier in his term.

The White House proposal slashes spending by US\$4.4 trillion over 10 years, and aims to reduce the deficit by US\$4.6 trillion in that time period. While Trump campaigned on a

promise of eventually eliminating the country's huge debt, each year of his plan projects significant budget deficits that actually would add to the US\$22 trillion debt.

This year's deficit will hover at around US\$1 trillion and decline next year to US\$966 billion if his plan were to be enacted. Even so, over 10 years, deficits would add US\$5.6 trillion to the debt, not counting interest pay-

'Never happened': Model denies trapping Weinstein accuser

IN the strongest defense testimony yet, a counters were consensual. Weinstein accuser's claim that she stood by and did nothing while the once-powerful movie mogul sexually assaulted the woman at a Beverly Hills hotel in 2013.

"Never happened," Claudia Salinas told jurors Monday at Weinstein's rape trial in New York City, forcefully repudiating model Lauren Marie Young's testimony last week.

Young testified that Salinas closed the door behind her and Weinstein as they went into the bathroom, where she alleges he stripped off his clothes, grabbed her breast and masturbated. Once it was over, Young said she found Salinas standing outside the bathroom and shot her an evil look before leaving as quickly as she could.

"If I had done that, I would remember that," Salinas testified. "I would never close the door on anybody.'

Salinas, now working as a social media influencer, took the witness stand as the defense called witnesses for a third day after more than two weeks of prosecution testimony. Among the prosecution witnesses were six women, including Young, who say the once-powerful Hollywood boss subjected them to vile sexual behavior.

"My name has been used in a disparaging way. Ms. Young's testimony that I've heard in the media is fictitious and flat out untrue," Salinas said in a statement sent to The Associated Press after she testified. "Under no circumstances would I ever have anything to do with an assault on a human being. This accusation was a vicious attack on my reputation."

The biggest remaining question at the landmark #MeToo trial is whether Weinstein will testify. Weinstein declined to answer a reporter's question about it as he left court on Monday, deferring to lawyer Arthur Aidala who declared: "It was a great day for the defense today."

Weinstein's lawyers say no decision has been made on whether he will take the stand. Weinstein, 67, is charged with raping a woman in a Manhattan hotel room in 2013 and forcibly performing oral sex on a different woman in 2006, but other accusers, such as Young, were called as witnesses as part of a prosecution effort to show he has used the same tactics to victimize many women over

Young's allegations were included in criminal charges filed against Weinstein in California on Jan. 6, just as his New York case was

Weinstein has maintained any sexual en-

Mexican model on Monday denied a Harvey Salinas met Weinstein in 2003, she said, and appeared in his 2009 film "Crossing Over" with Harrison Ford. She said she never had a romantic relationship with Weinstein, adding that he had a "very strong personality" and "at times, he wasn't nice to me."

Salinas disputed other parts of Young's account, saying that while they did meet up at the hotel the night of the alleged assault, it wasn't because Weinstein wanted to see her.

Asked on cross-examination if she told investigators last year that it was possible Weinstein took Young to the hotel room, Salinas replied: "What's true is that I wasn't there in a bathroom scenario. It could have happened but it didn't mean I was there."

Jurors also heard Monday from the former roommate of the woman Weinstein is on trial for allegedly raping. Talita Maia said that the woman spoke highly of Weinstein and once called him her "spiritual soulmate."

Maia, a Brazilian actress who lived with the woman in the Los Angeles area, was with her on the New York trip and said nothing seemed amiss when they met Weinstein for breakfast after the alleged rape.

The accuser testified last week that she didn't tell anybody what happened but was "pretty shut down" at breakfast.

"Did she seem like herself to you?" Weinstein lawyer Donna Rotunno asked.

"Yes," Maia responded.

Maia said she was testifying in response to a defense subpoena, telling jurors: "I don't want to be here at all." On cross-examination, she testified the two women had a falling out in 2016, but added, "I don't hate her or anything like that."

The Associated Press has a policy of not publishing the names of sexual assault accusers without their consent. It is withholding name of the rape accuser because it isn't clear if she wishes to be identified publicly.

Maia said she and the woman met Weinstein at a Hollywood party a few months before the alleged rape and that she believed the woman and Weinstein were in a relationship at some point and had stayed friends afterward.

Maia said she initially didn't know who Weinstein was, but once she found out he was a Hollywood bigshot, she teased him by saying "that's why everybody is being so nice to you.'

Maia said the woman she was summoned to testify about put her arm around Weinstein and said: "No. It's because he's so cute." AP

BRAZIL legend Pele is depressed over his poor health and reluctant to leave the house because he cannot walk unaided, his son Edinho said in an interview published in Brazil on Monday.

Pele, widely considered to be one of the greatest footballers in history and the only player to win three World Cups, spent most of his career with Brazilian team Santos before moving to New York Cosmos in the 1970s.

He will be 80 in October and has had hip trouble for years, which led to him now needing a frame to walk. Many of his recent public appearances have been in a wheelchair.

"He's pretty fragile," Edinho told TV Globo. "He had a hip replacement and didn't have an adequate or ideal rehabilitation.

"So he has this problem with

mobility and that has set off a kind of depression. Imagine, he's the king, he was always such an imposing figure and today he can't walk properly.

"He's embarrassed, he doesn't want to go out, be seen, or do practically anything that involves leaving the house. He is very sheepish, reclusive."

Edinho said he had argued with his father because he had not done the physiotherapy called for after a hip operation.

In April, Pele spent time in the American Hospital in Paris as he was being treated for a urinary infection.

IOSE Mourinho; magician or myth? Special One or Incredible Sulk? His success, or lack thereof, at Tottenham Hotspur might settle a few arguments, but either way, he remains the world's most talked-about manager, which is the way he has always liked

Mourinho was refreshed by the sabbatical he took after a less-thanstellar spell at Manchester United, but you sense he missed the spotlight, the daily cut and thrust with the media. Now it has got to the point where his reputation as a "born winner" needs a coat of paint. Perhaps he needs to prove that he is not yesterday's man in a Premier League era dominated by Jurgen Klopp and Pep Guardiola's attacking styles.

Mourinho would no doubt scoff at that suggestion and point to his creaking trophy cabinet, which includes Champions League wins in 2004 and 2010, plus eight league titles -- in four different countries -among 20 pieces of silverware.

He might also remind you that his first title, in 2004-05 with Chelsea, was won with two exciting wingers in Arien Robben and Damien Duff. He might add that his Real Madrid team scored more than 100 league goals in each of his three seasons at the Ber-

But a decade-and-a-half since he enchanted us in those early days at Stamford Bridge, has the charmer become a surly dinosaur?

In the opening honeymoon weeks at Tottenham, it almost seemed as if Mourinho was trying to reinvent

Which Liverpool star deserves to be Footballer of the Year?

THERE are two certainties between now and the end of the Premier League season: The first is that Liverpool will end a 30-year wait to be crowned champions of England and the second is that, when league-wide player of the year awards are handed out, the winner will come from Jurgen Klopp's all-conquering team.

That is not to downplay Kevin De Bruyne's contribution at Manchester City, because the Belgium international has been outstanding for Pep Guardiola's side. However, even if last season's domestic treble winners end this campaign with another three trophies -- the Carabao Cup, FA Cup and Champions League -- the best and most influential players have unquestionably plied their trade at Anfield.

It is has become a question of which Liverpool player is crowned, rather than if one of them wins, but how do you separate the contenders?

Alisson has been outstanding in goal, Virgil van Dijk has once again been a colossus at centre-half, and both full-backs, Trent Alexander-Arnold and Andy Robertson, have been, by some distance, the best in their position in England and, arguably, the Champions League.

Fabinho has become a crucial cog in Klopp's midfield; up front, Roberto Firmino has developed into one of the best centre-forwards in the game, while Sadio Mane and Mohamed Salah have scored 25 league goals between them to shoot Liverpool 22 points clear at the top of the table.

In recent weeks, captain Jordan Henderson has emerged as a leading candidate because of his increasing importance and is favourite with the bookmakers to win PFA Player of the Year, voted for by his professional peers, ahead of Mane and Van Diik.

He is not prolific in terms of scoring or assists, but lifting the European Cup last season seems to have injected Henderson with new-found confidence and belief, after it initially appeared he would have something of an impossible job to live up to the iconic status of his predecessor Steven Gerrard.

Nobody questions the 29-year-old's credentials anymore and that is testament to the former Sunderland player's impact, particularly over the past 18 months.

Despite Henderson's impressive season, though, he is not the obvious choice for individual honours. If you take him out of the Liverpool team, his qualities will be missed, but with Fabinho, James Milner, Geor-

FIFA eager to promote women, junior soccer

THE Federation of International Football Associations(FIFA) has said it is committed to promoting junior and women football among all its member associations.

The world soccer governing body's new regulations released recently are part of Forward 2.0 program seeking to ensure that member associations do not concentrate on senior national teams at the expense

In a bid to curb the problem of overlooking youth football, FIFA has introduced tough funding regulations in which member associations will be forfeiting a good chunk of funding if they do not participate in junior

The FIFA funding for each member associations is at \$1 million per year with \$500 000 allocated to administration while another \$500 000 is for specific

"Such activities include organizing men's, women's and youth competitions (two age groups for both girls and boys)," FIFA noted in its communique to member

"Each competition should involve at least 10 clubs for at least 90 matches and for at least six months each year and having active junior men's and women national teams, each one participating in at least four matches per year."

Failure to fulfil the activities will lead to FIFA deducting \$50 000 from the special activities funding.

There was no immediate comments from either Tanzania Football Federation (TFF) Secretary General, Wilfred Kidao, or the federation's information officer, Clifford Ndimbo, on the federation's readiness to implement the FIFA regulations as the officials' phones

However, the TFF current leadership seems to have put much emphasis on beach football and youth football for both men and women as there are sound and active junior national teams.

Almost all elite clubs in the country as well have female teams, which are participating in the Women

The country's junior national teams, Serengeti Boys and Ngorongoro Heroes, as well as women teams of all age groups, were all active last year competing at different continental events.

MOROGORO Municipal Council has set up charges for people that organize festivals in residential area with a view to curbing moral

The council's Cultural Officer, Sophia Kingwahi, disclosed the development in the region last weekend during the presentation of her office's budget estimates for the 2020/21 financial year.

Sophia disclosed festivals held in residential areas are charged a much higher fee, given they are associated with moral decay.

The official was responding to a question tabled by Elizeus Rwegasira, Chama cha Demokrasia na Maendeleo (CHADEMA)'s district's secretary, on why residential areas' festivals are charged 50,000/- per one event while people hosting festivals in halls pay 20,000/- per event..

"In 2019 events hosted in residential areas were not charged but, as there is an increase in cases of people dancing indecently in public, the Municipal Council introduced by-law on the issue," Sophia noted.

"Over five women were nabbed for dancing indecently in public in 2019, the situation forced the regional authority to come up with new solution for it," she disclosed.

She said the municipal's Culture Department works under National Arts Council of Tanzania (BASATA), which has been tasked with approving entertainment events, which take place across the country.


"Military reserves will conduct patrols tirelessly and people, who will be found misbehaving in events, will be punished as per the laws," she
