Z'bar seeks investors in renewable energy

ZANZIBAR welcomes investors in clean energy sources especially solar power to reach people in remote areas of the archipelago, a top official has stated.

Dr Mgereza Mzee Miraji, the permanent secretary for Energy, made this observation in Dar es Salaam yesterday, during the winding up of a three-day energy access investment forum, organized by the Alliance for Rural Electrification (ARE).

The government had opted for solar power in remote areas to avoid costs of grid extension, as the power is mainly for household needs.

"I would like to use this Forum to make a dedicated call to investors in the clean energy sector to come to Zanzibar and invest in solar plants projects as consumers increase in remote areas of the islands," he said.

The Zanzibar Energy Sector Transformation and Access (ZESTA) programme has since last December rolled out an 18 megawatt solar energy project billed at \$142m, he affirmed, elaborating that the World Bank funded project is set for completion in 2026.

ZESTA is expected to connect 308,000 households in Unguja Island, the most important solar project to be implemented in Zanzibar, he stated. Over 50 percent of households in remote areas are far connected to solar energy.

So far 130 kilowatt solar energy is being generated through the Zanzibar Energy Sector Support Project which ended nearly two months ago, he said, outlining efforts to connect households to clean energy sources.

The project dating from 2016 was intended to supply 80 kilowatt power to households in Njau Island and a further 50 kilowatt supply to households in Kokota Island in Pemba.

Norway disbursed NK 470,000 (Norwegian kroner) for its implementation, via the Zanzibar Electricity Corporation (ZECO). More investments in solar energy sources will enable most people in rural Zanzibar to have access to reliable energy, he added.

More households leave Ngorongoro

• As PM Majaliwa spoke, 25 households were embarking on their journey

PRIME Minister Kassim Majaliwa has said the voluntary relocation of people from the Ngorongoro Conservation Area (NCA)

was proceeding well with 293 households harbouring 1,497 people agreeing to move and restart at Msomera area in Handeni

District, Tanga Region. This follows accords involving onservation agencies, the residents and regional authorities in meetings held in Loliondo and Ngorongoro divisions, which the premier followed closely.

Adjourning the marathon Budget meeting of the National Assembly yesterday, premier Majaliwa said the households are being provided with food for three months, with allowance to cover their needs, and a supply of mattresses.

"Today, June 30, a total of 25 households of 105 people are on their way to Msomera, moving with their livestock, while others will continue to arrive in phases," he told an enthusiastic chamber.

He said the objective of this operation from the outset was to ensure that those being settled here will find better standards of social services.

He said that 103 houses have been already constructed and 400 more houses are in TURN TO PAGE 2

THE government has said it is working on plans to enable local companies to compete in tenders for bulk importation of fuel.

Erasto Mulokozi, acting executive director for the Petroleum Bulk Procurement Agency (PBPA), told journalists in Dar es Salaam yesterday that the government was consulting with major commercial banks to enable local companies to borrow and participate in the bidding.

He was conducting the bidding to get winners of tenders for fuel importation for August, where he stated that local companies lack the levels of capital required. "Now we want banks to form syndicates which will extend capital to local companies to facilitate bidding for fuel importation," he said.

A total of 480,000 tonnes of fuel, sufficient up to mid-October for all kinds of fuel needs like diesel, petrol, jet fuel and kerosene was on the bidding, he said, noting that world fuel prices rose from \$700 per tonne back in December to \$1,200 per tonne at present, touching off a spate of price increases pushing the government to intervene.

The price of fuel quoted by companies winning tenders changed from \$62 per tonne earlier to \$99 at present, the floor prices available in world markets, he said.

Bulk procurement started in January 2012 to mitigate supply and price unpredictability in the matter, showing a positive impact since then. It curbs excess costs in fuel imports, enables retail price control and curbing supply cartels and smuggling.

A study by the University of Dar es Salaam showed that the system enabled a significant reduction in fuel prices, along with increased tax compliance and retail trade


RAS, DAS told to scrutinise school joining instructions

ADMINISTRATIVE secretaries at the regional and district level will henceforth have to check and approve joining instructions for those selected to join secondary schools, to check abusive contributions that the government wants them stopped immediately.

Prime Minister Kassim Majaliwa issued this directive yesterday when adjourning the Budget session of the National Assembly, reacting to observations by MOs on the burden of contributions as undermining the government policy of free education.

The premier explained that most of the areas where contributions are supposed to cover, including electricity or paying guards are in



actual fact budgeted for in what the schools obtain from the government.

Regional and district secretariats will have to do more to monitor the use of funds directed to schools by the government, tasking the President's Office (Regional Administration and Local Governments) to work closely with the regional and district secretariats to monitor the use of the government stipend.

This is tied up with ensuring that no arbitrary contributions are demanded from students, pointing out that the government has been delivering funds directly into primary and secondary schools' accounts to cover learning and teaching tools, renovations, internal examinations and administration. Parents should not be charged to cover these needs, he stated.

Up to 10 percent of the stipend is used to fund electricity, water and security services, so no one is required to be charged to cover the same.

Emphasizing on the proper use of disbursed funds, the premier underlined that the government had decided to remove school fees

with good intention to facilitate education for all. On Wednesday, when closing the question and answer session in the House, Deputy Speaker Mussa Azzan Zungu cautioned that despite

formal abolition of fees in primary and secondary education, parents still have to find multiple contributions for the children to attend school.

He said that these contributions hurt parents, and puts at issue the sincerity of the government in removing school fees at all levels.

"Parents were expected to feel

actual relief from implementation of

the free education policy, but they are burdened with contributions to cover expenses of school supplies, food, power, employing guards and other costs," he stated, a situation which routinely compels poor parents to beg that their children remain in school.

District councils have the ability to cover such expenses but they shift the responsibility to parents, he stated, wondering why the responsible ministry was allowing them to do so.

Preparations of formulation of national policy on project monitoring and evaluation is ongoing, PM informs MPs

THE government has started preparations for the formulation of a national policy on monitoring and evaluation which will help closer control of spending and supervision of various projects in the country, the House heard yesterday.

Prime Minister Kassim Majaliwa revealed this yesterday when adjourning the Parliamentary Budget session.

According to him, once completed, the policy will help to further strengthen transparency and efficiency in implementation of all development

"We are doing this by engaging regulatory bodies responsible for monitoring and evaluation so as to analyze the areas they oversee and ensure all key areas are included including the management of development plans," he said.

He said in line with this, the government has already finalized the National Development Projects Management System which will come into effect in July, 2022 where among other things, will assist the government to strengthen monitoring and evaluation in the implementation of development projects and thus increase productivity and value for public spending on relevant projects.

The premier further said the government has also streamlined the structure and allocation of responsibilities of the office of the prime minister especially in terms of policy, coordination and parliament so as to strengthen the role of monitoring and evaluation.

"The aim is to ensure that monitoring and evaluation reports from government ministries and institutions are thoroughly analyzed as well as provide feedback on government performance," he added.

"I call on the Minister of State. President's Office, Public Service Management and Good Governance to work closely with the President's Office (Regional Administration and Local Governments, and the Ministry of Finance and Planning to address the shortage of monitoring and evaluation staff," he said.

The premier also said that preparation of the 2022 national Population and Housing Census had reached 87percent where the pilot census has already been conducted and proved futile.

He said the government works to ensure no one is left behind in this important exercise calling on the lawmakers to also support the exercise by educating the citizens.

He also said that implementation of the residential address exercise is progressing well and had reached 95

The prime minister however wanted responsible ministries and authorities to continue supervising well the $exercise\,which\,include\,addressing\,land$ conflicts which have occurred during the implantation of the programme.

Speaking yesterday after swearing in the new Chief of Defence Forces General Jacob John Mkunda as new CDF and Lieutenant General Salum Haji Othman as new Chief of Staff at State House, president Samia said the new tasks will be announced by the Chief Secretary anytime soon.

"You have served the army with dedication, and you are retiring but very strong, we will still use you in fact I have directed the chief Secretary to let the public know your new tasks anytime soon," he said.

The Head of State said in her brief speech that she will have close talks with the new army leaders saying they ought to start from where their predecessors had stopped.

President Samia on Wednesday, appointed General Mkunda as new CDF. Prior to the new appointment Mkunda was the Chief of Operations and Training at TPDF headquarters.

A statement issued by the Directorate of Presidential Communication at State

House in Dar es Salaam said General Mkunda replaces outgoing CDF General Venance Mabeyo.

Gen Mkunda replaced Gen Mabeyo after the latter has reached his statutory retirement age.

At the same time, President Samia promoted Major General Salum Haji Othman to Lieutenant General and appointed him as new Chief of Staff of the Tanzania People's Defence Forces

Prior to the appointment, Othman was Commissioner for Research and Military Development at the Defence and National Service ministry.

various stages of construction so as to ensure that all the residents are well accommodated.

Building residential houses and putting up other services in the new area was apace, each house having three acres of land. Pasture areas have been set aside along with cattle dips, farming areas and adequate water sources, he stated.

There is also a primary school and a secondary school, a dispensary and supporting infrastructure to ensure that the families start conducting income generating activities upon arrival, he elaborated.

The government was covering costs of the ongoing relocation exercise, sending buses and trucks to carry people and their belongings, they are leaving in Ngorongoro, he said.



Govt mulls revising laws, policies and regulations governing PwDs

THE government plans to review laws, policies and regulations relating to people with disabilities in effort to enable them fully access their rights, it has been revealed.

It also intends to soon start visiting the private sector employers to see if they comply with the requirements for the people with disabilities at work places.

Deputy Minister of State, Prime Minister's Office (Labour, Youth, Employment and People with Disabilities), Patrobas Katambi made the statement here, adding that while the law is quite clear, some employers fringe people with disabilities of their rights. He said while the Persons with Disabilities Act, No 9 of 2010 clearly stipulate the rights, most employers do not adhere to it, adding that even some offices do not have friendly infrastructures and equipment.

Speaking while officiating the opening of a meeting to discuss challenges facing people with disabilities in public offices, the deputy minister stressed that the push to revisit matters of PWDs is spearheaded by President Samia Suluhu Hassan.

The meeting convened by Ikupa Trust Fund brought together over 150 people with disabilities from across the country to discuss challenges facing them.

He said the president has directed the ministry to do all the needful to help solve challenges facing PWDs.

According to the deputy minister, it is on that spirit that she has approved a 3bn/budget for the renovation of colleges of people with disabilities and similar amount for construction of two new ones in Mwanza and Kigoma.

"Leaders at all levels including local government authorities should implement the people with disabilities act failure of which tantamount to discrimination" said Katambi.

He added that the government considers establishing special fund for the support of people with disabilities in the country.

Earlier, the chairperson, workers with disability group, Hamisi Sekejo, procurement officer at the Tanzania Electric Supply Company (TANESCO) in Mtera aired several challenges facing PWDs at work.

He cited lack of support equipment and infrastructure in most public offices, negative perception that PWDs should be given light duties or easy tasks and lack of database of people with disabilities, their levels of education and expertise.

Other challenges, he said include lack of experts to empower PWDs to cope and benefit at different environments in the country and the need for special allowances to enable them attend training, seminars and


This, he said should enable them pay for upkeep of their assistants.

US agency extends food donation to two refugee camps in Kigoma region

THE United States Embassy in Tanzania through its International Development Agency (USAID) has provided a food donation to serve for refugee camps in the Kigoma region.

The donation of 12,000 metric tonnes of fortified maize flour worth U\$9million (20bn/-) was handled over to the United Nations World Food Programme (WFP) office in Dar es Salaam yesterday to be supplied to refugees in the Nyarugusu and Nduta camps in Kigoma Region.

Receiving the donation, apart from thanking the USAID, WFP Country Director and Representative Sarah Gordon-Gibson declared that WFP Tanzania has faced significant funding shortfalls since 2020 when rations had to be reduced to 68 percent of the minimum required needs.

"We are grateful for this continued and timely assistance from the US. This contribution is critical not only because of the value of food going to refugees but also because of the economic impact it will make to Tanzania through the local procurement of food," said Sarah.

According to her, prolonged ration cuts compromise refugees' food consumption, nutrition and health. Despite the new donation, she said, WFP is still unable to provide full rations for refugees due to chronic funding shortages related to the scale and number of humanitarian crises globally.

She asserted that USAID is the largest donor to WFP's refugee operation in Tanzania, providing approximately one-third of its annual refugee budget. WFP had in February this year received a donation worth U\$4million from the USAID for related purposes.

In his remarks at the event, the United States Ambassador to Tanzania, Dr Donald Wright urged the government

to ensure that the humanitarian needs of all vulnerable migrants in-country

"Problems such as lack of access to better livelihood opportunities, limited healthcare and education services and malnutrition are exacerbated by instability and rises in prices as a result of Russia's unjust invasion of Ukraine.

The invasion has largely contributed to straining global food supplies, increasing fuel prices, and making the lives of refugees residing in Tanzania more expensive," said Wright.

According to him, the donation will make it possible for the WFP to provide an estimated 204,000 refugees in Nyarugusu and Nduta camps.

WFP provides each refugee with a monthly food basket containing fortified maize flour, pulses, vegetable oil and salt. It further provides nutritional assistance to pregnant and lactating women and children under five years old.

70 students cheat death in fire accident

ATLEAST 70 students of Bwiru Boys Secondary School in Ilemela District, Mwanza Region have escaped death following a blaze that destroyed their dormitory at around 9:00 pm Wednesday night.

Mwanza Regional Commissioner, Robert Gabriel calmed the students saying the regional government will make sure they get all their items that were destroyed by the fire for them to continue with their lessons.

security organs are here, warn the students that the building has fallen apart due to great pressure at the top, hence it is not fit for use, investigations have to be conducted to know the cause of the fire thereafter we will demolish it," the RC said, adding that the students will be provided with all their belongings destroyed by the fire.

Commenting on the incident on behalf of fellow student, Jamal Iddy

"Just calm down, defence and homework, they heard the ring of the emergency bell and when they went out they saw fire engulfing their dormitory

"So far we do not know the cause of the blaze," Jamal said.

Meanwhile, Mwanza Regional Fire Brigade and Rescue Services Commander Ambwene Mwakibete explained that there was no death from the incident and that after receiving the report they took immediate steps to extinguish it said when they were in class doing so that it does not spread to other

He said they are conducting investigations to identify the cause of the blaze; the fire destroyed the building and students' belongings including books, clothing, beds and mattresses.

"The school has a total of 11 dormitories, we succeeded to put down the fire so that it did not spread to other buildings, no one was hurt as at that time the students were awake, in class doing homework," said Mwakibete.

149,000 students benefit from free mosquito nets

MORE than 149,000 primary school students in Songwe Region are to benefit with distribution of free mosquito nets that aims to reduce malaria infections in the region.

The launch of the exercise, held at Mlowo Town, Mbozi District on Wednesday was officiated by Songwe Regional Commissioner, Omary Mgumba who called on teachers, parents and other stakeholders not to use the nets for fishing or as covers for their vegetable gardens and threatened stern action for those found to do so.

students to benefit are those from STD I to VII and added that every primary school in the region will get the nets and called on teachers to distribute them to every student.

"We have decided to start with primary school students because these are future adults hence it is better to educate them now on the correct use of mosquito nets," Mgumba said.

He said the research done in 2017 found out the malaria prevalence for Songwe Region was under one per cent while nationally it was seven per cent and called on the region's residents to continue taking precautionary Mgumba said in the programme measures against the killer disease.

He said the government's aim is to attain 3 per cent prevalence nationally by 2025 and to completely eradicate it by 2030; hence the government has embarked on distributing the nets through various groups including

Ministry of Health representative from malaria control division, Peter Gitarya said distribution of the nets will be conducted by the Medical Stores Department (MSD) to primary schools.

Gitarya warned teachers not to involve themselves in mosquito nets theft and called on parents and guardians not to sell the nets as they are solely for the campaign to eradicate malaria. In the same vein, Yonas Alfred, speaking at the event on behalf of residents of Songwe Region called for the support of the government and abides by the correct use of the nets.

TANZANIAN men have been encouraged to go for Covid-19 vaccination as the jabs are safe and have nothing to do with causing male impotence if they're inoculated.

Dr Baraka Nzobo, a public health specialist in the Ministry of Health made the call here recently when speaking during a capacity building workshop aimed at helping the government mobilise the community Covid-19, get organised by Farm Radio International (FRI).

The seminar involved journalists from various radio stations in Dodoma.

He said the community has no reason to avoid getting the Covid-19 jabs, which does not have any side effects other than going to boost the body's immune system to fight various diseases.

"Weurgethecommunity to come forward to go for Covid-19 vaccines that are recognized by the government, do not be deceived by the misconceptions about it," said Dr Nzobo.

He cited some of the misconceptions mislead the society that if they go for Covid-19 vaccines they will get children with cerebral palsy, and someone they'll turn into 'zombies' something which isn't the case.

He also said there are issues of some people buying certificates that they are being vaccinated against Covid-19, while they know for sure that they're not: "This is a result of mental retardation due to the fact that you are deceiving yourself. There is no reason for the community

to buy fake certificates. All they have to do is get vaccinated so that you can be safe."

Dr Nzobo urged the community to swiftly go and get the vaccines which have been the community professionally. approved by the government.

Regarding the superstitious beliefs of the Covid-19 vaccine, he asked reporters to use their pens to educate the community about the importance of getting the jabs in various

FRI's radio supervisor Esther Mwangabula stated that the workshop was geared towards empowering journalists on their role to better inform the community on the pandemic and ways to prevent it.

Mwangabula said the awareness campaign was aimed at to help governments mobilise

communities gain awareness on the importance of the Covid-19 vaccine, while urging journalists to use their skills to inform

Speak up on the importance of census, Dr Tulia advises clerics

NATIONAL Assembly Speaker Dr Tulia Ackson has appealed to clerics to use part of their homilies to emphasize on the importance of participating in the coming National Population and Housing Census.

She made the appeal in Dar es Salaam on Wednesday when speaking at the religious leaders' convocation about this year's National Population and Housing Census (PHC) that was organized by the Inter-Religious Council for Peace Tanzania (IRCPT).

She also called on parents or guardians not to hide children with disabilities and register them for the future record.

She said religious leaders have a direct link with their believers and therefore they must now take part in their homily to talk about censorship.

"We really depend on you as an important link in the coming exercise. I call upon all of you to use part of your homily in mosques and churches to address the importance of censor," she said.

According to her, the censor will help to set the coming 10 year national development vision when the previous ends in 2025.

She clarified that the coming censor has no relation with tribe, denomination, politics ideology and tax and therefore people should give the facts to the censor clerks.

IRCPT chairman, Alhad Musa Salum said religious leaders were ready to collaborate with the government to ensure the exercise becomes successful.

The cleric called upon Tanzanians to be ready to participate in the coming censor scheduled to kick off from August 23th this year.

He, however, expressed gratitude to President Samia Suluhu Hassan for her outstanding performances.

"Census has no religion, it is about all people. I call on all of you to ensure participate in censor," he said.

The commissioner of the 2022 PHC, Anne Makinda said the results of the census will be released to the public after one month.

She said it was the responsibility of everybody adding that this year censor will involve sub-villages.

"Census is important since among others will help to reduce bank interests,"she said. Former Bishop of the Evangelical Lutheran Church in Tanzania (ELCT) Alex Malasusa said that scriptures insist on obedience to leaders and therefore the public must

participate in the coming censor.

"Census is about being obedient to the authorities to enable them to make future plans on behalf of the majority," he said.

He said further that census was about future development adding that it signifies patriotism and unity.

On April O9, this year, Prime Minister Kassim Majaliwa, the chairman of a committee coordinating the census, said preparations for the census had reached 79 percent.

The last PHC was conducted in Tanzania in 2012. It is estimated that Tanzania has nearly 60 million people.

Work harder to ensure food security, land experts urged

ENABLING experts from various districts on projects for reversing Land Degradation Trends and Increasing Food Security in degraded ecosystems of semi-arid areas of Central Tanzania (LDFS) are required to bolster agriculture projects in their districts.

The call was made Tuesday this week in Morogoro by the director of environment in the Vice President's Office, Dr Andrew Komba when opening a training seminar on assessing and monitoring of projects' indicators.

Komba said implementation of the projects faced many challenges, including their delay hence the experts undergoing training will have the chance to make improvements.

However, Dr Komba added that many projects have stalled due to various reasons including internal aptitude and lack of accountability in projects areas hence; he added it was the right time for seminar participants to closely monitor them to

attain intended goals.

LDFGS Projects Coordinator, Joseph Kihaule said it is the responsibility of the enabling experts to fully supervise the infrastructures built from projects. He cited water dams, wells and farming

technologies as examples which they should regard as part of their lives as they assist them to strengthen irrigation and therefore increase food security in their areas.

Edson Apson, the training facilitator of the seminar said it was important to impart this education to the experts because many projects being implemented produce hazardous thermal energy.

For that reason, he said it was essential to make an assessment on the contribution of the projects in order to reduce gaseous emissions hence minimizing the effects of climate change.

The training was given to experts from districts councils of Kondoa (Dodoma Region, Mkalama (Singida), Magu (Mwanza), Nzega (Tabora) and Micheweni (Unguja).

OVER 100 children in Dar es Salaam have been rescued from the streets and returned to their families between January and May this year.

The Railway Children Africa (RCA) through its three-year care reform project rescued the children with the support from the government and stakeholders.

Speaking during the care reform project closure workshop in Dar es Salaam yesterday, Clara Fulgence RCA project officer said they have been reaching and protecting children living and working on the streets for over a decade.

"Through the project, we managed to rescue 128 children, among them 79 boys and 49 girls in five months. The number has dropped from 526 in 2021," she said, adding that investing in children is investing in the country's future.

Clara said children who have stayed for a long period at care houses have been taken back to their families as the centres are only short time

Wilfred Swai, RCA project officer said that before children are taken back to their families they are provided with life and entrepreneurship skills to help them establish income generating activities

She said: "We also give them small grants that are used as capital for improvement of their businesses."


He said most of the street children have been forced into the situation due to various reasons such as poverty and conflict at family level as well as sexual abuse.

A social welfare officer from Dar es Salaam, Lilian Chillo said the partnership between the government and RCA under the police special desk for children has managed to educate a good number of street children.

"We build friendship with the vulnerable children so that we can be able to get all the required information from them. Such kind of information is useful when preparing rescue plans," she said.

Bonephace Mrosso from Village of Hope (VOH) in Mwanza said: "Our mission is to bring lasting hope to orphans. We provide shelter, education, health care service and behaviour change sessions. We are serving 47 children who are still dwelling at orphanage centres."

Mrosso declared difficulties in helping and convincing children to move from orphanage centers to their families. He said there are challenges where some families refuse to take them back.

TAEC, IAEA in a five-year strategy to improve country's health sector

THE Tanzania Atomic Energy Commission (TAEC) in cooperation with the International Atomic Energy Agency (IAEA) is implementing a five-year health project, the key initiative which has seen installation of radiation therapy machines at Mwanza-based Bugando Hospital.

The five-year project (2017-2022) which has so far made great strides in ensuring radiation and treatment planning systems at Bugando Hospital are available targets to help provide cancer treatment services to the people of the lake region who have been struggling for a long time to pursue such treatment at Ocean Road Cancer Institute in Dar es Salaam.

Giving an exclusive interview to The Guardian, TAEC Director General (DG), Professor Lazaro Busagala informed that the project has already spent a total of 52.95bn/- over five years (2017-

2022). "During the same period, at least 33.4bn/-

medical equipment was procured along with nine professionals from the industry who attended a long-term fellowship training where 23.8bn/- was used to fund the training," he detailed.

Together with that, he added that, through the project, IAEA in cooperation with TAEC, ministry of health and the Institute of Food and Nutrition in human nutrition is conducting a special research using nuclear technology to diagnose nutritional problems in young children.

"The nuclear technology provides accurate diagnostic information compared to the use of other methods," he unveiled.

And he detailed that, in a period of the mentioned five years, the robust project spent at least 1.2bn/- to procure varied modern equipment for the improvement of human nutrition.

"Apart from the equipment, various training were provided such as meetings as well as various seminars done locally and abroad

whereby a total of 211.7m/- was spent," he revealed.

The Don added that in the human resource development sector, workers from various sectors have been trained through the International Atomic Energy Agency project in various areas including livestock, human health, agriculture, water resources management, nutrition and energy and industry.

The training provided, according to him was for a short-term for period of one to three weeks and long-term training, from six months to three years, so for a period of five years (2017 - 2022), a total of 3.2tn/- was spent by IAEA to fund training and research materials for students from various ministries and institutions in the country.

The vital project has been implemented under the Country Programme Framework (CPF).

CPF is a technical partnership program between Tanzania and the International Atomic Energy Agency which reflects the developmental needs and priorities of the member state on one hand and access to resources to implement those priorities on the other.

In addition, these priorities are essential for identifying all areas where nuclear technology can make a significant contribution to economic and social development.

EACJ ups jurisprudence on protection of human rights

EAST African Court of Justice (EACJ) has built jurisprudence on the protection of rights of individuals in East African Community under Articles 6 (d) & 7 (2) of the EAC Treaty on fundamental and operational principles of the community, which include protection of human rights and freedoms.

EACJ President Justice Nestor Kayobera made the remarks in Zanzibar when speaking during the official opening of a three-day first Tripartite Judicial Dialogue held in Zanzibar, which was organised by the three Courts, that is the African Court of Human and Peoples' Rights (AfCHPR), the EACJ and ECOWAS Community Court in collaboration with various partners led by the Roul Wallenberg Institute of Human Rights and Humanitarian Law.

He said that the court has handled over 600 cases which are not enough due to limited awareness on the court by the public.

AfCHPR President Lady Justice Imani Aboud said that Judicial Dialogue has become a critical tool to achieve justice in an increasingly globalized world, the purpose and gains are now established and undeniable.

Justice Imani stated that recent developments in Africa's social - political and legal landscape unequivocally demand that African leaders reaffirm their commitments to justice, whether to terrorism, armed conflicts, famine, and political violence, under development or poverty, justice continue to stand as the agreed solution. "We as judges and courts need to engage in consistent trading of legal and judicial solutions." said African Court President.

ECOWAS Court President represented by Lady Justice Dupe Atoki said that, the court was initially strictly an interstate court without individual's direct access to the court. However, in 2005, a Supplementary Protocol was adopted which amended the initial protocol on the court, expanding its initial mandate into four distinct mandates and these include; as Community Court; an Administrative Tribunal for ECOWAS Public Servants Human Rights Court and an Arbitration Tribunal.

Justice Dupe added that it's significant to note that the said Supplementary Protocol granted the court's jurisdiction to determine cases of violation of human rights that occur in any Member State and gave individuals direct access to the court in respect of human rights violations.

The Roul Wallenberg Institute of Human Rights and Humanitarian Law a leading partner in organizing the dialogue, represented by Prof Morten Kjaerum said that, the development of the mandates of both the regional and sub-regional courts in Africa, has not only contributed to the advancement of human rights in Africa but also to the harmonization of human rights standards in the region and for the unity and effectiveness of the African human rights system. The jurisprudence developed at this continent contributes greatly to the advancement of international law at all continents.

Konrad Adnauer Stiftung a partner represented by Dr Stefanie Rothenberg said "We don't have to go back far in time, if we want to see how essential the role of the courts with regard to guaranteeing the fundamental rights of access to justice for African citizens is."

Representing the UN Office of the High Commissioner for Human Rights Maymuchka Lauriston said that enhancement of human rights protection throughout the world is a common goal for the United Nations Systems and its international human rights mechanisms as well as for many regional mechanisms dealing with human rights matters. She added that regional and sub-regional bodies make important contributions to the process of domestication of international and regional human rights law through adjudication of legal norms and standards.

The judicial dialogue which commenced on 27th will go on up-to 29th June. Various discussions on judicial issues on promoting and protection of human rights, adjudication, jurisprudential issues related to women rights and indigenous people, execution of decisions of the three courts, challenges and prospects of cooperation in the implementation of the decisions as well as institutional cooperation among these courts.

The dialogue brought together judges from the three courts, legal and academic professionals, registrars and staff of the 3 courts. Other dignitaries in attendance were the Chief Justice of Zanzibar (designated), Minister of Justice, Attorney General, Regional Commissioner, and Judges of the High Court of Zanzibar among others

We need to come closer together in taming crime

OMETIME around mid-August in their evil ways. 2013 we used this very same column to express worry and fear upon having witnessed a series of criminal incidents, particularly violent attacks on influential people and even ordinary citizens.

We noted that several of the incidents had occurred - and were occurring - in broad daylight at political rallies, in open streets, etc., at times involving the splashing of people with acid and leaving them with various degrees of injuries.

We cited a month during which there were two incidents of the kind - one in Arusha Region in which an Arumeru District resident was the victim and the other with a Dar es Salaam businessman as the target.

A month or so earlier, a man was the victim in a brutal attack while on his way home in Zanzibar, while another was hit during a political rally in Igunga District

We rightly noted that there was every reason for our country, which has enjoyed decades of peace and harmony, to refuse to earn the disgraceful label of criminal elements having a field day with some finding acid attacks on innocent citizens people fashionable in an undeclared war.

We wondered why acid threatened to become a weapon of choice in such assaults, one idea being that it was all because literally anyone could readily or effortlessly access it.

Indeed, it was true that one didn't need to have some special permit to be able to buy the chemical. And we found this strange in that, for most lethal weapons often "misused" by criminals, one would need a permit to possess

On second thoughts, we reminded ourselves that there were after all lots of real weapons out there whose accessibility did not call for the need for permits.

This made us wonder whether cases of the misuse of acid were on the rise simply because criminals could use the chemical to effect and get away with their evil ways without trace.

While it is quite some time since the last reported case of acid-aided assault, we cannot rule out a recurrence of the same or other incidents using whatever weapons criminals can decide to apply

Contributions not suited

We sincerely believe that not only have our police and other lawenforcement agents most of the expertise and other resources they need to forestall and combat all manner of crime but also most have been doing what most they could to get hold of criminals and ensure the law takes its

However, time is now for the agents and other relevant authorities to forge closer links with the citizenry in combating the rising wave of what one could refer to as rare crime.

We have in mind cases of violent crime including homicide which are usually a tragic culmination of romantic relationships gone sour.

While it is clear that there are various time-tested ways of handling such incidents before the worst comes, the fact is that the frequency with which we have been witnessing cases of the kind lately is very real cause for concern.

For one thing, the need for enhanced vigilance in the way we store and handle weapons and other items likely to add the tragic or deadly nature of the incidents in question cannot be overemphasized.

Yet, how often is the importance or relevance of this consideration belittled

Going by the ease with which "small" but in effect deadly arms such as machetes, kitchen knives and pangas are sold along our urban streets and other places, one can only wish for tighter preventive and remedial intervention

Acid-aided attacks of the kind we have cited above appear to have become long-forgotten history - and whoever are to be credited with the laudable development have done us all proud, and we have plenty to learn from all this.

But we are not there yet, at least not what with what we see and know about the way we store and handle chemicals and weapons, etc. - however apparently safe or harmless.

Still, we have the capacity to conclusively address some of the challenges needlessly giving us a hard time. Let's go on and do more in taming the tide of crime using the resources in our hands and supported by all the legal means at our disposal.

T'S the "magic" number just about everyone knows: 120/80. If your blood pressure isn't at or below - that, you'll land smack in the prehypertension group.

And if, heaven forbid, you venture up to 140 on the top reading, you'll definitely be told it's time to start a "treatment programme". Code words for taking dangerous high bloodpressure drugs.

But more and more research coming out is telling us that's just plain wrong, wrong, wrong. The most recent study on aggressive blood pressure control out of Italy found that patients in a memory clinic who had the lowest systolic (top) number (achieved by taking blood pressure drugs) also had the most "cognitive decline".

And before that, a study published in the Journal of the American Geriatrics Society discovered that higher blood pressure in those aged 85 and older was connected to "resilience" in both physical and mental decline.

Another study, from the Netherlands, found that older people who were on blood pressure medication were more likely to suffer from dementia. The researchers said that the reason may be because, as you age, too low blood pressure can cause your brain to get an insufficient supply of blood.

Add this to that the fact that a review of four recent drug trials involving over 9,000 people with a systolic reading going up to 159 found that treating them with drugs does very little to prevent heart disease.

But it looks like some bad advice is amazingly sticky. And what we've been told all along about blood pressure seems to be made out of superglue.

Even new guidelines published in 2015 in the prestigious Journal of the American Medical Association haven't caused the shakeup it was expected to.

It was the first time that the top number in what is considered "high blood pressure" actually went up, the biggest difference being for those aged over 60.

A committee - one made up of many of the most well-respected heart doctors you can find - said that there was no reason for people who are 60 or over to start on drugs unless their blood pressure was 150/90 or higher. (It had been 140/90). And for people under 60, the numbers also got bumped up to 140/90.

Now this isn't to say that having a lower blood pressure reading isn't healthier. But it's all how you get that lower reading that really counts.

Dr Paul James, co-chairman of the panel that issued the new numbers, said someone whose top number is 120 will "have lower health risks" than, say,

someone with a reading of 140. But getting to that number with drugs

didn't show the same health benefits as being able to achieve it naturally. A big part of that reason could be that drugs to lower blood pressure are some of the riskiest ones out there.

For example, drugs in the "ARB" family can cause lupus, hypersensitivity and acute eye problems, including glaucoma. And if taken during pregnancy they can actually kill an unborn baby.

[Glaucoma is a group of eye diseases that can cause vision loss and blindness by damaging a nerve in the back of the eye called the optic nerve. The symptoms can start so slowly that one may not notice them. The only way to find out if one has glaucoma is to get a comprehensive dilated eye exam.]

In addition, people on ACE inhibitors that is, medications that help relax the veins and arteries to lower blood pressure - can develop sudden, lifethreatening swelling of the face and

And all these meds can cause blood pressure to fall too low, leading to dizziness and falls. So if your doctor is still clinging to the old party line about your blood pressure number, it's time to break the news to him or her that 120/80 has gone the way of eight-track tapes and rotary phones.

Meanwhile, despite all the bad things you've heard by now about diet soda, maybe you still think it will help you lose weight. But if you're looking to get rid of that muffin top, it's actually the last thing you want to drink.

A new study of 729 people 65 and older found that regular diet soda drinkers ended up with three times as much belly fat after nine years. And that's the riskiest kind of fat, linked to heart disease and Type 2 diabetes.

And those who fared the worst were the ones who were overweight to begin with. These people "are really in double or triple jeopardy", said senior author Dr Helen Hazuda. She said while they thought they were helping themselves, "it's actually totally

counterproductive". The new study seems to jibe with one done in Israel in 2015 on both mice and nearly 400 humans. It found that the three most widely used noncaloric synthetic sweeteners altered gut bacteria in a way that resulted in

increased glucose intolerance. Dr Hazuda also believes that artificial

sweeteners fool our bodies. She said instead of satisfying us, they actually cause us to crave sweeter and sweeter

Whatever the reason, this study is further evidence that diet drinks aren't the magic weight-loss elixirs (medical potions designed to cure) which advertisements make them out to be.

And then there's the "sideeffects" that have been associated with aspartame, the main artificial sweetener they contain - including migraines, dizziness, seizures and vision problems.

What should be clear is that drinking diet soda is a losing proposition. When it comes to everything but your weight,

Come to think of it, do you feel like you've tried countless products to bring back your youthful glow? You know the ones... the greasy creams, expensive oils and even those "beauty" pills you have to pop morning, noon and night... they're such a waste of time and money!

However, doctors warn that this information is offered as a general guideline and is not one-size-fits-all medical advice. They stress that it is important for people to consult their doctors before making any changes in their personal health care schedules.

He taught me these five principles while I was growing up, even though I spent 15 years of my life in school learning how to get a profession that would allow me to live the life I wanted, my father played a significant role in nurturing and shaping me as an individual. His pool of goldmine lessons can be summarized five times.

Don't let your past dictate your future. Small scale miners have been in my father's family for decades. In fact, every living male relative of my father worked as a one at some point. My father, on the other hand, had no desire to venture into mining.

My studied hard and became the first member of his family to attend higher learning institution and then earned the equivalent of a bachelor's degree in civil engineering as an escape route. To break the family cycle of miners, he landed an excellent job at a construction company.

As a reminder that anything is possible and that we should set our goals based on our desired destination rather than our current location, my father would relate this story to me regularly. "Don't let your past dictate your future," he would often say.

Treat everyone as if they're a high-



value customer. Everyone in his construction company, from the janitor to the MD is treated with dignity and respect by my

father, who is a modest man. "No matter how successful you become, remember that you still put your pants on one leg at

a time, like everyone else." That was his catchphrase and he added: Don't anticipate or demand special treatment from

When someone feels beneath you, never treat them cruelly. You never know who you'll meet or what they'll become, so treat everyone with respect. It's remarkable how much this can affect people, including yourself. It helps develop trust and respect, and it also encourages others to assist you achieve your goals.

When the stakes are high, do the hard things. A sports enthusiast like my dad was always fascinated by the players who were able to get the job done when the going got tough. They were the folks you could rely on, he told me so. When things are going well, it's simple to shine, but those who are genuinely the best shine when the going gets difficult. That's what sets you apart.

As a result of following this advice, I vol-

unteered for the difficult projects that no one else wanted to take on, and when we completed them effectively, I was able to stand out and advance in my career ahead of my peers early on.

Enter quietly, do a great job, exit loudly. Never tell me what you can do; show it to me. That was my father's adage when I was growing up. It was individuals who boasted about their abilities and then came in and failed that he despised. Come in softly, under promise, over deliver, then leave loudly since it always leaves a better impression, he would say.

As a child, he was taught by his father that it was better to talk about what you've accomplished rather than what you plan to accomplish. Use this advice to keep yourself on the correct side of the border between arrogance and confidence. In the wrong hands, arrogance may alienate others, but in the right hands, confidence encourages others to have faith in you.

You're able to sleep well at night, knowing that you've done the right thing. For, as long as I can recall, my father's mantra is it's never too late to do what's right. In terms of values, this was the most important one for him. He said it's easy to know the right thing to do; just ask your conscience, and if you always do the right thing, you will sleep a lot more soundly.

Decisions that can have a significant impact on the lives of others must be made frequently in business. These decisions aren't always easy, but if you can be sure you did the right thing, not only will you be able to look yourself in the mirror but also your coworkers. Having a clean conscience is a priceless commodity.

Following this advice has helped me achieve some amazing goals, things that others thought were impossible. It has allowed me to remain humble, earn trust and respect, and it has allowed me to sleep soundly at night.

I owe a debt of gratitude to my father for providing the solid foundation upon which I have built my life. I'm grateful for everything he's taught me and is still teaching me. When it comes to my children, I want to impart to them the same lessons. You can do the same too if not doing al-

LOBAL cashewnut trade is a multibillion business annually which attracts heavy investments not only from the private sector but governments to enable farmers get input to increase productivity and revenues.

Cashewnut has tremendous potential of production and marketing in Tanzania especially for export to other countries. It is termed as 'white gold' to describe its importance in the economy.

Because Tanzania is one of the countries with land suitable for cashew growing, the government is not taking chances. A total of 5,623 tonnes of farm input arrived at the Port of Mtwara last week to be distributed free to cashew growers in the country.

Sulphur dust subsidy imported from Turkey is a key pesticide since it prevents cashew powdery mildew disease-the most serious biological constraint in cashewnut production because the fungal disease attacks young panicles and flowers with consequent effect on the apple and the nut, resulting to losses of between 70 to 100 per cent.

Speaking at the reception of BOSS7 Vessel which docked with the consignment last Friday, Mtwara Regional Commissioner Brig Gen Marco Gaguti said the move follows a directive by President Samia Suluhu Hassan that cashew growers be provided with essential input to boost their productivity and incomes.

The RC said the shipment which was being offloaded just hours after the docking of the ship, would be distributed to all cashew-growing regions under strict supervision and coordination.

Mtwara District Commissioner Dunstan Kyobya who was also at the port appealed to relevant authorities in the cashew belt to ensure the in-

According to Observatory of Economic Complexity (OEC), in 2020, cashewnuts, fresh or dried were the world's 430th most traded product, with a total trade of USD6.87 billion (over 15trn/-). Between 2019 and 2020 the exports of cashewnuts decreased by -6.78 from USD7.37 billion to USD 6.87 billion mainly due to COVID-19 disruptions. Trade in cashewnuts represents 0.041 per cent of total world trade, says OEC.

Following the docking of the ship, cashew growers in the Southern Zone hailed the ongoing government support through free input but asked for more to be done to boost their productivity and earnings.

The farmers said distribution of free pesticides provided by the government in the 2020/21 and 2021/22 seasons has been a big shot in the arm for them but access to loans remains a big challenge.

From tilling the land, planting, pruning, weeding (four times per season), pesticide spraying (five times and sorting, the farmers said this is a labour-intensive undertaking that requires reliable financing for enhanced productivity.

Said Abdallah who owns trees in Magengeni Ward, Mtwara Region, told reporters that for instance, even with the free pesticides, he pays spray pump operator 300/- per tree.

"President Samia Suluhu Hassan has done a fantastic job so far. Without input subsidy the situation would have been very bad for me and my colleagues," he said.

"However, we have a big challenge when it comes to reliable access to loans. The available commercial banks hesitate to lend us money and even when the loan is approved, the money reaches us too late, mostly off the season."

The famer added that the lenders currently working with farmers have capped the maximum amount to 1mn/- which he said is peanuts for his 27 acres.

Rashid Kamkumba who owns 10 acres located in Naliendele in the region said he currently relies mainly on the input subsidy because he has no access to financing to expand production.

The 31-year-old said he cannot dig deeper into his pockets to buy input because prices of cashewnut to farmers for free.

which range from 1,400/- to 1,900/- per kilo are too low compared to the cost of production.

"I understand no one gets satisfied with money but going by the cost of production, a kilo should fetch between 3,500/- and 4,000/-," he said.

"The government should do more to attract investors in cashewnut processing locally as this will lead to competition and good prices for farmers.'

Khadija Matipa, Manager at Masasi-Mtwara Cooperative Union which also serves Nanyumbu District, said the government input subsidy in the two seasons upped production in Mtwara, Masasi and Nanyumbu districts from 65,000 tonnes (2020/21) to 69,000 tonnes in 2021/22.

"Our projection is to increase the tonnage to 85,000 in the 2022/23 farming season because the input has come in time," she said.

But according to Brig (rtd) Aloyce Mwanjile, Acting Chairman of CBT, huge chunks of cashew farms have now turned into dense forests because of abandonment by farmers who are not willing to invest both energy and resources.

"We are working with councils to use bylaws to get people to clean these abandoned farms," he said.

In May this year, CBT announced plans to increase production which includes provision of 25,000 tonnes of sulphur dust and 1.5 million litres of liquid pesticide

A voice for African wildlife: A conversation with Kaddu Sebunya

he CEO of the Nairobi-based African life Foundation, Kaddu Sebunya - in London to mark AWF's 60th anniversary while fundraising and lobbying - shares his thoughts with IPS on the climate and food crises, how Africans have their voice, why western countries need a 'reset' with Africa, what Prince Charles should say to the Commonwealth, how China is eating western 'cake', and what worries him more than anything else.

(IPS) How are the crises of climate and food security impacting AWF across Africa?

"It has a huge impact because everything is interconnected. In Kenya, we lost about 78 elephants to drought in Tsavo National Park [in the nine months to April]. That's more than any poaching, higher than any cause of death of elephants in the last 15 years. Elephants are a key species - when they suffer, we know what's going to happen to the plants, the frogs, the butterflies, the trees. They are a key we use to measure the health of the ecosystem. The elephant can tell you a lot about what is going to happen to all other species, including humans.

Drought and food shortages: people are going to make different choices. They are going to change the way they live. In many cases, the resources suffer. Smaller choices mean a different diet, so they use more firewood, they are going to cut more trees. When there is food scarcity and drought they are going to rely on hunting for protein... For many Africans, 70 per cent plus are in agriculture - that's their livelihood. If there is drought they are going to pick other options. If the Maasai have lost 40 percent of their livestock in northern Kenya they are going to look for alternatives... The nearest resource is going to be wildlife.

Governments are sourcing from the same budgets. If there is drought they will change priorities. Always environment and conservation are going to be the last choice. Education is going to suffer. All these other sectors suffer because the budgets are being reprioritised to drought and health.

And at the global level, you see in central and west Africa the impact on migra-

tion. We see rural areas emptying and young people moving to urban areas with no skills. Especially women and young girls suffer more. The young boys are recruited into terrorist groups or trafficked to Europe. So the repercussions of this are not just natural resources... it distorts the whole set-up, entire cultural systems, the entire social network and safety nets, and breaks down government systems... It's larger than just food... Societies are broken down. Bringing food in risks destroying local agriculture. This is why Ukraine is so important, raising the question of dependency on imported

What is AWF's response?

"Our work is to represent the voice of wildlife. Animals don't speak. Someone has to do that for them. We take that responsibility very seriously, in all these changes for us to be at the table, whether a board room, in corridors of parliament or community meetings, to be that voice for wildlife... The only long-term solution for drought is how we can manage nature better. But in most cases that is not factored in when we are talking about addressing the symptoms, when addressing famine so [the UN] bring in biscuits from Europe and elsewhere, high energy food... That's not a solution, that's a band-aid ... I was talking to someone from Ethiopia, he said the problem we have is all these NGOs and INGOs are bringing plastic into villages in Ethiopia and it doesn't come with the education of how you are going to dispose of all this plastic.

Historically it has been easier for international communities to talk to international NGOs who have been working on the continent or to talk government to government. It hasn't given us good solutions to our problems historically. And that's what we are asking that needs to be changed. It's going to take Africans to take ownership and responsibility and leadership, to permanently solve the problems Africa has. We don't have very good results where things have happened without African leadership. There are very few cases. Where that has been successful it has been very expensive, especially in our sector... They are either training thousands of rangers, they are bringing guns, they are buying and fuelling vehicles, and carrying on training to protect 1500 elephants. What we are doing, it is actually cheaper if you are supporting Africans who don't need guns to protect wildlife, they use a relationship with wildlife, who can be supported in developing their wild-

life economies...

Sometimes we think our work is to make it cheaper and sustainable. Models that have been used are not sustainable. Governments cannot sustain areas that require thousands of rangers and vehicles, I mean Serengeti is the size of a country in Europe... Everything I am telling you is coming from our experiences, what works and doesn't work. The challenge we have now over the next 10 years is how do we scale it up. A project we have been running in northern Rwanda for 30 years, the conservation of mountain gorillas, and how we have mobilised communities for them to have a stake in the tourism. Thirty years ago eco-tourism was an investor coming to the area, gets a concession, builds a wonderful lodge and he just had to hire local Africans and get a group of local women to dance for tourists, get a few households to sell crafts at the lodge and that model still exists... We said it's not enough. We raised the bar. Now we are talking about equity - communities must have equity in the tourism business and so in the lodges we build, like in Rwanda, Kenya, Namibia, Botswana, the communities own the lodge. The private investor is

a management firm.

The hard work in that formula is how to mobilise communities in that business unit. What works for that is our relationships with government. You can't do that in isolation to policies and laws... the conservation approach is political, economic and social. It's not about the science of conservation. It's not about the behaviour of elephants and rhinos. You have to get involved in the political discussion, the social discussion, the economic discussion and that's how you start moving... We flipped the investment model. It takes a lot of time but it's extremely successful.

How is China's growing role in Africa affecting conservation work?

We work in China. Pre-COVID I was spending a lot of time in Beijing talking to policy and Communist Party officials. It's good. We have seen results. We are part of the groups that helped China ban the ivory trade about six years ago... I was in Beijing. The day that China announced it, the price of ivory fell by 70 percent. Demand fell 65 percent for our African ivory... it was huge. We are working with China on mainly three fronts: it's the Chinese footprint on our continent: the infrastructure they are building, farming, the industries they are setting up in Africa. We are asking them to be responsible in doing that. We are not stopping it... Initially, they were telling us it was not their responsibility, that's African governments' responsibility, it's the contracts they signed with the African governments and African governments need to tell them what they want and African governments are not telling us we care about the environment so we are not going to care about it. We talked to them, we called them out. It was so important, they told me after huge arguments that went are succeeding in that. The other approach we used is that making sure that African governments are making these conditions so we spend a lot of time with African ambassadors in Beijing... The last thing that China wants to hear is Europe asking them to do better in Africa or US asking them to do better in Africa... Right now we have a technical advisory role to the African delegation on the Convention on Bio-diversity [in talks hosted by China].

Our third thing is people to people, especially the youth. If anything good comes out of this COVID it is Zoom, so we have created platforms where African youth interact with Chinese youth and they are having very very interesting conversations about Africa, about wildlife, educating each other. That's where the future is... Culturally we are very connected, family and extended families, cousins and aunts and uncles, it's so common between Chinese and Africans. The connection culturally is just so real. To the young people this is a globalised world... Culturally it is changing, we have seen that with consumption of African wildlife. We talk to older Chinese and they still think that owning ivory is a big deal, an investment. The young people want a Polo shirt and an Apple watch for their status, and so do the young Africans. They want to drive a Porsche, not have tonnes of ivory in their homes like their grandpar-

We have a very good relationship with Beijing zoo and Shanghai zoo where every year we have an exhibit for three months. One in Beijing, before COVID, 300,000 people were goin China are mind-blowing. They go with their families, they learn about the species and the habitat, they watch the videos. These are young middle-class families, they start questioning things. We have seen change in China.

How can the UK/EU change Africa policies and deal with China's growing presence?

[An] example is the Commonwealth. I think the UK has the opportunity to reset... I think the UK has an opportunity to change their role from big brother to maybe an uncle who sometimes is invited to a dinner and is sometimes left out of

African NGO directly. So we a wedding. But it's a huge opportunity for UK, and I don't see that happening as quickly as it should.

> I told the European Union parliament and some folks here in the UK in the discussion about China that it's tiring when you hear UK officials or EU officials complaining about China. For an African it's really tiring. And I have been telling them: look China is not eating Africa's cake, China is eating UK, French and German and Italian cake in Africa... because for the UK to whine about China in Africa when half of Africa speaks your language, half of Africa believes in you and have common values. Seventy percent of African leaderships attended Oxford, Yale, Harvard, London University and you sit in London and complain about China? A huge population of Africans are British. I'm yet to find a Chinese African or a community of Africans who speak Chinese.

The western world has to think deeper to understand the options China has given Africans. And look in the mirror and ask why, and counter offer and have a serious conversation. The Germans are doing that by the way - they are rethinking their engagement and I hope that actually with the war in Ukraine is going to change the relationship between Africa and Europe. You have a continent that has the richest minerals and richest industrial resources on the planet and you rely on Russia and for food? It's mind boggling. You rely on a country you define as enemy. It's total neglect of a continent that is so rich, because it's easier for Africa just to be exploited and do it that way and do the trade with Russia who is the ening in a day. The numbers emy. But 'we' don't want to trade with Africa, we just want to continue exploiting. And see what's happening now. It's that reset. It can be led by the UK, especially now as it has exited the EU. But I don't see that thinking here. If I was to address the Commons that is what I would tell them. I don't see them taking on that opportunity the UK has through the Commonwealth which is coming up. I don't know what Prince Charles' address is going to be but that's what it should be.

> 'Africa's resources are above, not below, the ground'

Our work is to tell Africans

that our wealth is above the ground. It's not underground as UK, France and others have told Africans. It's only when I come to Europe and North America where I hear Americans and Europeans say Africa is mineral-rich. Out of 54 countries, there are less than 10 countries that are mineralrich, so where is this idea that Africa is mineral-rich? And somehow Africans bought into that because Europe and North America only want the minerals in Africa. But the wealth of the continent is above the ground. We can feed Europe with organic food... you [the West] can achieve two objectives with one approach: you can get organic food out of Africa, stop the famine going on, but also you can offer Africa a better model of development, because if you don't, what happens in Africa won't stop in Africa, it will reach London and then the streets, whether in terms of refugees or in terms of flooding because of climate change, or just loss of biodiversity... It is so important that we start treating Africa as the last frontier for global solutions, whether it's health - the next virus is going to come out of Africa, no doubt. Africa is the last frontier of animals. It is in all our interests that the virus stays in the wild lands and the wildlife and that's the work

of conservationists... You want to solve climate change, you need to do something in a country that absorbs carbon... The source of energy for Congolese should be the most important solution for UK climate change policy. Because the Congolese population is growing - you know the largest French-speaking city is Kinshasa, it's not Paris. If those folks continue to rely on firewood as their energy source, you will have more carbon in the air and temperatures rising

I sound cynical but you don't have to change your [western] way of life drastically, but if you help Africa to leapfrog [in technology and development] that change shouldn't be so drastic but the more you don't help Africa leapfrog, the harder it will be for everyone... So the choices Africans are making to their prosperity is so crucial to the rest of the world... guess what, Africa is chasing the western world... they want London in Kenya just as it is. They want to drive big cars, they want to own a village house and a summer house, planes.

The research institute wants to make improved seeds of all crops adequate and available on time for the farmers in the country. The strategy seeks also to encourage local farmers to increase production and reduce the countries dependence on imports of some of the strategic crops like wheat.

The Ministry of agriculture has set aside enough funds for research and production of the improved seeds. For wheat alone there are more than 400m/- leave alone other strategic crops, he said.

I have talked to researchers here and they have said collaboration with the

consumption of wheat but the climate of this area also allows massive production of pyrethrum and Potatoes. We are therefore going to take advantage of this climate to set aside more than 200 hectares for production of wheat and more than 20 hectares for production of pyrethrum and the remaining will be used for production of potatoes," he said.

This time around, the budget has reinforced our hope to effectively and efficiently utilize our resources including research and production of improved seeds.

TARI-Uyole centre acting director Leonard Sabula said his centre is targeting the Ministry's agenda of 2030 in terms of improved seeds for the farmers by utilizing its centre's vast land across its sub stations.

"In agriculture, one of the problems many farmers face is the availability of improved seeds. So, we are working around the clock so that our centre produce enough improved seeds. We want our centre to contribute to the main goal o the Ministry we want to achieve. We also want to see agriculture sector grows by 10 percent." he said.

He said the centre in

private sector will be able to produce enough improved seeds and supply them to the farmers.

He said as a public research institute, it has built strong and good relationship with the farmers around many areas who are also benefiting from different technologies from TARI such as the improved seeds.

TARI Igeri substation incharge Elia Nyangasi said the climatic condition of the centre is almost comfortable all the year around for research and production of various crops such as wheat, pyrethrum and potato.

"We have received directives from Ministry of agriculture through TARI. We will make sure that we utilize the land which is under the centre to conduct fruitful research and production of the improved seeds for the farmers," he said.

In Tanzania, more than 90 percent of wheat production comes from either large-scale commercial farms in the northern highlands of Arusha, Kilimanjaro, and Manyara regions or small and medium-sized family farms in the southern highlands of Iringa, Mbeya and Rukwa regions.

WHO intensifies response to the looming health crisis in the greater Horn of Africa with food insecurity growing worse

THE World Health Organisation (WHO) is scaling up its operations in eastern Africa as the region faces acute food insecurity caused by conflict, extreme weather events - including the worst drought in 40 years - induced by climate change, rising international food and fuel prices and the impact of the pandemic.

Over 80 million people in the eastern African region are food insecure and resorting to desperate measures to feed themselves and their families. Acute malnutrition is high, especially among children.

As malnutrition increases, the health needs in the region are mounting, especially among children, and clean water is becoming scarce. As people leave their homes in search of food, they can no longer access health services, and become more at risk from disease outbreaks.

"The cost of inaction is high," said Dr Ibrahima Socé Fall, WHO Assistant Director-General for Emergency Response. "While the clear priority is to prevent people from starving, we must simultaneously strengthen our health response to prevent disease and save lives. Even one life lost from a vaccine-preventable disease, diarrhea, or medical complications from malnutrition in today's world is one life too many."

Dr Fall was speaking in Nairobi where WHO convened a two-day meeting [26-27 June 2022] to plan its response across the seven countries affected by the health emergency - Djibouti, Ethiopia, Kenya, Somalia, South Sudan, Sudan and Uganda - and coordinate with other UN agencies and partners.

WHO's emergency response is focused on ensuring affected populations can access essential health services, treating sick children with severe malnutrition, and preventing, detecting and responding to infectious disease outbreaks.

WHO is setting up a hub in Nairobi, from where it will coordinate the response and organize the delivery of life-saving medical supplies to where they are needed most. These supplies include medicines, vaccines, as well the medicines and equipment needed to treat children who are severely malnourished. Other than providing this critical supply, WHO is working with ministries of health in the affected countries to set up robust disease surveillance systems to be able to quickly detect and respond to disease

DR MZURI Issa, the Director of Tanzania Media Women Association for Zanzibar (TAM-WA-Zanzibar) has said the community with the ability to identify challenges that hinder the accessibility of their rights is the foundation in attaining equal opportunities for development via democracy in the community.

Mzuri explained that many communities are faced with various problems that hinder justice and their own development but they fail to solve them due to lack of a strong will in speaking about them at the relative levels for them to be addressed in time.

Mzuri was in Pemba Wednesday this week addressing community activists to demand for their rights, and women in particular to participate in leadership issues and democracy through the project for women to involve themselves in leadership that is being implemented by TAMWA-ZANZIBAR in collaboration with Zanzibar Female Lawyers Association (ZAFE- LA) and Pemba Environmental and Gender Organisation (PEGAO) under the sponsorship of the Norwegian Embassy in Tanzania.

She explained that if the community will have the ability to raise their problems and take appropriate steps, it will spur accountability in the provision of their rights.

Earlier, Mzuri called on the activists working in all districts of Pemba - Micheweni, Wete, Mkoani and Chake Chake to make sure they implement their responsibilities in helping the people by having the capacity to solve the challenges they face.

"The concept of the project in establishing mobilizers in the community is to make sure the citizen at the lowest level to raise the challenges

he/she faces so as to take steps on them as well as to be bold enough to sit on one table with appropriate authorities to find the solution thereof in a dem-

ocratic way," Mzuri said. She also explained that the existence of the mobilisers in the community aims to make provide providers in various institutions to increase the pace in the accountability in regard to solving obstacles people face in their areas.

Micheweni District Community Mobilizer Ali Othman explained that through meetings held in various shehia they identified some challenges including a limited understanding of women in issues that will enable them to enter leadership positions which hinders their full participation in those positions.

He also noted that another challenge is the presence of fake birth certificates for some citizens of Shumba Shehia, Micheweni District, North Pemba Region, which leads many citizens to lose their basic rights including leadership positions.

"The problem of the presence of fake birth certificates for the residents of Micheweni District, North Pemba Region is one of the biggest challenges we have raised in the community, as in our meetings in the shehia many citizens especially Shumba Urban Shehia their cry was to get fake certificates, "Explained the mobilizer.

He added that the presence of these mobilizers in the community has helped to build the capacity of the community to have the courage to speak out

about the problems they face

And Husna Khamis from Wete District explained that, after realizing the existence of the illiteracy problem of many citizens, especially women, they partnered with the community to establish adult classes to give citizens the opportunity to overcome the problem that deprives them of their basic rights.

He said, "Through the shehia mobilization, we have successfully launched 6 adult classes with a total of 130 people to enable them to read and write in Mlindo Shehia, Wete District and many of them are already learning to read and

write.' ZAFELA's evaluation and monitoring officer, Rajab Hamad, commended the ef-

forts made by the mobilizers for achieving monitoring of challenges and barriers that delay access to citizens' rights.

"I would like to congratulate the community mobilizers in Pemba for successfully monitoring the challenges of the people and ensuring that all our follow-ups have positive results from the monitoring you have done at various levels, and this is because the goal of this SWIL project is not only to raise issues but also to help collaborate and the community to find solutions to these problems."

The project to promote women's participation in leadership and democracy is a project aimed at promoting women's participation in leadership which is implemented by the Tanzania Media Women's Association (TAMWA-Zanzibar), Zanzibar Female Lawyers Association (ZAFELA) and Pemba Environment, Gender, and Advocacy Organization (PEGAO)) with funding from the Norwegian Embassy in Tanzania.

Reimagining ageing: Senior citizens as development agents

lder persons are highly visible across Asia and the Pacific: they work in agricultural fields producing our food supplies, peddle their wares as street vendors, drive tuk-tuks and buses, exercise in our parks, lead some of the region's most successful companies and form an integral part of our families.

Indeed, population ageing is one of the megatrends greatly affecting sustainable development. People now live longer than ever and remain active because of improved health. We must broaden the narrow view of older persons as requiring our care to recognize that they are also agents of development. With many parts of the Asia-Pacific region rapidly ageing, we can take concrete steps to provide environments in which our elders live safely, securely and in dignity and contribute to societies.

To start with, we must invest in social protection and access to universal healthcare throughout the life-course. Currently, it is estimated that 14.3 per cent of the population in Asia and the Pacific are 60 years or older; that figure is projected to rise to 17.7 per cent by 2030 and to one-quarter in 2050. Moreover, 53.1 per cent of all older persons are women, a share that increases with age. Therefore, financial security is needed so older persons can stay active and healthy for longer periods. In many countries of the region, less than one-third of the working-age population is covered by mandatory pensions, and a large proportion still lacks access to affordable, good quality health care.

Such protection is crucial because older persons continue to bolster the labour force, especially in informal sectors. In Thailand, for example, a third of people aged 65 years or over participate in the labour force; 87 per cent of working women aged 65 or over work in the informal sector, compared to 81 per cent of working men in the same cohort. This general trend is seen in other countries of the region.

Older persons, especially older women, also make important contributions as caregivers to both children and other older persons. This unpaid care enables younger people in their families to take paid work, often in metropolitan areas of their own country or abroad.

Older persons should also have lifelong learning opportunities. Enhanced digital literacy, for example, can close the grey digital divide. Older women and men need to stay abreast of technological developments to access services, maintain connections with family and friends and remain competitive in the labour market. Through inter-generational initiatives, younger people can train older people in the use of technology.

We must also invest in quality long-term care systems to ensure that older persons who need it can receive affordable quality care. With the increase in dementia and other mental health conditions, care needs are becoming more complex. Many countries in the region still rely on family members to provide such care, but there may be less unpaid care in the future, and care by family members is not always quality care.

Finally, addressing age-based discrimination and barriers will be crucial to allow the full participation of older persons in economies and societies. Older women and men actively volunteer in older persons associations or other organizations. They help distribute food and medicine in emergency situations, including during the COVID-19 pandemic, monitor the health of neighbours and friends, or teach each other how to use digital devices. Older persons also play an active role in combatting climate change by sharing knowledge and techniques of mitigation and adaptation. Ageism intersects and exacerbates other disadvantages, including those related to sex, race, and disability, and combatting it will contribute to the health and well-being of all.

Older persons are valuable members of our societies, but too often they are overlooked. Let us ensure that they can fully contribute to our sustainable future.

CUBA PLEDGES TO BUILD FERTILISER AND PESTICIDES PLANT IN TANZANIA

HE government has said importation of fertilizers from foreign countries would probably end if plans to bring Cuban investors to invest at the Kibaha based Labiofam plant.

Speaking to journalists yesterday shortly after meeting with Cuban Foreign Minister, Bruno Rodriguez Parrilla, Minister of Investment, Industry and Trade, Dr Ashatu Kijaji said they have agreed that Cuba will send a team of experts to sign contracts with the National Development Corporation (NDC) to increase production of pesticide and fertilizer to reduce

"The government imports 90 percent of locally used fertilizer, the Cuban investment at the Labiofam plant will significantly boost fertilizer production in the country," Dr Kijaji

He said a team of experts from Cuba are expected into the country from next weekend whereas among other things, it will be discussing with Tanzania authorities on obtaining accreditation for the factory to start operating.

Dr Kijaji added that the factory, which is run in partnership by Tanzania and Cuba has been successful in the fight against malaria as its products are going to be used to kill mosquito breeding grounds.

She said that malaria prevalence in the country is low, especially in Zanzibar.

Tanzania's Ambassador to Cuba, Valentino Mlowola promised to continue working to strengthen the relationship between Tanzania and Cuba for mutual benefits.

"The on-going discussion is a continuation of the positive fruits of the cooperation between the two countries which was initiated by the founders of the two nations," said Mlowola

He added: "The current fertilizer demand in the country is high; production at the Kibaha factory would facilitate its availability as one of the important agricultural inputs.'

NDC Director, Dr Nicolaus Shome said the factory plays a key role in boosting the country's economy as most Tanzanians are engaged in agriculture.

"Benefits of this factory in the agricultural sector are huge as the demand for fertilizer is high," said Dr Shome, adding that the government is determined to bring about major reforms in the agricultural

Dr Shome added that the factory started with eight technicians but the number has been growing. He said Tanzanians working at the factory will benefit with expertise brought by Cuban technicians.

THE Tanzania Women Chamber of Commerce (TWCC) has tasked the government to conduct a country-wide survey to see if the 10 percent loans issued by district councils to women, youth, and people with disabilities have an impact on them.

TWCC chairperson Mercy Sila made the challenge in an interview on Wednesday saying: "There is a need to survey so that we can have a proper data on how many women have benefited from these loans. This survey will make the government come up with the best solution."

She said: "We want to see if the business they carry out has brought positive changes to their lives, empowering them economically and socially as well as identify if their companies are growing or dying."

"As TWCC we want to see women take loans to benefit from it or they just take it for loan repayment because the majority of women-owned businesses are not growing. This study we'll make us see what's happened to them may be the district councils can change the loan procedure and allow more women benefit from it."

Sila also called on the TradeMark East Africa (TMEA) to assist them in conducting another research that will help them to identify constraints and impact of the 4 percent allocated for women by the district councils, provide recommendations and the way forward because the majority of women are not benefiting from those funds.

"You request 10m/- you get 500,000/- that is not enough because everyone has her business idea and when they issue loans they ask women to be in groups, we want them to consider individuals because other women have a big business that can help them to take loans individually instead of groups," she said.

TWCC was registered in 2005 and members of the chamber are enterprises and women's organizations.

Businesses hit hardest by liquidations under way in South Africa

NEW data from Statistics South Africa (Stats SA) shows that the total number of liquidations decreased by 1.6% in May 2022 compared with the same period a year ago.

Voluntary liquidations decreased by eight cases, while compulsory liquidations increased by five cases, the stats body said. The total number of liquidations decreased by 8.9% in the first five months of 2022 compared with the first five months of 2021.

The percentage change between March to May 2021 and March to May 2022, was -10.1%. Total liquidations amounted to 188 in May, up from 138 liquidations in April, and 182 in

Total liquidations to date amount to 788, down from 788 in 2021.

The trade, catering and accommodation sector continues to struggle post the pandemic, while financing, insurance, real estate and business services also saw a relative high number of closures in the reporting period

The Bureau for Economic Research (BER) said in a research note on Monday (27 June), that while South Africa's hospitality sec-

tor has seen a post-Covid rebound from a ter survey. This decline comes after a prior of hikes are expected this year, said Loos. low base, both hotels and restaurants still haven't seen a full return to normal.

In the second quarter, activity expanded strongly in the hospitality sector for the third quarter in a row, albeit at a slightly slower pace compared to the first quarter, the BER said.

The very high year-on-year growth rates for activity are due to the low levels of a year ago when few people went out to eat or travel due to Covid-19 fears and restrictions, the group said.

The BER also pointed to Stats SA data that showed continued weak hotel room occupation rates, while the real income of restaurants was still 35% below pre-pandemic

Commercial property activity

The second quarter of the 2022 FNB Commercial Property Broker Survey saw two of the three major commercial property sectors - office and retail - showing declines in perceived market sales activity levels, with only the industrial property market's activity rating rising further.

The percentage of broker respondents perceiving business conditions to be satisfactory declined slightly in the second-quarrising trend, remaining at a mediocre level, said John Loos, property sector strategist at

FNB Commercial Property Finance. This reflects an economy battling to fully recover from the very deep recession of 2020, and more recently pressured by rising interest rates, he said.

When asking brokers for their ratings of market activity levels on a scale of 1 to 10, we see that the group of respondents is still most upbeat about the industrial and warehouse property market. The industrial property market's second quarter 2022 activity rating rose from 6.2 in the prior quarter to

The retail property activity rating declined from 4.87 to 4.60 over the same two quarters. The office property market activity rating remained the weakest.

Rising interest rates may have begun to dampen the spirits of the market, said Loos. Global supply chain disruptions had been contributing to building global inflationary pressures, and more recently the war in Ukraine, and resultant sanctions and boycotts on Russia, have further exacerbated the problem, the strategist said.

The result has been 125 basis points' worth of interest rate hikes by the SARB since late 2021, while a further 100 basis points' worth

The FNB Commercial Property Broker Survey surveys a sample of commercial property brokers in and around the six major metros of South Africa, namely, City of Joburg and Ekurhuleni (Greater Johannesburg), Tshwane, Ethekwini, City of Cape Town and Nelson Mandela Bay.

Loos noted that this survey response gives a perspective of business confidence in the commercial property sector, which may be starting to reflect the recent business confidence trend for the broader economy, the latter having weakened since a few quarters

The RMB-BER Business Confidence Index for the second quarter of 2022 showed a similar 42% of survey respondents across the economy expressing satisfaction with business conditions, and this was a weakening from the prior quarter's 46 reading.

FNB also asked brokers about their perceived decline, increase or no change in activity levels compared to six months ago.

In the second quarter 2022 survey, even the industrial and warehouse market showed signs of losing strengthening momentum. "This implies that the respondents perceiving a strengthening in activity in this sector over the prior 6 months exactly

equals those that perceived weakening, said Loos.

The retail market returned a small negative reading, while the office property market reading was mildly positive.

"These indices in all three markets thus point to very little activity growth momentum having been perceived of late, interest rate hiking this year possibly having been the main cause of demand growth running out of steam," the strategist said.

Poor business confidence continues to weigh heavily on the commercial property market which has seen a marginal decrease in the number of commercial tenants in good standing in the first quarter of 2022 compared to the previous quarter.

The latest TPN Credit Bureau's Commercial Rental Monitor showed that tenants in good standing are those that have paid their rent in full and on time at the end of each month.

TPN's data showed that although the first quarter of 2022 indicates a small improvement compared to the last quarter of 2021, more than 10% of commercial tenants did not make any payment towards their rental expenses in the first quarter of this year, indicating the extent of their financial struggles.

NATO summit opens amid controversy, internal discord

MADRID

THE 2022 Summit of the North Atlantic Treaty Organization opened here on Wednesday amid mounting criticisms of the military alliance's aggressive security policy and lingering conflicts among its members.

NATO Secretary General Jens Stoltenberg told a press conference Wednesday afternoon that the leaders had decided to "transform and strengthen" the alliance at a "pivotal time for our security."

The decisions include strengthening NATO's forward defenses, enhancing the bloc's battlegroups on its eastern flank and increasing the number of high readiness forces to over 300,000, the NATO chief said, adding that the leaders had also agreed on a "comprehensive assistance package" for Ukraine.

At Wednesday's meeting, NATO invited Sweden and Finland to join the alliance, following Turkey's decision to lift a veto on the two countries' membership applications a day before.

"In any accession to the alliance, it is of vital im-

all allies are properly addressed," NATO leaders said in a joint declaration.

Turkey had initially been blocking the Nordic states' membership bids citing their ties with the Kurdistan Workers' Party and Syria's Kurdish People's Protection Units, which Turkey labels as terrorist groups.

But Turkey changed its position on Tuesday after a meeting of the leaders from the three countries together with Stoltenberg.

Despite Turkey's green light, the NATO chief acknowledged on Tuesday a lingering discord, saying "there will still be conflicts within the defense alliance.'

With the ongoing Russia-Ukraine conflict and the increasingly tougher western sanctions on Russia, strains among NATO allies have also intensified as the prices of energy and other essential commodities continue to soar, analysts have

"As a major center of conventions and exhibitions in the Asia Pacific region, the industry in Hong Kong has developed fast since its return to the motherland, particularly in the sectors of jewelry, clocks and watches, and beauty products," he said.

In the past years, scientists and researchers in the SARs have also widely participated in the country's major scientific and technological projects.

Pang Chuan, vice-president of the Macao University of Science and Technology, said universities in Macao and Hong Kong have cooperated closely in personnel exchanges, scientific and research cooperation, exchanges of laboratories and the joint education of students.

"Universities in Macao and Hong Kong are generally more international with more opportunities to take part in international cooperation," Pang said. "However, they are faced with a lack of supporting industries in the SARs.'

Pang suggested that universities in the SARs combine their advantages in research and development with hitech enterprises in the Greater Bay Area to better convert international scientific and research fruits.

Ma Chi Seng, a member of the Macao Sports Committee, lauded Hong Kong's sports achievements since its return to the motherland, noting that the Hong Kong SAR government has been dedicated to promoting Hong Kong as a city of international sports events, offering experiences that Macao could learn from.

FERDINAND Romualdez Marcos, 64, was sworn in as the 17th president of the Philippines yesterday at the National Museum in Manila with thousands of people witnessing the inauguration.

Wearing a native Barong Tagalog formal shirt, the son of former president Ferdinand Marcos took his oath of office, as his 92-year-old mother Imelda and family members look on.

Marcos said ensuring food sufficiency for a country battling soaring inflation will be among his top priorities as he began his six-year term.

Resident planners speed up beautiful countryside construction in East China

"IT'S a routine for me to work in the countryside two days a week," said "slashie" Jin Yuhang.

Jin is a designer of a state-owned architectural designing institute in Hangzhou, east China's Zhejiang province. He has been employed as a parttime resident planner for Tianmushan township in Hangzhou's Lin'an district since October 2018. Every week, he drives to work in the township 80 kilometers away from downtown Hangzhou for two workdays.

In Baihe village of Tianmushan township, neatly built new houses show a unique and attractive style belonging to canal towns in the lower reaches of the Yangtze River.

Jin joined the planning, designing, and construction of these houses, making them well integrated into the natural environment and surrounding structures in the village.

Villager Wang Zhihong is one who has benefited from the facelift. He has earned nearly 6,000 yuan (\$893.4) by renting out the spare rooms of his house, which was designed and built by Jin.

According to Zhao Haifeng, deputy mayor of Tianmushan township, some rural structures in the township were once oversized and encroached on neighboring properties or roads, and some didn't fit into the surrounding natural landscape or traditions.

To solve the problem, Zhejiang province, starting from June 2017, encouraged townships and subdistricts to invite resident planners to offer whole-process and multi-dimensional technical services and guidance on the planning, construction, and management of local structures.

Since 2017, Lin'an district has completed layout planning of 13 townships under its administration. Under the instruction of resident planners, the structures in all 222 local villages were built according to design drawings and fit well into the surroundings.

"Planning and designing are not just about office work. Great plans are made in the field," Jin said, adding that many of his design plans were improved as a result of on-site investiga-

In early 2021, Tianmushan township planned to demolish an idle school building and construct a neighborhood service center at the original site. After a field trip was made, Jin suggested converting the main body of the school building into the neighborhood service center. He also came up with detailed transformation plans, including reinforcing the main body, installing elevator, and elderlyoriented modifications.

Finally, Jin's plan was adopted for it avoided mass demolition and construction, shortened construction period and lowered general cost.

During the construction of the service center, Jin visited the construction site frequently to provide suggestions on the details of the construction chores, based on extensive solicitation of villagers' opinions, such as the gradient of the ramp on road and the height of the fence for the playground.

Jin has also played a significant role in the transformation of Yueliangqiao village of Tianmushan township, which has been turned from an obscure mountainous village into a popular tourist destination featuring vintage-style B&B hotels and pleasant

natural environment. He has taken part in every step of

the village's transformation, from the formulation of development plan to the arrangement of ornamental tree species. He also inspected construction sites to make sure the project make steady progress, and participated in the acceptance inspection and evaluation of projects.

"The value of planning lies in implementation," Jin said, explaining that resident planners must do a good job in the tasks following planning, such as reviewing construction drawings, management of construction, longterm operation, and maintenance, so as to ensure the smooth implementation of planning.

Russian division of Nokian Tyres will continue to operate

MOSCOW

THE division of Nokian Tyres in Russia will continue to operate, the plant in Vsevolozhsk will maintain the production, the company said in a statement on Wednesday.

However, the company noted that the final decision on the mechanism of further operation has not yet been made, negotiations with the parent company will be completed during the third quarter of this year.

Andrey Pantyukhov, General Director of Nokian Tyres in Russia, noted that "the sanctions restrictions adopted by the EU made it impossible for us to continue working in Russia as part of the Nokian Tyres concern."

"The management of the Russian company Nokian Tyres prepared and submitted a proposal on the future format of the company's operation in Russia in an autonomous mode to the board of directors of the concern," he added.

"We believe that the approval of this proposal will allow us to continue operating in Russia. However, the Board of Directors needs more time to make a decision. Also, the Board of Directors may consider other potential decisions as part of a controlled exit from the market. In any case, the goal is to implement the decision, which will ensure the continuation of the company's sustainable activities in Russia," Pantyukhov said.

He added that the company will continue its work in Russia, including the production of tires at the Vsevolozhsk plant, and does not plan further layoffs, despite the decrease in the production of the plant, whose products were mainly exported.

"Meanwhile, Nokian Tyres in Russia will continue its work, including production at the plant in Vsevolozhsk, and will fully fulfill all its obligations to employees, customers, consumers, suppliers, other partners and tax authorities," Pantykhov said.

He explained that after the EU introduced fifth package of sanctions the company will no longer be able to export tires manufactured at the the Nokian Tires plant in Vsevolozhsk after July 11.

"There will be a significant decrease in production of the Russian plant. The company does not plan to further reduce the number of personnel in Russia. Currently, we are working on how to provide the plant with raw materials amid sanctions restrictions to continue operating activities," Pantyukhov said.

On Tuesday, Nokian Tyres announced on its website that it has decided to initiate a controlled exit from the Russian market due to the situation in Ukraine.

The company stressed that this process will be done with due consideration to local employees and legislation. The Finnish tire maker notified the authorities of Russia's Leningrad region that it will lay off over 300 employees of its local plant in July.

Also on Tuesday, the French tire manufacturer Michelin announced that it would cease operations in Russia by the end of 2022 and transfer the Russian division to local management.

Brandishing a meat cleaver, two bearded men said in the video that they were avenging an insult to Prophet Mohammad caused by the victim.

They also alluded to Nupur Sharma, a former spokeswoman for the ruling Hindu nationalist Bharatiya Janata Party, whose remarks about the Prophet earlier this month triggered domestic and international outrage.

Ghumaria described the bloody attack on Kanhaiya Lal is his tailorshop in the city of Udaipur as "an act of terror". and said two suspects were being interrogated by federal investigators.

Two assailants slashed Lal's head and throat in an attack while he taking measurements, according to Bhawarlal Thoda, a city administrator in Udaipur.

R. Kelly sentenced to 30 years in sex trafficking case

DISGRACED R&B superstar R. Kelly was sentenced Wednesday to 30 years in prison for using his fame to sexually abuse young fans, including some who were just children, in a systematic scheme that went on for

Through tears and anger, several of Kelly's accusers told a court in New York City, and the singer himself, that he had misled and preyed upon them.

"You made me do things that broke my spirit. I literally wished I would die because of how low you made me feel," said one unnamed survivor, directly addressing Kelly, who kept his hands folded and his eyes downcast.

"Do you remember that?" she asked.

Kelly, 55, didn't give a statement and showed no reaction on hearing his penalty, which also included a \$100,000 fine. He has denied wrongdoing, and he plans to appeal his conviction.

The Grammy-winning, multiplatinum-selling songwriter was found guilty last year of racketeering and sex trafficking at a trial that gave voice to accusers who had previously wondered if their stories were being ignored because they were Black women.

Victims "are no longer the preyed-on individuals we once were," another one of his accusers said at the sen-

"There wasn't a day in my life, up until this moment, that I actually believed that the judicial system would come through for Black and brown girls," she added out-

A third woman, sobbing and sniffling as she addressed the court, also said Kelly's conviction renewed her faith in the legal system.

The woman said Kelly victimized her after she went to a concert when she was 17.

"I was afraid, naive and didn't know how to handle the situation," she said, so she didn't speak up at the time.

"Silence," she said, "is a very lonely place." Kelly's lawyer, Jennifer Bonjean, said he was "devastated" by the sentence and saddened by what he had

"He's a human being. He feels what other people are feeling. But that doesn't mean that he can accept responsibility in the way that the government would like him to and other people would like him to. Because he disagrees with the characterizations that have been made

about him," she said. The sentence caps a slow-motion fall for Kelly, who is known for work including the 1996 hit "I Believe I Can Fly" and the cult classic "Trapped in the Closet," a multipart tale of sexual betrayal and intrigue.

He was adored by legions of fans and sold millions of albums even after allegations about his abuse of young girls began circulating publicly in the 1990s. He beat child pornography charges in Chicago in 2008, when a jury acquitted him.

Widespread outrage over Kelly's sexual misconduct didn't emerge until the #MeToo reckoning, reaching a crescendo after the release of the documentary "Sur-

"I hope this sentencing serves as its own testimony that it doesn't matter how powerful, rich or famous your abuser may be or how small they make you feel – justice only hears the truth," Brooklyn U.S. Attorney Breon Peace said Wednesday.

A Brooklyn federal court jury convicted the singer, born Robert Sylvester Kelly, after hearing that he used his entourage of managers and aides to meet girls and keep them obedient, an operation that prosecutors said amounted to a criminal enterprise.

Several accusers testified that Kelly subjected them to perverse and sadistic whims when they were underage.

The accusers alleged they were ordered to sign nondisclosure forms and were subjected to threats and punishments such as violent spankings if they broke what one referred to as "Rob's rules."

Some said they believed the videotapes he shot of them having sex would be used against them if they exposed what was happening.

According to testimony, Kelly gave several accusers herpes without disclosing he had an STD, coerced a teenage boy to join him for sex with a naked girl who emerged from underneath a boxing ring in his garage, and shot a shaming video that showed one victim smearing feces on her face as punishment for breaking his rules. "The horrors your victims endured," U.S. District Judge Ann Donnelly said as she sentenced him. "No price was too high to pay for your happiness.

Lizzette Martinez was a 17-year-old aspiring singer when she met Kelly at a Florida mall. She was promised mentorship but quickly ended up "a sex slave," she said Wednesday outside court.

Asked whether Kelly's 30-year sentence was sufficient punishment, she paused before answering.

"I, personally, don't think it's enough," she said, "but I'm pleased with it.'

At the trial, evidence also was presented about a fraudulent marriage scheme hatched to protect Kelly after he feared he had impregnated R&B phenom Aaliyah in 1994 when she was just 15. Witnesses said they were married in matching jogging suits using a license falsely listing her age as 18; he was 27 at the time.

Aaliyah worked with Kelly, who wrote and produced her 1994 debut album, "Age Ain't Nothing But A Number." She died in a plane crash in 2001 at age 22.

Kelly didn't testify at his trial, but his then-lawyers portrayed his accusers as girlfriends and groupies who weren't forced to do anything against their will and stayed with him because they enjoyed the perks of his lifestyle.

His current lawyers had argued he should get no more than 10 years in prison because he had a traumatic childhood "involving severe, prolonged childhood sex-

ual abuse, poverty, and violence." As an adult with "literacy deficiencies," the star was "repeatedly defrauded and financially abused, often by the people he paid to protect him," his lawyers said.

Trades work in American sports, so why not in soccer?

he Los Ange-Dodgers baseball's answer to the question: "What if Manchester United were one of the smartest clubs in the world?'

In 2014, the Dodgers hired Andrew Friedman, something of a Billy Beane 2.0, away from the Tampa Bay Rays, something of an Oakland A's 2.0, to be their president of baseball operations. Friedman helped build a Rays team that made the World Series in 2008 and consistently featured in the playoffs despite running one of the lowest payrolls in the league.

The Dodgers hadn't won a World Series since 1988, but they lured Friedman away by making him the highest-paid executive in the sport -- and then giving him a ton of money to spend. Over the past eight years, Los Angeles has built up one of the league's biggest analytics departments, created one of baseball's top farm systems, developed an impressive track record of improving flawed players, and spent as much money on salaries as just about any other team. They finally won it all in 2020, and they're pretty much the favorites to win the World Series every season at this point. That trend doesn't seem likely to change any time soon, either: They began the current season with a leaguerecord \$310.6 million payroll and still have one of the league's five-best collections of prospects, according to MLB.com.

That all probably sounds pretty good to Chelsea fans, but at least for now, the Premier League club's new owner, Todd Boehly, hasn't hired another Friedman to overhaul makes it a little more diffithe latest sports team in his ownership portfolio. No, he's currently serving as his own Friedman. A handful of early reports suggest that Boehly wants to exploit a mechanism that his baseball team frequently uses but soccer teams almost never do: player trades. All of which raises a question that perhaps even Boehly himself is wondering: Why don't Premier League clubs trade their players more often? Well, because trades

don't exist In most American sports, players can be traded whether they like it or not. While a small number of stars have "no-trade" clauses negotiated into their contracts, the majority of players can be traded from one team to another, so long as their contract fits into their new team's roster in a way that doesn't violate the league's salary cap structure.

"In order to move a player in European football, it requires player consent," said Jake Cohen, a sports lawyer. "So a player has to agree to any transfer. whether that be permanently or on loan, which cult for teams to move players as they do in American sports. In European footthat can be negotiated

damental right guaranteed by FIFA."

For example, the Dodgers acquired MVP outfielder Mookie Betts from the Boston Red Sox (owned by Fenway Sports Group, the owners of Liverpool) via trade in early 2020. They then signed him to a 12year, \$356m extension that employs him through 2032, when he'll be 40 years old. Betts' contract does not have a no-trade clause, so if for some reason the Dodgers eventually decide to trade him to, say, the Kansas City Royals, then Betts won't be able to do anything about it. He'll still get paid the same amount, just by a new team. Hope you like barbecue.

Compare that the Romelu Lukaku situation. Not only did Chelsea pay Inter Milan a transfer fee of \$124.3m to acquire the player in 2021, they then gave Lukaku a five-year contract worth around \$85m in total. If the soccer world operated under the same conditions as MLB, perhaps Chelsea could have traded Lukaku for some other star player this summer, but they still would have had to find a team that wanted to acquire Lukaku at that same contract. Instead, Lukaku first had to agree to move to Inter Milan on loan for a season, and then Chelsea and Inter Milan had to separately negotiate a loan fee. What about swap deals? So, yes, there have been

what the European soccer world refers to as swap deals, where two players exchange teams, typically with an extra monetary amount being paid by the team who is acquiring the more valuable player. In 2009, Inter Milan and Barcelona swapped Samuel Eto'o and Zlatan Ibrahimovic, with the Catalan club paying an extra €45m to acquire the Swede. In 2011, Chelsea acquired David Luiz by paying €20m and sending Nemanja Matic, who would rejoin Chelsea three years later, to Benfica. In January of 2018, Manchester United swapped Henrikh Mkhitaryan for Alexis Sanchez, and the pair were reportedly considered equally valuable by both clubs because Sanchez's deal expired at the end of the season. And most recently, in 2020, Juventus paid €12m to acquire Arthur (valued at €72m) from Barcelona while sending Miralem Pjanic (€60m) the other

to remember that these moves only happened because all of the players agreed to leave their current clubs and sign new contracts with their new teams.

"When there's a transfer. it's usually a player moving in exchange for money, Player A to move."

and there's a couple negotiations going on," said Cohen. "There's the negotiation between the buying club and the selling club over the value of the player, or what the transfer fee is going to be. And there's a second negotiation going on concurrently between the buying club and the player over what the player's new employment contract is going to look like." This is why so many

transfers fall apart and become grist for the rumor mill: Two negotiations have to succeed. Let's just hypothetically say there's a 50-50 chance that any given negotiation is successful. Then the likelihood of a given transfer coming to fruition -- the two clubs agree and the player and his new club agree -- would be just 25%. (For the nonmath-inclined out there: $0.5 \times 0.5 = 0.25$.) If you're doing a swap deal, you now need four separate negotiations to work out, and that drops the likelihood of success in our hypothetical

world down to just 6%. "Instead of two concurrent negotiations going on, you now have four concurrent negotiations going on," said Cohen. With Player A, you have the negotiation between the buying club and that player's value. With Player B, you have a second negotiation over what that player's value is. You need the two clubs to agree to what the valuations are and how they're going to offset each other. Then, Player A and Player B both need to agree to new contract terms to their respective new clubs.'

However, there's also a fifth and sixth variable on both sides.

"If agents get wind that there's a potential player swap in the mix, they're going to attempt to lever-Again, it's important age that for the benefit of their own player," Cohen said. "They know that, 'Oh, if Player A is moving, then Player B is the key to this whole thing so we want a 20% increase in the overall compensation package.' If Player B doesn't move, that impacts the potential of

On top of all the transactional complications, there's also just a simple question of logic beneath all of this. None of the major American sports leagues have more than 32 teams. If you're a top team, then about onethird of those teams aren't going to trade with you because you're a competitor. And another third of those teams probably don't have players you want. So, there's only a small subset of professional baseball/ football/basketball teams that have players you'd be willing to try to acquire.

In the soccer world,

there are literally hundreds of other teams that you could theoretically sign valuable players from. The two best teams in the Premier League, Liverpool and Manchester City, just landed two players (Darwin Nunez, €75m, from Benfica and Julian Alvarez, €17m, from River Plate) from teams that don't even belong to the five biggest leagues in Europe, while Real Madrid brought Champions League-winning goal scorer Vinicius Junior in from Brazilian side Flamengo for €45m in 2018. Given all of that, what are the chances that the best player Chelsea could acquire for a given amount of money plays for a team that feels the same way about one of the players Chelsea currently employs but also would be willing to get rid of?

If the club's new ownership wants to remain competitive atop the Premier League without the massive transfer losses that Roman Abramovich funded every year, Chelsea are going to need to get more value out of the money they spend on signing players. Limiting your potential acquisition pool to transfer listed players on teams who would also want your players just isn't the way to get the most out of what you spend. It's not how the Dodgers won the World Series, and it's probably not how whoever Boehly hires to replace himself will do business either.

Ronaldo seeks \$626K from lawyer in rape case

LAS VEGAS

CRISTIANO Ronaldo is asking a U.S. judge to order a woman's lawyer to pay the international soccer star more than \$626,000 after claiming in a failed lawsuit seeking millions of dollars that Ronaldo raped the woman in Las Vegas nearly a decade earlier.

In a bluntly worded document, Ronaldo's attorney, Peter Christiansen, asks U.S. District Judge Jennifer Dorsey to make the woman's attorney, Leslie Mark Stovall, personally responsible for amount.

Stovall did not immediately respond Wednesday to telephone and email messages. Text messages to associate Larissa Drohobyczer were not answered. They are due to file an answer with the court by July 8.

Dorsey on 10 kicked the case out of court to punish Stovall for "bad-faith conduct" and the improper use of leaked and stolen documents to

pursue the case. Stovall "crossed the

before he filed this action, and his disregard for the rules of this court has continued unabated," the judge found.

Dorsey said in her 42page order that dismissing plaintiff Kathryn Mayorga's case outright with no option to file it again was a severe sanction, but said Ronaldo had been harmed by Stovall's conduct.

The Associated Press generally does not name people who say they are victims of sexual assault, but Mayorga gave consent through Stovall and Drohobyczer to make her name public.

The bid for court costs and fees for Ronaldo's attorneys, filed Friday, dwarfs the \$375,000 hushmoney payment that Mayorga received in 2010 to sign a confidentiality agreement and drop a criminal complaint alleging she was sexually assaulted.

"Given Stovall's abuses and flagrant misconduct, Stovall should be made personally responsible for ensuring Ronaldo is reimbursed for having to defend against his vexatious

border of ethical behavior and bad faith conduct," Christiansen's request for reimbursement said. He tallied attorney fees at between \$350 and \$850 per hour for nearly 1,200 hours of work.

Mayorga's civil lawsuit -filed in 2018 in state court and moved in 2019 to federal court -- eventually sought more than \$25 million in damages, plus attorney fees for Stovall.

It alleged that Ronaldo or his associates violated the confidentiality agreement

before a German news outlet, Der Spiegel, published an article in April 2017 titled "Cristiano Ronaldo's Secret" based on documents obtained from what court filings term "whistleblower portal Football Leaks.'

Ronaldo's attorneys accuse Stovall of obtaining stolen material containing privileged attorney-client communication and then trying repeatedly to make them pubic by attaching them to court filings

Mayorga is a former model and teacher who lives in the Las Vegas area. Her lawsuit said she met Ronaldo at a nightclub and went with him and other people to his hotel suite, where she alleged he assaulted her in a bedroom. She was 25 at the time. He was 24.



The official revealed: "The founder of these companies came to Tanzania and was a man focused on science and environmental issues and loved to work with Tanzania but it was not possible.'

Grothkopp pointed out: "Today we are ready to develop his ideas by entering into a partnership to support sports and the arts in Tanzania."

He further commended President Samia Suluhu Hassan for participating in the Royal Tour film, saying it has informed Americans and other people around the world about the beauty of Tanzania in tourism and investment.

The official disclosed: "I have watched the film and will watch it again, it is a completely international content, we are also ready to partner with you to promote Tanzania through our sports clubs and stadiums."

Abbas invited the company to partner with Tanzania as it is a country full of sports and artistic talents and promised that all key stakeholders in Tanzania will cooperate with the firm.

The medals are gold, silver, and bronze for the first, second, and third places finishers.

"Points will be allocated to first to 10th places, the top swimmer will get 20 points, second (16 points), third (14), fourth (12), fifth (10), sixth (eight), seventh (six), eighth (four), ninth (two) and 10th will get one point," she said.
