



Young engineers flying out for SGR operations training

A TOTAL of 14 young Tanzanian engineers are scheduled to leave for South Korea on Thursday, December 1 for five months of intense training on electric train operations on the standard gauge railway.

Masanja Kadogosa (pictured), director general for the Tanzania Railways Corporation (TRC), said at a send-off event in Dar es Salaam over the weekend, that operations training is part of contractual arrangements between TRC and the Korean Railroad Corporation (KoRail).

The accord provides for supervision of operations for a limited period and intense training for TRC staff to take over all lines of operations in due course, signed on

July 4 in the presence of President Samia Suluhu Hassan, at the State House in Dar es Salaam.

The training will focus on operations, rail safety, machines, information technology and maintenance of rail infrastructure in construction, signaling, communication and electric circuits, he stated.

PRESIDENT Samia Suluhu Hassan yesterday instructed record keepers and personal secretaries to perform their duties professionally and ethically for enhanced confidentiality.

Opening the 10th annual meeting of the Tanzania Records and Archives Management Professionals Association (TRAMPA), the president said the sector is the government's soul and the hub of its achievements.

She instructed Minister Jenista Mhagama (President's Office - Public Service Management) to work with her Zanzibar counterpart Haroun Ali Suleiman (Public Service and Good Governance) to link up efforts enhancing skills and ethics in the sector.

She directed the allocated a plot of land in the capital city area in Dodoma for TRAMPA to build a skills enhancement centre.

If members of the cadre lose records and archives nothing will be accomplished; she stated, remarking that even retired people will fail to get their records when pursuing their benefits from social security funds.

One mistake in record keeping will cause people to lose their rights and being up complaints, she said, underlining that records keeping has been simplified by technology,

technology of operating electric trains, he tasked the selected engineers to learn hard to add sufficient value to their level of expertise, he said.

Learning hard will help them to achieve their professional goals and corporate objectives, he stated, asking them to always must remember that they are public servants. "If anyone misbehaves, stern measures will be taken against such individuals," he said.

They will in due course be responsible for teaching others directly handling train operations, he pointed out, noting that the training is part of take-off preparations starting from the Dar es Salaam to Morogoro section now nearing completion, followed by the Morogoro-Makutupora section also veering towards completion.

'With rains, power supply gap ending'

THE 350 megawatts power supply gap prevailing during the past month has largely been restored and just about 100MW will be in short supply in the coming days, the power utility has declared.

Maharage Chande, managing director for the Tanzania Electric Supply Co. Ltd (TANESCO) said at the will continue to speak the truth and solve people's complaints in time weekend that since the rains have started and hydropower plants at Kidatu and Iyovu water levels increase, the situation will be vastly improving at the start of December.

With power rationing continuing to ease by February there will be no power rationing as Kinyerezi I gas-fuelled power plant will be added to add a more reliable power supply.

Answering questions from members of the public at the weekend via the Twitter social media platform which involved 1,000 people, he objected to the power shortages being made into a political issue.

World Bank praises Hai renewable energy centre

KIKULETWA centre for renewable energy training and research is a laudable example of how Tanzania is using renewable resources to come up with profitable projects, especially those empowering the youth, a senior World Bank official has stated.

Nathan Belete, the country director for Tanzania, Malawi, Zambia and Zimbabwe, made this remark at a visit to the centre, part of Arusha Technical College (ATC) which has wider regional links.



The centre is engaged in rehabilitating an ancient hot springs power station and using this facility and other innovation units to serve as a regional centre of learning in renewable energy.

It focuses on hydropower, solar, wind and biomass and supplies power to the national grid, where feasibility studies indicate that the current Kikuletwa potential is 1.7 megawatts.

Experts say the site could provide up to 17 MW of electricity, but the centre focuses on training artisans, technicians and professionals in power generation technologies.

The core area is micro hydro turbine testing and certification plus active participation in power generation by using renewable energy resources, earning World Bank praise for prudently utilizing funds directed at implementing key renewable energy projects.

The global lender injected 37bn/- into the ATC centre at Kikuletwa area in Hai District, TURN TO PAGE 2

demanded to know when the government will allow private investors to invest in the sector, citing Mtwara, Somanga Fungu and Kinyerezi gas power generation, and when TANESCO will be placed on the Dar es Salaam Stock Exchange (DSE).

Chande said private sector investments in the energy sector were a slow process "due to the history of lies than reality." He said the corporation wasn't afraid of working with the private sector, "but to be safe in the energy sector one has to be transparent."

He said the main challenge in power generation projects is the price of electricity, focusing on the price the producer will sell to TANESCO after generating, as there is a price differential between natural gas and hydropower (half of quotable natural gas wholesale price),.

He said the majority of people who participated in the debate that TANESCO had organized were unfamiliar with technical issues, demanding that "politicians stay away from power generation and distribution affairs. Instead, the issues should be dealt with by professionals in order to have a permanent solution for the country's power woes.'

He even asserted that the stateowned utility "will continue to speak the truth and solve people's

complaints in time," taking up the technical aspect once again in remarking that the country's power needs continue to rise.

"We have new consumers every day," he stated, pointing out that in the past six months there was no drought challenge but drought complicated supply drawbacks.

Ubungo MP Prof Kitila Mkumbo said during the online debate that politicians need to give chance to experts "as they are well mobilised only that politicians keep on derailing them."

He appealed to TANESCO to "have own answers for power outages by researching before announcing to the public, to enable the politicians to understand" the issues involved.

One contributor raised claims that TANESCO "was letting out water from hydropower dams to allow electric generators business to flourish," which the CEO sharply discounted.

He cited statistics showing that in 2011 and 2015 there was acute drought, and then in 2016, 2018 and 2018 average drought conditions prevailed. What TANESCO did was to deny power to big industrial producers and supply it to households, thus stemming acute power shortages in household use.

TANESCO cannot let out water from hydropower dams without following proper procedures or seeking to boost the trade in generators, he added.

Speaking in Dar es Salaam over the weekend during the inauguration of e-GA's board of directors Mhagama said there are still a number of loopholes that allow misuse of public funds, especially in local government authorities.

She also wanted the board to address challenges facing lowincome citizens in accessing services.

"I want the board to come up with strategies to solve the challenges facing citizens in the grassroots, we want every citizen to be able to use the services regardless of geographical locations," she said.

She further noted that e-GA board

members need to make sure that affecting many low-income citizens to make their lives easier.

"The guarantee given to you by the government is great and it is our expectation that you will work with integrity, a high level of professionalism and in the broad interest of our country as per laws and regulations," she said.

Mhagama further wanted the board to adhere to the relevant guidelines so as to meet stakeholders' expectations and bring productivity in the implementation of day to day activities.

"Think outside the box in different ways about how people can access online services from our government by eliminating the challenges that they face from wherever they are," she added.

COVID-19 vaccine uptake in Dar es Salaam Region has reached 3.4 million people surpassing the set target of 3.3 million, Regional Commissioner Amos Makala said yesterday.

Addressing joggers after a walkathon organised by Aga Khan Health Services in partnership with European Union and Aga Khan Development Networks, the RC urged the community to protect the most vulnerable and themselves through vaccination.

Makala said the walkathon aimed to raise public awareness and uptake of the COVID-19 vaccine to make people safe from the pandemic.

"I commend Aga Khan Health Services Tanzania and the EU for their efforts and timely support to the government particularly Dar es Salaam in strengthening health systems including promoting vaccination against COVID-19," he said.

Makala said the pandemic is far from over and that the risk of new variants, especially in under vaccinated populations, remains

high.

Theresia Mohele, Programme Manager of the EU COVID-19 response partnership programme said the walkathon is one of the joint activities implemented through the Eastern Africa COVID-19 response partnership project funded by the

EU. It aims at complementing the government of Tanzania's efforts in response to the Covid-19 pandemic, by strengthening healthcare systems and service delivery.

She said the initiative was accompanied by the dissemination of information on the importance of Covid-19 vaccine by different healthcare professionals and the respective government authorities were present to administer the vaccine to those who required it at the venue.

Dar es Salaam Regional Medical Officer Dr Rashid Mfauma thanked the AKHST in collaboration with the EU for the training to health providers and provision of equipment including masks during the pandemic.

He said the exercise was very important for the body, noting that it helps to keep it free from noncommunicable diseases such as cardiac, respiratory diseases, cancer, diabetes and hypertension diseases.

Men demand inclusion in **GBV** movements and laws

THE government has been urged to equally consider men's basic rights as women and children in its action plans if gender-based violence is to be slowed down and eliminated in the country.

Speaking at a consultative dialogue held in Dar es Salaam at the weekend, a cross-section of over 50 men from different professional and socioeconomic activities, advised the government not only to consider men as perpetrators of gender-based violence but part of the victims.

The dialogue organised by Tanzania Gender Networking Programme (TGNP) and UN Women was held to mark the beginning of the 16 days of activism against gender-based violence an annual international campaign that is being commemorated between November 25th and December 10th, the human rights day.

The dialogue brought together lawyers,

human rights activists and defenders, businessmen and from other professionals to discuss the mutual solution for abolishing gender-based violence in Tanzania.

Dr Katanta Simwanza, Engender Health senior programme technical advisor said that men are not viewed as gender-based violence victims when it comes to discussions of the issue in government policies and laws.

Simwanza argued that the National Plan of Action for Prevention of Violence Against Women and Children (NPA-VAW-2017/22) had portrayed men as perpetrators of violence but not highlighting them as victims of the same the other side.

"The action plan has eight components, all defending women and children. Our research at the institution shows that men are victims of gender violence by their wives but no one talks about it. This has to be balanced if gender-based violence is to be discouraged," said Simwanza.

He suggested that since the government

is currently drafting a new five-year action plan on the same issue, it has to contain a component that identifies men as victims of gender-based violence.

Mlowe Pasience, an advocate at 4Cz' Attorney and Consultancy argued that differences in economic positions between men and women have played a key driver in gender-based violence among others.

He said the same initiative the government initiates in empowering women economically should be the same way for men.

"Majority of institutions and government entities are paying much attention to women empowerment and as a result, when women are empowered they tend to turn everything at the family level under their control which results in brutal men's reaction," argued Pasience.

Dotto Zabron, professional teacher and gender issues activist said that lack of respect and recognition by married women to their husbands accompanied by infidelity is another source of violence.

According to him, men tend to beat women just in the protection of respect and recognition and thus more educative programmes are needed to sensitize communities, especially those with traditions that embrace men as the final judge of everything at the family level.

Omani firm gets green light for gas recovery after end of talks

ENERGY Minister January Makamba has said that the signing of the new natural gas agreement is historic because it's the first in 12 years, and has increased government benefits to 75 percent from 68 percent.

Production Sharing Agreement (PAS) involves the development of the Ruvuma block where the operator, ARA Petroleum Tanzania Ltd, which originates from Oman, has discovered natural gas.

Makamba made the remarks at the weekend in Dar es Salaam when the government and the oil and gas firm signed the addendum for Ruvuma PSA after completing the negotiation of terms between the Government Negotiation Team and ARA Petroleum Tanzania Ltd.

The signed gas addendum involved participating interest, profit share, royalty, and taxes, as well as levies that will constitute the 75 percent economic benefits.

The pact will also see an increase in withholding taxes-municipal levies as well as short and long-term, direct and indirect employment for Tanzanians.

In the pact, Tanzania Petroleum Development Corporation's (TPDC) national oil company holds a 15 percent participating interest.

The minister asked the TPDC and investors to ensure that the implementation of the gas project goes at high speed because all the exploration activities are already done.

"We want at least after 12-18 months, the gas should start flowing," he said, stressing that during the signing ceremony between the government, TPDC and ARA Petroleum Tanzania Ltd, the move provided confidence to other investors that the oil/gas exploration has started again.

Makamba also said for the first time under PSA, the government will earn huge as compared to previous contracts, adding it will also provide huge employment opportunities to Tanzanians, noting: "This project goes in line with plans of the government to

revive the Liquefied Natural Gas (LNG) negotiation which is ongoing in Arusha,

which will soon be concluded." TPDC director general Dr James Mataragio said the Ruvuma PSA goes back to 2005 when the agreement was signed by three parties, the government, TPDC, and Ndovu resources. In 2020 the company farmed out its 50 percent share to ARA petroleum limited.

He said at that time the consortium drilled two exploration wells, Ntorya1 and Ntorya 2, and discovered 466 billion cubic feet of natural gas.

Mataragio stated: The Company is now planning to drill at least 8 explorations and the development of the wells is anticipated to start next year."

He noted that the Ruvuma shareholders are expecting to invest approximately \$500 million in the development and production of the Ntorya gas field.

"As of this year, the Oman company ARA petroleum has invested an audited amount of \$52 million in the project."


He further said the current production of natural gas from onshore fields stands at 230 million standard cubic feet per day (mmscfd), whereby over 80 percent of it goes into power generation, and the rest is consumed in industries, household and Compressed Natural Gas for vehicles.

Mataragio noted: "We will continue to work with the company to complete the work obligations including the acquisition of way leave, construction of a 35km pipeline from Ntorya to Madimba gas plant with the aim of accomplishing the development of gas as soon as possible."

Erhan Saygi, ARA Petroleum Tanzania Ltd, general manager said the agreement is the first step of a long way journey in the development of the Ruvuma block as a gas field.

"We're preparing ourselves for the next stage project which is the development of this field in a safe, costeffective, but rapid fashion."

According to him, Tanzania has a growing demand for energy, and the Ruvuma block will fuel the growth of the country's economy.



Dr Kijaji said the AU Heads of State and government commended President Samia Suluhu Hassan's contribution to encouraging African women and youth to take advantage of the AfCFTA by participating fully in trade.

AfCFTA seeks to increase intra-African trade by 52 percent by the year 2022 and remove tariffs on 90 percent of goods.

Tanzania is already benefiting from the vast African markets as out of the 54 countries in the AfCFTA, it is already trading

with 19 countries under the East African Community (EAC) and Southern African Development Community (SADC).

AfCFTA covers a market of 1.2 billion people and a combined GDP of \$3.4 trillion. It is expected to strengthen the value chain for agricultural crops, stimulate production and boost smallholder farmers engaging in the cultivation of sunflower, cotton, spices, cloves and horticultural products.

"We also need to educate our traders, especially the small and medium scale entrepreneurs on the available market opportunities and business challenges," he said adding more emphasis should also be directed on improving packaging and branding of locally manufactured goods.

TAMWA to submit misgivings on Zanzibar Kadhi Courts Act

TANZANIA Media Women's Association-Zanzibar (TAMWA-Zanzibar) in collaboration with civil Society Organisations (CBOs) will on December 2 this year start celebrating 16 days of activism against gender based violence by presenting a report on the existing shortcomings on the Zanzibar Kadhi Courts Act that oversee issues of inheritance and divorces with the aim of having one Islamic law that will deal with family issues and which will mete out justice and equality to women and children.

The celebrations will take place at ZURA Hall in Maisara and will involve important participants from both government and nongovernment institutions which deal in legal issues, human rights and anti-GBV activists.

Among the laws that are cited to be outdated and seen to have many deficiencies includes the Kadhi Courts Act (No 9 of 2017), Mufti Act (No 4 of 2021), the 2007 The Waqfu and Trust Commission Act and Children's Act (No 6 of 2011).

These laws are cited as deficient as they deny women and children of their rights, especially in regard to inheritance, widows' rights after divorce and children upkeep after divorce.

Apart from many challenges in the laws in regard to women's rights, there are also laws that recognise the place of women in various issues, including the Kadhi Courts Act, Section 5(1) (f) that has given the women the right to submit complaints in regard to wealth distribution.

This could remove the long time repression on women who are left

poor after being denied of their inheritance.

However, the said section does not provide any concession to women as the implementation thereof follows the Judge's whims.

During the 16 days of anti-GBV anniversary celebrated worldwide, there are still many challenges facing women and children including the continuation of gender based violence and child abuse due to lack of a robust system to protect them. This year's slogan for the celebrations is "Lets Unite to Eradicate Gender Based Violence and Child Abuse" which calls for urgent steps to eradicate the problem.

Among CBOs to participate in the 16-day celebrations include Zanzibar association for the Disabled (UWZ) Zanzibar Legal Services Centre (ZLSC), Zanzibar Association of Development Writers (WAHAMAZA), TAMWA-Zanzibar and Zanzibar Female Lawyers Association (ZAFELA).

CCI embarks on study to find out reasons behind increasing problem of unplanned settlements

THE Centre for Community Initiatives (CCI) has embarked on a study aimed to dig deep into the causes behind the increasing number of unplanned settlements despite various efforts taken to address the challenge.

The study is conducted under the global project dubbed: African Cities Research Consortium (ACRC), a major six-year investment by the UK's Foreign, Commonwealth and Development Office (FCDO) to fund new, operationally-relevant research to address intractable development challenges in African cities.

Speaking during the event to discuss challenges facing residents in unplanned settlements in Dar es Salaam over the weekend, Dr Tim Ndezi, CCI executive director said the study will be engaging communities and key leaders so as to get to the real issues before coming up with recommendations.

"We commenced the study mid this year and it will go until late March, next year where we will issue recommendations for the government to take required measures to address various challenges including putting strong but friendly systems to promote land surveying," he said.

He said that inclusive, affordable and adequate housing is the key to the sustainable transformation of cities and communities, fighting poverty and other risks.

He said researchers will dig deep into why the problem was increasing and possible measures which should be taken to fight the vice.

Elaborating more about the study, Samwel John from CCI said the study is conducted in three major districts in Ilala, Kinondoni and Temeke.

He noted that 80 percent of Dar es Salaam residents live in informal settlements where they face a lot of challenges including lack of water due to poor systems, access to quality health and education services as well as poor sewerage systems.

Globally, approximately 1 billion people are living in informal

settlements/ encampments/slums. Among this 1 billion, approximately 238 million people are in sub-Saharan Africa. Even in the best of times, conditions in these informal settlements are often grossly inadequate. The communities are overcrowded, and families living there have no adequate water, sanitation, or regular income.

Husna Chechonge, coordinator of research of the Tanzania Urban Poor Federation (TUPF) commended CCI for coming up with the project as it will help stimulate more measures to fight informal settlements.

She noted that the urban poor struggle with issues of poor housing and threats of forced eviction. The population struggles very hard to access surveyed plots and when available they are sold at high prices, something which led them to settle in unplanned and sub-serviced settlements.

Dr Colman Msoka, who will research household microenterprises (HMEs) said the study is aimed to come up with crosscutting solutions that in the end help fight the increasing number of informal settlements for sustainable development.

"When you speak about HMEs, you will not skip the issue of housing as most of these businesses operate using family houses where a trade resides, the businesses are increasing but most of them do not grow with many also dying," he said.

Dr Msoka said that homebased businesses such as baking, processing, tailoring, repair works are important engines and drivers of socio-economic development but unfortunately they are not considered.

He said that the major aim is to generate insights and evidence that will help improve the living conditions, services and life chances of all city residents, particularly for disadvantaged communities.

Sabatho Nyamsenda from the University of Dar es Salaam (UDSM) said the study will also look at the political area, policy issues and how this was affecting the growth of planned settlements.

In management and higher positions they are under-represented (UNWTO/UN Women "Global Report on Women in Tourism" (2010)).

The factory was inaugurated at the weekend during the visit of the Katavi Region AGRI-CONNECT Advisory Committee that incorporated EU representatives and officials from both the ministries of Agriculture and finance and Planning.

KIBOWAVI director, Daniel Kalimbya said the project has cost euro 93,000, equivalent to 213m/by revamping an existing building as well as other structures and perimeter fence.

Kalimbya said they also built standard certificate.

The project is part of the a shop from sale of processed implementation of the initiative horticulture products, 'lishe' flour mill, spices processing machines and toilets. "We have also installed CCTV cameras and solar power systems for solar driers, wine making machine and other infrastructures," he said.

A lot depends on SADC regulators harmonising internet roaming costs

in the member states of the Southern Africa Development Community (SADC) are seeking to find ways of lowering internet roaming fees in each of them.

The idea is to make it easier for traders and other players to use the same channels or ICT products in the regional market.

Dr Khalid Mohamed, Zanzibar's Infrastructure, Communications and Transport minister, raised this issue when opening the ongoing second conference of the economic regulation committee of the association of communications regulatory bodies in the SADC region (CRASA).

He expressed readiness by Tanzania, as the host country, to further examine ideas on the table. The conference, whose host is specifically the Tanzania Communications Regulatory Authority (TCRA), was a follow-up to the drafting of a proposal for cutting roaming fees.

So far, it is a proposal largely drawn up by the CRASA secretariat, with undetermined inputs by member countries. The nearly week-long forum will seek to make out what works, and what might not, in relation to adopting the proposal and opening up cross country internet use.

The overall goal is that people across the region pay less for communication services whenever they cross into other member states, in which case sector ministers will go through the proposal to find out what can be done to lower roaming charges.

This effort will be tied to guidelines applicable to member states of the International Telecommunications Union (ITU), whose representatives are also understood to be in Zanzibar for the forum in progress.

Other facilitators at the event will definitely be available to assist at the

EGULATORY authorities national level or within the SADC secretariat, as needed.

Local organisers say the conference was primarily meant to cover a training seminar on broadband indicators, ICT price baskets, telecommunications bundling plus tariff collection, analysis and reporting.

TCRA executives specifically said that CRASA members would examine issues crucial to the growth of the communications sector, in particular strict the cost management of communications and attached services.

So far, the mood has been to project a fruitful session "so that everyone who attends, including TCRA delegates, will leave with engaging yet manageable homework". The barest minimum is to sink into that engagement and focus on a least common denominator to use.

Until now, what is most noticeable is the range of problems to be sorted out, the breadth of issues to be covered, where those attending the conference would first learn about communications cost planning and packaging for a better understanding of the issues.

This was likely to ease TCRA's outreach efforts in that regard given the fact that it is Tanzania that is home to the broadband backbone, a fibre optic cable joining planetary communicative highways with East Africa. It is among the more important such facilities in Africa, whatever may be the control, ownership details.

Top CRASA secretariat officials have said that member countries have been working on the harmonisation of regulations guiding the cost of communication services. They say the CRASA electronic communications division had prepared a study of indicative costs and are only waiting for the member countries "to embark on its implementation".



Telling the truth - even when it hurts

HOUGH they often claim to be detached observers, journalists enjoy, even unconsciously, being on the right side of history, fighting the "Good War," defending the "good guys".

The conflict in Ukraine is an example of what Herbert Gans, in his seminal 1980 essay entitled Deciding What's News, calls journalism's "enduring values".

"Some wars are fiendishly complicated and contain multitudinous shades of grey, but this one is (...) easy to characterise as an old-fashioned morality tale of good versus evil, or David against Goliath," Ben Coates wrote in Politico, ten days after the Russian



contradict the pro-Western, anti-Russian discourse on the war must also be told.

A June public opinion survey in Brazil, Germany, Poland, the UK and the US by the Reuters Institute for the Study of Journalism found that less than half the respondents thought that the media had provided a "range of different perspectives on the conflict".

Russian disinformation massive but Ukrainians' "patriotic storytelling at times takes liberties with reality," wrote Doan Bui in the French (strongly anti-Putin) liberal weekly L'Obs.

Kyiv may also be taking liberties with media freedom. The Committee to Protect Journalists (CPJ) warned on July 28 about a "draft media law that threatens to restrict press freedom in the country and would move it away from European Union standards". CPJ is an American independent non-profit NGO based in New York City, with correspondents around the world. Its mission is to promote press freedom by defending the right of journalists to report the news safely and without fear of reprisal and protecting the free flow of news and commentary by taking action wherever journalists are under threat. Of course, the Western media's war coverage, despite inevitable flaws, cannot be compared with the Russian media which have been put under total state control. But it is a reminder that in liberal democracies, journalists must distinguish themselves by providing all the news (and opinion) "that's fit to print".

We need to heed pleas for help even

centre devoted exclusively to caring for children with autism was once crying out for support, saying demand for its services by far outstripped the capacity it had to help out really meaningfully.

This is none other the then threevear-old Dar es Salaam-based World Federation Autistic Dav Care Centre (WFADCC), as it spoke about the daunting challenges it had been contending with.

The occasion was a memorable parents' visiting day, which was appropriately coloured by a fancy dress show where children with the medical condition were the main players.

These are times when most people's attention is often automatically drawn to overtly deadly or debilitating diseases like malaria, cancer, diabetes, tuberculosis and HIV-&-Aids, as "less violent" ones go virtually unnoticed.

Experts describe autism as a complex set of neurobiological disorders which typically last throughout a person's lifetime but which, despite the life-long plight of the victims, fall under the second category. This is most unfortunate because early professional intervention can expose the victims to a normal development process.

disrupts social and Autism communication skills, implying an impaired ability to read, move around and manage various other social cues. Its incidence in the US is approximately one out of every 150 births.

It was reported that 67 children were diagnosed with the condition every day, that a new case was diagnosed almost every 20 minutes, that more children would be diagnosed with autism than with Aids, diabetes and cancer combined, and that autism is the fastest-growing serious developmental disability in the US costing the nation over US\$35 billion a year.

As if these statistics were not gloomy enough, we are told that there is no medical detection or cure for autism and that the condition received less than five per cent of the research funding of many less prevalent childhood diseases.

It is hard to say how precisely much light annual and other commemorative events shed on autism, a disability usually beginning before three years of age.

But a consultant physician then serving as WFADCC's managing trustee once aptly underscored the need for society to chip in and help mitigate the havoc that autism can cause on children and the larger society.

Accordingly, he extended unqualified gratitude to all those who had been supporting the rare centre in their various ways.

The consultant noted that there was indeed no single cause or cure for the condition but it was quite possible to help people with autism into leading reasonably normal lives.

He added that it might also be a blessing in disguise that the condition occurs in all countries and within all social and economic classes.

It was clear that children at Dar es Salaam's WFADCC and, by extension, elsewhere had special needs and faced a wider range of difficulties relating to day-to-day social skills, communication, behaviour, imagination, sensory perception and learning.

The disability facing them was a nightmare to many parents and guardians and was the lot of many other Tanzanians, who would equally benefit from the services of similar centres.

Since only focused and selfless community action could serve as an adequately effective intervention, we must all feel obliged to make that intervention forthcoming because no one can tell who, when, where and how autism will next strike.

invasion of Ukraine.

For most reporters, Ukraine's resistance to Russia's aggression has the same moral clarity as other epic struggles, for example against the Somozas in Nicaragua in the 1970s or Myanmar's military regime today. In Ukraine, many journalists have reacted by rooting for the underdog, lauding the country's response and resilience.

"In the broadest sense, mainstream Western media have been pretty united in denouncing Russia's invasion," wrote Jon Allsop in the Columbia Journalism Review. The illegality of the war, the indiscriminate shelling of civilian areas, the commission of war crimes and Western governments' united front against what they see as Putin's revanchism have inevitably drawn a clear line in the sand.

Russia's Foreign Affairs minister, Sergei Lavrov, pushed back in early March. He accused Western media of being "very emotional", implying that they were biased and unprofessional in their reporting. But emotions and empathy are part of journalism.

"Emotion in journalism is important to convey the lived reality of the situation. It gives voice to victims and survivors, but it also acknowledges how these narratives are shaped. This is all crucial for reporting in Ukraine," Caitlin Knight argued in the Press Gazette.

Neutrality is neither a journalistic custom nor a virtue. Journalists are often partisan. Martha Gellhorn, George Orwell, Robert Capa and Andrée Viollis were not neutral during the Spanish civil war and even less so during the Second World War.

"We must always take sides. Neutrality helps the oppressor, never the victim. Silence encourages the tormentor, never the tormented. You can't ask journalists to stop being human in order to be good journalists," Auschwitz survivor and Nobel Peace Prize laureate Elie Wiesel famously said.

Impartiality doesn't mean inhumanity. As French-Swiss film director Jean-Luc Godard bluntly said, impartiality does not mean giving "five minutes to Hitler and five minutes to the Jews".

During the Balkan wars in the mid-1990s, journalists who stayed in Sarajevo embraced what BBC correspondent Martin Bell called the "journalism of attachment", in solidarity with the besieged population.

"Staggered by what they saw, many reporters forged ties to the city. They too had become Sarajevans," remembered RTL (Russia) and Le Monde (France) reporter Rémy Ourdan in his book Sarajevo. A Love Story. They too were asking for a military intervention to crush the snipers and the bombers.

"Gone was my wandering impartiality. I was for air strikes, for NATO intervention, for arming and training the Muslims," wrote British war correspondent Anthony Lloyd in his memoir, My War Gone By, I Miss it So.

Wars always raise the bar of journalistic responsibility. Ukraine is all the more challenging as it reflects a defining geopolitical shift and is being framed, notes Jason Farago in The New York Times as a culture war, as a clash of civilisations between liberal democracy and autocracy. Who in this context would like to be seen as providing comfort to the enemy?

The early August controversy over Amnesty International's statement accusing the Ukrainian military of stationing its troops and artillery near hospitals, schools and residential buildings encapsulated the dilemmas which journalists are also facing.

It really revolved neither around the facts documented by the organisation nor on the Uncomfortable stories

interpretation of these facts under international humanitarian law but on its impact in the battle of war narratives.

"Without wanting it, the organisation created material that sounded like support for Russian narratives," said Oksana Pokalchuk, Amnesty International's Ukraine director who resigned in protest. Seeking to protect civilians, this research instead became, in her view, a tool of Russian propaganda.

A similar dilemma emerged in early May when the New York Times published a story on the assistance which US intelligence services had allegedly provided to the Ukrainian military by helping them to target and kill Russian generals.

President Joe Biden was livid, according to news reports. The leaks sparked "an internal freak out at the White House", Politico wrote. Should the New York Times have abstained from publishing information which might have justified Russia's upping up the ante?

One of the key challenges for journalists covering war has always been to report on facts which will hurt their own "side".

"No one suggests that Ukrainian forces are always heroic. Few participants emerge unsullied from war and it's clear that Ukraine has challenges that predate the conflict. But impartiality is simply not about publishing on one side, and then on the other," wrote Bloomberg opinion columnist Clara Ferreira Marques.

Impartiality requires rejecting false equivalences between the aggressor and the victim or between facts and lies. It excludes the convenient and lazy he said/she said approach.

But impartiality does not exempt journalists from covering all sides thoroughly and rigorously. which

Journalists' core mission is to help citizens understand what is happening and also to keep their own governments accountable and protect them against self-delusion or hubris (excessive self-belief).

William Howard Russell, who covered the Crimea war for The Times in the mid-1850s, described war correspondents as the "luckless tribe".

The Ukraine war has again reminded us that it sometimes requires more courage to confront one's own sympathies, one's own public opinion or government than to face the enemy's bullets on the frontlines. As Le Monde founder Hubert Beuve-Méry once said: "We must tell the truth even when it hurts. Especially when it hurts." unique geographical location."

OME 120 students from several secondary schools in Tanga Region recently camped at Science, Technology, Engineering and Mathematics (STEM) Park centre here to learn what is billed as silver bullet to understanding the subjects.

This is because the method offers students one of the best opportunities to make sense of the world holistically, rather than in bits and pieces. For, it removes the traditional barriers erected between the four disciplines, by integrating them into one cohesive teaching and learning paradigm.

The course outline included how to solve various real-life problems using science, technology, engineering and mathematics both theoretically and practically.

Dr Lwidiko Edward from Tanga-based Project Inspire which supervises the centre said the camp targets to build capacity among secondary school students on how to utilize science consistently in solving various socioeconomic challenges.

He said another objective is to motivate students to like science and do away with misconception that the same is a reserve of exceptionally intelligent and talented students.

"Through this camp we are going to alter such misconception and introduce cutting edge methodologies of teaching and learning science for both teachers and students," he said.

"We will focus on agricultural science especially smart farming by providing infrastructure to leverage on advanced technology for improved productivity."

Chad Morris, Officer in charge of cultural issues at the US embassy in Tanzania said the mission availed USD 20,000 (over 46,000/-) for the development of STEM park centre because of the initiative's importance for national development.

He said the US government will continue supporting Tanzania towards establishment of many STEM centres in the country to prepare young scientists who can create jobs, employ themselves and others as well.

"The amount we donated has been earmarked for renovation and expansion for this STEM Park due to its potential for the country's development," he stated.

Morris explained that through the five-day STEM workshop, students and teachers in Tanga met experts from STEM Global Action (SGA) which provides teacher-training, science kits and other resources to support a series of activities that are advancing science, technology, engineering, and mathematics knowledge.

He said in May this year, STEM Global Action Tanzanian partner Project Inspire, participated in Africa Science Week, an initiative of the Next Einstein Forum that honours young African scientists by citing the impact of their collaboration with SGA over the past five months on teacher and staff training.

Mohamed Shauri, a teacher from Nguvumali primary school said he was empowered a lot in a past STEM workshop for teachers from 15 primary schools, a science fair with 200 pupils from Tanga primary schools as well as the recent workshops with secondary school students.

STEM: Education method that makes mathematics and sciences enjoyable

"It was exciting to watch young students learning STEM skills with so much ease and enjoyment and outlining approaches, strategies and tools with which to improve livelihoods in their communities".

"Bringing STEM to children, especially those from under-resourced communities and countries is good not only for the trainees but the world as a whole."

Bakari Sessige, Pande Ward Education Officer said: "I took part in a monthly virtual STEM home session with Africa Science Week and was delighted to see students and teachers in Tanga at the center take part in the training."

Mwanahawa Kombo, Physics and Mathematics teacher at Mikanjuni secondary school said that she took the training as a golden opportunity because it does not only give her modern teaching methods but also a rare opportunity to make new personal and professional friends.

John Steven, a form three student at Macechu high school commended the organizers and financiers of the training, adding that if the same is offered to many young Tanzanians, the country is likely to make strides in its development endeavours.

"Next year I will be in form four and my academic records show that I did better in science subjects since form one so this kind of opportunity is what I have been looking for," he said.

In 2013, New Orleans native Dr Calvin Mackie founded STEM NOLA and committed to bringing STEM education to neighborhood churches, community centers and schools, especially communities that lacked resources.

Supported by the US Embassy, STEM NOLA was selected last year for the engagement with Tanzania after an external evaluation found that 69 per cent of the New Orleans non-profit's K-12 students improved their performance in math, science and reading after one year in their afterschool programme.

His innovative approach to STEM learning has attracted support from some of America's biggest corporations and philanthropic foundations including the Entergy Corporation, Boeing Company, Ochsner Health System, Chevron Corporation, the W.K. Kellogg Foundation, AT&T Foundation and Fund II Foundation.

A year ago, Dr Mackie launched STEM

Global Action, a campaign and network of affiliates, including STEM NOLA, which pursues STEM education for children, parents and communities across the US and abroad.

Reading part of Dr Mackie's greeting ahead a five-day workshop in Tanga, one of the officials at the centre Samson Alphonce said: "Our work in Tanzania demonstrates that young students everywhere can be encouraged to enjoy STEM activities and create paths towards jobs and careers".

"We have an approach that has worked in New Orleans as well as other cities and states. It also works in other countries like Tanzania. We are ready to advance STEM education with children and parents anywhere around the globe."

Equatorial Guinea and how not to rig, or observe an election in an era of fraudulent democracy

EQUATORIAL Guinea's president Teodoro Obiang Nguema has clearly not read Nic Cheeseman and Brian Klaas's book How to Rig an Election, which "advises" leaders not to overcook their victories at the polls.

Instead, the provisional results of the 20 November presidential, legislative and municipal elections show Obiang's Democratic Party of Equatorial Guinea coalition took well over 90% of the vote in the Central African oil-rich state. The Convergence for Social Democracy of Andrés Esono Ondo is trailing with just 152 votes. In a population of fewer than two million, about 400, 000 registered voters placed their ballots.

Cheeseman and Klaas's book, despite its tongue-in-cheek title, takes a serious look at fraudulent democracy worldwide – a problem that is widespread in Africa. The authors note that "while a comfortable win is desirable ... it can demoralise political challengers while also persuading election monitors there is nothing worth investigating – a landslide victory often arouses suspicion."

They quote Belarussian president Alexander Lukashenko – Russian president Vladimir Putin's closest ally who has been in power since 1994 – speaking with astounding candour of his 2006 election victory. "I admitted that we rigged the election ... I gave the order to change it from 93% to around 80% ... because more than 90%, just psychologically, that is not well received."

And Cheeseman told ISS Today this week: "As dictators and their advisers told us when we were researching our book ... winning over 95% is 'banana republic'-style manipulation. If you want it to be believable, you need to keep your vote share between 60% and 80%. Giving yourself 96% of the vote basically says you don't care what people think – either domestically or internationally."

Cheeseman also suggested that it might not have been a good idea, in these circumstances, for the African Union (AU) to have sent an election observer mission to Equatorial Guinea. "When regimes operate on that basis, international election observers are unlikely to be able to have a positive effect, so avoiding legitimating a bad process may be the best they can do."

Obiang is Africa's and the world's longest-serving president. He has ruled the country with an iron fist for 43 years after toppling his uncle in a 1979 coup. And his landslide win does seem to show complete disregard for what anyone might think.

Rather paradoxically, he has been trying for the past several years, to present himself as a democrat who cares for his people. In reality, they remain mired in dire poverty despite the country having a GDP per capita of \$11,264 in 2022, putting it 70th in the world, ahead of the likes of Mexico, Turkey and South Africa.

Significantly, Obiang himself asked the AU to send the observer mission. In 2014 he volunteered Equatorial Guinea for peer review under the African Peer Review Mechanism – an AU body that assesses member states' governance. Revealingly though, he's never been scrutinised by the nations participating in the mechanism.

And, like the late Libyan dictator Muammar Gaddafi, Obiang has ingratiated himself with the AU by hosting several of its summits and reputedly paying for many delegations to attend, tapping the country's vast oil wealth. He also stepped in to host the 2015 Africa Cup of Nations soccer tournament when Morocco withdrew because of Ebola. Clearly, Obiang is trying to whitewash his poor governance record.

The results trickling from the electoral commission so far could conceivably be accurate because Obiang has eliminated or coopted the opposition. In 2018, for example, the courts dissolved the main opposition party Citizens for Innovation, for "undermining state security," and sentenced 21 of its 147 supporters accused of "rebellion" to more than 30 years in prison.

Obiang has a taste for implausible election victories. He won the 2016 contest with 93.7% of the vote, the 2009 poll with 95.8% and the 2002 one with 97.1%. Is another landslide win this time mostly aimed at proving a political point at home? Now 80, is he trying to eliminate any political rival to guarantee a dynastic succession to his son Teodorin, the current vice-president?

Given the country's large oil reserves and tiny population, it's astonishing that it has received two IMF loans recently, in 2019 and 2021. However, the loans have brought pressure for greater distribution of oil income.

But surely the AU should not allow itself to fall for Obiang's ruse? It sent a large observer mission comprising over 50 members from 37 African countries. The AU said it had deployed the mission "as part of the AU Commission's mandate and commitment to supporting credible, transparent and inclusive electoral processes in [AU] member states."

In its preliminary report on the elections, the observer mission reached a rather bland, although positive conclusion that "the general elections were in accordance with international standards and the national legal framework governing those elections." However, the report briefly mentioned that the results "were not systematically displayed" at each polling station as they should have been.

The Community of Portuguese Language Countries observer mission also noted the same problem. Posting election results at each polling station is widely accepted as a basic requirement for preventing rigging, as it makes it harder to doctor the results along the chain of evidence.

Was it wise for the AU to send observers to this election? Did it advance or retard democracy in Africa? On balance, one would have to suggest the latter. It's positive that the AU is trying to take elections more seriously. But a bland report focused on voting day and lacking in contextual perspective gives Obiang a free pass and lends him democratic credibility the country doesn't deserve.

Freedom House rates Equatorial Guinea in its lowest 'not free' ranking. The Ibrahim Index of African Governance gives it just 28.7 out of 100 for overall governance, placing it 51 out of 53 countries in Africa. On the democracy measure, it scored just 17 out of 100 for participation, rights and inclusion.

At a time when democracy is under threat from coups and third-term presidential bids, more rigour is needed from AU election observation – not just for the long-suffering Equatoguineans but for the continent at large. **DM**

RADE 11 learner Sinethemba Nkululeko wakes up daily at 3am to walk ten kilometres from his village to school in Willowvale, Eastern Cape. At 3:10pm he walks the ten kilometres back home. He is one of 15,000 learners in the province who are eligible for scholar transport but are not getting it, because there is no budget.

Responsibility for school transport was moved from the Eastern Cape Department of Education to the Department of Roads and Transport in 2011. According to Unathi Binqose, spokesperson for the provincial department of Roads and Transport, about 140,000 learners are in need of school transport, but currently 125,000 are being transported. Binqose said even this number is stretching the department's budget.

Binqose said that the department has to cut costs on events, travelling and accommodation for its employees in order to pay for scholar transport. Next year the department will only have budget to transport a bit more than 100,000 learners, leaving over 20,000 more learners without transport.

This means over 35,000 learners will likely be without school transport next year.

Long walk to education

Teachers in rural areas are worried that their schools might shut down because the learner numbers are dwindling every year due to the high rate of school dropouts.

Seventeen-year-old Sinethemba goes to LM Malgus Senior Secondary School in Willowvale. "Since 2020 there has been no scholar transport here. I wake up at 3am everyday because I walk about 10km from Zenzile Village to get to school. I leave my home at 4am and it is very dark in winter. For safety, I walk with my two classmates. We cross the rivers and walk through

the thick bushes. Then we arrive at school at 6am for morning classes.

"By 3:10pm the school closes and it is another 10km back home. I get back home about 5pm. Then I have to go to the river and fetch the water to wash my school uniform, bath and cook. I also have to collect the livestock and still do my homework. Then at 9pm I go to bed and sleep. But in the classroom sometimes it's hard to concentrate because I feel tired."

His classmate Luzuko Bohlo, 20, from Bikana Village also complains about the distance. He said, "I wake up at 4am and then go to school at 5am. Our school shoes are worn out in a few months. This is my third pair of shoes.

Sometimes we wear gumboots because we walk in wet places. Most of the time we don't finish our homework at home because we are tired.

"On wet days we stay at home because there is no way we can concentrate in classrooms while our clothes are wet." School principal Manelisi Mtshizana spends sleepless nights worrying about his school. "We have a huge dropout of learners because of the lack of scholar transport. When I arrived here in 2017 the number of learners was 172 and it has dropped to 103. I had to allow the matric failures to repeat the whole year in order to keep the school going. The matric pass percentage then was 13. But last year it was 50.

"I have 30 learners who travel 20km daily to school. Next year the number of learners who need transport will increase to more than 60, because I will be receiving new high school learners," he said.

"Since February I have been in and out of the department's office asking for scholar transport because my 30 learners couldn't come to school on wet days.

"Last week the department promised that it will organise transport, only for 35 learners," he said.

In Xhora Mouth in Bulungula Village learners walk long distances to get to Zwelenqaba High School in Thafalehashe Village. Bulungula Incubator Vibrant Village manager Lihle Mbikwana told GroundUp that learners walk four hours a day. "As a result many learners quit school when they reach high school because they can't cope with the long distance. "In 2009, while I was still a learn-

er we were promised scholar transport. But until today that has not happened."

Mbikwana says some parents rent rondavels for their children near Zwelenqaba High School. "They pay between R150 and R500 a month, depending on the quality of the rondavel. But this is not helpful because there are no strict rules in these rondavels. Sometimes a girl and a boy share the rondavel

Bulungula Incubator Vibrant and this leads to teenage pregnanillage manager Lihle Mbikwana cy," he said.

> Malibongwe Mtima spokesperson for the provincial education department referred all questions to the Department of Roads and Transport, which he said had been managing scholar transport since 2011.

Binqose said school transport was only a temporary solution anyway. "I still remember when I was an SABC journalist in 2015 a call was made by government that boarding schools should be built in order to cut the transport costs and minimise scholar transport accidents. But no department was given the task of building the boarding schools," he said. **DM**

Each production line of the plant is run by 20 to 30 employees and delivers a server every minute.

"This plant is one of the largest overseas manufacturing bases of Lenovo and the first one owned by the company in Europe. Relying on the unique geographical location and convenient transportion of Hungary, it significantly improves our supplying efficiency for European customers. The plant has created over 1,100 jobs for local communities, of which 60 percent are taken by females," said Guan Wei, senior vice president of Lenovo and head of the company's global supply chain.

This is a miniature of Chinese enterprises investing in foreign countries.

According to a report jointly issued by China's Ministry of Commerce (MOFCOM), the National Bureau of Statistics and the State Administration of Foreign Exchange, the country's outbound direct investment (ODI) increased 16.3 percent year on year to \$178.82 billion in 2021, ranking among the world's top three for ten consecutive years. By the end of 2021, China's ODI stock stood at \$2.79 trillion, ranking among the top three globally for five consecutive years.

The report said China has maintained its position a major foreign investor over the recent years, and seen a constantly optimizing investment structure and satisfying win-win results.

"The report shows that as the world's second largest economy, China is investing in a wide range of fields

in a number of foreign countries, especially in the high-tech sector. This will help maintain the stability of the global division of labor," said Wan Zhe, researcher at the Belt and Road School of Beijing Normal University.

While actively joining the overseas market, many Chinese enterprises have given full play to their advantages and deeply integrated themselves into the local development. The rapid development of new energy vehicles and consumer electronics has constantly expanded the market demand for nickel in recent years. Trying to grasp the opportunity, Lygend Resources & Technology Co., Ltd. based in Ningbo, east China's Zhejiang province, launched cooperation with an Indonesian company in 2018 and started building a nickel smeltery and a supporting power plant on Obi Island, Indonesia. In just a few years, a huge production base that includes a power plant, a port and living quarters has taken shape.

A polymeric additive plant invested by Chinese company Sennics Co., Ltd. was put into operation in the Rojana Industrial Park in Chon Buri province, Thailand in May this year. The plant, producing 25,000 tons of rubber antioxidants each year, is the first one in Southeast Asia that manufactures the product. Besides, it also provides convenient localized services for the production bases in Southeast Asia of its customers on the lower stream of the industry.

MOFCOM statistics indicated that China's non-financial ODI reached 627.4 billion yuan (\$87.6 billion) in the first 10 months of 2022, up 10.3 percent year on year. The country has been seeing more and more favorable factors under the trend of open development.

Policy support for Chinese enterprises exploring overseas market is strengthened. China has issued a regulation on the management of enterprises' overseas investment, held promotional events and forums on international capacity cooperation and jointly built industrial parks with other Belt and Road countries.

Chinese enterprises themselves are also actively exploring new models of doing business overseas. Some of them have acquired equity of prospering overseas companies, soon integrating themselves intensively into the overseas market.

For Javier Perea, CEO of the Spanish construction engineering companies Empresarios Agrupados Internacional, S.A. and Ghesa Ingenieriay Tecnologia, S.A., the fifth China International Import Expo was an opportunity to both exhibit his companies' services and "go home," as the two companies he manages were purchased by the China Energy Engineering Corporation in early 2020.

"The purchase was a great opportunity for us and significant for the designing and consulting services in the energy engineering sector. We will jointly bring our advantages into full play and help our clients achieve sustainable development," he said.

ETS facilitates TRA towards meeting revenue collection targets

TANZANIA Revenue Authority (TRA) has managed to achieve its revenue collection target by collecting 22.28trn/-(99.22 per cent) in 2021/22 fiscal year after involving various mechanisms including the use of the electronic Tax System (ETS) on branded products.

ETS system rolled out in Tanzania in 2019 after regulations was passed to have all manufacturers in the country install an electronic tax stamp management system. The tender went to a Swiss-based firm called SICPA which was contracted by the Tanzania Revenue Authority (TRA) to install and enroll all manufacturers, producers and importers onto the system.

Richard Kayombo, TRA director for taxpayer services and education (pictured), disclosed this at the weekend in Babati, Manyara Region at the event to issue awards to good taxpayers for the 2021/22 financial year.

Kayombo said the achievement was also contributed by the widening the tax collection base to enable the government implement its activities, adding that the collection is an increase of 4.13trn/- from the preceding year collection that stood at 18.15trn/-.

He said that in the 2021/2022 TRA was set to collect 23.6trn/adding that the government

depends on 60 percent of what revenue authority collects in any given year. Kayombo further said Man-

yara Region taxpayers have had a big contribution despite of the Covid-10 pandemic.

He also said the criteria used to award 27 taxpayers includes the amount of tax paid, correct recordkeeping, paying tax in time when due and collaboration with TRA as and when needed.

Manyara Regional Commissioner Makongoro Nyerere said the government will continue to put in place for them enabling environment and it is essential to plug corruption loopholes perpetrated by a few for their own interests.



The RC said when people pay taxes they encourage the President to implement various development projects and the awards spurs the taxpayers to increase efforts in tax paying.

Manyara Region TRA Manager, Pendolake Msangi thanked taxpayers in his region saying in 2021/22 FY TRA collected 27.8bn/- or 89 per cent of the target which was 31.3bn/-.

Msangi added that TRA's aims to award its taxpayers is to encourage business people to pay tax, adding that so far in the First Quarter of 2022/23 fiscal year, a total of 12.87bn/has been collected in Manyara Region.

Super Brands Limited, David Mulokozi, who was among the award recipients by scooping second position in Big Taxpayers category, thanked TRA for the awards saying they encourage them and pledged to work day and night.

Manyara Region TRA Taxpayers Education Officer Serapio Luanda said 27 traders received TRA awards including three big taxpayers, three middle level taxpayers and three small taxpayers.

He added that institutions that contributed in the tax collection drive in the region included two commercial banks and the regional commissioner's office.

South Korea's bid to host World Expo 2030 gains momentum

USAN, a South Korean city known for its outstanding meeting, conference and exhibition infrastructure, con-tinues to double down on its efforts to win the right to host the World Expo 2030.

Should the megacity be selected as the host of the World Expo 2030, approximately 50.5 million visitors from more than 200 countries would flock there, creating a large and enduring ripple effect that will change the city's future.

According to the South Korea's Bid Committee, which is headed by the country's Prime Minister Duck-soo Han, the city will use the slogan "Transforming the world, navigating toward a better future" to promote achievements in science and technology and other industries, present a new vision for the future, and introduce the diverse attractions of Busan on the international stage.

Africa urges climate actions rather than broken promises, double standards

MANY African participants walked into the UN climate conference held earlier this month in the Egyptian coastal city of Sharm El-Sheikh with much optimism, but came out with unmet expectations.

The two-week gathering, also known as the 27th session of the Conference of the Parties (COP27) to the United Nations Framework Convention on Climate Change (UNFCCC), sought to move from negotiations to implementation and call for actions when extreme weather events are impacting the lives of millions of people worldwide.

Despite some progress at COP27, including a decision to set up a "loss and damage" fund and an agreement to establish a global adaptation framework, developed countries have been blamed for taking a passive attitude toward issues such as providing financial and technical support to the more vulnerable developing countries.

Africa accounts for 4 percent of global greenhouse gas emissions, but suffers the most from them, noted African climate campaigners, adding that 20 percent of the continent's population live in countries that are in the top 10 most vulnerable to climate change. This year alone, the continent has seen deadly flooding in parts of West Africa and the worst drought in decades in the Horn of Africa.

Some 22 million people in the Horn of Africa are food insecure due to drought. Figures from the World Food Programme showed that at least 9.2 million livestock deaths occurred in the drought-affected areas of Ethiopia, Kenya



Climate Change and Resilient Development Strategy and Action Plan (2022-2032) and described it as "a key instrument in supporting regional collaboration on climate change and more effective international partnerships." "There is a need to improve the efficiency and effectiveness of transboundary cooperation to ensure that decision-making and investment occur at appropriate timeframes to respond to the speed of changes in the climate and environment," said the document. While developed countries are turning a deaf ear to Africa's call for deeper cooperation on green development, many developing countries, including China, are reaching out to the continent with utmost sincerity.

At the 8th Ministerial Conference of the Forum on China-Africa Cooperation held last year, China proposed that the two sides advocate green and

At the start of COP27, Chairperson of the African Union (AU) Commission Moussa Faki Mahamat called for climate justice to address the damage Africa has suffered due to climate change effects, appealing to the developed world to honour their promise made at COP26 to double funding by 2025.

However, as the conference closed on Nov. 20, African experts and civil society organizations found no good news for communities that are facing prolonged droughts, erratic rainfall and flooding. Pan African Climate Justice Alliance (PACJA), a collection of civil society organizations, said COP27 ended leaving millions of Africans in continued climate-related misery.

Africans left COP27 disappointed, said PACJA Executive Director Mithika Mwenda. "We came with the hope that the momentum created by the discussions in the year ahead of COP27 under the facilitation of UNFCCC, the COP Presidency, and the facilitation of friends of the COP will materialize with concrete outcomes in Egypt. But unfortunately, the end of COP is an anti-climax," he said. While describing the "loss and damage" fund agreement as a "much needed political signal to rebuild broken trust," UN Secretary-General Antonio Guterres said it is not enough to address concerns. "A fund for loss and damage is essential, but it's not an answer if the climate crisis washes a small island state off the map, or turns an entire African country to desert," he said.

Thirteen years ago in Copenhagen, developed countries promised to mobilize 100 billion U.S. dollars per year for climate actions in developing coun-

tries, but have so far defaulted with all kinds of excuses. In 2021, nearly 200 participating countries adopted the Glasgow Climate Pact at the end of COP26, which includes an unprecedented goal for developed countries to double the funding provided to developing ones for adaptation by 2025. However, doubts were high that developed countries would again fail to honor their commitment. This year at COP27, some rich nations attempted to cancel their long-delayed climate finance pledge, and although an agreement to establish a global adaptation framework was reached at the end of the conference, it lacked clarity and a credible roadmap to double adaptation funds.And while developed countries are going back on their word and are returning to coal energy, especially amid a linger-

ing energy crisis, some of them have been ordering developing countries to speed up green energy transition.

In mid-September, the European Parliament passed an emergency resolution urging Uganda and Tanzania to halt the construction of a crude oil pipeline that passes on a 1,445-km journey from the oil wells in western Uganda to the Tanzanian seaport of Tanga, saying it threatens the "protected and sensitive" ecosystems. The move was described as hypocrisy by Ugandan President Yoweri Museveni, who said later at COP27 that Europe is applying "brazen double standard" towards Africa in its climate and energy policies. "We will not accept one rule for them and another rule for us," Museveni wrote on his blog.

The African Development Bank's 2022 Africa Economic Outlook projected that Africa will need to mobilize as much as 1.6 trillion dollars between 2022 and 2030 to meet their Nationally Determined Contributions to fight climate change. But as the developed world has failed to meet its finance commitment to the continent's green energy transition, a few experts in Africa, like Jonathan Tabalanga, an international relations expert and lecturer at Uganda's Cavendish University, fear that the continent may be left with no options but to continue using fossil fuels for development."Africa is confronted with a decision to make on whether to get their people out of poverty through industrialization, which is also a problem to the environment, or resort to eco-friendly means of production which are extremely expensive," Tabalanga said. In late June, the AU published its

low-carbon development, and actively promote solar, wind and other sources of renewable energy, saying it will work closely with African countries to implement the green development program in the years to come.

China has walked the talk. For example, in De Aar, a town in the Northern Cape province of South Africa, Chinese company Longyuan Power has partnered with local firms on a wind power project that has been in operation since 2017 with an installed capacity of nearly 245 MW.

Chinese-built Adama wind farms. installed with 102 turbines with a total generating capacity of 153 MW, is helping Ethiopia tap into its rich renewable energy potential. In Kenya, official figures showed that the installed capacity of solar power is more than 100 MW, while the Chinafinanced Garissa Solar accounts for 50 MW.

GRADUATES at the Institute of Tax Administration (ITA) have been urged to observe professional ethics in their role of tax collection and to diligently collaborate with the private sector bearing in mind that it is the key driver of the country's economy.

The directives were issued last Friday by Deputy Permanent Secretary in the Ministry of Finance and Planning Dr Lawrence Mafuru during the 15th graduation ceremony held in Dar es Salaam.

Dr Mafuru said that the government recognizes the private sector as a key pillar in ac-

celerating the country's economy and with all initiatives in place of an attractive conducive environment for the business community; it is not healthy to get frustrated in the excuse of tax collection.

"Diligence and integrity are among key pillars when it comes to tax profes-'sionalism. The government hopes that you are going to play your roles in an ethical manner," said Dr Mafuru.

He urged ITA to prioritize courses related to international taxation since the government needs more experts in that area in the wake of multinational companies either trying to avoid or evade tax, especially through transfer pricing. Dr Mafuru also urged the institute which is under the custodian of Tanzania Revenue Authority (TRA) to invest in new technologies and produce competent experts who can work in line with the fastest transformations emerging in the digital economy.

"The government would like to see that researches conducted at ITA bring up proposed solutions on challenges related to tax collection and payment mechanisms;

The government is keen to see that the ITA also contributes in educating the public on the importance of paying tax voluntarily," said Dr Mafuru.

ITA Rector Prof Isaya Jairo said that the

graduation brought on board a total of 489 graduates from different levels of certificate, degree, post graduate diplomas and Masters' degree.

"Since the first graduation in 2008 there has been an increase in the number of students graduating from short courses. The number increased from 974 graduates in 2008 to 3,919 graduates in 2022," said Prof Jairo.

According to him, a total of 17,373 TRA employees have graduated from both short and long term courses since the institute was established. However, another 2,551 non-TRA employees have so far graduated from ITA on the custom and tax management courses.

"On the way forward the institute is working on developing a well systematic online distance electronic learning system. The institute has also been collaborating with continental institutions like the African Tax Administration Forum in delivering its services," said Prof Jairo.

TRA Deputy Commissioner General Mcha Hassan Mcha said that the institute is specialized at offering courses that are related to customs and tax administration.

"The institute offers its services with a mission of creating more responsible, diligent and trustworthy professionals who can serve for the public interest," said Mcha.



Morogoro region curbs livestock grazing in forests

MOROGORO region has come up with the new comprehensive strategy aimed at preventing livestock grazing in forest reserve to prevent deforestation and save water sources that flow directly from Morogoro region to fed Kihansi and Kidatu hydropower plant.

Morogoro Regional Commissioner, Fatma Mwassa (pictured) said on Friday last week while speaking to journalists from different media outlets who visited in her office to see the impact of "Conserving Forests through Sustainable, forestbased Enterprise Support in Tanzania (CoFor-EST) project funded by Swiss Agency for Development and Cooperation (SDC).

In a bid to prevent cattle encroaching on village and government forest reserve, livestock keepers will be required to be registered by the village government, get plots for grazing and find experts to see if the obtained area has enough space to accommodate cattle or not.

"We have decide to embark on this campaign after discovered that vegetation in other forests has been disappeared due to environmental degradation, water sources is also being destroyed while conflicts between farmers and livestock keepers is very high and people's death is also very high.

"As region, we want to protect our forests because 67 percent of water used for power generation at Kihansi Hydroelectric power station and Kidatu hydro power plant come from Morogoro and 97 percent of water used for power generation at Julius Nyerere Hydro Power station is also come from Morogoro, Region.

Elaborating on CoForEST project, she lauded Tanzania Forest Conservation Group (TFCG) and Tanzania Community Forest Conservation Network (MJUMITA) to join government's efforts to conserve forest in Morogoro Region.

She called on MJUMITA and TFCG to scale- up



their training programs and educate people living adjacent to government forest reserve on forest Conservation and management, the benefits it has for them to save our forests that is now disappearing due shifting agriculture, illegal charcoal production, fire and cattle grazing that cause environment degradation and loss of animal habitat.

Also, it provides training to livestock keepers on forest Conservation in areas where they are to help them understand the importance of forest Conservation.

"As region we are very glad for

what has been achieved in our region through CoForEST ptoject, the project has transformed people,'s life, majority of people are now aware of what is forest Conservation, the benefits it has for them and are now taking serious measures to conserve it something that was not the case in the past.

For her part, Mvomero District Council acting district executive director, Dr Philpina Philipo lauded TFCG and MJUMITA to introduce Co-ForEST project in Mvomero District Council, the project has brought in

Charting the global economy: OECD raises inflation forecast LONDON

CENTRAL banks around the world must be steadfast in their inflation fight even though economies will suffer as a result, the OECD said this week.

The organization boosted its 2023 inflation estimates and said it expects price increases the following year will remain above the targets set by many global central banks. While economies will slow because of tighter monetary policies, the OECD didn't forecast a recession.

Though a survey of US manufacturers showed a fifth month of shrinking activity, another report indicated a healthy increase in business investment. A survey of the euro area businesses indicated that any downturn may not be severe as initially expected.



Meantime, the Bank of China eased reserve requirements for banks to help bolster the world's second-largest economy.

Here are some of the charts that appeared on Bloomberg this week on the latest developments in the global economy:

World

The world's central banks must keep raising interest rates to fight pervasive inflation, even as the global economy sinks into a significant slowdown, according to the OECD. The organization raised inflation projections for next year and said that while the global economy will suffer a "significant growth slowdown," it's not forecasting a recession.

This week saw more major rate hikes across the world. with 75 basis-point hikes in Sweden, New Zealand and South Africa and full percentage-point moves in Pakistan and Nigeria. Turkey went the opposite way, cutting rates by 150 basis points.

US

Business activity contracted for a fifth month in November as demand faltered, while inflationary pressures continued to slowly ease. The S&P Global flash composite purchasing managers' index slid to the second-lowest level since the immediate aftermath of the pandemic.

Orders placed with US factories for business equipment rebounded in October, suggesting capital spending plans are holding up in the face of higher borrowing costs and broader economic uncertainty. Core capital goods shipments jumped the most since the start of the year, suggesting a solid start to fourth-quarter gross domestic product.

Europe

Euro-area businesses see tentative signs that the region's economic slump may be easing as record inflation cools and expectations for future production improve. A gauge measuring activity in manufacturing and services unexpectedly rose in November, according to S&P Global.

Sweden's home-price decline accelerated in October, as the Nordic country gripped by the most severe housing slump in three decades shows what may lie ahead for many other developed economies.

Asia

For the second time this year, China's central bank cut the amount of cash lenders must hold in reserve, ramping up support for an economy racked by surging Covid cases and a continued property downturn. The People's Bank of China reduced the reserve requirement ratio for most banks by 25 basis points.

Signs are growing in China that local government debt burdens are becoming unsustainable. China's 31 provincial governments have a stockpile of outstanding bonds that's close to the Ministry of Finance's risk threshold of 120% of income. A major cause of the financial squeeze is the property crisis.

DR Congo schedules presidential elections for December 2023

KINSHASA

DEMOCRATIC Republic of Congo said it will hold presidential and parliamentary elections on Dec 20, 2023, kicking off a year of complex preparations in the vast Central African country, large parts of which are overrun by militia violence.

Announcing the date at a ceremony in Kinshasa on Saturday, the electoral body, CENI, outlined several challenges, including the logistics of transporting ballot materials thousands of miles, health concerns about Ebola and COV-ID-19, and unrest that has forced hundreds of thousands to flee their homes.

But the government has pledged to stick to the timetable in the country of 80 million people.

"It is not a question of negotiating with the constitutional deadlines, it is a question of us of respecting them and consolidating our democracy," said government spokesman Patrick Muyaya. He said that the election will cost

about \$600 million, more than \$450 million of which has already been budgeted.

Election struggles are common in Congo. The last presidential poll, Congo's first democratic transition, was delayed by two years until it was finally held in December 2018. In that vote, President Felix Tshisekedi took over from his long-standing predecessor Joseph Kabila.

This time, similar challenges remain. Candidates are expected to be an-

nounced in October next year, with a peacekeeping forces, more than 120

I would like to point out that activities in this field should remain the corporation's priority," Putin said.

Russia's Rostec state corporation is capable of achieving breakthroughs in the field of electronics, Putin said.

"Since its founding, Rostec has been responsible for developing, producing and exporting high-technology products designed both for military and civilian purposes. There is a need not just to continue these efforts but to actively work in all promising areas that ensure Russia's technological sovereignty," the head of state pointed out.

"Undoubtedly, I expect Rostec to achieve breakthroughs in areas such as microelectronics, the electronic-component base, the aircraft industry, fifth-generation communication networks and on the whole, to make more active efforts to implement and promote domestic high-technology solutions in all fields that are important for the development of our economy as they determine the quality of life of our people and reduce our dependence on imported supplies," Putin noted.

UGANDA'S President Yoweri Museveni has extended a quarantine placed on two districts that are the epicenter of the country's Ebola outbreak by 21 days, adding that his government's response to the disease was succeeding.

Movement into and out of Mubende and Kassanda districts in central Uganda will be restricted up to Dec 17, the presidency said late on Saturday. It was originally imposed for 21 days on Oct 15, then extended for the same period on Nov 5.

The extension were "to further sustain the gains in control of Ebola that we have made, and to protect the rest of the country from continued exposure."

The government's anti-Ebola efforts were succeeding with two districts now going for roughly two weeks without new cases, the president said.

"It may be too early to celebrate any successes, but overall, I have been briefed that the picture is good," he said in a statement.

Informa Tech and Huawei host fourth broadband Africa forum

CAPE TOWN

AFRICA is on the cusp of a broadband explosion but must address significant challenges to ensure that the continent and economic benefits that come with it. This was the consensus at the fourth Broadband Africa Forum, hosted by Informa Tech and supported by Huawei.

During the forum, representatives from the African Union (AU), Africa Telecom Union (ATU), major operators, major vendors, and consultants held in-depth discussions on how to accelerate broadband adoption, improve broadband quality and promote the broadband service economy in Africa. They also highlighted the ongoing challenges faced by the continent when it comes to accelerating connectivity.

"One of the most obvious challenges in rolling out FMC [fixed-mobile convergence] is network availability," said Anderson Amlamba, director of the

AU's Management Information System. "The networks simply aren't there." When it comes to addressing those challenges, Amlamba stressed the need for cooperation.

"Governments need to work with operators to help ensure that they're enhancing and promoting their operations, rather than hindering," she said.

Several industry players also made commitments and announcements at the event. John Omo, the General Secretary of the ATU, outlined their commitment to supporting broadband universalisation in all African countries and striving to reach the target of 35% broadband penetration in Africa by 2035.

"The ATU has been continuously committed to rolling out broadband across the continent, not least because broadband is critical for economic development and social stability," Omo said. "Africa still lies far below the global average when it comes to broadband connectivity."

"Limited broadband inevitably leads to limited economic development and global trade," he added. "We must place broadband development at the core of our discourse."

Gary Lu, President of Network Marketing & Solution Sales at Huawei, pointed out that it was common consensus that ultra-broadband infrastructure being key to digital economic development, adding that fiber-based broadband must be deployed as soon as possible. "Fiber has been proven to be the best medium of high-speed broadband, once deployed, it has a 30 vear lifecvcle. But it is not easy at the beginning, which means we need cooperation from all of us, include government, carrier, and product supplier. '

Managers and experts from regional Tier-1 carriers - such as Tunisia Telecom's, South Africa's Telkom and Kenya's Safaricom - also shared their successes in copper-to-optical conversions, broadband market planning, all-optical city coverage and collaborations with third-party infrastructure suppliers.

"Safaricom's fixed-data customers have grown five times in the past four years, twice as fast as the industry average," said Franklin Ocharo, Head of Fixed Data at Safaricom.

That growth, he said, has been built on three key pillars: network, proposition and commercialisation.

"The beauty of light (in the shape of fibre) is the ability to connect the unconnected, to unlock innovation, to help save the planet and to futureproof the network," said Sunil Pivarlall. a Network Architecture and Modelling executive at Openserve, Telkom's fibre network.

"We have over 700 million people across Africa that don't have access to the internet. We need to get fibre to a point where it can be combined with other technologies, such as FWA [fixed wireless access], to get unconnected people connected." Agencies

wei Cloud Southern Africa said, "The Huawei Developers Competition (HDC) encourages developers to give full play to their imagination and innovative spirit, by using ICT technologies to solve practical problems and create unlimited value. We were very impressed by the caliber of entries and all six teams who reached the final phase delivered outstanding projects, each worthy in their own merit."

All six finalists received cash prizes and Huawei devices. Kenyan winners Spark Money got \$10 000, as well as a Huawei MatePad for each team member. Team NAC from Tanzania took second place along with an \$8 000 prize. South African teams Astel Systems, Innovo Networks and Malcam Solutions collectively placed third with each team winning \$5 000 and a Huawei Watch Fit for team members. Team Maverick from Nigeria winning the Cloud Ace Award and a \$2 000 prize.

Spark Money's Mfadhili Gitau described the competition as a life changing opportunity they grabbed with both hands. "Through initiatives and competitions like this one, African developers have the opportunity and support to create and innovate the right solutions for problems faced on the African continent. This could even help our continent become a technology hub serving the rest of the world.'

The competition also served as a platform for developers to network and share ideas. Safeguarding peace, stability in South China Sea a common will of regional countries

EARLIER this month, China and members of the Association of Southeast Asian Nations (ASEAN) issued a joint statement on the South China Sea at the 25th China-ASEAN Summit held in Phnom Penh of Cambodia.

It is an important document inked by the two sides on the South China Sea issue, which demonstrates China and ASEAN countries' common will and firm resolve to stay committed to rising above external disruptions and safeguarding peace and stability in the South China Sea.

The document also indicates that regional countries have the confidence, wisdom and capacity to handle the South China Sea issue.

The joint statement, at its beginning, recognizes the benefits of having the South China Sea as a sea of peace, friendship, and cooperation.

To build the South China Sea into a sea of peace, friendship, and cooperation is an important goal of China's South China Sea policy, as well as an inherent part of deepening the comprehensive strategic partnership between China and ASEAN.

In November, 2021, Chinese President Xi Jinping attended and chaired the Special Summit to Commemorate the 30th Anniversary of China-ASEAN Dialogue Relations via video link. He proposed that China and ASEAN countries should build a peaceful home, a safe and secure home, a prosperous home, a beautiful home and an amicable home together, stressing joint efforts are needed to safeguard stability in the South China Sea and make it a sea of peace, friendship and cooperation.

The incorporation of "a sea of peace, friendship and cooperation" into the joint statement this time mirrored regional countries' active response to and support for China's South China Sea policy.

It proved that China and ASEAN countries have reached a general consensus on what kind of South China Sea they should build.

The Declaration on the Conduct of Parties in the South China Sea (DOC) is the first political document signed by China and ASEAN countries on the South China Sea issue.

The document and its implementation ensure the basic stability in the South China Sea and create favorable conditions for regional prosperity and the in-depth development and comprehensive upgrading of China-ASEAN relations.

Facts have proved that the DOC is in line with the reality in the region and has the characteristics of the region. It reflects the common ground shared by regional countries on the South China Sea issue. It was proved effective in the past, remains effective today and will continue to be effective in the future.

The joint statement issued this time reaffirms that the DOC is a milestone document in ASEAN-China Dialogue Relations, recognizing the imperative of strengthened efforts and heightened goodwill towards the full and effective implementation of the DOC as the situation in the South China Sea has changed tremendously since the signing of the document.

The joint statement demonstrates that China and ASEAN countries will keep working together to abide by the basic principles and common conduct set by the DOC, to safeguard peace and stability in the South China Sea. The joint statement reaffirms that the parties concerned undertake to resolve territorial and jurisdictional disputes by peaceful means, through friendly consultations and negotiations by sovereign states directly concerned.

Over the recent years, China and ASEAN countries have raised and implemented the groundbreaking "dual-track" approach---disputes should be resolved peacefully through negotiation between the parties directly concerned, and China and ASEAN countries should work together to maintain peace and stability in the South China Sea. **People's Daily**

Chinese-sponsored solar-powered boreholes tackling water stress in Kenya's arid lands

NAIROBI

WINIFRED Nzioka's face lit up when a male farmhand delivered several jerrycans of water to her homestead on a balmy late afternoon to quench the thirst of mooing cows.

The middle-aged mother of five has put up a permanent house sandwiched between sunbaked farms at the heart of the southern Kenyan county of Machakos, which is in the grip of a prolonged dry spell.

A few yards from Nzioka's homestead is a public school where a solar-powered borehole sponsored by a Chinese entrepreneur is providing respite to water stress that used to torment residents of the arid plains that dot Machakos County.

The small-holder farmer told Xinhua during a recent interview that water woes are now behind her since she can draw the commodity from the solar-powered borehole at a modest fee. "I have benefitted a lot from the borehole where I obtain water for my cows and domestic consumption. We are happy because clean drinking water is now on our doorstep," said Nzioka.

Completed in around May, the solar-powered borehole at Kwakatheke Primary School, adjacent to Nzioka's home, is the brainchild of Li Xia, the chief executive officer and co-founder of Shenzhen Solar Run Energy Company Limited.

Through a partnership with local not-for-profit groups, Li has leveraged solar solutions to address water stress in Machakos and other Kenya's drylands bearing the brunt of climate-induced droughts.

Li, who had just landed from Egypt where she attended the UN climate conference, said harnessing solar power to pump water from boreholes is helping tackle the growing scarcity of the resource in Africa's climate hotspots.

Fabian Daniel, an 18-year-old farmhand, was in his element as he chaperoned two heifers that carted away 20-liter jerrycans filled with water drawn from a kiosk fed by the solar-powered borehole.

"We used to trek for about five kilometers and spend upwards of two hours to reach a water source, but it is no longer the case; now we are obtaining the commodity at this kiosk which is on our doorstep," said Daniel.

The young son of peasant farmers said he currently spends less than thirty minutes drawing water from

the kiosk and carting it home for domestic consumption and irrigating crops. "I think this water project is good for rural Kenyans affected by drought. We have to look for a way to make water available for these communities, including drilling boreholes.

Underground water is more reliable than rain," said Li. She noted that solar power, a renewable source of energy, could aid Kenya's quest for a green transition besides enhancing sustainable water supply for underserved rural communities.

Li stressed that access to a reliable water supply will enable Machakos villagers to undertake climate-resilient agricultural practices, boost their food security and broaden their revenue streams.

"Water is not only helping them to drink, but also helping them to increase

productivity in their farms. And solar power is a must; because in off-grid areas, you cannot draw water from underground sources without solar energy," said Li.

Li said courtesy of a strategic partnership with local enterprises and charities, her company has been able to utilize China's prowess in underground water utilization to tackle access gaps in Kenya's arid and semi-arid areas.

More than five million liters of clean drinking water has been delivered to households since the completion of the solar-powered borehole project and the kiosk in May this year, said Tajinder Singh, managing director of Project Maji, a not-for-profit social enterprise that has partnered with Li to tackle water woes in Kenya. Singh added that the public primary school is provided with one thousand liters of safe drinking water daily to help quench pupils' thirst, irrigate trees and improve sanitation and hygiene.

Singh disclosed that one 20-liter jerrycan of water is sold at 2.5 Kenyan shillings (about 0.02 U.S. dollars) at the kiosk, adding that regular monitoring is conducted to ensure the commodity meets the safety and quality threshold.

Susan Kennedy, principal of Kwakatheke Primary School, said the establishment of a solar-powered borehole has improved the academic performance and health of her 107 pupils.

"The children have been spared the agony of trekking long distances under scorching heat to look for water. The borehole water is safe for drinking and children are also using it to nurture trees and maintain the hygiene of their classrooms," said Kennedy.

Moscow does not take to heart European Parliament's resolution - Kremlin spokesman Moscow

THE European Parliament's resolution recognizing Russia as a state sponsor of terrorism is not legally binding, Moscow does not take such decisions to heart, Russian Presidential Spokesman Dmitry Peskov told the "Moscow. Kremlin. Putin" program on Rossiya-1 TV channel yesterday.

"The European Parliament is the kind of organization that rather bases its work on emotions, on an emotional approach," the spokesman said.

"Of course, it's no secret to us that in the recent years the European Parliament has had little love for us. In return, we have had little desire to take into account what's going on there," and to take it very much to heart, Peskov stressed.

"The situation when such blatant Russophobia and hatred towards Russia are just running over. But this does not have any legally binding nature.

That is how it should be treated," the Kremlin spokesman explained in a conversation with journalist Pavel Zarubin.

The Russian side sees "a huge lack of professional approach and a huge lack of professionalism" in the European Parliament, he went on to say.

"And emotions is such a changeable thing. Today they are Russophobic, tomorrow there will be something else. And then, maybe a moment of clarity will come," he summed up.

UN calls for eliminating violence against women, girls

THE United Nations on Friday called for efforts to eliminate violence against women and girls (VAWG) on the International Day for the Elimination of Violence Against Women, which falls on Nov. 25 annually.

In his message for the day, UN Secretary-General Antonio Guterres said that "now is the time for transformative action that ends violence against women and girls," adding that violence against women and girls is "the most pervasive human rights violation in the world."

Through a statement, Sima Bahous, UN Women Executive Director, called on governments and partners across the world to increase long-term funding and support to women's rights organizations, to make commitments to the Generation Equality Action Coalition on Gender-based Violence and donations to civil society organizations through the UN Trust Fund and support to the Spotlight Initiative.

"Resources matter and the scale of financial support for this cause does not match either the scale of the issue or the statements of concern made by those in leadership roles," Bahous added.

Eleven UN entities called for efforts to eliminate VAWG in a joint statement, kicking off the "UNITE! Activism to End Violence against Women and Girls campaign."

They reminded that an estimated one in three women experience gender-based violence during her lifetime. Last year, nearly one in five women aged 20 to 24 had been married before turning 18 and less than 40 percent who experience violence seek help of any sort. Furthermore, global emergencies, crises, and conflicts

have further intensified VAWG and exacerbated its drivers and risks.

"Since the start of COVID-19, 45 percent of women reported that they or a woman they know has experienced a form of VAWG," according to the statement.

All types of gender-based violence are also aggravated by natural disasters, as witnessed in 2005 during Hurricane Katrina, in 2010 during the Haiti earthquake, in 2011 during the tropical cyclones in Vanuatu, and in 2019 through 2022 during the Australian bush fires.

grown online as anti-rights movements have flourished. According to the UN entities, these factors have resulted in a shrinking space for civil society, a backlash against women's rights organizations, and increased attacks against women human rights advocates.

While ending gender-based VAWG might seem unimaginable, the UN underscored that "it is not." "Large-scale reductions in violence against women can be achieved through intensive feminist activism and advocacy coupled with evidence and practice-informed multisectoral action and investment," the statement continued.

Citing evidence suggesting that "strong and autonomous feminist movements" as being "the most critical factor" in ending VAWG, UN Women and its sister agencies are calling upon governments and partners to "act now to end violence against women and show their solidarity to women's rights movements and activists."

Through the UNITE campaign, the UN is asking for increased longterm funding and support to women's rights organizations working on solutions to prevent and respond to VAWG.

It is also advocating for resisting the rollback on women's rights; amplifying the voices of women human rights defenders and feminist women's movements; mobilizing more actors to join movements to end VAWG globally; and promoting the leadership and participation of women and girls in political, policy making, and decision-making spaces.

In addition, the statement emphasizes the importance of strengthening protections to prevent, eliminate, and address violence, harassment, threats, intimidation and discrimination against women human rights defenders and advocates.

On Dec. 20, 1993, the UN General Assembly adopted the Declaration on the Elimination of Violence against Women through Resolution 48/104.

Finally, on Feb. 7, 2000, the General Assembly adopted Resolution 54/134, officially designating Nov. 25 as the International day for the Elimination of Violence Against Women and in doing so, inviting governments, international organizations as well as non-government organizations to join together and organize activities designed to raise public awareness of the issue every year on that date.

VENEZUELA'S government and opposition have asked the United Nations to manage a fund for billions of dollars now held in foreign banks, which will be gradually unfrozen to combat a humanitarian crisis in the oil-rich nation, delegates announced in Mexico City on Saturday.

Sources told Reuters last month the frozen funds amount to more than \$3 billion.

The money, held in Venezuelan-owned accounts overseas, was frozen by US and European banks after the United States ramped up sanctions under the administration of President Donald Trump, designed to pressure President Nicolas Maduro to take steps toward free elections.

Talks between Maduro's government and its political opponents resumed in Mexico City on Saturday, mediated by Norway, after being on ice for more than a year.

US Secretary of State Antony Blinken welcomed the talks as "an important step toward restoring democracy to Venezuelans.

"We will look to the parties to achieve lasting agreements that set the course for free and fair presidential elections in 2024," he said on Twitter.

Maduro also posted a statement on Twitter, saying: "We will always strive for dialogue with all Venezuelan society. We continue to take important steps for the well-being of our country."

Following the announcement for a UNadministered fund, the US Treasury Department issued a license for Chevron , the second



largest US oil company, to expand operations in Venezuela, allowing it to import Venezuelan crude into the United States.

The government's delegation was led by congressional leader Jorge Rodriguez of Venezuela's ruling United Socialist Party (PSUV), and the opposition group was headed by politician Gerardo Blyde.

Maduro had said the aim of the talks was to recover the "kidnapped" resources for public investment: "Then we will see what other issues can be discussed."

The funds are set to help stabilize the country's electric grid, improve education infrastructure and deal with the impact of this year's deadly rains and flooding.

It is part of a broad agenda that covers US sanctions on Venezuela, conditions for the next presidential elections and the status of hundreds of political prisoners - though these issues will not be discussed in this round of talks.

"This agreement provides the template for how further progress can be secured," the European Union said in a statement.

More than 7.1 million Venezuelans have left their country according to UN estimates this year, many migrating to other Latin American countries or the United States, as Venezuela battles high inflation, and food and medicine shortages. More than half of Venezuelan migrants do not have access to three meals a day, UN estimates showed.

In Venezuela, a survey by local universities this year showed some 78 percent of the population was worried about lack of food, compared with 88 percent in 2021.

Some Venezuelan and US critics raised concerns the liquidity injection could boost Maduro's credentials before the country's 2024 elections.



How Ghana vs Portugal was second fiddle to vast galactic test of strength

THERE is a way in which a sideline event takes the limelight within a more formal event that is supposedly the issue of the day, for instance when Taifa Stars was playing Uganda's Cranes and won 3-0.

All ears were tuned to Burkina Faso vs Cape Verde as if either of them had obtained three points the side would have qualified, irrespective of the results of the local tie between Taifa Stars and Cranes.

That is, in a sense, happening in the current World Cup finals, and the issue is hardly about either qualification or such a win.

The late evening match between Portugal and Ghana was overshadowed by a huge contention in the UEFA circuit in the aftermath of a globally premiered interview, a 'royal tour' of the horizon with Piers Morgan, a syndicated interview radio and television magazine. Reports on the interview said it was requested by the player, Cristiano Ronaldo, wishing to reflect on his monumental disappointments with Manchester United, a club of his youth to which he returned after a decadelong career with giants Real Madrid and Juventus. The Ghana-Portugal match is his first since then.

Even from the commentary that was being aired by television pundits, the match was likely to make a mark on whether Ronaldo was right in his criticism of Manchester United coach Eric Ten Hag, complaining that the manager shows no respect for him.

It was due to being asked to enter the pitch in the dying minutes of the game, either in injury time or close to it.

Relations never actually steadied thereafter, with the interview he requested staging breaking point, leaving him a de facto free player.

The issue was that he rehabilitates himself before a worldwide audience so that he takes out some of the hounding arising from his non-respectful remarks, for the wider public to conclude that the coach was failing him.

It was a moment to show not just his ability to play but a show of class, demonstrating without a shade of doubt that he is a player who can make a difference in the high-level contest.

Facing Ghana with Portugal was a virtual substitute for facing any other Premier League side, and being tasked to show why his complaints are valid.

He then failed to use a clear opportunity, only needing to flip the ball above the goalkeeper.

The now sidelined Manchester United player put up a good game, with the less garlanded Ghanaian side handing the change all the way, striking another beautiful goal by a header at close range on the margin of the goal area.

There was little Ronaldo could have done in the dying minutes as he was substituted when the score was 3-1, the Portuguese side coach believing the score was beyond reach for Ghana.

Doubts probably lingered on as regards disrespect from the coach, as he wasn't actually above other Portugal players despite being captain, and the rivalry for the man of the match status, if it was there, could easily have been taken by another Portugal player or from the opposite side. Respect isn't easy to cultivate at age 37.

The match for once retained the respect that underdogs have generated in this year's finals, as it wasn't finally a moment for a rebirth of Ronaldo before his home fans and many others abroad, at the expense

Why are Man United and Liverpool suddenly on the market?

DOHA, Qatar

ENGLISH soccer's two most storied teams are suddenly in play.

Manchester United has joined great rival Liverpool in opening its doors to a potential buyout that could be the biggest in sporting history.

Following the sale of Chelsea in May, it sets up the prospect of three of the biggest Premier League clubs changing ownership in just a few months.

Newcastle was also bought by a consortium led by Saudi Arabia's Public Investment Fund last year.

So why this relative, but rapid, flood on to the market?

The acquisition of Chelsea by Todd Boehly and Clearlake Capital was a unique case, with Russian oligarch Roman Abramovich forced to sell after being sanctioned by the UK government for his links to Vladimir Putin.

Still, it feels like a significant factor in what has followed.

For any would-be sellers out there, it established a definite interest from the world's super rich wanting a piece of soccer's most popular league.

Boehly and Clearlake fought off rival bids from Chicago Cubs owners the Ricketts family, Boston Celtics owner Steve Pagliuca and UK billionaire Jim Ratcliffe among many others.

A fee of 2.5 billion pounds (\$3 billion) for a team that has a smaller stadium than any of its elite Premier League rivals has set a marker for United and Liverpool, who have long-been the most popular in England, with enormous global reach.

United claims to have more than one billion worldwide fans and followers.

It also has by far the biggest stadium in the Premier League, with Old Trafford's capacity at more than 75,000 in contrast to Chelsea's Stamford Bridge, which holds around 42,000.

"Using business fundamentals, any valuation doesn't give you 2.5 billion pounds for Chelsea," Kieran Maguire, author of "Price of Football," told The Associated Press. "If the UK government could get that... (price) for Chelsea, clubs run far more prudently could legitimately get more.

"I worked out Chelsea to be worth something like 1.5 billion pounds

4.5 billion would be reasonable for United. But numbers well in excess of that have been widely circulating since the Glazers, who also own the NFL's Tampa Bay Buccaneers, announced plans to explore "strategic alternatives" this week.

"I'm reading figures of \$6-7 billion and that's taken me aback," said Maguire. "The world of finance is full of very confident people who like shouting out big numbers."

Merchant bank Raine Group, which conducted the sale of Chelsea, is handling the process for United, which could include a full buyout. It will already be well-connected

with the type of people who would be serious candidates to launch takeover bids.

Maguire says the lure of owning a sports team is about more than just business.

"If you are a billionaire, who are the people you associate with? You've got as much as everyone vou know," he said. "You've got the yacht, you've got the helicopter. If you say you've got Manchester United, you own the room. It's like owning a Picasso or a Van Gogh. It's a scarce piece of work.

"If you really wanted the Mona Lisa you would pay a huge price. Is Man United the Mona Lisa of football?"

The Glazer family will certainly see the business case to sell. Likewise, the Fenway Sports Group (FSG), which owns Liverpool and this month confirmed it was open to selling shares in the club.

The late tycoon Malcolm Glazer bought United in 2005 for 790 million pounds (then about \$1.4 billion). The family stands to make a huge profit on that even by the most conservative valuations.

FSG bought Liverpool for 300 million pounds (then about \$476 million) in 2010 and would likely expect to command at least the same sale price as Chelsea.

Still, both clubs would likely have known the potential for profit even before Abramovich sold up.

Another reason why they are now open to selling could be because of the aborted launch of a new European Super League last year, which sparked a furious backlash from supporters.

A new competition for European soccer's wealthiest teams was seen as a way to bring in fresh broadcast revenues, without the

Costa Rica rallies late to beat Japan 1-0 in Group E

KEYSHER Fuller scored in the 81st minute to lift Costa Rica to a 1-0 victory over Japan on Sunday, leaving both teams with three points after two games in Group E of the World Cup.

Fuller took advantage of a defensive error when Japan failed to clear the ball and hit the net from 18 meters just off the fingertips of leaping Japan goalkeeper Shuichi Gonda.

The match at Ahmad Bin Ali stadium was tactical and largely lackluster, particularly in a first half that did not yield a single shot on goal. The second half was slightly better with Japan pressing throughout until Costa Rica broke through.

Costa Rica keeper Keylor Navas came up with several rapid fire saves in the final minutes to ensure the victory.

Japan has one Group E game remaining with Spain, and Costa Rica faces Germany in its final group match. With a victory, Japan could have all but wrapped up a place in the knockout stage after a 2-1 upset of Germany in its opener. Costa Rica was pounded by Spain 7-0 in its first game and just trying to survive.

Japan had the edge in corners, shots, and possession but could not find the net.

The first half might have been one of the worst of the tournament that has already seen four 0-0 draws. Neither team had a shot on goal in a tactical stalemate.

Ritsu Doan, who scored one of Japan's goals in the 2-1 win over Germany, looked the most threatening early with runs down the right side looking to cut in crosses.

Costa Rica's most menacing player always looked like Joel Campbell, trying to use his speed on the left flank.

There was more action in the first two minutes after the break than in the entire first half.

The Black Stars are the youngest team at the World Cup, with an average age of 24 years and four months. So it was encouraging that they held their own against Portugal and star Cristiano Ronaldo, whose 65th-minute penalty made him the first male player to score at five World Cups.

Afterward, Addo called the penalty "a special gift from the referee" but on Sunday he was keen to move on.

"It's in the past," he said. "It's gone. It's over. We can't change it."

Veteran captain Andre Ayew and Osman Bukari scored for Ghana against Portugal. Ayew was also on the Ghana team that went to the quarterfinals at the 2010 World Cup. Ghana was eliminated in the group stage at the 2014 tournament, and did not make he field for Russia in 2018.

With the win, Portugal led Group H going into the second round of groupstage matches. Ghana sits at the bottom of the table and would be eliminated if it loses to South Korea.

South Korea was making its sixth straight World Cup appearance. The team lost to Turkey in the third-place match as co-hosts at the 2002 World Cup.

US soccer displays Iran flag minus Islamic Republic emblem

DOHA, Qatar

THE U.S. men's soccer team has begun displaying Iran's national flag on social media without the emblem of the Islamic Republic as nationwide protests challenging Tehran's theocratic government continue.

The Twitter account of the U.S. men's team on Sunday displayed a banner with the squad's matches in the group stage, with the Iranian flag only bearing its green, white and red colors. The same could be seen in a post on its Facebook and Instagram accounts laying out the point totals so far in its group.

The U.S. men's team did not immediately respond to a request for comment. However, the absence of the emblem comes as monthslong demonstrations have challenged Iran's government since the Sept. 16 death of 22-year-old Mahsa Amini, who had been detained by the country's morality police.

The protests have seen at least 450 people killed since they started, as well as over 18,000 arrested, according to Human Rights Activists in Iran, an advocacy group following the demonstrations.

Iran has not released casualty or arrest figures for months and alleges without providing evidence that the protests have been fomented by its enemies abroad, including the U.S.

Tehran also restricts press access and has detained over 63 reporters and photographers since the demonmittee to Protect Journalists, making covering the unrest that much more difficult.

and its soccer federation did not immediately respond to a request for comment. Iranian state media had yet to acknowledge the emblem's absence on the U.S. men's team accounts, though comments raged online.

The Islamic Republic emblem, designed in 1980, is four curves with a sword between them. It represents the Islamic saying: "There is no god but God." It also resembles a tulip or lotus.

At the top and the bottom of the flag, there are 22 inscriptions of "God is Great" as well, which honors the date on the Persian calendar when the Islamic Revolution took hold.

The flag has become a point of contention at the World Cup. Apparent pro-government supporters have waved it, shouting at those demonstrating over Amini's death. Others at matches have waved Iran's lion and sun flag, an emblem of its former ruler, the late Shah Mohammad Reza Pahlavi.

More security forces could be seen at Iran's last match against Wales. In the capital Tehran, anti-riot police the same ones cracking down on protests – waved the Iranian flag after the Wales win, angering demonstrators. Team Melli will face the U.S. on Tues-

Argentines breathed a collective sigh of relief Saturday afternoon as the country obtained a decisive 2-0 victory over Mexico dissipating doubts that had emerged about Lionel Messi's team after the shock loss against Saudi Arabia on Tuesday. That loss had sent the country almost into a state of national mourning.

"The whole week was very sad, everyone was very aggressive as well, as if they were lost, without knowing what to do," Medina said. "We were all very nervous."

María del Carmen Martínez, 60, said she was "very tense" when she arrived at a plaza in Buenos Aires to watch the match on giant screens.

"I'm happy now," the retail worker said with a smile. "It's as if the players finally woke up."

Manuel Gauto, 21, agreed he saw a different team on the field than the one that fell before Saudi Arabia.

"They rose to the occasion and put their hearts into it," Gauto said. "They have another attitude now."

The mood was completely different in Mexico City, where thousands had gathered in bars and plazas to follow the match only to be left disappointed by their team's performance.

The coach "gave away the game," complained Daniel Martínez minutes after the match ended. "We're completely destroyed, but this doesn't end here."

There were long periods of silence in Mexico City's Revolution Square as fans found few moments to celebrate.

"I'm crying out of emotion but also sadness," Lupita Díaz said. "I love soccer but Mexico is failing us now." In Buenos Aires, the tension was alBenítez, 24, said.

All that pent up energy made the crowd explode in jubilation when Messi scored the first goal.

"Winning games is super important to recover confidence," Stamm added. "We have to go with humility and calm because each game is a final."

For Ariel Rivera, a 37-year-old, software developer, said that Saturday's victory showed "there is still hope."

"Argentina has everything that it needs to be able to win," Rivera said. "I think we're going to go far."

Meanwhile, in Doha, Qatar, Guillermo Ochoa's World Cup magic didn't work against Lionel Messi and Argentina.

Mexico's goalkeeper, known for big saves in soccer's biggest tournament, had stopped Robert Lewandowski's penalty attempt in El Tri's World Cup opener. But he was helpless against Messi's second-half blast from distance in the 64th minute on Saturday night.

Enzo Hernandez added a second goal in the waning minutes to give Argentina a 2-0 victory.

"The difference was because they had Messi," forward Henry Martin said. Doha's golden Lusail Stadium, which will host the World Cup final next month,

ing to stave off elimination, the onus was on Messi to score after a rather timid first half.

So he did. From outside the box, Messi's low, left-footed shot sailed out of Ochoa's reach and into the net.

At the final whistle, Ochoa and Messi grasped hands, and the goalkeeper known by his nickname Memo affectionately patted a gloved hand on his opponent's head. Ochoa did not speak to reporters after the game.

CAF announces dates for inter-club tournaments' group stages draw

THE Confederation of African Football (CAF) has officially announced that the draw for this season's Champions League and Confederation Cup group stages will be held on December 12 at its headquarters in Egypt.

Initially, the draw was scheduled to take place on November 16 but it failed to take place, given CAF said it would be scheduled for another date due to reasons beyond the confederation's control.

Simba SC and Yanga are the clubs representing Tanzania in the 2022/23 CAF Champions League and 2022/23 CAF Confederation Cup respectively.

The two have a long time to prepare for their matches due to their fixtures being slated to be played in February next year.

The TotalEnergies CAF Confederation Cup draw will be live from 13h00 (11h00 GMT) followed by TotalEnergies CAF Champions League draw at 14h00 (12h00 GMT).

Both draws will be live on CAF digital platforms and CAF TV partners.

Simba SC has been put in pot number 3 with the teams of CR Belouizdad and JS Kabylie from Algeria and Al Hilal SC from Sudan, who denied Yanga the chance to advance to the group stage of the premier club tournament in the continent.

The Tanzanian side will be eager to repeat their 2020/21 CAF Champions League group stage run having topped the group with 13 points ahead of Egypt's Al Ahly and AS Vita Club of DR Congo.

Simba SC as a result booked a place in the quarterfinals of the competition only to be eliminated by Kaizer Chiefs following a 4-3 aggregate loss to the latter.

Nabi explains crucial factor behind Yanga's 49-game unbeaten run

YANGA's head coach Nasreddine Nabi has lifted the lid on what he believes helped his club stretch its unbeaten run to 49 league games.


