



KCB (T), AzamPay ink online money transfers accord

KCB Bank (T) and AzamPay (T) have entered into a strategic partnership to further accelerate digital payments that will see the number of online transactions increasing by two folds to over 20m in a few years time.

The bank expects that the new partnership announced on Friday in Dar es Salaam will drive growth of e-commerce business in the country by simplifying online payments.

Briefing journalists on the partnership, KCB Bank Head of Marketing and Corporate Affairs, Christina Manyenye (pictured), said the online payment format guarantees

Ministry to evict herders from Nyerere Park zone

NATURAL Resources and Tourism minister Dr Damas Ndumbaro has announced government plans to remove herders who have invaded and engaged in human activities within the Julius Nyerere National

Addressing residents of Kalulu and Jakika villages in Tunduru District during a visit to listen to people's complaints of being invaded by wildlife in their farms, he said the park is reserved solely for tourism

He affirmed that problems posed

Though the government in the district set more than 200 grazing blocks, it is sad to note that some village officials allow herders to take their animals to prohibited areas

by wild animals; especially elephants, are to a great extent contributed by herders who introduce their livestock in prohibited areas which causes the

wildlife to flee their natural habitats. The government has already allocated special areas for grazing but due to financial muscle, herders bribe some unfaithful village officials and chairmen to get access to prohibited areas for livestock grazing, the minister explained.

He warned village officials to desist from corrupt practices allowing herders to graze animals in tourism areas, noting that such acts violate

THE Parliamentary Committee on Industries, Trade and Environment has recommended a change of the law guiding the Special Economic Zones Authority (EPZA) to focus more on the local market than export processing as is the case now.

This follows the slow pace in implementation of the Tanzania Mini Tiger Plan at the Bagamoyo Special Economic Zone and the Benjamin Mkapa Special Economic Zone which committee members toured recently.

In its report presented to the National Assembly on Saturday after the tabling of 2021/22 budget estimates for the Ministry Industry and Trade, the committee said the project was allocated 5bn/- in the 2020/2021 but by the time of the visit in March 2021, not a single cent was

"The EPZA law should be reviewed to increase the amount of goods being sold in the local market which is 20 per cent and the reminder 80 per cent is for export," reads the report.

"This will attract more investors to special economic zones and export processing zones because given its

Ex-BBC's journo steps down from high-profile job over Diana probe

LONDON

A former BBC chief who was criticised for his "woefully ineffective" probe into Martin Bashir's deception in securing a bombshell interview with Princess Diana on Saturday resigned as chair of Britain's National Gallery.

Journalist Bashir tricked Diana into giving a 1995 BBC television interview in which she lifted the lid on her troubled marriage to Prince Charles, an independent investigation concluded on Thursday.

Tony Hall (pictured), who had led an earlier investigation into the interview and was later named head of the BBC, said he had "today resigned as Chair of the National Gallery.

"As I said two days ago, I am very sorry for the events of 25 years ago and I believe leadership means taking responsibility," he said in a statement released by the world-renowned London gallery.

"I have always had a strong sense of public service and it is clear my continuing in the role would be a distraction to an institution I care deeply about".

Retired senior judge John Dyson said Bashir commissioned faked bank statements that falsely suggested some of Diana's closest aides were being paid by the security services to keep tabs on her.

Bashir then showed them to Diana's

population; Tanzania is a key market for products from these zones.

The committee noted the 5bn/- that was not disbursed in the last financial year was meant for undertaking feasibility study, preparation of a master plan, survey, design of onsite infrastructure as well as road construction.

The 'mini-tiger plan' is an economic projection envisaging fostering development increasing exports to the global market, a plan submitted to the parliament in May 2004 after a long period of negotiation in the bureaucratic spheres of parastatals and regulatory organizations, especially Tanzania Investment Centre.

The plan sought tacit support of fast growing countries forming the 'Tiger economies' South East Asia, especially Thailand, South Korea and distantly, Malaysia.

Tanzania was selected to be the center of this program as it met requirements including security,

political stability, millennium development programs, and numerous other factors but failed to carry out the necessary regulatory changes to enable special economic zones to take off, analysts say.

The plan began to be implemented in 2005 with a diversity of intentions like agricultural development, education promotion, construction of roads, water supply, investor outreach and other matters.

It was an imitation of fast developing Asian countries applying Tiger-style plans to their economic development, where Tanzania lacked credible local companies to pact with

Countries like South Korea, Vietnam and China have reached high levels of development through the use of free economic zones in coastal areas, which would cover regions of Tanga, Coast, Lindi and Mtwara if applied to Tanzania but no changes to the Land Acts of 1995 were conducted.

A trial period of the plan began in 2005 with the formation of specialized economic zones where a regulator sought to rent out land at high fees to investors for export processing industries, and most potential investors stayed away.

Questions have long been asked about how Bashir convinced Diana to talk on the BBC's flagship "Panorama" programme in November 1995, which was watched by a record 22.8 million people and won a string of television awards.

In it, she famously said "there were three people" in her marriage -- her, Charles and his long-time mistress and now wife, Camilla Parker-Bowles -- and also admitted adultery.

Bashir, now 58, was little-known at the time of the interview but went on to have a high-profile career on US television networks,

and interviewed stars such as Michael Jackson.

He returned to work for the corporation as religion editor until he stepped down last week, citing ill health, just hours before Dyson's report was submitted to BBC bosses.

On Sunday he apologised to Diana's sons Prince William and Prince Harry but said claims linking his actions to her death were "unreasonable".

A 1996 internal inquiry by Hall cleared Bashir of wrongdoing, but Dyson called that probe "flawed and woefully ineffective".

In particular, it did not ask Diana's brother for his version of events, Dyson said, lambasting it for failing to scrutinise Bashir's actions properly.

"If they had been able to test Mr Bashir's account by asking him to comment on Earl Spencer's detailed account, it is very unlikely that they would have believed him and concluded that he was an 'honest and an honourable man'," he wrote.

SGR trains to have special system to help in cutting likelihood of collisions

TANZANIA Railways Corporation has said the construction of the Standard Gauge Railway (SGR) will have in place modern system that will assist to avoid accidents during trains' operations.

It also said the system will not allow the train driver to increase or reduce the set speed.

The remarks were made at the weekend by the TRC assistant SGR manager for the 422km Morogoto Makutupora section Eng Christopher Mang'wela when addressing to engineers from the government and the private sector who visited the project whose implementation reached 61 per cent.

Mang'wela said the SGR operation will be of modern standard as it would be installed with special devices to direct the train driver to avoid accidents.

Earlier, speaking on behalf of the engineers present, the Engineers Registration Board (ERB) registrar Patrick Barozi said he has witnessed Tanzanians' aim and capability in the supervision

of big ongoing projects in the country as opposed to little supervision from foreigners.

"Bringing in our own engineers in the project will enhance the urge to take up many big contracts anticipated that would come up, this project is being well supervised from the start to where it has reached, and many of the engineers have learned a lot through the project," he added.

However, he said through the three SGR sections being implemented, local engineers have received adequate expertise that will help the government in implementing the next phases of the project.

For his part, an instructor from the University of Dar es Salaam (UDSM) Eng. Ramadhan Mlinga urged engineers in the SGR project to carefully follow up the project's last implementation stages in order to improve its next projects. "A project has five implementation stages including its being mooted planning, implementation, implementation's follow up and its closing up - all these stages have to be adhered to make a project a success," he added.

IN a stunning event after 15 years in Lake Victoria cotton growing zone, Kahama and Chato cotton growers have been paid a total of 90.6m/- by the Kahama Cooperative Union (KAU) and Chato Cooperative Union (CCU) in form of post-profit cooperative arrears and primarily because of Tanzania Agricultural Development Bank's (TADB) facilitation.

Presenting a facilitation report covering the last cotton growing season to the press over the

weekend, the TADB Lake zone manager, Mike Granta who spoke on behalf of the bank's managing director Japhet Justine said both the bank and the two cooperative unions are proud of the occurrence because, he said, it has restored the majesty of the cooperative movement and increased the disposable income of cotton growers.

"All of us are happy and proud of this incident. We work closely with the two unions. The payments are a result of hard work and honesty on the part of everyone who took part in the endeavour," he said.

Granta said the bank and unions struck a broad deal that sought to increase the financial might of the unions, restore the dignity of the cooperative movement and raise the price per kg to 900/-, increase growers' morale and confidence in the cash crop and improve their living.

Under that arrangement, he explained, the bank availed 11bn/- to the unions as an overall coordination package, enabling the unions to buy a kilogramme of cotton at 950/- instead of 810/-. "This forced other buyers to

trailing behind us," he reported, explaining that the unions used only 7.6bn/- because cotton on the market fell short of the projections.

The bank, he said, cooperated with the union in rehabilitating two ginneries at a cost of 1.2bn/-. Ginning adds value to the farmers' produce.

Govt and rice stakeholders in agreement on stepping up of food security in EA



The use of a single encryption to access content from different service providers; commercial agreements between broadcasters and advertisers; and the role of such facilities in licensing were among the issues discussed. This is the sixth time this year 2021 where TCRA has been organizing meetings to exchange ideas and experiences with the aim of improving Communication services.

TCRA is an independent body for the postal, broadcasting and electronic communications industries in the United Republic of Tanzania. It merged the former Tanzania Communications Commission and the Tanzania Broadcasting Commission. It is accountable to the Communications and Technology ministry. The Information Communication and Technology (ICT) sector reform in Tanzania is notable in that development was influenced by regional, political (national) and technological factors.

Expert: Many girls and women have very little knowledge about reproductive tract infections By Correspondent Marc Nkwame, Arusha

AS Tanzania prepares to join the rest of the world in observing the Menstrual Hygiene Day by the end of this month, scary observations have just emerged from recent studies on the girls' predicament as far as tampons, or lack of them, are concerned.

Apparently, most girls, especially students of boarding schools and those residing in rural villages have been found to lack access to those absorbency menstrual pads due to unavailability, unawareness or lack of money to buy the important toiletries.

"Parents usually send their daughters to boarding schools with little, if any, consideration of their menstrual health requirements," said Rogathe Severe Luakaki, the Project Officer for the Girls Power Initiative (GPI), explaining that the amount of pocket money given to the girls is not enough to cover their monthly needs for sanitary pads.

Due to that, some girls and young women in the country opt to smear 'Papier-mâché,' clay mud onto their private parts in order to contain outwards leakage of menstrual discharge, while others result to shoving themselves with pieces of foam mattresses, discarded clothes and other forms of crude fabrics.

According to the GPI officer, if girls continue to expose themselves to deadly devices in handling menstrual cycles they will be susceptible to contracting other serious infections in addition to risking possible injuries in even worse scenarios that may also lead to cancer.

In rural areas, girls sometimes resort to using leaves, especially large one from bananas or yams, plantains and other trees. GPI has described this phenomenon as 'Periods' Poverty.'

"Parents, or guardians only budget school fees, uniforms and pocket money but never remember menstrual products," stated Rogather pointing out the budget is only 2000/- per month which is just 26,000/ per year, quite affordable yet hardly considered.

The World 'Menstrual Hygiene Day' will be observed globally on May 28 and here in Tanzania, there will be special events to mark the day set to be staged in Arusha, Mbeya and Dar-es-Salaam regions, all targeting to reinforce awareness on the importance of ensuring girls hygiene to that effect.

The GPI organization has also been training girls on how to devise their own reusable homemade sanitary napkins from locally available materials and that can be safely recyclable, making them confident to face monthly circles with ease.

Mwajabu Mniga is the GPI coordinator who is also in-charge of organizing the 4th World Menstrual Day, in Arusha and arrangements for the 28th of May event have started, she said various organizations will participate at the pantomime to be staged at Elerai Secondary School grounds.

"We are targeting school girls as well as young ladies, empowering them on ways to devise or access all sanitaries absorbencies," said Mwajabu Mniga, adding that they were partnering with Jane Goodhall Roots and

Other partners include Wibena Impact from Uganda, Women Education and Development (WIDE), from Dar-es-salaam, Femi International, the parents and nurturing association of Tanzania (UMATI) and other supporters from Switzerland and Taiwan.

"We are addressing what we call periods' poverty, the problem of girls lacking saniatary products and stigma related to their menstrual changes," she stated. Events leading to the Global Menstrual Day have just been launched in Arusha.

GPI will also launch a six-month program starting next June, all the way to December 2021, that will entail worldwide online forums to address challenges affecting girls and women and how the governments can be involved in menstrual health.

This paper also managed to speak to a couple of girls who happen to be attending boarding schools and who preferred not to have their names published and they had this to say; "One of the things that drive most school girls to accept financial assistance even from vulgar and predatory men, is their striving to ensure that they get unlimited supply of tampons and other personal clothing items."

As far as the interviewed girls are concerned, most of them get apprehensive whenever they approach their menstrual cycles' dates, some even becoming psychologically affected, self-conscious and overly sensitive. "The situation usually gets worse when one lacks even the appropriate sanitary napkins to protect herself!" they pointed out.

Ministers can avoid traps by economic conspirators

HE current situation is not easy for policy makers at higher levels of the government, especially with cabinet ministers and permanent secretaries, owing to the changes wrought by the sixth phase government to obtain rapid improvement of the country's economy. Individual earnings and wider purchasing power are also targeted rather than generalized statistics of economic growth, especially as the lack of jobs was putting social cohesion at some risk, admittedly. Not everyone is positively inclined; resistance is likely.

In that case there is a psychological problem for those in leadership that would otherwise be grasped, as to how far actual actors in institutions that are being tasked with reform and examining their own roles critically can actually do the job. What is more perplexing is that this difficulty comes down to individual commitment to reform or change, and the extent to which this is the case can be noticed in what a top official says or the sort of advice such official gives to policy makers. But it needs that the one to whom that advice is directed can actually figure out what intent is involved, if it is proreform or is resisting it.

This sort of situation has been besieging Energy minister Dr Medard Kalemani, who has been facing systemic resistance in like manner as the prime minister was sorting out at the port of Dar es Salaam. Here what is malfunctioning is the prepaid meters system, arguably the most important tool connecting the power company (Tanesco) with the public, and where disruptions can have a lot of impact. The minister suspended three officials for failing to address the challenge in the pre-paid metering system.

Needless to add, the management ought to have been the first to ensure they properly do their work.

In that case, having the minister go to the spot and take measures is an indication of system failure, and his additional directive something worrisome has about it. He declared that the Luku system should be run by Tanzanians and not a company from outside the country, which apparently was related to the chaos in its operations, rather than existence of technical capacity locally and reducing costs by not procuring such services from outside. Obviously, it needs a proper feasibility study and recommendations like the late President Dr John Magufuli directed in relation to 'gold sand exports' to act on any clear proposals. What is at issue isn't whether,

prima facie, it is good or bad for the system to be run by a foreign company or be locally procured, but how it links with what has been taking place. Psychologically it isn't a foreign contracted company which can defy the government and the public by throwing the country or the city into darkness to get its way, but local stakeholders, especially within the company. So when the minister arrives there and issues that directive he may be playing precisely what the game set up envisaged, that the foreign company be removed. Then, lapses of a day or two where Luku sales are disconnected from a central register or revenue end point will be common, whether a blackout shall also be there or without it. Many will remember that only with the South African firm Netgroup did a number of public agencies pay their electricity bills; many wish foreign firms leave, so that they can tamper with the system, gain a lot.

Africa truly needs to start focusing on the neglected issue of mental health

health historically ∟on Africa's health and development policy agenda. Common experiences include: hallucination: hearing, seeing or feeling things that are not there; delusion: fixed false beliefs or suspicions not shared by others in the person's culture and that are firmly held even when there is evidence to the contrary; abnormal behaviour: disorganised behaviour such as wandering aimlessly, mumbling or laughing to self, strange appearance, selfneglect or appearing unkempt; disorganised speech: incoherent or irrelevant speech; and/or disturbances of emotions: marked apathy or disconnect between reported emotion and what is observed such as facial expression or body language.



ROM wet markets to empty markets, the functionality of food systems has shaped the COVID-19 pandemic and its impact, making it desperately clear that the status quo is unsustainable. Unsurprisingly, the inequities of the food system have been most acutely felt among the world's poor and marginalized people.

The number of poor people globally is likely to increase 20 percent above pre-pandemic levels, according to the newly published 2021 global food policy report. For emerging markets on the verge of middle-income like Ethiopia and Bangladesh, the pandemic threatens to reverse so much of the recent economic progress, underpinned by agricultural growth.

One in three young people in Bangladesh say they experienced moderate or severe food insecurity during lockdown, and in Ethiopia, more than 75 percent of people say they have lost income.

Pre-pandemic, Bangladesh and Ethiopia were among the so-called new "tiger economies", countries whose productivity was long held back by hunger, malnutrition and inequality, and where such factors have resurfaced since the start of the pandemic. For these economic tigers, their potential for both recovery and economic growth remains tied to agriculture, and fulfilling this potential will depend on science and innovation.

In agriculture, as with other sectors, the pandemic has fasttracked the digital revolution. While technology has provided short-

term solutions to reduce the impact with an emphasis on minimizing of restrictions on movement and labor, governments can take this opportunity to embed innovations for the longer term.

For example, CGIAR has been working with the Ethiopian government to develop apps that share nutritional advice as part of the Digital Ethiopia 2025 national strategy. Poor health and poverty are often interlinked, and these apps aim to help create awareness about food safety, consumption patterns and nutrition - all of which underpin good health.

Similarly, in Bangladesh, a new digital disease monitoring app allows users to identify hotspots, not only of COVID-19 but also crop and fish diseases. This has further protecting livelihoods and food security, which have both been impacted by the pandemic.

Secondly, while resilient and sustainable agricultural systems will not necessarily prevent another pandemic, they will go a long way in helping countries recover from the impact, and better prepare for the next shock.

Having data to measure disruptions and volatility in the agri-food chain, both at a global level and a national level, can inform policies that protect future food supplies. In Bangladesh, for example, CGIAR is working with local partners to monitor food, labor, input, supplies and prices, to advise on appropriate policies,

the impact of COVID-19 and other shocks on the most vulnerable members of society.

As the economic consequences of the pandemic become clear, supporting governments to develop and implement post-pandemic Action Plans with agriculture at their core can help provide a roadmap for recovery and future resilience. Data collection and innovative ways of collecting it such as the rise in farmer citizen scientists, who gather information within their communities - is vital to better understand the needs of those along the food chain and allow other countries to benefit from lessons learnt.

Finally, agriculture also offers the potential to reduce the extent a route to greater resilience of outbreaks and save harvests, against future health challenges in middle-income countries. As demonstrated by COVID-19, the crossovers between human, animal and environment health require an integrated One Health approach that tackles all three aspects together.

> This is why CGIAR researchers from ILRI have launched the One Health Research, Education and Outreach Centre in Africa (OHRECA), to leverage their expertise in animal health and cross-species disease to work alongside the Kenyan government and sequence the genome of SARS-CoV-2 circulating in Kenya.

But to fully develop a global One Health approach and support innovation in tackling hunger, malnutrition and climate change, governments and donors need to double their funding for agricultural research.

The recent announcement by the African Development Bank (AfDB) that it will continue to invest heavily in agricultural transformation is welcome news, and offers hope this will extend and build on the successes of the Technologies for African Agricultural Transformation (TAAT) program, led by CGIAR's IITA. The TAAT program has already brought to bear dozens of innovations, including 52 new technologies in Ethiopia alone, prompting the proposal being considered by the AfDB Board to fund a new, three-year phase of the

The effects of this pandemic are felt widely but unevenly, yet around the world, the common thread is food and food systems. No country or region can progress alone. But by leveraging all our agricultural research and innovation to bake in greater resilience in our food systems going forwards, we can accelerate the recovery and futureproof our food security.

Loss of income, increased food insecurity and reduced access to nutritional diets make it clear that agricultural transformation is central to a better functioning food system. It's time these tigers got their

ECENT media reports indicate that some officers at the Office of the Auditor General are allegedly exchanging their audit opinions for sums of money, usually determined by the officer or the team posted to an entity, thus aiding in occasioning loss to the State for private benefit.

This bitter reality has only come into the public domain after the now suspended chief executive officer of Uganda Airlines stated in a dossier to President Yoweri Museveni that officers from the Auditor General had allegedly asked for anything between Shs100 million and Shs150 million, if the airline was to get 'a good report'.

The same dossier stated that auditors from the Ministry of Works and Transport which oversees the airline had also allegedly asked for \$50,000 if the airline was to get a positive report.

While these do not come as major revelations, they confirm the position some people have held over time about the Auditor General's office. Just last year, executives

Auditor General can't afford stains from the Civil Aviation Authority complained about OAG staff who

had allegedly asked for \$1m to give a good report. While nothing came of these allegations then, the time for the Auditor General to act has come.

Insider jokes are that staff, who usually get a rotation of station every year and could be extended to a couple of years, are either rewarded or punished depending on the areas to which they get posted. It is alleged that postings within the agencies in infrastructure, for instance, are an elevation while being sent to health is a punishment.

These allegations cast all the good work that the Auditor General's office has done to the wind. It, therefore, begs the question. Are the reports from the Auditor General a true reflection of what is on the ground? Has the Auditor General's office been infiltrated by the selfseekers who now characterise part of the civil service? Are audit reports now on sale too?

The office of the Auditor General has been one of those that have done justice to the runaway spending

in this country. It is the one report accounting officers do not want to see on their desks; especially if they have qualified reports. It is also the report that MPs eagerly await for an entire year; just so they can rein in on errant accounting officers. It is one of the yardsticks on which the Permanent Secretary and Secretary to the Treasury uses when determining which accounting officer receives a new contract and which ones need to be replaced as accounting officers of their entities to which they are assigned to.

It is such a shame that such an institution is now viewed in the same lens as the other institutions of the State in which a few individuals have made corruption and the institution's name one and the same. For this, the Auditor General needs to act and act decisively.

I believe those individuals implicated in these allegations are known. Internal investigations should be instituted so as to offer a fair hearing to all parties, and if these persons are found to be wanting, then examples of them should be

made so as to offer a deterrence to anybody else who may want to ask for money so as to offer 'a good

The Auditor General also needs to lower the rotation period for all officers to one year such that nobody gets too comfortable, to cozy up with the entities they have been assigned to audit. No special considerations should be given even to those who have been posted to upcountry stations such as the local governments. The office should also conduct lifestyle audits so as to ascertain that everybody is living within their means and these should be followed up by declarations to the Inspectorate of Government such that the checks stay in place much longer than the duration of this crisis that the office has found itself in.

Lastly, the office should make corruption so risky that the officers will start to live by the example set for them by the Auditor General himself who is viewed as selfless, professional and a person of





So how cheering to know that Kiswahili has become the first indigenous language to be used by an organisation at an interstate level,

> Though trying to promote minority tongues is still a campaign in the making, but one that has always had my total attention.

Many years ago, I was in a London shop next to a group of young Africans conversing in a language I'd never heard before, and it sounded very melodic and pleasing to the ear.

The visitors told me they were from Tanzania, and the language was Swahili, which I thought was wonderful, and still do, and It's the only language I've come across where the oposite word for "yes" sounds so mild and

In English of course this is "NO".... in German it's "NEIN'...and "in Rus-

to the ear drums!

Yet in Swahili, (NO) "hapana" is so soft, as though those speaking the word, don't want to be impolite in giving a negative response to ...anything!

...and if Kiswahili is magical, what about the tribal languages, and why don't Tanzanians seem to value them?

When I first asked this question years ago, I was told these languages were "divisive", but the many differing cultural customs and habits which back them, can also be alienating, and not just the varying tongues. So should the customs also be done away with along with the languages and dialects, till everything is homogenised like the wester world now

Or perhhaps all tribal idendities could be merged into one cultural 'soup', rendering then meaningless. But look how boring parts of the world have become, since English and American now dominate and globalise the planet, along with promoting the capitalist culture.

Though the dominance appears benign, it can cause a degradation of the spirit, as well as eroding clan values. And let's not forget, crushing indigenous languages, was very often the first action conquerers and colonizers took, imposing their own tongues with barbaric discipline.

Dr. Victor Oladokun from the African Development the English idiom".

Bank, is passionate on this subject, and penned a piece ation, Oladokan says we have for the Guardian, writing, "... language is all encompassing and not just a means of communicating. It is also a repository of values, customs, culture and history...in short, it is the embodiment of who we are as a people".

But for some of the Nigerian and African elite, who do know their languages, but often decline to use them, Dr. Oladokan questions why they neglect to pass their knowledge on, and in what he calls linguistic snobbery, says they "often boast about the commmand their children have of

To add to this gloomy situa tech driven world today, that's dominated by less than a dozen global languages. And consequently, social media, TV and digital programmes, certainly don't utilise indigenous tongues, or deem them of any

But our wise doctor thinks that todays policy makers, producers, advertisers and the private and public sector, could team up to create regionally televised school debates etc. in the local languages. This could motivate the younger generation, and any awards they receive, could include academic prizes and scholarships, and the opportunity to meet and be honored by well

known national leaders.

...it seems ambitious though implementable, but how do we get to persuade those in a position to act?

...well, maybe appeals to tourism officials could be made here...like those in Kenya, where tribalism and all that goes with it, has been highly glamourised for multiple tourist purposes, with great success.

But does this degrade the culture, or keep it alive....possibly both!

Rawan becomes first Tanzanian woman to climb Mount Everest

RAWAN Dakik (pictured) has become the first Tanzanian woman to climb Mount Everest, the world's highest peak on a day when the first fatalities were recorded on the mountain.

Though she is yet to make it to the summit, Rawan has completed her second rotation at 7200m, she is now waiting for good weather to reach the summit, a feat she is likely to achieve on May 20.

Two climbers from the United States and Switzerland have died on Mount Everest, the first fatalities of this year's season, expedition organis-

ers in Nepal said Thursday. But in recent seasons, Everest has seen a surge in the number of climb-

ers, leading to overcrowding that has been blamed for multiple deaths. "Two climbers passed away on Wednesday," Mingma Sherpa of Seven

Summit Treks told AFP. Swiss climber Abdul Waraich, 40, died near the summit after reaching the top and suffering exhaustion, said Chhang Dawa Sherpa from the

same organisation. Speaking of her journey to the world's highest mountain on an Instagram story, Rawan said that climbing Mountain Everest is probably one

of the hardest things she has done. According to her she is waiting for the weather window alongside her team to push for the summit.

"Base camp was hit by a snow storm for a few days which caused damage in the icefall and a short delay to our schedule. We are waiting for the icefall doctors to head up and fix the route before pushing to our first rotation," she writes.

On March 20, 2021 she announced that she would be climbing Mountain Everest to support children living with Cancer.

"A few years ago if you'd ask me about climbing Everest, I would've probably told you that you're mad and I wouldn't plan on going that extreme. Here I am today, packing and getting ready for my departure tomorrow," said Rawan in an Instagram post.

She added: There was a lot of planning, training, organizing, a feel of mixed emotions, trip getting cancelled last year and a bunch of thoughts that can't be put into words.

Brewer sponsors 450 sorghum farmers at TARI exhibition

A TOTAL of 450 sorghum farmers from Kongwa, Mpwapwa and Chamwino districts in Dodoma have participated at the Tanzania Agricultural Research Institute (TARI) exhibition held at Hombolo over the weekend.

The smallholder farmers were sponsored by the Tanzania Breweries Public Limited Company (TBL Plc) because they are an essential part of the company's supply chain.

The company sources 74 percent of its raw materials locally, including 9,000 tonnes of sorghum for the production of its fast-growing affordable beer brands such as Eagle and Bingwa.

In 2020, TBL Plc collaborated with the United Nations World Food Programme (WFP) and Farm to Market Alliance (FtMA) to conduct a pilot project which supported 2,000 sorghum farmers in Dodoma. They were provided with seeds, crop insurance, crop-management protocols and agriculturalextension services to ensure improved aggregation and market access.

The company also partnered with TARI to research and develop sorghum seeds that are best suited to the soil and climatic conditions of Tanzania. These projects proved to be a phenomenal success, with a 70 percent improvement in sorghum production than in the previous years.

The project has now been extended to procure sorghum from 4,000 farmers for the 2021 season and had distributed 22 tonnes of the targeted sorghum seeds that were sourced from Namburi Seed Company in Mbeya and TARI in Dodoma.

TARI exhibition brought together agriculture stakeholders to showcase partnerships tailored to develop agriculture in Tanzania and address the challenges that farmers face in the field. The sponsored farmers had an opportunity to learn about farming practices and technologies that will allow them to increase their

productivity, and to create and strengthen partnerships with key stakeholders.

Speaking on behalf of the participating sorghum farmers, Leonard Yeramu, from Kongwa, thanked TBL for enabling them to participate in the exhibition as they have learned various techniques related to sorghum farming.

By supporting farmers with skills, networks and financial empowerment, TBL helps them improve their productivity, profit and efficient use of natural resources.

All these initiatives are in line with TBL's parent company AB InBev's goal of 100 percent of its direct farmers being skilled, connected, and financially empowered by 2025. representatives, but we want to do more".

Tanzania needs formal CHWs in rural areas, expert suggests

TANZANIA needs formal community-based health workers (CHWs) to address maternal mortality in rural areas across the country, an Obstetrician and Gynecologist at the Ifakara District Hospital Dr. Elias Kweyamba has sug-

Dr Kwevamba was speaking recently in Morogoro at a workshop on Sexual Reproductive and Maternal Health organized by Marie Stopes.

He said a formal community-based health program initiated by the government three years ago through the ministry of health, community development, gender, elders and children was key in ensuring that health experts are availed in most rural areas in the

Dr Kweyamba said the move did not only help health experts to conduct diagnosis to pregnant mothers and become aware of the pregnancy complications, but it also helps to save lives of pregnant mothers not having access to health facilities due to customs and

However, the expert said the program that was run for at least three years has since been stopped making it difficult to track the health of most rural pregnant mothers without access

to health facilities.

"We need such a project in the health sector if we are to save the lives of pregnant women and young mothers in rural areas," he said.

According to him, community-based health workers helped a lot in tracking the progress of pregnant mothers in rural areas without access to health facilities.

This, he said becomes easy for health experts to make diagnoses on pregnant mothers at an early stage and solve any arising pregnancy complications thereby saving lives.

Dr Kweyamba said it is very important for pregnant mothers to access services on time and at the right time as maternal mortality usually occurs when there is a delay to seek medical care, delay in accessing health services, and also in receiving care.

According to him, maternal complications and deaths cannot be predicted but can be prevented if there is the availability of formal communitybased health workers in rural areas. He said these community-based

health workers make visitation to homes of pregnant mothers to know the complication they face in their pregnancies but also to sensitize them on the importance of visiting clinics.

Health Organisation ((WHO)on maternal mortality in the country show at least 500/100,000 deaths occur annually with the major causes being hemorrhage, hypertensive disorder of pregnancy, obstructed labor, sepsis, and abortion complication.

The report says young adolescents age (10-14) face a high risk of complications death as a result of pregnancy complications than other women.

It says on average, the lifetime risk of maternal death in high-income countries is 1 in 33,000 compared with 1 in 41 in low-income countries.

However, the August 2020 report by UNICEF on Tanzania saving mothers and children lives through innovative, sustainable and comprehensive reproductive carried out between 2015 and 2019 said Tanzania had made gainful strides in reducing maternal and newborn deaths in line with global efforts of Sustainable Development Goal 3 which addresses all major health priorities including reproductive, maternal and child health.

Tanzania has therefore ensured that it invests heavily in healthcare services and also works closely with development partners in addressing challenges in accessing quality healthcare with a specific focus on reproductive, Available reports from the World maternal and newborn.

this side of the Niger River to have the courage to call for the dissolution of this union. A union where I am perpetually a secondclass citizen by the dictates of the southern elite and wholly accepted by the northern pseudo-elite. CRDB Bank Plc's shareholders unanimously endorsed a 22/- per share dividend being an increase of almost 30 percent compared to last year's 17/- per share earning.

The shareholders who were attending their 26th annual general meeting which ended here on Saturday paid tribute to Managing Director and CEO, Abdulmajid Nsekela and Board Chairman, Dr Ally Laay for continuing to make profit despite the difficult caused by the coronavirus outbreak last year.

Safaricom consortium wins Ethiopia licence bid on Sh91.8bn telcom offer

NAIROBI

SAFARICOM has been awarded a telecommunications licence to operate in Ethiopia – one of the world's last major closed telecoms markets, the Ethiopian government announced on Saturday.

Safaricom beat other consortia in the last stretch of a year long race for access to one of the world's last telecoms frontiers.

Ethiopian Prime Minister Abiy Ahmed said the Safaricom led consortium that includes its parent firms Vodafone and Vodacom, British development finance agency CDC Group and Japan's Sumitomo Corporation won the award after submitting a financial bid of \$850 million (Sh91.8 billion).

"The Council of Ministers has unanimously made a historic decision today allowing Ethiopian Communications Authority to grant a new nationwide telecom license to the Global Partnership for Ethiopia which offered the highest licensing fee and a very solid investment case," Prime Minister Abiy Ahmed said through his Twitter handle on Satur-

The Safaricom consortia is expected to invest over \$8billion (Sh864 billion) over the next decade, he added.

"With over \$8 billion total investment, this will be the single largest FDI into Ethiopia to date, said the Prime Minister noting that the process was competitive and above board.

"Our desire to take Ethiopia fully digital is on track. I would like to thank all that have taken part in this and for pulling off a very transparent and effective process," he said.

The Ethiopian Communications Authority had earlier listed 12 firms including Safaricom last November as among firms that had expressed interest in entering the country's telecommunications market.

ECA director general Balcha Reba said in a statement Friday the award marked a new era in the country's telecommunications development which would benefit all Ethiopians.

Ethiopia's nascent telecommunications sector is considered one of the most lucrative in the economy as the once inward-looking country opens up to foreign investment for the first



Players like Safaricom are attracted by the growth potential in the Ethiopian market, whose 100 million population offers a penetration rate of 44 per cent.

The Safaricom consortium, will likely now rely on funding from deep-pocketed foreign investors such as the US International Development Finance Corporation (DFC) Ethiopia investment.

South Africa's Vodacom and United Kingdom's Vodafone own a combined 40 per cent stake in Safaricom. Ethiopia had earlier this month made a U-turn and allowed foreign telecommunications companies to launch mobile phone-based financial services, setand CDC given the size and international nature of the ting the stage for Safaricom to introduce its popular

M-Pesa in the market of 110 million people. PM Ahmed said then the mobile financial services in the country will be opened to competition from next May, with foreign firms free to battle with State-run Ethio Telecom.

Retail investors learn to love the crypto rollercoaster

NEW YORK

WHEN Brjánn Bettencourt rolled out of bed on Wednesday morning to find the assets in his cryptocurrency portfolio slammed in their biggest selloff in years, he knew exactly what to do: buy more.

"Investing in crypto is not for the faint of heart," said Bettencourt, a 32-year-old photographer in Toronto who has owned bitcoin and ether over the last year-and-a-half to complement his stock portfolio. "I'm looking at this as a serious longterm investment."

This week, cryptocurrencies were buffeted by factors ranging from critical tweets by Tesla Inc CEO Elon Musk to governmental controls in China. The price of bitcoin, the world's biggest cryptocurrency, tumbled as much as 30 percent before retracing some losses. It is down some 40 percent from its highs of the year.

Leveraged positions in bitcoin and ether futures fell sharply last week, said Vanda Research, which tracks retail trades. This indicates that some retail traders probably have folded their tents.

"(The) crypto bubble has started to unravel and data from different exchanges suggest that retail investors are capitulating," Vanda researchers said.



But other retail investors have been happy to ride the turbulence out or trade around it.

"In crypto talk, when stuff like this happens, people say it shakes out all of the weak hands and the people ... who maybe bought because they saw it on the news," said Ethan Lou, author of "Once a Bitcoin Miner: Scandal and Turmoil in the Cryptocurrency Wild West," due this autumn.

As retail investors piled into cryptocurrencies, bitcoin surged around 345 percent in the last year, ether soared 1,219 percent and dogecoin skyrocketed 15,480%, according to Coinbase data. Crypto-exchange Coinbase said its more than 56 million users accounted for \$335 billion in trading volume in the first quarter: \$120 billion retail and \$215 billion institutional. That compares to \$30 billion in total a year earlier,

of which \$12 billion was retail, the company said.

Retail interest this year also scooped up shares of "meme stocks" such as GameStop pushing prices through the roof and punishing hedge funds that had sold the shares short.

Some retail investors have embraced the wild price swings in hopes of catching some of the next big rally. Users on Reddit's popular WallStreetBets forum have popularized the term "diamond hands" as shorthand for their willingness to hold an asset through thick and

Increased mainstream adoption has drawn the attention of regulators. The U.S. Treasury Department on Thursday called for new rules that would require large cryptocurrency transfers to be reported to the Internal Revenue Service. The Federal Reserve said cryptocurrencies pose risks to financial stability. China said it will crack down on bitcoin mining and trading activities.

Cryptocurrencies have been notoriously volatile throughout their history. Bitcoin plunged 94 percent in 2011, and dropped 82 percent between late 2017 and the end of 2018, causing many investors to back

Lily Francus, however, has tried to take advantage of the big swings.

The 25-year-old, who lives in San Diego and works as a quantitative researcher at a crypto hedge fund, first traded cryptocurrencies in 2017, but got out before the price crashed. Then last month she put about 1 percen5t of her net worth into various cryptocurrencies, joining a rally she saw as partly fueled by social media

She liquidated her ether and cut her bitcoin position when Musk hosted Saturday Night Live on May 8. She later bought 40 percent of her ether position back at a lower price.

The Tesla CEO has flip-flopped on whether the electric carmaker would accept bitcoin as a payment, and has often moved the price of dogecoin with his tweets.

When you see ... people diving into the markets for fear of missing out, that's usually a good time to get out," Francus said.

Doug Liantonio, 31, of Deerfield Beach, Florida, said he owns dogecoin and ethereum classic. With dogecoin prices down 50% from their highs, he is waiting for another rally before selling.

MP commends CRDB for extending to small-scale traders unsecured loans

STREETS hawkers popularly known as 'machinga' are becoming a huge industry which banks and other financial institutions cannot ignore but follow CRDB Bank Plc's example in giving the group concessional loans.

Arusha Urban legislator Mrisho Gambo told CRDB shareholders who are attending a seminar on basics of financial management and investing in stock market listed companies, that the Dar es Salaam based lenders' decision to give unsecured loans to the group with only their official business identity cards, is a major milestone towards fighting unemployment and poverty among youths.

"A bank that gives loans to 'Machingas' with only their identity card as collateral, is truly a Tanzanians bank," Gambo said while adding that because of CRDB's exemplary gesture to low income Tanzania, he will now buy shares to partly own the massive bank.

While paying tribute to Nsekela's good management leadership, the Arusha Urban lawmaker said any wise investor cannot avoid buying shares of the bank which has defied the coronavirus outbreak and continued to make profit in billions of shillings.

"With this kind of performance, it is clear that the future is bright," he added while pleading with Finance and Economic Planning Minister, Dr Mwigulu Nchemba and Bank of Tanzania to take measures and lower interest rates charged on loans in the market.

Bank of Tanzania's Deputy Governor Dr Bernard Kibesse also urged banks to continue lowering interest rates charged on loans saying the central bank is taking all necessary measures to ensure that the trend should steadily go down.

"As regulators, we will continue to support banks operate in a conducive environment," Dr Kibesse said while also challenging Tanzanians to invest in listed companies and government securities.

In his key note address to open the seminar, Dr Nchemba promised to meet bankers and discuss which policy and regulatory changes are needed to trigger sustained reduction of interest rates charged on loans which are currently hovering around 16 percent on average.

Jobs, paycuts slash payroll collection by Sh6.4 billion

NAIROBI

PAYROLL taxes fell Sh6.4 billion in the quarter ended March despite the Treasury reinstating income tax cuts, highlighting the impact of Covid-19 on layoffs and pay cuts.

The Kenya Revenue Authority (KRA) received Pay As You Earn (PAYE) taxes amounting to Sh98.97 billion in the period compared with Sh105.36 billion in the first three months of last year, the Treasury says in the quarterly budgetary review report.

The 6.06 percent drop in PAYE taxes, remitted by 9th of the following month, reflects a tough labour market which has seen firms step up salary cuts to stay afloat in an economy struggling to recover from Covid-19

The payroll taxes continued to fall despite the Treasury roping more workers into top tax rate bracket and ending tax reliefs for those earning more than Sh24,000 a month.

The tax cuts were introduced in April last year after Kenya reported its first case of the coronavirus and aimed to shield the economy. They were reinstated in January 1.

"The Covid-19 pandemic continues to adversely impact on jobs, livelihoods and enterprise performance. The job market has not recovered,"

Federation of Kenya Employers (FKE) executive director Iacqueline Mugo said. Treasury secretary Ukur Yatani reinstated the maximum income tax rate of 30 percent for workers on January 1 after getting approval from lawmakers, ending a six-month relief where the top rate tax had been reduced to 25 percent.

The Treasury spared workers earning monthly pay of Sh24,000 whose pay remain tax-free, but compensated this by expanding the maximum payroll tax band to apply from a salary of Sh32,333 compared with Sh47,057 in the pre-Covid period.

"Many people are out of employment and enterprises are trying very hard to stay afloat. The labour market impact of the pandemic indicates the devastating effect on the informal economy," Ms Mugo said

Findings of a monthly Stanbic Bank Kenya's Purchasing Managers Index (PMI) has suggested that while private firms gradually increased monthly workforce between October 2020 and March 2021, they stepped up pay cuts and lower salary offers for returning workers and new recruits.

Treasury data shows payroll taxes in nine months through March 2021 amounted to Sh251.58 billion, falling short of its target by 21.36 percent or Sh24.78 billion.

Zara Inditex to close all stores in Venezuela

CARACAS

INDITEX owner of brands including Zara, Bershka and Pull & Bear, will close all its stores in Venezuela in coming weeks as a deal between the retailer and its local partner Phoenix World Trade has come under review, a spokesperson for Phoenix World Trade said.

Phoenix World Trade, a company based in Panama and controlled by Venezuelan businessman Camilo Ibrahim, took over operation of Inditex stores in the South American country in 2007.

"Phoenix World Trade is re-evaluating the commercial presence of its franchised brands Zara, Bershka and Pull&Bear in Venezuela, to make it consistent with the new model of integration and digital transformation announced by Inditex," the company said in response to a Reuters request. "The five stores which remain open... will cease to operate in coming weeks".

Spanish group Inditex did not respond to Reuters' request for information about the closing measures.

The closures come as Inditex, the world's largest clothing retail group, scales back smaller outlets worldwide in favor of expanding flagship stores, with 1,200 closures expected by the end of 2021.

Up to 700 stores are due to close in Europe, as well as 100 in the Americas and 400 elsewhere in the world.

In at least three large Venezuelan malls, the spaces formerly occupied by Zara and Pull & Bear - another Inditex brand - are empty, said two local retail executives. Both spoke on condition of anonymity as they were not authorized to talk publicly about the decision.


In the capital, three stores have closed in May, according to Reuters witnesses. The Zara stores open until last week in Caracas were offering items from the spring collection. Ibrahim became Inditex' local partner in 2007 to assist in

dealing with changing local regulations and keeping shelves stocked as socialist former President Hugo Chavez' government exerted tight control over the foreign-exchange market, and businesses needed approval from the government to buy the dollars needed to import clothing.

That occasionally left clothing stores empty as businesses struggled to obtain hard currency.

Despite the decision to shut Zara locations, Venezuelan businessmen are currently allowed to import goods and sell them at hard-currency prices, a break from years of price controls on many key items. Luxury stores known as bodegones, and coffee shops that advertise prices in dollars, have surged as part of a chaotic economic liberalization.

The white walls blocking the entrance of a closed Zara store in Caracas announce the upcoming opening of a store by the name of Lola, an unknown brand in the country. According to local sources, Ibrahim's group will reopen those

Gaza truce holds as Israel admits Jewish visitors to flashpoint site

JERUSALEM/GAZA

The Israel-Hamas ceasefire held into a third day yesterday as Israeli police admitted Jewish visitors to a contested Jerusalem holy site where earlier confrontations with Palestinian protesters helped to ignite the cross-border Gaza fighting.

Police reported no unusual incidents at the al-Aqsa mosque compound - one of Islam's holiest sites - as Israeli social

media accounts showed a few dozen Jews in religious garb strolling around the site under guard.

A police spokesman described it as a regular scheduled visit after a break that began on May 3 for the Muslim holy month of Ramadan.

The site is also revered by Jews and is situated in East Jerusalem, which Israel captured in a 1967 war. Israel deems all of Jerusalem its capital, a status not rec-

CHINESE President Xi Jinping on Friday pledged to provide more COVID-19 vaccines to the best of China's ability to the world, calling for rejection of vaccine nationalism to make vaccines more accessible and affordable in developing coun-

Xi made the remarks via video at the Global Health Summit, which was co-hosted by Italy, which currently holds the G20 presidency, and the European Commission.

REJECTING VACCINE **NATIONALISM**

"It is imperative for us to reject vaccine nationalism and find solutions to issues concerning the production capacity and distribution of vaccines. in order to make vaccines more accessible and affordable in developing countries," Xi said, nization gap.Having already supplied 300 million doses of vaccines to the world, China will provide still more vaccines to the best of its ability, he said.

The Chinese president also pledged to support its vaccine companies in transferring technologies to other developing countries and carrying out joint production with them.

"Having announced support for waiving intellectual property rights on COVID-19 vaccines, China also supports the World Trade Organization and

other international institutions in making an early decision on this matter," he said.Xi proposed setting up an international forum on vaccine cooperation for vaccine-developing and producing countries, companies and other stakeholders to explore ways of promoting fair and equitable distribution of vaccines around the world.

"Vaccines are powerful tools in the fight against the pandemic. Yet, the problem of uneven vaccination has become more acute, as some developed Western countries are hoarding vaccines while offering nothing but superficial lip service to countries in urgent need," said Su Xiaohui, a researcher with the China Institute of International Studies.

Notwithstanding the limited production capacity and enormous demand at home, China has honored its commitment by providing free vaccines to calling for upholding fairness more than 80 developing counand equity to close the immutries in urgent need and exporting vaccines to 43 countries.

EXTRAORDI-MAKING **NARY RESPONSE**

In the face of continuing ravages of the pandemic, with repeated resurgence and frequent mutations of the coronavirus, Xi called for putting people's lives and health front and center, demonstrating a great sense of political responsibility and courage, and making extraordinary responses to an extraordinary challenge.

Russia's space corporation to submit its

updated lunar programme to govt in June

MOSCOW

RUSSIA'S state-run space corporation Roscosmos plans to submit its updated lunar program to the Russian government in June, Roscosmos Executive Director for Long-Term Programs and Science Alexander Bloshenko told reporters on Saturday.

"We will submit the program, updated in accordance with the four-launch scheme, to the government in June," he said during the New Knowledge forum.

According to the Russian space official, the current version of the lunar program envisages the use of a superheavy carrier rocket. The alternative variant is to use four Angara rockets for the purpose.

Roscosmos Director General Dmitry Rogozin said in late 2020 that the availability of two launch pads for the Angara carrier rocket (at the Vostochny and Plesetsk space centers) from 2023 would make it possible to combine launches, assembling crewed spaceships in orbit. This would serve as the basic instrument for the start of

lunar explorations, he said.

This March, the Roscosmos chief said a four-launch option of sending the crew to the Moon with the help of Angara rockets would be cheaper than a flight with the use of two super-heavy rockets.

Germany imposes UK travel curbs due to variant from India

GERMANY will impose fresh restrictions on travelers from the UK starting yesterday due to the rapid spread in Britain of the coronavirus strain first identified in India.

Travelers from the UK will have to spend two weeks in quarantine upon arrival in Germany even if they test negative for the virus, according to the foreign ministry. In addition, transport companies will only be allowed to bring German citizens back into the country.

Germany now classifies Britain as a "virus variant area," the country's highest risk category, following a recommendation from the Robert Koch Institute (RKI), according to the foreign ministry.

Supplies of COVID-19 vaccines are beginning to outstrip demand in the European Union's east - a phenomenon that may concern western member states whose citizens are wary of inoculation.

Some parts of the region are hitting a wall at a relatively early stage in their campaigns amid safety fears over AstraZeneca's shot, longstanding distrust of the authorities, fake news stories, and a lack of education on the benefits of the injection and the dangers of the virus itself.

UK journalist at centre of Diana storm denies link to her death

LONDON

A former BBC journalist found to have deceived Princess Diana in order to secure an explosive interview with her in 1995 has denied he was responsible for a chain of events that led to her death, a newspaper reported.

Martin Bashir (pictured) told The Sunday Times he believed his ac-

tions did not harm Diana. An independent investigation published on Thursday found that Bashir lied and deceived Diana that she was being spied upon to persuade her to agree to the interview in which she disclosed details of her failed marriage to Prince

"I never wanted to harm Diana in any way and I don't believe we did," Bashir told The Sunday Times.

Diana's eldest son William has said the way the interview was secured was "deceitful" and the BBC's failures contributed significantly to Diana's "fear, paranoia and isola-

His younger brother Prince Harry and Diana's brother Charles Spencer have said the interview was part of a series of unethical practices that ultimately cost Diana her life in a car crash in Paris

"I don't feel I can be held responsible for many of the other things



that were going on in her life, and the complex issues surrounding those decisions," Bashir told The

Sunday Times in an interview.

"I can understand the motivation... but to channel the tragedy, the difficult relationship between the royal family and the media purely on to my shoulders feels a little unreasonable ... The suggestion I am singularly responsible I think is unreasonable and unfair."

The Sunday Times quoted Bashir as admitting that he used forged bank statements which the inquiry said was part of the deception of Diana . "Obviously I regret it, it was wrong," he told the newspaper. "But it had no bearing on anything. It had no bearing on (Diana), it had no bearing on the interview."

Joint Russia-EU projects frozen due to Brussels, diplomat points out

JOINT projects of Russia and the European Union were blocked because of anti-Russian sanctions and aggressive rhetoric from Brussels, Russian Foreign Ministry Spokeswoman Maria Zakharova blogged on Facebook on Saturday in comments on allegations from the Austrian foreign minister that Moscow showed no interest in dialogue with the EU.

"This is not true. There were many political, humanitarian and economic projects in which Russia and the EU participated. But they were blocked after Brussels had adopted anti-Russian sanctions and replaced dialogue with aggressive rhetoric, baseless accusations and disinformation campaigns," Zakharova wrote on her Facebook page.

Earlier on Saturday Austrian Foreign Minister Alexander Schallenberg alleged ahead of the May 24 EU summit that the European Union wanted to build a dialogue with Russia, but Moscow was not interested

He also said that the European Union and Russia should cooperate on many tracks, from climate to the energy sector, expressing hope for a change in the mood of EU-Russia relations.

BBC still operates on deceit, from Diana to Xinjiang



Impressed by China's technological achievements, former Hungarian Prime Minister Peter Medgyessy, said, "The quality of life in China has also changed a lot, and this is perhaps even more important than technical progress."

"The success of the party is based on two things, one is that it has represented a stable set of values that can be maintained in the long run, and the other is its very good ability to renew itself," Medgyessy said.

Mahdi Dakhlallah, a leading member of Syria's ruling al-Baath party, said that the notion of "putting the people first" has pushed China forward.

Adan Chavez, vice president of the United Socialist Party of Venezuela, visited China four times between 2017 and 2019. Volcano erupts in eastern Congo, thousands flee Goma

LAVA from a volcanic eruption approached the airport of eastern Democratic Republic of Congo's main city of Goma late on Saturday, and the government urged residents to evacuate.

As the red glow of Mount Nyiragongo tinged the night sky above the lakeside city of about 2 million, thousands of Goma residents carrying mattresses and other belongings fled the city on foot - many toward the frontier with Rwanda.

Nyiragongo's last eruption in 2002 killed 250 people and left 120,000 homeless. It is one of the world's most active volcanoes and is considered among the most dan-

Rwanda's Ministry in Charge of Emergency Management said more than 3,500 Congolese have crossed the border. Rwandan state media said they would be lodged in schools and places of worship.

New fractures were opening in the volcano, letting lava flow south toward the city after initially flowing east toward Rwanda, said Dario Tedesco, a volcanologist based in

"Now Goma is the target," Tedesco told Reuters. "It's similar to 2002.

I think that the lava is going towards the city centre."

"It might stop before or go on. It's difficult to forecast," he said.

Emmanuel De Merode, head of Virunga National Park, asked park employees in parts of Goma to evacuate, according a note seen by Reuters. He said lava had reached the international airport on the eastern edge of the city but that it was not likely to reach other parts of Goma.

Celestin Kasereka, head of scientific research at the Goma Volcano Observatory (OVG), told reporters he did not think the lava was flowing fast enough to reach Goma.

A United Nations source said all UN aircraft had been evacuated to the city of Bukavu to the south and Entebbe in neighbouring Uganda. The power was also out across much of Goma.

Prime Minister Jean-Michel Sama Lukonde convened an emergency meeting in the capital, Kinshasa, where the government activated an evacuation plan for Goma.

"We hope that the measures that have been taken this evening will allow the population to reach the points that were indicated to them in this plan," government spokesman Patrick Muyaya said in comments broadcast on national television. President Felix Tshisekedi will cut short a trip to Europe to return to Con-

go on Sunday, the presidency said on Twitter.

On the streets of Goma, panic spread quickly.

"We are panicked because we have just seen the entire city covered by a light that is not electricity or lamps," said John Kilosho. "We don't know what to do. We don't even know how to behave. There is no information." Others fled to the city centre from villages and neighborhoods threatened by lava on the northern outskirts.

"We looked at the sky and saw the red colour of the volcano," said Richard Hazika Diouf from the Majengo neighbourhood. "We have fled to seek shelter in town."

Volcano watchers have been worried that the volcanic activity observed in the last five years at Nyiragongo mirrors that in the years preceding eruptions in 1977 and 2002.

Volcanologists at the OVG, which monitors Nyiragongo, have struggled to make basic checks on a regular basis since the World Bank cut funding amid embezzlement allegations.

Houthi leader dismisses US sanctions, warns more attacks

A LEADER of Yemen's Iran-aligned Houthi movement yesterday dismissed US sanctions on military officials and threatened possible expanded attacks on "aggressor countries" after Washington urged the group to engage seriously in peace efforts.

The United States on Thursday imposed sanctions on two Houthi military officials leading an offensive to seize Yemen's Marib region as the US special envoy on Yemen called for de-escalation and pressed for a cease-

The Houthis have been battling a Saudi Arabian-led military coalition for more than six years in a war that has killed tens of thousands of people and pushed Yemen to the brink of famine.

"Sanctions do not scare the mujahideen" holy fighters, Mohammed Ali al-Houthi, head of the group's supreme revolutionary committee, said in a Twitter post. "If they continue the blockade and aggression, then perhaps there will be strikes on unexpected sites in some aggressor countries.' The movement has kept up cross-border attacks on

Saudi Arabia and its offensive in Yemen's gas-rich Marib after Rivadh in March proposed a nationwide cease-

fire deal that includes reopening air and sea links to Houthi-held areas. But the Houthis have insisted restrictions be lifted on Hodeidah port, the main entry of Yemen's commercial and aid imports, and Sanaa airport before any truce

The Saudi-led coalition intervened in Yemen in March 2015 after the Houthis ousted the internationally recognised government from the capital, Sanaa, in a conflict widely seen as a proxy war between rivals Saudi Arabia and Iran.

US envoy Tim Lenderking on Thursday also urged the coalition to remove restrictions on all Yemeni ports and airports to ease what the United Nations says is the world's largest humanitarian crisis.

Kaizer Chiefs' hotel 'precautions' show 'technical committees' still rampant

PLENTY of behind-the-scenes contests were ongoing before the return leg of the CAF Champions League quarterfinals' stage between Kaizer Chiefs of South Africa and Simba SC of Tanzania, although Simba SC had already been shown the door with a 4-0 drubbing in the first leg.

Despite animated fan-zone magical expectations of a repeat of Mufulira Wanderers in 1978, few actual pundits or perhaps experts expected another 5-0 turnaround, and looking at the issue in psychological terms the matter didn't exist in the first place.

During those days no link existed between a club in Dar es Salaam and another in Lusaka, Ndola, or elsewhere, unlike current modernity, digital links.

In other words, there is room for a surprise the way Kaizer Chiefs stunned Simba with four goals that went unanswered, where plenty of explanations were given, and pre-match psychological contests and hotel premise precautions were so frenzied as to call into question, virtually, sanity itself.

While the visitors were said to have issued strict orders not to receive any guests - that they remain on their turf in hotel rooms up to playing time, and no psychic Trojan Horses would be allowed to bring any 'gifts' or 'greet' anyone.

When one is in foreign, strange, or hostile territory that was the least they could have

The home side was on the contrary awash with activities the previous day, all being noticed by passers-by on the busy off-road roads around the Benjamin Mkapa Stadium, engaged in regularly condemned, routinely disowned, and persistent sorcery operations ahead of the match.

One internet uploading showed a coconut breaking scene, which has no cooking explanation in that area except as clear routine Swahili witchcraft.

Whether this was an operation to merely beef up psychological preparations or was indeed the mainstay of what the club expected could turnaround the match prospects was something entirely opaque.

By the club's records or say register in that direction, there is something of a mixed grill from such operations, as it is well known from psycho-occult operations of that sort - that they are like a throw of dice and can come out in whatever manner.

It is not easy to say what causes potentially negative results if it is a cheating priest (better known as a local healer) or it

is the mechanism of that operation itself, as it involves from this side, and it spiritual beings with a different layer of command or was considered that 10 lovelty.

It is the disposition of this layer that is incapable of being accessed a priori, and when one indulges in their fancies, he is captive to them.

That is what can be surmised from a distant lesson that Simba registered in the past and evidently, the lessons were mixed so to speak, in which case that bitter experience did not dissuade the club from such practices.

A club chairman in the 1990s, aptly named Bamchawi, once in a pivotal encounter released three birds (pigeons or other) into the air, two went as instructed and the side scored two goals but the third failed to fly and fell back into the club chairman's laps.

He died that day or the following day, in which case linking cause and effect would not be difficult, thus the club fully knows what this portends.

What was also surprising was the time lag that the two matches (the first leg and return leg) were being played, as the fixed hour difference between Dar es Salaam and say Johannesburg is only one hour, but the starting period was six hours, namely 10 pm in the first leg and 4 pm in the return leg.

A discussion with a game pundit appeared to suggest that observers at the local level are at home with this sort of chaos whereas in the UEFA Champions League or Confederation Cup kick-off moments are part of wider regulated management of time, including sequencing of match shows, which admittedly is weaker in Africa or even non-existent. Federations here decide the starting time to inflict maximum pain on visitors.

That is what happened in the first leg as by 10 pm or 11 pm the cold in South Africa is unbearable for players

from this side, and it was considered that 10 pm might be an equally appropriate reciprocal starting point for the return leg fixture.

Pundits saw this as brilliant, instead of berating the starting time chaos

Not many expected that such theatrics would change the character of the game exceedingly, though it stood to make an impact on the capacity of the visiting side to withstand both the resolute morale of the home side and its unavoidable comfort in the 4-0 earlier margin.

One could expect that the weather gambit rather than the coconut theatrics could make a difference, but factually valid stories have been heard of goalkeepers seeing two balls at the same time while there is just one, etc.

One hesitates to call this amusing or to look forward to it as it is abysmally beneath the dignity of the game, but Africa loves it.

Taifa Stars set for World Cup qualifiers' preps in June

Coach's masterstroke takes Esperance to CAF Champions League semis

A MASTERSTROKE by Esperance coach Moine Chaabani inspired the Tunisian club to win a CAF Champions League quarterfinal penalty shootout on Saturday and set up a showdown against Egyptian giants Al Ahly.

Four-time African champions Esperance were leading Algerian visitors Chabab Belouizdad 1-0 in a second leg but trailing 2-1 overall with eight minutes remaining when the coach gambled.

Chaabani believed his side would score again and force a shootout so he took off goalkeeper Moez Ben Cherifia and introduced Farouk Ben Mustapha, a shot-stopper with a reputation for saving penalties.

Esperance scored again on 87 minutes through Mohamed Ben Romdhane to triumph 2-0, level the tie on aggregate and Ben Mustapha saved three spot-kicks while Esperance converted three to win 3-2 on penalties.

Chaabani is hoping to become only the second coach after Portuguese Manuel Jose to win the Champions League three times after guiding Esperance to glory in 2018 and 2019.

After building a 2-0 first-leg lead last weekend, quarter-finals debutants Belouizdad contained Esperance until the 67th minute when Abdelraouf Benguit scored near Tunis.

Substitute Benguit later put Esperance 3-2 ahead in the shootout and Ben Mustapha then foiled Chemseddine Nessakh to complete a dramatic comeback triumph. The Tunisians will host defending champions Ahly in a repeat of the 2018 final on June

18 or 19 with the return match the following weekend.

Defender Yasser scored on 11 minutes as Ahly held Mamelodi Sundowns of South Africa 1-1 in Pretoria to advance 3-1 on aggregate.

- Massive blow -

The early headed goal off a corner for the visitors was a massive blow to Sundowns as they had to find the net at least four times to survive, but never looked like achieving that feat.

Another defender, Mosa Lebusa, levelled after 30 minutes, also with a header after a corner, but the home side hardly troubled goalkeeper Mohamed el Shenawy in the second half.

Ahly are coached by South African Pitso Mosimane, who last September became the first sub-Saharan African to coach the Cairo club since it was formed in

The other semi-final, between Wydad Casablanca of Morocco and Kaizer Chiefs of South Africa, will bring together teams who meet at the group stage with each winning at home.

Wydad host the first leg and if they eliminate Chiefs, will stage the single-match final at their 67,000-capacity Stade Mohammed V ground in Casablanca.

The Moroccans had to wait until the third minute of added time before Walid el Karti scored to earn a harder than expected 1-0 win over Mouloudia Alger of Algeria and a 2-1 overall victory.

A late Clatous Chama goal completed a 3-0 triumph for Simba of Tanzania over Chiefs in Dar es Salaam, but the South Africans progressed 4-3 on aggregate to a first semi-finals appearance.

Sci-fi' Lewandowski breaks Mueller's 49-year scoring record

BAYERN Munich striker Robert Lewandowski said it felt like being in a "science fiction film" after scoring his 41st Bundesliga goal of the season on Saturday to break Gerd Mueller's 49-year-old German league record for a single campaign.

Lewandowski hit the net in the 90th minute of Bayern's 5-2 home win over Augsburg having equalled Mueller's record of 40, which was set in 1971/72, last weekend.

Lewandowski broke Mueller's mark with a classic poacher's effort, rounding the Augsburg goalkeeper to fire home having snapped up the rebound after Leroy Sane's shot was parried just before the whistle.

"You wait for 90 minutes and then it comes in the last few seconds," Lewandowski told Sky after the final round of games. "It was like being in a science fiction film. I've lost my voice. I saw Leroy shoot for goal, I had to keep believing and luckily it came off."

Lewandowski claimed the record having had his six previous shots all saved as Bayern lifted the Bundesliga trophy after the final whistle for the ninth straight sea-

They finished the season 13 points clear in the table.

"I was a little bit disappointed to have not scored sooner, but sometimes such records have to be fought for," added Lewandowski. "I was patient and believed until the end. I thank my team, who share the record with me. This is something very special, a historic moment in my career."

- 'Benchmark for future' -

It was the last game for Bayern head coach Hansi Flick, who will be replaced by Leipzig boss Julian Nagelsmann next season having won seven titles over the last 18 months.

"I will miss the team," said Flick, who is tipped to replace Joachim Loew as coach of Germany after the Euro 2020 finals. "For me it was an honour to have been part of this club. I am totally happy and proud of what we have achieved. It's the absolute benchmark for the future," added Flick, who won seven Sunday.

Suarez, Atletico vindicated by 'different' La Liga title

IN the end, of course, it had to be Luis Suarez.

"His name, Suarez, that alone is enough ... that tells you everything," argued the coach of Spain's new champions, redeyed Diego Simeone speaking about the man who won him the crucial match, the man who won him the title, the man who Barcelona needlessly, egotistically, bullied out of their club last summer.

When Simeone was grinning from ear to ear -- partially disguising the fact that he'd been in tears -- after his Atletico Madrid had won 2-1 at Real Valladolid to relegate the project President Ronaldo Luiz Nazario started nearly three full seasons ago, he was talking about Atleti's 34-year-old, 21-goal striker, and Suarez himself was in pieces.

We often, totally understandably, portray Suarez as a tough guy. That's because he is. Born on a tough street, in a tough city in a tough country, Suarez has always been something of a hero in Uruguay despite his frequent portrayal as a street fighter following his notable and regrettable lapses of judgement. But he's not that: in football terms, he's an absolute thoroughbred.

If you've met him, if you've spoken to anyone who knows Suarez -- even if you've just watched him closely for Ajax, Liverpool, his national team, Barcelona and now Atleti during a glorious career -you'll understand that he's a man who suffers fools not for a second, whose judgements, and whose tongue, can lacerate. He's a tough guy's tough guy. Not dedicated to the rules, previously prone to those lapses in judgement -whether in taunting or biting a rival -- and someone who absolutely believes that history always has and always will be written by the winners.

Yet there was "El Pistolero," not basking in the triumph of having scored late winning goals in Atleti's last two Liga matches to turn losing situations into the six points that made them champions for only the third time in 44 years. He wasn't leaping about, spraying champagne, finding cameras to waggle his fingers at in admonishment of the former Barcelona president Josep Maria Bartomeu, whose ugly ego meant that Suarez had to be booted out the door of the club he loved playing for. No, there was none of that.

Suarez, now an Atleti legend, was sat on the Nuevo Zorrilla turf not only crying but with his body wracked by sobs.

He'd spoken briefly to La Liga's broadcast, live, and managed to force out a few phrases about vindication, about how this had been the toughest year of his life for those who love him: his wife, his kids, the rest of his family. But he was forcing those half-formed sentences out via that peculiar means of communication when someone overcome by the emotional impact of events keeps thinking that this is the sentence they can enunciate clearly without their chest heaving and the tears overtaking the words on the way out ... but failing

When Atleti's leading goal scorer, their saviour, tried to make sense of his feelings, when he politely tried to answer the questions, we all saw him in a state we've not witnessed in public before. But that was just the beginning.

While Simeone took over the mic, and uttered some of the most beguiling, admirable and characterful sentences I've ever heard from him, Suarez was on the phone to someone he loves -- his wife Sofia Balbi, I'll wager. By now the tears were streaming down his cheeks, he was kind of shaking his head in disbelief at how consumed by emotion he was and the process of breathing, speaking and containing those huge sobs was making his chest heave in and out.

If we stop for a moment, it's clear that this wasn't simply about triumph. Suarez has won so much, been a central participant in magnificent victories, and ever since finding peace by moving from Anfield to Camp Nou he's redeemed himself without the merest hint that he might fall back into that uncontrollable rage that once saw him bite opponents and racially abuse Patrice Evra. So the fact that he was engulfed by the enormity of becoming Spain's champion, again, and leading Atleti to much lusted-after glory was not solely about winning.

Nor was it solely about the fact that he was hurt by the rejection of Barcelona far more than he's ever let on in public -- possibly hurt more than he'd even acknowledged to himself before. When you prove your enemies wrong there's satisfaction, but there's also a moment when the self doubts, the immense fear that those who put you down might be right this time, which have been gnawing at your subconscious, are vanguished once and for all.

However the third layer to what was going on was, I believe, the most important reason for seeing the hero of the hour seated on the grass involuntarily rendered helpless by a tsunami of emotion that, I'm willing to wager, he'd have normally felt like mocking in someone else. That most important reason was what Simeone went to immediately when asked what he felt about having become Spain's champion again, his third time at Atleti, having won the cup and league double as a wonderful midfielder in 1995-96 then as coach in 2013-14.

Having admitted that the referee's whistle, which ended the tal.

tortuous tension for Atleti's man in black, brought a smile surging up from inside him and the urge to laugh, Simeone then cut to the

"This has been a time when so many Atleti fans have died, when we've lost people all over the world to the strangest and most difficult of situations," he said. "We've all suffered and to be able to bring people this happiness, to give them something after all they've been through ... this is different. This is the best."

And he's right. Atleti have achieved something they've not managed since the mid-1960s. In every single league title win since 1966, Real Madrid haven't really been a force. Since then, when Los Rojiblancos have been champions of La Liga, Los Blancos have variously been fourth, sixth, ninth and even in 2014 Madrid were five points adrift on the final day. This has been the first time since the year England won the World Cup that Atletico have seen off their neighbours, their often loathed superiors, the team and the club that has dominated world football since the European Cup was born.

The fact that Atleti comprehensively lost the first Madrid derbi of the season and then tossed away a 1-0 lead in the second -having played exceptionally well, far better than Zinedine Zidane's side until Karim Benzema's equaliser two minutes from time -- had preyed on the consciousnesses of Simeone, the board, the experienced players and the fans. Zidane's team, against a hurricane of injuries and COVID absences, kept finding a way to cling on to Atleti, to make sure that if Simeone's mob tripped up just one more time, they'd be there.

There's no doubt that the biggest psychological scars Simone bears are the two lost Champions League finals when Madrid, each time in the most dramatic circumstances, denied Atletico the European crown. So for him to win this time, especially with reigning champions Madrid looking like remorseless, "seen this before, done this before" pursuers, well, this will be special and perhaps curative for Simeone. I think this will have vanquished some ghosts.

Yet he took time to think of the impact this will have on others. Those who've suffered because of the pandemic, those who've suffered because they're Atleti fans and Madrid get the chance, over and again, to lord it in Spain's capi-

(In a side note, I absolutely love the fact that Madrid, minutes after the final whistle of their hardfought 2-1 comeback win over Villarreal that would have retained the title if Valladolid had somehow conjured up a late goal, used Twitter to warmly congratulate Atleti and their fans for winning the 2020-21 Spanish title. Sheer class. Lovely touch of grace.)

Elsewhere, Barcelona stumbled to a 1-0 Lionel Messi-less win over Eibar, the miracle club with a town population you could fit into a large phone booth, who now, finally, succumb to reality and drop a division.

and Real Betis Vigo played master vs. pupil and the master won. When they were together at River Plate, Betis boss Manuel Pellegrini was coach and now-Celta coach Eduardo Caudet was his hard-working right midfielder. Caudet, since coming to Spain in November and revolutionising Celta, has made it crystal clear that Pellegrini was his inspiration, his teacher and remains someone the 46-year-old is trying to emulate.

Not this time, however, as Betis fought back from 2-0 down win 3-2 and ensure Europa League qualification. The dream scenario is that they and Real Sociedad, 1-0 winners over Osasuna, do Spain proud in that UEFA competition next season and that Villarreal, who really mustn't use Geronimo Rulli in goal against Manchester United in Wednesday's Europa League final, win that date and qualify for the Champions League. That's for another day.

Eventually President Ronaldo at Valladolid; Pacheta, the energising and talented coach at Huesca; and the mighty Jose Luis Mendilibar, who's done incredible things at Eibar were all left contemplating life in the second division, licking their wounds and thinking of what might have been. Not Atleti, though. They offered succour to Suarez when the sucker at Barcelona thought he could break the Messi-Suarez power couple, and they've reaped a golden reward.

The Uruguayan front man came, saw, conquered, and gave himself a feeling of vindication that overwhelmed him and gave us a beautiful eternal image to remind us that, ultimately, football isn't about sackings, statistics, stupidity, saves or daily newspaper sensation. It is a provider of the the most uplifting, outrageous, unpredictable human drama that television, opera, theatre and cinema can only gaze at in naked envy.
