# Samia upbeat on 50-50 goal in cross-party rally

RESIDENT Samia Suluhu Hassan has expressed optimism to attain the 50:50 agenda in leadership and decision-making posts, calling upon women to massively participate in the forthcoming general election.

She made the remarks yesterday at a forum organized by the ruling party women's wing (UWT) and the Tanzania Women Cross Party (TWCP) platform, where she said the country has recorded considerable progress in the area.

Efforts are being pursued to increase the number of women legislators to 40 percent, she told women from various political parties including ACT-Wazalendo and Chadema.

President Samia was constitutionally elevated to president on March 19th, 2021 following the death of fifth phase President Dr John Pombe Magufuli.

She actually expressed the hope of achieving the 50/50 leadership parity goal and in decision-making positions, urging that more women come forward to run for elective posts in the coming polls.

The 50:50 agenda will be achieved progressively; she said, noting that progress in the judiciary is appreciable, with the number of women judges much higher compared to previous years.

Out of 86 High Court judges, 40 are women and of the 26 regional administrative officers, 12 are women, she said, elaborating that efforts are ongoing



to further empower women and girls.

Plans are being worked upon to construct girls' science schools in every region and branches of the Vocational Education and Training Authority (VETA) in each district to equip young Tanzanians with the ability for innovation in science and technology.

On the health sector, the president said that the government is purchasing equipment to ensure specialized treatment is offered locally. A vast number of dispensaries, health centres and hospitals are going up across the country, she stated.

An online maternity support network named 'M-Mama' program has elicited interest around the world, she said, describing it as a practical, sustainable and scalable solution to reduce maternal and new-born deaths countrywide.

She said the government is determined to improve the agriculture sector and

# Ministry wants tourists to first visit Arusha Declaration house

INCOMING tourists visiting northern circuit national parks and heritage sites will also be taken to the National Museum of Nature Studies and the Arusha Declaration Memorial.

Mary Masanja, the Natural Resources and Tourism deputy minister, made this assertion here at the weekend when meeting members of the parliamentary standing committee on the docket, saying that the plan is meant to take up advertising the country's attractions along with some understanding of the wider cultural heritage.

Explaining the plan, she said seeing nature and wildlife resources bestowed to Tanzania

needs to be coupled with a mandatory plan for travel firms to take tourists to view the beauty of our wildlife reserves capped by "getting a true picture of the country's rich natural resources and the history thereof."

"In the circumstances, we are preparing to have in place a procedure for them to first visit our natural museums to make the visitor grasp Tanzania's history including its wildlife, how the country attained its independence and who were involved in the independence struggle," she stated.

She described the city of Arusha as the hub of the country's tourism industry "but you find an incoming tourist going directly to view our wildlife reserves. We think this is not proper," she emphasised.

The government set aside more than 2.2bn/- from the Covid-19 recovery loan funds for improvements on national heritage sites, she said, explaining that since the national heritages were being improved, they can advertise the country's tourism well enough.

Dr Oswald Masebo, the National Museum board chairman, put a request to the committee to increase budget funds for the National Museum to improve infrastructure facilities and conduct major upgrading.

Dr Gwakisa Kamatula, the Arusha Declaration Memorial curator, said the museum has been allocated 112.7m/- for upgrading the Arusha Declaration Memorial Hall. The project is 100 per cent complete, he added.

# 'RCs book contractors who are delaying projects'

**REGIONAL Commissioners** ought to take legal measures against contractors who fail to complete projects as per the time agreed, the ruling party's secretariat has declared. Mohamed Said Mohamed, the deputy secretary general (Zanzibar), said here at an event to mark the two years in office for President Samia Suluhu Hassan, that delayed projects instill resentment by the people for the government and the ruling party. The secretariat official was addressing hundreds of people gathered for an event to mark two years of President Samia in office, calling on RCs to supervise project implementation to reflect the value of the money disbursed. Regional officials must frequently visit ongoing projects in their areas to satisfy themselves whether implementation was in accordance with the signed contractual engagements, he emphasised.

"We will not tolerate any person who will obstruct development projects," the official intoned, urging RCs

# KADCO adding 100 parking lots

THE Kilimanjaro Airports Development Company (KADCO) is seeking to increase parking spaces at the airport from 85 to 187 lots. Christine Mwakatobe.

Christine Mwakatobe, KADCO managing director said here over the weekend that bulldozers are already on site working on a 2.7bn/expansion project. The move arises from the need to tame vehicle congestion, thanks to an upsurge in tourist traffic, pushing KADCO to initiate plans to counter parking space shortage.

entryway for about 80 percent of 1.5m tourists visiting the country annually, generating \$2.6bn in earnings.

It is the gateway for horticultural crop volumes meant for external markets, apart from exporting minerals, etc.

Parking space strains have lately been visible as at times KIA receives 300 tourist vehicles at one go, she said, noting that drivers spend a considerable amount of time in parking lots just to find a slot.

The scope of work involves the installation of cutting-edge floodlights, construction of a drainage system, resurfacing, plus revamping, widening of the parking area, a brochure indicates.

Expanding the parking lot has an environmental aspect for cars to maneuver, thus creating a safer environment for clients and staff, she said.

Expanding the parking area would augment benefits, creating more than 100 temporary jobs for residents around the airport as the work proceeds, she said.

Sirili Akko, the Tanzania Association of Tour Operators (TATO) chief executive officer, lauded the KADCO management for moving to expand the airport's parking lot.

This would offer holidaymakers a hassle-free trip right from arrival lounge, he said, noting that the number of tourists has continued to rise day by day,

This follows relaxing travel restrictions globally as the Covid-19 pandemic waned following global vaccination campaigns, and the impact of 'The Royal Tour' documentary, he said.

International airlines landing at KIA were 11 in 2020 and 13 at present, with cargo traffic rising by leaps and bounds/ KIA posted a 26 percent increase in cargo volumes from 2019 to 2021, making a wider parking lot a requirement.

The Bank of Tanzania's latest economic update shows that in the year ending January 2023, travel receipts rose significantly to \$2.6bn as tourist arrivals attained the 1.5m mark last year from 0.9m the preceding year.

Tanzania is closer to full recovery as the pre-pandemic number of tourist arrivals stood at 1,527,230 in 2019.

Produced by Peter Greenberg, the maiden film featuring President Samia as his key guide, showcased Tanzania's wildlife heritage and an array of investment spheres, launched in New York in April last year.

Chroniclers say the documentary presents a 360-degree view of Tanzania as a breathtaking safari destination, as well as the personal attitude of the country's leader as reassuring for potential investors and holiday makers around the world.

## Z'bar reclaims land plot

RAHMA Kassim Ali, Zanzibar minister for Lands and Human Settlements Development has directed officials of the Zanzibar Commission of Lands in collaboration with Unguja West "B" District to reclaim the one-acre land plot at Fuoni.

The land plot is owned one by Faki Rashed Faki but it has been apportioned and sold for building residential houses instead of farming activities as directed by the Zanzibar government.

Rahma issued the directives during her visit at the area soon after learning about the sale of the apportioned government land plot.

"Restoration of this land plot to the government is a lesson to all those who were given land plots for farming purposes and instead apportioned them for sale," said the minister.

She added that the lands ministry will make sure to follow up all such government plots and stern measures will be taken against whoever will be found going against their correct use.

However, she called on the people who want to purchase land plots to go to the Zanzibar Commission of Lands because the institution was legally created to administer all issues regarding land ownership.

She stressed that any person given land and wants to change its use should follow laid down procedures

For his part, Unguja North "B" District Commissioner, Hamidi Seif Saidi pledged to implement the directives in deeds, saying the district will not hesitate to take action against any person who will go against government directives in regard to the use of the land plots.

For his part, Faki Rashed Faki who claimed that he inherited the land plot from his parents and apportioned it for sale to two people said he did not know that government land is not for sale and that it is an offence to do so.

#### Background:



#### iii.Malindi Fish Landing Site and Market Facility

JICA and Government of Tanzania completed the project for construction of the Malindi Fish Landing Site and Marketing Facilities in Zanzibar's Urban West District, which was launched by the President and Chairman of the Zanzibar Revolutionary Council, Dr. Hussein Ali MWINYI, on January 10, 2023.

The about USD12.7million (JPY1.353billion) facility became the Zanzibar's largest fishing port aimed at boosting the blue economy in the Isles and improve people's health and incomes.

#### iv. Next INnovation with JApan (NINJA)

NINJA is a start-up support initiative designed to support entrepreneurs and start-ups in developing countries which are creating innovative business models and technologies to solve social issues. NINJA's support includes entrepreneurship development activities, business matching, promotion of venture/impact investment, and policy recommendations to strengthen the ecosystem.

JICA Tanzania launched the first NINJA competition in 2020, and the second NINJA in January 2022 (NINJA2) to continuously support further start-ups in Tanzania, who are trying to overcome Tanzanian social challenges.

#### v. Ladies First

JICA in collaboration with the National Sports Council of Tanzania [NSCT] and Athletics Tanzania [AT] have been organizing a ladies-focused athletics event called "Ladies First" at Benjamin Mkapa National Stadium since 2017 with the main objectives of women's empowerment and gender equality.



(a) Government priorities, Needs of the Tanzanian People and JICA:

During the era of Mwalimu Julius Nyerere, the first President of Tanzania, the newly independent Tanzania initiated policies which aimed at fighting what the administration termed as "the three enemies" of the nation namely: ignorance, disease and poverty and requested Development partners, including JICA, to extend support to the country to help fight those "enemies". Therefore, JICA be-

gan cooperation mainly in the area of human resource development, which is the foundation for nation building, starting with the acceptance of trainees and dispatching Japanese experts to various parts of Tanzania.

#### (b) JICA's Activities during this peri-

Based on the request of the new nation to support the nation building, JICA implemented various activities aiming at poverty alleviation such as agriculture development commencing with Kilimanjaro Region. In this regard, JICA dispatched experts in the field of agriculture and supported the establishment of the Kilimanjaro Agricultural Development Centre (KADC).

Moreover, faced with a severe shortage of qualified manpower, the country partnered with Japan to redress the situation. JICA accepted Tanzanians for training in Japan and in third countries and also dispatched the Japan Overseas Cooperation Volunteers (JOCV)to Tanzania, to build

In the 1970's, JICA supported the efforts of the Government in enhanc-

ing the livelihoods of Tanzanians thorough establishment of the Kilimanjaro Agricultural Development Centre (now Kilimanjaro Agricultural Train-

ing Centre - KATC), where thousands of farmers from across the country were trained in rice cultivation techniques. Moreover, JICA partnered with the Government in establishing the Lower Moshi and Ndungu Irrigation schemes in Kilimanjaro Region during the same period. These schemes enhanced extensively the livelihoods of the people in the concerned areas. In addition, the 1980's saw JICA supporting the improvement and rehabilitation of Dar es salaam city centre roads. The rehabilitation resulted into the promotion of economic activities by facilitating easy and safe movement of people and goods. The iconic bridge, (Selander Bridge) in Dar es Salaam was constructed during this time. It was constructed with JICA support in 1980, thereby alleviating the chronic traffic congestion which was being observed in the area during that time. It was in the same year (1980) that JICA opened its full scale office in the country to implement its activities in the country and to make such activities more effective.

#### 3. THE PERIOD OF PRESIDENT ALI HASSAN MWINYI (1985 – 1995):



Government priorities, Needs of the Tanzanian People and JICA:

This period saw the ushering in of the Trade Liberalization policy, whereby private investment was highly encouraged by the Government. In addition, the government continued to promote agriculture and industrial development policies. JICA continued to expand areas of cooperation, with particular emphasis on agricultural and industrial development.

Such reforms included: Public Sector Reform Program, Local Government Reforms and so forth. In addition, the Government came out to launch a special strategy to develop agriculture, considering that about 80 % of the population depend on for their livelihoods. During this period, JICA further strengthened its activities in the country. In the year 2004, the



#### (b) JICA's Activities during this period:

Regarding to the donor coordination, especially in the agricultural sector, JICA in collaboration with 7 other Development Partners (Ireland, Denmark, European Union, DFID, FAO, World Bank, WFP) teamed up with the Government to formulate the Agricultural Sector Development Strategy (ASDS) in 2002. Japan through JICA provided the Secretariat of the ASDS. To implement the ASDS, the Agricultural Sector Development Program (ASDP) was thereafter formed and JICA played

Agreement on Technical Coopera- a key role in its formulation. In addition, during this period the JICA - supported Kilimanjaro Agricultural Training Centre (KATC) was further strengthened by providing more training opportunities for farmers from across the country. Moreover, to support the Local Government reforms programs, JICA, during this period initiated the Strengthening Participatory Planning and Community Development Cycle for Good Local Governance Project (O&OD Project). Through this project many high ranking Central and Local Government Officials were accepted for training in both Japan and locally and is now commonly referred to as the "OSAKA"

#### 6. THE PERIOD OF PRESIDENT JOHN POMBE MAGUFULI (2015 – 2021):



(a) Government priorities, Needs of the Tanzanian People and JICA:

During this period, the Second Five - Year Development Plan (2016/17 - 2020/21) was launched. It laid emphasis on the development of infrastructure development, manufacturing, mining, enhancement in the provision of social services such as health, education, water and so forth. JICA implemented a number of projects including the improvement of the road situation

in Dar es salaam. Moreover, JICA increased the efforts to enhance the partnership with private sectors for co-creation, beyond conventional ODA.

#### (b) JICA's Activities during this pe-

JICA supported the construction of the first flyover in Tanzania, the "Mfugale Flyover" in Dar es Salaam.

JICA aims at supporting Tanzania's economic development by di-

rectly encouraging the partnership between the Japanese and Tanzanian private sectors in promotion, investment, and transfer of technology to the country, through such projects as "Fostering Car Mechanic and Car Maintenance Factory Network through Car Maintenance in Professional Practice Project", "Market-Oriented Agriculture enabler of Sweet Potato Varieties, Production and Storage Technology Disseminating Project", and "Off-Grid Solar Power Project", etc..

#### **Economic growth is most powerful** instrument for reducing poverty

A partnership is an arrangement where parties, known as business partners, agree to cooperate to advance their mutual interests. The partners in a partnership may be individuals, businesses, interestbased organisations, schools, governments or combinations. Organisations may partner to increase the likelihood of each achieving their mission and to amplify their reach. A partnership may result in issuing and holding equity or may be only governed by a contract.

Partnerships have a long history; they were already in use in Medieval times in Europe and in the Middle East. According to a 2006 article, the first partnership was implemented in 1383 by Francesco di Marco Datini, a merchant of Prato and Florence. The Covoni company (1336-40) and the Del Buono-Bencivenni company (1336-40) have also been referred to as early partnerships, but they were not formal partnerships.

In Europe, the partnerships contributed to the Commercial Revolution which started in the 13th cen-

In the 15th century the cities of the Hanseatic League, would mutually strengthen each other; a ship from Hamburg to Danzig would not only carry its own cargo but was also commissioned to transport freight for other members of the

league. This practice not only saved time and money, but also constituted a first step toward partnership. This capacity to join forces in reciprocal services became a distinctive national trade promotion organifeature, and a long lasting success factor, of the Hanseatic team spirit.

Tanzania has been shortlisted in the 2020 installment of the prestigious 'World Trade Promotion Organisation Award.'

Official statement from the International Trade Centre (ITC) revealed here that 18 national trade promotion organisations have been shortlisted for the 2020 World Trade Promotion Organisation (WTPO) Awards with Tanzania listed among the seven countries that stood up in the 'Best Use of Partnership,' category.

The shortlisted organisations are competing in three categories, including the 'Best use of a partnership,' in which Colombia, Egypt, Sweden, the Netherlands, Viet Nam, Zimbabwe and the United Republic of Tanzania have been slotted.

There is also the 'Best use of information technology,' where Brazil, China, Georgia, Malaysia, Portugal and the United Arab Emirates topped the bill, while for the 'Best initiative for inclusive and sustainable trade,' it was Austria, Costa Rica, Lithuania, Saint Lucia and Spain that got listed up.

The winners will be announced at the 13th WTPO Conference in to be held in Accra, Ghana, on the 14th of October, this year.

The WTPO Awards 2020 received 60 applications, the highest number since the awards were created in 2004. A jury of peers selected the shortlist. The jury is comprised of the 2018 award winners, and is chaired by ITC Executive Director Dorothy Tembo.

#### Firms should take internal audits extremely seriously and perform with utmost sincerity

THE internal auditing is an independent, objective assurance and consulting activity designed to add value to and improve an organisation's operations.

It helps an organisation accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control and governance processes. Internal auditing achieves this by providing insight and recommendations based on analyses and assessments of data and business processes.

With commitment to integrity and accountability, internal auditing provides value to governing bodies and senior management as an objective source of independent advice. Professionals called internal auditors are employed by organizations to perform the in-

ternal auditing activity. The scope of internal auditing within an organization is broad and may involve topics such as an organisation's governance, risk management and management controls over: efficiency/effectiveness of operations (including safeguarding of assets), the reliability of financial and management reporting, and compliance with laws and regulations.

Internal auditing may also involve conducting proactive fraud audits to identify potentially fraudulent acts; participating in fraud investigations under the direction of fraud investigation professionals, and conducting post investigation fraud audits to identify control breakdowns and establish financial loss.

Internal auditors are not responsible for the execution of company activities; they advise

management and the board of directors (or similar oversight body) regarding how to better execute their responsibilities. As a result of their broad scope of involvement, internal auditors may have a variety of higher educational and professional backgrounds.

The Institute of Internal Auditors (IIA) is the recognised international standard setting body for the internal audit profession and awards the Certified Internal Auditor designation internationally through rigorous written examination.

The Internal Auditing profession evolved steadily with the progress of management science after World War II. It is conceptually similar in many ways to financial auditing by public accounting firms, quality assurance and banking compliance activities.

While internal auditors are not independent of the companies that employ them, independence and objectivity are a cornerstone of the IIA professional standards; and are discussed at length in the standards and the supporting practice guides and practice advisories. Professional internal auditors are mandated by the IIA standards to be independent of the business activities they audit.

Auditors in the Tanzania have been advised to discharge their duties in line with global practices because of the critical roles they play in detecting and deterring fraud in organisations.

Vice President Institute of Internal Auditors Tanzania (IIA), Juma Kimori made the call over the weekend when speaking at the audit awareness seminar, organised for journalists from different media outlets.

# We must act more decisively to combat racism, discrimination and intolerance

I have recently visited Goree Island in Senegal, the infamous "door of no return" from which countless Africans were sent in chains to the Americas during the transatlantic slave trade.

As I moved around the island where thousands of human beings were traded as commodities, I was particularly appreciative that the United Nations General Assembly had made 2011 the International Year for People of African Descent. At the center of this initiative is the promotion of the economic, social, cultural, civil and political rights of people of African descendants, as well as their participation and integration in all aspects of society.

An early opportunity to reinvigorate advocacy is the annual commemoration of the International Day for the Elimination of Racial Discrimination which falls on

This date was chosen because it marks the massacre that occurred in1960 when 69 demonstrators were shot and killed during a nonviolent protest against apartheid in Sharpeville, South Africa. The International Day for the Elimination of Racial Discrimination is an annual reminder that we must act more decisively to combat racism, discrimination and intolerance. The increasing number of incidences in various parts of the world proves that enhanced commitments to full and effective implementation of international human rights law to counter these scourges are urgently

atlantic slave trade, one of the greatest stains on human conscience. The statistics bear out the enormity of this crime against humanity. Although estimates vary due to a lack of accurate documentation, it is thought that around 14 million Africans were transported to the Americas as slaves, and an addition-

progeny of the victims of the trans-

al 14 million were sent to the East. In the Americas alone, the number of Afro-descendants exceeds 200 million and many of them live in dire circumstances.

They are often among those who are affected the most by poverty, unemployment and precarious living conditions. This is not a mere accident of fate. We must recognize that at the root of this deplorable reality is structural discrimination that had its origins in places like Goree Island.

Indeed, the legacy of the slave trade persists in many of today's practices. We see reflections of discrimination against African descendants in racial profiling, overrepresentation in prison populations and poor access to quality education, justice and health services. All these obstacles, created by prejudice, intolerance and inequality, deny millions of people their universal human rights.

As recently as April 2009, at the Durban review conference against racism, racial discrimination, xenophobia, and related intolerance 182 States agreed that a renewed commitment was imperative to counter these scourges. It is high time to heed these pledges.

While UN commemorations offer opportunities to discuss and tackle the many challenges that people of African descent continue to face due to racism and racial discrimination, they also provide high profile platforms to showcase and celebrate their myriad contributions in all areas of human endeavour. In the arts and sciences, the law and politics, people of African descent have etched their mark in history, shaped nations and advanced the highest ideals of freedom, progress, resilience, industry, and self-reli-

Yet, in too many cases, history books, school curricula, and oral traditions do not accurately reflect the wealth and span of African descendants' heritage, work and achievements. These wilful or negligent gaps must be filled with the narratives of pain, strife and success that uniquely belonged to people of African descent and that they continue to experience.

I hope that 2011 will generate profound discussions regarding the challenges facing people of African descent and provide a multiplicity of fora where innovative proposals and solutions to face up to these challenges can be found.

### Gambia: Hungry world getting worse!

THE world has perhaps never seen this level of simultaneous agricultural disruption, according to agriculture executives, industry analysts, farmers and economists interviewed by Reuters, meaning it may take years to return to global food security.

Russia's invasion of Ukraine, a major agricultural exporter, sent prices of wheat, soy and corn to near records earlier this year. Poor weather has also reduced grain harvests in China, India, South America and parts of Europe. Fertiliser shortages meanwhile are cutting yields of many crops around the globe.

Ukraine's grain output could take years to rebuild after fighting wrecked crop handling, storage and shipping infrastructure in a country that accounted for as much as 17 per cent 3.2 million acres earmarked for corn and in-

of global corn exports and 11 per cent of wheat stead file prevented planting insurance claims exports before the war. The war will create a global wheat shortage for at least three seasons, according to Ukraine's agriculture minister. Ahead of a crucial North American harvest, grain seeding delays from Manitoba to Indiana have sparked worries about lower production. A smaller corn crop in the top-producing United States will ripple through the supply chain and leave consumers paying even more for meat than they already are, as corn is a key

source of livestock feed The difficulty planting corn, the single largest grain crop in the world, in the northern United States adds to a string of troubled crop harvests worldwide that point to multiple years of tight supplies and high food costs.

U.S. farmers may also leave unplanted some

that can compensate them when weather prohibits planting, according to University of Illinois economists.

The problems extend north across the border in Canada, where heavy snowfall through April was followed by a May rain storm that washed out Gary Momotiuk's fields

In mid-June, Momotiuk still had 1,200 acres unplanted. He abandoned plans to sow profitable canola and wheat crops because they would not have time to mature, and hoped to seed barley to feed his cattle.

Manitoba, the third-biggest provincial grower of spring wheat and canola in Canada, left 880,000 acres unplanted, the most in eight years and representing 9 per cent of the province's insured farmland, according to its agriculture department.

## Bombo hospital expands hearing loss treatment to newborns as cases rise

EARING loss is a global public health burden with data from the World Health Organization (WHO) showing that 34 million children have deafness or hearing loss, of which 60 per cent of cases are due to preventable causes. At the other end of the lifespan, approximately 30 per

cent of people over 60 years of age have hearing loss.

Hearing loss in children can be present at birth (congenital) or develop later in childhood (acquired). Congenital hearing loss can be hereditary (genetic) or caused by infections during pregnancy, including infection with cytomegalovirus or ru-

Primary school children were screened for hearing loss by the Muhimbili National Hospital Mloganzila and an otoscopy was performed on those who failed the screening. A total of 403 children were screened from three schools in rural areas of Tanzania and prevalence of hearing loss was found to be 7.1 per cent, 10.8 per cent and 16.7 per cent in the three schools.

The problem can affect one or both ears and ranges from mild to profound. Even mild hearing loss can interfere with

a child's speech and language skills. The earlier children with hearing loss start getting services, the more likely they are to reach their full potential.

After recording significant number of patients in its Ear, Nose and Throat (ENT) clinic, Bombo Regional Referral Hospital in Tanga Region has announced it will start screening and treating hearing loss newborns from May this year.

Dr Mohamed Sachedin, ENT

specialist at Bombo revealed the plan here during a fun walk in preparation for the commemoration of the World Oral Health Day (WOHD) today. He said that the introduction of the service will make Bombo one of the few hospitals in country that provide such services to newborn babies.

Dr Sachedin said for the period of three months from January to March this year, doctors attended to 1,000 patients

in the hospital's ENT clinic and 50 per cent of those checked were found with hearing loss and other associated problems.

The expert said that according to various studies, hearing problems can start once a baby is born and if not treated at early stages, the same can extend to old and become complicated whereas screening and treatment at early stage can solve the problem.

"Hearing loss can be either temporary or permanent depending on the type and cause. Ear tubes surgery or medication can restore a child's hearing," he said.

"Children with permanent hearing loss are often able to hear some sounds with technologies such as hearing aids or cochlear implants. Early intervention services can play a critical role in helping young children develop language and communication skills."

To avoid hearing loss, he suggested that people should wear a hearing protector if the noise or sound level they are exposed to is close to or greater than the occupational exposure limits.

Abdiel Makange, Bombo Regional Referral Hospital Secretary said early intervention is important for effective treatment, adding that ENT specialists have a duty and responsibility to educate the public on how to take care of their health.

"Teeth for example are essential parts that make someone smile and look charming. Now imagine if the teeth are left to decay or are removed yet someone needs to smile," he said.

Makange said that the hospital is implementing a project of widening the scope of its referral services whereby it recently installed a CT scan machine which has since reduced referrals to other hospitals by 70 per cent. Another referral service which is currently available at Bombo is kidney dialysis which patients in Tanga Region sought in other regions in the country as well as Nairobi, Kenya. Another is diagnostic imaging procedures through X-ray through computer technology.

"On behalf of the management of the hospital, I would like to thank the government availing funds which improved and expanded services at Bombo Regional Referral Hospital tremendously," he said.

# Growing pains: EFF's 10 years of adding fuel to the fire

INCE the EFF was founded 10 years ago, Julius Malema and his Red Berets have made citizens sit up and take note - for all the right and wrong reasons.

The party shook politics on its first outing when it won 6.35 per cent of the vote in the general election of 2014. It contested its first local elections in 2016, getting 8.19 per cent.

In 2019, the Red Berets increased their support nationally, garnering 10.80 per cent of the votes and, in the 2021 local elections, they received 10.31 per cent.

In 2014, the EFF was able to get seats in Parliament, a feat for any new party, but it was in 2016 that it became a real gamechanger in politics. For the first time, the ANC failed to win more than 50 per cent in the majority of metros.

As kingmakers, the Red Berets decided to work with the DA, keeping the once high and mighty governing party out in the cold.

The ANC lost Johannesburg, Tshwane and Nelson Mandela Bay, retaining only Ekurhuleni, Buffalo City, Mangaung and eThekwini.

However, Herman Mashaba's resignation from the DA heralded the end of the arrangement with the EFF. The break-

down in the parties' relationship ended the DA's rule in Johannesburg, a big blow to the official opposition. After that, the DA vowed never to work with the EFF again.

Despite the relationship between the parties ending on a sour note, the EFF continued trying to keep the ANC out of power and voted with the DA in most municipalities.

However, the latest coalition talks between the EFF and the governing party have facilitated a change - an agreement that could dethrone the DA in the councils where it, together with other smaller parties, has been able to have the majority of seats.

This move has given the EFF the opportunity to have its members be mayoral committee members and speakers - and it has left the ANC at the mercy of the Red Berets. In the light of the earlier example of what happened with the DA and the recent collapse of an agreement between the EFF and the IFP in KwaZulu-Natal, it's clear that Malema is always ready to play hardball

Political analyst Levy Ndou says that, although the EFF has made strides over the years, there is room for improvement. He points in particular to the party's conduct in Parliament, which could be detrimental to its standing in society.

"The EFF has achieved a lot. The party has been able to grow its support base throughout the country and overtake the DA as the main opposition in some areas," he says.

"Their numbers in the National Assembly have increased and their membership numbers stand at 1 million. They have all reason to celebrate."

However, at the same time, the EFF

needs to evolve into a trusted alternative to the ANC, which Ndou believes will not be possible until it stops its antics in Parliament.

"The EFF needs to look at strategies on how to approach issues in Parliament.

"They are known for disruptions and that has the potential to be a weak point for the party," he says.

The EFF's arrival in Parliament had South Africans intrigued by its shenanigans. The first was the party's decision to swap formal wear for overalls, gumboots and aprons, symbolising the party's support for the working class.

The 2015 State of the Nation Address (Sona) by former president Jacob Zuma was the first for the Fighters.

They ended up heckling Zuma, chanting "Pay back the money", which led to their removal from Parliament.

Every year, it continues to disrupt Sona. Malema founded the radical left-wing organisation in 2013. He was still bruised from being cast out of the ANC just a year earlier. In 2011, he was suspended from the ANC and later expelled for bringing the party into disrepute and sowing division.

The first recorded meeting of the EFF was at Uncle Tom's Hall in Soweto in July 2013. Before that, Malema worked on the ground. The first opportunity he saw to

introduce the country to the EFF was with the work he did at Marikana in North West.

On 16 August 2012, the South African Police Service opened fire on a crowd of striking Lonmin mine workers at Marikana. The gunfire killed 34 mine workers and left 78 seriously injured. In addition, 250 mine workers were arrested

Former EFF MP Andile Mngxitama believes that Malema is a "political genius" to have launched the party in Marikana, establishing the organisation among those who were most affected by what had happened.

"He is a master of symbolism, and is able to gauge the political pulse of the nation and manipulate the situation.

"There he met [EFF MP] Mam' Sonti [Nokulunga Primrose Sonti], who was a leader in that community. The EFF was able to cement itself as being pro the family of the victims who died in the massacre," he said.

Mngxitama joined the EFF in its early days. He was drawn to the party because of three elements: the EFF's decision to ground itself in ideals different from those in the Freedom Charter; the party's strong stance on land redistribution without compensation; and making its members take the Sankara Oath, inspired by Thomas Sankara, the revolutionary former leader of Burkina Faso.

"It was a time of great excitement for an alternative to the ANC and this was a radical organisation we wanted to build," he said.

But soon things turned sour between Malema and Mngxitama, who went on to form his own political party called Black First Land First. This was almost a clone of the EFF, but the difference was that it had a dismal showing at the polls.

As the EFF turns 10 years old, Mngxitama says he is saddened by the direction the party has taken.

"The EFF was the highest hope for an alternative but because of the neocolonial leadership that is why it is inconsistent with its political programme. They are not grounded in Marxism but vulgar pragmatism," he said.

The EFF has managed to penetrate university politics over the years and has made many gains. This could be because of its fairly young leaders and how they have modelled education as fashionable.

Malema was initially ridiculed for his poor matric results and for not having studied after high school, but he went on to obtain his BA in political leadership and citizenship from the University of South Africa in 2016.

The EFF Students Command leads in many institutions of higher education, including the University of Limpopo, the University of Venda and all five campuses of the University of KwaZulu-Natal.

Though the SRC presidency at the University of Cape Town had been held by an EFF member since 2018, the position was taken by an independent, Hlengiwe Dube, in 2022

According to data from the market research firm Ipsos, the EFF is still most popular among young people, polling highest in the 18-24 age group with 37%, followed by the 25-34 age group and then the 35-49 age group. The party gets the least support from citizens over 50.

The data, collected in November last year, also show a decrease in support by people in the 35-49 age group, which stood at 32% in November 2017 but dropped to

22% in November 2022.

Malema himself has lamented the lack of an older support base as it affects the calibre of leadership that the party attracts. This is one of the elements that the party will look into correcting if it wants to compete with the likes of the ANC.

Unlike its counterparts, the EFF often attracts community members who have little to no real knowledge of politics. Many are young and have no background in community work or activism.

The Ipsos data show that the party's strongest support is among South Africans whose highest qualification is secondary school, which has been a sore point for the party. This seems to spill over into its structures.

In recent times, the Red Berets have had the opportunity to hold governing positions in councils. However, Malema has made it clear that the party will not allow councillors without matric to take up those roles. This stance has caused tensions in the party.

Government scrambles on alert

The National Joint Operational and Intelligence Structure (Natjoints), security cluster ministers and private security companies will be on high alert today, as they try to ensure that the EFF's planned national shutdown does not turn violent.

Since the EFF announced its intention of bringing the country to a complete standstill, there have been growing concerns about the nature of the protest as the government, business and civil society lament the possibility that it might turn violent.

The shutdown was called to put pressure on President Cyril Ramaphosa to resign and demand the end to rolling blackouts, as well as to bring the issues that affect young people to the fore.

The party's leader, Julius Malema, has insisted that cries from various sectors of society are not valid as the EFF is a "nice" political party that has not incited any violence throughout its planning of the shutdown.

Natjoints, which includes the police, the military and civilian government departments, said it would ensure that the protest did not disrupt normal life.

"Natjoints reaffirms and assures the nation that measures are in place to prevent and combat any acts of criminality, and that Monday is a normal working and business day," according to the liaison body.

Security companies Thorburn and Fidelity seem to be on high alert for any trouble that might occur.

In a report based on intelligence that Thorburn received on 13 March, risk areas include the Union Buildings, Eskom head office and the presidential residence in Pretoria.

The Durban and Richards Bay ports are also listed, along with major routes, airports, shops, schools, universities and businesses. **DM**

# WHI's Kisasa Hiltop housing scheme impresses MPs



# Govt to heighten local content on mining sector

HE government has launched a special digital system tailored to help attract more Tanzanians to take part in the mining sector and ensuring the involved mining companies across the country are rolling out diverse social services to the local communities through the set Social Corporate Responsibility (SCR) regulations.

Corporate Social Responsibility (CSR) is the idea that a company should play a positive role in the community and consider the environmental and social impact of business decisions.

Among others, the incepted vital system aims to help the country's mining sector to further improve and attain the much needed local content.

In his remarks during an event for the official launching of the helpMinister for Minerals, Dr. Steven Kiruswa expressed that the structure will enable mining companies and service providers in the mines to submit various documents on the presentation of plans for the participation of Tanzanians in the vital sector, and the provision of services to the community in the mines electronically instead of using hard copies as it was done before.

The second forum for the implementation of strategies to heighten participation of Tanzanians in the mining sector convened in Arusha Region for two consecutive days under the coordination of the Tanzania Mining Commission (TMC), bringing together mining companies, mining service providers and financial institutions.

"The system we're launching today will also simplify the process of processing applications submitted to the Mining Commission, whereby the

**Correspondent** ful scheme, the Deputy responses to applications will be provided on time by experts from the Commission," he informed.

Dr. Kiruswa observed that the move made by the government to amend the mining laws in Tanzania has so far resulted into a series of successive developments in the sector, including an increase in employment in the mines from 50 percent to at least 96 percent and domestic purchase to the tune of 92 percent.

"The development, among others stimulated major changes in the general executions of the sector including unlocking and heighten various opportunities in employment and training opportunities to locals, technology transfer, research and development, as well as use of services and products provided and produced by the Tanzanians in the sector," he expounded.

He informed that employment for Tanzanians in large mines has

increased from 6,668 in 2018 to 15.341 in 2022 with Tanzanians getting various training to build the capacity to work professionally in the sector, the works that were previously handled by foreigners.

"During 2022, a total of 8,066 Tanzanians were

given various training in the mining sector and capacity building in the work performance where a total of 3.4bn/- was spent," he added.

Air operators in the Uganda have said operational costs such as high fuel prices, poor state of regional airstrips and low domestic demand are key factors that limit growth on domestic air transport.

The operators, who were eight in total, made the call while seeking renewal of their Air Service Licenses by the Civil Aviation Authority (CAA) at a public hearing conducted by retired deputy Chief Justice and CAA chairman, Steven Kavuma.

Uganda has 26 licensed air operators operating scheduled, and non-scheduled flights for passengers, cargo, training and aerial works.

Ms Catherine Mugo, the AeroLink accountable manager, said fixing runways such as that of the Kisoro [District] Airstrip was necessary since it remained a challenge to their air hauling services offered to tourists.

Airline operators also argued that the cost of operations remain high, driven partly by high fuel prices, and high charges for international passengers transiting through Entebbe International Air-

Airlines pay \$2.4 (Shs8,999) per litre of gasoline compared to their Kenyan counterparts who pay

Air operators in Uganda also incur an additional international passenger levy of \$57 (Shs213,731) for each passenger.

Ms Sheila Kobusingye, the Asante Aviation accountable manager, noted that sourcing local financing for their operations remains a huge challenge. However, Mr Fred Bamwesigve, the CAA director general, said at least 13 airstrips are operational, but admitted that there is still low usage of the facilities.

"We use our own resources to maintain facilities because they can't [raise revenue] for sustaining them," he said.

Airlines have continued to recover from Covid-19 effects where they reported low sales, worsened by the recent Ebola attack.

Entebbe International Airport, the country's main gate-way, has registered tremendous growth in passengers numbers, rising from 118,000 in 1991 to 1.8 million in 2019, before the advent of Covid-19, which greatly impacted the aviation industry.

In 2022, the airport recorded 1.57 million passengers, an increase of 87 percent post Covid-19 recovery. Cargo traffic has grown steadily over the years with 61,000 metric tons recorded in 2022.

In September last year, the \$9.5m (Shs35b) modernisation and automation of Entebbe International Airport project was commissioned in conjunction with the Korea International Cooperation Agency.

Part of the major project for upgrade and expansion of the airport, which includes resurfacing of both runways and associated taxiways were completed.

CAA data shows the Aircraft Apron has been expanded to create more aircraft parking spaces and a state-of-the-art new cargo centre with capacity to handle 100,000 metric tons of cargo per year was completed.

Mr Kavuma said the re-modified passenger terminal building is expected to be opened to the public in 2023 so that departing passengers can be dropped-off by the entrance to the terminal building into a more spacious and ambient facility.

Similarly, arriving passengers will exit through a bigger facility.

On completion of the on-going projects, Mr Kavuma said the airport's terminal capacity will be enhanced from the current two million to at least 3.5 million passengers in 2024.

Other projects include construction of a new fully automated aviation fuel hydrant system with enhanced capacity to store 20 million liters of aviation fuel, up from the current 7.5 million litres.



Protests even spread to the occupied West Bank, where Israeli settlements have long been considered a political stronghold for Netanyahu's right-wing coalition partners. More than 50 mostly modern-Orthodox Jewish protesters chanted traditional Jewish songs holding blue and white flags at a central junction in the West Bank settlement of Efrat.

"What they are trying to do is monopolize, to have all the power in their hands," Shmuel Wygoda, a college professor told Reuters in Efrat. "Once you have all the power in the hands of one side, it is a change, which we know from history, from totalitarian regimes, that all the power is unfortunately used against the people."

Now Xi is about to set foot on Russian soil for the ninth time as Chinese president. Over the past decade, the two heads of state have met with each other on some 40 occasions. Their frequent and high-quality exchanges have always been guiding the development of China-Russia

The past years have witnessed the steady growth of China-Russia ties with the inking of a host of important documents such as a joint statement on win-win cooperation and deepening their comprehensive strategic partnership of coordination in 2013, the China-Russia Joint Statement on a New Stage of Comprehensive Strategic Partnership in 2014, a 2015 joint statement on deepening comprehensive strategic partnership of coordination and advocating win-win cooperation, and the China-Russia Joint Statement on Further Deepening the China-Russia Comprehensive Strategic Partnership in 2017.

In 2021, the two presidents commemorated the 20th anniversary of the Treaty of Good-Neighborliness and Friendly Cooperation Between China and Russia and made the decision to extend the pact.

As the world is facing profound changes unseen in a century and the unprecedented pandemic, Xi and Putin have maintained close contact through various means, including a meeting during the Beijing 2022 Winter Olympics, traditional year-end online talks, calls and messages, and participating via video link in the ground-breaking ceremony of a bilateral nuclear energy cooperation project and other major events held in their respective countries.

Under the joint leadership of the two heads of state, the bilateral partnership has grown more mature and resilient.

As an ancient Chinese saying goes, "True partnership defies geographical distance." China and Russia have blazed a trail in the growth of major-country relations featuring strategic trust and good neighborliness, setting a good example for a new type of international relations.

Meanwhile, China-Russia ties are based on non-alignment, non-confrontation and non-targeting of any third party. The relations pose no threat to any other country in the world, nor are they subject to interference or provocation by any third party.

# BFT weighs in on Dar boxers' performance in IBA World Championships

BOXING Federation of Tanzania (BFT) has attributed the poor performance shown by the country's boxers in the 2023 International Boxing Association (IBA) Women's World Boxing Championships in India to a lack of experience and exposure.

Tanzania was represented by Lightweight boxer, Beatrice Nyambega, and Light Flyweight boxer, Rehema

Beatrice, on Friday, lost to Indian Jasmine Jaismine, whereas Rehema lost to Kenyan Beatrice Ongare.

Speaking from India, Lukelo Wililo, BFT president, attributed the outcome to a lack of experience and exposure at international events.

"This was the first time that our female boxers were battling it out in the Women's World Boxing Championships, the two were lacking that experience as it was their first time to compete in a high-profile international championship," the official noted.

The official pointed out: "In the first bout, Beatrice was not in her mood, she lost focus mainly because she was fighting an experienced Indian boxer Jasmine who was being cheered by the home fans."

"Rehema did all she could but was overpowered by Beatrice who has vast experience in international events," he said.

Beatrice, the 2018 Commonwealth Games bronze medalist, also outclassed Rehema in this year's East Africa Boxing Championships that took place in Dar es Salaam in January.

However, Wililo drew some positives from the early elimination of the boxers in the IBA Women's World Boxing Championships.

"The championships have helped the two boxers gain experience and exposure, this is, to BFT, a good beginning, we have learned a lot and we will make use of them while preparing for the next month's Zone 3 Boxing Championships, Olympic Games and 2026 Commonwealth Games in Virginia, Australia," he said. The BFT president said the Tanzania delegation will

remain in India until the end of the championships. He said while in India, the delegation will attend Congress for Women in Boxing, a technical meeting for coaches and team cutmen, international technical officials, and a boxing clinic.

Minister for Culture, Arts, and Sports Pindi Chana presented the national flag to the two boxers, urging the pugilists to hoist the flag high in the champion-

She said the government is happy that, for the first time, the country is taking part in the IBA Women's World Boxing Championships.

"We are happy that for the first time, our country is taking part in the IBA Women's World Boxing Championships, we are committed to developing sports in the country and we will continue doing that," she said.

The national team was backed by National Sports Council (NSC) and IBA while the pugilists' local camp was sponsored by Africa Human Rights Network (AHRN) and Mbezi's Oasis Village and Club Gym.

The IBA Women's World Boxing Championships started in Scranton, USA in 2001 and this year witnessed Tanzania field boxers in the showpiece for the first time.

More than 350 female boxers from 74 countries are battling it out in the championships which involve 12 weight classes.

The opening ceremony took place at K.D. Jadhav Indoor Hall, with preliminaries and quarterfinals slated for March 16-23, semi-finals are set to take place on

For the first time, IBA confirmed a lucrative prize fund of US\$2.4m for the Women's World Boxing Championships.

Gold medal winners in each of the 12 weight categories, IBA disclosed, will get US\$ 100,000, ensuring a bumper reward for finishing top of the podium.

Boxers taking runners-up place in their categories will collect US\$ 50,000, while third-placed pugilists are set to walk away with US\$ 25,000 each.
