

US envoy hails Samia for dialogue, media uplift

THE United States ambassador to Tanzania, Dr Donald Wright (pictured), has hailed President Samia Suluhu Hassan for placing a premium on political dialogue and lifting restrictions on the media, among other changes.

He was speaking at the University of Dodoma at a US -sponsored day of reflection on 60 years of ties between the two countries, on "the future of Tanzania's development trajectory and relations with

Ambassador Wright said that democracy and media freedom are pillars of US-Tanzania relations, "because standing above everything else is respect for the rule of law, democratic governance and human rights.'

US -Tanzania relationship are based on enabling the youth to seize opportunities for the future, along with increasing trade and investment between the two countries.

Others key areas of interest include bolstering peace and security in the region, while strengthening democratic institutions so that all members of society can participate fully in the process of governance, he said.

"These are the pillars on which sustainable development rests. History shows that countries which uphold democratic values are more peaceful, stable and prosperous in the long term," he declared, arguing that

PRESIDENT Samia Suluhu Hassan has pledged to prolong the provision of fuel importation subsidies each month until global

Last month the government disbursed 100bn/- to cushion importation costs, enabling the Energy and Water Utilities Regulatory Authority (EWURA) to set out new retail prices

Treasury cautions, advises on investments

WHAT seemed as the easiest way to make quick money online has left many Tanzanians, including professionals, crying after it turned out to be a scam.

The 'invest and reap, recruit others and get rich' app which started receiving deposits in March this year now no longer allows operating deposits, so investors can't withdraw their money, sending shivers down the spines of folks who poured millions into the scheme.

Those who have been hit hard deposited for the first time and withdrew easily with profits, then trusted the app and poured more money into the scheme which later curtailed access to those investments even if they were able to see what they have accumulated via phone screens.

The scheme by the name 'Idea Debater' offered a link for a potential investor to join, by opening an account where investment is to be done, and a possible gain.

The app provides room for one to move from one level to another depending on the deposits made, the level also determining the returns an investor withdraws, scheme participants explained.

James Lyimo, a participant who has lost more than 100,000/-, said he was in level one which was offering five-percent profit on investment, the first time he invested, so he decided to put up a 'reasonable' amount to yield more.

Those behind the screen operating the scheme were linking their investors with their colleagues on WhatsApp groups,

'Give extension officers motorcycles in five days'

PRIME Minister Kassim Majaliwa yesterday gave a five-day ultimatum to senior officials of the Ministry of Agriculture to ensure that motorcycles meant for extension officers countrywide are distributed immediately.

The premier, visiting the ministry's premises in the capital, expressed concern that the motorbikes have since April parked at the yard adjacent to the Vocational Education and Training Authority (VETA) offices here.

The motorbikes should reach District Executive Directors within five days from that moment, he ordered, explicitly noting that they should receive them by Sunday evening. He said the situation was unacceptable as the motorcycles are working tools meant for extension officers, "but they have remained



parked at your yard for months."

He said President Samia Suluhu Hassan handed over the motorbikes to the ministry for distribution to extension officers, but no efforts followed to have the DEDs collect them. The president's plan was to transform the agricultural sector whose growth is still minimal, he stated.

Prof Siza Tumbo, the permanent secretary for Agriculture, promised to work on the directives, to rapidly lift the 6,700 motorcycles onward for distribution to extension officers across the country.

The president had also tasked the ministry to look for local sources of funds in setting up an agriculture fund, with the President's Office ready to make a goodwill scan for partners to make the project a success.

Agriculture grew by 4.9 percent in 2020/2021, contributing 65 per cent of raw materials used by local industries, the president had stated, worried all the same that the data notwithstanding, growth in the sector is still minimal.

"We believe that if we invest more we can make the sector a working backbone of the economy," she stated, alluding to an increase in budget funds for extension services to TURN TO PAGE 2

Those wishing to invest need to do so in legal platforms such as the Dar es Salaam Stock Exchange and the UTT asset management and investor services, he advised.

It is high time people understood that there is no easy way of earning money, as anything new which involves investing and making profits must be well investigated before one decides to invest, the official added.

TANZANIA needs to adopt and implement strategic measures including involvement of more men for the country to achieve its goal of attaining 50/50 gender parity in key leadership roles by 2025.

Dr Dorothy Gwajima, the Minister for Community Development, Gender, Women and Special groups said that yesterday in Dar es Salaam in a forum on Women in Leadership and Political life in Tanzania.

She said the aim of the forum was to address the unique challenges that deter more women from occupying leadership positions in various sectors.

It was part of Nordic week celebrations, to promote partnership between Tanzania and the Nordic embassies in Tanzania-Sweden, Denmark, Norway, and Finland, and hosted by the Embassy of Finland in the country in partnership with Uongozi institute.

She said despite the progress made, there is still an under-representation of women in leadership and decision making positions in atmospheres

percentage of elected women.

She said as a matter of fact, there was a need to involve men in all aspects to empower women economically and address the gender gap.

"As more focus is to empower women economically and access to information, it is therefore very important to involve men in all stages to change their mindset to achieve the goal," she said.

Dr Gwajima said President Samia Suluhu Hassan's decision to involve more women in the position, shows her government commitment in championing gender equality.

Currently, the percentage of elected women leaders is 11 percent in the Tanzania mainland parliament and 16 in the Zanzibar's House of Representatives and seven percent at local level.

She said apart from that, there was a need to implement strategic measures to achieve the goal of 50/50 gender

The Chief Secretary of the Zanzibar Revolutionary Government, engineer Zena Ahmed Saidi noted that men and women are not enemies therefore;

men must fully be involved in the ongoing process. She said the country's goal to achieve 50/50 in elected positions can be achieved within a shorter time once men are fully involved in the whole

transformation process. Uongozi Institute CEO, Kadari Singo highlighted some key challenges including differences in enrollments at all education levels between men and

women (early years).

Others were school dropouts are higher among women (From primary to ordinary and advanced level) than for men counterparts and field choices (science and arts) made by men and women in the lower level of education have an impact on their leadership path.

The Uongozi Institute study (2019)

reveals that there was representation of women at various levels - only 26 percent of women compared to 74 percent of men in leadership positions across the board

Most countries in the world have not achieved gender balance, and few have set or met ambitious targets for gender parity (50-50).

She said evidence shows that women's leadership in political positions improves many aspects of

She said trends of women in leadership globally (2021), was 22 percent where only 11 women were serving as heads of state and 13 were heads of government.

Only 17 percent of government ministers were women, most of whom were overseeing social sectors and only 21 percent of government ministers were women.

According to the study, 14 countries have achieved 50 percent or more women in cabinets.

Samia: Fuel subsidies will apply until prices stabilise

position yesterday at the Bwanga area in Chato District, Geita Region when heading to Kagera for a three day tour of the region, noting that most countries are experiencing surging oil prices following the outbreak of conflict in Ukraine.

"The situation has not been caused by the government," she emphasized, noting that the whole world is experiencing similar problems. "When big countries fight, the effects are felt by every nation," she stated, assuring the public that the government will continue to disburse funds to control import prices until global fuel prices stabilise.

Initial intervention saw the retail price of petrol in Dar es Salaam be reset lower by 306/- per litre, in Mtwara by 282/- and in Tanga by 152/- per litre.

Retail prices for diesel were decreased by 320/- for Dar es Salaam, 476/- for Tanga and 486/- for Mtwara entry points, thus petrol in Dar es Salaam has a 2,994/-per litre price cap from 3,301/- per litre, with and diesel capped at 3,131/- from 3,452/- per litre earlier.

For fuel unloaded at Tanga port, the new price cap will be 2,985/- from the previous 3,137/- cap for petrol, while diesel will be capped at 3,162/- from 3,639/- per litre earlier, he said.

Fuel docking at Mtwara port will be sold at a 2,979/- capped retail price per litre from 3,262/- earlier, while diesel will sell at 3,165/- from 3,652/- per litre.

The Chato district residents had earlier complained to the president on rising fuel prices, saying it was affecting their purchasing power, requesting effective measures on the matter, while the MP, Dr Medard Kalemani, applauded the president for providing funds for building a modern bus stand.

He outlined a number of development projects in the district, asking for assistance on the growing land demand in Bwanga are, with President Samia advising Bwanga vaccination for children under the age residents to practice modern cattle of five, he added.

rearing methods and reduce the number of livestock to have enough land for agricultural activities. Land scarcity in the area stems from population growth, she said.

When in Biharamulo District, the president cautioned the local authorities on the supervision of funds allocated for development activities, underlining that hefty funds for development projects are directed to districts to improve the delivery of public services.

Home Affairs minister Hamad Yussuf Masauni told the residents that the government is working to end perennial challenges in obtaining national identification cards, affirming that the relevant agency, NIDA has contracted a firm to manufacture the cards, which will then be handed to all eligible members of the public.

Water minister Jumaa Aweso said the government is working to end water woes in the district, with 38 out of the proposed 78 water projects being implemented, out of a total of 1176 water projects across the country.

Agriculture minister Hussen Bashe said at the meeting that the government has scrapped a number of levies to boost cotton production and facilitate availability of inputs, including seeds.

"We have reviewed prices," he declared, noting that a kilo of cotton will now fetch 1,560/- to 1,900/per kilo, urging cotton farmers in Biharamulo District to sell their crop in Chato District for better prices, with coffee prices also stabilizing. At a recent auction in Ngara District, a kilo was sold at 3,720/-," he specified.

The regional commissioner, Maj. Gen. Charles Mbuge informed the president that the region was well prepared for the August 23rd census exercise, while the residential address postcode installation was progressing well, expected to be completed within the set time frame.

In the education sector, the US is making critical investments to ensure Tanzania's youth receive a foundation of quality education from the earliest



FORMER Tanzanian President and University of Dar es Salaam Chancellor Dr Jakaya Kikwete yesterday showered praise on Father of the Nation Mwalimu Julius Kambarage Nyerere for his charismatic leadership, saying that his leadership philosophy and qualities were rare.

Speaking during the opening of the three day 13th Mwalimu J.K Nyerere Centennial Intellectual Festival held at the UDSM Library auditorium under the theme, "Africans after Mwalimu J.K Nyerere Century 1922-2022: Reflections on the present and the future," Dr Kikwete said that the late Nyerere's philosophy helped to shape the country in terms of democracy, politics and social aspects during the country's 60 years of independence.

"Describing the late Mwalimu Nyerere's life in 45seconds is an understatement. It has taken various professors including Professor Issa Shivji years to pen down his autobiography. All I can say is he was a great leader, father, patriotic, liberator, Africanist and internationalist," he

He added," It is rear to find all these unique qualities in one person. He is now dead but his spirit and philosophy has refused to die. We shall forever continue to cherish his vision and philosophical ideology,"

Nyerere who marked 23 years this year since his death was such a visionary leader who put national interests first rather than his personal interests.

"His desire to serve public interest was unmatched. He at one time quit his teaching job to pursue his political ambition of building his party. HEET project to start agriculture colleges in universities, MPs told

THE government through the Higher Education for Economic Transformation (HEET) project new campuses and universities in the plans to construct agriculture country. colleges in some major universities in the country so as to start providing agricultural courses, the House heard yesterday.

The move will help produce enough experts to serve in the sector which include providing close support to farmers to boost yields and income.

Kipanga said the government through HEET which is implemented by the University of Dar es Salaam under the Ministry of Education, Science and Technology will construct a UDSM's-Lindi campus at Ngongo area so as to provide agricultural programmes.

The deputy minister said that through the project, the government will also improve infrastructure in higher learning institutions by building

The five-year project through the World Bank support aimed at promoting higher education as a catalytic force in the new Tanzanian economy.

Through the project the government will construct a new public university in Butiama - Mwalimu Nyerere University of Agriculture and Technology, Muhimbili University of Health and Allied Sciences-Mloganzila campus and Sokoine University of Agriculture Mizengo Pinda campus in Katavi.

Others are Mbeya University of Science and Technology campus in Rukwa Region.

It will also facilitate construction of new campuses in marginal satellite cities including Kagera, Tanga, Kigoma, Shinyanga, Mwanza, Simiyu, Ruvuma, Manyara and Singida.

HEET project is aimed to help strengthen the capacity and quality of the selected universities and institutes to prepare faculty, researchers and graduates, and build a strong and flexible, high-skilled workforce that can address Tanzania development challenges.

THE government has set aside 69.95bn/- in the 2022/23 fiscal year for the procurement of medicines and medical tools for health centres and district hospitals in the country.

Deputy Minister of State in the President's Office (Regional Administration and Local Governments), Dr Festo Ndugange made the statement in the Parliament yesterday during the questions and answers session.

He was responding to a concern raised by Kilwa North MP Francis Ndulano over acute shortage of drugs and essential medical tools in Kilwa especially at a health centre in Somanga ward.

"Let me assure you that in the next fiscal year, all health centres will be equipped with enough medicines and tools to facilitate provision of smooth health services to people," he said.

In his supplementary question Ndulano said since it was constructed

some years ago, the centre has been has allocated 250m/- for the grappling due to lack of essential tools construction of a surgery, mother and to support provision of quality health services to the community.

The Deputy Minister said that in the next fiscal year two health centres in Kilwa South will be constructed in two wards out of the 15 wards that are yet to get the facilities.

In his basic question, Tunduru South MP Daimu Mpakate sought to know when will the government improve the Mtina Health Centre for it to start providing surgical services as well as equip the Mchoteka with enough medical equipment.

He claimed that the government has been promising that it will construct health centres in each ward and equip them with enough medical tools but the pace is still very slow.

Responding, Dr Ndugange said the government was preparing a special strategic plan to construct three health centres in each ward which will also include Tunduru South.

"In the year 2022/23, the government buying medical devices," he said.

Govt mulls using academic certificates as collateral for loans to university graduates

THE government will work on the possibility to start using academic certificates as collateral to issue loans and capital to university graduates so as to support them establish income generating projects.

The services include company Tax Identification registration, Number (TIN), residence permits and other services.

"As for now experts are finalizing the plan and it is expected to start June 15 this year,' said Bunini.

Meanwhile, Single Window Project Manager, Robert Mtendamema said the institutions are creating the Single Window to enable an investor to get various permits on his/her investment at a go and as quickly as possible.

Also, the Commissioner General of Immigration, Anna Makakala said the system will assist in providing opportunities to visitors, tourists and investors wherever they will be able to get needed services from the single window

Tanzania Bureau of Standards (TBS) Director General, Dr Yusuf Ngenya said they will join the system in the Second Phase after investors start doing business and producing goods.

1. Background

WWF Tanzania Country Office (WWF TCO) is a Non- Government Organization dealing with environmental protection in Tanzania since 1990 and it has supported the Government of Tanzania in implementing various projects on Marine, Forest, Fresh Water, Energy, and Wildlife. are becoming more and more active in laying out strategies to combat the spread of extremist activities and terror

They are doing so in liaison with inter-governmental agencies in Africa including the African Union Commission, the Inter-Governmental Agency for Development (IGAD), the East African Community, the Southern African Development Community (SADC) and the United Nations Office of Counter-Terrorism (UNOCT).

In their unity they are developing a regional crisis communication strategy for East Africa and the rest of the region, lately facing more numerous terror attacks, and this standing as an effort reflecting anxieties across the region.

Djibouti, Kenya, Rwanda, Somalia, Tanzania and Uganda sent representatives to four workshops stretched out in a week-long event split between Nairobi and Kampala.

The events sought to come up with a regional approach or effective communications to tackle misinformation and prevent terrorist

Phrased rather differently, the idea was to come up with effective tools of reaching targeted populations where terrorists harbour and seek loyalties.

The tool kit is primarily geared at improving communications between governments and the people at the grassroots level, especially to shield youths more particularly targeted by terrorist groups out to hoodwink them into recruitment.

What this communications task implies is that a youth base inclined to dissatisfaction and simplistic criticism of the government or authority can be pulled into buying the stances or philosophies of these groups.

The terror groups invariably need to draw the youths with language directly relating to their immediate lives and on the exercise of authority.

Nor do the sponsors of terrorism have the same means or the same power of conviction with extremist narratives on reality - that is, on poverty and unemployment.

That is why, for instance, we need to intensify reform measures, with a view to attracting industries and investments in extractive industries to create jobs.

One idea would be that fewer youths would be impressed by those promising a future with guns and military uniforms.

IX countries - Benin, Burkina Ethiopia, Madagascar and Niger - have reported instances of ritual infanticide.

Eleven countries - Angola, Benin, Burkina Faso, Eswatini, Ethiopia, Ghana, Liberia, Madagascar, Rwanda and Zimbabwe - have reported ritual attacks against children with disabilities.

Five countries - Burundi, Democratic Republic of the Congo, Madagascar, Malawi, Mali and Tanzania - have reported attacks on children with albinism.

Seven countries - Central African Republic, Democratic Republic of the Congo, Ethiopia, Liberia, Nigeria, South Africa and Tanzania - have reported instances of violence against children accused of being witches.

Witchcraft accusations and ritual attacks against African children are hidden and ignored, but they are one of the most gruesome forms of violence against children.

New research from African Child Policy Forum (ACPF) shows that, every year, thousands of African children are accused of witchcraft and suffer ritual attacks, abuse, physical and psychological violence, yet most governments are turning a blind eye to these practices and trends.

"Africans have ignored this horrific violence for far too long," says ACPF Executive Director Dr Joan Nyanyuki.

She adds: "It is utterly unacceptable that witchcraft accusations and ritual

attacks on children are still widespread across the continent."

Dr Nyanyuki goes on to appeal to governments "to uncover this hidden shame and address these crimes and extreme forms of violence which have life-threatening effects and often result in the death of innocent children".

The report uncovers the prevalence of witchcraft accusations and ritual attacks against children across the African continent.

It finds shocking gaps and failures by governments, even as most countries are signatories to the African Charter on the Rights and Welfare of the Child (ACRWC) and the United Nations Convention on the Rights of the Child (CRC).

"Many countries' laws do not explicitly prohibit accusations of witchcraft against a child, which in itself is an act of psychological violence," notes Dr Nyanyuki.

She adds: "Worse still, beyond their failure to prevent these accusations and violent attacks, governments have also failed to minimise the harm children suffered when they fall victims."

The ACPF chief elaborates: "African states must uphold their obligations to protect all children, especially those who are vulnerable, at risk of being accused of being witches and of facing ritual killings.

"Among those in need of greatest protection are children with albinism body parts to use in so-called 'magical

who face most gruesome forms of ritual attacks resulting in extreme violence and death. Such accusations and attacks are crimes and must be treated as such - they must be outlawed and punished."

ACPF has expressed "great concern" seeing that, even with national child protection laws in place, witchcraft accusations and ritual attacks against children have been reported in some 20 African countries

The report highlights the case of a 13-year-old girl from Benin who spent years in a child reception and protection centre after being accused of witchcraft, only to be ostracised by family and community upon her return home and eventually being forced back into care after only four days.

"The horror to which children accused of witchcraft are subjected is indescribable," said Dr Nyanyuki.

She notes further: "They suffer public humiliation, forced confessions, torture, violent beatings, are forced to ingest traditional 'cleansing' medicines, are expelled from their homes, ostracised from their communities, maimed and, in extreme cases, murdered. They carry the scars of isolation, neglect and victimisation on their mental health for their entire lives."

The report acknowledges progress in tackling the abduction, murder and mutilation of children with albinism for

For examples, it showcases Malawi's new laws and dedicated government action which resulted in the number of attacks on people with albinism declining from 60 in 2016 to just four in

It concludes on a sombre note, though, highlighting the woefully inadequate human and financial resources needed to tackle witchcraft accusations and ritual attacks on children. What little support is available comes mostly from international donors.

'Brown envelope' journalism in Africa and how to combat it

FTEN going unreported, corruption in journalism is a major concern across Africa. Commonly referred to as "brown envelope" journalism, as it typically involves monetary bribes enclosed in brown envelopes, it seeks to influence journalists to produce more positive reporting on an issue or to kill a negative story.

activist Anna Meli believes that improving journalists' pay and working conditions as well as offering more training on reporting ethics could help proactively combat efforts to corrupt

Journalists and the Trade Union of Journalists are all over the world trying to fight for equal payment and equal treatment from the economic point of view of the journalist, just to avoid this phenomenon of brown envelopes," said

She adds: "We know that in some situations of precarious work, this might be a problem and journalists can be more influenced. It is important that we are working together with all journalists to have this kind of treatment at their

economic level." Joseph Asomah, an assistant professor at St. Thomas University in New Brunswick, Canada, meanwhile noted that this corruption can be challenging to address as it happens mostly in secret between the journalist and the one paying the bribe.

"However, efforts are being made by some non-governmental organisations to address the problem. For example, in Ghana, the Media Foundation for West Africa has established "The Fourth Estate" - an investigative reporting project specifically meant to promote accountability and make those in power answerable," said Asomah, who is from Ghana himself.

In Zimbabwe, many media watchdogs, experts and journalists agree that more training for journalists on reporting ethics is needed to combat the brown envelope journalism. Journalist Lulu Brenda Harris from the Centre of Innovation and Technology says that, to do away with brown envelopes, ethics must be ingrained in journalists.

'We have a duty to our audiences to adhere to ethics and be responsible not only in our reporting but also in the way we also source for stories," she said, adding: "Audiences trust us to tell them the truth. As journalists, we are in the broken the media will crumble.'

Tapfuma Machakaire, a long-serving journalist serving as ethics chairman at the Voluntary Media Council of Zimbabwe, also denounced the corruption and acknowledged the pervasive issue of poor wages in the country's media industry as a factor behind the perpetration of the unethical practice. "Brown envelopes are not part of journalism. They don't fit anywhere in the transaction of getting a story

published," he said. He elaborated: "We have been aware that the brown envelope syndrome has been with us for some time now and this is a result of the poorly performing economy of this country. Journalists are not well paid, and working conditions are very poor. As a result, they are tempted to accept something that can improve their living standards."

In Zimbabwe, the issue of bribery of journalists was reignited after one journalist wrote about how she turned down a US\$2,000 bribe offered by tobacco company representatives while reporting a story about how tobacco farmers are getting a raw deal from contractors in the country.

Let's do something to stop spiraling killings of women

HE dramatic increase in incidents of gender killings in Tanzania has taken a new dimension which requires immediate action to reverse the situation and make our country safe for all.

As a result, there have been a number of incidents involving killings of intimate partners, married women, female parents and elderly for jealousy or materialism.

A report by an advocate of the High Court of Tanzania and the Coalition for Women Human Rights Defender in Tanzania (CWHRD)'s Coordinator, Hilda Dadu asks questions as to what is causing the fastest growing tide in our country.

The situation indicates the violation of human rights of innocent women and extreme violence against women, lack of safety, peace and security for vulnerable women.

Our country is among those that have ratified various international conventions to protect the dignity of the individual and to protect the right to life. Examples of some of these treaties include International Convention on Human Rights (1948), Convention on the Elimination of All Forms of Violence Against Women (1979) and many more to protect women and girls against violence and

Our government has gone a step further by adopting the Universal Declaration of Human Rights (1945) and incorporating these values into the constitution of the United Republic of Tanzania of 1977.

We have the Penal Code Act Chapter 16 and multi-country policies that prioritize protection and security for women and girls as well as other groups against gender-based violence.

The government has done well by setting up gender desks in various government departments to deal with issues of gender-based violence including police stations and departments of government institutions within ministries.

Also commendable is putting in place the National Plan of Action to Reduce Violence against Women and Children (NPA VAWC) which ends this year in 2022.

Despite all this, the issue of killings of women by their partners or their biological children is growing and taking on a whole new dimension.

Since January this year, media outlets have been reporting incidents of gender killings and gender based violence from various regions in our country with some leading to deaths and permanent disabilities for women.

Some have been linked to superstitious beliefs, materialistic desires, carnal desires, jealousy, hate, stress as well as all aspects of patriarchy that have also been perpetrated by men as well as women.

For a long time, women have lost their lives and some lost their body parts simply because they are women. It should be noted that the right to life is a fundamental constitutional right that every human being has.

In Tanzania, this right is protected by the constitution under Article 14. Thus violating this right is a violation of the constitution as well as various international treaties which Tanzania has ratified.

The various international and regional human rights treaties which Tanzania ratified place significant emphasis on the right to life, such as the 1948 Declaration of Human Rights and the 1966 International Covenant on Civil and Political Rights.

Among major factors in the assassination of partners has been identified as jealousy or hate of love. The people who commit this atrocity against women are their spouses or

In 2020, according to a report released by the Legal and Human Rights Centre (LHRC) in 2021, there were 23 homicides compared to 12 incidents in 2019. The number attacks in the one month of January 2022 alone could be higher than those in the 2019 and 2020 reports.

These incidents violate the right to life of women. Regions highlighted previously as hotspots for these killings include Mara, Mwanza, Shinyanga, Simiyu, Arusha and Ruvuma. But now even the regions that were considered safe like Dar es Salaam, Dodoma and Rukwa are reporting their own cases.

These killings are violence against women and they violate their freedom from violence, as well as the right to life which is protected in accordance with the constitution.

What is the situation in the community about these gender killings by intimate partners or relatives? Society has found itself in a time of crisis, with many wondering if anyone else has been attacked today and who else will follow.

Extreme anxiety could be spreading amongst women who have been going through a difficult time with their partners. Many have been subjected to severe beatings and have been silent without reporting to the relevant authorities.

Many women in relationships live anxious, insecure and stigmatized lives. Does this happen to men as well? Do these women have a place to defend themselves if they see signs of murder in their homes? Do they make noise in their homes or is it a taboo for them to speak while they are inside?

Is an empowered woman really a threat to a relationship? How do state agencies and lawmakers view this issue? What are our spiritual leaders doing about it? Where are our social workers?

Where did we bury our patriotism as members of the same family? Has non-interference in the relationships of others been a factor in women being brutally attacked and even killed? Where is the value and dignity of the woman in the family, the community and the nation as a whole?

We should not let killings of women continue making news. Let's do something to stop this.



African solutions to African problems: Reframing science innovation

frica is plagued many epidemics - from tuberculosis and HIV/AIDS to malaria and wild polio – but the continent has also worked for decades to fight these threats. The key to beating these deadly diseases is turning inward to existing expertise and finding locally driven solutions.

The recent COVID-19 pandemic has placed public health back in the global spotlight and has also served as a reminder that science is not undertaken in an ivory tower. Science shapes humanity because it takes place among us. COV-ID-19 has also showcased that no epidemic takes place in isolation. Through collaboration we can build on the foundations of our knowledge to bring forward innovative ways to address health challenges that benefit all of humanity.

This is not a new idea. In fact, it is something that we became all too familiar with during the AIDS pandemic. Despair, pain, and loss

were rampant during the 1980s and early 1990s, at the beginning of South Africa's HIV epidemic. Every weekend, white funeral tents in rural KwaZulu-Natal seemed to mushroom up and multiply, signifying the growing toll the virus was taking on the country.

Witnessing this helped catalyse me to undertake one of the earliest population-based studies that looked closely at this emerging health issue in South Africa. HIV prevalence was low at the time, with less than 1% of the population having been infected.

But lurking within the data was a shocking revelation: young women (15-24 years old) were six times more likely to be infected compared to their male counterparts.

We knew something had to be done. That meant understanding what had led to this striking disparity in risk. So, we began speaking to women from all parts of society to try and get a better sense of what they were experiencing.

power dynamics of relationships and sex were disrupting disease prevention. Women didn't have the ability to protect themselves because of the limited options available to them – options like condoms, that placed the responsibility of reducing risk in the hands of men.

Meanwhile, cases continued to surge in South Africa at an alarming rate, doubling annually in the general population.

Existing methods to prevent HIV infection weren't going to cut it. Approaches designed in the global North were never going to be able to fully account for the needs of women in Africa. That's why new solutions had to be brought forward in-

One way that we sought to empower

women was through a gel that contained Tenofovir, antiretroviral (ARV) medication. This innovative approach, shown in the CAPRISA 004 trial, enabled HIV-negative women to protect themselves from the virus. CAPRISA's research on PrEP was recently recognised by the VinFuture Prize as a lifesaving innovation from the global South.

Today, Tenofovir is taken daily as a pill for HIV prevention, a solution also known as pre-exposure prophylaxis (PrEP). It has been adopted by the World Health Organization (WHO) as a key prevention option for both women and men.

And it hasn't stopped there - a range of new anti-retroviral drugs and long-acting formulations, delivered as injections and implants, are currently being evaluated to expand pre-

vention choices. AIDS is no longer a fatal condition, instead it is we still see too many deaths and new HIV infections, particularly in marginalized populations. Two-thirds of all people living with HIV/ AIDS are in sub-Saharan Africa and the region accounts

for 60% of all new infections. As we turn our focus towards other pandemics, such as COVID-19, we cannot afford to lose the gains made in HIV. It is a trap we fell into before – when early HIV work overshadowed TB efforts – and it is not one we can afford to be caught in again.

Even now, COVID-19 con-

tinues to draw on lessons from the decades of work that have been poured into our HIV/AIDS response. This includes leveraging existing testing tools to detect COVID, utilising clinical trial infrastructure to expedite vaccine development, calling on community engagement processes to educate the public, and relying on scientific expertise to guide governments in their response.

The AIDS pandemic has taught us that scientists, policy-makers, and civil societies cannot work in a vacuum. There must be a unity of purpose that galvanises the steadfast support of global leaders in governments and funding agencies across the world.

Africa has the scientific leadership and intellectual capital to develop new technologies and interventions. This is something we have shown time and time again. If there is a problem, then chronic yet manageable. But local research is surely the best path toward finding a solution.

Pursuing this path of innovation requires funding that will support and promote the growth and expertise of Africa's scientists. Our interdependency and shared vulnerability underscores the importance of collaboration and resource-sharing both globally and regionally that must be used for the benefit of humanity. There is no time for complacency. We must ensure that solutions are tailored by local research to best benefit those in need.




Islamic finance will sustain double-digit growth, says S & P

& P Global Ratings has projected that the global Islamic finance industry will see double-digit expansion again between this and next year after 10.2 per cent growth in total assets in last year.

In an executive summary by Senior Director, Financial Institutions Ratings, S & P Global Ratings, Dr. Mohamed Damak, S & P Global Ratings stated that Islamic finance growth last year was supported by Islamic banking assets in some Gulf Cooperation Council (GCC) countries and Malaysia, sukuk issuances exceeding maturities, and the solid performance of the Islamic funds industry.

"This year, we think higher commodities prices will underpin a stronger recovery in many core Islamic finance markets," S & P Global Ratings stated.

The report however noted that the Islamic finance industry is still held back by structural weaknesses, namely the complexity inherent to transactions and the correlation of



concentration in commodities-exporting countries.

The report pointed out that sustainability and digitalisation could unlock growth opportunities provided some prerequisites are fulfilled.

S & P Global Ratings had in a previous review stated that the latest auditing standard set out by AAOIFI would help to strengthen governance and growth of the Islamic finance market.

In a review of the new standard, S

Islamic financial institutions must follow, the new standard by AAOIFI addresses this gap by creating a hierarchy of the existing standards and regulations.

"In our view, enforcing the new auditing standard should enhance Sharia governance and market discipline in Islamic financial institutions," Damak stated.

He pointed out that while AAOIFI does not specify if the standard would apply to market instruments issued by entities that are not subject to internal Sharia audit, such as corporate or sovereign sukuk issuers, extending the practice of external audits to these instruments could also help strengthen their credibility.

Global Islamic finance assets had been projected to rise to \$3.69 trillion by 2024 as latest data showed a major surge in Islamic finance activities.

The 2020 Islamic Finance Development Report had projected that global Islamic finance assets might rise to \$3.69 trillion by 2024 after posting its recent highest growth of 14 per cent to close 2019 \$2.88 trillion.

ment Report was a collaborative effort 2018. of the Islamic Corporation for the Development of the Private Sector (ICD) and Refinitiv, one of the world's largest providers of financial markets data and infrastructure. Indonesia recorded one of the most notable improvements in the Islamic Finance Development Indicator (IFDI), moving into second place for the first time due to its high knowledge and awareness ranking.

The report covered 135 countries and was based on five key metrics comprising of quantitative development, knowledge, governance, awareness, and corporate and social responsibility (CSR).

According to the report, green and socially responsible investments (SRI) increased in the UAE and Southeast Asia in 2020.

The pandemic was a game changer as several Islamic banks reported losses and reduced profits throughout the year. The pandemic has also led to growth in some areas of the industry as some regulators turned to Islamic finance to mitigate the economic impact.

Citigroup to hire 3,000 in Asia institutional banking business

ITIGROUP Inc (C.N) intends to hire 3,000 new employees its Asia institutional business in the coming years, focusing on a fast-growing region where it has departed consumer banking in most regions, according to Citi's top executive.

The previously unreported staff expansion plans underline Citi's ambition to make institutional banking and wealth management engines of growth, seeking to bolster revenue in a region that has become a battleground for global banks looking to tap its vast economies and growing wealth.

Citi's institutional business includes investment banking, and corporate and commercial banking units that provide trade finance, cash management, payments, and custody services, among others."We're talking about real meat on the bones on growing our business across Asia," Asia-Pacific CEO Peter Babej told Reuters in an interview.

Babej took on the role in 2019 and previously worked as global head of the bank's financial institutions group. Citi has around \$200 billion in wealth assets in Asia, and the bank



was "on track" to grow client assets by \$150 billion by 2025, a spokesman said, despite global economic and markets uncertainties.

The bank's expansion of Asian institutional business comes on top of plans announced last year to hire about 2,300 people by 2025 for its wealth management unit.

Citi said last year that \$7 billion in capital released from divestment of consumer banking businesses in 13 markets, 10 of which were in Asia, would be either returned to shareholders or invested in lucrative institutional banking and wealth management units.

The bank's main regional institutional business are in Hong Kong and Singapore, and Babej said that these two hubs would be a key focus of the 3,000 additional headcount for the unit. It does not disclose the existing headcount for the business."That gives you a

Could branch banks be fast becoming thing of the past?

As some Slatington bank customers are absorbing the news of loss of two major branch banks in their community by year's end, others have already gone through these withdrawal pains, and, according to banking experts, more is yet to come.

In as little as five years, banks will no longer use branches as part of their customer service channels, according to twothirds of bankers polled for a recent survey.

The double whammy in Slatington affects customers of Wells Fargo, whose branch at 541 Main St. is scheduled to close on Aug. 3, and KevBank's branch at 502 Main St., which is scheduled to be consolidated with its Whitehall branch at 271 Mac-Arthur Road on Dec. 2. These are just two of a multitude of closings that have impacted local customers during the past decade, and the trend is sure to continue.

Of course, representatives for the banks offer their sincere apologies for customers who will be inconvenienced by these closings. Wells Fargo's Elise Corbett's statement is typical of these expressions of regret.

A member of the Tropical General Investment (TGI) Group - a pan-African group with diversified investments across seven African countries in various industries and a large network of origination, distribution, and supply chain hubs, "TTB will leverage the acquisition of UBN to enhance its capacity to capitalize on the unparalleled opportunities presented by the African Continental Free Trade Area (AfCFTA)."

"Afreximbank will continue to support the new merged entity in trade finance to



promote intra- and extra-African trade through its broad range of programmes and initiatives, including the Afreximbank Trade Facilitation Programmes (Af-TRAF) and AfPAY, the Bank's international payment services.

"The development impact of the acquisition is immense as TTB will leverage the merged entity to provide financing of about \$3

Credit Suisse weighs new round of job cuts after loss warning **ZURICH**

CREDIT Suisse Group AG is weighing a fresh round of job cuts, part of a renewed push to slash costs after warning of a second-quarter loss, according to people familiar with the

The Swiss bank is considering headcount reductions across divisions including investment banking and wealth management in different regions, said the people, who asked not to be identified as the matter is private.

The dismissals are likely to come as the bank prepares to update investors on risk, compliance, technology and wealth management on June 28, said the people. Final numbers are still to be decided, they said. A Credit Suisse spokeswoman declined to comment, pointing to the lender's statement on

The bank warned on Wednesday it expects a loss at the group-wide level and at its investment bank in the second quarter. Market conditions have remained challenging after the invasion of Ukraine and monetary tightening by central banks across the world, leading to weak customer flows and ongoing client deleveraging. "Given the economic and market environment, we are accelerating our cost initiatives across the Group with the aim of maximizing savings from 2023 onwards," Credit Suisse said, without providing more details.

Chief Executive Officer Thomas Gottstein's two years in charge have seen the \$5.5 billion hit from Archegos, the collapse of partner Greensill Capital and a string of profit warnings that eroded investor confidence, weakened key businesses and prompted an exodus of talent. The lender has said that 2022 will be a year of transition as it seeks to reduce risk at the investment bank while shifting resources to wealth management.

The Swiss lender employed more than 50,000 employees as of the end of 2021, according to its website. It recently overhauled top management after five profit warnings in the past six quarters, saying that its chief financial officer, legal counsel and head of Asia would all be either stepping down or leaving the company. It also named former Bank of Ireland Group Plc Francesca McDonagh as head of the Europe, Middle East and Africa region.

ROK, US, Japan condemn DPRK missile tests, urge talks

THE Democratic People's Republic of Korea's recent missile tests were "serious, unlawful" provocations, senior officials from the Republic of Korea, the United States and Japan said on Wednesday, urging Pyongyang to return to dialogue.

The ROK Vice-Foreign Minister Cho Hyun-dong, US Deputy Secretary of State Wendy Sherman and Japanese Vice-Foreign Minister Takeo Mori made the comments as they gathered in Seoul, days after the DPRK conducted the latest in a series of missile tests and signs of preparations for what would be its first nuclear test since 2017.

The three-way meeting of the coun-

RUSSIAN Defense Minister Sergey Shoigu said on Tuesday that the Ukrainian ports of Berdyansk and Mariupol on the Sea of Azov, seized by Russian forces, have been demined and are ready to resume grain shipments.

"The demining of Mariupol's port has been completed. It is functioning normally, and has received its first cargo ships," Shoigu told a Defense Ministry meeting in televised

Agricultural exports from southern Ukraine have been blocked since Russia started its "special military operation" in late February, driving grain prices higher.

Moscow says it was forced to engage in the conflict in Ukraine because of NATO's expansion. It says Western sanctions are to blame for the situation, which has threatened to trigger a global food crisis.

But the Kremlin said on Tuesday that Ukraine needed to demine the approaches to its ports in order for ships to be cleared by the Russian military before they could export

Ukraine is the world's fourth-largest grains exporter.

Global wheat prices hit record highs in March and the surge in food prices has triggered protests, as well as contributing to an acceleration in headline inflation rates throughout the world.

Ukraine's grain, oilseed and vegetable oil exports rose 80 percent in May month-on-month to 1.74 million metric tons. but the volumes are still significantly below the exports in May 2021, the Agriculture Ministry said on Tuesday.

The United Nations is working on plans with Kyiv and Moscow for how to restart grain exports from Ukrainian ports, with Turkey possibly set to provide naval escorts to ensure safe passage out of the Black Sea, Reuters reported.

Ukraine is receiving weapons and ammunition from the West. That assistance has become a target for Russian artillery and warplanes. Russia claimed on Tuesday that its forces took out two artillery systems given by the United States and a howitzer supplied by Norway.

Shoigu also said on Tuesday that Russian troops had been in full control of the residential areas of Severodonetsk, a key city in Ukraine's east.

Severodonetsk the largest city still in Ukrainian hands in the Lugansk region of eastern Ukraine has been the focal point of fighting in recent weeks.

Japan, NATO step up ties

In Asia, Japanese and NATO officials agreed on Tuesday to step up military cooperation and joint exercises as they said Russia's military operation of Ukraine is causing a deterioration of the security environment in Europe and Asia.

Japanese Defense Minister Nobuo Kishi said after meeting with NATO Military Committee chief Rob Bauer that Japan hopes to strengthen its ties with European countries and welcomes NATO's expanded involvement in the "Indo-Pacific" region.

Bauer's visit to Tokyo came as Japan's Maritime Self-Defense Force participates in NATO naval exercises in the Mediterranean Sea.

Japan has been increasing its military capabilities and cooperation with Europe, in addition to its alliance with the US and partnerships with other countries in the "Indo-Pacific" region and beyond.

Ryanair forces S. Africans to prove identity with Afrikaans test

DUBLIN/JOHANNESBURG

RYANAIR is requiring South African passengers to prove their nationality before traveling by completing a test in Afrikaans, a language used by just 12 percent of the population that has long been identified with apartheid and the white minority.

Europe's largest airline by passenger numbers, which does not operate flights to and from South Africa, said it required any UKbound passengers from the country to fill in the "simple questionnaire" due to what it described as a high prevalence of fraudulent South African passports.

"If they are unable to complete this questionnaire, they will be refused travel and issued with a full refund," a spokesman for the Irish

South Africa's Home Affairs desyndicates selling fake passports, said it would issue a statement on the Ryanair test.

The UK High Commission in

South Africa said on Twitter that the Ryanair test was not a British government requirement to enter the United Kingdom. The Irish High Commission did not immediately respond to a request for comment.

The low cost carrier said the test would apply to any South African passport holder flying to Britain from another part of Europe on the carrier. The airline did not immediately respond to a query about why it would apply to those routes, given Britain says it is not a requirement.

Zinhle Novazi, a South African attorney, faced the test when traveling by Ryanair from Ibiza, Spain, to London on May 29.

Turkey says Ukraine grain-export plan reasonable

IN a pocket park in Shinan district, Qingdao, east China's Shandong province, the grounds are painted to resemble piano keys, and over 30 types of flowers and shrubs are flourishing. Piano melodies are always resounding

through the park.

"I never thought that the pocket park would be so snazzy, and now it has become a 'back garden' for the residents," said a woman surnamed Zhang that lives in the neighborhood, who's delighted every time when seeing the colorful paintings and flowers in the park.

In Baoding, north China's Hebei province, there's a displaced plant-turned pocket park called Yinxing Park. According to local official Zhang Qingfei, the park was built the last year and the transformation only took two months.

There are currently 41 types of plants in the park, so that it always looks green throughout the year.

Pocket parks are often constructed in fragmented urban spaces for sports, leisure, and entertainment uses. In recent years, their prevalence in Chinese cities has increased. Built on brownfields, on irregular pieces of land, and around residential buildings, they offer extra green spaces for urban dwellers.

As one of the most accessible types of park, pocket parks present beautiful natural scenery for residents. Besides, they also come with smart equipment and related supporting facilities that help meet residents' demand for leisure, entertainment, sports and social interaction.

Every morning, Hao Xinhua, a senior citizen living in Hedong district, north China's Tianjin municipality, does physical exercise in a nearby pocket park. She told People's Daily that what attracts her there is not only its proximity to her home, but also the 11 pieces of fitness equipment that were newly introduced to the park last year.

According to Wang Ruigang, an official with Hedong district's sports bureau, the 11 sets of fitness equipment include a leg massager, an upper body pulley system exerciser, etc. Every equipment comes with a screen and can be connected to the phones of the residents. After the

residents input their personal information, the smart equipment can generate individualized and professional fitness

"Compared with traditional equipment, these are smarter, more tech-ish, and more interactive," said a resident named Li Wenming. According to Li, the park is also a place where his neighbors meet.

The construction of these parks is not the finish line, but the starting point of maintenance, which is very important for benefiting surrounding residents in a sustained manner.

A pocket park in Hanjiang district, Wuhan, central China's Hubei province,

has invited local residents to help with its management, hoping they could discover and solve the common problems faced by pocket parks.

Resident Lyu Jun, who currently serves as a "director" of the park, said he would go for a walk at the park every afternoon for inspection, from which he has learned many new plant species.

China is striving to make its cities more beautiful, greener and more habitable. According to a 2021 national bulletin on land greening status released by the Office of the National Greening Committee, China has built over 20,000 pocket parks and more than 80,000 kilometers of green lanes. The per capita

area of parks and green spaces for urban residents stood at 15 square meters.

An official with the Ministry of Housing and Urban-Rural Development introduced that China will keep building a well-balanced park system and strive to make it possible for its residents to "see greenbelts every 300 meters and parks every 500 meters." The country will also improve the leisure, sports, and emergency shelter functions of urban parks

and green spaces, the official said. Besides, China will enhance its management of urban gardens and strengthen oversight over relevant matters when they are being handled and after they have been handled, so as to promote the high-quality development of urban landscaping.

The Collective Security Treaty Organization (CSTO) should be a balancing factor in the Euro-Atlantic region, Russian Foreign Minister Sergey Lavrov said in an interview for a documentary, headlined 'CSTO Allies -30 Years on Guard of Collective Security.

"A heated debate is now under way regarding how to implement CSTO summit decisions on ensuring indivisible security. This is one of the fundamental issues that we are bringing up for the discussion," he said.

"We are asking those questions to our interlocutors, because, apart from the commitment to refrain from boosting anyone's security at the expense of others, everyone has undertook the commitment to prevent any organization - in this case, NATO - from claiming an exceptional role in security-related events and processes in the Euro-Atlantic region," the Russian top diplomat continued.

"We will press for those answers. One cannot simply promise something, sign something and do whatever he wants, it does not work this way. That is why CSTO should become a factor that ensures balance in the Euro-Atlantic region," the minister said.

The development of the Collective Security Treaty Organization (CSTO) is not to the liking of NATO coun-

"CSTO will develop depending on needs that do arise in practical life. Not everyone likes the organization's development, including our NATO colleagues," he said.

The minister went on to say that starting from mid-200s, CSTO has been inviting NATO to create mechanisms for consultations, information exchange and cooperation in various spheres of the Euro-Atlantic security, primarily within the framework of the Organization for Security and Cooperation in Europe (OSCE).

"NATO members, who continue to treat other states and organizations with arrogance, ignored those requests. A heated debate is now under way regarding ways to implement CSTO summit decisions on ensuring indivisible security.

This is one of the fundamental issues that we are bringing up for the discussion," the Russian top diplomat continued.

"The formula of indivisible security, signed by presidents and heads of governments of all NATO countries, envisages, among other things, that every nation, group of nations or organization abstains from attempts to claim the dominant role in the Euro-Atlantic region."

Lavrov stressed that all NATO actions are exactly what its members once undertook to avoid.

"We are asking those questions to our interlocutors, because, apart from the commitment to refrain from boosting anyone's security at the expense of others, everyone has undertook the commitment to prevent any organization - in this case, NATO - from claiming an exceptional role in security-related events and processes in the Euro-Atlantic region," the Russian top diplomat continued.

WTO chief: COVID-19 vaccine rights waiver within reach

KAMPALA / GABORONE / **LOS ANGELES / GENEVA**

AN international agreement on waiving intellectual property rights for COVID-19 vaccines is within reach ahead of a global trade meeting next week, the head of the World Trade Organization said yesterday.

In a telephone interview, Director-General Ngozi Okonjo-Iweala also said an agreement could be reached on fishing subsidies in time for the meeting, when 120 trade ministers from around the world gather at the body's Geneva headquarters.

"If we get one or two deliverables that will be good," Okonjo-Iweala told Reuters in a telephone interview. "I think we are within shouting distance of

Days before the meeting starts, none of the agreements in the three major negotiating areas of agriculture, fish subsidies or intellectual property rights for vaccines have been finalized for ministers to rubberstamp, trade sources say.

Instead, Okonjo-Iweala described a "hectic" atmosphere in Geneva where negotiators had been working late nights and weekends in order to try to resolve outstanding differences.

Since she was appointed more than a year ago, Okonjo-Iweala, a former Nigerian minister and chair of the GAVI vaccine alliance board, has prioritized a long-sought deal on a waiver for intellectual property rights for COVID-19 shots.

Botswana

Botswana is likely to enter its fifth wave of the COVID-19 pandemic, health authorities warned Monday, as the numbers of the cases have been on the rise.

Novavax

Advisers to the US Food and Drug Administration on Tuesday voted overwhelmingly to recommend that the agency authorize Novavax Inc's COVID-19 vaccine for use in adults, which the drugmaker hopes can become the shot of choice among some American vaccine skeptics.

The panel of outside vaccine experts voted 21-0 with one abstention in favor of the vaccine for those 18 and older after discussing whether the shot's benefits outweigh risks, including rare occurrences of heart inflammation that may be associated with the vaccine.

If the FDA follows the recommendation and authorizes the shot, it will be the fourth COVID-19 vaccine available for use in adults in the United States. The FDA has approved previous COVID-19 shots within days of panel votes, with distribution quickly following.

The timeline for Novavax is not clear.

Novavax Chief Commercial Officer John Trizzino said the agency is still reviewing documents detailing its manufacturing processes submitted last week.

"We hopefully expect to have product in the US in our warehouse by the end of June," he said in an interview, adding that the company plans to ship millions of doses made by its partner, the Serum Institute of India, soon after authorization.

Novavax's shot, which is already available in over 40 countries, is a more traditional type of vaccine employing technology that has been used for decades to combat dis-

Maryland-based Novavax is hoping to gain a foothold within the roughly 27 million US adults who are yet to be vaccinated, particularly those who do not want to receive a vaccine like the Pfizer / BioNTech or Moderna Inc shots based on groundbreaking messenger RNA technology.

Ugandan President Yoweri Museveni on Tuesday urged the public to adhere to the COVID-19 prevention measures, saying the country has started registering an increase in the number of COVID-19 infection cases.

Museveni in his State of Nation Address to the parliament said the country registers an average of two deaths per week due to COVID-19.

"We (are) now, again, getting two deaths per week from Corona. Be alert, again, please," the president said.

He said he has observed some huge public gatherings where prevention measures are not adhered to.

Museveni's warning comes days after the ministry of health warned that it is experiencing an increase in the daily number of COVID-19 cases compared to the stable trends it observed since January 2022.

Minister of Health Ruth Aceng in a tweet Sunday said the increase is similar to the rise the country faced in June 2021 when the Delta variant was prevalent.

China launches Shenzhou-14 crewed mission to complete space station construction

CHINA launched the Shenzhou-14 crewed spaceship at 10:44 a.m. on June 5. 2022, Beijing Time, sending three astronauts to its space station Tiangong.

After entering its designated orbit, the spaceship conducted a fast rendezvous and docking with the space station combination. At 8:50 p.m., astronauts Chen Dong, Liu Yang and Cai Xuzhe entered the Tianhe core module of the space station and began their six-month stay in orbit.

This is the 23rd spaceflight mission since the approval and launch of China's manned space program and the third crewed mission for China's space station

During the Shenzhou-14 crewed mission, the three astronauts are expected to complete the construction of the country's space station, which mainly consists of the Tianhe core module and two lab modules named Mengtian and Wentian, and finally establish the country's national space laboratory.

In the following six months during their stay in the space station, the Shenzhou-14 crew will witness the Wentian and Mengtian lab modules, Tianzhou-5 cargo craft, and Shenzhou-15 manned spaceship dock with the Tianhe core module.

During their stay in orbit, the crew members will carry out in-orbit verification of small and big mechanical arms, verification of the role of an airlock cabin in the Wentian lab module in supporting extravehicular activities, installation of extravehicular payloads and other space station-construction related work.

Meanwhile, the crew will continue public benefit activities including the "Tiangong Class" live science lecture, and conduct in-orbit health monitoring and examination, protective exercises, in-orbit training and drills, as well as a lot of other activities such as station platform inspections and tests, equipment maintenance and verification, and station and material management.

Following the launch of the Shenzhou-14 crewed mission, China will launch the Wentian and Mengtian lab modules to create a larger platform for scientific experiments and tests in space.

As China's national space laboratory, the Tiangong space station will be able to accommodate 25 experiment cabinets

for scientific exploration, according to Lin Xiqiang, spokesperson for China's manned space program and deputy director of the China Manned Space Agency (CMSA).

Each of the 25 experiment cabinets will be able to function as a small-sized lab where space science experiments for a single subject or interdisciplinary research can be carried out, with their overall capacity reaching an advanced international level, Lin said.

The Wentian lab module will mainly be used for space life sciences research. It will be equipped with experiment cabinets for experiments on life and ecology, biotechnology, and varying-gravity science research, as well as experiments and research in closed ecosystem. It will also support research into the response mechanisms of various kinds of plants, animals, microorganisms, etc. during growth, development, heredity, and senescence in space.

The Mengtian lab module is designed to serve microgravity research. Equipped with experiment cabinets for the study of physics of fluids, material science, combustion science, fundamental physics, space technology experiments and other disciplines, the lab module will be able to support research into the essential laws of relevant matter and frontier research including those in ultracold atomic physics.

China will establish the world's first cold atomic clocks in space consisting of a hydrogen clock, a rubidium clock and an optical clock in its space station on the basis of the cold atomic clock that once worked on board China's "retired" Tiangong-2 space lab.

The cold atomic clocks will form the most precise time and frequency system in space, which will serve frontier scientific research including gravitational redshift research and measurement of fine structure constants.

The country will also launch the Xuntian space telescope into the orbit of the space station to carry out wide-area survey observations.

Upon the completion of the inorbit construction of the space station, China's manned space program will enter a stage of application and development that will span more than 10 years.

According to China's initial plan for the new stage, the country will launch two manned spaceships and two cargo spacecraft every year, and astronauts will stay in orbit for a long term to carry out space scientific and technological experiments and maintain the space station.

The country also plans to develop reusable new-generation manned carrier rockets and spacecraft that can carry seven astronauts.

Senior diplomat says relations with Japan at important juncture

CHINA-JAPAN relations involve By doing so, Tokyo is also atlems, a senior Chinese diplomat said on Tuesday, adding that the difficulties and challenges faced by bilateral ties should not be ignored.

Yang Jiechi, a member of the Political Bureau of the Communist Party of China Central Committee and director of the Office of the Central Commission for Foreign Affairs, made the remark in a phone conversation with Takeo Akiba, secretary-general of Japan's National Security Secretariat.

Noting that China-Japan relations have reached an important point in history, with this year marking the 50th anniversary of the normalization of diplomatic ties between the two countries, Yang said China and Japan must stay on the right track, adhere to win-win cooperation, take a longterm perspective and enhance mutual trust on security.

Stable ties

He called on Tokyo to work with Beijing to ensure stable, healthy and resilient China-Japan relations over the next 50 years and jointly safeguard regional peace and prosperity.

According to a statement on the Foreign Ministry's website, Akiba told Wang that Japan stands ready to deepen cooperation with China, and appropriately handle differences and strengthen communications on sensitive bilateral issues and international hot spot issues in order to jointly build a constructive and stable Japan-China relationship.

Yang also elaborated on China's principled positions on the Taiwan question and issues related to Hong Kong and the Diaoyu Islands, among others, during the meeting.

Experts said that the meeting came at a time when Japan has been closely following the United States' "Indo-Pacific" strategy and is actively engaged in containing

China and stirring up confrontation in the Asia-Pacific region.

a number of old and new prob-tempting to regain its status in Asia. However, such a practice is not conducive to regional peace, stability and the healthy development of China-Japan relations, and Japan will inevitably have to pay the price for this, they added.

Last month, as US President Joe Biden made his first trip to Asia, Tokyo hosted the leaders' meeting of the Quadrilateral Security Dialogue, or Quad, an anti-China grouping consisting of the US, Japan, India and Australia. Japan also endorsed the Indo-Pacific Economic Framework launched by Biden in Tokyo.

Irresponsible remarks

During Biden's visit, Japan and the US made irresponsible remarks and groundless accusations on a series of issues related to China's domestic affairs, including on the Taiwan question.

Wang Junsheng, a researcher of East Asian studies at the Chinese Academy of Social Sciences, said that Japan is joining with the US to counter China as Tokyo is Washington's close ally, and also because it misjudges China's development.

"Japan is unwilling to see a rising China because it mistakenly assumes that China's development will harm its own interests," Wang said. "However, the fact is that as close neighbors, both China and Japan will benefit from their good relationship in various areas including trade and the economy, regional cooperation and tackling climate change."

Xiang Haoyu, a distinguished research fellow at the China Institute of International Studies, said in an article in Global Times that hyping up or creating so-called external threats for specific political purposes will not make Japan great again or bring it absolute security.

Instead, it will only get Japan into greater security dilemmas, Xiang said.

Morrison, Simba SC parting of ways was especially sentimental, not technical

SUALLY, players finish their contracted time in a club, often either one or two years, and either leave or are handed another contract, and, rarely, a player is more or less dismissed from the side, towards the very end the season.

Yet this is what has happened to Simba SC's Bernard Morrison, arguably one of the more inspiring players on the lineup, while not being the most acclaimed player in the side.

As with several other gifted players, there is sometimes a streak of irregular behaviour that administrators find gall-

But dropping the player is part of a wider reflection on building a winning team at the continental level, and like Chris Mugalu, John Bocco, or others, no one can be said to be perfectly safe.

That way, a minor disturbance but touching on a raw nerve can easily tilt the balance to other priorities.

There is a dismissive formulation after a disappointing epic, for example with Queen Elizabeth II, for whom passions were generated around the world of late in the wake of captivating pageantry before the Buckingham Palace where the frail monarch briefly appeared.

The past season was not as bad as that at Msimbazi Street club, but yes, it is a year many fans there prefer to

Germany coach Hansi Flick made seven changes to the team that drew in Italy 1-1 on Saturday, while Southgate made four to the side that lost in Hungary.

The 18-year-old Jamal Musiala, who was playing an outstanding game, fired a good opportunity at goalkeeper Jordan Pickford toward the end of the first half. There was still time before the break for Bukayo Saka to test Manuel Neuer, then shoot another chance

Germany failed to make more of further chances after Hofmann made the breakthrough.

Lorenzo Pellegrini continued his impressive scoring form to help Italy beat Hungary 2-1 in Cesena.

Pellegrini finished off a well-worked team move on the stroke of halftime when Matteo Politano cut into the right side of the area and put in a low cross for the Roma midfielder to slot in at the far post.

It was Pellegrini's second goal in as many matches for Italy, having also scored against Germany. Pellegrini scored nine times for Roma in Serie A last season and five times in the Europa Conference League to help his team win the trophy.

PAUL Pogba has spoken publicly for the first time since his departure from Manchester United and said he is looking forward to "enjoying" himself at his next

Last week, United announced that Pogba would leave the club for a second time on a free transfer after his contract expires at the end of June.

Sources have told ESPN that the midfielder is set to return to Juventus and Pogba said he wants enjoy his football again in the future.

"I just want the best for me," he told Uninterrupted on Tuesday. "I'm thinking, putting everything together, taking my time, and I'm just looking for the best, I want to play football, be myself always, and enjoy what I do.

"I need to enjoy what I do because otherwise I cannot perform well. I don't want to be thinking negatively. We can be losing games, trophies but you have to be happy and enjoy yourself -- that's what I'm looking for."

Pogba won three trophies during his second stint at Old Trafford but struggled to perform on a consistent basis and endured a difficult relationship with United supporters, who booed him against Norwich City and Liverpool last season.

The France international hinted that this treatment had a negative impact on him and his performances for

"Everybody wants to feel loved, everyone needs that in your soul to feel appreciated," he added. "Everything you do even when you grow up, when you do a good thing you like to hear: 'Well done, nice.'

The more Gavi stars for Spain, the more expensive it gets for Barcelona

was September 2020 when Ansu Fati, aged 17 years and 311 days, curled a sensational right-footed shot past Ukraine's Andriy Pyatov to become the youngest-ever goal scorer for Spain's national team. It was a record which had stood proudly untouched for 95 years -- since Real Union's Juan Errazquin, a few days off his 19th birthday, hit the net in a 3-0 friendly win over Switzerland in 1925

It's normally a good indicator of any record's significance if it has stood for a long time -- just think of Bob Beamon's incredible long jump mark of 8.90 meters which has endured since 1968. So Ansu -- also Barcelona's youngest scorer (16 years and 304 days) in LaLiga and the youngest ever to hit the net in the Champions League (17 years, 40 days) -- is pretty special.

Yet Ansu's newly established record for Spain lasted for just 637 days, until his Barca teammate, Pablo Martin Paez Gavira -- whom you'll know as Gavi (aged 17 years and 304 days) -snatched it away from him with a lovely left-footed finish in Prague to equalise against Czech Republic last Sunday.

It's the second time in a matter of months that this feisty, uber-talented kid has ripped up the nationalteam record books. Last November, while starring in a 2-1 victory over European champions Italy at San Siro, Gavi (at 17 years and 62 days) broke an record-holder Angel Zubieta in April 1936.

Enough of the stats, for the moment at least, because what's much more exciting about this young lad is his talent, energy, technique and ferocious will to win. Precisely the standout abilities which, combined, have made him the star player over Spain's last 180 competitive minutes: draws with Portugal and the Czechs which put Spain in a precarious position in Nations League Group A2. In fact, Gavi played more minutes for La Roja across the two matches than anyone except goalkeeper Unai

If you didn't manage to watch Luis Enrique's injury-hit, tiring Spain side these last few days I'm going to do you a wee favour. Find La Roja's goal against Portugal, but play it from the origins of the 25th-minute move.

It starts with a loose ball about 20 metres outside the Spain penalty area and a sprint. Gavi the Kid shouldn't get there first, but he leaves Portugal's Bruno Fernandes in a despairing heap on the ground. Then he strides about 50 metres, the ball tied to his foot, before slide-ruling a pass to right winger Pablo Sarabia, who is left to provide the simplest assist for Alvaro Morata to score.
