

EWURA lowers petrol, diesel cap prices as 100bn/subsidy pays off

THE government's decision to issue a 100bn/subsidy to cushion the rising fuel prices has started to bear fruit, as the Energy and Water Utilities Regulatory Authority (EWURA) moves to lower cap prices for petrol and diesel.

Titus Kaguo, the communications and public relations manager, said in a statement yesterday that the new prices relate to oil cargo now being imported, with retail prices for petrol in Dar es Salaam decreased by 306/- per litre, in Mtwara 282/- and Tanga 152/- per litre.

Retail prices for diesel were decreased by 320/- for Dar es Salaam, 476/- for Tanga and 486/- for Mtwara entry points, thus petrol in Dar es Salaam will now be sold at the price cap of 2,994/- from 3,301/- per litre and diesel fetching 3,131/- from 3,452/- per litre.

For fuel unloaded at Tanga port, the new price will be 2,985/- from the previous 3,137/- for petrol, while diesel will be sold at 3,162/- from 3,639/- per litre current prices, he said.

Fuel docking at Mtwara port will be sold at the diesel will sell at 3,165/- from 3,652/- per litre

The prices apply only in towns and cities where the ports are located, and are likely to change in other areas due to transportation expenses. There will be a certain relief from the previous prices, he asserted.

Ali Saeed, chairman for the tender evaluation committee of the Petroleum Bulk Procurement Agency (PBPA) opened the fuel tender for next month, urging local companies to participate in fuel importation tenders.

This will increase competition to facilitate price reduction, he said, citing winners of importation tenders with best transporting costs and profit projections, where participants shortlisted are Sahara Petroleum Services Co., the Tanzania Petroleum Development Co. (TPDC) and Vitol Bahrain, he said.

The participation of local companies would promote financial stability and promote experience in fuel business to shape the future of the business locally, he stated.

Trade in mobile cash registering big rise - report

FINANCIAL inclusion is continuing to expand in Tanzania, with the five mobile money service providers attracting three million new customers in the year ending March 2022.


A report covering quarterly communication statistics issued by the Tanzania Communications Regulatory Authority (TCRA) for the first quarter of this year shows mobile money accounts reached 35.74m, compared with 32.72m at the end of first quarter 2021, testifying to expansion of mobile money service as an important tool to enhance financial services countrywide.

It is especially useful in locations where there are no bank facilities or agencies, the report noted, indicating that M-Pesa has continued to dominate the market with 40 percent of the market share.

Diaspora is top priority in economic diplomacy drive

LINKING up with the Diaspora community is a major goal in the work outlook of the Ministry of Foreign Affairs and East African Cooperation as it focuses on economic diplomacy in the coming financial year, the National Assembly was told here yesterday.

Ambassador Liberata Mulamula, the minister, said this when tabling the ministry's 2022/2023 Budget estimates, tasking savings locally. Remittance rose compared to

Tanzanian embassies with attracting foreign direct investments and seeking to open up market opportunities for the country's goods

and services. The ministry is seeking 208.34bn/- for the year, where economic diplomacy relates to enticing not just the rest of the world to invest in Tanzania but also the Diaspora community as during the past year it has shown considerable interest in investing their

"The government has been engaging the Diaspora community to invest back home," she said, alluding to central bank data indicating that remittances from the Diaspora community increased to \$569.3mi in 2021 compared to \$400m the previous year.

TBL, Vodacom (T) linking up crop delivery, payment app

TANZANIA Breweries Limited (TBL) and Vodacom (T) yesterday launched a platform for records management and payment for farmers who supply TBL with raw materials.

The BanQu app unveiled in Dar es Salaam yesterday packages a blockchain platform tailored for farmers in the TBL supply chain to connect farmers and empower them financially, on the basis of remarks by Nape Nnauye (pictured), the minister for Information, Communication and Technology, who officiated at the unveiling ceremony.

BanQu is provided by a software service company as a blockchain-powered supply chain and records management platform. It was hired by TBL operator AB InBev of South Africa, with Vodacom coming in as a mobile money service provider for the new arrangement.

The purchasing platform on BanQu is connected to M-Pesa and payments can be directly deposited, he said, underlining that the government supports innovations and

arrangement is partly to blame for spiraling retail prices in the country.

As the tenders were opened, the Vitol Bahrain bid was at \$0.05 and apparently the lowest quotation in records of bulk procurement since the start of the past decade, he said, while Orlando da Costa, chairman of the Tanzania Association of Oil Marketing Companies (TAOMAC) said the bulk procurement system was competitive and the whole process was transparent.

Last month the government disbursed 100bn/- in a move by President Samia Suluhu Hassan to cushion importation costs and stop sharp price rises.

The president said the government would tighten expenditure for the remaining days of the current financial year, so that the money saved helps relieve the public from sharp price rises.

A Fuel Price Stabilization Fund was also envisaged, with the government drawing up the necessary arrangements for establishing it, the president had indicated.

TCU: Opening of varsities' technical campuses is fine

THE Tanzania Commission for Universities (TCU) says it has no problem with a new government plan for the establishment of technical education campuses across the

"It's a directive issued by the responsible minister for Education. There is no way TCU can act against the government plan," said Jorlin Kagaruki, TCU spokesperson in an exclusive interview with this paper.

The Guardian contacted the regulator of universities for comment after higher education stakeholders expressed their worries over the implementation of the latest government plan which seeks to sensitize universities to set up technical education campuses countrywide.

Winding up his ministry's budget estimates, Minister for Education, Science and Technology, Prof Adolf Mkenda told the National Assembly recently that the government encourages higher education institutions to set up technical

based education in the country.

Higher education stakeholders hailed the envisaged government plan, saying the move will create a pool of competent graduates in the wake of increasingly competitive and dynamic labour market.

However, some stakeholders expressed doubts that implementation of the plan will remain "a mere dream" if TCU does not review restrictive guidelines barring universities from offering technical education programmes at diploma and certificate

Interviewed, higher education stakeholder, Joseph Mfutakanga, cited specific TCU guidelines 1.5.2 which "restricts universities to offer NACTE accredited technical education (certificate, diploma) programmes that are being offered in a regular middle level institution operating in Tanzania and guideline 1.5.4 which restricts universities to start new competencetechnical programmes (certificate and diploma) that were not listed in the initial accreditation documents."

"It's time for TCU to review

to offer competence-based technical programmes in order to go at par with dynamics of today's competitive labour markets, new government education plans and Academic freedom for Universities," said Angela Mvula, an expert in higher education affairs based in Dar es Salaam.

When reached over the matter, Kagaruki allayed stakeholders' fears, saying TCU guidelines will not be "a stumbling block" in the implementation of the Minister's directive, allowing universities to open technical education campuses throughout the country.

"Let them (universities) go ahead with the setting up of respective campuses, if they face some challenges we will sit down and discuss how to handle them," noted Kagaruki.

As the situation stands currently, she added "TCU guidelines are not an impediment to the establishment of technical education campuses by universities, as directed by the responsible education minister."

Announcing the plan in the Parliament recently, Minister Mkenda, said among other things, the latest education in universities and other education institutions. higher According to the minister, the government would encourage universities and higher education institutions to set up technical campuses (for diploma and certificate programmes) in different regions across the country.

In fact, the minister was responding to long time concerns by Members of Parliament (MPs) and higher education stakeholders, who had on various occasions expressed a need to allow universities and other higher education institutions to offer technical education and produce competent graduates with technical skills required in the rapidly changing labour market.

"We have many graduates with higher CPAs who can hardly operate a simple machine. Investors, corporate companies and businesspeople cannot risk employing incompetent graduates just because they are holders of a first-class degree certificate. 

Each farmer will have a digital ledger, described as an 'economic passport,' connected to the TBL value chain and providing an immutable record of all crop transactions made.

The ledger will show agricultural cycles from input to harvest, keep a transparent and traceable payment history of crops delivered or sold, along with providing useful, quality metrics to improve productivity and business practices, he added.

Dr Mwinyi stresses importance of EFDs

ZANZIBAR President Dr Hussein Ali Mwinyi has stressed on the use of the Electronic Fiscal Devices (EFDs) in tax collection, as well as requiring members of public to demand cash sale receipts whenever they make purchases at shops to enable the government deal with the current economic situation.

Parliamentary c'mittee demands Dart buses on Kilwa Road next month

PARLIAMENTARY Committee Administration and Local Governments Affairs has urged the Dar Rapid Transit Agency (DART) to complete Kilwa Road section before the start of this year's international trade fair in the city next month.

The call was made at the weekend by the Committee Chairman Abdalah Chaurembo while winding up the committee's tour at DART offices to familiarize with activities undertaken by the agency.

"We know that your infrastructure is not complete 100 per cent but do whatever you can to complete it to enable Tanzanians use rapid buses to attend this year's Dar es Salaam International Trade Fair to reduce transport challenges for city residents and inspire people especially from Mbagala to attend the exhibitions," said Chaurembo.

Phase two of the DART project is along Kilwa Road from city centre to Mbagala Rangi Tatu; other parts of the corridor start from South Kawawa road at Morogoro Road junction to Mgulani JKT round with 20.3 km.

Chaurembo said President Samia Suluhu Hassan is optimistic that the project entire will complete on time and start before March 2023 so DART should continue to supervise closely the development of the project so that Mbagala residents can get easy transportation.

He said Mbagala residents have suffered for a very long time with transport problem adding that the completion of the project would be a great opportunity for them to easily move from one area to another.

Chaurembo also asked DART to advise the committee on proper ways to handle the problem of bodaboda and other drivers' interruptions in rapid transport roads which in many times resulted to fatal accidents.

He said the service provider in rapid transport infrastructure UDART should submit to the committee report regarding challenges of their business including the shortage of buses so that they can see how to help.

He also urged DART to closely monitor the supervisor of construction of rapid transport system, Tanzania National Road Agency (TANROADS) to ensure the project complete within agreed time and with good standards.

RUFFO, stakeholders issue sanitary pads in schools in Kisarawe District

A Dar es Salaam based-Raising Up Friendship Foundation (RUFFO) has donated 101 boxes of sanitary pads to support safe menstruation of girls at Mfuru primary and secondary schools in Kisarawe District, Coast Region.

Provided in partnership with Jubilee Health Insurance, Tanzania Youth Alliance, East Africa Education Foundation and Vijiji Tanzania, the pads will accommodate the girls for six months.

Speaking during the handing over event here during the weekend, RUFFO executive director Hilda Ngaja said the sanitary towels have been donated as part of commemoration of the International Menstrual Hygiene Day which is marked annually on May 28.

She said apart from providing the girls with the pads, the organisation which deals with child rights protection, also held a seminar where 250 students were trained and advised on menstrual hygiene management.

She noted that a good number of school girls

as well as women from poor families in both rural and urban areas are facing great challenges to access the sanitary towels, something which thwarts their development goals.

Laura Lyabandi, marketing officer from Jubilee Health Insurance noted that many girls miss school during their periods due to lack of sanitary pads, something which needs more coordinated efforts from both the government and stakeholders to address.

Kisarawe youth officer said the council has been implementing initiatives that aim to educate male youth on menstruations and thus be able to support their sisters during their important days.

"Every year we set aside a budget to purchase pads so as to support girls who are unable to access them, we appreciate support from stakeholders who have been coming here to complement our initiatives," he said. Alba Salum, a standard four student at Mfuru secondary school commended the organisations for supporting them with the hygiene towels which are going to help them stay comfortably for the next six months.

Government plans to use security organs to arrest examination leaks

THE government plans to engage defence and security organs in all processes beginning with preparations for the exams, distribution and during the release of results, in efforts to curb examination leakage to learners pursuing health

Deputy Minister for Education, Omary Kipanga told the National Assembly yesterday that the move aims at ensuring that what happened in August 2021 is not occurring again.

In November last year, the government through the office of the Chief Medical Officer Dr Aifello Sichalwe annulled results of the examination of August 2021 National Technical Awards (NTA) Level 5 clinical medicine countrywide due to leakage and ordered fresh sitting.

Dr Sichwale said they were working closely with the security organs to trace the culprits. He said there is no way the government could tolerate examination cheating especially to clinical medicine candidates, as they deal directly with human health.

Health had the mandate to oversee the policy Chief Government Printer," he noted.

issues that are strictly adhered to, including having qualified medical personnel to oversee the health sector thus professionalism, ethics and efficiency are of great importance to public health security.

He said it had come to the government attention that the second term clinical medicine theory examinations held nationally from August 16 to September 30th last year had leakage elements.

"Gas for vehicles cannot be confined in Dar es Salaam only, we expect to transport via gas tankers to gas stations for the people to use and we hope to work on the issue as fast as possible," Mramba added.

"While this is going on, policy procedures are going on, EWURA has started conceiving recommended process for the gas, as well as following up those changing vehicles engines to use gas are doing so to safety standards, we believe many vehicles will change to gas," he

The PS said gas has a safety system as the UDSM and Mlalakuwa.

In regard to the benefit from gas over liquid fuel, he said it is cheap by 40 per cent according to those who have installed the system in their vehicles.

Natural Resources, Tourism ministry: Status of reserved areas under review

THE Mto-wa-Mbu status as a Game Controlled Area hangs on limbo as human activities take over from the former pristine wildlife-filled precinct.

The Permanent Secretary in the Ministry of Natural Resources and Tourism, Dr Francis Michael, has said the government was indeed reviewing status of some reserved areas, including Mto-wa-Mbu GCA to see if they will continue to be graded as such or be relieved from prominence.

But there are tourist properties in the area that continue to pay hefty sums of money in form of Wildlife Management Area (WMA) charges, despite the lack of the said wildlife.

The additional USD 30 imposed on guests and visitors at their lodges and campsite adds charges to tourists who reportedly complain of not getting their value of money as the area is no longer the reserved precinct it was when the Game Controlled Status was given in 1974.

Investors lament the encroaching human settlements, mass cattle grazing, extended farms, noisy motorcycles and commercial vehicles that have turned the former reserve into an overcrowded and unplanned residential precinct.

Frank Benard Mbuya, the Operations Manager for the Manyara Wildlife Safari Camp, says demanding USD 30 per guest, as additional charges of venturing into Mto-wa-Mbu GCA, is proving to be too much for foreign tourists who have already paid their way to Tanzania.

Early this year, the Tanzania National Parks and the Tanzania Wildlife Authority truck-lifted all wildlife from Mto-wa-Mbu Game Controlled Area after it became apparent that the mostly zebra and wildebeests species were in conflict with people that have moved into the location.

"Without wildlife, tourists no longer

find this place attractive. And without wildlife there is no need to impose such charges. In fact, a number of camps and lodges have closed down as there is no business," added Mbuya.

He pointed out that, unless something is done, more properties will go out of business, affecting people who are employed in the lodges or local farmers and traders who supply

"Travel agents who rake the areas looking for suitable alternative places to take tourists find the Mto-wa-Mbu GCA as an overcrowded, badly polluted location unsuitable for leisure excursions," puts in Charles Pelly, the operations manager at Manyara's Secret.

His views are reflected by George Daniel, of the Mto wa Mbu Cultural Tourism entity who admits that business has fallen. "Tourists prefer to proceed onto the other side of Lake Manyara in Karatu, where the area is still pristine and there are no extra

Mto-wa-Mbu GCA used to be popular for walking safaris, biking and horse riding as well as canoeing around Lake Manyara, during the good old days of pristine areas filled with wildlife, but alas! This is no longer the case.

'Tax incentives deprive govt of revenue it so badly needs

THE government should not use tax incentives as the sole bait to attract foreign direct investment (FDI) because it has ended up depriving the government of much-needed revenues for strategic investments in public services and the economy.

Tax justice experts have advised that there are several other reasons investors want to prioritize, such as strong institutions, availability of energy, infrastructures, quality education systems, and other things, even before they consider tax incentives.

They were recently speaking at a policy conference organised by Friedrich Ebert Stiftung in collaboration with the Public Services International (PSI) affiliates on revenue mobilisation in the Tanzania mining sector to finance quality public services and the care economy held in

"If you want to consider high industrial metal prices and waive tax as key to attracting investment, I think you are missing the point," said Daniel Orbeko from Public Services International.

Responding to one of the recent article published in media which said that the government, through the Ministry of Minerals, wants to take advantage of the high demand for industrial metal and higher prices to grant new tax incentives to attract investors.

Orbeko who is a Public Services International (PSI) tax justice coordinator said experts have advised that over the years, investors have never prioritized tax incentives but rather strong institutions, availability of energy and quality education among other reasons.

He said when the prices are high, the companies would want to increase production to take advantage of the high prices, and these mining

companies are particularly after rewarding their investors and shareholders. The other thing is that these high prices are temporary. Therefore, they may not necessarily go into a new investment because they are granted new tax incentives.

"It takes time for the mining investment to start working. If you are considering high prices and providing tax incentives, I am sure by the time the establishment is done; the price would have gone down, which means there will be no need for further investment," he said.

The meeting also discussed the importance of effective resource mobilization to support the funding of quality social services such as education and health care.

Commenting on tax justice and the delivery of quality social services, the Director of Friedrich Ebert Stiftung (FES) said that tax justice should be understood as a way to finance an economic system that realizes gender equality and women's rights.

She sad this will enable Tanzanian economy to become more productive, equitable and sustainable.

Lost funds through tax incentives could be channeled towards improving care work and creating decent jobs in the sector such as financing early childcare and care for the elderly and people with disability. She added that, the income from taxation would be used to cushion the impact of spending cuts in health and social welfare policies as soon as debt servicing costs are rising and austerity measures are around the corner due to the coming global stagflation.

Coal exports say lots more than improvements at Mtwara port

are basking in the sun as the use of the port is now gathering speed, first with the directive that cashew nut shipments outside the country be done from there rather than loaded into lorries to Dar es Salaam for export. The next big thing is the rally in supplying coal to various countries seeking to close their dependence on Russian sources, as this address pressure on the decision makers there to do something about ending the conflict with Ukraine. It was all being predicted of late that African countries with considerable mineral resources will do better as the world adjusts to the new crisis.

Africa however lacks major food exporters despite having vast arable land, and by comparison with population density, could have done much better than some hitherto not so well known agriculture powers, Russia and Ukraine in particular. News that between the two of them they accounted for 30 per cent of total wheat exports around the world was surprising, as public opinion was more tuned to the fact that the United States donates upwards of 25 per cent of all grain consignments and other needs to the World Food Program (WFP). In the sea the shark is feared, but there are plenty of other massive hunters.

That said, the world economy is no longer the same with Russia being sidelined from a range of product exchanges in the West, while things are normal on its eastern flank as it sells oil and gas at lower than OPEC prices. of coal, rapidly.

ORT authorities at Mtwara It is hard to say that Western imposed sanctions are biting, except perhaps in sectors that are exposed to closing out the Western market or technological links, networking, etc. There may have been a spike in the rate of inflation in the first month of the war, but not much is reported on that lately

> The regional authorities were being informed by a Ruvuma coal mining firm that consignments totaling 300,000 tonnes of coal have been shipped to countries in Africa, Asia and Europe in the past seven months. The firm's branch manager was speaking ahead of loading the latest shipment of coal destined for the Netherlands, a flurry of Mtwara port use that started last November.

> The demand for coal is rising, contrary to what the latest global conference on climate envisaged, of cutting out coal use.

> This situation also spells good tidings for the East African Crude Oil Pipeline (EACOP) project where reports earlier this year were talking of banking and insurance institutions withdrawing as activists fume and curse over investing in fossil fuels. Now there is the disruption in Eastern Europe which demands that all these things be reworked, and without signs of a diplomatic ending which fully restores Ukrainian sovereignty to the satisfaction of the NATO bloc, disengagement from Russia will persist. EACOP has more breathing space than was otherwise thought, and with an effort, we can sell plenty



Services Health Amendment Bill now before Parliament deserves support from all legislators as it seeks to bar labour withdrawal in the health services, but offering compulsory arbitration in return when negotiations are deadlocked.

Vice President Constantino Chiwenga, in a speech as Minister of Health and Child Care, made clear when the Bill was introduced for its second reading that the primary intent of barring industrial action was because health services are so critical that people can actually die if labour is withdrawn.

The salaries bill is still the largest in the national Budget, and likely to remain so. In inflationary times, tax revenues do tend to rise at the rate of inflation.

Consumption taxes like VAT and the transfer tax, based as a percentage on money spent or money moved, obviously rise as more money is spent in both nominal as well as real

But even other sources of revenue such as PAYE, income and company taxes rise quite quickly as profits rise, at least in nominal terms, and private sector pay scales rise.

Generally, the Government salary rises follow a month or two behind the private sector rises since the Government must first collect the extra tax before spending it, but the gap is short.

The Government at the moment is determined to at least maintain this policy, combining the fiscal discipline needed for growth and the payment of the highest possible salaries and other benefits.

Very often the audited accounts of the strike fund are useful at tricky stages of negotiations since the union can make it clear that a strike can last.

But no union or staff association

are indulging in industrial action.

The private sector stopped pay many years ago and the State sector has now followed. This means that any strike action, even if legal, is largely doomed to failure since few workers can survive without regular

But we still need the equivalent of some sort of ultimate provision when negotiations break down, and even when everyone during the talks has been reasonable and responsible this can happen.

Arbitration has been followed in some private sector disputes, with a reasonable degree of success, at least producing a result that everyone can live with.

Quite interestingly and sensibly, the Government now sees this as a good way of resolving any irreconcilable dispute in the public health sector.

Ukraine crisis hits Africa's most vulnerable as aid costs spike

DAKAR

small charity broke ground this year on a clinic in northern Burkina Faso to care for thousands of women and children who have fled Islamist insurgents wreaking havoc along the fringes of the Sahara.

But when the Russia-Ukraine conflict started in February, global supply chains buckled and the cost of building materials, fuel and food spiked in West Africa. The charity's founder, Boukary Ouedraogo, was forced to make a tough decision: He halted construction of the clinic with only the foundations laid.

Similar calls are being made across sub-Saharan Africa, where aid projects are threatened by the fallout from the crisis in Ukraine, potentially putting millions of lives at risk.

Humanitarian agencies already struggling with widespread price increases under the pandemic say the crisis in Europe has made things worse. Even the cost of life-saving therapeutic foods for malnourished children has spiked.

Compounding the problem, some donors have diverted state aid from Africa's worst-hit countries to help support more than six million refugees who have fled from Ukraine.

Denmark said in March it was halving its aid to Burkina Faso this year to accommodate Ukrainian refugees. Its budget for Burkina's neighbor Mali, also in the grips of an Islamist insurgency, has dropped 40 percent.

Sweden has also said it plans to divert \$1 billion from its aid budget to help cover the cost of hosting Ukrainian refugees.

Ouedraogo's clinic was desperately needed in Kaya, a town of dirt streets and squat brick buildings surrounded by arid scrubland. Its population has swelled in recent years as thousands of people from surrounding villages flee militant attacks, straining the already basic health care system.

"What happened in Ukraine happened at the same time as the crisis in this country got worse," said Ouedraogo, who runs the BO Foundation in

"We hope all the donors can keep their attention," he said. "We felt what we were doing was going to reduce the number of deaths and infant mortality.'

Emergency levels

It's a similar story in Sudan. In a southern area faced with conflict and food shortages, a pediatric clinic run by Senegal-based medical charity Alima faces a \$300,000 funding gap due to an increase in costs, including fuel for the clinic's generator.

At this rate, Alima will have to shut the program down, said its director of operations, Kader Issa-

Action Against Hunger, a charity with operations across Africa, has seen the cost of foodstuffs such as rice, oil and sugar rise 20 percent to 30 percent over the past year.

This will reduce its coverage by the same amount, said Mamadou Diop, a representative from its West Africa office.

"We have to totally rethink our approach," said Diop. "We must decide, do we reduce supply or reduce the number of beneficiaries?"

The problem is not limited to Africa. The UN's World Food Programme (WFP) feeds 13 million people a month in Yemen, where the economy has been wrecked by years of war, but it has re-

It may have to make further cuts, after raising only a quarter of the \$2 billion it needs for Yemen this year from international donors.

"We're taking food from the poor and feeding the hungry," said WFP representative to Yemen, Richard Ragan.

"In June we will have to make some tough decisions about possibly even going down to just feeding five million, those who are really most at risk," he said.

Unique in scope

Still, Africa's problems are unique in scope. Conflict in Ethiopia, Somalia, Democratic Republic of Congo and the Sahel region have forced millions to flee their homes. Nearly half a billion people live in extreme poverty, according to the World Bank.

West Africa alone faces an unprecedented food shortage that threatens nearly 40 million people, driven in part by drought and the impact of the conflict in Ukraine on food prices and supply. The impact of higher costs on aid organizations varies, health specialists say.

Smaller non-profits reliant on institutional

donors such as governments for yearly budgets may struggle more than a larger charity such as Medecins Sans Frontieres, which raises money through public campaigns.

MSF said it did not foresee cutting back its operations due to the Ukraine crisis.

But few are immune. A drop in funding that preceded the conflict in Ukraine has forced WFP to cut rations in seven countries in West and Central Africa.

In Nigeria, the continent's most populous

country, the number of people receiving emergency assistance from WFP has dropped from 1.9 million in September to 650,000.

Like Burkina Faso and Mali, northern Nigeria is also wracked by a prolonged Islamist insurgency.

Health specialists and aid workers said it was too early to assess exactly what the impact on communities will be and it could take months to see how much damage the cutbacks cause.

"Further funding shortfalls will contribute to worsening food security and nutrition in locations where food insecurity is already at emergency levels," said WFP spokesman for Western Africa, Djaounsede Madjiangar.

Plumpy'nut spike

In Somalia, one-year-old Hassan howled in a blue plastic bucket suspended from a scale as a medical technician noted his weight: 5.6 kg.

It was an improvement. Hassan weighed only 5.2 kg when he first began receiving treatment for severe acute malnutrition at a clinic run by aid workers in the south of the country three months ago - about half what a boy his age should weigh.

His partial recovery is thanks to a sweet peanut paste called Plumpy'Nut developed by French scientists in the 1990s that has become a crucial weapon in the fight against child malnutrition. Three small sachets a day for six weeks can be enough to bring a starving child back to full health, according to UN children's charity UNICEF.

"He used to be much worse," said the boy's mother, Hasan Habiba Mohammed Nur, patting his bony legs under an oversized T-shirt. "The Plumpy'Nut has really helped him."

UNICEF says it spends \$137 million a year on therapeutic food and the overall market is estimated to be worth up to \$400 million.

But aid agencies say it is becoming too expensive.

Over the past year, the cost of Plumpy'Nut has risen 23 percent, including a 9 percent increase imposed since the Ukraine crisis began, Plumpy'Nut's main producer Nutriset, told Reuters. In a letter to customers in March warning of impending price increases, it said the cost of ingredients such as palm oil, milk powder and whey, and packaging including laminate for the sachets, had risen sharply. Shipping expenses have also rocketed. In all, costs are up 39 percent, Nutriset said.

The conflict in Ukraine is "indirectly impacting the price of raw materials, and prices will continue to increase even more in the weeks and months to come," Nutriset said.

The increases worry UNICEF. It predicts that prices of therapeutic foods will rise 16 percent in the next six months because of Ukraine and pandemic disruptions. Without further funding, 600,000 more children may miss out on treatment, it said in May.



Ugandan youth helps peers stay in school with free reusable pads

IN many poverty-stricken areas in Uganda, teenage girls skip classes during the menstrual cycle because they cannot afford sanitary pads.

The absenteeism results in poor performance which affects their self-esteem and eventually drop out of school, according to the ministry of education.

In Kalerwe, a slum area on the outskirts of the capital Kampala, Joanna Atukunda, 29, is determined to change the narrative.

Atukunda told Xinhua that step by step, girls from poor families would be able to stay in school because they have pads. As the world commemorated Menstrual Hygiene Day on May 28, Atukunda distributed free reusable sanitary pads in the area, reaching over 100 teenage girls.

Atukunda and her team also raised awareness about the importance of good menstrual hygiene management. "I lost both my parents when I was five years old.

My guardians, who helped me to get proper education, used to reside near slum areas in the western Ugandan district of Mbarara.

By the time I was 12 years old I would see how young girls in my neighborhood slums faced difficulty whenever they were in their menstrual period," Atukunda said.

After finishing her university degree specializing in gender and women health four years ago, Atukunda embarked on her passion of equipping adolescents in slum areas with knowledge on sexual reproductive health rights and quality education. She said girls in slum areas end up getting pregnant as they get money from men to buy sanitary pads.

Harriet Namazzi, a teenager in Katanga, another slum in Kampala, told Xinhua that she stays with her mother who cannot afford to look after a family of four children. Namazzi said sometimes she engages in petty work to earn money which she gives to her mother. Eseza Nakayemba, a community mobilizer, said with the help of people like

Atukunda, they carry out outreaches sensitizing youths especially teenagers about managing menstrual hygiene among oth-

She was speaking ahead of the Menstrual Hygiene Day commemorated under the theme "Making menstruation a normal fact of life by 2030".

several learning materials on menstrual health and hygiene targeting teachers, learners and parents.

The minister appealed to the media and cultural leaders to influence a shift in attitudes and perceptions around menstrua-

"It is unacceptable to prevent girls from getting education due to the stigma of menstruation. It is equally unacceptable to prevent women from earning an income and equally participating in everyday life due to the stigma of menstruation," the

FORUMCC and Same District residents plead for community participation in clean energy

LIMITED involvement of the rural communities, low resource allocation, and a slow pace in right technological advancement could hinder Tanzania's transition to clean

In a dialogue between District Officers (DOs), CSOs, organized under the FORUMCC who are also the Designated National Platform of the Pan African Climate Justice Alliance (PACJA) and the media held on Friday last week in Same District.

Stakeholders urged that rural communities in Tanzania are being left out in the planned move to clean energy.

"I had a 32 inches Solar powered Television screen, of which I am not using any longer because its power cable was damaged and its compatible spare is not in the market," said Benedict Missani, Same District development officer while sharing his experience on the slow pace of investment in the technological development in clean energy transition endeavor in Tanzania.

The participants also said unless the government addresses barriers, lack of access to clean energy could also be a hindrance to the aspirations of Vision 2050 towards energy transition.

Zainabu Daudi, a Councilor from one of the remote wards in Same District said the private sector is not actively playing its part because of limited knowledge and information about the demands of clean energy, which include equipment and technologies. "These, in rural areas are compounded by unclear business cases that could have been used to attract their investment," she noted.

Contributing in the dialogue from the CSOs representation, Titus Onesmo noted that the term "transition to clean energy" has recently made its way into National Policy and Climate Change discussions, but many workers in the local government and actors in the private sector are unaware of this term and are thus inactive in the green growth across all levels in the country".

Onesmo added that the government policy initiatives meant to ramp up green energy in the country should be promoted and decentralized for the understanding by the local government administrators and the private sector.

Gaspary Gratian, a participant from the CSOs said the real-world impact of such policies is not yet visible despite the government's publicly stated aim of boosting potential energy sources such as from the wind and solar energy".

He added that there is a gap between the political commitment and the actual implementation at local levels and the non-state processes on this transition.

He further pointed out that to grow the interest towards the real transition, reforms in terms of stakeholder's engagement and public awareness are crucial.

Online exhibitions, business matchmaking events vitalise Chinese market

VER the recent years, China has been moving a large number of exhibitions and investment promotion activities onto online platforms to facilitate economic and social development.

The 131st China Import and Export Fair, also known as the Canton Fair, recently concluded online. It was the fifth time the event was held on the internet.

On its official website, the Canton Fair sets up a series of sections, including Product Release, Exhibitors on Live, and VR Exhibition Hall, building an efficient trade platform for Chinese and foreign enterprises with modern information technology. It enables global merchants to conduct international business without even going abroad.

During the 10-day event, its website was visited 33.9 million times by 10.09 million visitors. A total of 85,300 live exhibitions were held by participating enterprises, in which over 3 million exhibits were displayed, including 951,500 new products, the highest in the event's history

Apart from major exhibitions such as the Canton Fair, online investment promotion activities are also being held online across China, and positive progress has been achieved.

Not long ago, the Jiutai district of Changchun, capital of northeast China's Jilin province, held an online investment negotiation. It was joined by over 30 representatives from enterprises. The district signed framework agreements on cooperation with six enterprises, with the total investment volume hitting 8.8 billion yuan (\$1.31 billion).

hui province, is also moving business matchmaking online. This year, the investment facilitation center of Hefei's Lujiang county has held more than 30 video conferences to attract investment. "We are moving business negotiation, project assessment, and agreement signing online to ensure smooth investment promotion," said an official with the center. According to the official, carrying out investment promotion activities online can maximally reduce the impacts of COVID-19.

Online exhibitions and business matchmaking also offer a new path for relieving the burden for enterprises and vitalizing market entities.

"Exhibition booths are scarce resources for small- and medium-sized foreign trade enterprises in brick-andmortar exhibitions as the area of each exhibition hall is fixed. However, the online Canton Fair has offered an opportunity for many small- and mediumsized enterprises and greatly optimized the resource allocation of the exhibition, contributing to the foreign trade sector by stabilizing market entities," said Bai Ming, deputy director of the International Market Research Institute at the Chinese Academy of International Trade and Economic Cooperation.

Besides, multiple provincial-level regions in China have rolled out relevant policies that encourage online exhibitions and business matchmaking.

For instance, the Department of Commerce of Jiangsu Province has proposed to hold an online exhibition to help service trade enterprises in the province smooth supply and demand in the international market.

The provincial government of Zhejiang has made and released a list of major exhibitions to be held, with an

Sudan's move to lift state of emergency widely welcomed

KHARTOUM

SUDAN'S Transitional Sovereign Council Chairman Abdel Fattah Al-Burhan's decision to lift the state of emergency and release the political detainees has been widely welcomed as the country has been plagued by political turmoil for months.

The tripartite mechanism of the United Nations, the African Union and the Inter-Governmental Authority on Development on Monday welcomed the decision "as positive steps to create the conditions needed for reaching a peaceful resolution for the current political impasse."

The mechanism said in a statement that it encouraged all stakeholders to be prepared for a constructive dialogue in good faith on a political solution and a peaceful way out of the current crisis. Sudan's National Umma Party, a major party in the opposition Freedom and Change Alliance, also regarded lifting the state of emergency as a positive

"The decisions to lift the state of emergency is a positive step toward building confidence," Al-Wathiq Al-Birair, secre-

tary-general of the Umma party, said in a statement. Al-Birair hoped that the decision would be implemented and that citizens would be allowed the right to peaceful expression to open the way for a serious political process.

Sudanese security authorities have released a number of political detain-

ees after Al-Burhan issued a decree lifting the state of emergency in the country on Sunday.

According to the Sudanese Emergency Lawyers Committee, Sudanese authorities freed "63 revolutionaries" on Monday, 24 of whom were held at Port-Sudan prison, nine at Dabak prison, and 30 at Kosti prison. According to the committee, there are still detainees at Suba prison, including 24 people from Al-Kalakla neighborhood who were arrested on Saturday during demonstrations in the capital Khartoum.

The decision to lift the state of emergency was to "prepare the atmosphere for a fruitful dialogue that achieves stability for the transitional period," Sudan's Transitional Sovereign Council said in a statement.

Sudan has been suffering a political crisis after Al-Burhan, also the general commander of the Sudanese Armed Forces, declared a state of emergency on Oct. 25, 2021 and dissolved the sovereign council and the government. Since then, Khartoum and other cities have been witnessing continued protests demanding a return to civilian rule.

The DSE market reports shows the Tanzania Share Index (TSI), which measures the performance of local listings, closed 0.40 points up to 3,965.89 points on Monday close from 3965.49 points during the close of last week's trading session.

The overall market index (DSEI) closed 0.01 points up on Monday this week at 1,898.38 points from 1898.37 points recorded during last week's

According to the market report, the improvement was a result of increasing share prices by Nico, which gained to 330/- on Monday from 320/- on Friday last week, which translates into 3.13 percent growth. This slightly pushed up the market caps to 22.83bn/- from 22.14bn/-.

Swissport Tanzania share price also improved by 1.01 percent during the reviewed trading sessions to 1,000/- from 990/-, pushing its market capitalization to 36bn/- from 32.55bn/- respectively.

However, the CRDB Bank counter had other 1.1 million outstanding shares on offer, as investors were seeking to sell them, the highest volume among all listed companies.

The second top mover was

Swissport, the aviation services provider, which recorded a turnover of 63.7m/- from transaction of 63,722 shares traded in seven deals at a price of between 990/- ad 1,000/- per share.

The report shows Tanzania Portland Cement Company (TPCCL) was third top mover after recording a turnover of 13.4mn/- following the transaction of 3,550 shares traded in two deals at a price of between 3,800/- and 4,000/- per share.

The reports have shown the market has so far recorded a turnover of 29.4bn/ during the first two months of the second quarter, of which foreign investors injected 19bn/ from share purchase and 21bn/- through share selling.

The amount is equal to 29.4bn/- recorded during three months of the second quarter of last year, which indicates that the turnover for this quarter will surpass those of the similar quarter of last year.

During the first quarter of this year, a total turnover of 34.8bn/- recorded, of which 24bn/- were injected by foreign investors through share buying and 19.6bn/- through share selling, which indicates that foreign investors sold more than what they bought.

The overall market capitalization closed at 15.8trn/-, lower than 16.3trn/recorded on May 31, 2021 close. Domestic market capitalization closed high at 10.8trn/- on Monday this week from 9.5trn/- recorded during the end of May last year.

OIL prices extended gains on Tuesday after the EU agreed to slash oil imports from Russia, fuelling worries of a tighter market already strained for supply amid rising demand ahead of peak U.S. and European summer driving season.

Brent crude for July, which expires on Tuesday, rose \$2.19, or 1.8%, to \$123.86 a barrel at 0650 GMT, after earlier rising to \$124.10 - its highest since March 9. The more active August contract rose \$2.25 to

at \$119.12 a barrel, up \$4.05, or 3.5%, from Friday's close. There was no settlement on Monday due to a U.S. public holiday.

Both benchmarks have posted daily gains since Wednesday. European Union leaders

THE Agricultural Tanzania Agricultural Development Bank (TADB) has devised a strategic plan to economically empower women and youths in collaboration with Investment Climate Reform Facility (ICR).

Uchumi demands billions from KDF in asset auction

NAIROBI

UCHUMI Supermarkets expects to receive Sh3 billion from the sale of its Lang'ata branch property, which was forcefully acquired by the Kenya Defence Forces (KDF) last year.

The retailer, currently struggling to stay afloat, said a letter of award from the National Land Commission (NLC) to aid the transfer of the property will be ready by end of June. The KDF said last year that it will forcibly acquire 3.7

acres on which Uchumi's Lang'ata branch sits, adding a fresh twist to the ownership of the prime plot that is the subject of a court suit.

The NLC, on behalf of KDF, has been working on a paper that will convert the land and buildings into military use since last year.

"Uchumi Supermarkets Plc is waiting for the letter of award. This is expected within the next 30 days. Creditors shall be notified in case of any variation to our projections," said the retailer during a creditors' meeting

Proceeds from the transactions are set to help pay the retailer's debt. The company carries the property at Sh806.6 million and says that the sale will leave it with a gain of Sh2.1 billion.

Creditors that had secured their loans using the as-



set include the government, which is claiming Sh1.3 billion, UBA Bank (Sh176 million), and ICDC (Sh115.9 million).

It remains unclear why the KDF has been pursuing the land that sits next to Wilson Airport in Nairobi which the US government warned earlier was vulnerable to terrorist attacks due to lax security.

The airport handles about 90 percent of domestic flights that mainly comprise chartered and commercial flights to holiday destinations such as the Masai Mara Game Reserve, Mombasa, Amboseli National Park, Lamu, Kilimanjaro, Diani, Lokichogio, and Nanyuki.

It is currently ranked among the busiest airports in terms of aircraft movement in East and Central Africa.

The supermarket says the High Court has so far stopped the seizure of any of its assets by creditors in favour of a company voluntary agreement (CVA) through which claims will be settled in an orderly manner.

Under the deal, the retailer and suppliers were to form a committee and agree on how to settle the Sh4.2 billion owed to them and ensure the payments are made

The Kenya Revenue Authority (KRA) and UBA are among the creditors that have sought to attach the retailer's properties to recover their money. The bank had gone to court to sell the Lang'ata Road land, which the retailer used as security for the loan.

Small flower farms lose 20pc produce on tight export space

NAIROBI

SMALL-SCALE flower farms are throwing away a fifth of their daily produce meant for export on the back of a shortfall in freight capacity, with big players locking them out through advance bookings on airlines.

Kenya Flower Council (KFC) chief executive officer Clement Tulezi says the freight capacity at the airport remains low as flight operations are yet to fully recover from interruptions caused by Covid-19 in 2020.

Mr Tulezi said available freight space stands at 3,500 tonnes against the required 5,000 tonnes a week.

"The larger players are able to lock space by pre-booking with the airlines and the freight forwarders. So space could be

found for them but for the smaller ones who probably are not able to export every day, it becomes a big challenge to access that space," said Mr Tulezi.

He added that the perfect scenario is to have more foreign flights coming in throughout the year. However, this could be restricted by the interests of the national carrier, which ideally have to be pro-

"That is the reality and this happens not just in Kenya but everywhere else. So it is not possible that all the foreign airlines will be given a free movement into Kenya.

But we believe that when we really need that capacity, the government can allow more foreign carriers to come in and lift

what we need," he said. Mr Tulezi was speaking on Monday dur-



ing this year's International Flower Trade & Exhibition that is taking place after a three-year break due to Covid-19.

The multi-billion shilling flower show brings together stakeholders from both local and international exhibitors and is where major deals in the industry are cut.

Europe accounts for nearly 70 percent of Kenya's cut-flower exports and the limited cargo capacity is making it difficult for Kenya to serve this market, threatening thousands of jobs.

Technology can fast-track financial inclusion for people with disability

A compassionate approach to the financial needs of persons with disabilities, supported by innovative technology solutions, has the potential in addressing the needs of the most vulnerable members of society across the Middle East and Africa, according to the latest white paper from Mastercard.

The study, Bridging the Disability Gap: An Opportunity to Make a Positive Impact, reveals that digital inclusion is the pathway to financial inclusion for persons with disabilities.

As governments adopt and prioritize policies to improve accessibility of services, this paves the way for public and private sector financial institutions, mobile network operators (MNO), fintech providers, and other organizations to develop and apply solutions.

Umar Hashmi, Vice President, Global Product and Engineering, Mastercard, said: "At Mastercard, we are a purpose-driven organization and put into practice our belief in 'doing well by doing good'. Diversity, equity, and inclusion are part of who we are, and we bring this to life by deploying products, services, and partnerships that are aligned with the 2030 Agenda for Sustainable Development and the 17 Sustainable Development Goals (SDGs), based on 'leaving no-one behind'."

According to the latest available data, one billion people, or 15 percent of the world's population, experience some form of disability, constituting the largest minority group in the world. Types of disabilities include visual, hearing, speech, mobility, cognitive, and psycho-social.

A combination of physical constraints in accessing financial institutions and services prevents many persons with disabilities from banking independently.



Depending on the type of disability, this includes being unable to travel to and enter a financial institution, branch, or ATM, not perceiving and understanding what is written on paper or electronic devices, being unable to hear, understand, and communicate with banking service providers, and being unable to access paper or digital content.

The paper includes real-life case studies of persons with disabilities having to depend on others to perform simple financial

tasks

at the event.

One interviewee said: "You should be able to access financial services in privacy; no one should know the details of your banking transactions, your balance, and how much you are spending." Others spoke about how access to services digitally would make a significant difference to their financial independence.

A 2019 UN report cites data that show persons with disabilities consider 28%

of banks in developed countries, and between 8% and 64% banks in some emerging economies, to be inaccessible.

However, measures are being taken to address this, at the government and corporate levels. The UAE has enforced a federal law concerning the Rights of People with Disabilities.

Emirates NBD bank has imparted Disability Equality Training to over 2,100 of its staff and has also taught them American Sign Language.

Disability The bank's Friendly Branch project, implemented in 2016, aims to facilitate and ease the banking experience. The three-phase transformation integrates infrastructure, technology, and services to enable and enhance accessibility.

According to the Mastercard white paper, in the Middle East and Africa, using digital inclusion as the pathway to financial inclusion for persons with disabilities must involve reducing the gap in smartphone ownership, mobile internet usage, and digital literacy.

Approximately 63% of the world's population is now online since the pandemic. Research in select low- and middle-income countries in the Middle East and Africa shows that, despite a large mobile disability gap, widening at each stage of the user's journey, 62% of adults with disabilities own mobile phones and 21% own smartphones.

Central Bank of Kenya cites two banks for insider loan breaches

NAIROBI

TWO commercial banks breached a Central Bank of Kenya (CBK) insider lending limit rule last year by giving loans to internal parties in excess of their core capital.

Each bank is required to have a core capital of at least Sh1 billion, with the funds forming an institution's permanent capital.

The law prohibits banks from issuing credit facilities that are unsecured or provided to insiders such as employees, directors, and shareholders and which cumulatively exceed the core capital.

The rule is designed to avoid insider dealings that can expose an institution to collapse, hurting depositors and other parties. "Two commercial banks were in violation of Section 11(1) (g) of the Banking Act as they exceeded the total insider borrowing limit of 100 percent of core capital, breaching the limits placed on lending to a single borrower," the CBK says in its newly published 2021 bank supervision report. The regulator did not name the lenders.

Though the CBK withheld their identity, they are likely to be private institutions.

The publicly traded banks have core capital far exceeding the Sh1 billion threshold and their lending to insiders represent a fraction of the permanent capital.

Lending out amounts representing the entire core capital to insiders is tantamount to withdrawing the cash that is critical in backing an institution's risk-taking business.

Banks usually take a substantial part of deposits and lend to some customers, with some of the borrowers defaulting. To manage the risk to depositors' funds, the institutions are required to have a core capital and other additional buffers.

Insider loans are among the multiple breaches that occurred in the banking sector last year.

The CBK in total flagged nine banks for non-compliance with various rules, compared with 13 in 2020, largely due to failure by owners to raise fresh capital in a depressed economy battered by Covid-19 shocks. Some institutions had multiple offences. "Appropriate remedial actions were taken on the concerned institutions by the CBK in respect of the violations," the regulator said without specifying the enforcement actions.

Eight commercial banks were in violation of Section 10 (1) of the Banking Act as they exceeded the single obligor limit of 25



percent of core capital.

A bank must not lend more than a quarter of its core capital to one borrower or related borrowers in the rule known as single obligor.

The law states that the advances, credit facilities, financial guarantees and other liabilities of the borrower and his associates shall be aggregated for the calculation of their total value and the restriction shall apply in respect of that person and his associ-

Breach of the single obligor rule was the most widespread compliance failure last year, according to the CBK report.

"Most of the violations were in respect to breach of single obligor limit, mainly due to decline in core capital in some banks that have continued to report losses," says the CBK report.

Five commercial banks were in violation of Section 12 (C) of the Banking Act and CBK prudential guideline on prohibited business, which restricts investment in land and buildings to 20 percent of core capital. Two commercial banks operated below the minimum core capital of Sh1 billion last year in an environment where smaller banks have struggled to attract fresh cash injections.

Five commercial banks breached the capital adequacy rule for failure to meet the statutory minimum required ratio for total capital to total risk-weighted assets of 14.5 percent.

Four banks, on the other hand, failed to meet the

statutory minimum required ratio for core capital to total risk-weighted assets of 10.5 percent.

Chinese banks now overflow with cash that nobody wants

BEIJING

CHINESE authorities are facing an uphill battle convincing companies and households to boost borrowing as long as Covid outbreaks and lockdowns continue to crush confi-

After loan growth weakened in April to the worst level in almost five years, several indicators suggest the data for May won't be much better.

Housing sales have continued to slump, indicating a lack of appetite for mortgages and subdued credit demand among developers and sectors linked to the property industry.

Struggling to find enough clients, banks have been swapping bills with each other just so they can meet regulatory requirements for corporate lending.

The reluctance to borrow stems in large part from uncertainty over China's Covid curbs, and whether future outbreaks could lead to repeated lockdowns like the one that crippled activity in Shanghai for weeks.

Businesses have had to halt production and cut jobs, revenue has slumped and profits have plunged. Many companies are putting expansion plans on hold.

"The sluggish credit demand points to worsening expectations among market entities and slowing business expansion," said Xing Zhaopeng, senior China strategist at Australia & New Zealand Banking Group Ltd. That suggests China's economic rebound might be weak even in the third quarter, as many investment activities can only start after loans are secured

The scenario is a challenging one for policy makers, who are pushing banks to lend more. The People's Bank of China told lenders last week to "go all out" in increasing loans. It's also pushed banks to lower mortgage rates and called on them to stabilize lending in the property sector.

The upshot is that the financial system is awash with cash, and any monetary easing from the central bank -- such as interest rate cuts and liquidity injections -- will likely prove less effective in spurring growth in the economy.

Here are four charts that show credit demand in China likely remained weak in May, even as Covid outbreaks began to wane and cities started to reopen.

Falling rates on a type of short-term interbank loan is one sign that banks aren't lending much to corporates.

The interest rate on transferring bankers' acceptances maturing in one month fell to 0.01% early last week. That's the fourth time since December that the rate approached zero toward the end of the month, according to data from the Shanghai Commercial Paper Exchange.

Purchases of the bills are counted as loans to companies. A rate near-zero means buying banks are asking for almost no discounts on those purchases, as they try to meet regulators' requirements to lend more even as firms won't borrow.

"The near-zero interest rate shows the imbalance between credit supply and demand remains outstanding," said Wang Yifeng, chief banking analyst at Everbright Securities Co.

Since last week's fall, those rates have started to improve, with the cost on the one-month tenor reaching 1.35% on Monday. The recovery came after last week's central bank meeting, and after Premier Li Kegiang held an emergency meeting with thousands of representatives from local governments, state-owned companies and financial firms and called on them to do more to stabilize growth.

Unlikely monkeypox outbreak will lead to pandemic, WHO says

THE World Health Organization does not believe the monkeypox outbreak outside Africa will lead to a pandemic, an official said on Monday, adding it remains unclear if infected people who are not displaying symptoms can transmit the disease.

More than 300 suspected and confirmed cases of monkeypox - a usually mild illness that spreads through close contact and can cause flu-like symptoms and pus-filled skin lesions - have been reported in May, mostly in Europe.

The WHO is considering whether the outbreak should be assessed as a "potential public health emergency of international concern" or PHEIC. Such a declaration, as was done for COVID-19 and Ebola, would help accelerate research

and funding to contain the disease.

Asked whether this monkeypox outbreak has the potential to grow into a pandemic, Rosamund Lewis, technical lead for monkeypox from the WHO Health Emergencies Program said: "We don't know but we don't think so.'

"At the moment, we are not concerned of a global pandemic," she said.

Once monkeypox has been contracted, the duration of the rash emerging and scabs falling off is recognized as the infectious period, but there is limited information on whether there is any spread of the virus by people who are not symptomatic, she added.

"We really don't actually yet know whether there's asymptomatic transmission of monkeypox - the indications in the past have been that this is not a major feature - but this remains to be de-

Brazil poll: Lula regains double-digit lead over Bolsonaro

BRASILIA

FORMER President Luiz Inacio Lula da Silva has reclaimed a double-digit advantage over incumbent Jair Bolsonaro ahead of Brazil's October election after another center-right candidate quit the race, according to a new poll on Monday.

The opinion survey, run by Instituto FSB with sponsorship from investment bank BTG, found that 46 percent of voters support Lula, up from 41 percent in April. Support for Bolsonaro was unchanged from a month ago at 32 percent in the survey.

In an expected second-round run-off between the two men, Lula would gain 54 percent of the votes and Bolsonaro 35 per-

The rejection rates for both Lula and Bolsonaro remain virtually unchanged, with 43 percent of voters saying they would never vote for the leftist Workers Party leader and 59 percent saying they would never vote for the far-right incumbent.

The FSB research institute interviewed 2,000 voters by telephone between May 27 and 29 in the poll commissioned by BTG Pactual bank. It has a 2 percentage-point margin of error.

China steadily promotes rural water infrastructure construction

Israel signs major trade deal with Gulf state UAE

DUBAI

ISRAEL signed a free trade agreement with the United Arab Emirates on Tuesday, its first big trade accord with an Arab state and a move aimed at boosting trade between the two Middle East nations.

The pact was signed in Dubai after months of ne-

"Done," Israel's Ambassador to the UAE Amir duced legislation Monday to im-Hayek said on Twitter, replying to another tweet he posted earlier saying "the UAE and Israel will sign FTA in the next hour.'

President of the UAE-Israel Business Council Dorian Barak said the trade agreement defined tax rates, imports and intellectual property, which would encourage more Israeli companies to set up offices in the UAE, particularly in Dubai.

The council predicts there will be almost 1,000 Israeli companies working in or through the UAE by the end of the year doing business with South Asia, the Far East and Middle East.

"The domestic market doesn't represent the entirety of the opportunity. The opportunity is really setting up in Dubai, as many companies have, in order to target the broader region," Barak told Reuters by phone.

Ahead of the signing, Israel's economy ministry had said the accord would remove tariffs on food, agriculture, cosmetics, medical equipment and med-

Canada to freeze handgun sales, and ban look-alike toys

OTTAWA

CANADA'S government introplement a "national freeze" on the sale and purchase of handguns as part of a gun control package that would also limit magazine capacities and ban some toys that look like guns.

The new legislation, which resurrects some measures that were shelved last year amid a national election, comes just a week after a gunman killed 19 children and two teachers in their classroom in Uvalde, Texas.

Prime Minister Justin Trudeau told reporters the new measures were needed as gun violence was increasing.

"We need only look south of the border to know that if we do not take action firmly and rapidly it gets worse and worse and gets more difficult to counter," he said.

The handgun freeze would contain exceptions, including for elite sport shooters, Olympic athletes and security guards. Canadians who already own handguns would be allowed to keep them.

Authorities do not expect a run on handguns in anticipation of the freeze, in part because they are so heavily regulated already, an official said in a briefing.

Canada has stronger gun legislation than the United States, but

while its gun homicide rate is less than one-fifth the U.S. rate, it is higher than that of other rich countries and has been rising. In 2020, it was five times Austra-

The rates in 2020 and 2017 respectively were the country's highest since at least 1997, according to Statistics Canada

Canada banned the sale and use of some 1,500 models of assault weapons, like the AR-15 rifle, two

years ago in the wake of a mass shooting in Portapique, Nova Scotia - a move some firearms owners say they are contesting in court. Speaking alongside Trudeau, Public Safety Minister Marco Mendicino confirmed the "imminent launch of the initial phase" of a program to buy back and compensate owners of such weapons.

While the Liberals have a minority of seats in Parliament, the legislation could pass with the support of

the left-leaning New Democratic Party.

The planned legislation would prevent anyone subject to a protection order or who has engaged in domestic violence or stalking from obtaining or keeping a firearms license.

It will also require long-gun magazines to be permanently altered so they can never hold more than five rounds and will ban the sale and transfer of large-capacity magazines.

The new laws would also ban some toys that look like real guns, such as airsoft rifles. Last week Toronto police shot and killed a man carrying a pellet gun. read more

"Because they look the same as real firearms, police need to treat them as if they are real. This has led to tragic consequences," Justice Minister David Lametti told reporters.

Tom Stamatakis, president of the Canadian Police Association, welcomed some of the moves, such as the "red flag" provisions in the case of domestic violence, and said he would like more information on enforcement and resources for measures such as the handgun

He completely supported a crackdown on fake guns, which he said were a "big chal-

"You cannot distinguish between what's a replica firearm and what's a real firearm, particularly when these incidences involving replica firearms occur often in very dynamic, quickly evolving circumstances."

Rod Giltaca, the head of the Canadian Coalition for Firearm Rights, said the handgun freeze was "absurd."

He said authorities were not using the tools they already had to tackle gun violence, such as calling people listed as references on gun license applications.

The Finals matchup: Celtics vs. Warriors for NBA title

SOMEWHERE, Gregg Popovich must be

Ime Udoka and Steve Kerr played for Popovich with of the San Antonio Spurs, both served as assistant coaches under him, and neither makes any effort to hide the affinity they have for the NBA's career victory leader.

And now, Udoka and Kerr are about to go head-to-head – in the NBA Finals.

The title matchup is set: It'll be Udoka and the Eastern Conference champion Boston Celtics facing Kerr and the Western Conference champion Golden State Warriors, a series that begins Thursday night in San Francisco. The teams split their two regular-season meetings, each winning on the other's home floor.

The Warriors have been waiting for an opponent since this past Thursday after needing only five games to beat Dallas for the West title. The Celtics got there the hard way, winning Game 7 in Miami on Sunday night to capture the East. "We stayed with it. We believed in each other. We made a commitment on the defensive end," said Celtics forward Al Horford, who, after 141 playoff games, is headed to the NBA Finals for the first time. "That was the biggest thing, defending."

For the Celtics, it's a chance at an 18th NBA championship - which would break the tie with the Los Angeles Lakers for the most in league history. For the Warriors, it's a chance at a seventh crown - which would break a tie

with the Chicago Bulls for third-most in league history. It's also a rematch of the 1964 finals, when Bill Russell and the Celtics topped the Warriors in five games.

"I've said it many times: You go to the finals, it's almost a two-month journey filled with stress and fatigue and everything else," said Kerr, who gave his team Friday and Saturday off before bringing them back to work Sunday. "So, if you can get a little bit of a break, it's very meaningful. Hopefully, we can get healthy and have a few days of really good prep and be ready to go on

Golden State won at Boston 111-107 on Dec. 17, behind 30 points from Stephen Curry. The Celtics rolled on Golden State's home floor in the rematch on March 16, winning 110-88 in the game in which Curry injured his foot – and that's

where his regular season ended. Curry was ready to go for the playoffs. So were the rest of the Warriors. They're 12-4 in the playoffs, getting through Denver, Memphis and

Dallas to get to the title round. "It all starts with Steph," Kerr said.

Udoka has a chance to become the 10th coach to win a title in his first season. El Moutaraji double gives Wydad **African Champions League title**

CASABLANCA

WYDAD Casablanca winger Zouhair El Moutaraji scored both goals as they claimed African Champions League glory with a 2-0 victory over holders Al Ahly in the final at a raucous Stade Mohammed V on Monday.

Wydad celebrated a third continental crown after triumphs in 1992 and 2017 as they denied Ahly a record third straight title after El Moutaraji scored his first with a thunderous long-range strike and grabbed a second from close range.

The goals sent the home fans into raptures, with the final controversially staged at Wydad's stadium after the Confederation of African Football said Morocco was the only bidder, Senegal having withdrawn their application.

Ahly failed in a bid to have the match postponed and moved to a neutral territory after their appeal to the Swiss-based Court of Arbitration for Sport was turned down last week.

Ahly's loss is more disappointment for Egyptian football in 2022 after the country were beaten by Senegal in the Africa Cup of Nations final in Cameroon and then lost to the same team in the playoffs for a place at this year's World Cup in Oatar.

Wydad gave an early warning to the visitors when striker Guy Mbenza struck the bar with a powerful shot from the edge of the box.

They then took the lead after 15 minutes as El Moutaraji picked up the ball 30 meters from goal and unleashed a superb strike into the top corner that gave Ahly goalkeeper Mohamed El Shenawy no chance

The Egyptians were rushed in their passing and coughed up possession too easily but looked dangerous from set-pieces and should have equalized when defender Yasser Ibrahim headed wide from a corner.

That might have turned the contest in their favor, but Wydad doubled their advantage three minutes into the second half when El Moutaraji stole in ahead of ballwatching Ahly defender Mohamed Hany at the back post.

His initial shot was saved but he lashed home the rebound.

Ahly tried to claw their way back into the game and forced a number of saves from Wydad keeper Reda Tagnaouti, but their night ended in disappointment despite the fact they dominated possession and looked the more enterprising of the two teams.

UEFA commissions inquiry into UCL final fiasco

PARIS

UEFA has commissioned an independent inquiry into the events which led to the delayed kickoff at the Champions League final between Liverpool and Real Madrid in Paris, including supporters being sprayed with tear gas by riot police outside the Stade de France.

Senior French politicians said on Monday that between "30,000-40,000 fake tickets" were a central factor in the disorder outside the stadium, which led to thousands of Liverpool fans being held in large crowds while waiting to enter via the turn-

UEFA also claimed on Saturday that the late arrival of supporters was another contributory factor to the delayed kickoff -- an allegation rejected by Liverpool, who demanded an inquiry over the weekend.

Many supporters and others present at the game have contested the claims by the French authorities and UEFA, with the UK government backing Liverpool's call for an

And UEFA has now confirmed that Dr. Tiago Brandao Rodrigues, a Portuguese politician, will compile an independent report that will spell out what happened in Paris and why.

In a statement, UEFA said: "UEFA has today announced it has commissioned an inresponsibility and behaviours of all entities involved in the final.

"The report will be independently com-

Messi: 'No doubt' that Benzema deserves to win Ballon d'Or

ACCORDING to Lionel Messi, there is "no doubt" that Real Madrid striker Karim Benzema deserves to win his first Ballon d'Or award this vear.

Messi has won a record seven Ballon d'Or awards as the world's best player, but saw his

new club Paris Saint-Germain eliminated by Madrid in the round of 16 of the Champions League this year – after Benzema scored a hat trick in the second half of the return leg.

Benzema netted another four goals against Chelsea in the quarterfinals and three against Manchester City in the semifinals – including the decisive penalty in extra time of the second leg – before Madrid defeated Liverpool 1-0 in the final on Saturday. Benzema was also the top scorer in the Spanish league as Madrid won the title in dominant fashion. "There's no doubt, its very clear that Benzema had a spectacular year," Messi said in

an interview to Argentine TV channel TyC Sports when asked if Benzema should get the prestigious award. "I think there is no doubt this year." In total, Benzema scored 44 goals in 46 matches with his club this season, and equaled

Madrid great Raúl González as the club's second-highest scorer with 323 goals. Cristiano Ronaldo leads that tally with 451. While Madrid knocked out a quartet of European giants on their way to the Champions

League title, Messi wasn't overly impressed with the team's style of play. Madrid needed big comebacks against both PSG and Man City and had Benzema to thank both times.

"Out of the blue they score against you, and the match changes automatically," Messi said about this Madrid team. "Madrid was not the best team in this Champions League,

The 34-year-old Messi is training with Argentina in Bilbao for the "Finalissima" – a

friendly between the Copa America winners and European champion Italy on Wednes-Messi could find himself going up against Benzema again at the World Cup in Qatar this year - both Argentina and France are among the main contenders - but insisted that

After winning Madrid another Champions League, Courtois deserves respect

IN the end, the Champions League final between Liverpool and Real Madrid was all about Sergio Ramos - again. And he'll love that.

Liverpool's second shot at Los Blancos in the ultimate club final in the space of four years was supposed to be about what Mohamed Salah craved: revenge. It would be payback for the moment in 2018's final in Kyiv when Ramos hauled him down to prevent a breakaway that threatened to give Jurgen Klopp's team the lead, a decision that ended in the Egypt striker dislocating his shoulder and being led, tearfully, from the pitch in the 30th minute of what became a 3-1 defeat.

In the end, 2022's final in Paris was actually all about what Real Madrid goalkeeper Thibaut Courtois wanted: not simply victory, but for his iconic moment in a Champions League final to date - a full-length left-to-right dive that failed to stop Ramos' brilliant added-time header from sneaking into the postage-stamp space between his fingertips and the right post of Atletico Madrid's goal in the 2014 final in Lisbon - to be erased from memory. That night, Los Rojiblancos went from 1-0 up with seconds remaining to a 4-1 thrashing in extratime. Courtois couldn't live with that image defining him.

Both men wanted to shake Ramos from their Champions League final pain. Salah couldn't; Courtois could - and did. The Belgium goalkeeper produced a majestic evening in the umpteenth match this season, across all the competitions in which Madrid competed, when a rival left the pitch thinking: "Why didn't we win that? How does Courtois do those

After the match on Saturday night, Courtois told Spanish media in the mixed zone: "Desire is what really makes the difference in a big final like this. The key is having repeated to myself, 'Today is my day. This is what I've worked for. Today I'm going to win this trophy. I will not lose another final.' So to make that happen is a fantastic feeling."

The strange thing is that, if you asked dedicated Real Madrid fans whether this was Courtois' best game, either since joining from Chelsea in 2018 or even over the past two seasons, many would stop, ponder and name days when he has been more crucial to Los Blancos' winning. But beauty is in the eye of the beholder, and many others will claim that the occasion, pressure, rival and trophy at the end means Saturday's performance was his zenith.


However, Courtois thinks he has been at his best level for the past two seasons. Earlier this term he admitted, ruefully, that it seemed his own evaluation didn't seem to count for much, that Madrid finishing trophyless in 2020-21 had obscured how superbly he'd played every week.

Rueful then, angry later when U.K. football magazine FourFourTwo usually considered intelligent and reliable -- published their ranking of goalkeepers around the world and, ludicrously, didn't place Courtois in the top 10. For anyone who knows anything about football, it was a complete aberration from the word "go." Nevertheless, a small seed for the magic Courtois produced to deny Liverpool in Paris on Saturday was planted.

Not long after the issue was published in March, Madrid's keeper gave an interview to Miguel Serrano TV and, when asked about it, said: "These people only show themselves up. Everyone is entitled to their opinion, and I'm not claiming that I'm first, second or third, but if neither I nor [Gianluigi] Donnarumma are in this top 10, then something's gone wrong. What happens is that, later, you find that it's people like this often get a vote in football's individual prizes, and it's then they confirm that they've really got no idea at all."

NFL legend Tom Brady - maybe you've heard of him - held a totally different view and launched a cross-Atlantic barb of his own. The Tampa Bay Buccaneers quarterback, inarguably one of the great sportsmen of

all time, in any sport, sent Courtois a signed shirt with the inscription: "Thibaut -- the best goalkeeper in the world!"

That's the context required to understand why Madrid's man of the match, in his first on-pitch interview after beating Liverpool 1-0, said: "Today, I needed to win a final -- for my career, for all the hard work, to put respect on my name because I don't think I have enough respect, especially in England. I saw a lot of criticism that I was not good enough or whatever."

Later, he added: "I said at the press conference on Friday that when Madrid play in finals, they win. I then saw a lot of tweets saying I would get humbled. It was the other way round. Liverpool were very strong today. I think I played a great game, and that was the difference.

In FourFourTwo's ranking. Aaron Ramsdale (Arsenal), Jose Sa (Wolverhampton Wanderers), Unai Simon (Athletic Club), Yassine Bounou (Sevilla), Jan Oblak (Atletico Madrid) all were named ahead of the man who has won 15 major trophies; played for Atletico, Chelsea and Madrid; and finished third at the 2018 the World Cup. Are you surprised it stung him? That he stored it and used it as motivation?

And then those who curate the list of candidates for the Yashin Trophy, the Ballon d'Or for keepers, didn't include Courtois either. In the voting for the 2021 award, he came in eighth, unbelievably enough, behind such luminaries as Aston Villa's Emiliano Martinez, Leicester's Kasper Schmeichel and Oblak - the Atleti keeper notoriously going through the worst form he has shown since moving to Spain eight years ago.

If you haven't been watching Madrid this term, then let the statistics guide you. Courtois needed to make 59 saves (more than anyone else) to win the Champions League and pulled off about 100 more than that in order to hand Madrid the LaLiga title. Remember, this is only the second time Los Blancos have managed to become champions of Spain and Europe at the same time since

Forwards Karim ma and Vinicius Junior, with more than 100 goals and assists between them this season, have caught the eye more. Midfielder Luka Modric has a tendency to do very special things on big occasions, too, but Courtois has been Madrid's

past two seasons. His middle names are Nicolas Marc, but if there were any justice in the world, they should be Notoriously Magnificent.

When he eventually looks back at his exploits at the Stade de France, I'll wager you that he rates the firsthalf save from Sadio Mane, with the scores level at 0-0, as his best technically. Against a raging drive, Courtois' fingertips did what they couldn't quite do in Lisbon eight years ago and tipped the ball onto the post. He quickly followed that up by leaping to his feet and pouncing on a loose ball in the 6-yard box before Salah could touch it into the

Then, I'd guess, he'll say that the second-half save from Salah was the most vital. There were nine minutes of normal time remaining, he'd already thwarted the Egyptian (twice) and Diogo Jota, but a goal at that stage, and Klopp's "mentality monsters" would not simply gain scoreboard parity, they'd have crucial momentum to go with their relentless attacking

Salah made good on his threat with a cannon of a shot that erupted off his right boot. How Courtois deflected it wide when the ball hit the top edge of his right arm, rather than getting a solid hand on it, we can only marvel at. Not only did it keep Madrid ahead, and effectively seal their 14th Champions League win, it caused two iconic images that, now, can erase that of Courtois' despairing and futile full-length dive as Ramos scored past him in 2014 with Atletico smelling the trophy.

Salah, on seeing the ball ricochet violently off to the right and out for a corner kick, sank to his knees in disbelief and despair. David Alaba, already a double Champions League winner with Bayern Munich, showed just what the split-second brilliance meant to him by leaping, like a child with his dad, fully into Courtois' arms and wrapping his legs around the Belgian's torso. Disbelief from Salah; utter, rampant relief from Alaba. Magic.

What competed with Courtois' nerve, physical size, mentality, decision-making and will to win in Paris on Saturday was his agility. For most of his important saves, he was throwing himself left or right to defend efforts destined for the lower corners, a feat that's vastly difficult for a 30-year-old who is 6-foot-7 -- or at least it should be.

Earlier this season, this phenome-

nal competitor, whose parents were both top-level volleyball players and who was himself tempted to dump football for the sport of his mum and dad, explained: "I played volleyball every summer, beach volleyball with my parents. In terms of reflexes, even at a young age I loved to jump and dive on the floor. I think that a volleyball player who is two metres tall has to drop to the ground very quickly, he has to have a good spring, he has to follow the trajectory of the ball well when the setter passes to him. I'm fast for someone who is two metres tall. Maybe it's my parents' genes, but it might also come from volleyball."

Real Madrid fans can be grateful for those formative years. Grateful, too, for the patient his mum happened to be treating when Courtois was an impressionable kid.

"My mum is a physio, and she was treating someone who would travel to watch Madrid play two or three times every season. He was a massive fan," Courtois told UEFA. "I already admired and followed Iker Casillas at that time, but this guy brought me back a Real Madrid flag, one of Casillas' shirts, too -- stuff like that. My mother wasn't really a football fan but since I was with my mum at work quite a lot, I heard lots of stories about Real Madrid and so I liked Los Blancos more and more thanks to that coincidence."

That's how it started way, way back, but this is how it started at the beginning of this Champions League season: Madrid went to San Siro on Matchday One against Simone Inzaghi's Inter Milan. The reigning Italian champions were fitter, faster and feeding off the home crowd's rabid desire to teach Carlo Ancelotti's team -- remember, he's an AC Milan legend -- a lesson. Madrid were under pressure. Edin Dzeko threatened to score time and time again, but Courtois masterfully denied all the Nerazzurri players before Rodrygo popped up with a goal to make it 1-0.

"We faced a keeper that it's really very difficult to score against," Inzaghi said that night. On Saturday night, Klopp justifiably said: "Courtois made three worldclass saves."

Praise, appreciation and a Champions League trophy lift, at last, for a keeper who isn't simply the best at his job anywhere in the world right now - and has been on and off throughout his entire career -- but is, arguably, among the best three or four footballers, at any position, anywhere in football. Let the Ballon d'Or awards this year match the reality of the situation for Belgium's big, bold, brash and utterly brilliant Spanish and European champion. Benzema is the clear winner, but Courtois should be second. Time to put things right there as well.

President Samia eyes Tanzania's bid for hosting 2027 AFCON tourney

PRESIDENT Samia Suluhu Hassan has said she will be at the forefront of ensuring that Tanzania meets the criteria for having six stadiums that will qualify for hosting the 2027 Africa Cup of Nations tourna-

The President made the statement at the State House in Dar es Salaam yesterday at a ceremony for the World Cup trophy tour.

Samia said to host the AFCON tournament, Tanzania must have six stadiums with the country already having three.

She said so far Tanzania has three stadiums, namely Benjamin Mkapa and Uhuru located in Dar es Salaam, and Aman Stadium located in Zanzibar.

"To host the AFCON tournament, we must have six qualified stadiums, so far we have three, and we need to get three more so, in that case, I will cooperate with the Ministry of Culture, Arts, and Sports to ensure we get other stadiums," she said.

"So far we have been assured of having one stadium after two companies, including Coca-Cola and another, to support the process of getting a fourth stadium, but we also need to get hotels and infrastructure to host the 2027 AFCON tournament," President Samia

The President said she commended the Ministry of Culture, Arts, and Sports for fighting to ensure that the country gets a chance to host the CAF Ordinary General Assembly, to be held in Arusha in August.

She asked the ministry to use the opportunity to promote the country and trade by feeding visitors Tanzanian food.

"I would like to attend the assembly that will bring together football officials for CAF, FIFA, and other football bodies, we should pray that I do not have other responsibilities during those dates," President Samia stated.

She said the arrival of the World Cup in Tanzania should be a catalyst for players and football stakeholders to do better in the game of football.

She stated: "This is a special day to host the World Cup tour, I'm glad to see Juliano Belletti, who has won the World Cup, I'm

happy that the World Cup has arrived here ahead of its trip to Qa-

"The women's and youths teams have been doing well in sports, this trophy should encourage us to prepare our youngsters to do well,"

"We are happy to receive the trophy and I urge the youths to come out in large numbers to watch it and take pictures with it," President Samia stated.

Coca-Cola Kwanza Company Director, Unguu Suley, said that the firm would like to thank President Samia Suluhu Hassan for hosting the World Cup.

"This is an important history for us, eight years have passed since the World Cup came to this country, and you are the first female President to receive this trophy, in the one year of your leadership there has been a lot of success in the game of football," Suley noted.

Simba SC announces coach Pablo Franco Martin's departure

PABLO Franco Martin is out as Simba SC's head coach after just six months in charge, the outfit announced in Dar es Salaam on Tues-

Simba SC and Martin have mutually agreed to part ways, per the team's

Martin was appointed as Simba SC head coach on November 6, 2021, taking over from French coach, Didier Gomes da Rosa, who was sacked alongside his assistants following the outfit's shocking CAF Champions League first preliminary round exit in the hands of an unfancied Botswana side, Jwaneng Galaxy FC.

The expectations were high for the former Real Madrid assistant coach who joined Simba SC from Kuwait side, Qadasia SC, last year.

However, Simba SC is poised to finish second in the NBC Premier League this season, trailing age-old rival Yanga by 13 points with five games to go.

Simba SC advanced from their 2021/22 CAF Confederation Cup which contained eventual winners, Morocco's RS Berkane, and ASEC Mimosas of Ivory Coast but failed to go past South Africa's Orlando Pirates in the quarterfinal stage.

Following a day dominated by speculation around his future, the 41-year-old's fate has been con-

In a club statement signed by the Chief Executive Officer Barbara Gonzalez, Simba SC confirmed parting ways with the Spaniard and fitness coach Daniel De Castro Reyes.

Assistant coach Suleiman Matola will be the caretaker coach until the end of the season.

The side revealed in the release: "Simba Sports Club has reached an agreement to mutually part ways with our head coach, Pablo Franco Martin."

The release noted: "We thank coach Pablo for the success achieved during his tenure with the club as he won the Mapinduzi Cup, and reached the quarterfinal of the CAF Confederation Cup."

"In his absence, the team will now be under coach Matola until the end of the season."

"Furthermore, the club has reached a mutual agreement to part ways with our fitness coach Daniel De Castro Reyes.'

This comes after Simba SC conceded a 1-0 loss to the age-old rival, Yanga, in this season's Azam Sports Federation Cup semi-final match which took place in Mwanza last weekend.

The results prompted club honorary president and investor, Mohamed Dewji, to declare this is their worst campaign in five years.

"This has been the worst season for Simba SC in the last five years, the board needs to make tough decisions on the way forward," Dewji tweeted on Saturday after the derby

"We need to overhaul our team and strategy and go back to the drawing board. We lacked motivation, passion, and hunger to win trophies this year."

Dewji revealed: "Overall the last five years have been a success for Simba SC, our budget has increased five times, we have won many trophies locally and have made a mark in the continent reaching three quarterfinals in Africa competitions... I can proudly say we are among the top 12 African clubs."
