## gone as 1,042 households leave

PRESSURE on the Ngorongoro Conservation Area (NCA) had diminished somewhat after 1,042 households with 6,461 family members with 29,919 head of livestock relocated from the zone to various villages.

Richard Kiza, CEO for the Ngorongoro Conservation Areas Authority (NCAA) said while presenting a three-year report from 2021 to the start of 2024 at a press conference in Dar es Salaam yesterday on relocation trends in the zone.

The families relocated to Msomera village in Handeni district and Saunyi village in Kilindi district both in Tanga region as well as Kitwa B village in Simanjiro district in Manyara region.

Relocating families were each compensated with a 2.5 acre of land and 10m/- inducement cash for those moving to Tanga

## 30,000 livestock TRC starts SGR trials with cautious speeds

THE Tanzania Railways Corporation (TRC) yesterday started trial journeys on the standard gauge railway (SGR) electric train from Dar es Salaam to Morogoro.

TRC director general Masanja Kadogosa told journalists after arrival that the train spent more than three hours contrary to the projected time of two hours when operations actually start.

The train left Dar es Salaam at around 9:40am and arrived in Morogoro at 12:45pm., with the South Korean-made train cruising between 50 and 130 kilometres per hour.

The first trial trip avoided reaching speeds of up to 160 kilometres per hour, with the TRC CEO explaining that it was vital to take precautions during trials, as proper operations haven't yet been permitted by the responsible authorities.

At a future moment the Land Transport Regulatory Authority (LATRA) will conduct an assessment to allow that trains cruise at 160 kilometres per hour, he specified.

The trials started in a series to ensure all the systems such as electrical circuits, signalling and breaks function properly, ready for

There are also comfortable hotel facilities in case one wants to take a rest," he further stated, while TAWA board chairman Maj. Gen, (rtd) Khamis Semfukwe earlier said that upwards of 15 cruise ships are expected to anchor at Kilwa in the course of this year.

### TRC starts SGR trials tied to cautious speeds

TRC to start SGR operations when the testing is over and it is commissioned, he said.

Starting the trials is tied to an implicit schedule directed by President Samia Suluhu Hassan to ensure that operations commence by June, he said, explaining that the locomotives test was successful.

TRC has now started testing four passengers' coaches, while testing the remaining wagons follows until it is ascertained that all the systems function properly, he said.

Testing of coaches from Dar es Salaam to Dodoma will

continue in the second week of March, he said, noting that TRC has sufficiently trained local technicians to operate the trains. The first batch of 167 technicians despatched to five countries had returned, thus having 20 locomotive drivers and over 200 electrical circuits,

signals and telecommunication technicians, he said.

TRC is set to despatch 80 engineering cadets of different cadres for training, the first set in electric multiple unit (wagons) cadets coming back next month, he said.

TRC started testing its first

electric locomotive on January 10 after it was delivered from South Korea, following a contract award in July 2021.

TRC awarded the South Korean manufacturer a 335·4bn won contract to supply 17 four-axle 25 kV 50 Hz electric locomotives and 10 EMUs, he added.

each are meant for holding diesel, five similar tanks will hold petrol, three such other tanks are reserved for jet fuel and one tank stayed for interface process-

The project was drawn up in 2015 and adopted in 2017 but its implementation was delayed due to various reasons, even as it promises substantial benefits to the government and oil traders, he said.

"We have struggled for more than ten years to start this project. Today, we are going to write a new history in our nation because this project was announced many years ago but its implementation never took place. It is a project of great benefit to our country in the oil transportation sector," the minister declared.

Completion of the project will help prevent losses from demurrage charges for delays in fuel unloading, as upwards of \$25,000 was being paid daily for a loaded ship, adding to \$0.25m monthly.

He urged the TPA management to build a wellequipped dock at Kigamboni area to keep up with the pace and size of the port. The current dock at Kurasini is insufficient and does not meet port standards and operations, he specified.

The Kurasini dock is small considering the scale of fuel operations, hence the need for a fuel unloading dock, he said, noting that ships stay for a long time, resulting in inefficiency and lack of productivity in fuel

TPA needs to ensure the implementation of the project by overseeing it on the basis of the contractual timetable, thus investment value for money, sparing the government additional costs in the case of contractors requesting extension for project implementation, he emphasised.

TPA director general Plasduce Mbossa said that the project will also reduce demurrage charges in cutting unloading time to be aligned to the Tanzania Zambia Oil Pipeline (TAZAMA), taking 48 hours to unload oil at the single point mooring (SPM).

"In other words, there will be an average saving of eight days, which is equivalent to \$ 0.2m as this cost affects pump prices, hence reducing fuel prices, diminishing the fuel crisis and cutting complaints among fuel companies" he elaborated.

The project will also strengthen fuel storage by ensuring sufficient fuel reserves, sorting out the 15 days oil storage limit at present, enhancing confidence among oil exporters as they can store their fuel in the port tanks, he said.

Deus Sangu (Kwela), the Public Investments Committee (PIC) chairman in the National Assembly, urged TPA to put up an emergency dock for ships, suggesting that the port can be a shipping and storage hub for neighbouring countries.

The Endline Evaluation (EE) aims to independently assess the progress of the current Strategic Plan (2019-2024), providing insights, lessons learned, and actionable recommendations. It evaluates the strategy's relevance, effectiveness, and efficiency within the country context.

#### Specific Objectives of the assignment

PURPOSE AND SCOPE OF THE EVALUATION



### Programme bolsters food security, eases starvation in northern regions

A Norwegian Agency for Development Cooperation (NORAD) programme to eradicate hunger, has significantly contributed to improve food security and reduce malnutrition in three regions of Kilimanjaro, Arusha and Manyara.

A Nansen project is a grant program funded by NORAD collaboration with the Norwegian Church Aid (NCA) with the aim of enhancing food security and alleviating hunger in the regions.

Speaking during the official visit by NCA to the project areas, Project Officer, Rev Andrew Munis from Evangelical Lutheran Church (ELCT) Northern Diocese said that the efforts focused on bolstering local climate resilient food produc-

"We are also focusing on fostering an increase in local value creation and boosting incomes for food producers," he explained.

Rev Munis added that through the grant which officially started June last year, they have been able to reach and support a total of 1,963 farmers from various villages.

He added that, through the project, 80percent of farmers have been economically empowered and helped to reduce Gender

Based Violence (GBV) cases, and 115 youth are employed.

Jamila Juma, one of the beneficiaries of the Nansen project from Endasaki village in Babati Rural District said that the project has helped them to get a drip irrigation system, good seeds, fertilizers, pesticides and agronomist support from NCA.

She explained that in the first phase of farming they managed to harvest 860 kg of maize, 330 kg of beans in a quarter acre area, where 660 kg of maize were sold at 660,000/- and 240 kg of beans were sold at 600,000/-, making the total 1.26m/-.

"We got many other benefits including buying one dairy cow and two goats, also each group member got a ration of 90kg of corn and beans, thus helping us to have food security in our families," Jamila explained.

She said they also planned to dig a water well to increase the access to sufficient water all the time and also to increase the production area in order to produce more.

NCA Advisor Karianne Jensen stated that the aim of the grants is to limit some of the negative consequences of the Ukraine war, increasing food security, nutrition and improving the livelihood of

### Bashe mulls creating agro-finance policy for farmers access soft loans

MINISTER for Agriculture Hussein Bashe has underscored the need to come up with a special agro-finance policy in order to enable farmers to access soft loans and improve their projects.

Bashe made the suggestion at the weekend here during the launch of Tanzania Agriculture Development Bank (TADB) branch, which will serve three regions of Tabora, Kigoma and Katavi.

According to him, it is important to have a special policy to promote financing of agricultural projects instead of the current situation where farmers have to seek for the loans in commercial banks which also have high interest rates.

"This will greatly improve productivity in the farming sector pulling farmers out of poverty," he said.

He added: "In our country, there are loans of over 20trn/- which are issued but only 10 percent go to the farming sector, I have already discussed this with the Finance Minister and the Central Bank governor, and I'm also seeking time to write to the Minister for Planning," he said.

Bashe said that it is not possible to see the farming sector grow to achieve intended goals, without having robust strategies to finance the sector.

He said that the government under President Samia Suluhu Hassan works hard to lift up the sector and improve the lives of farmers which include construction of modern irrigation infrastructure and expanding TADB services in order to bring agricultural transformation.

"After all these improvements, farmers will need funds to procure inputs. So it is important to have this policy in place to ensure that farming, livestock and fishery projects capitals," he said.

TADB Managing Director, Frank Nyabundege noted that until February, this year, TADB has enabled farmers and livestock keepers by providing loans worth 19.599bn/in the region of Kigoma (7.209bn/-), Katavi (2.394bn/-) and Tabora (9.996bn/).

"These loans have been granted for projects of rice, palm, bean, corn, cattle fattening, ginger, chicken, pig and sheep. The bank continues to put in place solid lending strategies for tobacco, cotton and honey crops, as these crops contribute to developing the economy of the regions," Nyabundege said.

Hussein Buchunguka, vice chairman of the Kigoma Cooperatives Forum thanked the bank for its great contribution to empowering farmers to purchase machinery for palm oil processing.

## Ierchants near conservancies want more education on natural resources protection

TRADERS doing business near national park corridors have asked the government to provide them with natural resources conservation education in order to prevent humanwildlife conflicts (HWCs).

The traders urged environmental and natural resource conservation experts to equip with the essential education which will also bar illegal wildlife trade.

Speaking at a stakeholders

meeting during the weekend here, Evaluna Kivunajabei, a beekeeper at Mafyeko ward in Chunya District said that human-wildlife conflicts and illegal trade do not only affect surrounding residents but goes further the country's economic

development. The meeting which brought both public and private sector stakeholders meant to discuss sustainable investment and controlling the illegal wildlife

"It is important for experts from the national parks to train entrepreneurs and residents living near the working in the areas on how to conserve and protect natural resources," Evaluna said.

She said that in the area where she comes from, there are many beekeepers and entrepreneurs of bee products who are doing their activities in protected areas but they do not have enough knowledge about the conservation of natural re-

Upendo Christian said that as she conducts her beekeeping and honey production in variit was important for her to get more education on forest conservation.

"We have been conducting various activities to generate income and that some entrepreneurs do not have enough understanding about the conservation of natural resources, a situation that makes them do things that affect the resources," she explained.

Dr Elikana Kalumanga, Private Sector Engagement Manager with USAID's Tuhifadhi Maliasili project said they have

### Govt to come up with local content policy to empower local contractors

THE government is soon expected to launch a local content policy for local contractors that will aim at empowering and supporting locals in the country.

Minister for Works, Innocent Bashungwa unveiled this yesterday in Dar es Salaam when speaking at the 21st anniversary of the Structured Engineers Apprenticeship Programme (SEAP).

The minister tasked the Tanzania National Roads Agency (TANROADS) to come up with favourable tender conditions for local contractors that will allow

the participation of more local contractors to compete in tender projects.

"I want to see TANROADS doing away with conditions like setting up huge securities, or turnover on tenders that bar local contractors from competing tenders," he

According to him, many projects also were not favourable for local contractors because roads projects being tendered for had long kilometres that hinder local contractors' capacity to compete.

"I want to see these roads cut into smaller portions of 10km or 20 km to allow local contractors participation. I have already had talks with the African Development Bank on this and they have assured me for a closer collaboration on the matter," he said.

He tasked the Engineers Registration Board (ERB) and Contractors Registration Board (CRB) to team up so as to remove several challenges faced in many projects in the country.

Bashungwa said through collaborative work, the two entities will ensure smooth implementation of projects while at the same time ensuring more qualified professional engineers who are behind the implementation of various projects.

The 21st anniversary of the SEAP programme will also see the funding of the third phase of the apprenticeship programme from 2024 up to 2034.

Bashungwa acknowledged the support of the Norwegian government, the World Bank and African Development Bank (AfDB) for supporting the SEAP programme to groom more professional engineers.

He said it was not right to see that over sixty years after independence, Tanzania should still have resident engineers and consultant engineers.

Registrar of the Engineers Registrations Board (ERB) Benard Kavishe said SEAP programme has helped to increase the number of female engineers from 3-percent in 2003 to 14- percent this year.

He said this programme is designed to equip female engineering graduates with practical knowledge and experience to become professional engineers.

ERB Board chairman Menye Manga hailed the support of the Norwegian government for its continued support as the SEAP programme enters its third phase.

The ERB Board chairman said at its inception in 2003, they had registered 3 percent of women engineers but the number has now increased to at least 14 percent, this year.

He said the Board is considering commencing the School of Professional Engineers (SOPE) in order to feel the gap of professional resident engineers in various undergoing big projects in the country.

The meeting also witnessed over 300 engineers taking oath as registered engineers having completed three years of their apprenticeship programme.

### **Summit in Nairobi addressing biodiversity** loss and pollution as environmental crises

THE world's most powerful UN environmental decision-making body started its sixth session here yesterday.

The United Nations Environment Assembly (UNEA-6) comes at a time when the world faces a "triple planetary crisis" of climate change, biodiversity loss, and pollution and waste.

Leila Benali, the president of UNEA-6, acknowledged the challenging circumstances, said: "We are living in a time of turmoil." She said the current turbulent times marked by escalating conflicts and geopolitical tensions call for the urgent need to restore trust in multilateralism and humanity.

"Our response here in UNEA-6 must demonstrate that multilateral diplomacy can deliver," she added, urging the participants to "restore trust in multilateralism, and humanity.'

Inger Andersen, executive director of the United Nations Environment Programme (UNEP), echoed this sentiment in her opening remarks.

"The world is watching and we need that unity to safeguard planet

Andersen urged delegates to focus on measures that promote climate justice, enhance air and water quality, and strengthen ocean govern-

This year's assembly boasts a record number of attendees, including heads of state, ministers, and over 5,000 representatives from governments, civil society, and the private sector. The summit this year will also feature the voices of the younger gen-

eration, who issued a strong declaration at the Youth Environment Assembly just a week ago. The week-long (5-day) assembly will tackle a range of pressing envi-

ronmental issues through 19 draft resolutions and two draft decisions currently on the table.

These resolutions aim to address various environmental problems such as transitioning to net-zero emissions, improving air and water quality, protecting oceans and marine environments, and building resilience to droughts and other climate-related disasters.

## ECOWAS lifts coup sanctions on Niger in new push for dialogue

The sanctions will be lifted with immediate effect, the president of ECOWAS Commission, Omar Alieu Touray said after the bloc's meeting in Nigeria's capital, Abuja that aimed to address existential threats facing the region as well as implore three junta-led nations that have quit the bloc to rescind their decision.

This week, one of the bloc's founding leaders and Nigeria's former military ruler, Yakubu Gowon, urged regional leaders to lift the sanctions, noting that the bloc is "more than a coalition of states (but) is a community established for the good of our people."

In the past year, however, the bloc has struggled to resolve the region's most pressing challenge: The Sahel, the vast, arid expanse south of the Sahara Desert that stretches which in turn has caused soldiers to depose elected governments.

The nine coups in West and Central Africa since 2020 followed a similar pattern, with coup leaders accusing governments of failing to provide security and good governance. Most of the coup-hit countries are also among the poorest and least developed in the world.

The sanctions against Niger and the threat of military intervention to reverse the coup were "the likely triggers to an inevitable outcome" of the three coun-

tries' withdrawal from the bloc, said Karim Manuel,

an analyst for the Middle East and Africa with the Economist Intelligence Unit.

With their withdrawal, "the West African region will be increasingly fragmented and divided (while) the new alliance between Mali, Burkina Faso and Niger fragments the West African bloc and reflects an axis of opposition to the traditional structures that have underpinned the region for decades," Manuel added.

## Discovering uses of free markets, integration enlivens talk on policy

REPORTS talk of residents of urban areas in Tanzania, most especially in the southern regions, demanding the lifting of controls currently in use so that traders can more comfortably import cheaper sugar - notably from Zambia and Malawi.

Admittedly, the people in question may not be fully aware of how the sugar sub-sector policy mirrors some of our failings.

The reason is that even this cry is intended to alleviate the current hardships and is not being made as a matter of principle, something that the Agriculture minister nearly went as far as admitting.

The good minister has recently declared that the government has protected sugar industries in the country for long enough - and that enough is enough.

It is reported that residents of the regions concerned want the government to temporarily lift customs rules applicable to sugar coming from neighbouring countries, just to ease the shortage.

Their reasons for the demand were clothed in official welfare considerations rather than competition and fair play, with the observation that acute shortage of sugar adversely affects daily consumption needs as well as trade and therefore development.

From their remarks, it would be discerned that were it not for the scorching shortages, most of the public would be at ease with those restrictions on sugar imports.

Why? The reason is the idea that when you hold back imports, you are doing a favour to local producers, and the person making that argument, or shouting approval for a political party arguing the same thing, doesn't realise that protection as such takes place at the expense of the consumer.

What is also absent in the policy

framework of the issue and indeed in public awareness is that the Common Market for Eastern and South-

ern Africa (COMESA) is tailored to

free movement of consumer staples

or supermarket goods.

But even the Southern Africa
Development Community (SADC),
where we are supposed to be active
members, has a reciprocal sugar
protocol dated 1996, when it was still
a free trade area.

Largely owing to weaknesses in relation to observing tenets of free trade - unlike under the Southern Africa Customs Union, where the rules are sharper - it was remodelled into SADC. Here governments choose the kind of cooperation they want

Had the sugar protocol started being applied here there would have been shortages all right, but plenty of the benefits due to periodic sugar crises and their political use would not be there either.

Early 2016 sugar imports were put on the bar and while debate continued on the pros and cons of doing so, people were paying for sugar at prices comparable to the present.

So, as people wait for solutions from the government rather than putting up policy demands, seven years later we are in the same rut. The said minister is tired of sugar protection yes, but then a cat has nine lives.

By the time the bills are placed before the legislature, if ever, the pain of shortages would have eased and people would be thanking the government for having put an end to traders hiking sugar prices, as there is no reflex on protected local sugar industries.

This view is tied up with our basic reflexes of independence and our automatic identification with what is national as opposed to what is foreign.



## Jane Goodall: 'I had to give up what I love best' at Gombe to inspire biodiversity conservation

AT almost 90 years old, Dr Jane Goodall, the world-renowned ethologist and conservationist, spends 300 days of her year travelling around the world, speaking to people about the urgency of animal conservation, biodiversity loss and climate change.

But despite being a Dame of the British Empire and UN Messenger of Peace, her fondest memories stem from her time in the Gombe National Park in Tanzania, learning about humans' closest living relative, the chimpanzee.

"I had to give up what I love best to try to save it. It's just one of those things," said Goodall, chuckling.

Goodall was speaking to Daily Maverick a few days into her South Africa trip, where she had already made appearances at events at Wits University, the JSE and at the Jane Goodall Institute's youth programme, trying to inspire those around her that there is still reason for hope.

Following a panel discussion with local researchers at the Origins Centre at Wits on Wednesday night, Goodall said: "Those were the best days of my lifebeing out in the forest, learning about the interconnection of all the species of plants and animals in the forest ecosystem."

Goodall said the reason she left was because she learnt about the true extent of deforestation in chimpanzee habitats across Africa at a conference in 1986.

"I went to that conference as a scientist, planning to spend the rest of my life probably studying chimpanzees in different areas, but I left as an activist," said Goodall at the event, which was in partnership with Oppenheimer Generations Research & Conservation and the Future Ecosystems for Africa programme.


Securing funding from National Geographic, Goodall then visited all six chimpanzee study sites in Africa, discovering not only the challenges faced by chimps but also the hardships of human communities surrounding their habitats.

"I visited the different chimpanzee sites to learn more about why chimpanzee numbers were dropping," said Goodall, explaining that she learnt about the bushmeat trade, the shooting of mothers to take infants to sell in the live animal trade and snares set by hunters.

"But I also learned a lot about the problems faced by so many of the human people living in and around chimpanzee habitat - the crippling poverty, the lack of good health and education facilities, the degradation of the land."

#### Community-led approach

Goodall established the Jane Goodall Institute (JGI) in 1977, a conservation organisation that uses a community-

communities to own the process of sustainable development and conservation.

Goodall realised early on the importance of not solely framing conservation around wildlife to locals, but showcasing how conservation can be beneficial for communities dependent on nature.

She said that from the very beginning, they went into villages, selected a group of seven local Tanzanians, who went and asked their community what they needed to make their lives better.

"They wanted to grow their own food, and for better education, especially for their children," said Goodall, "and so that's where we began.

"And gradually the people came to trust us... they came to see that, unlike other scientists who came, did their study and left, we stayed. We helped them try to get money so that we could introduce other things into the programme."

Since then the JGI has helped to improve health and education in all 12 villages around Gombe and has 25 offices worldwide.

Projects that help communities increase their income and rely less on the forest include community-managed micro-credit programmes, beekeeping and woodlot cultivation.

The latest thing the JGI has introduced is GIS mapping and satellite imagery, where volunteers from the different villages monitor the health of their forests.

"They're very proud of that village forest reserves - they were destroying them, but now they're saving them," said Goodalll.

"People have now become our partners in conservation. Before they resented people coming in like us. Now, they know that sav-

led approach, encouraging local ing the environment isn't just for communities to own the process of wildlife. It's for their own future."

#### Inspiring hope

Goodall says she is concerned by the many issues the world faces - from the climate crisis and biodiversity loss, to the wars raging in Ukraine and Palestine and the dozen conflicts in Africa.

**But for her, it's all about hope.** Goodall said that how she got into this space has become a rea-

into this space has become a reason to inspire other people that they can make a change.

"I was told at school that there

was no way I could go to Africa and live with wild animals - I didn't have money, I was just a girl, and Africa was far away. "But my mother said: 'No, if

"But my mother said: 'No, if you really want to do something like this, you're going to have to work really hard, take advantage of every opportunity, and if you don't give up, hopefully, you'll find a way.'

"And I've taken that message around the world and shared it particularly with young people in poorer communities. And the number of them who said, 'Jane, you taught me because you did it, I can do it, too'."

When Goodall was 23 she had saved up enough from a few jobs that she was able to board a ship to Kenya.

There she met paleoanthropologist Dr Louis Leakey, who eventually gave her the opportunity to go to the Gombe National Park to study wild chimpanzees.

After two years learning from the chimps, Goodall made groundbreaking discoveries that chimps use and make their own tools and have personalities and cultures. But as a young woman with no formal academic training, no one took her seriously.

So Leakey told her she had to complete her PhD in ethology at Cambridge University.

"So, there I was arriving in Cambridge, never having been to college... and can you imagine how I felt when all these scientists told me that I had done everything wrong? 'Jane, you shouldn't have given the chimps names, you shouldn't have talked about them having personalities, minds capable of problem solving, and certainly not emotions, happiness, sadness, fear, despair. Those are unique to us."

Goodall said that is what science believed in 1962, "but fortunately, I had a wonderful teacher when I was a child. And that teacher taught me that in this respect, these professors are completely totally, utterly wrong. That teacher was my dog, Rusty."

Goodall explained that if you share your life in a meaningful way with any animal - be it a dog, cat, horse or pig - it would be clear to you, as it was to her then, that we are not the only beings with personalities, minds and emotions.

And now, Goodall uses that same indomitable spirit to try to inspire hope in young people, who she began noticing were angry, upset and depressed when she travelled the world.

"I said to them, yes, you're right, we have harmed your future," said Goodall, "but it's not true that there's nothing that can be done about it."

Goodall went on to set up the JGI youth programme Roots & Shoots in 1991, which empowers young people by getting them involved in projects that protect the environment, wildlife or their communities. The programme is now in more than 65 countries worldwide.

#### What keeps her going

When asked what drives her to keep going, Goodall told Daily Maverick: "One, I'm an obstinate creature by nature, and I'm not going to give up.

"Two, I wouldn't do it if it didn't make a difference."

She added that when she was at the JSE the night before giving a talk on sustainable finance, an older man came up to her and said that she had changed his life.

In many ways, Goodall made a great sacrifice once she learnt the true extent of deforestation, having to leave behind the forest she loved, to try to save habitats around the world.

But for her, "it's just one of those things".

## JNHPP illustrating good uses of debt, loan market diversity

THERE is serious talk of the likelihood of President Samia Suluhu Hassan and her Egyptian counterpart, Abd el-Fattah Saeed Hussein Khalil el-Sisi, gracing the launch of a plant for an extra 470MW for the national grid next month.

The Coast regional commissioner, who acted as a sort of reality check in an otherwise self-congratulatory moment for those in charge of construction of the major hydropower facility, said that factories are being constructed rapidly.

While the contractors are drawn from Egypt, the financing is related to Turkish and Portuguese fund holders, a sort of novelty in the world of finance.

Thus the coming of the Egyptian president and Turkish President Recep Tayyip Erdo an before him was comparable in the hidden potential for development financing or credit for that matter from any of the usual sources we are attuned to believe hold the purse strings when it comes to such quests.

It is an indicator that the world has changed. Even if it isn't a multipolar world as some would wish or suggest, and not always with a good reason, it is certainly diverse in the potential for credit and spheres of global cooperation.

## Importance of taking initiative for restoring nature and biodiversity

NVIRONMENTAL destruction and biodiversity loss is accelerating at an alarming pace to the extent of threatening the existence of terrestrial species, according to the Living Planet Index (LPI) 2022.

The LPI 2022 tracks trends in mammals, fish, reptiles, birds and amphibians around the world since 1970-2018 and is published after every two years. 'Based on 6,617 monitored populations, representing 1,398 species of mammals, birds, amphibians, reptiles and fish, these populations have declined by an average of 83 per

It says the biodiversity loss and degradation of ecosystems and their services, stem from increasing demand for energy, food and other materials because of rapid economic growth, an increase in human population, international trade, and technology choices.

The LPI 2022 defines biodiversity as "the variety of life and the interactions between living things at all levels on land, in water and in the sea and air - genes, populations, species and ecosystems."

To address these crises, the LPI 2022 suggests building a nature-positive society in which people live in harmony with nature. This involves taking initiative at community level to restore nature.

"We know that the health of our planet is declining, and we know why. We also know that we have the knowledge and means to address climate change and biodiversity loss. First, we explore how values, rights and norms can take centre stage in decision and policy-making to drive the transformative change we need. In

addition, we consider models and scenarios which help us to imagine the future and understand what role economics, technology, consumption and production should also play."

The LPI 2022 says action to secure a nature-positive world can be taken by everyone, and can also be adopted nationally and internationally, to live in harmony with nature. Yet, we bear the brunt of heat-waves, floods, rain and windstorms and catastrophes, but what initiative do we take to mitigate climate change?

The LPI 2022 says the earth has warmed by 1.2°C since preindustrial times, and current human activity and political

from warming more than 2°C. Furthermore, it says global warming beyond 1.5°C will cause disasters to people and nature as the risk of tipping points escalates beyond this level. Thus, we must do something about it for present and future generations.

In Tanzania, while many people may not be doing much to mitigate climate change and biodiversity loss, there are initiatives taken at community level to restore nature that can inspire us to engage in positive change. Somanga Village in Kilwa District, Lindi Region, is a good example.

The village is situated along the shores of the Indian Ocean pledges will fail to prevent it and along Dar es Salaam-Lindi from Dar es Salaam. Somanga coral reefs were damaged when dynamite fishing in the Indian Ocean was rampant and before the introduction of beach management units (BMUs), but after coral reef restoration, according to group members, some rare fish species, which had disappeared, have started reappearing.

This is evidence that coral reef restoration initiative is not in vain. Some members of the coral reef restoration group were illegal fishers, but after realising the damage they had caused to the ocean ecosystem they reformed and turned into staunch supporters of coral reef restoration.

The group engaged in mangrove restoration was prompted by rampant mangrove loss caused by human activities such as cutting down some mangrove trees for building houses. Mangroves protect coastal areas against inundation and strong winds, and together with coral reefs, are habitats and breedinggrounds for aquatic life, including fish. When fish habitats and breed-grounds are threatened aquatic life is also threatened as well as the fishing community.

Somanga village serves as an example where ecological restoration is taking place as a community initiative and where the fishing community is aware of environmental destruction and has taken initiative to conserve and protect the environment.

## Teachers' shortage crisis: Government initiates online teaching trials

IN a bold move to address the pressing issue of shortage of qualified teachers in the country, the government has initiated trials for an innovative online teaching system.

The groundbreaking system, currently undergoing tests in selected schools in the Coast and Dodoma regions, allows a single teacher to instruct students across multiple regions simultaneously.

While the potential benefits, including simplified teaching processes and mitigation of the shortage, are evident, students at Dodoma Secondary School express optimism about the system enhancing their understanding and performance in national exami-

However, amidst these efforts, a new challenge emerges - a rapidly growing shortage of qualified teachers versus the escalating numbers of students at both primary and secondary school levels.

A study sourced from the National Bureau of Statistics reveals a concerning drop in the total number of teachers between 2017 and 2021, coupled with a significant increase in student enrollment. This widening gap raises questions about the government's ability to provide quality education to a growing number of Tanzanian students.

While the government is exploring innovative solutions, such as the online teaching system, the effectiveness of such methods comes into question.

An international study on online charter schools in the US, a similar initiative, reveals

'significantly weaker academic performance' in mathematics and reading compared to conventional schools. This raises concerns about the potential success of online teaching in a Tanzanian context.

Amidst these challenges, education experts, including HakiElimu policy analyst Makumba Mwemezi, emphasize the need for comprehensive budgetary considerations. The budget should reflect

the urgency of addressing teacher shortages and improving working conditions, as inadequate allocations may perpetuate existing challenges.

As Tanzania grapples with the complex task of balancing innovation with the need for qualified educators, the push for online teaching as a solution is met with skepticism.

Critics argue that the move might inadvertently contribute to rising unemployment, while practical issues such as unreliable power supply, lack of internet connections, and the difficulty of teaching science subjects online remain prominent concerns.

Tanzania's education system is at a crossroads, grappling with a severe shortage of qualified teachers and the introduction of unconventional methods, such as online teaching trials, to bridge this alarming gap.

While these trials hold promise in theory, it is essential to approach them with careful consideration and strategic implementation to ensure they effectively address the profound challenges facing the nation's education landscape.

The shortage of qualified educators has emerged as a criti-

cal concern, exacerbated by a decline in teacher numbers from 2017 to 2021. This issue is further intensified by a surge in student enrollment, attributed to the introduction of the free education program.

The resulting imbalance between the available teaching workforce and the escalating student population poses a grave threat to the overall quality of education in Tanzania.

In Shinyanga Region, some unemployed teachers, forced to take up alternative occupations like motorcycle driving and trading, express concerns over the potential implementation of an online teaching system as a cost-cutting measure.

They draw parallels between this scenario and the possibility of the Parliament conducting online deliberations to avoid hefty daily sitting allowances, which they view as excessive. This sentiment is fueled by the belief that such funds could be more equitably distributed among the nation's citizens.

As the government explores innovative solutions, such as the online teaching system, it is crucial to acknowledge the potential ramifications, including the risk of exacerbating unemployment issues.

Education experts and stakeholders emphasize that a holistic approach is urgently

needed to tackle the teacher shortage crisis. Rather than relying on short-lived measures that may not comprehensively address the impending challenges, there is a dire need to invest in sustainable solutions.

Censors argue that the government should prioritize increasing the education budget to at least 20 percent of the Gross Domestic Product (GDP), aligning with UNESCO's recommendations.

This strategic allocation of resources could facilitate the recruitment and training of more teachers, improving working conditions and ensuring a conducive environment for both educators and students.

should be a priority, considering the far-reaching impact on the quality of education and the nation's future. Rather than introducing measures that might inadvertently contribute to unemployment, a well-thought-out strategy focused on long-term solutions is essential.

Addressing teacher shortage

The commitment to reflecting these concerns in the budget is a crucial step, signaling a commitment to navigating the complexities of Tanzania's evolving education landscape.

In charting the way forward for Tanzania's education system, a delicate equilibrium must be struck between innovation and a resolute commitment to tackling the fundamental issues contributing to the shortage of teachers. A thriving and well-funded education sector stands not merely as a present-day investment but as a foundational pillar for constructing a sustainable and prosperous future for the nation.

Examining the experiences of developed countries provides valuable insights into achieving this delicate balance. For instance, countries like Finland have successfully integrated innovative approaches, including online teaching, without compromising the stability and employment opportunities within the teaching profession.

This underlines the importance of adopting strategies that harmonize technological advancements with measures to safeguard the livelihoods of educators, ultimately fostering a robust and dynamic education ecosystem.

## Western states scramble to explain themselves as UN calls for arms transfers to Israel to cease

HERE are moments when international treaties, long forgotten by the general public, suddenly spring back to life. Moments when a glimpse of reality shine through the thickladen bureaucracies of the United Nations and catches the attention of the world outside.

The debate that unfolded in 'sub-working group on current and emerging implementation issues' of the Arms Trade Treaty (ATT) on Wednesday 21st February was such a moment.

The State of Palestine and Control Arms – a civil society coalition – had, in January, requested a debate about the sit, and impact of weapons transfers brokering to the Israel-Palestine conflict. licenses of Never before, since the ATT's entry into force in 2014, had there been a formal discussion about non-compliance under the treaty.

The debate would, in more ways than one, become a clash of two worlds. On the one hand, the uncompromising and bloody reality on the ground in Gaza, where nearly 30,000 civilians – including more than 10,000 children – have been killed by Israeli bombs over the past four months.

On the other, the hushed and self-possessed world of multilateral diplomacy, where drama rarely elevates beyond the occasional request for points of order.

The stakes surrounding the debate had broken through the roof when the International

Court of Justice (ICJ) concluded, on 26 January, that there is a plausible risk that Israel's actions in Gaza are violating the Genocide Convention, placing the countries that are supplying Israel with weapons - most of which are parties to the ATT, with the exception of the United States – under significant pressure.

The foreign ministers of Italy and Spain had already announced that they will no longer export weapons to Israel. Citing the ATT and the EU common position on the export of military technology and equipment, a Dutch court had ordered, on 12 February, the government of the Netherlands to stop the export of F-35 fighter jet components to Israel.

While the Dutch government announced that they would appeal the order, the ruling had, in the following weeks, taken on a life of its own, leading parliamentarians and civil society groups in the United States, the United Kingdom, Germany, Canada and Denmark to urge their governments to stop arms transfers to Israel.

The big question, when the parties to the ATT met in Geneva last week, was how these countries would respond to allegations that they, by supplying Israel with weapons, risk complicity in genocide and other international crimes.

The ATT seeks to prevent and reduce human suffering by establishing common

international standards for the transfer of conventional weapons. Specifically, the treaty prohibits countries from transferring weapons if they know, at the time of transfer, that the weapons could be used to commit international crimes.

According to Hurini Alwishewa, a legal expert at the Graduate Institute, countries involved in supplying Israel with weapons can no longer claim ignorance: "With the ICJ finding that there is a plausible claim of genocide, the knowledge requirement is clearly fulfilled, and therefore exports of arms to Israel must not be authorised", she said at Wednesday's meeting.

In the run-up to the meeting, there had been rumours that the arms exporting countries would simply refuse to was even speculation that some countries would seek to dodge the debate altogether by filibustering the preceding agenda items.

But ultimately, the exporting countries realised that they had no other choice than to at least try to explain themselves. A few minutes before the debate was about to start, the United Kingdom, Germanv and the Netherlands could be observed wheeling their ambassadors in to the brutalist conference room at the

CICG in Geneva. Speaking from the podium, Nada Tarbush, a counsellor of Palestine's mission to the UN who rose to prominence after

a widely published speech delivered in November, was determined not to let the ambassadors' off the hook

"We are once again reaching out to exporting states to urge and urge them to explain their respective policies on arms exports to Israel. Particularly the United States, Germany, the United Kingdom, Italy, the Netherlands, France, Canada, Australia, Japan, the Czech Republic, Norway, and other states that may be involved as transit states including Greece, Cyprus and Belgium", Tarbush said, when laying out her case.

"We would be grateful to receive details of all extant arms export, transit, and brokering licenses of the supply of military and dual use items to Israel".

The arms exporters were, engage on the matter. There however, not prepared to engage in specifics. Instead, the United Kingdom and the Netherlands both downplayed its role in supplying Israel with weapons.

> "UK defence exports to Israel represent a small portion of UK arms exports", Aiden Liddle, the ambassador of the United Kingdom, said. While he made it clear that the ICJ's January ruling "is binding on Israel" and suggested that the United Kingdom's export licences to Israel may be revoked "if circumstances change and we reach a different view", Liddle did not explain how his country had initially concluded that weapons exports to Israel was in

line with the ATT

More evasively still, the Netherlands explained that "individual licenses can be granted, as long as there is no overriding risk that military goods may be misused by the end user" and stated that "applications requests for Israel have been granted in certain cases and denied in other cases".

Like the United Kingdom, however, the Netherlands failed to lay out the details of its export licensing decisions. Nor did they explain how they had concluded that the export of F-35 fighter jet parts comes with "no overriding risk" of misuse by Israel.

Germany, in a significantly more aggressive move, took issue with the debate as such, criticising Palestine and Control Arms for attempting "to Instead of explaining how Germany's export licences to Israel could be in line with international law, Ambassador Thomas Göbel offered what seemed like a full-fledged support of the manner in which Israel conducts its military operations in Gaza.

Echoing points made earlier in the debate by a representative of Israel – a signatory but not a party to the ATT – Göbel stated that "Hamas must stop its rocket attacks and refrain from using civilians as human shields and civilian infrastructure for military purposes [...] For Germany, Israel's security is not negotiable".

The exporting countries' attempts to justify their involvement in Israel's military operations in Gaza were. ultimately, found wanting. Tarbush made no secret of her disappointment, accusing the exporting countries for putting "themselves in a situation of criminal liability, of immorality in a situation where double standards risk irreversibly eroding the credibility of international law and the international system built since the Second World War".

But however incomplete, the mere fact that a debate about arms transfers to Israel could take place in the ATT is a positive step for the treaty. Too often, international treaties get caught up in their own institutional bureaucracies, resulting in a detachment from the realities that the treaties are set up to address. Since its entry into force ten years ago, the ATT has, sadly, been no exception.

Instead of criticising the State of Palestine and Control Arms for attempts to "politicise" the process, Germany and other countries supplying Israel with weapons, should see the debate as an opportunity to set a new, more reality-oriented, standard for ATT implementation.

Despite its imperfections, international law can play a key role in exposing doublestandards. By offering specifics now, western states will come in a much stronger position to demand transparency from others in the future. More importantly, history

shows that countries supplying other countries with weapons have significant power to shape the conduct and even outcomes - of military operations; to ensure that civilians are protected or, to put it bluntly, left for slaughter. Indeed, that realisation was one of the factors politicise the ATT process". driving the development of the ATT in the first place.

As Israel is preparing its ground invasion of Rafah, arms exporting countries are bound to be placed under increasing pressure. On Friday 23 February, a group of 41 UN experts, citing the ATT, called for any transfer of weapons to Israel to "cease immediately". If arms exporting countries are serious about their commitments to international law and a rules-based order, they should heed this call.

Otherwise, the Munich Security Conference's recent assessment of world politics as a steady trajectory towards a zero-sum game could well become reality.

## Heavy-duty trucks a major contributor to escalation of carbon emissions levels

EAVY-DUTY vehicles participate substantially to environmental pollution, accounting for over 40 percent of on-road nitrogen oxides (NOx) emissions, over 60 percent of on-road particulate matter (PM 2.5), and more than 20 percent of black carbon emissions, as revealed in the latest report by the UN Environment Programme

The report Used Heavy Duty Vehicles and the Environment - A Global Overview of Used Heavy-Duty Vehicles: Flow, Scale and Regulation report, jointly 

An increased number of heavyduty vehicle (HDV) are crisscrossing the continent but get frequently stranded for long days at

internation-al borders.

Climate and Clean Air Coalition (CCAC), provides a first global overview by the UN of the scale and regulation of used HDVs and their contribution to global air pollution, road accidents, fuel consumption and climate emis-

The report recommends ways to reduce the harmful aspects of used HDVs on people's health and the climate.

According to the study, HDVs are projected to considerably continue to grow with increasing economic activities and the need to move people and goods. This is based on past trends where global sales of trucks and buses or 'very weak' and enforcement

launched by the UNEP and the doubled in 15 years (2000-2015). Many developing countries

rely on used heavy duty vehicles (HDVs) imports to grow their fleet. While this promotes more affordable means to increasing mobility needs in these countries, the report finds that regulation and enforcement on the quality of used HDVs imported are either low or non-existent. Further amplifying their impacts, especially in the case of old, polluting, and unsafe used HDVs.

To date no country has minimum requirements for exporting used HDVs. The report finds regulations in over half of used HDV importing countries to be 'weak'

to be inadequate.

#### **African countries**

For example, while 25 African countries have adopted standards on used HDVs towards air pollution control, climate mitigation and improved road safety, only four have fully implemented

Worldwide, only two countries have included used vehicles in their national climate action plans (NDCs).

Rob de Jong, head of UNEP's Sustainable Mobility Unit, said: "Trucks and buses contribute to economic growth just about anywhere in the world, but ambitious regulations are needed

to curb their emissions causing major environment and health impacts. Introduction of cleaner bus technologies can be a major driver for the global revolution to low and, ultimately, zero emissions transport."

The report emphasizes that it is a shared responsibility of importing and exporting countries to ensure cleaner and safer used vehicles are on the roads of developing countries.

It shows the need for regional cooperation for introducing and enforcing minimum standards, such as emission standards and age limits, raising public awareness, and more research, for both environment and road safety benefits.

For example, by adopting Euro VI equivalent vehicle emission standards and cleaner fuels, as much as 700 thousand premature deaths can be avoided by

Currently 97 per cent of all newly registered trucks and 73 per cent of buses in the EU run on diesel. Better regulations on used HDVs can also lead to a leapfrog and greater uptake of advanced technologies in developing countries, including electric buses and trucks.

The report represents a first effort of quantifying and qualifying used heavy-duty vehicle flows, based on export data from Japan, the European Union, and Republic of Korea - altogether representing about 60 per cent of the total new and used HDV export market - to 146 predominantly low- and middle- income countries.

The report has limitations, most notably discrepancies in statistics, as well as lacking publicly available data from the USA, which does not separate exports of new and used vehicles, and China, an emerging exporter.

cholera: An overlooked outcome of climate change

GLOBAL warming is exacerbating the spread of a disease that should have been consigned to the dust bin of history a long time ago. We need to take action now.

In the 21st century, every case of and every death from cholera is preventable. Yet to this day, children around the world are still suffering and dying unnecessarily from the disease - and climate change is making the situation worse.

Climate change-related extreme weather and the destruction it causes are making headlines on a regular basis across the world. Yet the profound health implications of the climate emergency are often left untold.

Cholera is a diarrhoeal illness that spreads in places where access to clean water is limited and people end up consuming contaminated food and water. Poor sanitation and hygiene practices also accelerate its spread.

Cholera is completely preventable but also extremely dangerous, causing severe dehydration, diarrhoea and vomiting - symptoms that can kill within hours without

Combined with climate change, this bacterial illness poses an imminent threat to vulnerable communities across the world. In recent years, as the climate crisis has become more severe, there has also been a major surge in the number of cholera outbreaks across the world. We have seen repeatedly in different countries and communities climate-related intense tropical storms, heavy rains and flooding which damage or destroy water and sanitation infrastructure and cause untreated sewage to spill into clean water sources, and triggering cholera outbreaks.

According to UNICEF, 30 countries faced cholera outbreaks in 2022 - an alarming 145 percent increase from the previous five-year average..

Zambia, for example, is currently experiencing its worst cholera outbreak to date with more than 18,000 confirmed infections. The disease has already killed more than 600 people, a third of them children, and led to aid agencies warning of an "uncontrollable health crisis" in the country.

The continued suffering caused by cholera in countries classified as least developed by the United

Nations, like Zambia, exposes the deep inequalities within global society and the inadequacy of sustainable water, sanitation and hygiene access among poorer com-

More than quarter (28 percent) of households in Zambia do not have access to clean water. In rural areas, this figure rises to 42 percent. So it is not surprising that the country is currently experiencing a deadly cholera outbreak.

And the outbreak in Zambia is already spreading to neighbouring countries, where millions of people are already struggling with access to clean water and sanitation and dealing with the aftermath of extreme weather, threatening a catastrophic regional health crisis.

Zambia's neighbour to the east, Malawi, for example, is one of the least developed countries in the world and is still in the process of recovering from a major cholera outbreak that devastated it in 2023. Last year's outbreak was the worst in Malawi's history and the worst Africa has seen in the past decade.

It hit the country in the aftermath of three devastating storms -Cyclone Freddy, Tropical Cyclone

Gombe and Tropical Storm Ana - and severely hindered its recovery. About 59,000 cases and 1,750 deaths were recorded in the outbreak, but with many cases going unreported, these are certainly underestimates.

Yet this suffering is needless. Transmission of cholera can be stopped in its tracks - and sustainably prevented - through adequate access and investment in safe water, sanitation and hygiene. And this crisis is not limited to Southern Africa, we're seeing surges in cholera cases in Ethiopia too

Countries in Europe and North

America - once crippled by this disease - have long eliminated the threat of cholera through the provision of safe water and sanitation services for their entire populations. These successes should be replicated in countries fighting cholera today. The catastrophic, preventable cholera outbreaks in Southern Africa must be a wakeup call for all governments and development partners to increase funding for water, hygiene and sanitation, especially at this time of crisis when climate change is fuelling a surge in waterborne dis-

It is in the economic interest of governments to invest in water, sanitation and hygiene services and infrastructure because the cost of managing a cholera outbreak far exceeds the expense of preventing one.

The sixth UN Sustainable Development Goal of achieving "clean water and sanitation for all" by 2030 is seriously off track. For this goal to be achieved, the pace of progress needs to surge sixfold globally and twentyfold in least developed countries. There is need for immediate action, sustainable investment in clean water and a cholera-free future for all.

This is why WaterAid is calling on world leaders, governments, the private sector and donors to prioritise making safe water, decent toilets and good hygiene a reality for everyone, everywhere, especially the poorest and most vulnerable groups in climate-vulnerable regions.

In the face of the ever-growing threat of climate change, only by taking decisive action can we finally consign cholera to the history books and put an end to more unnecessary and avoidable deaths in Southern Africa and across the

## Minister roosts for special monetary policy targeting

agriculture sector

AGRICULTURE minister, Hussein Bashe (pictured), has emphasized the critical need for a dedicated financial policy in the agricultural sector. He underscored its vital role in granting farmers access to loans at low interest rates, contrasting the prevailing situation where they resort to commercial banks for borrowing.

According to him, such a policy would streamline loan accessibility for farmers, eliminating the various obstacles currently impeding their access to finance due to the absence of sectorspecific financial guidelines.

During a weekend address in Tabora, where he inaugurated a new branch of the Tanzania Agricultural Development Bank (TADB) serving Tabora, Kigoma, and Katavi regions, Bashe highlighted how the bank's presence would bolster agricultural productivity in the region.

"In all the economies of our country, incoming loans are more than 20tn/- and the amount that goes to this sector is less than 10 percent. And yet if you go to production in agriculture, the money given as a loan is very low. I have now spoken to the Finance minister, the Governor of the Bank of Tanzania and the Minister overseeing the Planning portfolio.

"We need a financial policy for agriculture because it is impossible for agriculture to be loaned using commercial bank policies, using that policy we will still not be able to lift people out of pov-

erty," said Bashe. Added that President Samia Suluhu Hassan is making efforts to raise the sector and improve the lives of farmers, including the construction of irrigation infrastructure and expanding the services of the agri-

cultural bank with the aim of bringing an agricultural revolution with sustainable plans that meet the needs of farmers through different services financially.

"Once the government has finished improving the infrastructure, the farmer needs money to buy fertilizers and inputs. Therefore, it is important and we must have a clear policy to get capital in production sectors such as agriculture, livestock and fishing, and as the minister I will push all those involved to get this policy and I believe it will be successful," said Bashe.

The Executive Director of TADB Bank, Frank Nyabundege, noted that until February, this year, TADB has enabled farmers and breeders by providing loans worth 19.599bn/- in the Kigoma regions 7.209/-, Katavi 2.394bn/- and Tabora 9.996bn/-.

"These loans have been granted for Rice, Bean, Cow fattening, Ginger, Chicken, Pig and Sheep and breeding projects. The bank continues to put in place solid lending strategies for tobacco, cotton and honey crops, as these crops contribute to developing the economy of Tabora Region," said Nyabundege.

Vice Chairman of the Kigoma Cooperatives Forum, Hussein Buchunguka, who is a palm farmer, thanked the bank for its great contribution to empowering farmers and in the purchase of machinery for processing the

'Today, the palm tree is recognized, before it was a temporary product, but now it is a product of the economy until we talk about the size you will see the oil produced from the palm tree, the journey to get rid of the shortage of oil has begun, thanks to TADB for supporting us and building our respect in agriculture," said Buchunguka.



## Balancing domestic income mobilisation crucial amidst diminished donor support

AX has remained a primary source of revenue for both central and local governments in Tanzania and revenue mobilization has been a long-standing concern in Tanzania.

Tax Equity that was done by the International Budget Partnership [IBP], the local government authorities continue to be heavily reliant on intergovernmental [IGT]-(80-90% transfers dependent on IGT), struggling to effectively raise own source revenues.

Senior Programme Officer Tax Equity Ghana, Dr Alex Ampaaberg said that in the pursuit of fairness and transparency in tax policies, IBP embarked on a mission to address the widespread injustice of inequitable taxation systems prevalent in many countries where it operates.

He said "The Tax Equity Initiative was born from this commitment, aiming to empower civil society to forge connections with a diverse array of stakeholders and influence domestic tax reforms."

Presenting these findings during Validation of Scoping Report that was organized by Policy Forum in collaboration with IBP over the weekend in Dar es Salaam, Senior Programme Officer Tax Equity, IBP-Tanzania/Zambia, Mtwaro Msoni said that in light of the country's large development needs, successive governments have placed revenue mobilization at the centre of economic policies.

Saying the objective of doing so is to support investment in education, health, and critical infrastructure while safeguarding fiscal sustainability.

Reliance on domestic revenue mobilization has also emerged as a top pri-

ority because of the significant decline in donor support.

Tax to GDP decreased by 0.8 percent from 12.2 percent in 2019/20 to 11.4 percent in 2020/21. Overall tax revenue to GDP ratio for the period under review was averaged 11.6 percent with the highest ratio of 12.4 percent in year 2015/16 According to a recently and 2016/17 while the least Tanzania Scoping Study on ratio was 10.7 percent observed in 2009/10.

Between 2000 and 2020, Tanzania's tax-to-GDP ratio was below the level of structural comparators such as Pakistan and Nepal, as well as aspirational peers such as Vietnam, and the SSA average.

Tax effort has steadily increased since 2000, with the tax gap narrowing from an average of about 8 percent of GDP from 2000 to a low of 5.6 percent in 2017.

Between 2000 and 2023, the growth of personal income tax (PIT) and corporate income tax (CIT) drove the increase in total tax revenue, while the contributions from VAT and excise taxes declined.

Tax Revenue buoyancy ratio, as observed overtime indicated that Tanzania had an average greater than one indicating sustainability of fiscal policy for Mainland Tanzania.

As a result, Tanzania has increased its total tax revenue while shifting to a greater reliance on direct taxes over indirect taxes.

The World Bank refers to Tanzania's tax system is progressive, but the tax net is very limited.

The PIT, which is based on a graduated rate structure, is very progressive, and revenue is collected exclusively from formal workers, who tend to be better off than their informal counterparts. Tanzania's VAT is also

progressive, unlike the VATs of many comparable countries. This is due in part to its narrow base, as many low-turnover businesses need not register for VAT.

The VAT turnover threshold was approximately 47 times GDP per capita in 2020, far higher than the thresholds in other large middle-income countries with significant informal Tanzania currently lacks

a dedicated tax incidence analysis, a critical tool for gauging the burden of taxation on its citizens. Such analysis is instrumental in revealing the impact of taxation on equity outcomes, providing crucial insights into how different taxes affect individual incomes and households.

While this detailed analysis is absent, the Tanzania Tax Statistics Report offers valuable insights into the compliance burden, shedding light on which group of tax payers pay particular taxes which is a good basis to further analyze incidence.

To improve tax performance the government has been undertaking several initiatives to strengthen its domestic revenues and improve management of its expenditures with a view to accelerating implementation of its priorities.

These measures among others include: Broadening the mandate of the Controller and Auditor General (CAG), voluntary tax compliance, cashless economy.

On cashless economy, the government is emphasizing the utilization of economic fiscal mechanisms to curtail cashless transactions and to increase the inclusion of transactions within the purview of tax obligations.

Other government initiatives scoped out include the restricting tax exemptions to less than 1 percent of the GDP by assessing the legal framework governing tax incentives.

Others are taxing the digital economy, and revaluation of property taxation.

A study done by Sikika in 2022 on the drivers of tax compliance in Tanza-

nia revealed that there are both primary and secondary drivers of compliance that need to be both addressed through improved tax administration and service delivery.

The study revealed that while taxpayer education, good customer care and assurance that tax administration pushes evaders are essential to drive tax com- 0.99 of GDP through tax expliance.

Tax payers are motivated by other factors like an improved service delivery or an integrated revenue policy that equitably distributes the overall tax burden.

Equally important to taxpayers is the question on how their taxes are spent. The argument is that mismanagement of financial resources as evidenced in the reports by the CAG surely demoralises taxpayer and lowers their level of voluntary compliance.

The scoping revealed that many Tanzanians believe they are overtaxed, considering the multitude of both direct and indirect taxes they must adhere to.

Although not fully disaggregated existing data provides insights into where the compliance burden lies. The Tax Statistics Report, last issued in June 2022 covering the years 2020 and 2021, stands out as a valuable resource in this regard.

However, there's a growing argument for assessing the impact of taxation on household income and wealth, which would serve as a more effective indicator for informing tax policy decisions. Rightfully so, such an analysis forms a Tax incidence assessment which is an accurate indicator of Tax Equity.

The recommendation is to enhance the publication of regular tax statistics by conducting householdlevel incidence analyses, including disaggregation of data by gender.

The scoping also observed that tax changes and the introduction of

new taxes are often justified by promoting equity, yet it is unclear how this equity is advanced beyond mere compliance, particularly in terms of its implications for household income and wealth.

Overgenerous tax incentives are compromising the nation's ability collect revenue. The scoping noted concerns on the tax incentives regime and the reporting of tax expenditures and benefits accruing from the regime.

Consistent with the Tax Justice Working Group Pre Budget-Statement of 2023 that expressed concern on the limited transparency and accountability in the extractive industry on non-disclosure of tax exemptions and contracts/ agreements that limit tax collections.

As noted in the 2023/2024 budget the government of Tanzania set the target for limiting tax exemptions to under 1 percent of GDP. Data compiled by the Global Tax Expenditures Database ranks 4th from the bottom with over 104

countries assessed. While the scope estimates that Tanzania losses penditures, it notes that the country ranks low in tax expenditure transparency and more critically low on the governance of the expenditures.

Currently tax expenditures are reported in the CAG report, but the data is not comprehensive.

These measures to a certain extent have helped the government increase its revenue collections as well as strengthen its tax collection systems to operate in a more transparent manner.

However, the tax-to-GDP ratio remains low despite gradual growth in the last ten years (8.9 percent in 2007 to 12.3 percent in

Civil Society interacted with during the scoping expressed that the current political landscape in Tanzania appears conducive to openness and accountability but more needs to be done.

To fully correct the problem of lack of timely and transparent publication of government information, along with limited public participation, several changes need to be implemented including but not limited to repealing regressive policies enacted during the previous regime that promoted secrecy and limited civic engagement.

Furthermore, it should strengthen governmental institutions responsible for disseminating information and facilitating public participation, and putting in place mechanisms to ensure the timely and transparent publication of government information.

## TFS gets set to direct 23bn/- into GDP in FY 2023/2024

FTER contributing to the country's Gross Domestic Product (GDP) a total of 20.5bn/during the past financial year of 2022/23, the Tanzania Forest Services (TFS) is now working on strategies to expand contributions to the state coffer in this fiscal year, targeting to dish out a total of 23.9bn/-

As of December last year, the government executive agency with responsibility of developing and managing forest and bee resources had already injected at least 13.3bn/- signaling its determination to accomplish the set mission.

The TFS Conservation Commissioner, Professor Dos Santos Silayo, said the agency is currently implementing an array of initiatives to scale up its working facilities and human resources with an eye to improve its service delivery.

Among others, he said, the ongoing interventions focuses to attain full management and utilization of all necessary forest and bee resources that the country has been endowed with, for the benefit of Tanzania's economic gain, unveiled that the far target is to contribute to the GDP at least 25.1bn/- by 2025.

And, Commissioner Silayo detailed, during the 2022/23 financial year, TFS managed to accumulate a total of 143.5bn/- (equivalent to 96percent of it set projections), added that, "As per

our revenues collections estimations, during the past two years TFS managed to raise a total of 298.89bn/-, the amount which was equal to 102 percent of our accumulation projections," he unveiled during an exclusive interview with The Guardian.

He said during the currently fiscal year, 2023/24, the esteemed agency is envisioning to collect a total of 161.8bn/-, saying as of 15th of February, this year, they had already managed to fetched about 89.6bn/-, the encouraging figure which reads at 56percent of the projected collections.

To ensure the accomplish its set visions, the Don expressed that during 2022/23 fiscal year, TFS has procured 31 modern vehicles as well as 44 motorcycles, at a total of 6bn/- in efforts to heighten and fast -tracking its daily roles.

To improve the agency's working equipment, the Don added that TFS has also purchased two modern tailor-made trucks for doing patrols in the complicated forest areas, made KAMAZ, worth at least 773.7m/- from the Equator SumaJKT Ltd Company.

As part to further cementing its roles on effective monitoring and improvement of bee and forest resources, Prof Silayo said TFS has also procured other 39 motorbikes at a cost of 452, 985,000m/-, two Land cruiser (made hardtop) vehicles which were bought by the Tanzania Forest Fund (TaFF) at around 337,353,600m/-.

"And in the current financial year we're looking existing mutual understand-

forward to purchasing the other 21 vehicles, two major tractors, one lorry, 56 motorcycles and two modern is expected to gobble up to 6.3bn/-," he informed.

He noted, the agency, TFS, is now working more seriously and keen to ensure the country is fully benefiting from its endowed resources in the sector of forest and beekeeping, added that several plans are afoot to be implemented inline to uplift the general performance of the vital economic sectors.

He communicated that TFS will also patriotically continuing to accomplish its dully role of paying reasonable contributions towards the Tanzania Forest Fund (TaFF), noting that during 2022/23 fiscal year it injected the crucial fund with 5.53bn/- added that in 2023/24 a total of 8.1bn/- will be dispatched to TaFF.

In regard to other developments, the TFS' chief boss, Prof Silayo said they are currently undertaking three major projects for scaling up preservation and improvement of the forest sector in the country.

The 62.7bn/- worth projects, being funds accrued from the development partners, include 'Integrated Landscape Management in the Dry Miombo Woodlands of Tanzania (DSL-IP), "Building the resilience of forest biodiversity to the threats of climate change in Tanzania's nature forest reserves' and 'Integrated Approach to Sustainable Cooking solution'.

"Implementation of these projects has surfaced due to

between Tanzania and other countries," he said.

Briefing over the projects, drones, the purchase which he unveiled that the 'Integrated Landscape Management in the Dry Miombo Woodlands of Tanzania (DSL-IP) was spending a total of USD 6.9million.

"The key objective of this project is to help curtail and reverse the negative trend of land degradation and loss of biodiversity in the degraded areas of the Miombo forests in western Tanzania by using an integrated landscape management approach, "he informed.

The other project, the 'Integrated Approach to Sustainable Cooking Solution, according to Prof. Silayo involves more than 34.3bn/-(Euro 12,500million).

"This project aims to promote sustainable forest management and woodfuel production in rural areas with an overall aim of enhancing environmental sustainability, in particular the sustainability of the wood-fuel value chain," he explained.

Together with that, he communicated that the package includes implementation of the third project, dubbed "Building the resilience of forest biodiversity to the threats of climate change in Tanzania's nature forest reserves'. He said the robust initiative is worth around USD4.8 million.

"The project is for carrying out activities to build the capacity of forests of nature reserves to withstand the negative effects of climate change by building forest protection infrastructure,

ing and good cooperation strengthening activities to increase income through eco-tourism, together with other activities meant to heighten incomes to the communities surrounding forests, "he unveiled.

Moreover, informing over the others TFS's achievement in developing the forest sector during the 2022/23 fiscal year, the Don stated that TFS had managed to establish one major tree farm in Makere area of Kasulu-Kigoma, occupying at least 65,000 hectare.

During the past fiscal year, he added that TFS had successfully produced 25.9 tons of tree seeds and planted a total of 32,735,653 seedlings of numerous tree varieties at different areas of the 24 public tree farms available across the country.

He said so far, TFS has managed to plant a total of 6,909 new trees as well as replace trees at a total of 2,434 at different state-owned tree farms in the country.

Dwelling over the other success obtained during the past financial year, Prof. Silayo said TFS managed to conduct a special forest inventory at a total of 42 forests (1,031,293 hectares) across the country, and later on developed the relevant management plans.

In the same vein, he informed that, during the period, TFS had also to upgrade 15 forests to the level of national forest parks, and other five national natural reserves forests, occupying a total of 58,216 hectares.

Similarly, he said during last year, TFS received a total of 4bn/- from the monies that was disbursed

Hassan for supporting improvement of forests preservations and tourism in the country.

"With the amount, we managed to construct at least five modern entry gates at five national parks, but also, the money assisted us to construct a 97km road, as well as a 190.5km-long tourists walking trails at 11 parks," he expressed.

He also added that through TFS's internal work plan, they have managed also to improve the country's ecological and cultural tourism attractions by reha-

by President Samia Suluhu bilitating at least 231.7km of tourist's trails, and 643.54 roads within forests.

## **Investors urged** to update data on web portal

INVESTORS have been urged to update their information using the Business Facilitation Portal necessary in tapping new investment opportunities, the Export Processing Zones Authority (EPZA) senior officer has said.

This was said by the EPZA Acting Head of Procurement Management Unit William Msoffe during their visits to EPZA licenced industries in Lindi, Mtwara and Ruvuma regions in an ongoing evaluation exercise of industries in the country.

Msoffe noted that EPZA launched the Business Facilitation Portal last year in order to provide investors with access to information and investment procedures at their fingerclicks.

"The Portal is an important platform for investors to access crucial investment information and also link them to new investment opportunities for grabbing," he said.

The system is linking EPZA with investors as well as institutions like the Tanzania Revenue Authority (TRA), Business Registrations and Licensing Agency (BRELA), Tanzania Immigration Department and Tanzania Bureau of Standards (TBS).

The system which is web based allow an investor to lodge various documents including license application and permits anywhere without visiting the EPZA offices.

He said they visited seven industries in Lindi Region, 10 industries in Mtwara Region and one Special Economic Zone in Ruvuma Region.

He said the products produced by EPZA programmes of Special Economic Zones and Economic Processing Zones have met the required market standards of USA, Asia, Europe and other global markets.

He said products that met the required international standards came from various sectors namely agriculture, mining, energy, forestry, garment and steel.

He said the government has been emphasizing on the need to add value to products from locally raw materials due to its multiplier effects in the country's economic development.

## Urgent call: Western reinvestment key to global order revival

THE world order seems to be fraying before our eyes. Russia's war against Ukraine, US-China tensions, America's shameful failure to provide Ukraine with more weaponry, Donald Trump's threats of an isolationist US pullback from the globe, Israel and tensions in the Middle East. It's time to reinvest in the bricks and mortar of the global order, but the prospects are dim, especially in America.

At the end of the second world war, the US created a strong military and security framework to contain the Soviet bloc at a time when European allies were far too weak to protect themselves. But assembling the bricks of the foundation was not enough. The US needed mortar to cement them. It did so via its remarkable post-war recovery: the Marshall Plan, trade liberalisation, the G7 and the creation of the International Monetary Fund, World Bank, the General Agreement on Tariffs and Trade and the World Trade Organization.

Decades of growth and prosperity followed in the 'West' (which I use to refer to the Transatlantic relationship, but also Japan, Korea, Australia and New Zealand). Of course, there were flaws. The US fell prey at times to an overly black and white Manichean world view and cowboy behaviour. Europe became a free-rider on American security. Many parts of the world - the global South - were long left out of rising global prosperity.

With the collapse of the Soviet Union and China's remarkable economic rise, the global landscape fundamentally changed. The US remains the world's largest and dominant economy, but it feels insecure, especially as it looks at China's growing might, and fails to grapple with inequality and polarisation at home.

Europe is prosperous, but growth has levelled off and the continent feels vulnerable standing next to a bellicose Russia, watching America step back from globalism. Many emerging markets have established sound fundamentals and prospered. The global South wishes to maintain its neutrality between US and China tensions, while on the whole welcoming Chinese economic assistance.

Against this background, the

West needs to reinvest in bricks and mortar. Don't hold your

#### **Bricks and mortar**

On bricks, Europe must quickly build up its defence capabilities. Its nations must far more uniformly treat the Nato defence spending goal of 2% of gross domestic product as a minimum. The Zeitenwende was a remarkable step forward, but mistakenly doubling down on the Schuldenbremse debt brake may vitiate its vision. Energy security must become an even greater priority, recognising the huge gains in turning off the Russian energy supply. The US 'pause' of liquid natural gas exports is a wrongheaded way to treat allies. Europe and the US must stay united to promulgate sensible multilateral sanctions against Russia. The US must resources stump up Ukraine.

On mortar, the West - especially the US - must better support the global South. Led by the US, the creation of the G20 at the leaders' level showed vision in recognising the need to go beyond the confines of a G7dominated system, which no longer had the clout to manage the global economy. The G20 was effective at the outset, but it has fallen into disrepair amid Russia's barbarism and US-China tensions. It is increasingly unable to tackle global challenges such as climate change.

President Joe Biden's administration and China's leadership have pragmatically stabilised the bilateral relationship over the last year. More open engagement is needed, devoid of hawkish cold war rhetoric. That could help to renew G20 efficacy.

While the US is increasingly veering towards protectionist sentiments - both Democrats and Republicans - many countries, particularly in Asia, view trade as essential for their economic security and a means to engage with America in the face of Chinese regional domi-

The Trump administration's withdrawal from the Trans-Pacific Partnership was a colossal blunder. The US needs to reinvest in trade, though the prospects are dim. It could promote closer ties with Asia by at least backing off from its recent Indo-Pacific Economic Framework moves and paring back tariffs where practicable.

### China refutes US report denying its contributions to global trade

**BEIJING** 

CHINA yesterday strongly opposed a US report that denies China's contribution to the multilateral trading system and global economy after it acceded to the World Trade Organization over two decades ago.

The Ministry of Commerce said in a statement that China as the largest developing WTO member has always firmly supported the multilateral trading system, genuinely practiced multilateralism, and earnestly fulfilled its WTO commitments.

The country has continuously improved its market economy institutions and legal systems based on its national conditions, expanded high-level institutional openingup, fully and deeply participated in the reform of the WTO, and actively helped other developing members, in particular the least developed countries, integrate into the multilateral trading system, the ministry said.

The Office of the United States Trade Representative recently released its 2023 Report to Congress on China's WTO Compliance.

The US side disregarded China's achievements in fulfilling its WTO commitments, distorted its progress in building a market economy and advancing reform and opening up, and made groundless and arbitrary accusations on its economic and trade policies, the

The ministry stressed that the US side smeared China's legitimate trade measures as economic coercion, labeled China's response to the US blockade and repression as decoupling, and falsely accused China of causing overcapacity, which fully reflects the unilateralism and bullying acts of the United States.

Exactly opposite to the US statements, China's positive and constructive role in promoting the multilateral trading system has been acknowledged and appreciated globally, the ministry said.

China was the first major developing country to accept the Agreement on Fisheries Subsidies, played a key role in successfully concluding negotiations on the Investment Facilitation for Development, and promoted the conclusion of negotiations on a number of global digital trade rules, the ministry said.

With "America first" as its starting point, the United States violated WTO rules, carried out unilateral trade bullying, and formulated discriminatory industrial policies, which has disrupted the global industrial and supply chains, seriously affected the international trade order, and undermined the common interests of WTO members, the ministry said.

The ministry called on the US side to correct its wrong deeds in a timely manner, earnestly abide by WTO rules and its commitments, work with China and other members to jointly uphold the rulesbased multilateral trading system with the WTO at its core, and earnestly play its due role in addressing global issues and chal-

## Health ministry: Palestinian death toll in Gaza rises to 29,692

GAZA

THE Israeli army killed 86 Palestinians and wounded 131 others in the Gaza Strip during the past 24 hours, raising the total death toll in the enclave to 29,692 and injuries to 69,879 since the Israel-Hamas conflict broke out on Oct 7, 2023, the Hamas-run Health Ministry said in a press statement on Sunday.

It noted that many victims remain under the rubble due to heavy bombardment and a lack of civil defense and ambulance crews.

A Palestinian was killed and four others were injured in an Israeli raid on a house in the Al-Shaaf area. east of Gaza City, Palestinian medical sources told Xinhua.

The sources added that artillery shelling on the western parts of Khan Younis city and the Al-Sabra neighborhood of Gaza City killed a number of Palestinians and injured dozens of others.

In the northern town of Beit Lahia, three Palestinians were killed and 10 others injured after the Israeli army attacked a residential house, with some people re-

maining under the rubble, according to Palestinian security sources. The security sources said violent clashes between armed Palestinian factions and Israeli forces broke out in the Al-Zaytoun neighborhood in the south of Gaza City, and explosions were heard in the area.

The Al-Qassam Brigades, the military wing of the Islamic Resistance Movement (Hamas), and the Al-Quds Brigades, the military wing of the Palestinian Islamic Jihad movement, announced in separate statements that their members "engaged in armed clashes with the Israeli forces east of the neighborhood and targeted their vehicles with shells and caused deaths and injuries among their

For its part, the Israeli army announced on Sunday two soldiers were killed in a battle in the southern Gaza Strip.

The army added that an officer and two other soldiers were seriously injured during a battle in the southern Gaza Strip, and they were taken to hospitals for treatment.

Israel has been launching a large-scale offensive against Hamas in the Gaza Strip to retaliate against a Hamas rampage through the southern Israeli border on Oct 7, 2023, during which about 1,200 people were killed and more than 240 were taken hostage.

### Eurasian Economic Summit highlights China' growing role in building better world for all

**ISTANBUL** 

THE 27th Eurasian Economic Summit, which ended on Thursday in Türkiye's cultural and financial hub of Istanbul, highlighted China's growing role in building a better world for all.

"It is impossible to talk about international relations in the 21st century without paying tribute to China's special role in building a new, much more functional and much more secure international relations," Zahari Zahariev, chairman of the Bulgaria National Association for the Belt and Road, told Xinhua after his speech at the summit.

Zahariev said that over the past decade, China has been contributing to laying the foundations for a world civilization through inclusive initiatives based on the principle of win-win.

"We are living in a very transitional pe-

riod. There are many risks confronting the future of mankind," Zahariev said, noting China has been struggling to create a better world for all. Speakers and participants at the summit's panels praised the BRI, which is marking its 11th anniversary.

Vladimir Norov, former foreign minister of Uzbekistan and former secretary general of the Shanghai Cooperation Organization (SCO), especially praised China's transportation projects, which connect Asia with Europe.

Such projects have been creating significant economic growth and sustainable development for many countries, he said. Speaking at a panel titled "Longing for Peace: Belt and Road Is 11 Years Old," Norov also noted that China's initiatives will help to solve global problems like climate change, food security and poverty.

Liu Gang, president of the Xinhua Insti-

tute, a Chinese think tank, said over the past 10-plus years, the BRI, spanning diverse civilizations, cultures, social systems and development stages, has forged new paths for interactions among countries.

"It has constructed a new framework for international cooperation, seeking the widest possible converging interests for the shared development of humanity," Liu said. Two research reports presented by the

Xinhua Institute, namely "The Belt and Road Development Studies -- A Synergy Approach to Global Development" and "For a Better World -- Looking at the Past Decade of Jointly Pursuing the Belt and Road Initiative from a Human Rights Perspective," were well received by experts and scholars at the

koye in the Donetsk People's Republic. In addition, seven enemy counterattacks were repelled near Novgorodskoye, Leninskoye, Lastochkino and Novobakhmutovka in the Donetsk People's Republic," the statement reads.

According to the Defense Ministry, the enemy lost up to 100 troops, four armored combat vehicles, eight motor vehicles, a Grad multiple rocket launcher, a D-30 howitzer and a Bukovel-AD electronic warfare system.

Moreover, russian aircraft, artillery units and missile forces hit Ukrainian troops and equipment in 127 areas in the past day, the Russian Defense Ministry said in a statement.

"Russian tactical aircraft, unmanned aerial vehicles, missile forces and artillery units hit enemy troops and equipment in 127 areas," the statement reads.

### South Africa's ANC pitches for votes as majority threatened

**JOHANNESBURG** 

SOUTH Africa's governing African National Congress (ANC) has launched its manifesto for the May elections, in which some polls suggest its share of the vote could fall below 50% for the first time.

President Cyril Ramaphosa addressed thousands of supporters at a rally in KwaZulu-Natal province.

The area will be a key battleground. Dissatisfaction with the state of the economy, public services and corruption has eaten away at ANC support.

The party of Nelson Mandela, who led the struggle against the racist apartheid system and oversaw the transition to democracy in 1994, has been the dominant force for the last 30 years.

But stubbornly high unemployment, which now stands at more than 32%, frequent power cuts and high crime levels, among other issues, have led some to turn away from the ANC.

There are challenges coming from the right, in the form of the main opposition Democratic Alliance (DA), and the more radical left with the Economic Freedom Fighters (EFF).

KwaZulu-Natal is also the home of former President Jacob Zuma, disenchanted with the party and now suspended from the ANC. He has thrown his weight behind a new formation - uMkhonto we Sizwe (MK) - which has already made some small inroads at by elections in the province.

Speaking at a stadium in the city of Durban, with the crowd decked out in the ANC's black, green and gold, President Ramaphosa promised that "we will do better".

It was an acknowledgement that there are problems, but he also emphasised the transformation that the country has made in the last three decades.

"South Africans are more educated, empowered and healthier than they were under apartheid," he said, urging people not to threaten that progress.

Looking forward, his party promises to create 2.5 million "work opportuni-



President Cyril Ramaphosa said that South Africa had made a lot of progress in the 30 years of

ties". It also pledges to boost investment and support the private sector as well as "eradicate corruption".

In his introduction to the manifesto, the president also wrote that "there are forces that seek to use this election to undo the progress of democracy. It is crucial that together we defend our hard-won freedom."

He did not name those "forces" but the ANC knows it faces its toughest electoral environment yet.

Since 1994, it has polled consistently above 50% in national elections, enabling it to run the country without challenge. But with some opinion polls showing that that support has dipped below an absolute majority, South Africa is facing the possibility of a coalition government after the 29 May general

In its party manifesto launched last week, the DA, under the leadership of John Steenhuisen, had a simple message: "Our country

is in crisis."

It has promised to create two million new jobs, end the power cuts and halve violent crime. The DA wants a more liberal economic approach, including introducing privatisation, especially in the energy sector.

On the opposite end of the political spectrum, the EFF's diagnosis is that the ANC has failed to dismantle the economic system that existed under apartheid.

Instead, the governing party has "reproduced and worsened apartheid economic inequalities", the EFF's high-profile leader Julius Malema wrote in his introduction to its manifesto.

The EFF's answer is to expropriate land without compensation and nationalise the "mines, banks and other strategic sectors of the economy, without compensation".

That wealth would then be used to benefit the majority of the population.

The MK has not yet released its manifesto, but at the party's launch last December Mr Zuma said the ANC had moved away from its roots and it was now his mission to "rescue" the "once-great movement".

There are more than 300 parties registered with the electoral commission, and though not all will necessarily take part in the May vote the stage is set for three months of hard campaigning.

#### Russia vows retaliation against Western actions on its assets

**MOSCOW** 

RUSSIAN Finance Minister Anton Siluanov warned yesterday that Russia would retaliate in kind to any actions taken by Western countries against its assets abroad.



We are watching the decisions of the Western countries," Siluanov (pictured) said during an interview with Russia's RIA Novosti news agency, adding, "Any actions with our assets will receive a symmetrical response." Western countries have imposed sanctions on Russia since February 2022, freezing both sovereign and private assets.

The country's currency reserves were frozen to the amount of roughly \$300 billion.

Various reasons have been cited for seizing the Russian assets. In October 2022, the EU leaders asked the European Commission to draft proposals for using the frozen assets to finance the reconstruction of Ukraine, according to

the RIA report. Russia has responded strongly against the Western sanctions. The Kremlin said they "would be another step towards violating all the rules and norms of international law". The Russian Foreign Ministry denounced freezing Russian assets in Europe as theft. Agencies

## **India-US to engage in homeland security talks**

INDIA and the United States are likely to conduct a significant dialogue on homeland security, focusing on topics such as counterterrorism, concerns related to Sikh radicals, cybersecurity, and aviation security, among other matters.

Sources familiar with the matter indicate that discussions will be led by Union Home Secretary Ajay Bhalla and his counterparts from the United States in the national capital.

The anticipated topics for discussion are cooperation in counterterrorism, cybersecurity, combating illegal migration, extradition, aviation security, safeguarding global supply chains, and maritime security, among other areas. The last homeland security dialogue took place in January 2022.

Senior officials from both sides are expected to attend the full-day gathering.

According to sources, issues linked to Khalistani separatist Gurpatwant Singh Pannun and several fugitives residing in the US are expected to be raised during the dialogue

India is expected to emphasise on issues such as the exploitation of the digital sphere by terrorist organizations for disseminating radical ideologies, recruitment, and financing terror-

Narcotics Control Bureau (NCB) officials are

expected to seek collaboration with the US Drug Enforcement Administration (DEA).

India will also emphasise on issues of cyberattacks on its essential infrastructure, including banks, railways, power and energy facilities, and hospitals.

Previously, non-state actors from China, Cambodia, the Philippines, and Myanmar have targeted critical infrastructure.

In 2022, data from the government-operated All India Institute of Medical Sciences (AIIMS) was breached. A senior official mentioned concerns regarding data sovereignty due to the misuse of Indian data by numerous Chinese lending apps and online investment fraud.

The meeting is significant as this would provide another platform for India to raise these issues with the US.

Last year, National Investigation Agency Director General Dinkar Gupta met with his counterpart Christopher Wray from the Federal Bureau of Investigation. During the meeting, Gupta discussed ongoing investigations in the US regarding the attack on the Indian consulate in San Francisco by Pro-Khalistan elements. He emphasised the growing nexus between terrorist organisations and members of organized criminal syndicates, which is extending its reach to the US.

#### Ramadan 'explosion' looms for Israel and Hamas

THE statistics speak volumes. Over the years, the Muslim holy month of Ramadan in Judea, Samaria and eastern Jerusalem has morphed into a breeding ground for Palestinian violence with terror attacks.

This year, Ramadan is expected to begin at sundown on March 10 and Israel is at war with Hamas. Israeli leaders have hinted that they will send ground forces into Rafah, Hamas's last stronghold if no agreement on a hostage release is made by then. On Sunday, Prime Minister Benjamin Netanyahu told the CBS News show, Face the Nation that the Israeli Cabinet was due to approve that same day a plan to evacuate Rafah as a precursor to entering the city.

"If we have a deal, it will be delayed somewhat, but it will happen. If we don't have a deal, we'll do it anyway," Netanyahu said.

Hamas is believed to have four battalions in

The terror group also threatened an "explosion" of rage if Israel moves to restrict Muslim worshippers from visiting the Temple Mount during Ramadan.

Ramadan is two weeks away and the clock is ticking. Will this Ramadan be remembered for a ceasefire, or the Battle of Rafah?

For the last three years, terror spiked during Ramadan anyway, so what difference does war make for Israelis? During Ramadan of 2021, Hamas orchestrated a barrage of rocket attacks from Gaza, triggering a full-blown 11day war. The violence spilled over into Arab-Israeli communities, where simmering tensions erupted into widespread riots and unrest.

During Ramadan of 2022, Palestinians killed 15 Israelis in terror attacks ranging from shooting, stabbing and car-ramming attacks. The surge of violence continued after Ramadan - four more Israelis were killed during the spring - and the Israel Defense Forces cracked down, launching Operation Wave Breaker.

By the end of 2022, counterterror operations thwarted more than 500 attacks, but 31 Israelis were killed.

#### Former Brazil PM denies coup plot as thousands rally in his support

**SAO PAULO** 

JAIR Bolsonaro, the former President of Brazil, led a massive rally in Sao Paulo on Sunday, vehemently denying accusations of involvement in a coup plot to cling to power, CNN

Thousands of Bolsonaro's supporters, adorned in the green and gold of Brazil's national flag, gathered on Paulista Avenue, a key thoroughfare in the nation's largest city, to express solidarity amid growing legal challenges.

Last week, the far-right populist used social media platform X to call for the protest rally, framing it as a "defence of the democratic rule of law." Bolsonaro is currently under investigation by the Brazilian Federal Police regarding an alleged coup attempt aimed at retaining power after losing the 2022 presidential election, as confirmed by his lawyer in early February. Former ministers from Bolsonaro's government are also under scrutiny, and some aides have been arrested, according to CNN.

Despite the mounting legal pressure, Bolsonaro, speaking on Sunday, maintained that he is a target of persecution, refraining from directly mentioning the investigating institutions. In 2022, Brazil's highest electoral court barred Bolsonaro from seeking political office until 2030, citing abuses of power and misuse of public media during the election campaign.

## Litang in SW China's Sichuan province finds secrets to tourism

LITANG county is located the sunlight, is to the southin the southwestern part of the Garze Tibetan autonomous prefecture, southwest China's Sichuan province. Situated on a plateau with an average elevation of over 4,000 meters, it is known as the "City in the Sky." With snow-capped mountains and picturesque grasslands, the scenery there is breathtaking.

Thanks to the internet and the growing popularity of cultural tourism, Litang has become a popular destination in recent years, attracting

more and more visitors. In 2023, the county received over 3.19 million visits and generated a total tourism revenue of 3.92 billion yuan (\$545 million), representing a year-on-year growth of 66.7

The Genyen scenic area, which features a 6,204-meter snow-covered peak that always shines brightly under west of Litang county across a grassland.

"There are hot springs here," said a tourist surnamed Chen, seeing the gentle flow of a stream in Rangrikar village at the foot of the Genyen Mountain. He took off his shoes and stepped into the water.

Chen had driven all the way from Shenzhen, south China's Guangdong province, and had already stayed in Litang for half a month. There were quite a few tourists living in the village, and Chen said that leaving behind the hustle and bustle of the city and immersing himself in the nature allowed his soul to rest.

Letong ancient town, a folk culture scenic area, was established in Litang in 2018, with a total investment of nearly 80 million yuan. Tourists can explore ancient landmarks, enjoy traditional opera performances, and wander through mini museums in the town, where around 4,000 local households live.

Horse racing has a long history in Litang, where a grand horse racing festival is held annually in the sixth month of the Tibetan calendar. This event has been hosted for over 400 years and gradually evolved into the Litang Horse Racing Festival that falls on Aug. 1 each vear.

During the festival, people dress up in their finest attire, prepare delicious food and drinks, and gather on the grassland to enjoy equestrian performances.

However, as the times have changed, the younger generation has been embraced by more and more modern cultural activities, resulting in a decline in the number of horse racing enthusiasts and inheritors of equestrian per-

In response to this, the Litang Horse Racing Festival encourages tourists to engage in horse riding activities, stages song and dance performances, and holds food exhibitions. In addition, it has collaborated with small-scale horse racing events in towns and villages to build unique tourism routes, further promoting the development of the horse breeding and racing industry.

After setting up his phone, Dawa, who was born in the 2000s, started livestreaming and introduced the essentials of horse riding.

Dawa returned to his hometown and became a live-streamer after graduating from university in 2023. Now he has around 40,000 followers on short video platforms. In Litang, almost every village has such young individuals.

To preserve culture and

make it bloom, remote small towns have to actively innovate amidst the collision of diverse cultures. Young people in Litang have brought traditional skills such as equestrianism, traditional opera, and textile craftsmanship to online spaces. From natural landscapes

to folk customs, Litang maintains a high level of popularity on short video platforms throughout the year. The popularity of short

videos has been on the rise, which has opened a new cultural window for Litang, nurturing over 30 online streamers each with more than 10,000 followers.

After a video featuring Tenzing Tsondu, a young man from Litang, went viral on the internet in November 2020, a short video showcasing charm of Litang received over 700 million views within 72 hours of its release, and

the online search volume for "Litang" surged by 620 per-

The online popularity translated into a boost for tourism. During China's National Day holiday in 2021, tourism revenue of Litang increased by 72.4 percent year on year. Throughout the year, the county received more than 1.6 million visits, generating tourism revenue of 3.98 billion yuan.

According to Gerong, director of the Litang culture and tourism bureau, the comprehensive tourism revenue of Litang accounted for 26 percent of the county's GDP in

"To achieve long-lasting success, we need to take solid steps," said Gerong. The cultural and tourism industry has a wide range of implications, and the county has organized various departments to discuss the development

path in depth. Services have become

more professional. The number of hotels in the county continues to increase and has exceeded 450.

Local training programs have been implemented to enhance the skills of employees, and a cultural and tourism "think tank" has been established. The number of B&B hotels in the county has exceeded 100.

Supporting facilities have been improved. Approximately 300 million yuan has been invested in tourism infrastructure construction, aiming to transform Litang into a provincial-level comprehensive tourism demonstration zone.

In 2022, a cultural and tourism big data center was established to digitize and consolidate tourism resources,

## Jurgen Klopp's kids secure one of his greatest achievements - and true Liverpool legacy

HIS was a victory forged in Kirkby. A victory that is up there with Jurgen Klopp's greatest achievements. Maybe, in a one-off match, in a final, his greatest

In terms of courage, in terms of determination, in terms of that belligerent refusal to accept circumstances have conspired against you, in terms of digging in, digging deeper and doubling down, it possibly even rivals that night in Istanbul in 2005 for Liverpool.

Maybe that is over the top given it was the Carabao Cup that was at stake, and not the Champions League and given Liverpool were facing a Chelsea side struck with an insipid lack of a killer instinct, rather than an AC Milan team that raced into a 3-0 half-time lead. But consider this...

Liverpool had 11 first-team players out. They had two, maybe three, from their strongest XI at the end. It was like an under-21 side laced with a few senior pros in Virgil van Dijk, Wataru Endo and Luis Diaz. Except Diaz, like Harvey Elliott, could barely run.

And consider this. Klopp turned to his bench. He turned to three hugely inexperienced teenagers, youngsters schooled so well at Liverpool's academy in Kirkby, and he showed how much he believed in them.

They returned that faith. was 18-year-old Jayden Danns, and Bobby Clark and Iames McCon-

was 21-year-old Jarell Quansah and, in goal, there was Caoimhin Kelleher, another academy product, albeit at 25, who made two outstanding saves. The first, to deny former Liverpool attacker Raheem Sterling, was world-class.

And so this is Klopp's legacy in what will be, of course, his final season. Not a 10th League Cup, as welcome as that is, not even keeping alive the dream of a quadruple. No, it is what he has done in bringing back the belief, the spirit, the defiance, the identity. This is Liverpool. This is what it

It will be some inheritance for Klopp's successor, with the impressive Conor Bradley, at 20, starting and taking nell, both just 19. There the game to Chelsea, and

with Elliott also just 20 but with more than a century of games under his belt and already something of a senior

In a sense, given the injuries and the fatigue, Klopp had little choice but to turn to the youngsters. But other managers would have hesitated. They would have persevered with the senior players and tried to keep them out there. But Klopp has the belief and the belief saw them home as he won his eighth trophy as Liverpool manager.

And then there is Van Dijk. Captain, leader, legend as Chelsea fans refer to their own, their former centrehalf John Terry. Van Dijk is that for Liverpool. As well as the kids did for them, as were cajoled and encouraged by Klopp, and as much as they grew into this occasion, Liverpool would have been nowhere without Van

They lost his centre-half partner, Ibrahima Konate. They took off Andrew Robertson and World Cupwinner Alexis Mac Allister also departed. And yet Van Dijk continued. He was the touchstone, the rallying point, the colossus. He was also the match-winner.

For the fourth time in four and a half years, a final between these two clubs went to extra-time. Chelsea, unfortunately for Pochettino, few could argue with that.

As fine a coach as he is, it is just one win in 14 for him when facing Klopp including the 2019 Champions League when he was in charge of Tottenham Hotspur. Pochettino bent over the hoardings. He knew this was a missed opportunity.

And how his team missed opportunities. Conor Gallagher was their best performer but he could not finish - flicking one chance against a post and then being denied by Kelleher. He was not alone. Nkunku, Disasi, Cole Palmer. They were all wasteful.

Maybe Chelsea will argue they had the better of it - and yet Liverpool also struck the goal-frame. Twice, in fact, with a Cody Gakpo header hitting the post, as did another from Elliott in extra-

Both sides also had 'goals' disallowed after VAR checks - a finish by Sterling and another header by Van Dijk with Liverpool aggrieved as it was ruled out for Endo blocking off. It was an offence but the argument is a

### Mbappe will play 'when I want him', says PSG coach **Luis Enrique**

AFTER taking off Kylian Mbappe as Paris Saint-Germain struggled to a home draw with Rennes on Sunday, coach Luis Enrique said the soon-toleave superstar will play "when I want him".

Luis Enrique took off France captain Mbappe in the 65th minute with PSG losing. His replacement, Goncalo Ramos, won and converted an added-time penalty that gave the home team a 1-1 draw in Ligue 1.

Mbappe has said he plans to leave when his contract expires after this season with Real Madrid expected to be his next destination.

"It's very simple, sooner or later, when it happens, we have to get used to playing without Kylian," Luis Enrique told the post-match press conference. "When I want him to play, I'll play him, and when I don't, same thing."

Between the 64th and 70th minutes, Luis Enrique replaced his entire forward line, also taking off Ousmane Dembele and Bradley Barcola.

"It's a message for everyone," said Luis Enrique immediately after the game. "If you think I'm going to accept a player slacking off on the pitch, I'm not."

At the press conference he stressed that he was not singling out any players and that the whole team was "less inspired" than usual.

"No, no, you've got it all wrong. It's a message for everyone. I'm delighted with the attitude of my players. But if anyone thinks I'm going to give up on them, I won't.

"I wanted to change the feel of the match. I didn't want to take off Dembele but I thought he was hurting. I'm lucky enough to coach around 20 very high-level players, and I want them to understand that every minute has to be earned."

PSG, who have an 11-point lead over Brest in Ligue 1, face thirdplaced Monaco on Friday before travelling to San Sebastian to face Real Sociedad in a Champions League round-of-16 secondleg game on March 5, holding a 2-0 lead from the first leg.

## Klopp ranks Liverpool's League Cup glory as his 'most special' trophy

LONDON

**IURGEN Klopp hailed** Liverpool's League triumph Cup final against Chelsea as the "most special" trophy of his career as the German learned he can win with kids.

Virgil Dijk van clinched Liverpool's 1-0 win with a dramatic header two minutes from the end of extratime at Wembley on Sunday.

Liverpool's victory was especially sweet for Klopp as it came during an injury-hit period for his club that forced him to field a remarkably inexperienced team.

The Reds started with 20-year-Conor Bradley and Harvey Elliott in his side and brought on Bobby Clark (19), James McConnell (19), Jayden Danns (18) and Jarell Quansah (21) from the bench.

Injuries had deprived Klopp of Mohamed Salah, Trent Alexander-Arnold, Diogo Jota, Darwin Nunez, Alisson Becker and Joel Matip among others, while Ryan Gravenberch was stretchered off in the first half.

In the circumstances, Klopp ranked the seventh major trophy of his nine-year Liverpool reign as the most memorable of his career.

"In more than 20 years it is easily the most special trophy I



have ever won. It is absolutely exceptional," he said.

"Sometimes people ask me if I'm proud of things and it's really tricky, I wish I could feel pride more often but tonight is an overwhelming feeling.

"I was proud of everyone involved in everything here. I was proud of our academy, I was proud of my coaches, I was proud of so many things. It was completely overwhelming.'

Former Liverpool defender Alan Hansen famously criticised Alex Ferguson's decision to blood a host of Manchester United youngsters, including David Beckham, Paul Scholes and Gary Neville, by saying "you can't win

It was a turn of phrase that came back to bite Hansen as United's kids

- 'A memory forever' -Wreathed in a bewildered grin in the moments after Van Dijk's goal and at his fist-pumping best in the post-match celebrations, Klopp revelled in every moment of what might be his last visit to Wembley after his recent announcement that he will leave Liverpool at the end of the season.

"I couldn't care less about my legacy. I'm not here for that. It had nothing to do with maybe my last game at Wembley," he said.

"It was about seeing the faces of the kids. For me it's a really nice memory forever."

Asked when he knew Liverpool's cadre of rookies were ready to step up on the big stage, Klopp said: "Obviously age is not a problem at all. It was clear in training, these were the boys

While Klopp hopes Liverpool's success boosts their bid to stay top of the Premier League and win the FA Cup and Europa League, Chelsea boss Mauricio Pochettino was left to urge his players to embrace the pain of defeat.

Pochettino's side paid for wasting a series of chances to kill off Liverpool towards the end of normal time.

"We didn't get the reward we wanted. They need to fill the pain. We played for a trophy we didn't get. There is nothing you can tell me to feel better," said Pochettino, who remains without a trophy in English football.

"They need to realise we need to work more, do better things, to compete at this level against a team that has been doing big things for many years.

"Liverpool lost the finals in the past, but they kept moving and kept believing. That is an example to us."

"They have not lost

their qualities but physically, mentally they need to rediscover their
