Govt probing suspicious rare ruby now displayed in Dubai

CAG: 500bn/big markets, bus stands unprofitable

AUDITS conducted on the management and performance of markets and bus stations countrywide has found no profit in using more than 530bn/- for the projects.

Charles Kichere, the Controller and Auditor General (CAG) says in his 2020/2021 annual report that the deficiencies arose from lack of seriousness when conducting feasibility studies for such projects, numerous cases of unsatisfactory work environments, lack of offices for market supervisors and lack of rental agreements with stall operators.

The report tabled in the National Assembly and open to public scrutiny says that regulations task local governments to manage and control markets and all bus stations. The cited deficiencies include land conflicts arising from lack of title deeds when the land was being taken over, and involvement of persons not working for local authorities. There was no profit in 533.68bn/- of public investments in markets and bus stations which were not operating, while others were operating only partially, he said, citing Chuno Market that was built under the strategic urban projects programme using up.54bn/- and was earning 138.1m/- annually. The market had 237 stalls that were vacant for more than four months and accrued 32.11m/revenue loss, the report noted, highlighting that Skoya and Chiyangu markets plus Chipuputa

MPs object to massive civil servants shortage

A COMPREHENSIVE strategy is needed on the part of the government to tackle the chronic shortage of civil servants in different cadres, members of the National Assembly have declared

They expressed these concerns in most crucial areas. yesterday when contributing to debate on budget estimates for the President's Office (Public Service Management and Good Governance) for fiscal 2022/2023, asserting that public service is vital to national life but it is grappling with a shortage of servants

Prof Kitila Mkumbo (Ubungo) said the public service is an engine for implementation of government policies, law enforcement and realization of development plans; hence it has to have the right staffing levels to do the

He said the public service faces challenges but critically it is shortage of staff nearly everywhere, with the demand for primary and secondary

A rare 2.8kg gemstone whips up a James Bond atmosphere in Minerals, Natural Resources and Foreign **Affairs** ministries

THE government has said it is investigating whether a rare 2.8kg gemstone now making headlines globally comes from the Winza mining location in Mpwapwa District, Dodoma Region.

Minerals deputy minister Dr Stephen Lemomo Kiruswa made remarks to this effect in the National Assembly here yes-

This comes in the wake of recent reports in social media that the gemstone, owned by a California resident in the United States, was at the Dubai market and was set to be auctioned at least after the Muslim Holy month of Ramadhan. Online profiles say Winza village is

known for ruby mining, as it is technically in the Usagaran Belt, a metamorphic geological zone, with rubies discovered in the area in 2007.

The government is thus seeking to establish if one of the world's biggest rough rubies that is set for auction in Dubai originated from Tanzania, as it has so far no idea how it left the country.

school teachers standing at 433,992 at present, with 258,291 teachers employed, at just over half of the demand, of 175,701 that is equivalent to 40 per cent of needs.

The health sector employs 98,987 medics and nursing staff against the requirement of 208,232 such employees, a shortage of 109,295 placements or around 52.5 per cent of total requirements, he stated, noting that this affects provision of services in dispensaries and health centres.

More than 70 per cent of the population receives medical treatment in these establishments, he said, citing the demand for health professionals as standing at 131,547 but just 48,579 are employed.

Agriculture needs around 20,000 extension officers but it only disposes of 6,600 officers, with employment gaps taken together totaling over 1.2m 'missing' civil servants, he stated, urging the formulation of a strategy to tackle the shortage of workers especially in crucial areas.

He described the 30,000 public servants to be employed next fiscal year as far too few compared to stated requirements. There is need for a national audit of civil servants to bring about efficient use of government manpower, the former academic observed.

The government must continue to improve the business environment for the private sector to set up more private schools which will employ available teachers, he stated, pointing out that just three per cent of schools countrywide are privately

Ester Bulaya (Special Seats-Chadema) said the demand for public servants is extremely acute, citing Bunda town council with over 900 staff placements not done. The district has 38 local government executives while it is supposed to have 80, while primary school teachers placements reach 1,252 but just 738 teachers are so far been em-

Similarly, the district council needs 48 extension officers but it so far has 34 and 184 health department staff as opposed to 402 professional staff needed, she stated. "We have a serious shortage of science and mathematics teachers where 162 are needed but we have 68 such teachers," she elabo-

Leah Komanya (Special Seats) urged the government to prioritize allocating newly employed servants to districts with serious shortages, pointing at Meatu District as facing acute shortages. Within five years 232 civil servants have been transferred and 156 others retired, mostly without replacements.

"We need 930 teachers for primary schools and 199 for secondary schools. The demand for health workers in Meatu is 675, but we have 68 such officers," she stated, highlighting that each of the eight dispensaries has a single qualified health practitioner.

Jenista Mhagama, the minister, had asked for 851bn/- to be used in fiscal 2022/23, where 670.08bn/- is for recurrent expenditure and 181bn/- is meant for development projects. The government set out 30,000 new employment positions, 120,210 promotions and repositioning of 8,080 civil servants.

About 120.7bn/- ill be used for the 30,000 new recruits, 42.3bn/- for higher payments of promoted staff and 2.2bn/- for those changing cadre, she

She said that 103.8bn/- has been set aside for payment of arrears for civil servants after the verification exercise is done, noting also that the government will strengthen the work of agencies responsible for national security and the fight against corruption.

The President's Office shall similarly emphasise ethics for government officials and other public employees, with intent to enhance productivity to realize the goals of national development, the min-

The government will also prioritize supervision of utilization of human and financial resources by emphasizing inclusiveness, with structural reforms for improvement of public sector outputs, she said, pointing out that during fiscal 2020122 the Tanzania Social Action Fund (TASAF) conducted a verification exercise on beneficiaries in 186 districts.

A total of 886,724 households were verified where 781,342 qualified to continue in the second phase of the scheme, while 105,382 households recording positive economic progress graduated from the plan, she added.

Productivity remains the biggest challenge in the sector limiting potential growth, particularly for smallholders, he said, noting that the value chain faces pressures of producer productivity and insufficient consumption, putting processors under pressure and enabling

informal trading. Tanzania's dairy sector comprises primarily of smallscale producers producing low volumes of milk for domestic consumption, with the dairy value chain being semi-structured, most of the milk sold informally with few aggregators and processors, he explained.

Weak consumption plus insuf-

ficient raw milk input supply leads to poor processor utilization, driving down profitability, he further stated, highlighting that despite prices being low, unprocessed milk retailers have higher margins due to limited transport and storage costs.

He suggested that policy interventions and viable programmes can drive sec-

tor growth and improve beneficiation."It is necessary to address value chain inefficiencies, including incentivizing processors to invest back into the value chain, while promoting ancillary service investments," he declared. A survey conducted by the board had shown that Tanzania currently produces 2.7bn litres of milk per year but

only 10 per cent of it is processed, which the board says is responsible for stagnation of the subsector Tanzania is second in cattle

The government had initiated communications with the said owner of the 2.8-kg gemstone, who is now in California, with the Natural Resources and Tourism ministry initiating investigations to establish its origin and its value.

The Tanzanian Embassy in the United Arab Emirates has been detailed to find out how the precious stone was obtained.

The deputy minister made the remarks when responding to a supplementary question from Mkinga legislator Dunstan Kitandula, who said that there were unconfirmed reports that the 2.8-kg ruby was at the Dubai market and was expected to be auctioned off anytime soon.

"How do we benefit as a country

because reports have it that it is from Tanzania," the MP queried, to which the deputy minister said that last Thursday (April 14) the government obtained information that the gemstone was in the Dubai market and was set to be auctioned.

The 8400-carat gem, which Dubai auctioneers have reportedly nicknamed Burj Alhamal, is being informally valued at US\$120 million (over 240bn/-), Kiruswa noted.

He said the government had initiated communications with the ruby's current owner, adding that the government is looking for important documents regarding the gemstone's ownership.

If it is established that it originated from Tanzania, "we will make sure that the country benefits jewel of the collection. from its purchase", he declared.

Media reports say that the rough ruby was mined in Winza and it will make its first public appearance in the market at the Waldorf Astoria in the Dubai financial centre, unveiled by the event's expected guest of honour, Hollywood actor Tamer Hassan.

"The launch of the Callisto collection in Dubai represents a groundbreaking moment for the company in its journey to becoming one of the world's leading metals and mineral assets management firm, holding four billion dollars in assets, in exclusive gemstones and gold," a top executive stated.

SJ Gold and Diamond managing director Patrick Pilati said on Tuesday that it was the first time the firm was introducing its crown

"Unveiling this one-of-a-kind

stone to the public for bidding is a clear continuation of our dedication to showcasing the best of the best in the UAE," the event's organiser remarked.

The Callisto collection, named after the famous Arcadian nymph of Greek mythology, includes millions worth of hand-picked white and yellow cut and uncut diamonds along with 12 unique rubies weighing 236,000 carats.

The Tanzanian stone was not heated, meaning that it has not been treated and so it is natural and that is why it is precious, he said.

It remains unclear when the gemstone was obtained, but the event's organisers have suggested that the variegated purplish-red rough ruby might have been mined at Winza in central Tanza-

Bus Stand in Mtwara-Mikindani municipality were not operating for a whole year, occasioning a total of 131.1m/- revenue loss. Mkuti Market in Masasi had 68 stalls that were not rented and could have earned 12.84m/during the year, while in other districts some markets and bus stands that were not operating as they lacked the necessary records, the report noted, citing Mangaka town bus station, Mbagala Kuu market, Kijichi market and its shops line up

Mangaka town in Nanyumbu District had a completed bus stand incorporates commercial installations for shops, pharmacies, restaurants and bars, but only 14 such units were rented, with 31 spaces vacant. Mbagala Kuu market and Kijichi shop frames in Temeke municipality were financed by the Dar es Salaam Metropolitan Development Projects (DMDP), where Mbagala Kuu market costing 1.19bn/- had 141 vacant stalls out of 180 available, a 78 per cent vacancy rate.

"The entire Kijichi market that cost 765.01m/- had no renters, while its shop frames costing 1.73bn/- were vacant as well, the report intoned. Makangarawe Market had 147 stalls vacant out of 186 installed spaces, with 14 shop frames out of 19 similarly vacant. Two butchery spaces and a big shop frame were not rented

as well At Kilole bus station in Korogwe town in the fiscal 2017/18 audit and the 2019/20 exercise a huge number of stalls were not rented, causing an estimated loss of 357.63m/-, the report added

Bashungwa lifts ban on Bodaboda in Dar's CBD

MINISTER of State in the President's Office (Regional Administration and Local Government - PO-RALG), Innocent Bashungwa has directed authorities in Dar es Salaam to rescind a ban on motorcycle taxis (bodabodas) from entering the central business district.

Speaking yesterday in Parliament, Bashungwa said though the intention to ban bodaboda and tricycle (Bajaj) taxis from operating in the central business district was good, its implementation would take a lot of young Tanzanians out of employment.

"Of course the intention is good, but the flaw lies in addressing the issue itself. The sixth phase administration recognizes and values the role of bodaboda and bajaj taxis in the creation of employment for Tanzanian youths. They regard it as their official employment," he said, calling upon the Dar es Salaam Regional Commissioner Amos Makalla to oversee the implementation of a reversal of the ban.

Initially, the ban was meant to start on April 20, 2022.

Ukonga legislator Jerry Silaa (CCM) moved a motion to ask the House to debate bodabodas and bajaj as a matter of urgency.

"You shall recall Madam Speaker that whenever you go to your constituency, you are welcomed by a group of youths riding bodabodas and in other areas, we seriously depend on

them. In Dar es Salaam however, there has been a lot of uncertainty surrounding this group," he said.

However, the Speaker said the motion could not be debated but instead, she asked the Prime Minister, who is the leader of government business in Parliament, to work on the issue and issue directives on how bodabodas and bajajis should operate across the country.

"The Prime Minister is here with us. We ask you to take this topic and issue directives, including on how they should operate so that people can know," she said.

In Tanzania, malaria remains a major disease burden. Almost all the population is estimated to be at risk of the disease, with children and pregnant women at the greatest risk. While malaria remains a significant public health concern, in the past two years the country has also been grappling with COVID-19, which has brought challenges to the health system and malaria prevention is even more important now than ever. The distribution of insecticide treated nets (ITNs) has been ongoing in Tanzania.

Health sector to employ over 7,600 civil servants

THE government has said it will start deploying health officials at different medical facilities countrywide following the recent announcement of over 32,000 jobs in which the health sector was given a permit to employ 7,612 public servants.

Deputy Minister of State in the President's office, Regional Administration and Local Government, Festo Dugange told the National Assembly yesterday that Itaka Health Centre located in Mbozi District, Songwe region is among the facilities that will be considered during the deployment of staff.

The deputy minister was responding to a question by Special Seats legislator, Juliana Shonza (CCM) who had sought to know when the government would deploy medics at the Itaka health centre which she said was facing shortage of staff thus derailing medical services at the area.

In response Dugange said: "The government continues to employ and deploying health officials to different health centres countrywide and during the 2020/2022 Mbozi District Council was given 17 medics out of which two were employed to offer services at the Itaka health centre."

A fortnight ago, the government officially announced 32,604 new employment opportunities with the health and education sectors getting the highest number of employees.

The new jobs up for grabs completes a total of 44,096 which was pledged by the government during the 2021/2022 financial year, according to the Minister of State in the President's Office (Public Service Management and Good Governance), Jenista Mhagama.

The minister said the process to recruit 32,604 kicked off on April 12, 2022 and by the end of June 30, 2022, all the positions will have been filled.

In hiring the new staff, the government plans to spend 26.3bn/- every month, an equivalent of 315.6bn/- per year. According to Mhagama, the education sector would be given 12,035 positions out of which 9,800 will be for hiring primary and secondary school teachers and that the recruitment exercise would be done by the ministry of State in the President's Office Regional Administration and Local Government (PORALG)

Also she added higher learning institutions would be given 2,235 for hiring lecturers for universities and trainers at other colleges under the ministry of education, science and technology and that the ministry in collaboration with the employment secretariat would coordinate the exercise.

In the new jobs, the ministry of health was given 10,285 positions out of which 7,612 public servants would be employed in hospitals, health centres and dispensaries which are under the regional administration and local government.

Rice farmers to benefit from new seeds resilient to climate change

RICE farmers in the country will now no longer have to face certain challenges including the effects of climate change that cause drop in the production of the crop following researchers' decision to continue making trials on new seeds expected to be introduced shortly.

The observation was made here yes-

terday by Climate-Smart African Rice Project coordinator, Prof Susan Msolla at a three-day meeting that discussed on achievements realised in the implementation of the project in the past two years. She said many rice growing areas in the country face floods challenges causing many farmers fail to harvest their crops.

She added that the project will provide a solution in regard to challenges rice farmers face many of them caused by the effects of climate change.

"We are trying to look for a new type of rice seed that will answer floods challenges as well as effects of climate change," said Prof Susan.

She said already, in Asian countries including the Philippines, they have tried the new seeds and have shown to withstand these challenges and trials done in Tanzania have shown good results.

Prof Susan further said the project will involve the provision of short term training for postgraduate students including 100 science students from various countries involved in the project.

"The project aims to learn various modern methods in rice production and how to store crops after harvest," said Prof Susan.

For his part, Deputy Vice Chancellor at Sokoine University of Agriculture (SUA) from Research and Professional Advice Department, Prof Maulid Mwatawala said the project is being implemented by the university in collaboration with the International Rice Institute (IRRI) and Tanzania Agricultural Research Institute (TARI). Prof

Mwatawala said the aim is to get quality

rice seeds that can withstand floods and effects of climate change that contribute to the increase of sodium carbonate in the rice fields.

He added that the project will assist in coming up with new types of rice seeds that can withstand climate change as well as empowering researchers to obtain research equipment and infrastructures.

WHRDs urged to forge links with parliament, networks

WOMEN Human Rights Defenders (WHRDs) have been urged to strengthening partnerships with Parliament and other networks such as Tanzania Women Parliamentary Group (TWPG), Tanzania Women Judges Association (TAWJA) to support reforms of legislation and policies.

UN Women Country Representative, Hodan Addou made the remarks yesterday when speaking at the launch the Coalition for Women Human Rights Defenders Tanzania (CWHRDs) five-year strategic plan.

Hodan said some of the policies have been a thorny as it bars them from freedom of association, assembly, and expand the room of civic space.

She said strengthening partnerships is crucial to easily address hurdles prevent WHRDs from exercising their rights to political participation.

She also advised them to build strong relationships with the Commission for Human Rights and Good Governance (CHRAGG), such as conducting joint gender-sensitive analyses on national legisla-

tion, policies and programmes to ensure compliance with the state's international human rights obligations.

Other issues includes strengthening capacities on the administration of justice to ensure effective access to justice by WHRDs, developing protection protocols and to act as referral channels to report cases of intimidation, threats and reprisals against WHRDs.

UN Women as a part of the UN System in Tanzania strongly believes that the significant role of Defenders of women's rights in bringing about positive development outcomes must be recognized and supported.

It is on this basis that in 2020, UN Women developed a guidance note on -Supporting Women Human Rights Defenders which provides a model of integrated action to guide our collaboration with, and support to WHRDs.

She was pleased to note that the new UN Sustainable Development Cooperation Framework for Tanzania plays an important role in strengthening engagement with civil society organizations

and WHRDs.

As national, regional, and international human rights protection mechanisms can offer remedies and protection for violations or threats. "I encourage you to actively participate in these mechanisms, particularly through the preparation of shadow reports to human rights reporting processes such as the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW and the Universal Periodic Review (UPR).

CHRGG's chairman, Judge (rtd) Mathew Mwaimu noted that his commission is working tirelessly to promote and protect the rights of human rights defenders.

So far, he said that the commission in collaboration with the Network of African National Human Rights Institutions (NANHRI) have conducted a baseline assessment to 13 Tanzanian Mainland ministries, departments, National Institutions and Agencies especially those in one way or another encounter with human rights defenders in their day to day activities.

Embrace Mwalimu Nyerere's legacy, Palestine envoy tells global leaders



SIDO out to improve products' packaging, branding, labeling

THE Small Industries Development Organization (SIDO) has brought together packaging entrepreneurs as well as manufacturers of packaging industries, to discuss the opportunities and challenges involved in packaging including branding and labeling.

Speaking during the opening of the meeting in Dar es Salaam yesterday, SIDO director of marketing and investment, Shoma Kibende said the organization has found that there are major challenges in the areas of packaging; branding and labeling that make Tanzanian products fail to gain competitiveness in the market.

"What removes the attractiveness of a product in the market includes how it has been branded, there is a packaging challenge for entrepreneurs as many of them use similar packages, something that fails to brand them and confuse customers. This is due to the scarcity or lack of access to the right packaging materials," Kibende said.

Kibende said there is huge demand for packaging materials in Dar es Salaam due to shortage of factories to produce enough and quality packaging materials.

"I urge entrepreneurs to use SIDO to get quality packaging tools. We have brought 11 industrialists from Coast Region so as for them also to share experience and see how to address this challenge, we want Tanzanians products to be quality and penetrate to other markets in Africa and abroad," he explained. Coordinator at SIDO Packaging Services Center Antonia Masoy said the

majority of entrepreneurs and traders have been importing packaging materials from neighboring countries due to scarcity of the materials in Tanzania.

"Any product that wins the market is the one that is packed in a quality material and looks attractive. Putting a product in a unique packaging material attracts more customers as they create trust and sometimes think that the specific product is from abroad. Entrepreneurs are still complaining that locally produced packaging materials are poor and they decay faster than those from outside the country," she said.

Antonia said the organization was working to establish a special network which will bring together entrepreneurs and producers of packaging materials so that they can discuss and increase quality of the materials and improve the penetration of the country's products locally and in international markets.

Acting manager from Nampack Tanzania, Benjamin Mutua said the company is engaging in the production of metal packaging materials inducing bottles for storing foods such as cashew nuts and processed foods.

He, however said, currently they have stopped producing the materials due to high competition in the market where a lot of packaging materials are imported and sold at a very low price thus killing the locally produced ones.

"Metal packaging tools are quality and firm, but we are now facing challenges in the market. Increase of low price packaging tools has killed our efforts," he asserted.

competitive markets laws to help young firms sail through

THE Economic and Social Research Foundation (ESRF) Principal Research Associate Prof Samuel Wangwe has called on government to come up with friendly laws that would make young companies to sail through competitive markets.

Prof Wangwe made the call in

Dar es Salaam when speaking during the launch of report on a comparative baseline study on establishing a start-up policy in Tanzania dubbed; "Inclusive and constructive business environment to

start up ecosystem". Prof Wangwe said start-ups create jobs which mean more employment which leads to improved economy.

"Specific policies and legislation be passed on startups which will set standards and procedures that must be followed by all stakeholders but also create a mechanism to nurture start-ups," noted Wangwe.

He further noted that the law should have clear provisions on the definition of startups to avoid

overlapping and multiplicity of roles and functions.

"The law should have a general provision on the entitlement of tax incentives for startups with specific incentives provided under the finance Act.

According to him, the Tanzania Commission for Science and Technology (Costech) Act 1986 was

amended to ensure there are provisions in the general framework of administration and coordination of the start-up ecosystem.

Ambassador of Netherland to Tanzania Wiebe de Boer said that the Embassy has been working together with Tanzania Startups Association (TSA) to strengthen the entrepreneurial ecosystem particularly to support creating a business friendly environment for start-ups to flourish and to attract national and foreign investment.

1. Project Overview

The Improved Quality and Accessibility of Education and Health Service Delivery by the Churches in Tanzania Project - phase II is being implemented by Christian Social Services Commission (CSSC) through financial support from Bread for The World (BfTW). This is a 3 years (January 2020 to December 2022) project which aims at improving access to quality education and health services by the underserved communities across five CSSC zones targeting all regions in mainland Tanzania and Zanzibar. Despite the invaluable contributions of churches' facilities in the delivery of health and education services, these facilities continue to face immense challenges. are constrained by unfavorable policies and guidelines, Insufficient understanding of government legal /policy frameworks, $In adequate\ Church\ policy\ frameworks,\ Weak\ management\ systems\ (financial,\ HR),\ and\ Inadequate\ teaching\ and\ learning\ environment.\ Churches'$ health facilities are also faced with a number of serious challenges such as poor adherence by the government to Service Agreements, resulting in decreased access to public resources (funds, personnel, medical supplies); Delays in the introduction of National Universal Health Insurance, creating an over-dependence on minimal out-of-pocket payments of a predominantly resource-poor rural population; insufficient understanding of government legal / policy frameworks; Inadequate capacity of the Church facilities to employ and retain qualified health staff; Inadequate quality of services (especially for lower-level facilities); Fragile financial sustainability as well as Weak capacity of Church health training

Progress towards reducing financial dependency and enhancing the sustainability of Churches-owned health and education facilities are substantially slower following the introduction of Direct Facility Financing (DFF) and the ongoing development of infrastructures in both the health and education sector. CSSC has worked closely with the government at the national, regional, and district levels to ensure the delivery of high-quality health and education services is sustained.

2. About Christian Social Services Commission (CSSC)

Christian Social Services Commission (CSSC) is an ecumenical body jointly established by the Tanzania Episcopal Conference (TEC) and the Christian Council of Tanzania (CCT) in 1992 to facilitate social services with the main focus on education and health services provided by the churches. The Commission was registered with the Ministry of Home Affairs in 1993 under the category of a not-for-profit faith-based organization. It is mandated to chart out a common action within the policies and legal framework of the Government of the United Republic of Tanzania aimed at expanding and improving the provision of social services, Education and Health. CSSC initiate, improve and strengthen cooperation with the Government, NGOs, and other stakeholders sharing and bearing the same aspiration and dedication to the provision of social services. Humankind can't help protecting planet Earth

It's a day first marked 52 years ago and intended, in the main, to demonstrate support for environmental protection.

EarthDay.org is said to be followed by around one billion people in at least 193 countries.

This means that many true and loyal "friends of the environment" globally are well aware of the Day and what it represents. The official theme for this year's edition of the celebrations is, aptly, 'Invest In Our Planet'.

With each passing day, the theme of environmental protection becomes more urgent than ever before, chiefly given the events that commonly rock people and economies around the world chiefly in relation to climate change.

When conflicts arise and disturb the pace of adopting renewable energies as the prices of petrol and other fuels rise or tensions limit world trade in rare minerals, efforts to tame the worsening global climatic situation take a hit.

At the same time, more realism is being noticed in some quarters, moving from a single-track mind of reducing carbon emissions by less industrial development to more proactive carbon absorption methods like reforestation of deserts; using hydrogen as a source of energy.

The early 1970s were marked by the classical study by French agronomist Rene Dumont, 'False Start in Africa', which shows graphically the depletion of resources like arable land and urbanisation trends fraught with limitations on health care or control of epidemics, etc.

There were other nerve-racking situations like the drying up of Lake Baikal in north central Asia owing to intensive irrigation especially for cotton farming.

Although there have been more than 50 Earth Days, climate change and other environmental issues still threaten the planet's health.

Michael Mann, a distinguished professor of atmospheric science at Penn State and author of 'The New Climate War: The Fight to Take Back Our Planet' (PublicAffairs, 2021), notes that Earth Day is an opportunity to take stock of where humankind stands in the battle to live sustainably on planet Earth.

"We are not yet on the path towards stabilising the warming of our planet below dangerous levels," Mann told Live Science in an

He added: "Earth Day is an opportunity to have a conversation about what we need to do. Truth be told, every day should be Earth Day. Without a livable planet, we have nothing."

How is Earth Day celebrated?

Each year, organisations and individuals engage in Earth Day activities, projects and campaigns to promote, protect or restore the environment.

Earth Day quizzes are one popular activity, and organisations such tional and EARTHDAY.ORG have online quizzes for people to test their environmental knowledge.

Children in the US meanwhile often celebrate by creating Earth Day-themed school projects such as Earth Day crafts and Earth Day drawings.

"There are two simple ways to celebrate Earth Day to make the world a little better," Nathaniel Weston, an associate professor of environmental science at Villanova University in Pennsylvania previously told Live Science.

"The first is to promote understanding of important environmental issues so that more people are aware of the critical actions we need to take to protect our environment," adding: "The second is to commit yourself to service on or around Earth Day - plant some trees, clean up a stream or help your local community garden."

Addressing climate change requires widespread and dramatic political action. A 2022 report by the UN's latest Intergovernmental Panel on Climate Change (IPCC) found that "rapid, deep and immediate" cuts to global carbon dioxide emissions across every section of society are needed to stop a climate disaster, Live Science previously reported.

In other words, individual Earth Day activities like planting a tree or buying "eco-friendly" products will not stop global temperature rises and climate breakdown.

Prof Mann recommends using the day to talk about the climate crisis. Discuss with your friends, family, neighbours, and "anyone else within earshot the need for policy action, and for voting in politicians who will support climate-friendly policies and voting out those who won't", he said.

In-orbit construction of China's space station to be completed this year

HE in-orbit construction of China's space station is expected to be completed this year, during which the country plans to carry out six launch missions, according to a press conference on the latest developments in China's space station construction held on April 17.

One day earlier, three Chinese astronauts of the Shenzhou-13 manned spaceship sent to orbit for the construction of China's space station returned to Earth safely after their six-month stay in space, completing the Shenzhou-13 manned spaceflight mission successfully.

sists of tasks in two stages: verification of key technologies and in-orbit construction, said Hao Chun, director of the China Manned Space Engineering Office (CMSEO), at the press confer-

March-5B, Tianhe core module of its space station, the Shenzhou-12 and Shenzhou-13 manned spacecraft, and the Tianzhou-2 and Tianzhou-3 cargo spacecraft, all of which helped the country achieve the goal of verifying key technologies for space station construction and laid a solid foundation for the completion of tasks during the next stage of in-orbit construction, according to Hao.

During the stage of key technology verification, breakthroughs have been made in many technologies, including those concerning astronauts' long-term stay and health care in space, regenerative environmental control and life support system, Hao pointed out.

The Shenzhou-13 crew's flawless completion of all scheduled duties demonstrates that China is fully capable of supporting astronauts' long-term stay in space.

The Tianhe core module of the space station has been in orbit for almost one year, during which it completed smoothly the rendezvous and docking with two manned spacecraft and two cargo spacecraft, Yang Hong, chief designer of the space station system of the China Manned Space Program, said at the press conference.

The core module's regenerative life support system has provided a optimal environment for astronauts' metabolism needs in orbit during the three-month stay of the Shenzhou-12 crew and the six-month stay of the Shenzhou-13 crew, Yang

Large-scale flexible solar cell wings have been supplying energy to the core module and the combinations of it and other spacecraft, and provided sufficient energy for tasks requiring a great amount of energy, such as extravehicular activities, rendezvous and docking, and a transposition test of the Tianzhou-2 cargo craft using the space station's robotic arm, with their power generation capacity exceeding design expectations.

The robotic arm has also played an important role in tasks during the whole stage of key technology verification. It has completed tasks in-

cluding assisting astronauts with their extravehicular activities, transposition of cargo spacecraft, and extravehicular status inspection.

As the key technology verification stage of the space station project has been completed, the project has officially entered the inorbit construction stage, according to Hao. China has planned six spaceflight missions for this year, includ-

ing the launch of the Tianzhou-4 cargo spacecraft in May, the Shenzhou-14 manned spacecraft in June, the lab module Wentian in July, the lab module Mengtian in October, the Tianzhou-5 cargo spacecraft and the Shenzhou-15 manned spacecraft, Hao said.

The Shenzhou-14 crew will consist of three astronauts, who will stay in orbit for six months, according to Hao, who disclosed that three more astronauts will be sent into space aboard the Shenzhou-15 spaceship near the end of the Shenzhou-14 mission. Crew members of Shenzhou-14 and Shenzhou-15 missions will spend a week together on board the space station during their rotation, after which the Shenzhou-15 crew members will work and live in space

The core module Tianhe and the lab modules, Wentian and Mengtian, will form a T shape to complete the in-orbit construction of China's space station, Hao said.

Research and development of the Wentian and Mengtian lab mod-

ules are progressing smoothly. Upon completion of the space station, the three modules will have a combined living space of more than 110 cubic meters.

With six sleeping areas and two sanitation areas, the space station will be able to support long-term stays by three astronauts and shortterm stays by six astronauts of two crews.

There will be more room for activities in the space station if counting that to be provided by manned spaceship and cargo spacecraft that will dock with the space station.

After the in-orbit construction of the space station is completed this year, the space station project will enter a new stage of application and development spanning more than 10 years, according to Hao, who added that the initial plan is to send two manned spaceships and two cargo spacecraft into space every year.

Meanwhile, astronauts will stay in orbit for an extended period of time to carry out space scientific and technological experiments and maintain the space station, he said.

China will also develop new-generation carrier rockets and manned spaceships so as to significantly enhance the country's manned space program's overall capabilities and technological lev-

el. Hao said. During the new stage of application and development, astronauts will use the science lab cabinets in the space station modules and large payload facilities outside the modules to carry out larger-scale space research experiments and tests of new technologies in fields including space life science and human body studies, microgravity physics science, space astronomy and Earth science, as well as new space technology.

"While carrying out research and development tasks for the construction of the space station, we have also pursued breakthroughs in key technologies for a manned lunar landing and deliberated on the plan for the mission," said Hao, adding that the focus of China's manned spaceflight missions will be shifted from the exploration of terrestrial space to that of cislunar space and then deep space.

FTER orbiting Earth for six months, the three crew members of China's Shenzhou XIII mission have departed from the Tiangong space station and returned to the mother planet on April 16th, finishing the nation's longest manned spaceflight.

When the People's Republic of China was just founded, it has been facing foreign technological blockade and containment. However, it has never shaken the confidence and will of the Chinese people. They see the upgrading foreign blockade as a power the drives them to work harder, and resort to independent innovation for developing their own technologies.

China is committed to realizing high-level sci-tech independence, but that doesn't mean that the country will shut the door for cooperation. Eyeing the future, China will advance international sci-tech exchanges with an opener mind and measures, and fully exploit international innovation resources to enhance innovation partnership and work with the rest of the world to promote global sci-tech progress and innovative development.

Lapse of UN Security Council's anti-piracy resolution may spell greater maritime security autonomy for Somalia

Piracy off the coast of Somalia has long captivated the attention of the media and governments. But the expiry of the United Nations Security Council's (UNSC) counter-piracy Resolution 2608 on 31 March attracted little publicity. It is the first time since 2008 that the UNSC has not renewed the region's piracy resolution.

The UN Convention on the Law of the Sea gives coastal states extensive rights and security responsibilities over their territorial seas - a zone extending 12 nautical miles from the coastline. In Somalia's case though, the government and navy were until recently practically non-existent, following the collapse of the state in 1991. Even so, international naval forces had to respect Somalia's territorial waters.

The problem of pirates using this zone as a refuge and the 12 nautical mile boundary as a barrier needed addressing. So annual UNSC resolutions since 2008 allowed foreign naval missions to legitimately use "all necessary means to repress acts of piracy and armed robbery" in this zone, with Somali consent. The resolutions allowed states to intervene in Somali territorial waters to pursue, intercept, seize and

Somalia's government increasingly insisted that the UN-SC's resolutions had achieved their primary objective of suppressing piracy and need not be renewed. Resolution 2068, adopted on 3 December 2021, was given a timeframe of just three months instead of the usual year. Somalia saw its continuation as an unfair imposition for two reasons.

First, the country has made progress in taking responsibility for its own security, both offshore and onshore. In August 2021. Somalia's Maritime Directorate began revising its maritime resource and security strategy. The National Maritime Coordination Committee initiated a mapping of all maritime activities, including international support.

Somalia's Ambassador to the UN Abukar Osman told the UNSC, "We have accelerated our efforts to build and capacitate our maritime law enforcement agencies and have established a specialised maritime unit to specifically deal with new international maritime threats and crimes".

According to the Somalia Transition Plan, security forces are expected to take over all responsibilities from the African Union mission in the country by 31 December 2024. The AU Transition Mission in Somalia (Atmis) has recently replaced the long-standing AU Mission in Somalia (Amisom). Maritime security has seldom featured in Amisom analysis and decision making, but piracy did exacerbate insecurity in Somalia by fuelling crime and corruption because of the circulation of large ransom pay-

Second, no successful hijacking has been reported since March 2017, and both attempts and attacks have declined sharply since 2013. This is referred to in the Secretary-General's 2021 report on piracy and armed robbery at sea off Somalia.

Observers such as the International Maritime Bureau suggest these remain insufficient reasons to let the UNSC resolution lapse, urging caution and pointing out that doing so might encourage piracy. Terrorism is worsening, as is the country's political crisis. It, therefore, seems unlikely that, in this context, Somalia's ability to provide maritime security will rapidly improve.

Several UNSC members, such as France, the United Kingdom and the United States (US), have advocated for the continuation of the anti-piracy measures, for example to protect World Food Programme vessels. The lapse is unlikely to reverse improved security trends but does raise questions about the continued presence of these and other big powers in the region.

First, crucial components of the maritime security architecture for dealing with Somali piracy remain in place. For instance, the internationally recognised transit corridor allows ships to safely travel the Gulf of Aden rather than sail close to Somalia. The shipping industry has also implemented several best practice measures that have reduced the risk of falling prey to pirates.

Second, criminal gangs capable of committing piracy have turned their attention to other illegal activities. To counter this threat, multilateral efforts are broadening their focus to incorporate transnational crimes at sea. Several counterpiracy initiatives have adapted to a new security reality off the coast of Somalia. The Jeddah Amendment to the Djibouti

Code of Conduct and the Contact Group on Illicit Maritime Activities in the Western Indian Ocean took proactive steps to revaluate or expand their mis-

The European Union's (EU) Operation Atalanta would be most affected by the nonrenewal of the counter-piracy resolution because access to Somali territorial waters was an essential component of fulfilling its mandate. The EU extended the operation for a year, expecting the UNSC resolution to be renewed. The problem was somewhat mitigated after the EU Council recently launched its Coordinated Maritime Presences concept, which complements Atalanta. The concept shows European resolve to stay involved in regional maritime security activities.

The changes brought on by the lapsing of the UNSC resolution will make it difficult for foreign countries to use counter-piracy to explain their military presence in the

region. AU Peace and Security Council members have shared their concerns about foreign military bases in Africa, many of which were justified in the name of fighting Somali piracy.

The enormous investments made by countries such as the US, Japan, Germany, Italy and China, combined with the interest of states such as Djibouti in generating revenue from their presence, means they are unlikely to vacate their bases soon. Growing geopolitical competition and militarism in the Indian Ocean, and insecurity stemming from the Yemen conflict, are also reasons why the situation probably won't change soon.

The way the EU, US, China and others now choose to frame their longer-term intentions in the region and their commitment to building Somalia's governance and security capabilities will be illuminated for the world to see.

"The government has been supervising closely to ensure that these new tourism products such as Serval Wildlife Zoo that operates well and adhere to all requirements so as to protect both animals and people," he said, noting that Serval Wildlife Zoo was a new product in Tanzania but can attract a lot of tourists because it allows people to see animals closely and enjoy their tour.

Fahad Nassor, manager of Serval Wildlife Zoo said they train animals in the zoo to get used to people and become friends whenever they visit them.

He said Serval Wildlife is a special zoo where tourists can be able to meet animals, stay with them in a friendly manner which is different to other zoos where no one is able to go near animals. Here animals can be trained to perform tricks, and visitors are able to get closer to them, feed them than in other zoos.

"In this zoo wildlife are friendly to human beings; and they're being managed by skilled experts, who are knowledgeable in everything and they're undergo medical check-ups for every six months," he said.

He called on zoo potential investors to be well-equipped with skills on how best they can venture into the new and promising industry. Tawa has been providing permits to investors on what to do, and it goes together with specialized animal catchers, who take the wildlife to the zoo.

The expert noted that price is set by the government in line with the required standards.

Serval Wildlife Zoo located between Mount Meru and Kilimanjaro is the first of that kinds in Tanzania, where wildlife can be kept and easily interact with human being, something which is different when the animal is the wilderness.

Road to European dream paved by extortion and exploitation

AST June, Mit Al Korama's youth gathered in front of one of their homes on a summer evening to tell stories of citizens from the village and neighboring villages who had successfully crossed the Mediterranean to Europe.

Some, they heard, returned with a large sum of money and built European-style homes for their families. Others chose to stay in the European Union and encouraged their brothers

A young man in his thirties from Talkha named "Mohamed Fakih" was among the group, and he said he assisted many people illegally migrating to the Italian coasts.

Despite the Egyptian government's warnings against illegal immigration and not visiting Libya, some young people continue to attempt to migrate illegally to Italy via Libya. Egyptian and Libyan smugglers put them at risk of drowning or kidnapping by gangs and armed militias demanding ransoms.

Fakih informed the Mit Al Korama youth that spots on a boat leaving for Italy in ten days were available. That spot could be theirs if they paid him 5000 US dollars.

Ahmed Emad, a 27-year-old with a diploma in tourism and hotels but no job, was one of five young people from the village keen on seeking a better life in Europe. To fund this trip to Italy, his family sold everything they owned and borrowed the rest.

"The mediator directed us to the Egyptian-Libyan border city of Salloum, where we met a group of smugglers who assisted us in crossing the border through mountain roads and out of sight of border guards. We arrived in Al-Masad, Libya," Emad told IPS. "The smugglers began to treat us differently there."

"As soon as we arrived, they pushed us into a huge building full of smuggled goods, fuel, sheep and cows, and people like us waiting for their turn to emigrate," Emad added.

The smugglers never stopped abusing and insulting the immigrants in the warehouse. When they complained to Fakih, the mediator who had taken their money, he advised them to wait patiently until the boat arrived to take the group to their final

"We were held captive in the warehouse for five and a half months, sleeping in the cow barn, drinking

from empty gasoline containers, and eating only one meal per day," Emad added.

Emad Eldanaf, his father, said they had no contact with the smugglers in Libya and were initially unable to reach the young men, making them highly anxious. Finally, contact was made.

"There were 28 men from our village on the boat. The most recent group returned in the last two weeks, and we're still negotiating with the militia about the remaining three," Eldanaf told IPS.

Emad's experiences were mirrored by Ibrahim Abdullah and his younger brother Kamal.

"We moved between several warehouses between Sabratha and Zuwara - 120 km west of Tripoli. On the eve of November 9, they told us we would sail from the Ajilat coast to Italy in hours," Abdullah told IPS.

"Eventually, we all moved to the boat, about 50 of us." The boat set sail at 11 pm.

"By dawn, water was seeping into the boat. We tried to drain the water until we became frustrated," Abdullah explained. "Death was only a few feet away."

According to Abdullah, the immigrants requested assistance from the Italian authorities, who said they would wait until the boat was closer to the Italian coast before intervening.

Tunisian authorities also ignored them. It was evident that they would sink with the boat and perish.

"We knew calling the Libyans would get us arrested, but we went ahead and did it anyway," Abdullah said, explaining their desperation.

"At noon, Libyan militia troops captured us and transported us to Tripoli port, splitting us into two groups, one sent to Prison 55 and the other in Bir Al Ghanam prison.

Bir al-Ghanam is a town in western Libya, located south of Zawiya. It was the site of several battles during the Libyan Civil War. Anti-Gaddafi forces took control of it on August 7, 2011, just weeks before taking Tripoli.

"We were referred to as 'the goods' by Libyan militias. They made us wish for death to be free of this agony. My father agreed to pay the ransom for our release after I pleaded with him," Abdullah recalls. "When the militias suspected that some families would not pay the ransom, they killed the detainees and threw their bodies in the desert. Two members of my group died and were thrown into the desert without being buried."

Emad, Kamal, and Abdullah remained with their militia for another four months. Lice and scabies were their lieutenants the entire time. Finally, their family reached

an agreement with the kidnappers, agreeing to pay US dollars 6000 for Kamal and Abdullah, while Emad's family had to pay US dollars 5000 to free him.

Haj Riad, a Libyan smuggler, acted as the middleman in the ransom payment. The money was transferred to several Libyan bank accounts, where he distributed it to militias and transported the three young men back to the Egyptian border.

Umm Ayman, a 60-year-old mother, sold a few of her land carats to raise 150,000 Egyptian Pounds (10,000 US dollars) to assist her two sons with their travels. Two of her three sons were then kidnapped with Emad and Abdullah.

A few months later, she had to sell her house, sheep, a cow, and the rest of her belongings, to pay US dollars 13,000 to have them back.

"We sold everything we owned to allow our children to travel, and we borrowed to bring them back. Even my mother's gold earrings had to be sold to pay the ransom," Ayman told

"When my children returned by the end of January, they sought out Fakih, the mediator, and found he had fled with his family."

The family believes he continues to entrap victims into the vicious circle as young people try to seek a better life in Europe.

CAG WANTS NHC TO TAKE LEGAL MEASURES AGAINST BMTL

HE Controller Auditor General (CAG) has directed the National Housing Limited (NHC) to take legal action against Business Machine Tanzania Limited (BMTL) and other officials for lack of trust after using the corporation's house to secure the bank loans without an approval from the owner (NHC).

However, the CAG has also called for the NHC to revisit its partnership policy to ensure that all weaknesses are removed to void any dangers that may arise from partnering firms.

This follows after the CAG audit for 2020/2021 found that BMTL used the NHC property title deed to secure 8.6bn/- loans without informing the owner.

The audit shows on June 25, 2005, NHC and BMTL entered into a partnership to develop plot number 39A with a title deed number 186156/32 located at Old Bagamoyo Road owned by the housing corporation.

The cost of the building was 8.66bn/- whereby 2.17bn/- or 25 percent of the share were owned by NHC and the remaining 6.49bn/or 75 percent were owned by BMTL as a strategic partner.

"Through my audit, I discovered that BMTL used the property title deed as collateral to secure concessional loan from three banks without informing the NHC, which is the owner," said CAG audit

The applied loans included 200mn/- from Diamond Trust Bank, 650mn/- from CF Union Bank and 650m/- from Savings and Credit bank, all totaling 1.5bn/-.

However, CAG unveiled that the house property which was under partnership was presented by BMTL as collateral to Bank M (which was later merged to Azania Bank) to secure a loan amounting 11.7bn/- without the approval of its NHC.

According to with reference number LR/T/186156/32/58 dated November 16, 2020 from the minister for land, house and human settlement development found that on June 5, 2015 the title deed for plot number 39A was put as collateral and registered under reference number FD 152161 with

the name of Bank M. However, CAG audit found that BMTL failed to service the obtained loans amounting 23.15bn/- from Bank M and the house was planned to be auctioned by Mark Auctioneer and Court Broker Co. on behalf of Azania Bank on July 27, 2020.

This indicated that, CAG said, BMTL was not trustful partner and NHC did not make any efforts to evaluate its business partner to determine its financial capability to implement such project.

Meanwhile, CAG audit has also found partners of the nine building projects with NHC which were under construction were leased by partners without any agreement with the housing corporation,

such as a house located at plot 4/44 in Mchikichini street in Dar es Salaam of which the partnership agreement was signed in April 2005.

"I have discovered that NHC did not earn any revenue from tenants of the buildings as partners claimed that in order to get dividends, the housing corporation must present title deeds for the ownership of the properties," CAG says.

Also, CAG audit shows NHC partners claimed that the leased area was part of the building they owned, based on distribution of flours as agreed on the agreement.

"The delay in establishing the partnership agreement has caused loss of funds that NHC would have generated from tenants," the CAG

Also, leasing uncompleted building under the partnership without an approval from NHC is denying its right to earn income from the property investment.

The audit has shown that NHC entered into agreement with various partners to invest on properties and until June 2021, the housing corporation had 149 such projects.

Through the audit, CAG has found some weaknesses on the partnership including delays in implementing the projects as the plots use were diverted into other use including turned into parking lots as well as delays in construction and NHC has never obtained any single shilling from those undeveloped plots.

Court rejects review of Spire STL'S natural gas pipeline

The US Supreme Court this week declined to review a lower court's decision that vacated FERC's approval of Spire STL Pipeline LLC, a completed 65-mile-long system that carries natural gas to the St. Louis area from Illinois.

Spire STL's system, initially issued a certificate by the Federal Energy Regulatory Commission in 2018, went into service in 2019. Scrutiny followed, with the Environmental Defense Fund (EDF) in 2020 arguing that the

certificate should be withdrawn because the Commission failed to follow its legal responsibilities when approving the project. FERC also should have more closely scru-

tinized Spire STL's precedent agreement with affiliate Spire Missouri Inc., EDF argued. In 2016, Spire STL had agreed to take about 87% of the system's expected capacity from the affili-

The U.S. Court of Appeals for the District of Columbia (DC) Circuit last December vacated the Commission's original certificate order.

The DC circuit ruling had followed one issued in June, when it agreed with EDF that FERC had failed to adequately examine the market need for the gas transmission project.

Spire appealed the lower court decision to the Supreme Court at the end of 2021, asking the justices to consider the potential "life threatening consequences" of what could happen without the estimated \$286 million gas pipeline already in service.

Spire STL connects to Rockies Express

Pipeline in Illinois and to points east in Missouri. While Spire had acknowledged that gas mand in the St. Louis area is expected to remain flat, the STL system enhanced reliability and supply security, it stated. Still, the Supreme Court declined to review the case in Spire Missouri Inc. et al v Environmental Defense Fund et al, No. 21-848.

'Since the STL Pipeline began service in November 2019, all market participants in the greater St. Louis region changed their pipeline supply arrangements," Spire noted. The STL system, it said, has allowed Spire Missouri to "reduce its captivity on Enable MRT, its historical supplier, that depends on gas production from the same gas producing regions in Texas and Oklahoma that suffered major operational disruptions just earlier this year during Winter Storm Uri," it said.

With the pipeline, Spire Missouri also has been able to "retire aging and obsolete infrastructure that required costly upgrades and maintenance," the company noted. In addition, the system has improved the "ability to provide service to the western-most areas of its St. Louis service territory without substantial cost," estimated at \$100 million, "and disruption to traffic and the environment in the region."

Spire said it is "pursuing options to bring in additional gas supply to the St. Louis region." Still, "increased gas demand and operational constraints" have reduced "Spire Missouri's ability to secure new firm supply contracts on other pipelines in the region...making it difficult to replace STL Pipeline supplies for the foreseeable future."

Analysts with ClearView Energy Partners LLC on Monday said, "In our view, Spire STL no longer needed Supreme Court intervention to ensure continued operations." FERC's temporary certificate order last December "appeared to provide much of the relief the court could

"Nevertheless, Spire STL's petition posed the 'to vacate or not to vacate' question in a pipeline proceeding to the nation's highest court for the second time in a year," the ClearView team noted.

Dakota Access LLC, whose 1,771-mile Dakota Access Pipeline (DAPL) oil conduit runs south from North Dakota, last September petitioned the Supreme Court to overturn another DC Circuit ruling. The circuit court had vacated authorizations from the U.S. Army Corps of Engineers because of a flawed National Environmental Policy Act review.

China-Europe trains stabilise trade amidst pressure on Shanghai port

Chinese producers and exporters are diversifying China-Europe trade routes by redirecting some orders from ships to trains and planes in an effort to tackle disruptions and uncertainties posed by the COVID-19 epidemic in Shanghai and some neighboring regions in the Yangtze River Delta, a major production and trade center.

The shift came as the port in Shanghai, the world's largest port in terms of container throughput, faces rising stockpiles of containers. Some large international shipping companies are suspending goods delivery at the port, posing serious challenges to the timely delivery of goods.

Some 60 percent of the goods lying at Shanghai port are "unclaimed" due to logistics disruptions on the roads and at sea, while the port has reached its limit and can hardly accommodate more containers, industry insiders said. The pressure has been passed on to the neighboring Ningbo Zhoushan port in East China's Zhejiang Province.

In the face of lingering uncertainties involving sea transport, some producers and exporters engaged in China-Europe trade are looking to diversify their trade routes from ships to trains and planes.

A trader based in Yiwu, a major small commodities trade hub in Zhejiang, told the Global Times on Sunday that he has received more inquiries from clients about diverting sea shipments to

person said.

What normally takes about 35 days by sea from Yiwu to cities in Germany only takes about 18-20 days by train, the trader said, indicating a clear competitive advantage for train service in avoiding disruptions.

China-Europe freight trains were dispatched from Yiwu, a year-on-year rise of 10.1 percent, a trend that industry insiders said would be sustained to ease the pressures at sea ports.

A factory manager in Yiwu told the Global Times on Sunday that the train is punctual, even though it may cost more than sea freight and the transport capacity is much lower. Planes are also part of his consideration at the moment.

The European Union Chamber of Commerce in China noted that its member companies estimated a 40 percent drop in the daily volume of cargo handled at the Shanghai port, according to media reports.

China-Europe freight trains. Wu Minghua, an independent industry analyst, told the Global Times that which is important, espethe major cause of sea freight disruptions is actucially for those more urgent ally on land, as truck drivers or high-value goods," the are still having difficulties in getting in and out of the port due to epidemic controls.

While cross-border freight trains can be an option in difficult times, sea transport will still be the main transport for international trade, industry experts said. In the first quarter, 370 A train can usually carry 50 standard containers, while a large ship can carry around 20,000.

Moreover, changing shipments from ships to trains is not always possible for various reasons, Tommy Tan, president of Shanghai EPU Supply Chain Management Co, an agent of China-EU freight trains, told the Global Times. Customers often prefer to choose another port instead, Tan said.

Some small and mediumsized traders are shifting to the Ningbo Zhoushan port, which is also under growing pressure. To smooth operations, the Shanghai Port has looked to strengthen the use of inland waterways and railways to unclog transport.

"While the government has set a goal of providing 85 percent clean and safe water in rural areas by 2025, this new investment is supporting our efforts to accomplish this daring ambition," he said. "We can't thank SBL enough for its dedication as this new plant also adds to 61 percent of the water supply in Hanang district."

Ester Elia, a Bassotu resident, joyfully celebrates the water plant's opening by expressing how beneficial it will be to their health.

"Now is the moment to cheer up

since our teeth will not discolor, and I am very delighted the price to get water here will be extremely reasonable,"

"I am extremely delighted to hear that this plan can supply water even to the other communities; I can't wait because I don't reside in Bassotu, so I am ready to tap from the fresh processed waters from this facility," says Alex Mkazi, who traveled from another hamlet to witness the launch.

The beer manufacturer funded the Nalgonda treatment plant, which was built by WaterAid to deflouride Lake Bassotu water after it was discovered that the community's Lake Bassotu water supply required immediate treatment after laboratory tests revealed that the water contained fluoride levels exceeding recommended World Health Organization (WHO) standards.

Following its completion, the project is now able to produce 900,000 litres of clean and safe water in 12 hours, which is enough to satisfy and exceed tions.

Bassotu ward's current average daily water demand of 700,000 litres.

Furthermore, the project has the overall potential to service Dangaida, Viendamudiga, and Dilna in Basuto Ward, which have a combined population of 14,000 people.

Consequently, by providing healthy water and eliminating disease and illness in the region caused by filthy, dangerous water, the beer maker's ingenious endeavor reinvigorates life in the hamlet and helps the community

US mortgage interest rates now stand at 12- year high

CALIFORNIA

THE average interest rate on the most popular U.S. home loan climbed to a 12 year high last week and fewer homebuyers sought properties in a sign that the Federal Reserve's aim of cooling the housing market may be beginning to have an impact, data from the Mortgage Bankers Association (MBA) showed on Wednesday.

The average contract rate on a 30-year fixed-rate mortgage increased to 5.20 percent in the week ended April 15 from 5.13 percent a week earlier, the MBA survey showed. It has risen 2 percentage points from one year ago.

The bulk of the run up, however, has occurred since the start of the year, causing the fastest climb in homefinancing costs in decades as the Fed abandoned a cautious approach to raising its benchmark overnight lending rate in favor of swifter and more decisive action to bring down persistently high inflation.

The central bank is also

set to decide at its next meeting on May 3-4 to begin reducing its portfolio of \$8.5 trillion of U.S. Treasuries and mortgagebacked securities, a stash of assets that had helped keep consumer borrowing costs for mortgages in particular - low throughout the COVID-

19 pandemic. Those expectations for Fed tightening actions have led to a surge in Treasury yields as financial markets reacted. The yield on the 10-year note US10YT=RR, which acts as a benchmark for mortgage rates, is at its highest level since 2018.

The latest increase in home-financing costs also led to fewer mortgage applications last week following a small bump in demand the prior week as buyers rushed to lock in rates before they moved higher.

The MBA said its Purchase Composite Index, a measure of all mortgage loan applications for purchase of a single family home, fell 3.0 percent on a seasonally adjusted basis to 254.0, while the refinance index fell 8 percent.

Share of real estate on Kenyan GDP grows further

NAIROBI

For the past two decades, the Kenyan real estate market has grown exponentially as evidenced by its contribution to the country's GDP which grew from 10.5 percent in 2000 to 12.6 percent in 2012 and 13.8 percent in 2016.

Greece to upgrade its LNG terminal to mitigate supply disruptions

ATHENS

GREECE'S only liquefied natural gas (LNG) terminal on the islet of Revithoussa near Athens will be upgraded as the country is preparing its energy system for the worst-case scenario, such as a complete cessation of natural gas supplies from Russia, Greek Prime Minister Kyriakos Mitsotakis said on Tuesday.

"Liquefied natural gas is extremely critical in order to achieve the expansion of gas supply sources. In this plan, Revithoussa in its current form, but

Managed by the Hellenic Gas Transmission System Operator (DESFA), the Revithoussa terminal is currently the only one in Greece that receives, temporarily stores and regasifies LNG and supplies the country's National Natural Gas Transmission System. Its LNG storage capacity is currently 225,000 cubic meters and can regasify 1,250 cubic meters per hour, according to the DESFA.

LNG cargoes arrived from six countries (the United States, Algeria, Nigeria, Egypt, Oman and Indonesia), according to DESFA data.

For years, approximately 40 percent of Greece's annual energy needs have been covered by imported Russian natural gas, according to the Ministry of Envi-

With activity continuing to rebound over the past year, East London's housing market is experiencing an influx of families, young professionals, and first-time buyers, says Sean Coetzee, area principal for Pam Golding Properties.

Says Coetzee: "Positively, with a median price of R1.34 million, freehold homes in East London offer good value and are accessibly priced for home seekers.'

For example, suburbs such as Cambridge and Amalinda, which were previously deemed 'blue collar' are enjoying an influx of buyers who are not only purchasing but making considerable improvements to properties, with sand, cement, and building materials in evidence in locations such as these, where modest starter homes can be had for as little as R1.1 million.

"Notably, and according to Lightstone statistics, over the 12-month period from April 2021 to March 2022, 76 percent of buyers were under the age of 50 years," says Coetzee. Also according to Lightstone, East London experienced a sharp increase in the number of plots sold in 2021, with a total of 245 plots sold, which is the highest number registered during the past decade.

Comments Coetzee: "We see many of our buyers purchasing now with a plan to build at a later stage on estates, especially on the East Coast, which has grown exponentially in popularity. For example, Balugha River Estate is 80 percent sold out and Khamanga Bay has seen a great deal of interest, especially in regard to vacant plot sales.'

Coetzee says there is a strong demand for decent, affordable accommodation for the city's senior citizens. "This is definitely a sector which offers lucrative returns for savvy investors and developers with the right product at the correct price."

Positive news for East London, with spin-offs for the local economy, including the residential property market, is Mercedes-Benz' R3 billion investment in production of the new generation C-Class.

In November last year, media reports stated that 16 companies in the automotive sector have invested a total of R3.3 billion in the East London Industrial Development Zone (IDZ), which is also expected to help boost the economy in the Eastern Cape, thereby creating in excess of 2 000 jobs, as well as further indirect jobs via the supply chain.

China's property sector could be turning around, analysts say

The tide may be turning on China's battered real estate

Investor confidence in the sector appears to be improving, as bond trading volumes and prices rose in recent weeks, in part boosted by the government's promise to support the sector and some loosening of policies.

But analysts say China's high-growth property market may be a thing of the past, set to be "changed forever" following the recent shakeup in the sector.

S&P Global Ratings said in an early April report that China's policy crackdown on its residential housing market has "bottomed," but that it will take several quarters for markets to feel the effects of the regulatory easing.

"When China's residential market emerges from this correction, it may be changed forever," S&P said. "We anticipate fewer developers will be able to employ the highly leveraged, fast-churn strategy that brought past success."

Recent reports show that some cities and banks are willing to support real estate again after a plunge in home sales in the last few months.

Since March, due to weakening market demand, banks in more than 100 cities in China have lowered mortgage rates by an average of 20

to 60 basis points, Zou Lan, director of the People's Bank of China's financial markets department, told reporters Thursday.

He also noted how Covid had affected some people's income and their ability to pay mortgages on time.

"It's hard to see the situation being resolved this year ... We will see developers not able to repay their debt.'

"The government's stance [is] trying to prevent the contagion, preventing the spillover from the real estate sector spillover to the real economy," Gary Ng, Asia-Pacific economist at Natixis, told CNBC in a phone interview earlier this month.

Any change in China's real estate industry has significant implications for the economy since property and

related sectors account for roughly a quarter of GDP, according to Moody's. The latest wave of Covid restrictions has added pressure to growth that was already slowing.

"The measures may have been too tight. Now we see this fine tuning of the policy," Ng said. "The worst time is over basically for those developers who are broadly in line with the current regulatory target or framework."

The problems of real estate developers in China came to a head after the authorities rolled out the so-called "three red lines" policy in August 2020, aimed at reining in developers after years of growth fueled by excessive debt. The policy places a limit on debt in relation to a firm's cash flows, assets and

capital levels.

While many developers reduced their debt levels accordingly, a result of the policy was that banks became less willing to lend to the sector.

Against this backdrop, Evergrande, the world's most indebted developer, fell into default for the first time late last year. As the debt crisis unraveled, other Chinese developers also started showing signs of strain - some missed interest payments, while others defaulted on their debt al-

The bond issuance in Asia's high yield bond market, dominated by Chinese real estate developers, slumped in the first quarter of this year. The region issued only \$4.4 billion worth of debt, about 85% lower than a year ago, according to data from Dealogic.

"This was a result of Chinese property developers largely being cut off from the bond market amid a growing number of stressed and distressed situations in the sector," said Dealogic.

However, sentiment turned around slightly in mid-March after China signaled support for its companies, and indicated that authorities would work toward stability in its struggling real estate sector.

THE Singapore property market has shown "a broad-based recovery", with improvement in metrics recorded across most segments, according to a 1Q2022 report by

The report comes ahead of property market data for 1Q2022 expected to be released by URA at the end of the month.

According to CBRE, both sellers and buyers adopted a wait-and-see approach post-cooling measures, with only 1,716 new private homes (excluding executive condominiums or ECs) sold in 1Q2022, well below the five-year average. "Private home returned in March.

price growth plateaued in 1Q2022 as cooling measures took effect," the report explains.

Private residential landed properties saw a marginal 0.4 percent increase q-o-q in prices, compared with a 5.0 percent surge in the preceding quarter. Overall non-landed home prices saw a 0.6 percent decline q-o-q, reversing from

the 5.3 percent growth in 4Q2021.

Government land sale sites Jalan Tembusu and Lentor Hills (Parcel A) saw subdued bidding as developers showed restraint post-cooling measures. Dairy Farm Walk and Bukit Batok West Avenue 8 EC site performed better, as confidence "Smaller collective sales also saw some success given the lower cost and development risk," the report adds.

CBRE expects new home sales to reach between 9,000 and 10,000 units, with prices rising by 3 percent, in 2022.

The office market continued to show strong momentum carried over from end-2021, as Singapore continued to open up, CBRE notes. The office market registered a third consecutive quarter of positive demand in 1Q2022, with a positive net absorption of 307,292 sq ft. Rents for Grade-A space in the core CBD increased by 1.4 percent q-o-q.

Non-bank financial institutions and technology companies underpinned

primary leasing demand, according to the report. Other rapidly growing sectors included pharmaceuticals, fast-moving consumer goods and flexible workspace operators.

CBRE forecasts core CBD Grade-A rents to grow by 6.9 percent y-o-y for 2022, on the back of the relaxation of workplace measures and limited supply.

"Occupier demand has generally improved across all submarkets, with islandwide business parks recording a positive net absorption of 186,982 sq ft in 1Q2022," the report states. Business park demand is in recovery, rebounding from negative levels in the preceding quarter.

WB chief warns food insecurity crisis could last into next year

THE Russia-Ukraine conflict has pushed up food prices and hit the poorest the hardest, World Bank Group President David Malpass said on Wednesday, warning that the food insecurity crisis will last for months and probably into next year.

"Its consequences are putting stress on poor people around the world," Malpass said at a virtual press conference during the 2022 Spring Meetings of the International Monetary Fund and the World Bank Group.

He noted that food prices are up already 37 percent year over year, and are going up more than Consumer Price Index, which is "significant" because it measures how much it hits the poor, who have to spend more on food in their daily budget.

The shortages of food, energy and fertiliz-

er - which are critical for the crop cycle, are "creating a food insecurity crisis that will last at least months and probably into next year," said Malpass.

"The food problem is severe... the prices crowd out the poorest, so it hits people in poor countries and especially in rural areas the hardest," the World Bank chief said in response to a question from Xinhua.

"There's also the tendency to move toward less nutritious food, if other food is not available in the diet," he continued.

On a positive note, he said, "we're entering this cycle of food insecurity with large global stockpiles, so as those are released, I think there can be progress," adding that it's important to start early.

Malpass noted there was "substantial" discussion on food security at the Spring Meetings on Tuesday, though he doesn't expect

an international agreement on the issue. "What I hope and expect is that many countries will step forward with individual solutions to alleviate the food crisis and the fertilizer crisis," he said.

At the press conference, the World Bank chief also noted that the multilateral lender expects to commit \$170 billion of financing over the next 15 months in the wake of the crises, which would be the largest set of commitments by the organization ever.

On vaccines, the World Bank will have committed 11 billion dollars in vaccination programs in 81 countries by the end of June, according to Malpass.

Malpass also urged policymakers to take steps to improve capital allocation of global resources, as the current capital allocation leads to deep and rising inequality. "That means more countries falling further behind, not making advancements, and not having the investment that is needed," the World Bank chief said.

"Some of that owes to the macro policies of the advanced economies. They've been borrowing very heavily from the global capital markets, which leaves less for other countries," he said. "That can be

Finnish parliament begins NATO debate

SEVERAl Finnish speakers on Wednesday stressed keeping the same pace with neighboring Sweden on the issue of joining NATO as the parliament began processing the extensive security document submitted by the government last week.

In the document, the cabinet took no stand on the membership but said membership of Finland and Sweden in NATO would reduce tension in the Baltic basin area in the long term.

The parliament discussion of the security report is expected to last a long time. The Parliament will not at this stage vote on the Finnish NATO membership, but the matter reverts back to the cabinet and the president.

The parliamentary vote would occur at the end of the would-be application process as Finland ratifies the agreement to join.

It is still unknown whether a simple majority would be sufficient for the passing or whether a two-thirds majority would be required. The issue is to be solved by the parliamentary constitutional committee, national broadcaster Yle reported.

Addressing the parliament, Prime Minister Sanna Marin expressed the hope that the parliament would debate the matter, showing respect to different views. "Unity is the best guarantee for security," she said.

"The time for decisions has come," Marin said. She elaborated that following recent decisions to boost defense, including a major air force investment, it is now time to talk about NATO membership. Marin has not published her personal view on the NATO issue yet.

Foreign Minister Pekka Haavisto underlined the importance of roughly simultaneous decisions by Finland and Sweden. He said that parallel processes in joining NATO would ease responding to a possible reaction by Russia. "Same pace" in the Finnish and Swedish processes was also echoed by Antti Lindtman, the chair of the Social Democratic parliamentary group.

"RUSSIA WILL ALWAYS BE OUR NEIGHBOR"

Foreign Minister Haavisto also took up the need to keep in contact with Russia in the future. "Russia will always be a neighbor to Finland, and effort must be made to maintain functioning relations with Russia," said Haavisto, adding that Finnish decisions are not directed against anyone.

Erkki Tuomioja, former Foreign Minister and current deputy chairman of the Parliamentary Foreign Affairs Committee, criticized the government report for lack of historical perspective.

Tuomioja said that a long-term view, both forward and backward, is needed. "The consideration of all good and bad aspects and risks must now be assessed by parliament," Tuomioja said, adding that he would base his stand on what information and answers will be obtained during the process.

STRONG SUPPORT, BUT QUESTIONS REMAIN

In their speeches Wednesday, many MPs have considered NATO membership to be a justified choice for Finland in the parliamentary debate on the security report.

Centrist Defence Minister Antti Kaikkonen said the most important impact of the NATO membership would be that Finland would be part of joint defense and within security guarantees. "The impediment against attacking Finland would increase," he said.

Kaikkonen added that general conscription, trained reserve, and high appreciation of national defense by the population would be cornerstones of Finnish defense also in the future.

It was previously reported that there were opposing opinions to Finland joining NATO because, with NATO membership, Finland would have to send troops to participate in NATO operations.

Finland would itself decide whether Finnish soldiers are sent to NATO operations abroad, Kaikkonen said.

Still, some speakers were concerned about the military alliance. The solution to applying for NATO is for many to

choose between two bad options, said national broadcaster Yle in an analytical article Wednesday. Jussi Saramo, chairman of the Left Alliance parliamen-

tary group, said the negative sides of becoming militarily allied have not been sufficiently focused on in the debate. As a NATO member, "Finland would be a potential target of a first strike," said Saramo. Xinhua



Macron cements frontrunner status with combative debate

PARIS

FRENCH President Emmanuel Macron cleared a major hurdle on the path to re-election with a combative TV debate performance against far-right candidate Marine Le Pen that convinced most viewers, a poll said, even if he was still deemed arrogant.

Although Le Pen came across as more polished and composed than in a TV duel for the presidency in 2017. Macron went on the offensive over her ties to Russian leadership, her plans for the economy and her policy for the European Union.

With the deciding vote just four days away, some 59 percent of viewers found Macron to have been the most convincing in the debate, according to a snap poll for BFM TV. That suggested the almost threehour showdown would not alter the course of the election, with Macron ahead in all previous polls.

Voter surveys have shown a widening of Macron's lead over Le Pen

to as much as 56 percent-44 percent since the first round on April 10, and analysts said the debate was unlikely to swing voting intentions in Le Pen's favor.

"Yes, Emmanuel Macron won but his adversary has avoided a repeat of last time's disaster," Gerard Araud, a former French ambassador said on Twitter. "This debate doesn't disqualify her like the one in 2017, but it doesn't help her close the gap either."

On the offensive for most of the debate, Macron's most piercing line of attack was on a loan to Le Pen's party for her 2017 campaign contracted through a Russian bank.

On the cost of living, rated the most important issue for the French in this election, Macron also appeared to put Le Pen on the defensive, asking her why she had voted against his plans to cap electricity prices if she wanted to help hard-up workers.

fully enjoy their human rights. It claims that the increasing racial discrimination against Asians exposes the country's fundamental racist nature.

Some U.S. politicians and media outlets are reluctant to acknowledge the racial discrimination against Asian Americans, but massive incidents are telling the truth that such discrimination is getting

According to a survey released by the Center for the Study of Hate and Extremism at California State University, San Bernardino (CSUSB), hate crime cases in the U.S. decreased by 7 percent in 2020 compared with 2019, but those against Asian Americans increased by 149

According to a report published on Nov. 18, 2021 by the national coalition Stop Asian American and Pacific Islander Hate, from March 19, 2020 to Sept. 30, 2021, a total of 10,370 hate incidents against Asian American and Pacific Islander people were reported to the organization, with the majority of the incidents took place in public spaces such as public streets and

Statistics released by the New York City Police Department on Dec. 8, 2021 showed that anti-Asian hate crimes in the city rose by 361 percent from that of 2020.

The UN Secretary-General António Guterres said in March 2021 that "Thousands of incidents across the past year have perpetuated a centuries-long history of intolerance, stereotyping, scapegoating, exploi-

> Discrimination on a systematic basis is akin to a long-standing malignancy in the United States. In the late 19th century, some politicians and media deliberately stigmatized Asian Americans as "Yellow Peril," and in 1924, all Asians were forbidden to immigrate to the U.S.

> Asian Americans have suffered from long-time prejudice, exclusion, and racial violence. The Associated Press once observed that "Racism against Asian Americans has long been an ugly thread in the

U.S. history."

British court approves extradition of Julian Assange to US

LONDON

BRITAIN'S Westminster Magistrate's Court issued a formal order on Wednesday to extradite WikiLeaks founder Julian Assange to the United States to face espionage charges.

The decision on whether to approve the

extradition now rests with British Home Secretary Priti Patel, although Assange's lawyers may still appeal within 14 days against any decision that approves the extradition.

"In layman's terms, I am duty bound to send your case to the Secretary of State for a decision," said chief magistrate Paul Goldspring after he issued the extradition order.

Last month, Britain's Supreme Court denied Assange permission to appeal against a High Court decision to extradite him to the United States.

Assange, 50, is wanted in the United States on allegations of disclosing national defense information following WikiLeaks's publication of hundreds of thousands of leaked military documents relating to the Afghanistan and Iraq wars a decade ago, which included an Apache helicopter video footage documenting the U.S. military gunning down Reuters journalists and children in Baghdad's streets in 2007.

He has been held at south London's high-security Belmarsh Prison since 2019.

He married his long-term partner Stella Moris, a lawyer, in the prison last month. The U.S. request to extradite Assange from Britain is politically motivated, Moris said last December.

The U.S. extradition request for Assange is retaliation in disguise, and this constitutes yet another example of the United States encroaching on other countries' sovereignty, Moris said.

"The United States is abusing its real power, its ability to get others to do what it wants because of its might, in order to silence him, because he has embarrassed parts of the United States," Moris said then.

Anger grows in South Korea over US-run labs

HONG KONG

BIOLOGICAL laboratories run by the United States military in South Korea are endangering residents' lives, and the experiments carried out at the facilities for military purposes should be banned, experts say.

"The fact that (these) facilities are located in Busan Port, where the population is dense, in a form the Korean government is not aware of at all, poses a risk of catastrophic and widespread civilian damage," said Woo Hee-jong, professor of the College of Veterinary Medicine at Seoul National University.

The academic linked the labs to the disaster that struck India when a gas leak at a US-owned factory in the city of Bhopal killed thousands of people in 1984.

Jeon Wi-bong, director of a civil group campaigning to shut down the biolabs in Busan Port, said there are about 20 schools, 30 apartment complexes, and major transport links within a 3-kilometer radius of the base that hosts the facilities

In contrast, the US army set up its Dugway biolab in the Utah desert, Jeon said. In 1968, about 6,000 sheep died in the Dugway area. The Salt Lake Tribune newspaper reported that the nerve agent VX was found in the area, citing a declassified report in 1978.

Although the US government claims that the South Korean biolabs were set up for biosurveil-lance purposes against biochemical threats, evidence unearthed has undermined this claim.

"JUPITR ATD is entirely part of the US military biowarfare-related overseas military strategy," said Woo, accusing the US of installing the facility in South Korea because it considers the Asian country to be part of its occupied sphere of influence. JUPITR ATD is the acronym for a biochemical lab project operated by the United States Forces Korea, or USFK.

Despite public criticism, the USFK has "deceived" South Koreans by denying the accusations made against the labs and making

excuses for their actions, Jeon said. When people protested against the JUPITR facility in Busan in 2016, the US asserted that no biochemical samples would be brought to the base. Yet it was found that biochemical samples were carried in dozens of times between 2017 and 2019, Jeon said.

In 2015, the Pentagon confirmed that it "inadvertently" sent live anthrax samples to a US lab in South Korea. A joint South Korea-US investigation found out later that samples of the lethal bacteria had been sent to South Korea 16 times since 2009.

Noting the development of bioweapons is strictly banned by the Biological Weapons Convention, Jeon said the biolabs operated by the USFK violate the convention and can be investigated by the United Nations Security Council if the South Korean government files a complaint. The convention has been signed by more than 180 nations, including South Korea and the US.

"Under Article 9 of SOFA, military cargo delivered to the USFK bases is not subject to customs inspection. As a result, the Korean people will not know anything even if the biochemical samples are delivered to these bases," said Jeon. SOFA refers to the Status of Forces Agreement, the military pact between the US and South Korea.

Woo said information about the overall status of the facility in question is still hidden as only some media and a few non-specialists had been invited to see its general experimental equipment in the past. He said the USFK had not been cooperative in addressing the concerns raised by the public.

Woo said the "unilateral and unequal" SOFA needed to be renegotiated for the South Korean government to at least secure information on the import of hazardous substances into the country.

From April 4-10, a group of activists and residents traveled across South Korea, staging a series of rallies calling for the end of joint military exercises between South Korea and the US as well as the closure of the USFK's bases and biolabs.

The US stations nearly 30,000 troops in South Korea after the 1950-53 war on the peninsula. The USFK's headquarters, Camp Humphreys in Pyeongtaek on the west coast, is the largest US overseas military base.

On April 5, Kim Moonjun, a professor from Kongju National University, submitted a petition to President-elect Yoon Suk-yeol's transition committee demanding the return of the land occupied by the Yongsan US base in central Seoul and the revision of the "unequal" SOFA, the Incheon Ilbo newspaper reported.

African officials say creation of smart cities on course to boost resilience

THE creation of smart and green cities across the sub-Saharan African region is on course to boost their resilience in the face of climate emergencies, disease outbreaks and mounting pollution, officials said on Wednesday at a virtual briefing in Nairobi, the Kenyan capital.

"Cities are critical to Africa's transformation and therefore we need to make them smarter, inclusive and resilient to the climate crisis and pandemic," Jean Pierre Elong, the secretary-general of United Cities and Local Governments of Africa (UCLG), remarked during an online briefing on the upcoming ninth edition of Africities Summit slated for May 17-21 in western Kenyan city of Kisumu

He said the continent stood to gain from investing in urban centers that are greener, digital and resilient to environmental shocks.

According to Elong, some of the key deliberations in the five-day summit include greening African cities, converting them into hubs for innovations and enterprise, sharing best practices to enhance urban renewal, and taming rural-urban influx in the continent.

Elong called on African leaders to prioritize investments in sound urban planning, green mobility and basic amenities like education, health, clean water and sanitation in order to make their cities livable and more resilient. Eugene Wamalwa, Kenya's Acting Cabinet Secretary for Devolution, said that East Africa's largest economy was leveraging innovative financing and robust policy tools in its bid to convert cities into hubs for growth, enterprise and cohesion.

Wamalwa said that by hosting the ninth edition of the Africities Summit, Kenya stood to gain from global best practices on stimulating urban renewal besides showcasing investment opportunities in its rapidly growing cities and rural towns.

The creation of smart, greener and resilient cities is also anchored on Kenya's vision 2030 development blueprint, according to Wamalwa. The summit, which is scheduled for May this year in Kisumu City, Western Kenya, will also provide an opportunity for discussion on how to prepare for the forthcoming Climate change conference (Cop27) to be held in Egypt in November this year.

Israeli war planes strike Gaza after rocket attack

ISRAEL carried out air strikes in central Gaza before dawn yesterday after a rocket launched from the Palestinian territory landed in Israel, Hamas officials and Israeli military sources said.

Two training camps used by Hamas, the Islamist group that rules the blockaded enclave, and no casualties were reported, witnesses said.

Israeli war planes struck a security post and part of an underground site used to produce rocket engines, the Israeli military said in a statement.

Earlier, a rocket fired from Gaza struck southern Israel, causing

slight damage to a house but no injuries, police said. No faction claimed responsibility for what is the second such attack in days.

An upsurge of violence in Israel and the occupied Palestinian territories has raised fears of a slide back to wider conflict. Since March, Israeli forces have killed at least 29 Palestinians in West Bank raids, and a series of deadly Arab street attacks have killed 14 people in Israel.

In a statement, Hamas said Israel's bombing will only

encourage Palestinians to "resist the occupation and step up their support for Jerusalem and its people". Confrontations in Jerusalem's Old City - particularly at Al-Aqsa mosque compound, known to Jews as Tem-

at Al-Aqsa mosque compound, known to Jews as Temple Mount - pose the risk of a relapse into a broader conflagration like last year's 11-day Israel-Gaza war, in which more than 250 Palestinians in Gaza and 13 people in Israel were killed.

Tensions this year have been heightened in part by the Muslim holy month of Ramadan coinciding with the Jewish celebration of Passover. By allowing more Jewish worshippers into the sacred compound, Palestinians say Israel is violating a centuries-old policy according to which non-Muslims may visit but not pray. Israeli leaders have said they are ensuring freedom of worship for all religions in Jerusalem.

Al-Aqsa is the third holiest site in Islam and also revered by Jews as the location of two ancient temples.

Palestinians want East Jerusalem, including its Muslim, Christian and Jewish holy sites, as the capital of a future state. Israel, which annexed East Jerusalem in a move not internationally recognized after capturing the area in a 1967 war, regards all of Jerusalem as its eternal capital.

G20 members urged to help stabilise world

BEIJING

IN the face of risks and challenges, all G2O members should work together to help stabilize the world, Chinese Finance Minister Liu Kun said.

Liu made the remarks when addressing the G20 Finance Ministers and Central Bank Governors Meeting held in Washington, DC both online and offline on April 20-21.

Liu said via video that G20 members should be committed to improving the international system with the UN at its core and the international order underpinned by international law, and avoid politicizing or weaponizing the world economy.

He added that G20 members should establish a sense of community, adopt responsible economic policies and explore innovative momentum to energize global growth, as well as address the concerns of developing countries through multiple channels and ensure that people's livelihoods are not impacted.

China welcomes all parties to support and participate in the Global Development Initiative, with a view to accelerating the implementation of the UN 2030 Agenda for Sustainable Development, Liu said.

China will continue to work with all parties to improve the global health governance system and strengthen financing cooperation against the pan-

Hong Kong begins relaxing social distancing restrictions

THE Hong Kong government has started relaxing social distancing measures.

The first stage, which went into effect yesterday, allows dine-in services at catering businesses and restaurants until 10 pm, four hours later than before, with the maximum allowed number of people per table increased to four, up from two.

Venues such as fitness centers, beauty parlors, massage spas, cinemas and religious sites were allowed to reopen, with seating capacity capped at 50 percent. Leisure and cultural services facilities, such as outdoor sports venues, public libraries and museums, also reopened.

Simon Wong Kit-lung, honorary chairman of the Institute of Dining Professionals who also manages the restaurant chains under the LH Group, said his group's restaurants are almost fully booked for the next two weeks, bringing business back to almost 80 percent of pre-pandemic levels.

But he cautioned that since only four people are allowed per table, traditional Chinese restaurants may not benefit as much – even though they can now host banquets for a maximum of 20 guests.

"If the 20 people have to sit at five tables,

not everyone would rush to make a booking

for Chinese restaurants – even for Mother's Day," he said.

The hospitality sector yesterday welcomed the relaxation of social distancing rules, say-

the relaxation of social distancing rules, saying the move hopefully will finally improve their incomes.

Meanwhile travel agencies now can organize the control of the con

Meanwhile, travel agencies now can organize local tours of 30 people, provided that tourist guides and customers have three and two vaccine doses respectively. If rapid antigen test results are negative for all customers, then the total number of customers per tour can be increased to 100.

An estimated 18,000 Hong Kong residents flocked to Ocean Park Hong Kong on Thurs-

day, the first day it was open since the park was closed because of the stringent social distancing measures.

Local visitors said that they will avoid mass gatherings when they are having meals in the park. Vaccinated overseas tourists are worried they have to wait in long lines to play game machines.

Gianna Hsu, the chairman of Travel Industry Council of Hong Kong, said it has received some 70 agencies' applications to host local tours, but she warned that local tours alone will not revive the industry without the resumption of cross-border travel.

In the first stage of the social distancing relaxation measures, the maximum number of people permitted at group gatherings in public places will be increased from two to four, while the prohibition on gatherings at private premises involving more than two households will be canceled. Members of the public must continue to wear a mask on all public transportation and in public places.

Meanwhile, the president of the Licensed Massage Association, Chow Chun-yu, said an estimated 2,000 massage spas reopened on Thursday, and bookings are quite full for the upcoming week.

Premises such as bars and pubs, party rooms and karaoke establishments as well as public beaches will be allowed to reopen in the second stage.

Dine-in service hours at catering businesses and restaurants will be extended to midnight, with the maximum number of people per table increased to eight.

In the third and last phase, the restrictions on the maximum number of customers, business and dine-in hours, as well as the limitation on the number of people per group gathering at all catering and scheduled premises, will be lifted.

A year of coach Nabi at Yanga

THIS week marks a year since Nasreddine Nabi was confirmed to take over Young Africans SC, popularly known as Yanga, as the head coach.

The Tunisian tactician succeeded Burundian Cedric Kaze and signed an initial 18-month contract, with an option to extend it.

It has been nothing short of a sensational journey so far. He led them to a second-place finish in the Premier League, as well as finishing runners-up in the Federation Cup last season.

At the start of this season, he led Yanga to beat city rivals Simba to win the Community Shield for the first time

Yanga remains the only unbeaten side in the 2021/22 NBC Premier League after 19 games.

They currently sit top of the league table, 10 points ahead of their intercity rivals Simba, and they have a genuine shot at winning their first league title since 2016/17.

Yanga has a chance at the double with a Federation Cup semi-final on the horizon where Nabi could potentially face Simba once again as the two clubs compete on two fronts in the domestic scene.

When Nabi arrived, there was a perceived gulf between Yanga and Simba but it is now assumed the gap is paper-thin.

In terms of statistical standings, Nabi has won 28 of the 38 games he has managed to date - a win percentage of

74% in all competitions.

So far Azam FC, Simba, and Rivers United have managed to inflict defeat on Nabi in that period.

After losing 1-0 to Azam FC in his first game in charge, Nabi is on a 27 unbeaten run in the league.

No Premier League side has lost fewer matches than Yanga in the competition since this time last year.

Nabi has been named the NBC Premier League coach of the Month three times. After guiding Yanga to victories against Simba and Ihefu SC and one draw with Dodoma Jiji FC, Nabi was named Coach of the Month for the first last season,

winning July's award. In October, Nabi led Yanga to three wins against Azam FC, Kinondoni Municipal Council (KMC) FC, and Geita Gold FC to take the coach's monthly award for the second time.

February was another good month for Nabi having won his third coach of the month award in Tanzania.

The lowest point in Nabi's reign was losing the Federation Cup final to Simba, with Taddeo Lwanga's secondhalf header from a corner kick taken by Luis Miquissone denying the Tunisian his first taste of domestic cup success in Tanzanian football.

There was also a failure in the CAF Champions League at the start of this

Yanga was eliminated by Nigeria's Rivers United in the preliminary round of the CAF Champions League in September, losing 1-0 in both legs.

Yanga head coach keen on sealing **NBC Premier League triumph**

YOUNG Africans SC (Yanga) head coach Nasreddine Nabi has said he needs to guide his outfit to victory in the next three Premier League matches to secure the top-flight title this season.

The coach made it clear that he wants to have his outfit play the three matches more strategically because the teams his side is to face are tough and are planning to disrupt it.

"We have a lot of work to do to make sure we achieve our championship goal, we have three tough matches that we have to play very carefully to win but my players have to work hard to achieve the goals," Nabi revealed.

Pundits' views on Taifa Stars' AFCON group maths not convincing, but all will still be well

RELIMINARY assessments chances for Taifa Stars in its group encounters with Uganda, Niger and Algeria are tentative and brave, to say the least, in the sense of putting up as much spin as possible, but they cannot arrive at any assurance as to the ability to make substantial gains in the

What was noticeable was the extent to which the wish for victory in whatever contest or match was being expressed, trying to pull at any likely string that may set the stage for an upset.

Any win by the national side will be an upset, with the sole exception of Niger, they still impressed in the latest finals.

By implication, the level at which Comoros played in that tourney, or Malawi and Niger for that matter were surprising, showing how African soccer at the national level is changing in tandem with club soccer.

That is where a sort of imbalance is seen among countries, that there are those with sufficient levels of investment of sponsorship capable of hiring good players and good coaches from around Africa especially, or within their specific regions to start with.

And at the national level, there are countries with better traditions of migration to the West, as well as flexible citizenship rules easing the signing of such youths.

Just one club has so far been able to scale sufficient heights of sponsorship and coaching recruitment to make a name in continental soccer, reaching quarterfinals once or twice, of off the cuff ethno-re- make a greater impact on

and the group stage more or less repeatedly.

Others have barely dipped their feet into this or that tournament and left it in a huff.

At least on that score, Tanzania has been able to print its name on the African soccer map, but national team success has been long and drawn out, such that even its appearance in the 2019 finals was typical of also-rans.

There was a commotion at the top level after that event, which ought to be discounted in this context.

Looking at that period and at the moment, there is noticeable realism as to what permits a national side to be good or put up an acceptable level of competition with the others, for instance discussing teams by rankings instead gional characterizations, a match. for instance, if 'Arabs' can win at the Benjamin Mkapa

There is at most a wish that the local stadium remains with an indomitable image as embodying a sort of magic wand where visiting teams are bound to

Stadium, etc.

It is hard to say that this view is backed up by substantive evidence, but the local club champions can lay claim to such a rule.

Yet even with the club side, the higher one goes up in a competition the more the preliminary rules fail to work, as they are more applicable when a team competes with more equal sides, where auxiliary factors like a home crowd and turf, the time at which the sympathy of officials

When the difference in skills is more noticeable, with quarterfinals starting for Simba SC lately, such presumed advantages are scaled to the minimum, as the psychological side of the contest has a smaller role to play compared with a weaker side at the preliminary stage.

That is why this difficulty also behooves Taifa Stars in their group stage outings as some preliminary rules won't work.

Listening to how the debates or discussions were proceeding, it was apparent that the wish to make the Benjamin Mkapa Stadium a trump card in the national side's chances was overwhelming, which comes down to saying a match is played and even there were few valid technical arguments for

The corollary to that projection is that we are likely to lose our foreign outings and rely on the local turf, but here spin takes effect, where a marginal expression of confidence in the team to obtain a draw in such fixtures, not daring to say it wins (with the possible exception of the lower placed sides in FIFA ranks, it remained unconvincing, all the same.

Focusing impregnable character of playing at the Benjamin Mkapa arena risks pulling the national side into 'technical committees' of another age, though it is at the club level that such phantasmagoria was often being heard.

What looks like it will change this time is how far the national side head coach may stand to be blamed, and what reasons could be cited for that kind of attitude, in case Tanzania takes third or last position, despite that even a second slot in the outcome wouldn't make a difference.

Only the top side proceeds with whatever stage, like making it to the World Cup or being placed for the playoffs, etc.

The national side coach is the anchor of this success in monitoring those playing outside and to an extent in grooming some of them as coaches of national youth teams earlier.

Complainers will be hard put as to where to start, in 2019 they still leveled their guns at the tactician, ex-Barcelona star Emmanuel Amunike.

Man United hire Erik ten Hag as 5th manager in 9 years

MANCHESTER, England

A MODEL of stability in Alex Ferguson's long trophyfilled tenure, Manchester United hired a fifth full-time manager in nine years since his retirement by bringing in Erik ten Hag from Ajax.

Ten Hag's arrival was announced by United on Thursday and the 52-year-old Dutchman will join at the end of the season to 2025. He's tasked with awakening a fallen superpower in European soccer that is enduring its longest trophy drought in nearly 40 years.

United has been led by interim managers Michael Carrick and currently Ralf Rangnick since Ole Gunnar Solskjaer was fired in November.

Adopting the attacking philosophy of the great Johan Cruyff, ten Hag succeeded in bringing the good times back to Ajax, leading the biggest team in the Netherlands to two Eredivisie titles - it could be three in a few weeks – as well as the Champions League semifinals in

Returning United to its former heights is set to be an even bigger job, given the team won the last of its record 20 English titles in 2013 – Ferguson's final season of his 26-year reign – and hasn't won a trophy since beating Ajax in the Europa League final in 2017.

United hasn't endured such a trophy drought in 40 vears and has slipped way behind rivals Manchester City and Liverpool despite continuing to spend heavily

The three-time European champion might not even return to the Champions League next season. United is three points out of the Premier League top four with five games remaining.

Ten Hag might be the biggest managerial gamble in United's turbulent post-Ferguson era.

Aside from a two-year spell with Bayern Munich's reserve team (in 2013-15, when Pep Guardiola was in charge of the first team), ten Hag has coached only in the Netherlands – with Go Ahead Eagles, Utrecht and most recently Ajax since 2017.

As such, he is untested in handling the egos of some of the biggest names in world soccer – and United has some of them in Cristiano Ronaldo, Paul Pogba and Bruno Fernandes.

An advocate of the 4-3-3 that is so popular in the Netherlands, ten Hag tries to play attractive, attacking football in the manner of the teams coached by Cruyff, whose shadow and philosophy hangs over the club like Ferguson's does at Old Trafford.

Ten Hag accepts his toughest challenge as Man Utd manager

ERIK Ten Hag has never shied away from a challenge, but the biggest task of the Dutchman's coaching career awaits after accepting the role of Manchester United

Ten Hag, 52, will leave Ajax at the end of the season having restored their pride at the top table of European football in the Champions League and dominated domestically in his four years in charge.

Performing a similar turnaround in United's fortunes after nearly a decade in the doldrums will be a higher mountain to scale.

But Ten Hag boasts an unblemished managerial record from his unconventional route to one of the sport's most prized jobs.

An unremarkable playing career included three spells as FC Twente, where he won his only major trophy as captain in the 2001 Dutch Cup.

It was at Twente where his journey as a coach began too, working alongside former United assistant and England manager Steve McLaren.

"I thought I knew football before, but going there and experiencing that... I knew nothing about football," McLaren told The Athletic of his experience with Ten

"I have to sit up in the stands to see the patterns of a game, but he could stand on the touchline (and see them). He always knew the answer to everything, how to change shape, change positions."

In his first role as a manager in his own right, Ten Hag got Go Ahead Eagles promoted to the top-flight of

Yet, instead of testing himself in the Eredivisie, he took the bold decision to take over Bayern Munich's reserve side in the fourth-tier of German football.

His two years in Munich coincided with Pep Guardiola's time as boss at Bayern with Ten Hag keen to soak up as much knowledge as he could from the Manchester City manager and the culture of working for a European giant.

"During my time at Bayern Munich, among other things, I saw how things work (at a big club)," Ten Hag said reflecting on his time in Germany.

"Every detail can be picked out for analysis. The media, people in general, always find something if you look for it. A hundred things can go right, if one thing goes wrong, people highlight it."

That level of scrutiny is now what he will have to get used to and a club where plenty has gone wrong in recent years.

Despite boasting one of the largest wage bills in world football, United have not won a trophy for five years.

Barring an unlikely resurrection in the final weeks they will not even by playing in the Champions League next season.

Man City wake up against Brighton to take lead from Liverpool in title race

watched Liverpool take top spot in the Premier League table on Tuesday night and then promptly claimed it back. Brighton, who arrived after back-to-back wins over Arsenal and Tottenham Hotspur, haven't had so much as a draw in this part of Manchester since 1982 but things like that don't matter when there are titles on the line. Graham Potter's team were so

well organised that City only managed one shot on target during the first half. With each opportunity that came and went the frustrated groans in the stands got louder and louder and more and more televisions in Liverpool flicked over to the football.

But by the time clocked reached 65 minutes it was back to the regular scheduled programming. On 53 minutes, Riyad Mahrez bundled his way through and scored for the 23rd time this season thanks to a deflection off Joel Veltman. The second, scored by Foden 12 minutes later, went in off Enock Mwepu.

Even teams as good as City need a bit of luck sometimes. They might need a bit more here on Saturday. particularly if Watford are as organised and resilient as Brighton. This time City get to put the pressure on Liverpool with Jurgen Klopp's side not in action until 24 hours later against Everton at Anfield.

"Liverpool are one of the best teams in football history," added Guardiola. "There are six games left and if we win all the games,

we are champions. If we don't win all the games, Liverpool will be champi-

"We have to win all the games. It's not necessary to tell that to the players, they feel it. We're competing with one of the best teams

After a gruelling stretch of games which, according to Guardiola, saw his players treated for a combined 71 injuries last week they are about to enter another one. After Watford on Saturday, it's the Champions League semifinal first leg against Real Madrid at the Etihad on Tuesday followed by a trip to Elland Road to face Leeds United four days later and then the return leg in Madrid at the Bernabeu.

The good news for Guardiola -- now the fastest manager to reach 250 English top-flight wins -- is that Ruben Dias was able to make his comeback from a hamstring injury as a half-time substitute against Brighton while Kevin De Bruyne, injured against Atletico Madrid last week, was brilliant for 83 minutes. City will need everyone -- particularly key players like De Bruyne and Dias -- if

they are going to hold off Liverpool and safely negotiate these next six games while also trying to win the Champions League for the first time in their history.

For now, Guardiola is just happy to be playing in the competition next season.

"It is one of the happiest days as next season we will be in the Champions League," said Guardiola. "People take it for granted but we have to be in the Champions League. When it happens mathematically it's because we have done really well. If you ask every club what the target is, it is to qualify for the Champions League. We have done it again. Once we got that it means we did really well so far and now we know exactly what we have to do. The players feel it."

After a rare three-game spell without a win and Liverpool demolishing Manchester United a day earlier, it would have been easy for City to creak under the pressure. Instead, they held their nerve and began the business end of the season the best possible way. One down, six to go.



It says everything about the vulnerabilities of every team below Liverpool and Manchester City that Arsenal can lose to Crystal Palace, Brighton & Hove Albion and Southampton at this relatively late stage of the campaign yet beat Chelsea and still have more than a puncher's chance of Champions League football. The difference may come from bitpart or fringe players seizing their opportunity.
