Speaker Ndugai says Parliament will be effective in govt oversight

NATIONAL Assembly Speaker Job Ndugai yesterday promised that the House will play its oversight role effectively despite being overwhelmingly from the ruling party.

In his acceptance speech shortly after being sworn-in for his second mandate in the chair, Ndugai told the public to expect serious and hot debates despite the near absence of opposition representatives.

He appealed to members of Parliament to fully play their roles in keeping checks on the government, saying the 12th Parliament has to achieve more than previous legislatures.

He reminded the lawmakers that their biggest task is to actively participate in matters raised in the House and whoever chose to keep quiet in fear of being cited as arrogant by some people or party will face challenges when seeking reelection in 2025.

He said that all MPs were elected to represent electorates by speaking in Parliament about issues affecting them, specifically cautioning CCM MPs that its crushing majority isn't meant to relent in the push for development and fulfilling election promises.

"It is evident that vast majority of members in this House are from CCM. You have to participate as expected of you and refrain from the notion that you will just pass issues without serious debates," he said.

He reiterated the call by President John Magufuli to the nation at his swearing-in ceremony, that elections are gone and that people should get down to work, saving, "After today's oath, we should know that we are done with elections. What is left is to deliver," he declared.

Those who will be lucky to be appointed ministers and deputy ministers should expect a rough time ahead as the legislature will do everything required to deliver on public expectations, he emphasised.

"The public expects a lot from this Parliament," the Speaker underlined, pointing out the need to work overtime to meet their expectations. As the highest



DOJ launches probe on 'baseless' Trump claims

WASHINGTON DC

INTERNATIONAL observers have criticised Donald Trump (pictured) for pushing "baseless allegations of systemic deficiencies" in last week's US election. Candidates should be responsible and not promote "harmful speculation," the Organisation of American States warned.

Bill Barr, the US attorney general, has authorised the Department of Justice to investigate "substantial" claims of voter fraud - prompting one of his top lawyers to resign. Richard Pilger said the move went against a "40-year-old non-intervention policy."

Joe Biden's team said it would only fuel the 'specious, speculative, fanciful or far-fetched claims' he professes to guard against, citing wording from Barr's memo describing claims the DOJ would not pursue. Trump and other Republicans have alleged widespread fraud, without offering any proof.

Meanwhile, the president-elect is preparing to defend the Affordable Care Act

The Serengeti has scooped Africa's Leading getaway in Mafia District, Thanda Island, grabbed Africa's Leading Luxury Island.

This is the second time in a row the destinations have won the categories they first scooped last year.

"The results follow a year-long search for the world's top travel, tourism and hospitality brands. Votes were cast by travel industry professionals and the public, with the nominee gaining the most votes in a category named as the winner," World Travel Awards posted in an announcement on Monday

Three die, one hurt in stray jumbos rampage

THREE people at Mtonya and Tulieni villages in Mindu and Napanya wards in Tunduru District, Ruvuma Region were crushed to death by elephants who invaded the villages.

Another Mtonya villager, Zuberi Mchopa (70) was admitted at Tunduru District Hospital for treatment after surviving a similar attack.


District Wildlife Officer Limbega Ally said yesterday that the incidents happened at different times on Monday, and after learning of the incidents, he dispatched armed game wardens "to chase away the elephants."

He mentioned the deceased as Jamila Mathayo Mchopa (47) of Tulieni village, Jastini Gideon Mchopa (54) of Mtonya who was killed as he was returning home from his farm and Stephano Hassan Joseph (78) of Mtonya village who was at his farm.

He said the tragic incidents werel due to villagers conducting farming activities in wildlife corridors connecting Lumesule Forest Reserve in Nanyumbu District, Mtwara Region and the Mwalimu Nyerere National Park (earlier part of the vast Selous Game Reserve).

More importantly, Slovak Republic stands ready to work together with all of our partners to enhance the economic well being through collaboration in trade and investments.

He said the two countries' relations have always been positive and it is his sincere believe that it will remain positive forever.

"This positive atmosphere also reflects on the promising outlook that Slovak Republic and Tanzania will enjoy from our cordial relations", he said.

The envoy said Slovak and Tanzania with all its potential would surely be able to develop stronger economic relations that will benefit the people.

The honorary Consul pledged to improve the tourism industry by inviting more tourists from Slovak to

in March, this year. According to the latest OECD Economic Outlook, Slovakia is set to

become the fastest growing developed economy in the world by 2020. The Organisation for Economic

Cooperation and Development (OECD) forecasts that the Slovak economy will grow at a robust rate of 3.6 per cent in 2020, the highest GDP growth rate among OECD economies.

Trailing behind Slovakia, other fastgrowing developed economies are Ireland and Poland (both 4 pc growth in 2019), Chile (3.7pc), Estonia (3.5 pc), Hungary and Latvia (both 3.9pc) and Slovenia (3.6 pc).

Bukoba in new battle to end malnutrition and stunting

AUTHORITIES in Bukoba have embarked in a programme aimed at eliminating malnutrition and stunting by encouraging primary and secondary schools to establish nutrition clubs that will provide a platform for students to extensively discuss issues related to balanced diet.

Bukoba District Executive Director, Solomon Kimilike revealed here yesterday when speaking at a meeting involving various stakeholders, including representatives from government, civil society organisations and media personnel.

Chaired by Kilimnike, the meeting was meant to chart ways to address malnutrition and stunting in the region, which is one of key food crop producers in the country, but reports have it that some children welfare was being endangered by malnutrition and stunting, hence, the need for immediate and serious measures to be in place.

According to the DED, serious campaign on the matter is a vital initiative that could help the district and the region at large mitigate the challenge.

So far Maruku and and Kemondo secondary schools are the only institutions, which had established nutrition clubs.

Kimilike commended the schools for their efforts, asking all primary and secondary schools in the district to emulate the spirit by establishing nutrition clubs within three weeks.

"Let students gather and discuss how to achieve optimum health, and heads of school should ensure they meet their needs," he said.

Nelson Sospater, District Education Officer for secondary schools and Joseph Matope, acting District Education Officer for primary schools promised to work on the directives for better results.

Matope also tasked all primary schools in the area to have hand washing facilities with running waters, and ensure that all schools provide

porridge at their respective premises.

District nutrition officer, Desdery Karugaba said the district performing well when it comes to nutrition related issued as they regularly communicate with parents and guardians, insisting on good environment when preparing and cooking their meals with more focus on balanced diet.

According to the Tanzania Demographic and Health Survey 's key findings report for 2015-2016, one in three Tanzanian children aged under five are stunted due to a chronic lack of essential growth nutrients such as vitamins and minerals. In the worst affected areas of the country, this ratio rises to almost one in two.

Business begins in House as Ndugai retains Speaker's seat

THE 12th parliament yesterday started its sitting after Members of Parliament overwhelmingly elected Kongwa Member of Parliament Job Ndugai as Speaker of the National Assembly.

Ndugai who was the Speaker in the 11th Parliament got 344 out of the 345 votes from the lawmakers as only one MP disapproved his bid to lead the August House for another five years.

He was the only contestant for the position after another candidate who had shown interest of becoming the Speaker was blocked after failing meet the conditions.

Speaking before the voting, the election manager who is also the Clerk of the National Assembly, Stephen Kigaigai said there were two people who showed interest in the post, one being Job Ndugai who was endorsed by Chama cha Mapinduzi(CCM) and Bonaventure Ndekeja of the National League for Democracy (NLD).

He said his office made announcement to the interested people and parties to submit their applications not later than 9th November, 2020 at 4:00 pm.

The other condition, according to the constitution, he said is that any person nominated by a political party to vie for the highest position in the Parliament, if not MP should file application at the National Electoral Commission (NEC) who has the mandate to certify if he or she qualifies to be a Member of Parliament.

Kigaigai said that up to the 9th November, 2020 deadline, only Ndugai had submitted his application at the Clerk's Office and it was until 6:00 pm, two hours after the deadline that Ndejekela's submission through email was received.

Tanzania Wildlife Research Institute (TAWIRI) has cautioned people living around the park to avoid discharging water saturated with chemicals into the river that is used by wildlife for drinking.

in the Serengeti National Park, Dr Emmanuel Masenga, TAWIRI director called on people living in the areas to avoid cutting trees and throw wastes into river Mara.

He said the preservation of the river that flows along the middle of the park was essential because its water is used by the wildlife and other creatures that were essential for the country's tourism sector.

Speaking at the Mara-Mori forum Fund (WWF) said people living in the

National Park's peripheries have from time to time been trained on environmental preservation.

He said in that plan they incorporated government officials, traditional leaders and other stakeholders including NGOs on tree planting campaign and cultivation of environment-friendly crops.

"We are assisting small miners to conduct their production activities Kanuni Kanuni, environmental by adhering to environmental coordinator from World Wildlife regulations and avoid discharging poison water into the river," he said.

RC orders crackdown on cement price hikers

TANGA Regional Commissioner Martine Shigela has instructed district officials and other leaders in the region to conduct crackdown on traders who hike the price of cement, as the ex-factory price of the commodity had not gone up.

The RC gave the instruction here yesterday during his visit at Kilimanjaro Cement factory in the city after reports of cement price hikes in some shops.

He said the aim of the crackdown was to identify and take steps for all traders who will be found to have deliberately hiked the cement price after hearing about cement shortage following the factory's mechanical breakdown.

"My order to government officials and other leaders at all levels to conduct crackdowns in your areas to find traders who hike cement price and should take legal steps against them including withdrawal of their trading licences," he stressed.

He also warned traders to stop hiking prices without official announcement, adding that many traders have the habit of hoarding goods in their go-downs and whenever there are production hitches they raise the prices the products.

"Cement is in plenty in the factory and its price had not been raised hence it illegal for the traders to take decisions of their own in hiking price," he said.

Filbert Nshange, the factory's chief financial officer explained that they have not raised the cement's ex-factory price contrary to claims, only that in the past one month, production stopped due to mechanical problems of the plant.

He said they have two ex-factory prices - for buyers from Tanga City they sell at 11,600/- per bag and for traders coming from outside Tanga the price is 10,600/- per bag.

Elders in Mbeya request enhanced health insurance

SENIOR citizens in Mbeya City have called on the government to issue enhanced health care insurance services to enable them get treatment at major health centres.

Gwantwa Mwakitalima, the chairman of the elders' 'Tumaini la Wazee' group in the city told reporters here that among obstacles for them was lack of health insurance acceptable to hospitals.

Mwakitalima said as for now the health insurance provided to them is acceptable only at health centres and dispensaries, and added that from the nature of their diseases, they ought to get treatment at hospitals.

Mwakitalima also appealed to the government and other stakeholders to provide them with food, accommodation and money for medical treatment.

He said due to financial impediments the elders, who hail from Nonde, Itiji, Maendeleo and Majengo wards in the city have no money to fend for themselves.

Rose Wilson, community worker providing services to the group said obstacles she encounters is that many of them have no financial means and ability to go for treatment at health centres.

She said many of them suffer from blood pressure and diabetes and have lost all ability to fend for themselves.

One of the elders, Mariana Chande said due to her age and the disease she was suffering from, she can no longer do any productive work that can give her even one meal a day.

Prakseda Mbulu, Secretary of Women of Purpose, a group for women reporters said apart from providing occasional assistance to the group, they also have the obligation to speak for their plight.

Govt help sought as scarcity of bags sees farmers fail to haul cashews to markets

A shortage of bags facing cashew nuts farmers in Nanyumbu and Masasi districts who are members of Masasi and Mtwara Cooperative Union (MAMCU), has made hundreds of tonnes of the crop fail to reach the ongoing cashew nuts auctions for more than a month now.

Cashew nuts farmers from various Agricultural Marketing Cooperative Societies (AMCOS) in Masasi District told this paper yesterday that for more than a month now there had been an acute shortage of bags in MAMCU, the situation that had seen many of them fail to take the crop to the auctions, and called for immediate government intervention.

Peter Jamali, a cashew nuts farmer and member of Mpeta AMCOS in Masasi District said the situation for cashew nuts farmers in AMCOS was pathetic, as huge quantities of the crop were packed in smaller sulphate bags (viroba) that are unfit for cashew nuts storage.

Jamali said in the circumstances there was great possibility of the crop to lose its quality by the time it is sent for sale, thereby lowering the price as well.

He said as for now it was difficult to know exactly the tonnage of the crop that fail to reach main warehouses for auctioning, but it was believed to be in hundreds of tonnes.

Another cashew nut farmer identified by only one name - Ajuwaye said they were surprised to see MAMCU without gunny bags and called for immediate government intervention.

He said bags shortage experienced during every cashew nuts selling season was becoming hardcore in MAMCU inflicting untold losses of incomes by farmers.

Salumu Mwarabu, Mpemwena AMCOS secretary said the volume of

the cashew nuts reaching auctions was small compared to what farmers had produced, adding that the main reason for the situation was the shortage of the bags.

Speaking to this paper about the complaints, Joseph Mmole, MAMCU manager for Masasi and Nanyumbu districts said the shortage of bags was attributed by the failure of the agent contracted to distribute the bags to do so on time.

"True, there are hundreds of bags of cashew nuts that had not reached the auctions due to lack of bags for storage, but we as the secondary union was making a follow up," he said..

He said the demand of bags for MAMCU's Masasi and Nanyumbu districts was one million bags, but so far only 500,000 bags were available.

NATURAL resources department is warning Tanga City residents to be on the lookout for crocodiles, which are on the increase in Kange dam located close to the city's bus terminal.

Crocodiles are on the increase in the area, which come from Mkurumazi river, which is close to people's settlements.

Natural resources officer in the city council, Aneny Nyirenda urged people to be alert of the alligators, the of coming out from the water and

dangerous predators.

Nyirenda warned women and children who wash clothes and swim in the dam to be careful as they should be watchful as the reptiles can attack people at anytime.

"So, people should avoid doing activities in the dam and river too as they are known for their ambush hunting technique, the crocodiles are indiscriminate hunters and attack any animal that comes within reach including humans.

"Their attack usually takes the form

clamping its victim in its powerful jaws, dragging them back into the water to drown them before stashing them under submerged branches or rocks to eat later," he said.

According to the official, the largest freshwater predators come from Mkurumuzi river to the dam as they look for food.

Crocodile is known for its aggressive nature and they are involved in most fatal attacks on humans, killing an estimated 300 people each year in the continent.

were killed, and several others injured by crocodiles on the banks of Zigi river since January in Muheza District, Tanga Region.

Muheza district forestry officer Jane Madege blamed villagers for ignoring the government's warnings to stay away from the river.

"We've been asking people not to engage in any activities within 60 meters from Zigi river because apart from exposing themselves to the crocodiles, it is also against the environmental protection law," said In 2018, it was reported that 17 people Madege.

TANZANIA Sisal Board (TSB) has embarked on an operation to assess sisal plantations across the country and warned to revoke ownership from the investors who had failed to develop them.

Mariam Nkumba TSB chair made the remarks yesterday here urging all investors to address the challenges because the board will not hesitate to reposses the farms, as it has been given full authority to do so.

"We have embarked on a special operation to assess all sisal plantations in a new move aimed to strengthen production of sisal, through the exercise, we will know the actual number of the plantations and farmers," she said.

The board chair pointed out that land was a major resource in boosting the production of the crop so the board will ensure that sisal farms are well developed.

She added: "When visiting the farms, we expect to see them clean and well prepared. Those which are undeveloped will be repossessed by the government and given to investors with the ability to develop them," she added.

According to her, the board is well prepared to make major reforms in developing the plantations to increase sisal production and revenue generation in order to benefit the country.

For his part, sisal farmers; agriculture marketing societies chairman, Greyson Nyari acknowledged that majority of farmers are still grappling to have modern processing machines of crop.

"In a bid to produce quality sisal, farmers need to have modern machines which will make the procedures easier with little costs," he said.

Sad Kambona, TSB director said the sisal industry has been growing year by year due to high demand of sisal for various industrial uses like automotive, construction and many others.

'There is high demand of sisal in Spain and Morocco, where tonnes of the produce are needed. The traders have been purchasing it at a fair price," he said.

Kambona further said that currently the sisal industry in the country is implementing its Ten Years' Sisal Development Plan for 2011-2021 whose major focus is to increase production and productivity, increased value addition of sisal, increase number of smallholder farmers in sisal production.

Dr Cantherine Senkoro, executive director of the Tanzania Agricultural Research Institute (TARI) Mlingano said that the government through the institution will produce five million seedlings of sisal crop.

Tanzania sisal industry is the oldest industry in the country which was established in 1893 when sisal plant was first introduced in the country by a Germany agronomist Dr. Richard Hindorf who brought the plant from Yucatan Mexico. From Tanzania then sisal spread to other sisal growing countries in Africa mainly Kenya, Madagascar, Mozambique, Angola and South Africa. However, at the moment Angola and South Africa are no longer producing sisal.

The major markets for Tanzanian sisal are China, Nigeria, Saudi Arabia, Hispania, India, German, Japan, Kenya, Libya, Uganda, Morocco, Ivory Coast, Zimbabwe and Egypt. Tanzania is the world's second largest producer of sisal after Brazil. It currently, has a total area of 153,540.61 hectares which is equivalent to 383,851.525 acres.

The Eastern Africa Sustainable Forest Programme had a 5-years strategy (2016-2020) and was designed to add value to the work that is already being implemented at the country level particularly going beyond things that are bilateral and regional in nature. on species and ecosystems evident. are already Projections indicate that unless emissions are rapidly reduced the climate crisis will get substantially worse. As ocean warming causes fish stocks to migrate toward cooler waters to maintain their preferred thermal environment, many of the nations that rely on commercial fish species as an integral part of their economy could suffer.

A new study published in Nature Sustainability from the University of Delaware, the University of California, Santa Barbara and Hokkaido University, shows that nations in the tropicsespecially Northwest African nationsare especially vulnerable to this potential species loss due to climate change. Not only are tropical countries at risk for the loss of fish stocks, the study found there are not currently any adequate policy interventions to help mitigate affected countries' potential losses.

The researchers used previously projected changes in the distribution range of 779 commercial fish species to estimate the number of species exiting national jurisdiction under contrasting emissions scenarios up to 2100.

Tropical nations in particular stand to lose the most species because there are few if any stocks to replace those leaving. Under a moderate emissions scenario, the research showed that by the year 2100, the average tropical nation could lose 7 percent of the species that were present in 2012.

While the exit of stocks from national fisheries is inevitable, carefully designed international cooperation could ease the impact on individual nations while preserving the resource for others. In addition to looking at the species loss, the researchers examined 127 international fisheries agreements, looking at the large, regional ones as

HE impacts of climate change well as smaller bi-lateral agreements. They found that none of the agreements have language that prepares countries for the exits of stock, climate change or range shifts.

> Traditional fisheries management assumes that fish are a renewable natural resource and that so long as their geographic range is static, they will remain plentiful in the absence of overfishing. But the long-term migration of a species out of a country due to climate change means that fish stocks may not always be renewable on the level of a given jurisdiction, even if they remain renewable on an international scale. For the jurisdiction losing the stock, this creates an incentive to overfish before it exits.

How to handle liability for loss and damages from climate changeincluding whether countries that are more developed and have emitted more carbon dioxide should be compensating countries that are less developed-has been an ongoing discussion throughout the annual United Nations' Conference of the Parties (COP) meetings during which countries work to address climate change.

In the most recent COP 25 meeting in Madrid in December, compensation was again discussed, and the meeting highlighted the interplay between climate change and the ocean, but fisheries were not addressed.

While the Small Island Developing States have so far concentrated on concerns about becoming climate migrants as their land is overtaken by the ocean, Oremus said the study should encourage them and other tropical nations to bring fisheries into the conversation. For many nations where fish are one of the main economic resources driving their gross domestic product, this is something that they'll want to take into account when they join together to try and negotiate climate agreements.

Ethiopia's slide into civil war is unfortunate reading, indeed

IGHTING has begun between the armed forces of the Ethiopian federal government and provincial authorities in Tigray, home to the dominant ethnic group in that country before the current administration of Prime Minister Abiy Ahmed took over back in 2017, amid yet another crisis, mass demonstrations, etc. The conflict arose from reforms carried out by the new premier, where the old guard (and mainly coming from the rebel province) complained they were being targeted in corruption cases. We have seen something of the sort in political tussles across the border, but not descending into war

A rather surprising element in how Ethiopia descended into civil war was the postponement of elections that were earlier due to take place in August, but postponed on account of lockdowns ordered in the wake of the Covid-19 pandemic from mid-March. Powerful Tigray political forces weren't convinced of this alibi and soon organized their own polls at about the time the national polls would have been held, and as the federal government did not follow suit to get the vote going, the region's legislature passed a motion of non-recognition of the federal government. As tensions continued, armed groups mobilized in Tigray readying for worsening conflict attacked an army camp for federal troops, crossing a government red line.

This descending into civil war is a lesson in political reform, and perhaps in global attitudes concerning reform in Africa generally, as the measures in vogue since around 1999 have overly focused on political reform, to ensure that countries hold free and fair elections. This view doesn't address basic questions of why countries descend into unrest and civil war, as such issues involve making choices on what economic systems work and which don't, and what ought to be done. Most African countries have retained tribal or communal structures dotting the countryside, where groups clash about water, land, livestock and posts.

The speed at which African countries slide into civil war on account of sharper struggles for control of resources, or dominating governments in order to decide on resources in favor of this or that part of the country isn't homogenous. But scarcely any African state is free from resource pressures leading to civil war, and for one thing, with most African economies nearly equaling at least a quarter of economies of smaller European powers, advanced economies want to trade with Africa, not aid it beat its odds. In other words there is no development aid formula for civil wars, but the International Criminal Court can assist.

Another strategic element that is being missed among analysts of African civil wars is that African states or national communities need a different integrating force from the sort of motleys of forces they have in each country, as virtually each of them suffers from economic stagnation in one way or another.

The worst case scenarios are still the bigger economies where conflicts rob them of ability to reach their potential (by Western or Far East standards), but even smaller economies have a sorry tale of stagnation since independence. This integrating force is to absorb their respective ethnic Diasporas by granting dual citizenships and allowing purchases of property at the local level, by themselves and their partners from the countries they were residing. This gives local people the cash to move into business and employ others, while purchasers basically start larger projects that industrialise the country. Conflict ends then.

Joseph R. Biden, Jr., was born on November 20, 1943 in the city of Scranton, the Commonwealth of Pennsylvania, to a working class family. His father was a furnace cleaner and a used car salesperson.[i] As a kid, Joe's dad lost his job in Scranton and had to seek employment in a neighboring state, Delaware. Regional aviation college and snags in advanced of training flight personnel

ALTHOUGH aviation in the country is growing rapidly, it is facing a shortage of aviation personnel like aircraft maintenance engineers and flight dispatchers.

To address this challenge, the government needs to invest in aviation colleges, enabling those who run such colleges to obtain sufficient learning and teaching materials. They also need to have workshops and instructors, to attain set targets in skilled aviation sector labour force

Regional Aviation College Principal, Hulka Omar says that the college has begun to offer the aircraft maintenance engineering (AME) course and the flight dispatch/flight operations course to students.

More than 170 students pursuing the AME course graduated and were employed by airline companies like Precision Air, Air Tanzania, Coastal Airlines, Auric Air and a Dubai flight company.

Demand for AME graduates is high, with 60 percent likely positions still unmet, he said, proceeding to

invite students dreaming to join airlines to pursue the AME course as employment opportunities are still high,, with offers from Nigeria, Kenya and Dubai.

AME is a technical training course preparing students in the maintenance of an aircraft, its various parts and engines. Students must pass science related subjects with a D pass and above, he stated.

Before a flight starts, AME experts work hard and make sure that each and every functional system in the aircraft is in working condition. The safety standards must be being followed so that the aircraft is flight worthy.

In short, AME professionals play a crucial role in the smooth functioning of aeroplanes, so it is an opwho studied in Canada, UK, China, Uganda, Pakistan, Scotland and other countries.

Before introducing the AME course, such experts were hired from Britain, Germany, USA, France and elsewhere, with local airline firms spending much money to hire them.

Elaborating on flight dispatch/ flight operations course, he says this is a six- month course introduced in 2014. Such personnel provide pilots with navigation information, relaying flight plan guidelines to ensure safe flight, he says.

the help of a team of people on the ground, aircraft dispatchers being a crucial link, checking flight fuel, flight plans, load control/weight balance, safety guidelines and weather patterns. No flight can take off without the dispatcher's permission, he pointed out.

The flight dispatcher must take into account the weather, at the start and during the flight and at its final destination. That means studying winds, thinking about alternative destinations, fuel requirements, altitudes and general traffic flow, he elaborated.

So far more than 350 students have graduated in this course, with graduates obtaining jobs in airports around the world with firms such as Swissport and United Aviation Services (UAS).

Students with ambition to work for airlines companies or airports agement, business studies, hotel should pass at least four science management, human resources subjects that include geography, physics, mathematics, chemistry with four D passes or above.

Operational decisions often come straight from a dispatcher who has Flight crew cannot fly without to let pilots know of any safety hazards or changes that can come up without warning, he further noted.

Dispatchers figure out how much fuel will be consumed during the flight, additional fuel that should be on the plane in case the pilot has to steer clear of weather or get to an alternate airport, he said.

COVID-19 hits life-saving health services in Africa

THE COVID-19 pandemic has dealt a heavy blow to key health services in Africa, raising worries that some of the continent's major health challenges could worsen.

The preliminary analysis by the World Health Organization (WHO) of five key essential health service indicators that include outpatient consultation, inpatient admission, skilled birth attendance, treatment of confirmed malaria cases and provision of the combination pentavalent vaccine in 14 countries finds a sharp decline in these services between January and September 2020 compared with the two previous years.

The gaps were the widest in May, June and July, corresponding to when many countries had put in place and enforced movement restrictions and other social and public health measures to check the spread of COVID-19. strong women empowerment agenda such as Bureau Veritas accomplish their goals by providing a platform to engage, connect, mobilize and impact their women communities through mentorship, knowledge sharing, and access to opportunities. During these three months, services in the five monitored areas dropped on average by more than 50% in the 14 countries compared with the same period in 2019.

"The COVID-19 pandemic has brought hidden, dangerous knock-on effects for health in Africa. With health resources focused heavily on COVID-19, as well as fear and restrictions on people's daily lives, vulnerable populations face a rising risk of falling through the cracks," said Dr Matshidiso Moeti, WHO Regional Director for Africa.

"We must reinforce our health systems to better withstand future shocks. A strong health system is the bedrock for emergency preparedness and response. As countries ease COVID-19 restrictions, we must not leave the door open for the pandemic to resurge," said Dr Moeti. "A new wave of COVID-19 infections could further disrupt life-saving health services, which are only now recovering from the initial impact."

Even prior to the COVID-19 pandemic, maternal mortality in sub-Saharan Africa was unacceptably high, accounting for about two-thirds of global maternal deaths in 2017. Preliminary data indicates that COVID-19 is likely to exacerbate women's health challenges and the new analysis found that skilled birth attendance in the 14 countries dropped.

In Nigeria, 362 700 pregnant women missed ante-natal care between March and August 2020. Over 97 000 women gave birth away from health facilities and over 193 000 missed postnatal care within two days of giving birth. There were 310 maternal deaths in Nigerian health facilities in August 2020, nearly double the figure in August 2019.

An additional 1.37 million children across the African region missed the Bacille Calmette-Guerin (BCG) vaccine which protects against Tuberculosis (TB) and an extra 1.32 million children aged under one year missed their first dose of measles vaccine between January and August 2020, when compared with the same period in 2019.

Immunization campaigns covering measles, yellow fever, polio and other diseases have been postponed in at least 15 African countries this year. The introduction of new vaccines has been halted and several countries have reported running out of vaccine stocks.

"Now that countries are easing their restrictions, it's critical that they implement catch-up vaccination campaigns quickly," said Dr Moeti.

"The longer, large numbers of children remain unprotected against measles and other childhood diseases, the more likely we could see deadly outbreaks flaring up and claiming more lives than COVID-19."

WHO has issued guidance on how to provide safe immunization services, including how to conduct a careful risk assessment before implementing preventive mass vaccination, with attention to appropriate protective measures to avoid transmission of COVID-19.

Why natural wet sponge of the Eastern Arc Mountains is being sent to 'graveyard'-Part 1

HE natural wet sponge of the Eastern Arch Mountains is being sent to the graveyard. Unlike in the past, currently, the number of upstream rivers and waterfalls are disappearing permanently and thousands of hector of forests are being degraded through illegal practices. An investigation conducted for nearly six month along the Arch Mountains has revealed that the natural wet sponge which usually holds water all the year-long while releasing it gradually in the form of waterfalls is swiftly drying. This potential Eastern Arc Mountains (EAMs) contains about 100 endemic species of animals, about 270 endemic species of plants, and about 50 percent of the forest cover (451,948 ha), within the largest remaining patches. The existence and survival of all these depends also on how the villagers surrounding the EAMs conserve and manage the village land forest reserves (VLFR) because they are interdependent.

The villagers and the natural resource committee of Handeni and Kilindi districts which form part of the Eastern Arch Mountains say if that situation continues unstopped, the life cycle of three major rivers of Ruvu, Pangani and Wami is also in danger. They will be soon be subjected to natural death.

Legal and economic experts have also described the predominance of the activities as contrary to the law. They include illegal agricultural activities in the forest reserve, charcoal harvesting, pastoralists, illegal timber and logs harvesting. These activities are threatening the existence of this important forest reserve along the Eastern Arch Mountains. The unsustainable activities have largely affected clean supply of water into the major rivers for the residents of Dar es Salaam, Morogoro, Coast and Tanga regions. They have also cleared the most valuable timber trees for illegal trade.

The case of Gole village, Handeni district, Tanga Region

The EAMs are not an island; they need total and conservation support and initiatives from in and outside the Arch Mountains. One of these are the village land forest reserves especially those adjacent or close to the Arch Mountains.

Gole village lies on the foothills of the Eastern Arch Mountains in Handeni District, Tanga Region. The villagers have 233 households with a total population of 1,668 including 835 women and 833 men are the custodian of about 6,782 hectors of Gole Village Land Forest Reserve (GVLFR). Here, the Guardian conducted an investigation to ascertain the major drivers of the degradation, the impacts caused and the gauge the efficacy of the conservation initiatives that has been undertaken in this VLFR which form part of the Eastern Arch Mountains.

Additionally, the investigation was geared at ascertaining the extent of institutional coordination in dealing with forest crimes in Handeni District. The institutions include the ministry responsible per

these agro-pastoralists claim to be allocated land but in interview with village leaders, they disclosed that there were no records to verify the process and acquired land.

A field survey revealed that the agro-pastoral dealers have even constructed water dam in the village land forest reserve and charging fees to villagers for the use of water, a situation which contravenes the provisions of the Water Resources Management Act which requires permits for large water uses. Gole village chairman Bakari Malinda explained that during the dry season, pastoralists are charged 1000 per each cow to get access to water

"This is illegal since large water users require permits, there were no evidence as to whether Our investigative reporter also observed that there is a problem of institutional coordination in addressing the situation in Gole Village Land Forest Reserve (GVLFR). This was evidenced by the fact that some government officials were publicly accused of taking sides to protect those involved in the forest degradation. For example, it was revealed that some members from the Village Natural Resources Committee for Gole village were illegally detained by the Police in Handeni in exchange for culprits who were arrested with their cattle illegally grazing in the Gole Forest Reserve. The village natural resource committee members John Gasaka and member Abdallah Mwingwa said those protecting the invaders into the forest reserve had been corrupted. As a result they could not enforce laws and implement their mandates vested to some of them.

Lack of institutional coordination was also associated with lack of clear information as to what actually transpired, some of village leaders were even not aware of boundaries between Kilindi and Handeni districts and henceforth becoming hard for them to intervene.

The village also has been working actively with one of the community based forest conservation project to resolve court case number 20/2019 (waiting for judgment at Korogwe District Land and Housing Tribunal), as well as Police case number IR/882/2020- both between Gole village and a famous agro-pastoralist called Lekoko, who is claiming for a substantial portion of the 6,782 hectors of Gole VLFR to be his grazing land. Kwefingo village based in Korogwe also opened and made close follow up of police case number KOR/RB2067/2020, followed by court case KOR/IR/602/2020 concerning illegal clearing of 3 acres of Sakare forest cover. The case was determined and the culprits agreed to pay a fine of 500,000/although they did not pay on time. On 9th July, the culprits were arrested and remanded in police custody for a day until they promised in writing to make the payments by 23rd July 2020. So far the villagers are still monitoring the actions. On 4th September 2020, Handeni District Executive Director wrote a letter to Commissioner for Land, Tanga Region to request for independent land surveyor to verify for boundary of the conflicting part of land if is either in Gole village, Handeni District or at Negero village, Kilindi District as demanded by the pastoralists claiming for the piece of the forest land. From 7th to 11st independent land surveyor visited the two villages Gole village in Handeni and Negero village in Kilindi District to verify the conflicting land issue as a last case evidence before final judgment, the land surveyor collected relevant information through field visits, observation, documents review and consultation with different stakeholders, that is Kilindi Land Office, Handeni Land Office and Gole village for information gathering. Sought for comments, the former Handeni District Commissioner Godwin Gondwe who was the district commissioner by then, said a number of actions have been put in place to ensure that this situation is addressed. These includes declaring the area free of any economic activity until when the pending case that was filled by forest invaders in Land Tribunal in Korogwe is determined, allowing Gole village natural resources committee to continue with patrolling the area. He called for collaboration between the two districts of Handeni and Kilindi to have this problem resolved. On the other hand, the newly appointed DC for Handeni Toba Nguvila said he has gone further to issue an order to suspend grazing and all other illegal activities that are being conducted in Gole Village Forest Reserve by all people. The villagers have commended the efforts saying this is the most significant steps for the forest reserve to protected against all forms of encroachments.

for forest management and its agencies thereto, district authorities where forest reserves are found (Handeni), ward and village authorities.

Different interviews which also involved field visit, attending the village meetings and sources from the village documents revealed that Gole Village Land Forest Reserve which was established in 2012 is disappearing. After its establishment the village developed the Forest Management Plan that was approved by the Handeni District Council on 9th July 2014. The Village Harvesting Plan has been developed for five years from August 2015 to July 2019, and reviewed in 2020 for next five years. The 2020 sustainable harvesting plan for timber tress show that, the forest is still worth of about \$100,000 annually, through sustainable sell of standing tree. The establishment of the VLFR is in accordance with policy statements number 5 and 6 of National Forest Policy 1998, sections 4 (b) (1) and 32 to 41 of the Forest Act No.14 of 2002, the Lands Act No.4 of 1999 and the Village Land Act No. 5 of 1999 which permits the establishment of Village Land Forest Reserves.

The Guardian learnt that the classification of land under these laws automatically recognised land set for reserves to be among the three categories of land others being the general land and villager land. The establishment of this VLFR is also in line with Tanzania's Forest Policy of 1998 which among other issues calls for community participation in conservation and management of forest resources.

Further investigation revealed that there is a gross violation of various Tanzania's laws and legislations. (Land Act No. 4 Of 1999, Forest Act No. 14 of 2002, Village Land Act No. 5 of 1999, Water Resources Management Act) and the Environmental Management Act No. 20 of 2004.

Main Illegal activities that degrade the village land forest reserve

Gole village chairman Bakari Malinda explained that the village forest reserve has been invaded by agro-pastoral who have forged village documents to justify their illegal activities in the forest reserve. Controversial allocation of village to famous agropastoral and business people is contrary to the provisions of the Village Land Act No. 5 of 1999. The investigation revealed that there were no minutes of the village assembly approving the said land to some agro-pastoral neither in Kilindi nor Handeni districts. The size of the land allocated to these agro-pastoral do not correspond to what the villages are mandated to allocate.

When this paper visited Negero village where

there was a permit granted in this case," he said.

Unbridled illegal felling down of trees

A field survey of the forest saw a group of illegal timber and log harvesters who after they had seen this reporter by far, they quickly dumped their equipment such as chain saw, axe and ran away. The site was no different from home as there were home cooking utensils such as pots, spoons, clothes, and shoes. About 30 workshops for illegal timber harvesting and processing were found in the reserve. In an interview with environmental expert, lawyer Musa Mnasizu from Community Wildlife Management Areas Consortium (CWMAC) said part XI of the Forest Act No. 14 of 2002 enumerates a number of forest crimes and such illegal activities are contrary to the provisions of the Forest Act No. 14 of 2002. The activities conducted in this reserve are punishable under the law. Environmental degradation as the result of illegal livestock keeping in the forest reserve, this is contrary to the provisions of the Environmental Management Act No. 20 Of 2004 which calls upon for people in Tanzania to take necessary measures to protect the

This is due to uncertainty on boundaries of the forest reserve and pending case in Land Tribunal in Korogwe District which has precluded villagers from conducting activities that are legally permitted by the Forest Act, No. 14 of 2002 where they could benefit from sustainable use of forest resources. It was also observed that the village has failed to use its village harvesting plan due to the land use conflict.

For instance, Gole village based in Handeni District conducted regular forest patrols such that, between May and June, five serious forest crimes (perceived to be implicated with corruption scandals), involving village forest land grabbing, illegal encroachment and grazing of 640 cattle were identified, reported and punished, where by three culprits were fined based on provision of village forest by-laws, and they are still working with the district council to resolve two cases.

Sanlam in talks with parent firm to delay repaying loan, again

NAIROBI

UNDERWRITER Sanlam Kenya is negotiating for a second extension of a Sh2.8 billion loan repayment to its parent company, Sanlam Group. The Nairobi Securities Exchange-listed firm was initially meant to settle the amount in 2019 but was unable to make the payment in the period when its cash holdings stood at Sh1.1 billion.

It then negotiated an extension to settle the debt in December 2020 –

an arrangement that has been scuttled by the economic fallout from the Covid-19 pandemic, prompting the underwriter to seek a further extension of the repayment. "We are in the final stages of restructuring this facility given the pandemic situation.

"Sanlam Capital was also able to allow us to restructure this (outstanding loan)," Sanlam Kenya Group chief executive Patrick Tumbo said without disclosing the terms of the of the renegotiation. To settle the debt, Sanlam Kenya put on market land and

Horticulture exporters on the spot for fleecing farmers

KIGALI

WHEN farmers in Nyanza District got a Rwf6 billion irrigation dam in 2015, beneficiaries were expecting to earn a lot of income that would lift them out of poverty. The dam with 1.82 million cubic meters and irrigation system has a capacity to irrigate 301 hectares in three sectors of Nyanza District; namely Rwabicuma, Nyagisozi, and Cyabakamyi.

The multibillion project was supposed to benefit 2,640 households but some of them, who invested in horticulture, are counting losses after they accused 'exporters of fleecing them.' Gerard Habimana, the president of farmers' cooperative 'Jya Mbere Muhinzi Nyanza' told The New Times that they supplied Rwf34 tonnes of chili worth Rwf24.2 million to Diversity Venture Company Ltd but they only got a payment of Rwf2 million.

"Now, we are in a dilemma. We have no more capital. Some farmers have abandoned agribusiness because they are discouraged. We are trying

SA investors exit local coal project on climate worries

JOHANNESBURG

SOUTH African investors have pulled out of a local multi-billion dollar coalfired power plant project, putting its construction at risk as opposition to the use of fossil-fuels in the country grows despite crippling power shortages. Across the world, investors are coming under increasing pressure to ditch coal, the most polluting of fossil fuels, and switch to greener energy.

The latest exits from the 630 megawatt (MW) Thabametsi coal-based power plant project in the water-scarce northern Limpopo province follow the withdrawal last month of South Korea's state-run Korea Electric Power Corp (KEPCO), and South Africa's big four banks last year after they were targeted by environmental activists.

to negotiate with other companies but it is yet to mature," he said.

He said that the total post-harvest losses have amounted to 'Rwf100 million' considering the other produce that rotted away due to lack of market. The farmers, who grow their crops on 50 hectares, had grown chili on 16 hectares. The farmers had invested between Rwf2 million and Rwf3 million per hectare and each hectare yields between 7 and 10 tonnes.

They started to harvest in February, 2020 but ended up into unexpected losses. "There are many farmers but the chili famers were 35 farmers. We were supposed to sell at Rwf700 per Kilogramme," he said. The New Times has learnt that the same issues have affected other farmers in other areas such as Kigali, Rulindo district, Kayonza, Kirehe and others.

Seeking justice

According to a copy which The New Times has seen, some farmers like Alexis Ndekezi have taken the exporters to courts and a pretrial conference will be held on November 19 at the Commercial High Court in Nyamirambo at 10:30. It is not the first time that there have been wrangles between farmers and exporters are not the first that have affected farmers.

For instance in 2018, coffee dealers contracted to supply about 60 containers of unroasted coffee to a Canadian firm never got payment of Rwf4.5 billion. The firm later returned the coffee to the farmers, who suffered losses.

MPs' recommendation

Edda Mukabagwiza, the Vice Speaker in charge of Legal Affairs and Government Oversight, told The New Times that MPs recently toured different parts of the country and are compiling reports and recommendations that also looked into farming cooperatives issues.

"We are compiling reports of what all MPs found during field trips. We are going to follow up and put all issues in recommendation. If the plenary sitting approves, we will also submit recommendations to the Prime Minister.

Concerning the issue of chili farmers, I told the Nyanza District administration to handle it. Again we recommend cooperative agencies to help farm cooperatives prepare contracts with exporters that will avoid further swindling," she said.

Exporters react

Speaking to this paper, Marie Immaculée Mujawayezu, the Manager of Diversity Venture Ltd, admitted that they owe money to farmers in Nyanza but explained it is Rwf17 million instead of Rwf22 million as farmers say.

She explained that the issue was caused by Covid-19 disruptions adding that they are in wrangles with over 14 farming cooperatives across the country which they didn't pay. "NAEB suspended

us but we requested to let us continue work so that we get income to pay farmers in installments. We need a meeting with farmers and NAEB for negotiations because if we do not open, we will not be able to pay them," she said.

What NAEB says

NAEB Communication Officer. Pie Ntwari told this reporter that the Kenyan company had been swindling farmers since 2019 and therefore it was suspended. "It was not due to Covid-19 impact that made the company struggle. Even before Covid-19, the company had been fleecing farmers in the country. NAEB asked that investor to pay farmers but refused. Rishi Sunak sets out Britain's bid to remain a financial leader with first green bond issue

LONDON

BRITAIN'S finance minister Rishi Sunak set out plans to bolster the UK's position as a global financial leader on Monday with the issue of the country's first green bond next year, as the country looks to extend its dominance in green finance and financial technology. In his first speech on financial services, Mr Sunak said the sector will be essential to the UK's economic recovery as the UK embarks on a new life outside the EU in the Covid-19 era.

Mr Sunak said the government was unilaterally setting out how it would let EU financial services firms operate in Britain after the post-Brexit transition period ends on December 31, as it was now clear there were "many areas" where the EU was not prepared to even assess access to British firms. "We are starting a new chapter in the history of fi-

nancial services and renewing robust environmental disclosure the UK's position as the world's pre-eminent financial centre," Mr Sunak said.

"By taking as many equivalence decisions as we can in the absence of clarity from the EU, we're doing what's right for the UK and providing firms with certainty and stability. Our plans will ensure the UK moves forward as an open, attractive and well-regulated market, and continues to lead the world in pioneering new technologies and shifting finance

towards a net zero future." To help the UK meet its 2050 net zero target, Mr Sunak said the government will issue its first Sovereign Green Bond in 2021, subject to market conditions. The bond will help finance projects that will tackle climate change, finance much-needed infrastructure investment and create green jobs across the country.



developed by Pfizer Inc. and BioNTech SE was more than 90% effective in preventing Covid-19 infections sparked a surge of bets Monday on stocks such as cruise operators and airlines that wilted amid the pandemic. Traditional refuges such as Treasuries, gold and the yen slumped.

But experts said the shot still has hurdles to clear, adding questions about its production, distribution and performance remain unanswered.

That tempered the euphoric earlier embrace of a potential path out of the health crisis. Concerns about US fiscal stimulus, the transition of power to President-elect Joe Biden and surging virus cases also came back to the fore.

Monday's vaccine news was a positive and profound shock that "catalysed a rogue wave of rotational optimism across global bond curves and riskassets alike," Edward Acton, rates strategist at Citigroup Inc., wrote in an email.

However, he added "there's a great deficit of information we're facing when analysing a post-vaccine landscape – with plenty of room for disappointment.

A successful vaccine would shake up the prospects for the global economy. Yet some forecasters remain cautious about changing their outlooks without clarity on how quickly a shot can be rolled out.

The pandemic continues to escalate in the US, Europe and elsewhere, with global cases now past 50 million.

While markets were surprised by the efficacy of the Pfizer inoculation, the "challenge from here is looking through rising virus cases, slowing data and perhaps less names into shares that would benefit if the pandemic ebbs. Principal Global Investors Chief Strategist Seema Shah wrote in a note that "market sentiment may be in the early stages of a burst of positive energy."

Value shares - stocks trading at lower multiples to profits or book value – jumped globally. JPMorgan Chase & Co. strategist Marko Kolanovic said the vaccine news buttresses the case for the value rotation to endure. Jim Vogel of FHN Financial

said the reaction in bonds looked "appropriate," while stocks seem "slightly ahead themselves." Sundial of Capital Research Inc.'s Jason Goepfert noted that bursts of equity gains such as in the past week can often see a pullback as the moves are digested.

The vaccine-sparked global stock rally stalled Tuesday and havens such as gold and the yen clawed back some of Monday's losses. S&P 500 futures slid 0.7% of 2:55 p.m. in Tokyo, erasing the gains sparked by the Pfizer release. Progress toward an inoculation could also have an impact on the timing and scope of fresh spending on US pandemic relief, according to Michael Purves, chief executive officer at Tallbacken Capital Advisors LLC. The "stronger the vaccine

news becomes, it seems reasonable to assume that a Republican Senate will fight for a considerably smaller fiscal package the economy and the markets can count on," he wrote in a note. That could wind up becoming a "considerable market vulnerability," he added.

Ouster of US defence chief sends shockwaves through Washington

WASHINGTON

U.S. President Donald Trump abruptly fired Defense Secretary Mark Esper on Monday, sending shockwaves through Washington.

"Mark Esper has been terminated," Trump tweeted. "I would like to thank him for his service."

The announcement came only days after a Pentagon spokesman said Esper "has no plans to resign, nor has he been asked to submit a letter of resignation.'

Mark Meadows, the White House chief of staff, reportedly called Esper to give him a heads-up that the president's tweet was going to be sent out. In a letter to Trump on Monday, Esper said he accepts the president's decision to replace him as he serves "the country in deference to the Constitution," while stressing his efforts to keep the Pentagon "out of politics."

Esper, 56, began to lead the U.S. Department of Defense in mid-2019 after serving as secretary of the Army. During his tenure at the Pentagon, Esper played a major role in implementing the Trump administration's national security policies and mobilizing military resources to help the country address the COVID-19 pandemic.

However, he was at odds with the

White House on several occasions over domestic issues. This summer, when demonstrations against police brutality and racial injustice swept across the country and Trump threatened to deploy active-duty troops to respond to violence arising from the events, Esper held a press conference in Pentagon making clear his opposition to the idea.

"The option to use active-duty forces in a law enforcement role should only be used as a matter of last resort, and only in the most urgent and dire of situations," Esper said in June. "We are not in one of those situations now."

Recently, Esper reportedly helped lawmakers on Capitol Hill craft legislation to pull the names of Confederate leaders from military bases, after the national reckoning over police brutality, racism, and slavery, despite public opposition from Trump.

Nancy Pelosi, top Congressional Democrat, said in a statement that "it is concerning that reports show that this firing was an act of retribution," arguing that the move could put the country's national security at risk.

A flurry of other Democrats, including House Armed Services Committee Chairman Adam Smith, also lashed out at the firing of Esper and



its timing. Democrat and former U.S. Vice President Joe Biden has declared victory for the 2020 presidential election, while sitting President Trump hasn't conceded and is pushing for legal challenges. "In the national security community, it is well known that periods of presidential transition leave our country exposed to unique threats," Smith said in a statement. "It is imperative that the Pentagon remain under stable, experienced leadership."

Trump tweeted on Monday that Christopher Miller, director of the National Counterterrorism Center, will be the Pentagon's acting chief "effective immediately."

Miller, 55, was sworn in as director of the National Counterterrorism Center, aligned under the Office of the Director of National Intelligence, in August this year.

Most recently, he served as deputy assistant secretary of defense for special operations and combating terrorism.

Jim Inhofe, an Oklahoma Republican and chairman of the Senate Committee on Armed Services, tweeted he is looking forward to tions at Raytheon, a major U.S. defense contrac-"working with him to ensure that these pri-

orities remain paramount and to working with President Trump to maintain stability at the Pentagon, particularly as we work to enact the 60th annual NDAA.

"Inhofe was referring to the National Defense Authorization Act, a bill authorizing appropriations for fiscal year 2021 and setting forth policies for the department's programs and activities.

James Mattis, the Trump administration's first defense secretary, resigned in late 2018 over policy disagreements with the president. In May 2019, Trump announced intention to tap Patrick Shanahan, then acting defense secretary, to formally lead the department but the decision was reversed a month later when Shanahan said he was withdrawing.

Days later, the president said he would name Esper for the post in a permanent capacity. The nomination quickly passed the Senate with a bipartisan support.

Before joining the Trump administration, Esper was the vice president for government relator. Xinhua

Biden's victory may worsen US sanctions against Russia, says Japanese analyst TOKYO

JOSEPH Biden's victory in the US presidential election will apparently result in Washington's tighter sanctions against Russia, including those in the field of export of fossil fuels, one of Japan's leading specialists on the former Soviet Union, Nobuo Shimotomai, has told TASS.

"With the advent of a Catholic president the Democratic Party's habitually strong pressure on Russia on various issues, including Ukraine, will soar," said Shimotimai, an honorary professor of Tokyo's Hosei University, author of two dozen books on various aspects of Russian politics and history. "The probability of sanctions will grow.

As the trend towards ecologically clean energy sources gains strength in the United States and the European Union countries, there is a great risk the import of fuels will begin to be taxed with the aim of reducing carbon dioxide emissions, which would be equivalent to sanctions against Russia."

Shimotomai believes that an acute standoff between the Democratic and Republican parties in the United States will continue and a new conflict between the new president and the Senate may flare up.

"In a situation like this US policies will be domesticallycentered, so reformatting relations with Russia in the interests of dealing with world problems will be rather hard."

The current Japanese government, Shimotomai said, has vowed commitment to the policies of the previous Shinzo Abe-led Cabinet, which sought a dialogue with Russia.

"However, the possibility of some major shifts on this track is insignificant, given the coronavirus pandemic situation, the global economic crisis and US-Chinese confrontation," Shimotomai said, adding that Biden's election might open up new opportunities for Russian-Japanese relations.

On November 3, American citizens headed to the polls to elect 435 representatives to the House, 35 senators out of 100 to the Senate, and the President and Vice President of the United States.

Though the vote count is still underway, major US media outlets project that the Democratic contender has presumptively won the presidential election.

Both Fox News and Associated Press have put Biden over the top, beyond the needed 270 vote threshold. Trump is challenging the current outcome, claiming irregularities in the ballot processing in key swing states, and has filed lawsuits to fight his case in court. Agencies

Afghan woman shot, blinded, for getting a job

KABUL

THE last thing 33-year-old Khatera saw were the three men on a motorcycle who attacked her just after she left her job at a police station in Afghanistan's central Ghazni province, shooting at her and stabbing her with a knife in the eyes.

Waking up in hospital, everything was dark.

"I asked the doctors, why I can't see anything? They told me that my eyes are still bandaged because of the wounds. But at that moment, I knew my eyes had been taken from me," she said.

She and local authorities blame the attack on Taliban militants - who deny involvement - and say the assailants acted

Activists also said that the Human Rights Council's examination of the United States, the first since May 2015, amounted to an indictment of the Trump administration's policies and called for President-elect Joe Biden to usher in reforms.

Dozens of delegations took the floor at the half-day session to voice concerns and make recommendations.

"What we saw today was unsurprising condemnation by many countries around the world of the United States' human rights record," Jamil Dakwar, director of the human rights program at the American Civil Liberties Union (ACLU), told a news briefing.

"We've heard country after country...calling and urging the United States to take serious measures to address structural racism and police violence," he said.

The Trump administration, which quit the Geneva forum in June 2018 accusing it of an anti-Israel bias, defended US policies.

Alexander Maugeri, US deputy assistant attorney general, said that authorities in Minnesota had filed second-degree murder and manslaughter charges in Floyd's death.

"A number of member states raised concerns about discrimination and excessive force in policing. Where there is misconduct by police officers or law enforcement agencies, state and federal law provide remedies," Maugeri said.

China and Russia called on the United States to root out racism and police violence, while Cuba and Venezuela said it must provide equal access to health care during the COVID-19 pandemic.

France called on US authorities to halt executions at the federal level, close Guantanamo Bay detention facility, and "guarantee women and girls access to their rights and sexual and reproduc-

The attack on Khatera, who only uses one name, is indicative of a growing trend, human rights activists say, of an intense and often violent backlash against women taking jobs, especially in public roles. In Khatera's case, being a police officer could have also angered the Taliban.

The rights activists believe a mix of Afghanistan's conservative social norms and an emboldened Taliban gaining influence while the United States withdraws its troops from the country is driving the escalation.

The Taliban are currently negotiating in Doha, Qatar, with the Afghan government to broker a peace deal in which many expect them to formally return to power, but progress is slow and there has been an uptick in fighting and attacks on officials and prominent women around the country.

"Though the situation for Afghan women in public roles has always been perilous, the recent spike in violence across the country has made matters even worse," said Samira Hamidi, Amnesty International's Afghanistan campaigner. "The great strides made on women's rights in Afghanistan over more than a decade must not become a casualty of any peace deal with the Taliban." Agencies

Ethiopia 'seizes airport in Tigray', AU seeks ceasefire

NAIROBI

ETHIOPIAn troops took an airport in the Tigray region during an offensive against local leaders defying Prime Minister Abiy Ahmed's authority, state-affiliated TV said yesterday, as the African Union (AU) called for an end to bloodshed.

Hundreds have been killed in an escalating conflict that some fear could slide into civil war given the deep animosity between the Tigrayans and the government of Abiy, who comes from the majority Oromo ethnic group.

Various Tigrayan forces surrendered during the seizure of Humera airport, near the border with Sudan and Eritrea, while the military also captured a road leading from the town to the Sudanese border, the Fana broadcaster reported.

Reuters could not confirm the report, and there was no immediate response from the Tigray People's Liberation Front (TPLF), which governs the state of more than 9 million people.

Abiy, who won the Nobel Peace Prize in 2019, ordered air strikes and sent troops into Tigray last week after accusing the TPLF of attacking a military base. Tigrayans say Abiy's government oppresses and discriminates against them and behaved autocratically in canceling a national election.

The Addis Ababa-based AU bloc called for peace talks and a ceasefire. "The chairperson (Moussa Faki Mahamat) appeals for the immediate cessation of hostilities and calls on parties to respect human rights and ensure the protection of civilians," it said in a statement.

Rushing to front line

Reuters reporters on Monday traveling in Tigray and the neighboring Amhara region saw trucks packed with militia fighters and pickups with mounted machine-guns rushing to the frontline in support of the federal government push.

Warplanes have bombed arms depots and other targets, both sides say, while aid workers and security sources have reported heavy fighting on the ground.

Military and security sources in Amhara, on the side of the federal troops, have spoken of 500 deaths on the Tigrayan side and hundreds also from the national military.

Amid calls from the United Nations and others for talks, Abiy's spokeswoman denied suggestions from some diplomats that he was ignoring mediation efforts and endangering stability in the poor and turbulent Horn of Africa region.

"There is no rebuffing of anyone by the prime minister. He had acknowledged and given gratitude for the concerns shown," the spokeswoman, Billene Seyoum, told Reuters.

"Nevertheless, Ethiopia is a sovereign nation and its government will ultimately make decisions in the long-term interest of the country and its people."

Russia to improve from Biden in White House

MOSCOW

THE Democratic nominee Joe Biden who has won the US presidential election as the American media outlets claim, will hardly make positive contributions to Washington's policy regarding Russia, Chairman of the Russian State Duma (lower house) Foreign Affairs Committee Leonid Slutsky told reporters on Sunday, adding though that Moscow is ready to cooperate with any head of the US administration.

"Unfortunately, one should not expect substantial changes for the better regarding Russia," he said. "Biden together with President [Barack] Obama launched sanctions at various levels against Russia," the deputy noted, adding that the Democratic nominee directly called Russia "the main enemy" of the United States in his pre-election rhetoric. "That is why one should hardly expect any of the Russian politicians to applaud this time on account of the results of the American election," he said.

"However, Russia - and that has been stated at the top level - is ready to cooperate with any US president. It is still one of priorities, particularly at the parliamentary level, to normalize bilateral relations," Slutsky stressed.

"All aspects and possibilities of the Russian-American dialogue" will be analyzed at a meeting of the round table in the State Duma at the end of November, he added. "We are not speaking about a new 'restart' so far, though it is necessary to look for ways of efficient cooperation, first of all in such areas as global healthcare, strategic stability, arms control, cybersecurity, and peaceful space,' Chairman of the State Duma Committee said.

Along with the efficacy data generated from the clinical trial, Pfizer and BioNTech are working to prepare the necessary safety and manufacturing data to submit to the FDA to demonstrate the safety and quality of the vaccine product produced, according to Pfizer.

India's Modi facing tough battle in first vote since pandemic

INDIAN Prime Minister Narendra Modi's party, which is in coalition with the ruling alliance in Bihar, is fighting a tough battle to retain control of the eastern state as vote counting began vesterday.

The vote tally has been slowed down considerably because of COVID-19 protocols in place, and no clear verdict had emerged by late yesterday afternoon.

Trends show the ruling coalition that includes Modi's Bharatiya Janata Party (BJP) pulling ahead in some 127 seats. The opposition grouping, led

by the charismatic 31-year-old politiment and an economy experiencing cian Tejashwi Yadav was leading in 106 seats in the 243-member state assembly. Most exit polls have shown citizens rejecting the ruling coalition in favor of the opposition alliance.

About 25 percent of the votes polled have been counted so far, according to Election Commission officials in New Delhi. It's not immediately clear when a final vote count will be available.

Bihar is India's poorest state, but with a population larger than any nation in the European Union it sends 40 lawmakers to federal parliament, giving it outsize political importance. Losing the state amid soaring unemploy-

the sharpest dive in decades will be a setback for Modi, who invested a lot of political capital in the campaign.

The state is currently governed by Nitish Kumar of the Janata Dal (United) party who has ruled for three straight terms. But in the face of an anti-incumbency wave Modi was the main campaigner, addressing more than a dozen rallies across the province despite pandemic restrictions. Modi's BJP entered an alliance with Kumar's party after the last election in 2015

If confirmed, the loss is likely to turn attention to Modi's policies -- including setting in motion the world's strictest



virus lockdown -- and embolden the opposition to question his handling

of India's pandemic. The stay-at-home order and the job losses it triggered led to an exodus of poor migrant workers, over 1.5 million from Bihar alone, from India's big cities. With more than 8.5 million cases, India's virus infections trail only the United States.

The spotlight is now on Yadav, the youthful leader of the Rashtriya Janata Dal party and the chief ministerial candidate of the opposition alliance. A one-time cricketer and the son of a former chief minister, Yadav sought to win over younger voters with the promise of a million government jobs. Bihar's unemployment rate has climbed to 12 percent -- almost double that of the na-

tional average of 6.7 percent -- since the lockdown.

"A loss will also put pressure on the center to concentrate more on populist policies that give a fillip to job creation," said Ajay Bodke, chief executive officer for portfolio management services at Prabhudas Lilladher Pvt. "With a massive shortfall in tax revenues and divestment proceeds due to economic slowdown as a result of COVID-19 pandemic, the government needs to expedite structural reforms hobbling medium-term growth which are bound to create backlash among sections of society."

ON November 13, this year, the Taifa Stars will take to the field to face off against one of the mighty Maghrebs of African football, the Carthage Eagles of Tunisia, in a critical AFCON finals' qualifier of enormous importance for the Stars.

It bears noting here that the Taifa Stars have a distinctly unflattering record against all manner of North African opposition, which is cause for great concern especially when one remembers that the key Taifa Stars vs Tunisia clash will take place away from home in the Tunisian capital, Tunis.

No spectators means no roars, the magic of the Masters

AUGUSTA, Ga

THE roars were endless Sunday at the Masters, coming from everywhere for just about everyone.

One moment stood out in 2011.

From below the rise of the fairway on the par-5 eighth hole, it sounded like a sonic boom. That was an eagle cheer coming from the green, no doubt. But for whom?

"Tiger Woods just came through," a marshal said, and thus ended the mystery.

But it didn't end there.

Woods, who started that final round seven shots out of the lead, now was tied for the lead. Moments later, as Woods headed to the ninth tee, another cheer rang out from the 18th green. And then, another one down by Amen Corner. And then a third cheer in the direction of the 15th green.

More birdies? Eagles? No, it was the crowd scattered across the golf course responding to seeing scoreboards change as Woods moved into a tie for the lead. He couldn't keep it going. That was the year eight players had at least a share of the lead at some point on the back nine until Charl Schwartzel finished with four straight birdies.

An incredible day. Amazing atmosphere. And now, silence.

This Masters in November will be missing the patrons because of the COVID-19 pandemic and missing the very essence of what makes Augusta National so magical.

"It echoes there. It travels," Woods said. "It's unlike any place in the world.

Woods has heard his share. He probably can still hear the lustrous chants of "Tiger! Tiger!" after he celebrated a fifth and most unlikely Masters victory last year.

Or the change in pitch from anticipation to letdown to delirium when his chip on the 16th hole in 2005 trickled down the hill, stopped

for a full second on the brim of the cup until gravity took over and the ball dropped for a birdie.

Ask what one moment stood out and it wasn't even for him.

He was paired in the final round with Davis Love III in 1998. Right behind them was 58-year-old Jack Nicklaus, making an early charge, chipping in for birdie on No. 3.

"The roars were so much louder. Those were Nicklaus roars," Woods said. "And that's what I had grown up watching and got a chance to experience in person."

Nicklaus had company in producing a cheer that Phil Mickelson still remembers. It was the second round of 1991. Mickelson, the 20-yearold U.S. Amateur champion, opened with a 69 and was on the 18th green.

"Tom Watson and Jack Nicklaus were playing together and on the 16th green, one of them made the putt from down below to the front right up-on-top pin. And the place erupted to the point where the ground actually shook and you could feel the vibrations in my feet," Mickelson said.

"And moments later, the other player - I don't know who putted first between Tom and Jack – made the same putt and the place erupted again," he said. "That was my first Masters."

A charge even more stunning than Woods in 2011 – which also fell short – was Jordan Spieth in 2018. He started the final round nine shots behind, and his birdie on the 16th put him at 9-under for the day and tied with Patrick Reed. Along for the ride that day was Justin Thomas, friends with Spieth since they were teenagers. "He made about a 35-footer and that was the loudest roar I've ever heard in my life. It felt

like the ground was moving. It was insane," Thomas said. "I'm getting goosebumps just thinking about it, talking about it. It was unreal.

From Arsenal and Barcelona to Djibouti: Alex Song has new goals

CAIRO

ALEX Song used to play for marquee European clubs Arsenal and Barcelona. Now, he is preparing to line up with Arta Solar 7 of Djibouti in the CAF Confederation Cup.

It will be a tall order for the 33-year-old Cameroonian as the team from the tiny Horn of Africa nation drew Al Mokawloon Al Arab (formerly Arab Contractors) in the preliminary round draw in Cairo Monday.

While success in Africa has eluded the Cairo outfit of late, they won the now defunct African Cup Winners Cup three times between 1982 and 1996.

Mokawloon qualified by finishing fourth behind African giants Al Ahly and Zamalek and 2020 Confederation Cup runners-up Pyramids in the Egyptian Premier League.

The route to Africa for Arta was less daunting as they lifted the FA Cup in Djibouti, a country ranked 51st in Africa and 185th in the world.

This will be their third consecutive Confederation Cup appearance with a heavy defeat by Kariobangi Stars of Kenya in 2018 followed by a better showing when going down to Al Khartoum of Sudan.

Should the virtually unimaginable happen and Arta eliminate Mokawloon, they would face an even bigger obstacle in continental giants Etoile Sahel from Tunisia.

Etoile are the only club to have won all five current and now defunct CAF competitions -- the Champions League, Confederation Cup, Super Cup, African Cup Winners Cup and CAF Cup.

Apart from playing for the senior team, Song will supervise youth development at Solar during his twoyear contract.

- Refused pay cut -

The Douala-born relative of Cameroon football legend Rigobert Song was ditched by Swiss side Sion this year after refusing to take a pay cut necessitated by the effects of the coronavirus pandemic.

Apart from wearing the colours group draw up for grabs. of Arsenal and Barcelona, Song



played for Bastia in France, Charlton Athletic and West Ham United in England, Rubin Kazan in Russia and Sion.

Why more injuries and more games is no coincidence

WHAT do Cristiano Ronaldo, Christian Pulisic, Ansu Fati, Trent Alexander-Arnold and Joshua Kimmich all have in common? Other than being some of the biggest names in world football, they have all suffered injuries that have left them either out of, or likely to miss, this week's international break.

Here we are, two months into the 2020-21 season in early November, and the players are already struggling to keep pace with the incessant workload -- according to The Athletic, muscle injuries in the Premier League in the first five weeks of the season were up 42% on the same stage in the previous campaign.

Rather than having to play international games this week, what the players really need is a rest.

Some will get just that, with several Serie A clubs blocking their players from leaving for international duty due to COVID-19 concerns and a worrying outbreak in Denmark raising the prospect of all overseas Danish players being unable to return home without having to enter

quarantine. But for the others, the internationals will go on

and the leading players will have to play yet again. Ronaldo, who limped out of Juventus' 1-1 draw with Lazio on Sunday with an ankle injury, may yet report for Portugal's triple header against Andorra, France and Croatia, while Pulisic has been named in Gregg Berhalter's 24-man squad for the United States' two games against Wales and Panama, despite the Chelsea forward being sidelined since late October with a hamstring injury.

But Ansu (knee), Alexander-Arnold (calf) and Kimmich (knee) will all be absent when their international teams play this week and there are plenty of others who have suffered injuries in a season that has been congested like never before due to the fixture list being impacted by the COVID-19 pandemic.

ESPN reported this summer that football's top players would face an unprecedented test of their endurance this season, with some having no more than two weeks' rest in a 13-month campaign from June 2020 to July 2021, due to last season not finishing until mid-August and the new one beginning in early September.

Managers have voiced their concerns over the demands being placed on players, who have seen the pre-Christmas fixture schedule packed with two triple-header international breaks and six matchdays in the Champions League and Europa League -- all crammed into an eight-week period.

It was always going to heavy-going this season, with the second half of the campaign also seeing

England, the two-week winter break introduced last season will not be repeated this term with too many games to squeeze into a short time.

England manager Gareth Southgate was one of the first speak out over the workload -- Southgate, after all, may need his players to be fit and firing all through to the delayed Euro 2020 final at Wembley on July 11.

"The calendar is packed and it needs collaboration from everybody to try to resolve that," Southgate said in September. "It's easy to try to cram everybody's desire in, in terms of their own competitions, but the reality is that the best players end up playing in the most matches and we have to try and play our part in terms of navigating that." Southgate was right to flag up the problems ahead, but nothing has been

done about them and managers are becoming increasingly agitated by the pressure of having to get a team ready to play every three or four days.

Manchester United manager Ole Gunnar Solskjaer used his postmatch news conference after Saturday's 3-1 win at Everton to complain about his team having to play at 12.30 p.m. GMT on Saturday, having travelled to Turkev to face Istanbul Basaksehir on Wednesday evening.

"The kickoff time set us up to fail," Solskjaer said. "We have been to Turkey, played loads of games this season already,

busier-than-usual fixture lists. And in we got back Thursday morning and we are playing Saturday lunchtime, it's an absolute shambles. Players this season, in these times, a pandemic, mentally and physically, it's draining."

United were victims of the Premier League TV deal, which give BT Sport a Saturday 12.30 p.m. GMT slot. If BT Sport selects United, then the Premier League can do nothing about it, although a change to the rules, preventing teams in action in Europe on Wednesdays from playing in the early Saturday slot, would be a positive step.

Liverpool manager Jurgen Klopp was equally critical of the fixture list following his team's 1-1 draw at Manchester City, which resulted in the loss of Alexander-Arnold, with the German making it clear that everybody -- clubs and national teams -- will suffer.

"Usually in a season we all have an October, November and then a very, very tricky December," Klopp said. "This year, the October is like the December, the November is like the December and the December is still like the December. This intensity is really difficult. We lost Trent [against City] and I'm pretty sure Gareth Southgate is not fine [with that]. If we continue like this and hopefully we can play a Euros in the summer, if they happen, let's see who will be part of that, which plavers."

The most obvious solution to the overheated fixture schedule would surely have been to shelve the forthcoming and country

international break or, at the very least, reduce the list to just one game.

Sources have told ESPN that, having postponed Euro 2020 this summer, UEFA was determined to stage the Nations League in the opening months of the season for both sporting and financial reasons for the competing nations.

International fixtures, and the finances they generate, are the lifeblood to many associations, especially due to the money earned from broadcasting revenue at a time when crowds are reduced, or prohibited altogether, as a consequence of the pandemic. But while the club managers can stomach losing their players for competitive internationals, it is the friendlies that prompt so much frustration.

The United States, having not played an international fixture since February, can legitimately cite the need to use this break, but it is difficult to see the benefit of Portugal facing Andorra, the team sitting 145th in the FIFA World Ranking, unless it has been set up to help Ronaldo (101) -- if fit -- close in on Ali Daei's world record of 109 international goals.

When England arranged a Wembley friendly with New Zealand -- ranked 121 by FIFA -- for this week, sources told ESPN that it was primarily scheduled to honour a broadcasting deal which required a game to be played. No game would mean breaking the terms of the TV deal and the prospect of having pay back a sum described by sources as "seven figures."

New Zealand have since pulled out of the fixture due to concerns over COVID-19, but England have filled the gap by securing a friendly with Republic of Ireland, rather than allowing Southgate's players to have much-needed rest.

With eight months of this season still to play -- Euro 2020 and Copa America both run until mid-July -- the determination of most major nations to play three internationals in the space of six days in November seems nonsensical. Not to mention there is another treble-header of matches in March when 2022 World Cup qualifying gets underway.

And it points towards more top stars being injured and unavailable when the season reaches its climax, for both club

THERE was no luck for South African fallen giants Kaizer Chiefs when the CAF Champions League preliminary round draw was made in Cairo Monday as they were paired with Cameroon outfit PWD Bamenda.

It promises to be a tough two-leg tussle with the overall winners facing 2018 semi-finalists Primeiro Agosto of Angola soon after for a place in the lucrative group phase.

Bamenda are debutants with much to prove as no Cameroonian club has won the elite African club competition since a Canon Yaounde side boasting stars like Thomas N'Kono and Theophile Abega lifted the trophy 40 years

Then, the best footballers from the central African country played at home. Now, those who display talent as teenagers are snapped up by European clubs, greatly weakening the domestic game.

If Bamenda have no Champions League pedigree, they are sure to be a typical Cameroonian club, full of physicality, skill, stubbornness in the face of adversity and oodles of national pride. Soweto-based Chiefs think of themselves as one of the biggest clubs in Africa and when it comes to off-field activities such as marketing they have few equals.

But success has eluded the holders of 53 domestic competitions since winning the last of four South African Premiership titles five seasons ago under England-born coach Stuart Baxter.

They have hired local, Italian and German coaches since, but 20 attempts at winning a league or cup competitions failed.

Chiefs' Champions League record would embarrass a club from a much lesser football power than South Africa as they have never reached the group stage in five appearances.

"Our Champions League performances have not been what one would expect from a club like Chiefs," concedes club founder, chairman and former star Kaizer Motaung. - Increased travel costs -

A better draw for them would have been a tie against a club from a small neighbouring southern Africa state, as going to Cameroon will not only be more challenging but greatly increase travel costs.

Chiefs fired German coach Ernst Middendorp after finishing runnersup in the league last season having led for 28 of the 30 rounds, and brought in Gavin Hunt.

Hunt is a no-nonsense handler, a former defender who looks like he would be equally at home drilling cadet soldiers on a parade square.

He won three consecutive league titles with SuperSport United and one with now disbanded Bidvest Wits, using players seemingly less talented than those he now has at Chiefs.

But his results since the season kicked off last month -- two narrow wins, a goalless draw and three heavy losses -- have been disappointing.

There are mitigating factors, like injured leading scorer Samir Nurkovic from Serbia, but rumours have it that he may soon be lured to the Middle East by higher salary offers.

A transfer ban until mid 2021 imposed on the club by FIFA for illegally signing Malagasy Arohasina 'Dax' Andrianarimanana has not helped either as Hunt clearly wants to strengthen his squad.

"It is what it is," says the normally talkative coach with little to enthuse about these days. Bamenda may only add to his discomfort.

Finland coach remains focused on Euro 2020 dream despite wait

HELSINK

THE postponement of Euro 2020 put Finland's major tournament debut on ice but, when the finals do come around, the Nordic nation have their sights set on emulating the remarkable recent achievements of Iceland.

One of the enduring memories of the last European Championship in France in 2016 is that of Iceland -roared on by a huge support and their "Viking Thunder Clap" -- knocking out England on their way to the quarter-finals.

Iceland reached the last World Cup too, and still hope to go to the next Euro along with Finland, who will be there when it finally goes ahead a year behind schedule.

"In a way it's already a dream for us to play in the finals, but we are not going there just to participate, we want to achieve something more," Finland coach Markku Kanerva told AFP in an interview ahead of his team's latest get-together and a friendly against world champions France on Wednesday in Paris.

"It's the same with Sweden in the World Cup, they did very well," said Kanerva, with a nod to Finland's neighbours who reached the quarter-finals in Russia in 2018.

"I believe they are examples for us because they are from the Nordic countries as well and there are some strengths in all our Nordic countries, mentally and, as I mentioned, we are organised teams and we can also learn what have been the key factors behind their success."

In a nation of 5.5 million people where football plays a distant second fiddle to ice hockey, Finland had never really come close to reaching a major tournament before, even in the days of the great Jari Litmanen, a Champions League winner with Ajax in 1995.

But Kanerva was appointed in 2016 and led them to Euro 2020 as they finished second in qualifying behind Italy.

"We weren't the favourites in our group because Italy was the favourite, then Bosnia and Herzegovina and Greece as well, they were the main candidates to qualify. And we managed to surprise them," said Kanerva, whose side are 55th in the FIFA rankings.

- Pukki 'a huge figure' -

He was grateful for the goals of Norwich City striker Teemu Pukki, a "huge figure in Finnish football" according to Kanerva, and who contributed 10 in the qualifying campaign as the team did their bit to raise the sport's profile at home.

"People are talking more about football and congratulate us, me and all the players as well, and there are many people who said, 'I never believed the Finnish national team could qualify for a major international tournament,' and they're very proud of that, and we are as well.

"The players believe in themselves and as a team we believe we can achieve something new and we actually did it."

Excitement about going to the Euro increased when they were drawn in the same group as neighbours Russia, Denmark and the world's top-ranked team Belgium.

It is only 200 kilometres from the Finnish border to Saint-Petersburg, where they are due to play Russia and Belgium, but talk of an influx of Finnish supporters is on hold due to the health crisis and rumours the Europe-wide format might be changed.

Nevertheless Finland are preparing the best they can, and are currently doing well in the Nations League, notably beating the Republic of Ireland home and away.

Over the next week, after facing France, they play in Bulgaria and Wales where they will be without Augsburg's Fredrik Jensen, a scorer in each of the last three Nations League matches.

But Kanerva can call on the likes of Bayer Leverkusen goalkeeper Lukas Hradecky, midfielder Glen Kamara, ex-Arsenal and now of Rangers, and Bundesliga-based Joel Pohjanpalo.

And then there's Pukki.

"He was one of the key players in our qualification, scoring ten goals...so of course that's his role, to score goals," said Kanerva.

"And Teemu can't score goals without good delivery, and that's very important to keep in mind that someone has to assist his goals as well. So of course there are many other important players in the squad with a very huge role behind our success."


All boxers were introduced yesterday during the official weigh-in at Colosseum Hotel in Dar es Salaam.

Mkalekwa vows to defeat Shauri in non-title bout

IT has been a very good year for professional boxing in Tanzania. The sport's fans have been witnessing various bouts since the resumption of sporting activities at the domestic level.

If a person talks about boxing in the country, then he or she can hardly forget professional Welterweight boxer Saleh Mkalekwa, who is doing justice to his talent when he is in the ring fighting for victory.

Meanwhile, Tanzania's Namungo FC will face South Sudan's Al Rabita in the preliminary round of the 2020/21 CAF Confederation Cup.

They will host Al Rabita between November 27-29, 2020 in the first leg before meeting again for the second leg between December 4-6, 2020.

If Namungo FC win the tie, they will then meet Sudan's Al Hilal Obeid in the first-round showdown.

Al Hilal Obeid are among the 13 clubs that have been handed byes for the preliminary round.

Namungo FC, coached by Thierry Hitimana, are currently struggling for form in the 2020/21 Vodacom Premier League campaign, winning just four of their ten opening league matches, with their main problem being their lack of goals.

The Lindi-based side booked a continental ticket for the first time in their history after reaching the finals of the previous season's Federation Cup and locking horns with Simba SC in the clash.

Despite losing the game 2-1 they qualified since Simba SC had won the league and were eligible to play in the CAF Champions League.
