

Former PM Sumaye back in ruling CCM

FORMER Prime Minister Frederick Sumaye (pictured) yesterday returned to the CCM fold, saying he has taken the step to have a platform to air his views and

It is two months after he announced that he was no longer a member of the leading opposition party, Chama cha Demokrasia na Maendeleo (Chadema).

On December 4 Sumaye who served ten years as prime minister during the third phase government quit Chadema three days after his failed bid to be elected chairman for the party's Coastal Zone.

In the election he garnered 48 "no" votes

Sumaye explained that due to what transpired in the election and as regards his earlier bid to collect forms to vie for the party's national chairmanship against Freeman Mbowe, there was no longer need for him to remain in the party.

But yesterday he reverted to the dominant party, announcing his decision before CCM Secretary General Dr Bashiru Ally at a Board of Trustees meeting that started early yesterday.

"I have been prime Minister for 10 years and leader for many years, hence I will not be doing justice if I remain at some place

Personally I have unquestionable patriotism and I always look ahead for the country's interest

without giving my advice and contribution to the nation.


"You cannot contribute anything if you do not have a platform, since if you give it on the roadside people may attack you," he said, noting that he agonized about whether he had "reached a level to be despised," and judged against it, thus opting to "return to the party reared me and I am proud that I still have something to contribute to this nation," said Sumaye amid applause from the audience.

Interrupting his speech by saying "CCM Oyee" several times Sumaye said he has returned to CCM so that he joins fellow members and other wananchi to build the ruling party.

"Without wasting your time I have decided to return because of this reason. It is my hope of assisting the country; my problem was only the country. Personally I have unquestionable patriotism and I always look ahead for the country's interest.

"I have come here to build our party and country and if there are any shortcomings here and there I will have a platform to speak from. I will give my advice to party leaders including the Secretary General. Being inside the party I will have a big opportunity to offer my contribution, so I

Samia: Work harder to end Africa's interminable wars

TANZANIA has appealed to the African Union (AU) and the wider international community to increase efforts in ensuring peace is obtained in the continent's conflict areas, especially in the Democratic Republic of Congo (DRC).

This would be helpful for Tanzania to offload its long time refugees burden, Vice President Samia Suluhu Hassan said at the opening session of the 33rd Ordinary Conference for AU heads of state and governments at its Addis Ababa headquarters.

This year's conference slogan 'Silencing the gun' has come at an opportune moment since conflicts and the absence of peace in some African countries delay the continent's economic development, she said.

Netherlands hands 76.5bn/for city modern dumpsite

THE Netherlands Embassy in Tanzania has disbursed 76.5bn/- for construction of a modern dumpsite at Pugu on the outskirts of Dar es Salaam to facilitate management of solid waste in the country's commercial capital.

Mussa Hassan Zungu (pictured), the Minister of State in the Vice-President's Office (Union matters and Environment), said the Netherlands agreed to finance improvement of outlays infrastructure at



the Pugu dump site and paving the road to the site to ease waste delivery.

"We had a successful conversation with Ambassador Jeroen Verheul of the Netherlands. They will provide 1.5bn/- for the feasibility study and research before disbursing 75bn/for the project which will see Dar es Salaam residents getting a modern dump site," he told journalists shortly after talks with Ambassador Verheul.

Zungu noted that completion of the project will enhance the city's environment conservation efforts, cutting health risks to people residing near the dump site. Waste generated in the city is massive whereas the current Pugu dump handles 5,000 tonnes per

THE Office of the Director of Public Prosecutions (DPP) yesterday handed over to the state assets worth over 70bn/- nationalised from criminal businesses across the country.

The assets in the form of various types of minerals, cash and cars, including the 12bn/- that has already been paid through plea bargaining by about 300 suspects in money laundering, tax evasion and economic sabotage cases.

Handing over the assets at the Bank of Tanzania (BoT), DPP Biswalo Mganga said the asset recovery was done in the past three to four years. The nationalised properties include minerals like gold, diamond and tanzanite.

"The assets are also part of the others recovered in the past, stored in a special Asset Recovery Account at the BoT," he said.

Authorities have also nationalized 24 residential houses, nine land plots, 65 vehicles, two plantations, 6,894 pieces of timber and one

The DPP said the assets value does not include plots and houses because their valuation is yet to be conducted, as they were being handed over to the Treasury PS.

Minister urges new board to strive for quality services

Transport Communication, minister Kamwelwe has urged the new board of directors of Marine Services Company Limited (MSCL) to ensure improved marine services as well as purchasing quality vessels.

Kamwelwe made the remarks yesterday at the inauguration of the board which was recently formed by President John Magufuli. The board is chaired by Prof Zacharia Mganilwa.

"We believe that MSCL will grow to a strong company as the government has heavily invested in it. We want you to ensure quality and reliable services to the people", said the minister urging board members to also make sure MSCL operates profitably and give dividend to the government.

He said during the period of the outgoing board the company's services were deteriorating with most of its ships not functioning properly. He said the company was solely depending on subsidy from the government to operate.

"The President took measures to revive MSCL to make it operate independently, but also provide better

services to Tanzanians. You have all the three ships rehabilitated and a new one at Lake Victoria", he added.

According to him, the President also paid 10 months' salary arrears to workers.

The minister hailed the Chief Executive Officer (CEO) of MSCL, Eric Hamisi for managing well the company as it was about to collapse. He said new CEO has managed to control theft of spare parts and enhanced revenue collections from fares and cargo

Meanwhile, Hamisi noted that the out-going board managed to revive cargo services from Dar es Salaam to Kampala in Uganda through both, ship and railway services.

THE African Development Bank's (AfDB) African Economic Outlook 2020 was praised at the 33rd African Union Summit in Addis Ababa for being an effective blueprint for addressing the continent's human capacity gap.

The 2020 edition of the flagship report, under the theme, "Developing Africa's workforce of the future," was presented at a side event attended by policymakers, global and regional development organizations, civil society, the media and academia.

The Commissioner for Economic Affairs at the African Union Commission, Victor Harison, observed that the report tackled the challenges

the development of Africa's workforce for the future through the prism of education, skills and infrastructure."

"The facts mentioned in the second part of this report are striking. It reminds us of the size of the investment that must be made in the development of human capital in Africa, an essential transformation," the Commissioner

Vincent Nmehielle, Secretary General of the African Development Bank, said the African Economic Outlook had become the blueprint for planning and for sound economic research about the continent.

"The question then is: why are we presenting the report at the African Union? This is where Africa's sociocomponent for achieving productive economic policy and political decisions are made. It is therefore important that

heads of state know the key policy recommendations for the year," he said.

molecule involved in the development breakdown. Further investigation of cerebral malaria, a deadly form of the tropical disease. The study identifies a potential drug target and way forward toward alleviating this condition for which few targeted treatments are available.

In studies with mice, investigators discovered that the EphA2 protein is important for onset of leaky brain, a hallmark symptom of cerebral malaria. The team also demonstrated that blocking EphA2 with different drugs prevented this dangerous symptom from occurring. According to the researchers, the findings indicate that a similar therapeutic strategy could potentially prevent the disease in humans.

"The advance is really significant," says Tracey Lamb, Ph.D., senior author of the study and associate professor in Pathology at University of Utah Health. "New targets to block a leaky brain in malaria are urgently needed to prevent mortality from cerebral malaria."

The research, led by scientists at U of U Health in collaboration with Centre Pasteur du Cameroun in Cameroon, appears online in the journal PLOS Pathogens.

Cerebral malaria strikes more than 575,000 each year, disproportionately affecting young children in sub-Saharan Africa. The tropical disease causes fluids to leak from the brain, and coma, eventually killing 20% of those who are infected. Among survivors, 80% develop long-term neurodevelopmental symptoms including seizures and mental health disorders.

Disruption of the blood brain barrier is a critical step in the pathogenesis of cerebral malaria that makes the disease so deadly. True to its name, the blood brain barrier is made up of cells that line blood vessels and fit together tightly, assembling into a barricade. The semi-permeable cell wall keeps fluids from the nervous system from mixing with the bloodstream while allowing essential metabolites to pass through.

when they saw that the molecule became activated at the site of the SCIENTISTS have identified a key blood brain barrier just prior to its showed that EphA2 disrupts the blood brain barrier by loosening the tight junctions between cells, removing the glue that keeps these cells bound to each other.

> With a key player identified, the scientists wondered whether blocking EphA2 would protect the blood brain barrier during infection. Treating infected mice with two different agents showed this seems to be the case. One agent was a repurposed cancer drug, Nilotinib, that inhibits several molecules including EphA2. The second was an engineered protein that specifically blocked molecules called ephrin ligands that will interact with EphA2 and prevent its activation.

> According to the study's first author Thayer Darling, Ph.D., it is notable that both therapeutics were effective when given four days after infection. They did not need to be administered as a preventive prior to infection which can be difficult to do in a real-world situation.

> "Usually children are not brought in to the clinic until they're already experiencing symptoms of malaria," says Darling, who carried out the research as a graduate student with Lamb. "We're hopeful that therapeutics that target EphA2 may be able to prevent cerebral malaria in children after the onset of those initial symptoms."

> The work was primarily conducted in laboratory mice but additional results show clinical relevance. Blood from children with symptoms of cerebral malaria have elevated levels of an Ephrin protein that binds EphA2. Finding the marker in these children suggests the same pathway mediates the disease in both mice and humans.

> "Understanding how infection with malaria parasites can lead to deleterious neurological conditions is key to discovering new therapeutic means to curb malaria-associated deaths globally," says co-author Lawrence Ayong, Ph.D., a professor at

Rising prices of vegetables to go down soon, says NBS

FOOD prices in the country are likely to decrease if all factors remain the same, the move that is likely to end public outcry of escalating price of vegetables, the National Bureau of Statistics (NBS) said yesterday.

Announcing the annual headline inflation rate for the month of January 2020, the bureau's acting director of population census and social statistics, Ruth Davison said there are all indications that food prices are likely to go down as farmers are nearer the harvesting

She said the annual headline for the month of January 2020 has decreased to 3.7 percent from 3.8 percent recorded in December 2019.

"The decrease of the headline inflation explains that , the speed of price change for commodities for the year ended January 2020 has decreased compared to the speed of price change recorded for the year ended December,2019," she said.

She noted that the overall index went up to 117.60 in January ,2020 from 113.38 recorded in January,2019, adding that food and nonalcoholic beverages inflation rate for the same moth has also decreased to 5.7 percent from 6.3 percent recorded in December 2019.

Annual inflation rate for food consumed at home and away for the month of January, according to the acting director, has also decreased to 6.4 percent from 6.9 percent recorded in December, 2019.

On the other hand, the 12- month index

change for non-food products in January, 2020has slightly increased to 2.4 percent from 2.3 percent recorded in December, 2019.

The annual inflation rate, which excludes food and energy for the month of January 2020, she said, has stagnated at 2.1 percent as it was recorded in December, 2019.

At the same time, the national consumer price index from December,2019 January,2020 has increased by 0.4 percent compared to increase of 0.6 percent recorded from November, 2019 to December, 2019.

"The overall index has increased to 117.60 in January,2020 from 117.10 recorded in December,2019" she said, adding that the increase in overall index is attributed to the price increase for food and non-food items.

Some of the food items that contributed to such increase include fish by 1.7 percent, vegetables (4.1), beans (2.2), cassava (2.4) and cooking bananas (1.7).

On the other hand, some of the non-food items that contributed to such increase includes, actual rental paid by tenants by 2.3 percent, petrol(1.4) and school fee for private primary and secondary schools b 1.9 and 1.8 percents respectively.

In comparison with other East African countries of Kenya and Uganda, all the three countries have experienced decreased annual headline inflation rate with Uganda having 3.4 percent compared to 3.6 percent recorded in December as Kenya also move down from 5.82 percent recorded in December,2019 to 5.78 percent in January.

Mining town appeals for banking services

MINERAL traders in Makongolosi town in Chunya District, Mbeya Region are forced to travel more than 35 kms for banking services as the town lacks these facilities.

They claim they get the service at Mkwajuni, headquarters of Songwe District or Chunya town, the situation

that poses hazards to them when Makongolosi town has many people carrying huge amounts of cash to and from the banks.

Speaking during the visit by the Chunya to inspect the area's gold markets who also need banking services and established at the mining sites, the traders appealed to the government to bring banking services closer to them. One gold trader, Juma Solomon, said

He said apart from the minerals District Commissioner business, there are also to bacco farmers Makongolosi is nearer to tobacco farming zone. "A miner who has just received a lot of cash has no peace especially when carrying the cash to

the bank as every time you think of the but mobile money agents in the area possibility of being attacked," he said.

The Chairman of Chunya District Council Bosco Mwanginde said the town has a huge circulation of cash due to minerals trade, and added that long distances to areas with banks pose great danger to the traders.

He said some of the traders use mobile services to store their money,

fail to offer adequate services because often traders need huge amounts of cash for minerals purchases.

"One person can hold up to 100m/ in cash and it becomes too risky for him to travel to Chunya or Mkwajuni for banking services," Mwanginde said.

Speaking on the issue, Chunya District Commissioner Maryprisca

Mahundi said there is one bank agent in Makongolosi town whose agency serves two banks but he also cannot cope with the huge number of people needing banking services.

She called upon banks in the country to grab the opportunity to open branches in the area to assist the wananchi, while also expanding their own banking business.

Moshi Rural residents went into panic yesterday following information that desert locusts from Kenya are swarming across the district and likely to spread further posing significant threat to food security.

The desert locusts have wreaked havoc in Somalia and Ethiopia. , Reports show that, the first swarm of locusts crossed the border in to Kenya from Somalia on 28th December 2019.

Speaking in separate interviews, the residents expressed worries since most of them cannot differentiate between desert locust and hoppers.

Aurelia Francis from Kishumundu village, Uru East ward in Moshi rural district said: "We were informed by our leaders on the invasion of desert locust in our area spreading from Kenya through Korini in Old Moshi ward and Mwasi South village located near the Tanzania/Kenya border".

Anna Ngowi from Mwasi South village said villagers are worried of the insects as they are likely to cause hunger. She said in 1960s when the 'dangerous hoppers' invaded the area. people experienced hunger, calling upon Kilimanjaro region authorities to take measures to control them from spreading further into the country.

Locusts can cover as much as 150 kilometers (93 miles) a day and an average swarm will destroy crops sufficient to feed 2,500 people for a year, according to the UN.

A single swarm can contain up to 150 million locusts per square km of farmland, an area the size of almost 250 football fields.

Mweagala explained that the incident occurred last Saturday at around 5.00 pm when the three were bathing at the pond in the vicinity of their home and managed to bring the three when one of them stumbled into deep

He said after the other two saw their kin not emerging from the water, they decided to go after him to try save him, but they too stumbled into deep water and started screaming for help.

The wananchi rushed to the scene children out but their condition was

He said they were rushed to the Igunga district hospital for treatment but at around 7.00 pm all of them were pronounced dead.

The father of the deceased, Joshua Said said he was told by neighbours via phone that his three children drowned in the pond and were rushed to the hospital and added when he arrived at the hospital to only to be told all were

Ag Igunga district medical officer Mashaka Lunyilija confirmed to have received the three children at the hospital and that as they were receiving treatment all of them were pronounced

Tabora Regional Police Commander ACP Barnabas Mwakalukwa said he has yet to receive the report from OCD Iganga but called upon the wananchi to be careful when allowing their children to bathe in water ponds and rivers as more than 20 children have been reported to have drowned in Tabora

Floods pose danger to rice harvests in **Mbarali District**

FARMERS in some areas of Mbarali District in Mbeya Region claim that there is the danger for them to delay in rice farming due to floods that sweep away seeds each time they plant.

Speaking to this paper at different times on Monday, they said the ongoing rains bring benefits to some areas, but in others they are a big loss due to floods.

One farmer Hohm Mjwanga, a resident of Chimala Ward said each time he plants rice seeds in the fields, floods come to sweep them away while in other fields the seeds rot due to high water levels at all times.

He said even though rice needs a lot of water, but not on the levels at present, many farmers are not well conversant on how to cope with floods in their paddy farms.

"I prepared a rice field to reap one bag of rice, but what I harvested was only quarter of the bag which is of low quality due to flood water," said Mjwanga.

He said for big farmers including investors of big farms flood water is beneficial as they have the technology in controlling the quantity of water in their farms.

Another farmer Toros Magoha, said there are areas where irrigations scheme are employed but even there floods have swept away the seedlings and have no hope of replacement

He said as of now they plant depending on the rains and in case the rains cease even for a week, they stop until it rains

WMO appeals for more investments in weather services

THE World Meteorological Organisation (WMO) has urged the World Bank (WB) and other development partners to capacitate member countries to invest on Public-Private Partnerships (PPP) for best provision of weather services.

Hooke said engaging private sector is key in the production and provision of high-quality and reliable climate and weather services.

Dodoma leads the nation in high percentage of stunting

DODOMA leads other regions in the country for having high prevalence and percentage of stunting among under- five year children, a situation which attributes to poor performance in education sector within the region.

According to the regional medical officer (RMO), Dr Best Magoma, currently, the region's stunting average stands at 37.2 percent, which is more than the national stunting rate of 31.8 percent.

Speaking during the Regional Nutrition Committee convened in capital city under chairmanship of Dodoma regional commissioner (RC) Dr Binilith Mahenge; Dr Magoma expressed the need for authorities in all districts within the region to embark on fresh strategies to counter the situation.

"The effects of stunting are usually irreversible and are mainly delayed motor and cognitive development (impaired mental processes of perception, memory, decision making and reasoning). However, stunted girls are likely to experience obstructed labour during childbirth hence highly exposed in developing fistulas and even maternal and/or newborn deaths," he observed.

He added, stunting also predisposes an individual to overweight, obesity and related adulthood consequences such as cardio-vascular heart diseases, hypertension and diabetes.

"There's a need for all districts to commissioners from all six districts conduct serious public awareness, of Dodoma, health experts and other especially among primary school stakeholders also saw launching pupils to impart them with key knowledge over how to cheat the dangerous ill disease from grass root levels," he urged.

Expert stresses need for regular health screening

TANZANIANS have been urged to cultivate the habit of doing regular medical check-ups to know their health

This will help them identify any strange condition and seek early treatment to avoid sudden deaths which are becoming common in the Tanzanian society.

Tunduru District Medical Officer (DMO), Dr Wendy Robert made the call yesterday here when speaking with this paper on the district's strategy to scale up medical services in the southern Tanzania's district.

Dr Robert urged Tanzanians to prioritise health by undergoing regular check-ups into daily lives, saying some diseases do not necessarily portray

the only way for us to know our full health status is to attend check-ups in health facilities rather than relying on traditional healers.

She said there is need to always know one's health status in order to be in a better position to deal with conditions that might prove fatal if unattended to.

"Currently the district has 65 health centres and three hospitals, which provide better health services, the situation that doesn't provide a room for people to seek services to traditional healers," she said.

According to her, authorities in the district have come up with a new strategy that compels health facilities to X-ray room, morgue, as well as one offer competitive services to all people residential house for staff, incinerator, irrespective of their socio-economical background, so that there is no room

Equal opportunity to women benefits all

CONOMIC opportunities girls. for women matter not just because they can bring money home . They also matter because opportunities empower women more broadly in society and this can have a positive impact on others. If women have a bigger say in how household money is spent this can ensure more of it is spent on children.

Improvements in the education and health of women have been linked to better outcomes for their children in countries as African countries and Tanzania is no exception. Giving power to women at the local government level led to increases in public services, such as water and sanitation.

Just as the costs of inequality are huge, so is the challenge in overcoming it. The gaps in opportunity between men and women are the product of pervasive and stubborn social norms that privilege men's and boys' access to opportunities and resources over women's and girls'.

What is therefore required is a sustained, comprehensive drive to end inequality. This will require addressing multiple and reinforcing barriers to equality among families, job and product markets, as well as among formal and informal institutions.

A first step would be to improve the access for girls to education to reduce the in-built disadvantages that they have from birth onwards. This is recognized by many across South Asia and there has been a lot of progress, with initiatives such as Educate Girls in India tackling the root causes of gender inequality in education.

A second step would be to address market and institutional failures that lock women into low return, highly vulnerable forms of employment and of self-employment.

Much can be achieved by encouraging the creation of a large number of jobs that are seen as suitable and safe for women. A third step will be to address the violence against women and

Violence has a multitude of negative effects, from poor education and health to discouraging women from commuting to better-paid jobs. Many countries have adopted progressive legislation. But many laws are not enforced, the public and law enforcement are largely unaware of them, and structural weaknesses in police and judicial systems deny women access to justice and render

laws ineffective. A woman is a female human being. The word woman is usually reserved for an adult, with girl being the usual term for a female child or adolescent. The plural women is also sometimes used for female humans, regardless of age, as in phrases such as women's rights . Women with typical genetic development are usually capable of giving birth from puberty until menopause. There are also trans women (those who have a male sex assignment that does not align with their gender identity), and intersex women (those born with sexual characteristics that do not fit typical notions of male or female).

In business school and in the workplace, women may face unique challenges and, therefore, must find unique ways to overcome those challenges. While each woman's experience is different, preparing for certain situations and knowing how to handle them can help women succeed academically and professionally.

Remedies will include improved legal systems, institutions, and services. Specific remedies could include using reproductive health personnel as a way of counselling women suffering this violence. It could also include sensitizing police officers so they no longer stereotype victims, building shelters for abused women, and appointing judges specialized in gender violence issues. Remedies will also require expenditure on infrastructure so that cities are well lit and women are safe on public transport.

Teenage pregnancies a global social and medical problem

teenage motherhood are a cause for concern worldwide. From a historical point of view, teenage pregnancies are nothing new. For much of human history, it was absolutely common that girls married during their late adolescence and experienced first birth during their second decade of life.

This kind of reproductive behavior was socially desired and considered as normal. Nowadays, however, the prevention of teenage pregnancies and teenage motherhood is a priority for public health in nearly all developed increasingly in developing countries. For a long time, teenage pregnancies were associated with severe medical problems; however, most of data supporting this viewpoint have been collected some decades ago and reflect mainly the situation of per se socially disadvantaged teenage mothers. According to more recent studies, teenage pregnancies are not per se risky ones.

A clear risk group are extremely young teenage mothers (younger than 15 years) who are confronted with various medical risks, such as preeclampsia, preterm labor, and small for gestational age newborns but also marked social disadvantage, such as poverty, unemployment, low educational level, and single parenting. In the present study, the prevalence and outcome of teenage pregnancies in Austria are focused on.

Teenage pregnancies and teenage motherhood are a cause for concern worldwide. According to the World Health Organisation (WHO), about 16 million girls aging between 15 and 19 years and about one million girls younger than 15 years give birth every year. Nowadays, the vast majority of teenage pregnancies occur in low- and middle-income countries characterized

▼EENAGE pregnancies and by poor health-care services; therefore, complications during pregnancy, birth, and postpartum phase (e.g., 42 days after birth) are the second cause of death among girls aging between 15 and 19 years worldwide. Additionally, it is estimated that some three million teenage girls undergo unsafe abortions, which may result in consecutive reproductive problems or even death. Fifteen years ago, The United Nations International Children's Emergency Fund (UNICEF) reported that worldwide every fifth child is born by an adolescent mother and 80 per cent of these socalled teenage pregnancies occur in third-world countries

Although in traditional societies the majority of these pregnancies are socially desired, several studies have pointed out the enormous risks which are associated with teenage pregnancies such as anemia, preterm labor, urinary tract infections, preeclampsia, high rate of cesarean sections, preterm birth, and low birth weight infants and even maternal and newborn mortality.

Teenage pregnancies, however, still also occur in high-income countries and despite much better medical care teenage pregnancies are also considered as risky and policy tries to avoid too early motherhood. This is not only due to medical problems, but first of all the social consequences of teenage motherhood. Therefore, the analyses of causes and consequences of teenage pregnancies have been the topic of much research and debate.

Today, teenage pregnancies are a worldwide phenomenon. About 11 per cent of all births worldwide are still girls aged 15-19 years old. According to the World Health Statistics 2014, the average global birth rate among 15-19 year olds is 49 per 1000 girls, whereas country rates range from 1 to 299 births per 1000 girls. Rates were highest in sub-Saharan

HEN the 33rd African Union Summit began Sunday, conflict in Cameroon's Anglophone regions was on the agenda. Yet the violence is unlikely to be seriously discussed by African leaders.

If the African Union (AU) is to live up to its founding charter's high ideals, its members must confront the human rights abuses occurring in Cameroon, rather than sweeping them under the carpet.

Cameroon's historically Englishspeaking Northwest and Southwest regions are home to 20% of the country's population. The UN-backed referendum following independence in 1960 failed to give the Anglophones the option to form an independent country.

Although they were promised a degree of autonomy under a federal system, power shifted the Francophone-dominated capital, Yaounde, by 1972. There has been an 'Anglophone Problem' of marginalization in Cameroon ever since.

Peaceful protests began in 2016. when the government imposed French-speaking teachers and judges on Anglophone schools and courts, with a systematic process of eroding the common law.

Impartial international human rights groups believe the regime responded with disproportionate force. Escalation over the past three years has seen more than 200 villages burned, opposition leaders and journalists detained and tortured, civilians randomly fired upon and terrorized, causing 656,000 people to flee their homes for the bushes, Francophone regions, or nextdoor Nigeria where 50,000 people are currently living in refugee camps. More than 2,000 people are thought to have

In response, some of the more extreme Anglophone secessionists formed increasingly violent militias over time, forcing schools, clinics, markets, and businesses to stay closed.

Human rights organizations report atrocities on both the government and separatist sides. The economy is at a stand-still, and normal life is impossible for many of the 5 million residents of the Northwest and Southwest.

Reacting to international pressure, the Cameroonian government held a Major National Dialogue over several days in October 2019. These limited talks were boycotted by separatist groups and some members of civil society were unable to safely attend.

The government subsequently granted 'special status' to the two Anglophone regions. However, critics argue that the proposed level of autonomy remains loosely defined,

with power remaining in the centralized Francophone administration Yaounde.

Even so, any implementation is uncertain, especially in light of the legislative and municipal elections set for Sunday February 9, in which few Anglophones are expected to participate or vote due to worsening violence and horrific threats.

The Centre for Humanitarian Dialogue in Switzerland has offered to facilitate peace talks, but the Cameroonian government has not consented to take part. Very recently, the Africa Forum announced a Symposium on Cameroon in April to support a peaceful resolution -- a welcome development.

The African Union role

The AU is well aware of the violence suffered by unarmed civilians in the Anglophone regions. As recently as November 2019, a delegation including the chairperson of the AU Commission urged President Paul Biya to implement the conclusions of the Major National Dialogue, encouraging peace and stability through this nonviolent process.

Yet, in his New Year's message, Cameroon's leader reminded his citizens that the armed forces would carry out their duties "without weakness." Biya persists in believing a military solution will resolve the Anglophone issues.

In January 2020, Cameroon delivered a 190-page report to the AU, measuring its own performance against its obligations under the African Charter on Human and Peoples' Rights. The document, which amounts to a student

that Cameroon had ratified sundry protocols protecting human rights.

Its description of Cameroon is at odds with the findings of watchdog groups such as Transparency International and Freedom House, both of which give Cameroon the lowest ranking.

Human Rights Watch and Amnesty International would also struggle to recognize the country as it appears in its report to the AU.

Cameroon The government congratulates itself for creating a National Commission for the Promotion of Bilingualism and Multiculturalism, aimed at "maintaining the peace," "consolidating national unity" and "maintaining social cohesion."

The report to the AU also justifies shutting down the internet in the Anglophone regions for four months in 2017, saying that people were using it to stir up "hatred, violence, insurrection and secession." Freedom of speech applies only if used in a "responsible manner."

Three months ago, 65 mainly African human rights groups wrote an open letter to the chairperson of the African Commission on Human and Peoples' Rights, calling on the AU to urgently take specific actions to address the deteriorating security situation in Cameroon. They received

no response. Among many observers, the AU has a poor reputation. Some criticize it for spending more time seeking to guarantee its leaders' immunity from prosecution than persuading its members not to persecute minorities or detain political opponents.

The African Commission on Human

marking her own essay, boasted and Peoples' Rights held its 2019 summit in Egypt under the leadership of current AU Chair and Egyptian President Abdel Fattah al-Sisi -- US President Donald Trump's "favorite dictator," who is not known for respecting civil liberties.

If the AU is to gain legitimacy in the eyes of African citizens, it must prove it exists not for the well-padded political and business elite, but to speak the truth when one of its members violates the founding principles of the AU.

Cameroon deserves more than the slap on the wrist delivered in a 2018 AU resolution. Diplomats know there is a difference between hand-wringing resolutions urging Cameroon to respect human rights, and exerting genuine, sustained pressure on President Biya behind closed doors.

The only way forward for Cameroon is through inclusive peace negotiations between the government and both moderate and extremist Anglophone voices.

The AU summit -- whose 2020 theme is "Silencing the Guns" for development --should make it clear to the Cameroonian government and the armed separatist groups that there will be consequences if they refuse to participate in the proposed Swiss-led peace talks, and the upcoming Africa Forum symposium as well.

If the AU's African Charter on Human and Peoples' Rights is to mean anything, it must apply to a situation

Clues on how to beat gender bias in immigration reporting

MEN make up nearly half the population of immigrants worldwide, yet when it comes to media coverage, their voices often are missing from the mix. An analysis by the Fuller Project for International Reporting sheds light on why this gender gap exists, and on what kinds of stories we tell - and don't tell - about immigration in general.

Fuller's review of 100 stories on immigration from various news media outlets found that coverage focused almost exclusively on national security, conflict and crisis. Issues impacting women specifically were sorely lacking. The sample was randomly drawn from the Migratory Notes' newsletter, which compiles articles on migration.

"The findings helped identify underreported stories that were important to the national conversation on immigration," said Fuller Project co-founder and executive director Xanthe Scharff. The Fuller Project reports globally and in the United States on issues that impact women.

"The absence of women's voices was striking," said Rikha Sharma Rani, a reporter who spearheaded a yearlong reporting series on immigration and women for the Fuller Project in hopes of filling the gap identified by

The results of the content analysis painted a dismal picture of how immigration reporting leaves out women. One of the findings was that only two out of the 100 stories focused on issues that directly affect women, such reproductive health and domestic violence.

Women were quoted half as often as men in the 100 stories. Only one article focused on the accomplishments of women immigrants and their contributions to society.

Not only does the coverage fail to acknowledge that women face unique challenges as they migrate, but that they make meaningful contributions once they are settled.

A report by the National Business of immigrant entrepreneurs in America are women, and 13 per cent of all women-owned companies are run by women born outside the US.

According to a report in New American Economy, immigrant women play critical roles as caregivers and service providers all across the country. As entrepreneurs and STEM (science, technology, engineering and mathematics) workers, they have helped spur eco-



nomic growth and innovation.

Without consciously acknowledging women's economic role, and leaving their voices out of coverage, these stories go overlooked.

Besides the focus of stories, the team at the Fuller Project also identified gender bias in the sources quoted in stories. Male government and law enforcement officials who deal with immigration were three times as likely to be quoted as women immigration officials in the stories examined in the

Although government immigration workers tend to be disproportionately male - only 5 per cent of Customs and Border Patrol agents are women there are women experts in a variety of fields capable of commenting for stories. Yet male voices predominated

The Fuller study concluded that journalists need to make a concerted effort to include the voices of women and girls in media coverage of immigration.

In a co-authored Columbia Jour-Women's Council noted 40 per cent nalism Review (CJR) article, Rani addresses questions about gender bias in immigration reporting: "The failure to tell a more representative range of stories about the immigrant experience helps push a largely derogatory and inaccurate narrative of immigrants. These narratives influence which policies are embraced by the public and endorsed by their representatives in government."

building awareness that women are underrepresented, as the Fuller study does. Then, reporters should go the extra mile to find their missing voices.

Rani offered the following advice for building the immigrant narrative, with an eye toward giving women fairer coverage: "Broaden the lens. Look at how immigration touches all aspects of society, from the economy to education and politics. Take a wider view of the impact immigrants make when they resettle - men and women."

In CJR, Rani writes: "How might our debate on immigration be different if more stories showed immigrants building flourishing businesses, working in public service, and contributing in a myriad of ways to the betterment of communities?"

Go beyond the border. Once people enter into a new country, there is a tendency for reporters to drop the story. Yet, for immigrants, this is the beginning of their dreams for the future. What transpires when they start a new life? Where do they live, what jobs do they take on and what are some of the biggest challenges they face? Ask these questions in general, then take a closer look at how immigrant women are settling in, specifically.

Explore root causes of immigration. Rani called the reasons people leave their home countries "a hugely underexplored piece of the immigrant conversation". Investigate why people are leaving their home countries, and workers, they have helped spur eco- The first step to fairer coverage is explore potential policies or changes • **Agencies**

that are working to address these root

Investigate violence as the culprit. Women are largely the ones affected by domestic violence, which was accepted in the US as a reason for seeking asylum until 2018, when the 2014 decision was reversed.

To gain a greater understanding, Rani suggests the comparing and contrasting of countries in a single region to see how they handle violence within their borders. Which have been most successful at quelling domestic violence or attacks by criminal gangs? What policies are in place that work? Would these same strategies be effective in other places?

Look beyond crisis and failure. Rani admits that journalism's watchdog role in exposing wrongdoing and drawing attention to problems remains important. "But if that's all you're reporting, you're creating a very misleading picture of immigrants," she says.

"There are so many untapped human interest stories out there. The challenge is to make sure women's voices and their issues are included in the overall conversation," she adds.

Malawi court gives electoral justice in Africa a much-needed boost

TILL this week's Malawi Constitutional Court ruling to annul last year's presidential election set a precedent for more bravely independent judicial rulings on other African elections? Or will Malawi instead follow Kenya's discouraging example, which showed a spark of judicial independence on elections three years ago before relapsing into the familiar pattern of incumbent presidential predominance?

The Malawi court found this week that so many voting documents had been altered - many of them with Tipp-Ex correcting fluid that it had to declare null and void the re-election of President Peter Mutharika in last May's polls.

In a unanimous decision five judges, with Judge Healey Potani presiding, said 'it has been our finding that the irregularities and anomalies have been so widespread, systematic and grave such that the integrity of the results has been seriously compromised.' So the results declared by the Malawi Electoral Commission 'cannot be trusted as a true reflection of the will of the voters as expressed through their votes duly cast.' The court called for fresh elections within 150 days.

The court's judgment, coming almost a year after the vote, was also a victory for civil society which had mounted unprecedented and sustained mass mobilisation in Malawi. Mutharika's political opponents and judicial activists in Malawi and elsewhere have hailed Judge Potani's ruling.

Kaajal Ramjathan-Keogh, Executive Director of the Southern Africa Litigation Centre (SALC), said: 'SALC was encouraged to observe the independence and integrity displayed by the High Court sitting as the Constitutional Court in the decision handed down earlier this week. This served as affirmation of the civic protests which were ongoing since May.

'It is a concern however that the electoral challenge result has only been handed down now some nine months after the election. It is also significant that this is the first time in the history of Malawi that the validity of presidential elections [has] been subjected to a full trial process.'

It was indeed a huge triumph that the courts stamped the imprimatur of judicial authority and credbility on one complaint at least.

This on a continent where countless elections are rigged by incumbents, where courts have invariably thrown out such challenges received, and where it is probably true to say that sham democracy might become the norm.

The Constitutional Court also sternly rebuked the electoral commission for having violated Malawi's constitution by tampering with the results. The court ordered the Public Appointments Committee of the National Assembly to 'inquire into the capacity and competence of the current [electoral commissioners]

to conduct fresh elections.' The court gave Parliament 21 days to amend the electoral legislation to provide for run-off elections in the event that no single candidate secures a majority of votes. This arose from the fact that the court also ruled that Mutharika had been reelected unconstitutionally because he had not secured 50% plus one vote.

He had won only some 38.5% of the votes, while second-placed Lazarus Chakwera of the Malawi Congress Party garnered 36% and United Transformation Movement leader Saulos Chilima came third with 20%. These two contenders brought the results challenge to the court.

Despite winning only a plurality and not a majority of the votes, Mutharika was declared duly elected because the electoral act doesn't prescribe a majority. Judge Potani ruled that the electoral act thereby violated the constitution which is specific that a presidential candidate must secure a majority of votes to be duly elected.

As far as can be established, the Malawi court's annulment of last year's election was unprecedented in Africa - except, significantly, for one previous ruling. That was of the Kenyan Supreme Court throwing out the reelection of President Uhuru Kenyatta in the August 2017 elections, also because of irregularities in vote tallying.

Grant Masterson of the Johannesburg-based Electoral Institute for Sustainable Democracy in Africa told Daily Maverick that the Malawi court ruling would have farreaching consequences for democracy in Africa. Masterson, who observed both the overturned Kenyan and Malawi elections, said the annulling of elections through judicial review should encourage voters everywhere to pursue legal redress 'with an elevated expectation of success.'

The Constitutional Court's judgment is probably causing some embarrassment to election observers, as did the Kenyan court's overturn of the election there. Observers from the African Union, Southern African Development Community, Commonwealth and European Union all praised the Malawi Electoral Commission for its conduct of the elections in their interim reports immediately after the voting.

The Kenyan precedent is generally not very encouraging for what might happen next in Malawi. Masterson told Daily Maverick that the Kenyan experience suggested it would be a massive challenge to organise fresh elections in such a short time. But the most dismaying precedent from Kenya is that the re-run elections plunged into chaos for a variety of judicial and political reasons.

Kenyatta's main presidential rival Raila Odinga demanded deep reforms to the electoral commission to ensure the re-run was truly free and fair. Kenyatta never allowed these reforms and when Odinga went back to the Supreme Court just before the October 2017 re-run to demand a delay, the court couldn't muster a quorum of judges.

UNFPA highlights need to address sexual and reproductive health of women in crisis areas

t is a hot and cloudless morning, a sign that it will be sunny right through the afternoon. Joseph ■ Mailu moves along rows of fruiting mango trees with a long pole in his hand, harvesting the mature fruits.

The United Nations Population Fund (UNFPA) is appealing for \$683million in their mission to address sexual and reproductive health services for women and girls in conflict areas in

At the Humanitarian Action Overview 2020, launched on Thursday, the sexual and reproductive health agency highlighted the urgency with which the issue should be treated.

With more than 168 million people currently requiring humanitarian assistance in the world, UNFPA projects 45 million women, girls and young people will be affected by some kind of conflict this year.

For women and girls, sexual and health reproductive health rights have often come as secondary priority in crisis situations, but experts say it's time to make them a primary concern.

"[These] types of service have long time been forgotten," Arthur Erken, Director of UNFPA Division of Communications and Strategic Partnerships (DCS), told IPS. "It should not be an afterthought, it should be part and parcel of [the whole concern]."

"We're focusing on women and what they're going through because they're on the front lines," Ann Erb Leoncav-

allo of UNFPA told IPS. "They're trying to take care of their children, they're getting pregnant, they're having babies, they're getting bombed, they're suffering from floods, high waters, you name it." Leoncavallo added that many of the

women in areas of conflict might head single-parent households or have their own trauma. "They get depression, they get traumatised because they faced increased of gender-based violence," she said. The \$683 million will be used for efforts towards women's reproduc-

tive and sexual health rights across 57 countries, of which about \$300 million will be directed towards UNFPA's projects in Arab state regions, including countries such as Syria, Yemen, Iraq, Sudan, and Somalia.

In order to help women reach out for help, unlearn their shame and stigma, UNFPA is currently working with a "safe space" for many women to take a break from their everyday activities.

The "women and girl safe spaces" is dedicated space in the refugee camps where women can come and meet with other women, share notes, relax, and have a safe environment to discuss concerns and ask for help, Erken explained.

"It's safe, men are not allowed," Erken said, adding that the purpose of the space is to put a lot of attention to calming women, giving them breathing space, and often counselling ser-

He says there doesn't seem to be any stigma about women coming into these spaces, pointing out refugee camps in Jordan that have the facility. He learned from some of the service providers the women do visit, when their kids are in school and their husband occupied.

Dr. Afrah Thabet Al-Ademi, a UNFPA medical doctor in Yemen who works with women who have escaped conflict, says education has a role to play in destigmatising these services for refugee population.

A staggering \$100.5 million is being requested specifically for the crisis in Yemen, the highest on the list provided by UNFPA.

"A lot of women who are not educated, who feel targeted, and feel stigma to talk about their needs or family

planning," Al-Ademi told IPS.

She recalls one time when she was meeting with a woman who had just given birth and who had covered her baby with a headscarf.

"When she exposed the baby, I found that she covered the baby with a newsletter, she didn't have clothes," Al-Ademi told IPS.

As a result, UNFPA in Yemen is now developing a kit specifically for mothers of new borns, to be put in "health facility for any woman who comes in for deliver".

"The clothes is like a dignity for her," said Al-Ademi.

The "Mama Kit" has clothes for the baby, pads for the mother, blankets, and diapers, among other things for the newborn.

Chinese society unites together to battle against novel coronavirus

CHINA has mobilized all resources available to battle against the novel coronavirus. In the race against the virus, all society members are united as one, supporting the country's epidemic prevention and control so as to finally overcome the difficulties with concerted efforts.

At present, finance departments at various levels are strengthening financial support for epidemic prevention and control. Governments are supporting local enterprises to deliver assistance to places in need of help. Medical corporations are working day and night to produce medical materials and develop anti-virus drugs. The whole society is donating supplies and money for epidemic control with strong enthusiasm.

As of Feb. 3, finance departments at various levels have allocated a total of 47 billion yuan in subsidies for the prevention and control of the epidemic. The money has been mainly used for treating patients, subsidizing medical staffs and epidemic prevention workers, and purchasing equipment needed for epidemic prevention and control and rapid diagnostic reagents.

In addition to the financial support, customs and civil aviation departments have also acted to ensure the curbing of the virus.

According to customs statistics, from Jan. 24 to Feb. 2, customs across the country imported 240 million pieces of epidemic prevention and control materials in 94,000 batches with a total value of 810 million yuan. Protective equipment including 220 million pieces of masks, 2.529 million pieces of protective suits, and 279,000 pairs of goggles, which was worth 610



million yuan, accounted for 74.9 percent of the imports.

As the forefront of the battle against the epidemic, customs of Wuhan Tianhe International Airport inspected and released 7.77 million pieces of imported epidemic prevention and control materials in 22 batches by Feb.1.

At present, Chinese customs have set up special service counters and green channels at customs clearance sites across the country to provide convenient and efficient customs clearance services for epidemic prevention and

By Feb. 2, a total of 4,330 flights have delivered 604,563 pieces of protective materials such as masks, protective suits and disinfectants weighing 4,671.54 tons. Among them, 138 flights headed to Hubei, delivering 192,475 pieces of prevention and control materials weighing 1,213.62 tons.

At the same time, the civil aviation authority actively coordination authority active authority authority authority authority authority authority author

ed various airlines, transporting 7,558 medics and bringing 399 Chinese stranded overseas back home by charter flights.

Affected by the epidemic, some enterprises encountered temporary difficulties in production and operation.

To solve the issue, various provinces and cities in China have successively introduced relevant measures to support the healthy development of these enterprises and those engaged in

the production of anti-epidemic materials.

On Feb.3, the Beijing municipal government issued relevant measures to assist enterprises to guarantee the supply of protective materials and raw materials, as well as logistics and transportation. The measures are also expected to supervise and guide enterprises to ensure smooth operation and safety.

Binzhou, east China's Shandong Province, formulated twelve policies to support the development of small- and medium-sized enterprises (SMEs). The municipal finance department raised 30 million yuan to establish a financial stability fund for the SMEs to get through the epidemic, and provided bridging funds for enterprises that see short-term difficulties of capital turnover to repay and renew loans on time.

North China's Hebei Province has coordinated and organized a total of 142 key logistics parks and enterprises to guarantee the supply of daily necessities. All of them are actively preparing and transporting materials to guarantee market supply.

In addition, people from all walks of life have been donating materials and money to support the fight against the virus with rising enthusiasm.

As of 7:00 a.m. Feb. 3, the Red Cross Society of northwest China's Qinghai Province received donations totaling 37.58 million yuan, including 35.08 million yuan of monetary donations and materials worth 2.5 million yuan. On the same day, Liuzhou Iron & Steel Co. Ltd. based in south China's Guangxi Zhuang Autonomous Region announced to donate 30 million yuan to support the autonomous region, as well as Liuzhou, Fangchenggang, and Yulin under its administration.

Pharmaceutical companies across China also gave a quick response in a united manner.

Up to now, more than 40 biomedical companies in the Beijing Economic-Technological Development Area have participated in the fight against the novel coronavirus, and the products developed by more than 20 companies have been directly used for epidemic prevention and control.

Four antiviral drug production enterprises in Shijiazhuang, Hebei Province, including Shijiazhuang Pharmaceutical Group Co., Ltd., Shijiazhuang No.4 Pharmaceutical, Yiling Pharmaceutical, and Shineway Pharmaceutical have been running at full capacity to produce medical materials. They have expanded their daily output by 2 to 3 times.

As of Feb. 2, 15 medical and health material manufacturing companies in the city produced 36,600 pieces of surgical masks, 4.4 million pieces of protective masks, and 95,000 pieces of isolation suits.

These medical supplies have offered strong support for national epidemic prevention

Insecurity in the Sahel won't be solved at high-level summits

ERROR attacks in the Sahel have increased five-fold since 2016. In addition to civilian casualties, attacks on military personnel in the Sahelian states, as well as those of the international forces in the region, have risen.

The 2019 Global Terrorism Index lists countries like Mali and Niger among the top 10 states affected by terrorism in Africa. During the last quarter of 2019, nearly 200 soldiers, including 100 Nigeriens and over 90 Malians, were killed by extremists. On 26 November 2019 France, which has 4 500 soldiers engaged in the Sahel region, lost 13 in Mali during a counter-terrorism operation.

It was in this context of increasing insecurity that a high-level summit involving the affected countries - Burkina Faso, Chad, Mali, Mauritania and Niger - was convened in Pau, France, on 13 January. Officially, the main aim of the summit was to strengthen counter-terrorism operations under the auspices of the G5 Sahel. In another sense, it was centred around France's foreign policy objectives.

French President Emmanuel Macron wished to defuse criticisms following the death of French soldiers in a helicopter crash in Mali, and to show that his country intervened at the request of governments in the Sahel countries concerned (see map). The summit also appeared to be an opportunity for France to get clarification from the Sahelian leaders on recent protests against the French military presence in countries like Mali

The final declaration of the G5 Sahel summit marks a continuity with the existing doctrine which focuses on hard security to the detriment of other issues such as development and accountable leadership. Part of the failure of the G5 Sahel's current strategy is the imbalance between these different pillars, poor sequencing of actions and insufficient consideration of the issue of governance.

Mali and Burkina Faso have experienced successive attacks in the Liptako-Gourma area, a rural trans-border zone connecting Mali, Burkina Faso and Niger, which offers favourable conditions for terrorist activities.

The inability of states to integrate these border regions into their national policies and to promote their development has led to disinterest or even the



rejection of state authority. This rejection is linked to both the actions and inactions of government, and has made the work of the entrepreneurs of violence easier.

Public demonstrations in several Sahelian states, especially Mali, show a loss of legitimacy of France in the eyes of local communities after being greeted almost as 'liberators' in 2013.

On 10 January - three days before the summit - these demonstrations aimed to send a strong message to both France and the Malian delegation to Pau. Hundreds of Malians gathered around the Independence Monument in the capital Bamako, where the French flag was burnt and banners displayed with slogans such as 'Down with France'.

In this context, the G5 Sahel summit is a reminder that since 2012, when the crisis in Mali and then more generally in the Sahel escalated, partner states have failed to take full responsibility for their

territorial security. Furthermore, leaders in the Sahel need to recognise that heavy-handed responses often worsen the security situation. G5 Sahel summit focused on hard security to the detriment of development and accountable leadership.

The counter-terrorism toolkit should be broadened to include non-military approaches. It is clear that the crisis in the Sahel has reached an impasse, with states unable to achieve total military victory.

States such as Mali could test the possibility of talks with militants, potentially aiming for local ceasefires before broadening the scope for dialogue. Or at the least, facilitate discussions among local communities to achieve a clearer understanding of the root causes of violent extremism.

Mali has already taken a step in this direction with the recent initiative of the Malian president's High Representative for the Centre, Dioncounda Traoré, to establish dialogue with two leaders of the Group for the Support of Islam and Muslims. Until such new approaches are tested, leaders will continue opting for short-term and coercive strategies that can deliver quick political gains.

Although the transnational nature of terrorism can benefit from external support, the inspiration for lasting solutions should be located where the problem exists. The decision to convene the G5 Sahel summit in France, far from the realities of those affected by terrorist violence, reinforces the notion of a paternalistic former colonial power taking action in Sahel states. This does little to build trust between Sahelian governments and their

citizens - something that is essential to stabilise the affected countries. Increased violence in the Sahel is mainly a consequence of decades of weak governance

For example, establishing or strengthening inclusive exchange networks that highlight the needs of a locality and obligations of its state representatives would create conditions for fruitful dialogue. Beyond preventing and moderating tensions, these networks enable communities to get more involved in security discussions.

m security discussions.

Building trust also depends on improved governance, especially when it comes to access to social services and justice. Evidence has shown that some communities resort to protection offered by terror groups in areas where government

security services are weak.

The intensification of violence

in the Sahel, as a result of terrorism but also the resurgence of local conflicts, is above all the consequence of decades of weak governance in affected countries. Longstanding neglect of communities in remote rural areas and the failure to constructively engage the rising youth population have also enabled terror groups to exploit leadership gaps.

Military action can have only a limited impact in the absence of coherent political responses at the local, national and regional levels. Governments need to engage affected communities about how to better tackle the structural challenges they face. Looking inwards and acting on the concerns of local communities would reduce the inclination to constantly seek solutions from outside.

Next East Africa locust swarms airborne in 3 to 4 weeks, UN warns

ROME

THE UN's Food and Agriculture Organization (FAO) warned Sunday that nymph (baby) desert locusts maturing in Somalia's rebel-held backcountry, where aerial spraying is next to unrealizable, will develop wings in the "next three or four weeks" and threaten millions of people already

Once in flight and hungry, the swarm could be the "most devastating plague of locusts in any of our living memories if we don't reduce the problem faster than we are doing at the moment," said UN humanitarian chief Mark Lowcock.

The locusts were now "very hungry teenagers," but once mature, their progeny would hatch, generating "about a 20-fold increase" in numbers, warned Keith Cressman, FAO locust forecasting officer.

"Mother Nature" alone would not solve the crisis, said Dominique Burgeon, resilience director of the FAO, which has urged international donors to give \$76 million (€69.4 million) immediately.

Swarms, which left damage across parts of Ethiopia and Kenya in December, could also put Uganda, South Sudan, Eritrea and Djibouti at risk, making it the worst such situation in 25 years, the FAO said.

East Africa already has 19 million people facing acute food insecurity, according to the regional inter-agency Food Security and Nutrition Working Group (FSNWG).

'Huge' consumption of foodstuffs and fodder

Somalia last week declared a locust emergency, with its agriculture minister, Said Hussein Iid, warning that "food sources for people and their livestock are at risk."

Desert locusts, normally solitary but triggered to swarm by certain conditions, could consume "huge amounts of crops and forage" when present in large numbers, said Iid.

Experts say aerial pesticide spraying is the only effective control, but that the current hotspot for maturing locusts is in an inaccessible swathe of Somalia held by or under threat by the al-Qaida-linked al-Shabab extremist group.

Alberto Trillo Barca said at a police-guarded press briefing in northern Somalia attended by The Associated Press news agency.

"In the next three or four weeks, these nymphs, as we call them, will develop wings," Barca said on Thursday.

'Unprecedented locust crisis'

UN Secretary-General Antonio Guterres,

speaking in the Ethiopian capital, Addis Ababa, as an African Union (AU) summit kicked off, said Saturday: "There is a link between climate change and the unprecedented locust crisis plaguing Ethiopia and East Af-

"Warmer seas mean more cyclones generating the perfect breeding ground for locusts. This is getting worse by the day," said Guterres.

Climate experts point to a rain-bearing cyclone that reached Somalian waters in December. Its winds had carried locusts from the Arabian Peninsula. Last week, the FAO said swarms had also been sighted in Oman and Yemen.

The locust density in East Africa was so high that even normal drier weather would still fail to inhibit another breeding generation, said Burgeon.

Replacement crop unrealistic

A farmer in Kenya's eastern Kitui County, Esther Kithuka, told the Reuters news agency last Monday that she was worried about crop destruction. Another growing season due to start in April would be too short for any

meaningful production. Since last century, six desert locust plagues or what experts called regionwide "upsurges" have occurred. One of the worst occurred in 2003-2005 in North and West Africa

AFRICAN countries have made progress toward eradicating malnutrition and stunting but need to do more to hit United Nations malnutrition targets by 2025. This was the main message of a meeting that took place during the 33rd African Union Summit.

Speakers at a meeting of the African Leaders for Nutrition (ALN) included the heads of state of Madagascar, Cote d'Ivoire and Sierra Leone, national ministers of health as well as African Development Bank (AfDB.org) President Akinwumi Adesina, head of the African Development Bank.

Leaders acknowledged the scope of

the challenge but sounded a note of world's children being exclusively optimism. "We can conquer hunger in Africa," said Madagascar's President Andry Rajoelina, one of five African Leaders for Nutrition champions. "I call on all our partners to continue to work with us to address hunger and malnutrition." Ivorian President Alassane Ouattara said leaders should take it a step further. "I have proposed for the AU to focus on tackling malnutrition as a theme for 2021," he said.

Stunting has declined by eight percentage points across Africa since 2000, an advance on one of the UN's 2025 targets. African countries have also shown strong progress toward achieving the target of 50% of the

breastfed for the first six months of life. The other targets are: halting the epidemic of obesity; reducing anemia in women of reproductive age; reducing low birth weight and reducing wasting.

The ALN, a partnership of the African Union and African Development Bank, brings together heads of state, Finance Ministers and other leaders to raise awareness and accountability, and reinforce investment by African governments to end malnutrition among children.

The ALN meeting, held in Addis Ababa on Saturday, offered an opportunity to take stock of achievements ahead be held in Tokyo in December.

Adesina outlined initiatives by the Bank and African Union to reduce malnutrition, such as the Continental Nutrition Accountability Scorecard, which offers African leaders a snapshot of nutrition-related progress and

During his opening remarks, Adesina emphasized the paradox of African malnutrition.

"We have 65 percent of the world's remaining uncultivated arable land. We have an abundance of freshwater and about 300 days of sunshine a year. There's no reason for anyone to go hungry," the Bank chief said.

Walking hard, getting nowhere — but Cyril Ramaphosa still enjoys a 62% approval level

UT of 20 key pledges, President Cyril Ramaphosa has made progress on only four and the two major areas of his focus, economic growth and unemployment, have worsened in the past year. Yet, new research by Ipsos shows that Ramaphosa has consistently high popularity rankings as people trust he will get it right.

He measures 62% popularity, only slightly down on the measurement of 2018 when he became president when he enjoyed the approval of 70% of South Africans. Among ANC members, he enjoys an approval rating of 82%, giving him enormous party support for his reform project.

In previous years, Daily Maverick has measured progress on the state of the nation (SONA) addresses on processes, but this year, it chose to measure by impact and completion.

On those outcomes-based measures, Ramaphosa has not done well, but that may be because reform takes longer than a year and can take up to a decade to be effected. The trouble is that Ramaphosa may not have a decade in office because of the factions that lace

Projections for growth in South Africa 2020 by the SA Reserve Bank, the International Monetary Fund (IMF) and the World Bank are all at under 1%.

Unemployment is at its highest ever levels and youth unemployment is particularly impervious to any statistical improvement although South Africa is not short of great ideas, and social entrepreneurs to fix the vexing problem.

Pundits say an investment-grade downgrade to junk when Moody's makes its decision later this year is almost certain. That will see between US\$5-bn to US\$8-billion leave the country, according to modelling by the SA Reserve Bank.

Yet, the reform project is struggling: While he has made important inroads in rebuilding the National Prosecuting

Authority under national director Shamila Batohi, the rate of investigation and prosecution of state capture cases has been slow. Ramaphosa promulgated an NPA investigative directorate led by Hermione Cronje and she has initiated the first major state capture-led investigation into Regiments and Trillian, but the NPA seems light years away from prosecuting the political big-wigs who enabled grand corruption.

At Eskom, incoming CEO André de Ruyter is off to a galloping start, but not before the utility has racked up debts so high that they are now likely to be sovereign - that is, they threaten the country.

A new deal is being inked to get the Public Investment Corporation (PIC) to take over the lion's share of Eskom debt, but the utility has been impervious to improvement in the year under measure. Regular power cuts have become a way of life while tariffs are going up, adding to the burden of all South Africans.

A blistering row

Earlier this year, Ramaphosa and Business Unity SA's president Sipho Pityana had a blistering and uncharacteristic row at a Nedlac meeting as the private sector took public its longstanding complaint that reforms are

Not a single element of the economic stimulus package the president announced in September 2018 when the economy tanked to its worst levels in decades has been successful at scale.

This includes a youth employment plan, the finalisation of the land reform programme (notably expropriation without compensation), a new visa regime to allow skilled emigration and tourism, the restructuring of Eskom and the allocation of spectrum to allow for data prices to come down.

The Youth Employment Service (YES), which aims to secure internships for 2-million young people over the medium-term depends on a growing economy, but the outcomes for spectrum allocation and an e-visa system illustrate the problem. Both plans are running way behind target.

A pilot e-visa project is being tested in Kenya because East Africa is a big feeder market into South Africa, and there is finally a policy paper on spectrum allocation.

But the regulator, Icasa, is a long time away from allocation. The telco industry has also said it will go to court if the spectrum auction plans are implemented as set out.

In numerous interviews, officials say Ramaphosa has made good progress in eight areas.

These are on youth employment (responsibility lies in the presidency), an infrastructure fund (it has a CEO, Sean Phillips and an infrastructure official in the presidency, Kgosiento Sputla Ramakgopa), tourism, the private sector investment drive and the move toward a capable state.

Officials say the reforms at the NPA and at the SA Revenue Service (SARS) are evidence of capability being restored. But all of these are process improvements (a policy paper, an appointment of a new person, a new budget to follow a political commitment), not scaled at impact.

Cutting Ramaphosa some slack "I'm not disappointed at the clean-up agenda," says a leading businessperson who requested anonymity. Momentum to fix institutions including the NPA, SARS and the intelligence services had been good. "It's unrealistic to expect big prosecutions," he said. He is impressed by the commitment to undo capture at Eskom and Transnet.

"There is a clear agenda to roll back state capture. I cut him [Ramaphosa] some slack." Business, he said, is looking with great interest at the recommendations that come out of the Zondo Commission of Inquiry into State Capture including the reduction of powers of the president and also clarity on the appointment of a Public Protector.

"The August [2019] xenophobic attacks showed up that the police are a complete mess. The business forums who hijack construction sites for rents reveal a [shocking] degree of lawlessness. [The] fixing of the police has not happened," he said.

"[The president] has not managed the [business] confidencesapping issues of expropriation without compensation and the National Health Insurance. These would be the ones people regard as a disincentive to investment," said the businessman. The idea that Ramaphosa should be cut slack is common and it shows up in the Ipsos research.

Just over six in 10 South Africans surveyed said Ramaphosa is doing fairly to very well and he





Shanta Gold acquires Acacia Kenya's assets in new deal

N a new deal, Shanta Gold has entered into a definitive agreement through which it will acquire 100 percent of the shares of Barrick Gold Corporation's subsidiary, Acacia Exploration (Kenya)

In its latest report, the London Stock Exchange listed company said through the deal which is valued at U\$15.5 million (over....) it takes over interests in Barrick's AEKL whose primary asset is a 100 percent interest in licences held by Afriore in West Kenya.

"With U\$7 million cash and U\$7.5 million shares, Barrick becomes Shanta's fifth largest shareholder with 6.4 percent interest," the company stated while noting that Shanta will also inherit certain liabilities but also adjust for certain working capital items, for up to an additional U\$4 million in cash consideration to settle third party liabilities.

Shanta which owns and operates New Luika Gold Mine in Chunya district of Mbeya region, said it however required regulatory approvals in Kenya which include-standard consents from the mining authorities to the assignment of interests and the transfer of prospecting licences-approval of the transaction by Competition Authority of Kenya. The company further noted that the transaction is expected to close around mid-2020.

Among other highlights, the company has acquired high-quality gold project with high grade gold resource of 1,182,000 ounces gold grading 12.6 grams per ton; long term exploration potential; major presence in a geologi-

Zambia regulator digs in heels over bundles of non-expiring data

LUSAKA

MOBILE industry stakeholders, including the country's telecommunications industry regulator ZICTA, are confident the introduction of non-expiry data bundles by 12 February 2020 will improve the country's internet penetration rating.

According to recent ZICTA statistics, there are 10, 893, 183 internet users in Zambia representing 62.7% penetration, while the number of mobile phone users currently stands at 16, 889,138, representing 97.2% penetration.

In August 2019 lawmakers passed a motion in Parliament that prevents ISPs from prescribing expiry dates on internet bundles purchased by customers. The lawmakers argued that forcing expiry dates is tantamount to stealing from subscribers because expired bundles benefit the service provider rather than the end users.

To date, MTN Zambia and Airtel Zambia have introduced non-expiry bundles. Airtel Zambia managing director Apoorva Mehro-

tra said, "With the introduction of non-expiry bundles, more customers will now be able to browse."

MTN Zambia chief executive officer Bart Hofker said, "The introduction of the nonexpiry bundles is in line with the changing needs of our diverse customer base." ZICTA director general Patrick Mutimunshi said while service providers' point out that non-expiry bundles slow down business because of having to wait for consumers to exhaust their bundles, the regulator remains adamant that it had little choice in the matter.

Consumer Unity Trust Society (CUTS) Zambia centre coordinator Chenai Makumba said the issue of bundles expiring had been one that many consumers have complained about over the past couple of years - at times consumers' bundles expired before they had been depleted! "We therefore encourage other mobile phone networks to follow suit and provide consumers with the option to buy non-expiring data bundles," Makumba said.

Vodacom to launch 5G services in SA this year

JOHANNESBURG

VODACOM said on Tuesday that, thanks to its recently concluded roaming agreement with Liquid Telecom, it will launch next-generation 5G services in South Africa in 2020.

"Having been the first network to commercially launch 5G in Africa through Vodacom Lesotho, we expect to be able to launch 5G services in South Africa this year," it said alongside a trading update for the three months ended 31 December 2019. "This is possible thanks to a recent roaming agreement with Liquid Telecom, as 5G spectrum is largely unassigned in South Africa."

TechCentral reported in December that Vodacom and Liquid Telecom had signed an agreement which would, in effect, give the country's biggest mobile operator access to a key spectrum band, allowing it to offer 5G services nationally, potentially piping its nearest rivals to the post in deploying the super-fast next-generation technology.

The two companies signed the deal to exploit Liquid's legacy spectrum assignment in the 3.5GHz band. Vodacom said on Tuesday that it has also revised its roaming agreement with Rain for 4G/LTE coverage. This, it said, will "further expand our 4G capacity in an environment

where delays in assigning available spectrum will constrain capacity for all networks." Vodacom Group increased its revenue by 6.6% (6.1% normalised) in the fourth quarter of the 2019 calendar year on the back of a successful summer campaign in South Africa and good growth in its international operations. It added almost half a million customers in South Africa on the back of the campaign. In its other markets, it added 1.7 million customers.

Increased data uptake South Africa revenue and service revenue growth rates improved to 5.9% and 4.6% respectively, supported by increased data uptake, it said. International operations delivered service revenue growth of 9% (7.1% normalised), with strong growth in data and M-Pesa mobile money revenues.

"Our sustained investment programme, aimed at delivering a better experience for customers in each of the countries where we operate, continues to yield results," said group CEO Shameel Joosub in remarks alongside the trading update. To be considered, bidders were required to offer and qualify as independent third parties to the company for transparency, technical expertise and soundness, unbiased expertise to execute process testing, provide engineering services to develop and verify the process plant proposed by the company.

"Additional transparency requirements are to meet with company's authorized persons; engage in conversations about the process testing and project engineering; engage in discussions and respond to inquiries. Outstanding references were required and have been received among qualified bidders," he added.

Sinclair's statement further noted that a qualified bidder is required to develop project resources and involve consultants and subcontractors to the extent authorized by the company, and add value to the

"Qualified bidders are also required to visit the project site to establish equipment and infrastructure and evaluate what is available on site; identify the available feedstock and discuss representative sam-

ple requirements for further mineralogical and metallurgical test work required to verify a required flow sheet and equipment sizing for the proposed plant," the TGC executive chairman stated.

The foregoing are the simplified and general requirements of qualified bidders, the statement noted.

The company will choose among the field of qualified bidders, an organization

which will ensure the path and process forward, including team objectives, and local legal requirements. The company will also choose an organization with a history of success and one which will be flexible in the event the understandings of the company and bidder require supplementation in our agreement for a smooth process forward, the statement explained.

The finalization process includes a review by State Mining Corporation technical team with subsequent review for clearance with the Tanzanian Mining Commission. The Buckreef Gold Project is jointly developed by Stamico and TGC.

LONDON-BASED **ICBC** Standard Bank has raised \$6 million (Sh600 million) from international investors betting on the future performance of the Kenyan shilling.

The debt instruments, known as currency-linked notes, were listed on the Irish securities market, Euronext Dublin, on Wednesday. Investors in such securities are usually paid back their principal upon maturity.

They could also receive an extra payment if the reference currency (the Kenyan Shilling) appreciates relative to the US dollar on the maturity date compared to when the contract started. If the local currency depreciates or remains flat, investors are entitled to their principal only.

Currency-linked notes are among the tools used by global banks to raise funds for their operations and investments. "Euronext Dublin approves the admission of the undermentioned securities to listing on the Official List and trading on the regulated market of Euronext Dublin," the exchange said of the ICBC Standard Bank debt issue.

The notes, which are now tradable, are set to be redeemed on January 27, 2025.

The latest securities highlight global banks' increased use of derivatives based on Kenya's debt and currency movements. Citigroup and ICBC Standard Bank Plc, for

Nigeria sets ambitious target for growth in mining industry

CAPE TOWN

NIGERIA expects its mining sector to grow to 3% of GDP within the next five years from just 0.3% currently as the government seeks to diversify the economy away from oil, the minister for mines and steel development said on Wednesday.

Nigeria has been trying to boost the sector as part of efforts to diversify its economy. Gold, lead, zinc, limestone and coal are among seven strategic minerals Nigeria has identified for investment. "We've seen steady growth ... and we're now poised for exponential growth as investments start crystallising," Olamilekan Adegbite told Reuters on the sidelines of the Mining Indaba in Cape Town.

But insufficient geo-spatial data, weak infrastructure and limited enforcement of regulations have held the industry back. The government's aim is unrealistic, said Alexandre Raymakers, senior Africa analyst at risk consultancy Verisk Maplecroft.


"Nigeria's national infrastructure network is currently ill-equipped to sustain major industrial mining operations that would be needed to raise mining's GDP contribution to that extent," he said. Most mining of gold, tin and zinc in Africa's largest economy is carried out on an artisanal basis.

Gold in the northwestern state of Zamfara is routinely smuggled to neighbouring Niger and Togo. The government banned mining in Zamfara last April due to banditry, but aims to lift the ban by end-March.

Foreign miners investing in the country include Australia's Symbol Mining, developing lead and zinc projects in the Benue Trough region, and Toronto-listed Thor Explorations which owns the Segilola gold project north of Lagos.

Drumming up enthusiasm for the country at the conference, Adegbite emphasised companies operating in Nigeria can wholly own their projects, unlike in other African countries where the state must hold a stake. He said he expects 50 active mines by the end of his tenure, in 2023.

Adegbite said the government would require mining companies to sign agreements with local communities, who remain unhappy with a perceived lack of development and benefits, before investing. "We've learnt our lessons from the oil industry and we're not repeating that mistake, so one of the major fundamental requirements before you can do anything in Nigeria is local community agreements," he said.

Cosatu wants workers to have R104bn up to equity in Eskom

JOHANNESBURG

THE Congress of South African Trade Unions, the country's biggest labour federation and a key ally of the ruling party, said it wants the R104 billion of Eskom's debt held by the state pension fund manager to be converted into equity owned by workers.

The proposal, made in an opinion piece in Business Day newspaper by Cosatu's General Secretary Bheki Ntshalintshali, is part of a deal the labour federation is trying to reach with business and government to rescue Eskom. The utility can't supply sufficient power to the country and has R454 billion in debt. "This will result in workers becoming shareholders in the power utility," he

said, without giving further details. Eskom is seen as key to South Africa's economic performance and the country's ability to hold onto its last investment grade credit rating. Regular power

cuts are hindering output in Africa's most industrialised economy. Ntshalintshali also recommended that at least 10% of all pension funds, whether private or government owned, be invested in government bonds

geared toward social investment and employment creation.

"Workers believe that their retirement funds can contribute toward economic growth, socially desirable investments and employment creation," he said. The raising of the possibility of so-called prescribed assets is likely to anger investors who are opposed to having their investments dictated by government.

MTN's 'controversy-free' time in Nigeria may be short-lived

MTN has reduced the risk of a material regulatory penalty in Nigeria, but the telco is not off the hook, as it still has to overcome more hurdles in that country, according to analysts.

They say MTN is not yet off the hook in Nigeria, given the tax case has been referred to other parts of government and the central bank is still holding back on granting a mobile banking licence. The telco recently received a fresh lifeline in Nigeria, following the decision by the attorney-general to withdraw a \$2 billion tax claim.

At the time, MTN stock surged 5.3% on the Johannesburg Stock Exchange on the news that the 16-month-long battle between Africa's largest mobile telephony company and authorities in its biggest market had ended. The development was viewed as a turning point for MTN's fortunes in Nigeria, a country where it has had long-running battles with authorities.

In August 2018, the Central Bank of Nigeria (CBN) demanded MTN repatriate \$8.1 billion (R117 billion) to Nigeria, which the bank said the company had sent abroad in breach of foreign exchange regulations.

In December of the same year, MTN agreed to make an almost \$53 million payment to resolve the dispute. At the time, it was agreed MTN would pay a notional reversal amount of \$52.6 million, without admission of liability.

This was for a 2008 private placement remittance worth around \$1 billion that the CBN found was based on certificates that did not have final approval. Almost three years ago, MTN agreed to pay more than \$1 billion to settle a dispute over SIM cards in Nigeria. This was after the telco failed to meet a deadline to disconnect 5.1 million unregistered SIM cards on its Nigerian network.

However, last week, MTN senior executives, led by chairman Mcebisi Jonas and group CEO Rob Shuter, met with Nigerian president Muhammadu Buhari and announced R23 billion fresh capital investment in the West African country. On the same day, MTN applied to have the tax legal action struck off and the request was granted by the

versy-free environment" for MTN in the West African country may be shortlived. "We believe the risk of a material regulatory penalty on MTN has reduced significantly given these improved relations. However, we believe it is still early to conclude that MTN is now off the hook in Nigeria, given the tax case has been referred to other parts of government and the central bank is still holding back on granting mobile banking licences to MTN and Airtel," says Peter Takaendesa, head of equities at Mergence Investment Managers.

"The business has seen a good recovery operationally, with revenue growth in low double-digits and improved profitability, but investors remain concerned about the uncertain regulatory environment in Nigeria, given developments over the past few years."

Petri Redelinghuys, founder of Her-

enya Capital Advisors, believes there's still a long way to go for the company to enter a "controversy-free" phase.

"Surely you're not talking about the same MTN that stands accused by the US Justice Department of making payments to the Taliban terrorist organisations for the protection of their cell tower infrastructure, because if it's the same MTN, then I don't see this controversy-free MTN of which you speak," he

MTN stands accused of violating US anti-terrorism laws. The complaint alleges MTN paid bribes to al-Qaida and the Taliban to avoid having to invest in expensive security for its transmission towers. The alleged payments helped finance a Taliban-led insurgency that led to the attacks in Afghanistan between 2009 and 2017, the accusations say.

The telco responded to the allegation, saying: "MTN is reviewing the details of the report and is consulting its advisers but remains of the view that it conducts its business in a responsible and compliant manner in all its territories and so intends to defend its position where necessary."

Sabelo Dlamini, senior research and consulting manager at International Data Corporation South Africa, says the most important thing now "that MTN has been able to resolve its challenges with the Nigerian government, is for the telco to wholly focus on its core business of connecting people.

"Every business, either local or foreign, needs government backing to succeed, and in MTN's case, continue to succeed and break new ground. This 'new phase of controversy-free environment' enables MTN to do just that."

Mobile money bet

The analysts, however, believe new opportunities now exist for MTN with the "balanced relations" in Nigeria established. According to Dlamini, MTN will be able to focus on offering the best customer experience to subscribers.

"Even as mature as the Nigerian telecoms market is, excellent quality of service leading to excellent customer experience is still a key differentiator. This is a unique area MTN can focus on to maintain its position as market

"The telco recently launched mobile money services. It's a step in the right direction and the market is ready for Now, analysts say this new "contro-such products; however, MTN needs to strategically position mobile money to meet the needs of the different demographics that exist in the market," he explains.

Takaendesa agrees: "Mobile data revenue remains a big opportunity that requires a significant investment for the operators in Nigeria. The most attractive opportunity in terms of profitability is mobile money, but unfortunately, the authorities are holding back on granting full services licences that are required to fully extract value out of this segment.

"MTN Group has already connected close to 30 million mobile money customers in 14 countries and Nigeria remains the biggest potential mobile money market in its portfolio." He believes MTN can do a bit more to prevent further controversies in other countries where it has a footprint.

Egypt's population juggernaut approaches 100 million mark

RAGAB Gamal's wife is due to deliver their third child this month. Throughout her pregnancy, she had seen an obstetrician only

"Too expensive," said Mr Gamal, a street sweeper who supplements his monthly 1,200-pound income by working as a guard at an unused apartment block in Cairo's middleclass Abdeen district. "The doctor's visit cost us 150 pounds. She will deliver our baby wherever God chooses for her to do so."

Mr Gamal, his wife and children Ziad, 6, and Gamal, 2, live in the building's basement, in a space without doors or windows. To fend off the bitter Cairo winter, they light a fire every night. He went to Cairo six years ago, as one of the millions of Egyptians who have migrated to big cities in search of jobs.

But in a country where an exceptionally high birth rate has for decades offset economic growth, his plans belie his social status and his conservative background in Minya, a province south of Cairo. Like most rural citizens in Egypt, many Minyans hold to the notion that married couples can have as many children as possible in the belief that God will provide for

"No more," Mr Gamal said when asked if he planned to have more children. "Three is enough." He is one of eight siblings whose father supported the family by doing odd jobs. "Three are enough because my dream is to buy a home back in Minya and we are saving for that," Mr Gamal said. "We need to have our

"When we do, I will send Umm Ziad and the children there to live. They have suffered enough with me here in Cairo." Mr Gamal's reference to his wife as Umm Ziad, or "mother of Ziad", is in keeping with the practice in rural Egypt to not give the name of an adult woman to an unrelated male.

His determination to have no more than three children would probably endear him to Egypt's government and its President, Abdel Fattah El Sisi, who does not mince his words when talking about the most serious challenges facing his country. "Terrorism and population growth," said Mr El Sisi, who has been in office since 2014. "We have equated the people who try to kill us with the population growth as our main challenge."

Zhang Long and Chen Xiao from eastern China's Shandong Province held a special wedding last Thursday in the bridegroom's courtyard, with the bride's father as the host and her mother as the photographer.

Answering the government call for staying at home and avoiding crowds amid the novel coronavirus outbreak, many Chinese couples have chosen to postpone weddings, but Zhang and Chen agreed to press on with their schedule but scrapped all the festive trappings.

"We're in a critical time of epidemic prevention and control, so we decided not to invite guests or hold a banquet," said Zhang, the bridegroom. "After all, a wedding is just a ceremony, and the most important thing is our happiness."

On the day of the wedding, Zhang, wearing a mask, followed the custom to drive to the bride's house in Licha Town, the city of Qingdao.

There, in a romantic ritual, he lifted the bride's red veil to see a mask on her face. "Because of the mask, I didn't even know the color of the lipstick she was wearing," the bridegroom recalled.

Presided by the bride's father, the wedding lasted no longer than two minutes. "My father in law spoke very quickly. Bow to heaven and earth, bow to parents, bow to each other, and the wedding was over. We didn't even have the chance to say our wedding vows," Zhang said.

Before the novel coronavirus swept the nation, Zhang's plan was to have a typical Chinese wedding complete with all the pompous rituals. He booked a 50-table feast, 20 wedding cars and invited four pairs of groomsmen and bridesmaids

"Everything was canceled. He only spent several hundred yuan to marry me, but it doesn't matter, as long as he is the right man for me," said Chen Xiao, the bride. On the way back to the groom's house, they passed three checkpoints where their body temperature was measured.

"The volunteers there congratulated us during the checks," Chen said. "Although no relatives or friends came in-person to congratulate us, I believe more people blessed us from their hearts.'

Many villagers gave them thumbs up in the WeChat group chat after Zhang Long's father announced the no-guest wedding. "We are in a critical time of novel coronavirus preven-

The villagers support their decision," said Liu Jingming, party chief of the Licha Town. This is not the first no-guest wedding held amid China's anti-coronavirus fight.

World's happiest people seek road to financial literacy

THE most cheerful people on Earth are about to get some help managing their finances.

In Finland, which topped the most recent United Nations World Happiness Report, the central bank is drawing up a financial-literacy strategy for citizens.

The idea, conceived in a country that already outperforms much of the rich world in education, is to figure out whether a bit more financial acumen will help Finns borrow less.

Finnish household debt has doubled in the past two decades against a backdrop of falling interest rates and the gradual obsolescence of cash as a form of payment.

The people of Finland, home to companies like Nokia and Rovio of Angry Birds fame, are known for being more tech savvy than most. up by a third over the past decade.

About twenty years ago, cash was used in 70% of payment transactions at stores, with cards accounting for the rest. Now, those metrics have flipped: card, mobile and other digital modes of payment were used in more than 80% of the time in 2018, according to data compiled by the central bank.

Olli Rehn, the governor of the Bank of Finland, says, "Consumers have largely already moved to a digital world" when it comes to payments. "People no longer have such physical budget limitations as they used to do, and that makes it harder for people to manage their finances."

That's where the central bank

hopes to make a difference. Its first step will be to compile data and best practices from organizations already working in the field in a bid to scale up their work and ensure all groups in society are getting adequate assistance.

Then, it will set national targets for financial literacy, and work with third-party providers to coordinate the roll-out of the national plan. (The central bank is still working on the details of the program.)

Finland has already explored other ways to cut household debt. The financial regulator has capped home loans at 85% of a property's purchase price, and plans for further restrictions are in the works at the Finance Ministry.

By 2023, the government wants to have a credit registry with records of everyone's borrowing to help lenders assess whether to grant a new loan. Rules on consumer credit were tightened last autumn.

Trump's \$4.8 trillion budget likely to get thumbs-down from Congress

WASHINGTON

PRESIDENT Donald Trump's \$4.8 trillion budget proposal for fiscal year 2021 was likely to get a chilly reception from lawmakers yesterday over its proposals to slash spending on foreign aid and social safety net programs.

The White House plans to unveil the budget blueprint for the fiscal year starting on October 1 at 12:30 p.m. eastern time, but administration officials confirmed key figures from the document over the weekend.

Democrats are expected to object to the deep spending cuts on domestic programs, while some Republicans may raise concerns over debt and deficits.

The budget calls for a 21 percent cut in foreign aid to \$44.1 billion,

down from \$55.7 billion enacted in fiscal year 2020. It would make savings in outlays to safety net programs including \$130 billion in Medicare through drug pricing reforms, \$292 billion to food stamp and Medicaid programs by enacting new work requirements for beneficiaries, and \$70 billion through a clamp-down on eligibility for federal disability benefits. An administration official said

the White House was making the proposals for substantial cuts despite an assumption that Congress, which controls U.S. purse strings, would allocate more money on spending than Trump wants. With forecasts for strong economic growth, the budget predicts some \$3.7 trillion in government receipts in the 2021 fiscal year.

Last year Trump signed a two-



year budget deal with Congress that increased federal spending on defense and several other domestic programs, adding to growing government debt. That legislation authorized \$2.75 trillion in new defense and non-defense spending through Sept. 30, 2021.

Trump's budget is largely a political document.

It includes spending on Trump's priorities as he seeks re-election later this year, including \$2 billion to fund further construction on a border wall with Mexico, a project that is especially popular with his

political base, and funding for an infrastructure bill that is unlikely to be passed by Democrats and Republicans in Congress.

Military spending would rise 0.3% to \$740.5 billion.

The budget forecasts \$4.6 trillion in deficit reduction over 10 years and assumes economic growth at an annual rate of roughly 3 percent for vears to come, officials said. Trump has taken credit for the strength of the U.S. economy thanks in part to tax cuts he championed and Congress passed earlier in his term. The budget funds an extension of those cuts over a 10-year period with \$1.4 trillion.

The White House proposes to slash spending by \$4.4 trillion over 10 years and reduce the deficit by \$4.6 trillion in that time period. **Agencies**

AU, Arab League reject Trump's controversial Mideast peace plan

THE African Union (UN) and the Arab League (AL) on Sunday voiced their rejection of the newly unveiled U.S. peace plan that has sparked growing tensions between Palestine and

African Union Commission Chairperson Moussa Faki Mahamat said the U.S. plan was devised without consulting Palestinians and violates existing AU and UN resolutions on the Israeli-Palestinian conflict.

"The case of Palestine is the most flagrant example of the fragility of the international situation. The American-Israeli plan which is called the 'deal of the century' has been prepared out of any consultations and also in the absence of those who are mainly concerned," Mahamat said at the opening of the 33rd AU summit held in the Ethiopian capital of Addis Ababa.

It violates the UN resolution and those of the AU and is trampling on

the rights of the Palestinian people, he said, adding that the peace plan is heightening the tensions in the region and beyond.

U.S. President Donald Trump on Jan. 28 unveiled his controversial Middle East peace plan for the Palestinian-Israeli conflict, which would limit the sovereignty of a future Palestinian

He outlined the 80-page plan at the White House along with visiting Israeli Prime Minister Benjamin Netanyahu, which recognizes Jerusalem as Israel's "undivided capital," while claiming that the Palestine capital will include areas of East Jerusalem.

The plan, described by Palestinian President Mahmoud Abbas as the "slap of the century," allows Israel to claim sovereignty over certain areas of the occupied West Bank, including Israeli settlements and the Jordan Valley.

Ahmed Aboul Gheit, the AL secretary general, said "the Arab League highly and constantly appreciates the

principled position of the AU in support of the Palestinian cause and the legitimate rights of the Palestinian people to end the Israeli occupation of their territory and their independent state" "I am confident that Africa will maintain its established commitment in standing with the struggle of the Palestinian people in their rejection of this unjust deal, as was articulated by the Palestinian leadership, the Arab League, the Organization of the Islamic Cooperation and the European Union," said Aboul Gheit.

In response to the U.S. plan, the Palestinian National Authority earlier this month informed Israel and the United States it will "cut all relations" with them.

Palestinian Prime Minister Mohammed Ishtaye who is attending the AU summit here also called on the international community to reject the peace plan.

Josep Borrell, the high representative of the European Union (EU) for foreign affairs and security policy, said last week that the U.S. Middle East peace plan has departed from "internationally agreed parameters."

To build a just and lasting peace, the unresolved final status issues, including issues related to borders, the status of Jerusalem, security and the refugee question, must be decided through direct negotiations between both parties, Borrell said in a statement.

"In line with international law and relevant UN Security Council resolutions, the EU does not recognise Israel's sovereignty over the territories occupied since 1967. Steps towards annexation, if implemented, could not pass unchallenged," Borrell said.

Meanwhile, Palestine is seeking a position from the UN Security Council in the wake of Trump's announcement. The U.S. peace plan intends to make illegal Israeli settlements on Palestinian land a done deal and wants to make Palestinians live under apartheid, Ishtaye said.

'No major incidents' at close of general elections in Cameroon despite threats by separatists

POLLING at Cameroon legislative and municipal elections ended at 6 p.m. local time (1700 GMT) on Sunday, with authorities expressing satisfaction with the conduct of the polls, despite threats from armed separatists in the country's restive English-speaking regions.

The polls were marked by "calm, order and discipline," Essousse Erik, director general of national electoral body

Elections Cameroon (Elecam), west and northwest regions told a press conference in the capital Yaounde on Sunday evening.

"No major incident likely to disturb conduct of the polls was reported nationwide. There was sufficient electoral and all the local polling commissions with conducting the twin elections performed their tasks," Erik said.

Voter turnout was "massive" in the English-speaking south-

where armed separatists had vowed to interrupt the elections, Cameroon's Minister of Territorial Administration Paul Atanga Nji told reporters.

"At the close of the polls, it is clear that the boycott calls material in all polling stations, made by ill-intentioned political parties and terrorists did not have any impact on the population," he said, referring to separatists in the Anglophone regions as terrorists.

At least two armed separat-

ists were killed Sunday in the northwest region as they tried to disrupt the vote, security sources told Xinhua under condition of anonymity, adding that a security member was also killed in the northwest region by separatists in a different incident.

However, separatists claimed on social media that five soldiers were killed in coordinated attacks in the two crisis-hit regions. "Terrorists are reduced to social media propaganda and manipulation to influence weak minds," the minister said.

Sunday's vote was also boycotted by opposition leader Maurice Kamto and his Cameroon Renaissance Movement (CRM), citing insecurity in the English-speaking regions and 'biased" electoral code.

The CRM has a single representative in the current National Assembly, which has 180 seats, with 148 of them occupied by the ruling Cameroon People's Democratic Move-

After casting his ballots at a polling station in Yaounde, Cameroonian President Paul Biya called on Cameroonians to vote, "contrary to calls for boycott by some small political parties," Biya told reporters.

Over 6,800,000 voters were registered for Sunday's polling, including more than 970,000 from the English-speaking regions, representing 14 percent of the total registered electoral population. Xinhua

DEMOCRATIC presidential contenders Pete Buttigieg and Bernie Sanders traded jabs over money and message on Sunday, two days before New Hampshire voters pick their choice to take on Republican President Donald Trump in November.

The rivals, who were essentially tied for the top two spots in last week's Iowa caucuses. offer stark alternatives for the top of the Democratic ticket. Sanders, 78, is a U.S. senator and impassioned progressive who has spent almost three decades in Congress, while Buttigieg, 38 (pictured), is a moderate military veteran who served two terms as mayor of South Bend, Indiana.

The Iowa Democratic Party on Sunday released updated results showing that Buttigieg won 14 delegates and Sanders 12. While the numbers are low in terms of the total a candidate would need to secure the nomination, a win provides critical early momentum.

Tuesday's New Hampshire primary, the second in a stateby-state nominating contest, also will test the staying power of U.S. Senator Elizabeth Warren, who finished third in Iowa, and former Vice President Joe Biden, who placed fourth. They joined the field of 11 Democratic candidates campaigning in packed school gymnasiums and hotel ballrooms six days after the Iowa caucuses drew lowerthan-expected numbers of vot-

Russian diplomacy in Africa and beyond

RUSSIA is one of the few countries celebrating Diplomats' Day as a professional holiday on February 10. In 2002, a Presidential Decree established this date to commemorate the founding of the Russian Diplomatic Service

The date itself is closely associated with the history of Russia's first foreign affairs agency - the Ambassadorial Department (or "Posolsky Prikaz") in Russian. It is in February 1549 that the Department, set up by Czar Ivan IV, was first mentioned in official chronicles.

At the same time, the traditions of Russian diplomacy are much deeper seated in history. In 860, Ancient Russia received international diplomatic recognition by striking the "Treaty of Peace and Love" with Byzantine Empire. Exchange of envoys between Russia and Medieval Europe was also quite intense.

As Russia became a strong and consolidated state in the 16th century, the need for a body to implement foreign policy decisions became increasingly apparent. In 1549, diplomatic service was made into an office of the State, receiving a special

The Ambassadorial Department successfully managed Russian foreign policy throughout the 16th and 17th centuries, with the first permanent Russian diplomatic missions abroad open- the UN, G20, BRICS, and seeking in the 1600s. In 1718-1720, it the Collegium of Foreign Affairs by Emperor Peter the Great.

This marked the emergence of the Russian Empire and the establishment of Russia as a great European power, while a con- investment and infrastructure stellation of talented diplomats serving within the Collegium laid down the basic principles and methods of Russian diplo-

> With new political and humanitarian initiatives, as well as projects, Russia has shown major interest in engaging with Africa on a deeper and more comprehensive level.

Making Oscar history, 'Parasite' wins best picture

IN a milestone win that instantly expanded the Oscars' horizons, Bong Joon Ho's masterfully devious class "Parasite" became the first non-English language film to win best picture in the 92-year history of the Academy Awards.

"Parasite" took Hollywood's top prize on Sunday night, along with awards for best director, best international film and best screenplay. In a year dominated by period epics - "1917," "Once Upon a Time ... In Hollywood," "The Irishman" - the film academy instead went overseas, to South Korea, to reward a contemporary and unsettling portrait of social inequality in "Parasite."

True to its name, "Parasite" simply got under the skin of Oscar voters, attaching itself to the American awards season and, ultimately, to history. The win was a watershed moment for the Academy Awards, which has long been content to relegate international films to their own category. But in recent years, to diversify its membership, the Academy of Motion Pictures Arts and Sciences has invited many more overseas voters.

Multiple standing ovations greeted Bong's several wins. "I am ready to drink tonight," Bong said, prompting roars from the crowd. Unexpectedly called up again for best director, Bong saluted his fellow nominees, particularly Martin Scorsese, and concluded: "Now I'm ready to drink until tomorrow."

After the Dolby Theatre had emptied out, the "Parasite" team still remained on the stage, soaking in their win. Backstage, Bong was still gobsmacked. "It's really f--ing crazy," he told reporters, clutching his awards.

The victory for "Parasite" – which had echoes of the surprise win by "Moonlight" over "La La Land" three years ago – came in a year when many criticized the lack of diversity in the nominees and the absence of female filmmakers. But the triumph for "Parasite," the Palme d'Or-winner at last year's Cannes Film Festival, enabled Hollywood to flip the script and signal progress, nevertheless. No Korean film had ever won an Oscar

before.

In doing so, the film academy turned away another history-making event, again denying Netflix its first best-picture win despite two contenders in "The Irishman" and "Marriage Story," and a big-spending awards campaign blitz.

Mendes' audaciously conceived World War I film "1917," made to seem one continuous shot, had been the clear favorite heading into Oscars, having won nearly all the precursor awards, including top honors from the Producers Guild, the Directors Guild, the Golden Globes and the BAFTAs. In the end, "1917" went home with three awards for its technical virtuosity: Roger Deakins' cinematography, visual effects and sound mixing.

All of the acting winners – Brad Pitt, Renée Zellweger, Joaquin Phoenix and Laura Dern – went as expected. While Pitt, notching his first acting Oscar, had regaled audiences with one-liners in the run-up to Sunday, he began his comments on a political note.

"They told me I have 45 seconds to speak, which is 45 seconds more than the Senate gave John Bolton this week," Pitt said, alluding to the impeachment Quentin Tarantino. "I'm thinking maybe Quentin does a movie about it."

Barca, Real Madrid rebound with wins after Copa eliminations

MADRID

REAL Madrid and Barcelona rebounded from disappointing Copa del Rey eliminations with away victories in the Spanish league on Sunday to continue their closely fought title race.

Three days after losing in the cup quarterfinals, Madrid routed Osasuna 4-1 and Barcelona edged Real Betis 3-2. The results kept leader Madrid three points ahead of second-place Barcelona.

Barcelona's victory relieved some of the pressure still surrounding the club since coach Ernesto Valverde was replaced by Quique Setien at the beginning of the year.

"We could have done some things better, but I'm happy with our performance," Setien said. "The team has been improving. It was a very important victory away from home, where we had been strug-

In its previous four matches on the road this year, Barcelona's only win was at third-division club Ibiza in the Copa del Rey.

Setien was in charge of Betis the last time it had beaten Barcelona in 2018. That was the team's only win in its last 18 league matches against Barcelona.

The Catalan club trailed twice on Sunday, rallying with three assists by Lionel Messi in a tense match in which both teams finished with 10 men. Betis' Nabil Fekir was shown a second yellow card in the 76th minute and Barcelona's Clement Lenglet was sent

off in the 79th, also with a second yellow. Lenglet had scored the winner just seven minutes

earlier with a header off Messi's free kick. Betis opened the scoring just six minutes into the match with a penalty kick converted by Sergio Canales after video review saw a handball by Lenglet inside the area. Barcelona equalized three minutes later with Frenkie de Jong scoring from close range after a well-placed pass by Messi.

Betis went ahead again with a low shot by Fekir in the 26th after a blunder by Barcelona midfielder Arturo Vidal, but the visitors evened the match with Sergio Busquet's close-range goal off a set piece taken by Messi three minutes into first-half stoppage
