# Four presidents at Samia's side in independence show, pageantry

## Country's achievements based on the rule of law, Samia says in night address

#### By Correspondent James Kandoya

FOUR presidents from neighbouring states yesterday joined the commander in chief of the armed forces, President Samia Suluhu Hassan, to mark 60 years of independence.

Scores of invited dignitaries and thousands of city residents were treated to traditional pomp and pageantry as the country marked the big day at Uhuru Stadium in Dar es Salaam. Members of the armed forces and especially commando units stole the show with a display of combat skills, thrilling those gaping at the performance.

Members of the army, the police, the Prisons Department and the National Service mounted a nearly flawless parade and match past, saluting the Head of State and visiting presidents.

This was followed by a show of what men and women in uniform can do in combat situations-a segment that drove spectators to wild applause throughout.

President Samia inspected a guard of honour to commemorate December 9, 1961 when Tanganyika hoisted its flag as the country became independent within the Commonwealth, retaining the Queen of England and Great Britain as Head of State for one year, until it attained republican status on December 9, 1962.

It was the first time President Samia attended such event since assuming office, and also coinciding with its being marked with a special flavor as the country completed six decades of self rule.

## EALA: MPs must work to end intra-EAC trade impediments

## **By Guardian Reporter**

MEMBERS of the East African Legislative Assembly (EALA) have been urged to take up the task of unlocking business opportunities as part of the EAC regional integration agenda.

Senior EALA member Abdikadir Aden, standing in for Speaker Martin Ngoga, said at an Inter-Parliamentary Forum on EAC Affairs high level dinner organized by East African Business Council (EABC) on Wednesday in

EALA members and other legislators across the sub-region should work to remove barriers and sort out disputes in trade and investments in the EAC bloc, he stated, noting that this is essential for increased economic growth and prosperity in the region.

The EAC trading bloc was the fastest growing trade zone in Africa, he observed, asking that MPs work to ensure that national interests do not supersede EAC ambitions and aspirations.

EABC CEO John Bosco Kalisa said economic potential in the EAC bloc is hindered by the high cost of doing business arising from double taxation, persistent non-tariff barriers (NTBs), non-harmonized product standards and dissimilar policies on work permit, aside from telecommunication impediments.

MPs across the region should champion the implementation of the one network area for communication, quick ratification, referring to a pact among EAC partner states in 2014 to create one network area (ONA) covering

THE government has appealed to tourism stakeholders within the country and abroad to advise it on how to increase the number of tourist arrivals from the current 1.5m to five million in the next few years.

The government wants the sector's contribution to the Gross Domestic Product (GDP) rise from the current 17.5 per cent to 35 per cent in the next few years, plus enhancing forex earnings from 25 per cent currently to 50 per cent eventually.

Dr Allan Kijazi, the permanent secretary for the Ministry of Natural Resources and Tourism, issued this appeal on Wednesday during a symposium to mark 60 years of Tanganyika independence under the theme 'Tourism and hospitality growthopportunities and challenges.'

"The door is open; you can visit my office to give us your advice on how we can improve hospitality or training that we offer at the National College of Tourism (NCT) and other colleges, to help Tanzania provide the best services for tourists coming to Tanzania," he told the participants.

Even as the ministry awaits advice from stakeholders, the NCT needs to be creative and come up with a new and comprehensive strategy that will help the college to produce highly qualified hospitality professionals suitable in the tourism sector that in turn will enhance international tourists to visit the

## 'Govt researchers should conceive policy strategies for agricultural extension'

EXTENSION officers in the country are required conceive various strategies and systems that would enable close communication with researchers, farmers, livestock keepers and fishermen in order for them to engage in profitable production activities, especially at the time the world was facing challenges from both climate change and Covid-19 pandemic.

The call was made by here at the weekend by the Chairman of Tanzania Society of Agricultural Education and Extension (TSAEE), Prof Catherine Msuya at the opening of the society's annual general meeting.

She said as for now there is there are issues of climate change and Covid-19 hence they should concentrate in conceiving systems and technologies that would enable the people to continue producing crops profitably.

"I know we have demonstration farms but we must also look for other systems that would enable to easily bring together all

stakeholders aimed at improving the value chain on agricultural products, livestock and fisheries," said Prof Msuya.

For her part, Neema Semwaiko, Agricultural Officer based in Mwanza said through the meeting they have learned about various good issues, including the use of ICT in agriculture that they will apply in their areas of work.

"From the technology we have acquired, we shall go to apply where we came from in improving communication among extension officers and our farmers and will assist to communicate with many more stakeholders at one time," she

Julitha Bulali, Extension officer from Mkuranga District appealed to the government to continue empowering extension services experts at all levels to enable them serve the people appropriately.

"This meeting has enabled us extension officers from various areas in the country to meet to exchange experience that would help us improve the performance of our works," Bulali said.

country's attractions.

"Tanzania is endowed with a lot of tourism potential, but what we get from there is little by comparison," he stated, insisting that Tanzania will not reach the targets if public institutions and the private sector "will not partner to ensure our dream comes true."

Presently tourism is one of Tanzania's fastest growing economic sectors that account for 17.5 per cent of the gross domestic product (GDP), with the sector directly employing close to half a million people and contributing a quarter of all foreign currency earnings, he stated.

"I believe if we take serious measures on it, Tanzania will manage to reach the targets," he further noted, urging public and private sector firms to take measures to promote domestic tourism.

Domestic tourism is vital because the market is huge, as right now Tanzania has 60 million people, he said, elaborating that 90 per cent of tourism sector earnings is generated from wildlife tourism.

"Let us focus on other areas, identify new tourism potentials so that we can raise our GDP and move where we are to another position," he further noted.

Lineo Morenammele, Deanof the School of Enterprise and Management at the University of Lesotho, on a working visit to see what Tanzania is doing in the tourism and hospitality sector, the country needs to empower trainers

or lecturers to go to areas where tourism services are offered.

They should conduct research and see what is required in the market and thus train students accordingly, she said, elaborating that this will help develop suitable skilled labour, help tourists access the best services while in Tanzania.

This will relate to the funds they put into the sector while here, and help to attract more international visitors to those attractions, she asserted.

The visiting team of researchers wants to see what is required to improve hospitality such that it will attract more international visitors to Tanzanian attractions, she emphasised.

Dr Shongo Mlozi, the NCT Chief Executive Officer, said the NCT management is proud for what has been achieved so far as the college has four campuses that offer different courses in tourism, in Dar es Salaam, and Mwanza regions.

The college runs three programmes that include hospitality, tourism and event management for short and long courses at certificate and diploma level, he said, noting that next October the college will introduce degree in hospitality and tourism management.

Enrolled students had increased to 1050 students at present, with 3000 students having graduated, he stated.NCT will renovate its campus located in Arusha to assist the college produce highly skilled labour force, he added.

THE health promotion and system strengthening project (HPSS) has donated sorted equipment to the University of Dodoma (UDOM) in health promotion

Additionally, 13 national level health promotion coordinators and administrators are taking part in the training. "The Children (MoHCDGEC) and the President's training covers different participatory approaches that seek to empower communities to take over control of their health and wellbeing", said Kebby

He noted that by the end of the training, participants are also expected to deepen their knowledge in planning, budgeting, implementing and supervising interventions for community and school health promotion.

According to the national health policy of 2007, National health promotion policy guidelines and national school health services guidelines, the government commits to ensure the population is safe from preventable and avoidable diseases so as to contribute to the national economic development.

The initiatives by Swiss TPH/HPSS and UDOM,he said are therefore meant to support this government's vision in making available quality preventive, promotive, curative and rehabilitative health services through properly trained health personnel.

Besides financing the training, Swiss TPH/HPSS project has provided assorted teaching and learning aids to UDOM in order to enhance the function of offering health promotion training, research and documentation so as to support the Ministry of Health, Community Development, Gender, the Elderly and health services.

Office - Regional Administration and Local Government (PORALG) as well as non-state actors (NSAs) in delivering health promotion initiatives.

The partnership between Swiss TPH/ HPSS project and UDOM dates back to 2014 and is aimed at supporting the government in bridging the shortage health workers, particularly in the area of health promotion.

He said the government through the Energy Ministry is supervising the biggest hydropower project and that the project was financed by Tanzania and costs 6.559trn/- and upon completion will generate 2,115 MW of power.

He also reminded that JNHPP was essential for the country's strategic mega projects.

"As supervisors we have been given the responsibility by our President, Samia Suluhu Hassan to make sure the project is implemented professionally at the cost earmarked, the minister said.

He also said the project's contractors hail from Egypt and that the visit by the Egyptian minister, Assem Hafez El Gazar who was assigned to supervise the project shows how the Egyptian Government takes the project seriously to make sure it is completed successfully.

"We have come here today to inspect the project's development and to see whether there were any challenges faced by both Tanzanian and Egyptian governments so that we could solve them for smooth implementation of the project," said Makamba.

He said after inspecting the project they were pleased that it was going on well apart from a few small existing challenges that were holding back the project's speed, and added that it was normal for big projects to be faced with small challenges.

## Govt reaffirms commitment to empower girls access education

THE government has reaffirmed the commitment to work together with the Campaign for Female Education (CAMFED) in empowering girl children access education and relevant life skills.

Deputy Permanent Secretary in the President's Office - Regional Administration and Local Government, Dr. Grace Magembe, made the remarks here, stating that the organisation is doing a lot to help empower Tanzanian girls and adolescents, and is worth emulating.

Dr Magembe made the remarks while officiating at the opening of CAMFED Tanzania annual general meeting, adding that education is the only way to empower people, especially girls from poor backgrounds.

The deputy PS who represented the Permanent Secretary, Prof Riziki Shemdoe at the meeting said, "CAMFED is complementing

government efforts in eliminating one of the enemies of development-foolishness, among Tanzanian children and empowering them to be productive citizens".

She noted that the government appreciates effort of such stakeholders since it has no ability to provide everything to all people in the country. However, the deputy PS challenged the organization to scale up its activities in more districts councils in the country.

Earlier, CAMFED Tanzania board chairperson, Jeane Ndyetabura told the meeting that her organisation has supported 143,019 students to go to primary and secondary schools using donor funds.

Of these, 88,355 students have been supported to go to primary schools - CAMFED's Safety Net Fund for partner primary schools provides essential items for children to prevent them from dropping out of school.

Other 54,664 students have been supported to go to secondary school - CAMFED provides holistic support, that might include school or exam fees, uniforms, sanitary wear, books, pens, bikes,

boarding fees or disability aids.

"CAMFED Tanzania partners with 821 schools - We work in genuine partnership with government schools to help improve the learning environment for all students." She said.

CAMFED Tanzania, she said works alongside local schools, community groups, parents and stakeholders, to identify the most marginalized children in communities and ensure they get the material and emotional support they need to learn and thrive.

The chairperson explained that together with CAMFED association leaders, they catalyse the activism of CAMFED champions in the partner communities to support more vulnerable children to go to primary and

secondary schools.

Since 2005, 731,868 students have been supported to go to school by CAMFED association members and community initiatives.

Out of these, 290,321 students have been supported to go to school directly by CAMFED association members. Often using profits from their businesses, the association members support on average 3 more children to go to schools - multiplying the impact of their education.

At least 441,547 students have been

supported to go to primary and secondary school through community initiatives. This she explained includes parents, teachers, education officials and traditional leaders, who rally resources to support even more children to go to school.

She noted that the movement in Tanzania has grown to 29,320 CAMFED association members helping to form the largest network of its kind in Africa. Young women educated with CAMFED support spearhead the programs and help more vulnerable children to go to school.

## Firm to empower Kahama gold dealers to access foreign markets

GOLD dealers and middlemen in Kahama District, Shinyanga Region expect to benefit by Sab Gold Limited (SGL), the firm that has embarked on empowering them to access foreign markets in order to reap more profits from the business.

SGL aims to assist groups of small gold miners, middlemen and gold buyers by showing them opportunities in the gold business in foreign countries where there were reliable markets.

This was revealed on Wednesday by SGL manager, Abdulrahim Sangey when speaking to this paper in his office, saying many dealers get opportunities to export minerals, but end up in loss due to their ignorance of world market prices for the minerals.

Sangey said as for now, gold prices in the world markets have been fluctuating from time to time which dealers in Kahama District ought to know.

"Many dealers exporting the minerals end in losses, but we shall make sure we find reliable markets

for them and connect them to foreign buyers," said Sangey.

He said if gold dealers sell their mineral to them they will get more profit as from five kilos a week sold a dealer will get 3.4m/- profit whilst from 10 kilos a week he gets 8m/profit and for the whole year he could end up with 300m/- profit.

For his part, Juma Maganga, Kahama based gold dealer said the firm could be a big saviour to them as it could open doors to foreign markets for them.

Earlier, during his recent visit at the Kahama gold market, District Commissioner Festo Kswaga said he recognises the big contribution from various firms who have invested in the district and still there are more friendly areas for investments for

## NGO provides trachoma treatment to nearly 1,141 patients in Singida Region

HELEN Killer International (HKI), a non-governmental organisation has succeeded to provide treatment for trachoma to nearly 1,141 patients from all districts in Singida Region who have been living with the ailment for many years without hope of treatment.

The remarks were made here at the weekend by Singida Region Administrative Secretary (RAS), Dr Dorothy Mwaluko in her speech read on her behalf by the region's medical officer, Dr Victorina Ludovick at the function to close the trachoma eradication project in the

Dr Mwaluko also revealed that a total of 212,952 households had been reached, out of which 212,812 anticipated, equivalent to 100.1 per

All patients received treatment and that the implementation of the project involved in empowering officials at regional and district levels, 116 wards and 454 villagers.

"To a large extent, the problem has been of great success in providing eye diseases treatment, in particular trachoma, trachoma, in villages and homesteads in all districts in the region," said the Singida RAS.

He said, however, that this does not mean that all trachoma sufferers in the region have been treated but they have reduced the prevalence of the diseases to acceptable levels, stressing that other patients will continue getting treatment in the normal way.

Singida Region's coordinator for eye treatment services, Dr Upendo Mwakabalile said apart from the achievement, there are few other patients who remain due to various

Dr Mwakabalile also stressed that for that reason a team from each

council has prepared a task plan on how to continue treating the small number of trachoma patients who remain untreated.

Submitting report on the project's implementation to the official guest, Trachoma Project manager from Hellen Keller International, Athuman Tawakal said the aim to establish the institution in 1915 was among others to help to avoid becoming blind that could be prevented. He said HKI's other aims in its establishment was to save lives of people in vulnerable groups and who had no ability to carter for themselves.

# Independence Day address did justice to 60 years' achievements, aspirations

RESIDENT Samia Suluhu being done right now. Hassan issued a moving speech on the night before celebrating 60 years of independence of Tanganyika, where she put a stamp on indelible marks of progress and aspirations at the moment. While in past years many in the country took the national airline as something that we can't run and tried all sorts of formulas, now the president says we have made down payment for yet another batch of give aircraft. It is an amazing situation to add to still formidable achievements, not least of which is the surprising manner in which our hospital facilities and expertise dwarf most other systems regionally, now.

In remarks concerning the road network, the president noted that Tanzania was a large country where the tarmac road network that we have at present would for some other countries - meaning with regionally large sizes or populations comparable to ours - be the entire length of all their roads. Quite often analysts or commentators miss out this aspect, as to how difficult it is to ring a spacious country like Tanzania with a network of tarmac roads. Former President Jakaya Kikwete once narrated that the fourth phase worked to complete total regional links on tarmac.

Given the good work done by the fifth phase and continuing at present, the work now being pursued is to complete linking all districts by tarmac road, on the basis of the president's remarks. It means it isn't a dream that will take time to be realised but something that is

And .noticeably, the fifth phase succeeded in raising popular expectations of what the government is capable of achieving, standards that were taken up in earnest by the sixth phase, and stand to durably mark the pace of work that has improved during the past half decade. It is a modernisation of governance, greater effectiveness.

There were equally interesting aspects the president focused upon, though of varying degrees of likely appreciation, for instance that there are 17 political parties that are seeking temporary registration. That this is the case at present shows that a new sense of freedom is creeping up in society, and at the same time indicates affinities and potential alliances at the political level. Forming new political parties isn't just an illustration that scores of people want to challenge the ruling party, but also that they don't have as much faith in the current leading voices in opposition. It is a contentious renewal of political life as such.

Still the most remarkable achievement that we may perhaps point out for the past 60 years is fairly recent, namely the death of the president while in office, and moving to a completely smooth transition with full loyalty of state institutions. This is a remarkable testimony of the resilience and appropriateness of our constitutional structures and the wider governance framework generally, despite that considerable numbers of experts and pundits keep repeating the constitution needs to be overhauled.

## Human Rights Day: A moment to reflect on the world's most essential collective demand

marked annually across the world on December .10 each year, following a United Nations General Assembly resolution back in 1950 to have an international observance day on the matter. It was close to two years after the UN adopted the Universal Declaration of Human Rights in 1948, an effort to sketch out values that are indisputable for the whole of humanity, above the din of moral and ideological contentions of the post-WW2 world, and as they have developed since then. The notion of human rights and their recognition in governance dwarfs all other goals, values held by all social groups.

In marking this day, President Samia Suluhu Hassan gave a stylish indication of the spirit of this day in her pre-celebration nationwide address, pointing at the decision to allow a return to formal schooling for absentee pupils or those who faced various challenges.

There was no mention of pregnancy as such or that one is now a mother, as that is simply a challenge that the youthful citizen will have faced, which doesn't call for a harsh position by society. Another discussant, Prof. John Ruhangisa who taught law and later was Registrar for the East African Court of Justice (EACJ) remarked in a symposium in Dar es Salaam that human rights observation in governance needs sympathy, not routine minded conservatism.

Human Rights Day is marked on December 10 as it was the day in 1948 that the universal declaration was

UMAN Rights Day is adopted by the General Assembly, urging all member states and interested organizations to mark the day as they saw fit. Chroniclers say that it is usually marked by high-level political conferences and meetings and by cultural events and exhibitions to illustrate the human rights situation around the world. Human rights is a gold standard, a sort of mercury to evaluate other political and moral values in society, that so long as they have to skip essential aspects of human rights, there is something wrong with them.

Chroniclers observe that although the universal declaration with its broad range of political, civil, economic, social and cultural rights isn't a binding document, it inspired more than 60 human rights United Nations instruments which together constitute an international standard of human rights.

The manner in which Tanzania has lately changed policy course is an illustration as on the basis of the local balance of forces, in terms of sentiment or moral expression, the shift would not have taken place. But those in authority decided that it was pointless to combat a point of view that sympathises with those who find themselves facing such challenges. What they need is help, not judgment.

It isn't surprising that the policy shift is the country's most notable gift to the world for this year's anniversary. Some critics insist that it is schooling, health care and employment which are critical to human rights. They have a point, but liberty is more than social facilities.

## Let us reform or disband Nigeria's NYSC


As politicians and the media guide us to and through the maze of possibilities, permutations and speculations around 2023 as a prelude to new a beginning in Nigeria, here is an item for discussion and a proposed agenda for those planning to lead in 2023: Let us radically reform or disband the National Youths Service Corp (NYSC).

An aside, if you are over 50 years old today or younger but familiar with the history of Nigeria, I know what you are thinking and I can guess your facial expression seeing Kila writing about NYSC. Yes, I am laughing too so please feel free to enjoy your laughter.

The most obvious reason to reform or disband the NYSC is that of safety but that is a mere but crucial topical issue. The security situation in the country has muffled the sense of adventure in potential corps members and transformed the feel and aroma of NYSC into anxiety. Thus arrival of the NYSC call in Nigeria of today makes parents and guardians of young certified learned adults close to being called to join the NYSC pray and fast that their young ones are not sent to volatile areas of the country. To top up their fasting and praying, many Nigerians resolve to looking for who can influence their postings. Can you in knowledge and conscience blame them? The link between their anxiety and acts of nepotism and corruption does not need much explanation.

Let us remind ourselves, the NYSC is mandatory one year scheme for graduates who finish their tertiary education under the age of 30 years. A sort of conscription for graduates that was created in 1973 with a military decree as part of efforts to reconstruct, reconcile and rebuild Nigeria after the civil war. Part of its main aim was to be a vehicle that will foster development of common ties amongst the youths of Nigeria and to promote national unity. Decree No. 24 was the establishment decree.

Regardless of what you think of the NYSC, I think it is safe to argue that the profile, configuration



democratic process and not as a response to a dramatic situation like war. Military decrees and all forms of executive orders are generally swift but rarely capable of taking account of sensibilities and sustainability. A democratic country should not be guided by decrees and civil society should as much as possible review laws and practices conceived under military and emergency duress.

It is a wrong and lazy way of thinking. Nigerians do not mistrust themselves because they do not know each other. Nigerians mistrust themselves because those in power fail to provide enough services and opportunities for all but insist on rationing insufficient services and opportunities through nepotism, tribalism and other forms of favouritism at the detriment of merit.

Classroom is the place to learn about people, places and culture. If travel one must, then let the national tourism industry grow. Let state governments focus on making their states attractive to the curious,

that any Nigerian can be himself or herself within the provisions of the law in any part of Nigeria.

In practice, the NYSC is a very widely used means to substitute for large deficiencies of the country like teaching. It is shockingly amazing how we as a people fail to see the dangerous error in allowing youth corpers to teach in our classrooms instead of insisting on professionally trained teachers who are in the profession because they want to. I have an information for you: It was one thing to know Maths, Economics, Biology or Literature, it is another thing to how to teach it. The fact that we do not consider this simple fact is a grave indictment of our consideration for education and one of the strong reasons why our educational system is failing.

Times have changed and a lot has happened since May 1973 when the NYSC was invented. The easiest thing to do is to scrap the scheme. We have two years to think of what to do with it. By 2023 when a new government will come into power and the NYSC will be 50 years old, many of those billed to serve will probably be young adults born in 2000. We are talking generation Z here. The idea of governing Gen Z with rules and schemes invented in 1973 is simply ridiculous and destined to fail.

My fellow trained teachers know curriculums are currently being modified to suit Gen Z. There is no point saying they are spoilt, strange or overpampered, they are simply different. Evolution is real, we have the fortune of misfortune of dealing with a new breed of human species born into a digital and highly interconnected world. Everything is optional for them. Coercion is an aberration they don't get; sanctions and threats are concepts alien and empty to them. They are born to be motivated, incentivised and

recognised. The easiest thing to do is to scrap the scheme. We have two years to think of what to do with it. If we do not want to disband the NYSC here is an option: Let us make NYSC optional and specialised. Let it be a full voluntary military service that allows only those who want to join do so for one year and with that they get the option to, depending on their interest and ability, join the armed forces, custom, police and other security services as trained graduates.

# Climate crisis exacerbates urban inequality in Latin America

**RIO DE JANEIRO** 

he Brazilian megalopolis of São Paulo recorded 932 flooded premises on Feb. 10, 2020. The Mexican city of Tula de Allende was under water for 48 hours in September 2021. In Lima it almost never rains, but the rivers in the Peruvian capital overflowed in 2017 and left several outlying municipalities covered with mud.

Floods have become increasingly frequent in large Latin American cities, probably due to the effects of global warming and also to local factors, such as the extensive areas of concrete and asphalt that have replaced vegetation.

Extreme weather events are aggravating inequality "in a Latin America that has the most inequitable societies in the world," said engineer Manuel Rodríguez, professor emeritus at the Universidad de los Andes who served as Colombia's first minister of environment and sustainable development (1993-1996).


"The poorest of the poor live in shantytowns and slums in the areas most vulnerable to environmental risks, on undevelopable land along riverbanks or in the foothills," where they are tragically affected by floods and landslides, he told IPS by telephone from Bogotá.

This is especially important in Latin America, the world's most urban region, where one in five people live in cities.

Thus, in addition to the 932 points of flooding reported to the fire department on Feb. 10, 2020, São Paulo also suffered 166 landslides that destroyed many houses. No deaths were reported on that day, but torrential rains usually claim lives in Greater São Paulo, which is home to 22 million people.

Brazil's largest city, which spreads among rolling hills and numerous small valleys, has many neighborhoods that have had to learn to cope with flooding in the rainiest summers. This is due to the 300 streams that crisscross the area, most of which are covered by avenues or enclosed in channels that are unable to contain heavy downpours.

A good part of the 1.28 million inhabitants of the "favelas" or shantytowns of São Paulo, according to the 2010 official census, live on low-lying land, often along streams, without sanitation, and

they are the first victims of floods. The poor make up 11 percent of the population of São Paulo proper.

In Rio de Janeiro there are also riverside favelas, but the ones built on hillsides or on the tops of hills that separate the city and some neighborhoods are much better known. The risk in these areas is landslides, which have killed many people.

In Brazil's second largest city, favelas are home to 1.39 million people, 22 percent of the total population, according to the 2010 census.

"The topography allows them to live close to their jobs" so the choice is "between formal employment or living where housing is cheaper," said Carolina Guimarães, coordinator of Rede Nossa São Paulo, a non-governmental organization that seeks to promote a "fair, democratic and sustainable" city.

Lima, which has 10 million inhabitants, and other cities in Peru and Ecuador were victims of El Niño Costero, a climatic phenomenon that warms the waters of the Pacific Ocean but only near these two countries, where it also leads to more intense rainfall.

These and other Andean countries also face the threat of melting glaciers that could deprive the population of the Andes highlands of water, said Rodríguez. In the Caribbean, the biggest threat is hurricanes, which are becoming more frequent and more

#### **Greater poverty, more impacts**

In addition to the fact that these phenomena hit the poor harder in Latin America, in the world's most unequal region the poor have fewer resources to overcome the losses caused by the climate crisis, added the Colombian

"Buying a new refrigerator and other appliances damaged each time it floods costs them much more. Poverty is a cause, driving them to disaster, and also a consequence of the disasters themselves," said Guimarães, a former knowledge management coordinator at UN Habitat, the UN agency for human settlements.

## It is a perverse logic.

The real estate business drives up the costs of the best, safest sites complete with infrastructure and services. There are too many at-risk areas where the poor "build their homes with their own hands," without the support of a public policy that ensures them housing with "access to the city," she told IPS by telephone from São Paulo.

"There is a spatial inequality that results from the low-density expansion model of cities, which pushes low-income families to the periphery, makes access to public transportation difficult and requires long commutes," said Pablo Lazo, director of Urban Development and Accessibility at the World Resources Institute (WRI) in Mexico

WRI Mexico designed the Urban Inequality Index (UDI), a tool for the formulation of public policies, which initially covers 74 metropolitan areas. It measures the public's access to formal employment and services such as education, health and transportation, as well as food and culture.

This urbanization model also gives rise to shantytowns in risky areas, "a constant pattern that is repeated in Mexico City, whose eastern neighborhoods are built on hillsides, where water runs off very quickly, fueling landslides," he said in an interview with IPS via video call from the Mexican capital.

Greater Mexico City is home to nearly 20 million people.

Rodríguez said this precariousness "is a widespread phenomenon in Latin America and the Caribbean, where 25 percent of the urban population lives in informal settlements." Pushed to the periphery, where land is cheaper, but there are no jobs or public services, nor urbanization, the poor prefer slums near the center, he said.

Making inequality even more glaring

#### "The covid-19 pandemic laid bare the inequalities," Lazo stressed.

As an example, he said "there were more deaths on the eastern periphery of Mexico City, where inequality is greater. One factor is distance: it takes five times longer to get to the hospital from the periphery than from the center, so many people don't even take patients to the hospital."

In addition, without water for hygiene and hand washing, the disease spreads more readily among the poor.

There is also a disparate power relationship between cities themselves. Tula de Allende, a city of 115,000 inhabitants located 70 kilometers north of the Mexican capital, suffered a major two-day flood in September 2021, not only because of the rains.

Mexico City's water authorities discharged an excess of rainwater and wastewater into the Tula River that could flood the capital and its outlying neighborhoods, to the detriment of the city downstream, where the river overflow displaced more than 10,000 people and left a hospital without electricity, resulting in the death of 16 patients.

Concerted action is needed. A new governance model based on planning and coordination at a citywide level could be the way forward, said Lazo.

In Rio de Janeiro, Aruan Braga, urban policy coordinator for the Favelas Observatory, told IPS that "building a more equitable and democratic city requires including, in planning, lowincome areas that sustain the city in day-to-day life but don't have the right to participate in decision-making."

Favelas lining hills are the bestknown image of Rio de Janeiro, but there is also a large vulnerable population in low-lying, flood-prone areas. One example is the Maré Complex, where some 130,000 people live in 16 favelas.

On the shores of Guanabara Bay and the Cunha channel, so polluted they are like an open sewer, the complex suffers "floods every year," said Braga, a sociologist with a master's degree in development policies, who explained that the Maré Complex was built on a large piece of land reclaimed from mangroves and flood plains.

It was built by settlers relocated from more central favelas or from wealthy and beachside neighborhoods five decades ago, in a wave of "expulsion" from favelas that continues today. Maré also grew because it is next to Avenida Brasil, the main access route to the city center, and because it is home to industrial facilities.

## New policies for a new model

The four interviewees agreed that public policies are needed to make it possible to start reducing urban inequality in Latin America.

Lazo highlighted the need for mechanisms to control the market's "greed", such as a requirement that private housing projects include low-cost units.

"In France that proportion is 50 percent," he said, to illustrate.

Braga said one good possibility for reducing the housing deficit in Rio de Janeiro would be by allocating empty public buildings to social housing. There are many unused state-owned buildings because the city was the capital of the country until 1960.

Movements seeking community solutions, "social urbanism", urban agriculture and mobilization of the population for a more equitable and inclusive city point to the future, according to

Her Rede Nossa São Paulo has conducted studies on inequality that pointed to a difference of up to 22.6 years - from 58.3 to 80.9 years - in life expectancy between poor and rich neighborhoods in the city.

Bogota is in the process of organizing its territorial planning and there is talk of the "30-minute city", following the example of Paris, which seeks to ensure that no one has to walk more than 15 minutes to do everything they need, Rodriguez said, describing a new model in Latin America.

The statistics are dire: One in three women have experienced a form of gender-based violence in their lifetime, be it sexual violence, physical violence, or child marriage. The message is clear: Women and girls deserve a safer, brighter future - free from genderbased violence.

For those living in protracted crises, the risks are compounded as these often create new risks for girls forced to travel long distances to and from schools and learning spaces, or the lack of safe and gender-segregated WASH facilities. These risks, in turn, often compel families to keep their girls out of school and even to marry them off as children to reduce the risk of gender-based violence in and around schools.

This is why Education Cannot Wait (ECW) - the UN global fund for education in emergencies - has become the first global fund to join the Call to Action on Protection from Gender-Based Violence in Emergencies. The 'Call to Action' is a multi-stakeholder initiative to transform how gender-based violence is addressed in humanitarian emergencies. ECW made the announcement during the '16 Days of Activism against Violence against Women and Girls' campaign that kicked off on November 25 and ends on December 10.

"To no one is the campaign so real as it is for girls and adolescent girls who want to go to school, but face gender-based violence in emergency and protracted crisis contexts. These girls fear for their lives, they fear for their security, and they desperately need safe learning spaces so they can reach their full potential and be assured of their inherent human right to live free from fear and violence and to quality education," said Yasmine Sherif, Director of Education Cannot Wait.

Sherif is talking about the one in four children in Africa who live in conflict zones. She is also referring to UNESCO projections which show that 9 million girls between 6-11 years of age - compared with 6 million boys of the same age - living in sub-Saharan Africa will never go to school. These estimates were before the COVID-19 pandemic. Now, with school closures and COVID-19 restrictions, the situation has worsened.

The United Nations estimates that women and girls together account for 72 per cent of all human trafficking victims reported globally. Three out of four child trafficking victims are girls. A majority of women and girls are trafficked for the purpose of sexual exploitation. Globally, 15 million adolescent girls, aged 15-19 years, have experienced forced sex.

ECW points out that in armed conflicts, forced displacement, climate-induced disasters and protracted crises, gender-based violence risks are exacerbated, increasing the challenges already faced by girls, adolescent girls and women, as they are disproportionately affected by the impact of emergencies on education.

# ECW joins call to action on protection from gender-based violence in emergencies

Although education is a fundamental human right for all children and adolescents, ECW finds that families are more likely to prioritize boys' education, choosing not to pay for girls' school fees, uniforms and other supplies as a result of the economic impact of

armed conflicts, forced displacement and other crises.

Sherif and other experts in girls' education emphasize that betterdesigned education programmes with a strong, gender-sensitive, protection component can help mitigate such risk - by keeping girls and women safer and supporting them when they experience gender-based violence. This provides them with the skills and knowledge they need to improve their own lives.

Joining forces with more than 95 stakeholders including governments, UN agencies, international NGOs, donors, and local civil society organizations, ECW "aims to contribute to change and foster accountability from the humanitarian system to address gender-based violence from the earliest phases of a crisis.'

As the United Nations global fund for education in emergencies and protracted crises, ECW is positioned to make and implement bold commitments to support gender-based violence risk mitigation.

The 16 Days campaign, which this year has the theme, 'Orange the world: End violence against women now!', has become an important rallying point to raise awareness and make a difference.

Mary Chepkwony, a field coordinator for the Kenya-based Rural Women Peace Link tells IPS that bold commitments to safeguard the rights of women, girls and adolescent girls are timely and critical.

"Gender-based violence cases are on an unprecedented increase, hence the need to strengthen local- and rural-based women organizations to improve the safety and security of women and girls," she says.

Concerns are rife that COVID-19-driven economic insecurity is increasing girls and women's vulnerability to gender-based violence in homes globally. Additionally, schoolrelated gender-based violence is a major obstacle to universal schooling and the right to education for girls.

Meaningful partnerships with local women organizations are crucial for the design and implementation of safe, quality and inclusive education to ensure that girls are not left behind.

"This week, Education Cannot Wait launched two new guidance notes on gender-based violence risk mitigation measures and meaningful engagement of local women organizations," says Sherif. These guidance notes will help ECW and its partners to support commitments to eliminate genderbased violence risks among women, girls and adolescent girls.


These short and practical guidance notes are based on global best practices and are being systematically integrated in the design and implementation of EWC-supported invest-

"We firmly believe that education in emergencies and protracted crises can greatly contribute to reducing the incidence of gender-based violence by creating safer education in emergency programming. Girls' access, retention, and learning outcomes can only increase, creating a lasting positive impact on their communities," says Sherif.

She explains that education in emergencies programming and protection - particularly gender-based violence risk mitigation - reinforce each other and when combined, can lead to positive outcomes for girls and their communities.

Chepkwony applauds these efforts, saying ongoing risk mitigation efforts around the world are a step in the right direction for the safety of women and girls.

ECW already supports these risk mitigation measures across its broad global portfolio. For instance, in Syria and Somalia, referral mechanisms to the gender-based violence sub-cluster were established to ensure disclosure of cases are dealt with according to best practice.

## NECTA outlines achievements during 60 years of independence

IN commemorating 60 years of Tanganyika's independence, the National Examinations Council of Tanzania (NECTA) has outlined various achievements by the council that enabled it to operate in a modern way, including the use of modern equip-

NECTA Executive Secretary, Dr Charles Msonde says in the past the printing of examination papers and related paperwork was done in black and white, the situation that made it hard for students to understand the question(s) from what they had been taught in class when it was in color.

However, he adds: "From efforts of the various phases of the government, the Council was able to buy printing equipment that could print examinations papers in color."

Dr Msonde says that the government has done a great job improving the printing unit, as students' certificates used to be imported.

"The Council was thus able to buy modern printing machines that incorporated security marks on the certificates it issues, and these are more of high quality than those that came from foreign," Dr Msonde says in an interview.

ence, NECTA was able to go with time by using various ICT systems in its daily operations, noting that the machines include those for registering primary school students (PReMs) by using computers that have done away with challenges faced by teachers having to travel to NECTA offices to present CDs that contained candidates' particulars.

improve its systems by creating a new system for taking pictures of students who were registered in their registration records both for PreM and

He said heads of primary and secondary schools take pictures of candidates using mobile phones and the particulars directly go into the database for record-keeping. "The system has ena-

bled the Council to save more than 2.1bn/- that was being used in the past paying photographers who take pictures of students at schools and submit them to the Council,

stressed Dr Msonde. Another system that

has changed the image of NECTA is the digital system of Primary Schools Statistics Form Number 9 (TSM9) (pupils' enrolment data system), which for a long time teachers were having difficulty filling in student information

by hand on those forms. "The work was timeconsuming and costly for

the government. In view of the inconvenience caused by teachers and with the aim of simplifying the work and reducing the use of government funds; NECTA created the system that facilitates digital access to TSM9.

"The system also facilitated the sending of digital forms wherever need-

ed including the school, council, and national level. The system was created which saved the use of 2.3bn/- used to print hard copies annually and distributed to the regions for distribution at council and School level," emphasizes Dr. Msonde.

The council also improved Primary School Leaving Examination (PSLE) marking process by using information and communications technology (ICT), which started last year. "This digital marking system of correction was previously created by experts from the UK-based company called (DRS), which was cost the country a lot of money," he says.

As a result of this success, the National Examinations Council has been able to overcome the dependency on using software created by the UK-based company--DRS), which despite being costly in making systemic updates; dependence compromised the security of

the processed data. According to the NECTA boss, Tanzanians should be proud of because the Tanzania Examinations Council is a role model in Africa. This is due to the facilitation of government; the council has been able to create a system to facilitate the enrollment of students to join universities and colleges

online. Using our IT experts, the council created an Application Program Interface (API) that enables the systems of universities colleges, Tanzania Commission for Universities (TCU), the National Council for Technical Education (NACTE), and the **Employment Secretariat** to contact the NACTA's examination results system.

Dr Msonde adds that the system has enabled Tanzanians who want to further their education to apply for admission without submitting their certificates unlike in the past where they had to walk with their certificates in order to apply for admission to colleges.

The 48 year-old NECTA has been marking using different centers such as teachers' training colleges, secondary schools, and other institutions.

Dr. Msonde says in order to reduce the overlap of work between the Examinations Council and the Institutions used for the examination marking process, the government has dished out funds for building marking center at Mbezi Wani in Dar es Salaam, with the capacity to hold 900 markers at once.



APDA's active, interdisciplinary approach sets it apart from the other programs.

It pushes students to challenge their pre-existing beliefs and understand the nuances behind various social issues. It also provides students with the right tools to harness the information they learned.

This process has helped us uncover our potential as the leaders of the 21st century.

At the end of the course, the future leaders presented at a youth forum. The teams then spoke to parliamentarians about the proposals they had been developing throughout the course. The students joined teams based 

on their interests in the global issues identified.

These issues included technological inequality among different social classes, another was negligent/careless littering, and a third was an uninformed citizenry.

The first team spoke about utilizing technology to empower social minorities and resolve poverty.

Their presentation included proposals like involving the youth in smart agriculture.

The second team discussed ways to reduce littering while increasing recycling. They introduced an application that utilizes collective intelligence to map out trash cans in public spaces.

The third and final team spoke about the need for an information-sharing system between government departments and firms. They used the Australian precedent to support their views on sharing health information.

Moreover, they devised a plan to call on the youth to combat the older persons' issues with internet technology.

After the presentation, teams answered questions and debated their ideas with Arab and Asian parliamentarians.

The open discussion ranged from general feedback and questions of how to encourage the youth to participate in parliaments to specific inquiries regarding several policies proposed by the teams. Delegates also asked the students to collaborate with the youth in their countries.

Students eagerly responded to their offers, hoping to maintain a close and steady relationship in the future.

# TIPER READY TO HOST NATIONAL STRATEGIC PETROLEUM RESERVE

#### **By Property Watch Reporter**

IGAMBONI based Tanzania International Petroleum Reserve Limited has enough facilities to host the country's proposed strategic petroleum reserve for emergency use.

TIPER's Deputy Managing Director, Martin Mosha said in Dar es Salaam mid this week that the company which is jointly owned by Treasury and Audax Orvx Geneva of Switzerland, has invested heavily in expanding and modernising the facility.

"Currently we have capacity to store 254 million litres of petroleum products after heavy investment made since 2000," Mosha said while noting that the former Tanzania Italian Petroleum Refinery which changed its function in 1999, has since become a complete storage facility.

He said storage capacity of the facility increased from 140 million in 1999 when the Italian government through Agip Oil sold its 50 percent shares to Audax Oryx Geneva. "The government through Treasury owns 50 percent

of shares," he added.

Mosha explained that in 2018, the government had made a decision to turn TIPER's Kigamboni tank farm into a national strategic petroleum reserve facility but that the decision was suspended almost immediately.

"We are ready to become a strategic oil reserve tanker owners per day," the CAG for the country, a move that will save the nation report stated while noting that in money and time," he stated while revealing that the addition, up to one percent of the offloading of petroleum products from oil tankers product is lost through leakages as to different depots of oil marketing companies the offloading is done to different oil

paid to ship owners.

"But we also lose almost one percent of the products through leakages," the TIPER Deputy MD stated while stressing that such losses can be reversed in addition to stabilization of pump prices if the Kigamboni tank farm is utilised fully.

The Kigamboni TIPER tank farm stands on a 50 hectares piece of land with direct connections to Kurasini Oil Jetty and Dar es Salaam Port's SPM. "But we are also connected to all oil marketing companies depots for easy transferring of petroleum products," Mosha stated.

In his report in 2016/17, Controller and Auditor General advised in a report that TIPER be turned into a single receiving facility for all petroleum products imported into the country to save the nation demorrhage charges which are paid to shipping liners for offloading delays at the port.

"The country pays up to U\$25,000 per day in delaying charges to oil causes delays which attract demorrhage charges marketing companies oil depots.

# **Data centre** volume growth set to brighten Africa's future

**CAIRO** 

The world's major data centres have been typically centralised at several key points across the globe. Together, these data centre locations account for a substantial share of a global footprint. Compared to its continental counterparts, Africa is lagging with a total datacentre size of approximately 140,000m2 which is comparable Switzerland.

The continent, as it stands, is clearly underserviced. For example, live IT power demand in markets like **Dublin and London total 795.8MW** but in markets such as Johannesburg and Nairobi live IT power accounts for 54.9MW and 19.04MW, respectively.

But there is some good news, with growing digitisation and the rollout of 4G and 5G infrastructures (across the continent) this means data centres' volumes are set to grow significantly in the next five years. We have the possibility to "leapfrog" in technology and embrace the latest best practices and trends established today and thus see a fleet of modern facilities with higher efficiencies. Africa with its population of 1.3 billion is driving a rapid and accelerating deployment need, particularly with a young technology savvy and dynamic populace; the sky could be the limit.

To accelerate Africa's digitalisation, there is a number of significant hurdles to be crossed. For one, cloudbased service providers require closer proximity to populated centres to enable them to deliver more sophisticated services in a timely and competitive manner while also reducing data shipment costs.

Currently, nearly half of Africa's colocation facilities are based either in South Africa or Nigeria with Kenya and Morocco following suit. Ironically, many African websites are currently hosted in European datacentre facili-

Datacentres must be as close as possible to the user to minimise latency, thus ensuring fast and reliable access to the information or services. Closer proximity typically translates into more capacity and speed, which drives down costs and ultimately increases accessibility.

As it stands, the African datacentre market can be segmented into three main tiers: Tier-1 - Cairo in Egypt, Johannesburg and Cape Town in South Africa, Lagos in Nigeria, Nairobi in Kenya. These locations tend to be leading Africa's datacentre markets and are supported by investment from multinationals, developers, and operators; Tier-2 are those cities strategically positioned in the most populous countries which include Giza and Alexandria in Egypt, Addis Ababa in Ethiopia, Luanda in Angola, Accra in Ghana, Maputo in Mozambique, and Dar es Salaam in Tanzania; and Tier three markets are those sparsely populated countries with poor infrastructure connectivity and business opportunities.

## Barrick's Bulyanhulu acquires highly prospective licences for expansion

TWIGA Minerals Corporation, a joint venture between Barrick and the government has announced the acquisition of new prospecting licences by Bulyanhulu Gold Mine Limited, a subsidiary of

Bulyanhulu has entered into a binding agreement with Barrick Gold Corporation, Tembo Gold Corp., the Mineral Industry Promotion and Consulting Company Limited, a wholly-owned subsidiary of Tembo, dated December 7, 2021 in respect of the acquisition of certain prospecting licences.

In a statement, Barrick said under the purchase agreement, Bulyanhulu will acquire from MIPCCL a 100 percent interest in six prospecting licences held by MIPCCL. The licences are located in areas adjacent to the Bulyanhulu mine and have the potential to add significant mineral reserves to Barrick's asset base in Tanzania.

"Under the terms of the purchase agreement, the consideration payable by Bulyanhulu is U\$6 million, plus certain other contingent payments. Such contingent payments will be calculated based on the inferred, indicated and measured gold mineral resources identified in the areas of land which are covered by the licences using Barrick standards for determining mineral resources," the statement added.

Bulyanhulu is required to invest a minimum of U\$9 million in the licence area over the course of the four years following the closing of the Transaction. Concurrently with the execution of the purchase agreement, Bulyanhulu has agreed to subscribe for, on a non-bro-

kered private placement basis, 5,518,764 of common shares of Tembo at a price of C\$0.27 per common share, the statement

## Kenya receives 'Africa's largest' 3D-printed affordable housing project

## **NAIROBI**

A new neighbourhood near Mombasa, Kenya is to be built in record time thanks to a worldbeating 3D printing technology.

It was recently announced that Africa's largest 3D-printed affordable housing project will be developed by 14Trees, a joint venture between Holcim and CDC Group, the UK's development finance institution. The 52

house Mvule Gardens project will be located in Kilifi town, north of Mombasa, in Kenya.

Earlier this year, 14Trees built the world's first 3D printed school in the Salima district of Malawi. The development followed the company's first 3D-printed prototype house in Lilongwe, Malawi - built with precision in less than 12 hours, which significantly reduces the four days spent building a home with conventional building practices.

Building on a track record of speed and progress, the new complex in Kenya underscores 14Trees' forward plan to support Africa's innovation in construction and further develop 3D printing technology across the continent.

This project was made possible by Holcim's proprietary ink, TectorPrint, giving the walls structural function to bear the load of the building. The new technique reduces the environmental footprint by more than 50% compared to traditional processes and lowers CO2 emissions typical to standard methods of cement production.

Further, 14Trees identifies natural fibre components to strengthen best practices in 3D printing for construction in Africa and creates locally based skilled

jobs in sustainability and 3D technology operations, among other areas.

The new 52 house community will be part of the Green Heart of Kenya regenerative ecosystem, a Kenyan model for inclusive and climate-resilient cities. The project is a testament to 14Trees' high regard for sustainability and won the IFC-EDGE advanced sustainable design certification, recognising resource-

efficient and zero-carbon buildings.

In addition, the purpose-built design by the United States -Africa-based architectural practice, MASS Design Group, seeks to provide modern and replicable housing units adapted to the needs of underserved communities among lower-income households. 14Trees will begin construction of Mvule Gardens in the first quarter of 2022.

## Abu Dhabi's **Chimera to invest** \$100m in Naguib Sawiris's Gemini

Abu Dhabi-based investment company Chimera is investing \$100 million in Egyptian developer Gemini Global Development for a significant minority equity stake in the company in a bid to support its expansion in the Arab world's most populous

The new investment from Chimera will help develop the operations of Gemini, which is a subsidiary of Ora Developers, the two companies said on Monday. "Through this partnership, Chimera continues to grow and further enhance its global portfolio by investing in a prominent player operating in a high-growth sector in Egypt," said Syed Shueb, chairman of Chimera.

Set up in 2007, Chimera is part of Abu Dhabi's Royal Group, which is active in a number of sectors including property, construction, food and beverages, hospitality, aviation and health care. The group has more than 60 companies under its umbrella and employs 120,000 people.

Cairo-based Ora Developers is owned by Egyptian billionaire Naguib Sawiris and is known for building a number of successful property projects in the North African country, including Zed El Sheikh Zayed, Zed East and Pyramid Hills.

"Since inception, our goal for Ora Developers was to continuously seek opportunities that will help us to expand our offerings to various markets while partnering with leading global investors, contractors and retailers," Mr Sawiris said. The Egyptian company is planning to spend at least \$1 billion on expanding its presence in African markets over the next five years, Mr Sawiris told The National in an interview last month.

Ora is currently building projects in Grenada, Egypt, Pakistan and Cyprus. The company is also considering plans to expand its presence in Pakistan, where it is developing a large residential project in the capital, Islamabad, that includes commercial facilities and a golf course. Egypt's property market has been attracting the interest of investors from Gulf countries, who are looking to tap into one of the largest property markets in the Mena region.

## Kenya Railways adds SGR coaches on Christmas demand

## **NAIROBI**

Kenya Railways has increased passenger capacity on the standard gauge railway (SGR) train between Nairobi and Mombasa to cater for the rising demand during the Christmas festive season. The company has increased coaches to 11 from eight for economy class passengers.

First-class passengers will also get an additional unit from the two coaches in operations. The increased capacity from the extra coaches takes effect from December 9 to January 6, 2022. The Madaraka Express train's bookings register shows it is fully booked for the Christmas season.

The train is currently pulling eight coaches (944 passengers) on economy class tickets and two coaches (144 passengers) on the first-class tickets. Kenya Railways increases the number

of coaches during the holiday seasons to meet demand surges. Last month, the company said the trains had been fully booked up to December 24.

Fares on the economy class section are Sh1.000 with firstclass tickets going for Sh3,000. Children below three years are not charged any fee to take a

ride on the train while those from 3-11 years pay half the price adults pay on the economy and first-class tickets.

The SGR passenger train

service between Nairobi and Mombasa was launched in June 2017. The trains have been departing daily from both directions, offering a five-hour nonstop connection between the country's two major cities.

The inter-county service train that was launched in 2018 charges Sh70 from Mombasa to Mariakani, Sh310 from Voi to Kibwezi, Sh220 from Athi River to Emali on economy class coaches. # South Africa new border fencing and improved military facilities in the pipeline

The newest addition to South Africa's list of agencies, authorities and other government sanctioned organisations - the Border Management Authority (BMA) is set to take its first operational steps in the upcoming festive sea-

Parliamentary Portfolio Committee on Home Affairs (PCHA) and the Select Committee on Security and Justice heard earlier this month (December) discussions were underway with the SA National Defence Force (SANDF) hierarchy to finalise a memorandum of agreement allowing for part-time soldiers to be called up on detached service to the BMA. They are apparently going to be involved in patrol work alongside Department of Home Affairs (DHA) officials.

Apart from almost immediate deployment, the defence/home affairs discussions cover what was termed "seconding" the Reserve Force. This some parliamentarians took to indicate part-time soldiers could well be the nucleus of the BMA's border guard conducting law enforcement at ports of entry and on the borderline. The BMA border guard will be "launched sometime early next year." One parliamentarian with concerns, particularly as regards the BMA's cost, is Democratic Alliance (DA) shadow home affairs minister Adrian Roos.

He asks initially how the BMA is allowed to go ahead without secured funding in the light of presentations outlining, among others, a personnel cost of R2 974 962 978 and a further R5 281 133 622 for goods and services. There was, in the Parliamentary presen-

tation, no indication of the goods and services cost decreasing once specific goods, for example office equipment, are acquired.

Roos would rather the BMA has as its major tasking co-ordination

of border control and security. "Make funding for maintenance and repair (of border headquarters buildings, including water provision and ablution facilities) available to the Defence Works Formation (DWF) and boost the allocation for SANDF patrols."

An approach of this type should see National Treasury either come forward with "funding guarantees for full implementation of the BMA or its mandate should be adjusted to that of a lead agency." "This agency would be responsible for development and implementation of coherent border security and control policy, facilitating co-operation and co-ordination between border stakeholders," Roos said adding this approach was an option put forward in the socio-economic impact assessment of the BMA

"For the foreseeable future while SANDF border patrols suffer crippling underfunding and delinquent border washing line builders are back in business, the BMA will busy itself with stationery, uniforms and duplication of administrative staff. The hope is National Treasury will be able to fund it sufficiently to avoid becoming a bureaucratic shell staffed with millionaire managers," is his take on BMA appointments and the necessities associated with setting up offices.

Knowing hindsight is 20/20, Roos goes back to 2003 when the SANDF was "removed" from border security in favour of the SA Police Service (SAPS). "By 2008 it was apparent SAPS would not be able to adequately manage border security alone.

n 2009 government reversed the decision with the SANDF redeployed to secure border areas under Operation Corona. "We cannot afford to backtrack again and sit with a bureaucratic beached whale in five years' time."

## VIETNAM WAREHOUSE SECTOR SEES OPPORTUNITY AMID PANDEMIC

et's go back to the end of June 2021, when the ultracontagious Delta variant triggered a spike in infections in Ho Chi Minh City, reaching as high as 4,000 cases for the first time.

As an office worker in a non-priority vaccination group, you hastily ordered an imported box of FDA-approved 3M 1870+ N95 masks from the e-commerce site Shopee. Before the spike, orders were delivered within 3-5 days, and certainly in no more than a week. However, in fact, due to strict social distancing restrictions, it wasn't until mid-September, when you'd already received two doses of AstraZeneca, that your order arrived at your door.

In that 10X-longer delivery window, several things happened: city authorities tightened social distancing measures three consecutive times, the number of infections exceeded 650,000, and the number of COVID-19-related deaths surpassed 16,000. With the pandemic putting incredible pressure on importers, sellers, e-commerce sites and delivery companies, the shipping delay was an inevitable consequence of an overloaded global supply chain. Alongside the epidemic's heartbreaking statistics is a gloomy economic picture: in the third quarter of 2021, Vietnam's GDP shrank by 6.17 percent, and nearly 10,000 businesses left the market every month.

While the effects of COVID-19 have touched nearly every aspect of the global economy, not all businesses have been adversely impacted. "The pandemic has certainly led to an unfortunate series of events. However, from a business perspective, it's been an accelerant for warehouse demand," said Lance Li, CEO of BW Industrial Development Joint Stock Company, in an interview with Forbes Vietnam.

While the pandemic left the world grappling with supply-chain and logistical disruptions, the demand for warehouses has soared due to overwhelmed transport networks and a surplus of raw materials to ward off inventory shortages. BW, the largest industrial forrent developer in Vietnam specialising in the development of warehouses and factories for rent, witnessed a high volume of inquiries throughout the pandemic.

The company's long-term development strategy allowed it to capture these short-term opportunities efficiently: it developed light, modern, industrial warehouses satisfy the rising demand in manufacturing and explosive growth e-commerce. in Currently, BW offers a variety of product lines, mainly ready-built factories, ready-built warehouses and built-to-suit facilities.

BW's operations are targeted at specific customer groups, among which are the e-commerce platforms in a "money-burning" race to win the market without racking up massive investment in fixed assets while allocating resources mainly for promotions and expansion.

Another group of customers using leased assets is foreign investors implementing the China+1 strategy due to the ongoing trade war between the US and China. # Average UK property prices hit record high of £272,992

LONDON

The average British house price recorded its fastest growth in 15 years in November taking property values to a record high of £272,992 (\$361,765).

House prices rose 8.2 per cent compared with November last year and 1 per cent against October's £270,027, with quarterly house price inflation at its strongest level since 2006, with 3.4 per cent growth, according to the Halifax House Price Index.

"This is the fifth straight month that average house prices have risen, with typical values up by almost £13,000 since June, and more than £20,000 since this time last year," said Russell Galley, managing director of Halifax.

"Since the onset of the pandemic in March 2020, and the UK first entering lockdown, house prices have risen by £33,816, which equates to £1,691 per month." Britain's property market has continued to rise since the end of the stamp duty holiday on October 1 despite fears that it would stutter once the tax break ended.

Mr Galley said the performance of the market is underpinned by a shortage of available properties, a strong labour market and keen competition among mortgage providers keeping rates close to historic lows.

"Those taking their first step on to the property ladder are also playing an important role in driving activity, with annual house price inflation for firsttime buyers at 9.1 per cent compared to 8.8 per cent for home movers," he said.

This trend is also reflected in different property types, with double-digit annual price inflation for flats of 10.8 per cent over the past year compared with slower gains for detached properties of

6.6 per cent.

"This could suggest the 'race for space' is becoming less prominent than it was earlier in the pandemic, with industry data also showing the overall number of completed transactions has fallen back since the end of the stamp duty holiday," Mr Galley said.

Halifax said the average house price in Wales has passed £200,000 for the first time. Wales also had the strongest annual house price inflation in November, at 14.8 per cent, while Northern Ireland recorded an

increase of 10 per cent and Scotland 8.5 per cent

Meanwhile, London continued to lag the rest of UK in its rate of house price growth, with annual inflation of 1.1 per cent. Looking ahead, Mr Galley said there is now greater uncertainty than has been the case for quite some time, with interest rates expected to rise to guard against further increases in inflation.

"Economic confidence may be also be dented by the emergence of the new Omicron virus variant, though it remains far too early to

speculate on any long-term impact, given insufficient data at this stage, not to mention the resilience the housing market has already shown in challenging circumstances," he said. "Leaving aside the direct impact of a possible resurgence in the pandemic for now, we would not expect the current level of house price growth to be sustained next year given that house price to income ratios are already historically high, and household budgets are only likely to come under greater pressure in the coming months."

# Hydrogen-powered jet concept produces no emissions

LONDON

A UK-backed research group has unveiled a design for a liquid hydrogen-powered airliner theoretically capable of matching the performance of current midsize aircraft without producing carbon emissions.

The FlyZero concept envisions a plane carrying 279 passengers non-stop from London to San Francisco at the same speed and comfort as today, the Aerospace Technology Institute said in a statement on Monday. The group, a partnership between the UK government and industry, is meant to accelerate high-risk projects that will benefit home-grown aerospace firms.

Hydrogen propulsion is seen as one of the most promising technologies for achieving carbon-neutral commercial aviation, but it's expensive, and it will take years to develop the planes and build infrastructure such as airport refuelling capacity.

The UK, which hosted the Cop26 climate summit last month, is funding new technologies to help create aerospace jobs while meeting its climate targets. The government has committed £1.95-billion of funding to ATI since its start in 2013 through 2026, an amount to be matched by industry.

"These designs could define the future of aerospace and aviation," said business secretary Kwasi Kwarteng in the statement. "By working with industry, we are showing that truly carbon-free flight could be possible, with hydrogen a frontrunner to replace conventional fossil fuels."

ATI said it expects hydrogen aircraft to be operating from the mid-2030s offering better economics than conventional planes. By early next year, the FlyZero project will publish detailed concepts for regional, narrow-body and midsize aircraft, with technology road maps, market and economic reports and a sustainability assessment, the group said.

The midsize aircraft being showcased on Monday would store hydrogen at -250°C in cryogenic fuel tanks at the rear of the plane and in two smaller "cheek" tanks along the forward fuselage to keep the aircraft balanced. It would have a wingspan of 54m, between Boeing's 767 and 787 twin-aisle jets, and be powered by two turbofan engines.

## **Act now to curb Omicron's** spread, WHO's Tedros tells world

GOVERNMENTS need to reassess national responses to COVID-19 and speed up vaccination programs to tackle Omicron, though it is it too early to say how well existing shots will protect against the new variant, the World Health Organization said on Wednesday.

The variant's global spread suggests it could have a major impact on the COV-ID-19 pandemic, and the time to contain it is now before more Omicron patients are hospitalized, WHO director-general Tedros Adhanom Ghebreyesus said.

"We call on all countries to increase surveillance, testing and sequencing," he told a media briefing. "... Any complacency now will cost lives."

The WHO noted early evidence from BioNTech and Pfizer of the effectiveness of their vaccine against Omicron.

The German and US companies said on Wednesday a three-shot course of their COVID-19 vaccine was able to neutralize the new Omicron variant in a laboratory test, while two doses resulted in lower neutralizing antibodies by a factor of 25.

Warning against jumping to conclusions from the test, the WHO's chief scientist said it was too soon to say whether the reduction in neutralizing antibodies meant the shot was less effective.

## **Envoy: US 'democracy summit'** anything but democratic

THE United States has become a major obstacle to the democratization of international relations by holding the so-called "Summit for Democracy," which is harmful to the cause of international democracy and solidarity, Chinese Ambassador to Russia Zhang Hanhui has recently written.



In an article published in Russian newspaper Komsomolskaya Pravda, Zhang (pictured) outlined the dangers of such a summit, particularly due to its hidden motives and undemocratic nature, saying that the United States, which has been criticized by the global community for its own handling of human rights issues, is now deeply gripped by domestic and foreign troubles.

"Racial discrimination, the gap between the rich and poor, a chaotic electoral system, and problems with tackling the pandemic" have all proven the ineffectiveness of Washington's democracy in its national governance, said the diplomat.

Using democracy as a pretext for expansion, Zhang added, Washington has intervened abroad on numerous occasions, hiding its true motives under humanitarian purposes or human rights protection.

In fact, "the democratic transformations there have led to numerous humanitarian disasters on a global scale, including the wars in Afghanistan, Iraq and Syria," said the ambassador.

It is absolutely absurd when a country that grossly violates international law and the principles of national sovereignty with the aim to maintain its hegemony decides to host a summit for democracy, Zhang said, adding that the very fact that Washington decides which countries are invited and can be considered democratic is in itself "illegal" and discriminatory

"The summit will not bring tangible benefits to realworld democracy," he said.

## Omicron 4 times more infectious than Delta in new study

**JAKARTA KUALA/ SINGAPORE** 

THE Omicron variant of CO-VID-19 is 4.2 times more transmissible in its early stage than Delta, according to a study by a Japanese scientist who advises the country's health ministry, a finding likely to confirm fears about the new strain's contagiousness.

Hiroshi Nishiura, a professor of health and environmental sciences at Kyoto University who specializes in mathematical modeling of infectious diseases, analyzed genome data available through Nov 26 in South Africans in Gauteng province.

"The Omicron variant trans-

mits more, and escapes immunity built naturally and through vaccines more," Nishiura said in his findings, which were presented at a meeting of the health ministry's advisory panel on Wednesday.

Concerns are swirling globally that Omicron could deal the world a bigger blow than even Delta, and the World Health Organization has cautioned that it could fuel surges with "severe consequences."

But a jump in cases in South Africa in the wake of the variant's emergence hasn't yet overwhelmed hospitals, leading to some optimism that it may only cause mostly mild illness. Pfizer Inc and BioNTech SE also said this week that a booster dose of their vaccine could fortify protection against the strain.

Japan has reported its fourth case of the Omicron coronavirus variant, TV Asahi said on Wednesday.

Australia

COVID-19 infections have been spreading in pubs and clubs in Australia's biggest city, including three new cases of the Omicron variant found among people who went on a harbor party cruise, sending officials rushing to trace contacts.

Authorities have been easing restrictions in Sydney since early October when the city emerged from a nearly four-month lockdown to contain the Delta coronavirus variant after the population reached higher vaccination levels.

Dozens of people who attended a Sydney pub quiz tested positive for the coronavirus and officials are awaiting the results of genomic tests to see if they are infected with the Omicron variant.

Daily COVID-19 infections have been steadily rising as restrictions have eased with New South Wales state, which includes Sydney,

logging 420 new cases on Thursday, its biggest rise in about two months, with most caused by the Delta variant.

Australia Deputy Prime Minister Barnaby Joyce has tested positive for COVID-19 in Washington, DC while on an official visit, his office said in a statement yesterday.

The remaining members of his delegation have tested negative and Joyce will remain in isolation until further advice, the statement said.

Joyce had been experiencing mild symptoms and chose to get tested for COVID-19. He is the highest-ranking Australian leader to contract the virus since the pandemic began. **Agencies** 

## France frees man who was held over suspected Khashoggi link

THE Saudi man arrested at a Paris airport over suspected links to the killing of journalist Jamal Khashoggi was released on Wednesday after officials concluded it was a case of mistaken identity, Paris prosecutors said.

French law enforcement sources on Tuesday named the man as Khaled Aedh Al-Otaibi, the same name as a former member of the Saudi Royal Guard listed in US and British sanctions documents and a UN-commissioned report as having been involved in Khashoggi's killing in Turkey.

The Saudi Embassy in Paris had said late on Tuesday the arrested person "has nothing to do with the case in question."

Prosecutors said in a statement checks had shown that a warrant issued by Turkey, which had triggered the arrest when the man's passport was scanned during border checks, did not apply to the man arrested at the airport.

Khashoggi, a Washington Post journalist and critic of Saudi Arabia's de facto ruler, Crown Prince Mohammed bin Salman, was last seen entering the Saudi Consulate in Istanbul on Oct 2, 2018. Turkish officials believe his body was dismembered and removed. His remains have not been found. Last year, a Saudi court jailed eight people for between

seven and 20 years over the killing, but none of the defendants was named. The trial was criticized by a UN official and human rights campaigners who said the masterminds of the murder remained free.

In her 2019 report for the United Nations, former UN investigator Agnes Callamard named Al-Otaibi as being part of a Saudi team that killed Khashoggi and dismembered his body before flying back to Saudi Arabia.

A Saudi official told Reuters: "Media reports suggesting that a person who was implicated in the crime against Saudi citizen Jamal Khashoggi has been arrested in France are false."

"This is a case of mistaken identity. Those convicted of the crime are currently serving their sentences in Saudi Arabia."

The 2019 report compiled by Callamard said Al-Otaibi was a member of a 15-man Saudi team involved in killing Khashoggi after the journalist went to the consulate to obtain a document to allow him to marry his fiancee.

That report said Al-Otaibi was one of five members of the team who were not in the consulate itself - where the report said the killing took place - but in the consul general's residence. Agencies

## Cumulative value of trade in goods between China and BRI countries reaches \$10.4 tln

THE Belt and Road Initiative (BRI) has yielded fruitful results over the past eight years since it was proposed. From 2013 to September 2021, the cumulative value of trade in goods between China and countries participating in the BRI amounted to \$10.4 trillion.

The proportion of the volume of trade in goods between China and BRI countries in the country's total foreign trade volume increased by 4.1 percent-

age points from 2013 to 2020. Recently, multinational electronics company TCL Technology put into operation its subsidiary which just settled in the comprehensive bonded zone of Chengdu International Railway Port in Chengdu, capital of southwest China's Sichuan province.

The unimpeded international logistics has facilitated trade. During the past eight years, trade cooperation between China and BRI countries has continuously scaled new heights, and BRI countries have become China's important trading partners.

In the first ten months of this year,

China's foreign trade volume with BRI countries amounted to 9.3 trillion yuan (about \$1.46 trillion), surging 23 percent year on year. During the period, the country's volume of exports to BRI countries climbed 21.9 percent from the same period last year to 5.27 trillion yuan, while its imports from these countries rose 24.5 percent year on year to 4.03 trillion yuan.

On Nov. 17, customs officers inspected a batch of cross-border ecommerce packages for export at the comprehensive cross-border e-commerce pilot zone in Hangzhou, capital of east China's Zhejiang province. After passing customs inspections, these goods were transported to Hangzhou

Xiaoshan International Airport in Xiaoshan district of Hangzhou and then to Belgium by a cargo flight dedicated to cross-border e-commerce.

These packages were transported to a cargo transshipment hub in Liege, Belgium, and then quickly distributed to surrounding countries, noted Zhu Zekun, manager of the business department of Zhejiang Ueasy Business Service Co., Ltd., a provider of comprehensive services for foreign trade

"Buyers in foreign countries usually receive their packages sent from China five days after they place order on e-commerce platforms," said Zhu. The rapid development of new

business forms and models in trade, in particular, cross-border e-commerce, market procurement trade, and overseas warehouses, have provided new possibilities of business expansion in BRI countries for more small and medium-sized foreign trade enterprises, lowered the threshold for trade, and stimulated driving forces of the highquality development of foreign trade.

"The customs clearance procedures are handled in less than half an hour. The more convenient trade has not only enriched market supplies for BRI countries, but also brought considerable rewards to us," said an employee of an agricultural product company based in Hotan prefecture of northwest China's Xinjiang Uygur autonomous region. **People's Daily** 

# Russia advocates peace, but has right to ensure its security — Putin

RUSSIA advocates peace but has the right to ensure its security in the medium to long term, Russian President Vladimir Putin said on Wednesday.

"It's a loaded question," he said at a news conference following a meeting with Greek Prime Minister Kyriakos Mitsotakis, when asked by reporters if Russia was going to invade Ukraine.

"Russia is conducting a peaceful

policy but it has the right to ensure its security, as I mentioned, in the medium and longer term," he went on to say. "We are discussing it with our partners, all of our partners, including the person I spoke with yesterday, the President of the United States of America, Mr. Biden."

Putin and Joe Biden held a video call that lasted two hours on December 7. The talks focused on the situation around Ukraine, while the leaders also discussed bilateral relations, cybersecurity and the Iranian nuclear deal.

# US Senate passes Republican bill to overturn Biden vaccine mandate

#### WASHINGTON

THE Democratic-controlled US Senate on Wednesday approved a Republican measure that would overturn President Joe Biden's COVID-19 vaccine-or-test mandate for private businesses, with two Democrats joining Republicans to back the initiative.

The 52-48 vote sends the legislation to the Democratic-led House of Representatives, where it faces strong headwinds, while Biden has threatened to veto it.

The legislation would overturn administration rules ordering businesses with 100 workers or more to require vaccinations or coronavirus testing for millions of employees.

The measure was not subject to Senate rules that require 60 of its 100 members to agree on most legislation, meaning it could pass with just a 51-vote simple majority. Two Senate Democrats - Joe Manchin of West Virginia and Jon Tester of Montana - joined 50 Republicans in voting for the bill.

The initiative underscores the intense political opposition facing administration efforts to combat COVID-19 at a time when health officials are trying to contain the highly contagious Omicron union.


"I have always supported a vaccine mandate for federal employees and the military because maintaining essential services and military readiness the federal government provides is a matter of national importance," Manchin said in a statement following the vote.

"However, I do not support any government vaccine mandate for private businesses. It is not the place of the federal government to tell private business owners how to protect their employees from COVID-19 and operate their businesses," he said.

Manchin added he was fully vaccinated and had received a booster shot, and encouraged all Americans to do the same.

Republicans have said they were inundated with calls from businesses with up to 500 workers that are concerned about having to fire employees who oppose COVID-19 vaccines and testing.

"It's got Main Street America scared," Republican Senator Mike Braun, who was spearheading the legislative drive,



said before the Senate vote.

The White House said in a statement on Tuesday that employers would face no burden from the mandate because the vast majority of American adults are fully vaccinated and noted that the rule exempts small businesses.

Biden's private business mandate has already been put on hold by a federal appeals court. A US judge in Georgia also blocked a Biden vaccine mandate aimed at federal contractors on Tuesday

"We are in the middle of a public health crisis. Everyone sees the damage it causes," Senate Majority Leader Chuck Schumer, the top Democrat, said in a speech. "The way to solve this is to be driven by science."

The United States has the world's highest daily average of new reported coronavirus infections. The virus has infected 49.5 million Americans and killed more than 794,000, the highest death toll of any country, according to the Reuters COVID-19 Tracker.

Republicans touted the measure's bipartisan support as a clear message of public concern about the mandate's potential impact on workers, businesses and the economy

The chamber's top Republican, Mitch McConnell, branded the Biden mandate as an "illegal" and "absurd" government effort to micromanage the lives of private citizens.

## **UN Security Council voices concern over sentencing of Myanmar's civilian leaders**

THE Security Council on Wednesday expressed deep concern over the sentencing of Myanmar's State Counsellor Aung San Suu Kyi, President Win Myint and others.

In a press statement, the members of the Security Council reiterated their calls for the release of all those who have been arbitrarily detained since the military takeover on Feb. 1.

"The members of the Security Council once again stressed their continued support for the democratic transition in Myanmar, and underlined the need to uphold democratic institutions and processes, refrain from violence, pursue constructive dialogue and reconciliation in accordance with the will and interests of the people of Myanmar, fully respect human rights and fundamental freedoms and uphold the rule of law," said the statement.

## Scholz takes reins from Merkel, ushers in new era for Germany

BERLIN

OLAF Scholz from Germany's Social Democratic Party (SPD) was sworn in Wednesday as the new Federal Chancellor, taking the baton from his predecessor Angela Merkel who bowed out from the political stage after a 16-year run.

Scholz, deputy chancellor and finance minister under former Chancellor Merkel, won 395 votes from the 736-seat Bundestag, the lower house of Parliament.

He will lead Germany's first threeparty coalition composed of the SPD, the Greens, and the Free Democratic Party (FDP). His new cabinet of 16 ministers will helm a green transition, infrastructure upgrade and social welfare development amid a fourth wave of the COVID-19 pandemic.

As a new chapter in German politics unfolds, the world is watching how the 63-year-old new chancellor will live up to his commitments and what his new government means for Europe and the rest of the world.

#### AMBITIOUS PLANS

Scholz's new government has announced ambitious plans regarding Germany's domestic and international interests, but questions remain. The 177-page coalition agreement signed on Tuesday places climate change as priority.

The deal pledges to phase out coal by 2030 instead of 2038, to cover 80 percent of power demand with renewables instead of the previous 65-percent target and to have at least 15 million electric vehicles on German roads by the decade's end.

As part of the agreement, the new government plans to increase the minimum wage from 9.6 euros (10.85 U.S. dollars) an hour to 12 euros (13.60 dollars) an hour, build 400,000 new housing units every year and restrict rent

The new government will also focus on upgrading infrastructure, providing faster internet speeds, improving health services, and offering more training to the jobless.

One big question is how the new government will raise enough funds for all its plans without violating either its promise of no tax increases or the "debt brake" -- Germany's constitutional cap on new borrowing from 2023 onward.

Analysts here believe the state-owned development bank KfW will play the role of an innovation and investment agency, using its expanding balance sheets to leverage private investments in green energy and digitization.

As for foreign policy, Germany's new government will continue to strengthen the European Union (EU) on the global stage and will make sure that Germany is part of that process, Scholz said at a press conference on Tuesday."

German foreign policy is a policy of continuity," he added. Scholz's first trip outside Germany as chancellor will take him to France, just as Merkel did after her first election in 2005, and then to

Brussels for meetings with top EU officials.

Observers say the smooth transition of power relies more on solidarity among the three coalition parties, which had different and sometimes opposing priorities before and during the election on issues like climate change, taxation, fiscal policy and the appointment of ministers in the new cabinet.

How to ensure unity within the new government, achieve its objectives and lead Germany in the post-Merkel era is likely to be a test of political wisdom for the new chancellor.

## China will continue to deliver more brilliant performance on WTO stage

THE year 2021 marks the 20th anniversary of China's accession to the World Trade Organization (WTO). In this particular year, a review of China's role in the WTO is of great significance for the new journey of cooperation between the country and the international organization.

Over the last two decades, China has grown from a rule taker into an important participant in rule making within the framework of the WTO. During its full participation in the work of the WTO, the country has learned in practice, improved its work through introspection, and accumulated plenty of experience, making contributions to the normal operation of the three major functions of the WTO, i.e. rule negotiation, policy review, and dispute settlement. As a major force in rule nego-

As a major force in rule negotiations under the WTO, China has deeply participated in multilateral trade negotiations including the Doha Round negotiations and negotiations on fisheries subsidies, and submitted or cosponsored over 100 negotiation proposals, making substantial contributions to facilitating the expansion of the scope of products covered by the Information Technology Agreement and the reaching of the Trade Facilitation Agreement.

China is undoubtedly a "straight-A student" in WTO's policy reviews. The country has gone through nine transitional reviews and eight trade policy reviews from the WTO, in which it has given honest answers to more

than 10,000 questions raised by other WTO members. During the WTO's eighth trade policy review of China alone, which was held at the end of October, the country answered over 2,500 questions from other WTO members.

Besides, China has served as a "night watchman" of the WTO's dispute settlement mechanism. The country has participated in nearly 200 lawsuits in the WTO. After the international organization's dispute settlement mechanism was paralyzed, China, together with dozens of other WTO members including the European Union, established the multiparty interim appeal arbitration arrangement that opens to all members, endeavoring to safeguard the WTO's two-tier dispute settlement system.

Over the last two decades, China has developed from a user of public goods to an important supplier of public goods on the WTO stage. It should be

noted that China's development is closely intertwined with the world's prosperity. As China's gross domestic product accounts for a larger proportion of the world's total, the country voluntarily shoulders greater international responsibilities and provides more public goods.

As a close friend of the least developed countries (LDCs), China has provided funds and established the China's LDCs and Accessions Program (the China Programme) together with the WTO Secretariat, in bid to support the LDCs in integrating into and benefitting from the multilateral trading system by helping them with capacity building and sharing experience with them. It has helped six LDCs accede to the WTO under the program.

China has been a supporter and advocate of the reform of the WTO. Back in 2018, the country already put forward specific proposals and suggestions for

the reform of the WTO, and has explored new routes to making the WTO rules keep up with the times. It initiated the Friends of Investment Facilitation for Development (FIFD) and proposals for plastic pollution prevention and control, which have been joined by over 100 and more than 60 members respectively, making WTO rules more responsive to the needs of the times.

China is also a practitioner of

China is also a practitioner of the opening-up of markets. During the recently concluded negotiations on services domestic regulation, China, as a key participant, contributed to the success of the negotiations. It will implement the negotiations' results on the basis of most-favored-nation treatment to further open the service market, which will benefit all WTO members.

Over the last two decades, China has fulfilled its commitments to the WTO and taken active actions, playing a constructive role in promoting the development of the international organization.

China has achieved an "A+" score in fulfilling its WTO commitments, noted Pascal Lamy, former Director-General of the WTO.

During the WTO's eighth trade policy review of China, representatives of many WTO members spoke for justice, acknowledged China's contributions to the multilateral trading system, expressed gratitude to China for its selfless support for other countries in their COVID-19 responses, and looked forward to China's bigger role in the WTO.

## Russia's Sputnik V is world's safest Covid vaccine, says RDIF CEO

MOSCOW

RUSSIA'S Sputnik V coronavirus vaccine in the safest and the most effective vaccine in the world, CEO of the Russian Direct Investment Fund (RDIF) Kirill Dmitriev said in an interview with the Izvestia daily that came out yesterday.

"The latest data indicate that it is the best, the most effective and safest vaccine in the world," he said.

As an example, he cited a study conducted in Hungary. It demonstrated that Sputnik V's efficacy is 98% "It is the highest

figure.

It means that people inoculated with Sputnik V are protected against death from the coronavirus infection by 130 times better than those unvaccinated. It is the highest level of protection among the five vaccines that were studied," he said.

He also noted that Sputnik V's is

He also noted that Sputnik V's efficacy lasts for a longer time as compared with other vaccines and it causes much lesser side effects.

Dmitried also said that Sputnik V is highly effective against new coronavirus mutations. "As of today, Sputnik has demonstrated the highest efficacy among all other vaccines against genome mutations. So, there are no serious grounds to doubt Sputnik's high efficacy against new mutations," he said, adding that the Gamaleya Institute, the vaccine developer, is studying the new Omicron strain and will release its findings in two weeks.

He also said that in case of the emergence of new infectious agents, Sputnik's platform can be adapted quite swiftly and the production of a new vac-

cine may be launched in two to three months.

Sputnik V was registered in Russia on August 20, 2020 to become the world's first officially recognized coronavirus vaccine. By today, its has been approved for use in 71 world nations.

As of today, Sputnik has demonstrated the highest efficacy among all other vaccines

The statement read: "On behalf of the TBF we would like to inform you that the Kurasini Heat Basketball Club, who are the champions of the 2020 National Basketball League (NBL) and represented Tanzania in the 2021 Basketball Africa League (BAL) Qualifiers held in Dar es Salaam from October 29-31, 2021 and made it to the second stage, has opted out (BAL) Elite 16, which takes place in Johannesburg, South Africa."

A statement that was issued by Basketball Dar es Salaam's Chairman, Shendu Mwagalla, on behalf of Kurasini Heat, explained had issued the reasons for the withdrawal.

According to the statement, there was an uncertainty of the

safety of their players due to the emergence of another COVID-19 variant in South Africa.

The letter was sent to the headquarters of the International Basketball Federation, FIBA Africa, Abidjan, Ivory Coast, and TBF was given a

The statement further said: "FIBA Africa has informed TBF of the decision by Kurasini Heat and will submit a statement of the decision to the FIBA Africa Executive Committee which will make the final decision."

"The TBF calls on all clubs participating in international competitions to make adequate preparations before confirming their participation in international competitions to avoid any inconvenience to the respective clubs, TBF and FIBA."

The TBF statement revealed: "We would like to thank all those who participated in one way or another to help the Kurasini Heat participate in this important African Basketball Championship which is being run in partnership between FIBA Africa and the USA's National Basketball Association (NBA)."

The BAL Qualifiers, dubbed Road to BAL 2022, up to now involves a total of 16 teams doing battle for the right to secure the remaining six slots for the 12-team Final Round of the BAL.

Six teams from Angola, Egypt, Nigeria, Rwanda, Senegal, and Tunisia have automatic entry to the BAL.

It's the first time since 2003-04, when Barca were in the UEFA League, that the Catalan club will not be in the knockout stages of the Champions League, a competition they have won five times.

Xavi, who replaced Ronald Koeman as coach in November, conceded that the loss in Munich served as a wake-up call to the scale of the task facing him.

"A new era starts today. We start from zero. Our objective is the Champions League, not the Europa League but that is our reality now and we have to try and win it."

Xavi's return to Barcelona as coach began with two wins and a draw, but the defeat to Bayern came after a 1-0 reverse at home to Real Betis in LaLiga at the weekend, which left Barca languishing in seventh in the table.

"I've seen how tough the reality is," Xavi added. "I hoped we would compete better. Bayern are better. That's the reality. But we're going to work hard and give our all so that this doesn't happen again. It's a feeling of helplessness.

"We have to start to get Barca back where they belong, which is not in the Europa League. This is also a hammer blow for me as a coach. We will work hard to bring Barca back, but we have to change a

Barca have declined sharply since last winning the Champions League in 2015. Since then, they have suffered heavy defeats to Paris Saint-Germain (twice), Juventus (twice), AS Roma and Liv-

Bayern, meanwhile, have now beaten them 8-2, 3-0 and 3-0 in their three meetings over the last 16

## Pelé in hospital due to colon tumor, to be released in days

BRAZILIAN soccer great Pelé was hospitalized in Sao Paulo to continue his colon tumor treatment. Hospital Albert Einstein said in a statement on Wednesday that 81-year-old Edson Arantes do Nascimento is "stable and expected to be released in

the next few days." Pelé's assistant Pepito Fornos told The Associated Press that Pelé is having chemotherapy sessions to treat the tumor that was found during routine exams at the end of August.

Pelé was briefly put in intensive care after surgery on his colon. He was discharged on Sept. 30, almost one month after being hospitalized, and doctors said he would begin chemotherapy.

Kely Nascimento, a daughter of Pelé's living in the United States, posted a picture of one of his sisters and her father in hospital. Both were smiling.

"My father finished a procedure that was scheduled for months," Nascimento said. "In two or three days he will go back home to enjoy Christ-

Pelé had been recovering at his home in Guarujá, outside Sao Paulo. He published several videos and photos on his social media channels showing his health is improving.

The Brazilian's latest Instagram post was published Tuesday; a picture of him and another World Cup winner, Germany great Franz Becken-

Pelé won the 1958, 1962 and 1970 World Cups and remains Brazil's all-time leading scorer with 77 goals in 92 matches.

Before his health scare, Pelé had been staying out of the public eye following the cancer-related death of his brother, Jair, in March 2020.

# Barcelona out of Champions League, snow extends group stage

ARCELONA's 17 - y e a r advancing to the Champions League knockout each season ended Wednesday with an exit from the group stage that failed to finish on time because of snow in Italy.

Barcelona fell to a 3-0 loss at Bayern Munich that dumped the fivetime European champion into a dismal – and deserved – third place in Group E.

"We start a new era, from zero, from here," Barcelona coach Xavi Hernández, who rejoined a club in crisis last month, told broadcaster

Bayern's perfect six straight wins started with a 3-0 win at Camp Nou in September, and a repeat result at home let Benfica rise above Barcelona – and into the round-of-16 draw on Monday – by beating Dynamo Kyiv 2-0.

Only 15 of the 16-team lineup in the knockout stage were known on Wednesday night.

## Barcelona's Champions League exit shows just how far they have fallen

BARCELONA will play in the Europa League in the new year. The very same Barcelona that wanted to -- and still want to -- form a Europethe knockout rounds of the Champions League, missing it for the first time in 17 seasons. What chance would they have in a Super League?

Wednesday's 3-0 defeat against a Bayern Munich side in second gear, coupled with Benfica's big win over Dynamo Kiev in Lisbon, sentenced them to third place in Group E and condemned them to Thursday night football in 2022. It's the first time since 2003-04, when they didn't qualify for the Champions League, that Barca won't be in the last-16 of Europe's elite competition.

They've lost by three goals or more to Paris Saint-Germain (twice), Juventus (twice), Roma, Liverpool and Benfica in Europe in the past four seasons alone. And then there's Bayern, who have now beaten them by three goals or more three times over the past 16 months, totting up an aggregate score of 14-2.

If Bayern Munich are the benchmark in Europe along with their

> Another cliche in Barcelona at the moment is "it is what it is," born from the now infamous comment made -- and heavily criticised by the local media -- by previous coach Ronald Koeman after the 3-0 defeat to Bayern at Camp Nou in September. There's perhaps no better way to sum up Barca's situation at the right now.

There have been positives since Xavi took charge, but Bayern once again showed how much work Barca have to do. They can deal with not being in the Champions League knockout stages this season, but not being in the competition at all next year would be another economic disaster among many. Until then, they may want to put organising a Super League on the backburner.

## Legal experts support Simba SC in row with TFF

SOME legal experts are backing Simba SC's decision to threaten to opt-out of wearing jerseys bearing new NBC Premier League co-sponsor GSM

Early this week, a clip of the voice of Simba SC Chief Executive Officer (CEO), Barbara Gonzalez, went viral on social media, she was heard threatening that her side will not wear the jerseys with the GSM Group logo.

She said first Tanzania Football Federation (TFF) did not consult Simba SC on the sponsorship with GSM Group and also clubs are not aware of the content of the contract signed between the two and how will the clubs benefit from the agreement.

"We were not consulted on the matter, only three days have remained and TFF told us to put on the jerseys with GSM Group logo, we wrote them a letter on December 2 demanding to know the contest of the contact but they have not responded to us."

"I will go to a pre-match briefing with our lawyer, we want an explanation," she was heard saying.

Giving his legal opinion, a lawyer Adam Jabir said: " It is not the first time in Tanzanian major football leagues that a club had refused to wear the sponsors' logo, we saw that when Yanga refused to wear Vodacom Compay's logo as it was not their choice

"It is debatable what contractual rights do the football clubs have under the agreements with the League organizers on the one hand and sponsorship contracts between sponsors and the league organizers on the other.'

"Meaning contractual rights between parties can be enforced but it cannot against third parties unless there was consent by the third party. It is debatable whether Simba SC can be held for breach of contract entered by TFF and GSM on the basis that GSM Group is a secondary sponsor (NBC is the main sponsor. Beyond what is debatable the TFF rules perhaps solve the grievance by Simba SC."

There is no regulation requiring Simba SC to wear the logo on the left side of the jersey as the rules prescribe that the main sponsors' logo is displayed on the right-hand side," Jabir said in part of his legal opinion.

He further reasoned that the terms between TFF and GSM Group should have a beneficial interest to Simba SC for GSM Group to advertise on the left shoulder of Simba SC jersey that is to say TFF should fully disclose the terms of the sponsorship to the clubs and narrate on how the clubs are going to benefit from it.

Jabir went on to advise that Tanzania Premier League Board should amend its regulations as the current regulations are silent on the scenario of this nature.

"Moreover Tanzania Premier League Board should amend its regulations to reflect this scenario as the current regulations are silent hence it will be kind of difficult to enforce this GSM Group sponsorship saga within clubs without a proper legal backup," he said.

Another lawyer, Leonard Mwakasenge, said Simba SC has a point and it must be listened to.

"Simba SC are raising many pertinent issues which must be addressed. In my opinion, the 2021 TFF regulations on sponsorship need to be amend-

"Yes contract has some agreements which are exclusive, but for the interest of the game, they should no any secret," the lawyer disclosed in a monitored radio interview.

TPLB information officer, Karim Boimanda, said one of the conditions which the co-sponsor and TFF agreed was that clubs should wear jerseys with GSM Group's logo on the left side.

"That was the condition which we agreed with the co-sponsor, I can tell you that up to this time no club has come informing us they have a sponsor of the left side jersey," he said in the radio interview.


TANZANIA once had Hollywood, the premises in which one of the most successful films was shot, which is still located within the Arusha National Park, currently serving as a tourist lodge.
