TMA forecasts five more days of heavy rains

TANZANIA Meteorological Agency (TMA) has warned of rains above normal range between December 5th and 9th that will pound 17 regions including Dar es Salaam.

The TMA weather forecast for the coming five days said the 17 regions that will experience the heavy rains for five consecutive days is virtually the whole country with exception of Tanga, Kilimanjaro, Arusha and Singida regions.

Regions will experience above normal range rains today while Dar es Salaam and Coast regions will experience rains arising from periodic winds and storms in the outlying sea.



In May, uninterrupted rainfall also caused serious flooding in Dar es Salaam, resulting in the displacement of occupants in over 1.000 houses and the destruction of more than 1,500 dwellings and important infrastructure

"The rains are expected to cause havoc at different parts of the country especially in Dar es Salaam. We anticipate floods in lowland areas as well as destruction of infrastructures such as bridges and houses," the forecast noted, worrying that rains may also bring businesses to a standstill.

Powerful winds lately experienced in western parts of Somalia and north -west Madagascar would generate above range rains on the seashore for two days, on Thursday and Friday.

TMA appealed to people engaged in various economic activities to continue following up weather forecast to take precautions.

October death toll from heavy rains in different parts of the country reached 30, on the basis of police reports.

At least 30 people were killed by flash floods in Morogoro and Tanga regions.

Germany, EAC sign \$128m pact on health, education

yesterday GERMANY announced additional funds amounting to \$128 million (294bn/-) for supporting health and education programmes among member countries of the East African Community (EAC).

A greater portion of the funds, about \$105 million (over 241bn/-) has been allocated for the EAC immunization programme with GAVI, the global alliance for vaccination.

EAC Secretary General Amb.Libérat Mfumukeko and the Chargé d'Affaires at the German embassy, Jörg Herrera signed the pact in Arusha yesterday.

Investing in the health sector is not only an investment for sustainable social development but also for a country's and the region's economic development

With the support grant, the programme will be financing the procurement of at least four different types of vaccines (Pentavalent, Rotavirus, Pneumococcal and Measles) for children in the six EAC partner states.

Officials said the programme is financed through the German Development Bank, KfW and implemented in collaboration with Gavi, the Vaccine Alliance.

The cooperation aims at reducing child mortality in the region and mainly targets newborns. To date, KfW through the EAC has financed nearly80 million doses of life-saving vaccines for the region since support started in 2013.

The average immunization coverage in the region has been substantially increased, making the EAC's immunization programmes the strongest in Sub-Sahara Africa, an EAC statement indicated.

The pacts were signed before the Minister



for Industries and Trade, Innocent Bashungwa (pictured) and the Indian High Commissioner to Tanzania, Sanjiv Kohli at the opening of the two-day India-Tanzania Business Forum in Dar es Salaam yesterday.

The two pacts will among other things improve business relations and inter-country trade between India and SADC countries, fostering economic growth, the minister noted. Traders and investors from both sides

THOUSANDS of primary school pupils who passed this year's Standard Seven national examinations will not join secondary schools in January 2020 for lack of classrooms, the government confirmed yesterday.

Announcing the 2020 Form One selection in Dodoma, the Minister of State in the President's Office (Regional Administration and Local Governments) Suleiman Jafo said that 58,699 pupils, equivalent to 7.73 percent of those who passed exams, have not been selected.

He said that out of the non selected pupils 28,567 are boys and 30,132 girls.

Minister Jafo directed heads of regions and districts facing shortage of classrooms to complete construction of the remaining rooms by end of next February. He tasked regional and district administrative secretaries to ensure the directive is implemented accordingly for students to join Form One by March 2 next year.

The number of pupils who missed chances to join secondary school in Arusha are 4,739, Dar es Saalam (5,808), Iringa (3,480), Kigoma (12,092), Lindi (1,695), Manyara (728), Mara (9,493), Mbeya (2,716), Coast (2,918), Rukwa (686), Simiyu (6,616), Songwe (4,684) and Tanga

"All the 58,699 students will join secondary school education early March next year after completion of the classes," the minister

He applauded 13 regions that have been able to select all eligible pupils to public secondary schools, listing them as Dodoma, Geita, Kagera ,Katavi, Kilimanjaro, Morogoro, Mtwara, Mwanza, Njombe, Ruvuma, Shinyanga, Singida and Tabora.

He however noted that a total of 701,038 pupils equivalent to 92.27 percent, (335,513 boys) and (365,525 girls) have been selected to join secondary schools.

"We have allocated schools for 81.3 percent of all the candidates. Of the number, 363,999 (47.9 percent) are girls and 395,738 (52.08 percent) boys," he said, noting that among the passed candidates, 1,461 are disabled (0.19 percent), of whom 777 are boys and 684 girls.

He cautioned school administrators and other civil servants to stop ordering students to pay any type of contributions since Tanzania implements a fee free education policy for both primary and secondary schools.

Announcing results of the 2019 Standard Seven primary school leaving examinations, National Examination Council of Tanzania (NECTA) Executive Secretary, Dr Charles Msonde said a total of 759,737 out of 933,369

More than 4000 engineers issued with special identification cards

ENVIRONMENTAL sustainability and urbanisation are among the outstanding topics being addressed in the ongoing 30th National Conference of the Institution of Engineers in Tanzania.

Organised by IET in collaboration with Engineers Registration Board the event, being held at Ngurdoto Mountain Lodge also tackles issues of sustainable engineering, urbanisation, housing and urban planning, energy, water and transportation infrastructure. will enjoy exchange of information, technology and skills as well as investment opportunities available in the various countries, he stated.

He welcomed the Indian business community to explore investment opportunities in Tanzania and other SADC countries especially in agriculture and processing industries.

"Tanzania has a vibrant market based economy with unlimited investment and business opportunities which you are invited to explore," he told the visitors.

More investment opportunities are found in horticulture, cashew nut processing and production of edible oil, he pointed out.

There are prime investment areas whose potential has scarcely been utilized, said Bashungwa, insisting

on the need for partnership projects encouraged to set up Export between local and foreign investors.

He said India and Tanzania have always maintained a good relationship, with several high level diplomatic visits, bilateral agreements along with project cooperation, technical training, cultural exchanges and friendly interaction at various international forums.

A member of the CII Africa Committee, Manikanatan Rajendran said the CII business delegation will interact with key industry officials and businessmen from Tanzania to increase collaboration.

He cited targeted sectors as infrastructure, power, railways, manufacturing, software, renewable energy, education and development, telecommunications, engineering, automobiles and ICT.

Indian companies would be

Processing Zones (EPZ) manufacturing or processing facilities in Tanzania, which will in turn help Tanzania move up the export value chain to become a manufacturing powerhouse.

"Indian companies have enormous experience in working with the PPP model to develop infrastructure, aviation and power projects. This model could be used to promote Indian investment in Tanzanian projects," he declared.

High Commissioner Kohli said that the business forum and the two signed pacts will further enable exchange of experience and technology, enabling participants to expand business and create more trade opportunities.

He vowed to continue strengthening ties between the two countries which include increasing partnerships in trade.

Kohli also called on Tanzanian companies and from other SADC countries to partner with Indian companies to make maximum gains especially in agriculture.

India is among the leading trading partners of Tanzania, holding about 16 percent of Tanzania's foreign trade. A major part of India's trade with Tanzania comprises of petroleum products, pharmaceuticals, raw materials and essential machinery. In fiscal 2018 - 2019 India's bilateral trade with Tanzania stood at \$2.6bn, while Indian firms are among the top five investment sources in Tanzania.

The acting chairperson of the SADC Business Council, Angelina Ngalula said that with the pact, traders and investors from India and SADC countries will be able to establish partnerships and enjoy market opportunities for various products.

THE Tanzania Medicines and Medical Devices Authority (TMDA) has issued a total of 26,478 permits in the financial year 2018/19 compared to 13,018 issued in 2015/16, equivalent to an increase of 203 per cent.

This has been achieved through use electronic system which enables customers to submit applications and pay fees online before being issued with the permit within 24

A statement issued vesterday by the Acting Director General of TMDA Adam Fimbo said they have succeeded to increase the importation and exportation control of medicine and medical devices within and outside the country through an electronic system.

Fimbo said the issuance of permits to customers has been facilitated largely through a system of Integrated Management Information System (IMIS) which is used to keep information and data of TMDA comprised of products, buildings registered and those of the customers whereas they can bring their applications online without going physically to the offices.

"In carrying out the instruction of the President Dr John Magufuli issued on May, 2017 which aims to speed up the delivery of cargo at the Port, the authority has set its inspectors who work 24 hours a day all week, a move enabled it successfully achieved and exceed the goals set in the controlling of quality, safety and efficacy of drugs, medical devices, and reagents to protect public health,"

The acting director general said: "Within this four years in the leadership of President Magufuli we have managed to implement a programme of monitoring the quality of products on the market (Post Marketing Surveillance Programme - PMS), about 1,136 samples of human medicines where monitored and investigated in this period where the 96% continued to meet quality criteria."

According to Fimbo, TMDA has introduced an electronic system known as "ADR reporting tool" for monitoring the public reporting of adverse drug reactions and medical devices by using mobile phones or computers to send

He explained that TMDA staffs have conducted investigation in the year 2017/2018, and destroyed the total of 140,705.25 tonnes of pharmaceutical products and medical devices for human use worth 22,394,078,744 shillings compared to the destroyed 664.68 tonnes in 2018/19.

He added that TMDA has strengthened laboratory activities to increase surveillance equipment including the installation of 25 small movable laboratory (minilab kits) at the customs stations in favour of the preliminary investigation of the product. Survey results show that the samples examined met criteria of quality and safety standards to an average of 90%

Meanwhile, Fimbo said the authority has increased

its budget from 34.64bn/- in year 2015/16 to 53.31bn/- in vear 2018/19 equivalent to 53.8%. This has enabled service delivery efficiency and provide dividends to the government each year up to about 29bn/-.

TMDA was established in 2003 and operates under the Ministry of Health, Community Development, Gender, Elderly and Children. TMDA was known as the Tanzania Food and Drug Authority (TFDA) before its obligations changed from July this year when the Finance Act of 2019 made amendment to the authority's law.

Report stresses need for enhancing of education, sensitisation on animal welfare and food safety

A new report released yesterday in Dar es Salaam by World Animal Protection has shown that meat consumers in Tanzania are less concerned about how an animal is treated before it lands on their table as

The report titled: "Consumers perceptions on animal welfare and food safety" covered four countries-Tanzania, Kenya, Uganda and Zambia.

According to World Animal campaigns manager for animals in farming, Dr Victor Yamo, 37.2 per cent of Tanzanians who participated in the study do not consider meat being free from chemical contamination as important. "Similarly, 54.37 per cent of the participants did not consider how the animal is raised as being important while 60.7 per cent and 56.8 per cent did not consider the welfare of the animal during transportation and slaughter to be important," he said.

Dr Yamo said: "Of significant importance is that consumers are willing to pay more if they are assured that the meat products are free from antibiotics and chemicals and the animals are raised and transported in high welfare conditions and ultimately slaughtered humanely."

"This report points to a significant need for enhanced education and sensitisation of Tanzanian consumers on animal welfare and the correlation between how animals are raised and the quality of the meat that ends up on their tables."

According to him, it is important that producers and key players along the meat value chain adopted high welfare production systems.

The report further states that 89.9 per cent of the respondents would purchase more meat and meat their meat and meat products," said Dr products with a food safety assurance Yamo.

marker from supermarkets and fast food restaurants while 38.2 per cent of the respondents will purchase more if the production was environmentally friendly and 36.7 per cent would increase their meat consumption if the production system was animal welfare friendly. 60.1 per cent of the people interviewed would purchase more if assured the meat is free of chemicals.

The report also shows that 53.3 per cent were able to link the use of antibiotics in farming systems to poor welfare within the production system and 79.4 per cent of the participants knew that antibiotics in the meat had a negative impact on the health of the consumers. 87.8 per cent of the consumers were able to connect poor animal welfare to poor quality of meat that ends on their plates.

On the same line, 61 per cent were willing to pay more for meat that is produced in high welfare. In addition, 71.4 per cent percent of people interviewed would stop sourcing and tell their family and friends to stop sourcing meat if they knew supermarkets sourced meat products from poor animal welfare producers.

He reminded the Veterinary professionals in Tanzania of their critical role in not only educating producers and consumers on the importance of animal welfare in ensuring wholesome products but also the important role in ensuring that appropriate policies and regulations around animal welfare and food safety are in place to not only protect the consumers but also to ensure that the Tanzanian production system met international standards.



Taking A New Look **At The News ESTABLISHED IN 1995**

It is tragic that UN forces are paying a heavy price keeping peace in DRC

ISTURBING news has been streaming in from Beni, on the northern side of the Democratic Republic of Congo (DRC), just next door.

First it was about sporadic rebel attacks on civilians, and later about people venting their anger on the UN peacekeeping mission (MONUSCO).

Both incidents are as appalling as they are regrettable, what many could see as especially disquieting being the apparent inability by the UN mission there to fulfil its role or rather the lack of common ground on interpreting the role of the UN forces there.

Surely, people in the area have a right to believe that they ought to be protected by the UN mission, though that isn't quite its role.

Even in the wake of massive demonstrations in Beni, climaxing in the torching of the town hall and the compound housing regional or major offices of the UN mission in the zone, MONUSCO has continued to conduct its duties as usual.

Recent reports said that the peacekeepers were conducting extensive patrols in even one day after the setting on fire of their compound. They are not harbouring grudges on activist elements in the population urging people to stand against the presence of the UN.

By definition UN peacekeeping forces are there to watch who breaks peace accords, not to sweep rebels or anti-UN activists from forests and scrubs, as that is the work of national armed forces or a foreign country 'invited' to

Peacekeeping in war-ravaged Somalia has had elements of the two

overly successful as yet.

Tanzania lost three peacekeepers in a similar attack last year, as peacekeepers are in a sense having low defence levels as they don't attack any camps or fortifications, their sole official role being to see who breaks a truce - and report the same.

Last week's reports on the torching Beni town hall and the UN compound in the city was prompted by what protesters saw as failure by government forces and peacekeepers to prevent a deadly weekend attack by the Allied Democratic Forces (ADF) rebel group.

What is however surprising is that this situation continued for several days running, as if no one is in the place to inform the residents that the UN force is not mandated to do the

The head of the UN mission briefed the UN Security Council on what she described as a very disturbing situation. This was not quite new as immediate former UN Secretary General Kofi Annan was widely condemned in Africa for failing to stem the genocide in Rwanda in 1994 in his capacity as overall 'head' of UN peacekeeping.

The UN wasn't in charge of any security branch in Rwanda, unlike the French who were deeply involved. So, aiming every manner of blame relating to the chaos in the DRC at the UN generally and MONUSCO is the product of unfair and misguided judgment and

The DRC has experienced turmoil for so long that it should be leading initiatives to ensure that the tragic experience comes to an end and peace and harmony reign, making enhanced social and economic development aspects, and neither aspect has been possible.



HE ill-fated COP25 has found a host location at the third time of asking but, just like its predecessors, the highpowered international summit looks to be big on gestures and small on reversing the direction of humankind.

Starting on Monday, COP25, or the 25th Conference of the Parties to the **UN Framework Convention on Climate** Change, to give the summit its full name, will bring together top officials from 197 countries with the aim of establishing a set of new national targets towards cutting emissions.

The talks were originally due to be held in Brazil, but the government there pulled out 12 months ago. Chile offered to take over but, after weeks of street protests, the government there pulled out, too. Finally, the Spanish government stepped in four weeks ago to take over.

What are the talks about? The talks will review the progress made since the much-ballyhooed Paris Agreement was signed at COP21 in December 2015. The Agreement is meant to reduce emissions enough to keep global temperature rises 'well below' two degrees Celsius above pre-industrial levels, and ideally 1.5 degrees. The world has already warmed by about one degree Celsius from that baseline, leaving nations with even less leeway.

Each country has promised to set a national goal for lowering emissions along with a plan for how that might be achieved. But does setting targets

There were two main problems with the Paris Agreement. First, there is no international mechanism to enforce the targets that countries declare. Beyond domestic laws and 'peer pressure' from other countries, there is no penalty for failure.

Second, the cuts pledged so far are nowhere near sufficient, if climate models are correct, to stop the world from warming by well over two degrees. Hence the demand for new, even more ambitious targets to be set, both in Madrid and at the 2020 meeting in Glasgow, the UK.

Countries do seem to be stepping up their ambitions - or, at least, their rhetoric. For example, more and more countries are vowing to reach 'net zero' emissions by 2050 or shortly after. The new president of the EU Commission, Ursula von der Leyen, has in the past few days demanded that EU member states commit to cutting emissions by 55 per cent by 2030.

Do we believe politicians this time? The record on achieving emissions cuts in this way is very poor. For all the grand declarations at UN events, the reality is that even the weak targets set so far have only been met by accident rather than by design.

For example, the Kyoto Protocol, signed in 1997, committed industrialized countries to cut overall

Giraffe conservation may call for some balancing of fauna ecology

on the first National Giraffe Conservation Action Plan, which has just launched in Arusha, with the iconic tall mammals reportedly in serious danger of

That isn't how we normally think of giraffes, as they aren't as seductive for tourism as the 'big cats' traditionally crowding conservation talk. And it only means that conservation is being diversified a bit.

Experts meeting for the launch and explaining what the strategic plan is all about said execution will take five years starting next month.

The plan includes a countrywide census to establish the population of the wildlife species, where the principal threat is said to relate to drastic changes in the animals' natural habitats. That reference is both true and too broad, as giraffes are range animals rather than a closed-habitat type.

Documentation being used at that event was basically that, at the moment, Tanzania has an estimated population of 30,000 giraffes but they are facing a number of threats - including diseases. That sounds rather normal unless there is a strange disease, like the killer one that struck lions a decade ago or thereabouts.

The reported diseases are 'giraffe ear disease' which originated from Mikumi National Park and 'giraffe skin disease', which was first reported in Ruaha National Park. There are promising indications of both being tamed.

It is viruses which have a habit of killing instantly, not some parasites usually doing little more than merely touching the skin or ear.

Natural Resources and Tourism

XPERTS have been working minister Dr Hamisi Kigwangalla says that, the disease problem apart, one catalyst speeding up the giraffe's extinction is loss of habitats.

He warns that human activities have encroached reserved areas, reducing the wildlife territory, noting that the portion of territory we have left for wildlife habitats in many cases equals a medium-sized European country.

We are further told, or rather yet again warned, that Tanzania loses an average of 400,000 hectares of forest cover each year, and has witnessed a 15 per cent reduction in natural vegetation cover in the last decade.

These are areas where policy action and embedded global support can make a difference, for instance by spreading out drip irrigation methods to obtain enough moisture and a minimum of fertiliser as well as throwing tree seeds to germinate.

There is another point worth underlining: that excessive focus on human activities may actually miss the point, as non-poaching activity scarcely diminishes the variety of animals in national parks and game reserves.

Land area currently reserved for wildlife is an assurance that particular species and any others have ample space to roam, and the issue is whether other species which ought to have predators as well for being overly protected.

It would also surely pay for scientists to check fauna ecosystems and see if there is need to reduce the number of group hunters but not so much the scavengers, this by taking a sober assessment of their impact on specific species. Keeping heaping the blame on human activities alone all the time will be to little avail.

emissions by five per cent, compared to 1990, by 2012. The targets were just about met - but mainly because of the deindustrialisation of Eastern Europe and Russia after 1990, along with unrelated events in Western countries, namely the economic crisis of 2008-

So, what will actually happen? The scale of the problem is highlighted by the UN Environment Programme's Emissions Gap Report 2019, published on November 26, 2019. The report analyses the 'emissions gap' between what is currently happening, what countries have pledged to do and the emissions reductions that are needed.

In short, far from emissions falling rapidly or even stabilising, they have carried on rising at about 1.5 per cent per year. That also means that the cuts that are needed to reach the goals in the Paris Agreement must be made even faster.

Should we even bother with emissions targets? At which point, it is surely worth asking: Is the problem a lack of political will, as many critics maintain, or is the whole process of setting targets simply wrong?

When faced with the problem of maintaining or improving living standards for their own citizens, governments' first thought will always be to protect their own position rather than make cutbacks.

And French President Emmanuel Macron's desire to go against his people with a fuel tax a year ago - which provoked a year of Yellow Vest protests - shows the political costs of the elite trying to impose its green policies on a reluctant electorate.

In truth, the West has barely recovered from the crash of 2008.

Politicians are highly unlikely to jeopardise what little growth is being witnesses by imposing more taxes and restrictions on pollution.

Even when the politicians do manage to squeeze policies through, those policies prove highly cost-inefficient. Germany has spent over €300 billion (\$330.5 billion) on introducing renewables like wind power and solar power, yet these make up just oneseventh of the country's energy needs and German consumers now pay the highest electricity prices in Europe.

Is there a better way? There is, if we stop predicting doom and put our faith into human ingenuity instead. For one thing, there is no 'climate emergency'. We should ignore the advice of Greta Thunberg to 'panic'. These claims are an attempt to silence dissent and debate, to force us to do what the eco-warriors want rather than take a balanced view.

So, ONE: We should not panic. The world is likely to get warmer, whatever we do. But thanks to economic development, mostly powered by fossil fuels, we are in a better position to deal with whatever nature throws at us.

Just one example: the number of deaths from natural disasters has plummeted in the past century thanks to better transport, communications, healthcare and food supplies. We need more economic growth so that we may drag billions more people out of poverty and be even more resilient in the future.

TWO: We need to apply the best technologies - and develop even better ones. Let's pick the 'low-hanging fruit' the easiest and cheapest ways to cut

emissions. For example, low-energy lighting

both cuts energy use and saves money very quickly. Switching from coal to gas for electricity generation has been successful in the UK and the US.

Alongside that, let's invest in things that are good ideas in themselves but also happen to cut emissions, so-called 'no regrets' policies.

Electric and hydrogen-powered vehicles don't produce greenhouse gas emissions and can drastically improve the air in our cities - and they need less maintenance, too. Let's strive to make them cheaper and more reliable.

THREE: Let's stop wasting money on renewable. Wind and solar can be useful if the conditions are right where there's lots of sunshine or plenty of wind. Otherwise, they don't cut emissions by much and they are not reliable, but they do increase the cost of energy.

We need reliable, affordable forms of low-carbon energy, whether it is existing technology like nuclear fission or new possibilities like nuclear fusion. Let's use some of the money we save on renewables to launch a new wave of energy research.

Some of these things will take time to come to fruition. But we must take the long-term view - which is exactly what the green activists always demand.

So, instead of quick headlinegrabbing but meaningless fixes to stave off the apocalypse, we must trust ourselves to work our way out. Not that you will hear much of that optimistic rhetoric in Madrid.

news-media industry has long lamented how the digital revolution has broken its business models. Today, a majority of digital advertising money goes to Facebook and Google, and media companies are struggling to reinvent themselves through digital subscriptions.

But the disruption hasn't only affected advertising: it has also fundamentally changed and challenged journalism itself.

Historically, journalism has played a central role in shaping public discourse. News organisations have served as gate●keepers and chosen what to amplify. They have always been good at catching the audience's attention and driving engagement. This has, however, also been about ethics and purpose.

But the new public sphere has a different logic from the old. Today, journalism is just one of many actors providing information on what is going on in the world – only one of many providers of content, in an ecosystem which optimises for anger, fear and other strong emotions and where lies travel faster than the truth.

In this new world, journalism needs to change, and journalists need to learn the landscape and avoid the pitfalls. If we don't, journalism risks becoming a mirror to

the anger-driven, social-network logic – instead of a counterweight on the side of truth and reason.

Given these new challenges, here are five lessons for journalism in the age of rage.

Don't get your news, angles or sources from Twitter

Twitter is, compared with the bigger social-network platforms, a small shop. But in the news ecosystem it is hugely important, and unfortunately often in a destructive way. Politicians and pundits are overrepresented on the platform;

so are propagandists and manipulators.

Still, many journalists spend a disproportionate amount of time on Twitter, looking for angles and topics. Since the platform is easy to manipulate for anyone with access to money or a network of bots, this makes them easy targets for manipulation.

The architecture of the new public sphere makes life harder for journalists. But it also makes their job more important than before.

Twitter also distorts journal-

ism in more subtle ways. Journalists love engagement. Due to the nature of the platform, the content to which journalists get the strongest reactions on Twitter tends to be variations on the big topic of the day – the stories everyone is

The question is: was it necessary and important to cover this spectacle? Should the media report on intolerant provocations by marginal figures?

Distinguish political dismissal from relevant critique

The architecture of the new public sphere makes life harder for journalists. But it also makes their job more important than before.

It's harder not only because they can't single-hand-

edly set the agenda but also because the undermining of journalism is a central part of the political programme of many right-wing populist parties currently on the rise.

The attacks on journalism – as 'fake news' – by government heads Donald Trump in the US, Rodrigo Duterte in the Philippines and Viktor Orbán in Hungary are not isolated events: they are part of a pattern.

The undermining of the free press is at the centre of the political agenda for authoritarians across the globe. It is a difficult balancing act to be aware that journalism is under attack yet, at the same time, to stay open to justified criticism.

Cover Big Tech better

The rise of Big Tech is one of the most important stories of our generation. Facebook has over 2.3 billion monthly users and You-Tube last year had 1.8 billion logged on. The majority of Americans get their news from social networks and the same is true of most European countries.

Individually, journalists need to find the strength and the motivation to go on, without retreating or becoming overly defensive.

Never in the history of humankind have companies existed with such reach and impact on information and human communication. These new global superpowers need to be reported on and scrutinised, not only from the 'tech' angle.

here are many forms of hatred and exclusion in our world. There is fear of strangers, fear of foreigners, fear of other races, fear of people with other languages, cultures or religions.

On the basis of many of these fears, we build exclusions. We ostracise people. We push them away from us. We exclude them from jobs, houses and opportunities. Sometimes, as in apartheid South Africa, we deprive people of all their elementary rights simply because they are of a different race.

This kind of exclusion we call discrimination. Discrimination is the enactment of our fears and hatreds of other people on the basis of who and what they are.

I have practised some forms of discrimination and I have also experienced

As a young boy growing up in apartheid South Africa, I enjoyed the benefits of better schools, better hospitals, better public transport, better parks and better beaches - all for whites only. Those benefits made my life better, unjustly so, and the privileges they conferred on me continue in many forms.

But I have also experienced discrimination.

As an adolescent in Pretoria, as I grew into sexual selfconsciousness, I realised to my horror that I was gay.

Apartheid South Africa was viciously homophobic - like most of the rest of Africa still is. Gays and lesbians, transgender people and gender non-conforming persons were persecuted, assaulted, sidelined and jailed.

Later, I embraced being gay - but I lived in fear of apartheid's anti-gay laws.

All this discrimination is external. It is enacted prejudice. It is what we, the perpetrators, do to those we

fear and hate. But there is something

more insidious, more secret and far more difficult to grasp. It is what some of us sometimes experience within ourselves. This is when we take from the outside the hatred and ignorance and fear and prejudice that is enacted there - and adopt part of it into our own deepest self.

This we can call internalisation of stigma.

Let me give you an example. It is a painful example, because it's from my own life.

I am a proudly and openly gay man. I have fought for LGBTI equality and have served with pride as a judge in my country's highest court. I have a wonderful loving partner, committed to me as I am to him.

Despite all this, sometimes I hear a tiny voice, from deep inside me: But is it really normal? Isn't there perhaps something wrong with being LGBTI?

It is an unwelcome voice. It means that I have taken deep within myself the 2,500 years of I knew I would die before I was homophobic hatred that told me, 40. I would never see justice or every day of my life, that being non-racialism in my country. But carry the brand of one of human-

gay is evil and immoral and unnatural and unbiblical and perverted and sick.

Of course I know this is not true. I know that throughout human history a small part of humanity has always been queer. We have been vital, productive, creative members of all human societies. We still are.

Yet, even though I know full well that being LGBTI is normal, natural as being left-handed, that small voice from deep inside me still sometimes pipes up. It undermines my self-belief, my confidence and my pride.

I have experienced this in a second, I think far worse, way.

When I was a young man, soon after I came out as proudly gay, in the early years of the AIDS epidemic, I became infected with HIV.

I discovered this in December 1986. It was a terrible moment, for AIDS was then a certain death sentence. Although I was only 33, even worse than the death sentence of AIDS was the shame of having HIV.

I felt so ashamed that for years I could speak to almost no one about it. I felt contaminated, impure and unclean. I thought I deserved what I had got because I brought it on myself.

None of this is true. No one who seeks human connection through sexual contact ever deserves to pick up any ill effects. This, I realized only very late -

after I fell severely ill with AIDS and faced certain death. But as a judge in democratic

South Africa, I could buy my life back by taking antiretroviral medicines. A near-miracle happened within me. Since then, the virus has been successfully repressed in my body.

And I know that HIV is just a viral particle, a tiny fragment of life, that medication is effectively beating back. But still. From deep down inside me, there is a tiny voice that taunts me: You are unclean because you have HIV. You ity's most-feared and abhorred contaminations. And - you deserve this.

I have internalised the stigma of HIV.

People can internalise shame for many different reasons.

For more than 400 years, white people have oppressed and subordinated and stigmatised black people. They have treated them as less worthy, as inferior, merely because of the colour of their skin - especially in Africa.

European settlers colonised Africa, took away its resources, enslaved its people, marginalized black people in the countries of their own birth. And, in South Africa, they built one of the world's most rigidly systematic structures of oppression and exclusion - apartheid.

As a white person, I have no title to speak of what centuries of racial domination has done to my compatriots.

But Steve Biko did speak about it. He said that the most powerful instrument in the hands of the white oppressor is the mind

must be made to realise that they are not superior. Blacks must be made to realise that they are not inferior."

of the black person. "Whites

He was talking about the internalisation of racial shame - what my friend Nene Molefi calls "internalised oppression".

Biko called for black people to throw off the yoke of racial stigma - to assert themselves with pride and joy as black.

Because of this proud, defiant message, the apartheid police beat Steve Biko to death. Yet, his legacy lives with important lessons for us all, white and black, gay and straight, living with or without HIV.

To understand those lessons, we have to ask: What are the effects of internalised stigma? And what can we do about them?

we internalise When shame, a part of us helps to disable ourselves. It prevents us from acting fully and equally as human agents.

We see this most painfully in the HIV epidemic in South Africa, where over seven and a half million are living with HIV or AIDS. Across the rest of Africa, many many more millions. Yet AIDS in Africa remains largely a disease of silence, a disease of the mute. Where almost no one says openly: I am living with HIV.

Partly, this is because we are scared of being discriminated against and rejected. For too many, prejudice against AIDS remains frighteningly real, especially for women, who bear the brunt of diagnosis, and of having to care for others with AIDS.

But the silence also comes from within.

We have good laws against discrimination. And we have wonderfully lucid, deeply reasoned judicial decisions.

The Constitutional Court, in which I was privileged to serve, gave two beautiful decisions on AIDS - barring discrimination against people living with HIV - and requiring President Thabo Mbeki to start making antiretroviral treatment available to prevent newborns contracting HIV. Those decisions said that HIV and AIDS are not shameful. It is a fully medically manageable condition.

Also, when I started speaking out about living with HIV, a flood of love and affirmation and approval engulfed

Why the continuing silence? The reason lies in the internalisation of stigma and shame.

Internalised shame about HIV is a powerfully destructive force in the epidemic. It has disabled many millions of Africans - including leaders, singers, artists, soccer stars - from speaking about their diagnosis, their treatment, their survival. It has barred them from fully and proudly participating as citi-

zens in public life. So the first effect of internalised shame is that it disables our capacity to act as full citizens.

The second effect is that we risk living in isolation and anger and fear - not knowing how to deal with the injustice of the stigma we experience from outside.

That anger can translate into militant activism, into hatred for the people that we feel are oppressing us. Our internalised shame as LGBTI people can make us resent those we regard as straight, make us hate straight people for past individual acts of oppression, for centuries of homophobia. Internalised shame about HIV can make us angry and destructive towards those we think do not have HIV.

Our internalised shame as black people may do the same. As a white person, I can only guess - but I think that some of the racial interactions in my country today are complicated by feelings of internalised shame about race. **DM**

The app's Real Time Deals model combats algorithms used by other ride-hailing companies, which rack up prices because of peak hours, traffic and request history.

"inDriver allows passengers to set their own fare for their chosen route. Nearby drivers who receive notice of ride requests have three choices - accept the fare offered, ignore the offer or bargain for a higher price. Passenger can choose either car or bajaj," a statement

A hint for African governments on attracting investment

In the words of the Foundation's chairman, Olusegun Obasanjo, "We had deep and robust discussions about how we can get Africa to take its rightful place as a global economic powerhouse by attracting the investment needed to build our economies and improve the lives of our people.'

To develop Africa's economies at a rate fast enough to keep pace with Africa's fast-growing population, which projected to double by 2050, the continent requires large injections of foreign and local direct investment.

The scale of the challenge is daunting. At current rates, in just 30 years, the same amount of time since the Berlin Wall fell, Nigeria's population will increase to over 400 million, while Tanzania's, currently 53 million, will grow to the more than double to 95 or nearly 40% of the

million, while Uganda will balloon from 43 million to 106 million, according to the United Nations.

The anticipated pace of growth of African cities is even greater, projected to remain at over 4% for the next three decades, twice the global average. Africa's share of global urban residents will as a result mushroom from 11.3% in 2010 to 20.2% by 2050. Using China's estimated capital spend per urbaniser, Africa's upcoming urban explosion will demand finding an extra \$3-trillion in extra financing over the next generation on capital spend alone to get ahead of the urban demographic boom. So far, the continent is

not even close. FDI flows to Africa rose to \$46-billion in 2018, an increase of 11% on 2017 according to UNCTAD's World Investment Report 2019. Africa is better off in FDI terms than 2017, but not against much of the preceding five years. 2018's partially stronger FDI to the continent was still nearly 18% lower than the \$56-billion achieved in 2012 and 2015. Africa's share of FDI is just 3.5% of \$1.3-trillion; its share of global population is almost 17%. Developing Asia same size as that of Russia received, by comparison, at 137 million. This is mirrored in the experience of many African countries: from Angola to Zambia, governments' failure to attract long-term investment (beyond the commodities sector) has been a brake on growth and development. Across the continent, business and investor confidence is usually weak and their relationship fragile, reflecting concerns widespread corruption and wild swings in the commitment governments macroeconomic stability and the rule of law.

The governance aspects that lower returns on investment can be termed costs", and comprise the premium added by malfeasance, policy uncertainty, the absence of infrastructure, fractious business-labour regimes, capital controls

avoidable and inefficiencies. These "frictions" come at a cost to development by discouraging investors and constraining job creation.

For Africa to increase its per capita GDP from its current levels (\$1,800) to the global average (\$11,000) by 2050, it will have to increase its economy 12-fold, allowing for the rate of population increase. This requires an average annual growth rate of 7.4% for the next 30 years.

This will require, in turn, transforming Africa's investment attractiveness. Reducing these frictions, encouraging





Johannesburg, Cape Town join league of global fintech hubs

Four African cities - Johannesburg, Nairobi, Lagos and Cape Town – are listed in the top 100 cities worldwide for fintech businesses.

The cities form part of a new league table of global fintech hubs, according to Findexable's Global Fintech Index City Rankings 2020. According to Findexable, the Global Fintech Index is the first global, real-time, objective ranking of all cities where there is a fintech cluster.

It explains the rankings are determined and updated using the company's proprietary algorithm, which is digital and real-time. It uses open data and data sharing to create a continuously updated index.

The company points out that many of the cities which traditionally top the lists of leading financial centres are conspicuously absent this year. However, South Africa (37) and Kenya (42) made it into the top 50 fintech countries in the world, with Nigeria (52) and Ghana (58) close behind. Top of the worldwide list is the San Francisco Bay area, followed by London, New York and Singapore. The US also tops the list for fintech countries, followed by the UK and Singapore.

The Global Fintech Index City Rankings 2020 identifies emerging hubs, fintech companies and trends. The index algorithm ranks the fintech ecosystems of more than 230 cities across 65 countries, incorporating data from Findexable's global partners including StartupBlink, Crunchbase and SEMrush, together with a consortium of regional partners such as the Africa Fintech Network.

Simon Hardie, CEO and founder of Findexable, says: "This [the index] is the inspiration of a thousand hours

of interviews, surveys and Internet searches - and the product of four months of algorithm development to create, for the very first time, a fully global ranking of fintech countries and

"The rankings in the report are proof of how much, and how fast, the world is changing." Hardie notes: "Fintech is the electricity of the global digital economy making connections and finding the path of least resistance to make it easier and cheaper to transact.

"Keeping up with the pace of change and keeping track of progress, however, is essential if fintech's innate digital difference is to be successfully converted into real-world value." A recent study by PwC says fintech investment in Africa is likely to be valued at \$3 billion by 2020, with SA and Nigeria receiving a significant portion of these investments.

"SA's financial services (FS) sector is undergoing a process of unprecedented change brought about by the disruptive impact of fintech challengers and the emerging technologies powering their business models. Fintechs are redrawing the competitive landscape and blurring the lines that define players in the FS landscape," says PwC.

SA's fintech strengths are digital banks, crypto-currency, insurtech and SME financing, the Global Fintech Index notes. In SA, 2019 has been dubbed the year of the digital banks, with new players like TymeBank, Discovery Bank and Bank Zero coming in to the fray to disrupt the traditional financial services market.

On the insurtech front, start-ups like Pineapple and Naked, among others, hogged the limelight. Several crypto-currency marketplaces have also mushroomed in SA, including Naspersowned Luno, AltCoinTrader, VALR.com and iCE3X.

DUBAI

Amid a slowdown in the residential sector in the region, a German developer will this month promote its housing project in Tanzania to Arabian Gulf investors.

The developer, CPS Live, will be making its pitch at the Arabian Travel Market, which runs from April 25 to 28 in Dubai. The project is in a free economic zone, which enables foreigners to get a title in the form of a 99-year lease under their name.

"Economic slowdown in the Arabian Gulf region currently motivates investors to search for new markets," said Sebastian Dietzold, the managing director of the Fumba Town Development and the founder of CPS Live. "The [Arabian Gulf] is currently the strongest growing touristic market [for Zanzibar], which has historically strong links to especially Oman and the UAE."

The first 400 units of the 1,500-unit, US\$120 million project on the coast are to be handed over starting at the end of next year. The entire project is to take about five years to be complete. CPS Live is to continue to manage Fumba Town for at least 10 years after completion, including letting and management services for house owners living abroad.

A German prefabrication factory is under construction near the site to supply the villas, and is expected to be ready in September. It would have an annual capacity of 250 homes a year. The project started rolling in 2011, when CPS Live and the **Zanzibar Investment Authority** started talks for a residential project on the island.

The demand for affordable housing is on the rise in the country. The capital city, Dar es Salaam, remains the major residential market in Tanzania, and foreigners cannot own apartments. The public sector is building a large number of low and middle-income housing across the country, and in Dar es Salaam alone, pension funds were expected bring to the market at least 8,000 residential units last year, according to a report from the consultancy Knight Frank last year. The Tanzania Buildings Agency also plans to build 2,500 units across the country, it said.

Tanzania's government is implementing austerity measures, which includes state spending cuts, according to the research company IHS. The GDP per capita by purchasing power parity in 2014 for Tanzania is US\$2,000 to \$2,999, according to the IMF.

According to Mr Dietzold, the first phase of the Fumba Town Development is about 80 per cent sold, mostly from Tanzanians at home and abroad. Located on Unguja, also known as Zanzibar Island in the archipelago, the development aims to be a satellite township for Zanzibar town.

The developers expect a 15 to 20 per cent return on rentals and a capital appreciation. Prices start at \$45,900 for a two-bedroom villa. Mr Dietzold started CPS Live in 2004 in Germany and moved to Zanzibar in 2011.

Ports development on Lake Kivu to transform maritime transport

KIGALI

Last week, the Government secured funding from the Netherlands to finance the development of four ports at Lake Kivu, expected to promote maritime transport, trade and tourism.

The grant arrangement will see the Netherlands co-finance 45 per cent of the construction of the ports and their facilities which will improve ferry and cargo transport between the Rwandan ports. Rwanda currently relies heavily on road transport which weighs heavily on transport and maintenance costs, officials say.

The presence of lakes and rivers might attract both the transport of passengers and goods, but there is currently no significant inland waterway services except the very limited waterway operations in Lake Kivu.

With the existence of ports, the Government seeks to turn around that situation and transform maritime transport and make it a major transportation alternative for both persons and goods. The Rwf22 billion project which will be built in the four districts of Rubavu (Nyamyumba), Rusizi (Bugiki), Karongi (at the Karongi cross-border market), and Rutsiro (Nkora region), will be operational by 2022, officials say.

According to the Rwanda **Transport Development Agency** (RTDA), there will be three major ports with a capacity of about 1.5 million passengers per year, projected to reach 2.8 million by 2036. A smaller port, the fourth planned port, in Karongi District will start with a capacity of about 300,000 passengers per year by 2020 and 400,000 passengers by 2036.

The Singapore-based private equity firm is acquiring the office property at 2-10 Wentworth Street in Parramatta from Centuria Property Funds through its open-ended SCORE+ Fund, which invests in core and core-plus real estate assets in Asia Pacific.

The acquisition is the company's third Australian purchase in less than two months through its SCORE+ and RECAP funds. "Two Wentworth Street is an excellent addition to the SCORE+ Fund portfolio and is consistent with its strategy of acquiring well-located and stable, income-generating sets," said SC Capital Partners' chairman Suchad Chiaranussati.

Sydney-based Centuria announced separately that it had exchanged contracts on Two Wentworth Street five years after purchasing the property for A\$45.1 million.

Tencent pays RMB 8.5b for mixed-use site on Shenzhen's Qianhai Bay

The Shenzhen government has awarded tech giant Tencent an 809,124 square metre (8.7 million square foot) plot of reclaimed land to develop a "future city" focused on technology and innovation, according to an announcement years by the city's Land and Real Estate Exchange Centre.

The creator of social networking app WeChat has agreed to pay the city a total of RMB 8.52 billion (\$1.21 billion) for the right to develop facilities dedicated to cloud technology, medical technology, education technology, and sports technology - as well as hotels, schools and apartments on

which already Tencent, employs 38,000 people in Shenzhen, expects to build a commercial hub providing workspace for 75,000 Tencent employees in the Bao'an district location.

Developing a Tencent City in 7 Yielding a total gross floor area

of two million square metres, the site will house six research facilities for new technologies - including cloud technology, medical technology, education technology, and sports technology - as well as hotels, schools and apartments.

Retailer Landmark Group has opened a new, Dh1 billion fully-automated 'Mega Distribution Centre' at Jebel Ali Free Zone in Dubai.

The company behind the eMax, Centrepoint, Home Centre and Babyshop brands, has said the new distribution centre is a 43 metre, high-bay warehouse capable of handling 300 million items a year. It has the capacity to house up to 2.2 million cartons and 250,000 garments on hangars, and will handle them using 1,300 'robotic multi shuttles' 94 lifts and 28 workstations.

"The opening of Mega DC marks a huge milestone for Landmark Group," said the company's chairwoman and chief executive, Renuka Jagtiani. "We are very proud to have built this fully-automated facility, which will serve our customers even better by ensuring speed and agility of operations but will also project the future of supply chain for our region."

Landmark Group was set up by founder-chairman Micky Jagtiani in 1973 when from a single store in Bahrain. Its headquarters moved to Dubai in 1990 and the company now operates more than 2,300 outlets across 22 countries in the Middle East, Africa and India. It employs more than 55,000 staff.

Landmark Group's automated distribution centre's "adoption of technological tools like artificial intelligence, big data, IoT, robotics and automation to drive logistics solutions is in step with what we do at DP World," said the chairman of Dubai's ports operator and of the Jebel Ali Free Zone Authority, Sultan Bin Sulayem.

"Customers are looking for speed, transparency, efficiency and effectiveness. A new approach is necessary to meet their demands along the supply chain. We believe Landmark Group is innovating to enable smarter trade," he added. The centre will have a shuttle system for handling cartons and tote banks with 'inter-aisle transfer technology', Landmark Group said in a statement.

It also has an automatic storage and retrieval system capable of storing more than 36,000 pallet positions, serviced by 41-metre tower cranes. About half of the centre's power requirements will be met through an 8.2 megawatt array of rooftop solar panels, the largest of its kind in

House judiciary panel takes over **Trump impeachment proceeding**

WASHINGTON

The Democrat-led House Judiciary Committee took over a months-long impeachment proceeding into U.S. President Donald Trump by holding its first hearing on Wednesday.

After opening remarks by Chairman Jerry Nadler and Ranking Member Doug Collins, four constitutional law professors, three chosen by Democrats and the other invited by Republicans, provided testimony to the panel and took questions from lawyers and lawmakers of both parties.

The first witness, Noah Feldman, professor of law at Harvard Law School, testified that he believes Trump's conduct "clearly constitutes" the constitutional standard for "high crimes and misdemeanors."

"According to the testimony presented to the House, the solicitation sought to gain an advantage that was personal to the president. This constitutes a corrupt abuse of the power of the presidency," Feldman said.

In contrast, Jonathan Turley, professor of public interest law at the George Washington University Law School, cast doubt on the speed and scope of the proceeding, saying he is "concerned about lowering impeachment standards to fit a paucity of evidence and abundance of anger."

"Fast and narrow is not a good recipe for impeachment," Turley said. ing, said they "cannot wait for the elec- Donald Trump won in 2016, and it's the reason

"They tend not to survive. They tend to collapse in front of the Senate."

Stanford University Law Professor Pamela Karlan and University of North Carolina Professor Michael Gerhardt also testified and largely sided with Feldman.

House Democrats are looking into whether Trump abused his office by pressuring Ukraine into launching investigations that could benefit him politically. Lawmakers are also examining whether the Republican conditioned a White House meeting or a military aid to Ukraine on those

Wednesday's hearing came a day after the House Intelligence Committee released a report on its findings in the impeachment inquiry, which called evidence of Trump's alleged misconduct and obstruction of Congress "overwhelming."

Trump, who is in London meetings with other leaders on Wednesday, told reporters that he had seen the report, which he called "a joke."

The president, who has consistently denied any wrongdoing or a "quid pro quo," weighed in on the ongoing hear-

"To do it on a day like this where we're in England ... It just happened to be scheduled on this day. It's really honestly, it's a disgrace," he said.

Ranking Member Doug Collins lashed out at Democrats during the hearing, accusing them of having tried to impeach Trump since he was elected, while the panel's top Republican claimed the impeachment inquiry is driven by "the clock and the calendar" rather than "the facts."

The Democrat-led impeachment inquiry has found that Trump, "personally and acting through agents within and outside of the U.S. government, solicited the interference of a foreign government, Ukraine, to benefit his reelection," claimed the intelligence panel's report that also accused the president of having "engaged in an unprecedented campaign of obstruction."

"Democrats still don't get it - they are pushing ahead with impeachment based on opinions from liberal law professors from coastal universities," House Minority Leader Kevin McCarthy Nadler, who presided over the hear- tweeted on Wednesday. "This is the reason that

he will win again in 2020."

House Speaker Nancy Pelosi, who initiated the impeachment inquiry into Trump in late September, tweeted, "the facts are not contested," urging Congress to decide how to carry out its constitutional duty, as Democrats were reportedly on track to potentially vote on impeaching Trump by Christmas and voters remained sharply divided over Trump's impeachment and his removal from office.

According to the nation's constitution, the House shall have the sole "Power of Impeachment" while the Senate shall have the sole "Power to try all impeachments."

Trump will be impeached if the House approves any of the articles of impeachment the House Judiciary Committee has recommended by a simple majority vote.

But conviction can only happen in the Senate and requires at least two-thirds of its members, or 67 senators, to vote in favor. Currently, the Senate has 53 Republicans, 45 Democrats and two independents.

White House Counsel Pat Cipollone met with Republican senators on Wednesday to discuss how the impeachment process might unfold over the coming months.

Zimbabwe court appoints Mugabe daughter to identify his assets

HARARE

A court in Zimbabwe yesterday appointed Robert Mugabe's daughter to identify assets left by the late former leader so they can be distributed to his beneficiaries, his lawyer



Zimbabweans are keen

to know how much wealth Mugabe accrued during his 37 years in power. Many assume that he and his family amassed a vast fortune - perhaps as much as \$1 billion, according to a leaked U.S. diplomatic cable from 2001.

The Master of High Court in Harare appointed Bona Chikore executor of her father's estate, the Mugabe family lawyer Terrence Hussein told reporters, adding that this had been agreed by family members.

Hussein said Mugabe's wife Grace and Bona (pictured) attended vesterday's meeting at the court but sons Robert Jr and Bellarmine Chatunga were away. They, however, gave written consent that their sister should be appointed executor.

For many years, Mugabe and Grace were widely reported by Zimbabwean and foreign media to have deposited money and bought properties abroad, including in Asia, where they spent most of their annual family holidays. The family has denied this.

But a legal dispute that spilled into the public in 2014 over a \$5 million villa in Hong Kong suggested Mugabe's family had been buying overseas property. The government said it owned the house.

Hussein said journalists and United States and Britain, who were critical of Mugabe, should prove that he had properties abroad so they could be registered with the court. "This is the good thing about saying falsehoods, those falsehoods will be exposed. Where are the properties?" Hussein said when asked about reports that Mugabe had properties abroad.

Hussein told Reuters on Tuesday that the process of establishing Mugabe's assets would take some time, casting doubt on a state media report that the former leader left \$10 million and some properties in the capital. *Agencies*

IN recent years, racial discrimination, gun violence, and political polarization in the U.S. have led to massive demonstrations and even street violence in some cases. If demonstrations break the legal bottom line, the U.S. law enforcement departments will surely take tough measures to quell the violence.

On June 29, far-right extremists and left-wing activists took to the streets for a standoff in Portland, Oregon. Shortly after the demonstration start-

ed, projections began to appear. After that, the law enforcement department revoked the permit for the demonstration and declared the situation a riot. Flash bombs and rubber bullets were used to bring the standoff to a close and perpetrators were ar-

rested. The law enforcement effort was widely supported by local politicians

officers to control violence was applauded by the local community. Portland Mayor Ted Wheeler pointed out that whoever resorts to violence under the guise of freedom of expression is unwelcome in the city.

The U.S. law enforcement officers won't tolerate violent protesters, not to mention that the protesters may challenge or endanger the security of the police officers.

The strong and tough measures taken by the U.S. government to quell massive riots are still remembered by many Americans even until today.

In 1992, the largest riot in the U. S. in the 20th century broke out in Los

To quell the riot, the then U.S. President George Herbert Walker Bush even dispatched the 1st Marine Division and the 7th Infantry Division. Statistics show that about 12,000 people were arrested.

In 2011, the Occupy Wall Street campaign swept across the U.S., and law enforcement agencies were highly vigilant. During the clearance of the campaign at Zuccotti Park in Manhattan, the center of the movement, New York police dispatched thousands of police officers and arrested 200 protesters who refused to cooperate.

in Ferguson, Missouri. The governor of the state declared a state of emergency and dispatched a large number of law enforcement officers and heavy equipment such as armored vehicles to suppress the riot.

In 2015, racial riots broke out again in Baltimore, Maryland. The governor of the state also declared a state of emergency, imposed a curfew, and mobilized thousands of National Guard members to quell the riots.

The U.S. public does not need to worry about the lack of law enforcement. On the contrary, excessive law enforcement and violent law enforcement have been a major problem facing American society for a long time.

According to data released by the FBI in 2017, U.S. law enforcement agencies approved more than 10 million arrests (excluding arresting of traffic violators) in 2016, and an av-

In 2014, a major racial riot took place erage of 3,298.5 people per 100, 000 residents were arrested. According to The Washington Post, U.S. police shot and killed 998 people in 2018 alone.

Forces agitating for violence, chaos will be rejected

THE US signed into law the socalled Hong Kong Human Rights and Democracy Act of 2019, confusing right from wrong, in an attempt to blatantly bolster rioters and violence as well as intentionally disorder the current situation of Hong Kong.

The perverse acts of some US politicians will only arouse the indignation of all Chinese, including those in Hong Kong, exposing the hypocrisy, selfishness and hegemonic desire of the US side.

The violence conducted by rioters in the past five months cannot be disguised or beautified by some countries. Radicals attacked the legislative council, government buildings and other public facilities, and set malls, banks and campuses on fire.

They deliberately attacked dissidents, violated human rights such as freedom of speech, and hurt innocent citizens. Such misdeeds are appalling and outrageous.

According to statistics, more than 460 groups of traffic lights in Hong Kong were damaged, 46,000 meters of railings were demolished and about 2,900 square meters of floor tiles on the sidewalks were destroyed as of the end of October.

One hundred forty five subway stations and light rail stations that were often used by Hong Kong citizens were sabotaged along with facilities inside the stations.

The access gates were damaged about 1,600 times, surveillance cameras inside the stations about 1,100 times and the routes of more than 300 franchised buses, 300 minibuses and all tram routes had to be diverted or stop operation due to road closures and illegal activities of rioters.

"Hong Kong stares into the abyss amid growing violence," said a report in the Economist. Even some American media admitted that some Hong Kong protesters are becoming "in-

creasingly violent and ugly."

"Hong Kong's economic and social governance has been seriously damaged by the chaos."

"What is happening in Hong Kong is no longer a legal expression of pursuit, but a destruction of their

"No country in the world can tolerate such violent crimes."

Such voices are echoed by intellectuals across the world who expressed shock and anger at these violent acts.

The US law seriously distorts the facts, portraying the violent acts as "a beautiful landscape" and the police's extremely restrained law enforcement as "violent suppression."

No wonder people began to question where these US politicians put their conscience and human nature. Some claimed that their "human rights standards are applicable around the world", and consider the law to be "a commitment to democra-

cy, human rights, and the rule of law". In fact, America's human rights record is so infamous that it's not qualified to lecture other countries.

The law was simply a trick for them to confuse the public, and support separatist forces, using a double standard on human rights issues.

As justice always prevails, Hong Kong's strong call for "opposing violence, loving peace, supporting the police and protecting security," as well as citizens' voluntary acts of clearing roadblocks and their petitions urging the court to punish rioters, all hit American politicians in the face, demonstrating the strong desire of all citizens in Hong Kong to end violence and stop the chaos.

Hong Kong is China's Hong Kong and its affairs are China's internal affairs. The Chinese are able to settle Hong Kong affairs. THE African continent is home to over 25.2 million forcibly displaced persons of which some 7.4 million are refugees and 17.8 million Internally Displaced Persons (IDPs), the African Union (AU) said on Wednes-

Noting that Africa also hosts 484,000 asylum seekers and some 712,000 stateless persons, the AU said in a statement issued on Wednesday that forced displacement has continued to plague Africa over the years, largely triggered by intra-state conflicts, including intercommunal and ethnic violence, per-

According to the 55-member pan African bloc, the major drivers of forced displacements in Africa are attributed to factors including politi-

"Despite commendable efforts to address and manage forced displacement in Africa, displaced persons continue to experience abuse, exploitation, and violations," the AU said, adding that a large number of displaced persons have remained in need of humanitarian assistance, finding themselves in "protracted situations where solutions have become illusory."

It also stressed that although an increasing number of displaced persons currently are hosted in communities and located in an organized environment, the particular situation of women and children remain dire ably limited.

Israel's foreign minister says he hopes Corbyn loses British poll

JERUSALEM

ISRAEL'S foreign minister said yesterday that he hopes Jeremy Corbyn loses next week's British election, citing allegations of anti-Semitism buffeting the Labour Party leader.

With Israel in political disarray of its own after two inconclusive elections, the British contest has elicited few comments from Israeli leaders despite deep concern among British Jews over Corbyn and media reports that some might opt to emigrate if he wins.

Last week, Foreign Minister Israel Katz said the Israeli government had not discussed the prospect of Corbyn's election or the future of intelligence and security ties with Britain should the veteran pro-Palestinian campaigner become its leader.

But pressed on the issue in an Israeli Army Radio interview on Thursday, Katz was more forthcoming as the Dec 12 ballot approaches.

"I won't meddle in internal elections but I personally hope that he won't be elected, with this whole wave of anti-Semitism...I hope the other side wins,"

Labour Party spokesmen did not immediately respond to a request for

Katz played down the prospect that security relations with Britain, which include intelligence sharing over Islamist militant activity, would necessarily be degraded should Corbyn take

"Leaders don't harm their country's own interests so fast. But we will of course discuss these things if they oc-

Corbyn has rejected allegations of anti-Semitism - last week Britain's chief

On Tuesday, Corbyn made a direct anti-Semitism in his party.

"Obviously I'm very sorry for everything that has happened," he said. "But I want to make this clear, I am dealing with it, I have dealt with it."

Polls have shown Labour trailing Prime Minister Boris Johnson's Conservative Party. And for now, Israel does not appear to be bracing for any influx of British Jewish immigrants.

Asked about this possibility, its Im-

migration Ministry said in a brief statement only that it "is prepared to take in immigrants from all over the world and welcomes immigration in any political situation". quasi-governmental Jewish

Agency for Israel, which handles immigration requests abroad, said 507 British Jews moved to Israel between January and October, an 8 percent rise apology for not doing enough to tackle compared with the same period in 2018. Yigal Palmor, the agency's head of

international relations, played down any sense that Corbyn's candidacy was a major spur for British Jews to leave.

"We have no solid findings to show an increase in British immigration (due to the elections). What we have are more general indications - more discussions of the option," he said.

THE United Nations food agency has warned of a tropical storm that could cause strong winds and some rains across Somalia's Puntland and Somaliland.

alert issued in Mogadishu. "Strong winds associated with the storm may cause destruction of weak structures and fishing gears along the coast," it said.

JOSE Mourinho conceded his former club Manchester United had deserved their 2-1 Premier League victory over his new team Tottenham Hotspur on Wednesday and hailed the performance of Marcus Rashford.

Mourinho took over as Spurs manager last month, nearly a year after he was fired by United.

"I think they deserved the victory by their first half. We didn't start well at all," said Mourinho, whose side fell behind to a seventh-minute goal from Rashford.

"I think for the first 30 minutes they were the best team, and I think because of that, for this strong 30 minutes where we were not there, and also because of the way we conceded the second goal, I think they deserved to win," he added.

Mourinho noted that Ole Gunnar Solskjaer's side, held by Aston Villa and Sheffield United in their last two league games, had delivered their best displays against the top-

"United results against the best teams this season have been good. Chelsea, Liverpool, Leicester," he

"For the way they play it is easier for them. They are not afraid to have a defensive approach. It is easier for them against better teams, against teams who want more of the ball," he added.

The Portuguese, sacked by United after two and a half seasons in charge, had plenty of praise for his former forward Rashford

"When he plays from the left he is really dangerous and I knew that and gave the players the best information about it. His first goal is a typical Rashford goal coming on the inside. Our boys knew that clearly," he said.

Solskjaer was unsurprisingly even more fulsome in his praise of the 22-year-old England international, who delivered a performance of real quality.

Man Utd inflict first Spurs defeat on Mourinho as Liverpool romp clear

LONDON

JOSE Mourinho endured an unhappy return to Manchester United as Marcus Rashford struck twice in a 2-1 defeat for Tottenham while Liverpool maintained their eight-point lead at the top of the Premier League, putting five goals past Everton.

Second-placed Leicester equalled their top-flight league record of seven consecutive wins with a 2-0 victory against bottom side Watford while Chelsea bounced back from two consecutive league defeats to beat Aston Villa 2-1.

Mourinho's first loss since taking charge of Spurs eases the pressure on Ole Gunnar Solskjaer as United moved above Tottenham, up to sixth in the table.

Rashford smashed United into an early lead with the help of some poor goalkeeping by Paulo Gazzaniga, the England international's powerful shot creeping in at the near post and he had chances to extend the lead.

Yet for all United's dominance in the first 45 minutes, one moment of brilliance from Dele Alli pulled Mourinho's men level before the

Alli plucked the ball out of the air and skipped beyond two United defenders with one touch before slotting home his fourth goal in as many games since Mourinho took charge.

United were handed the chance to retake the lead when Rashford went down under Moussa Sissoko's challenge in the penalty area early in the second half and he put his recent spot-kick woes behind him to send Gazzaniga the wrong way.

"The three points are massive for us," said Solskjaer.

"We've had too many draws this season and given too many points away from winning positions. It's a great lesson the last two games (Sheffield United and Aston Villa) and we came back in a great manner."

UEFA president criticises VAR use, says football needs uncertainty

NYON. SWITZERLAND

FOOTBALL needs uncertainty, the head of European soccer body UEFA said on Wednesday, as he criticised the way VAR technology had changed the character of football matches.

Aleksander Ceferin said that UEFA would propose soccer's rulemaking IFAB make changes to the way the VAR system, officially introduced in 2018, was being implemented, though he did not want to give more details.

The use of VAR, where match officials use video replays to check decisions by the referee on the pitch and flag possible mistakes, has been surrounded by controversy over the last few months.

Critics say the system goes far beyond its original remit and that decisions are taking too long.

"The game is changing and we are afraid that it is changing too much," Ceferin told reporters following a UEFA executive committee meeting, adding that the search for refereeing perfection was futile.

"Football needs uncertainty because the players make mistakes and the referees on the pitch have to take responsibility, not some people hidden in a van or a building 500 kilometres from the venue," he said.

"I can live with the fact that referees are human beings who make mistakes but now when technology makes a mistake, that is a problem," he said.

Ceferin said he was not against VAR in principle but said that "we have to make it clearer, we have to make it faster, we have to make it less invasive but it will stay."

One of the biggest sources of controversy has involved offside decisions where VAR officials use gridlines superimposed on the screen, leading to goals being disallowed because a player's toe or armpit was offside.

"The line is very thin and it's drawn by the VAR so it's the subjective line of an objective fact which is a bit strange," said Ceferin.

Other sources of confusion include the new handball rule and how far back in a move VAR officials should



go when checking for infringements.

"Do we check five minutes, do we check 15 minutes?" he said. "The referee never said in the past that we had to go back to a foul seven minutes ago."

"We still don't know which handball is handball, who is drawing the lines, how thick the lines are....there are many questions ahead."

Meanwhile, UEFA is to introduce a new-look playoff system for its 2022 World Cup qualifying competition which will avoid the need to compare results of teams in different groups.

UEFA said the 55 teams, who will be battling for 13

in Qatar, will be divided reached the last 16 from into 10 groups.

The 10 group winners will qualify directly for the World Cup while the runners-up will go into the playoffs along with two more teams from the 2020-21 Nations League.

Those 12 teams will then be divided into three paths, with a one-leg semifinal and a one-leg final in each path to decide the remaining three European finalists. In the qualifiers for the

2018 World Cup, there were nine groups where the winners qualified directly and the eight best runners-up went into four two-leg playoffs. Meanwhile, the women's

Champions League is to be transformed with the introduction of a group stage in what European governing body UEFA says will be a "game changer".

UEFA said on Wednesday that, instead of the knockout format which is currently used, the competition would consist

"The world's best women's club competition will get both the platform and visibility it deserves," said UEFA president Aleksander Ceferin.

UEFA added that marketing and television coverage would be centralised from the group stage onwards and matches would be scheduled to avoid clashing with any other major European football.

"There is a clear increase of the interest in the women's game. We see it from everywhere," UEFA deputy general secretary Giorgio Marchetti told reporters.

Marchetti said that UEFA had wanted to introduce the system earlier but decided that conditions were not quite right. "But now, with the investment of UEFA, investments of the national associations, investment of the clubs, we see that the game is growing," he said.

Gondaliya, the committee pointed out, seemed to have been upset by what he felt was inconsistency by the match's umpires in issuing decisions.

The situation, the committee pointed out, was diffused without much harm.

"In light of this, and based on witness statements, the committee has decided to issue a warning to the player in question and has demanded a written apology from the player," the committee disclosed in the statement.
